It added that the employment schemes, such as the Pradhan Mantri Mudra Yojana, have played a crucial role, accounting for 36 lakh additional female voters.

MI News Service, Raiganj: A woman in her mid-40s carried her ailing husband on her back on Monday as no wheelchair was available at the outpatient department of the Raiganj Government Medical College & Hospital (RGMCH).

Photos and videos showing Salita Barman, a homemaker from Raipur village under the Raiganj block of North Dinajpur district carrying her 51-year-old husband Paritosh on her back have gone viral on social media, sparking outrage.

This has prompted Krishna Kalyani, the Raiganj MLA, to question the kind of infrastructure available at the RGMCH, which happens to be the largest state-run referral hospital in North Dinajpur district. Sources said that recently Paritosh suffered an injury to his leg while supervising construction work in his house. On Monday, the couple reached the RGMCH in an e-rickshaw. However, there they found no wheelchair to take Paritosh to the outpatient department. "I was perplexed," said Salita. "On one hand, no wheelchair was available to carry my husband who couldn't walk because of his injury. On the other hand, the private security personnel posted at the entrance to the hospital insisted the e-rickshaw driver leave the place quickly." She said she had to carry her husband as there was no alternative. "Finding no other alternative, I asked my husband if I could carry him on my back to the outpatient department. Somehow, I carried him to the OPD."

#### JU tightens rules against ragging, implements stricter measures

Kolkata: Ragging remains a contentious issue at Jadavpur University (JU), resurfacing prominently after the death of a firstyear Bengali department student in August 2023, reportedly due to ragging in the main hostel. This tragic incident sparked widespread outrage across the state. Adding to the controversy, reports have emerged that some students allegedly involved in ragging managed to secure jobs through campus interviews. This revelation has prompted JU authorities to adopt stricter measures to address the menace of ragging. During a recent anti-ragging committee meeting, university officials decided to implement firm actions against those found guilty.

The committee resolved to withhold the academic mark sheets of students involved in ragging. Without these documents, securing new employment will be difficult for the accused. This measure aims to deter such behavior and hold offenders accountable. The decision comes amid ongoing legal battles involving students accused of ragging. While several students are currently in jail for their involvement in the 2023 case, others have only received show-cause notices or temporary suspensions from semesters. However, actions against 15 students were stayed by the Calcutta High Court, allowing them to continue attending classes and exams. One fourth-year civil engineering student, allegedly involved in ragging, reported-



ly secured a job through campus placement. This incident was discussed during the anti-ragging committee meeting, leading to the decision to withhold mark sheets unless authorized by court orders. Faculty members believe this move will

discourage reckless and inappropriate behavior among students, creating a significant deterrent against ragging. Since the August 2023 tragedy, no major incidents of ragging have been reported in JU hostels. Minor issues that arose were promptly addressed following complaints. Today, a special POCSO court in Alipore is set to hear the case related to the August 2023 ragging death. The incident had drawn national attention and prompted JU to re-evaluate its anti-ragging policies. The university's new measures aim to reinforce discipline while ensuring that such tragedies are not repeated. By targeting the academic and professional prospects of offenders, JU hopes to instill a culture of accountability and respect on campus.

# State stops use of ringer lactate: CMS issues new guidelines

#### MI News Service, Kolkata:

In a significant move, the Central Medical Store commonly used intra-(CMS) has issued a direc-venous fluid for rehydrative to remove Ringer Lac- tion and electrolyte manufactured by West Bengal Pharmaceuticals from all hospitals and healthcare centers across the state. The circular mandates immediate withdrawal of the stock from hospital wards and storage in sealed areas. CMS has also instructed authorities to submit detailed reports confirming compliance with this directive.

The controversy surrounding this specific Ringer Lactate solution has prompted the State Health Department to take a firm stand. Although initial instructions to cease its use were issued earlier, reports suggest that Chief Medical Officers of Health (CMOHs) in several districts were yet to receive the directive. Concerns were also raised about the lack of clarity on suitable alternatives to replace the solution, leading to widespread apprehension among healthcare providers. In response, the CMS has now clarified that no Ringer Lactate solutions from West Bengal Pharmaceuticals are to be used, even if they remain in stock. The directive emphasizes the need to ensure patient safety and eliminate any potential risks associated with the use of the controversial

Ringer Lactate is a solution balance. However, the specific batch produced by West Bengal Pharmaceuticals has been at the center of quality concerns. Although the exact nature of the controversy has not been disclosed. the Health Department's decision to recall the product underscores the importance of maintaining stringent quality standards in medical supplies.

Healthcare authorities have been tasked with ensuring the immediate removal of the affected product. CMS has directed all hospitals to seal the withdrawn stock securely and maintain records of compliance. Regular monitoring and reporting mechanisms have been put in place to track the progress of this directive.

This proactive measure by the State Health Department reflects its commitment to prioritizing patient safety. However, the sudden shift has also raised questions about the existing quality control mechanisms for medical supplies in the state. Experts have emphasized the need for regular inspections and stringent quality checks to prevent similar incidents in the future.

# Trade licenses only after paying waste management fee: New KMC rule

MI News Service, Kolkata: The Kolkata Municipal Corporation (KMC) has made it mandatory for establishcommercial ments to pay a waste management service charge to obtain or renew their trade licenses. This directive has been communicated online to all businesses within KMC's jurisdiction. The Urban Development and Municipal Affairs Department is expected to release a gazette notification soon to clarify and formalize the rule. According to KMC, the waste management service charge applies to commercial establishments with an area of 500 square feet or more. Payment of this charge is a prerequisite for obtaining a trade license, and a software system has been implemented to enforce compliance.

During a recent Mayorin-Council meeting, it was strengthen this rule through a gazette notification. However, the prowill first presented in the municipal assembly for approval, ensuring compliance with legal procedures.

A senior KMC official revealed that the waste management department has already generated 64 crore in revenue, of which approximately 42 crore from service came charges. However, many commercial establishments remain outside the purview of this charge. To address this, KMC has integrated the waste management fee with the trade license fee structure, ensuring that all elibusinesses contribute.

The official also noted a challenge: several businesses opt to pay trade license fees for five or ten years in advance, leading to questions about corresponding waste management fees. To resolve this, KMC has issued notices stating that waste management charges for the entire trade license period must also be paid upfront.

The Urban Development and Municipal Affairs Department will soon publish these decisions in a gazette notification, making them legally binding. Notably, this rule applies solely to commercial establishments and excludes residential proper-

This initiative highlights KMC's commitment to sustainable urban management and financial efficiency. By linking trade licenses to waste management fees, the corporation aims to ensure that all commercial establishments contribute to maintaining the city's cleanliness and infra-

# Medinipur Med College implements junior doc ban in OT amid saline incident

MI News Service, Kolkata: Following the saline controversy at Medinipur Medical College, junior doctors have been barred from entering operation theatres (OT). The college principal, Mausumi Nandi, issued a directive prohibiting postgraduate trainees (PGTs) from participating in surgeries or administering anesthesia.

Heads of the gynaecology, general surgery, orthopaedics, ophthalmology, and ENT departments were instructed to

ensure only senior doctors and senior residents (SRs) conduct surgeries. The decision has sparked debates about whether senior doctors alone can manage the volume of surgeries and deliveries conducted daily across the state. Many question the feasibility of excluding juniors, given their critical role in maintain-

ing hospital efficiency.
Chief Secretary Manoj Pant alleged that OT protocols were not followed during the incident at Medinipur. He claimed the treatment of patients, including pregnant women, was handled by trainee doctors. "Surgeries must always occur under the supervision of senior doctors. In this case, trainees were solely responsible, violating the established protocols," he

Pant emphasized that junior doctors must operate under senior supervision and adhere to duty rosters. A preliminary

investigation pointed to negligence, prompting the college administration to enforce the directive. Non-compliance will now be treated as a punishable of-

The Junior Doctors' Front released a statement criticizing the health department's handling of the situation. They accused Health Secretary Narayan Swaroop Nigam of attempting to scapegoat junior doctors while ignoring systemic issues.

# Howrah residents can now check legality of buildings online

MI News Service, Kolkata: In a move to promote transparency, Howrah Municipality is launching a new online system to help residents check if nearby high-rise buildings are legally constructed. By visiting the municipality's website and entering the building's holding number, residents can instantly verify whether the construction or additional floors have been approved by the

civic body. If the search reveals that a building permitted for three stories has been extended to six stories without approval, residents can report it directly to the municipality. The civic body will then investigate and, if necessary, demolish the unauthorized sections.

The new system is set to go live by March, according to Howrah Municipality's Chief Administrator, Sujoy Chakraborty. He explained that this initiative would not only curb unauthorized construction but also empower citizens to act against illegalities. "The municipality will now have better control over monitoring and preventing unauthorized structures in the city,' Chakraborty said. The online system will

also benefit potential homebuyers by allowing them to verify whether the building they plan to purchase a flat in is fully approved. Chakraborty noted, "Many buyers unknowingly purchase flats in illegal sections of buildings. Later, when the municipality identifies the unauthorized part and demolishes it, the buver faces significant trouble. This system will prevent such issues.

# **Centre considering manda**tory hallmarking for silver



MI News Service, New Delhi: Food and Consumer Affairs Minister Pralhad Joshi on Monday asked the Bureau of Indian Standards (BIS) to consider implementing mandatory hallmarking for silver and silver artifacts following consumer demands. "There is a demand from consumers for mandatory hallmarking of silver. You (BIS) can deliberate and take a call," Joshi said at the 78th BIS Foundation Day event. The work in this direction has already begun and the government will take a decision after completion of stakeholder consultations and feasibility assessment by BIS, the minister told reporters on the sidelines of the event.

"I have asked BIS to work out feasibility and take reactions from consumers and ornament dealers. We will consult all stakeholders and start the process," he added. Silver hallmarking, which certifies the purity of the white metal, is currently voluntary. BIS Director General Pramod Kumar Tiwari told that the Bureau could be ready to implement mandatory silver hallmarking within 3-6 months, adding that the stakeholder discussions were underway.

"Several rounds of discussions were held with stakeholders and they are in favour of it. The discussion on printing a unique six-digit alphanumeric code is going on," Tiwari said. The move follows successful implementation of mandatory gold hallmarking introduced in June 2021, which now covers 361 districts. The existing system includes a unique six-digit alphanumeric code (HUID) certifying gold purity. According to the minister, about 90 per cent of jew-ellery being purchased is now hallmarked. More than 44.28 crore gold jewellery items have been hallmarked with unique IDs since the launch. Stakeholders from Gujarat, Karnataka and other states have requested the extension of mandatory hall-marking to silver, the minister added. BIS, established under the BIS Act in 1986, is an autonomous national body responsible for setting quality standards for

products and services.

# **Assam CM asks companies** not to hire Bangladeshis MI News Service, Guwa- Assam 2.0" investment

Himanta Biswa Sarma exhorted industrialists not to hire illegal Bangladeshi migrants in their units for "cheap labour".

Addressing a press conference here after meeting slew of industrial leaders from corporate houses including the Tatas, Adani Group and Mahindras, Sarma said there is a need to "strike at the roots" of the illegal migration from Bangladesh problem by not hiring such migrants. He explained that there are middlemen hired by the industry to get labour from Bangladesh, and the industry has to decide not to employ such labour. When asked if the issue featured during his discussions with industry captains over the weekend, Sarma said there is no need to "remphasise" an issue on which Assam has been fighting since 1979.

The state is looking at investment commitments of Rs 1 lakh crore from the central government and entities allied with it at the upcoming "Advantage

Guwahati in February. Attracting investments in sectors such as tourism, semiconductors and defence is the other focus area of the summit to be held on February 25-26. He said the Tata group's mega Rs 27,000-crore investment for a semiconductor assembly plant is on schedule, and the first phase will be inaugurated in either November or December this year. Apart from that, the Tatas have also evinced interest to set up a 500-MW solar capacity in the state, he said, adding that an industrial policy is in the works where fallow land being held by tea estates can be converted to put solar power capacity. Sarma said given the state's proximity to the northeastern theatre which sees maximum deployment of Army, the state is also looking to attract investments into defence production and repair. This aspect has featured during interactions with the Adani group and Mahindras, Sarma added.

# Textiles players seek duty reliefs, tax incentives from govt

MI News Service, New Delhi: The textile and apparel industry expects the budget to reduce import duties on raw materials as it aims to become a \$350-billion market by 2030, including \$100 billion in exports. Industry groups are also lobbying for a direct benefit transfer (DBT) system for cotton farmers and tax incentives to exporters.

The Confederation of Indian Textile Industry (CITI) has urged the government to cut basic customs duties on key raw materials such as man-made fibres (MMF), filaments and chemicals such as purified terephthalic acid (PTA) and monoethylene glycol (MEG). High tariffs inflate production costs, putting Indian manufacturers at a disadvantage compared with competitors such as Bangladesh and Vietnam, which enjoy duty-free imports. "Expensive raw materials weaken the cost competitiveness of Indian textile products, said a CITI official.

## Ex-IAS officer Puja Khedkar moves SC against Delhi HC's order dismissing anticipatory bail

The High Court had refused to grant her bail, stating that a strong prima facie case was made out against her and that an investigation was required to unearth the "larger conspiracy" to manipulate the system

The matter is expected to be listed before the Supreme

Court tomorrow. The High Court while passing Judgement had made strong observations against Khedkar, stating, "It's a classic example of fraud, not with a constitutional body but also with society

and the nation as a whole." The High Court bench stated that the UPSC is regarded as a prestigious examination and the incident in question represents a fraud not only against an organization but also against society at large. The court emphasized that interrogation is necessary to uncover the conspiracy in-

As a result, the court ruled that the plea was dismissed, and the interim protection granted to Khedkar was va-

The court observed that, prima facie, the conduct in this case appears to be aimed at deceiving the organization. It noted that the individual was not a legitimate candidate for the benefits but had been obtaining them through forged documents.

The court also highlighted that the father and mother held high-ranking positions, suggesting the possibility of collusion with influential in-

# Air pollution linked to higher hospitalisations for heart, lung diseases



Washington DC [US]: Short and long-term exposure to fine particulate matter (PM2.5) air pollution is associated with an increased risk of hospitalisation for severe heart and lung disorders, according to two large US studies published in The BMJ.

Together, the results suggest that no safe threshold exists for heart and lung health.

According to the Global Burden of Disease study, exposure to PM2.5 accounts for an estimated 7.6 per cent of total global mortality and 4.2 per cent of global disability-adjusted life years (a measure of years lived in good health).

In light of this extensive evidence, the World Health Organization (WHO) updated the air quality guidelines in 2021, recommending that annual average PM2.5 levels should not exceed 5 mg/m3 and 24-hour average PM2.5 levels should not exceed 15 mg/m3 on more than 3-4 days each year.

In the first study, researchers linked average daily PM2.5 levels to residential zip codes for nearly 60 million US adults (84 per cent white, 55 per cent women) aged 65 and over from 2000 to 2016. They then used Medicare insurance data to track hospital

admissions over an average of eight years.

After accounting for a range of economic, health and social factors, average PM2.5 exposure over three years was associated with increased risks of first hospital admissions for seven major types of cardiovascular disease - ischemic heart disease, cerebrovascular disease, heart failure, cardiomyopathy, arrhythmia, valvular heart disease, and thoracic and abdominal aortic

Compared with exposures of 5 mg/m3 or less (the WHO air quality guideline for annual PM2.5), exposures between 9 and 10 mg/m3, which encompassed the US national average of 9.7 mg/m3 during the study period, were associated with a 29 per cent increased risk of hospital admission for cardiovascular dis-

On an absolute scale, the risk of hospital admission for cardio-vascular disease increased from 2.59 per cent with exposures of 5 mg/m3 or less to 3.35% at exposures between 9 and 10 mg/m3. This means that if we were able to manage to reduce annual PM2.5 below 5 ug/m3, we could avoid 23 per cent in hospital admissions for cardiovascular disease," say the researchers.\*

These cardiovascular effects persisted for at least three years

after exposure to PM2.5, and susceptibility varied by age, education, access to healthcare services, and area deprivation level.

The researchers say their findings suggest that no safe threshold exists for the chronic effect of PM2.5 on overall cardiovascular health and that substantial benefits could be attained through

adherence to the WHO air quality guideline.
"On February 7, 2024, the US Environmental Protection
Agency (EPA) updated the national air quality standard for annual PM2.5 level, setting a stricter limit at no more than 9 ug/m3. This is the first update since 2012. However, it is still considerably higher than the 5 ug/m3 set by WHO. The newly published national standard was not sufficient for the protection of public health,"

In the second study, researchers used county-level daily PM2.5 concentrations and medical claims data to track hospital admis sions and emergency department visits for natural causes, cardiovascular disease, and respiratory disease for 50 million US adults aged 18 and over from 2010 to 2016.

During the study period, more than 10 million hospital admissions and 24 million emergency department visits were recorded.

They found that short-term exposure to PM2.5, even at concentrations below the new WHO air quality guideline limit, was statistically significantly associated with higher rates of hospital admissions for natural causes, cardiovascular disease and respiratory disease, as well as emergency department visits for respiratory disease. For example, on days when daily PM2.5 levels were below the new WHO air quality guideline limit of 15 mg/m3, an increase of 10 mg/m3 in PM2.5 was associated with 1.87 extra hospital admissions per million adults aged 18 and over per day.

The researchers say their findings constitute an important contribution to the debate about the revision of air quality limits, guidelines, and standards.

Both research teams acknowledge several limitations such as possible misclassification of exposure and point out that other unmeasured factors may have affected their results. What's more, the findings may not apply to individuals without medical insurance, children and adolescents, and those living outside the US.

However, taken together, these new results provide a valuable reference for future national air pollution standards.

# **Common headaches** are linked to neck $\oplus$ inflammation: Study

Our imaging approach provides first objective evidence for the very frequent involvement of the neck muscles in primary headaches, such as neck pain in tension-type headache, using the ability to quantify subtle inflammation within muscles," said Nico Sollmann, M.D., Ph.D., resident in the Department of Diagnostic and Interventional Radiology University Hospital Ulm, and the Department of Diagnostic and Interventional Neuroradiology at University Hospital Rechts der

Isar in Munich, Germany. Tension-type headaches affect two out of every three adults in the U.S. People with tension-type headaches often feel a tightening in the head and mild to moderate dull pain on both sides of the

While these headaches are typically associated with stress and muscle tension, their exact origin is not fully understood.

Migraines are characterized

by severe throbbing pain. Migraines generally occur on one side of the head, or the pain is worse on one side. It may also cause nausea, weakness and light

According to the American Migraine Foundation, over 37 mil-lion people in the U.S. are affected by migraine, and up to 148 million people worldwide suffer from chronic migraine. Neck pain is commonly associated with primary headaches. However, no objective biomarkers exist for myofascial involvement.

Myofascial pain is associated with inflammation or irritation of muscle or of the connective tissue, known as fascia, that surrounds the muscle.

For the study, Dr Sollmann and colleagues aimed to investigate the involvement of the trapezius muscles in primary headache disorders by quantitative magnetic resonance imaging (MRI) and to explore associations between muscle T2 values and headache and neck pain frequency. The prospective study included 50 participants, mostly women, ranging in age from 20 to 31 years old. Of the study group, 16 had tension-type headaches, and 12 had tension-type headaches plus migraine episodes. The groups were matched with 22 healthy controls. All participants underwent a 3D turbo spin-echo MRI. The bilateral trapezius muscles were manually segmented, followed by muscle T2 extraction.



# Hearing relaxing words in sleep slows your heart down: Research



Washington DC: Researchers from the GIGA - Centre of Research Cyclotron at the University of Liege discovered that the body reacts to the external world when sleeping, which explains how sensory input might alter sleep quality.

Researchers at ULiege have collaborated with the University of Fribourg in Switzerland to investigate whether the body is truly disconnected from the external world during sleep. To do so, they focused on how heartbeat changes when we hear different words during sleep. They found that relaxing words slowed down cardiac activity as a reflection of deeper sleep and in comparison to neutral words that did not have such a slowing effect. This discovery is presented in Journal of Sleep Research and sheds new light on brain-heart interactions during sleep. Matthieu Koroma (Fund for Scientific Research -FNRS postdoctoral researcher), Christina Schmidt and Athena Demertzi (both Fund for Scientific Research - FNRS Research Associate) from the GIGA Cyclotron Research Center at ULiege teamed up with colleagues from University of Fribourg to lead a previous study analysing brain data (electroencephalogram) showing that relaxing words increased deep sleep duration and sleep quality, showing that we can positively influence sleep using meaningful words. By that time, the authors hypothesized that the brain also remains able to interpret sensory information in a way that makes our body more relaxed after hearing relaxing words during sleep. In this new study, the authors had the opportunity to analyze cardiac activity (electrocardiogram) to test this hypothesis and found that the heart slows down its activity only after the presentation of

relaxing, but not control words. Markers of both cardiac and brain activity were then compared to disentangle how much they contributed to the modulation of sleep by auditory information. Cardiac activity has been indeed proposed to directly contribute to the way we perceive the world, but such evidence was so far obtained in wakefulness. With these results, the ULiege researchers showed that it was also true in sleep, offering a new perspective on the essential role of bodily reactions beyond brain data for our understanding of

sleep.
"Most of sleep research focuses on the brain and rarely investigates bodily activity", says Dr. "We nevertheless hypothesize

that the brain and the body are connected even when we cannot fully communicate, including sleep. Both brain and body infor mation need then to be taken into account for a full understanding of how we think and react to our environment", explains Dr. Demertzi. "We shared freely our

methodology following the principles of Open Science hoping that the tools that helped to make this discovery will inspire other researchers to study the role played by the heart in other sleep functions", Dr.Koroma advo-

This work offers a more comprehensive approach about the modulation of sleep functions by sensory information. By looking into the cardiac responses to sounds, we may, for example, study in the future the role of the body in the way sounds influence emotional processing of memories

# People who follow plant-based diet are less prone to OSA

Los Angeles [US] : People who consume a plant-based diet rich in vegetables, fruits, whole grains and nuts are less likely to suffer from obstructive sleep apnea (OSA), according to a study published in ERJ Open Research.

People who consume an unhealthy plant-based diet rich in refined carbohydrates, sugary drinks, and high-sugar, high-salt foods are more likely to develop

People with OSA frequently snore loudly, their breathing begins and ends throughout the night, and they may wake up multiple times. This not only causes fatigue, but may also increase the risk of high blood pressure, stroke, heart disease, and type 2 diabetes

The new study is one of the first large-scale analyses to investigate the correlation between plant-based diets and OSA risk.

Researchers said its findings suggest that eating a healthy, plant-based diet may help prevent

or treat OSA. The research was led by Dr

Yohannes Melaku from Flinders University in Adelaide, Australia.

He said, "Risk factors for obstructive sleep apnoea may stem from genetics or behaviour, including diet. Previous research has primarily focused on the impact of calorie restriction, specific dietary elements and weight loss. There's a gap in our knowledge of how overall dietary pat-terns affect OSA risk. With this study, we wanted to address that gap and explore the association between different types of plant-based diets and the risk of OSA."

The research included data on 14.210 people who were taking part in the US National Health and Nutrition Examination Survey.

Participants were asked to explain everything they had eaten over the last 24 hours. Researchers categorised this information according to whether people were eating a healthy plant-based diet (including whole grains, fruits, vegetables, nuts, legumes, tea and coffee) or a diet high in animal foods (including animal fat, dairy, eggs, fish or



seafood and meat). They also looked at whether people were eating an unhealthy, plant-based diet (including refined grains, potatoes, sugar-sweetened drinks, sweets, desserts and salty foods).

Participants also answered a

questionnaire designed to gauge

fering from OSA. People with diets highest in plant-based food were 19% less likely to be suffering from OSA, compared with those eating diets lowest in plant-based food. Those eating a largely vegetarian diet were also at a lower

whether they are likely to be suf-

risk. However, people eating a diet high in unhealthy plant-based foods were at a 22 per cent higher risk, compared to those eating low amounts of these foods.

The researchers also found differences in the risks for women and men, with a plant-based diet

having a stronger correlation with OSA risk for men and an unhealthy plant-based diet having a bigger increase in women's risk. Dr Melaku said, "These results

highlight the importance of the quality of our diet in managing the risk of OSA. It's important to note these sex differences because they underscore the need for personalised dietary interventions for people with OSA.

This research doesn't tell us why diet is important, but it could be that a healthy plant-based diet reduces inflammation and obesity. These are key factors in OSA risk. Diets rich in anti-inflammatory components and antioxidants, and low in harmful dietary elements, can influence fat mass, inflammation, and even muscle tone, all of

which are relevant to OSA risk." The researchers now plan to investigate the links between eating ultra-processed food and OSA risk in the same group of people. They also intend to study the interaction between diet and OSA

risk over the longer term. Professor Sophia Schiza is

Head of the European Respiratory Society's assembly on sleep-disordered breathing, based at the University of Crete, Greece, and was not involved in the research. She said, "Obstructive sleep

apnoea is a frequently occurring condition, and a significant number of individuals remain unaware of their own diagnosis despite the associated risks. There are treatments available for OSA and patients can also take certain steps to improve their condition This involves refraining from smoking, maintaining a healthy weight, and staying physically

active.

"The findings of this study propose that modifying our diet might be beneficial in managing or avoiding OSA. Being aware that incorporating a wide variety of vegetables, fruits, and whole grains into our diet while minimizing the consumption of unhealthy foods and sugary drinks can greatly improve our overall health. We need to make it as easy as possible for everyone to adopt a healthy diet.'

## Elon Musk is an evil person, say **President-elect Donald Trump aide** Stephen K. Bannon



News Service, New York: Stephen K. Bannon has launched a stinging attack on Elon Musk, calling him a "truly evil person", in comments that deepen hostilities between two men who have been influential advisers to President-elect Donald J.
Trump. "I will get Elon
Musk kicked out by the time he's inaugurated,' Bannon said of Trump's inauguration on January 20, in an interview with the Italian newspaper Corriere Della Sera. "He won't have a blue pass with full access to the White House. He'll be like everyone else."Bannon was an architect of Trump's presidential election victory in 2016 and served for a time as chief strategist during his first term in the White House. Since his release in October from a four-month stint in federal prison for a contempt conviction, Bannon has renewed his war of words with Musk, who poured more than a quarter of a billion dollars into Trump's election win in November and has since become a constant presence at his side.

In the interview, published last week, Bannon said of Musk: "He's a truly evil person. Stopping has become a proposal." has become a personal issue for me."The insults reflect broader tension on the Right in the US about the direction of the movement that Trump has championed and fears that Musk could use his influence to sideline powerful figures within that movement to promote his own agenda. Musk does significant business with the federal government as the chief executive of SpaceX, and also runs the automaker Tesla.

Some Right-wing personalities who initially welcomed Musk's entry into Republican politics now say they feel deceived, raising questions about the

durability of their alliance. Trump tapped Musk to co-lead an effort aimed at slashing the federal bureaucracy, but it is not clear what if any role Bannon will have in the administration. Before he left office in 2021, Trump pardoned Bannon before he faced a trial on charges that he misused money he had helped raise for a group backing Trump's border wall. Musk has not publicly responded to the

statements by Bannon. One focus of their dispute has been the use of H-1B visas to bring skilled foreign workers to US companies, a practice decried by some conservatives who oppose immigration. Musk supports the visas, like many tech leaders who say they help to bring critical workers to their companies.

# One Indian national killed, another wounded while serving in Russian army: Ministry

MI News Service, Moscow: One Indian national apparently recruited by the Russian army has been killed while another was receiving treatment for injuries at a hospital in Moscow, the Indian foreign ministry said on Tuesday.

Prime Minister Narendra Modi's government has "strongly taken up" the matter with Russian authorities in Moscow and with the Russian Embassy in New Delhi while reiterating its demand for the early discharge of remaining Indian nationals serving in the Russian army, the ministry said in a statement.

"We are working with the Russian authorities for early transportation of the mortal remains to India," the ministry said. "We have also sought the early discharge and repatriation to India of the injured person." Both came from the southern state of Kerala, it said. Indian police in May arrested four people linked to a network of human traffickers on suspicion of luring young men to Russia with the promise of lucrative jobs or university places only to force them to fight in the war with Ukraine.After the deaths of Indian nationals last year in the war, New Delhi demanded that there be a verified halt to recruitment of Indian nationals by the Russian army and urged Indians to exercise caution while seeking employment in Russia. About 45 Indian nationals were discharged from the Russian army and efforts were underway to get a further 50 released, India's foreign ministry said in September.

## China's Tibet region hit by several earthquakes days after major tremors, casualties among clergy unknown

MI News Service, Tibet: At least two Tibetan Buddhism monastic centres were severely damaged in Tibet with an unknown number of monks and nuns hurt, according to the few state media reports on the damage to religious sites since last week's powerful earthquake. The magnitude 6.8 quake reduced to rubble roofs and walls at a monastery and a nunnery about 15 km (nine miles) east of the epicentre in Tingri county, China Tibet Online reported on Sunday

Buddhist monasteries and nunneries are key to Tibet's cultural identity. Families send at least one male child to a monastery for studies, while monks are a source of blessings and council in communities. Authorities have yet to reveal how many monasteries and nunneries were damaged though they were quick to tally more than 3,600 collapsed houses. It was also unclear if the clergy were among the 126 people who died in a headcount that has not changed since the day of the Jan. 7 quake. The violent shaking trapped several of Dzongbu Temple's nuns, who were later pulled out from underneath the collapsed structure, China Tibet Online said. Rescuers later moved them to makeshift facilities outside a less-damaged monastery. The nearby Sengar Chode Monastery, founded in 1541, is home to a number of relics, which have since been moved into the custody of county officials, Global Times reported. # Economic woes not a deal breaker as China's Lunar New Year travel rush kicks off

MI News Service, Beijing: The annual travel rush for China's Lunar New Year celebrations officially began on Tuesday, with many taking a mental break from their worries about the future to reunite with family or take a holiday.

The peak travel season in the world's second-largest economy kicked off with a train departing from Beijing minutes after midnight, taking early bird travelers from the capital to Hefei in eastern Anhui province.Most people aim to be with family for the traditional reunion dinner on the eve of the New Year, which falls on Jan. 29 this year. The 40-day travel season will continue until Feb. 22, during which authori-

domestic trips will be made. The forecast matches 2024's estimate, although only 8.4 billion trips were actually made during last year's festivities. Railway passenger volume is expected to exceed 510 million passengers, while more than 90 million passengers are expected to fly. However, the number of journeys by private vehicle is expected to reach 7.2 billion trips, or about 80% of the total domestic passenger flow, national television broadcaster CCTV said. Most of China's 1.4 billion population will be celebrating this year's Lunar New Year, also known as the Spring Festival, at a time when the economy is struggling to sustain a durable recovery ties estimate a record 9 billion hamstrung by weak domestic



demand and a prolonged property market crisis. Some travelers said they

would not allow the state of the

economy to take the shine off the upcoming celebrations. "Although the economy has slowed down, I think the coun-

try as a whole is taking into consideration (the economic situation) and us, as ordinary people, are living well (day to day)," said Wang Zhixu, a 55vear-old who works in property management services, and was at the station in Beijing. "Peace within our country brings us the most happiness." Air passengers who purchased multiple destination tickets for the festive period rose 50% compared to last year, and hotel bookings in some counties have increased, CCTV said.

Beijing, Guangzhou, Harbin, Dali and Fuzhou were popular destinations for holidaymakers making the most of the eight-day public holiday. But for young people looking for work, the outlook is differ-

ent. Shi Zhenyue, 22, en route to Harbin for a holiday with friends before travelling on to Wuxi in eastern Jiangsu province to celebrate the New Year with family, hoped for an improvement in the economy so she could join the workforce. "If the economy does get better (in the new year), I will have a better chance of finding a job, and I won't have to go back to study for a master's or doctoral degree. And if the economy improves, my father's bonus (from work) won't be halved. Everything else is fine," Shi said. Youth unemployment hit 18.8% last August, the highest since the authorities changed the way they calculated the figures in December 2023. Although joblessness data has shown

some improvement in recent months, millions of college graduates have been pushed into accepting low-paying work or even subsisting on their parents' pensions. Many have also abandoned the stresses of big cities for a simpler life away from the hustle. For 33-year-old He who lives in northeastern Liaoning province with her fiance, the slower pace of life is a comfort. "Because we are not in a very big city like everyone else, we may not have too much pressure," said the small business owner who only gave her surname. "We had also stayed in the big city for a period of time after graduation, and then we chose to go back to our home town where we feel is friendlier, and also happier," she said.
