NCW welcomes court verdict in **RG Kar rape and** murder case

MI News Service, New Delhi: The National Commission for Women (NCW) has welcomed the Kolkata court's verdict sentencing the prime accused and later convict in the RG Kar Hospital rape-murder case Sanjay Roy to life imprisonment till death, but also urged legal action against the other accused



individuals currently out on bail. The gruesome crime committed on August 9, triggered widespread protests across the country. Announcing the verdict on Monday, Additional District and Sessions Judge Anirban Das in Sealdah court declared Sanjay Roy guilty of the rape and murder of a postgraduate trainee doctor at RG Kar Medical College and sentenced him to life imprisonment till death. According to a release, though the Commission had initially advocated for the imposition of the death penalty,

acknowledges the court's decision to impose a sentence of life imprisonment for the convict. "The NCW appreciates the swift proceedings of the case, which have led to a sense of justice being served. The social outcry surrounding this case demanded a strong judgment, and it is reassuring to see that justice has been delivered," the release said. "The Commission believes that this conviction will instill a sense of justice in society and remind everyone that such crimes will not go unpunished. We also call for accountability, urging that the other accused involved in the case, currently out on bail, should face legal action if found guilty," it added. It also mentioned that the Commission commends the statement made by the mother of the convict, which highlights that the law is bigger than emotion in such grave mat-

Junior doctors hold protest rally outside Sealdah Court, demanding sterner punishment for R G Kar convict

MI News Service, Kolkata: Demanding stricter punishment like death sentence for the convict Sanjay Roy in the RG Kar rape-murder case, hundreds of junior doctors held a protest rally outside the Sealdah

Court on Monday.

Participating in the rally, a protesting doctor asserted that they would approach the higher court with their demand.

"We wanted a stricter and exemplary punishment, this punishment of life imprisonment is not enough. We will move to higher courts seeking a stricter judgement," he said.

Meanwhile, Chief Minister Mamata Banerjee has expressed dissatisfaction over Monday's judgement for the convict Sanjay Roy in the RG Kar hospital rape-murder case and said if the case had been with Kolkata Police, they would have ensured a death penalty.

"I learned about the sentencing from the media. We have always demanded capital punishment and we continue to stand by it. However, this is the court's decision and I can't say much about this. For three other cases, Kolkata police ensured capital punishment through thorough investigations concluded within 54-60 days. This was a serious case. Had it been under our purview, we would have ensured the death penalty long back," CM Mamata said while addressing the media at Malda.

However, on the contrary, senior Congress leader Salman Khurshid has welcomed the judgement and said that it would convey a message to those who commit such heinous crime. "The biggest worry that people express in our country is that many sad incidents take place - people keep waiting for the Court and that leads to apathy. But, in this case, a quick investigation was done and the Court has also pronounced its judgement in very little time - and the judgement is also apt, it should be welcomed. Will it convey a message to those who commit such crimes?" Khurshid said.

But Union Minister and BJP state President Sukanta Majumdar also expressed dissatisfaction in the verdict, calling for a deeper investigation. Speaking to reporters after the verdict Majumdar, however, refrained from commenting against the court's decision.

"We wanted the highest punishment (for the convict Sanjay Roy). Being an elected representative, I can't say anything against the court verdict. The public of West Bengal does not believe that only one person is involved in the RG Kar rape-murder case. I think there should be more depth in this, as Sanjay is saying that police and other people were also involved," the BJP leader said.

The case involves the rape and murder of a trainee doctor whose body was found on August 9 in the hospital's seminar room.

Convict Sanjoy Roy sentenced to life imprisonment for rape and murder of lady doctor in R G Kar hospital

MI News Service, Kolkata: Ending all speculations about the verdict, the Sealdah court in the city on Monday awarded life imprisonment till death, to Sanjoy Roy, the lone convict in the heinous rape and murder case of a lady doctor in RG Kar Medical College and Hospital which had rocked the entire nation.

The court of Additional District and Sessions Judge Anirban Das in Sealdah had on Saturday held Roy guilty of the crime committed against the postgraduate trainee doctor at the hospital on August 9 last year, which sparked off unprecedented and prolonged nationwide protests.

Judge Das said the crime did not fall under the "rarest of the rare" category as justification for not giving death penalty to the convict.

The court also directed the state to pay a compensation of Rs 17 lakh to the family of the deceased doctor, which however refused."We do not want money we only want an early justice for my poor daughter", said the victim's father in the court.

The sentence was passed after the judge heard the final statements of the convict and his counsels placed in self-defence as well as those of the victim's family, and the CBI.

Roy, a former civic volunteer with Kolkata Police, was held guilty under Sections 64 (rape), 66 (punishment for causing death), and 103(1) (murder) of the Bharatiya Nyaya Sanhita

During Monday's hearing, the Central Bureau of Investigation (CBI) victims family strongly advocated for the the victim in a desperate

death penalty, terming the crime as the 'rarest of the rare' and citing Supreme Court guidelines on capital punishment.

Emphasizing gravity of the crime, the CBI stated "Creating such an offence is a rarest of rare crimes." Two sections give death. This

also said that till date he had uttered only those words as he was told by his lawyers to say inside the court.

However, before announcing the verdict the Sealdah Court adjourned its proceedings until 2:45 pm on Monday after both

Roy was convicted of rape and murder by the special court nearly six months after his arrest on August 10, a day after committing the crime inside the hospital premises.

The judge Anirban Das hinted at the possibility of a death penalty or life sentence for convict Roy due to the severity of the crime. However, junior doctors at RG Kar Hospital, where the victim was a trainee, expressed dissatisfaction with the verdict. They cited unresolved questions and the absence of action against other potential suspects, demanding a more thorough investigation into the case, including the motive and the involvement of

The 31-year-old lady doctor was raped and brutally murdered at the state-run R G Kar hospital on August 9 last year. The victim's body was found in the seminar room of the hospital. The incident led to

"Not satisfied, Kolkata Police would've ensured death penalty", says Mamata Banerjee on RG Kar verdict

MI News Service, Kolkata /Malda: Chief Minister Mamata Banerjee on Monday expressed dissatisfaction over the court verdict of the R G Kar Hospital rape and murder case giving life imprisonment to convict Sanjay Roy, and said if the case had been with Kolkata Police, they would have ensured a death penalty.

I learned about the sentencing from the media. We have always demanded capital punishment and we continue to stand by it. However, this is the court's decision and I can't say much about this. For three other cases, Kolkata police ensured capital punishment through thorough investigations concluded within 54-60 days. This was a serious case. Had it been under our purview, we would have ensured the death penalty long back," CM Mamata said while addressing the media at Malda.

After taking over the case on August 14, 2024, the CBI took five months to seek the death penalty for the accused in the RG Kar case. This comes in strong contrast with the stringent action taken by West Bengal police that ultimately led to the swift delivery of justice by the courts and the death penalty for culprits in cases such as Joynagar, Farakka, and Hooghly as they were wrapped in 50-60 days," she asserted.

Further, questioning the CBI's role in the case and trial, CM Mamata Banerjee said that she is not aware of how the CBI had handled the

case. "The details are theirs (CBI) to explain. Even though we had said that we would hand over the case if needed, the case was deliberately taken away from us. Our primary goal was always to secure the harshest possible punishment for the convict. I am not satisfied with this verdict," Mamata Banerjee added.

Praising the state police, the West Bengal CM said that they acted swiftly from nabbing the accused within just 24 hours of the crime on Au-

"During the CBI investigation, many speculated that the central agency delayed the probe deliberately under political pressure, raising serious questions about its effectiveness. In contrast, Kolkata Police acted swiftly, nabbing the accused, civic volunteer Sanjay Roy, within just 24 hours of the crime on August 9, 2024. But, despite the clear and early arrest, the case was transferred to the CBI on August 13 following political pressure, leading to delays that would shake the faith of many," Mamata Banerjee said.

She also claimed that once the CBI took over the investigation on August 14, 2024, it took two long months for the agency to file a chargesheeton October 7. "This two-month gap raised serious questions, as the Kolkata Police had already identified and arrested the accused and the

MI News Service, New Delhi: Senior Congress leader Rahul Gandhi has written to Union Health Minister J P Nadda and Delhi Chief Minister Atishi, highlighting the plight of hundreds of patients and their family members huddled on the footpath and subway outside AIIMS here and sought concrete steps to resolve this "humanitarian crisis".

The Leader of Opposition in the Lok Sabha also urged the central government to take concrete steps to strengthen the public healthcare system in the upcoming budget and increase the necessary resources for it. In a post in Hindi on X, on Monday Gandhi said, "I have written letters to the Chief Minister of Delhi and the Union Health Minister to provide better facilities to the patients and their families coming to Delhi AIIMS from all over the country."

He said "Recently I saw that in freezing cold these people are forced to sleep in the subway under the metro station, where there is no provision of drinking water or a toilet. There are heaps of garbage lying around. The arrival of such a large

number of patients to Delhi AIIMS also shows that people are not getting affordable and good quality health facilities where they live," Gandhi said.

"I hope that taking cognizance of my letter, the Chief Minister of Delhi and the Union Health Minister will take immediate steps to resolve this humanitarian crisis," he said. In his letter to Nadda, Gandhi said he wants to bring to his attention "the distressing situation" outside

Kolkata: The Current Situation studies reveal that in 98% of cases involving violence against intellectually disabled women and children, victims are unable to provide detailed accounts of what happened to them. In many instances, they don't even realize that they are being subjected to abuse, whether it be domestic violence or forced child marriag-

According to NCRB data (Crime in India 2019–2021), her story with CWF in 2017: 273 cases of child marriage were registered in West Bengal during this period. The situation worsened during the COVID-19 pandemic, with over 2,607 POCSO (Protection of Children from Sexual Offenses) cases being registered in 2021.

Intellectually disabled girls and women are not only unsafe but are also at a higher risk of mental health issues such as depression, anxiety, PTSD, and phobias. Many remain undiagnosed and untreated, leading to prolonged suffering and, in extreme cases, suicide. Challenges such as societal

"My daughter loved playing football. It was her favorite game. I traveled with her to various competitions, but during one event in another state, her male coach physically abused her. She became terrified and unable to articulate the incident. After counseling, we discovered what had happened. scraping off top layer of narrow roads for repairs

MI News Service, Kolkata: The Kolkata Municipal Corporation (KMC) has started scraping off the top layer before re-laying it on relatively narrow roads like BB Chatterjee Road in Kasba and Sarat Ghosh Garden Road in Dhakuria after similar work on arterial roads like Park Street and CR

Avenue was done earlier. When a fresh layer used to be laid earlier, the existing top layer was rarely removed or

scraped off. Rainwater from waterlogged streets enters ground floor rooms in many houses as the height of roads has become higher than houses on their periphery. Residents across the city complain that roads were much lower when they built their houses.

Uneven and undulating surfaces are another feature of almost all roads in Kolkata. Patchwork on broken roads is done hastily and without care and these end up forming undulated surfaces. Cars and buses move jerkily on the bumpy surface of these roads.

The KMC wants to put an end to this practice and see that road levels do not go above houses along the road.

Scraping off the older layer, as is being done on BB Chatterjee Road, will guarantee that the road's overall height does not rise further, said a senior official of KMC.

"Henceforth, the top layer on all roads that are 5m-wide or more will be removed before laying a fresh top layer. We are now laying a fresh top layer on BB Chatterjee Road after scraping off the old layer. We have plans to take up such projects on a few more roads in the coming months, before the next monsoon," said the offi-

The KMC is yet to focus on lanes and bylanes inside localities, which means many houses along such lanes whose heights have increased will remain vulnerable to flooding during monsoon.

The KMC has four which have drums that can scrape off 1m width of asphalt from a road. A fourth one has a narrower drum. A wide section of the road is scraped off by running the machine over it multiple times.

"We will procure five more road milling machines so we can take up projects on many roads simultaneously or can finish the work on one road faster by deploying multiple machines," said a

KMC official. The use of milling machines depends on the condition of the roads. Some roads that become battered or whose top layer wears off need a fresh top asphalt layer. The milling machine is used to scrape off the top layer on the entire length of such a road.

On other roads, only the uneven portions are scraped off to flatten the surface because the rest of the surface is still in good condition. "We removed only select portions on Park Street when we flattened the surface

recently," said the official. The work to remove the undulated stretches on Park Street has been completed between the Park Street-Chowringee crossing and the Mullick Bazar crossing. Such undulations on the rest of Park Street, from Mullickbazar to Park Circus, re-

Transfer policy: Bengal govt to count pupil-teacher ratio in govt schools

MI News Service, Kolkata: The state has decided to get the exact count of the teachers working in government schools along with their period of

An official said they want an idea of the pupil-teacher ratio in schools before deciding whether some teachers should be transferred.

The school education department issued an order.

The schools have been asked to state how long the teachers have been working in the respective insti-

An order signed by the commissioner of the school education de-partment said: "It has been decided by the competent authority that the rationalisation of the government school teachers will be done shortly. For the purpose of this rationalisation process, posting details of all the teachers are necessary.

A portal has been developed for this purpose. You are therefore requested to enter the posting details of all the teachers posted in your

A copy of the order has been sent to the heads of all 39 government

Regular teachers of government schools have been asked to send their compliance report by January

An official of the department said they also want to get an idea of the tenure for which a teacher has been posted in a school and then decide on the transfer.

"Some teachers have been teaching in a school for two decades. Such teachers could be transferred to another school. But while transferring a teacher, we will calculate the pupilteacher ratio so the transfer does not weaken the strength of the teachers in a school. It has to be borne in mind that teaching in a government school is a transferrable job," the official said.

The official said that unlike government-aided schools that are suffering from a poor count of students prompting the department to merge

Woman kills 8-yr old son Research scholars of IICB accuse chief of 'abuse, mismanagement'

MI News Service, Kolkata: Research scholars at the Indian Institute of Chemical Biology (IICB) have written to the director general of the Council of Scientific & Industrial

Research (CSIR) accusing the director of the Jadavpur campus of "harassand abuse", "research and academic mismanagement" and "impeding research progress".

The PhD students have written that the tenure of director Vibha Tandon is marked with persistent verbal abuse, which resulted in a "hostile and demoralising environment" on the campus. They have alleged that Mass Spectrometry and other machines are not being made available to them, impeding research.

The students have accused the director of "curtailment" of their research publications. "These ongoing issues have fostered a climate of distrust, frustration and dissatisfaction, preventing students from focussing on their academic pursuits and damaging the institute's reputation as a premiere research organisation," the students have written to the CSIR director general, N. Kalaiselvi.

When contacted for her reaction to the students' allegation, IICB director Tandon said in a text message: "Henceforth you please send an official email/letter to CSIR-IICB and administration will provide you a reply'

IICB, a biomedical research centre, was estabin 1935 and inducted "under the aegis" of the CSIR in 1956.

A PhD scholar at the institute said they had no option but to write to the CSIR director general as their attempts at approaching the IICB director to convey their grievances to her had met with a rude response.

"She usually does not want to grant any appointment. Even if we manage to meet her, the director behaves rudely and does not pay any attention to what we have to say. Left with no choice, we decided to approach the director general of the CSIR," the scholar said. The students have alleged that the curtailment of their research publications has led to the worsening research integrity" of the institute.

A grand jury found him guilty on 34 counts of falsifying business records. The Biden-Harris campaign said at the time that no one is above the law while Trump called the verdict the result of a "rigged" political system.

Just days before his swearing-in, Trump was sentenced to no punishment at all in his hush money case, with Judge Juan Merchan giving him an unconditional discharge.

Throughout all this, his ardent supporters have rallied behind him and his policies, including on the economy and immigration.

bank decided to cut the cash reserve ratio by 50 basis points to 4 per cent that was aimed at freeing up ₹1.16 lakh crore worth of bank funds that had been sequestered through the CRR mechanism. But it seems that the ploy hasn't worked. A Morgan Stanley report has highlighted just how acute the problem has become. "Despite a CRR reduction of 50 basis points in December 2024, liquidity is tracking in deficit in December and January, after remaining in surplus between March to November 2024," it said. It added: "The trend in inter-bank liquidity reversed as it swung to a deficit in mid-December, with an average of \$ 7.8 billion in December and tracking at ₹15 billion in January (month to date)."

NSG drill in Metro

Mahindra looks to scale up auto business globally

MI News Service, Mumbai: Having consolidated its position in the domestic market, Mahindra & Mahindra is now looking at ways to expand its presence across international markets, as per a top company executive.

The Mumbai-based auto major is looking to scale up its automotive business globally in a phased manner with plans to leverage its existing distribution channels in various overseas markets in the first phase In an interaction Mahindra & Mahindra (M&M) Executive Director and CEO for auto and farm sectors Rajesh Jejurikar said new products like the under-development lifestyle pickup truck and the new range of electric models would allow it to enter new international markets. He noted that the automaker already has a strong presence in countries like South Africa, Australia, New Zealand, Morocco, and Chile with an established distribution network. "A lot of these geographies started for us as markets where we sold Scorpio pick-up. Now these markets are enabling us to launch models like XUV 700, Scorpio N, and XUV 3XO," Jejurikar said. So, that's phase one, which is existing markets with products the automaker had launched in the last three or four years, he stated. The second part will initiate with the introduction of the global lifestyle pick-up, which would cater to both righthand and left-hand drive markets, he stated "It will open up newer markets for example, the ASEAN region is a big pickup market where we today don't have a presence at all," Jejurikar said. In 2023, M&M unveiled a "Global Pik Up" concept which is expected to move to the production stage in 2027. The company aims to tap into the international lifestyle pickup market with the model. Jejurikar said the third leg of enhancing global play would see the electric SUVs debuting across various right-hand drive markets.

MI News Service, New Delhi: The army chief, General Upendra Dwivedi, has requested his Nepali counterpart to revive the recruitment of Gorkhas in the Indian Army, which has not taken place in four years because of the pandemic and then the Himalayan nation's refusal to allow its ethnic community to join the Indian armed forces under the controversial Agnipath

"I have personally requested the Nepal Army chief to revive the recruitment of the ethnic Gorkha community in the Indian Army. I am very hopeful that it will resume sooner than later," Dwivedi told.

The recruitment of soldiers from Nepal has been suspended since 2020 following the Covid-19 pandemic and the introduction of the Agnipath scheme in 2022, under which soldiers, called Agniveers, are recruited for four years and have no retirement benefits. They are not entitled to gratuity or pension and 75 per cent of them will be demobilised after the completion of four years while the rest retained as regular cadre based on merit and organisational requirements.

Before the scheme, a fit general-duty soldier had to serve 15-18 years in the army.

Functioning of biological membranes can be controlled by DNA origami: Study

Washington [USA] : Scientists at the University of Stuttgart have succeeded in controlling the structure and function of biological membranes with the help of 'DNA origami'. It will help in facilitating the transportation of large therapeutic loads into cells. It now paves a new way for the targeted administration of medication and other therapeutic inventions

The team of scientists used DNA origami structures as reconfigurable nanorobots that can reversibly change their shape and thereby influence their immediate environment in the micrometre range.

The researchers found that the transformation of these DNA nanorobots can be coupled with the deformation of the giant unilamellar vesicles (GUVs) and the formation of synthetic channels in the model GUV membranes.

These channels allow large molecules to pass through the membrane and can be resealed if necessary.

It is a very valuable instrument which can be added to the toolbox of synthetic biology. Prof. Laura Na Liu and her team published their findings in the journal Nature Materials.

The shape and morphology of a cell play a key role in its biological function. This corresponds to the principle of "form follows function," which is common in



modern fields of design and architecture.

biology. Advances in DNA nanotechnology However, the transfer of this principle to artificial cells is a challenge in synthetic allow the creation of novel transport

channels that are large enough to facilitate the passage of therapeutic proteins across cell membranes.

In this emerging field, scientists such as Prof. Laura Na Liu, Director of the 2nd Physics Institute at the University of Stuttgart and Fellow at the Max Planck Institute for Solid State Research (MPI-FKF), have developed an innovative tool for controlling the shape and permeability of lipid membranes in synthetic cells.

These membranes are made up of lipid bilayers that enclose an aqueous compartment and serve as simplified models of biological membranes. They are useful for studying membrane dynamics, protein interactions, and lipid

This work is a milestone in the application of DNA nanotechnology to regulate cell behaviour," Liu says. The team works with giant unilamellar vesicles (GUVs), which are simple, cell-sized structures that mimic living cells. Using DNA nanorobots, the researchers were able to influence the shape and functionality of these synthetic cells. DNA nanotechnology is one of Laura Na Liu's main research areas. She is an expert in DNA origami structures -- DNA strands that are folded by means of specifically designed shorter

Al-driven technique analyses heart cells' inner electrical signals from outside: Study captured by invasive and more researchers led by the University of California, San

Diego, and Stanford University has discovered a noninvasive approach for monitoring electrical activity inside cardiac muscle cells from the outside, without physically penetrating the

The method is based on capturing electrical signals from outside the cells and using AI to reconstruct the signals within the cells with high precision.

The electrical signals inside heart muscle cells provide insights into how the heart functions, how its cells communicate and how they respond to drugs. However capturing these signals typically involves punctur-ing the cells with tiny electrodes, which can damage them and make large-scale testing complicated.

Now, researchers have found a way to peer inside the cells without actually going in.

The key lies in extracting the relationship between the signals inside the cells (intracellular signals) and those recorded on their surface (extracellular signals). "We discovered that extracellular signals hold the information we need to unlock the intracellular features that we're interested in," said Zeinab Jahed, a professor in the Aiiso Yufeng Li Family Department of Chemical and NanoEngineering at UC San Diego, who is one of the study's senior authors. Keivan Rahmani, a nanoengineering Ph.D. student in Jahed's lab, is

the first author of the study. While extracellular signals can be captured with less invasive methods, they do not provide much detail about the cell's electrical activity. "It is like listening to a conversation through a wall-you can detect that communication is happening, but you miss the specific details," explained Jahed. "In contrast, intracellular signals offer the details, making you feel like you are sitting inside the room hearing every word clearly, but they can only be technically challenging methods." Using AI, Jahed, Rahmani and colleagues developed a method to correlate extracellular signals with specific intracellular signals.

To develop the new method, the team first engineered an array of nanoscale, needleshaped electrodes. These electrodes, each up to 200 times smaller than a single heart muscle cell, are made of silica-coated with platinum. Heart muscle cells, derived from stem cells, were grown and then placed on the electrode array.

The researchers collected a massive dataset--thousands of pairs of electrical signals--each pair linking an extracellular recording with its corresponding intracellular signal. The data included how the cells responded when exposed to various drugs. This offered a rich library of data on how heart muscle cells behave under

different conditions. When analyzing these pairs, researchers identified patterns between the extracellular and intracellular signals. They then trained a deep learning model to predict what the intracellular signals looked like based solely on the extracellular recordings. In tests, their model created accurate and complete reconstructions of the intracellular

This work has important applications in drug screening, said Jahed. Every new pharmaceutical must undergo rigorous testing to ensure it does not adversely affect the heart--a process known as cardiotoxicity testing. Part of this process involves collecting detailed intracellular data from heart cells. Subtle changes in these electrical signals can provide clues about a drug's effects on the heart, which can help drug developers assess the safety of new medications. "Currently, this is a lengthy and costly process. It typically starts with tests on animal models, which don't always predict human outcomes," said Jahed.

Nuroscience study results can be better predicted by AI than human experts, say researchers

England [UK]: Large language models, a type of AI that analyses text, can anticipate the results of proposed neuroscience studies more correctly than human experts, according to a new study led by UCL (University College London) researchers.

The findings demonstrate that large language models (LLMs) trained on vast datasets of text can distil patterns from scientific literature, enabling them to forecast scientific outcomes with superhuman accu-


The researchers say this highlights their potential as powerful tools for accelerating research, going far beyond just knowledge

Lead author Dr Ken Luo (UCL Psychology & Language Sciences) said, "Since the advent of generative AI like ChatGPT, much research has focused on LLMs' question-answering capabilities, showcasing their remarkable skill in summarising knowledge from extensive training data. However, rather than emphasising their backward-looking ability to retrieve past information, we explored whether LLMs could synthesise knowledge to predict

"Scientific progress often relies on trial and error, but each meticulous experiment demands time and resources. Even the most skilled researchers may overlook critical insights from the literature. Our work investigates whether LLMs can identify patterns across vast scientific texts and forecast outcomes of experiments.

The international research team began their study by developing BrainBench, a tool to evaluate how well large language models (LLMs) can predict neuroscience

BrainBench consists of numerous pairs



that briefly describes the background of the research, the methods used, and the study results. In the other version, the background and methods are the same, but the results have been modified by experts in the relevant neuroscience domain to a plausible but incorrect outcome.

The researchers tested 15 different general-purpose LLMs and 171 human neuroscience experts (who had all passed a screening test to confirm their expertise) to see whether the AI or the person could correctly determine which of the two paired abstracts was the real one with the actual study results.

All of the LLMs outperformed the neuro-

accuracy and the humans averaging 63% accuracy. Even when the study team restricted the human responses to only those with the highest degree of expertise for a given domain of neuroscience (based on self-reported expertise), the accuracy of the neuroscientists still fell short of the LLMs, at 66%. Additionally, the researchers found that when LLMs were more confident in their decisions, they were more likely to be correct.* The researchers say this finding paves the way for a future where human experts could collaborate with wellcalibrated models.

The researchers then adapted an existing LLM (a version of Mistral, an open-

source LLM) by training it on neuroscience literature specifically. The new LLM specialising in neuroscience, which they dubbed BrainGPT, was even better at predicting study results, attaining 86% accuracy (an improvement on the general-purpose version of Mistral, which was 83% accurate).

Senior author Professor Bradley Love (UCL Psychology & Language Sciences) said: "In light of our results, we suspect it won't be long before scientists are using AI tools to design the most effective experiment for their question. While our study focused on neuroscience, our approach was universal and should successfully apply across all of science.

"What is remarkable is how well LLMs can predict the neuroscience literature. This success suggests that a great deal of science is not truly novel, but conforms to existing patterns of results in the literature. We wonder whether scientists are being sufficiently innovative and exploratory."

Dr Luo added: "Building on our results, we are developing AI tools to assist researchers. We envision a future where researchers can input their proposed experiment designs and anticipated findings, with AI offering predictions on the likelihood of various outcomes. This would enable faster iteration and more informed decision-making in experiment design."

The study was supported by the Economic and Social Research Council (ESRC), Microsoft, and a Royal Society Wolfson Fellowship, and involved researchers in UCL, University of Cambridge, University of Oxford, Max Planck Institute for Neurobiology of Behavior (Germany), Bilkent University (Turkey) and other institutions in the UK, US, Switzerland, Russia, Germany, Belgium, Denmark, Canada, Spain and Australia.

Study finds how gut microbes play role in regulating stress responsiveness throughout day

Cork [Ireland] : A groundbreaking study has revealed the critical role of gut bacteria in regulating stress responses through interac tions with the body's circadian rhythms.

The findings pave the way for the development of new microbial-based medicines to help people better manage stress-related mental health problems including anxiety and depression, which are frequently connected changes in circadian and sleep

This groundbreaking study from University College Cork and APC Microbiome Ireland, a Research Ireland Centre, provides compelling evidence that the trillions of microorganisms in the gut orchestrate the body's hormonal responses to stress in a timedependent manner, opening the door to new therapeutic approaches targeting the gutbrain axis. Published in Cell Metabolism, this study shines a spotlight on the intricate relationship between the gut microbiota and the hypothalamic-pituitaryadrenal (HPA) axis, the body's central stress response system. The research demonstrates that depletion of gut microbiota leads to an hyperactivation of the HPAaxis in a time-of-day specific manner, which alongside with alterations to the brain's stress and circadian responding regions, results in altered stress responsivity across the day. The study further identifies specific gut bacte-



ria, including a Lactobacillus strain (Limosilactobacillus reuteri), as key influencers of this circadian-regulated stress mechanism. L. reuteri emerged as a candidate strain that modulates glucocorticoid secretion (stress hormones), linking the microbiota's natural diurnal oscillations with altered stress responsiveness.

This groundbreaking discovery opens up new possibilities for psychobiotic interventions aimed at improving mental health outcomes by targeting gut bacteria that influence stress regulation.

With modern lifestyles increasdisrupting circadian rhythms through irregular sleep patterns, high stress, and poor diet, this research underscores the importance of the gut microbiota in maintaining the body's natural stress-regulation processes. Speaking about the findings, Principal Investigator Professor John Cryan said, "Our research has revealed an important link between the gut microbiota and how the brain responds to stress in a time-specific way. The gut

microbiome doesn't just regulate digestion and metabolism; it plays a critical role in how we react to stress, and this regulation follows a precise circadian rhythm. These findings underscore the importance of maintaining a healthy microbiome, particularly for those living in today's stressful and fastpaced environment.' First author Dr Gabriel Tofani

added "Our findings underscore the importance of not only the gut microbiota composition, but also how gut microbes change across the day. By showing that gut bacteria influence how the body handles stress throughout the day, we're helping to understand the mechanisms through which the microbiota shapes our responses to the environment around us. Our work also demonstrates that exploring this relationship between the gut microbiota and circadian rhythms will be key in the development of microbiota based therapies for the stressrelated disorders in the future".

"This study is a significant leap forward in our understanding of how the microbiome shapes our mental health," said Professor Paul Ross, Director of APC Microbiome Ireland. "At APC, we are committed to unravelling the many ways in which our gut microbiome impact human health, and this research provides crucial insight into how targeting specific bacteria may help manage or even prevent stress-related conditions


Study finds breakthrough tool for detecting problems during protein synthesis

Tokyo [Japan]: Protein synthesis in eukaryotic cells--found in plants, animals, and fungi-involves more than just the straightforward ribosome assembly of amino acids.

During or shortly after their synthesis, over one-third of all human proteins need to be delivered to the endoplasmic reticulum (ER). These proteins' structure and function depend on the critical folding and changes that take place in the ER, such as the creation of disulphide (S-S) bonds.

To overcome these challenges, a research team including specially appointed Associate Professor Hiroshi Kadokura and Professor Hideki Taguchi from the Institute of Science Tokyo, Japan, developed an innovative 'reporter' molecule that can detect ER-related problems during protein synthesis. Disruptions in protein translocation to the ER or disulfide bond formation underlie several diseases, and understanding the mechanisms that govern these processes is essential in biology medical science. Unfortunately, the tools available to study them are either quite limited in scope or require exceptionally expensive equipment and carefully repeated measurements.

While designing this reporter, the researchers took a page from a fusion protein called MalF-LacZ, derived from Escherichia coli bacteria. In these microorganisms, the MalF part of the protein helps



with translocating LacZ from the cytoplasm to the cell envelope.

Once transported there, the LacZ enzyme undergoes oxidation through disulfide bond formation, thus deactivating it. Therefore, problems in either transportation or disulfide bond formation would result in an abnormally activated LacZ enzyme Inspired by these elegant natu-

ral mechanisms, the research team developed a reporter molecule based on firefly luciferase (FLuc) that operates in a similar manner. Luciferase is a bioluminescence producing enzyme of firefly that produces light when it catalyzes the oxidation of Dluciferin in the presence of oxyadenosine triphosphate (ATP), and magnesium ions (Mg2+). More specifically, they engineered a FLuc variant that is

rendered inactive by disulfide bond formation in the ER, but remains active in the cytosol or if disulfide bonds do not form. They 'targeted' this compound to the ER by introducing specific modifications, and made it more prone to misfolding (and deactivating) within the ER by strategically replacing amino acids in the FLuc sequence with Cysteine.

Using this reporter, the researchers could easily detect problems in protein translocation to the ER, as well as problems in disulfide bond formation. A bioluminescence producing enzyme of a different type can serve as an internal control and ensures precise measurement.

Furthermore, the reporter protein is equipped with a motif that undergoes a modification (glycosylation) only when the protein is

translocated into the ER. Thus, they could also determine which of the two possibilities were the underlying cause for the activation of the FLuc reporter.

To showcase the power of this method, the team ran experiments in cells where the redox environment of the ER was chemically altered, disrupting disulfide bond formation. Additionally, they showed that the proposed reporter can detect defects in protein translocation induced by a potential anti-HIV drug, signaling the successful inhibition of the virus. "Given that luciferase-based assays are well-suited for highthroughput platforms, we suggest that this approach will facilitate large-scale screening of small molecules that specifically block the biosynthesis of harmful secretory pathway proteins," highlights

Notably, this novel reporter bears several advantages over other available methods, including its simplicity, robustness against environmental fluctuations, and high reproducibility. Our reporter system will serve as a valuable tool across various fields related to secretory pathway proteins, extending beyond fundamental studies,' Taguchi, hopeful for the future.

With any luck, these efforts will lead to a better understanding of both life processes and diseases. paving the way to new medical advances and treatments.

Untill the end of 2022, Axar averaged 21.26 and struck at 131.25 in the T20s. Since the beginning of 2023, the southpaw's performances have significantly upped, reflected in a 30.32 average and 145.62 strike rate.

His versatility was up for display, with India, Delhi Capitals and Gujarat using him under different circumstances. Axar has struck six fifties in the last two years while coming in at numbers 3, 4, 6 and 7.

Not only Axar, Hardik Pandya, Tilak Varma, Rinku Singh and captain Suryakumar Yadav, have been effectively used as floaters.



"Batting-wise, it's not just with me, but we spoke in 2023-24 itself that the openers are fixed, but everyone from Nos. 3 to 7 have been told that they can come into bat anytime, in any situation. It is not just that one batter will bat at a particular position. Our middle order will come to bat depending on the match situation, what kind of bowlers are bowling at the time, which match-up works well," Axar told reporters on

according

"We've spoken about that, how we can all be floaters, be it coming in early or obviously finishing. This is not just for me, but for everyone from No. 3 and below, especially if they are in good touch in the nets. We will adjust accordingly. In T20Is, how you use your batters is so crucial, so this is an important factor in batting," he added.

Axar will step into the stadium to face England with the added responsibility of playing Suryakumar's deputy role. The 31-year-old acknowledged that he would need to learn to take

"It has just been a day, but as part of the leadership group, there is an extra responsibility. The T20I side is settled, so there's not much pressure, but there are small decisions that need making, and during the game, I need to work closely with Suryakumar," Axar said.

"As part of the leadership group, you have to learn to take harsh decisions. We have spoken ions, and that will help build trust in this group. The T20I format is such that it is so fast that you have to make decisions quickly, so the larger conversations [with the coaches] is about how to do that," he added.

The five-match T20I series will begin on Wednesday at the iconic Eden Gardens. The squad resembles the one that toured South Africa in November last

The T20I series will be followed by a three-match ODI series, which will alow India to bolster its preparation and find the perfect combination for next month's Champions Trophy.

Australian Open: Sinner, Shelton move into quarterfinals

MELBOURNE [AUSTRALIA] : Top seed and defending cham-pion Jannik Sinner moved into the Australian Open quarterfi-nals following a hard-fought win over Holger Rune in the fourth round match on Sunday, during which he struggled with his fitness.

The world number one had skipped practice before the match and taken consultation from the tournament doctor ahead of the match, but managed to secure a win by 6-3, 3-6, 6-3, 6-2.

5, 6-3, 0-2. Struggling in Melbourne's 32-degree heat, Sinner called for a medical timeout during which he received a pulse check in the middle of third set. At the previous change of ends, after a 10-minute game during which he saved three break points, Sinner sat on a bench, with an ice towel on his face with his right hand twitching uncontrol-

The Italian looked physically drained from the treatment, but as the set progressed, he started to move better. Also, thanks to Rune's 16 unforced errors, Sinner secured the third set and broke early in the fourth set to

reach the quarterfinals of the competition for the third time.

Following the match as quoted by ATP's official website, Sinner said, "I think we saw that today I was struggling physically Camp house a late. physically. Came here as late as possible. I knew that it was going to be very, very difficult today. You know, playing against a tough opponent, but also playing against myself a little bit.

"When I am not feeling well on court, sometimes I tend to walk a little bit on the left. But, no, injury-wise I have nothing. Just health-wise a little bit struggling, but I am good with injuries.

"Of course, the time of the court with me and the doctor,

we talked a little bit. It helped me today, and it also shows that this tournament has great organisation," Sinner conclud-

Sinner secured 83 per cent of first-serve points and hit 35 winners and 35 unforced errors as compared to Rune's 31 winners and 54 unforced errors.

Sinner record against Rune improved to three wins and two

Also, on the other hand, Ben Shelton secured a berth in Australian Open quarters as well following Gael Monfils' retirement in the match due to an injury

The 22-year-old Shelton was leading by 7-6(3), 6-7(3), 7-6(2), 1-0 in a two hour, 56-minute battle, but Monfils called the match as the physical demands of running started to take a toll on his body and hindered his movement.

Speaking after the match, Shelton said, "Obviously he (Monfils) has played a lot of long matches, so I wanted to make it as physical as possible. There is a lot of things he does unbeliev-ably well, counter-punching, making you feel uncomfortable on the court, getting to the net. So, being able to find that balance was tricky because he was serving so well.

"Gael is someone I have watched since a little kid, I always say he has the greatest highlight tape of all time, and you saw some of that tonight. At 38 years old, I hope I am still walking without crutches... To push me the way he did today and entertain everyone in New Zealand and Australia in the way he has the last couple of weeks is so impressive.

"I hope to be able to create some memories like that with my family watching on at that age, because it is really special and unheard of in any other sport," he concluded.

Steve Smith update ahead of Sri Lanka series, Champions Trophy

MELBOURNE [AUSTRALIA]: In an encouraging update ahead of the Sri Lanka Test series, Cricket Australia revealed that star batter Steve Smith's elbow injury is not as bad as it seemed and has been cleared to join the Test squad.

Australia boosted by positive

The Australian squad are preparing for a two-match Test series in Sri Lanka starting from January 29, which will be swiftly followed by the ICC Champions Trophy.

The 35-year-old, who was named Test captain for the Sri Lanka

series in the absence of Pat Cummins, picked up a right elbow injury whilst attempting a throw during a Big Bash League fixture on

But he has been subsequently cleared to play, as revealed in a media release by Cricket Australia.

"Steve Smith has undergone a specialist medical review today following his right elbow injury sustained during the Big Bash League. He has been cleared to rejoin the Test squad and travel to Dubai," said the media release as quoted by ICC.

"Smith is expected to return to batting later in the week to begin his preparation for the first Test against Sri Lanka," added the

The news comes as a boost to an Australia side who were already

without captain Cummins due to an ankle injury.
Cricket Australia have also confirmed that National Selection Panel is keeping a close observation on Cummins, who has been

named as the captain for the upcoming Champions Trophy. Also in recovery is left-arm spinner Matt Kuhnemann, who sustained a fractured thumb while playing in the Big Bash League earli-

Kuhnemann, who was named in Australia's Test squad for Sri Lanka, is expected to resume bowling this week with a view to joining the squad in Sri Lanka if he continues to progress well.

The tour of Sri Lanka is the final series of the current World Test Championship (WTC) cycle, with Australia guaranteed a place in June's final against South Africa.

Pant became the most expensive player in the history of the IPL, being bought by Lucknow Super Giants for a massive Rs 27 crores during the IPL mega auction at Jeddah held in November

He beat compatriot Shreyas Iyer, who had just become the most expensive player in the league's history, going to Punjab Kings (PBKS) for Rs 26.75 crores a few minutes before his record-breaking bid. Iyer had beat Australia's Mitchell Starc, who marked his return to IPL after years with a record-breaking bid of Rs 24.75 crores.

Initially, there was a bidding war between LSG and Royal Challengers Bengaluru (RCB), with the latter giving up. Sunrisers Hyderabad (SRH) entered the bidding war, trying to in 76 T20Is at an underwhelming them to playoffs in the same sea-



attack and Delhi Capitals (DC) tried to use the 'Right To Match card, but they could not match the value LSG put for Pant, breaking the bank for him and going beyond Iyer's value

The swashbuckling wicket-keeper-batter is an all-format for India and a livewire on the field. Having proven himself as a man for big stages in Test cricket, Pant's T20 game is just as solid. Though he has scored 1,209 runs bolster their explosive batting average of 23.25, a strike rate of

almost 128 and just three fifties, his overall T20 numbers are way better, having made 5,022 runs in 202 matches at an average of 31.78, a strike rate of over 145, with two centuries and 25 fifties.

Pant represented Delhi Capitals (DC) for his entire IPL career since 2016, scoring 3,284 runs in 110 matches at an average of 35.31, with a century and 18 fifties. He was appointed as the team's captain in 2021 and led

Australia captain Alyssa Healy in doubt for rest of Women's Ashes amid foot injury SYDNEY [AUSTRALIA] : Australia captain

Alyssa Healy's availability in the rest of the Women's Ashes 2025 is in doubt after the 34-year-old developed "mid-foot soreness", as reported by ESPNcricinfo.

Healy had to miss the first T20I match of the series against England at the Sydney Cricket Ground after growing a foot soreness. Earlier during the Women's T20 World Cup 2024, the Aussie skipper sustained an injury on the same place.

In a statement, Cricket Australia stated that Healy is being managed in a boot and will not be available for today's game. 'Alyssa has developed mid-foot soreness

on the same side as her previous plantar fascia injury following the ODI series. She is currently being managed in a boot and will not be available for this evening's game," Cricket Australia's statement was quoted by ESPNcricinfo as saying. It added that the medical team is con-

sulting with specialists to make an appropri-

"Cricket Australia's medical team is consulting with specialists to develop an appropriate management plan over the coming days. Her availability for the remainder of the series will be assessed as more information becomes available." it added.

The Aussie captain injured her right foot during the ICC Women's T20 World Cup match against Pakistan in October last year, followed by a knee injury during the Women's Big Bash League (WBBL).

As a result, she missed the ODI series against India at home and was restricted to playing only as a batter during the New Zealand tour. Meanwhile, Australia has won the ODI series 3-0. With three T20Is and a one-off Test left, Australia is one win away from retaining the Ashes. The hosts have taken a 6-0 points lead over England in the series. England will need to win all three T20Is and then the series-concluding Test match to end their 11-year Ashes drought.
