

#### Section of politicians are hand in glove with those who want to break Manipur, alleges CM Biren Singh

MI News Service, Imphal: Squarely blaming a section of politicians for allegedly joining hands with some secessionist forces and working hand in glove with those who want to break the state, Manipur Chief Minister N Biren Singh has claimed that too much politics over the ethnic issues has confused the people in this North Eastern state and created

internal conflicts. Speaking at a programme at Khangabok in Thoubal district on Thursday, the Chief minister said many people outside the state still do not understand the core of the current issues in Manipur which is gripped by a deep rooted ethnic violence between Meitei and Kuki communities and left over 250 people dead and thousands homeless since May 2023. He said that the state government's opposition is to the new immigrants in the state who are engaged in drug-related activities and not against anyone who has settled before.

In this connection, he claimed that taking advantage of the present situation some politicians were working in collusion with the forces which are trying to destabilise Manipur

Addressing the local people, Singh also cautioned them against exinterference in the ongoing ethnic turmoil, blam-

ing it for increasing

confusion and internal divisions in the state.

Too much politics has confused the people and created internal conflicts. Even some politicians are hand in gloves with those who want to break Manipur," Singh said, without naming any individual or party. He further alleged that "agents" within Imphal Valley were instigating tensions at the behest of external forces.

Since May 2023, Manipur has been caught in violent clashes between the Meitei and Kuki communities, resulting in over 250 deaths and the displacement of thousands. The crisis erupted over long-standing

#### Cal HC orders fresh probe by senior CID officer into death of four undertrials

MI News Service, Kolkata: In a major rected the ADG, CID, to nominate an move, the Calcutta High Court has directed the Additional Director General (ADG) of West Bengal CID to nominate an officer of higher rank than that of an inspector to hold a fresh investigation into the death of four undertrial prisoners in different police stations in South 24 Parganas district in 2023.

The court, however, said on Thursday that it is not inclined to transfer the investigation in the case to the CBI as prayed for by the petitioner, since the matter can be inquired into by a higher official of the state's Criminal Investigation Department (CID). Holding that it is not satisfied

with a report of the CID, prepared by an inspector in August 2023 on the death of the four undertrial prisoners, the court scrapped the said re-

The bench said the investigation has to be done by a senior officer of the CID since the allegation is against police officials.

A division bench presided by Chief Justice TS Sivagnanam di-

officer of higher rank than that of an inspector for holding a fresh investigation into the death of the four undertrial prisoners and proceed to take action in accordance with law.

The court said the officer nominated by the ADG should be "young and dynamic" and "will not be persuaded by any statements made earwould conduct a dispassionate inquiry into the matter, regardless of the fact that there are allegations against the officers of the West Bengal police department.

The bench, also comprising Justice Hiranmay Bhattacharyya, directed that the investigation be completed within eight weeks and a report be filed before the appropriate court. The petition was filed by the Association for Protection of Democratic Rights (APDR), praying for the handing over of the investigation to the CBI for an independent inquiry into the cause of death of the four undertrial prisoners in 2023.

The petitioner claimed that the cause of death of the four undertrials was unnatural and suspicious, alleging that they died on account of injuries inflicted upon them following their arrest by the police in different cases lodged at Baruipur, Maheshtala and Budge Budge police stations in South 24 Parganas district.

The court said after going through the report and submissions of the lawyers, it is of the prima facie view that the cause of death of the four was not owing to narcotic drug use by the accused persons as claimed in the said report.

The bench said the post mortem report clearly shows external in-

The state informed the court that it has paid compensation of Rs 5 lakh to the families of each of the deceased undertrial prisoners.

The bench also expressed hope that West Bengal's DGP will invite periodical reports from all the police stations in the state on installation and functionality of CCTV and recording devices. It also directed the DGP to initiate

The blood, which saves their lives, creates an iron overload in the system. The excess iron must be chelated out of their system. The process is both painful and costly. Who inherits; A Thalassaemia patient may be born only when both the parents of the patient are carriers of this disease. The carriers are people who carry one good gene and a defective one. Because the good gene compensates for the defective ones, a carrier acts and carries on like a normal person. But when two carriers produce a child there is 25% probability that both their defective genes combine to give birth to a Thalassaemia patient. The need of the hour is to prevent marriage between such carriers or ensure that after marriage, through pre-natal diagnosis, no Thalassaemia child is born. ## **Cal HC dismisses petition** against 'Swasthya Sathi'

MI News Service, Kolkata: The Calcutta High Court dismissed a public interest litigation (PIL) challenging the Swasthya Sathi Scheme, a flagship health insurance initiative by the West Bengal government. The petition, filed by an NRI doctor, argued that the scheme was launched with the intention of exploiting the upcoming elections and lacked any real foundation. During the hearing on Thursday, Chief Justice T.S. Sivagnanam observed that since Swasthya Sathi was a government initiative, created based on specific government policies,

the court had no grounds to intervene in the matter. The judge emphasized that government decisions related to public welfare were not within the court's purview to question unless there were clear viola-The petitioner tions. claimed that despite having Swasthya Sathi cards, many people were unable to access benefits, and several hospitals were refusing to accept the card. He further alleged that the scheme was merely a preelection gimmick designed to gain political leverage, accusing the government of using it as a tool for electoral advantage. The petitioner also

raised concerns about the equity of the scheme, pointing out that while the government provides Rs 5 lakh insurance cover per family, the number of members per family varies. He questioned how this amount could be the same for families of different sizes. However, the court clarified that since the scheme was aimed at public welfare, and given the government's decision to implement it, the court would not interfere.

The state government, in defense, argued that

Swasthya Sathi was part of its commitment to providing healthcare benefits to all citizens. The government also stated that the scheme was designed to be inclusive and accessible, with efforts underway to address any implementation issues, including hospitals not accepting the

With the court dismissing the petition, the Swasthya Sathi scheme will continue to operate as planned, and the government has assured further improvements in implementation and accessibility for all beneficiaries.

## **CBI** Court show-caused investigating officer in RG Kar corruption case

MI News Service, Kolkata: The special CBI court has issued a show-cause notice to the investigating officer (IO) of the Central Bureau of Investigation (CBI) for alleged lapses in the RG Kar Medical College financial corruption case. On Thursday, the judge raised concerns over why the agency had not informed the court

that the West Bengal government had granted approval to frame charges against former principal Sandeep Ghosh.

The court questioned, "Why was the information not conveyed to the CBI court despite state government approval? Why did it take three days for the special court to learn about this?

The court has given the CBI 24 hours to submit written explanation from the investigating officer detailing why the agency failed to notify the court on time. The judge made it clear that any delay in handling sensitive financial corruption cases would not be tolerated.

The case was initiated following allegations by

Superintendent (Non-Medical) of RG Kar Medical College, who filed a petition in the Calcutta High Court, accusing the institution of massive fiirregularities nancial amounting to several crores of rupees. Based on these allegations, the Calcutta High Court ordered a CBI probe into the matter.

## **Cal HC orders strict CCTV monitoring in police stations**

MI News Service, Kolkata: In the wake of multiple recent crimes, including an incident where a prisoner escaped from a police van and opened fire at officers, the Kolkata High Court has issued stringent directives to all police stations across the state. Chief Justice T.S. Sivagnanam has instructed that all police stations must ensure their CCTV cameras are fully operational. On Thursday, while hearing a case related to custodial deaths, the Chief

Justice warned the state

authorities about the critical importance of CCTV surveillance. He directed the Director General of Police (DGP) to closely monitor the functionality of these systems. Reports on CCTV performance must be sent to the DGP at regular intervals, and the storage and recording devices must also be properly checked to ensure they are functioning without errors. The High Court further mandated disciplinary action against any police officers found violating

CCTV regulations. Any failure in maintaining the surveillance system could lead to charges of misconduct against the responsible officials. The High Court's strict stance on CCTV surveillance is linked to a custodial death case that has been under judicial scrutiny. In 2023, four prisoners died while in custody at Baruipur Jail. Following the incident, the Kolkata High Court had ordered an investigation by the Criminal Investigation Department (CID).

124 Kg of cannabis

seized from secret

car chamber MI News Service, Kolkata: In a major crackdown on drug trafficking, Kolkata Police's Narcotics Cell seized 124 kg of cannabis hidden inside a secret chamber of a vehicle in the Hastings police station area on Wednesday night. Acting on a tip-off, officers intercepted the vehicle and conducted a thorough search, leading to the discovery of the concealed

drugs Sources that the large consignment of illegal cannabis was being transported from Angul in Odisha to Mandirbazar in South 24 Parganas. Based on intelligence inputs, police set up surveillance near AJC Bose Road and Belvedere Road, where they intercepted a white goods transport vehicle.

Initially, the search no suspicious items, but upon closer inspection, officers discovered a false compartment cleverly hidden within the vehicle's structure. The chamber was sealed with metal grids to evade detection. Once accessed, the police recovered 123 kg 802 g of cannabis, a substantial haul in the ongoing fight against narcotics smuggling.

Two individuals were arrested in connection with the case: Sourav Banik (25) from Mandirbazar and Kamal Sardar (21), also known as Bidda, from the same local-

Authorities that these two were acting as couriers for a largsmuggling network. responsible for distributing illegal drugs across various districts. The arrested duo has been charged under the Narcotic Drugs and Psychotropic Substances (NDPS) Act and is currently in police custody for further questioning.
Police officials believe

that the operation is part of a larger drug syndicate, with potential links to interstate smuggling rings. Investigators are now focusing on: Identifying the suppliers and financiers behind the shipment, by tracing the intended recipients of the consignment and by determining if similar hidden compartments were used in previous smuggling attempts

The seized vehicle has been impounded as forensic experts analyze its modifications, hoping to uncover further evidence.

This seizure highlights the increasing use of innovative methods by drug smugglers to transport contraband across state borders. Law enforcement agencies have intensified efforts to combat drug trafficking, with recent seizures of cannabis, heroin, and synthetic drugs in various parts of West Bengal.

Officials have urged citizens to remain vigilant and report suspicious activities to help curb the growing menace of narcotics smuggling.

Ballygunge Junction is one of the biggest and busiest Junctions in the Sealdah Suburban Section with movement in 4 directions. Also, Kankurgacchi Road Junction is one of the important junctions in the Sealdah Suburban Section which involves all movements in the Sealdah Main line and this is interlinking junction for Sealdah Main and Sealdah South Section. The existing Route Relay Interlocking (RRI) Systems at Ballygunge and Kankurgachi were commissioned in 1994 & 1993 respec-

tively. The earlier systems were based on old technology and it were prone to failure because of its age. It was hard to provide spare material for day to day maintenance because of old technology. To overcome this challenge Railway has decided to equip

Ballygunge and Kankurgachi with the state of Art Electronic Interlocking Systems. Ballygunge Electronic

According to UK ministry of defence (MoD), the precision of the clock is so refined that it will lose less than one second over billions of years, allowing scientists to measure time at an unprecedented

Further improvement to GPS accuracy could transform global navigation systems, aiding in everything from satellite communica-



'We chose to investigate chronic kidney disease because some of the patients experience rapid deterioration of their condition without us knowing exactly who. Our goal was to understand which patients are most at risk and whether we can intervene early to delay or even prevent this progression," says Professor at the Department of Clinical Medicine at Aarhus University, Christian Fynbo Christiansen, one of the authors of the study.

A simple measurement The study showed that patients with newly diagnosed mild to moderate chronic kidney disease within three years have a 15 percent risk of rapid progression, which could lead to severe cardiovascular disease or even death.

Surprisingly, the study also showed that the risk of rapid progression varied significantly among patients.

A simple measurement of protein in the urine proved to be a strong indicator of the course of kidney disease. For women without diabetes or elevated blood pressure/cardiovascular

disease and without the protein albumin in their urine, the risk of rapid progression was seven percent, while the risk peaked at 47 percent for men with both diabetes, elevated blood pressure/cardiovascular disease, and albumin in their urine.

"This is an important finding since albumin can be used as an indicator of kidney disease progression, thereby making it possible to identify patients at high risk of rapid deterioration of the disease, and it can improve the prevention of complications and hopefully increase patients' quality of life," explains Christian Evnbo Christiansen, adding:

"It underscores the need to use this simple test to a far greater extent.

Benefit for patients and socie-

The measurement can help healthcare professionals to target treatment and follow-up to patients at high risk. This could potentially be a significant gain for patients both in Denmark and the rest of the world.


"We hope that this result can contribute to increased awareness of the importance of using readily available markers including albumin in the urine to identify patients at high risk of rapid progression," says Christian Fynbo Christiansen.

And it's not only the patients who can benefit from the results. Faster and more effective prevention could also potentially help to reduce healthcare costs.

"I think we will focus much more in the future on patients with milder stages of the disease like those we included in this study. If we get better at preventing and treating chronic kidnev disease and its associated complications, it could potentially benefit both patients and society," explains Christian Fynbo Christiansen.

He emphasizes that further research and development of precise treatment methods are still needed. Although the study provides important insight into risk groups, a precise model for predicting individual patient outcomes is still lacking.


#### Researchers discover that unique immune cells stop metastatic cancer



A research team at the National Cancer Institute-desig-Montefiore Einstein Comprehensive Cancer Centre (MECCC) has uncovered a natural immunological response in mice that prevents escaping cancer cells from growing into tumours was published today in the jour-

"Preventing or curing metastases is the most critical challenge in cancer," said study leader Julio Aguirre-Ghiso, Ph.D., director of MECCC's Cancer Dormancy Institute. "We think our findings have the potential to point to new therapies to prevent or treat metastatic disease." The study's co-first authors are Erica Dalla, Ph.D., a former student, and Michael Papanicolaou, Ph.D., a postdoctoral fellow in Dr. Aguirre-Ghiso's lab.

Cells that migrate from primary tumors and seed metastatic tumors are called disseminated cancer cells (DCCs). Some DCCs behave aggressively, immediately starting tumors in new tissue, while others remain in a state of suspended animation referred to as dormancy. "It's long been a



never cause metastases, and we believe we've found the explanation," said Dr. Aguirre-Ghiso, who is also professor of cell biology, of oncology, and of medicine and the Rose C. Falkenstein Chair in Cancer Research at Albert Einstein College of Medicine. Breast cancer and many other types of cancer metastasize to the lungs. In research involving three mouse models of metastatic breast cancer, Dr. Aguirre-Ghiso and colleagues determined that when breast cancer DCCs spread to the lung's air sacs (alveoli), they are kept in a dormant state by immune cells known as alveolar macrophages.

'Alveolar macrophages are the lung's first responders, defending the organ against bacteria and dangerous substances like environmental pollutants,' said Dr. Aguirre-Ghiso. These specialized macrophages, he notes, appear early in embryonic development and reside within

new role for these macrophages, in which they recognize DCCs and actively interact with them, and-by secreting a protein called TGFb2--produce signals in the cancer cells that keep them in a dormant state," Dr. Aguirre-Ghiso said "Since every organ in the body has its own set of tissue-resident macrophages, they may function to keep DCCs in check in those organs as well. Our study has shown for the first time that these specialized macrophages function to actively induce dormancy in DCCs.

Confirming the importance of alveolar macrophages in keeping DCCs dormant. Dr. Aguirre-Ghiso and his team found that depleting them in the mice significantly increased the number of activat ed DCCs and subsequent metastases in their lungs compared to mice with normal levels of the

#### Himachal's second space lab becomes functional

Bilaspur (HP) Himachal Pradesh's second space lab was inaugurated here on Tuesday to provide school students with hands-on experience in space science, robotics, and aerospace technology. The first space lab is already functioning at Ghumarwin School in Bilapsur district. There are plans to set up five such labs in the district, an official statement said. "A space lab is a crucial step to inspire school children and kindle their interest in space science and technology," Technical Education Minister Rajesh Dharmani said after inaugurating the space lab at a government school.

The space labs are integral to Bilaspur's educational reform initiative, established to spark students' interest in Science, Technology, Engineering, and Mathematics (STEM), he said.

The lab is equipped with drones, 3D printers, telescopes, and models of Indian Space Research Organisation missions. Students will be introduced to in-depth knowledge of subjects like satellite communication and aerospace engineering, which are becoming globally important, he said. The minister said children from nearby schools can visit the lab and it will serve as a regional centre for science education. Additionally, educational trips to ISRO's Space Application Centre in Ahmedabad are being organised, he said, adding so far, 10 students have been there, and preparations are underway to send 50 more. Dharmani also inaugurated the first Activity-Based Learning (ABL) classroom in Bilaspur district. The ABL approach deviates from traditional learning, focusing instead on interactive and real-life experiences.

## Researchers find self-monitoring improves physical activity of elderly who require care

WASHINGTON DC: Self-monitoring of physical activity with an accelerometer and feedback is an effective method for improving physical activity in the elderly who need long-term care

The Kobe University study is the first to show that this demographic's physical activity can be increased using simple and safe methods, potentially lowering long-term care costs and preventing serious illness.

Taking more steps and sitting less is well understood to have a significant impact on a variety of noncommunicable diseases, including heart disease, diabetes, orthopaedic diseases, and stroke

This is particularly problematic in senior citizens who depend on long-term care such as in day-care centers, as it is known that they take fewer steps and spend more time sitting than healthy people of similar age. The resulting higher risk of falling ill not only decreases health-related quality of life in these people, it also stretches already scarce resources in healthcare systems. And while it is known that self-monitoring can improve the physical activity even among the elderly, the effectiveness of this approach has not been shown for this high-risk demographic. The Kobe University research team of health scientists IZAWA Kazuhiro and KITAMURA Masahiro filled this gap by conducting a comparative analysis with 52 long-term care patients at a day care center in Japan on the effectiveness of self-monitoring of physical activity.

They educated the participants on the importance of increasing physical activity and asked participants to wear



accelerometers that record steps, sitting time and activity of various intensity. The 26 participants in the intervention group were additionally asked to record their progress in a calendar daily and received weekly feedback and advice.

The results now published in the journal European Geriatric Medicine show that the intervention group took more steps, spent less time sitting and were more engaged in light physical activity. The authors write, "The results of this intervention promoting physical activity in this target population were novel to this study. Older people with longterm care needs have reduced mobility and activity compared to healthy older people, so increasing physical activity is not easy. However, goals such as increasing the number of steps can be easily understood and practiced, and reducing the time spent in sedentary behavior, such as by standing or taking a short walk, are activities that can be performed indoors and do not require high mobility.

Since this was the first study to include not only on steps in the self-monitoring but also time spent sitting, it is possible that these two affected each other. The Kobe University researchers explain, "A previous study in healthy older people reported that moderate to vigorous physical activity increases when sedentary behavior decreases, which is somewhat similar to the findings in the present study." Izawa adds, "While traditional self-monitoring interventions have focused primarily on the number of steps taken, this study focused on both steps taken and sedentary behavior. As a result, we believe this may have facilitated their behavior change.

While this study clearly shows the effectiveness of such simple measures as wearing an accelerometer, self-monitoring and receiving feedback on one's progress on the physical activity, its five-week period was too short to capture actual benefits on health-related quality of life.

Izawa and Kitamura said, "The results of this study may serve as an important foundation for future research on promoting physical activity among older adults in need of assistance. In particular, self-monitoring interventions have been shown to contribute to improved physical activity and can be applied to care prevention strategies. Future studies should include larger samples, a broader range of activities and long-term follow-up to verify the sustained effectiveness of the intervention.



### Israel to sever ties with UN Palestinian refugee agency



Service, Jerusalem: Israel said it would sever all ties with the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) starting on Thursday, accusing the agency of employing Hamas operatives and enabling "terror activity" in

"UNRWA is riddled with Hamas," Israeli Foreign Ministry spokesman Oren Marmorstein said on social media platform X.

"Beginning January 30, Israel will cease all engagement with UNRWA in accordance with Israeli he wrote.Marmorreiterated Israel's commitment to humanitarian aid reaching Gaza but said assistance would be

channeled through "alternative organizations," including other UN agencies, international NGOs, and foreign governments, Xinhua news agency reported.

An Israeli law passed in October 2024 mandates an end to UNRWA's operation on Israeli land — including East Jerusalem, which Israel annexed in a move not recognised internationally — and contact with Israeli authorities from Thursday.

It also bars Israeli officials from any contact with UNRWA. The move has drawn condemnation from international leaders and aid groups.

UNRWA, which provides vital healthcare, education, and emergency services to millions of Palestinians, denied the allegations and

said it has received no formal evidence from Israel to

substantiate the claims. Commissioner-General Philippe Lazzarini said on Tuesday that the agency has been the target of a "fierce disinformation campaign" to "portray the agency as a

terrorist organization. The headquarters of UN-RWA is facing an immediate shutdown due to bans passed by the Israeli legislature in October.These restrictions threaten the organization's operations across the occupied West Bank and Gaza Strip, where UNRWA provides crucial support to around 2 million Palestinians, many of whom are homeless as a result of the ongoing 15-month Israel-Hamas war

#### **Trump signs Laken Riley Act,** allows detention of undocumented migrants accused of criminal offences

Washington DC: United States President Donald Trump on Wednesday (local time) signed the Laken Riley Act, which mandates pre-trial detention of illegal migrants accused of theft, burglary or shoplifting, The Hill reported.

The passing of the act in the House marked Trump's first legislative victory as the bill received 263-156 vote, with 46 Democrats supporting it after the Senate approved the measure in a bipartisan 64-35 vote.

"This is a very important law, this is something that has brought Democrats and Republicans together. That's not something that's easy to do -- Laken did it. America will never, ever forget Lak-en Hope Riley," Trump said at the bill signing, calling it "a landmark law" that can "save countless innocent American lives."

Trump thanked the Republicans for voting for the bill, as well as the Democrats who voted across party lines and warned that those who didn't vote for it "are going to be sorry."

The order will direct the Department of Defense and Department of Homeland Security to prepare a 30,000-person migrant facility at Guantanamo Bay.

The facility in Cuba has been used to house military prisoners, including several nvolved in the 9/11 attacks, The Hill reported.

"We have 30,000 beds in

GALLE [SRI LANKA]: A maiden double hundred by UsmanKhawaja and terrific centuries from Steve Smith and Josh Inglis helped Australia end the second day of the first Test against Sri Lanka on a high, posting their highest-ever total in Asia at Galle

on Wednesday.

At the end of the day's play, Sri
Lanka was 44/3, with Dinesh
Chandimal (9\*) and
KaminduMendis (13\*) unbeaten in

Australia started the day at 330/2, with UsmanKhawaja (130\*) and Steve Smith (104\*) unbeaten on the crease.

Khawaja and Smith offered no respite to Sri Lankan bowlers, soon bringing up their 200-run partnership and Khawaja reaching 150 runs in 223 balls, with 10 fours and a six.

N i s h a n P e i r i s , PrabathJayasuriya and Jeffrey Vandersay had no reply for the

Australian dominance as they kept being hit for boundaries now and then. Australia reached the 400-run mark in 99.1 overs.

The 266-run partnership between Khawaja and Smith was undone by Vandersay, who trapped the batter leg-beforewicket for 141 in 251 balls, with 12 fours and two sixes. Australia was 401/3 in 99.5 overs.

Inglis, the Test debutant was on the crease next and got off the mark in Tests with a boundary against Vandersay on his first-ever ball. While Inglis piled on runs against spinners, Khawaja made history by reaching his first-ever double century in Tests in 290 balls, with 16 fours and a six.

Inglis became the 21st Australian to score a century on Test debut, in just 90 balls, with 10 fours and a six. However, an easy catch to KaminduMendis at covers on a Jayasuriya delivery brought an end to his 94-ball 102-run knock. Australia was 570/5 in 133 overs.

All-rounder Beau Webster and wicketkeeper-batter Alex Carey were the fresh pair on the crease, taking Australia to the 600-run mark in 142.4 overs.

Webster lost his wicket to Vandersay after a 59-run stand, for 23 runs in 50 balls. Australia was 629/6 in 149.2 overs.

Australia declared their

innings at 654/6, with Carey (46\* in 69 balls, with a four) and Mitchell Starc (19\* in 19 balls, with two fours and a six) unbeaten, breaching the score of 617 against Pakistan in Faisalabad in 1980 to establish a new record of their highest total in Asia.

dry spell in red-ball formats stands out. In 10 Tests last year, the seasoned star scored just 417 runs at an average of 24.52, with only one century and one fifty.

Harbhajan had a simple solution for Virat to cure his run-scoring woes: "Occupy the crease." The former spinner believes that if the 36-year-old spends time on the crease, runs will naturally flow from his bat.

"When he goes out to bat, he should occupy the crease and spend three to four hours. Even if Virat scores zero, he will still be ViratKohli. He will never be a lesser player. His achievements are very big. He should occupy the crease, and if he does that, he will score runs," he added.
