TMC doubts public welfare in upcoming Union Budget, prepares to intensify pressure on Centre

MI News Service, Kolkata: The Union Budget for the 2025-26 fiscal years is set to be presented by the third NDA government on February 1, tomorrow, but the Trinamool Congress (TMC) is skeptical that it will benefit the public. Ahead of the presentation of the Union Budget, the party is preparing to mount further pressure on the central government.
This stance was made clear by Abhishek Banerjee, the All-India General Secretary of TMC, as he spoke to the media at Dum Dum Airport before his leaving for Delhi.

As the Union Budget countdown begins, all eyes are on Finance Minister Nirmala Sitharaman, who will unveil the nation's fiscal roadmap for 2025. Nirmala Sitharaman tables Economic Survey 2024-25 on the opening day of Budget session

MI News Service, New Delhi : Finance Minister Nirmala Sitharaman tabled the Economic Survey for 2024-25 in both the Lok Sabha and the Rajya Sabha before both the houses were adjourned for the day on the opening day of the Budget session on Friday.

As is the convention, the Union Finance Minister tabled the pre-budget detailed state of the country's economy document in Parliament, a day ahead of the presentation of Budget for the next financial year -

2025-26. The Economic Survey document, prepared by the Economic Division of the Department of Economic Affairs in the Ministry of Finance and formulated under the supervision of the Chief Economic Adviser, gives insights into the state of the economy and various indicators of 2024-25 (April-March) and some outlook for the next

The Economy Survey document also typically gives some idea about the tone and texture of the actual Budget for 2025-26, to

be presented on Saturday.

The first economic survey reportedly came into existence in 1950-51, when it used to be a part of the budget documents. In the 1960s, it was separated from the Budget documents and presented the day before the Union Budget.

According to Survey documents, the Indian economy grew by 5.4 per cent in real terms in the July-September quarter of the current financial year 2024-25. The quarterly growth was quite lower than RBI's forecast of 7 per cent. In the April-June quarter too, India's GDP grew at a slower pace than was estimated by its central bank. The Reserve Bank in its latest monetary policy had cut India's growth forecast for 2024-25 to 6.6 per cent from 7.2

per cent. The government expects 6.4 per cent growth. India's GDP grew by an impressive 8.2 per cent during the financial year 2023-24, and continued to be the fastest-growing major economy. The economy grew by 7.2 per cent in 2022-23 and 8.7 per cent in 2021-22.

The budget session of parliament which begin on Friday on January 31, will continue till April 4.The budget will be presented on February 1. On budget day, the Finance Minister will present the Union Budget in the Lok Sabha at 11 am. The budget speech will outline the government's fiscal policies, revenue and expenditure proposals, taxation reforms, and other significant announcements

With this upcoming Budget Presentation, Sitharaman will be presenting her eighth budget in a row. Earlier in the Droupadi Murmu, as per the convention, formally inaugurated the Budget Session with an address to a joint session of both the Houses of Parliament. where the President stated that with the efforts of the government, India is going to become the third largest economy in the world soon. "My government's mantra is Sabka Sath, Sabka Vikas, Sabka Vishwas, Sabka Prayas", she said.

Several foreign diplomats also reached the new Parliament House to witness the proceedings of the 2025 budget session on Friday. Among

Daughter of Indian immigrants among those killed in worst US air crash

MI News Service, Washington (DC): Asra Hussain Raza, the daughter of Indian immigrants, was among the 67 people killed in a tragic midair collision between an Army helicopter and a jetliner at Ronald Reagan National Airport in the US, according to a local media report on Friday. The collision, deadliest aviation disaster in the US since 2001, happened when American Airlines Flight 5342 collided with the Army helicopter as it approached the airport on Wednes-

day night and fell into the icy Potomac river. As a result Raza, 26, died with all other co passengers in the aircraft, her father-in-law, Dr. Hashim Raza said. A daughter of Indian immigrants, Raza graduated with honours in 2020 from Indiana University and married her college sweetheart in August 2023, Hashim Raza said.

Asra was a Washington, DC-based consultant who travelled to Wichita twice a month to work on a turn-

around project for a hospital there, her father-in-law said. She would often call him at the end of his late emergency room shifts to make sure he stayed awake on the drive home. She went out of her way for everybody," her father-in-law said.

The husband of Asra said his wife texted him that she was about to land, but by the time he got to the airport to pick her up, his life had changed forever. "She said, 'We're landing in 20 minutes,'" Hamaad

Raza said adding that was the last thing he heard from his wife. "I was waiting and I started seeing a bunch of EMS vehicles speeding past me, like way too many than normal, and two, my texts weren't going through,' Hamaad was quoted as saying by the local media. "It's just, feels crazy that it happened to us, to be honest," he said adding "I mean, it's like you see these things happen in the news, you see them happen in other countries. And then, I show up to the airport,

and my wife's not responding, and I look on Twitter and I see that it's her flight." He said he's been surrounded by loved ones who are all devastated by the tragic and unexpected loss. "We are now at the point where we are switching from a rescue operation to a recovery operation," said John Donnelly, the fire chief in the nation's capital.

The plane was found upside-down in three sections in waist-deep water, and first responders were searching an area of the Potomac as far south as Woodrow Bridge, roughly 3 miles (4.8 kilometres) south of the airport, Donnelly said.

The helicopter wreckage was also found. Images from the river showed boats around the partly submerged wing and the mangled wreckage of the plane's fuselage. The collision was the deadliest US air crash since 2001.

H.S Council introduces new measures to prevent question paper leak

Concerns over question paper leaks in examinations have been a longstanding issue. Every year, the Higher Secondary Education Council implements various changes to tackle this challenge. This year is no exception, as the council has introduced multiple modifications in the examination process to strengthen security and prevent leaks.

One of the key changes pertains to the storage and handling of question papers. Previously, the selection of schools for distributing question papers was conducted under strict security measures, often within police stations. However, starting this year, this process will undergo a significant transformation. While security measures will remain intact, the selection process will no longer involve local police stations. Instead, the sorting and selection of question papers will be managed directly from the printing press.

In addition, the council has decided to install metal detectors at all examination centres. Reports of students being caught with mobile phones during exams have been a recurring issue. To curb such incidents, metal detectors will now be deployed to ensure that electronic devices do not enter the examination hall.

However, these are not the only changes introduced by the Higher Sec-

Traditionally, question papers were sent to schools in sealed envelopes, which were then opened by the headmaster or principal of the respective institution. The council believes that opening the question packets well before the exam begins poses a significant risk, as it provides ample time for potential leaks. To mitigate this, the process of unsealing question papers will now be altered.

At present, the question papers are unsealed in the principal's office before being distributed to the students. However, under the new system, this practice will be discontinued. Instead of opening the sealed envelopes in the principal's office, the question papers will now be directly unsealed inside the examination hall, in the presence of students. This move aims to eliminate any possible gaps in security and ensure that the question papers remain confidential until the very last moment.

Med Council Registrar resigns before Cal HC deadline

MI News Service, Kolkata: Manas Chakraborty, Registrar of the West Bengal Medical Council, has resigned ahead of the deadline set by the Calcutta High Court. Chief Justice had advised him to step down by 5 PM today, warning that failure to comply would lead to a formal directive for his removal. Before the deadline, Chakraborty submitted his resignation to the Council President. Manas Chakraborty's term as Registrar ended on November 1, 2019. However, allegations surfaced that he was illegally reappointed without informing the Council. The controversy led to a legal battle, with claims that Council President and TMC MLA Sudipta Roy facilitated his unauthorized extension. In response, the High Court directed Chakraborty to resign voluntarily, failing which a removal order would be issued. Following this, Chakraborty stepped down, confirming that he acted in accordance with the court's instructions. During Thursday's hearing, the Chief Justice observed that Chakraborty had remained in the position beyond his retirement period without any legal grounds.

State Govt opposes UGC's draft on Univ appointments

The University Grants Commission (UGC) has recently proposed significant changes in the process of appointing Vice-Chancellors (VCs) and faculty members in colleges and universities. A draft proposal has been prepared, and the central body has sought feedback from all states. In

response, a committee formed by the West Bengal government has submitted a report strongly opposing various provisions in the draft, calling it undemocratic and an attack on the federal structure.

State Education Minister Bratya Basu stated that the committee's report would be

sent to the UGC after consultation with Chief Minister Mamata Banerjee. The state's report has raised objections to 10 key provisions in the UGC's draft proposal.

Key Objections Raised by the State Government are VC Appointment Committee Size. The UGC draft suggests forming a three-member commit-

tee for appointing VCs. The state government committee argues that a five-member committee is necessary. The state insists that in addition to the Chancellor (Governor), UGC representatives, and university officials, a representative of the Chief Minister must be included, as state governments play a key role

in land allocation, infrastructure, and administration.

The state government emphasizes clear eligibility criteria and a transparent selection process for Vice-Chancellors.

The UGC draft proposes making the Vice-Chancellor the chairman of faculty appointment committees. The

state committee strongly opposes this, stating that a VC should not head the recruitment process.

The UGC draft also proposes making Ph.D. mandatory for assistant professor positions. The state government wants more flexibility, allowing universities to recruit based on merit, teaching

ability, and research experience. The state committee recommends that librarians and physical instructors be granted faculty status. The committee states that if the UGC does not agree to the five-member VC selection committee, then the existing state university laws should be respected.

Modi govt mulls cut in corporate tax

Delhi: The Modi government is considering a proposal to reinstate concessional corporate tax rates for new manufacturing units to revive private investment and counter slowing growth. Ahead of the 2025-26

Budget, the finance min-

istry is discussing the possibility of slashing the tax rate to 15-18 per cent for companies establishing greenfield and brownfield projects, according to officials familiar with the matter. The corporate tax rate for domestic companies stands at 22 per cent at present. A lower rate could make India a more attractive destination for global manufacturers, aligning with the "China+1" strategy, where companies diversify their supply chains away from Beijing. The concessional 15 per cent tax regime was introduced in 2019 under Section 115BAB of the Income Tax Act. It aimed to boost manufacturing by offering globally competitive rates to companies incorporated after October 1, 2019, and commencing production by March 31, 2023. However, the scheme

saw limited adoption due to disruptions caused by the Covid-19 pandemic subsequent lockdowns. In response, the government extended the deadline to March 31, 2024, but chose not to prolong it further after lukewarm industry interest. Now, the proposal is back on the table with a possible adjustment to a slightly higher rate of 18 per cent, plus surcharges, reflecting a more pragmatic approach to balance incenconsiderations. The proposal comes amid con-



cerns about India's slowing growth trajectory, projected at 6.4 per cent for this fiscal year and below 7 per cent for 2025-26. "Extending the concessional tax rate would provide an opportunity for investors considering India as a potential destination," said Rohinton Sidhwa, partner at Deloitte India. "The measure has been pivotal in promoting economic goals and attracting foreign investments in the past." Aseem Mowar, tax partner at EY India, highlighted the scheme's strategic importance in competing with countries such as China, Japan and Vietnam. "Reintroducing this tax benefit would bolster India's manufacturing sector, generate jobs and enhance revenue, even with a slightly higher rate of 18 per cent," he said. Mowar suggested including infrastructure sectors such as EV charging and smart city projects, which could reduce reliance on fuel imports.

He also advocated for extending benefits to global capability centers (GCCs), which have seen significant growth in India

over the past five years. "GCCs play a crucial role in India's economic landscape, with an esti-

mated 1,700 centers generating \$64.6 million in revenue. This number is expected to grow to 2,200 by 2030." Including GCCs under the concessional tax regime could boost India's appeal as a hub for MNCs. The reintroduction of concessional tax rates has been a consistent demand from industry groups such as Assocham.

In its pre-budget memorandum, the association urged the government to revive the scheme, citing its potential to promote exports and support the "China+1" strategy. "The benefit would make India more competitive and attract multinational groups to set up manufacturing hubs here," Assocham said. It emphasised the importance of aligning tax policies with global trends to maintain India's attractiveness as an investment destination.

Geopolitical shifts have also strengthened the case for such incentives. With the US and other nations reducing their reliance on China, India stands to gain. The finance ministry and the Prime Minister's Office are expected to finalise the proposal in the coming before budget announcement on February 1.

TVS launches 3wheeler EV in city

MI News Service, Kolkata: TVS Motor Company will launch an electric L5 cargo vehicle by the end of 2025 even as it introduced its first electric three-wheeler in the L5 segment in the city. Christened the TVS King EV MAX, the electric auto is TVS's first electric passenger vehicle

The L5 segment has a market of 42,000 units per month of which 16,000 units are electric vehicles.

Both Mahindra and Bajaj are in the electric L5 segment with Piaggio in the third place. "We are very confident that EV adoption will rise in the L5 passenger vehicle segment. The segment is dominated by CNG, LPG and petrol vehicles. With CNG prices rising and very few CNG stations in Calcutta, we think electric adoption will rise in this market," said Rajat Gupta, business head, commercial mobility, TVS Motor Company, while launching the vehicle in the city on Monday. The company has launched the vehicle in Uttar Pradesh, Bihar, Jammu and Kashmir and Delhi so far. "It will be available across the

country in the coming months," said Gupta. The TVS King EV Max has a range of 179 km on a single charge. It has a 51.2V lithium-ion LFP battery with a top speed of 60 km per hour. The vehicle will retail at ₹2,95,000 (ex-showroom) and come with a warranty for six years and 150,00 km whichever is earlier. The vehicle can be charged up to 80 per cent in two hours, 15 minutes and up to 100 per cent in 3.5 hours.

tion (IOC), the country's largest oil refiner, reported per cent decline in its standalone net profit for the third quarter of 2024-25 because of significant inventory and foreign exchange losses, coupled with weaker refining margins. Net profit stood at ₹2,873.53 crore for the October-December period down from ₹8,063.69 crore in the same quarter a year ago, the company disclosed in a stock exchange filing on Monday. Profit rebounded sharply from ₹189.01 crore in the July-September quarter.

The sharp year-on-

year decline was attrib-

uted to a ₹7,800-crore inventory loss and ₹1,900crore in forex losses, IOC director (finance) Anuj Jain said. Inventory losses occur when crude oil purchased at higher prices is later processed and sold at lower prevailing prices, forex stemmed from currency fluctuations. spreads — the difference between crude oil costs and product prices — also weakened significantly. Diesel cracks dropped to \$10.8 per barrel from \$19.18 per barrel a year ago, while petrol cracks fell to \$3.63 per barrel from \$7.04. IOC's gross refining margins (GRM) fell to \$2.95 per barrel in the third quarter compared with \$13.53 per barrel in the corresponding quarter a year ago,, reflecting the broader pressure on prof-

itability. Despite the profit drop, IOC achieved its highestever quarterly fuel sales at 26.13 million tonnes (mt), up 6.2 per cent year-on-

Petrochemical sales rose 7 per cent, and gas trading volumes surged 24 per cent during the period, according to IOC chairman A.S. Sahney.

UPS notified for greater financial security to govt employees



MI News Service, New **Delhi:** The Modi government has notified the Unified Pension Scheme (UPS), set to roll out on April 1, 2025, guaranteeing central government employees an assured pension of 50 per cent of their average basic pay from the 12 months preceding retirement, provided they complete 25 years of service.

The scheme, aimed at providing greater financial security to the 23 lakh central government employees currently enrolled in the National Pension System (NPS), combines features of the Old Pension Scheme (OPS) and NPS to ensure guaranteed pensions. This initiative seeks to enhance retirees' financial stability, addressing demands for a more predictable post-retirement

Employees with at least 10 years of service who retire on superannuation will qualify for assured payouts from their retirement date. Similarly, those retired under Fundamental Rule 56(j) — a proallowing the vision government to retire employees in the public interest — will also be eligible unless their retirement results from a penalty.

Employees opting for voluntary retirement after 25 years of service will receive payouts beginning on the date they would have superannuated had they continued working. Howindividuals disremoved, or missed, resigning from service are excluded from the scheme.

For shorter service du-

rations, payouts will be proportional. Employees with at least 10 years of qualifying service are assured a minimum monthly pension of ₹10,000. In cases where a retiree dies post-superannuation, the scheme provides for a family pension equivalent to 60 per cent of the last admissible payout, offered to the spouse.

Dearness relief, calculated similarly to the Dearness Allowance (DA) for serving employees, will be applied to both individual and family pensions once disbursement begins.

Retirees will also receive a lump sum amount equivalent to 10 per cent of their monthly emoluments — basic pay and DA for every six months of completed service. This payment will not affect the assured pension amount. The UPS will operate through a dual-fund model. An individual corpus will be funded by employee contributions of 10 per cent of basic pay and DA, matched equally by the government. Additionally, a pool corpus will be supplemented by an 8.5 per cent government contribution, ensuring sufficient resources to support guaranteed payouts. This scheme is being introduced as an alternative within the NPS framework, reflecting the government's intent to enhance retirement security while balancing fiscal responsi-

ED's Kochi Zonal Office arrested the persons namely; Daniel Selvakumar, Director of Xoduz Solutions Pvt Ltd and operator of Tyrannus Technology Pvt Ltd; Allen Samuel, Director of Aprikiwi Solutions Pvt Ltd., Anto Paul Prakash, proprietor of Global Expositions and Infomedia Solutions and the Director of Sozo Technology Pvt Ltd; and Kathiravan Ravi, Director of Future Vision Media Solutions Pvt Ltd on January 30.

The case originated from 11 First Information Reports (FIRs) filed by victims in Kerala and Haryana that they were extorted in the name of loan facilitation and blackmail for excess repayment.

Researchers discover blood stem cell could transform bone marrow transplants

achieved a first for the world: they have successfully created blood stem cells that closely resemble human tissue. Additionally, the discovery may eventually result in customized therapies for kids suffering from bone marrow failure syndromes and leukaemia.

The study, which was headed by the Murdoch Children's Research Institute (MCRI) and published in Nature Biotechnology, has successfully surmounted a significant obstacle in the production of human blood stem cells, which are capable of generating red, white, and platelets that are highly similar to those seen in human

MČRI Associate Professor Elizabeth Ng said the team had made a significant discovery in human blood stem cell development, paving the way for these lab grown cells to

be used in blood stem cell and bone marrow transplants. 'The ability to take any cell from a patient, reprogram it into a stem cell and then turn these into specifically matched blood cells for transplantation will have a mas-

"Prior to this study, developing human blood stem cells in the lab that were capable of being transplanted into an animal model of bone marrow failure to make healthy blood cells had not been achievable. We have developed a workflow that has created transplantable blood stem cells that closely mirror those in the human embryo.

"Importantly, these human cells can be created at the scale and purity required for clinical use."

In the study, immune deficient mice were injected with

the lab engineered human blood stem cells. It found the blood stem cells became functional bone marrow at similar levels to that seen in umbilical cord blood cell transplants, a proven benchmark of success.

The research also found the lab grown stem cells could be frozen prior to being successfully transplanted into the mice. This mimicked the preservation process of donor



blood stem cells before being transplanted into patients. MCRI Professor Ed Stanley said the findings could lead to new treatment options for a range of blood disorders.

"Red blood cells are vital for oxygen transport and white blood cells are our immune defence, while platelets cause clotting to stop us bleeding," he said. Understanding how these cells develop and function is like decoding a complex puzzle.

"By perfecting stem cell methods that mimic the development of the normal blood stem cells found in our bodies we can understand and develop personalised treatments for a range of blood diseases, including leukaemias and bone marrow failure." MCRI Professor Andrew Elefanty said while a blood stem cell transplant was often a key part of lifesaving treatment for childhood blood disorders, not all children found an ideally matched donor.

"Mismatched donor immune cells from the transplant can attack the recipient's own tissues, leading to severe illness or death," he said.

"Developing personalised, patient-specific blood stem cells will prevent these complications, address donor shortages and, alongside genome editing, help correct underlying causes of blood diseases." Professor Elefanty said the next stage, likely in about five years with government funding, would be conducting a phase one clinical trial to test the safety of using these lab grown blood cells

Riya was diagnosed at the age of 11 with aplastic anaemia, a rare and serious blood disorder where the body stops producing enough new blood cells. Riya's family, including parents Sonali and Gaurav Mahajan, were in India at the time when she started to feel fatigued, rapidly lost weight and developed bruises on her thighs. "We took Riya for a simple blood test, her very first one. But as soon as the results came in, we were told to rush her to the emergency department due to her being so low on platelets and red blood cells," Sonali said.

"Riya was originally diagnosed with leukemia because the symptoms are very similar to aplastic anaemia. When we got the eventual diagnosis, it was a complete shock and a condition we had never heard of before. "The doctors told us she had bone marrow failure and she started needing regular platelet and blood transfusions to get her blood cell count up.


Sonali said the family had already planned to return to Australia for Riya's high school education, but the diagnosis fast tracked the return.

"Once they were able to stabilise her, we were given a two-day window to fly her to Australia to be hospitalised,"

"As soon as we got off the plane we went straight to The Royal Children's Hospital. Within days Riya started therapy, but she never really responded to the medication of the result of

"Eventually a bone marrow transplant was recommended due to the amount of transfusions she was needing to have and the concerns around possible long-term complications." Sonali said over six months they struggled to find a perfectly matched donor and were losing hope. Despite being a half match, Sonali, following specialist advice, became her daughter's donor. Following the bone marrow transplant in June last year, Riva remained in hospital for three months where she had minor complications.

Medication increases radiation therapy's efficacy for lung cancer that has progressed to brain



Washington [US] : A group of researchers from the University of Cincinnati has discovered a possible novel approach to enhance the efficacy of radiation therapy and enhance the prognosis of patients with lung cancer metastasizing to the brain.

The research, which was headed by Debanjan Bhattacharya, PhD, as the lead author, was just released in the journal Cancers.

Lung cancer accounts for approximately one in five cancer deaths in the United States, making it the primary cause of cancer death, according to the American Cancer Society. About 80 per cent to 85 per cent of all instances of lung cancer are non-small cell lung cancer (NSCLC), which is the most common kind of the disease.

Up to 40 per cent of lung cancer patients develop brain metastases during the course of the disease, and these patients on average survive between eight and 10 months following diagnosis.

Current standard of care treatments for lung cancer that spreads to the brain include surgical resection and stereotactic brain radiosurgery, and whole brain irradiation is standard in patients with more than 10 metastatic brain lesions.

"Lung cancer brain metastasis is usually incurable, and whole brain radiation treatment is palliative, as radiation limits therapy to toxicity," Bhattacharya, research instructor in the Department of Neurology and Rehabilitation Medicine in UC's College of Medicine. 'Managing potential side effects and overcoming resistance to radiation are major challenges when treating brain metastases from lung cancer. This highlights the importance of new treatments which are less toxic and can improve the efficacy of radiation therapy, are less expensive, and can improve the quality of life in patients." Bhattacharya and his colleagues at UC focused on AM-101, a synthetic analog in the class of benzodiazepine drugs first developed by James Cook, a medicinal chemist at the University ofWisconsin-Milwaukee. Prior to this study, AM-101's effect in non-small cell lung cancer was unknown. AM-101 is a particularly useful drug in the context of brain metastases in NSCLC, Bhattacharya said, as benzodiazepines are known to be able to pass through the bloodbrain barrier that protects the brain from potential harmful invaders that can also block some drugs from reaching their target in the brain.

The team found AM-101 activated GABA(A) receptors located in the NSCLC cells and lung cancer brain metastatic cells. This activation triggers the "self-eating" process of autophagy where the cell recycles and degrades unwanted cellular parts.

Specifically, the study showed that activating GABA(A) receptors increases the expression and clustering of GABARAP and Nix (an autophagy receptor), which boosts the autophagy process in lung cancer cells. This enhanced "self-eating" process of autophagy makes lung cancer cells more sensitive to radiation treatment.

Using animal models of lung cancer brain metastases, the team found AM-101 makes radiation treatment more effective and significantly improves survival Additionally, the drug was found to slow down the growth of the primary NSCLC cells and brain

In addition to making radiation more effective, adding AM-101 to radiation treatments could allow for lower radiation doses, which could reduce side effects and toxicity for patients, Bhattacharya said. The team is now working toward opening Phase 1 clinical trials testing the combination of AM-101 and radiation both in lung cancer within the lungs and lung cancer that has spread to the

Bhattacharya began this research while working in the lab of former UC researchers Soma Sengupta and Daniel Pomeranz Krummel, who are now at the University of North Carolina at Chapel Hill. Bhattacharya credits their mentorship and the collaboration with other experts within UC and across multiple academic research institutions in the United States. Bhattacharya also emphasizes the role of shared university research resources that helped the study move forward. He dedicates this work to his father, who died in 2021 while he was in the early phases of the research.

Study finds new source of cardiac inflammation



California [US] : Globally, ischemic heart disease is the leading cause of death. myocardial infarction (MI), commonly referred to as a "heart attack," is the first event in which insufficient coronary blood flow results in the death of a portion of the heart. Heart failure, heart wall remodelling, and severe inflammation result from this.

Surprisingly, anti-inflammatory medications have not been able to stop heart failure. They are therefore not a standard component of post-MI care. The most effective cellular and molecular targets for inflammation, however, might still be unidentified.

In the Aug. 28, 2024 issue of Nature, researchers from University of California San Diego in the laboratory of Dr. Kevin King, associate professor of bioengineering and medicine, and a cardiologist at the Sulpizio Cardiovascular Center, report the discovery of a novel mechanism of cardiac inflammation that may expand therapeutic opportunities to prevent heart attacks from becoming heart failure.

Inflammation after MI is classically credited to professional immune cells like neutrophils and macrophages that infiltrate the infarcted heart and respond to molecules in the debris of dying cells. So the team was surprised when they discovered that the proinflammatory "type I interferon (IFN) response" was activated, not in the infarct where immune cells were concentrated, but instead in the borderzone, surrounding the infarct.

The borderzone has been a fascinating yet understudied area of the infarcted heart. It is where surviving heart muscle cells attempt to stabilize and even proliferate after being disconnected from their dying neighbor cells. Unfortunately, the borderzone has proven a challenging region to study because it is not easily isolated from the rest of the heart. Researchers overcame this obstacle using methods they recently reported based on single cell RNAseq and spatial transcriptomics where cells of the borderzone are recognized based on their patterns of gene expression.

To determine which cell type initiates borderzone inflammation, the team created a library of conditional knockout mice. each unable to initiate IFN signaling in a different cell type. To their surprise, heart muscle cells called cardiomyocytes emerged as the dominant initiators of borderzone IFN signaling. They found that mechanically stressed car-diomyocytes in the borderzone frequently suffered nuclear envelope rupture, which allowed escape of nuclear DNA and sensing by cytosolic DNA sensors, leading to activation of IFN signaling. This in turn caused mechanical weakening of the heart wall and made it vulnerable to dilation, thinning, and rupture, providing a mechanistic explanation for the team's previous reported observation that mice lacking responses

improved survival after MI.
"In the hospital, we care for patients with heart attacks and heart failure every day. New therapeutic targets for MI with the potential to prevent devel-opment of heart failure are incredibly important, said Dr. King, senior author of the study an on the faculty in the Shu Chien Gene Lay Department of Bioengineering and the Division of Cardiology at UC San Diego.

Many questions remain, however the newly reported findings suggest that limiting mechanical stress at the borderzone, inhibiting DNA sensing, and preventing type I IFN signaling may represent new opportunities for patients to avoid development of heart failure after MI.

Study gives insight into treatment of rectal cancer

WASHINGTON [US]: Positive outcomes from a novel treatment for locally advanced rectal cancer include the occasional full avoidance of surgery. The chance of a recurrence is also decreased.

According to a thorough study done at Uppsala University and published in eClinicalMedicine, the approach is beneficial.


"The tumour disappears completely more often, thereby increasing the chance of avoiding surgery and retaining normal rectum and rectal function. Moreover, there are fewer metastases," said Bengt Glimelius, Professor of Oncology at Uppsala University and Senior Consultantat Uppsala University Hospital, about the new method. Rectal cancer affects around 2,000 people in

Sweden every year. Of these, a third have a high risk of recurrence. When a person is diagnosed with rectal cancer, part of the bowel is often removed, which could lead to the need for a stoma or problems controlling one's bowels. Patients often first receive radiotherapy or a combination of radiotherapy and concurrent chemotherapy for five weeks, followed by surgery and usually an additional round of chemotherapy for up to six months.

A study conducted by Uppsala University in everyday healthcare shows that it is possible to double the chance of eliminating the need to surgically remove part of the bowel if all radiotherapy and chemotherapy are given first and then the patient undergoes

"If the tumour disappears completely during treatment, surgery is not required. This means that the rectum is preserved and the need for a stoma and a new rectum is eliminated. When part of the rectum is surgically removed, the new rectum does not quite understand that it should be able to refrain from frequently sending a signal to the brain that you need to use the toilet," said Bengt Glimelius.

A large number of doctors, researchers and research nurses have contributed to the study.



Patient data was collected for a large number of patients via the Swedish Colorectal Cancer Registry (SCRCR), with 461 patients included.

Locally advanced rectal cancer has traditionally been treated with a combination of radiotherapy and chemotherapy, followed by surgery and further chemotherapy. Four years ago, a randomised study showed that an alternative approach of one week of radiotherapy followed by just over four months of chemotherapy resulted in more tumours disappearing completely and fewer having distant metastases. Later on, however, slightly more local recurrences were observed. Uppsala was the first region to choose to introduce this treatment, but with a shortened chemotherapy period of three months. Several other regions later followed suit. The new study confirms the results of the previous randomised study, but also that the noted increase in local recurrences was not observed here. "With the old treatment, the randomised study failed to find any tumour in 14 percent of patients who underwent surgery. The new model doubled that figure to 28 per cent.

Study finds how certain diabetes medications might prevent dementia

Washington [US]: According to a study published, sodium-glucose cotransporter-2 (SGLT-2) inhibitors used to treat type 2 diabetes may prevent dementia, with higher advantages with prolonged treatment.

The findings of the Korea study were published in The BMJ.

The effect size may have been exaggerated in this observational analysis, the researchers add, and they now state that randomized controlled trials are required to corroborate these results.

According to the World Health Organization, the number of people with dementia globally is expected to reach 78 million by 2030 and type 2 diabetes is associated with a greater risk of developing dementia.

A recent study of over 65s with type 2 diabetes suggested a decreased risk of dementia associated with SGLT-2 inhibitors versus another type of diabetes drug, dipeptidyl peptidase-4 (DPP-4) inhibitors. But the effects on younger people and specific types of dementia (eg, Alzheimer's disease, vascular dementia) remains unclear.

Korea National Health Insurance Service database to identify 110,885 pairs of adults with type 2 diabetes aged 40-69 years who were free of dementia and started taking either an SGLT-2 inhibitor or a DPP-4 inhibitor between 2013 and 2021.

All participants (average age 62; 56% oped dementia. Potentially influential fac-



tors including personal characteristics, income level, underlying risk factors for dementia, other conditions and related medicine use, were also taken into account.

Over the follow-up period, a total of 1,172 participants with newly diagnosed dementia were identified

Dementia rates per 100 person years were 0.22 for those using SGLT-2 inhibitors and 0.35 for those using DPP-4 inhibitors, corresponding to a 35% reduced risk of dementia associated with use of SGLT-2 inhibitors compared with DPP-4 inhibitors.

The researchers also found a 39% reduced risk for Alzheimer's disease, and a 52% reduced risk for vascular dementia associated with SGLT-2 inhibitors compared with DPP-4 inhibitors.

What's more, the effect of SGLT-2 inhibitors seemed more pronounced with longer treatment duration. A 48% reduced risk of dementia was seen for more than two years of treatment versus a 43% reduced risk for two years or less.

This is an observational study so no firm conclusions can be drawn about cause and effect, and the authors note that details of health behaviours (eg, smoking and alcohol consumption) and duration of type 2 diabetes were not fully

However, they point out that this was a large study based on nationally representative data that included relatively younger people with type 2 diabetes, and results were highly consistent across sub-

As such, they say SGLT-2 inhibitors might prevent dementia, providing greater benefits with longer treatment and they call for randomised controlled trials to confirm these findings.

This study reports promising results that have important implications for clinical practice as well as from a public health perspective, say researchers from Taiwan in a linked editorial.

They agree that further trials are needed to confirm these findings, and suggest that studies are also needed "to explore the underlying mechanisms of any neuroprotective effects of SGLT-2

inhibitors.

As no cure currently exists for dementia and few effective treatment options are available, strategies that can potentially prevent onset are critically important, they write. Given the substantial socioeconomic and public health burdens associated with both dementia and type 2 diabetes, they also recommend that clinical guidelines and healthcare policies should be updated regularly to incorporate latest best evidence on the potential benefits of SGLT-2 inhibitors, including reduced dementia risk





Myanmar junta extends state of emergency on coup's fourth anniversary

ISL: Bengaluru FC face Punjab FC in a battle of contrasting styles and tactical adjustments in focus



NEW DELHI [INDIA] : Punjab FC will host Bengaluru FC at the Jawaharlal Nehru Stadium in New Delhi in the Indian Super League (ISL) 2024-25 on Saturday. The Panagiotis Dilmperis-coached

team will have their task cut out in improving their home form since they have not won any of the last four encounters at this venue.

Bengaluru FC had beaten Punjab FC by a slender margin of 1-0 in the reverse fixture. However, the latter is one of the four active teams that the Blues are yet to round off a league double over, alongside Hyderabad FC, Mohammedan SC, and Mohun Bagan Super Giant.

Both these teams are struggling for form, with Bengaluru FC having drawn once and losing twice in their last three away encounters. Their most recent match on the road saw them fall to a 0-1 loss to the Mohun Bagan Super Giant in Kolkata. They will want to find their groove upfront, as the last time they had not netted in consecutive away encounters was in 2022.

Bengaluru FC have suffered losses in four out of their last five encounters. They are placed fifth in the points table with 28 points from 18 matches, on the back of eight wins and four draws. Punjab FC followed in the ninth position with 20 points from 16 games due to six victories and two draws.

Punjab FC trails the sixthplaced Mumbai City FC (27) by seven points, having played a game fewer than the Islanders (17). They have a reasonable period in hand to reignite their charge for the top-six, whereas the Blues will want to push upwards as the

second-placed FC Goa have five more points (33) than them, having played a game less (17).
Punjab FC are the only team

yet to find the back of the net through a headed goal in the current ISL season. On the other hand, they have conceded the second-most goals this way (7). Coach Dilmperis will have to work to ensure that his side's aerial prowess on both ends is finetuned to yield them the required returns.

Bengaluru FC have recorded 147 sequences of 10+ open-play passes this season, the secondmost behind Mohun Bagan Super Giant (151). Their highest-ever season tally is 152 (2017-18). This shows that they have embraced implemented Gerard Zaragoza's playing philosophy to the full tilt this season.

Bengaluru FC have scored six headed goals this season, with only Mohun Bagan Super Giant (8) bettering them in this manner. The Blues have made good use of their players in the flanks by having them deliver consistent crosses for their target men in the box. Given Punjab FC's drawback in defending aerial attacks, the Blues might just make the most of their proficiency in this regard.

Punjab FC head coach Panagiotis Dilmperis simplified the tasks for his team for the coming match.

"We will try to address as many issues as they try to create for us. Hopefully, we manage to keep a clean sheet and score more than them," Dilmperis was quoted in a release from ISL as saying.

Bengaluru FC head coach Gerard Zaragoza admitted that his team is preparing well for the coming match.

We have six games remaining in the league now, but the most important part is the next game against Punjab FC. The team has been training well," he said.

The two teams have played thrice in the ISL. Bengaluru FC and Puniab FC have won once each, whereas one game has ended in a draw.

Afghanistan's 2015 World Cup hero Shapoor Zadran announces retirement from international cricket

NEW DELHI [INDIA]: Afghanistan's left-arm speedster Shapoor Zadran announced his retirement from international

The tall fast bowler featured in 44 ODIs and 36 T20Is for Afghanistan since making his debut in 2009. Across both formats, he scythed 80 wickets. His last international appearance for Afghanistan dates back to March 8, 2020, in a T20I match against Ireland in Greater Noida.

During his playing days, Zadran was a typical fast bowler with an aggressive mentality, and once he even cited the Rawalpindi Express Shoaib Akhtar as his idol.

He emerged as one of the key figures in Afghanistan's rise to dominance on the international stage. He gained a cult hero status during the ODI World Cup 2015. The left-arm speedster ended the campaign with ten wickets, accompanied by some animated celebrations. His tally of wickets included modern-day greats Steven Smith, David Warner, Kane Williamson, Tillakaratne Dilshan and Mahmudullah.

The 37-year-old's most decorated performance came against Scotland. With figures of 4/38, he helped Afghanistan secure their first victory in the ICC tournament. "Today is the day I never wanted to face, but it eventually comes for every player. After 22 years of service, sacrifice, and love for cricket, I, officially announce my retirement from international cricket. This has been one of the toughest deci-



sions of my life because cricket has been more than just a game to me, it has been my passion, my identity and my purpose, Zadran wrote in his Facebook

post.
"Since childhood, I dreamt of representing Afghanistan, and looking back now, I am proud to have played a part in raising our nation's flag on the international stage. My journey began in the most challenging times of Afghan cricket," he added.

Zadran thanked the fans, his family, teammates, and coaches who helped him overcome the set of challenges that he faced in his

"I faced difficulties, played under limited resources, and overcame many obstacles, but I never lost faith. The support of cricket fans, my teammates, coaches, and especially my family kept me going through every

hardship," he said.

"I sincerely thank everyone who stood by my side throughout this long journey. The love, prayers, and unwavering support of my family, friends, fans, and the people of Afghanistan have been my greatest strength," he added.

In the end, he wished for Afghanistan's success and said he would celebrate every victory and hope the new stars would take Afghanistan to greater heights.

"I will always be grateful for it. Though I am stepping away from international cricket, my commitment to the game remains. I will always pray for the success of Afghanistan cricket. If not as a player, then as a devoted supporter, I will celebrate every victory and hope for the emergence of new stars who will take Afghan cricket to greater heights," he concluded.
