Rs 12.75 lakh per annum. after taking into account a standard deduction of Rs 75,000. This higher exemptions and rejigs have been effected under the new income tax regime. "I am now happy to announce that there will be no income tax payable up to income of Rs 12 lakh with an average income of Rs 1 lakh per month other than special rate income such as capital gains, under the new regime," the finance minister said amid thumping of desk in appriciation by the ruling party MPs in-cluding Prime minister Narendra Modi.

'The new structure will substantially reduce taxes of the middle class and leave more money in their hands to spend at will, boosting household consumption, savings and investment," Sitharaman said in her 2025-26 Budget speech. As per the rejig, for people earning more than Rs 12 lakh per annum, there will be nil tax for income up to Rs 4 lakh, 5 per cent for income between Rs 4 and 8 lakh, 10 per cent for Rs 8-12 lakh, 15 per cent for Rs 12-16 lakh. A 20 per cent income tax will be levied on income between Rs 16 lakh and 20 lakh, 25 per cent on Rs 20-24 lakh and 30 per cent above Rs 24

in the new regime with an income of Rs 12 lakh will get a benefit of Rs 80,000 in tax. A person having income of Rs 18 lakh will get a benefit of Rs 70,000 in tax while a person with an income of Rs 25 lakh gets a benefit of Rs 1.10 lakh, she said.. Adhil Shetty, CEO of Bankbazaar.com hailing the budget proposals said "In a significant move, Finance Minister Nirmala Sitharaman relaxed the conditions for tax relief on self-occupied properties in the 2025 Union Budget. Bengal toll at Kumbh stampede reaches 5 families accuse UP govt of mismanagement

MI News Service, Kolkata: The number of people who had died in the stampede at the Mahakumbh in Allahabad reached five after three more pilgrims from the state were reported dead on Friday. On Thursday, the state government confirmed the deaths of two elderly women pilgrims — Basanti Poddar, 63, from Calcutta's Golf Green and Urmila Bhuniya, 78, from West Midnapore's Salboni. Within 24 hours, the administration received news of three additional deaths in the tragic crowd rush near the Sangam riverfront of Allahabad. The three are Bidhan Ruidas, 42, from West Burdwan's Jamuria, Gayatri Dey, 60, from Birbhum's Rampurhat, and Amiya Saha, 33, from Malda's Kaliachak.

According to family members, Bidhan and Gayatri were killed in the stampede early Wednesday morning, while Amiya died from

suffocation after being trapped in the crowd, soon after the tragic incident. As the bodies of Salboni's Urmila and Jamuria's Bidhan were sent without post-mortem reports or death certificates, family members cried about alleged mismanagement by the Yogi Adityanath government in UP. They accused the Uttar Pradesh administration of attempting to suppress the number of deaths in the stampede. Bidhan, a toto (erickshaw) driver from Jamuria in West Burdwan, had gone to the Mahakumbh Mela via Varanasi with his brother-in-law and a friend on Monday. His family members had last spoken to him on Tuesday night. Bidhan's brother-in-law, Bishnu Ruidas, said they were heading towards the river confluence for the holy dip when they got separated. later found him in the hospital morgue in Prayagraj. We weren't

assisted by the UP government. We were helplessly roaming from one hospital to another to find Bidhan," said Bishnu.

He said the hospital authorities handed him Bidhan's body but without a death certificate or postmortem report. "How can they do this? Without a death certificate from the hospital in Prayagraj or a post-mortem report, how can we prove that Bidhan died in the Kumbh stampede and claim compensation?" Bishnu asked. Family members of Urmila raised similar concerns about the Yogi government's lackadaisical approach to delivering their loved one's body.

The district administrations conducted post-mortems of Bidhan and Urmila at their respective district hospitals, following instructions from chief minister Mamata Banerjee. They also made necessary arrangements for the last rites. "Following our chief

minister's instructions, we have been in touch with the families since they were informed about the tragedy. Today, we conducted the post-mortem of Urmila Bhuniya, whose body arrived from Uttar Pradesh on Thursday evening, in the presence of senior officials and minister Manas Bhuniya," said Khursheed Ali Qadri, West Midnapore district magistrate.

Qadri added that the administration would inquire about the legal procedures for issuing the death certificate. Pratap Dey, the son of Gayatri, who went missing from the Mahakumbh on Wednesday morning, said he received a list of deceased persons, where his mother's name and photograph appeared at serial number 18. 'We couldn't contact my mother since Wednesday morning. Finally, we learned that she was among those killed in the stampede.



Families await the return of their loved ones after tragedy at Kumbh Mela

MI News Service, Kolkata: Families are anxiously waiting for the return of their loved ones, as five residents of the state tragically lost their lives while attending the Mahakumbh. Some victims had gone to bathe, while others got lost in the chaos of the rush at the KumbhMela. Several individuals are still missing, and their families have approached the administration for help in locating them.

One of the missing individuals is Geeta Mandal (60), from Gosaba in South 24 Parganas, who disappeared after taking a dip in the KumbhMela. She had traveled to Prayagraj with her son. Gaurang Mandal, her son, shared, "While returning from the dip, due to a traffic jam, my mother and I got separated. I cannot find her, and the police at the station are not providing any help. Amit Mitra slams Union Budget as "Destructive" and "Anti-People"

MI News Service, Kolkata: In the Union Budget, while significant tax relief has been announced for the middle class, there have been several neglected sectors and cuts to important projects, which Finance Minister NirmalaSitharaman outlined. The state's former finance minister and current economic advisor, Amit Mitra, heavily criticized these announcements, calling them "destructive" and part of a "anti-people conspiracy." He presented data and statistics to demonstrate how cuts to social welfare projects and food subsidies go against public interest.

Mitra raised concerns over the lack of a clear direction for controlling inflation in the Budget. He also pointed out the issue of health insurance GST, questioning why the government did not reduce it despite repeated demands from economic experts and his own repeated proposals as the Chairman of the GST Council. Many had hoped that the Budget would provide some relief in this area, but Sitharaman's speech failed to address it. The economic advisor also questioned why the Budget did not tackle inflation, particularly given the rising prices of essential goods. He stressed that reducing GST on health insurance was a much-needed move, but it was overlooked in the Budget.

In terms of women's welfare, Industry Leaders applaud

Budget speech. This followed an earlier surge when the Finance Minister announced that there would be no income tax for individuals earning up to Rs 12 lakh. The news initially sent the markets rising, but the rally was short-lived as the markets turned flat soon after. The Budget estimate for the financial year 2025-2026 is around Rs 31.47 lakh crore, as announced by Sitharaman in Parliament.

The Nifty FMCG, Auto, Realty, and Consumer Durables indices saw positive movement, while other sectors struggled. Among sectoral indices, the Nifty Metal index recorded the biggest loss with a fall of 1.94 per cent. It was followed by Nifty Oil and Gas which dropped by 1.93 per cent, and Nifty PSU Bank and Nifty Mid-Small IT and Telecom, both of which de-



clined by 1.29 per cent. In other Budget-related updates, the new tax regime will revise the tax rate structure. For income between Rs 0 and Rs 4 lakh, there will be no tax. Income between Rs 4 lakh and Rs 8 lakh will be taxed at 5 per cent, while income between Rs 8 lakh and Rs 12 lakh will attract a 10 per cent tax.. For income between Rs 12 lakh and Rs 16 lakh, the tax rate will be 15 per cent, and for income between Rs 16 lakh and Rs 20 lakh, the rate will be 20 per cent. Income between Rs 20 lakh and Rs 24 lakh will be taxed at 25 per cent, and any income above Rs 24 lakh will be taxed at 30 per cent.

Meanwhile, global markets were also impacted on Saturday as Wall Street indices fell after US President Donald Trump announced tariffs on Canada, Mexico, and China, set to take effect from February 1.

She also proposed to revise the BCD rate on knitted fabrics covered by nine tariff lines from "10 per cent or 20 per cent" to "20 per cent or Rs 115 per kg, whichever is higher". In line with 'Make in India' policy, and to rectify the inverted duty structure, she proposed to increase the BCD on Interactive Flat Panel Display (IFPD) from 10 per cent to 20 per cent and reduce the BCD to 5 per cent on Open Cell and other components. "To further boost the manufacture of such Open Cells, the BCD on these parts will now stand exempted." To the list of exempted capital goods, she proposed to add 35 additional capital goods for EV battery manufacturing, and 28 additional capital goods for mobile phone battery manufacturing. Considering that shipbuilding has a long gestation period, she proposed to continue the exemption of BCD on raw materials, components, consumables or parts for the manufacture of ships for another ten years.: To prevent classification disputes, the government has proposed to reduce the BCD from 20 per cent to 10 per cent on Carrier Grade ethernet switches to make it at par with Non-Carrier Grade ethernet switches. To facilitate exports of handicrafts, the government proposed to extend the time period for export from six months to one year, further extendable by another three months, if required. To enhance India's competitiveness in the global seafood market, the government proposed to reduce BCD from 30 per cent to 5 per cent on Frozen Fish Paste (Surimi) for manufacture and export of its analogue products. She also proposed to reduce BCD from 15 per cent to 5 per cent on fish hydrolysate for manufacture of fish and shrimp feeds. In July 2024 Budget, to promote development of domestic maintenance, repair and overhaul for aircraft and ships, the government extended the time limit for export of foreign origin goods that were imported for repairs, from 6 months to one year and further extendable by one year.

He stated that those involved in illegal building construction and corruption would face personal hardships as they aged, citing health issues and family problems as poconsequences. "When you do your work with respect, you will be able to stand tall, looking at yourself in the mirror with pride," Hakim added.

Fire breaks out in Dharmatala eatery, no casualties reported MI News Service, Kolkata:

A sudden fire broke out early in the morning at a food stall in Dharmatala, sending thick smoke into the air and causing panic in the area. Firefighters rushed to the scene, initially deploying two fire engines. As the flames spread further, three more engines were called in to control the situation. While the fire has been brought under control, residual smoke continues to linger in the vicinity.

According to local sources, the fire erupted at a pub located at 4/1 Hog Street, near the Dharmatala crossing. The area, known for its dense commercial setup, also houses a popular biryani restaurant nearby. Given the congestion, the incident created a sense of alarm among shop owners and residents. Eyewitnesses reported that firefighters acted swiftly, preventing the fire from escalating

into a major disaster. The blaze was controlled before it could cause significant damage to adjacent establishments. The latest updates indicate that the fire is now under control, but the exact cause remains unclear. Fire department officials are investigating to determine how the incident occurred. The affected building, located near the New Market area, houses not only commercial outlets but also several offices and residential units.

People living in the building panicked as the fire spread, fearing for their safety. Firefighters used hoses to spray water from the street, covering the surroundings in thick white smoke. Curious onlookers gathered on the road, observing the efforts to douse the flames. Since it was early morning, many shops in Dharmatala were still closed at the time of the incident.



MI News Service, New Delhi: Congress on Saturday slammed the Union Budget 2025-26, stating that Finance Minister Nirmala Sitharaman is walking on a worn-out path and she and Prime Minister Narendra Modi have not followed the advice of Chief Economic Advisor on the need to deregulate and that the government's "stranglehold" on the activities of the people is getting tighter. Addressing a press conference, former Finance Minister P Chidambaram said the economy will trudge along on the old path and deliver no more than the usual 6 or 6.5 per cent growth in 2025-26. "This is a far cry from the 8 per cent growth rate that the CEA estimated in order to become a developed country. In our view, this is a government with no new ideas and no will to reach beyond its grasp," he said. Recalling economic reforms carried out in 1991 and 2004, he said the Finance Minister is not keen to de-regulate. Chief Economic Advisor V Anant Nageswaran on Friday held a press conference on the Economic Survey which was presented in Parliament. Chidambaram said, "it is evident that neither the FM nor the PM care for the advice of the Chief Economic Adviser". "He gave sensible advice in the Economic Survey. 'Get out of the way' was his call to the government. On the contrary, the Budget is full of new schemes and programmes, many of which are beyond the

Study finds breakthrough tool for detecting problems during protein synthesis

in eukaryotic cells--found in plants, animals, and fungi-involves more than just the straightforward ribosome assembly of amino acids.

During or shortly after their synthesis, over one-third of all human proteins need to be delivered to the endoplasmic reticulum (ER). These proteins' structure and function depend on the critical folding and changes that take place in the ER, such as the cre-ation of disulphide (S-S) bonds.


To overcome these challenges, a research team including specially appointed Associate Professor Hiroshi Kadokura and Professor Hideki Taguchi from the Institute of Science Tokyo, Japan, developed an innovative 'reporter' molecule that can detect ER-related problems during protein synthesis. Disruptions in protein translocation to the ER or disulfide bond formation underlie several diseases, and understanding the mechanisms that govern these processes is essential in biology

Unfortunately, the tools available to study them are either quite limited in scope or require exceptionally expensive equipment and carefully repeated measurements.
While designing this reporter,

the researchers took a page from a fusion protein called MalF-LacZ, derived from Escherichia coli bacteria. In these microorganisms, the MalF part of the protein helps with translocating LacZ from the cytoplasm to the cell envelope.
Once transported there, the

LacZ enzyme undergoes oxidation through disulfide bond formation, thus deactivating it. Therefore, problems in either transportation or disulfide bond formation would result in an abnormally activated LacZ enzyme.

Inspired by these elegant natural mechanisms, the research team developed a reporter molecule based on firefly luciferase (FLuc) that operates in a similar manner. Luciferase is a bioluminescence producing enzyme of firefly that produces light when it



catalyzes the oxidation of Dluciferin in the presence of oxygen, adenosine triphosphate gen, adenosine triphosphate (ATP), and magnesium ions

(Mg2+). More specifically, they engineered a FLuc variant that is rendered inactive by disulfide bond formation in the ER, but

remains active in the cytosol or if disulfide bonds do not form. They 'targeted' this compound to the ER by introducing specific modifito misfolding (and deactivating) within the ER by strategically replacing amino acids in the FLuc sequence with Cysteine.

Using this reporter, the researchers could easily detect problems in protein translocation to the ER, as well as problems in disulfide bond formation. A bioluminescence producing enzyme of a different type can serve as an internal control and ensures precise measurement.

Furthermore, the reporter protein is equipped with a motif that undergoes a modification (glycosylation) only when the pro-tein is translocated into the ER. Thus, they could also determine which of the two possibilities were the underlying cause for the activation of the FLuc reporter.

To showcase the power of this method, the team ran experiments in cells where the redox environment of the ER was chemically altered, disrupting disulfide bond formation. Additionally, they showed that the proposed

tein translocation induced by a potential anti-HIV drug, signaling the successful inhibition of the virus. "Given that luciferasebased assays are well-suited for high-throughput platforms, we suggest that this approach will facilitate large-scale screening of small molecules that specifically block the biosynthesis of harmful correctory, pathway, pretains." secretory pathway proteins, highlights Kadokura.

Notably, this novel reporter bears several advantages over other available methods, including its simplicity, robustness against environmental fluctuations, and high reproducibility "Our reporter system will serve as a valuable tool across various fields related to secretory pathway proteins, extending beyond fundamental studies," say Taguchi, hopeful for the future.

With any luck, these efforts will lead to a better understanding of both life processes and diseases, paving the way to new medical advances and treatments.

Miracle Surgery: Reimplantation Restores Finger of 4-Year-Old Child



Finger reimplantation is a microsurgical marvel, a testament to the intricate skills of plastic surgeons. When a child, especially a young boy, suffers a finger amputation, the prospect of reattachment can offer hope for regaining function and preserving hand appearance. However, this delicate proce-

dure presents unique challenges. In a remarkable display of modern medical expertise, a 4-year-old child recently underwent successful finger reimplantation surgery at Peerless Hospital following a traumatic accident. The intricate procedure, carried out by Dr. Akhilesh Agarwal, plastic surgeon. It has given the young patient a new lease on life and highlights the extraordinary possibilities of modern tech-

A 4year old kid suffered a severe injury while playing with a kitchen knife. The accident resulted in the amputation of his right index finger. Upon arrival at the hospital, the child was rushed into emergency surgery. The procedure, which lasted over several hours, involved meticulous repair of the finger's structures, including bones, tendons, blood vessels, and nerves. Using advanced microsurgical techniques, Dr. Agarwal reconnected arteries as small as 1 millimeter in diameter, restoring blood

flow to the reattached digit Dr. Akhilesh Agarwal, the lead surgeon, described the operation as "a race against time." He explained, "In such cases, every minute counts. The quicker we can restore blood circulation, the higher the chances of

survival for the amputated. Time is of the essence in finger replantation. The severed finger must be preserved in a cool, moist environment, such as a plastic bag filled with ice water. Prompt medical attention is crucial to maximize the chances of successful reattachment.

The days following the surgery were critical. The medical team at PICU lead by Dr Saheli Dasgupta, monitored the child closely to ensure proper blood flow to the reimplanted finger and to prevent complications such as infection or clotting. Fortunately, the recovery has been smooth, with the young patient regaining partial sensation and movement in the finger within weeks of

"The determinant for successful reimplant is proper transport of part. First the part has to be washed and dried. Place it in a plastic bag or container. Then put it on ice" added Dr.Agarwal of Peerless Hospital

This groundbreaking success is a testament to advancements in medical technology and the dedication of healthcare professionals. Additionally, the coordinated efforts of critical care intensivist, surgeons, anesthesiologists, nurses, and physical therapists ensured the best possible outcome.

While the child faces months of physical therapy to fully regain function, the prognosis is optimistic. Children have a remarkable ability to heal and adapt, and Dr.Agarwal believes that the young patient will regain most of the finger's functionality over time. The time in which the parts can be reimplanted varies depending on level of amputation. Hand and fingers can be reimplantsame time frame. The family expressed their heartfelt gratitude to the medical team, saying, "We are forever thankful for the doctors and nurses of Peerless Hospital who worked tirelessly to save our child's finger. Their compassion and skill have made all the difference." The successful reimplantation of a 4-year-old's finger is a beacon of hope and a reminder of the incredible capabilities of modern medicine. Research reveals artery calcification more common in night owls



Stockholm [Sweden] : According to a study from the University of Gothenburg in Sweden, artery calcification is nearly twice as common in night owls as it is in early birds. Circadian function appears to be crucial in the early stages of cardiovascular disease.

Atherosclerosis involves fatty deposits accumulating on the inside of the arteries, making it harder for blood to pass through. The disease develops over a very long period of time and is not noticed until it leads to blood clots causing angina, heart attack. stroke. Previous research has shown that people with late-night habits have an increased risk of cardiovascular disease, but this is the first study to show how circadian rhythms specifically affect calcification of the arteries.

Coronary artery calcification The study, which has been published in the journal Sleep Medicine, involved 771 men and women aged between 50 and 64, all of whom are part of the larger population study SCAPIS. The degree of artery calcification in the heart's coronary arteries was

examined using computer tomog-

raphy. Participants themselves indicated their so called chronotype on a five-point scale: extreme morning type, moderate morning type, intermediate type, moderate evening type, or extreme evening type. Of the 771 participants, 144 dentified as extreme morning types, and 128 as extreme evening types. Among the group who were most alert in the morning, 22.2% had pronounced artery calcification - the lowest proportion of all five chronotypes. The extreme evening type group had the highest preva

"Our results indicate that extreme evening chronotype may be linked not only to poorer cardiovascular health in general, but also more specifically to calcification in the coronary arteries calcification atherosclerosis,"

Self-reported chronotype

Those who had experienced a heart attack were excluded from the study, meaning that the study participants were healthier than the general population. Another weakness identified by the researchers is that participants themselves provided their chrono-

Each chronotype can be said to have an average time when half of the night's sleep has passed. In a previous study on the same population, though not necessarily the same individuals, this time occurred at 02:55 AM for the extreme morning type group and at 04:25 AM for the extreme evening type group. With the remaining chronotype groups' mid-sleep times were somewhere in between these extremes.

SCAPIS stands for Swedish CArdioPulmonary bioImage Study. It is a research project within the field of cardiac, vascular, and pulmonary disease. As part of the project, 30,000 randomly selected Swedes aged 50-64 have undergone extensive health examinations: blood sampling, functional tests, and radiological advanced imaging of organs and blood vessels.

Discovery of brain cells raises hopes of fertility treatments



Washington DC [US] : Researchers from Nagoya University's Graduate School of Bioagricultural ciences and Japan's National Institute of Physiological Sciences have demonstrated how a specific type of neuron in the brain influences the release of hormones that control ovarian function in females, such as follicular development and ovulation. These discoveries, published in the journal Scientific Reports, could help researchers better understand and treat reproductive diseases in both animals and humans.

Kisspeptin neurons in the brain regulate the release of hypothalamic gonadotropin-releasing hormone (GnRH) and pituitary follicle-stimulating hormone/luteinizing hormone (LH). This process is important for reproduction, as pituitary hormones stimulate the ovaries to perform their reproductive functions. Examples include follicular development and ovulation in all mammals, including humans.

There are two main areas of the brain involved in the process: the arcuate nucleus (ARC), in which kisspeptin neurons maintain the regular rhythmic (pulsatile) secretion of GnRH/LH that maintains normal follicular development and sex steroid production; and the anteroventral periventricular nucleus (AVPV), in which kisspeptin neurons trigger a surge of GnRH/LH that leads to ovulation.

The researchers focused on the fact that kisspeptin neurons in the ARC produce and respond to dynorphin, an inhibitory substance "Kisspeptin neurons in the ARC express both dynorphin and its receptor, whereas those in the AVPV express the receptor only, suggesting a particular role of such kisspeptin neurons in fertilization," Mayuko Nagae, a postdoctoral fellow, and Yoshihisa Uenoyama, an associate professor at Nagoya University in Japan and corresponding author of the paper, explained in a joint statement. However, the exact role of dynorphin and its receptor in the regulation of kisspeptin neurons was not clearly understood.

To investigate this, the researchers genetically modified female rats to delete Kiss1, a gene that codes for kisspeptin, only in neurons that expressed the dynorphin receptor. They found that the genetically modified rats with deleted Kiss1 in dynorphin receptor-expressing cells had only 3% of kisspeptin neurons in the ARC and 50% in the AVPV. The rats were still fertile, but they had a longer estrous cycle, lower ovarian weight, and fewer pups than normal rats.

The results indicate that kisspeptin neurons with dynorphin receptors are important for normal female rat reproduction, as they allow proper hormone secretion and ovulation. "This is the first report to show that kisspeptin neurons receiving direct input of dynorphin are needed to fully generate the GnRH/LH pulse and surge in female rats, says Professor Hiroko Tsukamura from Nagoya University, the principal investigator of the research group and another corresponding author of the paper

Professor Tsukamura is excited about the prospect of more studies to understand the molecular mechanism that controls kisspeptin neuronal activity. She says, "Our findings can help our understanding of the central mechanism underlying reproduction and have applications in the treatment of ovarian disorders in livestock and infertility in humans.



This atlas serves as a map of the mouse brain, describing the kind, location, and chemical information of over 32 million cells as well as information on cell connectivity.

The mouse is the most often used vertebrate experimental model in neuroscience research, and its cellular map paves the door for a better understanding of the human brain probably the world's most powerful computer. The cell atlas also provides the groundwork for a new generation of precision treatments for those suffering from mental and neurological illnesses of the brain.

The findings were published in Nature.

"The mouse atlas has brought the intricate network of mammalian brain cells into unprecedented focus, giving researchers the details needed to understand human brain function and diseases," said Joshua A. Gordon, M.D., Ph.D., Director of the National Institute of Mental Health, part of the National Institutes of Health. The cell atlas describes the types of cells in each region of the mouse brain and their organization within those regions. In addition to this structural



information, the cell atlas provides an incredibly detailed catalog of the cell's transcriptome -- the complete set of gene readouts in a cell, which contains instructions for making proteins and other cellular products. The transcriptomic information included in the atlas is hierarchically organized, detailing cell classes, subclasses, and thousands of individual cell clusters within the brain. The atlas also char-

acterizes the cell epigenome -- chemical modifications to a cell's DNA and chromosomes that alter the way the cell's genetic information is expressed -- detailing thousands of epigenomic cell types and millions of candidate genetic regulation elements for different brain cell types. Together, the structural, transcriptomic, and epigenetic information included in this atlas provide an unprecedented map

of cellular organization and diversity across the mouse brain. The atlas also provides an accounting of the neurotransmitters and neuropeptides used by different cells and the relationship among cell types within the brain. This information can be used as a detailed blueprint for how chemical signals are initiated and transmitted in different parts of the brain. Those electrical sig-

laboration and paves our path for more precision brain treatments, said John Ngai, PhD, Director of the NIH BRAIN Initiative." Of the 10 studies included in this collection, seven are funded through the NIH BRAIN Initiative Cell Census Network (BICCN), and two are funded through the larger NIH BRAIN Initiative. The core aim of the BICCN, a groundbreaking, cross-collaborative effort to understand the brain's cellular makeup, is to develop a comprehensive inventory of the cells in the brain -where they are, how they develop, how they work together, and how they regulate their activity -- to better understand how brain disorders develop, progress, and are best treated. "By leveraging the unique nature of its multi-disciplinary and international collaboration, the BICCN was able to accomplish what no other team of scientists has been able to before," said Dr. Ngai.

Chinese military activities intensify near Taiwan

News Service, Taipei: Taiwan's Ministry of National Defence stated that it detected one Chinese aircraft and six naval vessels around the island as of 6 am (UTC+8) on Saturday.

Both types of equipment are strong indications that China is serious about one day invading Taiwan.

The Taiwan-China issue is a complex and longstanding geopolitical conflict centred on Taiwan's sovereignty. Taiwan, officially known as the Republic of China (ROC), operates its own government, military, and economy, functioning as a de facto independent state.

However, China considers Taiwan a breakaway province and insists on the "One China" policy, which asserts that there is only one China, with Beijing as its capital.

This has fuelled decades of tension, especially since the Chinese Civil War (1945-1949), when the ROC government retreated to Taiwan after the Communist Party, led by Mao Zedong, took control of mainland

Damage has also been reported in Zaporizhzhia, as well as in the Odesa, Sumy, Kharkiv, Khmelnytskyi, and Kyiv regions. As of now, six people are confirmed wounded. In Kharkiv, one person was killed by a strike drone. In the Sumy region, this Russian attack claimed two more lives. My condolences to their families and loved

ones," the post added. Zelenskyy further reiterated the urgent need for stronger air defence support from international partners, emphasising that every system and interceptor missile could save lives.

Indian amateur Kartik Singh makes history at International Series India

GURUGRAM (HARYANA) : It was a historic day at DLF Golf and Country Club for Indian amateur Kartik Singh, as he made the cut at International Series India, the youngest-ever player from the subcontinent to do so on the Asian Singh carded a one-under-par

71, taking him to a four-over total at the halfway stage and safely inside the cut line which fell at eight over.

Having only played one Asian Development Tour event previously this was Singh's second appearance in a professional tournament, with a field that he could have only dreamed of previously. featuring the likes of two-time winner Bryson DeChambeau, home favourite Anirban Lahiri and fellow LIV Golf League star Joaquin Niemann.

The world no.1 Under-15 amateur admitted that familiarity with his home course played to his advantage.

In a press release, he said, "It feels unreal playing with Bryson, because normally I'm looking at him on TV, and here I'm playing with him in the same tournament, so it's a great experience. I knew this is my home course, so I defi-



nitely have that advantage and then I know if my game is at that level and if I play my game, I'm able to compete with the pros.

"The experience was very good today. Today, I played quite well, I played one under. I was four under after 11 holes, but it's okay. I mean, I'm still happy with one under par on this course. Yesterday was not that good, but I'm still happy that I was able to make the cut, and hopefully, I can play well this weekend," he added.

The tournament, located in Gurugram on the outskirts of Delhi, has been affected by the weather with round two only finishing on Saturday.

Singh has honed his skills at DLF Golf Academy and has always had the support of his family. Despite his youth, his demeanour reflects that of a seasoned pro.

"My family has always sup-ported me since I started golf. My coach, 'DP' has helped me with my game, and DLF Golf Academy and Callaway have also helped me with my practice. I was practicing elsewhere the last three weeks, so I came back on Saturday. I only played this week, like the tournament week, only the normal practice round so I wasn't able to play the course beforehand but I know it so well.

An impressive 10 Indian's made the cut, on the testing Gary Player-designed course, with Lahiri (-1) leading the way. No other Indian was under par at the halfway stage, with Gaganjeet Bhullar the nearest challenger at two over.

ISL: FC GOA LOOKS TO EXTEND UNBEATEN AWAY RUN AGAINST JAMSHEDPUR FC

JAMSHEDPUR (JHARKHAND) [INDIA]: Jamshedpur FC are all set to host FC Goa at the JRD Tata Sports Complex in the Indian Super League (ISL) 2024-25 on Sunday.

The Red Miners are placed third in the points table since they have 31 points from 17 matches courtesy of 10 victories and a solitary draw. While they trail table-toppers Mohun Bagan Super Giant (40) by nine points, the Mariners have also played an additional game as compared to Jamshedpur FC, as stated in a release from ISL Their nearest target would be

surpassing the second-positioned FC Goa, who have 33 points to their name currently from as many encounters as Jamshedpur FC. The Khalid Jamil-coached side have a chance to do a league double over the Gaurs, since they had defeated Manolo Marquez's men by 2-1 in their reverse fixture on September 17, 2024.

Jamshedpur FC are relishing a formidable home record as of



now, as they are unbeaten in their last five games in the stadium, winning four times. However, they have emerged victorious only once in the five times that they have hosted FC Goa at the venue, losing thrice and drawing

They have failed to record a clean sheet in any of these matches, a fact that could inspire the FC Goa frontline, which has netted 32 times in 17 encounters

this season. FC Goa have been impressive defensively though, registering shutouts in their previous two ISL games. Their last longer such run was between October and December 2023, which also comprised a 1-0 win against Jamshedpur FC.

All in all, this is an encounter straight for the top-two spot as of now. The top-two ranked teams at the end of the league stages qualify directly for the semi-

finals, whereas the sides from third to sixth spots play a singlelegged eliminator at the higherranked side's home venue. If Jamshedpur FC wins this match, they will leapfrog FC Goa in the points table, and if the Gaurs prevail, they will build a formidable distance with the Red Miners - an equation that brings lasting interest in this fixture.

Jamshedpur FC have optimised their strengths in this campaign. It is reflected by the recording of 22 shots from throwins in the current season, which is the highest tally among all teams. They have also attempted at least one shot from a throw-in in each of their previous six encounters, showing that they make the most of any minute opportunity coming their way.

Jamshedpur FC have netted four goals from the penalty spot this season, the joint-most alongside Odisha FC. At the same time, FC Goa have conceded five penalty goals, again the joint-highest with Chennaiyin FC and Kerala

Blasters FC. The Gaurs will have to track their defensive actions inside the 18-yard box closely.

FC Goa have been prolific offensively in away encounters, finding the back of the net in their previous eight ISL clashes on the road. They have also locked in their longest unbeaten away streak, winning and drawing four times each.

Brison Fernandes has netted six goals this season. A goal against Jamshedpur FC will make him only the seventh Indian player to score 7+ goals in a single ISL season. He has also made 49 recoveries in addition to winning 60 duels

Jamshedpur FC head coach Khalid Jamil stressed the need to get a positive outcome in this game. "We are preparing well. The team is entirely focused. We need to get a positive result on our home ground," Jamil was quoted in a release from ISL as saying. FC Goa head coach Manolo Marquez praised Jamshedpur FC's season so far.
