tial", Banerjee said. The chief minister highlighted her government's developmental efforts since 2011, stating that these initiatives have helped over 1.72 crore people rise above the poverty line in the state. "Our continued focus

MI News Service, New Delhi: The Indian government has made it clear to their US counterpart that none of the deported Indians should be mistreated, and said that their focus should be only on strong crackdown on the illegal migration industry and not any harassment.

The was stated by External Affairs Minister S Jaishankar on Thursday through a statement in the Rajya Sabha amid opposition protests over the treatment meted out to 104 Indians, who were deported from the United States and brought to Amritsar on Wednesday.

"We are of course engaging the US government to ensure the returning deportees are not mistreated in any manner during the flight," Jaishankar said.

"At the same time the House will appreciate that our focus should be on strong crackdown on the illegal migration industry, while taking steps to ease visas for the legitimate travellers," he said.

The minister stated that the process of deportation is not a new one."The standard operating procedure for deportation by aircraft provides for the use of restraints. However, we have been informed that women and children are not restrained," he said.

"Further need of deportees during transit related to food and other necessities, including possible medical

MI News Service, New Delhi : Leader of Opposition in the Lok Sabha Rahul Gandhi has once again lashed out at the Rashtriya Swayamsevak Sangh (RSS) and accused them of attempting to erase diverse his-tories, cultures, and traditions in India.

Addressing a protest rally by the DMK students wing against the University Grants Commission (UGC) draft rules on Thursday, the Congress leader alleged that the RSS aims to impose a single idea, history, tradition, and language on the country. "I have been saying now for some time that the aim of the RSS is the eradication of all other histories, all other cultures, all other traditions in this country. That is their starting point, and that is what they want to achieve," Rahul Gandhi said. Gandhi claimed that the RSS's attack on the Constitution is part of their larger agenda to dominate India's cultural and educational landscape, stating, "They attacked the Constitution because they wanted to impose one idea, which is their idea, one history, one tradition, and one language on this country."

Gandhi claimed that the RSS's attack on the Constitution is part of their larger agenda to dominate India's cultural and educational landscape.

This attempt that they're doing with the education system of the different states is just another attempt to push their agenda...," said the Congress MP. He expressed his support for protests

like the one organized by the DMK students wing, stating that the RSS needs to be held accountable for their actions.

"I wish that multiple protests like this happen because the RSS needs to be made to understand that they cannot attack the Constitution. They cannot attack our states. They cannot attack our cultures, our traditions and our histories," said Rahul Gandhi.

The protest in New Delhi was organized by DMK students in opposition to the proposed changes in the UGC draft rules, which they believe threaten the federal structure of India's education system.

According to UGC's new draft guidelines, candidates can qualify for faculty positions at higher institutions by clearing the UGC-NET in a subject of their choice, even if their undergraduate and postgraduate degrees are in different disciplines

Education Minister Dharmendra Pradhan announced the guidelines for the appointment of faculty in higher education. It also includes changes to the selection process for Vice-chancellors, including the expansion of eligibility criteria to include professionals from academia, research institutions, public policy, public administration, and industry.

As per the guidelines, the subject of the PhD degree precedes the disciplines studied in undergraduate and postgradu-ate degrees for faculty selections.

Hooligans target homes of Awami League leaders in fresh wave of vandalism in Bangladesh

MI News Service, New Delhi / Dhaka: Protesters in Bangladesh targeted the houses of several leaders of deposed prime minister Sheikh Hasina's Awami League and continued the demolition of a memorial in Dhaka to the country's founding leader Sheikh Mujibur Rahman on Thursday

On Wednesday night, protesters rallied in front of Mujibur Rahman's house in the capital's Dhanmondi area, now a memorial, following a social media call for a "bulldozer procession" before Hasina's scheduled virtual address from exile in India. The mob set the house on fire. Similar cases of arson were also reported from other parts of Bangladesh. 'They can demolish a building, but not the history... but they must also remember that history takes its revenge," Hasina said in her address on Wednesday night while her father's home was being demolished. An excavator was seen at work at the house continuing with the demolition. The building in the adjacent plot which had housed the offices of several Awami League outfits was also demolished. The violent demonstrators also defaced murals of Mujibur Rahman. The residence

Cousin and wife arrested in Dattapukur murder case

MI News Service, Kolkata: The Dattapukur police have successfully solved the gruesome murder case of Hazrat Laskar, a 25-year-old resident of Gaighata. The breakthrough came when investigators identified the victim through his clothes and tattoos, which were found on the headless body recovered from Bajitpur in Dattapukur. According to police sources, Hazrat's cousin, Obaidullah Mandal, and his wife, Nisha, have been arrested in connection with the murder. The motive behind the crime was reportedly Obaidullah's desire for revenge against Hazrat, who had been having an extramarital affair with Nisha while Obaidullah was in jail. The initial autopsy report indicates that Hazrat was murdered around 2 am,

with his hands and feet tied before his throat was cut with a heavy sharp object. Investigators believe that Hazrat worked in a garment factory, based on stickers found on his clothing. The police are still searching for the severed head and have made inquiries at local factories to gather more information about the deceased. No alcohol was found in his system, and the murder is believed to have taken place in the field where the body was recovered. Obaidullah had claimed that another person was involved in the crime, and police have traced the accomplice's location to Jammu and Kashmir. The investigation is ongoing, with the police working to uncover more details about the brutal mur-

State mulls to augment ginger cultivation in South Bengal

MI News Service, Kolkata: The Horticulture department has decided to augment production of ginger in South Bengal in a bid to reduce dependency on stock coming from North Bengal. The department has been successfully cultivating the same at Simlapal in Bankura. "We have been growing ginger in some parts of South Bengal for the last two-three years but the quality is no match to the 'Gorubathan' variety cultivated in North Bengal. We decided to launch a pilot project to find out if the same variety can be cultivated in the south. We identified one farmer (Utpal Mahapatra) for cultivating this variety. The seeds were sown before the onset of winter. We got 60 quintals of yield which is now selling like hot cakes," said Subhasis Batabyal, director of state Horticulture Development Board. During the Joypur

Utsav and Krishi (Agriculture) Mela, held from January 25 to 30, Mahapatra's success story in ginger production was shown to the farmers to encourage them to take up the same. "Farmers in a large part of South Bengal have a tendency to pursue potato cultivation. Due to stiff competition, they often don't get the desired results for the hard labour they put in. Shifting to ginger production will ensure better income," said a Food Processing In-dustries and Horticulture (FPI &H) department official. Minister in-charge of the department, Arup Roy recently visited Simlapal and witnessed the ginger culti-vation. Batabyal said, now farmers in Kotulpur, Joypur, Bishnupur, Taldangra, Simlapal, Roypur and Sarenga will be encouraged to grow ginger on a large scale while small farmers will be roped in.

MI News Service, Kolkata: West Bengal Chief Minister Mamata Banerjee has requested three major airlines—Air India (Tata-owned), British Airways, and Lufthansa—to consider launching direct flights between Kolkata and Europe. She claimed that the Tata Group has responded positively to her appeal, raising hopes for the return of direct air connec-

tivity between Kolkata and European destinations. Mamata Banerjee also revealed that Tata Sons Chairman N. Chandrasekaran has assured her of significant future investments in West Bengal. However, he was absent from the Bengal Global Business Summit (BGBS) on Wednesday. Addressing his absence, the Chief Minister explained that she had spoken with Chandrasekaran on Tuesday evening, and he had expressed his com-mitment to West Bengal but was unable to attend due to an unforeseen issue. Instead, senior Tata officials represented the group at the event. Mamata Banerjee emphasized her request for Air India to restart direct flights to Europe, highlighting the current inconvenience for passengers who must transit via Doha or

At one time, direct flights operated between Kolkata and European cities, but these services were gradually discontinued: Lufthansa previously operated flights between Frankfurt and Kolkata, but the airline terminated the route in 2012. British Airways halted its Kolkata-London flights in March 2009, while, Air India discontinued its Kolkata-London service in October 2008.

Industry experts cited low profitability as the primary reason for airlines withdrawing direct Kolkata-Europe routes. A tourism industry source explained that the business class occupancy on these flights was significantly lower than in Bengaluru, Delhi, or Mumbai. The lack of premium travelers made the route financially unsustainable, leading to its closure.

With Mamata Banerjee's renewed push and a potentially positive response from Tata Group, Kolkata's international connectivity could soon improve, benefiting both business and tourism sectors.

Lalbazar issues strict guidelines for passport verification

MI News Service, Kolkata: In a bid to ensure thorough verification of passport applications, Lalbazar has issued strict instructions to all police stations and the Special Branch (SB) of Kolkata Police. The directive warns officers that negligence in verification will not be tolerated.

Key directives issued by the Lalbazar department are that Officers must carefully examine all documents submitted with passport applications.

It is mandatory for local police officers to physically visit the applicant's residence to confirm their identity and Indian citizenship.

If any suspicion arises regarding submitted documents, officers must verify their authenticity with the issuing authority. In case of discrepancies, officers are required to report the matter immediately

Lalbazar has made it clear that if any passport-related fraud surfaces, the concerned police officers will face disciplinary action.

Recently, Kolkata Police Commissioner Manoj Verma held a meeting with top officials to discuss multiple irregularities in passport verification. Sources indicate that the issue was highlighted following a recent incident at Alipore Court, where a judge questioned Kolkata Police about verification lapses. A senior police official revealed, "The birth certificates submitted for some passports were fake. Additionally, several other documents provided by certain applicants were also found to be fraudulent. That is why all police stations have been warned.

Senior officials at Lalbazar suspect that some police officers responsible for passport verification are not performing their duties diligently.

As per standard procedure, officers must personally verify an applicant's details at their residence. However, there are allegations that officers are being lax, allowing fraudulent documents to go unnoticed.

This negligence has, in some cases, led to Indian passports being issued to foreign nationals.

This is not the first time passport verification irregularities have been reported in Kolkata. Authorities are now taking a zero-tolerance approach to prevent fraud and ensure that only eligible applicants receive passports. With Lalbazar's new directive, police officers handling passport verification will now face greater scrutiny, ensuring a more secure and accountable process.

Protesting students also removed the name of Sheikh Mujibur Rahman from Bangabandhu Sheikh Mujibur Rahman Hall of Dhaka University.

The homes of former lawmaker of Kushtia-3 and Awami League Joint General Secretary Mahbubul Alam Hanif and president of Kushtia Awami League Sadar Khan were also ransacked.

Protesters in Chattogram took part in a torch procession last night to demonstrate against Hasina's speech, which was broadcast on Bangladesh Awami League's social media accounts.

They later defaced Mujibur Rahman's murals at Chittagong Medical College and in the city's Jamal Khan area. Protesters also defaced a mural of Mujibur Rahman at Begum Rokeya University in Rangpur.

In Barishal, demonstrators brought a bulldozer to the house of Serniabat Sadiq Abdullah, former mayor of the city corporation and a relative of Hasina. He owns a two-storey home in the city's Kalibari Road area.

Protesters also vandalised murals of Mujibur Rahman near the Circuit House ground in Mymensingh city and at the National Poet Kazi Nazrul Islam University in Trishal.


The mayhem on Wednesday began after Anti-Discrimination Students Movement leader Hasnat Abdullah wrote on his verified Facebook account: "Tonight, Bangladesh will be liberated from the place of pilgrimage for fascism." Hasina, delivering her address organised by Awami League's now disbanded student wing Chhatra League, in a relatively calm tone called upon the countrymen to organise a resistance against the current regime.

They are yet to have the strength to destroy the national flag, the constitution and the independence that we earned at the cost of lives of millions of martyrs with a bulldozer," Hasina said in a visible reference to Professor Muhammad Yunus's incumbent regime.

They can demolish a building, but not the history... but they must also remember that the history takes its revenge," she said.

Vijay Durg as part of **Colonial Legacy shift** MI News Service, Kolkata: Fort William in Kolkata, the headquarters of the Indian Army's Eastern Command, has been of-

ficially renamed Vijay Durg as part of the Modi government's efforts to eliminate British colonial influences from the nation's heritage. The iconic fort, which was initially named after King William III of England, is now named after the historic Sindhudurg fort on Maharashtra's coast, which was a key naval base during the reign of Chhatrapati Shivaji Maharaj.

The decision to rename the fort was made in the second week of December, though it has not yet been formally announced. However, Wing Commander Himanshu Tiwari, Chief Public Relations Officer of the Ministry of Defence in Kolkata, confirmed that 'Fort William' is no longer used in internal communications.

Fort William, built nearly 250 years ago, was named after King William III, the British monarch during the fort's establishment in 1700. The King was also a key figure in the spread of Protestant Christianity in Europe.

In addition to renaming the fort, other structures within the complex have also received new names. Kitchener House is now Manekshaw House, and the South Gate, previously

known as St George's Gate, is now Shivaji Gate. According to a senior official from the Eastern Command, the new Fort William, covering over 177 acres, replaced the original fort destroyed by Siraj-ud-Daula's forces in 1757. Construction of the new fort began in 1758 and was completed in 1781. The fort was designed with enhanced defenses, including 497 cannons placed along the ramparts. Hyderabad Police bust fake education certificate racket, two arrested

Hyderabad: Hyderabad Police arrested two individuals on Wednesday for their alleged involvement in a fake education certificate racket, which was being operated to provide forged academic documents to job seekers and students.

The arrests were made by the Dabeerpura Police and the South East Zone Task Force at Diamond Hotel, New Road Chanchalgu-

The accused have been identified as Abdul Qadeer (47), a private teacher residing in Shalibanda, and Mohd Shakeel (37), an unemployed resident of Dabeerpura. Another key suspect, Sanjay Sharma alias Sahil Sharma from Kanpur, Uttar Pradesh, is still absconding.

According to police of-ficials, the arrests were made based on credible intelligence. Sub-Inspector G. Naganna and his team intercepted the accused while they were travelling

on a two-wheeler towards Yakutpura.

Investigations revealed that the duo had been supplying fake educational certificates to individuals who lacked formal qualifications, charging them large sums by promising employment opportunities both in India and abroad.

Authorities have seized a total of 91 counterfeit certificates, additionally, the police recovered two mobile phones, Rs 1,080 in cash, and a motorcycle used in the crime.

During the investigation, it was found that the accused had ties with Sanjay Sharma, who was responsible for fabricating the fake certificates. The arrested individu-

als would collect details and payments from clients and forward them to Sharma via WhatsApp. Sharma would then create the forged documents and courier them to Abdul Qadeer, who would hand them over to the buvers



Researchers discover protein that help prevent cancer treat-ment-related heart damage



Washington [US] : Blocking the protein CDK7 could prevent heart damage caused by a routinely used cancer chemotherapy treatment, according to a study conducted by scientists at Washington State University. Importantly, the researchers discovered that blocking CDK7 could improve the medication's cancer-killing efficacy.

Based on an animal model, the study's findings potentially lay the groundwork for future treatment options to decrease chemotherapyrelated heart damage and improve treatment efficacy. This has the potential to help people with cancer live longer lives. Heart damage caused by chemotherapy can manifest decades later and lead to heart attacks, heart failure, cardiomyopathy, and other types of heart dis-

The findings of the study were published in the journal Cardiovascular Research, the WSU

study focused on doxorubicin, a chemotherapy drug used to treat breast cancer, lymphoma, leukemia and other cancers.

Capable of killing a wide range of cancer lls, doxorubicin and other similar cells. chemotherapy medications are known to be toxic to the heart. Despite this toxicity, the drug still sees a lot of use.

"Doxorubicin remains the mainstay treatment for certain cancer types for which targeted therapies or other better treatments are not available," said senior study author Zhaokang Cheng, an associate professor in the WSU College of Pharmacy and Pharmaceutical Sciences.Cheng has been working to unravel the underlying mechanisms of doxorubicininduced heart toxicity to make the use of doxorubicin safer for patients who rely on the drug. This new study builds on findings from earlier research that showed that doxorubicin activates a protein known as CDK2. That protein then activates another known as FOXO1, which causes heart cells to die. Cheng's team collaborated with WSU cancer biology researcher Boyang (Jason) Wu to take a closer look at CDK7, a protein that helps fuel cell growth and has been shown to play a role in the development of cancer.

The researchers found that CDK7 activated CDK2, which set off the chain of molecular signals that eventually led to heart cell death. They also showed that mice that lacked the CDK7 gene were protected from doxorubicininduced heart toxicity. Next, they used a CDK7 inhibitor drug known as THZ1 to block the protein's activity and examine the impact on heart health and cancer growth. A similar inhibitor is currently being tested as an anticancer drug in clinical trials, but its effect on the heart is still not clear.

"We are the first to study the effect of THZ1 on the heart and tumour growth in the same model," said study first author Jingrui Chen, a WSU research associate. "And what we found is that this CDK7 inhibitor drug can increase heart function and at the same time inhibit tumour growth.'

Though more research is needed, the researchers said their findings suggest that combining doxorubicin and THZ1 could help prevent heart damage and increase the effectiveness of chemotherapy treatment.

The researchers' next step is to test the effect of THZ1 on heart damage and cancer growth in younger mice and follow them longer. This would more closely mimic longterm doxorubicin-induced heart toxicity seen in childhood cancer survivors. They also plan to look at other proteins that may somehow be involved in the signaling pathway that underlies doxorubicin-related heart damage.

Study reveals key protein that helps prevent excessive bone loss in osteoporosis

Tokyo [Japan] : Osteoporosis, a disorder characterised by porous and weak bones, is a major hazard to skeletal health. As the foundation of the human body, bones provide critical structural support. When bone mass decreases, it not only weakens this support but also lowers general function, resulting in a lower quality of life

With an ageing population and a rise in osteoporosis cases, the burden on healthcare resources for long-term care is clear. As a result, there is a need to understand the mechanisms that cause osteoporosis and develop effective targeted therapeutics to mitigate its long-term effects.

Osteoblasts and osteoclasts are two types of cells that play critical roles in bone tissue maintenance and remodelling. Osteoblasts are bone-forming cells that synthesise and deposit new bone tissue, whereas osteoclasts break down and remove old or damaged bone tissue. Increased proportion of osteoclasts causes bone mass loss in situations such as osteoporosis, rheumatoid arthritis (joint inflammation), and bone metastases (cancer that has spread to the bones). Osteoclasts develop from the development of macrophages or monocytes, two types of immune cells. Suppressing osteoclast differentiation could thus be used as a therapeutic technique to prevent bone loss. However, the precise molecular pathways driving the complicated process of bone remodelling are unknown. In a new groundbreaking

study, Professor Tadayoshi Hayata, Mr. Takuto Konno, and Ms. Hitomi Murachi from Tokyo University of Science, along with their co-workers, delved deeper into the molecular regulation of osteoclast differentiation. Receptor activator of nuclear factor kappa B ligand (RANKL) stimulation induces the differentiation of macrophages into osteoclasts. Further, bone morphogenetic protein (BMP) and transforming growth factor (TGF)-b signaling pathways have been implicated in the regulation of RANKL-mediated osteoclast differentiation. In the current study, the researchers sought to investigate the role of



Ctdnep1 - a phosphatase (an enzyme that removes phosphate groups) that has been reported to suppress BMP and TGF-b signal-

Giving further insight into their work set to be published on July 30, 2024, in Volume 719 of Biochemical and Biophysical esearch Communications, Prof. Hayata states, "RANKL functions as an 'accelerator' for osteoclast cell differentiation. Driving a car requires not only the accelerator but also the brakes. Here, we find that Ctdnep1 functions as a 'brake' on osteoclast cell differentiation.

First, the researchers examined the expression of Ctdnep1 in mouse-derived macrophages treated with RANKL and untreated control cells. They noted that Ctdnep1 expression remained unchanged in response to RANKL stimulation. However, it localized in the cytoplasm in granular form in the macrophages and differentiated into osteoclasts, distinct from its normal peri-nuclear localization in other cell types, indicating its cytoplasmic function in osteoclast differentiation. Further, Ctdnep1 knockdown (downregulation of gene expres-

sion) resulted in an increase in tartrate-resistant acid phos-phatase-positive (TRAP) osteoclasts; wherein TRAP is a marker for differentiated osteoclasts. Additionally, Ctdnep1 knockdown led to an increase in the expres-

sion of crucial differentiation markers including 'Nfatc1', a RANKL-induced master transcription factor for osteoclast differentiation. These results support the 'brake function' of Ctdnep1, whereby, it negatively regulates osteoclast differentiation.

Moreover, Ctdnep1 knockdown also led to increased absorption of calcium phosphate, suggestive of the suppressive role of Ctdnep1 in bone resorption. Lastly, while, Ctdnep1 knockdown did not alter BMP and TGF-b signaling, cells deficient in Ctdnep1 showed elevated levels of phosphorylated (activated) proteins downstream of the RANKL signaling pathway. These findings suggest that the suppressive effect of Ctdnep1 in osteoclast differentiation may not be mediated by BMP and TGF-b signaling, but, through the negative regulation of RANKL signaling and Nfatc1 protein levels.

Overall, these findings provide novel insights into the process of osteoclast differentiation and reveal potential therapeutic targets which can be pursued to develop treatments that address bone loss due to excessive osteoclast activity. In addition to diseases characterized by bone loss, Ctdnep1 has also been reported as a causative factor in medulloblastoma - a childhood brain tumor. The authors are, therefore, optimistic that their research can be extended to other human diseases beyond bone metabolism.

Semaglutide ingredient can help protect kidney function in people with obesity: Study

WASHINGTON [US], Semaglutide, a glucagon-like peptide-1 (GLP-1) receptor agonist, has been shown in the SELECT Trial to be effective in preventing the loss of kidney function in people who are overweight or obese and have established cardiovascular disease but do not have diabetes.

The remarkable secondary analysis from the SELECT (Semaglutide Effects on Heart Disease and Stroke in Patients with Overweight or Obesity) experiment, a randomised trial with a participant pool of 17,604

The study's findings, according to experts, give individuals who suffer from obesity hope since this illness is known to increase the risk of renal function decline and macroalbuminuria, or abnormally high levels of the albumin protein in urine.

With an average follow-up of approximately 3.5 years, among patients who were administered a once-weekly subcutaneous injection of semaglutide 2.4 mg (n=8,803) adverse kidney-related events were experienced by 22% fewer persons (1.8%) compared to those receiving placebo (n=8,801) (2.2%) (p<0.05). These events included death from kidney causes, initiation of chronic kidney replacement therapy, significant (>= 50%) decline in kidney function, or onset of persistent macroalbuminuria. Semaglutide's ability to prevent the onset of macroalbuminuria was highlighted as a pivotal factor in reducing

the likelihood of kidney-related complications

The study also assessed the impact of semaglutide on estimatglomerular filtration rate (eGFR), a measure of kidney function in removing waste and excess water from the blood through urine. The findings indicated a significantly lesser decline in eGFR among semaglutide recipients compared to the placebo group, with the effect being more pronounced in participants with baseline eGFR below 60 mL/min/1.73 m2 (p<0.001). These results indicate the potential for semaglutide to particularly protect kidney function in individuals with a pre-existing kidney

impairment. The reduction in urinary albumin-to-creatinine ratio (UACR) further substantiated semaglutide's beneficial effect on kidney health, with a significant decrease observed in semaglutide-treated individuals compared to placebo (p<0.001). UACR analysis measures the ratio of albumin (a protein) to creatinine (a waste product) in urine, aiding the detection of albuminuria, which can signal kidney damage

or dysfunction. With semaglutide,

"The observed benefits in eGFR and UACR are particularly encouraging, suggesting potential for the enhanced management of kidney complications in the patient population with overweight and obesity without diabetes. The findings also underscore the importance of continued research into the possible renal benefits of semaglutide and highlight its role as a promising therapeutic option in the multifaceted management of cardiovascular and renal health in this high-risk population."

have created a generalized method for "cloaking" proteins, which may allow for the recycling of materials like antibodies for biological research and therapeutic applications.Lipid nanoparticles, which resemble tiny bubbles of fat, have the ability to ensnare the "cloaked" proteins. Because of their microscopic size, these bubbles are able to secretly deliver their cargo into living cells, where the proteins unfold and begin to work as medicine. The group's paper published in ACS Central Science. The lead author is doctoral student Azmain Alamgir, who works in the labs of the paper's co-senior authors, Chris Alabi, associate professor of chemical and biomolecular engineering, and Matt DeLisa, professor of engineering.

For some drugs to impact a cell's biology, and ultimately treat disease, they need to get inside the cell and reach a specific space. Protein-based therapeutics have

many virtues - they can have more specific effects, with lower toxicity and diminished immune response - but ease of delivery is not one of them. Proteins are large and cumbersome and don't freely diffuse into cells as easily as small molecules do.

"We had been looking for a clever way to efficiently get our engineered proteins inside of cells, especially in a translational context that would not only work in lab-cultured cells, but that would also be effective and safe in animal models and eventually in humans," DeLisa said. The researchers had the broad idea of using a bioconjugation approach that would allow the proteins to be loaded into lipid nanoparticles, which form around nucleic acids.

Light therapy helps in brain connectivity following injury

Illinois [US] : A study suggests that lowlevel light treatment may have an impact on the healing process in the brains of individuals who have experienced serious brain injuries.

The findings of the study were published in Radiology, a journal of the Radiological Society of North America (RSNA).

The ability of various wavelengths of light to heal wounds has been researched for many years. Low-level light treatment was used by researchers at Massachusetts General Hospital (MGH) on 38 patients who had experienced moderate traumatic brain injury, which is defined as a head injury severe enough to affect cognition and/or be detectable on a brain scan. Within 72 hours of their injury, patients underwent light therapy using a near-infrared lightemitting helmet.

"The skull is quite transparent to near-infrared light," said study co-lead author Rajiv Gupta, M.D., Ph.D., from the Department of Radiology at MGH.

"Once you put the helmet on, your whole brain is bathing in this light.

The researchers used an imaging technique called functional MRI to gauge the effects of the light therapy. They focused on the brain's resting-state functional connectivity, the communication between brain regions that occurs when a person is at rest and not engaged in a specific task. The researchers compared MRI results during three recovery phases: the acute phase of within one week after injury, the subacute phase of two to three weeks post-injury and the late-subacute phase of three months after injury. Of the 38 patients in the trial, 21 did

not receive light therapy while wearing the helmet. This was done to serve as a control to minimize bias due to patient characteristics and to avoid potential placebo effects.

Patients who received low-level light therapy showed a greater change in resting-state connectivity in seven brain region pairs during the acute-to-suba-

cute recovery phase compared to the control participants.

There was increased connectivity in

those receiving light treatment, primarily within the first two weeks," said study coauthor Nathaniel Mercaldo, Ph.D., a

statistician with MGH. "We were unable to detect differences in connectivity between the two treatment groups long term, so although the treatment appears to increase the brain connectivity initially, its long-term effects are still to be determined.

The precise mechanism of the light therapy's effects on the brain is also still to be determined. Previous research points to the alteration of an enzyme in the cell's mitochondria (often referred to as the "powerhouse" of a cell), Dr. Gupta said. This leads to more production of adenosine triphosphate, a molecule that stores and transfers energy in the cells. Light therapy has also been linked with blood vessel dilation and anti-inflammatory effects.

There is still a lot of work to be done to understand the exact physiological mechanism behind these effects," said study coauthor Suk-tak Chan, Ph.D., a biomedical engineer at MGH.

While connectivity increased for the light therapy-treated patients during the acute to subacute phases, there was no evidence of a difference in clinical outcomes between the treated and control participants. Additional studies with larger cohorts of patients and correlative imaging beyond three months may help determine the therapeutic role of light in traumatic brain injury.

The researchers expect the role of light therapy to expand as more study results come in. The 810-nanometerwavelength light used in the study is already employed in various therapeutic applications. It's safe, easy to administer and does not require surgery or medications. The helmet's portability means it can be delivered in settings outside of the hospital. It may have applications in treating many other neurological conditions, according to Dr. Gupta.

There are lots of disorders of connectivity, mostly in psychiatry, where this intervention may have a role," he said. "PTSD, depression, autism: these are all promising areas for light therapy.

While addressing a news conference, Adorni said, "President (Javier) Milei instructed (foreign minister) Gerardo Werthein to withdraw Argentina's partici-pation in the World Health Organization.

We Argentinians will not allow an international organization to intervene in our sovereignty, much less in our health," he add-

Manuel Adorni attributed Argentina's decision to "profound differences regarding... health management, especially during the pandemic that... led us to the longest lockdown in human history and a lack of independence in the face of the political influence of some states," CNN reported.

The announcement comes just weeks after US President Donald Trump signed an executive order, announcing the withdraw-al of the US from WHO.

A day earlier, access to DeepSeek was restricted on computers at South

Korea's foreign, trade, and defence ministries.

Additionally, a separate official from the unification ministry said that the ministry intends to implement similar restrictions

"The unification ministry has (since 2023) prohibited the input of undisclosed official data into all generative AI at the request of the National Intelligence Ser-vice and the interior ministry," the official said.

Asked whether the ministry would block access to DeepSeek, the official said, "We plan to take follow-up measures within the day, including block-ing access," without directly mentioning its name, Yonhap reported.

Meanwhile, the Ministry of Environment on Thursday joined many other government ministries

in blocking access to DeepSeek. The ministry blocked access to DeepSeek from its internet-connected PCs from 9 am (local time), Yonhap reported.

Turkestan Organizations mark Ghulja massacre as part of ongoing Uyghur oppression

MI News Service, Istanbul: The International Union of Turkestan Organizations (IUETO) led a significant protest to mark the 28th anniversary of the Ghulja Massacre, an event that has become a symbol of the ongoing oppression faced by the Uyghur people in East Turkistan.

Around 1,200 Uyghur diaspora members gathered outside the Chinese Consulate in Istanbul on Wednesday, urging the international community to take stronger action against China's continued genocide and human rights abuses in the region.

The protest was led by Hidayet Oguzhan, President of IUETO, who highlighted the atrocities committed by the Chinese government on February 4 and 5, 1997, in the city of Gulja (Yining). On those days, a peaceful demonstration, sparked by the arrest of Uyghur women gathering for prayers during Ramadan, was violently suppressed by Chinese police and military forces. Hundreds of protesters were killed by gunfire, freezing temperatures, and brutal repression.

"On this tragic anniversary, we remember the lives lost in the Ghulja Massacre, but also all the



innocent people who have suffered under China's continued occupation of East Turkistan," Oguzhan stated. "The Ghulja Massacre is only one of many horrific events in a chain of oppression that continues to this day.'

IUETO used the anniversary to draw attention to the ongoing repression in the region, where millions of Uyghurs and other Turkic Muslim minorities continue to face systematic violence. Since 2014, China has escalated its genocidal policies in East Turkistan, including the mass detention of over 3 million Uyghurs in so-called "reeducation camps," where individuals are subjected

to forced labour, physical torture, and indoctrination. The Chinese government has also imposed severe restrictions on religious practices, destroyed mosques, and engaged in forced sterilizations and abortions.

The protestors also called attention to China's efforts to erase Uyghur culture and identity. Under the "Sibling Fam-ily Project," Uyghur children have been forcibly separated from their families and placed with Chinese families for assimilation. This policy has led to the destruction of Uyghur family structures and the loss of cultural transmission

Super Kings' run-chase stuttered throughout with the Joburg side unable to put together any meaningful part-nerships as they slipped to 152/7 in their 20 overs.

The Eliminator was virtually decided in two separate overs of each innings.

The Sunrisers innings was delicately poised on 14975 with 12 balls remaining when Markram and Marco Jansen (23 in 12 balls, with two fours and two sixes) bashed 29 runs off Lutho Sipamla's penultimate over.

Sipamla conceded three sixes, two boundaries and delivered a no ball to finish with the second-most expen-sive figures of 0/72 in SA20 his-tory. Imran Tahir (2/21) was the pick of the bowlers for JSK.

In contrast, the Super Kings were on track at 91/3 after 12 overs requiring 94 from 48 balls with set batters Jonny Bairstow (37 in 17 balls, with three fours and three sixes) and Wihan Lubbe (13) at the crease.

Sunrisers skipper rolled the dice and opted to bowl out seamer Craig Overton (2/20). The decision reaped the desired rewards with Overton sending down a miraculous double-wicket maiden over by dismissing both Lubbe and Moeen Ali as the Super Kings slumped to 91/5.

There was no way back for the Super Kings as they were left to contemplate a third playoff in a defeat in a row.

DUBAI [UAE] : India Under-19 star Trisha Gongadi along with Australia's veteran wicketkeeper-batter Beth Mooney and West Indies' Karishma Ramharack were nominated for January's ICC Women's Player of the Month award on Thursday, according to ICC. Trisha Gongadi (India Under 19)

Trisha Gongadi consistently shone with the bat for the India side at the ICC Women's U19 T20 World Cup in Malaysia as she flourished in her role as an opener. Her aggressive batting style at the top of the order set the tone for India.

She became the first batter to score a century in the tournament against Scotland with a spectacular 110* off 59 balls at a monstrous strike rate of 186.44.

Gongadi was the leading run scorer in the tournament at the end of the semi-finals stage. Her batting exploits were instrumental as India eventually went on to win the tournament.

Gongadi scored 265 runs off six U-19 T20Is at an average of 66.25 and a strike rate of 149.72. She even contributed with the ball, taking four wickets at an average of 7.50 and an economy rate of 3.75.

Beth Mooney (Australia)

Beth Mooney had a fantastic January with commendable performances in the T20 series against England.

She scored two fifties which included a knock of 94 not out as Australia whitewashed England 3-0 in the T20I component of the Ashes series.

Mooney was undoubtedly Australia's standout batter, earning the Player of the Match award in both the first and final T20Is of the series. She also finished as the leading run-scorer across the T20Is

Apart from her batting, Mooney was outstanding behind the stumps, taking three catches and executing a stumping during the T201 series.

Mooney amassed 213 runs in three T20Is at an average of 106.50 and an exceptional strike rate of 146.89.

She also scored 90 runs in three ODIs at an average of 30 and a strike rate of 82.56 to end her January.

Karishma Ramharack (West Indies)

Karishma Ramharack was a standout performer for the West Indies in their ODI series against Bangladesh.

After a slow start to the series, Ramharack found her groove in the second ODI. She dismantled the Bangladesh middle-order and finished the game with figures of 4/33 off her 10 overs with an economy rate of 3.30 and remained a standout performer for the West Indies despite their loss.

ISL steps into Shillong as NorthEast United FC aim to push playoffs against Mumbai City FC

SHILLONG (MEGHALAYA) : NorthEast United FC will host Mumbai City FC as the Indian Super League (ISL) makes its debut in Meghalaya with this match taking place at the Jawaharlal Nehru Stadium in Shillong on February 7.

The Islanders will be targeting a bounce back after a goalless draw in their previous game against East Bengal FC, whereas the Highlanders are aiming to extend their unbeaten streak to nine games, a release from ISL stated

In the reverse fixture, the Highlanders prevailed by a dominating 3-0 margin and will have their eyes set on securing their second league double against Mumbai Čity FC, having previously done so in 2020-21. It was incidentally the last time that NorthEast United FC had qualified for the playoffs as well, and they are arguably primed to do so this season around as well.

Currently, NorthEast United FC have 29 points on the back of seven victories and eight draws after 19 encounters, placed fourth in the points table, having drawn four times and won once in their last five games.

The Islanders are positioned sixth in the rankings, as they have 28 points to their name from 18 games due to seven wins and draws each. Their last five games have seen the team win and draw twice. Incidentally, Mumbai City FC's seven stalemates this season are only surpassed by NorthEast United FC's eight.

Amid injury concerns, Australian camp hit by shock ODI retirement of Marcus Stoinis

MELBOURNE [AUSTRALIA] : Australia all-rounder Marcus Stoinis has shocked the cricketing world by announcing his retirement from ODI cricket with immediate effect, reported the International Cricket Council (ICC) on Thursday.

Stoinis will retire from ODIs with immediate effect so the 35year-old can concentrate on T20I cricket, meaning Australia will be without his services for the upcoming ICC Champions Trophy. The Aussies are already suffer-

ing an injury crisis for the tournament in Pakistan and UAE that commences on February 19, with all-rounder Mitch Marsh already ruled out of the eight-team tournament and key pacers Pat Cummins and Josh Hazlewood also in serious doubt.

It means Australia may be on the lookout for up to four new players for their 15-member Champions Trophy squad, with the likes of Spencer Johnson, Jake Fraser-McGurk and Sean Abbott all likely to be in the mix as replacement.

Australia great Ricky Ponting recently said uncapped all-rounder Mitchell Owen should be considered for the Champions Trophy and the 22-year-old has many similar qualities that Stoinis possesses. Stoinis finishes his international ODI career having represented Australia on a total of 71 occasions in 50-over cricket and having appeared at two ICC Men's Cricket World Cups in 2019 and 2023, with his most recent contest coming against Pakistan in Perth in November last year. He scored 1.456 runs in 64 innings at an average of 26.69, with a century and six fifties and best score of 146. He also took 48 wickets at an



average of 43.12, with best figures of 3/16. Stoinis suggested the deci-sion to retire from ODI cricket was made so he could focus on prolonging his T20I career, but said he would still be keeping a close eye on proceedings at the Champions Trophy.

"Playing ÔDĬ cricket for Australia has been an incredible journey, and I am grateful for every moment I have had in the green and gold. Representing my country at the highest level is something I will always cherish," Stoinis said as quoted by ICC.
