BJP government to set up Special **Investigation** Team to probe **AAP** corruption

Kejriwal loses New Delhi AAP drowned due to liquor policy focus on money: Anna Hazare

MI News Service, Mumbai: As the BJP looked all set to re-capture the Delhi seat of power after more than 26 years, Arvind Kejriwal's mentor and social activist Anna Hazare, said the AAP "drowned" due to the liquor policy and its focus on money.

In a strong word of criticism of Kejriwal, the anti-graft activist further said a candidate's character should be clean and he should know the virtues of sacrifice. They also failed to understand its duty to serve people selflessly, he said

The Aam Aadmi Party (AAP), born from Hazare's anti-corruption crusade, fell behind its main opposition BJP from the beginning of the counting of votes for the 70-member Delhi assembly polls held on February 5. The BJP is poised to form the next government in Delhi after more than 26 years, as the latest trends of the counting showed that the saffron party went ahead in 48 of the 70 assembly seats by this afternoon, while the AAP maintained lead in 22 others. "With the liquor policy issue came the money and they drowned in it. The (AAP's) image was tarnished. People saw he (Arvind Kejriwal) talks about clean character and then about liquor," Hazare, who led the anti-corruption movement in 2011, told reporters. The Kejriwal-led AAP was founded in

2012 following the anti-corrup-

tion movement. "AAP lost as it

failed to understand the need to

serve people selflessly and took



the wrong path. Money took the front seat which dented AAP's image, leading to its defeat," Hazare said.

Hazare said, "I have been saying for a long time that while contesting the election - the candidate must have a character. good ideas and have no dent on image. But, they (AAP) didn't get that. They got tangled in liquor and money - his (Arvind Kejriwal) image was dented because of it and that's why they are getting fewer votes in the election." Hazare also emphasised the importance of proving one's innocence in politics.

He added, "People saw that he (Arvind Kejriwal) talks about character but gets involved in liquor. In politics, allegations are made. One has to prove that he is not guilty. The truth will remain the truth...When a meeting was held, I decided that I would not be part of the party - and I have remained away from that day.", he said. Kejriwal is known to be Hazare's protege but the two

FIR lodged against Rahul Gandhi in Odisha for alleged 'anti-national' statement



MI News Service, Bhubaneswar: Members of the BJP, its youth wing, RSS and Bajrang Dal of Jharsuguda district in Odisha have lodged an FIR against Congress leader Rahul Gandhi for allegedly making an "anti-national" statement.

Informing this a senior police officer of the district said on Saturday that the FIR was registered on Friday based on a complaint lodged by members of BJP, its youth wing, RSS, Bajrang Dal, of Jharsuguda district against the Opposition leader in the Lok Sabha to IGP Northern Range, Himanshu Lal on February 5. He said the FIR against Řahul Gandhi, at Jharsuguda police station (case No 31) under section 152 (criminalizes acts) of BNS for making false or misleading information that threatens India's unity, sovereignty and integrity

The complaint alleged that the Congress leader has been deliberately making anti-national statements which hurt each and every Indian individual. The IGP forwarded the complaint to Jharsug-

for inquiry and necessary legal action. As per the direction of the SP, an FIR has been registered against Gandhi at Jharsuguda police station (case No 31). "I do not know the nature of the allegation against Rahul Gandhi, let me see it first. The Congress as a political party has been fighting against the ideology of BJP and RSS," former Union Minister and senior Congress leader Srikant Jena said.

Holding Rahul Gandhi responsible for a speech he made last month, the police sources said based on a complaint from one Rama Hari Pujhari, a resident of Sarabhal in Jharsuguda and a local functionary of the BJP the FIR was lodged. It pertains to a speech that Gandhi made at the inauguration of Congress's new headquarters at Kotla Road near Rouse Avenue District Court Complex in Central Delhi on January 15. On that day, Gandhi accused the Rashtriya Swayamsevak Sangh (RSS) and the BJP of "capturing every single institution" in the country, claiming that his party was not only fighting the BJP , but the Indian state itself. In his complaint on behalf of the BJP, the RSS and other similar right-wing outfits, Pujhari accused Gandhi of "deliberately giving anti-national statements which hurt each and every Indian individual"

Kunal Ghosh dismisses BJP's claims, asserts TMC's strength in Bengal

MI News Service, Kolkata: After the Bharatiya Janata Party's (BJP) historic victory in Delhi, political debates in West Bengal have intensified. BJP leader Suvendu Adhikari declared that Bengal is next in line for change and outlined several prom-ises the party would fulfill if it came to power. However, Trinamool Congress (TMC) state secretary Kunal Ghosh firmly dismissed these claims, stating that the Delhi election results would have no impact on Bengal's political landscape. For the first time in 26 years, the BJP has secured power in Delhi, forming a government after its last victory on December 3, 1998. This development has led to speculation about its possible influence on the upcoming Bengal Assembly elections.

In the 2021 Bengal elec-tions, the BJP had set a target of winning over 200 seats but fell significantly short, securing only 77, while the TMC won over 200 seats and formed the government. Similarly, in the 2024 Lok Sabha elections, the BJP's seat count in Bengal declined, while the TMC increased its tally. Additionally, the TMC continued its winning streak in several byelections held after the gen-

Despite these results, Suvendu Adhikari remains confident about the BJP's chances in Bengal. Addressing a public gathering in Purba Medinipur, he stated, "AAP's defeat in Delhi signifies the defeat of TMC as well since they had supported AAP." He further asserted, "After Delhi, it is now Bengal's turn for a change." Adhikari also announced several promises, including an increase in widow and old-age pensions. He stated that under BJP rule, beneficiaries of the housing scheme would receive ₹3 lakh instead of ₹1.2 lakh. Reacting to these state-ments, Kunal Ghosh took to social media to strongly counter Adhikari's claims. Posting on X (formerly Twitter), he confidently predicted that the TMC would secure more than 250 seats in the 2026 Bengal elections.

India's Moral Obligation to Protect Persecuted Minorities from Bangladesh

MI News Service, Kolkata: The alarming persecution of minorities in Bang ladesh— Hindus, Sikhs, Buddhists, Jains, and Parsis—has escalated to an existential crisis. These communities face brutal violence, including killings, rapes, arson, and looting, at the hands of radical elements, highlighting the failure of Bangladeshi authorities to protect them. Given its historical role in offering refuge to persecuted groups from Myanmar, Sri Lanka, and Afghanistan, India must act decisively to extend humanitarian assistance to these vulnerable minorities. Advocate Nripendra Krishna Roy has filed a Public Interest Litigation (PIL) on behalf of Amnesty India, a human rights organization, urging the National Human Rights



Commission and the Indian government to intervene. Under the Universal Declaration of Human Rights (1948), India is morally and legally bound to provide asylum to those fleeing persecution. The country's ethos of Vasudhaiva Kutumbakam (the world is one family) demands immediate action. Failure to do so contradicts India's longstanding tradition of sheltering the oppressed and undermines

its regional leadership in human rights protection. The PIL requests the

Indian government to provide temporary refuge and humanitarian aid to these communities. If no action is taken, judicial intervention under Article 226 of the Indian Constitution may be sought. India must uphold its commitment to human rights and prevent the cultural and religious extinction of these persecuted minorities.

Kolkata Police STF recovers weapons, 3 arrested

MI News Service, Kolkata: Burrabazar, the bustling commercial hub of Kolkata, is always teeming with activity, with traders and buyers crowding its narrow lanes throughout the day. However, as the area fell silent on Friday night, the Special Task Force (STF) of Kolkata Police launched a major operation, uncovering a fresh stockpile of illegal firearms. The raid was conducted based on intelligence gathered from recent ar-

A few days ago, police apprehended several individuals near Surendranath College in Sealdah, recovering firearms from them. During interrogation, the arrested suspects revealed crucial details, prompting the authorities to extend their search to Burrabazar. Acting on this information, the STF carried out a latenight operation around 11 PM on Friday, leading to the seizure of more weapons.

The city has been on high alert following the re-covery of firearms in Sealdah. Concerns over security have intensified, particularly after a recent incident in which Kolkata Municipal Corporation (KMC) Councillor Sushanta Banerjee was shot at in broad daylight. The latest discovery of weapons in Burrabazar has once again raised questions about the safety of the city.

During the operation, police detained three individuals—Santosh Sahani, Jitendra Kumar, and Manoj Kumar-all residents of Uttar Pradesh. From them, officers recovered two firearms, 17 rounds of ammunition, and a vehicle. The exact purpose for which these weapons were being stored remains unclear.

Kalyani firecracker explosion: Nabanna asked DM to submit report

MI News Service, Kolkata: The West Bengal government has directed the District Magistrate to conduct an independent investigation and submit a report on the Kalyani firecracker explosion. This comes after Nabanna had already sought a report from the district police. In addition to the ongoing police probe, the state administration has now mandated a separate inquiry by the District Magistrate. Furthermore, the government has announced compensation of ₹2 lakh for the families of the de-

According to sources, four people lost their lives in the explosion that occurred at an illegal firecracker factory in Rath Tala, Kalyani, Nadia district. Following the incident, political leaders and administrative officials visited the site. Later in the night, the Special Task Force (STF) of the state police inspected the scene. The fire department confirmed that the factory was operating without proper authorization, making it completely illegal. The property owner has been detained for questioning, and security measures have been intensified, including the installation of CCTV cameras and a police picket at the site. Several injured victims were rushed to Kalyani JNM Hospital for treatment. Meanwhile, the factory owner, Khokon Biswas, has been ar-



rested. The explosion was so intense that it shook the entire area, causing the tin roof of the factory to be blown away and severely damaging nearby trees and properties. Local residents rushed to the scene to assist in rescue operations before police arrived within 30 minutes. The fire department faced challenges in reaching the site due to narrow roads, but firefighters managed to enter on foot and assist in the rescue operations. The police and fire department recovered the bodies from the debris. Later in the evening, Subrata Guha, the divisional fire officer of Nadia, inspected the site and confirmed that the factory lacked a valid license. He reiterated that it was an unauthorized firecracker manufacturing unit

operating in violation of safety regulations. Before the fire department's arrival, local residents had already begun efforts to douse the flames using water. Their quick response helped prevent further damage. Political figures, including West Bengal Pradesh Congress President Shub-hankar Sarkar and Ranaghat MP Jagannath Sarkar, also visited the site to assess the situation.

The tragic incident has once again raised concerns over the proliferation of illegal firecracker factories in West Bengal. Despite previous accidents, unauthorized units continue to operate, often without adequate safety measures. The state government's decision to conduct a dual investigation—by both the po-lice and the District Magistrate—suggests a serious approach to identifying lapses and taking correc-

Authorities have vowed strict action against illegal firecracker factories operating without licenses. The installation of CCTV cameras and the deployment of police personnel indicate heightened surveillance to prevent further incidents. With multiple investigations now underway, the government aims to hold those responsible accountable while ensuring that such tragedies do not recur in the future.

Over 9.8 lakh candidates to appear for Madhyamik

MI News Service, Kolkata: The Madhyamik 2025 examination is set to begin on Monday, February 10, and will continue until February 22. The West Bengal Board of Secondary Education (WBBSE) has announced that students will be allowed to enter exam centers from 9:30 AM on the first day. A total of 2,683 exam centers have been designated for this year's exams. According to WBBSE, a record 9,84,753 students have applied for the Madhyamik examination this year, an increase of 62,000 students compared to the previous year. Among them, 4,28,803 are male students, while 5,55,950 are female stu-

However, 136 schools failed to issue admit cards correctly, affecting 181 students. Some of these students had been performing consistently well, but due to errors by school authorities, they did not receive their admit cards on time. WBBSE has expressed strong discontent over the negligence shown by these schools, stating that corrective actions must be taken to prevent such incidents in the future. WBBSE has also implemented strict measures to enhance security and prevent question paper leaks. Officials warned that no electronic gadgets will be allowed inside the exam halls. If a student is found carrying any such device, their examination will be canceled. Last year, 45 students had their exams canceled for violating this rule. WBBSE has banned teachers from carrying any electronic gadgets during invigilation duty in the upcoming Madhyamik (Class 10 board) examination. The WBBSE recently released guidelines stating that invigilators must submit their mobile phones and other electronic gadgets to "their respective Centre Secretary/Venue Supervisor immediately on reporting to duty on examination days.' The restriction will be applicable on examination days from 9 am to 4 pm. A daily register will be made

to keep a record of the

gadgets submitted.

How weight loss could reduce chances of severe infections in diabetic people

new research, weight loss therapies may lower the risk of severe flu cases and other infections in patients suffering from diabetes.

The research will be presented at the annual meeting of the European Association for the Study of Diabetes (EASD) in Madrid. Spain September).

The study by Rhian Hopkins and Ethan de Villiers, of the University of Exeter Medical School, University of Exeter, Exeter, in the United Kingdom, there is evidence to support the link between severe illnesses and a higher BMI.

In contrast, there was no evidence that mild hyperglycamia contributes to the likelihood of a severe infection.

Hopkins says: "Up to one in three hospitalisations in people with diabetes are for infections and people with diabetes are twice as likely to be hospitalised with infections than the general population. They are also at high risk of readmission.

"Previous studies have found that a higher BMI and poor blood sugar control are associated with severe infections. However, these studies have been observational and so haven't been able to prove that the links are causal.

"If one or both of these factors can be shown to be causal, it may be possible to design interventions to lower the risk of severe infections in those at high risk, such as people with diabetes." The new study used data from the UK Biobank, which holds medical and genetic data on around 500,000 people in the UK, to explore the effect of higher BMI and poor blood sugar control on hospitalisation for bacterial and viral infections.

The 486,924 participants were classified into three groups: those with a record of hospitalisation for a bacterial infection, such as pneumonia or a urinary tract infection, (n=64,005) or a viral infection, such as flu, (n=14,562) and an infection-free control group (n=408,357).

A higher BMI was found to be associated with hospitalisation with infections. The likelihood of being hospitalised with a bacterial infection increased by 30 per cent per 5-point increase in BMI (for instance, an increase in BMI from 30 kg/m2 to 35 kg/m2). Similarly, every five-point increase in BMI was associated with a 32 per cent increase in the likelihood a severe viral infection.

Mild hyperglycaemia was also found to be associated with severe infections. The likelihood of being hospitalised with a bacterial infection increased by 32 per cent per 10mmol/mol increase in HbA1c, a measure of blood sugar levels. Similarly, every 10mmol/mol increase in

HbA1c was associated with a 29 per cent increase in the likelihood of a severe viral infection.

The team then used Mendelian randomisation, a technique that uses genetic information to establish whether a factor actually causes ill health, to determine if the relationships were causal.

This suggested that a higher BMI is one of the causes of severe bacterial and viral infec-

However, mild hypergly-caemia did not appear to be a cause of severe infections.

The study didn't focus on individuals with diabetes. However, given how vulnerable they are to infections, the results may be of particular rel-

She adds: "Infections are a major cause of death and ill health, particularly in people with diabetes. Anyone admitted to hospital with a severe infection is also at high risk of being admitted again with another. However, we currently have few effective ways to prevent this."

"This study demonstrates that higher BMI is a cause of hospital admission with infection. Clinicians could discuss weight loss options for people with a high BMI at risk of severe infections and readmission to hospital for infection."

"While this message may be particularly relevant to people with diabetes, it applies more widely, too."

Maths says Deutsche Bank research ANI NEW DELHI: Generative

AI, while gaining widespread attention, is not without its flaws. A recent report by Deutsche Bank Research highlighted that despite its strengths, the technology still struggles with certain tasks, particularly when it comes to mathematical calculations.

AI Good at some

tasks, but bad with

The report noted that though generative AI has proven useful in many areas, such as summarizing, translating, and even generating creative content on a wide range of topics, its limitations in reasoning, learning abstract concepts, and developing an under-standing of the world remain significant obsta-

"Generative AI is certainly flawed... while Generative AI is surprisingly good at some activities, it is surprisingly bad at others, such as making mathematical calculations" said the report.

As per the report one of the key issues is the tendency of generative AI systems to produce hallucinations, or inaccurate information, despite using reliable data. It noted that these systems can also introduce bias or irrelevance into their outputs, and existing solutions have not fully addressed these problems. This remains a challenge, even as AI models continue to evolve.

The report also pointed

out that much of the optimism surrounding AI's potential to boost productivity comes from controlled experiments. However, realworld applications show that the technology may not be as effective in every set-

ting.
For instance, highly reg-ulated industries like financial services and healthcare, where the stakes are especially high, have been slow to adopt generative AI despite the potential benefits of analyzing vast amounts of unstructured data.

The risks in these sectors--where errors could lead to serious consequences--make it harder for them to integrate AI into everyday use.

"The gap between high experimentation and low uptake is particularly striking in regulated industries such as financial services and healthcare" the report added.

In some cases, generative AI is showing potential in unexpected ways, such as generating novel research ideas, identifying irony, and even creating game engines that simulate real-world environments. However, as per report the generative AI tools will only get better from here. And indeed even if they never did, it would take years for companies and individuals to find and implement the best use cases of AI.

Study gives more insight into cardiovascular health in early pregnancy

Washington [US], September 8 (ANI): According to research, maintaining good cardiovascular health during the first trimester of pregnancy may mitigate genetic risk of developing preeclampsia and or gestational

The preliminary findings were presented at the American Heart Association's Hypertension Scientific Sessions 2024

Leading scientific interchange on new developments in basic and clinical research on hypertension and its connections to heart and kidney disease, stroke, obesity, and genetics will take place during the Chicago meeting, which takes place from September 5-8, Preeclampsia and gestational

hypertension are examples of hypertensive disorders of pregnancy that are a major cause of death for both expecting mothers and their unborn children. Based on a person's genetic background, a validated risk model known as a polygenic risk score can be used to estimate the likelihood that they will develop certain disorders. The American Heart Association's Life's Essential 8 (LE8) scoring system is used to determine cardiovascular health in early pregnancy, but it is unclear how much this score influences the risk.

"We were looking to see if there was an association between



cardiovascular health during early pregnancy and risk of developing a hypertensive disorder of pregnancy such as preeclampsia or gestational hypertension, even across genetic risk groups for these diseases," said study coau-thor Vineetha Mathew, a fourth year M.D.-candidate at Tufts University School of Medicine in Boston. "Our results found that across all genetic risk groups, better first trimester cardiovascular health may partially mitigate the risk of adverse pregnancy outcomes and the risk of developing hypertensive disorders of pregnancy." The study investigated whether cardiovascular health in the first trimester of pregnancy can offset a genetic risk for developing gestational hypertension and preeclampsia during pregnancy. The researchers analyzed data on more than 5,000 individuals who were pregnant for the first time to calculate the rates of these hypertensive disorders during pregnancy. For the analysis. researchers classified each individual's genetic risk using a previously validated polygenic risk score, which estimates susceptibility to a disease based on the

cular health scoring system caterizing first trimester health sta tus from favorable to unfavorable adapted Association's Life's Essential 8 and assigned to each woman. Seven out of eight of the LE8 components (diet, physical activity, sleep, nicotine exposure, diabetes, baseline blood pressure, and body mass index - not cholesterol levels) were incorporated into a cardiovascular health score for the entire cohort of pregnant individuals. Cholesterol was added for a sub-group (47%) for whom these values were measured. The analysis examined the association of cardiovascular health and genetic risk with preeclampsia and gestational hypertension and was adjusted for age, self-reported race and ethnicity, education level and marital status. "What was really interesting about our findings was how cardiovascular health in the first trimester appeared to be protective for all. We saw that the odds of developing a hypertensive disorder of pregnancy among those with a high genetic risk combined with favorable cardiovascular health was comparable or even better than those with low genetic risk but unfavorable cardiovascular health," Mathew said.

Her research colleagues have examined the incidence and death of melanoma for various age groups over time by analysing data from the Swedish Melanoma Registry. 

This is the first time we see this in Sweden, and we are actually the first European country to report a decline," said Hildur Helgadottir. In terms of mortality, the curves have also turned downwards for ages up to 59, but not for those over 60. Hildur Helgadottir believes that the decrease in mortality in the younger groups is due both to a reduction in the incidence of the

disease and to the introduction of new oncological drugs that have improved the prognosis for the disease. She believes that the fact that mortality is not decreasing in the elderly is because the incidence of the disease is still so high in this group. "The question is why the risk of melanoma has decreased. "We have not directly analyzed the causes in our study. but we have hypotheses about factors that we believe have interacted," said Hildur Helgadottir.

"There are four main factors, she said. The first is increased awareness of sun protection.

"The first national 'Sun Safe' campaign in the 1990s specifically highlighted the importance of protecting children. About 20



vears later, we believe that this has led to a reduction in the incidence of the disease in younger adults." said Hildur Helgadottir.

Another factor is that access to sunbeds has decreased drastically. Since 2018, there has been an 18-year age limit on sunbeds, but the number of public sunbeds decreased much earlier.

Third, mobile phones and computers mean that children and young people are spending more time indoors and are not exposed to sunlight in the same way today. Finally, immigration means that there are more individuals in Sweden with darker pigmentation who can tolerate the sun better. "We see that it is necessary to continue the work of



ODISHA'S ALL 314 BLOCKS TO OWN SPORTS STADI-UMS IN 5 YEARS

The Odisha government has approved a new project for the construction of stadiums in all 314 blocks of the state over a period of five years. The Cabinet has approved an outlay of Rs 4124 crore for the

SAM KONSTAS AIMS TO BECOME ALL-FORMAT PLAYER, RECALLS IMPERSONATING ENGLISH ICONS

NEW DELHI [INDIA] : Australia's young prodigy Sam Konstas has set a long-term goal of becoming an allformat player after being overlooked for two Tests against Sri Lanka in the sub-continent.

Konstas, 19, is still new to the challenges, success and hardships that a player goes through in international cricket. The young opener earned his maiden baggy green in front of a sold-out crowd at the MCG in the Boxing Day Test against India.

With a swashbuckling 60(65) in the first innings, Konstas made a strong case for himself to become

the next big thing in the future. After taking his first step in the international circuit, Konstas isn't looking to limit himself to the redball format. He wants to explore white-ball cricket and emerge as an

an all-format player one day. Travis Head is a legend of the game, just the way he goes about it is pretty simple, and he takes on the bowlers. I'm very lucky at my age to learn from these guys, and hopefully, I can build on that," Konstas said as quoted from The Sydney Morning Herald.

In his first Test appearance for Australia, Konstas caught the world by surprise with a touch of unorthodox in his stroke play. The world of cricket came to a pause when Konstas flawlessly executed a perfect ramp shot to smoke the ball past the boundary line off Jasprit

The 31-year-old pace spearhead needed a moment to realise that he had conceded the first six in the Test format after more than 4,000 days.

Konstas continued to exhibit a wide array of shots from his arsenal during the final Test in Sydney,



which was enough to convince the selectors to send him to Sri Lanka. However, after considering and

taking all factors into account, Travis Head was promoted from middle to top. The decision worked wonders,

with Australia celebrating an emphatic win by an innings and 242 runs in the series opener.

Konstas was sent home before the second Test, but the opportunity to watch and work with the likes of Head and Steve Smith gave him much-needed inputs to improve his

"I don't think I'm that good at my sweeps or reverse [sweeps], but that's something to work on when I'm back in Sydney. Uzzy and Marnus are the best at it, and then you see how Steve and Travis approach it differently. So understanding your strengths and trying to stick to it as

long as possible." he said. It is yet to be seen if Konstas will be in talks for Australia's World Test Championship (WTC) final against South Africa on June 11 at the iconic
