Collective efforts imperative to establish global framework for AI: Modi

MI News Service, New Delhi/Paris: Prime Minister Narendra Modi on Tuesday made a strong case for collective efforts to establish a global framework for artificial intelligence (AI) based on open source which enhances trust, transparency and is free from biases

Co-chairing the AI Action Summit along with French President Emmanuel Macron here, Modi said that AI is changing the polity, economy, security and society, and is writing the code for humanity in this century. "There is a need for collective global efforts to establish governance and standards that uphold our shared values, address risks and build trust," Modi said, adding that governance is not just about managing risks and rivalries but is also about promoting innovations and deploying them for global good. "We must democratise technology and create people-centric applications. We must address concerns related to cyber security, disinformation and deep fakes," the

prime minister said. Stressing on the need to develop quality data sets free from biases, the prime minister said there is a need to develop open-source AI ecosystems that enhance trust and transparency.

He said the technology should be rooted in the local ecosystem for it to be effective and useful.

Modi started his address with an observation on the potential of AI by stating that AI can cut through jargon and summarise medical prescriptions in a language that can be understood easily. At the same time, he added that one also needs to understand the limitations and biases of AI. "We must think deeply and discuss openly about innovations and governance. Governance is also about ensuring access to all, especially in the global south. It is where the capabilities are more lacking, be it compute, power, talent, data or the financial resources," Modi said.

IED blast in J&K kills 2 army personnel including officer

MI News Service, Srinagar: Two Army personnel, including a captain, were killed and another was injured when an improvised explosive device (IED), believed to have been planted by terrorists, exploded near the Line of Control (LoC) in the Akhnoor sector near here on Tuesday, officials said.

The Army confirmed the fatalities in the blast and said "own troops are dominating the area and search operations are underway". The officials said the troops were on patrolling duty when they were hit by the powerful explosion near a forward post in the Bhattal area at around 3:50 pm. The injured personnel were rushed to a hospital where

two of them, including a

captain, succumbed to their injuries, they said, adding that the condition of the other injured soldier is "out of danger".

Jammu-based The White Knight Corps unit of the Army saluted the supreme sacrifice of the two soldiers.

"Suspected Improvised Explosive Device blast reported in #Laleali in Akhnoor Sector during a fence patrol resulting in two fatalities. Own troops are dominating the area and search operations are underway.

"White Knight Corps salutes and pays tribute to the supreme sacrifice of two gallant soldiers," it said in a post on X.

The entire area was cordoned off after the explosion, the officials said.

MI News Service, Washington: US President Donald Trump signed an executive order directing the Department of Justice to pause enforcing a nearly half-century-old law that was used to launch a bribery investigation against the

Adani Group. Trump signed an order to pause enforcing of the 1977 Foreign Corrupt Practices Act (FCPA) that prohibits American companies and foreign firms from bribing officials of foreign governments to obtain or retain business.

The President directed US Attorney General Pam Bondi to pause enforcement of FCPA, which was at the heart of some of the US Department of Justice's most high-profile cases, including an indictment against Indian billionaire and Adani Group head Gautam Adani and his nephew Sagar. Last year DoJ under President Joe Biden charged Adani for allegedly being part of a scheme to pay over USD 250 million (about Rs 2,100 crore) bribe to Indian officials in exchange



of favourable terms for solar power contracts.

This was concealed from the US banks and investors from whom the Adani group raised billions of dollars for the project, the prosecutors had alleged last year citing FCPA that allows pursuing foreign corruption allegations if they involve certain links to American investors or markets. The pause and the review is being seen as a relief to the Adani Group but it remains to be seen what stand the DoJ takes after the six month review period.

The order that Trump

signed asked "the Attorney General to review guidelines and policies governing investigations and enforcement actions under the FCPA" in 180 days.

'During the review period, the Attorney General shall cease initiation of any new FCPA investigations or enforcement actions, unless the Attorney General determines that an individual exception should be made," it said.

Also it sought "review in detail all existing FCPA investigations or enforcement actions and take appropriate action with respect to such matters to

restore proper bounds on FCPA enforcement and preserve Presidential foreign policy prerogatives".

FCPA investigations and enforcement actions initiated or continued after the revised guidelines or policies are issued "shall be governed by such guidelines or policies; and must be specifically authorized by the Attorney General"

After the revised guidelines or policies are issued. the Attorney General shall determine whether additional actions, including remedial measures with respect to inappropriate past FCPA investigations and enforcement actions, are warranted and shall take any such appropriate actions or, if Presidential action is required, recommend such actions to the President, it added.

Last year, the DoJ had charged a former executive at renewable energy firm Azure, which was at the heart of a case accusing Adani of perpetrating a bribery scheme. The DoJ also brought a criminal indictment.

Cybercrime: Govt envisages using AI to track 'mule' accounts

MI News Service, New **Delhi:** The government is planning to use Artificial Intelligence to identify 'mule' accounts where cyber fraudsters park swindled funds, Union Home Minister Amit Shah has said.

Chairing a meeting of the Parliamentary Consultative Committee for the Ministry of Home Affairs on the topic of 'Cyber Security and Cyber Crime' on Monday, Shah also said that for national security reasons, 805 apps and 3,266 website links have been blocked based on the recommendations of the Indian Cybercrime Coordination Centre (I4C), the government's cybercrime monitoring and detection

Additionally, he said, 399 banks and financial intermediaries have come on board, over six lakh suspicious data points have been shared, more than 19 lakh mule accounts have been caught, and suspicious transactions worth Rs 2,038 crore have been prevented.

Shah said efforts are underway to use Artificial Intelligence (AI) for identifying mule accounts, in coordination with Reserve Bank of India (RBI) and all banks to establish a system for their detection, an official statement said.

The home minister said the government will ensure the closure of mule accounts before they even become operational.

A mule account is a bank account used by criminals to move stolen money. He said a total of 1,43,000 FIRs have been registered on the I4C portal which has been used by more than 19 crore people.

MI News Service, Birbhum: A huge quantity of explosives was recovered from a truck in the Rampurhat area of West Bengal's Birbhum district on Tuesday morning. Police apprehended the vehicle and discovered 16,000 kilograms of ammonium nitrate, a highly explosive substance. According to officials, the truck was carrying 320 sacks, each containing 50 kilograms of ammonium nitrate.

Three individuals, including the driver and his assistant, have been detained and taken to Rampurhat Police Station for questioning. Police sources revealed that the driver failed to produce valid documents justifying the transport of such a large quantity of explosives. Additionally, inconsistencies were found in his statements during initial questioning.

According to reports, the truck originated from Sangareddy in Telangana and was headed toward Deoghar in Jharkhand. Authorities suspect the explosives

may have been intended for illegal or insurgent activities and have launched an investigation. This is not the first such seizure in the region. Last month, police recovered 20,000 detonators and 15,000 gelatin sticks from an abandoned house in Rampurhat's forested area. Illegal explosives are frequently found in Birbhum, where stone quarries often use them for blasting. In a major operation on June 30, 2022, authorities seized 81,000 detonators, 27 kg of ammonium nitrate, and 1,925 kg of gelatin sticks in Muhammadbazar, Birbhum. The Special Task Force (STF) of the state police carried out the

Following the National Investigation Agency's (NIA) takeover of the case on September 29, 2022, multiple arrests were made, including several influential Trinamool Congress leaders and local businessmen involved in the illegal trade of explosives.

MI News Service, New **Delhi:** As India's One Day International (ODI) series against England continues on home soil, a related discussion found its way into Parliament. Trinamool Congress (TMC) MP Mohammad Nadimul Haque raised a significant issue regarding cricket commentary, emphasizing the need for its improvement.

During the Rajya Sabha's Question Hour, Haque stressed the importance of continuing cricket commentary on All India Radio (AIR), a medium that has long connected millions of cricket enthusiasts across the country. His statement received appreciation, including from Vice President and Rajya Sabha Chairman Jagdeep Dhankhar, who acknowledged the relevance of the issue.

Speaking in the Rajya Sabha, Haque urged that cricket commentary

straints have reportedly hindered this effort. He contested this reasoning, arguing that AIR has a massive reach, with millions of listeners tuning in regularly. "We must utilize this platform effectively," he asserted.

He also raised concerns over BCCI's decision not to grant broadcasting rights to AIR, questioning why India's national broadcaster is being sidelined despite its historical contribution to cricket cover-

Haque highlighted a growing concern—the declining quality of cricket commentary on AIR. He lamented that radio, which once produced legendary cricket commentators, is losing its significance in sports broadcasting. To support his point, he named iconic commentators like Sushil Doshi, Sunil Gupta, Vineet, and Prakash Wankar, who all emerged from radio commentary.

He argued that allowing AIR to continue cricket broadcasts at a high standard would help preserve its legacy and promote the growth of sports journalism in

In his speech, Haque suggested measures to improve the quality of AIR's cricket coverage, proposing the development of world-class sports programming. He pointed to the successful models of BBC (UK) and ABC (Australia) as examples India could follow.

"All India Radio reaches 98% of India's population through its 591 stations. As the national broadcaster, it should not be neglected Instead, we should use it effectively to connect with a broader audience," Haque said.

LPG cooking made mandatory in Anganwadi Centres, announces Shashi Panja

MI News Service, Kolkata: The West Bengal government has made the use of LPG gas mandatory for cooking in all Anganwadi centres across the state. This decision comes in the wake of a tragic accident that occurred recently. On Tuesday, Women and Child Welfare Minister Shashi Panja announced that the entire LPG connection process will be completed across all Anganwadi centres within the upcoming financial year.

The decision follows a devastating fire accident that took place on February 7 at an Ancentre in the Balurghat Rural area. A 55year-old worker, who had been employed at the centre for 18 years, was cooking using a wood-fired stove when her clothes accidentally caught

The flames spread rapidly, leaving her severely burnt. A farmer working nearby noticed the incident and rushed to help, but the injuries were too severe. Apart from her face, most of her body sustained critical burns. She was immediately taken to Khaspur Hospital and later transferred to Balurghat District Hospital due to the severity of her condition. Despite the doctors'

best efforts, she succumbed to her injuries between 7:00 and

7:30 PM on the same day. This tragic first-of-its-kind accident in an Anganwadi centre has deeply shocked both the administration and the public. The district authorities have expressed their condolences and announced a compensation of 2 lakh for the

deceased worker's family. During the state assembly session on Tuesday, Minister Sashi Panja stated that West Bengal currently has 81,321 Anganwadi centres. The implementation of LPG connections across all these centres is estimated to cost 37.81 crore.

The government has now made it mandatory for all Anganwadi centres to shift to LPG cooking, eliminating the use of traditional wood-fired stoves. This initiative aims to prevent similar fire hazards and ensure a safer cooking environment for workers and children in Anganwadi cen-

Authorities believe that this safety measure will significantly reduce the risk of accidental fires while also improving hygiene and efficiency in food preparation.

Speaker holds hearing on Manik Bhattacharya's salary request

MI News Service, Kolkata: West Bengal Assembly Speaker Biman Banerjee conducted a hearing on whether former TET Board President and Palashipara MLA Manik Bhattacharya is entitled to receive his salary for the period he was in jail. Bhattacharya, who was incarcerated from October 11, 2022, to September 12, 2024, had applied for his legislative salary for the 23 months he spent in prison. However, this request led to a debate within the Assembly, prompting the Speaker to seek legal advice before

making a decision. According to sources, Speaker Banerjee consulted West Bengal's Advocate General (AG) regarding the legal aspects of Bhattacharya's claim. The AG reportedly advised that Bhattacharya is not eligible to receive salary for his jail term. This opinion was based on legal precedents and legislative rules governing MLA remuneration.

The hearing lasted for over an hour, during which Bhattacharva's representatives argued in favor of his claim, citing procedural grounds.

NRS Med College bans free Wi-Fi for on-duty staff

BSF rescues injured Bangladeshi miscreant after attack in Dakshin Dinajpur

MI News Service, Dakshin Dinajpur: The Border Security Force (BSF) rescued and provided medical aid to a critically injured Bangladeshi miscreant who had attacked border personnel near the India-Bangladesh border in West Bengal's Dakshin Dinajpur district. The incident oc-curred on February 7, when a group of Bangladeshi intruders launched an attack on BSF jawans. During the confrontation, a BSF personnel sustained injuries, while one of the attackers, Md Alauddin, a 22-year-old resident of Thakurgaon, Bangladesh, was critically wounded. Following the attack in Malikpur village, the BSF acted swiftly to provide emergency medical assistance to the injured Alauddin. He was immediately taken to Gangarampur Government

Hospital for treatment. Despite being an at-tacker, the BSF troops ensured that he received proper medical attention and did not succumb to his injuries. Hospital sources confirmed that Alauddin responded positively to treatment and remained

under medical supervision until he was stable. After receiving medical care, Alauddin was handed over to the Gangarampur police station, where legal proceedings were initiated against him. Authorities are currently investigating his role in the attack, along with the identity of his accomplices.

In response to the cross-border intrusion, the BSF contacted the Border Guard Bangladesh (BGB) and informed them about the incident. The BGB has been instructed to take necessary action to prevent their nationals from illegally entering Indian Territory and engaging in criminal activities.

This clash at the international border once again highlights security challenges faced by Indian border forces in preventing unauthorized cross-border movement and illegal activities. While India remains committed to border security, it also upholds its humanitarian values, as demonstrated by the BSF's decision to ensure medical assistance for the injured miscreant before handing him over for legal action.

Mahakumbh: Multiple road accidents kill devotees



MI News Service, Prayagraj/Kolkata/Bhopal: Multiple road accidents killed many Mahakumbh devotees. Three devotees on their way to attend the Maha Kumbh died after being hit by a vehicle near Nagnathpur National Highway here on Tuesday, police said. Utraon SHO Pankaj Kumar Tripathi said Jagori Mahato (45), Kunti Mahato (70) and Alpana Mahato (47) among other devotees were travelling in a bus. The bus stopped at a nearby petrol pump on Nagnathpur National Highway at 5.30 am. While some passengers went to the fields to defecate, the three women went near the road divider and in the meantime a speeding unknown vehicle hit the women, he said.

Hearing relaxing words in sleep slows your heart down: Research

the GIGA - Centre of Research Cyclotron at the University of Liege discovered that the body reacts to the external world when sleeping, which explains how sensory input

might alter sleep quality.

Researchers at ULiege have collaborated with the University of Fribourg in Switzerland to investigate whether the body is truly disconnected from the external world during sleep. To do so, they focused on how heartbeat changes when we hear different words during sleep. They found that relaxing words slowed down cardiac activity as a reflection of deeper sleep and in comparison to neutral words that did not have such a slowing effect. This discovery is presented in Journal of Sleep Research and sheds new light on brain-heart interactions

Matthieu Koroma (Fund for Scientific Research - FNRS postdoctoral researcher), Christina Schmidt and Athena Demertzi (both Fund for Scientific Research - FNRS Research Associate) from the GIGA Cyclotron Research Center at ULiege teamed up with colleagues from University of Fribourg to lead a previous study analysing brain data (electroencephalogram) showing that relaxing words increased deep sleep duration and sleep



influence sleep using meaningful words. By that time, the authors hypothesized that the brain also remains able to interpret sensory information in a way that makes our body more relaxed after hearing relaxing words during sleep. In this new study, the authors had the opportunity to analyze carhypothesis and found that the heart slows down its activity only after the presentation of relaxing, but not control words.

Markers of both cardiac and brain activity were then compared to disentangle how much they contributed to the modulation of sleep by auditory information. Cardiac activity has been indeed proposed to direct-

world, but such evidence was so far obtained in wakefulness. With these results, the ULiege researchers showed that it was also true in sleep, offering a new perspective on the essential role of bodily reactions beyond brain data for our understanding of

sleep.
"Most of sleep research focuses on the brain and rarely investigates bodily activi-

"We nevertheless hypothesize that the brain and the body are connected even when we cannot fully communicate, including sleep. Both brain and body information need then to be taken into account for a full understanding of how we think and react to our environment", explains Dr. Demertzi.

"We shared freely our methodology fol-lowing the principles of Open Science hoping that the tools that helped to make this discovery will inspire other researchers to study the role played by the heart in other sleep functions", Dr.Koroma advocates.

This work offers a more comprehensive approach about the modulation of sleep functions by sensory information. By looking into the cardiac responses to sounds, we may, for example, study in the future the role of the body in the way sounds influence emotional processing of

Gene therapy improves advanced heart failure in animal model: Study



LOS ANGELES [US] : During a heart attack, blood stops flowing into the heart. Without oxygen, a portion of the heart muscle dies.

The heart muscle does not regenerate, instead, it replaces dead tissue with a scar made of cells called fibroblasts that do not help the heart pump. If there is too much scarring, the heart gradually enlarges (dilates), weakens, and eventually ceases working.

The current thought is that advanced or chronic heart failure, a stage in which the cardiac muscle has become too weak, is a point of no return. The present understanding is that it is not possible to stimulate a heart in this condition to generate new heart cells to repair itself and that only palliative treatment is available to patients," said corresponding author Dr Tamer M. A. Mohamed, associate professor of surgery and medicine and director of cardiac regeneration at Baylor College of

"In this study published in the journal Cardiovascular Research, we show that advanced heart failure can be treated to improve cardiac function in an animal model.

In a previous study, Mohamed and his collaborators had successfully used gene therapy to improve acute cardiac dysfunction in animals. Their method effectively and specifically delivered genes that promote proliferation to heart cells, generating new heart muscle. This approach not only strengthened the heart improving its ability to keep the blood flowing, but also prevented typical subsequent congestion in the liver, kidneys and lungs in rats

and pigs.

"In this study, we did something that had not been done before," Mohamed said. "We intervened with the same gene therapy but not during acute heart failure or early in the disease as in our previous experiments, but late in the disease during the chronic phase four weeks after cardiac injury had severely damaged the heart.

Four months after treating the animals, the researchers checked cardiac function and heart structure. "We were surprised to see evidence of significant heart cell proliferation, a marked reduction in scar size and a significant improvement in cardiac function," said first author Dr Riham R E Abouleisa, assistant professor of surgery-cardiothoracic surgery at

Baylor.
"Although heart dilation and lung congestion associated with chronic heart failure were not improved, the treatment partially improved liver and kidney functionality." The findings showed for the first time that contrary to expectations, it is possible to induce heart cell proliferation during advanced states of heart failure and improve heart function, with some beneficial effects on the liver and kidneys' func-

tions "Our work has important implications for the large group of patients with advanced heart failure for whom there are currently no treatments to improve their condition," Mohamed said. "This approach offers the possibility of developing future new therapies for this deadly disease."

Study finds how pesticide exposure linked with stillbirth risk

ARIZONA [US]: New research suggested that living less than 0.3 miles from a pesticide use area before getting pregnant and throughout the first trimester of pregnancy may increase the risk of stillbirths.

Research by Mel and Enid Zuckerman College of Public Health and Southwest Environmental Health Sciences Centre. Certain pesticides, particularly the class of organophosphates, were linked to stillbirth throughout the first trimester of pregnancy and a 90-day preconception window, according to research findings.

The study "Pesticide Exposure During the First Trimester and Its Associations With Stillbirth" was released in the American Journal of Epidemiology.

"In this study, some specific ingredients stood out due to their significant associations with stillbirth risk," said first author Melissa Furlong, PhD, who studies the chronic health effects of environmental contaminants as an assistant professor and environmental epidemiologist at the Zuckerman College of Public Health and a member of the Southwest Environmental Health Sciences Center at the R. Ken Coit College of Pharmacy. "These findings underscore the importance of considering individual pesticides rather than just the overall pesticide class, as specific chemical compounds may pose unique risks. It also highlights the potential for pre-pregnancy exposures to affect reproductive outcomes.

To conduct the study, researchers linked Arizona pesticide use records for 27 different pesticides with state birth certificate data that included 1,237,750 births and 2,290



stillbirths from 2006 to 2020. They found that living within .31 miles (500 meters) of specific pyrethroid, organophosphate or carbamate pesticide applications during a 90-day pre-conception window or the first trimester was associated with an increased risk of stillbirth. Specifically, the pesticides cyfluthrin, zeta-cypermethrin, organophosphates as a class, malathion, carbaryl and propamocarb hydrochloride were linked to increased stillborn births pre-conception. During the first trimester, fenpropathrin, permethrin, organophosphates as a class,

acephate and formetanate hydrochloride were associated with stillbirths. "Among organophosphates, acephate showed the strongest effect estimates on stillbirth, so that exposure to acephate in the first trimester was associated with a doubling of risk," said co-author Paloma Beamer, PhD, a professor and interim associate dean at the Zuckerman College of Public Health and a member of the Southwest Environmental Health Sciences Center, U of A Health Sciences Asthma and Airway Disease Research Center and BIO5 Institute. "Within the pyrethroid class, cyfluthrin exposure during the 90 days prior to conception almost doubled the risk of stillbirth."

Pesticides are chemical substances used to control pests in various settings. They are commonly categorized into different classes, such as organophosphates, pyrethroids and carbamates. The primary route of exposure for most people is through diet, but household use. agricultural drift and occupational exposure are also significant pathways.

Researchers say while some pesticides may not have been directly implicated in this study, they could still pose risks to maternal and fetal health. Pregnant women may be particularly vulnerable to the

adverse effects of pesticide exposure due to physiological changes during pregnancy, such as increased metabolic rate, altered hormone levels and changes in the immune system. The developing fetus may be more susceptible to the toxic effects of pesticides during this period of rapid growth and development.

sexual health in males treated with prostate cancer: Study

WASHINGTON DC [US] : According to a new study, a diet low in meat and dairy but high in fruits, vegetables, grains, and nuts is associated with lower rates of erectile dysfunction, urinary incontinence, and other frequent side effects in prostate cancer patients.

Led by researchers at NYU Grossman School of Medicine and Harvard T.H. Chan School of Public Health, the analysis of more than 3,500 men with prostate cancer explored whether eating a more plant-based diet was associated with quality-of-life issues that often arise after treatment. Sorting patients into five groups (quintiles) based on the proportion of plant versus animal foods the men said they eat, the authors found that the quintile that consumed the most plants scored 8% to 11% better in measures of sexual function compared with the group that consumed the

Similarly, the results revealed up to 14% better scores for urinary health, with fewer instances of incontinence, obstruction, and irritation. The authors further found up to 13% better scores in hormonal health (which assesses symptoms like low energy, depression, and hot flashes) among the highest quintile of plant-based diet compared with the lowest.

"Our findings offer hope for those looking for ways to improve their quality of life after undergoing surgery, radiation, and other common therapies for prostate cancer, which can cause significant side effects," said study lead author and urologist Stacy Loeb, MD. "Adding more fruits and vegetables to their diet, while reducing meat and dairy, is a simple step that patients can take, added Loeb, a professor in the Departments of Urology and Population Health at NYU Langone Health.

Prostate cancer is among the most common and deadliest forms of cancer among American men,

according to the U.S. Centers for Disease Control and Prevention. Previous research by the same team had already found that eating a plant-based diet may reduce the risk of developing the disease in the first place. Other investigations have connected this diet to a lower risk of sexual dysfunction in general but not specifically for those with prostate cancer, who are at particularly high risk for such issues.

The new study, publishing online Feb. 13 in the journal

every two years, assessed frequency of incontinence, difficulties maintaining an erection, and problems with bowels, energy, and mood, among many other health concerns. Most of the patients (more than 83%) had received prostate cancer treatment, Loeb notes, and all included in the current study had early forms of the disease that had not yet spread to other organs. She adds that when searching for potential connections between plant-based diet and health, the



Cancer, is also believed to be the first of its kind to show better urinary health in these patients based on nutrition, says Loeb.

For the research, the team analyzed data from the Health Professionals Follow-Up Study, an ongoing investigation begun in 1986 and sponsored by Harvard Chan School. The data set is composed of information on more than 50,000 male dentists, pharmacists, optometrists, osteopaths, podiatrists, and veterinarians. The project was designed to better understand how nutrition influences risks related to cancer, heart disease, and other serious

As part of the project, men with prostate cancer answered a questionnaire every four years about the kinds of foods they ate and in what proportions. Another survey, which was administered research team took into account weight, physical activity, and many other factors that could affect quality of life.

Among the findings, the researchers say, eating high amounts of any plant-based food was linked to better sexual health, urinary health, and vitality scores, regardless of demographic factors, lifestyle differences, or history of other medical issues such as diabetes. Eating more healthy plant-based food was also associated with better bowel function, which, Loeb says, may be explained by the dietary fiber found in plants.

"These results add to the long list of health and environmental benefits of eating more plants and fewer animal products," said Loeb. "They also clearly challenge the historical misconception that eating meat boosts sexual func-

\oplus Plant-based diet linked to better $\,$ Study reveals new ways to find accurate \oplus method for cervical cancer screening

TOKYO, JAPAN: About 500,000 new cases of cervical cancer are detected annually, making it a very common type of cancer. The startling fact is that there are 20 times more people with cervical intraepithelial neoplasia (CIN), another name for precursor lesions in the cervix.

Early detection of cervical cancer can have a significant impact on a patient's prognosis regarding treatment outcomes, as it can with many other potentially fatal illnesses. Consequently, it is critical to design screening techniques for cervical cancer and CIN that are simple, convenient, and effective.

At present, the most popular methods of screening for these disorders are the cytology examination and the human papillo-mavirus (HPV) test. Although cytology is widely used as a screening technique in many nations, its sensitivity for identifying CIN is very poor. However, although HPV infections may not necessarily result in cervical lesions, HPV tests have poor specificity despite their high sensitivity. It is even more important to develop better diagnostic techniques in light of these shortcomings.

Against this backdrop, a

research team led by Professor Takuma Fujii from Fujita Health



University, Japan, aimed to identify biomarkers that could assist in the early detection of cervical cancer. In their latest paper published in Cancer Science, they report on a series of compounds that show abnormal expression in serum and cervical mucus samples of cervical cancer patients. These findings could potentially revolutionize disease prevention strategies. Interestingly, the use of cervical mucus samples as part of a potential diagnostic tool was not initially planned. "We wanted to investigate how changes in local immunity are related to cervical cancer, and so, we aimed to study all the currently known microRNAs (miRNAs) associated

with the development and progression of cervical tumors," explains Fujii. Adding further, Fujii says, "Initially, we focused on developing a serum-based diagnostic method for clinical use. However, we realized it would be better to first verify if molecular expression levels in the local tissue correlated with serum, assessing the feasibility of a serum diag-nostic method." To achieve these goals, the research team compared the miRNA and cytokine profiles from serum and mucus samples. These were collected from patients with cervical cancer or CIN who underwent routine gynecological examinations at Fujita Health University Hospital, over approximately eight years. Through initial screening, the researchers identified three candidate miRNAs and five candidate cytokines in serum, and five candidate miRNAs and seven candidate cytokines in mucus

With the help of miRNA realtime PCR tests and cytokine immunoassay experiments on a larger sample size, the team verified the abnormal expression of these biomarkers on patients with cervical cancer at different stages of the disease. They subsequently evaluated the diagnostic potential of these compounds. Surprisingly, while miRNAs and cytokines in serum showed limited diagnostic accuracy, a specific combination of miRNAs and cytokines in mucus samples proved much more promising. This suggests that focusing on changes in local expression levels, rather than serum levels. may offer a superior diagnostic strategy. "Our study, for the first time, demonstrates that analyzing mucus samples can distinguish cervical tumors from normal tissues more accurately than serum samples. Using such a method as an additional option to traditional screening techniques could help discover cancer and precancerous conditions at an earlier stage, remarked Fujii.

Heart transplant amid Delhi downpour: Fortis Gurugram saves Rohtak man's life with Kolkata donor heart

surrounding National Capital Region were grappling with intense rains and sudden showers on July 31, a team of doctors at Fortis Gurugram successfully transplanted the heart of a 54-year-old brain-dead woman from Kolkata into a 34-year-old man from Rohtak, Haryana, who was suffering from dilated cardiomyopathy. The donor heart was received from a government hospital in Kolkata, where the 54-year-old road accident victim was admitted and later declared brain-dead.

After receiving approval from the National Organ & Tissue Transplant Organisation (NOTTO), the team of doctors from Fortis Hospital Gurugram went to Kolkata to retrieve the heart. For swift transportation of the



organ, Kolkata Police created a green corridor, and the heart was brought to NetajiSubhash Chandra Bose International Airport in Kolkata.

The heart was flown to Indira Gandhi International Airport, Delhi, and was smoothly transported from the airport via VIP exit. The

Delhi and Gurugram Police seamlessly coordinated to create a green corridor, enabling the organ to traverse the 18 km distance from IGI Airport to Fortis Hospital, Gurugram, in just 13 minutes despite heavy traffic congestion and sudden downpours. The entire process was managed in around 4 hours with the help and support of around 100 police officers. The heart was successfully transplanted by a team of doctors led by cardiothoracic vascular surgeon Dr. UdgeathDhir. Post-transplant, the patient is stable and under constant observation in the cardiac ICU. The 34-year-old recipient was brought to Fortis Gurugram in a critical state, with only 10-15 per cent of his heart functioning, and was registered on the NOTTO list for a heart transplant.

Hell will break out if hostages not released by Saturday, **Trump warns Hamas**

MI News Service, Washington DC: United States President Donald Trump said on Monday that Israel should end the ceasefire in Gaza and resume military action if all hostages are not released by the end of the week, Times Of Israel reported.This came after Hamas announced a delay in releasing hostages scheduled for Saturday. Speaking with the reporters, Trump said that Israel might choose to dis-regard his ultimatum and the Saturday noon deadline, adding that he might speak to Prime Minister Benjamin Netanyahu. "As far as I am concerned, if all of the hostages aren't returned by Saturday at 12 o'clock, I think it's an appropriate time. I would say, cancel it and all bets are off and let hell break out. I'd say they ought to be returned by 12 o'clock on Saturday," Trump said.Trump's comments came hours after Hamas announced that it intended to delay the next release of Israeli hostages planned for Saturday, "until further notice," in response to what it claimed were Israeli violations of the ongoing hostage-ceasefire deal, Times of Israel reported.

In a post on X published before Trump spoke, Abu Obeida, spokesman for Hamas' Obeida, armed wing Qassam Brigades, said that the handover of the hostages "who were scheduled to be released next Saturday ...

Trump to host Jordan's King Abdullah II amid push for Gaza resettlement plan

MI News Service, Washington: President Donald Trump will host Jordan's King Abdullah II at the White House on Tuesday as he escalates pressure on the Arab nation to take in refugees from Gaza — perhaps permanently — as part of his auda-cious plan to remake the Middle

The visit is happening at a perilous moment for the ongoing ceasefire in Gaza as Hamas, accusing Israel of violating the truce, has said it is pausing future releases of hostages and as Trump has called for Israel to resume fighting if all those remaining in captivity are not freed by this weekend.

Trump has proposed the US take control of Gaza and turn it into "the Riviera of the Middle East," with Palestinians in the war-torn territory pushed into neighbouring nations with no right of return.

He suggested on Monday that, if necessary, he would withhold US funding from Jordan and Egypt, longtime US allies and among the top recipients of its foreign aid, as a means of persuading them to accept additional Palestinians from Gaza.

"Yeah, maybe. Sure, why not?" Trump told reporters. "If they don't, I would conceivably withhold aid, yes." Jordan is home to more than 2 million Palestinians and, along with other Arab states, has flatly rejected Trump's plan to relocate civilians from Gaza. Jordan's foreign minister, Ayman Safadi, said last week that his country's opposition to Trump's idea was "firm and unwa-

In addition to concerns about jeopardizing the long-held goals of a two-state solution to the Israel-Palestinian conflict, Egypt and Jordan have privately raised security concerns about welcoming large numbers of additional refugees into their countries even temporarily. When asked how he'd persuade Abdullah to take in Palestinians, Trump told reporters, "I do think he'll take, and I think other countries will take also. They have good hearts." The king is also meeting with top Trump administration officials during his visit, including Secretary of State Marco Rubio, national security adviser Mike Waltz, Middle East envoy Steve Witkoff and Defense Secretary

Pete Hegseth. He is the third foreign leader to hold an in-person meeting with Trump since his Jan. 20 inau-

Trump announced his ideas for resettling Palestinians from Gaza and taking ownership of the territory for the US during a press conference last week with Israeli Prime Minister Benjamin Netanyahu.

Trump initially didn't rule out deploying US troops to help secure Gaza but at the same time insisted no US funds would go to pay for the reconstruction of the territory, raising fundamental questions about the nature of his plan. After Trump's initial comments, Rubio and White House press secretary Karoline Leavitt insisted that Trump only wanted Palestinians relocated from Gaza "temporarily" and sought an "interim" period to allow for debris removal, the disposal of unexploded ordnance and reconstruction.

But he was asked in an interview with Fox News' Bret Baier that aired Monday if Palestinians in Gaza would have a right to return to the territory under his plan, he replied, "No, they wouldn't."

Speaking about Syria, Shea further said that the US is closely watching the situation in Syria, as it wants stability and secu-

rity in the region,

"We are also watching closely the situation in Syria. The United States wants stability and security in the region, and we want a Syria that lives in peace with its neighbors, respects human rights, and prohibits terrorists from using its country as a safe haven," she said. "The United States is

Imran Khan requests court to conduct open hearing of his cases



abad: Former Pakistan Minister Imran Khan has requested hearing of his cases in the open court. Imran Khan has filed a petition before the Islamabad High Court, saying multiple 'false' cases have been registered against him and his trial was being conducted in the 'controlled' environment of Adiala Jail, Dawn re-

In the petition, Imran Khan said that his trial in the Adiala Jail was being conducted in violation of law and the Constitution. It also said that his lawyers were being harassed. The petition said that Pakistan Tehreek-e-Insaf founder Imran Khan since his arrest in 2023 has never been presented before an open court and his trials have been conducted in makeshift courts in the prison.

In the petition, it was said that the jail administration did not permit international media to cover the trial proceedings and only a handful of reporters were permitted to be present during the proceedings. It is said that media could not mention former Pakistan PM's name and used the term 'PTI founder' for him. The petition urged the court to issue order for conducting Imran Khan's open trial to ensure fair trial as mentioned in the constitution.

Meanwhile, Khan's sister Aleema Khan, who had a meeting with PTI founder on Monday, said that he would write a third letter to Pakistan's Chief of Army Staff General Asim Munir next

Over the past few days, Imran Khan had already writtent wo letters to General Asim Munir, which have been shared with the media as well. The establishment has denied receiving any such message.

Speaking to reporters outside Adiala Jail, Aleema Khan said previous letters to Pakistan's army chief were not written for any deal or relaxation, instead they were aimed at making the powers that be understand that differences between the people and the armed forces were rising, according to Dawn report.

She said, "Imran Khan has clearly said that he will face all his cases before the existing judges despite the fact that the judges are being recruited to ensure that he does not get justice.



Ranji Trophy: Vidarbha, Gujarat, Mumbai continue to fight for title after cruising to semi-finals with emphatic wins 2025 as the West Indies spinner Jomel

NEW DELHI [INDIA]: Vidarbha, Gujarat and defending champions Mumbai booked their seats in the semifinals of the ongoing Ranji Trophy, with Kerala and Jammu and Kashmir fighting for the final spot.

In the first quarter-final, despite losing their footing in the first innings, Mumbai showed their champion mentality and effortlessly bounced back to confirm Haryana's exit from the tournament.

Royston Dias bamboozled Haryana batters with his left-arm seam and lifted Mumbai to a 152-run victory at the historic Eden Gardens. The first clash of the final eight began with Mumbai crumbling in front of Haryana pacers on a hazy morning of Day 1.

For the first 30 overs, Mumbai were forced to sit and witness a horror show from the batters. The starstudded line-up, including Suryakumar Yadav, Shivam Dube and Ajinkya Rahane, returned to the dressing room without making much of an impact.

Mumbai were reeling at 113/7 after group-stage hero Shardul Thakur's dismissal. But once again, Mumbai's lower order played the hero's part and came to the rescue. Tanush Kotian and Shams Mulani patiently dealt with the pacers to force an unprecedented comeback.

The duo forged a 165-run stand for the eighth wicket to propel Mumbai to 315. Haryana responded with gallantry as skipper Ankit Kumar tonked 136 to keep his side in the game. However, a collapse in the middle order saw Haryana slip from 218/3 to 301, therefore conceding a 15-run lead.

In Mumbai's second turn, Rahane played a captain's knock and fired a blistering ton to keep Haryana at bay, Dube (48) and Suryakumar (70) chipped in with valuable contributions, setting a competitive 354-run target for Haryana to chase down.

In reply, Haryana stumbled to 60/5 early and needed a moment of magic to turn the tides in their favour. Opener Lakshay Dalal (64) while Sumit Kumar (62) frustrated Mumbai for some time but couldn't resist the relentless pressure from the bowlers. s

In the second quarter-final, Tamil Nadu were always chasing the shadows after Vidarbha slammed 353 runs on the board, courtesy of Karun Nair's century in the first innings.

In reply to Vidarbha's 353, Pradosh Ranjan Paul and Sonu Yadav waged a lone war with their fifties as Tamil Nadu folded on 225, conceding a mammoth 128-run lead.

Vidarbha continued to maintain the pressure on Tamil Nadu as Yash Rathod raised his side to a state of dominance with a rollicking century in the second innings. Vidarbha ended their second turn with a 272run total, setting a massive 401-run target for Tamil Nadu to chase for a spot in the final four.

The target proved to be too much for Tamil Nadu as they folded their innings on 202, suffering a 198run defeat.

In the third match of the final eight, Urvil Patel and Gujarat pacers played a crucial hand in Saurashtra's demolition en route to the final four of the Ranji Trophy.

After Saurashtra fell on 216, Urvil (140), who broke the record for the second-fastest T20 fifty in November, wreaked havoc with the bat with his maiden first-class century.

Along with Urvil, Jaymeet Manishbhai Patel (103) was also at the forefront of Gujarat's spicy attack. Their classic strokeplay allowed Gujarat to put 511 on the board and take a hefty 295-run lead over Saurashtra.

Saurashtra were completely torn apart when they came out to bat for the second time in the game. Saurashtra batters resisted but eventually faced the impending defeat. Priyajeet Narendrasinh Jadeja starred for Gujarat with his four-wicket haul as Saurashtra conceded a defeat by an innings and 98

SO Bharat President Mallika Nadda thanks government for awarding cash prizes to medal-winning athletes

NEW DELHI [INDIA] : Mallika Nadda, the President of Special Olympics Bharat (SO Bharat) welcomed the decision of the Ministry of Youth Affairs and Sports (MYAS) to allocate cash prizes for athletes with intellectual disabilities, winning medals at the World Games.

This decision came after the Ministry's revision of the cash awards allotment scheme to medal winners in international tournaments, according to a press release from SO Bharat.

"It's an essential step in the direction of making the Indian sports culture more inclusive. These prizes are not just a way to help the athletes with their finances but also act as a motivation tool, encouraging athletes with intellectual and developmental disabilities to become a part of the sports world and redefine their lives. We are extremely thankful to Mansukh Mandaviva, Minister of Youth Affairs and Sports, and Raksha Khadse, (MoS) Ministry of Youth Affairs and Sports for recognizing the efforts, hard work and achievements of our athletes," said Mallika Nadda while thanking the Ministry of Youth Affairs and Sports.

As per the latest revision of the Scheme of Cash Awards to Medal Winners in International Sports Events and their Coaches, issued on January 31st, the cash award scheme will be applicable for the events held quadrennially, i.e., after every four years, like the Specia Olympics World Games.

Athletes winning gold medals at the Special Olympics World Games will be given Rs 20 lakhs each while the silver and bronze medalists will be awarded Rs 14 lakhs and Rs 8 lakhs, respectively.

The decision can be seen as an attempt to make the sporting world more inclusive, recognising the efforts of athletes with intellectual disabilities and motivating more people to engage in sports, which holds a promis-



Jomel Warrican, Beth Mooney bag ICC Players of the Month for January

DUBAI [UAE] : The International Cricket Council (ICC) on Tuesday unveiled the Men's and Women's Players of the Month for January Warrican and Australia batter Beth Mooney.

Warrican, with his left-arm spin, inspired the Caribbean team to their first Test win in Pakistan since 1990. On the other hand, Mooney was at her scintillating best as Australia convincingly outclassed England in the Ashes.

With his memorable performance in the sub-continent, Warrican won his maiden ICC Men's Player of the Month award by fending off tough competition from two standout spinners, Pakistan's seasoned ball tweaker Noman Ali



and India's mystery spinner Varun Chakravarthy. The 32-year-old's scythed 19 wickets in two Test matches in January at an average of just 9.00.

Despite Pakistan winning the series opener, Warrican returned with ten wickets in Multan's spin-friendly conditions. In the first innings, he registered figures of 3/69 which was preceded

He continued to outshine everyone with his brilliance in the second Test, not only with the ball but also with the bat in hand. He arrived at the crease when the West Indies were tottering at 95/9 in the first innings, and lifted the spirits

with his unbeaten 36. His exploits with Kemar


by his career-best spell of 7/32 in the second.

Roach foiled the Pakistan onslaught and propelled the tourists to a respectable total of 163. With contributions of 4/43 and 5/27, his allround heroics heralded a historic 120-run victory. He was crowned with the Player of the Series accolade, a recognition for his sensation-

al performance. Warrican becomes the first West Indian to win the award since his compatriot spinner

Gudakesh Motie achieved the feat back in May 2024.
