#### **Islamic State** unable to mount large-scale attacks in India: **UN report**

MI News Service, New York: Terror group Islamic State was unable to mount large-scale attacks in India but its handlers tried to incite lone-actor attacks through supporters based in the country, a UN report has said.

According to the 35th report of the Analytical Support and Sanctions Monitoring Team concerning ISIL (Da'esh), Al-Qaida and associated individuals and entities, these terror groups and affiliates remained resilient and adaptable to external counter-terror-

ISIL (Islamic State of Iraq and the Levant) is a terrorist group that aims to establish a caliphate in West Asia. It's also known as the Islamic State and Da'esh. "ISIL (Da'esh) was unable to mount largescale attacks in India. However, its handlers tried to incite lone-actor attacks through Indiabased supporters. The pro-ISIL (Da'esh) Al-Jauhar Media continued to spread anti-India propaganda through its publication Serat ul-Haq," the report said. The report also added that with over two dozen terrorist groups operating in Afghanistan, UN member states assessed the security threat emanating from the country as a continuing driver of instability in the region and beyond

"Despite the loss of territory and attrition among senior and mid-tier leadership figures, the presence of terrorist organisations in Afghanistan posed a serious challenge to the stability of the country, as well as to the security of Central Asian and neighbouring States," it said. Separately, the 20th report of the Secretary-General on the threat posed by ISIL (Da'esh) to international peace and security said that the severity of the threat posed by Da'esh remains concerning. Despite steady progress by member states and internapartners in targeting Da'esh leadership and financial operations, the group continues to demonstrate resilience and adapt its modus operandi, the Secretary General's report said. "The situation Afghanistan remains concerning, with ISIL-K (Islamic State - Khorasan Province) continuing to represent a threat not only to the country but also to the region and beyond," UN Secretary-General Antonio Guterres said in his report. "I continue to call upon all Member States to to prevent Afghanistan from again becoming a hotbed of terrorist activities affecting other countries," Guterres said. The report by the Analytical Support and Monitoring Sanctions Team further said that notwithstanding measures taken by the Taliban to counter IŠIL-K,

# India a solar Super power: UN climate chief

MI News Service, New York: UN climate chief Simon Stiell has called India a "solar superpower" and urged it to develop an ambitious climate plan covering its entire economy, saying that an even stronger embrace of the global clean energy boom will supercharge its economic rise. Stiell, who is in India to attend the ET Global Business Summit, lauded India's efforts to mitigate climate change, saying that while some governments only talk, "India delivers". "India is already a solar superpower, one of only four countries to have installed more than 100 gigawatts of solar... Energy access is on the rise with villages across the country electrified by 2018, well ahead of schedule," he said. "Now there is a real opportunity to take the next step and unleash even bigger benefits for India's 1.4 billion people and economy. India is already headed firmly in this direction, but an even stronger embrace of the global clean energy boom will supercharge India's economic rise," he said.

Stiell said India has an opportunity that only a few countries have: "To realize ambitious plans to deploy hundreds more gigawatts of renewable energy capacity. To lead a new wave of green industrialization, developing, scaling, and exporting vital technologies." He said the world's fifth-largest economy is well-positioned to reap the benefits of ambitious, economy-wide climate plans.

The UN climate chief added that India's leaders have a rare opportunity to deepen whole-of-

industry. Countries are required to submit their next round of Nationally Determined Contributions (NDCs), or climate plans, for the 2031-2035 period this year. With many countries, including India, missing the February 10 deadline, Stiell earlier this month urged them to submit their plans by September at the latest. "India's new NDCs will have targets achievable with the means available. Mitigating climate change requires financial and technological support, along with other enablers. Developed countries are unwilling to provide this support. Why should countries that did not cause climate change continue to suffer?" the source said. The collective aim of these climate plans is to limit global temperature rise since the start of the industrial revolution to 1.5 degrees Celsius, the key goal of the 2015 Paris Agreement. Developed countries, historically

responsible for most of the greenhouse gas emissions driving climate change, were required to deliver a new and ambitious financial package to support climate action in the developing world at the UN climate conference in Azerbaijan last

However, they offered a paltry USD 300 billion by 2035, a mere fraction of at least USD 1.3 trillion needed annually from 2025. India had called the sum "too little, too distant", "paltry" and "an optical illusion". The government's Economic Survey 2024-25 tabled in Parliament in January said the lack of funding from developed countries to mitigate climate change in the Global South may prompt developing countries to "rework" their climate targets.

### Weekend rush at Mahakumbh | Zelenskyy calls for @ 1,000 vehicles every hr



MI News Service, Prayagraj: The number of hakumbh-bound vehicles in Madhya Pradesh's Rewa, bordering with Prayagraj, has increased in the past 24 hours, prompting the administration to be on alert, officials said on Sunday. Around 1,000 vehicles were moving towards Prayagraj in Uttar Pradesh every hour at Chakghat border here and nearly 800 returning from there in the same pe-riod, they said. Prayagraj is located around 45 km from the Chakghat border in Rewa district. The first parking for the Mahakumbh in Prayagraj has been set up just six kilometres from the Chakghat border in Uttar Pradesh, the officials said, adding that elaborate arrangements have been made for the people at the "holding areas" and help

The number of Prayagraj-bound vehicles on National Highway no. 30 has increased in the past 24 hours. In addition, a large number of people were also returning from Prayagraj, resulting in the increase in number of vehicles on the road, in-charge Inspector General, Rewa range, Saket Prakash Pandey said. "As of now, we are not stopping the vehicles at Bela, Gangev and Chakghat holding points but police and administration are in alert mode," Pandey

The situation is not like a traffic jam, but the number of vehicles going to Mahakumbh in Prayagraj has gone up from Saturday due to it being the weekend, Sub Divisional Officer of Police Udit Mishra said. The administration has made arrangements in the "holding areas", besides enhancing the help centre amenities, Mishra said. Similar holding areas have also been made in Maihar, Katni and Satna districts of MP, the officials said. Traffic has increased on the border as the fair area and Prayagraj city have been declared as 'no-vehicle zone", they said. Earlier this month, heavy traffic jams were seen on the 250-km-long stretch from Katni on the border along the two states due to vehicles heading towards the Maha Kumbh fair. The Mahakumbh commenced on January 13 and will con-

clude on February 26.

# **European Army**

MI News Service, Munich: Two top European leaders stiffened their spines over unsettling new policies from Washington under President Donald Trump, as Ukraine's president urged creation of an "armed forces of Europe" and the leader of Germany de-nounced meddling in its election after US Vice President JD Vance met with a German far-right leader.

Strident speeches from Ukrainian President Volodymyr Zelenskyy and German Chancellor Olaf Scholz on Day 2 of the Munich Security Conference testified to the impact of a blizzard of Trump decisions that have resonated at home and in Europe, notably his hopes to end the Russia-Ukraine war and nurture perceived allies on

whether the idea will catch on with European leaders. Zelenskyy has sought greater military and economic support from the European Union for years and repeatedly warned that other parts of Europe could be vulnerable to Russia's expansionist ambitions too.

While the bloc — along with the United States - has been one of Kyiv's strongest backers, pockets of political disagreement in EU over its approach to Moscow and economic realities, including national debt levels that have crimped defence spending, have gotten in

the way of greater support.
Zelenskyy alluded to a phone conversation between Trump and Russian President Vladimir Putin this week, after which Trump said he and Putin

# India to be connected with longest under sea cable Project 'Waterworth': Meta

MI News Service, New Delhi: Social media major Meta tagged India as one of its largest markets to be connected with the company's world's longest undersea cable "Project Waterworth" which is expected to be operational by the end of this decade.

Meta has announced Waterworth" which will reach five major continents and span over 50,000 kilometers -- longer than the earth's circumference. The project was part of the USA-India Joint Leaders' Statement that was released on February 13 following the visit of Prime Minister Narendra Modi to USA. "Meta is investing in India -- one of its largest markets -- bringing the world's longest, highest capacity and most technologically advanced subsea cable project to connect India, the US, and other lo-



Local telecom operators connect with undersea cables to provide internet access to their customers. #### **Pre-bite vaccination** for pet parents made mandatory: Siliguri Admin

MI News Service, Siliguri: The Siliguri administration has made it mandatory for pet owners to get vacci-nated along with their pets. Tufan Maity, the deputy director of the district Animal Resources Development (ARD), said the move was part of a slew of measures undertaken by the administration following a rise in the canine population in the Siliguri region. "The measures include anti-rabies vaccination of pets, sterilization of canines to control the birth rate, and awareness drives about the mandatory prebite vaccination of pet owners," Maity said. People who feed stray dogs regularly have also been directed to take the prebite vaccination. A source in the civic body said the canine population across the SMC and adjacent areas is more than 30,000. Incidents of attack and dog bites have now become a regular menace. Amit Jain, the leader of the opposition in the SMC, raised the issue at the board of councilors' monthly meeting last week. "The residents are scared of stray dog attacks. Many cases are being reported in almost every locality. It is high time for the civic body to take immediate measures to present it." Isian ures to prevent it," Jain said. A source in the Siliguri district hospital said that more than 150 cases of anti-rabies vaccination are reported daily. Sources in the ARD also cited a World Health Organization report stating that almost 20,000 people die from rabies every year across the country.

#### Tamluk gets **POCSO** court

MI News Service, East Midnapore: The Chief Justice (CJ) of Calcutta High Court, TS Sivagnanam, inaugurated an exclusive POCSO court at Tamluk, East Midnapore, highlighting that the judges committee based on Supreme Court (SC) directions have decided that 25 such courts are presently required for Bengal. The CJ said Bengal faces a difficulty of space crunch. Due to this, whatever prototype courtrooms have been drawn up at the national level cannot be implemented here.

However, the Chief Justice of India was assured that whatever facilities are required, will be provided and the state government is willing to sanction funds for that. He highlighted that based on the apex court's decision the judges committee had reviewed the requirement of POCSO court in Bengal.

The committee was of the opinion that minimum 50 courts will be essential as against seven functioning here.

Subsequently, it was scaled down to at least 25 courts which ought to be established here. The CJ requested state Law minister Moloy Ghatak to take note of it to ensure Bengal is in the national map.

### **Councillors** donate for treatment: 'Gesture' to raise cash for Aasmika's medicine

MI News Service, Hoogly: All 23 councillors of Baidyabati municipality in Hooghly district have donated their one-month salary for the treatment of one-year-old Aasmika Das, who has been suffering from rare spinal muscular atrophy (SMA) and needs to be administered a vaccine worth ₹16

The municipality has 23 councillors — 19 from the Trinamool Congress, two from the Congress and one each from the CPM and the Forward Bloc.

A team of 17 councillors, including three from the Opposition, visited Aasmika's house in Daspara, near Ranaghat in Nadia district, on Friday and handed over to the family ₹2.51 lakh, which is the aggregate monthly remuneration of all the 23 councillors, including the chairperson and the vice-chairperson.

The councillors also donated an additional ₹3.5 lakh that they had collected from businessmen in the area. "During our board meeting last month, we decided that we would donate our one month's salary for Aasmika's treatment. As part of the decision, we met the family on Valentine's Day to send our token of love to the baby suffering from a rare disease," said Pintu Mahato, the chairman of Baidyabati municipality. A chairman of a municipality receives ₹20,000 a month as remuneration, while a vice-chairman and a councillor are paid ₹15,000 and ₹10,000, respectively.

"We know our contribution is not large, but our gesture sends a clear message to all councillors and office-bearers of 128 municipalities and seven corporations in the state that if they contribute one month's earnings, we can save the life of this little one," Mahato said. A source said a few municipalities had already expressed their desire to help the baby. Aasmika, the daughter

of a young web designer, is diagnosed with the SMA, which progressively weakens muscles and put her life in jeopardy. SMA is caused by a mutation in the SMN1 gene, responsible for producing a protein crucial for the survival of motor neurons. Specialised doctors in three cities who examined the girl prescribed an intravenous injection onasemnogene abeparvovec, sold under the brand name Zolgensma — as the only possible lifeline for her. It costs ₹16 crore. The little girl has until June this year to receive the vaccine.

Suvongkar Das, Aasmika's father, said they had accumulated around ₹7.5 crore so far through crowdfunding and donations from different organisations and individuals.

The court sent Chand alias Arif Akhtar and Rahul Pasi to 10 years' rigorous imprisonment and slapped a fine of Rs 5,000 on each offender, the National Investigation Agency (NIA) said in a statement.

The duo, along with one juvenile, had hurled three bombs in quick succession at the gate next to ex-MP Arjun Singh's officecum-residence -- Majdoor Bhawan -- at Jaggadal in North 24 Parganas district on September 8, 2021, the statement said. While Akhtar and the juvenile were apprehended by the local police, the NIA, which took over the case on September 14, 2021, chargesheeted the accused in December 2021. While Pasi and Akhtar were pronounced guilty and sentenced by the NIA special court on Saturday, the juvenile continues to be in parental custody, the statement said. MI News Service, Deocha-Pan**chami:** Tribal people at the site of the proposed Deocha-Pachami coal mine in Birbhum district on Saturday worshipped a dozen trees which had been translocated from their centuries-old location. The state government began the process of translocating 980

trees from a 376-acre plot, which is part of the first phase of chief minister Mamata Banerjee's dream project. As of Saturday, 12 mahua (Madhuca longifolia) trees were translocated to the new site, approximately 1.5km from their original location. A source said all the 980 trees, of which 744 are mahua, would be transplanted within six months. Other species of trees include arjun, saal, sirish and murga. A team of tribal priests, led by Rabilal Tudu, reached the new site of the transplanted trees on Saturday afternoon and performed traditional rituals for half an hour. "These trees are like gods to us and we have been worshipping them for centuries since the time of our great forefathers. As the government has translocated these trees, our people prayed for their survival," said Rabin Soren, president of Disham Adivasi Ganota, a tribal organisation that has been fighting for the community's rights since the announcement of the project. Babulal Mahato, an additional district magistrate, was present during the tree worship ceremony. That the adivasis conducted the traditional rituals showed that they were supportive of the administration's efforts, said a senior official.

"Before performing the rituals, the tribal people of the Dewanganj area held a meeting to decide whether they would proceed with

gave their approval," said a source, adding that it was a great relief for Mamata Banerjee's government to continue with basalt mining. Since the government announced plans to set up the world's second-largest coal mine in Deocha-Pachami, with a comprehensive compensation package for those giving up their land for the project, the adivasis' sentimental attachment to the 980 trees became a challenge. The local people informed the government of their decision not to cut down any of the 980 trees. A senior official has said the current challenge is to ensure the survival of all the translocated trees, as each one is worshipped by different tribal families in the area. "As we have learned from experts, it will take about three months to ensure that a particular translocated tree has survived,"

the rituals. Eventually, the leaders

said the official. "We are very careful about the translocation process and the subsequent care of these trees, as they hold deep sentimental value for the local people," he added. In addition to the translocation of the trees, the government has been carrying out the mining of basalt overburden.

"Removing the basalt overburden is important before we reach the coal layer," said an official. The state government is eager to advance the Deocha-Pachami project ahead of the 2026 Assembly elections, in which the coal mine will be presented as one of the state's biggest successful industrial endeavours. "That is why all top state government officials are closely monitoring every development on the ground. There is a clear directive to address all issues, even those which might seem minor,"

said a source.

### **Over 83 Lakhs** students to get more eggs in mid-day meals

MI News Service, Kolkata: Students from pre-primary to Class VIII in government-run schools across the state will now get two extra eggs per week with their mid-day meals until March 31. This is in addition to the one egg they receive every week. The Office of the Project Director, Cooked Mid-Day Meal Programme (now PM Poshan), under the state School Education Department, recently issued a directive outlining the initiative.

The notification states that Rs 8 per student has been allocated for 11 days. This is to provide supplementary nutrition to 85,93,783 students under the scheme. District authorities have been instructed to serve one extra egg twice a week, in addition to the existing provision of one egg per week. A total of Rs 75.62 crore has been approved. The directive specifies that the required funds will be drawn from the unspent balance of the cooking cost at the district-level from the third quarter of the 2024-25 financial year. Additionally, no separate limit will be sanctioned through the Public Financial Management System (PFMS), and the fourth-quarter cooking cost allotment must not be used for this

He, however, did not announce a ban on imports of poultry items from the southern state. Notably, West Bengal sources eggs from Andhra Pradesh.

The West Bengal Poultry Federation assured that stringent surveillance has been in place since November last year to prevent the virus from entering the state. The outbreak has also started affecting poultry sales in Bengal, with markets witnessing fewer buyers. As a result, chicken prices have dropped to Rs 200 per kg, down from Rs 220 just a few days ago. Despite the decline in prices, demand remains weak as uncertainty over the virus persists, traders said. According to a doctor,

bird flu is common during this period, but the virus generally does not transmit to humans. There is a risk of virus transmission among those who handle birds, but experts do not see any risk in consuming cooked poultry meat, as the virus gets killed in exheat. treme Andhra Pradesh minister K Athcannaidu had on Wednesday said there was no need to panic over the outbreak of avian influenza in the state as measures to control it are in place.

On Saturday (15.02.2025), Malda Division successfully executed the simultaneous insertion of two more LHS structures—one at Level Crossing (LC) Gate 53 between Ballalpur and Dhulian Ganga Station and another at LC Gate 41 between Dhulian Ganga and Nimtita Station in the New Farakka-Azimganj Section. Kolkata: In yet another major infrastructure upgradation, the layout of Gobar Danga has been successfully corrected to enhance the sectional speed from 50 KMPH to 110 KMPH. The massive layout correction was accomplished at Gobardanga Railway Station on February 15th and 16th, enhancing safety and efficiency of train operations significantly. The following extensive work focused on this mega block for a crucial layout correction at Gobardanga station, which had safety hazards. ### **Manufacturing and inspection of Battery Energy Storage System (BESS) pack complete to haul stranded Metros** from the mid section in case of power cut or grid failure

Kolkata: Metro Railway, Kolkata, India's first Metro, is going to achieve another feat very soon. It has been the torch-bearer in introducing new technologies, innovative ideas and running trains under the river in Indian Railways for the first time to provide commuters a fast and comfortable journey. Now our Metro is gearing up to introduce a new technology which would be another first-of-its kind initiative in the country to further ensure commuters' safety and improve energy consumption.

In order to ensure passengers' safety in an eco-friendly way, Metro Railway is going to install Battery Energy Storage System (BESS) at Central sub-station of Blue Line very soon. This new system, an amalgamation of inverters and Advanced Chemistry Cell (ACC) Batteries, is capable of doing wonders in case of a sudden power cut or grid failure. As per the National Programme on Advanced Chemistry Cell Battery Storage approved by the Union Cabinet in 2021 with budgetary outlay of more than Rs.18,000 crores, this scheme has been envisaged in Metro Railway, first time among all Zones of Indian Railways as well as all other Metro systems in India, to strengthen the eco-system for electric mobility and battery storage. Foreign multi-nationals like Siemens, Toshiba, Delta and Eaton have already expressed their eagerness to work with Metro Railway, Kolkata to implement this ambitious project. Order was placed through an open bidding process to M/s



Delta Electronics Pvt. Ltd. on 04.05.2024 to install 4 MW BESS with 6.4 MWh Lithium Iron Phosphate (LFP) battery

as energy storage element. Layout plan and manufacturing clearance was issued in the month of September-October 2024. With fast-track processing and manufacturing, the vanced Chemistry Cell (ACC) Battery pack (LFP type) was ready for inspection in January 2025. Inspection was scheduled in the first week of February, 2025. A team consisting of Shri Abhishek Verma, Dy CEE/Maintenance/ Blue Line and Shri Uttam Kumar Bar, SSE/Masterda Surya Sen were deputed for inspection of battery pack at Taiwan manufacturing unit with approval of Railway Board. Inspection has been successful and dispatch clearance has been issued. It is expected that Battery pack will reach the installation site in the middle of March 2025. The system is expected

to be installed, commissioned have prepared the specifiand fully operational in May

Adhering to the norms of Make in India Policy of Govt. of India, this company, which is an Indian subsidiary of M/s Delta Inc. Taiwan, will manufacture the power converter system of the battery in India and LFP battery in Taiwan, holding company of M/s Delta. Shri Abhishek Verma, Dy CEE/Maintenance/ Blue Line has been instrumental and also the nodal officer for the detailed specification as well as installation of this project. This new system has been designed in such a way that the electricity generated by it

can be used to haul passenger packed stranded rakes at 30 km/hr speed from the mid-tunnel to the next station in case of any power failure or even National Grid Failure. This is indeed a huge advancement as passenger packed trains won't have to wait in underground tunnels or on viaduct for restoration of power supply in case of a disruption of power. Thousands of passengers can be brought to safety with the help of this system. Railway Board has also provided funds for smooth execution of this eco-friendly project. This new system, equipped with green batteries and having lifespan of around 14 years, will require around 106 sq. metre space only to install. It is going to reduce carbon footprint with better energy efficiency, long life and occupy lesser space sans health hazards, fire hazards which are associated much more with acidic / alkaline

Metro Railway engineers

print to supply 4 MW power generated by this battery pack from a particular location to any station between Dumdum to Tollygunge of North-South Corridor using 33 kV ring main system. It has a potential to save the peak hour demand which may help Metro Railway to save Rs.7 crore in its lifetime. Apart from that, it will also ensure power factor improvement which in turn save another Rs. 6 crore. This battery may also be used as a storage system at night and then the stored energy can be used in the day time during peak hours. This proposed system will also not allow power factor to drop below 0.9 at any time leading to further savings.

If everything goes as par plan, Metro Railway, Kolkata is going to be the first Metro in India which will be in possession of fully functional BESS by May 2025.

#### Successful rebuilding of Brick Masonry Bridges no. 16 & 21 in Seoraphuli - Tarakeswar section

News Kolkata: Eastern Railway's Howrah division has successfully completed the rebuilding of Brick Masonry Bridges No. 16 & 21 in Seoraphuli -Tarakeswar section over Down Line, ensuring improved structural integrity and enhanced operational efficiency. This project was executed within a planned 10-hour Traffic & Power Block for rebuilding of both bridges. The block was taken from 23:20 hrs of 15.2.2025 to 09:20 hrs of 16.2.2025, during which the existing bridges were dismantled and replaced with RCC Box Bridges using the Cut & Cover method. Each bridge now consists of four (04) slabs and three (03) boxes, signifiantly improving their durability and strength.

The power block was successfully cancelled at 08:00 hrs, followed by the cancellation of the traffic block at 08:20 hrs i.e. well in advance of scheduled duration, ensuring the smooth resumption of railway operations.



Advanced machinery was deployed for the execution of the work such as a 140 Ton Railway Crane, three Poclain machines, one JCB Breaker and one Hydra were used

to facilitate the construction process.

Additionally, several important maintenance works were carried out during the block. A total of 2400 Track

Meters (TM) of ERC greasing was completed between Seoraphuli & Diara and Welding (SKV) of 24 Nos of Rail joints was executed between Seoraphuli & Singur . Moreover, BRM (Ballast Regulating Machine) work for laying of Ballast over a span of 5054 Track Meters (TM) was completed between Bahirkhanda & Tarakeswar in the shadow of the block period. These activities contributed to overall track strengthening and ensured safer train operations. The successful execution

of this bridge rebuilding work within the scheduled block duration highlights Eastern Railway's commitment to infrastructure modernization and passenger safety. The new RCC Box Briages will provide enhanced reliability and efficiency, contributing to smoother and safer railway services. Kolkata: Eastern Railway's Sealdah Division successfully carried out major developmental works at Gobirdanga station in Barasat - Sealdah section over Sealdah division during a planned block period from 23:30 hrs on 15.02.2025 to 09:00 hrs on 16.02.2025. A workforce of 400 labourers, supported by track machines, tower wagons, and earth-moving equipment, was mobilized to execute critical railway infrastructure upgrades aimed at improving safety, efficiency, and operational reliability.

Extensive track alignment and point shifting work at Gobardanga station was undertaken to facilitate smoother and more efficient train movement. The project involved the shifting of two points and the execution of a 500-meter slewing of the curve, significantly improving track alignment. Additionally, ten Overhead Equipment (OHE) masts were relocated to a newly designated alignment, with new masts already installed

preparatory work. A 0.5 km OHE realignment, including one crossover, was completed, with further checking and fine-tuning scheduled during a corridor block using tower wagons.

To improve signaling efficiency at Gobinda station, a crossover Point 51 was replaced by 51A and shifted 11 meters towards the Sealdah end. In addition, point junction boxes, DC track circuit bonds, and six glued joints were relocated accordingly, ensuring seamless train operations and enhanced safety.

Apart from the major track modifications at Gobardanga, several other crucial works were undertaken to strengthen railway infrastructure such as Deep

Screening of Platform no -2 at Chandpara was carried out using Ballast Cleaning Machines (BCM), significantly improving track sta-bility alongwith Tamping & Deep screening of plain track between Dattapukur-Bira section was done using BCM machine for ensuring smoother train movement and enhance ride quality for

passengers. # **Newly elected BJP MLAs to** meet in Delhi to choose Chief Minister candidate today

MI News Service, New Delhi: The newly elected Delhi Bharatiya Janata Party (BJP) MLAs are scheduled to meet on Monday (February 17) at 3 PM at the Delhi BJP State Office to decide the Chief Minister (CM) candidate.

All BJP MLAs have been notified of the meeting.

Voting for the Delhi As-

sembly elections took place on February 5, and the results were announced on February 8. The BJP won 48 out of the 70 seats in the

Delhi Assembly.

The party did not announce a Chief Ministerial face before the elections. With the current Delhi Assembly's term ending on February 23, the swearing-in ceremony could take

place before that. According to sources, the Delhi Chief Minister's swearing-in ceremony may take place at the Ramlila ground on February 18.

The BJP has secured power in the Delhi Assembly after 27 years, winning 48 seats out of 70. This election was a direct contest between BJP and the Aam Aadmi Party (AAP).

However, AAP could only secure 22 seats this time. Prominent AAP leaders like Arvind Kejriwal, Manish Sisodia, Saurabh Bhardwaj, and Satyendra Jain could not taste victory this time.

Several names are in the race for the position of Delhi CM, with the most prominent being Parvesh Verma. The BJP fielded

vener Arvind Kejriwal in New Delhi and became a key figure after defeating Kejriwal.

Satish Upadhyay is another strong contender for the CM position. He has served as the Delhi BJP president and was also the president of the Delhi Youth

The third name on the list is Ashish Sood, the Punjabi face of the BJP in Delhi. Jitendra Mahajan is also considered a potential candidate for the CM position The fifth name in the run-

ning is Vijender Gupta. If the party opts for a female leader, former Delhi Mayor and first-time MLA Rekha Gupta could be a

"The ceasefire on the Line of Control is intact and continues to be observed as per the understanding between both the armies (of India and Pakistan). Tension due to some stray incidents of cross-LoC firing and a suspected IED blast on one of our PTLs on the LoC is being dealt with through the established mechanism. No exchange of fire of heavy-calibre weapons has taken place," the statement further read. The Army further stated that minor incidents along the LoC are not uncommon and that concerns have been raised with the Pakistan Army at the appropriate level. It assured that the situation remains stable, is being closely monitored, and that Indian forces maintain a high level of alertness while continuing to assert dominance over the LoC.

# Study finds how new technique transform breast cancer detection

ILLINOIS [US] : A novel breast imaging technique detects cancer with great sensitivity while dramatically reducing the likelihood of false-positive results, according to a study published today in Radiology: Imaging Cancer, a jour-nal of the Radiological Society of North America.

Researchers believe the technology has the potential to provide more reliable breast cancer screening to a wider variety of individuals.

Mammography is a useful screening tool for early identification of breast cancer; however, its sensitivity is lowered in dense tissue, caused by the masking effect of dense fibroglandular tissue. Because nearly half of the screening population has dense breasts. many of these individuals require further breast imaging, usually with an MRI, following mammography. Low-dose positron emission

mammography (PEM) is a novel molecular imaging technique that provides improved diagnostic performance at a radiation dose comparable to that of mammography.

For the study, 25 women, median age 52, recently diagnosed with breast cancer, underwent lowdose PEM with the radiotracer fluorine 18-labeled fluorodeoxyglucose (18F-FDG). Two breast radiologists reviewed PEM images taken one and four hours post-18F-FDG injection and correlated the findings with lab results.

PEM displayed comparable performance to MRI, identifying 24 of the 25 invasive cancers (96 per cent). Its false-positive rate was only 16 per cent, compared with 62 per cent for MRI. Along with its strong sensitivity and low false-positive rate, PEM could potentially decrease downstream healthcare costs as this study shows it may prevent further unnecessary work compared to MRI. Additionally, the technology is designed to deliver a radiation dose comparable to that of traditional mammography without the need for breast compression. which can often be uncomfortable

for patients. The integration of these features--high sensitivity, lower false-



positive rates, cost-efficiency, acceptable radiation levels without compression, and independence from breast density--positions this emerging imaging modality as a potential groundbreaking advancement in the early detec-tion of breast cancer," said study lead author VivianneFreitas, MD, MSc, assistant professor at the

University of Toronto. "As such, it holds the promise of transforming breast cancer diagnostics and screening in the near future, complementing or even improving current imaging methods, marking a significant step forward in breast cancer care." Low-dose PEM offers potential clinical uses in both screening and diagnostic settings, according

to DrFreitas. "For screening, its ability to perform effectively regardless of breast density potentially addresses a significant shortcoming of mammography, particularly in detecting cancers in dense breasts where lesions may be obscured,"

she said. "It also presents a viable option for patients at high risk who are claustrophobic or have contraindi-

cations for MRI. The technology could also play a crucial role in interpreting uncertain mammogram results, evaluating the response to chemotherapy, and ascertaining the extent of disease in newly diagnosed breast cancer, including involvement of the other breast. DrFreitas, who is also a staff radiologist in the Breast Imaging Division of the Toronto Joint Department of Medical Imaging, University Health Network, Sinai Health System, and Women's College Hospital, is currently researching PEM's ability to reduce the high rates of false positives typically associated with MRI scans. Should PEM successfully lower these rates, it could significantly lessen the emotional distress and anxiety linked to false positives, Dr. Freitas said. Additionally, it might lead to a decrease in unnecessary biopsies and treatments. More studies are needed to determine low-dose PEM's exact role and efficacy in the clinical setting.

"While the full integration of this imaging method into clinical practice is yet to be confirmed, the preliminary findings of this research are promising, particularly in demonstrating the capability of detecting invasive breast cancer with low doses of fluorine-18-labeled FDG," DrFreitas said. "This marks a critical first step in its potential future implementation in clinical practice.

# Study gives insight into predicting neurodevelopmental disease in children from parent's traits

the development of neurodevelopmental and psychiatric illnesses such as autism or schizophrenia is challenging since they are influenced by a wide range of hereditary and environmental factors. A new study, led by Penn State researchers, shows that evaluating parents for their manifestation of these disorders -and related diseases like depression and anxiety -- may be a more accurate method of predicting the prevalence, and potential severity, of the disorders in affected children than screening for genetic variants alone.

This is most likely attributable, at least in part, to genetic variations passed down from parents to children that would not be detected by a genetic screen and would result in more severe disease, according to the researchers. The American Journal of Human Genetics published a paper that described the research. According to the researchers, understanding how both parents contribute to their child's diagnosis can help with genetic counseling and the formulation of therapeutic intervention strategies for children affected by these conditions.

We looked at the presence of neurodevelopmental and psychiatric traits in children and parents from a large set of families," said SanthoshĞirirajan, interim department head and T. Ming Chu Professor of Biochemistry and Molecular Biology in the Penn State Eberly College of Science and lead author of the paper. "We saw an increase in the presence of neurodevelopmental disorders in children whose parents both report having the trait, including psychiatric traits like anxiety or

The team looked at 97,000 families, many including children with neurodevelopmental disorders such as autism or intellectual disability and evaluated how risk factors -- genetic features and the presence of the traits -in both parents impact the trajectory of the disease in the children. The datasets included genetic information and questionnaire data from families in a large public biobank, as well as from families from specific studies of neurodevelopmental disorders. The researchers evaluated parents and their children for symptoms of the various disorders and assessed known genetic mutations that can give rise to such disorders. Their analysis revealed that parents tend to select partners with the same or related disorders, leading to increased prevalence and, potentially, severity of the disorder in their children. "Most neurodevelopmental disorders are genetically complex, meaning that they aren't caused by a single gene," Girirajan said. "This makes it hard to trace the exact genetic underpinnings of a disorder in an individual and even harder to predict how the disorder will play out in affected children.'

The researchers explained that complex genetic diseases can be caused by mutations in many genes, each of which could be inherited from one or both parents, or occur spontaneously in the newly formed genome of the child. The child's disease prognosis results from the combination of mutations that they inherit and how they interact with one another during development. This is called the "multi-hit model" because the disease results from multiple different mutations in many different genes.

'We have been studying one such mutation -- a deletion of a small segment of chromosome 16 -- that has been implicated as a risk factor for several neurodevelopmental disorders," Girirajan said. Symptoms of these disorders can manifest as seizures, schizophrenic features, depression and anxiety, along with characteristics related to addiction. "This mutation is often passed from a parent to a child, but the child regularly has more severe symptoms of the disorder than the parent. We wanted to know if other 'hits' for the disorder could be coming from the other parent. So, we looked at the traits of both parents in a large cohort of families with children with neurodevelopmental disorders.

### RESEARCHERS GIVE INSIGHTS INTO CELL'S REPAIR SYSTEM

WASHINGTON [US] : In living organisms, the membrane that encloses the cells is incredibly delicate and flexible. Many biological activities depend on how it repairs and protects itself from harm, yet this process is still poorly under-Researchers stood. ForschungszentrumJulich have now used cryo-electron microscopy to uncover intriguing new information. Known from the photosynthetic system of plants, algae, and bacteria, the membrane protein Vipp1 may generate a variety of structures that may be used as instruments to reinforce and strengthen the cell membrane when needed. In a follow-up investigation, the scientists also managed to get fresh perspectives on the role

of the associated bacterial protein PspA. Vipp1 and PspA are two molecules that have exceptional plasticity and may take on many shapes, such as rings and tubes with various diameters. The cell membrane has numerous important functions. For instance, it protects the inside of the cell from the environment. At the same time, nutrients are absorbed through the cell membrane. waste products are excreted. and signals are transmitted between cells. Despite its central role, the cell membrane is also very sensitive. It consists of a thin layer of lipids which, although protective by themselves, are also susceptible to stress caused by physical pressure and stretching or chemical influences. Environmental

factors such as UV radiation or toxins can also damage the membrane. In plant cells, for example, intense light can severely stress and even damage the membranes in the chloroplasts, where photosynthesis takes place. Proteins such as Vipp1 are therefore essential for the survival of the cell, as they protect the membrane structures and repair them if necessary. How exactly the mechanism works is not yet fully understood. However, thanks to the state-of-the-art crvo-electron microscopes at Julich's Ernst Ruska-Centre, the researchers have now been able to gain new insights into the interaction between Vipp1 and the cell membrane. They discovered that Vipp1 forms carpet-like structures.

# PREGNANT WOMEN SHOULD AVOID FAST FOODS

WASHINGTON DC [US] : According to a study published in the journal Environmental International, if you're pregnant, you should think twice before running out to get a cheeseburger or grabbing for a packaged pastry.

Oddly enough it's not the food that the report targets -- not the fries, burgers or even the shakes and cakes -but what touches the food before you eat it.

Research shows that phthalates, a class of chemicals associated with plastics, can shed from the wrapping, packaging and even from plastic gloves worn by food handlers into food. Once consumed during pregnancy, the chemicals can get into the bloodstream, through the placenta and then into the fetal bloodstream.

The chemical can cause oxidative stress and an inflammatory cascade within the fetus, researchers noted. Previous literature has indicated that exposure to phthalates during pregnancy can increase the risk of low birth weight, preterm birth and child mental health disorders such as autism and


This is the first study in pregnant women to show that diets higher in ultraprocessed foods are linked to greater phthalate exposures, the authors wrote.

"When moms exposed to this chemical, it can cross the placenta and go into fetal circulation," said senior author Dr. SheelaSathyanarayana, a UW Medicine pediatrician and researcher at the Seattle Children's Research

Affecting Neurocognitive Development and Learning in Early Childhood (CANDLE) research cohort, which comprised 1,031 pregnant individuals in Memphis, Tenn., who were enrolled between 2006 and 2011. Phthalate levels were measured in urine samples collected from during the second trimester pregnancy. researchers found that ultraprocessed food composed 10% to 60% of participants' diets, or 38.6%, on average. Each 10% higher dietary proportion of ultraprocessed food was associated with 13% higher concentration of di(2-ethylhexyl) phthalate, one of the most common and harmful phthalates. Ultraprocessed foods, according researchers, are made mostly from substances extracted from foods such as oils, sugar and starch, but have been so changed from processing and the addition of chemicals and preservatives to enhance their appearance or shelf life that they are hard to recognize from their original form, researchers noted. These include packaged cake mixes, for example, or packaged french fries, hamburger buns and soft drinks. When it comes to fast food, gloves worn by the employees and the storage, preparation, serving equipment or tools may be the main sources of exposure. Both frozen and fresh ingrethese sources, said lead author Brennan Baker, a postdoctoral researcher in

Sathyanarayana's lab. This is the first study, researchers say, to identify ultraprocessed foods as a link between exposure to phthalates and the socioeconomics issues facing the mothers. The mothers' vulnerability might stem from experiencing financial hardships and from living in "food deserts" where healthier, fresh foods are harder to obtain and transportation to distant markets is unrealis-

"We don't blame the pregnant person here," said Baker. "We need to call out manufacturers and legislators to offer replacements, and ones that may not be even more harmful.

Their distressed families have sought help from Majlis Bachao Tehreek (MBT) leader Amjed Ullah Khan, urging him to appeal to the Indian Embassy in Riyadh and the Consulate General of India (CGI) in Jeddah for the immediate release of their loved ones. The workers were detained on January 14, 2025,

In a post on X, Amjed Ullah Khan made an urgent plea to Union Minister of External Affairs Dr S to intervene and ensure the safe return of the detained Hyderabadi work-

According to Khan, 19 workers were lured by an agent named Mohd Akber (Contact: 9642672204, 9951576330) with promises of food delivery jobs in Jeddah under an employer named Kholoud Ahmad Alqouzi (Contact: +966502505261).

"The residents of Hyderabad were assured a salary of 1,500 Saudi Arabian Riyals (around Rs 35,065), free accommodation, a two-wheeler with fuel, along with temporary food assistance until their Iqama (residency permit) was issued," Khan said.

Upon arriving in Jeddah on July 26, 2024, the workers were left idle for over a month before being assigned gruelling delivery jobs under harsh conditions, including: 30 km travel per order and

NEW DELHI: The 'Mecca of Indian Cricket', Eden Gardens will mark both the commencement and the conclusion of the 18th season of the Indian Premier League 2025, by hosting the touropener between Defending Champions, Kolkata Knight Riders and Royal Challengers Bengaluru on March 22 and the final on May 25.

Eden Gardens, the home ground of KKR will also play host to Qualifier 2 on May 23. Notably, this is the first time in almost a decade, that the IPL will conclude at the iconic Eden Gardens, having done so previously in 2013 and 2015.

"The Board of Control for Cricket in India (BCCI) announced the schedule for the TATA Indian Premier League (IPL) 2025. The 18th edition of the prestigious tournament will commence on March 22, 2025, and the Final will be played on May 25, 2025," IPL said in a statement.

The other two playoff matches, Qualifier 1 and the Eliminator will be played in Hyderabad, home of 2024 runners-up Sunrisers Hyderabad, on May 20 and May 21, respectively

Overall, IPL 2025 will consist of 74 matches spread over 65 days, including 12 double-headers. The tournament will kick off with a mouth-watering affair between KKR and Challengers Bengaluru on March
