

India now emerging as global factory, becomes a 'World Force', says PM Modi

Mi News Service, New Delhi: With more and more Indian products going global and making their presence felt across the world, India is no longer considered merely the supplier of workforce but has become a "world force" of its own, Prime minister Narendra Modi asserted here on Satur-

Claiming that his "vocal for local" campaign is bearing fruits, the Prime minister while speaking at the NXT conclave where the 'NewsX World' channel was launched, said the "world used to look at India as its back office for decades but the country is now emerging as the factory of the world. Now, India is not merely the workforce but a world force" PM Modi further said the country is manufacturing semiconductors and aircraft carriers and its superfoods like 'makhana' and millets, Ayush products and yoga are being embraced across the world. In addition India has also become a major automobile producer and its defence export is rising, he

Modi said India should be presented as it is, without any colour. It does not need any make-up, he said, adding that real stories from the country

should reach the world. prime minister said the BJP-led NDA government's re-election for a third term showed people's trust and hoped that the new global news channel from India would take the country's achieve-

He said the world is looking at India in the 21st century, and that the country is constantly generating positive news. India is now leading many global initiatives, he said, referring to him co-hosting the recent AI summit and India's presidency of the G20 last

year. Citing the Maha Kumbh, he said it highlighted India's organising skills and innovation. Noting that his government has repealed many obsolete laws, he said an Act made by the British criminalising the dancing of 10 or more persons remained in force till it was annulled by his dispensation. Taking a swipe at the "Lutyens jamaat" and "PIL ke thekedaar", he said they go to courts for everything but kept mum over such a law. They did not think of liberty then, he said. He said that the country was now emerging as a manufacturing hub and a "factory of the world". "For decades, the world referred to India as their back office. Now, India is becoming the new factory of the world. We are no longer just a workforce but instead becoming a world force," Modi said.

The prime minister said that India's rising defence products showcase the strength of its engineering and technology to the world. "From electronics to the automobile sector, the world has witnessed India's scale and capability. India is not only providing products to the world but is also becoming a trusted and reliable partner in the global supply chain," Modi said. The prime minister said India's leadership in various sectors was a result of years of hard work and systematic policy decisions. Bilateral relations need to ramp up for improved trade and investment, feels Nirmala

MI News Service, New Delhi: As the overall economic situation in the world is witnessing a churn for various reasons, Union Finance Minister Nirmala Sitharaman has underscored the need to ramp up India's bilateral relations with every country for improved trade and invest-

Speaking at BS Manthan, the Finance Minister said bilateralism seems to be the new catalyst tool as the world is passing through a very interesting yet challenging times. However, the government is making all efforts to make India move up the ladder and be an engine of global growth, the Finance minister said. . "Bilateralism is now taking the top of the agenda... It is for us to ramp up our bilateral relations with many countries, not just for trade, not just for investment, but also for strategic relations. So multilateralism, sort of, out, I'm still saying with a qualifying word 'sort of out', but bilateralism is very much your only catalytic tool that you can use," she said. Observing that multilateral instituare increasingly tions fading away, she said, every attempt to revive them and energize them is not having



more than your own country. You have no more forums left which can effectively deliver... multilateral institutions and their contributions probably are fading away, at least in the near future, till an attempt is made to revive them with that kind of energy... It's not going to happen in the next few years," Sitharaman said. Asserting that global trade is undergoing a complete reset, she said, "the terms and references with which all of us played trade, with some kind of an anchor in the World Trade Organization are no longer available." There is no Most Favoured Nation (MFN) concept, she said, adding, every country wants to be treated special, and every country wants to be sure

One person died as Uttarakhand govt intensifies rescue operations in avalanche site, 49 labourers found alive so far

MI News Service, Dehradun: One labourer died and 49 were pulled out alive from the snow till Satuday evening after a huge avalanche engulfed a BRO camp in the high-altitude Mana village in Uttarakhand's Chamoli district on Friday morning, as rescuers raced against time to find survivors.

However, 7 more workers still remain trapped under at least 8 feet of snow. Earlier in the morning hundreds of rescuers resumed their search for last 8 of the

57 labourers who still remained trapped under several feet of snow in the high-altitude Mana village as the weather cleared up.

According to official sources, Army choppers were roped in for intensifying the search operation after the weather condition improved.. The nearest airstrip at Gauchar has been readied for more helicopters, Chamoli District Disaster Management Officer N K Joshi said. "It is a little cloudy at the moment but once the weather becomes

he said adding two smaller avalanches had already followed the initial one. The Army and Indo-Tibetan Border Police (ITBP) personnel based in Mana have resumed the rescue operation, he said adding a let-up in rain and snowfall can help speed up efforts to trace the remaining 8 labourers who remained trapped under the snow for more than 24 hours now. Altogether 57 Border Roads Organisation (BRO) labourers were trapped under heavy snow when a huge lanche rolled over their camp on Friday morning. Soon a massive rescue operation was launched and one by one 49 labourers were rescued. As Rain and continuous snowfall hampered the rescue efforts, the operation was suspended as the night fell. The BRO camp was situated at the footbill of a mountain between Mana and Badrinath. Uttarakhand chief minister Pushkar Singh Dhami who is likely to visit the accident site on Saturday if weather permits, met an injured worker who was airlifted to Joshimath. Education Minister Bratya Basu faces student vandalism at Jadavpur University, sustains minor injury



MI Nerws Service, Kolkata: West Bengal Education Minister Bratya Basu received minor injury when a group of students from Jadavpur University threw brickbats at his car while he was leaving the university campus after holding a meeting there on Saturday. Informed sources said as the minister was leaving the university after holding a meeting of a Professors organization, affiliated to the ruling Trinamool Congress, a number of students belonged to Leftist organisations launched a massive protest and rushed towards the minister's car. Taking advantage of subsequent melee some students reportedly deflated the tires of the Education minister's car. As the Minister got out of his car and tried to talk to the students, they started shouting 'Go Back' and other slogans against him while continuing their protest Later, the minister's car and the two pilot cars accompanying it were vandalized. The 'looking glass' of Bratya's car was also broken. The minister said that he was injured due to bricks batting. Later he went to the Trauma Care Center of SSKM Hospital for treatment.

Some professors who tried to protect the minister during the protest, were also not spared from the students' wraths. At one point professor Omprakash Mishra was chased with sticks by several students from the Left and ultra-Left organizations. Later, the university security guards rescued him. Two other professors were reportedly injured in scuffle. Soon reinforcement from the Jadavpur police station rushed to the spot and brought the situation under control.

TMC spokesman Kunal Ghosh has severely condemned the incident and demanded a thorough inquary and proper action against the culprits soon

Encounter between security forces and Naxalites in Chhattisgarh to flush out militants



MI News Service, Raipur: A fierce encounter broke out between Naxalite forces and security personnel in remote Sukma district of Chhattisgarh on Saturday, police said. The heavy gunfight began in the morning inside a deep forest area under the Kistaram police station area, where a joint team of security personnel acting on a tip off about the presence of some armed Maoists went out on an anti-Naxalite operation, the police said. He said personnel from the District Reserve Guard (DRG) and CoBRA (Commando Battalion for Resolute Action — an elite unit of CRPF) were involved in the operation launched on Friday based on inputs about the presence of Maoists in the area. The official said the intermittent exchange of fire which began early in the morning was still continuing, and it was still now known whether there was casualty or recovery of arms and ammunition from the area. Further details are, however, awaited.

Meanwhile, in his stride to bring an absolute peace in the state Union Home Minister Amit Shah has directed security forces to ensure free movement of people on all roads in Manipur from March 8. Chairing a meeting where the security situation of Manipur was reviewed, the home minister said that strict action should be taken against those creating obstructions on the roads. This was the first such meeting held after the imposition of the President's rule in the northeastern state, which has been witnessing ethnic violence since May 2023. Over 250 people have lost their lives in the violence. Focus on recovery of weapons looted from police armouries, keep level of violence under check, and try to establish peace as soon as possible: these are some of the instructions that Union Home Minister Amit Shah reportedly gave Manipur Governor Ajay Bhalla and the security establishment on Saturday.

Shah on Saturday held an hour-long meeting at the North Block to take stock of the security situation in Manipur. The meeting was attended by Manipur Governor Ajay Bhalla, Manipur Security Advisor Kuldiep Singh, state Director General of Police Rajiv Singh, Intelligence Bureau chief Tapan Deka, Union Home Secretary Govind Mohan, Additional Secretary (North East) Prakash

Zelenskyy thanks the USA after unprecedented showdown with Trump in Oval Office

MI News Service, Washington (DC) : Hours after the unprecedented showdown in the Oval Office with the American President Donald Trump and Vice President J D Vance, Ukrainian President Volodymyr Zelenskyy on a complete turnaround has thanked the US President and his country for its support to the conflict with Russai during the past three years After departing the White House following the unprecedented verbal dual with the American top leaders at the Oval Office meeting on Friday night (Indian time), where Trump shouted at Zelenskyy, accusing him of "risking millions of lives" and warning that his actions might lead to World War III. the Ukranian President possibly realising that the situation was going out of his hand, acknowledged the contribution of the USA in his country's fight against Rus-

sia since 2022. However, a little earlier in re-



sponse to Trump's accusations, Zelenskyy abruptly departed the White House without signing the crucial minerals agreement with the US, which Trump had insisted upon as a prerequisite for continshouting match between the two Presidents (Trump and Zelenskyy) during the Oval office meeting, the relations between the two countries hit a new low. Standing firm on his stance, Zelenskyy said

towards Russia on a dime and added the spat with Trump is not good for both sides. During the diplomatic meeting expected to finalise a peace agreement between Ukraine and Russia, Trump pressured Zelenskyy to accept a ceasefire and accused him of stalling negotiations. The blow-up is likely to scramble affairs in Europe and across the globe. Several world leaders including Canadian Prime Minister Justin Trudeau, outgoing German Chancellor Olaf Scholz, French President Emmanuel Macron, Australian Prime Minister Anthony Albanese rallied in support of Ukraine. The rift between Trump and

Zelenskyy has ballooned in recent days as US officials attempted to negotiate the minerals deal with Ukraine. In last few weeks, Trump told his closest advisers that he does not like the way in which Zelenskyy has tried to drum up US support for Ukraine, claiming he

the struggle of a democratic nation versus an authoritarian regime led by Vladimir Putin, who clearly has imperialistic designs, not just on Ukraine, but through-out that region." Italian Prime Minister Girgio Meloni noted that a division between the US and European Union will not be beneficial and urged for a summit. "What is needed is an immediate summit between the United

Narcotics, cash worth over Rs 1 crore seized, illegal cannabis farms destroyed across **Cooch Behar**

MI News Service, Cooch Behar: Police, the Border Security Force (BSF), and the Narcotics Control Bureau (NCB) seized narcotics and cash worth over ₹1 crore from different locations and destroyed several illegal cannabis farms across Cooch Behar on Wednesday.A police team raided the house of Swapan Mondal, a resident of Dhalaguri, a village in the Mathabhanga subdivision. They seized 9.8 kg raw opium gum from the house. "Also, ₹33,44,760 was seized in cash from there. We have arrested Swapan Mondal and a case under the NDPS Act has been registered against him," said Sandip Garai, the additional superinten-dent of police (Mathabhanga).

"Our officers will interrogate him to know from where he had obtained the suspected narcotic and the cash. We suspect he is associated with a drug smuggling racket," he added. The cost of the seized opium gum in the clandestine market is ₹40 to 50 lakh, sources said. In another incident, troops of the 78th battalion of the BSF of the Guwahati frontier, posted at Chitrakoot border outpost in Cooch Behar, conducted a joint operation with NCB and seized five quintals of cannabis. A person has been arrested in this connection.

Youth arrested with four firearms, magazines and ammunition by Malda police

MI News Service, Malda: Police in Malda seized four firearms, magazines and ammunition and arrested a person on Thursday. Pradeep Kumar Yadav, the district police chief, said Ratua police had intercepted Razzak Sheikh aka Tota, 35, in the Nakkatti bridge area in Ratua. He is from Daulatpur Baisnabnagar. men searched him, they found four seven mm pistols, four magazines, with one round of live ammunition in each magazine," said Yadav.

Sheikh was heading towards Malda in a twowheeler. The police have also seized Police officers suspect that he was supposed to sell the loaded firearms to some person who deals with illegal firearms in the district. "During preliminary investigation, he has revealed the name of one of his associates. We are in search of the person," said an officer. TMC Leader Found Dead with Multiple Injuries

MI News Service, Palta: The discovery of the lifeless and bloodied body of Hannan Gazi, a local leader of the Trinamool Congress, in Palta has generated significant concern and unrest, both within the community and among political circles in the region. Gazi was found with severe injuries, including deep wounds to his head and legs, which has led his family to assert that his death was the result of a murder. The circumstances surrounding the incident have further heightened tensions in the area. According to sources, residents reported hearing a loud noise around 1:20 AM. Upon investigating, several individuals emerged from their homes and discovered Gazi's body on the street in a state of bloodied distress. The local police were immediately notified, and officers from the Titagarh police station arrived at the scene to recover the body, which was subsequently sent for autopsy. An in-

has been launched. The deceased leader's brother, in a statement, emphasized that Gazi was a grassroots activist. He expressed doubts that the injuries could have resulted from an accident, asserting that the nature of the wounds indicated intentional harm. "These types of injuries are not consistent with an accident," he stated. "The head and leg injuries are clear signs of being inflicted by a sharp weapon or a blunt object, possibly a rod. "Sources reveal that Gazi was also involved in managing the local auto union, a role that afforded him significant influence in the area. Given his political and social prominence, the police are examining the possibility of a political motive behind his death. The investigation is ongoing, with authorities carefully exploring any potential links to local politics. As part of the investigation, the police have already apprehended an individual named Abhijit Nandi, who was reportedly associated with Gazi. Nandi was arrested due to inconsistencies in his statements, and further questioning is expected to shed light on the circumstances of the crime. It remains to be seen whether new evidence will emerge from his interrogation. In addition, Gazi's aunt has voiced skepticism regarding the explanation provided by Nandi, who claimed that the leader's death was the result of a car accident. She, along with other family members, contends that the injuries sustained by Gazi do not support this version of events, further suggesting that foul play may have been involved. As the investigation progresses, both the authorities and the family hope that additional details will come to light, helping to clarify the true cause of Gazi's death and any potential political motivations behind this tragic event.

Jalpaiguri tea auction centre to reopen



MI News Service, Siliguri: The North Bengal Tea Auction Centre in Jalpaiguri will again witness the auction of the brew in March, after a gap of around 11 years. The centre had been opened in 2008 by the then state commerce and industry minister, Nirupam Sen. However, the facility had been hit by the low inflow of teas ever since its inauguration. Eventually, the centre closed down in 2014. North Bengal has a second tea auction centre in Siliguri, around 45km from Jalpaiguri. The Siliguri centre was established in 1976. "We have received an official communication from the Tea Board which announced the dates for

auction will be conducted online and the necessary infrastructure repairs will be completed soon," said Purajit Bakshi Gupta, the vice-chairman of the North Bengal Tea Auction Committee that runs the centre. He said the committee had been lobbying the Union government for a decade for the reopening of the Jalpaiguri centre. "Our local MP Jayanta Roy was also instrumental in making the auction centre operational," added Bakshi

According to him, the mock auction test will be conducted on March 10 at the centre on Shivaji Road in Jalpaiguri town. "If the mock test succeeds, the first auction will be conducted on March 31.

Kalimpong municipality to take up Rs 266 crore Amrut 2.0 water scheme for the hill town

Thursday officially informed residents of the hill town that they are taking up a drinking water project under a central scheme to meet a longstanding demand of the people. The project, which has been taken up under the Centre's Amrut (Atal Mission for Rejuvenation and Urban Transformation) scheme, will be executed with an estimated cost of around ₹266 crore. "Today (Thursday), we elaborated on the proposed drinking water project before the residents through a PowerPoint presentation. The estimated cost is Rs 265.97 crore," said Ravi Pradhan, the chairman of the board of administrators of the hill civic body. The presentation was held in the presence of Ruden Sada Lepcha, the local MLA, officials of the state municipal engineering directorate (MED), and officials of the civic body at the Town Hall, a prominent auditorium in Kalimpong. Under the scheme, 50 per cent of the project cost will be shared by the Centre

MI News Service, Darjee- per cent. The rest 10 per ling: Authorities of the cent will be borne by the Kalimpong municipality on civic body. The MED and the municipality will jointly execute the project. "We will initiate the tender process in March. Once the process is complete, we have set a target to finish the project within 24 months," said Pradhan. The Kalimpong municipality was established in 1945 when the town had a population of only around 4,000. As of now, the town has 23 wards. Around 80,000 people dwell in the civic area. There is a drinking water supply facility for households and commercial areas but the supply is too inadequate vis-à-vis the demand. Because of poor supply, people have to buy or arrange water for drinking other purposes. Bagdhara, a hilly stream in ward 12 of the town is the major source of water for the town. "There are some other streams from where water is sourced for the town. The requirement is around 7 million litres per day (MLD) while the municipality can hardly provide 2 million litres per day. The new project will be able to largely meet the demand," said a civic body source.

Villagers Clash with Police in Chopra, Help Accused Escape

MI News Service, Chopra: Tensions are high in Chopra's Kalkapur area after villagers clashed with police on Saturday, obstructing the arrest of accused Mujibur Rahman. Villagers shielded Rahman and enabled his escape following his apprehension by authorities. After Rahman's arrest, Villagers allegedly formed a barrier in front of the police van,k resulting in a scuffle with law enforcement. It is alleged that the villagers helped Rahman escape amidst the commotion. Chopra Police Station IC Suraj Thapa, along with a large police force, responded to the scene and launched a search operation. While police sources indicate that 11 people have been arrested in connection with the incident, Mujibur Rahma remains

This incident is not isolated as past events in Chopra have involved violence against police as well. These events raise concerns about the effectiveness of the law enforcement in the area. Chopra MLA Hamidul Rahman stated that some locals claimed Rahman was not a criminal but a former Gram Panchayat Member. Rahman also alleged that the police had damaged houses and did not possess a warrant. As of now, the situation in Chopra remains tense as authorities continue their search for Mujibur Rahman. The clash between villagers and police raises questions about the community's relationship with law enforcement. The events in Chopra are likely to spark further debate about policing methods and local governance in the region.

Father and Autistic Daughter found dead in Kolkata Shop

MI News Service, Kolkata: A tragic discovery was made in South Kolkata's Behala area, as the bodies of a businessman and his 22 year old daughter were found in his office in Shakuntala Park on Friday Swain Page 52 who day. Swajan Das, 53, who ran a water purifier and chimney business, was reportedly mentally disturbed, and his daughter Sreeja was autistic. Das told his wife that he was taking Sreeja to the doctor on Friday afternoon. When they did not return, she panicked and began to search for them. The bodies of Das and his daughter were found around 7 p.m.

According to sources, Swajan Das had been mentally disturbed for a long time and his daughter had also been suffering. The landlord of the property where Das rented his office stated that Das always paid his rent on time and seemed worried about his daughter's health but he showed no signs of depression. Police are investigating the incident currently and whether this was a murder or a suicide is yet to be uncovered. The homicide branch of Lalbazar police is also working on this case.

Suspension of AAP MLAs 'blow to democracy', claims **LOP Atishi**

then how will democracy survive?" the AAP leader said in the letter. 21 out of the 22 AAP legislators, including Atishi herself, were suspended from the Delhi Assembly for three days on Tuesday after they protested against the alleged removal of B R Ambedkar's portrait from the newly appointed Chief Minister's office.

The Speaker ordered the suspension for disrupting Lieutenant Governor V K Saxena's inaugural address. The newly Okhla MLA Amanatullah Khan was the only AAP legislator spared from the suspension as he was not present in the House during the protest. The motion for suspension was moved by Minister Parvesh Verma. "On Tuesday, 25 February 2025, during the address of the Honorable Lieutenant Governor, the MLAs of the ruling party raised slogans of Modi-Modi', while the opposition MLAs raised slo-gans of 'Jai Bhim' respecting the views of Baba Saheb Dr. Bhimrao Ambedkar ji. It is very unfortunate that no action was taken against any MLA of the ruling party, but 21 MLAs of the opposition were suspended from the House for 3 days for raising the slogan 'Jai Bhim'," Atishi wrote in the letter. Adding that the "injustice" did not stop, the AAP leader claimed that when the suspended MLAs were going to protest peacefully in front of the Mahatma Gandhi statute in the Delhi assembly premises in a "democratic" way, they were stopped and prevented from entering the assembly grounds. "This is an insult not only to the MLAs but also to the mandate given by the people," she said.
"Hon'ble Speaker, you

have also been the leader of the opposition for years. Even when you were suspended from the House for some reason, you were not stopped from going to the assembly premises and registering protest in front of the Gandhi statue. Because this is our democratic right. But today, the rights of the MLAs of the opposition are being violated. We have also seen this tradition in Parliament when an MP is suspended from the House, he is allowed to go to the Parliament premises and protest in front of the Gandhi statue," the Leader of Opposition added. After a BJP vs AAP face-off in the assembly, the House session was extended by two days till March 1.

JU obstinate about scholarship verification stand

MI News Service, Kolkata: Jadavpur University has rejected a demand from students that the university authorities not verify the credentials they submitted while applying for a state government scholarship. At JU, the university ad-ministration usually capitulates before students who mount pressure by confining the VC, pro-VC, and other officials to extract their demands. It did not happen this time. The latest unrest at JU started when the university decided to verify the credentials uploaded by the students while applying for the Swami Vivekananda merit-cum-means scholarship offered by the state higher education department. The Mamata Banerjee government launched the scholarship to assist meritorious students from economically backward families who choose to pursue higher education. Students pursuing BTech get ₹1,500 each month during the four years of the course. The eligibility criteria state the total family income for the prospective scholars will not be more than ₹2.5 lakh a year. It also states that since it is a merit-cum-means scholarship students have to pass each semester examination, without supplementary exam, and upload the marks on the portal of the scholarship. A JU official said the problem started when it emerged that two JU students, who could not clear the semester examina-tions, fudged the records and uploaded tampered grade cards on the portal while seeking a renewal of the scholarship. Since the time of Covid-19, students at the university have been issued soft copies of grade cards, and the students coming under the ambit of the scholarship are required to upload the details of the CGPA (cumulative grade point average) on the portal. While there was a delay in clearing the scholarship amount, the two students, accused of tampering with their grade cards, complained to the chief minister's office alleging that they were being denied the scholarship, said a JU official. "The CMO told the department to process the records and clear the scholarship. When the department contacted the university to check the records of these two students, it emerged that the duo submitted doctored records. When this was communicated, the depart-

ment told the university that henceforth JU must verify the records submitted by all students, and the scholarships would be granted after the verification," said a JU official. This decision infuriated the students who confined the VC, pro-VC, other officials and the heads of departments, demanding that no verification would be allowed and the credentials submitted by the students have to be endorsed by the university. "The two students — a boy and a girl — who were summoned to Bikash Bhavan (the education department headquarters) a fortnight ago admitted that they had fudged records following the advice of senior students. This means the malpractice has been going on for some time," said a senior JU official. JU has found out that altogether 42 students stand accused of tampering their records. Bhaskar Gupta, the JU interim VC, told "We left it to students to submit the records to avail of the scholarship. But they have broken our trust by submitting tampered records. The university will now verify the records thoroughly before the details are uploaded on the scholarship portal.

More KMC 'SHCs' keep mobile units at bay

MI News Service, Kolkata: The setting up of more Satellite Health Centres (SHC) to bridge the gap in rendering healthcare services has compelled the Kolkata Municipal Corporation's (KMC) to keep its five mobile medical units in abeyance. According to the KMC, during 2024 as many as 2464763 patients visited the health establishments of the civic body including the urban health and wellness centres (UHWCs), better known as satellite centres. So far, about 22 such UHWCs have been set up in the city to bridge the gap in services. Such centres have helped in taking off some load from the 144 urban primary health centres (UPHCs) in the city. One of the apparent effects of such augmentation of the UHWCs is exterminating the need for the five mobile medical vans of the KMC. An official said these mobile units have now been kept in abeyance since more UHWCs would be coming up in the city, thereby filling in the serv-

ice-gap at the periphery.
The five mobile units were inaugurated in 2018 and were equipped with a doctor, a laboratory technician, a pharmacist and a driver cum helper. It catered to both communicable and non-communicable diseases similar to that of the health centres. Such units were meant to deliver services in the remote areas. Mayor Firhad Hakim had said that the civic body often gets complaints from residents of wards with huge areas where a primary healthcare centre alone is unable to serve the entire population of that ward.

One person died as Uttarakhand govt intensifies rescue operations in avalanche site

From PG 1 Disaster Management Authority, the trapped labour-ers are from Bihar, Uttar Pradesh, Uttarakhand, Himachal Pradesh, Punjab, and Jammu and Kashmir, among other states. The list also has 8 labourers' names, without mentioning the states they belong to. Disaster Management Secretary Vinod Kumar Suman said that the task is challenging as there is at least seven feet of snow near the avalanche site. According to an Army public relations officer (PRO), four of the rescued workers are in critical condition. All 49 rescued labourers have been shifted to the Indo-Tibetan Border Police (ITBP) camp in Mana for medical care. Mana, located three kilometres from Badrinath, is the last village an altitude of 3,200 meters. Footage from the site shows rescue teams struggling through deep snow in a landscape completely blanketed in white. The avalanche had struck between 5.30 am and 6 am on Friday, burying all the 57 workers inside eight containers and a shed in the BRO camp, according to the Army. More

than 100 personnel from the Ibex Brigade, trained for high-altitude rescues, were deployed. The teams included doctors and ambulances. Rescue remain difficult due to continuous snowfall, rain, and darkness. Chamoli's disaster management officer NK Joshi said that while Army and ITBP teams stationed in Mana had been working since morning, reinforcements from outside were however, unable to reach the site because of severe weather conditions. Local villagers noted that the accident site is prone to avalanches during winter and that the BRO camp is usually closed at this time of the

Goyal and other senior officers of the MHA. "The home minister was categorical that the initial phase of efforts to bring normalcy back in Manipur has to focus on recovery of weapons. He also asked the security establishment to ensure no fresh wave of violence started in the state,' a home ministry official said. Sources said the home minister did not broach the subject of talks between warring ethnic communities in the state. "The first priority is to ensure a prolonged period of peace. That will pave the way for talks. Meanwhile, the Intelligence Bureau and North East Advisor A K Mishra will continue to engage groups on either side of the ethnic divide in the state," the official added. Sources said officers from Manipur gave Shah a detailed presentation on all the steps taken in the past couple of weeks to bring normalcy back in the state, informed sources said these meetings are now likely to be held routinely by Shah on the lines of security review meetings held for Jammu and Kashmir. This is the

first security review meeting that Shah held on Manipur after former chief minister N Biren Singh's resignation on February 11. Following this, the Centre had imposed President's Rule in the state with the responsibility of state administration and law and order falling in the hands of Governor Bhalla. Since then, Bhalla has embarked upon a comprehensive overhaul of the security approach in the state, which includes rolling out an amnesty scheme for surrender of weapons, cracking down on militia, and facilitating movement of goods and people across the ethnic divide. Bhalla's amnesty scheme, whose deadline ended on Thursday, facilitated the surrender of 246 weapons by Meitei militia Arambai Tenggol, which has been at the forefront of engaging in gunfights with Kuki militia. The group has also been accused of burning down Kuki villages in the fringes of Imphal Valley in response to similar acts by Kuki groups. To facilitate the further surrender of weapons, the deadline has now been extended to March 6 following demands from Kuki and Meitei groups.

Indian Railways Marks 100 Years of Electric Traction _ A Century of Progress Traction Distribution (TRD) - A Role Model for Indian Railways: ECoR GM

Bhubaneswar: Indian Railways proudly celebrates the centenary of electric traction, marking 100 years of technological evolution and operational excellence since the launch of India's first electric train on 3rd February 1925. Over the past century, electrification has revolutionized railway operations, significantly enhancing efficiency, sustainability, and speed while reducing dependence on fossil fuels.

On this momentous occasion, East Coast Railway (ECoR) General Manager Shri Parmeshwar Funkwal highlighted the crucial role of automation, maintenance, and diagnostics in modern railway operations. He emphasized the need for Indian Railways to adapt to rapid technological advancements and prepare for the next 25 years. Shri Funkwal also underlined the importance of improving asset maintenance and acknowledged Traction Distribution (TRD) as a role model within Indian Rail-

celebration was attended by ECoR Additional General Manager, all Principal Heads of Departments of East Coast Railway, and senior officials, including the Principal Chief Electrical Engineer, who collectively recognized the remarkable journey of railway electrification

The foundation of railway electrification in India was



laid on 3rd February 1925, when the Great Indian Peninsula Railway (GIPR) introduced the first electric train service between Bombay VT (now Chhatrapati Shivaji Maharaj Terminus) and Kurla. This 16 Route Kilometer (RKM) section operated on a 1500V DC traction system and was inaugurated by the then-Governor of Bombay, Sir Leslie Wilson. With this milestone, India became the 24th country in the world to adopt electric traction.

The initial phase of railway electrification posed sever-al technological challenges, including speed control and power transmission. However, continuous innovations led to the adoption of 3000V DC traction in the 1950s, with the Howrah-Burdwan section being the first to be electrified under this system in 1957. Recognizing the superior efficiency of 25 kV AC traction, Indian Railways standardized this system in

1957 based on recommendations from the Traction Advisory Committee.

The centenary of electric traction marks a significant milestone in Indian Railways' journey toward modernization and sustainability. From the launch of a 16 km electric train service in 1925 to achieving 100% broad gauge electrification in 2024, the transformation has been extraordinary. With a vision to achieve net-zero carbon emissions by 2030, Indian Railways is set to redefine the future of railway transportation in India, making it faster, greener, and more efficient.

News Service, Kolkata: Railway Protection Force (RPF),Eastern Railway continues to play a crucial role in assisting local police and law enforcement agencies in maintaining security and curbing crime on railway premises. In a series of successful operations, RPF officials of Howrah, Sealdah, Asansol, and Malda Divisions demonstrated their commitment to safeguarding passengers and ensuring compliance with the law.

On 28.02.2025, under Operation Rail Prahari, RPF

personnel of Howrah Division assisted officials of Wajirganj Police Station, Bihar, in apprehending an accused kidnapper, Nitish Kumar (M-23), and successfully rescuing a minor girl, Manisha Kumari (F-16), from Chandanpur Railway Station. 'If a vehicle is well-maintained...": Mixed reactions to Delhi's 15-year vehicle refueling ban



MI News Service, New Delhi: The Delhi government's decision not to allow refueling for vehicles older than 15 years after March 31 has sparked mixed reactions. While some residents see it as a necessary step to combat pollution, others question its fairness, arguing, "If a vehicle is well-maintained, why ban it?'

Many residents believe roadworthiness should be based on a vehicle's condition rather than its age.

A cab driver backed the decision, telling ANI, "The government is right. Vehicles expire after 15 years, so they should not be driven on the roads. Such vehicles should be sent to the scrapyard.

However, a resident opposed the move, arguing that the focus should be on vehicles that contribute to pollution. "This government decision is wrong. If the condition of the vehicle is good, then its validity should be increased. Only those vehicles should be stopped that are spreading pollution. We maintain our vehicles from time to time, so the decision should be taken only after seeing the condition of the vehicle..." he said while speaking to

Another local supported the measure, saying that it would help reduce air pollution. "Considering the pollution levels in Delhi, I think this decision is appropriate. It will help curb pollution in the city," he said.

Meanwhile, a vehicle owner criticized the decision, saying, "This decision is not right. Vehicles are responsible for pollution in Delhi to a certain extent. Most of the pollution is from dust and factories, so more focus should be on this front..."

A petrol pump manager explained the implementation process, stating, 'A system is being put in place. A machine has been installed at the pump, and speakers and cameras will also be installed."

"Announcements will be made for vehicles whose registration has expired, and our staff will not provide fuel to those vehicles," he said.

He added, "This system has not started yet. Our staff will check the vehicle's registration certificate before providing fuel."

To combat air pollution in the national capital, Delhi Minister Manjinder Singh Sirsa announced the new fuel restriction for vehicles older than 15 years after a meeting with offi-

cials here on Saturday. The Minister for EnWildlife also said that a special team would be formed to identify and restrict the movement of such vehicles in and out of

He added that Delhi Airport, high-rise buildings, large office complexes, and hotels would be required to install anti-smog guns to help control pollu-

'After March 31, fuel will not be provided to vehicles older than 15 years. There are some big hotels, office complexes, the Delhi airport, and construction sites in Delhi. We are going to make it mandatory for all of them to immediately install anti-smog guns to control pollution at their places. We are going to make it mandatory for all the high-rise buildings in Delhi to install smog guns. We are going to make it mandatory for all the hotels in Delhi to install smog guns," Sirsa

told reporters. The Delhi government is also exploring artificial rain through cloud seeding as an additional measure to reduce pollution.

'We are going to make it mandatory for all the commercial complexes... We have decided today that we will take whatever permission we need for cloud seeding, and we will ensure that when there is severe pollution in Delhi, rain can be caused through cloud seeding, and pollution can be con-

trolled," Sirsa added. Air quality in the national capital and surrounding areas typically worsens with the onset of winter, prompting authorities to take urgent action.

New study suggests effects of PTSD on body vary by culture

World Health Organisation, around 3.9 per cent of the global population has had post-traumatic stress disorder (PTSD) at some point in their lives. That figure is greater in the United States, at over 6 per cent.

Individuals can develop PTSD after experiencing or witnessing a traumatic event, which can endure for months or years. However, much remains unknown about this mental health problem. Anthropologists, social scientists, and veterans from Arizona State University and the Naval Postgraduate School are the first to study the link between cortisol and testosterone levels and PTSD in a non-industrialized community

This new study sheds more light on the PTSD puzzle. Previous studies about PTSD and hormones have focused only on people living in Western or European industrialized societies. They included people who suffered from different types of trauma like car crashes, assault and multiple deployments, according to Ben Trumble, a research scientist at the Institute of Human Origins and associate professor at

and Social Change. The studies showed the majority of people diagnosed with PTSD had very little change in their cortisol levels throughout the day. Instead, the results showed "blunted" levels of cortisol and not

the School of Human Evolution

"In healthy men, hormones

like testosterone and cortisol follow a pattern throughout the day," Trumble said. "Hormone levels are the highest just after waking up, and then decline rapidly. Levels are low throughout the day, and rise again at night.'

The big question Trumble and colleagues wanted to answer was, would they see this same pattern in a non-industrialized population with people who suffered from the same type of trauma?

"Our study is the first to examine associations between hormones (cortisol and testosterone) among the Turkana," Trumble said. "Turkana pastoralists experience a high degree of combat exposure, and 28% of men have symptoms of PTSD. Because nearly everyone gets exposed to combat, we can see if there are biological differences in hormones for those with PTSD and those without PTSD. So, in this case we can compare apples to apples and not apples to oranges."
"We did not find any difference

Mathew's relationship with the Turkana since 2007 led to this project and many others, providing valuable information about non-industrialized cooperation, cultural norms and warfare.

While the study answers questions about hormonal regulation, there is still the question of why are the Turkana cortisol levels "normal" in those diagnosed with

PTSD compared with Western populations?

The study sites many possible reasons including physical activity and cultural differences. The scientists say more research is need-


A previous publication by Zefferman and Mathew stated that unlike soldiers of nation-state societies, "Turkana warriors are strongly endorsed by the whole community, have elevated status, perform culturally sanctioned rituals after raids, and are deeply integrated with their correspon-

ding civilian community. These longstanding cultural traditions of warriorhood may buffer them from some of the negative physiological responses to combat trauma.

Mathew and the others emphasize the importance of sharing their findings with the Turkana. The researchers have engaged with the community over several years, and discuss findings from this and other ongoing studies and what these findings mean for future research.

"We can only do this research because of the support and help of the people we do the research with -- the Turkana," Zefferman said. "We acknowledge that their willingness to work with us is what has allowed us to do this research with potential benefits to our society. "We go there at the our society. Key protein identified for treating Alzheimer's disease: Study



Cologne [Germany] : A team of researchers from the University of Cologne has made an important contribution to understanding the role of the tau protein in Alzheimer's disease

Using human induced pluripotent stem cells (iPSCs), the international team demonstrated that a specific variant of the tau protein, known as the 1N4R isoform.

mediates the harmful effects of protein clumping in human brain cells (iPSCs) to demonstrate that

the 1N4R tau isoform is responsible for the pathological effects on the cell. iPSCs are human stem cells that are generated from other cells. For example, skin cells can be reprogrammed into iPSCs and then transformed into brain cells (neurons). The researchers tested different forms of the tau protein by expressing them specifically in nerve cells. This allowed them to analyse how each protein isoform affects the cell. According to Dr Sarah Buchholz, first author of the study, "this study represents a significant advance in helping us to understand the mechanisms of Alzheimer's disease. By identifying 1N4R tau as a key protein, we have discovered a potential new target for future treatments."

The study's interdisciplinary approach not only helps to better understand Alzheimer's disease but also demonstrates the importance of human cell models in neurodegenerative Further studies are needed to translate the results of this study into clinical application, in particular to validate the results in adequate animal models and to develop specific therapeutics that

26 cases filed against Baba Ramdev in Kerala courts so far over misleading ads

MI News Service, Kerala: Baba Ramdev, the prominent yoga guru and businessman, is facing a significant legal challenge in Kerala, where 26 cases have been filed against him in various courts across the state over misleading advertisements for Patanjali Ayurved's products.

These cases stem from violations of the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954 (DMR Act), which prohibits the advertisement of drugs with claims of magical properties or miraculous

On February 20, 2025, an affidavit submitted to the Supreme Court by Sujith Kumar K, the Drugs Controller in Kerala's Drugs Control Department, highlighted how Patanjali Ayurved Limited had breached the provisions of the DMR Act. The affidavit points out that the company's advertisements, which appeared in various print media outlets, falsely claimed that certain Patanjali products could cure or prevent specific diseases, a clear violation of the law.

As a result, legal action was taken not only against the company but also against the newspapers that published these advertisements. The publications under scrutiny include well-known Malayalam and English dailies such as Mathrubhumi, Malayala Manorama, Kerala Kaumudi, and

In total, 31 prosecutions have been launched against the manufacturer of Patanjali's Divya products for allegedly distributing these misleading ads. Of these, 26 cases have been officially registered, while five others remain pending due to non-cooperation from the print media outlets involved.

These cases have been filed in various courts across Kerala, including the Judicial First Class Magistrate courts in Kozhikode, Kottayam, Kakkanad, Thiruvananthapuram, Kattappana, and Palakkad, as well as the Chief Judicial Magistrate courts in Thrissur and Kollam.



He said that Taiwanese universities and research institutions have been prohibited from participating in any academic activities or exchanges with these seven Chinese universities to protect technology vital to national security interests, Taipei Times reported. Since from the US have been restricted from studying or working at these universities.

Dubbed the "seven sons of [China's] national defense," Chinese Ministry of National Defence had founded the universities before they were transferred to the Chinese Ministry of Industry and Information Technology, Cheng said.

The seven universities include Beihang University, Beijing Institute of Technology, Northwestern Polytechnical University, Nanjing University of Aeronautics and Astronau-

Israel mourns hostage as second Phase Gaza ceasefire talks intensify

Jerusalem: Mourners in Israel on Friday were burying the remains of one of the final hostages released in the first phase of the ceasefire between Hamas militants and Israel, as negotiators discussed a second phase that could end the war in Gaza and see the remaining living captives returned home.

The funeral procession for Tsachi Idan, an avid soccer fan who was 49 when he was abducted by Hamas militants, began at a Tel Aviv football stadium en route to the cemetery where he was to be buried in a private ceremony. The office of Israeli Prime Minister Benjamin family hostage in their to me today is the outcome Netanyahu has said Idan, taken from Kibbutz Nahal Oz during the Hamas-led October 7 2023 attack that sparked the war in Gaza, was killed in captivity.

His body was one of four released by Hamas early Thursday in exchange for over 600 Palestinian prisoners, the last planned swap of the ceasefire's first phase, which began in January.

Idan was the only one of his family taken to Gaza. His eldest daughter, Maayan, was killed as militants shot through the door of their saferoom. Hamas militants broadcast themselves on Facebook live holding the Idan

home, as his two younger children pleaded with the militants to let them go.

"My brother is the real hero. He held on," Idan's sister, Noam Idan ben Ezra, said in an interview on Israeli radio Friday. She said Idan had been "a pace away" from being released during a brief ceasefire in November 2023, when more than 100 of the 251 people abducted on October 7 were

released. "Tsachi was forsaken twice. The first time when he was kidnapped from his home and the second time when the deal blew up, she added. "The fact that Tsachi is not standing next

With the first phase of the ceasefire deal set to end Saturday, relatives of hostages still held in Gaza are ramping up pressure on Netanyahu to secure the release of their loved ones.

According to Israel, 32 of the 59 hostages still in Gaza are dead, and there has been growing concern about the welfare of an unknown number who are still alive, particularly after three hostages released February 8 appeared emaciated.

"EFFORTS OF ENTIRE TEAM CAME TOGETHER": MINNU MANI ON DELHI CAPITALS' PER-FORMANCE AGAINST MUMBAI INDIANS

BENGALURU (KARNATAKA): An all-around effort led the Delhi Capitals to a dominant nine-wicket win over the Mumbai Indians in their sixth match of the WPL 2025 at the M. Chinnaswamy Stadium on Friday.

Minnu Mani and Jess Jonassen bagged three wickets each, restricting Mumbai Indians to 123/9 in 20 overs. Delhi Capitals then chased the target in just 14.3 overs, courtesy of Meg Lanning's unbeaten 60 off 49 balls and Shafali Verma's 43 off 28. This victory took them to the top of the points table with four wins, two losses, and eight points.

Reflecting on the performance, Mani, who returned with stunning figures of 3/17 in three overs, said they performed well in all departments.

"The efforts of the entire team came together nicely on the field. We always keep things simple and stick to our plans in every match. Whatever strategies we make, we ensure they are executed well on the ground. It was the same approach today, nothing new," she said, according to a release.

The 25-year-old player from Wayanad, Kerala, has been a part of Delhi Capitals since the inception of the WPL. She went on to make her T20I debut in the same year and became the first woman from Kerala to play for India.

Speaking about her journey and learnings so far, Mani said, "The senior players in the team have been very help ful. Compared to my first and second year, my bowling has improved a lot. They have guided me on how to bowl according to the situation and the batters, what kind of length and line to use, when to make changes, and how to adapt. I've learned all these things from them, including how to manage myself during the game.'

When asked about playing under the captaincy of the legendary Meg Lanning, Mani said, "I admire Meg Lanning a lot, and playing under her has helped me learn so many new things. She is always supportive of all the players, both on and off the field. Whenever we discuss something or ask her for advice, she always has plenty of insights and ideas to share. It has been a truly special experience to play along-side her."

After completing a double over Mumbai Indians, Delhi Capitals will now take on the home side, Royal Challengers Bengaluru. They will be the first team in the WPL to play on back-to-back nights and will aim to end the Bengaluru leg with a win and further extend their lead on the top of the points table.

Karun Nair's unbeaten 132 puts Vidarbha on course for Ranji Trophy glory

NAGPUR (MAHARASHTRA) [INDIA]: Had things unfolded differently two seasons ago, Karun Nair might have been playing for Kerala. After Karnataka unceremoniously dropped him, Nair reached out to Kerala, but they couldn't commit at the time. Having already spent an entire season without competitive cricket, he couldn't afford to wait. That's when Vidarbha came knocking, and he seized the opportunity, as per ESPNcricinfo.

Two seasons later, Nair is leading Vidarbha's charge toward their third Ranji Trophy title. He batted the entire day, crafting an unbeaten 132, his 23rd first-class century and fourth of the season pushing Vidarbha's lead to 286 at stumps with six wickets in hand. If he lifts the trophy, it will be his third, having won his first two with Karnataka in 2013-14 and 2014-15.

Nair's innings might have been cut short early, but fortune favoured him. On 31, during the morning session, an awkwardly rising delivery from young pacer Eden Apple Tom caught his glove and lobbed towards first slip, only for Akshay Chandran to drop a straightforward catch. Had that chance been taken, Vidarbha would have been reeling at 55/3. Instead, Nair and Danish Malewar, a 21-year-old in his debut season, made Kerala pay, adding to their unfinished business from the first innings, where a mix-up had led to Nair's run-out

The duo stitched together an 182-run stand for the third wicket. Malewar, who had already impressed with 153 in the first innings, contributed 73, steadying the innings after the early dismissals of Parth Rekhade and Dhruv Shorey in the first three overs. Rekhade was beaten through the gate by Jalaj Saxena's in-drifter, while Shorey fell to a brilliant diving catch by Mohammed Azharuddeen at first slip, giving MD Nidheesh an early breakthrough.

Kerala had more opportunities

to break the partnership but failed to capitalize. Malewar survived an lbw appeal against Saxena, with DRS ruling it as umpire's call. That was just the beginning of a frustrating period for Kerala. They dropped a crucial catch of a big-match player, saw their pacers Nidheesh and N Basil receive two warnings each for running onto the danger area, and allowed two healthy edges off Saxena to slip through an unmanned cordon. Instead of attacking, Kerala found themselves on the back foot, and Vidarbha capitalized.

Malewar had another stroke of luck when he overturned an lbw decision against Nidheesh, with replays showing the ball swinging late and missing leg stump. Despite the early action, Kerala failed to stay aggressive, ultimately paying the price. Nair took full advantage of the

Nair took ithi advantage of the field placements, piercing gaps through covers as Kerala left the off-side open to invite him to drive against the turn. His well-executed reverse sweeps along the ground made him even tougher to contain. Malewar, meanwhile, absorbed the pressure from Saxena, playing within himself until reaching his half-century, after which he showcased his confidence with a glorious lofted drive over mid-off.

As the partnership flourished, Kerala briefly resorted to a legstump line in an attempt to unsettle the batters. However, with Vidarbha already sitting on a comfortable lead, Kerala realized too late that they needed to be more aggressive by then, the pair had already added over 100 runs.

Nair survived on 65 when a leading edge off Saxena fell just short of the bowler. He responded by playing a reverse sweep, neutralizing any pressure. He soon crossed the 800-run mark for the season and raced into the 80 with back-to-back sixes off Aditya Sarwate, sending one over long-on and the other over long-off. Upon reaching his century, Nair dropped his bat, removed his gloves, and held up both palms towards the dressing room--a symbolic nod to his nine centuries across the season before settling back into his innings.

across the season before settling back into his innings.

The long-standing partnership finally ended when Chandran's part-time left-arm spin found Malewar's glove, with Sachin Baby taking a sharp catch at slip. Yash Rathod then joined Nair and batted fluently, even surpassing Madhya Pradesh's Shubham Sharma to become the season's leading run-scorer at one stage.

Kerala briefly found some

respite when Sarwate got one to turn sharply, trapping Rathod lbw--a decision that went their way upon DRS review. However, such moments were rare for Kerala on a day dominated by frustration. With their hopes of a maiden Ranji Trophy title hanging by a thread, they now need nothing short of a miracle to stage a comeback on the final day.

PCB 'considering' domestic players for T20I series in New Zealand

LAHORE [PAKISTAN]: The Pakistan Cricket Board (PCB) has decided to give the domestic players the opportunity to play in the upcoming T20I series against New Zealand after Pakistan's shambolic run in the ongoing Champions Trophy, Geo News reported citing sources.

Sources informed Geo News that domestic players have been asked to travel to Lahore for the selection process for the five T20Is against the Blackcaps, beginning on March 16. In addition, a meeting will be held between the young cricketers and board officials.

With the T20 World Cup set to be held next year in Indian and Sri Lanka, the decision to send domestic players to New Zealand could turn out to be PCB's long-term strategy for the marquee event.

In addition to the recent developments, former wicketkeeper-batter Rashid Latif suggested a list of young players who should be considered for the upcoming series. Hassan Nawaz, Ali Raza, Abdul Samad, Akif Javed and Muhammad Nafay were some of the



players he recommended.

His other recommendations for the probable squad included Muhammad Haris, Sufyan Muqeem, Arafat Minhas, Irfan Khan Niazi, Zaman Khan, Mohammad Wasim, Abbas Afridi, Jahandad Khan, Agha Salman, Abrar Ahmed, Omair Bin Yousuf and Khushdil Shah.

Notably, some reports claim that Pakistan players are considering opting out of their white-ball tour of New Zealand. The players are considering taking a "break" from the white-ball tour, which consists of five T20Is and three ODIs.

The recent changes in Pakistan's camp stem from their dreadful run in the Champions Trophy. As a global cricket event returned to Pakistan after nearly three decades, New Zealand stepped up to spoil the party.


