MI News Service, New Delhi: Even as the actual festival of Holi is at least 24 hours away, people across the country have already started celebrating the joyous occasion by sprinkling colours on one another and participating in music, dance and other traditional festivities.

From temples to streets, vibrant hues and joyous gatherings mark the onset of the festival, symbolising the triumph of good over evil.

In several states, celebrations began on Thursday evening with the Holika Dahan, a ritual bonfire that symbolises the victory of devotion and righteousness.

In Mathura and Vrindavan, famous for their grand Holi celebrations, devotees began the traditional rituals, including the famous Lathmar Holi.

Cities like Varanasi, Jaipur, and Delhi witnessed enthusiastic crowds smearing each other with colors and enjoying festive treats like gujiya and thandai.

However, everywhere heavy police deployment was made to maintain peace and ensure peaceful celebrations.

In Rajastĥan's Jaisalmer, holi celebrations were held at the Shri Lakshminath Ji temple on the day of Holika Dahan. Prayers were offered, bhajans were sung, and colours were smeared on each other at the temple premises.

Border Security Force (BSF) personnel posted at border outposts also celebrated Holi on Thursday with great enthusiasm. To make the experience memorable, the senior officers and jawans make special arrangements ahead of the festivities by distributing sweets.

Holi celebrated at Sambhal's Kartikeya Mahadev first time in 46 years

MI News Service, Sambhal (UP): Thousands of devotees from all across the state celebrated Holi at Kartikeya Mahadev in Khaggu Sarai on Thursday for the first time in 46 years amid tight security,

The event saw enthusiastic and joyful participation from a number of social and Hindu organisations at the temple, which was reopened last December after it was shut following riots in 1978.

Additional Superintendent of Police (ASP) Shreesh Chandra said ample police forces have been deployed to ensure a smooth and peaceful celebration of Holi.

Holi was celebrated peacefully at the Kartikeya Mahadev Temple in Khaggu Sarai. There is no need for anyone to worry. People have enjoyed the festival in a secure environment," he said adding that there was no report of any tension or any untoward incident from anywhere.

The temple is located close to Shahi Jama Masjid, a site which has been at the centre of controversy following violence on November 24, 2024, that led to the death of four people. The violence had broken out after a group of people held a protest during a court-ordered survey of the mosque. Vishwa Hindu Parishad (VHP) district President Anand

TMC's strategy meeting on 'Phantom Voters' by Abhishek, set for Mar 15

MI News Service, Kolkata: The Trinamool Congress (TMC) is set to hold a virtual mega meeting on March 15 to address concerns over 'phantom voters' in the electoral rolls. The meeting will be chaired by Abhishek Banerjee, the party's All-India General Secretary, and will be attended by core committee members, MPs, MLAs, district presidents, municipal chairpersons, and senior party leaders.

According to party sources, the meeting will include members of the state committee, municipal councillors, district council heads, and key organizational leaders. This initiative follows Chief Minister Mamata Banerjee's strong stance on the issue, which she first raised during an assembly session before reiterating it at the TMC's mega rally at Netaji Indoor

The issue of fraudulent voters in the electoral rolls has become a significant concern for the TMC. Mamata Banerjee has accused the BJP of attempting to manipulate voter lists to gain an advantage in the 2026 Assembly elections. She has alleged that the Election Commission, under BJP's



influence, is allowing inclusion of fake voters in the rolls to artificially boost the party's electoral prospects. To counter this, the TMC formed a high-level committee led by senior party leader and TMC President Subrata Bakshi to investigate and address the problem. Abhishek Banerjee, along with other top leaders, is also part of this committee. The first review meeting took place on March 6 at Trinamool Bhavan, where initial findings were discussed, and it was decided that a follow-up meeting would be held on March 15.

Abhishek Banerjee, who was unable to attend the March 6 meeting due to prior engagements, has taken direct charge of the voter list investigation and has called for a detailed review meeting. Initially scheduled for March 16, the meeting was later rescheduled to March 15 to ensure maximum participation from senior leaders. The upcoming meeting is expected to assess the progress of voter list verification efforts, identify irregularities, and discuss strategic measures to

ISRO undocks Spadex satellites, paves way for India's lunar exploration

MI News Service, New Delhi: The Indian Space Research Organisation (ISRO) has announced successful the completion of its SpaDeX mission's (space) de-docking on Thursday, marking a significant milestone in India's future in space exploration.

Congratulating ISRO for achieving this rare feet,Union Minister Jitendra Singh said the ISRO team had accomplished the unbelievable de-docking" of "SPADEX satellites and the event was "heartening for every Indian!"

"This paves the way for smooth conduct of ambitious future missions including the Bharatiya Antriksha Station, Chandrayaan Gaganyaan," Singh said in a post on X.

Further he said that "PM Narendra Modi's continuous patronage keeps the spirits soaring.

The undocking process involved a precise sequence of events, culminating in the separation of the SDX-01 (Chaser) and SDX-02 (Target) satellites that was launched on December 30 in 2024, using Polar Satellite Launch Vehicle (PSLV)-C60, from the Satish Dhawan Space Centre in Sriharikota.

It included the successful extension of SDX-2, the planned



release of Capture Lever 3, and — satellite servicing, space station the disengagement of the Capture Lever in SDX-2. After these mand was issued in both SDX-1 and SDX-2, leading to the successful separation of the satel-

ISRO successfully completed docking of the two SPADEX satellites (SDX-01 and SDX-02) in the early hours of January 16 this year, making India becoming the fourth country -alongside China, Russia and the United States-in the world to

have space docking technology. According to ISRO, the groundbreaking mission aims to showcase India's technological prowess in spacecraft rendezvous, docking, and undocking -- a critical capability for future advancements such as operations, and interplanetary exploration.

It is a cost-effective technology demonstrator mission for the demonstration of in-space docking using two small spacecraft launched by PSLV.

This technology is essential for India's space ambitions such as putting an Indian on Moon, sample return from the Moon, the building and operation of Bharatiya Antariksh Station (BAS).In-space docking technology is essential when multiple rocket launches are required to achieve common mission objec-

The SpaDeX spacecraft were designed and realized by the UR Rao Satellite Centre (URSC) with the support of other ISRO centers.

MI News Service, New Delhi : With both Airtel and Jio announcing partnerships with Starlink, the Congress on Thursday alleged that these have been orchestrated by Prime Minister Narendra Modi "to buy goodwill" with US President Donald Trump through Starlink's owner Elon

The largest opposition party also said many questions remain unanswered and the most important one relates to the na-

Congress General Secretary in-charge Communications Jairam Ramesh said that within literally 12 hours both Airtel and Jio have announced partnerships with Starlink, seemingly overcoming all their objections to its entry into India - which they have been voicing for quite some

time. India's largest telecoms company Reliance Jio and its rival Bharti Airtel have signed separate deals with Elon Musk's SpaceX to bring the Starlink internet service to the country.

The move has caught most analysts by surprise, as Musk has publicly clashed with both companies recently. It comes as Indian and US officials discuss a trade deal. US President Donald Trump has threatened to impose retaliatory tariffs on 2 April. The agreements, touted to expand satellite internet coverage across India, are still conditional upon SpaceX obtaining the Indian government's approval to begin operations. Starlink had 4.6 million subscribers across the world, as of

Rahul Gandhi slams BJP over exam paper leaks, saying future of 85 lakh students is at stake

MI News Service, New Delhi: Leader of Opposition Rahul Gandhi has emphasised that leaks of examination papers were a "systematic failure", and hoped that this "serious problem" could be eradicated if all political parties and governments set aside their differences and take a united but stern steps together.

The senior Congress chief said the future of 85 lakh children in six states is at risk as paper leak has become the most dangerous "padmavyuh" for our youth.

"Paper leaks put hardworking students and their families into uncertainty and stress, taking away the fruits of their hard work. It also sends the wrong message to the next generation that dishonesty can be better than hard work, which is completely unacceptable," he said in a post in

"It has not even been a year since the NEET paper leak shook the country. After our protest, the Modi government hid behind a new law and called it a solution, but so many recent leaks have proven that to be a failure as well," he said. This serious problem is a systematic failure, Gandhi asserted. It will be eradicated only when all political parties and governments forget their differences and take strict steps together, the Leader of Opposition in the Lok Sabha said. "The dignity of these exams is the right of our children and it has to be protected at all costs," Gandhi asserted. Using the 'chakravyuh' metaphor as a leitmotif, Rahul Gandhi had last year claimed that an


Putin-Trump meeting can be arranged 'quickly' after US resumes Ukraine aid

MI News Service, Moscow : A day after the US lifted its suspension of military aid and intelligence sharing for Ukraine, Russia has remarked that a phone call between President Vladimir Putin and his US counterpart Donald Trump could be arranged "very quickly" if necessary, according to the state-run TASS news agency.

The Trump administration on Tuesday resumed military aid and intelligence sharing for Ukraine, as Kyiv endorsed a US proposal for a 30day ceasefire in the war with Russia, pending Moscow's approval, during pivotal talks in Saudi

Reacting to the development, the Kremlin said it does not rule out the possibility that the issue of a telephone conversation between Putin and Trump may arise following the US-Ukrainian negotiations and could be organised swiftly.



to prevent water body during holi MI News Service, Kolkata: In a stringent pre-festival directive, Kolkata Police warned revelers against entering water bodies for a bath after consuming alcohol during Dol and Holi. To enforce this, law enforcement agencies will closely monitor at least 66 Ghats across the city on Friday and Saturday. Additionally, local clubs have been cautioned to prevent individuals from entering ponds or lakes in an intoxi-

cated state. Sources indicate that police stations have already begun public announcements via loudspeakers to spread awareness about safety regulations. On the festival days, officers have been instructed to swiftly respond to even minor disturbances. To ensure order in narrow lanes and bylanes, dedicated bike patrol units will also be deployed. A key focus remains on maintaining communal harmony during the cele-

brations. Over the past two years, three people have drowned in Kolkata's rivers and lakes during Dol festivities, prompting authorities to take preemptive measures this year. Special security arrangements will be in place across 66 Ghats, covering both the Hooghly River and various ponds and lakes. Notably, Kolkata

Police's Disaster Management Group will be sta-tioned at 44 ghats to prevent mishaps. These teams will not only be responsible for safety but also for ensuring that no intoxicated individuals enter the water.

In a citywide operation, approximately 21,000 police personnel will be deprevent ployed law-and-order disruptions. Senior officers, including Joint Police Commissioners and Deputy Commissioners, will personally oversee security arrangements. More than 100 key locations across Kolkata will have police pickets. Furthermore, 58 PPR

(Police Patrol Response) vans will conduct regular surveillance across the city, and bike patrol units will navigate congested areas to prevent any untoward incidents. Strict measures have also been implemented to curb nuisance activities such as throwing water balloons or colours from high-rise balconies onto pedestrians. Additionally, police teams will ensure that stray dogs and other animals are not subcolour smearing.Police have assured the public that in the event of any disturbance, enforcement teams will reach the scene promptly to restore order.

State Transport Dept implements reforms to ease traffic congestion

MI News Service, Kolkata: Chief Minister Mamata Banerjee has voiced concerns over insufficient pubtransportation, particularly on key routes such as the airport and Nabanna, after witnessing passengers struggling to find buses. This prompted the Transport Department to take immediate steps to increase bus frequency and trips across several routes.

However, Transport Minister Snehasis Chakraborty, on Thursday, clarified that deploying government buses on all routes is not feasible, especially where private bus services are already operating efficiently.

Local police, municipal authorities, and Toto unions will work together to implement this system effec-On Thursday, Transport Minister Snehasis Chakraborty acknowledged the issue, he stated that the government aims to control their movement by introducing registration measures and issuing official stickers for easy identification. Additionally, specific guidelines will be introduced to ensure smoother traffic management. A special committee will be formed to frame these guidelines, comprising representatives from municipal bodies, traffic authorities, nodal agencies, and Toto unions.

Humayun Kabir showcaused over controversial remarks

MI News Service, Kolkata: In a fresh controversy, Trinamool Congress (TMC) MLA HumayunKabir has been issued a showcause notice by the party's disciplinary committee following his remarks against Leader of the Opposition, SuvenduAdhikari. The decision came after a high-level discussion in the West Bengal Assembly on Thursday, with Chief Minister Mamata Banerjee instructing strict action. Kabir has been given 24 hours to respond. Additionally, Minister Siddiqullah Chowdhury has been advised to refrain from making any statements on the matter.

The controversy erupted after SuvenduAdhikari made a remark that triggered strong reactions from Kabir. Speaking outside the Assembly on Thursday, Kabir questioned why the administration had not taken suo-motu action against Adhikari for his comments. He accused the police of inaction and criticized the authorities for allowing communal tensions

"If SuvenduAdhikari continues his attacks on an entire community and does not retract his statement, send him to Murshidabad. Let us know in advance when he is coming, and I will ensure he is surrounded. He must withdraw his words, or he will see what happens in Murshidabad," Kabir warned.

Kabir also asserted that his community's honor came before his political allegiance. "My community comes first, not my party. If you attack my people, do you think I will remain silent? I will not spare Suvendu unless he withdraws his remarks," he declared.

Investigation progresses in businessman's murder case

MI News Service, Kolkata: The investigation into the app cab murder case involving the recovery of a businessman's body inside a trolley bag has advanced significantly. Detectives from Ghola Police Station have contacted the family of the deceased, Bhagarama Singh, in Rajasthan. Reports indicate that his relatives will soon travel to Kolkata. On Wednesday midnight, the arrested suspects, Krish and Karan, were taken to the crime scene for a reconstruction of events. Investigators made them reenact the crime inside the house where the murder allegedly took place. During interrogation, the suspects revealed that they had been working with Bhagarama Singh for over five months. However, the businessman reportedly failed to repay a substantial sum despite multiple reminders. The tension escalated over the past week, culminating in the murder. Krish confessed to slitting Bhagarama's throat, but investigators suspect Karan was also actively involved in the killing. SCIENTISTS FOUND FOUR TINY PLANETS ORBITING ONE OF OUR NEAREST STARS

Astronomers have revealed new evidence that there are not just one but four tiny planets circling around Barnard's Star, the second-nearest star system to Earth.

The four planets, each only about 20 to 30% the mass of Earth, are so close to their home star that they zip around the entire star in a matter of days. That probably means they are too hot to be habitable, but the find is a new benchmark for discovering smaller planets around nearby stars.

"It's a really exciting find -- Barnard's Star is our cosmic neighbor, and yet we know so little about it," said Ritvik Basant, Ph.D student at the University of Chicago and first author on the study. "It's signaling a break-through with the precision of these new instruments from previous generations.

The finding adds weight to a November study by a team using a different telescope, which had found strong evidence for one planet around Barnard's Star and hints


hopes of finding planets around it. First discovered by E. E. Barnard at Yerkes Observatory in 1916, it is the nearest system that has the same configuration we do -- i.e., with only one star. (The absolute nearest star system to us, Proxima Centauri, has three stars circling each other, which changes the dynamics of planet formation and

Barnard's Star is a type called an M dwarf star, which we now know are extremely numerous in the universe. Scientists, therefore, would like to know more about what kinds of planets they host.

The trouble is that these faraway planets are far too tiny to be seen next to the brilliance of their stars, even with our most powerful telescopes. That means scientists have had to get creative to search for them.

One such effort was led by UChicago Prof. Jacob

Bean, whose team created and installed an instrument called MAROON-X, which is attached to the Gemini Telescope on a Hawaiian mountaintop and designed specifically to search for distant planets.





Study group formed to know if water pollution occurs due to immersion of PoP idols

MUMBAI: Maharashtra minister Pankaja Munde on Wednesday said a study group has been formed by the state government's science and technology commission to ascertain whether pollution occurs due to immersion of Plaster of Paris (PoP) idols in water bodies.

The Environment and Climate Change Minister told the state legislative assembly that the study group has been formed by the Rajiv Gandhi Science and Technology Commission headed by nuclear physicist Dr Anil Kakodkar.

Responding to a calling attention motion, Munde said the state government was taking steps to follow the pollution norms, but at the same time not let the businesses and festivities be affected due to the ban on the use of PoP for making idols.

Tall idols of Lord Ganesh are made from PoP, which are installed during the 10-day Ganesh festival celebrated on a large scale across Maharashtra.

Munde said on January 21, she held a meeting with several MLAs and Women and C h i I dDevelopment Minister Aditi Tatkare over the Bombay High Court's directive to strictly comply with the Central Pollution Control Board (CPCB) guidelines that ban the use of idols made of PoP and their immersion in water bodies.

According to her, the MLAs stated that some NGOs and scientists are of the opinion that PoP does not lead to pollution of water

"I also asked (them to give) for scientific reasons behind it (that PoP does not lead to pollution) and we will send them to the CPCB and take a decision accordingly," Munde said.

The issue is not only emotive but also the one related to employment, Munde said.

She said Cultural Affairs Minister Ashish Shelar visited the Rajiv Gandhi Science and Technology Commission's office in Mumbai and requested its officials to explain what kind of pollution occurs due to the PoP idols. The commission accepted it.

"A study group has been formed and a report will be presented before the court. Evidence (that PoP idols do not lead to pollution) needs to be given to the CPCB. We are gathering evidence and telling the CPCB about it," Munde said.

When asked by NCP MLA Anil Patil whether the state government will file a review petition in the Bombay High Court, Munde said the department was positive about it.

Blood test shows promise for early detection of dementia

QUEBEC: A simple blood test for people with a certain sleep disorder may help predict the development of dementia years before symptoms occur, according to a

new study. Idiopathic REM sleep behaviour disorder (iRBD) causes people to physically act out their dreams while sleeping. The disorder is also associated with a very high risk of Parkinson's disease and a related condition called Dementia with Lewy Bodies. This is a form of dementia that often causes memory and cognitive loss. as well as vivid visual hallucinations and movement difficulties similar Parkinson's

University McGill researchers have discovered that a blood test, originally developed to detect Alzheimer's disease, could also identify which patients with the iRBD sleep disorder are most likely to develop Dementia with Lewy Bodies The blood test analyzes two proteins in the blood that serve as biomarkers for Alzheimer's.

"Detecting dementia risk early could have significant implications for how doctors guide patients, helping them plan for the future and potentially allowing for more personalized, effective treatments," said Dr Ronald Postuma, a Professor in McGill's Department of



Neurology and a clinical researcher at The Neuro (Montreal Neurological

Institute-Hospital). Researchers followed 150 iRBD patients, testing their blood for the biomarkers and tracking their health annually. Remarkably, the blood test, taken four years before,

However, there may be a limit to how much skillful parenting may boost a newborn's language and cognitive skills, particularly if the family is experiencing substantial depri-

If someone has basic needs covered such as stable access to housing, food and insurance, "then parenting can make a difference," Barch said. "But if basic needs are not met, that's



cognition, and parenting doesn't have the opportunity to have the positive influence.

Supportive parenting may not be able overcome the "hit" that deprivation causes to a newborn's brain development. The research can be helpful in developing social programs that invest in prenatal care and parent training.

First author Shelby Leverett, a PhD student in neuroscience at WashU Medicine, explained they were initially surprised by the results because much of the scientific literature shows that parenting skills can be an effective intervention target, but the majority of those findings may be based on a narrower, more advantaged, sampling of the 'social disadvantage" spectrum.

"It's really important that we aim to support families so we can eliminate disadvantage and kids have a chance to develop optimally," Leverett said.

IPL 2025: MITCHELL MARSH CLEARED TO PLAY FOR LSG ONLY AS BATTER

NEW DELHI [INDIA]: Australia T20 skipper Mitchell Marsh has been cleared to play for Lucknow Super Giants only as a batter in the upcoming edition of the Indian Premier League (IPL) 2025, according to ESPNcricinfo.

Marsh is set to travel early next week despite missing out on the recently concluded Champions Trophy due to a back injury. The 33-year-old all-rounder was ruled out of Australia's ODI tour of Sri Lanka and the Champions Trophy due to "lower back pain and dysfunction."

According to ESPNcricinfo, Marsh went to see a back specialist in early February and underwent a period of rest to resolve the problem. In recent weeks, he returned to batting and has been cleared to play in the IPL for LSG only as a batter.

In the mega auction held last year in Jeddah, LSG acquired him for Rs 3.3 crore. Mash is expected to join the LSG camp on March 18, where he will reunite with his former head coach, Justin Langer, who is set to enter his second season with the fran-

Marsh has not played competitive cricket since January 7. His last appearance was in the Big Bash League (BBL) for the Perth Scorchers, and he was rested for the final two matches of the competition.

Before BBL, he made his last appearance in the whiteball format during Australia's tour of the UK in September.

Before getting picked by LSG, Marsh represented the Delhi Capitals in the last three IPL seasons. His time in the cash-rich league has been riddled with injuries. In the last edition of the cash-rich league, he sustained an injury in his hamstring after four games and returned home to rehab.

Meanwhile, Australia's famed pace trio Mitchell Starc, Josh Hazlewood and Pat Cummins, who missed the Champions Trophy, are expected to be fit for the tournament.

Sudirman Cup: India drawn in Group D with Indonesia, **Denmark and England**



XIAMEN [CHINA]: The Indian badminton team is grouped alongside Indonesia, Denmark and England for the Badminton World Federation (BWF) Sudirman Cup Finals 2025 which will be held in Xiamen, China from April 27 to May 4.

The draws were announced on Thursday, as per Olympics.com. Sudirman Cup is an international mixed team competition held every two years.

Each tie in the competition features five matches, one each of men's singles, women's singles, men's doubles, women's doubles and mixed doubles. A total of 16 teams will be taking part in the 19th edition of the tournament. Four seeded teams were placed in separate groups during the draw and defending champions and hosts China are top seeds in group A. Indonesia, South Korea and Japan are seeded second, third and fourth, respectively.

The competing teams include defending champions, tournament hosts and top-performing sides in Asian and European mixed team continental championships. India made it to the Sudirman Cup 2025 based on their rankings. Winners from mixed team continental championships of Africa, Oceania and Pan America also secured

their spots in the tournament. Furthermore, China qualified both as hosts and reigning champions, giving Asia an additional qualifying berth.

With 13 title wins, China is the most successful team in the Sudirman Cup history. South Korea have four titles while Indonesia have one title to their name.

India produced its best results in the Sudirman Cup in 2011 and 2017, reaching the quarterfinals. In the last edition, India was eliminated in the group stage, losing to Malaysia and Chinese Taipei.
