Justice Joymalya Bagchi takes oath as SC judge

MI News Service, New Delhi: Chief Justice of India (CJI) Sanjiv Khanna administered the oath of office to Justice Joymalya Bagchi, a judge of the Calcutta High Court, as a Supreme Court judge here on

The CJI administered the oath to Justice Bagchi in presence of several other Supreme Court judges at a ceremony on the apex court premises.

With the swearing in of Justice Bagchi, the top court will have 33 judges against its sanctioned strength of 34.

Justice Bagchi, a judge of the Calcutta High Court is set to become the Chief Jus-

tice of India in 2031. Justice Bagchi's name was cleared by the central government on March 10 for appointment as a Supreme Court judge.

On March 6, a five-member collegium headed by CJI Khanna recommended his name for Supreme Court judgeship.

The collegium — also comprising Justice BR Gavai, Justice Surya Kant, Justice Abhay S Oka and Justice Vikram Nath noted that no Calcutta High Court judge had risen to become the CJI since the retirement of Justice Altamas Kabir on July

Justice Bagchi is poised for a remarkable tenure, serving over six years in the top court, with the added distinction of holding the office of Chief Justice of India.

Born on October 3, 1966, Justice Bagchi will assume the office of CJI upon the retirement of Justice KV Viswanathan on May 25, 2031. His tenure will last till his retirement on October 2, 2031.

Justice Bagchi was appointed a judge in the Calcutta High Court on June 27, 2011. He was transferred to the Andhra Pradesh High Court on January 4, 2021. Later in November 2021, he was repatriated to the Calcutta High Court and has been functioning there since then.

He has served as a high court judge for more than 13 years and stands at serial number 11 in the combined all-India seniority of high court judges, including chief justices.

India and New Zealand ink pacts on Defence and trade

MI News Service, New Delhi: Even as Prime Minister Narendra Modi has conveyed concerns to his New Zealand counterpart Christopher Luxon over certain unlawful elements carrying out anti-India activities in that Pacific island nation, both the countries signed a mega pact on Monday to institutionalise their defence and security ties.

However, setting aside these con-cerns, both the Prime ministers held wide-ranging talks with a focus on ramping up overall bilateral ties, especially in areas of trade, defence, education and agriculture.

In his media statement, PM Modi said both sides have decided to strengthen and institutionalise defence and security partnership and a roadmap will be prepared for cooperation in the defence industry

"We both are unanimous against terrorism. Whether it is the Christchurch terrorist attack of March 15, 2019, or the Mumbai attack of November 26, 2008, terrorism in any form is unacceptable,

The prime minister further stated that strict action is necessary against those guilty of terrorist attacks. "We will continue to cooperate together against terrorist, separatist and radical elements," Modi said.

"In this context, we shared our concern about anti-India activities by some illegal elements in New Zealand," he said. PM also Modi said India is confident that it will continue to receive

Upon arrival, Banerjee

paid her respects at Dada Huzur's mausoleum, engaging in prayers alongside the shrine's clerics. She then participated in the Iftar event at the Dhanpota Musafir Khana, where she interacted with numerous senior clerics, including Pirzada Imran Siddique, Pirzada Mehrab Sid-dique, and Pirzada Syed Nazimuddin Hossain. During these interactions, the clerics proposed the establishment of a university named after Dada Huzur to honor his

Tulsi Gabbard held talks with Rajnath Singh to boost **Indo-US defence ties**



MI News Service, New Delhi : US Director of National Intelligence Tulsi Gabbard held talks with Defence Minister Rajnath Singh here on Monday focusing on boosting defence and security ties between the two countries.

Gabbard who is on a two-day visit to New Delhi, is here to find ways to enhance defence and security ties between India and the USA. Several other issues relating to intelligence gathering were also discussed during the hour long meeting be-tween Singh and Gabbard,

sources said. Gabbard arrived in New Delhi early Sunday for her maiden visit, marking the first high-level trip to India by a senior official of the Donald Trump administration.

Soon after her arrival in New Delhi on Sunday morning, National Security Advisor Ajit Doval met Gabbard and had held a one on one meeting with her. According to sources, during the meeting they had a detailed discussion on several facets of the India-US relationship.

Tulsi Gabbard is visiting India as a part of her multi-nation trip. The Asia leg of Gabbard's visit will culminate in an address on March 18 at the Raisina Dialogue, a multinational gathering of security offi-cials in Delhi, to which Prime Minister Narendra Modi has invited her.

In a social media post, Singh said he was "happy" to meet the US national intelligence chief and that they discussed ways to further deepen the India-US partnership

Meanwhile, Doval has

also chaired the important security meet with Gabbard and other top intelligence officials including US Director of National Intelligence, Canadian spy chief Daniel Rogers, and UK National Security Adviser Jonathan Powell among others. Discussions were held on how to improve cooperation in dealing with security challenges, including terrorism and the risks from new emerging technolo-

Indo- US military exercises in cooperation with the India-US global strategic partnership were also discussed along with talks on cross-border terrorism . A defence deal was also reportedly discussed.

The development holds special significance in the India-US relations since it marks the first high-level visit to India by a senior of-ficial from the Donald Trump administration.

In a one-on-one meeting, talks on how to improve and better the intelligence sharing between the US and India, were held between Doval and Gabbard. Discussions were also carried out on how New Delhi and Washington can work together more closely on security. The key meet also covered security in the Indo-Pacific region, efforts to fight terror funding and money laundering, and topics related to extradition and immigration. The intelligence leaders also reportedly talked about various global issues, including the Ukraine war and the conflict in the Middle

SC allows RG Kar rape and murder victims' parents to approach Calcutta HC

MI News Service, New Delhi / Kolkata: The Supreme Court on Monday granted the parents of the victim in the RG Kar Medical College rape and murder case the liberty to approach the Calcutta High Court, where their plea is already filed.

A bench led by Chief Justice of India Sanjiv Khanna allowed the deceased victims' parents to approach the Calcutta High Court, noting that a single judge bench of the High Court is monitoring the case.

The top court was hearing a suo moto case in the rape and murder of a trainee doctor, which took place at the RG Kar Medical College and Hospital on August 9 last year.. Sen-Advocate Karuna Nundy represented the vic-

tims' parents. As per Nundy, the victims' parents today sought a clarification from the apex court about their case filed before the Calcutta HC, seeking further probe into the incident of rape and murder case of a 31 year old lady doctor inside the hospital premises, which shook the entire nation and the world. .

After granting the victims' parents liberty to approach the High Court, the CJI Sanjiv Khanna-led bench disposed of their plea filed before it.

On January 29, this

year, the parents of the victim withdrew their plea before the Supreme Court seeking a fresh investigation into the incident.

The victim's parents had filed the (now withdrawn) plea as an Intervention Application (IA) in the suo motu case, which had been registered by the top court in August last year, a few days after the infamous incident took place.

In the January 29 hearing, a Bench led by Chief Justice of India Saniv Khanna had asked Karuna Nundy whether the top court should proceed with the case, as a plea regarding similar issues had already been filed before the Calcutta High Court.

After considering the submissions made in the affidavit filed before it, the Court had warned the senior counsel to be cautious with her arguments, as there is already a conviction against the sole accused (now convict) Sanjoy Roy in the case.

The Court had suggested that Nundy withdraw the plea and file a fresh one, noting that the original plea had been filed by the victim's parents before the trial and the conviction in the cases. Following a brief exchange, the parents

Tension prevails in parts of Manipur following assault of tribal leader and imposition of Prohibitory orders

MI News Service, Imphal: The authorities imposed prohibitory orders under 144 CRPC in the entire Churachandpur district and its neighbouring areas in strife torn Manipur on Monday following clashes between the Hmar and Zomi communities, a day after a Hmar tribal leader was assaulted amidst demands from the community to identify the perpetrators, police said.

According to the additional district magistrate, the prohibitory orders have been imposed under Section 163 of the BNSS 2023 also.

"Whereas reports have been received from the Superintendent of Police, Churachandpur, indicating a serious apprehension of a breach of law and order in the district, which is likely to disturb peace and tranquillity among different communities and may lead to damage to life and public property," the order stated.

Earlier, a day after a leader of the Hmar tribe was assaulted by unknown miscreants in the district headquarters town of Churachandpur in Manipur, tensions escalated on Monday morning as locals demanded the identification of the perpetrators, police said.

However, as a precautionary measure, the additional dismagistrate imposed prohibitory orders across the district under Section 163 of the BNSS 2023.

Housing scandal rocks Arambagh: allegation of embezzlement and favoritism

News **Hooghly:** A controversy has erupted in Arambag, Hoogly after it was discovered that housing money had discovered that housing money had been misappropriated and allocated to ineligible beneficiaries. The allegations have sparked widespread outrage, with locals claiming that those who genuinely need assistances have been deprived of benefits. At the center of the scandal is Trinamool member Vandana Kundu, who allegedly received housing money despite already owning a one-story house. Kundu has built an additional two-story structure on top of her existing home, sparking accusations of embezzlement and favoritism. Hailstorm devastates potato, leaving farmers in distress

Bankura: hailstorm swept through Bankura district in West Bengal, causing widespread damage to potato crops and leaving farmers in a state of panic. Illegal land encroachments: Firhad reaffirms Govt's Stance

MI News Service, Kolkata: Illegal land encroachments continue to be a persistent issue across both urban and rural areas in Bengal. While the Kolkata Municipal Corporation (KMC) has taken measures in the city, and the state government has intervened elsewhere, reports suggest that clandestine land grabs and unauthorized construction remain rampant.

Many complaints regarding illegal land occupation and waterbody encroachments have been directly reported to Kolkata Mayor Firhad Hakim through the Talk to Mayor program, prompting immediate action. However, the problem persists. Addressing the issue during a question-answer session in the Assembly on Monday, West Bengal's Urban Development and Municipal Affairs Minister, Firhad Hakim, declared that no illegal land acquisition would be tolerated in the state.

His statement came in response to a query by BJP MLA Shankar Ghosh, who raised concerns over unchecked land encroachments. Hakim firmly stated, "No land in Bengal can be allotted without auction or ministerial approval, as per the state's land policy."

The issue has been a matter of contention for years. Unlawful land grabs have reportedly led to unauthorized constructions across the state, with allegations that promoters are illegally acquiring land for real estate projects. Even street vendors have been accused of forcefully occupying footpaths and public spaces. The recent spate of building collapses in Bengal has further intensified scrutiny on this matter.

A year ago, Chief Minister Mamata Banerjee took a strong stand against illegal land occu-

pation, encroachment of water bodies, and unauthorized footpath usage. Following a highlevel meeting at Nabanna, she ordered a crackdown on encroachments and illegal parking operations. Her directives led to surveys, eviction drives, and the clearance of illegally occupied spaces. Footpaths were freed from unauthorized vendors, and public lands were reclaimed. Despite these efforts, reports

indicate that illegal land acquisition continues. The governrecently conducted surveys across Kolkata and other districts to assess the extent of encroachments. Chief Minister Banerjee had earlier instructed officials to develop a structured plan to permanently prevent such activities. However, opposition parties have accused the state government of encroaching on people's livelihoods, alleging that a faction within the TMC and local administration is fueling illegal land grabs in exchange for

As per the data, during the month, mop up from Central GST stood at Rs 35,204 crore, State GST at Rs 43,704 crore, Integrated GST at Rs 90,870 crore and compensation cess of Rs 13,868 crore. Total refunds issued during February were Rs 20,889 crore, a 17.3 per cent increase over the yearago period. Net GST collections during February 2025 grew 8.1 per cent to about Rs 1.63 lakh crore.

Academic scores cannot define true abilities exams small part of growth journey: PM Modi

New Delhi : Academic scores alone cannot define a student's true abilities and exams are just a small part of the larger journey of knowledge and self-growth, Prime Minister Narendra Modi has said.

In a podcast with Lex Fridman released on Sunday, Modi said a strange mindset has developed in society today where even schools measure their success by students' rankings.

"Families too feel pride when their child achieves a high rank because they believe it improves their educational and social status. This mentality has resulted in increased pressure on children. Kids also began feeling that their entire lives depend on 10th and 12th grade exams.

"We have introduced significant changes in our new education policy to address this issue. But until those changes take effect on the ground, I feel another responsibility. If our children face challenges, it is my duty to listen to them, understand them, and ease their burden," he said.

The prime minister noted that when he conducts 'Pariksha Pe Charcha', he gets insights directly from the students, understands their parents' mindset, as well as the perspectives of people in the educational field.

"So these discussions don't just benefit the students. They benefit me too," he said. Modi



asserted that exams are valuable for assessing knowledge in a specific domain but they cannot become the sole measure of someone's overall potential.

"Many people may not score high academically, yet can hit a century in cricket because that is where their true strength lies. When the focus shifts to actual learning, scores tend to naturally improve," he said.

During the over three-hour interaction, the prime minister also advised parents to understand that life is not just about taking exams. "Families should

understand that their children aren't trophies meant to be displayed or models to show off in society. It is not about saying, 'Look, my kid scores so high'. Parents really need to stop using their kids just as status symbols. "Secondly, students should always keep themselves well-prepared beforehand. Only then can they appear for exams feeling stress-

and their abilities. Sometimes I see students panic over the smallest issues during exams," he said. "Those lacking confidence con-

free and confident. They should

have complete trust in themselves

stantly keep looking for distractions. But if you are confident and have genuinely worked hard, just take a minute, take some deep breaths, relax your mind and refocus your attention calmly," he

During the podcast, Modi also shared anecdotes about innovative ways used by teachers during his childhood that helped him grasp concepts better.

Sharing his mantra of always focusing on learning, the prime minister said he used to learn a lot from reading, but these days, more and more he learns by being fully present.
"Whenever I meet someone,

I am fully present in the moment. I give them my full attention. This complete focus allows me to grasp new concepts quickly. When I am with you, I am fully present, grounded in the moment. No calls or messages can pull me away from this moment with you. I am fully present focused on the here and now. That's why I always believe this is a habit everyone should embrace. "It will sharpen your mind and improve your learning ability. Besides, knowledge alone cannot light the way. You must immerse yourself in the flow of practice. You cannot master driving merely by reading the life stories of great drivers. You must get behind the wheel and take the road yourself," he said.

MIT researchers devise process to convert skin cell directly into neurons

Washington DC [US] : Researchers devised a process to convert a skin cell directly into a neuron, eliminating the need to generate induced pluripotent stem cells. Such neurons could be used to treat spinal cord injuries or diseases such as Amyotrophic Lateral Sclerosis (ALS).

Converting one type of cell to another -- for example, a skin cell to a neuron -- can be done through a process that requires the skin cell to be induced into a "pluripotent" stem cell, and then differentiated into a neuron.

Researchers Massachusetts Institute Technology (MIT) have now devised a simplified process that bypasses the stem cell stage, converting a skin cell directly into a

Working with mouse cells, the researchers developed a highly efficient conversion method that can produce more than 10 neurons from a single skin cell. If replicated in human cells, this approach could generate large quantities of motor neurons. which could potentially be used to treat patients with spinal cord injuries or diseases that impair mobility.

"We were able to get to yields where we could ask questions about whether these cells can be viable candidates for the cell replacement therapies, which we hope they could be. That's where



As a first step toward developing these cells as a therapy, the researchers showed that they could generate motor neurons and engraft them into the brains of mice, where they integrated with host tissue.

Galloway is the senior author of two papers describing the new method, which appears today in Cell Systems. MIT graduate student Nathan Wang is the lead author of both papers.

The MIT team also hopes to increase the efficiency of this process for human cell conversion, which could allow for the generation of large quantities of neurons that could be used to treat spinal cord injuries or diseases that affect motor control,

such as ALS. Clinical trials using neurons derived from Induced pluripotent stem cells (iPSCs) to treat ALS are now underway, but expanding the number of cells available for such treatments could make it easier to test and develop them for more widespread use in humans,

New antibody reduces tumor growth in treatment-resistant breast, ovarian cancers: Study

London [UK] : Immunotherapy, or antibody treatment that activates the patient's own immune system against cancer, is increasingly being studied as an alternative to chemotherapy and radiotherapy. This is because it directly targets cancer cells, reducing the negative effects associated with more conventional treatments.

Tumours, such as some breast and ovarian cancers, can express the marker HER2. HER2 is responsible for cancer growth and is the target of existing therapies, such as the most commonly used type of antibodies, IgG. However, this treatment is not always effective in some patients.

Now, scientists have investigated a different antibody type, IgE, which activates the patient's immune system in different ways than IgG. As they act on different immune cells to IgG, IgE antibodies uniquely stimulate otherwise inactive immune cells in the 'microenvironment' surrounding the tumour to target the cancer cells

In the study, led by Dr Heather Bax at King's College London, the team engineered IgE versions of existing IgG therapies and tested their ability to activate immune cells against HER2-expressing cancer cells.

shown to direct IgE was immune cells against HER2expressing cancer cells, and slowed tumour growth in mice.



The tumours grown in mice are known to be resistant to conventional treatments, suggesting this new treatment could be an option for patients who don't respond to existing therapy.

Further investigation revealed that IgE antibodies stimulated and reprogrammed the 'immune microenvironment' around the tumours themselves, shifting from an immunosuppressive to an immunostimulatory response. This means the immune system was activated to target the cancer cells and overcome the tumour's actions to suppress attack.

The study has shown the potential of IgE as a new therapy for HER2-expressing cancers, including those resistant to other treatments. The researchers believe that, with the right investment and development, this approach could be used in humans in as soon as 3-5 years.

Senior Author Dr Heather Bax, Postdoctoral Research Fellow in St. John's Institute of Dermatology, at King's College London, said, "Around 20% of breast and ovarian cancers express the marker, HER2. By generating anti-HER2 IgE antibodies equivalent to the clinically used IgGs, for the first time we demonstrate that IgEs harness unique mechanisms to reprogramme the immune microenvironment, switching immune cells to effectively target HER2expressing cancers, including those resistant to existing thera-

"Our findings indicate that IgE antibodies could offer a potential new therapy option for patients with HER2-expressing cancer."

Study finds how to treat aggressive cancers


California [US]: Alternative RNA splicing is similar to a movie editor cutting and rearranging scenes from the same video to produce distinct versions of a film. By deciding which sequences to keep and which to cut, the editor can create a drama, a comedy, or even a thriller from the same raw material.

Similarly, cells splice RNA in various ways to make a wide range of proteins from a single gene, fine-tuning their activity to meet specific needs. However, when cancer rewrites the script, this process is disrupted, promoting tumor growth and survival.

In a recent study, scientists from The Jackson Laboratory (JAX) and UConn Health not only show how cancer hijacks this tightly regulated splicing and rearranging of RNA but also introduce a potential therapeutic strategy that could slow or even shrink aggressive and hard-to-treat tumors. This discovery could transform how we treat aggressive cancers, such as triple-negative breast cancer and certain brain tumors, where current treatment options are limited.

At the heart of this work, led by Olga Anczukow, an associate professor at JAX and co-program leader at the NCI-designated JAX Cancer Center, are tiny genetic elements called poison exons, nature's own "off switch" for protein production. When these exons are included in an RNA message, they trigger its destruction before a protein can be made--preventing harmful cellular activity. In healthy cells, poison exons regulate the levels of key proteins, keeping the genetic machinery in check. But in cancer, this safety mechanism

Anczukow and her team, including Nathan Leclair, an MD/PhD graduate student at UConn Health and The Jackson Laboratory who spearheaded the research, and Mattia Brugiolo, a staff researcher who contributed his expertise, discovered that cancer cells suppress poison exon activity in a critical gene called TRA2b. As such, levels of TRA2b protein



Anczukow explained. Anczukow, Leclair, and Brugiolo then went on to see if they could increase the inclusion of the poison exon in the TRA2b gene and reactivate the kill switch. They found their answer in antisense oligonucleotides (ASOs)--synthetic RNA fragments that can be designed to increase poison exon inclusion in specific ways. When introduced into cancer cells, ASOs effectively flipped the genetic switch, restoring the body's natural ability to degrade excess TRA2b RNA and inhibit tumor progression.

cancers, leukemias, and colorectal cancers,

"We found that ASOs can rapidly boost poison exon inclusion, essentially tricking the cancer cell into turning off its own growth signals," said Leclair. "These poison exons work like a rheostat, quickly adjusting protein levels--and that could make ASOs a highly precise and effective therapy for aggressive cancers.

Interestingly, when researchers completely removed TRA2b proteins using CRISPR gene editing, tumors continued to grow--suggesting that targeting the RNA rather than the protein could be a more effective approach. "This tells us that poison-exon-containing RNA doesn't just silence TRA2b," explained Anczukow. "It likely sequesters other RNA-binding proteins, creating an even more toxic environment for cancer cells."

Further studies will refine ASO-based therapies and explore their delivery to tumors. However, preliminary data suggest that ASOs are highly specific and do not interfere with normal cellular function, making them promising candidates for future cancer treatments.

Par panel recommends single independent drug controller for AYUSH

New Delhi: A parliamentary committee has recommended the consolidation of all AYUSH drug-related standard-setting processes under a single independent drug controller in alignment with the Drugs and Cosmetics Act, 1940, and its associated rules

To achieve this, the ministry should establish a streamlined and inclusive mechanism that actively involves stakeholders in the development of pharmacopoeial standards, ensuring greater efficiency and uniformity, said the Parliamentary Standing Committee on Health and Family Welfare in a report presented in the Rajya Sabha this week.

Additionally, the Pharmacopoeia Commission for Indian Medicine & Homoeopathy (PCIM&H) and Central Council for Research in Ayurvedic Sciences (CCRAS) may come together to coordinate and collaborate in this initiative, the committee emphasised in its 165th report on "Demands for Grants 2025-26 (Demand No. 4) of Ministry of Ayush"

This will enhance the scientific testing and evaluation of a larger number of ASU&H (Ayurveda, Siddha, Unani, and Homoeopathy) drug samples to ensure safety, efficacy, and quality, strengthening the foundation of research and standardisation in the sector.

The committee flagged that the state-wise reach of Arogya Fair/Ayurveda Parv is less compared to the size of India with its 28 states and eight Union Territories.

The committee also took note of the financial and physical performance made under the international cooperation scheme with respect to budgetary allocation and set objectives.

It recommended that going forward communication should be made with first-world countries like the UK and the

The committee reiterated its recommendation that the outcome of the research scheme should successfully demonstrate the effectiveness of Avush systems and the novel technology successfully developed out of such research and development must harness the potential of Ayush in the interest of public health delivery.

Further, noting that the scheme is one of the most significant schemes under AYUSH, the panel recommended extending it in financial years beyond 2025-26 with adequate budgetary allocation.

The committee expressed happiness and welcomed the laying of the foundation of a WHO Global Traditional Medicine Centre (GTMC) at Jamnagar, Gujarat and said that increasing collaboration with WHO in the Avush Sector is significant in the global acceptance of traditional medicine and Ayush health-

Such events will certainly help with the rapid growth of traditional medicine and healthcare.

It recommended that steps be taken on priority to complete the project early and make the GTMC functional.

In push to end Ukraine war, **Trump to discuss** ceasefire with **Putin today**

MI News Service, Washington DC: US President Donald Trump has said he will speak with Russian President Vladimir Putin on Tuesday as part of efforts to end the ongoing war in Ukraine.

Speaking to reporters on Air Force One while travelling from Florida to Washington on Sunday, Trump said, "We will see if we have something to announce maybe by Tuesday. I will be speaking to President Putin on Tuesday." He added that significant progress had been made over the weekend, stating, "We want to see if we can bring that war to an end", reported by Associated Press (BBC).

The war, which began three years ago with Russia's invasion of Ukraine, is still ongoing. While Moscow did not succeed in overthrowing the Ukrainian government, it continues to control large parts of the country.

Trump said that key topics in the talks would include land and power plants. "We will be talking about land. We will be talking about power plants," he explained, describing the discussions as "dividing up certain assets"

At least 53 killed in US airstrikes on Yemen's Houthis

MI News Service, Sanaa: The Houthi-run Health Ministry has said that the overnight US strikes killed at least 53 people, including five women and two children, and wounded more than 100 people in Yemeni state capital Sanaa, media reported. The US has escalated its strikes against Iran-backed Houthis, with President Donald Trump vowing on Saturday to use 'overwhelming lethal force' against the rebels tional ships in the Red Sea in 'solidarity' with Gaza. Multiple US strikes in Yemen's capital Sanaa and other areas have resulted in numerous casualties with the militants also vowing escalation as they face one of the most extensive attacks since the war in Gaza began in October 2023

US conducted overnight airstrikes on multiple targets in Yemen starting around midnight on Sunday, targeting the capital Sanaa. and other places, including Houthi stronghold province of Sadaa. Trump said that the Houthis must stop their attacks on international ships in the Red Sea, one of the busiest shipping routes in the world. If they don't, the US President vowed that 'hell will rain down' on them like 'nothing you have seen before'. US Secretary of State Marco Rubio told CBS News on Sunday that the strikes will continue until the Iran-backed militants 'no longer have the capability' to attack international ships.

He stated that Indian Railways is providing safe and high-quality services to passengers at affordable fares while securing a leading position globally. Comparing Rail fares, he mentioned that fares in Pakistan, Bangladesh and Sri Lanka are higher than in India, while in Western countries, rail fares are 10-20 times higher than in India. On the subsidy provided to passengers, the Railway Minister said that while the cost of train travel per kilometer is ₹1.38, passengers are charged only 73 paise, meaning a subsidy of 47% is provided. In the financial year 2022-23, passengers received a subsidy of ₹57,000 crore, which increased to approximately ₹60,000 crore in 2023-24 (provisional figures). He emphasised that the goal is to provide safe and improved services at minimal fares. Highlighting the benefits of Railway electrification, the Minister noted that despite an increase in the number of passengers and cargo, energy expenses have remained stable. Indian Railways aims to achieve Scope 1 net zero emissions by 2025 and Scope 2 net zero emissions by 2030. This non-fossil energy-based goal will completely offset the Railway's ca bon emissions. The Railway Minister also announced that locomotives manufactured at the Madhepura factory in Bihar will soon be exported. Indian Railways is exporting passenger coaches to Mozambique, Bangladesh and Sri Lanka, while locomotives are being exported to Mozambique, Senegal, Myanmar Lanka, Bangladesh. Additionally, bogie underframes are being exported to the United Kingdom, Saudi Arabia, France and Australia, while propulsion parts are being sent to France, Mexico, Germany, Spain, Romania and Italy. This year, India produced 1,400 locomotives, surpassing the combined production of the U.S. and Europe. Additionally, 200,000 new wagons have been added to the fleet. The Railway Minister stated that in FY 2024-25. Indian Railways will transport 1.6 bi lion tons of cargo, making it one of the world's top three freight carriers, alongside China and the U.S. This underscores the increasing capacity of Indian Railways and its crucial role in the logistics sector. He further stated that 41,000 LHB coaches have been manufactured with a strong focus on railway safety. During Prime Minister Narendra Modi's third term, all ICF coaches will be replaced with LHB coaches. The implementation of long Rails, electronic interlocking, fog safety devices and the 'Kavach' safety system is progressing rapidly. Expressing gratitude to Prime Minister Narendra Modi, Mr. Vaishnaw mentioned that earlier, Indian Railways

received ₹25,000 crore in financial support, which has now increased to ₹2.5 lakh crore. This funding has led to significant infrastructure improvements, including the construction of 50 Namo Bharat trains designed for short-distance travel, offering both AC and non-AC options. Regarding the recent incident at New Delhi Railway Station, the Railway Minister informed the House that a high-level committee is investigating the unfortunate accident. All CCTV footage and relevant data have been secured and approximately 300 individuals Ten critical measures have been taken to prevent such incidents in the future. The Railway Minister reiterated the government's commitment to serving the poorest sections of society. He emphasised that the number of general coaches is being increased to 2.5 times that of AC coaches. Under the current production plan, 17,000 non-AC coaches are scheduled formanufacturing. NASA announces Sunita Williams and Butch Wilmore's return date to Earth

MI News Service, Washington, DC: NASA astronauts Sunita Williams and Butch Wilmore, stranded at the International Space Station for over nine months, will return to Earth on Tuesday evening, NASA announced in a statement. Williams and Wilmore are scheduled to travel back to Earth alongside Nick Hague and Roscosmos cosmonaut Aleksandr Gorbunov aboard a SpaceX Crew Dragon spacecraft. NASA will provide live coverage of the agency's SpaceX Crew-9 return to Earth from the International Space Station, beginning with Dragon spacecraft hatch closure preparations at 10:45 pm EDT on Monday. NASA and SpaceX met on Sunday to assess weather and splashdown conditions off Florida's coast for the return of the agency's Crew-9 mission from the



International Space Station. In a statement, NASA stated, "NASA will provide live coverage of the agency's SpaceX Crew-9 return to Earth from the International Space Station, beginning with Dragon

spacecraft hatch closure preparations at 10:45 p.m. EDT Monday, March 17." "NASA and SpaceX met on Sunday to assess weather and splashdown conditions off Florida's coast for the return of the agency's Crew-9 mission from the International Space Station. Mission managers are targeting an earlier Crew-9 return opportunity based on favorable conditions forecasted for the evening of Tuesday, March 18," it added.

According to a NASA statement, the updated return target continues to allow the space station crew members time to complete handover duties while providing operflexibility less-favourable weather conditions are expected later in the week.

However, the spacecraft came back to Earth unmanned in September. This came after NASA and Boeing identified "helium leaks and experienced issues with the spacecraft reaction control thrusters" on June 6 as Starliner approached the space station.

World Uyghur Congress hails **US** sanctions on Thai officials over Uyghur deportations

MI News Service, Munich: The World Uyghur Congress (WUC) has expressed its appreciation for the recent sanctions imposed by the US State Department on Thai officials involved in the deportation of Uyghur refugees to China.

In a statement shared on the social media platform X, WUC stated, "The World Uyghur Congress welcomes and thanks the US Department of State for imposing sanctions on Thai officials involved in the deportation of Uyghurs to China. This decisive action sends a strong message that complicity in persecution of Uyghurs will not go unpunished. We urge other gov-ernments to follow this example and take concrete measures to protect Uyghur refugees and hold those responsible for their deportation accountable.

The US State Department announced on Friday that it would impose sanctions on an undisclosed number of current and former Thai officials involved in deporting at least 40 Uyghur men to China, despite concerns they could be imprisoned or even executed there. US Secretary of State Marco Rubio stated that he has swiftly taken action to enforce visa restrictions on those responsible for the deportations. The deportation of Uyghur refugees from Thailand to China has been a long-standing point of contention for human rights organisations. Human rights organisations have urged countries to adopt policies that protect the rights and safety of Uyghur refugees, ensuring they are not forcibly returned to a country where they face grave human rights abuses. Earlier, Amnesty International had also condemned Thailand's decision to deport Uyghur detainees to China, calling it "unimaginably cruel." Sarah Brooks, only leads to savings in op-Amnesty's China Director, emphasised that returning these Uyghurs to China exposes them to serious human rights violations, including torture, arbitrary detention, and enforced disappearance, as seen in Xinjiang. Brooks highlighted that the men had already suffered over a decade of arbitrary detention in Thailand after fleeing repression in China. The Uyghurs, a Muslim ethnic group in China's Xinjiang region, face severe

News Gaza/Jerusalem: At least 15 Palestinians in the Gaza Strip were killed by Israeli military strikes over the past 24 hours, the enclave's health authorities said on Sunday. Among the dead, nine people were killed on Saturday by Israeli drone attacks in northern Gaza, which targeted a group of people in Beit Lahia and bombed a vehicle, the official Palestinian news agency WAFA reported. The Israel Defense Forces confirmed its attack on Beit Lahia in a statement, saying the targets were "terrorists." Israeli forces have recently intensified airstrikes in Gaza amid uncertainty over the durability of a phased ceasefire agreement reached between Israel and Hamas in January. The first six-week phase of the deal expired on March 1, and negotiations on the second phase remain stalled. The death toll from Israeli attacks in Gaza since the start of the conflict on Oct. 7, 2023, has topped 48,000, with more than 111,000 others injured, according to the latest data

from the Gaza-based health

authorities.

New Fueling Points for Diesel Locos at Chitpur and Ranaghat to improve operational efficiency

Previously, locomotives operating in and around Chitpur and Ranaghat were required to travel to Beliaghata Shed for fueling, leading to unnecessary travel time, crew costs, and increased congestion on tracks. With the introduction of these decentralized fueling stations, diesel locomotives in these areas can now be fueled locally, significantly reducing the need for long-

distance travel. This strategic move not erational costs but also has a direct positive impact on the overall efficiency of train operations. The reduction in travel time for fueling will decrease crew requirements and fuel costs, while simultaneously easing congestion on the tracks. As a result, suburban train services on Sealdah Division will see improved mobility, benefiting millions of daily com-

muters.
