## Mamata Banerjee says Waqf (Amendment) Act not to be implemented in Bengal

West Bengal Chief Minister Mamata Banerjee assured the Muslim community in Bengal on Wednesday that the amended Waqf Act will not be implemented in the state and that she will not allow "any divide and rule policy" to persist

Addressing a programme of the Jain community in Kolkata, the Chief minister said she will protect with all her might the minority people and their property. "I know you are aggrieved because of the enactment of the Waqf Act. Have faith on me, nothing will happen in Bengal by which one can divide and rule," she said adding. "I would protect all minority people and their properties in West Bengal". You send out a message that all have to stay together,"

who is also the Trinamool Congress supremo, appealed to the people not to pay heed to those who provoke them to launch a political movement. Apparently referring to the violence over the Waqf (Amendment) Bill at Jiaganj in Murshidabad district on Tuesday, she said, "See the situation in the bordering areas of Bangladesh. This (Waqf Bill) should not have been passed now. We have 33 per cent of minorities in Bengal. What will I do with them?" History says that Bengal, Bangladesh, Pakistan and India all were together. Partition took place later. And those are living here, it's our job to give them protection," she said.

Baneriee said that if people are together, they can conquer the world."Some people will provoke you to assemble and launch a movement. I will appeal to all of you not to do it. Please remember when Didi is here, she will protect you and your property. Let us have trust in each other," the chief minis-

At the Jain community programme, Banerjee said she visits places of all religions and will continue to do so. "Even if you shot me dead, you will not be able to separate me from (that) unity. Every religion, caste, creed... all of them pray for humanity and we love them," she said.

Banerjee said she goes to Durga Puja, Kali Puja, Jain and Buddhist temples, gurudwara, church and Guru Ravidas temple, adding that "In Rajasthan, I visited Ajmer Sharif as well as Brahma Temple in Pushkar". Bangladesh. This (Waqf Bill) should not have been passed now," Mamata Banerjee stated further.

The Waqf (Amendment) Bill was passed by both the Lok Sabha and the Rajya Sabha last week after marathon debates in both Houses of Parliament and President Droupadi Murmu gave her assent to the Bill on Saturday making it an Act now.But Chief minister Mamata Banerjee has assured the Muslim community of Bengal that the amended Waqf Act will not be implemented in her

Speaking at the Jain community event , Mamata Baneriee said "We have 33 per cent Muslims here in West Bengal. They have been living here for centuries. What should I do? throw them out? It is my duty to protect them."

Without naming the main opposition BJP in Bengal, Mamata Banerjee ridiculed the party and said they say Hindus are not protected here. "If I am invited by the Jain community won't I attend? I will. Who protects Hindus here? This is your home too. We believe in live and let live". .

Referring to the Waqf Amendment Bill, 2024 and its clearance by both Houses of Parliament overriding strong criticism from the Opposition, Mamata Banerjee said "If I resist someone from occupying my house, I cannot allow anyone else's property to be snatched".

In the Lok Sabha, 288 members had supported the Bill while 232 members voted

against it. Among the Opposition parties, only the Biju Janata Dal voted in favour of the amendments. In the Lok Sabha when the Bill was placed, three of the Trinamool Congress MPS were absent. The amendment, interpreted by those opposed to the Bill, say it allows more power to the government, including a provision to play a greater role in the survey of properties under the Waqf boards. The Waqf boards and tribunals, which will also have non-Muslim members, must provide valid documents to claim a property as waqf, though the final decision will rest with the government.Unlike the previous law where the wagf tribunals decision was considered final, the new bill

allows for judicial intervention

in case of disputes.

system will be brought into effect where all waqf properties would have to be registered within six months of the new law coming into effect. For new properties to be registered under the Waqf boards submissions will have to be made via the new registration system.

MI News Service, New **Delhi:** The Delhi Police will launch an investigation after TMC MP Mahua Moitra claimed on Tuesday that a few people, allegedly belonging to right-wing ideology, forcibly tried to close fish shops in South Delhi's Chittaranjan Park area.

Sources in the force said they have not received any complaint about the matter, but they are verifying all the facts from the social media post.

"The market is a licensed market according to MCD records. The video appears to be outdated, but we are verifying the date of the incident. The police have not received any complaint so far," said a police source.

Trinamool Congress MP Mahua Moitra on Tuesday claimed that fish and meat shops in southeast Delhi's Chittaranjan Park, a Bengali-dominated area, were shut. She also posted a video, alleging that "BJP goons" were "threatening" fish market traders for

Responding to Moitra's claim, the Delhi Police said it did not receive any complaint, but the matter was under enquiry.

In the clip posted by Moitra on X, a man dressed in a saffron t-shirt and jeans is heard saying it was wrong to set up a fish

market next to a temple in Market No 1 of Chittaranjan Park, popularly known as CR Park, one of the poshest areas of Delhi.

"The market is just adjoining the temple. This is wrong. It is hurting the sentiments Sanatana Sanatanas. Dharma says we should not kill anyone... "This is pure fiction that fish and meat are offered to deities. There is no such proof in the 'shastras'. The entire country is watching this," the man said in the video.

In the video, a shopkeeper is telling the man that the fish market was allotted by the DDA. To this, the man said, "Yes I know that. The DDA can't run away with its responsibility. We will fix their mistakes. CR Park is a posh area and foreigners

Moitra said, "The temple in CR Park that BJP goons laying claim to was built by the non-veg market vendors! They pray there - the big pujas are held there. Three months of a BJP government in Delhi. Good anniversary present."

To substantiate her allegation, Moitra shared a screenshot of a WhatsApp message written in Bengali by a resident who claimed that the "forcible closure" of meat and fish shops in CR Park was a "terrible situation". "Didi, I saw your tweet about the forced closure of meat shops. I live near CR Park. Here, all the meat markets and

## **RBI lowers GDP growth** projection to 6.5 pc for FY26

MI News Service, Mumbai: In view of the growing uncertainties in global trade and policy announcements India's growth forecast for the current financial year has been lowered to 6.5 per cent from earlier esti-mated 6.7 per cent by the Reserve Bank of India Announcing this here on Wednesday RBI Gover-

nor Sanjay Malhotra while unveiling the outcome of the first bi-monthly Monetary Policy Committee meeting for the current financial year, said the prospects of agriculture sector, however, remain bright on the back of healthy reservoir levels and robust crop production in 2025-26.

RBI has lowered the growth projection to 6.5 per cent from the earlier estimate of 6.7 per cent for the current financial year due to global uncertain-ties, the RBI Governor said adding "While the risks evenly balanced around these baseline projections, uncertainties remain high in the wake of the recent spike in global volatility. It may be noted that the growth projection for the current year has been marked down by 20 basis points relative to our earlier assessment of 6.7 per cent in the February policy," he said

Malhotra said manufacturing activity is show-



ing signs of revival with business expectations remaining robust, but servsector activity continues to be resilient.

The RBI Governor also announced a 25 basis point cut in policy repo rate on Wednesday, saying the central bank is targetnon-inflationary growth. The RBI Governor said global economy was currently going through a period of huge uncertainty, posing multiple challenges to policymaking, alluding to the sweeping tariffs announced by Trump.

Meanwhile RBI'S action this afternoon was the second successive rate cut

by the bank's Monetary Policy Committee. A lower rate spurs growth as loans are expected to become

Experts earlier pre-dicted that RBI will again reduce the rate by 25 bps on Wednesday against the backdrop of moderating inflation and the need to stimulate growth as Trump tariffs pose severe challenges to the global economy, a move that the central bank ended up making in view of the cur-rent global economic developments.

In his remarks, the RBI Governor conceded that tariffs were expected to impact merchandise exports. He also said that Îndia's GDP was seen growing at 6.5 per cent in FY26. The inflation was forecast at 4 per cent . However, the central bank's rate-setting body can't sit at ease after Trump announced sweeping tariffs. The US President has announced a 26 per cent reciprocal tariff rate on India, effective April 9, which can fuel inflationary pressures going ahead. Economists have also warned of likely recessionary effects at play due to the tariffs, which down demand. After effecting two back-to-

## China pledges to strengthen ties with neighbours amid Trump's tariff war

MI News Service, New Delhi / Beijing: Taking a tough stand against the unilateral tariff policy of US President Donald Trump, Chinese President Xi Jinping on Wednesday pledged to strengthen the strategic relationships with neighbouring countries by "appropriately" managing differences and enhancing its supply chain across the globe.

As China's tariff war with the US escalated, in his first public speech after China was hit with an unprecedented 104 per cent tariff by the USA on its exports to America, Xi called for building a community with a shared future with neighbouring countries and striving to open new ground for China's neighbourhood

According to Chinese state media, Xi made the remarks at a central conference on work related to neighbouring countries, which was held in Beijing from Tuesday to Wednesday.

President Xi Jinping's decision to quickly retaliagainst Donald Trump's sweeping tariffs sent the world a clear message: If the US wants a trade war, China is ready to fightto the end .

After weeks of responding with only tarmeasures



Chinese President Xi Jin-

calling for dialogue, China signaled a tougher approach on Friday by answering Trump's "reciprocal" tariffs with blanket duties of its own and more export controls. The Communist Party's official newspaper followed that up with a Wednesday editorial declaring Beijing is no longer "clinging to illusions" of striking a deal, even as it leaves a door open to negotiations.

China's response has jolted global markets, fueling fresh volatility as investors brace for a prolonged and disruptive trade war. Trump deepened those worries by striking a defiant tone on Tuesday, saying he won't strike deals to cut levies unless they eliminate the US trade deficit with that country. We believe that before we can sit down to negotiate a deal we have to fight, because the other



side wants to fight first," Wu Xinbo, director at Fudan University's Center for American Studies in Shanghai, said of China's stance. On the possibility of a Trump-Xi phone call, Wu said: "You just slapped my face and I'm not just going to call you and beg your pardon.

Stocks tumbled on concerns over the trade war's impact on the global economy. Asia capped the worst day since 2008. A gauge of Chinese shares listed in Hong Kong fell into a bear market, while the city's benchmark Hang Seng Index plunged the most since 1997. Europe's Stock 600 tumbled more than 6 per cent at one point, while S-P 500 futures signaled more turfor American markets.An escalation

## **Youth Goes Missing After Night** Out, Shocking News Follows News Service, through police communi-

Jalpaiguri: In a tragic incident late Tuesday night, two young men from the Banarhat LRP Mor area of Dooars lost their lives in a road accident near the Chunavarti Culvert, close to the Chamurchi Outpost. The deceased have been identified as Shiv Saha (20) and Sanjeev Mahato (21), both residents of the same locality.

According to sources, the two friends had left in the evening to visit a relative in Chamurchi but failed to return home by 10 PM. Concerned, the families began searching for them. The devastating news of their deaths reached them the following morning of the accident.

Locals reported that the

police recovered a severely damaged motorcycle from the accident site, indicating the severity of the impact. However, the grieving families suspect that the incident may not have been a simple road accident. They allege that a vehicle struck the youths from behind near the culvert while they were on their way back home. The sudden and untimely deaths of the two friends have cast a pall of grief over the entire area. Meanwhile, the police have launched an investigation into the incident to determine the exact cause

The municipality's leadership will need to address these concerns to prevent further escalation and ensure the ward receives the necessary attention and resources.

### Rs 11 Lakh Road Starts Peeling Within 72 Hours

Balurghat: In Balurghat's village Malancha gram panchayat, South Dinajpur, a 300-meter cast-iron road is being constructed. The road serves as a key route for residents of two to three

In Sribai village under Malancha gram panchayat of Tapan police station in South Dinajpur district, the construction of a 300-meter cast-in-place road has been halted following serious allegations of substandard work. Local residents reported that the road, constructed just a day earlier, began to deteriorate within hours. Stones and sand were seen coming loose from the sur-

# Vacant posts: SSC mulls fresh recruitment drive

On the ramifications of global tariff war on MI News Service, Kolkata: The school service commission is "going ahead" with its preparations for a India, RBI Governor said it fresh recruitment process to fill the posts that have fallen vacant after the Supreme Court last week scrapped the jobs of 25,773 teaching and non-teaching staff in Bengal's government-aided schools. global uncertainties, while services exports are ex-

An SSC official said the commission was completing "internal preparations" so recruitment tests could be held in pursuance of the court's April 3 order.

"We have to ready our internal logistics ahead of the test. Meetings have to be held with the regional offices of the commission. We have to mobilise our staff across the state. In all probability, we have to let 22 lakh candidates who wrote the test in 2016 appear for the fresh exam," the official said. "It is going to involve a lot of planning, which will take time."The commission last held any kind of recruitment test nine years ago. In between, the only exercise it carried out was counselling to appoint teachers

at the upper primary (Class V to VIII), secondary and higher second-

We have been out of touch for quite some time when it comes to holding written tests. If 22 lakh candidates are allowed to write the test again, we have to retrieve their data from our server," the official said.

On April 3, the secretary of the school education department wrote to SSC chairperson Siddhartha Majumdar: "Without prejudice to the rights of the government in law and otherwise, it has been decided to request you to immediately take necessary steps to initiate fresh selection process as per direction of the Supreme Court.'

Earlier on the same day, the court said candidates not specifically found tainted but terminated would be eligible to participate, with appropriate age relaxation, in the next round of recruitments to fill the vacancies necessitated by the mass dis-

The Telegraph reported on April 5 that the SSC would ask the apex court whether the age relaxation offered to candidates should be extended to everyone who wrote the 2016 test or only to those who lost

their jobs even though their hiring process was not "tainted".

"These issues can be taken up with the court later. The commission first needs to complete its internal preparations on human resources and technical backup that would be required. The apex court must get the impression that its April 3 order is being complied with. Or else the court will view this as an act of defi-ance," the official said.

In her interaction with termi-nated teaching and non-teaching staff at Netaji Indoor Stadium on Monday, chief minister Mamata Banerjee said while she would do her utmost to protect the jobs of all those the Supreme Court had deemed "not specifically tainted", she kept reminding the audience they would have to adhere to the Supreme Court order.

"If the state government's petition of clarification or modification of the April 3 order falls flat, then holding the recruitment test to reinstate the jobs is the lone option. So, the preparations need to be made. Or else the test cannot be conducted at the earliest," said an SSC official.

locked in a paradox of pressure and pride," said Craig Singleton, a senior fellow at the non-partisan Foundation for Defense of Democracies. "But here's the dilemma: if Xi refuses to engage, the pressure escalates; if he engages too soon, he risks looking

Policymakers huddled in Beijing over the weekend to discuss plans to accelerate stimulus to boost consumption, as Xi leans on China's vast consumer base to help absorb the country's manufacturing output.

Several major global banks — including UBS Group AG, Goldman Sachs Group Inc. and Morgan Stanley — sounded the alarm over the weekend about the potential economic fallout from the US's steepest tariff hikes in a century. They warned that this could put even more pressure on China's already modest 2025 growth forecasts, which are already as low as 4 percent.

Beijing has several tools it could reach for if tensions with Washington worsen. At the same time, China may widen its diplomatic outreach by building stronger economic ties elsewhere. Last month, trade officials from China, Japan and South Korea jointly called for open and fair trade. During a recent visit to Brussels, Chinese Vice Finance Minister Liao Min expressed a willingness to work with the European Union to defend the multilateral trading system. The Chinese Embassy in Ottawa also made similar overtures about partnering

with Canada.

Xi's expected visit to Southeast Asia later this month takes on added importance. Beijing will likely be watching what countries like Cambodia, Malaysia and Vietnam might offer Washington in hopes of tarmoves could undercut Chinese interests.

Still, despite the increased pressure, there's no clear sign that China is looking to fully decouple from the US. Instead, it seems to be asserting its position and bracing itself for a prolonged standoff, while keeping future options open. "China wants to convey to the US that it is not intimidated and is willing to stand its ground," said Henry Gao, a law professor at Singapore Management University, who researches Chinese trade policies. The court asked the organisation if they had sought permission from police.

Advocate Mayukh Mukherjee, representing the outfit, said they had applied to Kolkata Police but were awaiting a response. The court allowed the organisation to file the petition and said the hearing would take place on Wednesday.

Several senior officers of Kolkata Police said they could not recall when a Hanuman Jayanti procession was last held on Red Road. There have, however, been political rallies and cultural and religious gatherings on Red Road in the past.

## SC to hear WBBSE plea to retain untainted teachers

Kolkata: The Supreme Court has scheduled for April 17 a hearing on the West Bengal Board of Secondary Education's (WBBSE) plea seeking permission to retain untainted teachers until a fresh recruitment process is completed.

This follows the apex court's April 3 judgment quashing the 2016 recruitment of over 25,000 teaching and non-teaching staff owing to widespread irregularities.

A bench of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar listed the matter for hearing after senior advocate Sanjay Hegde, representing the board, requested an urgent hearing.

The petition, filed through advocate-onrecord Hima Lawrence, seeks "appropriate directions and/or modification of the Judgment to permit the appointed candidates not found to be tainted to temporarily continue in various schools, without claiming any equity in their favour until the end of the academic year or until the process for fresh appointments is concluded, whichever is earlier, so that education of the students does not suf-

Notably, the board stated in its application that it received approval from the Bengal govern-

ment on April 3 to begin the selection process fol-lowing the court's deci-sion to uphold the Calcutta High Court's ruling that quashed the entire selection process.

"Appropriate steps are being taken in terms of the Judgment for filling up of the vacancies which have arisen on account of the selection process having been set aside. The Applicant is informed that a letter dated 03.04.2025 addressed by the State Government to the West Bengal Central School Service Commission has been issued," the application said.

The board cited several concerns to support its request:

The WBSE oversees 9,487 high schools (of which 6,952 have higher secondary sections for Classes XI and XII) serving over 78.6 lakh students. It also supervises 6,350 Upper Primary Schools (Classes VI-VIII). Approximately 88 per cent of student enrollments in the state are in government or government-aided schools.

The teacher strength of 1,51,568 (excluding headmasters) is already strained, with most schools relying on a single teacher per subject for Classes V to X. The termination of 17,206 teachers — 11.35 per cent of the existing teaching staff — would have a "devastating impact" across schools in the

Currently, the pupilteacher ratio in the secondary schools stands at 52:1, well above the 30:1 ratio prescribed under the Rashtriva Madhvamik Shiksha Abhiyan. This ratio would further deteriorate to 58:1 if the terminations proceed.

The education system in the State, includclassroom instructions particularly in subjects such as Mathematics, Science, and Languages, would be gravely and irreparably prejudiced. The students would suffer from significant learning gaps, especially those preparing for board examinations, and many ongoing classes will come to a halt," the board argued.

The board further emphasised that "the immediate termination of the teaching staff will also put significant burden on the remaining teaching staff, leading to larger class sizes and compromised learning environment. The academic year commenced in January and the classes are midway. Sudden stoppage of teaching would have a significant detrimental impact on the learning process of the students".

## Demolition must make structure unlivable: KMC

MI News Service, Kolkata: The demolition of a building will mean smashing its ceilings, floors, beams and columns and not merely drilling holes that can be repaired easily, the Kolkata Municipal Corporation (KMC) has said in a notification.

Firhad Hakim had earlier asked officials to ensure demolition squads did not just drill holes in a ceiling or a floor. Developers often rebuild illegal structures if only a hole is

The KMC commissioner issued a circular

on this last week.

Engineers and officials assigned to demolish a building will be held accountable if they do not make the structure unfit for living."The demolition process must be comprehensive and should not be restricted to partial dam-

age," the circular said. " L o a d - b e a r i n g columns, pillars and beams must be removed to ensure that the structure cannot be reoccupied... all ceilings and floors must be dismantled so the building is rendered entirely non-habitable."

## City to get week-end squall: MeT Dept

MI News Service, Kolkata: The Met office has predicted that the wait for the rain and strong wind might be over before the end of this week.  560 Cases Detected During the Intensive Operation MI News Service, Kolkata: In a continued effort to curb ticketless travel and promote passenger discipline, Eastern Railway conducted a special ticket checking drive on April 9, 2025, in the Sealdah – Ballygunge - Majerhat section, with a special focus on Majerhat station. ## Sri Lanka releases 14 Indian fishermen

Fourteen Indian fishermen were released as a special gesture, people familiar with the matter said. The fishermen issue is a contentious matter in India-Sri Lanka ties. There have been several alleged incidents in the past of Sri Lankan Navy personnel using force against Indian fishermen in the Palk Strait which is a narrow strip of water separating Tamil Nadu from Sri

In his media statement after talks with the Sri Lankan president, Modi called for adopting a "humane approach" on the matter. "We also discussed issues related to fisherlivelihood. agreed that we should proceed with a humane approach in this matter," Modi said in his media statement after meeting Dissanayake. "We also emphasised on immediate release of the fishermen and their boats," he said.

At a media briefing, Foreign Secretary Vikram Misri said the fishermen issue was discussed in tween the two sides. "As the prime minister said himself during his remarks, there was emphasis on the need to adopt a humanitarian and constructive approach to cooperation on these issues because these are ultimately issues that impact the livelihood of fishermen on both sides of the Palk Bay," he said.
"The Prime Minister

emphasised that at the end of the day, it is a daily issue for the fishermen and that certain actions that have been taken in recent times could be reconsidered," Misri said. The foreign secretary said both sides also emphasised the need to intensify the institutional discussions on the issue. "Both sides are in touch with each other on the possibility of convening the next round of fishermen's association talks between Sri Lanka and India," he said. The PM concluded his three-day trip to Sri Lanka on Sunday.

## **Govt proposes abolition** of digital tax on online advt

MI News Service, New Delhi: The government proposed to abolish the equalisation levy or digital tax on online advertisements from April 1, a move that will benefit advertisers on digital platforms such as Google, X and Meta. These changes are part of the 59 amendments to the Finance Bill introduced by minister of state for finance Pankaj Chaudhary in the Lok Sabha. As part of the amendment, effective April 1, 2025, the 6 per cent equalisation levy on online advertisements will be abolished. This will reduce the tax burden on digital ad consumers. The equalisation levy on online advertisement services was imposed on June 1, 2016.

According to the amendments proposed in the Lok Sabha, Section 163 of the Finance Act, 2016, levying equalisation levy will not apply on or after April 1, 2025. The levy was introduced by the Finance Act 2016 for online advertisement services, provision for digital advertising space, or any other facility or service for the purpose of online advertisement only.

## India's forex reserves see sharpest rise in 2 yrs

MI News Service, New Delhi: After the \$10 billion forex swap undertaken by the central bank on February 28, when it bought dollars against rupee to inject liquidity in the system, the country's foreign exchange reserves saw a huge \$15.267 billion spike during the week ended March 7. The sharp rise during the week was the sharpest jump in over two years. The forex reserves had increased to an all-time high of \$704.885 billion in September last vear 2024. Foreign currency assets,

a major component of the reserves, increased by \$13.993 billion to \$557.282 billion. Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves. The Special Drawing Rights (SDRs) were up by \$212 million to \$18.21 billion. India's reserve position with the IMF was down by \$69 million at \$4.148 billion in the week, the RBI data showed. Meanwhile, high frequency indicators point towards a sequential pickup in momentum of India's economic activity during the second half of 2024-25, which is likely to sustain moving forward.

## **Howrah division constructed** another Limited Height Subway



MI News Service, Kolkata: Eastern Railway's Howrah Division has successfully executed the major engineering Development work for insertion of LHS (Limited Height Subway) and simultaneous closure of Level Crossing gate No. 5/T. This critical work was carried between Guskara and Pichkurir Dhal stations 09.04.2025.

A traffic block of 6 hours from 03:30 hrs to 09:30 hrs on 09.04.2025, was granted on both UP and DN lines to facilitate the execution of this critical work and completed the work within the targeted time successfully. Under the main scope of work, 10 Nos. RCC Boxes (6m x 4.65m) along with 9 Nos. Base Slabs were successfully inserted to the LHS. For this, 2 Nos. 350ton Road Cranes and 5 Poclains were deployed to handle the heavy-duty operations efficiently.

Simultaneously, several track and infrastructure development works were completed during this period. These included 3 Nos. of Points & Crossings Tamping at Jhapaterdhal Station, 4.639 km of Plain Track Tamping and 4.639 km of Ballast cleaning has been done Khana- Saithai Section. Additionally various Engineering maintenance work also been done between Khana - Sainthia section. Switch and Crossing, Point & Crossing also upgraded. Moreover Welding of Rail Joints, Rail Renewal, painting of the Foot over Bridge, Replacement of Platform Shed were also done. This block operation was not only a major infrastructural achievement but also a fine demonstration of teamwork, technical skill, and resource optimization. ## Cabinet committee clears procurement of 26 Rafale fighter jets: Report

MI News Service, New crore," ANI reported. Delhi: The Cabinet Committee on Security (CCS) chaired by Prime Minister Narendra Modi on Wednesday cleared a proposal to procure 26 naval variants of Rafale fighter jets from France at a cost of around Rs 64,000 crore for deployment on board aircraft carrier INS Vikrant, sources in the defence establishment

The delivery of the jets will begin around five years after the signing of the contract under an inter-governmental framework between India and France.

According to ANI, the deal is expected to be signed in the coming weeks. The Indian Navy will re-

ceive 22 single-seater aircraft and four twin-seaters, built to operate from aircraft carriers like INS Vikrant.

"The deal will also ensure five years of performance-based logistics support and spares for the 36 Rafale jets already inducted into the Indian Air Force (IAF) in 2016 under a contract worth Rs 59,000

Additional DCP (North) Bajrang Singh Shekhawat said the driver, identified as Usman Khan (62), a resident of Rana Colony in Shastri Nagar, was under the influence of alcohol at the time of the incident.

"He lost control of the SUV and hit most of the victims in an area of about 500 metres near the Nahargarh police station," Shekhawat said.



### Israel fighter jet bombs Gaza home killing 20 including children

## **US-China trade war escalates: Beijing issues White Paper,** alleges rising unilateralism and protectionism

MI News Service, Beijing: China has released a white paper criticising the US for imposing tariffs on over USD 500 billion worth of Chinese exports since 2018, calling it a form of "unilateralism and protectionism" that undermines global trade coopera-

China's State Council Information Office on Wednesday released a white paper titled "China's Position on Some Issues Concerning China-US Economic and Trade Relations." The paper alleged that friction in trade between the US and China has significantly impeded normal economic and trade cooperation between the two countries, as reported by Xinhua. According to Xinhua,

yhe Chinese government issued the document to clarify the facts about China-US economic and trade relations and elaborate the position of the Chinese side on relevant issues, according to the white paper. This comes after the White House announced on Tuesday (local time) the imposition of a 104 per cent tariff on China starting Wednesday, marking a significant escalation amid the tariff tension that has shaken the markets. During a press briefing, White House Press Secretary Karoline Leavitt emphasised that it was 'mistake" for China to retaliate against the US, asserting that when America is challenged, the response is forceful and unyielding. "It was a mistake for China to retaliate. When America is punched, He punches back harder. That's why there will be 104 per cent tariffs going into effect on China tonight... If China reaches out to make a deal, he will be incredibly gracious,' Leavitt declared.

Leabvitt stated that the

new tariffs are part of the Trump administration's ongoing effort to address what it deems unfair trade practices that have led to job losses and economic strain on American workers. The paper asserted that these measures will have severe consequences for bilateral economic and trade relations between the two nations. The white paper came as rising unilateralism and protectionism in the United States have significantly impeded normal ecoand cooperation between the two countries, Xinhua reported. It said that the US has imposed tariffs on Chinese exports worth over USD 500 billion since 2018, with average tariffs on Chinese goods now standing at 42.1%, significantly higher than pre-trade war levels.

Mentioning the recently levied US comprehensive additional tariffs on Chinese products, including tariffs citing the fentanyl issue as the pretext, "reciprocal tariffs," and an additional 50 percent on existing tariffs, the White Paper said that the isolationist and coercive nature of US conduct -- run counter to the principles of the market economy and multilateralism, and will have serious repercussions for the economic and trade relations between the two countries.

### US warns of ' unacceptable risk' from Chinese control of Panama Canal ports, vows to counter influence

MI News Service, Washington DC: Defence Secretary Pete Hegseth, during a visit to the Central American country, stated that China's dominance over Panama Canal ports poses an unacceptable risk to US security. As Radio Free Asia (RFA) reported, this highlighted the US's commitment to enhancing its influence in the Western hemisphere.

The Panama Canal has emerged as a center of geopolitical conflict, as China's participation in its ports raises US apprehensions regarding control and dominance over this vital global trade channel. President Donald Trump has often claimed that the United States is being charged excessively for using the Panama Canal and that China exerts influence over its management, according to RFA. At a ribbon-cutting ceremony for a new USfunded dock at the Vasco Nunez de Balboa Naval Base following discussions with Panama's President Jose Raul Mulino, Hegseth declared that the US will not permit China or any other nation to jeopardize the canal's operations.

"To that end, the United States and Panama in strengthening our defense and security collaboration in recent weeks than we have in decades,' he said. Hegseth noted that companies from China continue to oversee critical infrastructure in the canal region. "This provides China with the capability to conduct surveillance acthroughout Panama. This situation makes both Panama and the United States less secure, less prosperous, and less sovereign. As President Donald Trump has emphasised, this condition unacceptable," he stated. In reaction to Hegseth's statements, the Chinese embassy in Panama issued a statement on X critiquing the US government.

They claimed that the US had employed "blackmail" to advance its interests, asserting that Panama's decisions regarding business dealings are a "sovereign decision of Panama and something the US should not interfere with," as highlighted by the RFA report.

## UK cybersecurity agency warns of Chinese spyware targeting Uyghurs, Tibetans, and Taiwanese

MI News Service, London: The National Cyber Security Centre of the UK and various international organizations focused on cybersecurity and intelligence announced on Wednesday that hackers are using two types of previously recognized spyware to monitor Uyghur, Tibetan, and Taiwanese individuals as well as civil society groups, per a report from the Central Tibet Administration (CTA). The malicious software

known as MOONSHINE and

BADBAZAAR can infiltrate the microphones and cameras of devices, collecting messages, photos, and location data, which permits users to be surveilled in real time without their awareness, according to the CTA report. Spywareinfected applications are being leveraged to target individuals and groups worldwide associated with activities deemed a threat to China's stability by the state, according to a press release from the NCSC

Those believed to be at the highest risk of being targeted include individuals connected to Taiwan's independence movement, organizations advocating for Tibetan rights, and Uyghur Muslims. Additionally, ethnic minorities from or within China's Xinjiang Uyghur Autonomous Region. democracy advocates, and members of the Falun

the rumours of stone pelting were bogus. He said, "Allegations of stone pelting were made but our investigation found that it wasn't true. We are now investigating how these rumours were spread. During the attacks, no one got hurt." Uttar Pradesh Congress took to X

to criticize the Yogi government stating that the incident is a result of communal politics. It said, "Some Hindu organisations had blamed the Muslim community for the alleged stone building during the Ram Navami's procession in Kanpur; the police have denied these allegations. In the same case another video has surfaced in which people involved in the procession are seen vandalising while passing through a Muslim

The Kanpur police have registered several FIRs in different incidents related to Ram Navami procession from different parts of Kanpur. The police have registered 9 cases pertaining to mischief during the ramnavami procession including playing DJ about the permitted volume and other allegations, claims a report published by the Hindustan.

Separate reports have been filed in areas like Gaganganj, Moolganj, Chakeri, Panki etc. Police are on the lookout for a youtuber who had allegedly spread the stone pelting rumour. The investigation is ongoing with 200 booked as a case has also been registered against many unidentified individuals for disturbing the peace.

# Egypt's Grand Mufti rejects IUMS fatwa urging war against Israel

MI News Service, Cairo: Egypt's Grand Mufti, Nazir Ayyad, has firmly rejected a fatwa issued by the International Union of Muslim Scholars (IUMS), which declared armed jihad against Israeli forces a religious duty for every able-bodied Muslim. The fatwa, which shared on Friday, April 4, via IUMS Secretary-General Ali Al-Qaradaghi on X, has sparked debate across the Muslim world.

In a statement on X on Monday, April 7, Ayyad said that "the Egyptian Dar al-Iftaa has reviewed recent calls for armed jihad against the Israeli occupation by every Muslim, and calls on Islamic countries to immediately intervene militarily and impose a counter-blockade." In the first clause, the Egyptian Dar al-Ifta affirmed that "jihad is a precise legal concept with clear and defined conditions, pillars, and objectives in the Sharia. No single entity or group has



the right to issue fatwas on these delicate and sensitive matters, in a manner that contravenes the principles of Sharia and its higher objectives, and that endangers the security of societies and the stability of Islamic countries." The second clause stressed that supporting the Palestinian people's legitimate rights is a legal, humanitarian, and moral

duty-but this support must align with their best interests, not be used to advance particular agendas or reckless actions that lead to more harm and suffering for them. The third clause emphasises that only a legitimate state or political leadership has the authority to declare jihad or wage war, not unofficial groups or individuals. It cautions that urging people to defy their governments leads to chaos and disorder, which is prohibited in Islam. The fourth clause warns that calling for jihad without considering the nation's circumstances is irresponsible and goes against Islamic principles, which prioritise caution, public interest, and avoiding harm. The fifth and sixth clauses emphasise that, in Islamic law, those who call for jihad should lead by example, following the Prophet's practice, rather than inciting others and avoiding responsibility.

The Indian star won the 2023 edition with a throw of 88.67m and secured second place in 2024 with an effort of 88.36m, finishing behind Czech Republic's JakubVadlejch, the Tokyo 2020 silver medallist.

"Last year taught me a lot but I was proud to be on the podium for India once again at the Olympic Games I'm now fully fit and really enjoying the hard work that Jan Zelezny and I are putting in," Chopra said, referring to his coach, as quoted from Olympics.com.

Last season, Neeraj grappled with a groin issue before clinching silver at the Paris Olympics, where Pakistan's ArshadNadeem claimed gold with an Olympic record. He also finished second in the Diamond League Final, competing with a fracture in his nonthrowing left hand.

"I know the fans expect big things from me when I compete (in Doha) - and with good conditions and a great atmosphere that's definitely possible - but I pride myself on my consistency, which I believe is one of my greatest strengths. For me, that's more important than just chasing a number," he said.

Across six events in 2024, Chopra made the podium each time winning twice and finishing runner-up on four occasions

Bracewell didn't stop there as he went on to grab the wicket of Faheem Ashraf, ending with an economical 1-39 from his eight overs, with Ben Sears' sizzling five-wicket haul leading the home side to a 43-run win and the series

His blitz with the bat has also pushed him up 12 places in the batter rankings, to 89th position, while retaining his 18th spot in the bowlers rankings.

Ben Sears was the big winner for the bowlers, taking five wickets to finish with 10 for the three matches, helping him to Player of the Series accolade. He jumped 64 spots in the bowling rankings.

His defined role upfront results in him embracing a limited responsibility in the final third, contributing minimally in the build-up, and instead banking on his tremendous efficiency to consistently get MBSG strikes.

Maclaren hasn't struck the back of the net in either of his two

appearances against Bengaluru FC, though.

The talismanic Sunil Chhetri has had a record-equalling season, scoring 14 goals and bagging two assists in 27 matches. The 40-yearold has defied expectations by matching the numbers of his personal best season from 2017-18 (14G, 2A), and has carried his form into the playoffs, heading the strike against FC Goa in the semi-final that handed the Blues a place in the summi fixture.

LalengmawiaRalte has been a powerhouse at the centre of the park for MBSG, playing 21 games and averaging 47 passes per match at 83% accuracy. The midfielder has produced 14 goal-scoring opportunities, made 17 clearances, 31 interceptions, emerged victorious in 106 duels, and rounded off 131 recoveries.

He has won the third-most tackles (48) in the competition, and his only goal so far for the Mariners was the decisive one in the semifinal that sent MBSG into the final. Jose Molina will bank on the ex-Mumbai City FC star to stimulate them into dictating the flow of the proceedings in the middle.

Rahul Bheke has been an inspired signing made by Bengaluru FC in the summer, in a move that has paid rich dividends over the course

The seasoned defender has been vital to their philosophy of building attacks up from the back, averaging 50 passes per game at 85% accuracy. He has won 18 tackles, 44 aerial duels, alongside registering 15 blocks, 26 interceptions, and 80 recoveries. His 121 clearances have been essential in enabling the Blues to keep 10 clean sheets, whereas the 34-year-old has also come in handy in the final

third with three goals to his name.

Subhasish Bose, the MBSG defender, has been dynamic on both ends of the field this, making the third-most interceptions (46) and scoring six goals - only behind Chhetri (14) and BrisonFernandes (7) amongst Indian players. ## ISL 2024-25 Final: Juicy tactical battle on the cards as Jose Molina, Gerard Zaragoza set sights on coveted Cup

KOLKATA (WEST BENGAL): The stage is set for a high-stakes tactical showdown as MohunBagan Super Giant (MBSG) take on Bengaluru FC (BFC) in the final of the Indian Super League (ISL) 2024-25 season. The summit clash will unfold at the iconic Vivekananda Yuba BharatiKrirangan (VYBK) in Kolkata on Saturday, according to

the ISL Media Team At the heart of this clash are two Spanish masterminds--Jose Molina (MBSG) and Gerard Zaragoza (BFC)--both no strangers to the big occasion. Molina, who led ATK to the title in 2016, returns to the ISL finale in his first season back with MBSG. Zaragoza, formerly the assistant to CarlesCuadrat during BFC's 2018-19 championship run, now gets his moment in the



spotlight as head coach.

There are quite a few facets where Molina and Zaragoza's fates align here. Besides their Spanish heritage, it is their first full season with the club.

While Zaragoza had joined Bengaluru FC midway through 2023-24, Molina entered the MBSG setup in the summer preceding this season.

The two tacticians have had successful previous spells in the league, suggesting that they were well-acquainted with the setup and structure, easing their transition and enabling them to hit the ground running immediately.

Molina, who has won 23 of his 43 games in the ISL so far, with his victory percentage of 53.5%being the third highest such rate for any head coach in the competition (min. 10 games) behind

only Albert Roca (66.7%) and Des Buckingham (57.4%), is refraining from calling out the favourites for the final, despite the game occurring in their home turf, where MBSG have been unbeaten this season.

"I think in the finals, nobody is a favourite. Anything can happen. Of course, we believe in ourselves. We trust in ourselves and in what we are doing. We think that if we are at our best, we are going to get the trophy," he remarked in the buildup to the match, as quoted from the ISL Media Team.

Zaragoza's men began the season with five consecutive wins and clean sheets and looked in strong contention to at least finish in the top two until about December. January came as a surprise for the Blues, though,

with the side losing four of their five matches, even dropping out of the top-six momentarily.

Three wins and a draw in their last five league fixtures saw BFC settle for third place before storming past Mumbai City FC and FC Goa in the playoffs. The character shown by Zaragoza's men in overcoming a difficult phase, coupled with the contributions of seasoned hands such as Sunil Chhetri, Rahul Bheke, and Alberto Noguera, propelled them into the final. Zaragoza blended their experience seamlessly with the youthful exuberance of players like VinithVenkatesh, Suresh Singh Wangjam and NamgyalBhutia at different phases of the season.

"We have Sunil Chhetri, these amazing foreigners, this amazing defensive Indian line, and the

best goalkeeper in India. We are BFC. We need to remember that we have been in ISL, and we have played four finals. That save a lot," Zaragoza said in a statement of intent before the final.

When Zaragoza undertook the Bengaluru FC job in December 2023, he stressed on playing a positive brand of football. He has walked that talk with the Blues scoring 44 goals from inside the box this season - the highest amongst all sides. Their 51 big chances this season have been their highest such tally in a single campaign, and their 62.8% conversion rate this term is the team's best in a single season of the competition. Molina's MBSG, though, have not conceded a goal in their last seven home games, keeping a league-high 16 clean
