The trunk of the 435m-long skywalk takes off at the SP

Mukherjee Road-Kali Temple Road intersection and ends outside the gates of the famous

Kalighat Kali temple. A 30-metre arm of the skywalk starts near the Kalighat fire brigade intersection and merges with the trunk near Kalighat police station.

There are five points of entry or exit: from SP Mukherjee Road; out-side the Kalighat temple; on Sadananda

MI News Service, Hisar (Haryana): On the occasion of Ambedkar Jayanti, Prime Minister Narendra Modi flagged off a twice a week commercial flight from here to Ayodhya and laid the foundation stone of the new terminal building at the airport on Mon-

In line with his commitment to make air travel safe, affordable and accessible to all, PM Modi laid the foundation stone of Maharaja Agrasen Airport's new terminal building to be built at an estimated cost of over Rs 410 crore.

It will include a stateof-the-art passenger terminal, a cargo terminal and an ATC building. The

project is targeted to be completed in two years. After PM Modi flagging off the inaugural flight from Hisar to Ayodhya twice a week, and three flights in a week to Jammu, Ahmedabad, Jaipur, and Chandigarh will mark a significant leap in Haryana's aviation con-

The new Article 324 proposed by Ambedkar before the Constituent Assembly made the poll machinery centralised by having a singular poll authority for holding state and national elections.

Regional Commissioners were proposed to help the EC function across India.

During the first Lok Sabha elections in 1951, Regional Commissioners were appointed for six months in Bombay and Patna. After that, there was no such deployment.

State Chief Electoral Officers (CEO) now work as the EC's limbs in respective states and union territories. Article 324 gives the EC "plenary powers" to conduct elections and prepare electoral rolls.

The EC has exercised its constitutional powers to deal with issues where election laws and rules are silent.

The Supreme Court has on various occasions upheld these powers saying Article 324 is a vast reservoir of powers for the poll panel.



The UK has spent weeks working on a trade deal with the US to avoid the full impact of the level of tariffs introduced on countries such as Canada and China.

Asked whether it was true that the UK had agreed a deal with US official but were awaiting sign-off from the US president, Business Secretary

Jonathan Reynolds replied: "That is not an inaccurate reflection.

The US plan sets baseline tariff of 10 per cent with items from countries that the White House described as the "worst offenders" facing far higher rates for what Trump said was payback for unfair trade policies.His move breaks with decades of US policy embracing free trade. Analysts said it was likely to lead to higher prices in the US and slower growth around the world. 'We don't want any tariffs at all, but a lower levy than others vindicates our approach. It matters because the difference between 10 per cent and 20 per cent is thousands of jobs," PM Starmer said.

But according to Conservative shadow Home Chris Philp Secretary "Dozens and dozens of countries have the 10 per cent tariff, which is not based on any sort of negotiating genius by the government, it's based on the USA's assessment of our tariffs and other obstacles."Noting that UK car exports will still be imposed with a whopping 25 per cent tariff, he said getting a free trade deal with the US "should be a priority" for the government, adding that it should also "make sure our domestic economy is better prepared to weather the storm that is clearly com-

The Conservatives are also claiming the UK has benefited from being outside the EU.Shadow Trade Secretary Andrew Griffiths said: "The silver lining is that Brexit - which Labour ministers voted against no less than 48 times - means that we face far lower tariffs than the EU: a Brexit dividend that will have protected thousands of British jobs and businesses."Northern Ireland's Economy Minister Caoimhe Archibald said the tariffs were "deeply regrettable" and urged the government to "keep the north's unique circum-

#### Youth Freed, Visits Ayodhya, Then Murdered

News Service, Hooghly: A young man, Snajy Rajbangshi, was brutally murdered in Hooghly near the local station Sunday night. Recently released from prison and having returned from trip to Adyodya, he was found hacked to death, sparking a police investigation into a suspected revenge killing.

A fatal assault Occurred in the Loharpara area of Hooghly district, resulting in the death of Sanjay Rajbangshi. The Chuchura Police station confirmed the incident, stating the victim was discovered deceased late Sunday night. Authorities are investigating the incident as a potential act of revenge. Preliminary reports incident that Sanjay Rajbangshi had recently released from custody following a conviction in a 2019 homicide case. #### Bus stand sweet stall, vendor's space crunch

News Service, Durgapur: A Durgapur sweet shop sparked outrage by converting a government passenger waiting room into an extension counter, displaying and selling sweets. Bus passengers and locals are protesting the enforcement, claiming administrative inaction and political collusion. While the shop owner cites Poila Baisakh rush and his maintenance of the space.

A public passenger wait-

ing room, constructed by the Durgapur Municipal Corporation at Hadko intersection in Ward 27, has been repurposed as an extension counter for a neighboring sweet shop, triggering widespread discontent among bus passengers and local residents. The sweet shop, located adjacent to the shelter, has reportedly occupied the seating area with displays of various confectionery items, including sandesh, clove latika, gaja, and kachori. Furthermore, allegations suggest that the shop's customers are utilizing the shelter's premises for dining, forcing commuters to endure prolonged exposure to the elements while awaiting transportation. Deepak Kumar Paswan, a local resident, asserts that repeated requests for the shop owner to vacate the public space have been disregarded, with the municipal administration failing to intervene. BJP MLA Laxman Ghorui has criticized the situation, alleging administrative complicity and accusing Trinamool Congress leaders of accepting bribes from the sweet shop owner, thereby enabling the encroachment. The shop owner, Gautam Batbyal, defends his actions by citing increased business during the New Year period and claims responsibility for the shelter's maintenance, justifying the placement of his merchan-

## **Police intervenes in violent Monk clash**

Siliguri: Siliguri is gripped by escalating violence in following alleged attacks on Charak monks. Clashes between two9 groups have erupted in ward number four, resulting in widespread vandalism, shop looting and injuries to police personnel. The unrest, which began two days prior with attacks on Caraks pilgrims, intensified dramatically on Sunday promoting the development of Rapid Action Force (RAF) as authorities struggle to quell the escalating tensions and control the spread of rumors.

Siliguri has become the site of significant civil unrest following allegations of attacks against Charak monks. Clashes between two factions and looting, leaving debris

have escalated in Ward number four, resulting in widespread property damage and injuries to law enforcement. The situation, which has been volatile for two days, intensified Sunday with reports of further assaults on Charak pilgrims. Initial incidents involving attacks on pilgrims triggered heightened tensions, which were temporarily mitigated by swift administrative action. However, the situation deteriorated markedly on Sunday, with renewed reports of violence. A large-scale confrontation ensued, involving hundreds of individuals from opposing groups. Multiple commercial establishments were subjected to vandalism

scattered throughout the area. Two police personnel sustained injuries while attempting to restore order. A police spokesperson stated, "Upon receiving reports of projectile attacks, officers were dispatched to the location. The prevailing situation appears to be exacerbated by the dissemination of unsubstantiated rumors. We are urgently appealing to the public to refrain from propagating or acting upon unverified information." information." In response to the escalating violence, the Rapid Action Force (RAF) has been deployed to the area. The region remains tense, and authorities are conducting extensive patrols to prevent further outbreaks of conflict

#### **Corruption claims, Tilottama's** mother supports jobless teachers

Panihati: Seeking justice and highlighting widespread corruption, Tilottama's parents will join the unemployed teachers' protest, following their daughter's tragic death, which they attribute to systemic corruption.

Tilottama's parents have pledged their support to the upcoming Navanna campaign, organized by unemployed qualified teachers, scheduled for April 21st. Representatives from the Deprived Job Seekers, Employees, and Unemployed Oikyamancha met with the family in Panihati on Monday to extend a formal invitation.

Oikyamancha rep-tives articulated The resentatives

Service, that the Navanna campaign aims to address the systemic corruption they allege has deprived qualified individuals of employment opportunities. "Talent is being stifled across Bengal due to corruption," stated a representative, emphasizing that Tilottama's case is symptomatic of a broader issue. "We have appealed to Tilottama's parents and the public to unite in this fight." Tilottama's father reiterated his long-standing demand for justice, stating, "The injustice they have suffered requires adjudication. We will participate in the April 21st Navanna campaign to demand accountability. We urge all conscientious citizens to join this procession." Tilottama's mother

Tarakeswar: Domestic dispute turns fatel in Tarkeshwar, A vegetable seller Adhir Mondal is suspected of murdering his cloth seller wife Nayantra Mondal,, and then Committing suicide,, amidst accusation of extramarital affair.

Authorities are investigating a suspected murder-suicide that occurred in the Talpur Paschimpara area of Tarkeshwar on . Monday morning. Adhir Mondal (48), a local vegetable vendor, and his wife, Nayantara Mondal (38), a cloth seller, were found deceased at their residence.

Preliminary reports indicate that Adhir Mondal allegedly assaulted his wife with a sharp object, believed to be a vegetable cutter, before taking his own life by hanging. The incident occurred following a period of escalating domestic discord. According to neighborhood sources, the couple had experienced prolonged marital strife, with Adhir Mondal reportedly harboring suspicions of infidelity. Family sources confirm that the couple had two daughters, one married and the other a minor. The incident unfolded after the couple's younger daughter left for morning tuition. Upon discovering the deceased, local residents alerted the Tarkeshwar Police Station. Officers arrived at the scene, recovered the bodies, and initiated an investigation. The bodies have been sent for post-mortem examination.

The Tarkeshwar Police are currently conducting a thorough investigation to determine the precise sequence of events and the underlying causes of this tragic incident.

#### **Bhangar Chaos: CCTV** disabled amid arson attacks

MI News Service, Bhangar: CCTV Targeted, Vehicles Torched in Bhangarh Clashes: A Waqf protest descended into violent chaos, with allegations of ISF involvement in the destruction of surveillance equipment and arson attacks on police vehicles.

Renewed violence erupted in Bhangarh during a Waqf protest, resulting in the destruction of CCTV surveillance systems, arson targeting police vehicles, and widespread vandalism. The incident has triggered a wave of accusations between political factions, raising concerns about the instigators of the unrest.

The violence, which unfolded in the Sonpur Bazar area, followed a morning of heightened tension during a procession organized by the Indian Secular Front (ISF). The afternoon witnessed a dramatic escalation, with police vehicles being vandalized and set ablaze. Motorbikes were also targeted, leaving charred wreckage strewn across the streets. Notably, CCTV cameras, installed by the Kolkata Police following the area's jurisdictional transfer, were systematically destroyed. Authorities suggest this targeted destruction indicates an attempt to obstruct identification of the perpetrators. Law enforcement has deployed significant reinforcements to the area, and several arrests have been made. Reports indicate that five police personnel sustained injuries during efforts to quell the violence. Canning East MLA Shawkat Mollah condemned the violence, alleging ISF involvement and characterizing their actions as "anti-social." In response, MLA Naushad Siddiqui challenged the impartiality of police accusations, asserting that Trinamool Congress members were involved in the arson. He called for a thorough investigation based on video evidence, suggesting that individuals were operating under the guise of ISF members.

## Firhad urges Waqf act protesters to march to Delhi, not disrupt Bengal

MI News Service, Kolkata: In the wake of rising tensions surrounding the Waqf Act, West Bengal Minister and Kolkata Mayor Firhad Hakim has categorically dismissed the rationale behind ongoing protests in the state, asserting that the legislation is not being implemented in Bengal. Amid escalating demonstrations led by the Indian Secular Front (ISF), Hakim has called for unified protests in Delhiwhere the law originatesrather than causing public inconvenience in a state that has

not adopted the controversial Act. Over the past few days, Murshidabad has witnessed heightened agitation over the Waqf legislation. On Monday morning, ISF workers and supporters launched twin protest marches from Bhangar, led by party MLA Naushad Siddiqui. The destination was Kolkata's Ramleela-Maidan. However, one of the processions was intercepted mid-route by police, prompting protesters to breach barricades in defiance. This led to heated confrontations, physical altercations, and eventually, police lathi-charge to restore order.

Addressing the unrest, Hakim stated, "The Chief Minister has already clarified that the Waqf Act will not be enforced in Bengal. Then why the drama? Why inconvenience the public? When we block roads, all sections of society are affected. If the law isn't even applicable here, what is the purpose of such protests-just to show numbers?" He added pointedly, "If you must protest, why not go to Delhi, where the law is being implemented? That's where opposition makes sense.'

In a sharp political retort, Leader of the Opposition Suven-duAdhikari mocked the ISF-led protest, referring sarcastically to Siddiqui's previous interactions with the Trinamool leadership.
"We don't attend BAC meetings,
but Naushad does. He even held one-on-one meetings at Nabanna. This wasn't expected after having fish fry together," Adhikari said, insinuating collusion. Despite the chaos, Siddiqui proceeded towards Ramleela-

that all participants were legitimate ISF workers. "If TMC members pose as ISF and join our march, that's another issue. But our rally was peaceful—we took no provocative steps," he as-

#### **Bus rams into Park Street** divider, 5 injured

MI News Service, Kolkata: A major road accident occurred this morning in the bustling heart of the city, causing panic and high-lighting persistent concerns over public transport safety. A government-run bus travelling from Howrah lost control and crashed into the central divider at Park Street, near Chatterjee International in Maidan, around 10:30 AM. The impact was so intense that the vehicle mounted the divider, severely damaging its front portion and forcing emergency crews to cut through both the bus and the divider to facilitate

Preliminary reports suggest the accident may have stemmed from mechanical failure. The driver, upon sensing a malfunction, attempted an emergency stop. However, with several vehicles in close proximity, he swiftly chose to steer the bus into the divider to prevent a larger catastrophe. Fortunately, due to low pedestrian traffic at the time, a tragedy

It has also emerged that a reckless race between two buses may have contributed to the incident. Witnesses claim that during the aggressive manoeuvring, the govern-ment bus lost control, smashed through a railing, and eventually came to rest atop the divider. The front of the bus bore the brunt of the collision, with multiple components dislodged and strewn onto the road. At the time of the

crash, there were approximately 15 passengers on board. Five were reportedly injured, with one inrequiring hospitalization. Among the passengers were a woman and a child; the child sustained a minor head injury and was rushed to SSKM Hospital. After receiving preliminary treatment, both were discharged.

The aged concrete divider remains partially broken and unstable, with the bus precariously tilted, posing a risk of toppling. As a precaution, both sides of the affected lane were cordoned off, and vehicular movement in the area temporarily suspended. Traffic congestion followed, but normalcy was gradually restored after a crane removed the damaged bus.

Authorities have launched a thorough investigation to ascertain the cause of the accident. Key questions have been raised regarding the bus's speed, mechanical upkeep, and whether negligence played a role. Eyewitnesses and local commuters expressed relief that the consequences weren't more severe.

#### Kunal Ghosh alleges BSF-central nexus behind Bengal unrest

MI News Service, Kolkata: In a startling revelation, Trinamool Congress spokesperson Kunal Ghosh has alleged that a section of the Border Security Force (BSF), in collusion with certain political factions and central agencies, is facilitating the infiltration of violent elements across the border to incite unrest in West Bengal. Addressing a press conference, Ghosh demanded a thorough investigation into the recent disturbances in Murshidabad, warning of a deep-rooted conspiracy aimed at maligning the

"Democratic protests, meetings, and rallies are legitimate in any civil society," Ghosh remarked. "However, in areas where violence has broken out, there are serious allegations that some infiltrators, with the tacit support of a segment of the BSF, crossed the border to provoke conflict and damage

Bengal's reputation. Locals are unable to identify the main instigators—those who led the violence seem to be outsiders," he added. Ghosh went further to

implicate a covert alliance between central agencies and select political actors, suggesting the existence of a "blueprint" to orchestrate such disruptions. There are growing claims that, under the influence or direction of certain central agencies, a section of the BSF was manipulated to allow these instigators in, only for them to vanish after executing their plans," he said. "Why are these individuals untraceable? Why can't locals recognize them? These people lit the fire, both literally and figuratively.'

He squarely placed the blame on the Bharatiya Janata Party (BJP), accusing the party of fuelling instability for political gain. "This is the BJP's agenda provocation and division. I

urge people not to fall into their trap. We demand an impartial investigation to verify the authenticity of these claims. It's a dangerous conspiracy," Ghosh as-

Meanwhile, BSF intelligence sources have presented a parallel theory, suggesting that extremist elements from Cha-paiNawabganj in Bangladesh may also be involved in fuelling the recent violence in Murshidabad and Malda. Intelligence reports pointing in this direction have already been submitted to the Inspector General for

As the controversy deepens, the political blame game escalates, casting a shadow over law and order in Bengal and raising urgent questions about cross-border infiltration, communal provocation, and politicisation of national security forces.

### State Edu Dept seeks list of eligible and ineligible candidates from SSC

MI News Service, Kolkata: In a significant developfollowing Supreme Court's cancellation of the 2016 SSC recruitment panel, the West Bengal School Education Department has formally requested a district-wise list of eligible and ineligible candidates from the School Service Commission (SSC). This step marks a crucial move by the state government toward resolving the ongoing crisis involving nearly 26,000 terminated school employ-Sources within BikashBhavan confirm that the request specifically pertains to those candidates whose eligibility status remains unclearthose neither explicitly deemed ineligible nor officially validated as qualified. Although the SSC had previously submitted a general list of ineligible and ambiguous cases, this time the department has asked for the classification to be broken down by dis-

trict, enabling quicker

ground-level assessment by District Inspectors of Schools (Dis). This initiative follows a series of high-profile meetings with affected jobseekers. Just last Monday, Chief Minister Mamata Banerjee addressed a gathering at Netaji Indoor Stadium, urging the dismissed candidates to remain patient and continue attending schools. She assured that "not a single deserving candidate will be deprived of their job" and mentioned that multiple plans were in motion to reinstate eligible individuals. Echoing similar sentiments Education Minister BratyaBasu held a follow-up meeting where he indicated that the SSC had already begun preparing the eligibility lists.

According to internal sources, a preliminary list of approximately 19,000 eligible candidates has already been emailed to the Education Department. SSC also reportedly included in this updated list not previously tagged as ineligible by the court but were omitted in earlier

communications. The department plans to verify all submitted data thoroughly before taking any administrative action. The next course of action will follow after legal vetting and cross-verification by local education officers. The Education Minister also stated that if all legal consultations align, the final eligibility list will be published by April 21.

The Supreme Court's judgment had earlier labelled the 2016 recruitprocess "unconstitutional" and "institutionally corrupt,' leading to the termination of thousands of teaching and non-teaching staff. While the court ruling triggered waves of protest, the state government's ongoing measures signal a renewed effort to distinguish the deserving from the undeserving and deliver justice through a legally sanctioned pathway.

### Guv steps in on Murshidabad unrest, talks with CM Mamata

MI News Service, Kolkata: Amid escalating unrest in Murshidabad over the Waqf Act, West Bengal Governor C.V. Ananda Bose has directly communicated with Chief Minister Mamata Banerjee to assess the ground situation. In a rare move, the Governor released a video message on Sunday evening, declaring that Raj Bhavan is closely monitoring developments in the violence-hit region. Towards the end of his address, Bose also issued a spirited message in Bengali, calling for peace and order.

Over the past few days, Murshidabad has witnessed widespread agitation and communal tension sparked by protests against provisions of the Waqf Act. In response, the administration has deployed police forces along with paramilitary units, including the Border Security Force (BSF), to maintain order. Following directives from the Calcutta High Court, additional central forces were dispatched to the district. On Saturday, Director General of Police Rajeev Kumar visited Murshidabad to take stock of the situation. On Sunday morning, he assured the media that the situation was "fully under control." Anand Rai, Superintendent of Police for the Jangipur Police District, echoed this sentiment, stating that conditions have improved significantly. However, he raised concerns about misinformation being circulated on social media, urging the public not to fall prey to rumours. As a preventive measure, internet services have been suspended in several parts of Murshidabad. Restrictions have also been extended to select regions in Malda and Birbhum districts, where internet access will remain blocked until 10 PM on Tues-

In his official statement, Governor Bose asserted, "I have spoken to the Chief Minister about the Murshidabad situation. Raj Bhavan is keeping a close watch. The Union Home Ministry is also monitoring the developments. Miscreants are being arrested. Neither criminals nor their masterminds will be spared. No one will be allowed to take the law into their own hands. The state police and BSF are working in tandem, and sufficient central forces have been deployed. The Centre is prepared to send more forces if necessary." nIn a striking conclusion to his address, the Governor, switching to Bengali, proclaimed, "Sangharsha, hingshahobena, hobena. Cholbena, cholbena"—a resounding call for peace and an end to violence.

## Afghan national with fake identity arrested

MI News Service, Kolkata: In a significant breakthrough, the Special Security Control Organisation of Lalbazar apprehended an Afghan national at Delhi Airport who had been living in India for years under a fabricated identity. Identified as Mohammad Nabi Khan, the accused was attempting to flee to Kabul via Delhi when officials intercepted and arrested him based on a pre-existing Look Out Circular (LOC). According to sources from Lalbazar, Nabi was among ten Afghan nationals who came under scrutiny in 2022 for illegally residing in Kolkata. These individuals were found occupying three rooms on a Waqf property in the BidhanSarani area under the jurisdiction of Shyampukur Police Station. The matter came to light when the Waqf Treasurer lodged a formal com-

plaint with the police. Upon investigation, it was discovered that though all ten possessed valid Afghan passports, they had fraudulently acquired Indian identification documents, including Aadhaar and PAN cards, to extend their stay unlawfully. In the initial phase of the investigation, five of the accused were arrested, while the remaining five absconded. Lalbazar authorities subsequently issued LOCs against them. Of these absconders, four are still at large, and efforts to trace and apprehend them are ongoing. Meanwhile, legal proceedings in the case are underway in court. Police have already filed a charge sheet. Following Nabi's arrest on Friday, he was brought before the Chief Judicial Magistrate's (CJM) Court in Kolkata on Sunday under transit remand.

## Bengal Health Panel bans withholding Bodies over unpaid hosp bills

MI News Service, Kolkata: In a stern move to uphold patients' rights and dignity after death, the West Bengal Clinical Establishment Regulatory Commission has issued a strong directive to private hospitals: no deceased patient's body can be withheld over unpaid medical bills. The commission has also indicated that stringent regulations are on the cards to prevent such practices. This directive follows numerous annual complaints where grieving families were denied custody of their deceased relatives because they couldn't clear pending hospital dues. "Even if there are outstanding bills, no excuse will be tolerated when it comes to releasing a dead body," stated Commission Secretary Arshad Warsi. "Hospitals often appeal to us, citing their financial concerns. But we must prioritise ethics and humanity," he added. The issue came into sharp focus during the recent state conference of the Progressive Nursing Home Association, where All India Nursing Home Association chairman H. M. Prasanna pointed out a "lack of compassion" in many Bengal nursing homes. Warsi echoed the sentiment, citing unethical practices like excessive and often unnecessary testing on critical patients within the first 24 hours of admission, leading to inflated bills. According to Warsi, some patients are billed as much as Rs 50,000 to Rs 60,000 in a single day through tests like MRI and CT scans—many of which may not be medically warranted. This overbilling, he noted, damages trust and burdens families during already traumatic times.

## Rs 4K Cr fraud: SC scraps bail of 13

MI News Service, New Delhi: The Supreme Court set aside the anticipatory bail granted to 13 individuals accused of corporate fraud involving over ₹4.000 crore of public funds. Punjab and Haryana High Court had earlier granted anticipatory bail to the accused, but the Supreme Court deemed the decision "perverse and untenable" after the ministry of corporate affairs' Serious Fraud Investigation Office challenged the high court's order. The accused had defied arrest warrants and the proclamation order issued by a special court in Gurgaon.

"Even though the non-bailable warrants were issued from time to time against the respondents, and even though the proclamation proceedings were initiated against them, the high court has passed the impugned orders. "The said orders have been passed in utter disregard of the mandatory conditions contained in Section 212(6) of the Companies Act, and also ignoring the conduct of the respondents accused. Such orders being in the teeth of the legal position settled by this court, as also in the teeth of Section 212(6) of the Companies Act, would fall into the category of perverse orders and therefore untenable at law," a bench of Justices Bela M. Trivedi and Prasanna B. Varale said.

ration (BMC), the city's current water supply stands at a meagre 5.67 lakh million litres, a drop from last year's levels of nearly 9 lakh million litres during the same period.

Mumbai's water supplies at the current rate of consumption last for around 45 days without substantial rainfall or alternate water supply arrangement. Most of the larger water sources like Modak Sagar, Middle Vaitarna and Bhatsa, which are the primary source of the water system, are at

critically low levels. Around 1800 water tankers in the city provide non-potable water from ring wells and borewells.

The capacity of each such vehicle is 10,000 litres. According to estimates, these tankers supply around 200 million to 250 million litres of non-potable water per day, which is used primarily at construction sites, in shopping malls and for infrastructure projects.

These vehicles also supply 50 million litres of poaround 800 to 900 groundwater sources in Mumbai.

As people are facing a water shortage in some areas, Shiv Sena (UBT) leader Aaditya Thackeray has raised his voice on the

Thackeray criticised the government's delayed response in addressing the pressing issues of depleting ake levels and the ongoing tanker strike. He labelled the situation as "avoidable" and held the state administration accountable for "failing to prepare for a predictable summer short-

Thackeray urged the BMC to release a transparent action plan and ensure equitable water distribution, particularly in slum areas and densely populated regions.




# Researchers discover that unique immune cells stop metastatic cancer

NEW YORK [US]: The majority of cancer deaths are caused by metastatic disease, which occurs when cancer spreads from the primary tumour to other areas of the body. and researchers understand how cancer cells escape the primary location to seed new tumours, it is unclear why some cancer cells produce new tumours decades later and others do not.

A research team at the National Cancer Institute-designated Montefiore Einstein Comprehensive Cancer Centre (MECCC) has uncovered a natural immunological response in mice that prevents escaping cancer cells from growing into tumours elsewhere in the body. The study was published today in the journal Cell.

"Preventing or curing metastases is the most critical challenge in cancer," said study leader Julio Aguirre-Ghiso, Ph.D., director of MECCC's Cancer Dormancy Institute. "We think our findings have the potential to point to new therapies to prevent or treat metastatic disease." The study's co-first authors are Erica Dalla, Ph.D., a former student, and Michael Papanicolaou, Ph.D., a postdoctoral fellow in Dr. Aguirre-Ghiso's lab.

Cells that migrate from primary tumors and seed metastatic tumors are called disseminated cancer cells (DCCs). Some DCCs behave aggressively, immediately starting tumors in new tissue, while others remain in a state of suspended animation referred to as dormancy.

which they recognize DCCs and actively interact with them, and--by secreting a protein called TGF-b2--produce signals in the cancer cells that keep them in a dormant state," Dr. Aguirre-Ghiso said. "Understanding how immune cells keep DCCs in check could lead to new antimetastatic cell therapies among other strategies," Dr. Aguirre-Ghiso said. For example, he noted, it may be possible to strengthen macrophage signaling so that DCCs never awaken from dormancy or find ways to prevent older DCCs from becoming resistant to dormancy signaling.

# Simple measurement may predict risk of worsening kidney disease: Study



WASHINGTON DC [US]: Aarhus University researchers discovered a simple way for predicting which people are most likely to develop chronic kidney disease rapidly. This could be a key step towards improved prevention and treatment.

About ten percent of the Danish population suffers from chronic kidney disease, and some individuals experience rapid deterioration after the diagnosis is made.

Now, a team of researchers from Aarhus University in a comprehensive study has investigated the precise risk of rapid progression, and the result could be a significant step towards more effective treatment of the disease.

The study, which is based on data from Danish health registers, provides healthcare professionals with new insights into how to better identify patients at high risk of rapid worsening of kidney disease.

"We chose to investigate chronic kidney disease because some of the patients experience rapid deterioration of their condition without us knowing exactly who. Our goal was to understand which patients are most at risk and whether we can intervene early to delay or even prevent this progression," says Professor at the Department of Clinical Medicine at Aarhus University, Christian Fynbo Christiansen, one of the authors of the study.

A simple measurement

showed that the risk of rapid progression varied significantly among patients.

A simple measurement of protein in the urine proved to be a strong indicator of the course of kidney disease. For women without diabetes or elevated blood pressure/cardiovascular

disease and without the protein albumin in their urine, the risk of rapid progression was seven percent, while the risk peaked at 47 percent for men with both diabetes, elevated blood pressure/cardiovascular disease, and albumin in their urine.

"This is an important finding since albumin can be used as an indicator of kidney disease progression, thereby making it possible to identify patients at high risk of rapid deterioration of the disease, and it can improve the prevention of complications and hopefully increase patients' quality of life," explains Christian Fynbo Christiansen, adding:

"It underscores the need to use this simple test to a far greater extent."

The measurement can help healthcare professionals to target treatment and follow-up to patients at high risk. This could potentially be a significant gain for patients both in Denmark and the rest of the world.

"We hope that this result can contribute to increased awareness of the importance of using readily available markers including albumin in the urine to identify patients at high risk of rapid progression," says Christian Fynbo Christiansen.

And it's not only the patients who can benefit from the results. Faster and more effective prevention could also potentially help to reduce healthcare costs.

"I think we will focus much more in the future on patients with milder stages of the disease, like those we included in this study. If we get better at preventing and treating chronic kidney disease and its associated complications, it could potentially benefit both patients and society," explains Christian Fynbo

Christiansen.

He emphasizes that further research and development of precise treatment methods are still needed. Although the study provides important insight into risk groups, a precise model for predicting individual patient outcomes is still lacking.



# Researchers find clues about dementia's behavior changes

MICHIGAN [US]: When most people think of dementia, particularly Alzheimer's disease, they often think of memory loss first.

However, dementia alters a person's behaviour, whether it leads them to become agitated or worried, melancholy, nervous, or apathetic, or even changes their entire personality.

Over time, these behavioural changes can cause as much disruption in their life as losing their capacity to think and remember effectively.

Now, a team of University of Michigan researchers reports new clues about what might be happening in the brains of people experiencing even the earliest signs of dementia-related behavior changes.

ior changes.

Using two types of advanced medical imaging to study the brains of 128 people in the early stages of dementia, they show links between one of the brain's most crucial communication networks, a protein called tau, and the level of behavioral symptoms a person has.

person has.

This goes beyond the role of tau that scientists have already known about in people with more advanced dementia: causing tangled nerve fibers in brain regions

involved in thinking and memory.

The new study suggests that tau disrupts the integrity of the brain's salience network. This highway of connections between specific brain regions is key to our ability to understand and decide how to react to things that are happening around us. It also helps us process our own thoughts and

emotions. The researchers showed that the more a person's salience network had been disrupted in the presence of tau, the more behavioral changes that person would experience. They report their findings in Alzheimer's & Dementia: The Journal of the Alzheimer's Association.

While the one-time imaging of these 128 research volunteers can't show cause and effect, the strong association between tau, salience network disruption and behavior change is intriguing, the team says.


They call for further study of the potential connection in other populations, and for research to evaluate change over time to explore what might be going on within the pathways of connected brain cells that make up the salience network, and explore how it relates to tau buildup and behavioral changes over the course of years.

They also hope to test whether they could slow behavioral change in people with early-stage dementia by targeting the salience network with mild electrical current or magnetic fields applied from outside the skull and guided by precise imaging.

The researchers, from the

The researchers, from the Research Program on Cognition and Neuromodulation Based Interventions (RP-CNBI), are led by Alexandru D. Iordan, Ph.D. and program leader Benjamin M. Hampstead, Ph.D. Both are faculty in the U-M Medical School's Department of Psychiatry.

lead author of the new study, says, "What we see is that the presence tau pathology relates to behavioral symptoms not in a direct relationship, but rather through dysfunction of a specific network in the brain -- the salience network. The more affected this network is, the more severe the behavioral symptoms." He adds, "This is the first study that links the biomarker status of an individual with the dysfunction of this network, and behavioral symptoms, in people on the Alzheimer's disease spectrum." The team used functional magnetic resonance imaging, or fMRI, to study each volunteer's brain and trace three different networks that each connect far-flung areas of the brain. They used a measure called the network segregation index, to gauge how functionally independent each network was relative to other brain networks.

They combined fMRI findings with results from a battery of neuropsychological tests and behavioral questionnaires the volunteers took. They also looked at results from positron emission tomography, or PET, scans that showed whether the person's brain contained excess tau protein as well as beta amyloid, another Alzheimer's-related protein.

The salience network was the only one of the three networks whose level of integrity correlated with the presence of tau and the severity of dementia-related behavioral issues. The defaultmode network appears to be involved as a supporting player. The third network studied, called the frontoparietal network, was not related to behavioral symptoms. The new study showed that unlike tau, the presence of just amyloid in some volunteers' brains was not related to issues with the salience network or linked to that person's level of behavioral symptoms.

Iordan notes that the salience network is also known to be involved in some psychiatric disorders and in frontotemporal dementia, a type of early-onset, rapidly progressing dementia marked mainly by behavioral and personality changes.

Iordan notes that PET scans

for tau and amyloid are now used clinically in the diagnosis of dementia, and in managing treatment with new medications that aim to reduce the buildup of amyloid, with the goal of slowing cognitive decline.

But blood tests that can also detect the presence of tau and amyloid, and use them as biomarkers of dementia risk, have also started to become available. Since they're much less expensive than PET scans, they might also be useful in future studies of tau's role in behavioral changes too, he says.

says.

Further research could also help explain and even predict variation in the onset of behavioral changes in people with dementia, and the pace of decline. It might also lead to ways to identify people whose behavior changes are their earliest detectable sign of dementia risk, even before cognitive ability changes.

But the most exciting thing to Iordan and his colleagues?

"Our findings provide us with a functional target for potential intervention," he said. "We will soon be able to see if brain stimulation changes these relationships thanks to a larger study led by Dr. Hampstead that evaluates the effects of different doses of weak electrical currents applied to the brain. This larger study is nearing completion, and we are very excited to see what the results show, so stay tuned!"

#### Over 250 ex-Israeli intelligence officials urge end to Gaza war, return of hostages

MI News Service, Jerusalem: More than 250 former officials of Israel's Mossad intelligence agency have signed a letter urging the government to immediately end the war in the Gaza Strip and bring about the release of the Israeli hostages still held there, Israel's state-owned Kan TV News reported.

According to the report, the signatories include three former Mossad chiefs: Danny Yatom, Efraim Halevy, and Tamir Pardo, as well as dozens of other veteran officials in the service. The ex-Mossad members said, "Continued fighting endangers the lives of the hostages and our soldiers, and every possibility must be exhausted to reach an agreement that will end the suffering. We call on the government to make courageous decisions and act responsibly for the country's security." They expressed support for hundreds of military aircrew members, in reserve or retired, who signed a similar letter, calling for a cessation of hostilities and the return of the hostages, Xinhua news agency reported. Following the publication of the aircrew members' letter on Thursday, Israeli Air Force Commander Tomer Bar decided to terminate the service of active reservists among the signatories. Israeli Prime Minister Benjamin Netanyahu backed the dismissal decision and lashed out at such letters, calling the signatories "an extremist fringe group" attempting to "break Israeli society from within.' Also on Sunday, about 200 Israeli military doctors signed a petition with the same demand for stopping the fighting and bringing home the hostages, according to several media outlets that published a copy of the letter. 'The continued fighting in Gaza is primarily intended to serve political and personal interests, without any security purpose, and endangers the lives of soldiers and hostages," it said.

#### Thousands rally across Turkiye against Israel's attacks on Gaza

MI News Service, Ankara Thousands of people across Türkiye took part in a protest Sunday against Israel's attacks on Gaza under the motto "Gaza is Dying! Rise Up!" People in several provinces of the country expressed their support for Palestine. Hundreds gathered at Beyazıt Square in Istanbul for a march that the Turkish non-governmental organization the IHH Humanitarian Relief Foundation had called for days in advance to draw attention to Israel's attacks on the Gaza Strip since Oct. 7, 2023, which have claimed thousands of lives. # Social Economic Development and Challenges on USBRL Project





MI News Service, Kolkata: Brief history and time line: Linking Kashmir with Indian Railway network is centuries old dreams. The first idea for building a narrow gauge rail link to the Kashmir Valley was mooted over a century ago, when foundation stone laid for Jammu – Srinagar rail link by Maharaja Pratap Singh on 1st March 1892, later in 1898 by Maharaja Ranbir Singh. Four viable routes were found to link Punjab with Srinagar and the Kashmir Valley, the Banihal route from Jammu, the Poonch route via the Jhelum Valley, the Panjar route from Rawalpindi also via the Jhelum Valley and the Abbottabad route from Kalako Serai though Hazara in the upper Jhelum Valley. Detailed surveys were conducted for a mix of meter and broad gauge tracks. However, the inhospitable climate, the tricky terrain, restricted resources and history confined this idea to survey reports and drawing boards. In 1905 the British also revisited the idea and Maharaja Pratap Singh agreed to the line between Jammu and Srinagar via Reasi following the Moghul road. This plan envisaged a narrow gauge track to cross the Pir Panjal range, but the project remained a dream only. The project was considered several times after independence also, but it was only in the year 1981 sanction was given for the Jammu-Udhampur Rail link project.In 1994-95, the final Rail link between Udhampur- Srinagar-Baramulla (USBRL) was sanctioned and in the year 2002, the central government declared this Railway line a National Project. Some of the important key events/ mile stones during the journey of making reality the dream of connecting Kashmir valley with the network of Indian Railways are as fol-

## **Uttarakhand: Atleast 170 madrasahs** sealed, Chief Minister calls it 'historic step

News Service. Dehradun: In recent days, over 170 madrasahs have been sealed across Uttarakhand, with state authorities citing the absence of registration with the Madrasah Board or the education department as the primary reason.

This crackdown has sparked concern, particularly in Muslim-majority such Banbhulpura in Haldwani, where a joint team from the district administration, municipal corporation, and local police conducted inspections on Sunday,

April 13. Seven madrasahs were sealed during the operation for allegedly running without valid documenta-

According to a state-

ment from Chief Minister Pushkar Singh Dhami's office, the action follows findings from comprehensive surveys carried out by government-appointed teams. The Chief Minister described the move as a "historic step," emphasizing that institutions believed to be fostering radicalism under the guise of education would not be

allowed to operate. He maintained that the state is committed to preserving educational inand national security.

Officials indicated that this may be the initial phase of a broader effort, nearly madrasahs currently under investigation. Notably, many of the sealed institutions have been operating for decades, prompting concern among local residents and educators. Community members fear that long-standing schools are being shut down without due process or clear criteria.

Civil rights groups and Muslim religious leaders have responded with calls for a fair, transparent review process. They warned that mass closures lacking proper justification could deepen feelings of alienation among minority communities and erode trust in state institutions.

They urge the government to distinguish between unregistered but legitimate institutions and those that may pose genuine concerns, ensuring that educational access is not unfairly restricted.

This act of the Governor has started a turf war between the representatives of Aryavarta and the people living in Dravidstan or Tamil Nadu. In Tamil Nadu's educational curriculum, particularly in the Tamil language, "Kambar's Ramayanam, written by Tamil poet Kambar, is being taught, which is very different from the Ramayana written by Valmiki and later Tulsi Das.

While Tulsi Ramayana has transcended from a work of fiction to "religious scripture," in Aryavarta, the Kambar Ramayana remains a work of literature in Tamil Nadu. The State Platform for Common School System (SPCSS), an organisation comprising educationists, in a statement, has demanded the immediate removal of Tamil Nadu Governor from his post for "violating his oath of office." "Mr. R. N. Ravi was invited as the Chief Guest in his capacity as the Governor of the State of Tamil Nadu. He was not invited as a preacher of a particular religion. He was not asked to give a religious sermon,'

# Madrid, Bayern, Dortmund, Villa face do-or-die situations in UEFA Champions League Quarter-finals Leg 2



NEW DELHI: After a thrilling first leg filled with goals and some nerve-wracking fixtures, the UEFA Champions League quarter-finals now head into the decisive second leg, where Real Madrid, Bayern Munich, Borussia Dortmund, and Aston Villa face uphill battles to overturn unfavourable results against their respective oppositions.

In the first match of Wednesday, Barcelona head to the BVB Stadion Dortmund with a commanding 4-0 lead from the first leg. The pressure is surely on the shoulders of the German side to pull off a remarkable comeback at home. However, given the Catalan club's current form and their appetite for winning even under pressure, it appears to be a

tall order for Dortmund.

Barcelona's attacking trio continues to dominate both in La Liga and the Champions League, and all eyes will be on their captain, Raphinha, who now leads the charts for both goals and assists in the ongoing season.

In the second fixture on Wednesday, Aston Villa will aim to capitalize on their home advantage against a confident PSG side, fresh off clinching the Ligue 1 title under manager Luis Enrique. After a 3-1 loss in the first leg, the English side faces a stiff challenge.

PSG, known for their swift counterattacks, will look to maintain a compact defensive structure while waiting for openings, as Villa are expected to attack relentlessly in search of a turnaround.

The quarter-final action will continue on Thursday as Inter Milan hosts Bayern Munich at San Siro. Inter Milan stormed into the second leg with a narrow lead, having executed a brilliant defensive performance in Munich.

Their disciplined 3-5-2 system, built around midfield control and a patient buildup, contrasts with Bayern's fast-paced and direct attacking approach. It will be up to Harry Kane and his teammates to break through Inter's resilient setup and keep their European hopes alive.

Finally, defending champions Real Madrid face an almost insurmountable challenge against Arsenal, trailing 3-0 from the first leg. While the odds are stacked against Madrid, Los Blancos have a history of producing dramatic comebacks in the competition, most notably in 2022 against Manchester City.

Real Madrid will look to draw on that spirit once again and rely on their big-match mentality to try and pull off another unforgettable night in Santiago Bernabeu in Champions League history. All the action will be live on the Sony Sports Network from Wednesday.

## "Never seen someone play against Bumrah like this": Basit Ali hails Karun Nair for explosive display

ISLAMABAD : Former Pakistan batter Basit Ali was left gobsmacked after witnessing Karun Nair toying with the world's best Jasprit Bumrah with a technically sound and magical strokeplay in the ongoing 18th edition of the Indian Premier League (IPL) 2025.

Even though Delhi Capitals antagonistically succumbed to a 12-run defeat while pursuing Mumbai Indians' daunting 206run target, the high-scoring fixture will be remembered for Nair's valiance

He singlehandedly carried Delhi's hopes of ending Mumbai's flawless record while defending a 200-plus target. On his return to the cash-rich league after three years, Nair decimated Mumbai's pace express and toyed with the spinners in his explosive 89 from a mere 40 deliveries without breaking a sweat.

The highlight of his swashbuckling effort in the high-scoring Arun Jaitley Stadium was how effortlessly he demolished Bumrah's prowess in the whiteball format. Basit struggled to remember a top-class batter in



made Bumrah tilt at the windmills the way Nair did in Delhi's home ground. For the former Pakistan batter, Nair is a "very big player."

"In the last five to six years, I have never seen someone play against Bumrah like this. Even if the top-class batters in the world, including Virat Kohli, Rohit nobody has played against him like that. The way Karun Nair counterattacked Bumrah made it feel like someone was playing cricket. The way he scored over extra cover, he is a very big player," Basit said on his YouTube channel.
