Bahrampur: A day after visiting the relief camps and meeting the victims of the violence hit Murshidabad district there, West Bengal Governor C V Ananda Bose visited the riot-hit areas of Shamsherganj (in Murshidabad district) on Saturday to review the ground situation and interacted with the affected people, a senior official said. Bose will then headed to other strife-torn areas of Dhulian, Suti and Jangipur in the district, official source said here on Saturday.

Despite Chief Minister Ma-

mata Banerjee's request not to visit the riot affected areas of Murshifabad because of the present situation, the Governor arrived in Malda by train on Friday and met people who have taken shelter in a temporary refugee camp after fleeing the violence-hit areas of Murshidabad district. At least three people, including an 80 year old shopkeeper, were killed and over 274 arrested in connection with violence, loot and arson that took place following protests over Waqf (Amendment) Act that engulfed these Muslim-majority areas from April 8-12.

Before leaving for Shamsherganj this morning from Farakka Government Gest House, where the Governor spent his night after visiting the Malda relief camps, Bose once again interacted with some more members of the affected families



governor reached the riot-hit areas in Murshidabad today to assess the situation there by himself and talk to the locals, the sources informed .. While consoling them Bose assured them that "proactive action" would be taken to address their grievances .. "I met the family members who are at the camp here. They have briefed me in detail. There will certainly be proactive action taken," the governor had said. Along with Governor CV Ananda Bose a team from the National Commission for Women (NCW) also visited violence-affected areas of Murshidabad district on Saturday.

Meanwhile, BJP MLA Agnimitra Paul said that what happened in Murshidabad was an 'eye opener', referring to the violence following the protests over the Waqf Amendment Act earlier this month. On April 17, displaced, with many migrating to Jharkhand's Pakur district, while others have taken refuge in relief camps set up in Malda. Defying Chief Minister Ma-

mata Banerjee's plea, Governor Ananda Bose visited a temporary relief camp where people from violence-hit Murshidabad have taken shelter since last week's clashes that left three persons dead and several policemen injured. Teams of NHRC (National Human Rights Commission) and National Commission for Women (NCW) also visited Malda's Parlalpur High School, which has been converted into a relief camp. At the Malda shelter, the Governor spent nearly two hours interacting with men, women and children living there.

"I listened to their grievances and understood their feelings. They told me that goons entered their homes, assaulted them and their family members, looted, and then set fire to their houses. They all said they want to return to their homes. But they sought protection. They want a secure environment," the Governor told the media. "They need new houses as their homes have been reduced to ashes and ransacked. They want a proper livelihood... They all demanded that a permanent BSF camp be set up in the area for their security," Bose

"I assured them that they will get justice. I will take up the matter both with the state governmust try to restore normalcy. Will try for a permanent solution and do whatever is required,' the Governor said. Sumati Mondol, who took shelter at the school after fleeing from her home in the Bedbona area of Dhulian municipality, said she urged the Governor to set up a permanent BSF camp in the violence-hit areas.

"We told him (the Governor) in detail what happened on April 11 and April 12. We are not allowed to meet our relatives from outside. This is like a prison. But we still refused to go. Where will we go? Our houses are damaged. Today, there is Central force, but when they will not be there, who will save us? We appealed to him to set up a permanent camp of the BSF in the area," Mondol said.The Governor also said that he would "verify reports from the field, visit hospitals, residences, and relief camps. The central forces and state police are working together, and the situation will soon normalise. I will send my recommendations after the visit.

On Thursday, after he publicly announced his plan to visit violence-hit areas in Murshidabad, Chief Minister Mamata Banerjee made a public appeal to him to defer his visit. "I would appeal to the Governor to wait for a few more days. The situation in Murshidabad is fast becoming normal with confidence-

# **NCW** team meets riot-affected people in Murshidabad



National Commission for Women (NCW), led by its chairman Vijaya Rahatkar, met the riot-affected people in different areas of Murshidabad district on Saturday and assured them that all steps would be taken by the Centre to ensure their safety in future. The affected women narrated their plight during the violent days and demanded that permanent BSF camps be set up in select areas of the district and an NIA probe into the recent communal clashes. which claimed three lives. Rahatkar said, "I am dumbfounded by the agony these women are having to suffer. What they went through during the vio-lence is beyond imagina-tion." The NCW chief told the victims that there was 'no cause for worry" as the Centre was beside them. "We have come here to see your plight. Please don't worry. The country and the commission are beside you all. Don't feel that you are alone," Rahatkar told the victims at Betbona village. During the visit to the village by the NCW members, the riot-affected women broke down before them. The villagers were seen holding placards that displayed messages - 'We don't want Lakshmir Bhandar, we want BSF camp. We want

BJP MLA Sreerupa Mitra Chaudhury, who was accompanying the NCW team, said "This is my constituency, Dakshin Malda. I have been contesting from here for the last 12 years, and what I have seen this time is unprecedented. I had never seen violence on such a scale here in the last 12 years." The NCW team also visited the Dhulian area of the Murshidabad district, which witnessed violence on a massive scale during protests against amendments to the Waqf Act on April 11 and 12. The NCW team had also visited a relief camp in Malda district on Friday and met those displaced by the Murshidabad riots.

The commission had assessed the condition of women affected by the recent communal violence in parts of the state. "From what we've seen so far, the situation is extremely distressing. We can feel their pain and suffering," the NCW chief said. The NCW had earlier taken suo motu cognisance of the violence erganj, Suti, Dhulian, and Jangipur areas of Murshidabad on April 11 and 12. Three people were killed and hundreds rendered homeless during the clashes, which occurred in Muslim-majority areas, amid protests against amendments to the central Waqf Act.

## Seven hardcore criminals arrested in J-K's Samba, weapons seized

He identified the arrested accused as Yaqoob Ali alias "Yuka", Ismail alias "Bachu" and Mohd Igbal of Samba; Mohd Sain, Murad Ali and Mohd Irfan of Jammu; and Gazanfer of Doda, and said they were members of an organised syndicate and were planning to commit some "heinous offence".

# Modi will pay a two day visit to Saudi Arabia next week

MI News Service, New Delhi: Prime Minister Narendra Modi will pay a two-day visit to Saudi Arabia beginning Tuesday with focus on further expanding bilateral cooperation in several key areas including energy, trade and defence. A number of the two sides following talks between Prime minister Modi and Saudi Mohammed bin Crown Prince Salman Al Saud. The visit will provide an opportunity to build on the already strong strategic partnership between the two countries, Foreign Secretary Vikram Misri said at a media briefing here on Saturday. This will be Prime Minister Modi's first visit to Saudi Kingdom in his third term. Since first assuming office in 2014, Modi has travelled there twice before — in 2016 and 2019.

Sources said that trade and investments, energy cooperation, reviving the 'India-Middle East-Europe Corridor' and defence partnership will be among the issues on the agenda for discussion between the top leaders of both the countries on April 22-23. Thistime PM Modi is visiting Saudi Arabia at the invitation of the Crown Prince Mohammed bin

According to the Ministry of External Affairs, the Ptime minister's visit follows the State Visit of Mohammed bin Salman to New Delhi in September 2023 to attend the G20 Summit and co-chair the first meet-



ing of the India-Saudi Arabia Strategic Partnership Council. India and Saudi Arabia share close and friendly ties with a long history of socio-cultural and trade contacts. As strategic partners, the two countries share strong bilateral relations across various areas, including political, defence, security, trade, investment, energy, technology, health, education, culture and people-topeople ties. India's relations with the oil rich Kingdom have evolved into a stronger and enduring partnership in the past decade, expanding into many strategic domains, with growing investment commitments, broadening of defence cooperation and intensive high-level exchanges across sectors, the MEA statement said. The visit of PM Modi reflects the importance India attaches to its bilateral relationship with the Kingdom of Saudi Arabia.

further deepen and strengthen our multi-faceted partnership, as well as to exchange views on various regional and international issues of mutual interest, according to the MEA. The Prime Minister's upcoming visit comes at a time when the US and Iran are holding talks with Washington seeking a deal on the latter's nuclear programme and tensions in West Asia with the Hamas-Israeli conflict. PM Modi's visit also comes ahead of the expected visit of US President Donald Trump to Saudi Arabia next month.

### 12 Naxal dumps and bunkers destroyed by security forces in Chhattisgarh



MI News Service, Raipur: In yet another successful mission to end the menace of Naxalism once and for all by next year. the security forces unearthed and destroyed as many as 12 sophisticated weapon dumps and a bunker with a concrete slab, hidden on a hill top in Chhattisgarh's Bijapur district, official

sources said on Saturday. The operation was carried out by the 208th battalion of the elite Commando Battalion for Resolute Action of the CRPF unit, from its Jeedpalli camp, the sources said. "One of the hideouts was like a bunker of 160 square feet. It had a concrete slab on it. Six solar plates, two Maoist uniforms, two ceiling fans and other materials were recovered from there," he said. Earlier this month, another Maoist bunker used by the ultras to duck aerial surveillance, dump arms and ammunition was found by the security forces in Pujari Kanker area in Bijapur district in south Bastar of Chhattisgarh.. The bunker was spotted by the district reserve guard (DRG) personnel during the January 16 encounter with the Maoists in the forested area, a senior district police officer said adding the tunnel-shaped bunker, camouflaged within deep jungle with leaves and other materials, had electricity supply from a generator and can

# India exports first pomegranate consignment to the US via sea route

MI News Service, New Delhi: In a major development in the present volatile situation in the world trade, India has exported 14 tonnes of pomegranate, for the first time through sea route to the US, the commerce ministry said on Saturday. Traditionally the exports were done by air route. Now the industry is embracing the cost-effective and sustainable sea-freight mode. India shipped pomegranates comprising 4,620 boxes, around 14 tonnes, which reached the US East Coast last week, according to the official statement.

According to official sources. the US granted market access for pomegranates, during the season in 2024-25. India has started first full-scale sea shipment of 14 tonne of Bhagwa pomegranates



from Maharashtra to New York, marking a key step in expanding horticultural exports to the United States (US). The Agricultural and Processed Food Prod-Export Development Authority (APEDA) facilitated the initiative in coordination with the

United States Department of Agriculture's Animal and Plant Inspection (USDA-APHIS), the National Plant Protection Organisation (NPPO), and the ICAR-National Research Centre for Pomegranate (NRCP) in Solapur.

follows earlier static and airfreight trials that successfully extended the fruit's shelf life to 60 days. According to APEDA, the shipment, containing 4,620 boxes, was delivered within five weeks and was positively received in terms of both appearance and quality. "This ance and quality. development is part of a broader effort to enable Indian horticulture producers to participate more competitively in global sup-ply chains," said Abhishek Dev, Chairman, APEDA. "Sea protocols for perishable items like pomegranates can lower logistics costs while opening up longdistance trade opportunities."

#### Jafrabad woman's plea says "Save us, are we criminals for being Hindu?"

MI News Service, Malda: The aftermath in Malda is stark, with victims recounting the devastating speed and extent of the destruction. One resident described the scene as 'nothing, nothing... every-thing was burned,' high-lighting the complete loss of possessions, including essential school supplies, and the urgency of the situation which left no time even to change out of uniforms. The recent unrest in neighboring Murshid-abad has forced numerous families to seek refuge in a shelter camp in Vaishnav-nagar, Malda, leaving a significant impact on the education and well-being of the displaced children. Among those affected are over 40 young students who have lost their homes, belongings, and essential school supplies in the tur-moil. Eyewitness accounts from the camp paint a grim picture. Many chil-dren, some still clad in their white school uniforms – the only clothes they managed to salvage exhibit visible signs of trauma. Mothers at the camp voice deep concerns about their children's future, questioning when it will be safe to return home and when their education can resume. The uncertainty surrounding their displacement and the loss of their educational resources have created a palpable sense of anxiety among both the children and their parents.

## Elephant dies, glare on use of pesticides; after electric wires, new threat to jumbos

MI News Service, Jhargram: A wild elephant was found dead at Nayagram in Jhargram district on Thursday, and the forest department suspected that the animal had consumed paddy sprayed with pesticides. Vijay Kumara Salimath, the chief conservator of forests (CCF) of the south western circle, said the use of heavy pesticides on paddy fields was the likely cause of the 12-year-old male's death.

Although the actual reason will be known after the postmortem report comes in, our preliminary findings suggest that the elephant consumed paddy sprayed with pesticides one or two days ago," said Salimath.

# Teenager killed in reckless speeding, 5 injured MI News Service, Kolkata: A

tragic incident on the Garden Reach Flyover late Friday night claimed the life of a 17-year-old boy and left five others injured, sparking concerns about the reckless driving habits of minors in the city. The accident occurred when a car, traveling at high speed, overturned and crashed, with most of the victims being teenagers.

The deceased has been identified as Shubham Das, a resident of the Garden Reach Paharpur area. The car, speeding dangerously, suddenly flipped over, ejecting Shubham who was then crushed beneath it. The others were trapped inside the vehicle.

Hearing the crash, locals rushed to the scene, and emergency calls were made to the police. The injured were quickly transported to the hospital, where Shubham was declared dead. The other victims are currently receiving medical treatment for their injuries.

The incident has raised serious concerns regarding the involvement of minors in driving vehicles. Local reports suggest that Shubham was behind the wheel during the crash. However, police sources state that at the time of the accident, the steering wheel was in the hands of another injured youth. Preliminary investigations indicate that the high speed of the car caused the driver to lose control, leading to the crash.

### **West Bengal job seekers** suspend Nabanna protest, trusting CM's assurance

In a significant turn of events, job seekers and those who have lost employment have decided to temporarily suspend their planned Nabaanno march, following assurances from Chief Minister Mamata Banerjee. The decision was communicated to the Howrah and Kolkata Police Commissionerates via letters on Saturday. De-bashish Biswas, one of the convenors of the Job Seek-ers and Jobless Unity Forum, confirmed that de Nabaanno protest, scheduled for April 21, has been postponed for now.

According to Biswas, further decisions will be made after sitting down for discussions with the Chief Minister and the Chief Secretary. The decision comes in the wake of a distressing judgment by the Supreme Court on April 3, which led to the termination of 25,752 teachers and nonteaching staff in the state. The repercussions have been felt heavily, especially in Kolkata and other districts of West Bengal, as former employees and job applicants raised their voices against the decision. In response to these developments, Chief Minister Mamata Banerjee had attended a rally at the Netaji Indoor Stadium on April 7, where she offered her support to the affected individuals and assured them of her government's efforts to address the situation. The promise of dialogue with the Chief Minister and senior officials has been seen as a ray of hope for those who have been adversely impacted by the Supreme Court's ruling.

Meanwhile, the School Service Commission (SSC) has officially informed that it will release separate lists of eligible and ineligible candidates on April 21.
With assurances from Chief Minister Mamata Banerjee, the SSC, and the Supreme Court's ruling, the terminated teachers have expressed renewed faith in the process. Consequently, they have announced the suspension of their planned protest march to Nabanna on April 21. Debashis Biswas, one of the key conveners of the "Job Aspirants, Employees, and Terminated Teachers United Forum," stated, "We have temporarily suspended our Nabanna march. We have informed both Howrah City Police and Kolkata Police in writing. We hope that the Chief Secretary and the Chief Minister will listen to our appeals. That is what we will seek for now." He further mentioned that future decisions regarding their movement will be made only after holding discussions with state authorities.

### **Kolkata Police initiates** 'Happiness Guarantee Program'

MI News Service, Kolkata: Amid rising concerns over mental health challenges faced by law enforcement personnel, Kolkata Police has introduced a wellness initiative titled the Happiness Guarantee Program aimed at supporting officers and personnel grappling with stress, depression, and burnout. The initiative, launched at the Police Training School, witnessed participation from nearly 250 police officials, including ACPs, Joint Commissioners, and officers of various ranks. The demanding nature of police duty — spanning rigorous shifts, constant exposure to crime scenes, law and order responsibilities, and the high-stakes pressure of investigations has long been associated with psychological strain. Over time, this relentless routine has contributed to alarming trends such as hypertension, reduced efficiency, emotional breakdowns, and even cases of suicide within the

To counter this, the Happiness Guarantee Program promotes structured interventions like daily yoga, meditation, breathing exercises, and mindfulness practices. These activities are not just recommended but are being actively integrated into daily routines to offer holistic stress relief. ACP (Headquarters) Alok Sanyal, the chief proponent of the program, emphasized the need to separate professional stress from personal life. "Officers must learn to disconnect from duty-related anxieties once they return home. Household involvement post-shift brings emotional balance and helps mitigate job-induced stress," he stated. The program outlines several benefits: promoting calmness during high-pressure operations, strengthening inter-personal bonds among colleagues, improving overall well-being, and fostering joy in duty. Yoga expert Papia Bhardwaj, who addressed the participating officers, highlighted the importance of flexibility in routine. "Police jobs often lack a fixed schedule. Therefore, officers must use any available time for walking, yoga, pranayama, and breathing exercises to build mental resilience and positivity," she advised. The initiative also targets a troubling reliance on sleeping pills, which some personnel use to combat insomnia born from chronic stress. By encouraging natural relaxation techniques and emotional self-care, the department hopes to reduce dependence on such medications.

# W. Bengal unveils strategic river dredging initiative

Riverbank erosion continues to pose a significant threat across various distriets of West Bengal, par-ticularly during the monsoon season. Annual flooding, triggered by the collapse of riverbanks, has led to the submergence of countless homes, displacing communities and damaging local infrastructure. In response to growing public demand for a permanent solution, the West Bengal government has now embarked on a novel strategy to tackle the crisis. In a marked shift from traditional practices, the state government, under the guidance of Chief Minister Mamata Banerjee, has launched a public-private initiative aimed at maintaining river depth and reducing erosion through systematic dredging. State Irrigation Minister Manas Bhunia has confirmed that private entities will be allowed to extract and commercially sell dredged silt and sand from riverbeds. This policy, already in its

implementation phase, will



operate through a tender system—where contracts will be awarded to the companies offering the highest royalties per cubic metre.

'This time, the state will not bear the dredging costs," Bhunia declared, emphasizing that the project aligns directly with the Chief Minister's advice following protracted delays in financial support from the Centre. The state govern-ment has repeatedly accused the Central government of withholding essential funds, prompting Mamata Banerjee and sen-ior Trinamool Congress leaders to voice strong criticism. The erosion crisis is most acute in districts like Malda, Murshidabad, and South 24 Parganas—where nearly 40 kilometers of

Manikchak to Baishnabnagar in Malda experience annual collapse. Additional erosion hotspots include parts of East Burdwan, Hooghly, and East and West Midnapore. According to administrative sources, large swathes of land in Murshidabad also remain perennially vulnerable. In the 2025 fiscal

budget, the state has introdedicated "Nadibandhan" (River Control) project, allocating Rs. 200 crore to support erosion control and riverbank fortification. Officials report that district administrations in Birbhum and Midnapore have already commenced groundwork under the new scheme. Under this model, private contractors will be permitted to commercially trade the extracted silt, while paying the government fixed revenue. The dual benefit lies in generating state income while maintaining navigability and depth in critical river stretches—a pragmatic approach to a long-standing environmental challenge.

# TMC launches voter verification drive through 'didir doot' app

The initiative, formally classified as a party programme, involves BLA-2 (Booth Level Agents) representatives conducting door-todoor surveys across West Bengal to verify voter details. This extensive campaign is being coordinated the through launched mobile application—Didir Doot—which was officially rolled out on Wednesday.

On the first day of the campaign, BLA-2 workers were seen actively moving through alleys and neighborhoods, armed with smartphones, engaging with residents and collecting voter data.

paign covers over 80,000 polling booths across the state, and operations have already commenced in 26 organisational districts. The Didir Doot app has been specifically designed to enable real-time data verification, geotagging, and seamless digital submission of reports by ground-level workers. To ensure efficiency and accuracy, TMC has already conducted training sessions for BLA-2 agents across various districts.

### **United WB NSOF Teachers Associ**ation Appeals for Regularisation

MI News Service, Kolkata: To address the issues of unemployment and rising population, the central and state governments jointly initiated vocational educa-tion in schools. Introduced in 2013 as a pilot in Haryana and West Bengal, this scheme enables secondary and higher secondary students to study vocational subjects along-side general ones. This dual education enhances both skill and employabil-ity. In West Bengal, the contribution of the Hon'ble Chief Minister in launching this initiative was significant.Since 2016, CSS-VSE (Centrally Sponsored Scheme for Vocationalization of School Education) under NSQF has been successfully running in over 1,611 government and government-aided schools. Around 3,222 teachers are appointed as per NCERT and state norms. These teachers, despite being full-time educators of per-manent vocational subjects like IT, Electronics, Con-

struction, Banking, Health Services, etc., have been kept on a temporary basis for 12 years without any salary revision.Unlike other states, in West Bengal, the Technical Education Department (DVET) runs the scheme through private agencies, not the School Education Department. This has led to delayed salaries, missing EPF/ESI deposits, denial of maternity leave, and no provision of textbooks or resources to students. Teachers are burdened with triple workloads, including clerical tasks, without any recognition or job security. Despite repeated appeals and meetings, the issue remains unresolved. The association now seeks immediate intervention from the Chief Minister and Education Minister for regularisation, fair salary, and the removal of agencies to restore dignity and ensure justice for the thousands of dedicated vocational teachers in Bengal.

Major commodities of export from India to Saudi Arabia include engineering goods, rice, petroleum products, chemicals, textiles, food products, ceramic tiles. whereas, major commodities of import for India from Saudi Arabia are crude oil, LPG, fertilizers, chemicals, plastic and products thereof .Indian investment in Saudi Arabia has increased in recent years reaching approximately USD 3 billion (August 2023). The total Saudi investment in India has been about USD 10 billion. ). These investments are across diverse sectors such as management and consultancy services, construction projects, telecommunications, information technology, financial services and software development and pharmaceuticals. Saudi Arabia remained India's third largest Crude and Petroleum products sourcing destination for 2023-24. India imported 33.35 MMT of crude oil in 2023-24 from Saudi Arabia, accounting for 14.3 per cent of the India's total crude oil imports. In 2023-24, Saudi Arabia was the third largest LPG sourcing destination for India, accounting for 18.2 per cent of the total LPG imports of India for 2023-24. Another area of partnership is the India-Saudi Arabia defence ties that have strengthened in recent years. The first ministerial visit on the defence side in over 12 years took place when the then MoS (Defence) Ajay Bhatt visited Riyadh for the World Defence Show in February 2024. India and Saudi Arabia enjoy extensive naval cooperation and two editions of the bilateral naval exercise, 'Âl Mohed Al Hindi', have been concluded so far. engineering elite. Devadatta had previously made headlines for topping her state's Class 10 board exams, where she had already expressed her ambition to become an engineer. Her flawless JEE Main score now propels her one step closer to that dream. Rajasthan once again asserted its stronghold in the national rankings, contributing the highest number of toppers-seven in total. Telangana, Maharashtra, and Uttar Pradesh followed closely with three toppers each. Delhi and Gujarat had two toppers apiece, while Karnataka, West Bengal, and Andhra Pradesh each had one student who achieved a perfect score.

#### Kolkata police issues notice to Telangana police over alleged illegal arrest of businessman

Kolkata: In a dramatic inter-state row, the Kolkata Police has issued an official notice to Telangana Police, questioning the legality of a recent arrest that bypassed all local protocol. The development stems from an incident where a businessman was allegedly taken into custody from a south Kolkata hotel by officers from Telangana without prior notification to the Kolkata Police or producing the detainee before a city

According to sources at Lalbazar, the Shakespeare Sarani Police Station dispatched the notice to Golconda Police Station in Telangana on Friday. The notice seeks clarification on the arrest and has summoned the officers involved for questioning. The move follows a formal kidnapping complaint lodged by the friends of the arrested businessman, who alleged that the arrest resembled an abduction due to its secretive execution.

The incident occurred on Wednesday evening at a hotel on Camac Street. Yashvinder Singh, a businessman from Howrah, had rented a room there with a few friends. Shortly afterward, several men identifying themselves vaguely as police officers entered the premises. The friends claim they were not informed which state or department the officers reprethey revealed their affiliation response.

#### iPhone gift leads to heist: Café cashier arrested in Rs 2.5 lakh theft

News Service, Kolkata: In a bizarre case blending romance and crime, a young cashier from a popular café in Ballygunge, South Kolkata, was arrested for allegedstealing Rs 2.53 lakh from the establishment's safe to buy an iPhone as a birthday gift for his girlfriend. Despite employing calculated tricks—like disabling the café's power to shut down CCTV surveillance—the accused, identified as Chanchal Bhuniya, was nabbed within 24 hours, thanks to a digital trail left by an app-

based bike ride. According to police and court sources, the theft occurred in the early hours of Thursday. Upon opening the café on Friday morning, the staff discovered the safe had been broken into and reported the theft to Ballygunge police. Investigations revealed that the perpetrator had entered the premises using a duplicate key and deliberately cut off the electricity around 4:30 a.m., rendering the CCTV cameras ineffective.

The police, suspecting ininvolvement, began scrutinizing the call records of all café employees. Chanchal Bhuniya's phone showed a call placed to an app-based bike service during the time of the theft. The company confirmed that a ride had been booked from Ballygunge to Ramnathpur in Magrahat, South 24 Parganas. Acting swiftly, officers from Ballygunge Police Station tracked Chanchal to his

hometown and arrested him. A sum of Rs 49,920 was recovered from his possession, and during interrogation, Chanchal confessed that he used the stolen money to purchase an iPhone for his girlfriend's birthday. A subsequent raid at the girlfriend's residence led to the recovery of the iPhone along with the purchase receipt.

#### **Celebrating 100 Years of Howrah Division:** A Journey from Vision to Reality

Kolkata: The Howrah Division of Indian Railways is celebrating a century of its monumental contribution to the nation's transportation network, and its history is deeply rooted in the vision, perseverance, and determination of several remarkable individuals. The story of Howrah's railway network begins long before its establishment as a division, with the pioneering efforts of Prince Dwarakanath Tagore, Lord Dalhousie, and Sir Rowland McDonald Ste-

phenson. The vision for railways in Eastern India can be traced back to Prince Dwarakanath Tagore, the enterprising grandfather of Rabindranath Tagore. In 1833, his company, Carr, Tagore & Company, acquired the Raniganj Colliery, setting the stage for the industrial development of the region. Dwarakanath recognized the need for a railway network to connect the coal-rich regions of Bengal with Calcutta. In response, he founded the Great Western Bengal Railway (GWBR), which proposed a railway line from Calcutta to Rajmahal along the Ganga River, with an East-West spur to connect the coalfields. Despite his ambitious plans and offers of financial support, his dream was not to be realized, as the collapse of his Union Bank and lack of influence in England led to his defeat by the East Indian Railway (EIR).

vision faltered, Rowland McDonald Stephenson, the first agent of the East In-Railway Company, continued to push forward with the railway's development. In 1845, the EIR was formed with Stephenson at the helm, and after years of tireless negotiations with the British government, a contract was signed in 1849 to build a line from Calcutta to Rajmahal, largely based on Dwarakanath's original proposal. The first sod was turned in 1851 by Lord Dal-

housie, marking the beginning of railway construction in Eastern India.In 1854, sixteen months after the first train in India ran between Bombay and Thane, the first train in Eastern India chugged out of Howrah Station for Hooghly on August 15, 1854. This marked a significant milestone, not just for Howrah, but for the entire Eastern Railway net-

Over the years, Howrah Station, initially a small stop, grew into a bustling railway hub. It became the gateway to Eastern India, with mul-

In fact, two days ago, five children were injured while playing with a ball in the neighboring police station Kaliach, mistaking it for a bomb. There is a refugee camp in Parlal Pur High School in this Vaishnavnagar police station area. Every day, central ministers, national commissioners, gov-

ernors and VVIPs go there. And bombs are being stored in that police station area. There is a lot of excitement around this. These bombs were recovered from the Jalrahi Sisa area of Vaishnavnagar. On receiving the information, the bomb squad and fire brigade reached the spot. Bombs were defused with utmost caution. But the question arises where did so many bombs come from.

### "SC going beyond its limits; responsible for inciting religious wars in country": BJP leader Nishikant Dubey

MI News Service, New Delhi: Bharatiya Janata Party leader Nishikant Dubey on Saturday alleged that the Supreme Court is responsible for "incit-ing religious wars" in the country, saying the Parliament building should be closed down if the apex court has to make the laws. "The top court has only one aim 'Show me the face, will show you the law'. The Supreme Court is going be-yond its limits. If one has to go to the Supreme Court for everything, then Parliament and State Assembly should be shut," Dubey

"There was an Article 377 in which homosexuality is a big crime. The Trump administration has said that there are only two sexes in this world, either male or female... Whether it is Hindu, Muslim, Buddhist, Jain or Sikh, all believe that homosexuality is a crime. One fine morning, the Supreme Court said that we abolish this case...Article 141 says that the laws we make, the judgments we give, are applicable from the lower court to the Supreme Court. Article 368 says that Parliament has the right to make all laws and

right to interpret the law. The top court is asking the President and Governor to tell what they have to go regarding the Bills. When Ram Mandir or Krishna Janamboomi or Gyanvapi comes, you (SC) says 'Show us the paper'. Mughals ke aane ke baad jo Masjid banne hai unke liye keh raho ho paper kaha se dikhao," he added.

The BJP leader further alleged that the Supreme Court want to take this country towards "anar-

chy."
"How can you give direction to the appointing authority? The President appoints the Chief Justice India. The Parliament makes the law of this country. You will dictate that Parliament?... the ongoing hearing in the Supreme Court over several petitions challenging the constitutionality of the Waqf (Amendment) Act, Notably, the Centre had

assured the Supreme Court during the hearing held on April 17 that it would not denotify any 'Waqf-by-user' provision and would not include any non-Muslim members in the Board. The assurance comes a day after the top court said it will consider staying those parts of the law.

The Congress leaders attacked Nishikant Dubey over his statement on the Supreme Court and said that the latter continuously "demolishes" all other institutions.

Congress leader Manickam Tagore termed Nishikant Dubey's statement on the Supreme Court "defamatory," and said that his attack on the top court is "not acceptable.

"This is a defamatory statement against the Supreme Court. Nishikant Dubey is a person who continuously demolishes all other institutions. Now, he has attacked the Suas he is not speaking in Parliament but outside it. His attack on the Supreme Court is not acceptable," Tagore told ANI.

Congress MP Imran Masood said that the reported statement made by the BJP leader is "unfortunate.'

"The kinds of statements that are coming against the Supreme Court are very unfortunate...This is not the first time that the Supreme Court has given a decision against the full majority government... This frustration is incomprehensible," Masood said.

The Supreme Court's recent decision to set a timeline for the President of India to take a decision on the bills sent to her has also triggered a debate, with Vice President Jagdeep Dhankhar voicing disapproval of the judgment.

Earlier on April 17, Jagdeep Dhankhar said India cannot have a situation where the judiciary directs the President, adding that Article 142 of the Constitution has become a "nuclear missile against democratic forces for the judiciary.

Speaking at the Valedictory Function of the sixth against Democratic forces,

to Article 145(3), which deals with the composition of the bench required to decide substantial questions of constitutional law.

"We cannot have a situation where you direct the President of India, and on what basis? The only right you have under the Constitution is to interpret the Constitution under Article 145(3). There, it has to be five judges or more. When Article 145(3) was there, the number of judges in the Supreme Court was eight, 5 out of 8, now 5 out of 30 and odd. But forget about it; the judges who issued a mandamus virtually to the President and presented a scenario that it would be the law of the land have forgotten the power of the Constitution. How can that combination of judges deal with something under Article 145(3) if preserved, it was then for five out of eight. We also need to make amends for that now. Five out of eight would mean interpretation will be by majority. Well, five constitutes more than the majority in eight. But leave that aside. Article 142 has become a nuclear missile

NEW DELHI: Generative AI, while gaining widespread attention, is not without its flaws. A recent report by Deutsche Bank Research highlighted that despite its strengths, the technology still struggles with certain tasks, particularly when it comes to mathematical calculations.

The report noted that though generative AI has proven useful in many areas, such as summarizing, translating, and even generating creative content on a wide range of topics, its limitations in reasoning, learning abstract concepts, and developing an understanding of the world remain significant obstacles.

# Study finds how weight loss could reduce chances of severe infections in diabetic people

WASHINGTON: According to new research, weight loss therapies may lower the risk of severe flu cases and other infections in patients suffering from diabetes.

The research will be presented at the annual meeting of the European Association for the Study of Diabetes (EASD) in Madrid, Spain (9-13 September).


The study by Rhian Hopkins and Ethan de Villiers, of the University of Exeter Medical School, University of Exeter, Exeter, in the United Kingdom, there is evidence to support the link between severe illnesses and a higher BMI.

In contrast, there was no evidence that mild hyperglycamia contributes to the likelihood of a evere infection.

Hopkins says: "Up to one in three hospitalisations in people with diabetes are for infections and people with diabetes are twice as likely to be hospitalised with infections than the general population. They are also at high risk of readmission.

Previous studies have found that a higher BMI and poor blood sugar control are associated with severe infections. However, these studies have been observational and so haven't been able to prove that the links are causal.

"If one or both of these factors can be shown to be causal, it may be possible to design interventions to lower the risk of severe infections in those at high risk, such as people with diabetes." The new study used data from the UK Biobank, which holds medical and genetic data on around 500,000 people in the UK, to explore the effect of higher BMI and poor blood sugar control on hospitalisation for bacterial and viral infections. The 486,924 participants were classified into three groups: those with a record of hospitalisation for a bacterial infection, such as pneumonia or a urinary tract infection, (n=64,005) or a viral infection, such as flu, (n=14,562) and an infection-free control group (n=408,357). A higher BMI was found to be associated with hospitalisation with infections. The likelihood of being hospitalised with a bacterial infection



increased by 30 per cent per 5-point increase in BMI (for instance, an increase in BMI from 30 kg/m2 to 35 kg/m2). Similarly, every five-point increase in BMI was associated with a 32 per cent increase in the likelihood a severe viral infection.

Mild hyperglycaemia was also found to be associated with severe infections. The likelihood of being hospitalised with a bacterial infection increased by 32 per cent per 10mmol/mol increase in HbA1c, a measure of blood sugar levels. Similarly, every 10mmol/mol increase in HbA1c was associated with a 29 per cent increase in the likelihood of a severe viral infection.

The team then used Mendelian randomisation, a technique that uses genetic information to establish whether a factor actually causes ill health, to determine if the relationships were causal.

This suggested that a higher BMI is one of the causes of severe bacterial and viral infections.

However, mild hyperglycaemia did not appear to be a cause of severe infections.



study suggested that the risk of malignant melanoma, or skin cancer, may be declining in Sweden, at least for people under the age of 50. Waqf properties cannot be sold or least by anyone permanently. We found that the Waqf properties were illegally registered through fictitious processes and those who sold such properties for charitable purposes could not be traced as their addresses were fake.'

Raj also added, "We have asked the collectors and the SPs to recover all the illegally sold properties, cancel the registrations and also resolve the issue that came to light during the survey of the

The people who have been sent notices include those living on the Waqf properties but have not paid rent since years.

According to Raj, in Chhattisgarh no non-Muslims have donated any land to Waqf Board. He expressed his disappointment over individuals treating Waqf properties as their personal assets and said that all properties are being evaluated by the Board cur-

A team from the Ministry of minority affairs was sent to Chhattisgarh last week to inspect the work properties and their current status.

### Now even Sharbat is divided: Communal polarization of business

MI News Service: Even something as simple and unifying as sharbat has now fallen prey to communal polarization—divided along Hindu-Muslim lines.

Baba Ramdev, whose Sangh affiliations are well known, is a living embodiment of the alliance between Hindutva politics and corporate interests. Draped in saffron robes, he is both a symbol and a product of the Sangh-BJP's Hindutva-corporate nexus. People still recall the moment when Ramdev, fearing arrest, tried to escape dressed in a salwar-kurta-a garment often associated with Muslims. Ironically, it was this "Muslim" attire that shielded him during his moment of cowardice. Yet today, this same Ramdev is at the forefront of peddling hatred and fear about Islam and Muslims.

His latest controver-sial remark is: "There is a company selling sharbat, and the money it earns is used to build madrasas and mosques. If you drink that sharbat, madrasas and mosques will flourish. But if you drink Patanjali sharbat, gurukuls, Acharyakulam, Patanjali University, and the Indian Education Board will thrive. That's why I call this Sharbat Jihad. Just like love jihad and vote jihad, Sharbat Ji-

had is also going on."

This video statement, currently circulating on social media, is a thinly veiled attack on Rooh Afza. Interestingly, Ramdev does not challenge its quality. Rooh Afza is a non-alcoholic herbal drink created in 1906 in Ghaziabad by Hakim Hafiz Abdul Majeed during British rule. An expert in Unani medicine, he crafted the drink using herbs and rose essence to provide relief in the scorch-

ing Indian summers. To-day, it is manufactured by Hamdard Laboratories, a well-regarded institution. The current formula includes eight herbs and extracts from eight fruits and vegetables. Over 115 years, Rooh Afza's quality and reputation have remained

A rival product, Dil Afza, was introduced to compete with Rooh Afza but was later banned by the Delhi High Court—a decision up-

held by the Supreme Court.
No official report or
credible evidence supports Ramdev's allegation that the proceeds from Rooh Afza are used to build mosques or madrasas. He has offered no proof to back this inflammatory claim. Publicly available information shows that Hamdard is run by a non-profit trust with a secular ethos. It celebrates both Holi and Eid, and in 2008, actress Juhi Chawla became its brand ambassador. Had the company been driven by a religious agenda, it is unlikely she would have represented the brand.

On the other hand, Ramdev openly admits that profits from his sharbat will fund educational initiatives aligned with the Sangh ideology—institutions that are likely to promote a regressive worldview rooted in varna and caste hierarchy, rather than scientific temper and constitutional values. His agenda is a clear attempt to erode secularism and the foundational principles of the Indian

Constitution.

The Rise of Patanjali: A
Corporate Built on Contro-

Patanjali was co-founded by Ramdev and Balkrishna in 2006. From toothpaste and skincare to treatments for fever and typhoid, the

brand now covers a vast product range and is valued at over Rs 10,000 crore. Ramdev's rise—from a TV yoga guru to a corporate tycoon—illustrates the worst aspects of crony capitalism: deceit, fraud, and exploitation.

To promote his products—often criticized for their dubious quality— Ramdev has consistently attacked modern medicine. During the COVID-19 pandemic, he claimed that lakhs had died due to allopathy and introduced Coronil as a cure. The AYUSH Ministry later banned the product, labeling it "substandard." In 2016, the army rejected Patanjali's Amla juice due to poor quality. Its cow ghee has also faced scrutiny. Back in 2006, CPI(M) leader Brinda Karat accused Ramdev of using human and animal bones in his medicinesan allegation supported by factory workers who also reported violations of labor laws and underpayment. The Labour Department's inquiry confirmed these

Thus, Patanjali's empire has been built not just on marketing and nationalism, but on worker exploitation and unethical practices.

Ramdev's Gulab Sharbat: A Copy of a Century-Old In-

Ramdev's Gulab Sharbat, promoted as a nationalist alternative to Rooh Afza, is not a new invention. Its primary ingredient—rose—was used by Hakim Hafiz Abdul Majeed over a century ago. Ramdev's version is essentially a copy of Rooh Afza, wrapped in a different label

and an ideology of division.
But the real issue isn't about which sharbat is better. The controversy lies in how Ramdev is communalizing a common beverage to drive his brand's sales. No law in India permits hate speech, false marketing, or the communal division of food and drink products. His attempt to create a "Hindu Sharbat" versus "Muslim Sharbat" narrative—accusing Muslims of waging "Sharbat Jihad"—echoes the very tactics of colonial rule. Lessons from History: A

Cup of Unity In his article "Hindu Sharbat aur Muslim Sharbat", independent journalist Sanjeev Shukla recounts

a powerful anecdote: During the trial of the Azad Hind Fauj soldiers at the Red Fort, Colonel Sehgal, Dhillon, and Shahnawaz became national symbols of resistance. To disrupt this unity, the colonial government ordered tea to be served as "Hindu tea" and "Muslim tea" to the imprisoned soldiers. But the soldiers rejected this communal ploy. Each morning, when the tea arrived, they would mix it in a large vessel and share it—reaffirming their collective spirit and unity.

This act was a beautiful symbol of the unity that powered India's freedom struggle.

Rebuilding Divisions for Profit

through India's independence movement-breaking down barriers of caste and religion—is being systematically dismantled by the Sangh-BJP and their corporate allies. A US airstrike on an important oil port held by Yemen's Houthi rebels killed more than 70 people and wounded many others, the Iranian-backed rebel group said on Friday, marking a major escalation in the military campaign President Donald Trump launched against the faction last month.

The overnight strike on the Ras Isa port sent massive fireballs billowing skyward and turned tanker trucks into burning

It was the first American attack on a Houthi-controlled oil facility in the new US bombing campaign. It also came just before the resumption of negotiations in Rome between the US and Iran over Tehran's rapidly advancing

nuclear programme, which Washington has linked to its attacks in Yemen.

The US is targeting the Houthis because of the group's attacks on shipping in the Red Sea, a crucial global trade route, and The Houthis are the last

militant group in Iran's self-described "Axis of Re-sistance" that is capable of regularly attacking Israel. The port is a major hub

for incoming fuel shipments that power areas of Yemen held by the Houthis, and analysts say the airstrike could seriously affect daily life there.

The Houthis, who said the attack killed at least 74 people and wounded 171 others, aired graphic footage of the aftermath on their al-Masirah satellite news channel, showing corpses strewn about the port and smashed tanker trucks. They denounced the strike as a "completely unjustified aggression".

"It targets a vital civil-ian facility that has served the Yemeni people for decades," the group said in a

US Central Command declined to answer any questions about possible civilian casualties but referred to a statement in which it said "this strike was not intended to harm the people of Yemen".

"US forces took action to eliminate this source of fuel for the Iran-backed Houthi terrorists and deprive them of illegal revenue that has funded Houthi efforts to terrorize the entire region for over 10 years," it said in its statement. A US official said the attack sent a message to those supplying fuel to the Houthis despite sanctions. The official spoke to The Associated Press on the condition of anonymity to provide details not yet made public.

Hours after the US strike, the Houthis launched a missile toward Israel that was intercepted, the Israeli military said. Sirens sounded in Tel Aviv and elsewhere. Meanwhile, the Houthis

said they shot down another American MQ-9 Predator drone, which the US official acknowledged.

Hindu women were caught smuggling liquor under burqas at Mania railway station in Katihar, Bihar, revealing the persistent failure of the state's liquor ban and the controversial misuse of religious

clothing. Veena Devi and Nandini Kumari, residents of Pipradhari Tola, were arrested while attempting to bring liquor from West Bengal into Bihar. Disguised in burgas over sarees and pretending to be pregnant, they had tightly taped tetra packs of foreign liquor to their bodies—Veena

Subhash Kumar Singh, Excise Superintendent, said the women were caught based on a tip-off, part of a special crackdown targeting border smuggling routes like railway lines and rivers. "Their plan was clever, but not clever enough," Singh remarked, emphasizing that smugglers are constantly adapting to evade law enforcement.

The incident sparked outrage and debate. While burgas are often criticized by right-wing groups as symbols of backwardness or extremism when worn by Muslim women, the silence after Hindu women used the garment for criminal activity has exposed double standards. "This is pure hypocrisy," said Zeba Khan, a women's rights activist in

insulted for wearing burgas, but when Hindu women misuse it, no one reacts.'

Local voices echoed similar sentiments. Faizan Ahmed, a resident, questioned the lack of media and political response: "Imagine the uproar if Muslim women had done this. But since they were Hindu, everyone's

"This is already three times longer than the one enforced in October 2023 when the

war started," it added. It noted that there are "at least 20 displacement orders issued by the Israeli military between 18 March and 14 April, in total," resulting in "about 69% of the Gaza Strip is under active displacement orders, within the 'no-go'

zone or both." The agency estimated that 'nearly 420,000 people have been displaced yet again

It also said that "resumed bombardments and the total restriction on aid are severely hampering humanitarian agencies' ability to respond to urgent needs-especially food, clean water, sanitation, shelter, and medical supplies." Israel resumed its attacks in Gaza on March 18, shattering a two-month truce.

More than 51,000 Palestinians have been killed in Gaza in a brutal Israeli onslaught since October 2023, most of them women and children.

The International Criminal Court issued arrest warrants last November for Israeli Prime Minister Benjamin Netanyahu and his former Defense Minister Yoav Gallant for war crimes and crimes against humanity in Gaza.

#### Meta deletes 90,000 pro-Palestine posts at Israel's request

Since Octo-Francisco: ber 7, 2023, when Israel launched its latest military offensive on the Gaza Strip, a parallel battle has been unfolding online. According to a recent report by Drop Site News, technology giant Meta has removed over 90,000 pro-Palestinian posts from Facebook and Instagram, allegedly in response to takedown requests from the Israeli

government. The data, reportedly sourced from whistleblowers with access to internal records, indicates that Meta complied with 94 percent of Israeli takedown requests.

Most of the targeted accounts were based in over 60 countries, mainly Arab and Muslim-majority nations. In contrast, only 1.3 percent of the takedown requests were related to Israeli users. Much of the removed

content was flagged under Meta's internal categories related to "violence and incitement" or other security-related concerns. While Meta has not of-

ficially confirmed the figures, it has defended its moderation policies repeatedly, claiming they are designed to promote safety and curb incitement to violence.

With mainstream media offering limited coverage, Palestinians have relied on social media to share evidence of the crisis in Gaza.

Following this early jolt, Jos Buttler joined Sai Sudharsan, and both picked their respective targets in spin and pace. While Sai collected two fours against Starc, Buttler proved to be lethal against DC skipper Axar Patel and Vipraj Nigam's spin. GT brought up their 50 runs in 4.3 overs, thanks to a huge six over long-on by Buttler.

At the end of six overs, GT was 67/1, with Sai (34\*) and Buttler (25\*) unbeaten. Sai smashed Mukesh Kumar for two fours in the final over of the powerplay. However, in the eighth over, this assault, removing Sudharsan for a promising 36 in 21 balls, with five fours and a six as the batter failed at attempting to pull. The ball went into the hands of Tristan Stubbs at deep mid-wicket. GT was 74/2 in 7.3 overs.

in four overs

In the next over, some more brute hitting from Buttler and careful strike rotation brought down the deficit to 25 in 18 balls.

Rutherford failed to clear a full toss by Mukesh Kumar, giving a catch to Starc at long-off, for 43 in 34 balls, with a four and three sixes. GT was 193/3 in 18.5 overs.

The equation came down to 10 runs needed in the final over and Rahul Tewatia started off by

smoking Starc for a huge six and finished off with a four on the next. Buttler was left stranded at 97\* in 54 balls, with 11 fours and four sixes.

Kuldeep Yadav (1/30) and Mukesh (1/40) were among the wickets for DC.

NEW DELHI [INDIA]: Himanshu Jakhar, who created history after becoming the first Indian to clinch gold in men's javelin throw at the U-18 Asian Athletics Championships in Dammam, Saudi Arabia, on Saturday, will be a major attraction at the upcoming Khelo India Youth Games in Bihar, scheduled from May 4 to 15.

Himanshu, who hails from Salahawas village in the Jhajjar district of Haryana, clinched the yellow metal with a massive throw of 67.57 meters, much ahead of China's Lu Hao (63.45m) and Uzbekistan's Ruslan Sadullaev (61.96m). His father, Dalbir, and mother, Reena, are farmers, as per a Sports Authority of India (SAI) press release.

The 17-year-old Himanshu Jakhar picked up a javelin just five years back, training in his home village initially before shifting to the SAI Centre in Hissar. Talking to SAI Media from Saudi Arabia, Himanshu said that his next target is the Khelo India Youth Games in Bihar, scheduled from May 4 to 15.

"It has been a wonderful experience to be able to win gold for the country here. But it was a lot of hard work, along with my coaches, to reach this far. I have been training at the SAI Centre in Hisar under coach Arvind for the last 2-3 years and with better coaching, better equipment, better ground and gym, etc, I was able to make the country proud. My next target is now to attract the talent scouts at the Khelo India Youth Games and then Junior Nationals," Himanshu

"Khelo India is a great initiative of the Government of India, and a platform like this is essential for individuals in my age group to slowly make a contribution towards the nation," he added.

Himanshu, whose previous personal best in the 700 g javelin throw was 74.56 m, achieved at the National Junior Athletics Championships in December 2024, sees Olympic champion Neeraj Chopra as his inspiration.

"He (Neeraj Chopra) is an inspiration to not just me but the entire country. What he has achieved for India does not happen every day.
