Mamata announces industrial resurgence in Bengal lays foundation of 1600 MW Thermal Power projects

 $\boldsymbol{M\!I}$ News Service, Salboni: In a significant step toward strengthening West Bengal's energy infrastructure and industrial growth, Chief Minister Mamata Banerjee on Monday laid the foundation stone of a 1,600 MW ultra-supercritical thermal power plant at Salboni in Paschim Medinipur district. The state-of-the-art project will be implemented by JSW Energy at an estimated investment of ₹16,000 crore. This greenfield venture marks JSW Group's first major entry into the energy sector in Eastern India. The proposed plant will consist of two units of 800 MW each, with the first unit scheduled for commissioning in 42 months and the second in 48 months.

Calling it a "historic and landmark initiative," Chief Minister Banerjee praised JSW Group for its commitment to Bengal's development. "This project will supply power to 23 districts and generate employment for nearly 15,000 people. It is not just a power plant; it is a symbol of industrial resurgence and energy security," she said, lighting a digital lamp and unveiling the foundation plaque at the event. She emphasized that the plant, based on ultra-supercritical

technology, would operate with minimum environmental impact. "We believe in eco-friendly industrialisation. This is the need of the hour," Banerjee stated. She further revealed that two additional power units are being planned to meet the state's growing electricity needs. The Chief Minister also used the occasion to reiterate her message of peace and unity amidst recent disturbances in a few districts. "Our country is known for its diversity, and Bengal celebrates that with unity. We must all work together and stay positive," she said, reminding the public of her open letter calling for harmony. The CM also addressed the recent unrest in certain areas, reminding the public of the government's ongoing efforts to maintain peace. "I just want to say, love one another and stay happy," she stated. Banerjee also reiterated her commitment to ensuring social harmony, following her recent open letter to the people of the state urg-ing peace and understanding.

During her speech, Banerjee took a dig at her critics, particularly those questioning the state's development initiatives. She pointed out the tangible progress

made, including the ongoing work in the JSW cement plant and other large-scale projects launched at the World Bengal Business Summit. "Critics may say nothing is happening, but they should look at the reality. I inaugurated the cement factory here, and now work is in progress. At the Business Summit, proposals worth Rs 19,000 crore came in, and projects worth Rs 16,000 crore are already underway. More will follow soon, she added.Banerjee also mentioned the collaboration with Dr. Devi Shetty, announcing the commencement of a hospital project in Rajarhat as part of the state's expanding healthcare infrastructure. "Dr. Shetty had promised to work with us, and we are beginning with this hospital," she concluded, reiterating her administration's commitment to development and service to the people of West Bengal. JSW Group Chairman Sajjan Jindal, present at the event, termed Salboni a "dream project" and reaffirmed the Group's longterm commitment to Bengal. "This project will use the best technology with zero pollution. The farmers of this land must benefit from the industry," Jindal said. He also laid

the foundation stone for an industrial park near the plant, expected to generate thousands more jobs. Cricketer Sourav Ganguly and

Trinamool Congress MP Dipak Adhikari (Dev) were also present at the ceremony. Banerjee concluded by reaffirming Bengal's pro-industry stance: "Our government ensures a business-friendly environment, robust infrastructure, and consistent policy support. With six new economic corridors and a Synergy Committee clearing ₹1,000 crore worth of projects, Bengal is ready for a new era of industrial growth." After spending the night at the state guest house, Mamata Banerjee will inaugurate a solar power project in Garbeta, in the same district tomorrow on April 22. She is also scheduled to Midanpore town later during the day. . Prior to today's programme, the Chief minister said the Trinamool Congress government under her leadership had been organizing the Bengal Global Business Summit (BGBS) every year which has resulted in attracting substantial investments in the state over the past several years.She said, "every year after the BGBS, some people ridicule the $\,$ summit, but right now, they can see that Bengal has become the destination for industries and industrialists. As a result, two thermal power plants are coming up in Shalboni alone.." "As the population grows, the demand for electricity increases, so we are focusing on power projects", the Chief minister said adding "We are also developing six economic corridors. Once the Deucha-Panchami project is complete, Bengal will have no problems for power for the next 100 years.

The Chief minister also announced the details of some other ongoing power projects, including a 660-megawatt plant in Durgapur, a 960-megawatt plant in Sagar Dighi, a 660-megawatt plant 1,600-megawatt plant in Santaldihi. These projects, she hopes, will provide many job opportunities, strengthen the economy, and ensure 24-hour electricity for all. Tomorrow on Tuesday, Mamata Banerjee will inaugurate a solar power project in Garbeta, also in West Medinipur. This project,

New Delhi and Washington are now holding negotiations to seal a bilateral trade agreement that is expected to address a variety of issues, including tariff

and market access. JD Vance and Usha are parents to three lively kids - Ewan. Blake and daughter Mirabel Vance. His two sons were wearing a kurta pyjama, and his daughter, the youngest of the three, was wearing an anarkali suit on their arrival here. The couple's eldest son, Ewan, wore a blue kurta for his India trip. After getting off the aircraft, he walked down the stairs while his parents waited for him on the tarmac. 88 year old Pope Francis passed away after a protracted illness

MI News Service, Rome / Vatican City : Pope Francis, who was suffering from various old age ailments including pneumonia for the past few months, passed away this morning at his residence, the Vatican said on

According to a statement issued by the Vatican, the Pope passed away on Easter Monday at the age of 88 at his residence in the Vatican's Casa Santa Marta.

The Vatican statement said Cardinal Kevin Farrell, Camerlengo of the Apostolic Chamber, announced the Papal death at the Casa Santa Marta at 7-35 AM (local time): "Dearest brothers and sisters, with deep sorrow, I must announce the death of our Holy Father Francis. At 7:35 this morning, the Bishop of Rome, Francis, returned to the house of the Father. His entire life was dedicated to the service of the Lord and of His Church. He taught us to live the values of the Gospel with fidelity, courage, and universal love, especially in favour of the poorest and most marginalised. With immense gratitude for his example as a true disciple of the Lord Jesus, we commend the soul of Pope Francis to the infinite merciful love of the One and

Triune God. Just 24 hours ago on Easter Sunday, the Pope delivered his Easter



message from the balcony of St Peter's Basilica in presence of thousands of people from across the globe who had gathered in Vatican Square to listen to the Pope's mes-

Later he met US Vice Preident J D Vance at his office as Vance was on a three day tour of Italy. He was the last foreign dignitary who called on the Pope for his blessings. . The 88year-old head of the Roman Catholic Church was recently discharged from Rome's Gemelli Hospital, where he spent five weeks receiving treatment for an infection that led to double pneumonia. On Easter Sunday, he was able to offer the "Urbi et Orbi" blessing to the city of Rome and to the world. Only the pope can offer this blessing, which includes the offer of an indulgence, a remission for the effects of sins.

"Christ is risen! These words capture the entire meaning of our existence, for we were not made for death but for life," the official X handle of the Pope said on Sunday. Cardinal Angelo Comastri, Archpriest emeritus of Saint Peter's Basilica and Vicar General emeritus of Vatican City, led the liturgy in the Square and delivered the homily of Pope Francis, prepared for the occasion, as reported by Vatican News

Pope Francis dedicated his Easter Urbi et Orbi message to calling for peace worldwide, global disarmament, and the release of prisoners. Pope Francis was the first Pontiff from the Jesuit Order and the first from outside Europe since the 8th century, Born in Buenos Aires, Argentina, as Jorge Mario Bergoglio, he was ordained a Catholic priest in 1969. Following the resignation of Pope Benedict XVI on February 28, 2013, a papal conclave elected Cardinal Bergoglio as his successor on March 13. He chose Francis as his papal name in honour of Saint Francis of Assisi

There will now be a nine-day period of official mourning after which the Cardinals will go into conclave to elect the new Vicar of Christ.

Howrah Chemical factory fire in Domjur contained, **RAF** deployed

MI News Service, Howrah: A major fire is raging at an ONGC chemical factory in Domjur, Howrah creating widespread black smoke. Initial firefighting efforts failed to the intense blaze, intensified by numerous chemicals and oil tankers. Explosions are occurring and the RAF has been deployed. Firefighters can't accest the site, raising casualty concern's despite. worker evacuation. Their cause is unknown, and more resources are being mobilized.

A significant fire erupted at an ONGC chemical factory situated in the Domjur area of Howrah, West Bengal, resulting in a substantial plume of black smoke that has reportedly engulfed approximately 8% of the surrounding area. Initial response efforts involved 15 fire tenders; however, the fire brigade has since suspended direct firefighting operations using water, citing the ex-treme intensity of the blaze, which cannot be effectively countered by water alone. There is a considerable risk of rapid fire propagation within the chemical facility due to the presence of a large quantity of flammable materials. In response to the escalating situation, the Rapid Action Force (RAF) has been deployed to the area. The ONGC-operated chemical plant is located in a relatively isolated area within Domjaur. Preliminary reports indicate a significant inventory of chemicals stored at the facility, including an estimated 100 to 150 oil tankers. The stored materials are reportedly undergoing explosions, causing tremors throughout the site. The combination of the substantial volume of flammable substances and prevailing gusty winds is contributing to the swift spread of the fire. The factory's location outside densely populated residential areas offers a degree of mitigation against wider community impact, which officials acknowledge as a

However, the possibility individuals being trapped inside the factory remains undetermined, as firefighters have been unable to gain access to the interior. Authorities are currently exploring alternative strategies to bring the fire under control. Notably, residential quarters for factory workers are located within the vacant surrounding the plant, and these occupants have been successfully evacuated to secure locations. Despite ongoing efforts, containment of the fire has not yet been achieved, and there are indications that additional fire tenders will be deployed to the scene. The cause of the fire is currently under investigation.

receiving no response de-spite persistent knocking, fellow students broke down the door, only to find Walker deceased. The Kharagpur Town police were immediately notified and arrived at the scene. Walker's family in Maha-rashtra has been informed of the tragic incident. An autopsy is scheduled for Monday at Medinipur Medical College Hospital to determine the cause of death. Authorities are currently investigating whether it was a case of suicide or foul play. This incident marks the second student death by hanging at the presti-gious institution this year. A few months prior, another student, a resident of Kasba, was found deceased in his hostel room in a similar manner during a holiday visit by his parents. These repeated incidents have left IIT authorities in a state of uncertainty and heightened concern.

Body ready for cremation, police intervene after starting discovery

Authorities in Bongaon intervened to halt the cremation of a 65-year-old man after crematorium staff raised concerns regarding the circumstances of his death. The deceased, identified as Dhrub Kundu, a resident of Garapota, was brought to the Bongaon Bhupendranath Seth Smriti Maha Crematorium for cremation on Monday.According to reports, crematorium workers became suspicious after observing the body and reviewing the death certificate, which had been obtained from a local homeopathy doctor. of Bongaon Municipality. Subsequently, the police were informed and swiftly arrived at the crematorium. The scheduled cremation was immediately stopped, and the body was taken to Bongaon Hospital for a thorough autopsy. The incident has reportedly caused considerable unease at the crematoclaims he passed away at home on Sunday morning. However, the suspicious observations by the crematorium staff have triggered a police investigation to ascertain the actual cause of death and rule out any possibility of foul play. CPIM rally, Kunal Ghosh hints at "Fake Attendees"

MI News Service, East Midnapore: The CPIM's recent brigade rally, showcasing a mobilization of marginalized workers, has sparked a political firestorm, with Kunal Ghosh accusing the BJP of infiltration and both Trinamool and BJP leaders labeling it a failure. Kunal Ghosh Alleges BJP Infiltration of CPIM Brigade Rally, Amidst Claims of Strong Turnout Egra, East Midnapore: Trinamool Congress state general secretary and spokesperson Kunal Ghosh has alleged that individuals "disguised" as CPIM supporters attended the Left Front's brigade rally, insinuating a deliberate infiltration by BJP affiliates. Speaking at a function in Egra on Sunday evening, Kunal Ghosh dismissed the rally as a "goose brigade," asserting that BJP voters comprised a significant portion of the attendees. De-



spite reports of a substantial turnout, with roads in East Midnapore reportedly "red on red" due to the influx of workers, daily wage Kunal Ghosh maintained that the rally was orchestrated to attract BJP votes. He criticized the CPIM's slogan, suggesting it served as a conduit for transferring allegiance to the BJP. "The slogan of that brigade is the brigade of the CPM, come on. Then come back from the brigade to vote for the BJP," Kunal Ghosh stated.

He further downplayed the

rally's significance, arguing that assembling a crowd of four individuals was not a substantial feat. Kunal Ghosh also invoked the concept of an alliance, dubbing the rally a "Ram-Left brigade and Inquilab-Jai Shri Ram brigade," a clear reference to the perceived convergence of CPIM and BJP interests. His remarks echo a similar sentiment expressed by other political figures. BJP leader Su-vendu Adhikari and Trinamool leader Jayaprakash Majumdar both dismissed the rally as a "flop show," mirroring Kunal Ghosh's critical assessment. The CPIM rally, while showcasing a significant mobilization of marginalized labor leaders and a considerable crowd, has become a focal point of political contention, with allegations of external influence casting a shadow over its perceived success.

Murshidabad displaced returned as Parlalpur

MI News Service, Murshidabad: About 85 families who fled their homes in Murshidabad's Shamsherganj area due to violence over the Waqf Act have safely returned home. They had taken shelter in a reef camo at Parlalpur High School in Malda's Vaishnavnagar. Local authorities, including the Superintendent of Police and MALs, facilitated their return. The situation is now calm, with 292 accused arrested and 153 cases filed.

In a significant development, approximately 85 families who were forced to flee their homes in Murshidabad's Shamsherganj area due to recent violence sparked by opposition to the Waqf Act have safely returned residences. The families had taken shelter in a relief camp at Parlalpur High School in Malda's Visnagar. Under the leadership of Jangipur Superintendent of Police Anand Roy, and in the presences of local dignitaries including Jangipur MP Khalilur Rahaman,

Shamsherganj Amirul Islam, and farakka MLA Monirul Islam, the families were escorted back t their homes via the Dhulian Kanchantala Gnaga Ghat . The violence had led to widespread vandalism, with cars and houses being set on fire, prompting many families to cross the Ganges and seek refuge in the Parlalpur High School shelter camp. However, with the situation now under control, the administration facilitated the families return home. According to Superintendent of Police Anand Roy, a total of 153 cases have been filed, and 292 accused individuals have been arrested in connection with the violence. Local leaders have attributed the return of the families to the restoration of peace and normalcy in the area. The successful rehabilitation of the displaced families marks a positive step towards rebuilding and restoring normalcy in the affected areas of Mur-

Man gets death sentence for murdering wife in front of 4-yr-old son

MI News Service, Jalpaig**uri:** A Jalpaiguri court has sentenced Sujit Bhowmik to death for the brutal axe murder of his wife in 2023, which occurred in front of their minor son. The motive is believed to be the wife's discovery of her husband's extramarital affair, leading to frequent domestic disputes. When the victim's parents attempted to intervene, Sujit also allegedly tried to kill them. The Additional Third Court Judge deemed the crime "rarest of rare," also sentencing Sujit to life imprisonment and a ₹1 lakh fine for attempted murder. though the convict claims the incident was staged.

In a verdict delivered on Monday, the Additional Third Court Judge of the Jalpaiguri District and Sessions Court sentenced Sujit

De Bhowmik to death for the murder of his wife in 2023. The crime, which occurred in Charerbari Sarkarpara under the Maynaguri police station jurisdiction, involved the accused repeatedly striking his wife with an axe in the presence of their minor son. The prosecution argued that the murder was a consequence of the wife's discovery of Mr. De Bhowmik's alleged extramarital affair, which had become a source of constant domestic conflict. The wife was reportedly perceived as an impediment to this relationship. On the morning of the fatal incident, further unrest at their home allegedly escalated, culminating in the violent attack. During the incident, the victim's parents were also present at the residence.

Bakura School's science department crippled as 6 teachers lost jobs

MI News Service, Bakura: A court order has thrown the science department of Jhilimili School in Bankura, a crucial institution for 1,500 students in the Jangalmahal border region, into chaos as 9 teachers, including 6 from science, lost their jobs. The school, serving an economically disadvantaged tribal area across three districts, now faces a severe crisis with the future of its science de-

partment and overall education hanging in the balance. Jhilimili High School in the Ranibandh block of Bankura district is grappling with a significant educational crisis following a recent court order that resulted in the dismissal of nine teachers, including six from its science department. Situated on the southern border of Bankura, bordering the Bandwan block of Purulia and the Belpahari block of Jhargram districts, the school serves as a crucial educational hub for over 1,400 students from these economically disadvantaged tribal regions. The abrupt departure of a substantial portion of the teaching staff, particularly within the science department, has cast a pall of uncertainty over the academic future of the students.

Digha buzzing for temple opening, mystery Jagannath statue washes ashore

MI News Service, Digha: Just days before its grand inauguration by Chief Minister Mamata Banerjee, the newly built Jagannath temple in Digha is already illuminated and the beach town is abuzz with festive decorations. However, the celebratory atmosphere was briefly disrupted on Sunday by the unexpected arrival of a full-sized Jagannath statue on the seashore near Maiti Ghat, sparking widespread speculation and excitement among locals and tourists alike. The image of the idol quickly went viral, adding an intriguing element to the upcoming temple



opening. Preparations are in their final stages for the imminent inau-

guration of the Jagannath temple in Digha, a project spearheaded by Chief Minister Mamata Banerjee. The coastal town is currently adorned with illuminations and experiencing heightened activity in anticipation of the event. However, an unexpected incident on Sunday caused considerable local excitement.

A complete Jagannath statue was discovered on the Digha shoreline, prompting widespread speculation regarding its origin within the popular Bengali tourist destination. State Govt mandates signage on hazardous chemical transport vehicles to avert accidents

MI News Service, Kolkata: In a significant move aimed at enhancing road safety and preventing chemicalrelated disasters, the West Bengal government has introduced a new directive requiring mandatory signage on vehicles transporting hazardous substances. Following multiple incidents involving flammable and toxic cargo, the State Transport Department has issued detailed guidelines to ensure that such vehicles are clearly marked and easily identifiable on the roads.

Under the new Standard Operating Procedure (SOP), all trucks and tankers carrying inflammable chemicals, including LPG, CNG, petrol, diesel, radioactive materials, and toxic gases, must display signage both at the front and rear. These signs must clearly indicate the type of chemical being transported, allowing other vehicles to maintain a safe distance and exercise caution. The directive comes In the wake of a tragic incident on Central Avenue, where a tanker carrying chemical fuel collided with a stationary truck, resulting in a fire that killed the driver. Several other similar accidents across the state have prompted the government to take stringent preventive measures Earlier, the Transport Department had already mandated the use of fire extinguishers, spark arrestors, and trained drivers for vehicles transporting hazardous materials. In addition, such vehicles must environmental clearance from the Pollution Control Board. As part of the new rule, drivers must also carry complete documentation detailing the source and destination of the cargo, and if inter-state transportation is involved, permissions from both state authorities must be se-

Kolkata teacher enters **Guinness World Records for collecting** 1.034 movie tickets

MI News Service, Kolkata: In an age where everything is a click away — be it shopping, entertainment, or movie tickets — one man's passion for tradition has earned him global recognition. While most people book film tickets online and rarely visit box offices, Devangon Seal, a school teacher from Kolkata, has made a world record out of standing in line at cinema halls and collecting printed movie tickets — a hobby that has earned him a place in the prestigious Guinness Book of World Records.

Devangon, a resident of Jyangra in Baguiati, has been a cinema enthusiast since childhood. He remembers dialogues and songs from countless films and has an emotional connection to the theatres themselves. His journey began in 2003 when he watched Bombaiyer Bombete at Jaya Cinema in Lake Town. Instead of discarding the ticket, he preserved it. That moment sparked a lifelong habit. Since then, Devangon has travelled across West Bengal — from Medinipur and Barasat to Bardhaman and North Bengal — visiting theatres such as Roxy, Paradise, Elite, Chhabighar, Minar, and Bijoli. In every instance, he retained the physical ticket. His personal collection now boasts 1.034 tickets from 197 different single-screen theatres. Among them, Jaya Cinema remains his most frequented venue, with 154 tickets alone preserved from that hall. By profession, Devangon teaches at a private school, but cinema is his enduring passion. He recently submitted his meticulously archived ticket collection to the Guinness World Records authorities.

Bench reassigned in 32,000 primary teacher termination case: Hearing from April 25

MI News Service, Kolkata: In a significant development in West Bengal's prirecruitment controversy, the Calcutta High Court has reassigned the highprofile case involving the cancellation of 32,000 primary teacher appointments. The matter will now be heard by a division bench headed by Justice Tapabrata Chakraborty, with hearings scheduled to commence on April 25. The final hearing in the main case has been slated for April 28.

The controversy dates back to the 2016 recruitment of primary school teachers based on a panel formed after the 2014 Teacher Eligibility Test (TET). Allegations of largescale corruption soon surfaced, prompting the then-Calcutta High Court judge, Justice Abhijit Gangopadhyay, to order the cancellation of the 32,000 appointments in May 2023. Challenging this verdict, the West Bengal Board of Primary Education approached the division bench. Initially, the case Justice Chakraborty's bench would now preside over the hearings. Proceedings will begin with the hearing of the Board's petition challenging the cancellation order, followed by the main hearing

KMC initiates crackdown on illegal street encroachments in New Market area

MI News Service, Kolkata: In a decisive move to restore pedestrian rights and uphold civic order, the Kolkata Municipal Corpo-ration (KMC) is set to launch a fresh eviction drive against illegal street encroachments by hawkers, particularly in the bustling New Market area. Despite clear directives prohibiting stalls on roads or pavements, several hawkers have been found blatantly flouting the rules by occupying public path-

According to KMC sources, under the provisions of the 2018 Street Vending Rules, hawkers are permitted to set up stalls only within one-third of the pavement's width, leaving the remaining twothirds free for pedestrian movement. However, this guideline is being grossly violated, especially across Bartram Street, Lindsay Street, and Humayun Place. Field inspections reveal that hawkers have not only taken over footpaths but, in some instances, extended their stalls into designated parking zones, obstructing vehicular movement and disrupting urban mobility.

Allegations have also surfaced that certain hawkers have set up shop



dangerously close to New Market's entrance gates, causing congestion and affecting the visibility and accessibility of permanent retail outlets. Local shopkeepers claim their businesses are suffering due to the unregulated sprawl of street vendors who enjoy unfair advantages without complying with licensing norms or civic duties.

Speaking to the media, KMC Mayor-in-Council Debasish Kumar affirmed that the Corporation will soon undertake a rigorous and sustained clearance operation. "All stalls encroaching on roads and pavements will be removed. Such violations cannot be tolerated. These drives will be carried out at regular intervals and will not be halted under any pressure," Kumar as-

serted. He further clarified that hawkers who are removed must wait for a fresh allotment of space through the Town Vending Committee before resuming their trade. "The newly allocated zones might be away from New Market. But until then, they will not be allowed to occupy any part of the public road-

way," Kumar stated. This initiative underscores KMC's commitment to reclaim public spaces, ensure smoother pedestrian traffic, and uphold the city's visual and functional urban order. The civic body has already begun notifying police and enforcement departments, setting the stage for a wide-scale operation aimed at restoring lawful urban discipline in one of Kolkata's busiest commercial hubs.

Punjab govt transfers three IAS, 9 PCS officers News Service, from the state government

Chandigarh: In a major reshuffle, Punjab government on Monday transferred three Indian Administrative Service (IAS) officers and nine Punjab Civil Services (PCS) officers, as per an official order issued.

"Authorities concerned will make internal arrangements for the disposal of the work of the posts falling vacant as a result of this order. Officers concerned are directed to join their new place of posting immediately," the order stated.

Earlier this month, the Punjab Government issued transfer orders of 65 Deputy Superintendent of Police (DSP) officers in the state.

"The officers may be relieved immediately with the directions to report at their new places of postings by April 7, and their charge assuming/ relinquishing reports be sent to the office immediately,"

the order stated. Another order by the Punjab government announced the

transfer of 97 senior police officers, including 11 Indian Police Service (IPS) officers. "The officers concerned are directed to join their new place of posting immediately," the order from the state government stated.

Meanwhile, the Punjab Police recovered Rs 46.91 lakh in drug money and arrested five people, including a police constable posted in Ludhiana. This action is part of a large campaign launched by the Punjab Police to fight drug trafficking.

Shielding The Elders : Importance of mmunization Against Flu and Pneumonia



Study finds how lung cancer captures immune cell metabolism for its own growth

LA JOLLA (CALIFORNIA) [US]: Lung adenocarcinoma is the most common type of lung cancer, accounting for the majority of cancer-related fatalities in the US. There are various causes of lung adenocarcinoma, one of which is a mutation in a protein known as EGFR. Non-mutant EGFR stimulates cell proliferation in response to injury, but mutated EGFR promotes out-of-control growth, which can lead to cancer. Modern immunotherapies are ineffective against EGFR-driven lung adenocarcinoma, and while certain medications exist to treat the malignancy, patients usually acquire resistance to them within a few years. This gap in the therapy toolkit prompted Salk Institute researchers to look for weak points in the cancer's development process. The researchers discovered that EGFR-driven lung adenocarcinoma hijacks a specialized population of lung-resident immune cells known as macrophages, which are responsible for disposing of diseased and damaged cells as well as maintaining a delicate balance of protective lipids (fats) around lung alveoli, which are required for breathing. Lung cancer cells recruit macrophages into the tumor microenvironment and modify their lipid metabolism, transforming them into cancer fuel sources. The newly powered tumor cells subsequently stimulate further macrophage growth to provide additional fuel--a novel self-perpetuating cancer strategy.

The findings, published in Cancer Discovery on January 25, 2024, provide new inspiration for lung adenocarcinoma interventions that disrupt this tumor cellmacrophage relationship. The researchers suggest that treatments using EGFR inhibitors may be more successful when paired with statins, a class of drugs commonly used to lower cholesterol levels

"We have discovered a novel way that lung cancer cells manipulate their local environment and other cell types surrounding them to promote their own growth. In this case, the tumor cells exploit lung-resident macrophages--remodeling them to provide nutrients, like cholesterol, to the cancer cells and stimulate tumor growth," says senior and co-corresponding author



"Our results reveal new therapeutic possibilities for immunotherapy-resistant EGFR-driven lung adenocarcinomas," said co-corresponding author Christian Metallo, professor and holder of the Daniel and Martina Lewis Chair at Salk. "We have identified a key metabolic relationship between macrophages and alveoli that is exploited by tumor cells to support the cancer's metabolic demands--now we just have to disrupt that exploitation.

Susan Kaech, professor, director of the NOMIS Center for Immunobiology and Microbial Pathogenesis, and holder of the NOMIS Chair at Salk. "One exciting implication of this work is that lung cancer treatments may be improved by simply adding statins, an already widely used class of drugs, to the patient's treatment plan." Lungs rely on tiny bulbs called alveoli, which expand and deflate with our breath, to facilitate the exchange of oxygen and carbon dioxide between the air and our blood. Alveoli are crucial to human survival, and their health is dependent on a lipid-rich environment created by alveolar

cells and sustained by macrophages. Lipids, such as cholesterol, are fatty compounds that support bodily function by helping cells move, store energy, and absorb vitamins. This unique ability of lung-resident macrophages to maintain lipid balance becomes more complicated when tumor cells begin to exploit those lipids to help themselves grow. A better understanding of the mechanisms macrophages use to regulate their metabolism and lipid production can provide insight into how tumor cells selfishly manipulate those mechanisms to help themselves. "The tumor cells excrete even more of a growth factor called GM-CSF (granulocyte macrophage colony-stimulating factor), which then causes the macrophages to grow alongside them and change their metabolism, resulting in excess lipids that the tumor cells use to strengthen themselves," says first author Alexandra Kuhlmann-Hogan, former postdoctoral researcher in Kaech's lab and current postdoctoral researcher at UC Los Angeles. "The cancer was effectively hijacking this normal macrophage process of maintaining the lungs with healthy lipids in order to fuel itself."

"Not only were the tumor cells metabolically reprogramming the macrophages-they were also instigating a feedback loop that encouraged an optimal metabolic state in the tumor cells themselves," said co-corresponding author KaterinaPoliti, scientific director of the Center for Thoracic Cancers at Yale Cancer Center and professor of pathology at Yale School of Medicine. When the EGFR-driven lung adenocarcinoma cells secreted GM-CSF, it stimulated a gene in the macrophages called PPARg (peroxisome proliferator-activated receptor gamma), which jump-started their metabolic reprogramming and subsequent secretion of lipids. In addition to using these macrophage-curated lipids to grow, the tumor cells also use the lipids to power the continued activation of the EGFR-drive that helps the cancer grow. Kaech predicts that disrupting this loop could be a novel intervention for slowing down EGFR-driven cancer growth. Exactly how the delivery of lipids like cholesterol to tumor cells powers the EGFR oncogenic pathway, the researchers aren't yet sure.

"Our results reveal new therapeutic possibilities for immunotherapy-resistant EGFR-driven lung adenocarcinomas," said co-corresponding author Christian Metallo, professor and holder of the Daniel and Martina Lewis Chair at Salk. "We have identified a key metabolic relationship between macrophages and alveoli that is exploited by tumor cells to support the cancer's metabolic demands--now we just have to disrupt that exploitation."

Scientists find new method of boosting chemical reactions using electricity



ducted by chemists at the University of Chicago discovered a technique to use electricity to enhance a sort of chemical reaction commonly used in the synthesis of novel pharmaceutical medication candidates

The finding, which was published in Nature Catalysis, represents an advancement in the field of electrochemistry and indicates a road ahead to creating and directing reactions--and making them more sustainable.

'What we want to do is understand what's happening at the fundamental level at the electrode interface, and use that to predict and design more efficient chemical reactions," said Anna Wuttig, UChicagoNeubauer Family Assistant Professor and the senior author on the paper.

"This is a step towards that eventual goal.

In certain chemical reactions, electricity can boost the output--and because you can get the needed electricity from renewable sources, it could be part of making the worldwide chemical industry greener. But electrochemistry, as the field is known, is especially complex. There is much scientists don't know about molecular interactions, especially because you have to insert a conductive solid (an electrode) into the mix to provide electricity, which means the molecules interact with that electrode as well as with each other. To a scientist trying to untangle the roles each molecule is playing and in what order, this makes an already complicated process even more complicated.

'What if you think about it as electrochemistry providing us with a unique design lever that's not possible in any other system?" she said.

In this case, she and her team focused on the surface of the electrode that provides the electricity to the reaction.

"There were hints that the

surface itself is catalytic, that it plays a role," Wuttig said, "but we don't know how to systematically control those interactions at the molecular level.'

They tinkered with a type of reaction that is commonly used in manufacturing chemicals for medicine, to form a bond between two carbon atoms.

According to theoretical predictions, when this reaction is performed using electricity, the yield from the reaction should be 100 per cent, that is, all the molecules that went in are made into a single new substance. But when you run the reaction in the lab, the vield is lower.

The team thought the presence of the electrode was tempting some of the molecules away from where they were needed during the reaction. They found that adding a key ingredient could help, a chemical known as a Lewis acid added to the liquid solution redirected those molecules.

"You get a near-clean reaction," Wuttig said.

Moreover, the team was able to use special imaging techniques to watch the reactions unfold at the molecular level. "You can see that the presence of the modulator has a profound effect on the interfacial structure," she said.

"This allows us to visualize and understand what's happening, rather than regard it as a black box.'

This is a crucial step, Wuttig said, because it shows a path forward towards being able to not only use the electrode in chemistry but also to predict and control its effects. Another benefit is that the electrode can be re-used for more reactions.

"This is a step towards sustainable synthesis," she said. "Moving forward, my group

is very excited to use these types of concepts and strategies to map out and address other synthetic challenges.

Study shows how brain's internal compass guides the body

Washington DC: Our sense of direction is essential for navigating the world around us. It serves as the brain's internal compass guiding us in the right direction and, more significantly, prompting us to reverse course when we're going the wrong way

Yet despite a large body of research on how navigation works in the brain, scientists still lack a clear understanding of how this internal compass directly guides behavior. Now, a study conducted in fruit flies and led by researchers at Harvard Medical School offers new insights into how two distinct brain regions -the seat of the compass and the steering center -- communicate during navigation.

The findings are published in

Nature. In the study, researchers examined the brains of fruit flies knocked off course while running in a particular direction. They discovered that three distinct groups of neurons enable communication between the compass and the steering regions of the brain and work together to help the fly course-correct. In doing so, the neurons translate signals from a fly's internal compass into behavior to keep it moving in the right direction


"Until now, no one really knew how sense of direction, which is an internal cognitive state, relates to the actions an animal is making in the world," said senior author Rachel Wilson, the Joseph B. Professor of Basic

Research in the Field of Neurobiology in the Blavatnik Institute at HMS.

Despite their small size, fruit flies have complicated brains and behaviors -- and thus the findings could provide a foundation for future studies on how signals in the brain become actions in more species, including

Staying on course

Humans and other complex animals have an internal compass made of brain cells that use internal and external information to generate a sense of direction. In fruit flies, scientists have figured out that these cells -- called headdirection cells -- are arranged in a circle, making them especially easy to study. Contrary to what their name implies, fruit flies spend more time walking than flving. Previous research has shown that as flies walk around, these head-direction cells actively track their rotational movements, such as turning right or left. In the new study, Wilson and colleagues wanted to explore how this compass is functionally connected to the steering region of the brain to understand how it guides navigation. To do this, they used an existing wiring diagram of every neural connection in the fruit fly brain to build a computational model of how these regions might be linked. With this model, they were able to identify and make predictions about the layer of neurons that connect the two regions. To validate their predictions, the

researchers analyzed the activity in the layer of neurons identified

by the model as the flies walked around in a virtual reality environment. Often, flies ran straight in a random direction, likely in an

effort to escape their environment. When their virtual world was rotated to move them off course, the flies swiftly coursecorrected. Interestingly, these course corrections were carried out by three separate groups of neurons: Two sets of neurons nudged the fly to go right or left, and one issued a signal to turn

around completely.
"You can think of these three groups of neurons as three sentries guarding a castle," Wilson "with each responsible for surveilling in a different direction and prompting the correction needed to keep the fly moving towards its goal." The findings explain how fruit flies use their sense of direction to estimate where they are in relation to a goal and how they use this estimate to adjust their behavior.

"This is a really concrete description of how a complicated cognitive process works and how it produces specific, guided behaviors in real time," Wilson said. The findings complement a second study, also published in Nature on Feb. 7 and led by a separate team of researchers at The Rockefeller University, that describes parts of the same neuronal circuit in fruit flies. Taken together, the two studies provide an even more complete understanding of how sense of direction translates into behavior in the animals.

A strong starting point Wilson said that her team's observations have implications

beyond identifying the connec-

tions between the brain's compass and steering regions. The findings provide important clues about the format and location of navigation al goals in the brain -- and may pave the way for understanding how other types of goals are stored

Court acquits Jitendra Tyagi aka Waseem Rizvi in 2021 hate speech case



Haridwar: Jitendra Tyagi, formerly known as Waseem Rizvi, has been acquitted in the 2021 Dharam Sansad hate speech case by a Haridwar court. The verdict, delivered on April 16 by Chief Judicial Magistrate (CJM) Avinash Kumar Srivastava, cleared Tyagi of all charges on the grounds of "benefit of doubt" due to lack of conclusive evidence.

The case stems from a controver sialthree-day Dharam Sansad event held in December 2021 at the Niketan Ashram in Haridwar, Uttarakhand. Several religious leaders who attended the gathering were accused of delivering provocative and hate-filled speeches targeting specific communities.

The event sparked widespread outrage after videos of the speeches went viral on social media, leading to sharp criticism from across

Among the critics was the Akhil Bhartiya Akhada Parishad, the apex body of Hindu monastic orders, which publicly condemned the hate rhetoric. The Parishad reiterated that Sanatan Dharma tolerance in India

is rooted in peace, harmony, and mutual respect, and does not support any form of violence or hatred toward other religions.

Jitendra Tyagi, a former chairman of the Uttar Pradesh Shia Waqf Board, had announced his conversion to Hinduism in December 2021, shortly before the Dharam Sansad event. Following his participation, an FIR was registered against him at the Kotwali police station in Haridwar on January 1, 2022. He was arrested nearly two weeks later on January 13 near the Uttar Pradesh-Uttarakhand bor-

Over 90,000 displaced Palestinians sheltering in 115 UN-run facilities across Gaza: UNRWA



MI News Sevice, Gaza: More than 90,000 displaced Palestinians are currently taking shelter in 115 UN-run facilities across the Gaza Strip amid a humanitarian crisis caused by Israel's 19-month onslaught, the UN agency for Palestinian refugees (UNRWA) said on Sunday. "An already dire situation is deteriorating due to bombardment and the siege blocking the entry of humanitarian and commercial supplies," UNRWA said in a statement. Since March 2, 2025, Israel has kept all Gaza border crossings closed, blocking the entry of essential food, medical, and relief supplies, exacerbating an already dire humanitarian situation, according to multiple reports from international organizations and rights groups. The UN refugee agency estimated that nearly 420,000 people have been displaced yet again since the breakdown of the ceasefire in March.

The Israeli army resumed its assaults on Gaza on March 18, and has since killed 1,827 people, injured, and shattered a Jan. 19 ceasefire and prisoner exchange agreement. More than 51,200 Palestinians have been killed in Gaza in a brutal Israeli onslaught since October 2023, most of them women and children. The International Criminal Court issued arrest warrants last November for Israeli Prime Minister Benjamin Netanyahu and his former Defense Minister Yoav Gallant for war crimes and crimes against humanity in Gaza. Israel also faces a genocide case at the International Court of Justice for

"A short while ago, the IDF (Israel Defense Forces) struck several launchers and a military infrastructure site from which Hezbollah operated," the military said in a statement.

Earlier in the day, the military struck the area of Houla in southern Lebanon and killed a militant who, according to the statement, served as Hezbollah's head of engineering in the Odaisseh area.

Despite a ceasefire agreement that went into effect in November 2024, Israeli forces have continued to carry out occasional strikes inside Lebanon, claiming they target Hezbollah "threats."

69 per cent of Gaza under Israeli displacement orders: UN agency

MI News Sevice, Gaza: The United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) said that 69 per cent of the Gaza Strip is under active Israeli displace-

The Israeli army issued at least 20 displacement orders between March 18 and April 14, UNRWA said in a press statement on Sunday, adding that the agency "currently operates 115 shelters across Gaza, housing more than 90,000 displaced people."

Some 420,000 people have been displaced again since the ceasefire collapsed on March 18, it said, warning that the already dire humanitarian situation in Gaza is worsening due to Israeli shelling and the seven-

week-long aid blockade. UNRWA stressed the need for an early ceasefire, the release of all hostages, and the unfettered flow of humanitarian aid and commercial supplies into Gaza, Xinhua news agency report-

Israel has blocked the entry of all humanitarian aid into Gaza since March 2. It then ended a two-month ceasefire with Hamas on March 18 and resumed deadly air and ground assaults on the enclave.

Meanwhile, at least 29 Palestinians were killed in Israeli attacks on Gaza on Sunday, according to the Civil Defence in Gaza.

In central Gaza, 10 people were killed and some others wounded by an Israeli

house in the Nuseirat refugee camp, Mahmoud Basal, spokesperson for the Civil Defence, told Xinhua.

In southern Gaza, a Palestinian woman was killed and four others wounded in an Israeli drone attack on a tent housing displaced people in the Al-Mawasi area in Khan Younis city, and four others were killed in another two separate Israeli at-

tacks on the city, Basal said. The renewed Israeli attacks have so far killed 1,827 Palestinians and injured 4,828 others, Gaza health authorities said Sunday, adding the death toll in the enclave since the war began in October 2023 has risen to 51,201, with

Govt directs Google to remove Chinese app for showing wrong map of India

The Ministry of Electronics and Information Technology (MeitY), along with the Survey of India (SoI), has directed US tech giant Google to remove the Chinese chat app Ablo' from its Play Store, as the app is not correct in its depiction of India's territorial borders.

The government's notice states that the China-based video chat platform, which has over 10,000 downloads on Google Play, misrepresented the Union Territories of Jammu & Kashmir and Ladakh, and entirely omitted Lakshadweep Island from its map. The directive also reiers to the Criminal Law (Amendment) Act, 1990, which makes such misrepresentations a punishable offense with imprisonment of up to six months, fines, or

ject map in the 'Ablo' app available at Google Play Store depicts Indian map with erroneous external boundary of India which jeopardises the sovereignty and integrity of India," the notice states.

MeitY has cited Section 79(3)(b) of the Information Technology Act, 2000, which intermediaries mandates mandates intermediaries to "expeditiously remove or disable access" to content that violates Indian laws, in its notice to Google.

MEITY's notice states that the issue of incorrect maps on digital platforms, was flagged during a meeting with SoI. The ministry has asked Sol to pursue legal action against such apps under relevant laws.

The IT Ministry also cited the Supreme Court's 2015 Shreya Singhal v. Union of India judgment, "It is evident that the sub- which obligates interme-

ernment order.

Google appears to have complied with the order, as Google Play Store landing page of the app now shows the message: "We're sorry, the requested URL was not found on this server". The app is also now unavailable on Apple's App Store for the Indian users.

Earlier in 2023, MeitY and SoI flagged apps on the Play Store such as World Map Quiz and MA 2 – President Simulator for depicting India's borders incorrectly. Similarly, in 2021, Twitter (now X) was pulled up by the Indian government over non-compliance with the IT Rules 2021.

The then Twitter India chief Manish Maheshwari was booked by the Uttar Pradesh police on charges for incorrect representation of the map of India.

China warns countries against trade deals with US that harm Beijing's interests

MI News Sevice, Beijing: Amid the ongoing trade war, China on Monday has warned that it firmly opposes any trade deals with the United States at the expense of Beijing's intests, state media reported, adding that it will slap countermeasures in "resolute and reciprocal manner" against coutries which strive to "appease" Washington.

Under the guise of so-"reciprocity," the United States has been recently arbitrarily imposing tariffs on all its trading partners while pressuring them to engage in so-called "reciprocal tariff" negotiations, an official spokesperson for China's Ministry of Commerce said, according to Xinhua news agency.

The spokesperson was responding to reports that the United States is preparing to pressure other countries to restrict trade ties with China in exchange for tariff exemptions.

'This is essentially using the banner of 'reciprocity' as a pretext to pursue hegemonic politics and unilateral bullying in the field of international economy and trade," the spokesperson said as per the Chinese media outlet.

While the Donald Trump administration has imposed 10 per cent tariff on various countries, it has put duties of upto 145 per cent on many products from China. Beijing has retaliated by slapping duties of 125 per cent on US goods.

The Chinese spokesperson said that pursuing shortterm, self-serving interests by harming others' interests in exchange for so-called "exemptions" is akin to making a pact with the tiger for its skin - it will ultimately leave all parties empty-handed, harming others without benefiting oneself, the spokesperson said as cited in the Global Times.

China warned against international trade returning to the "law of the jungle" and said that it is willing to strengthen solidarity and coordination with all parties, join hands to deal with them, jointly resist unilateral bullying, safeguard its legitimate rights and interests, and defend international justice.

Israel conducts over 200 strikes in Gaza within days, kills Islamic Jihad member

said on Monday that it carried out more than 200 airstrikes across the Gaza Strip over the past three days, killing a member of the Islamic Jihad movement.

Human rights group decries "systematic crimes" against Baloch people

Protesters stated that despite being involved in lawful economic activity, they are subjected to harassment, their vehicles taken, and their livelihood looted. Union members said the Coast Guards impounded vehicles at night without notice, even though the diesel was being transported with valid permits issued by the Balochistan government. After their

ul-Abideen, only empty vehicles were returned, while the diesel was confiscated. Drivers emphasized that they oppressure, often purchasing diesel on credit and surviv ing on minimal income after exhausting labor. The seizure of their diesel means the erasure of their only means of survival. "We will discuss development of Yoga in Arab world...": AYSF president on PM Modi's visit to Saudi Arabia

JEDDAH [SAUDI ARABIA]: Nouf-Al-Marwaai, President of the Asian Yogasana Sports Federation (AYSF) and recipient of India's fourth-highest civilian award, Padma Shri, spoke on her journey with the discipline, Prime Minister Narendra Modi's upcoming visit to Saudi Arabia and his role in promotion of Yoga worldwide.

With Manchester City set to square off against Aston Villa on Tuesday night, Guardiola sent a strong message to fans as they fight for a spot in next season's UCL.

"Absolutely. After Aston Villa, the game against Wolves be a final, then Southampton, because every game counts. But Villa are a contender to qualify for the Champions League, and when you see the game they played against my friend Luis Enrique and PSG, I was really impressed," he told reporters as

quoted from Sky Sports. They can play a low block, but when they decide to go, with the weapons they have, the speed they have, the set-pieces, it's a final, and we need our people because I think our people want the Champions League again next season and hopefully they can wait from minute one. Sometimes we are slow, sometimes we are not playing good, but we need them desperately to support us, to make noise and being there all the time because it's a final. Absolutely, it is a
