#### **SC refuses** to entertain fresh plea challenging **Waqf** (Amendment)

MI News Service, New Delhi: Remaining firm and in accordance with their previous stand, the Supreme Court on Friday refused to enter-tain a fresh plea chal-lenging constitutional validity of the Waqf (Amendment)

A bench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan is scheduled to hear petitions on the issue on May 5. The bench, which had earlier made it clear it will hear only five of the over 70 litigants, today again said that no more fresh pleas will be entertained on the issue.

"If you have some additional grounds, you can file an intervention application," the CJI told the counsel for petitioner Mohammad

On April 29, the bench refused to enter-tain 13 petitions challenging

constitutional validity of the Act. "We are not going to increase the number of petitions now. This will keep on piling and would become difficult to han-

dle," it said.

On April 17, the bench decided to hear only five of the pleas before it and titled the case: "In Re: Waqf (Amendment)." (Amendment) 2025". The Centre then assured the bench it will neither denotify waqf properties, including "waqf by user", nor make any appointments to the central waqf council and boards till

About 72 petitions were filed against the law. They included those by AIMIM leader Asaduddin Owaisi, All India Muslim Personal Law Board (AIMPLB), Jamiat Ulama-i-Hind, the Dravida Munnetra Kazhagam (DMK) and Congress MPs Imran Pratapgarhi and Mohammad Jawed.

While appointing three lawyers as nodal counsel, the bench asked the advocates to decide among themselves who was going to

"We clarify that the next hearing (May 5) will be for the preliminary objections and for an interim order." the bench said.

The Centre recently notified the Act, which got President Droupadi Murmu's assent on April 5, after its passage in Parliament following heated debates in both houses

The bill was passed in the Rajya Sabha with 128 members voting in favour and 95 opposing it. It was cleared by the Lok Sabha with 288 members supporting it and 232 against it.

# Mamata Banerjee visits fire-ravaged hotel in Burrabazar, promises action against guilty

MI News Service, Kolkata: West Bengal Chief Minister Mamata Banerjee visited the fire-ravaged hotel in central Kolkata soon after returning to the city from Digha on Thursday, and made it clear that those responsible for the death of 14 people will not be spared.

The Chief minister reached the site of the Hotel at Mechhua Falpatti in Burrabazar area on her way back from Digha and said that special committees comprising police, administration and fire services department are being set up to monitor and identify establishments which are flout-

ing fire safety norms. The teams will conduct surprise checks in the city as well as district towns. Those in the administration found guilty of oversight and negligence besides inept handing of providing operational NOCs to buildings with inadequate fire safety, will also come under the purview of stern pnishment," she said.

'The panels will prepare reports and submit them to my office in the next 15 days," the Chief Minister added.

The devastating fire at a private budget hotel on Tuesday left 14 people, mostly visitors to the city, dead. The victims included a woman and two children.

Flanked by Kolkata Police Commissioner Manoj Kumar Verma and senior ministers Sujit Basu and Sashi Panja, Mamata. Banerjee informed reporters that the hotel had already been sealed off and its owner and manager were arrested.

## PM Modi commissions Rs 8,867 cr **Vizhinjam International Seaport in Kerala**

MI News Service, Thiruvanathapu**ram**: Marking a major step towards putting India's southern most state of Kerala on the global maritime map, Prime Minister Narendra Modi on Friday officially commissioned the Vizhiniam International Seaport, here, which was completed at an estimated cost of Rs 8,867 crore.

Speaking after commissioning the port, the Prime minister said the facility will bring economic stability to both Kerala and the rest of India and referred to Chief Minister Pinarayi Vijayan as a "pillar" of the opposition INDIA bloc. He told him and Congress MP Shashi Tharoor, both of whom were present on the dais, that the inauguration event will give "sleepless nights" to many.

Though, the person translating his speech did not translate it properly the PM however, said "the message has gone across to whom it was

Giving details of the development in the country, Modi said that India was among the top three nations globally on the number of seafarers and in the last 10 years, the capacity of our ports has doubled, their efficiency improved and the turnaround

time there decreased by 30 per cent. Modi further said that the seaport has been constructed at a cost of Rs 8,800 crore, and its transshipment hub capacity is set to triple in

"It is designed to accommodate large cargo ships, addressing a critical need. Until now, 75 per cent of India's transshipment activities were conducted at foreign ports, resulting in significant revenue losses for the

"However, this is about to change. The funds previously spent abroad will now be channeled into domestic development, creating new economic opportunities for the people of Vizhinjam and Kerala, ensuring that the nation's wealth directly benefits its citizens," he said.

He said that the people of Gujarat will be disappointed with Adani Group chairman Gautam Adani for building such a huge port in Kerala as he (Adani) hails from the western Indian state.He also said that state Ports Minister V N Vasavan's reference to Adani Group, a corporate entity, as a partner of the Communist government shows the changes taking place in the nation. The PM also referred to the era before slavery and said that India flourished with prosperity for thousands of years.

'At one point, it held a significant share of the global GDP. What set India apart from other nations during that time was its impressive maritime capabilities and the thriving economic activity in its port cities. Kerala, in particular, played a major

## India's manufacturing sector growth hits 10-month high in April

MI News Service, New in over 14 years at the start building initiatives. mentum in the Indian manufacturing sector improved in April, with output increasing at the fastest pace since June 2024, on the back of another strong expansion in order books, a monthly survey said on Friday.

The seasonally adjusted HSBC India Manu-Purchasing facturing Managers' Index (PMI) rose from 58.1 in March to 58.2 in April, indicating the strongest improvement in the health of the sector for ten months. In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction. A key factor contributing to the latest improvement in output growth was a sharp rise in new business. The manufacturing sector's rate of expansion was supported by better domestic and international demand.

According to the survey, the total sales were supported by a sharp rise in international orders. New business from abroad **Continued on Page 3** grew to the greatest degree of the 2025-26 fiscal year and this demand was led by Africa, Asia, Europe, the Middle East, and the Americas, the survey partici-

pants said.
"The notable increase in new export orders in April may indicate a potential shift in production to India, as businesses adapt to the evolving trade landscape and US tariff announcements," Pranjul Bhandari, Chief India Economist at HSBC, said.

This positive trend was accompanied by notable rises in employment and purchasing activity.

"Manufacturers continued to enhance their staffing levels in April to meet growing output requirements. Exactly 9 per cent of survey participants took on extra workers. with a combination of permanent and temporary contracts reportedly being offered," the survey said.

Purchasing rose in tandem with new business growth, and the latest sharp expansion in input buying was also partly attributed to stock-

"Manufacturing output growth strengthened to a ten-month high on robust orders. Input prices increased slightly faster, but the impact on margins could be more than offset by the much-faster rise in output prices, of which the index jumped to the highest level since October 2013," Bhandari added.

On the prices front, robust demand for Indian goods boosted firms' pricing power, with selling charges hiked to the greatest degree since October 2013. This was despite a modest uptick in input costs. Strong optimism regarding output prospects over the coming year was evident in the April data, driven by expectations of demand strength. Marketing efforts, efficiency gains, and new client enquiries also underpinned positive

The HSBC India Manufacturing PMI is compiled by S&P Global from responses to questionnaires sent to purchasing managers in a panel of around 400 manufacturers.

## US hopes Pakistan cooperates with India to 'hunt down' terrorists, says Vice President Vance

MI News Service, Washington (DC): Expressing hope that Pakistan will fully "cooperate" with India to "hunt down" the Pahalgam militants as they were operating from their soil, US Vice President JD Vance has said that his country also believes that India will not respond to the Pahalgam terrorist attack in a way that might lead to a "broader regional

conflict". Vice President Vance who undertook a four day visit to India with his family last week made these remarks on Friday in an interview with Fox News, saying that he and his family

were in fact present in Jaipur in Rajasthan when the Pulwama terrorist attack took place (on April 22) killing as many as 26 innocent tourists and other civilians.

Condemning the attack as horrific, Vance said "Our hope here is that India responds to this terrorist attack in a way that doesn't lead to a broader regional conflict," Vance said.

Amid escalation in tension between India and Pakistan after the Pahalgam incident, Vance also said that he hoped Pakistan, "to the extent that they are responsible", will fully cooperates with India in hunting down terrorists that "sometimes operate" in their territory.

Vance said "I am worried about any time you see a hot spot breaking out, especially between two nuclear powers. We have been in close contact with our friends in India and Pakistan.""Our hope here is that India responds to this terrorist attack in a way that it doesn't lead to a broader regional conflict. And we hope that Pakistan, to the extent that they are responsible, cooperates with India to make sure that the terrorists sometimes operating in their terri-

tory are hunted down and dealt with. That's how we hope this unfolds," he said.

Meanwhile, in response to the Pahalgam terrorist attack, India initiated a series of diplomatic measures against Pakistan, including the suspension of the Indus Water Treaty, the suspension of visas for Pakistani nationals and the closure of its airspace to Pakistani aircraft, among others.

Vance's statements are in line with those of the US State Department. On Thursday, the department stated that the US stands strong with India against terrorism and that

Prime Minister Narendra Modi "has our full support". State Secretary Marco Rubio has urged both India and Pakistan to "work toward a ...responsible resolution that maintains long-term peace and regional stability in South Asia," it said. In a call with Rubio on Wednesday, External Affairs Minister S Jaishankar has underlined that the "perpetrators, backers and planners" of the Pahalgam attack "must be

brought to justice". Defence Minister Rajnath Singh, meanwhile, explicitly named Pakistan during a call with US Defence Secretary

Pete Hegseth on Thursday "Pakistan has a history of supporting, training and funding terrorist organisations," Singh told Hegseth. In response, Hegseth is reported to have expressed Washington's support towards "India's right to defend itself." Vance was in India at the time of the attack and had dialed up PM Modi to express his condolences. In fact, US President Donald Trump was among the first global leaders to call up PM Modi after the Pahalgam terrorist attack. Reacting to the

## Police recover dead body from trolley bag

Raiganj: Just days after the gruesome discovery of a dismembered elderly man's body in a trolley bag in Kolkata, a similar unsettling incident has emerged in North Bengal. A dead body was found concealed within a red trolley bag in a cornfield adjacent to the Islampur bypass in the Sonakhoda area, under the jurisdiction of the Islampur police station. The chilling recurrence of this method of concealment has sent ripples of fear and speculation across the state. The discovery was made on

Friday morning by a local resident who was passing by the area. Noticing the unusually placed and sizable red trolley bag in the cornfield, the individual grew suspicious. He promptly alerted other locals, and upon their collective assessment, the Islampur police were notified. A team of police officers swiftly arrived at the scene, secured the area, and recovered the trolley bag. The remains found inside were then transported to the Islampur Subdistrict Hospital for a crucial post-mortem examination. This procedure is expected to shed light on the cause of death and potentially provide vital clues for the ongoing investigation. According to preliminary information released by police sources, the deceased is estimated to be approximately 45 years old. However, the identity of the individual remains unknown. Investigators are currently exploring various avenues to identify the victim, including examining missing persons reports from the region and neighboring districts. The eerie similarities between this case and the recent Kolkata incident, where the victim's body was tragically found in multiple pieces inside a trolley bag, have not gone unnoticed. While authorities have not yet established any direct link between the two cases, the modus ope-

cerns about a potential pattern or the involvement of individuals familiar with this method of disposal. Local resident Amit Pal, who was among the first to notice the trolley bag, shared his experience with reporters. "I was on my way to the market earlier today. I saw this large, red trolley lying in the cornfield. It seemed out of place, so I felt a bit uneasy. I continued to the market, bought my fish, and returned home. It was only later that I heard the shocking news about a body being found in that very trolley. This is truly disturbing and something I've never witnessed before in our area." The incident has understandably created a sense of unease and anxiety within the usually tranquil Sonakhoda area. Residents are grappling with the unsettling nature of the discovery and the potential implications for their community's safety. The Islampur police have launched a comprehensive investigation into the matter. Their efforts will likely focus on identifying the deceased, determining the time and cause of death, and tracing the origin of the trolley bag. Investigators will also be canvassing the area for potential witnesses and examining any available CCTV footage that might offer clues.

Given the recent similar incident in Kolkata, state-level police authorities are likely monitoring the investigation closely. The possibility of inter-district coordination in the investigation cannot be ruled out if any connections between the two cases emerge.

As the investigation progresses, the community awaits further updates, hoping for a swift resolution and the apprehension of those responsible for this heinous act. The discovery serves as a stark reminder of the vulnerability of peace and the challenges faced by law enforcement in maintaining public safety.

## Arjun Singh declares Suvendu Adhikari as a true public leader

## Madhyamik debacle: Ghatal student dies by suicide

MI News Service, Ghatal: Ghatal mourns as Madhyamik examinee Ritam Ghosh, a student of Sri Aurobindo Vidya Mandir, tragically took his own life after being disheartened by his scores of 347, a result his family noted was lower than his expectation.

A pall of grief has descended upon Gopinathpur in the Bisingh Gram Panchayat of Ghatal block, following the tragic suicide of a Madhyamik examinee. Ritam Ghosh, a student of Sri Aurobindo Vidya Mandir, reportedly took his own life by hanging himself after the release of the West Bengal Board of Secondary Education (WBBSE) Madhyamik (Class 10) examination results.

The distressing incident came to light on Friday when Ritam's body was discovered at his residence. The news has sent shockwaves through the local community and the school.

According to family sources, Ritam had secured 347 marks in the recently declared Madhyamik results. While not a failing score, his family stated that Ritam was visibly upset and disheartened as he had anticipated a higher outcome. They expressed their utter disbelief that this disappointment would lead

to such a drastic and irreversible decision. Upon receiving information about the incident, officers from the Ghatal police station promptly arrived at the Ritam Ghosh residence. They recovered Ritam's body and initiated the necessary legal procedures, including sending the remains for a post-mortem examination. Ritam's father, Rabindranath Ghosh, was inconsolable, and the entire family is currently in deep mourning. The tragedy has also cast a somber shadow over Sri Aurobindo Vidya Mandir. The headmaster of the institution, Gautam Jana, expressed his profound shock and sorrow. "Ritam was a very good boy and a diligent student. We never imagined that he would resort to such an extreme step," he stated, highlighting the unexpected nature of the incident. The teaching staff of the school also shared their grief and disbelief. Adding to the sense of loss, Ashok Kumar Maiti, a Group D staff member at the school and a neighbor of the Ritam Ghosh family, commented, "He was a boy from my neighboring village. His parents were very caring and attentive; they always kept a close watch on him. I am at a loss to understand why he would do this.

## nembering rhapsodic RAY in his 105 th Birthday

Satyajit Ray, one of the most iconic filmmakers in world cinema, would have turned 105 on May 2, 2025. Bengal, and indeed the entire world of film lovers paid tribute to Ray for his profound contributions to cinema, literature, and culture.

Ray's films, such as Pather Pancha-Aparajito, Charulata, and The Music Room, remain timeless classics, apart from Kapuroosh-Mohapuroosh, Nayak and many more. His deep understanding of human nature, his subtle yet powerful storytelling, and his ability to portray the intricacies of Bengali life are what make his work so universally

In Bengal, especially Kolkata (Calcutta), Ray was remembered through special screenings of his films, discussions, exhibitions, and sometimes even retrospectives. His legacy continues to inspire new generations of filmmakers and artists and the community as

Satyajit Ray, also known as 'Manik da' in West Bengal or among Bengalis is one of the greatest filmmakers in the history of cinema, is renowned not just for his artistic mastery, but also for the

One of his most immortal and beloved creation is 'Feluda', the iconic detective character who appears in a series of short stories and novels writ-



The UN had earlier expressed apprehension that the region might witness a famine -- a fallout of the civil war that resulted in the possible influx of other ethnic groups into Bangladesh alongside the Rohingya. Speaking on the issue, BNP leader Alamgir said. "We do not want to become another Gaza ... We do not want to get involved in another war. We

come here and create more trouble for us. We are already in a serious problem with the Rohingya." He said the BNP did not have any objection in extending help to people in distress but consultations with political parties were required as "we don't want anyone to come to our territory to create troubles" afresh. The BNP's reaction came amid reports that more Rohingya were trespassing into Bangladesh every day to escape the brutality of the Arakan Army.

The Daily Star newspaper, quoting Rohingya sources, said they faced murders, torture, forced disappearances and recruitment into the rebel group as human shields against junta forces. "Currently, a large number of Rohingya are fleeing from Rakhine state.

Bangladesh's Refugee Relief and Repatriation Commissioner Mizanur Rahman said. Since November 2023, about 1.30 lakh Rohingya have entered Bangladesh. Most of them arrived after June Bangladesh last week acknowledged the Arakan Army' presence in its rugged south eastern region, saying it was disrupting trade with Myanmar. More than 13 lakh Rohave crammed into makeshift refugee camps Bangladesh's south eastern part as they escaped a brutal military crackdown in 2017, while about 70,000 fled last year amid do not want anyone to fresh violence.

# 6 bars closed: Mamata cracks down on imprudent fire safety violators

MI News Service, Kolkata: Six bars and restaurants in Celica Park, formerly known as Magma House, on Park Street were shut down after chief minister Mamata Banerjee made a surprise visit on her way from the fireravaged Rituraj Hotel and flagged her concerns about fire safety measures.

Rows of LPG cylinders stored on racks in multiple tiers on one side of the building's entrance came to light after the chief minister instructed officials to lift iron shutters that covered them.

"Fifty thousand people will die if so many gas cylinders ex-

plode," Mamata said. "I heard about this from someone who recently visited a restaurant here. He said some four to five thousand people

won't be able to come out of the building using the narrow stairs and requested that I take immediate steps. There are two elevators, but people aren't aware that they would not work in case of a fire," she said.

Mayor Firhad Hakim and the fire and emergency services minister, Sujit Basu, accompanied Mamata with Kolkata Police commissioner Manoj Verma and industries minister Šashi Panja.

"The mayor, police commissioner and fire services minister will meet and arrive at a decision," Mamata said.

The chief minister also said the terrace won't be shut for a restaurant before leaving the spot. "I had information about this particular place, so I showed

Sources said the three, along with senior police officers and bureaucrats, met with building representatives soon thereafter, and the decision to shut the six restaurants was taken subse-

Sandip Gupta, director of the Celica Park group, said the restaurants closed after the meeting were: Black Cat, Boujee House, AMPM, Moti Mahal Delux, Barbeque Nation and

Located in the northwest corner of Allen Park, Celica Park comprises a cluster of multi-storied buildings, home to several popular bars, restaurants and night spots.

Metro visited the Park Street address on Thursday and found that the rows of LPG cylinders

the chief minister spoke about were kept on one side of Park Centre, a 10-storey building housing commercial offices, eateries, and retail stores inside Celica Park.

'This is how it is supposed to be kept. According to the guide-lines of the fire department, there is supposed to be a gas bank, which must be located outside restaurants and not inside. This gas bank must be fitted with complete depression and suppression systems," said Vineet Khemani, legal head of the Celica Park Group.

Mamata also alleged that one of the terraces has been shut and converted into a restaurant.

"The terrace has been closed, and a restaurant has been built. Around four to five

thousand people gather on holidays," Mamata said.
"There is only one stairway

to come down from there. No one has the right to shut the terrace. It is an open space. But a restaurant has been built. During an emergency, they can't gather on the terrace.

Asked why the administration wasn't aware of the alleged irregularities, Mamata said owners were reluctant to take corrective measures even after the Kolkata Municipal Corporation, the fire services department and the police issued notices.

We don't want everyone to be arrested. But they should take alternative actions," Mamata said. "It can't be just about business and making money. I will not spare if one life is lost.

## Kolkata fire tragedy: Police arrest owner of Rituraj Hotel

MI News Service, Kolkata: One of the owners of Rituraj Hotel, where a fire on Tuesday evening killed 14, was arrested by police.

Akash Chawla has been charged with causing the deaths of 14 people who were either working at his hotel or were there as guests. He has also been formally accused of flouting fire safety rules.

The hotel's manager, Gaurav Kapoor, has also been arrested.

More than 100 people were trapped inside the five-storey building after the fire broke out on the first floor.

Both were produced before Sealdah court. Their defence lawyer said Chawla was not attached to the daily operations of the hotel while Kapoor was "only an employee"

Chawla and Kapoor are residents of Howrah. Police officers who have examined the accused said they have "claimed innocence" about the lack of fire equipment.

One of them reportedly told the police that the hotel had sprinklers, but he was not aware that the sprinklers were defunct.

"Both the owner and the manager were aware that there were several lacunae in the hotel," the prosecution's lawver told the additional chief judicial magistrate's court in Sealdah.

The lawyer said: "Apart from that, there was no emergency exit, no fire safety measures despite high occupancy, no fire fighting safety equipment and thus the incident of the devastating fire causing deaths."

The two have been charged with culpable homicide not amounting to murder, attempt of culhomicide amounting to murder and violation of the fire safety norms. The police said that during the investigation, it was clear that the fire licence of the building was not renewed after 2022. Sources in the po-

lice said it has been found that the bar on the first floor was owned by Vivek Chawla and, after his death, the ownership passed on to his nearest kin. The police are probing whether the hotel had the necessary police permit to run even after the fire licence had lapsed three years ago.

## Follow fire safety norms or face severe action: Mamata

MI News Service, Kolkata: Chief minister Mamata Banerjee sent the city's business community a tough message: Follow fire safety norms or face government action.

Mamata, who was visiting Rituraj Hotel where a fire had killed 14 people on Tuesday night, said the owner and the manager had been arrested.

"It's the hotel owners' responsibility to ensure the safety of guests. But they (Rituraj Hotel) will not renew the licence; they will flout all rules," a grim-faced chief minister said, addressing local traders who stood around her near the fire-rav-

"They will only do business and make money. They do not care about human

Officials have said the hotel flouted multiple safety norms: it had fire sprinklers but no water, its emergency exit was blocked, and all its windows had been

The hotel's fire licence had not been renewed after 2022, fire and emergency services officials said.

"The building will be sealed. Pipelines are there, but no water. There is only one staircase. Two people were trapped on the staircase and died. We were able to rescue more than 90 using ladders," Mamata said. "Many rooms were found locked and could not be opened. There was no facility to let the smoke out of the building.... When you are in the hotel business, looking after the guests' well-being is your responsibility.

The state government has arranged to fly the 12 identified dead to their hometowns, Mamata said. Two bodies remain to be identified.

Referring to congested areas lined with old buildings in Jorasanko and Burrabazar, where the flouting of fire safety norms is widespread, the chief minister warned

people against storing plastics and other inflammable material.

"This building has pipelines but no water source. Sometimes we keep the fire system but not water. We dump plastics and chemicals in residential dwellings. Why do you do this? These are highly inflammable," she said.

"I have seen some people start a fire in their business interest. Please do not play with fire. Only those who lose their near ones in a fire understand the pain. And this can happen to each of us if we don't (take precautions)...

Mamata recalled the 2008 blaze at the towering Nandaram Market that destroyed one of central Calcutta's biggest business hubs, fuelled by rampant violations of fire safety norms. She said plastic was being dumped again at the Nandaram market.

"There should be an alternative (es-

cape route) in an emergency. Those who don't make arrangements for an alternative, should they be spared?" she said. "I am extremely rough and tough on

this matter. You have to listen to us. The administration will give you all the help. And if you don't listen, we will take ac-Hours after she spoke, six Park Street

restaurants were shut down. They will be reopened only after the administration is convinced about their fire-preparedness. Mamata appealed to shopping malls,

shops and markets not to stock plastic. These only aggravate fires. There could be a short-circuit.... AC machines need to be checked; gas cylinders need to be checked," she said.

"I'm not against anyone. I just want you to live safely. Even if you don't vote for me for saying this, it is OK, but please save your life first. This is not to beg for your votes but to ensure your own

Mamata then struck a hopeful note. "I'm hopeful that after this, the busi-

nessmen, the traders' associations, the traders' organisations, will do the needful," she said.

Mamata added: "I don't differentiate between people when it comes to life. All are equal before me.'

The chief minister ordered that a team be formed with the Kolkata mayor, municipal commissioner, police commissioner, divisional deputy commissioners, superintendents of police and district magistrates to survey for fire-safety violations and dangerously run-down buildings. It must submit a report in 15 days.

She said, without elaborating, that traders need not take the local councillors into confidence

Parts of central kolkats are congested with dilapidated buildings, many ofwhich the civic authorities have declared as "dangerous" while asking the occupants to vacate them.

Most such notices are ignored.

"Let the KMC (civic body), police and the fire department hold a meeting. Let these dilapidated buildings be repaired by their occupants," Mamata said.

"Even in the case of disputed buildings, let there be repair work. I hope people will rise above all this (disputes) and ensure the safety of human lives.

At these meetings, Mamata said, the authorities should be humane and ensure that those evicted get a temporary place to stay at. She cited how a large number of central Kolkata residents were temporarily relocated for the East West Metro



# Do you know intermittent fasting protects against liver inflammation liver cancer? Study finds

**HEIDELBERG, GERMANY:** Fatty liver disease frequently causes chronic liver inflammation and can possibly result in liver cancer. Scientists at the German Cancer Research Centre (DKFZ) and the University of Tubingen have demonstrated in mice that intermittent fasting on a 5:2 schedule

can block this progression.
Fasting lowers the development of liver cancer in mice who already have liver inflammation. The researchers discovered two proteins in liver cells that are both responsible for the beneficial effect of fasting. An approved medication can partially replicate this effect.

Nonalcoholic fatty liver disease is the most prevalent chronic liver disorder. It can have cataconsequences: unchecked, it can cause liver inflammation (metabolic dysfunction-associated steatohepatitis, MASH), cirrhosis, and even malignancy. Fatty liver disease is often thought to be a direct result of obesity. Obesity has become increasingly common in rising countries such as India and China, in addition to Europe and the United States. As a result, the number of cases of liver failure and cancer is increasing rapidly in the afflicted countries.

"The vicious circle of an unhealthy diet, obesity, liver inflammation and liver cancer is associated with major restrictions and suffering for those affected and also represents a considerable burden on healthcare sys-Mathias tems," says Mathias Heikenwalder, DKFZ and University of Tubingen. "We have therefore investigated whether simple dietary changes can specifically interrupt this fatal

Intermittent fasting has already been shown in several studies to be an effective means of reducing weight and alleviating certain metabolic disorders. Heikenwalder's team has now tested in mice whether this approach can also protect the liver from fatty degeneration and chronic inflammation.

The animals were fed with a high-sugar and high-fat diet correspondind to the typical Western diet. One group of mice had constant access to the food. As expected, these animals gained weight and body fat and developed chronic liver inflammation.

The mice in the other group

were given nothing to eat on two days a week (5:2 intermittent fasting, or 5:2 IF for short), but were allowed to eat as much as they wished on the other days. Despite the high-calorie diet, these animals did not put on weight, showed fewer signs of liver disease and had lower levels of biomarkers that indicate liver damage. In short.

## Researchers find how eye ultrasounds help detecting brain shunt failure in children

WASHINGTON: A recent study suggests that using an ocular ultrasound in the emergency room could help detect children with brain drainage tube failure quickly and safely.

Research presented at the Pediatric Academic Societies (PAS) 2024 Meeting in Toronto.

A ventricular shunt is a small plastic tube that is surgically placed to drain excess fluid and relieve pressure on the brain. Ventricular shunts are used on children to treat hydrocephalus, a disorder caused by improper brain fluid drainage or absorption from tumors, brain bleeds, and other sources. According to specialists, within two years following implantation, about 30% of shunts break, become misplaced, or become clogged, and an additional 5% fail annually after that.

When a patient visits the emergency department for potential shunt failure, their symptoms are often nonspecific, including headache, vomiting, and fatigue,



according to researchers. Shunt failure is life threatening, and children with shunts typically multiple computed undergo tomography and magnetic resonance imaging scans per year, exposing them to excessive radiation and sedation. A backup of fluid causes the optic nerve sheath

to swell, which researchers can measure with eye ultrasound.

The study found that comparing the diameter of the optic nerve when a patient is symptomatic to the diameter when they are well can help determine if a shunt is blocked.

"The research team is interest-

ed in finding ways to lessen radiation exposure and expedite diagnosing shunt failure in the emergency department," said Adrienne L. Davis, MD, MSc, FRCPC, pediatric emergency medicine research director at The Hospital for Sick Children (SickKids) and presenting author. "The study uses patients as their own controls by measuring the optic nerve when well and sick--a strategy that individualizes this test for every patient and recognizes that every patient with a shunt has a unique degree of shunt depend-ence and ability to tolerate high brain pressures.

The researchers studied 76 pairs of eye ultrasounds of nearly 60 children presenting to the Toronto hospital's emergency department with potential shunt failure. Researchers note that while findings are promising, results require further confirmation in a larger population of children with shunts across North

## Meditation training can support wellbeing in older people: Research

n 18-month meditation programme can increase the wellbeing of older persons, according to a new randomised controlled trial led by an international team co-direct-

The findings, published in PLOS ONE, show that meditation can improve people's awareness, connection to others, and insight.

While the meditation training did not confer significant benefits on two commonly used measures of psychological wellbeing and quality of life, the researchers say their findings may reveal limitations in existing methods of tracking wellbeing.

Lead author Marco Schlosser (UCL Psychiatry and University of Geneva) said: "As the global population ages, it is increasingly crucial to understand how we can support older adults in maintaining and deepening their psy-chological wellbeing. In our study, we tested whether long-term meditation training can enhance important dimensions of wellbeing. Our findings suggest that meditation is a promising

non-pharmacological approach to support human flourishing in late life.

The study is the longest randomised meditation training trial conducted to date, and explored the impact of an 18-month meditation programme on the psychological wellbeing of more than 130 healthy French-speaking people aged 65 to 84. The study, led by Principal Investigator Professor Gael Chetelat, took place in Caen, France. It was conducted by the European Union's Horizon 2020-funded Medit-Ageing (Silver Sante Study) research group which involves UCL, Inserm, University of Geneva, Universite de Caen Normandy, Lyon Neuroscience Research Center, University of Liege, Technische Universitat Dresden, and Friedrich Schiller University Jena.

The researchers compared a meditation programme, which included a nine-month mindfulness module followed by a nine-month loving kindness and compassion module, delivered by weekly group sessions (two hours long), daily home practice (at least 20 minutes), and one retreat day, with a



group that did English language training (as a comparison group) and a nointervention control group.

The team found that meditation training significantly impacted a global score that measures the wellbeing

dimensions of awareness, connection, and insight. Awareness describes an undistracted and intimate attentiveness to one's thoughts, feelings, and surroundings, which can support a sense of calm and deep satisfaction. Connection captures feelings such as respect, gratitude, and kinship that can support more positive relationships with others. Insight refers to a self-knowledge and understanding of how thoughts and feelings participate in shaping our perception - and how to transform unhelpful patterns of thought relating to ourselves and the

The benefits of meditation training to an established measure of psychological quality of life were not superior to English language training, while neither intervention significantly impacted another widely used measure of psychological wellbeing. The researchers suggest this may be because these two established measures do not cover the qualities and depth of human flourishing that can potentially be cultivated by longerterm meditation training, so benefits to awareness, connection and insight are missed. The programme did not benefit everyone equally, as participants who reported lower levels of psycho-

logical wellbeing at the start of the

trial showed greater improvements compared to those who already had higher levels of wellbeing.

Co-author Dr Natalie Marchant (UCL Psychiatry) said: "We hope that further research will clarify which people are most likely to benefit from meditation training, as it may confer stronger benefits on some specific groups. Now that we have evidence that meditation training can help older adults, we hope that further refinements in partnership with colleagues from other research disciplines could make meditation programmes even more beneficial.

Senior author Dr Antoine Lutz (Lyon Neuroscience Research Center, Inserm, France) said: "By showing the potential of meditation programmes, our findings pave the way for more targeted and effective programmes that can help older adults flourish, as we seek to go beyond simply preventing disease or ill-health, and instead take a holistic approach to helping people across the full spectrum of human

# Vitamin D medicine do not protect children from bone fractures: Study



large clinical research sponsored Queen Mary University of London and the Harvard T.H. Chan School of Public Health discovered that vitamin D supplementation do not strengthen bone strength or prevent bone fractures in vitamin D-deficient youngsters. The findings call into question widely held beliefs about vitamin D's benefits on bone health.

Around one-third of children have at least one fracture before the age of 18. This is a major global health issue, as childhood fractures can lead to life years of disability and/or poor quality of life. The potential for vitamin D supplements to improve bone strength has attracted growing interest in recent years, based on vitamin D's role in promoting bone mineralisation. However, clinical trials designed to test whether vitamin D supplements can prevent bone fractures in children have not previously been con-

Working with partners in Mongolia, a setting with a particularly high fracture burden and where vitamin D deficiency is highly prevalent, researchers from Queen Mary and Harvard conducted a clinical trial to determine if vitamin D supplementation would decrease risk of bone fractures or increase bone strength in schoolchildren. The study, published today (1 December) in Lancet Diabetes & Endocrinology, is the largest randomised controlled trial of vitamin D supplementation ever conducted in children.

Over the course of three years, 8,851 schoolchildren aged 6-13 living in Mongolia received a weekly oral dose of vitamin D supplementation. 95.5% of participants had vitamin D deficiency at baseline, and study supplements were highly effective in boosting vitamin D levels into the normal range. However, they had no effect on fracture risk or on bone strength, measured in a subset of 1,438 participants using quantitative ultra-

The trial findings are likely to prompt scientists, doctors and public health specialists to re-consider the effects of vitamin D supplements on bone health.

Dr Ganmaa Davaasambuu, Associate Professor at the Harvard T.H. Chan School of Public Health, said:

"The absence of any effect of sustained, generous vitamin D supplementation on fracture risk or bone strength in vitamin D deficient children is striking. In adults, vitamin D supplementation works best for fracture prevention when calcium is given at the same time - so the fact that we did not offer calcium alongside vitamin D to trial participants may explain the null findings from this study.

Professor Adrian Martineau, Lead of the Centre for Immunobiology at Queen Mary University of London, added:

"It is also important to note that children who were found to have rickets during screening for the trial were excluded from participation, as it would not have been ethical to offer them placebo (dummy medication).

Thus, our findings only have relevance for children with low vitamin D status who have not developed bone complications. The importance of adequate vitamin D intake for prevention of rickets should not be ignored, and UK government guidance recommending a daily intake of 400 IU vitamin D remains important and should still be followed."

## Researchers find link between adverse childhood experiences, muscle dysmorphia

dolescents and young adults who had adverse childhood experiences (ACEs) prior to the age **L**of 18 were shown to have a much higher likelihood of exhibiting signs of muscle dysmorphia, according to a recent study.

The findings were published in the Clinical Social

These new findings emphasize the need for greater understanding of the relationship between muscle dysmorphia, or the pathological pursuit of muscularity, and adverse childhood experiences (such as emotional abuse, sexual abuse, and domestic violence), as prior research has shown that over half of North American children and adolescents experience at least one adverse childhood experience

"Those who experience adverse childhood experiences may engage in the pursuit of muscularity to compensate for experiences where they once felt inferior, small, and at risk, as well as to protect against future victimization," says lead author Kyle T. Ganson, PhD, MSW, an assistant professor at the University of Toronto's Factor-Inwentash Faculty of Social Work. "The experience of adverse childhood experiences may also increase body dissatisfaction, specifically muscle dissatisfaction, which is a key feature of muscle dysmorphia." Previous studies have



shown that adverse experiences in childhood can lead to harmful health effects. While prior research has demonstrated that adverse childhood experiences are highly common in people with eating disorders and body dysmorphic disorder, few studies have looked at the association between adverse childhood experiences and muscle dysmorphia.

The study's researchers analyzed data from over 900 adolescents and young adults who participated in the Canadian Study of Adolescent Health Behaviors. In total, 16% of participants who experienced five or more adverse childhood experiences were at clinical risk for muscle dysmorphia, underscoring the significant traumatic effects that such experiences can have on mental health and well-

"Importantly, our study found that gender was an important factor in the relationship between adverse childhood experiences and muscle dysmorphia symptoms," says Ganson. "Boys and young men in the study who have experienced five or more adverse childhood experiences had significantly greater muscle dysmorphia symptoms when compared to girls and young women.

The authors note that boys and young men who experience adverse childhood experiences may feel that their masculinity was threatened from these experiences. Therefore, they engage in the pursuit of muscularity to demonstrate their adherence to masculine gender norms such as dominance, aggression,

and power. "Ît is important for health care professionals to assess for symptoms of muscle dysmorphia, including muscle dissatisfaction and functional impairment related to exercise routines and body image, among young people who have experienced adverse child-

hood experiences, particularly boys and young men,

# Brain waves detected during sleep can protect against epileptic activity: Study

Clow waves, which are normally only present in the brain during sleep, are also present when awake in patients with epilepsy and may protect against the condition's heightened brain excitability, according to a new study led by UCL researchers.

The research, published in Nature Communications and involving the National Institute for Health and Care Research (NIHR) UCLH Biomedical Research Centre, examined electroencephalogram (EEG) scans from electrodes in the brains of 25 patients with focal epilepsy (a type of epilepsy characterised by seizures arising from a specific part of the brain), while they carried out an associative memory

The electrodes had been placed in the patients' brains to localise abnormal activity and inform surgical treat-

During the task, participants were presented with 27 pairs of images that remained on a screen for six seconds. The images were in nine groups of three - each group featuring a picture

of a person, a place and an object. In each case, participants had to remember which images had been grouped together. EEG data were recorded continuously throughout the task.

After reviewing the EEG data, the team found that the brains of people with epilepsy were producing slow waves - lasting less than one second - while they were awake and taking part in the task.

occur-The rence of these "wake" slow waves increased in line with brain increases in excitability and decreased the impact of epileptic spikes on brain activity.

In particular, there was a decrease in the "firing" of nerve cells, which the researchers say could protect against

epileptic activity. Senior author, Professor Matthew Walker (UCL Queen Square Institute of Neurology), said: "Sleep is crucial for repair, maintenance and resetting brain activity. When we are awake we experience a

erience a progressive increase in brain excitability, which is redressed during sleep. "Recent studies

have indicated that a specific form of brain activity. slow waves during sleep, play a crucial role in these restorative functions. wanted to address whether

these 'sleep' slow waves could occur during wakefulness in response to abnormal increases in brain

activity associated with epilepsy. "This study unveils, for the first time, a potential protective mechanism, 'wake' slow waves, employed by the brain to counteract epileptic activity. This mechanism takes advantage of occurs during sleep, but, in people with epilepsy, can occur during wakeful-

As part of the research, the team also wanted to test if the occurrence of "wake" slow waves had any negative effects on cognitive function.

During the memory researchers found that the "wake' slow waves reduced nerve cell activity and so affected cognitive performance - increasing the length of time required by patients to complete the task.

The team reported that for each increase of one slow wave per second, the reaction time increased by 0.56

seconds. Professor Walker said: "This observation suggests that the cognitive difficulties - in particularly, memory deficits - experienced by individuals with epilepsy may be attributed, in part, to the brief impairments induced

by these slow waves. The team hope that future studies will be able to increase such activity as a potential novel treatment for people with epilepsy.

The aim was to showcase key safety-focused infrastructure initiatives currently underway at the station.

Under the guidance of Divisional Railway Manager. Malda, Shri Manish Kumar Gupta, several steps are being taken to strengthen the track and enhance safety. In this regard, Senior Divisional Engineer-I, Shri Champakjyoti Rajvanshi, and SSE/P.WAY/MLDT, Shri Amar Kumar Sarkar, interacted with media representatives and provided detailed insights into the systematic initiatives undertaken to improve track infrastructure and ensure safer, smoother train operations. In line with the division's safety enhancement efforts, officials presented an overview of major infrastructure works underway at Malda Town Station. A key highlight of the interaction was the use of Ultra-Flaw Detection (USFD) technology. This non-destructive testing method plays a vital role in the early detection of internal flaws in rails, welds, Switch Expansion Joints (SEJs), and turnoutsthereby preventing potential failures and bolstering operational safety. As part

significantly strengthened its Ultrasonic Flaw Detection (USFD) system to proactively detect internal flaws in rails, welds, SEJs (Switch Expansion Joints). and turnouts. Such flaws, if left undetected, can lead to rail fractures, posing serious risks to safe train operations. To ensure thorough and regular testing, the division has deployed 6 dedicated USFD testing teams, each supervised by qualified and experienced USFD supervisors. These teams are tasked with scanning every inch of track under Malda Division using advanced ultrasonic equip-

As a result of this intensified testing: • 18 numbers of IMR (Immediate Removal) defects were identified and promptly removed as per the prescribed safety protocols. • 1479 numbers of DFWO/OBS (Defects Found With Observation) were detected and have been appropriately secured and placed under strict observation in line with railway guidelines. Through this robust and proactive approach, Malda Division has significantly minimized the risk of rail fractures and potential derailments, reinforcing its commitment to safe and uninterrupted train operations. ## "Give him time, don't rush it": KapilDev's clear-cut take on "good" talent VaibhavSuryavanshi



LUCKNOW (UTTAR PRADESH): Cricketing legend KapilDev has emphasised the importance of "giving time" to 14-year-old rising sensation VaibhavSuryavanshi, whose talent was unearthed in the ongoing 18th edition of the Indian Premier League.

The Pink City marvelled at the fireworks produced by the bat of a 14-year-old southpaw at the SawaiMansingh Stadium in a high-scoring run-fest against the Gujarat Titans, which ended with an eight-wicket triumph for the Rajasthan Royals.

Right after grabbing the headlines for his record-shattering exploits, Suryavanshi hit rock bottom with a two-ball duck against Mumbai Indians on Thursday at the same venue.

KapilDev, who captained the 1983 World Cup-winning team of India acknowledged that the teenager, who hails from Bihar, possesses a "good" talent and ability but believes the key to success lies in giving a player time.

"Give him time, don't rush it. He is a good talent and has good ability. But you need to give time to players," the veteran former cricketer told reporters here.

Suryavanshi was the mastermind behind Rajasthan's successful pursuit of Gujarat's daunting 210-run target. He single-handedly decimated GT's bowling unit, boasting 694 international caps.

He blazed his way to his maiden IPL hundred in a mere 35 deliveries, the fastest by an Indian in the cash-rich league's history and overall the second-quickest after 'Universal Boss' Chris Gayle's 30-ball ton against Pune Warriors in 2013.

Suryavanshi, at 14 years and 32 days, became the youngest player to score a century in T20 cricket. The 14-year-old's splendid 100 from a mere 35 deliveries is the fastest IPL century by an Indian, bettering Yusuf Pathan's 37-ball hundred against Mumbai Indians (MI) back in 2010.

The 14-year-old teenager tonked 11 maximums during his sizzling display with the bat, which is the joint-highest by an Indian in an IPL inning alongside Murali Vijay. The former Indian opener struck 11 during his 127 against RR in 2010.

## **ECB CONFIRMS WILL NO LONGER PLAY CRICKET AT ANY LEVEL**

LONDON [UK]: The England and Wales Cricket Board (ECB) on Friday announced that transgender women will no longer take part in women's and girls' cricket at any level in England and Wales following a change to its regulations regarding eligi-

ECB released a statement to announce its decision which read, "The ECB is today announcing a change to its regulations regarding eligibility for transgender players in women's and girls' cricket. This is based on the updated legal position following the recent Supreme Court ruling.

"With immediate effect, only those whose biological sex is female will be eligible to play in women's cricket and girls' cricket matches. Transgender women and girls can continue playing in open and mixed cricket," the statement added.

The decision from the ECB comes in the wake of the recent Supreme Court ruling on the definition of a woman in equalities law. Earlier, the ECB, had banned transgender women from elite competitions to bring its eligibility policy into line with that adopted by the International Cricket Council in 2023. "Our regulations for recreational cricket have always aimed at ensuring that cricket remains as inclusive a sport as possible. These included measures to manage disparities, irrespective of someone's gender, and safeguard the enjoyment of all players. However, given the new advice received about the impact of the Supreme Court ruling, we believe the changes announced today are neces-

believe the changes announced today are necessary," the statement continued.

The governing body acknowledged that the decision will have a "significant" impact on transgender women and girls. However, the governing body vowed to "support" people who this change has impacted. "We acknowledge that this decision will have a significant impact on transgender women and girls. We will work with Recreational

Cricket Boards to support people impacted by this change in our regulations," the statement added.

"We await updated guidance from the Equality and Human Rights Commission (EHRC) and will study this carefully. We maintain that abuse or disputation has a pleasing in purpose that abuse are supported by the company of the crimination has no place in our sport and are committed to ensuring that cricket is played in a spirit of respect and inclusivity," the statement



## IPL 2025 chasing shadow of last year as six appeal declines; spinners stamp authority

NEW DELHI [INDIA]: The 18th edition of the Indian Premier League (IPL) is chasing the shadow of the previous edition with six appeal taking a dip and spinners dictating the terms of play.

IPL 2024 set a new benchmark in T20s in terms of aggressive batting and high-scoring affairs. At the beginning of IPL 2025, setting new standards in the tournament was on the

A staggering 119 sixes were struck in the first five games compared to 87 last year, and 200-plus totals were breached on six occasions, including three totals of over

Since then, bowlers have retaliated with vigour under conditions that haven't been a paradise for powerhitting. As a result, after the conclusion of 50 matches in the ongoing cash-rich league, the numbers have



fallen behind in terms of run rates, courtesy of the 38 six-hitting fest sixes and 200-plus totals.

At the same stage in 2024, Kolkata night Riders, Sunrisers Hyderabad and Royal Challengers Bengaluru boasted run rates in excess of 10. However, the Gujarat Titans are the only side to tick the box.

While diving deeper into phase-wise statistics, franchises have managed the highest run rate and struck more sixes in the powerplay, but the statistics have seen a slight drop in the other two phases. During the middle overs, the average run rate slipped from 9.00 to 8.89, while the death overs registered a drop from 11.81 to 11.02. The regression in sixhitting best resonates with the overall comparison between the two seasons. The ongoing edition had 38 more maximums after 29 matches than IPL 2024. However, after the 30th match, the difference was reduced to just 13, between Royal Challengers Bengaluru and Sunrisers Hyderabad last year. After the conclusion of 50 matches, the current edition is lagging behind a staggering 70 sixes. In IPL 2024, there were three fixtures in the first 50, where more than 35 sixes were struck. But this year, 32 is the highest mark that has been breached

The ball tweakers are collectively faring much better in 2025 than they did last year, with 220 wickets at an average of 30.02. In IPL 2024, spinners combined to scythe 154 wickets

at an average of almost 37. In IPL 2025, Noor Ahmad, YuzvendraChahal, KrunalPandya, VarunChakravarthy, KuldeepYadav and R Sai Kishore have stormed their way to 12 wickets or more, compared to the last season, where Chahal and Kuldeep had managed to do so after 50 games.

## S SREESANTH SUSPENDED FOR THREE YEARS BY KERALA CRICKET ASSOCIATION

THIRUVANANTHAPURAM (KERALA): The Kerala Cricket Association (KCA) has suspended former Indian cricketer S Sreesanth for three years, citing false and defamatory remarks made against the association amid the controversy surrounding Sanju Samson's omission from India's squad for the ICC Champions Trophy held earlier this year, as per a release from KCA.

The decision was made during a special general body meeting of the KCA held in Ernakulam on Friday, April 30.

Sreesanth, who currently serves as the co-owner of the Kerala Cricket League franchise Kollam Aries, had made critical public comments linking the KCA to Samson's exclusion.

Following these statements, showcause notices were issued to Sreesanth as well as to three franchise teams, Kollam Aries, Alleppey Team Lead Contender Sai Krishnan, and Alleppey

The general body reviewed the responses from the franchises and deemed them satisfactory. As a result, no further action will be taken against them. However, the KCA advised all franchise teams to exercise greater caution when appointing individuals to team management roles.



The association also announced its intention to pursue legal action against Samson's father, Samson Vishwanath, former cricketer RejiLukose, and a news anchor from the 24x7 news channel, citing defamatory remarks made in public

forums against the association. S. Sreesanth's international cricket career was marked by moments of brilliance, controversy, and resilience across


Sreesanth made his ODI debut for

India in 2005 against Sri Lanka. He was later called up to the Test squad in 2006 for the England series and played a T20 match against South Africa the same year. He was part of India's 2007 T20 World Cup and 2011 ODI World Cupwinning teams.

Across all formats, he played 90 matches and took 169 wickets at an average of 35.89 and an economy rate of 4.49. His best bowling figure, 6/55, came against England in 2006. In August 2013, the BCCI banned Sreesanth for life, along with teammates AjitChandila and AnkeetChavan, over alleged IPL spot-fixing.

His ban was later reduced to seven years and ended in September 2020. He returned to domestic cricket in 2021, representing Kerala in the Syed Mushtaq Ali Trophy. He also entered the IPL auctions in 2021 and 2022 but went unsold. Sreesanth played 27 Test matches, taking 87 wickets and scoring 281 runs. In 53 ODIS, he claimed 75 wickets. In T20IS, he played 10 matches and took seven wickets.

In the IPL, he played for Punjab Kings, Kochi Tuskers Kerala, and Rajasthan Royals, taking 40 wickets in 44 matches at an average of 29.85 and an economy of 8.14.
