Speaking after reaching the district headquarters of Murshidabad on Monday afternoon on a two day visit to talk to the families of the victims of the last month's violence, the Chief minister said during her visit she is also taking stock of the situation. "The complete truth about this will be revealed soon. She also criticised the opposition and those behind the violence, terming them as 'enemies of Bengal'.

Mamata Banerjeee who is scheduled to visit troubled areas of Dhulian, Shamserganj and Suti on Tuesday, said "I will not blame any community. Some people have become religious leaders. In the name of religion, they talk rubbish. They are the ones who create unrest. They are the enemies of Bengal." Reminding the heritage of Murshidabad, Mamata Banerjee said, ''Murshidabad was once the capital of Bengal.,and said trouble broke out only in two wards in the district last month. Only two-three people are creating this chaos. Who did it, how did it happen, I am cross-checking. There is also division in the role of some media outlets. When I get the com-

plete information, I shall announce it."The Chief minister further stated that, "When I do politics or sit in any chair, all religions are equal to me, everyone is equal. I do not want any community to be attacked in Bengal. There was a conspiracy in Murshidabad." She also criticised the National Human Rights Commission and the National Commission for Women for visiting the affected areas and said, "The Human Rights Commission came the very next day after the incident! Did it go to Manipur? It did not go to Uttar Pradesh, Rajasthan, Delhi, Bihar! What happened here suddenly? It was preplanned where one community attacked another community.

She said that Trinamool Congress leader Kalyan Banerjee MP, is in touch with the family members, adding "This is an extremely sad situation . His name is Sahu. Our party's Kalyan Banerjee is in touch with the family members. I want that he should be rescued as soon as possible. We have clearly said that our party is with the Union government on the issues of internal and external security. We are not resorting to any divide and rule here.

Meanwhile, the BSF has issued a strict advisory to its jawans to remain alert and vigilant during bor-

der patrolling. A senior BSF officer has confirmed that, although the advisory has been a part of their regular briefing, after Pakistani Rangers captured and detained the jawan during patrolling duty, all patrolling parties have been instructed to be extra cautious during duty.

"Amid ongoing tension at the border, jawans have been asked to be extra cautious and avoid inadvertently crossing the border during patrol duty. Even the farmers working on farms at the borders have been asked to be vigilant," the officer said.

According to another BSF officer, such incidents are common in the Punjab border where jawans from both sides often cross the international border areas inadvertently and issues are used to get resolved in a single flag meeting, but this time Pakistan is not turning up for the meeting despite several attempts.

"Pakistan is not responding because of ongoing tension after the Pahalgam attack, but we have lodged our protest with the Pak Rangers and are making all efforts to bring back the jawan," the officer added. Pakistani Rangers detained the BSF trooper on April 23 after



Robbery at empty house

Together, Nityananda and Maya had two daughters, and Maya gave birth to their third daughter at home on Sunday. Enraged at the birth of another girl, Nityananda allegedly wrapped the newborn in cloth and threw her into a nearby well. He later confessed his actions to his sister-in-law, who immediately alerted other family members. Neighbors and relatives rushed to the spot and managed to rescue the infant, who was immediately taken to Krishnanagar District Hospital for treatment. This training, allegedly conducted in Pakistanoccupied Kashmir with instruction at launch pads and Pakistani bank facilities, was not universally provided, but rather given to select terrorists, according to central and military intelligence. MI News Service, Kolkata: The controversy surrounding the origin of the neem wood used for the Jagannath temple idol in Digha took a new turn, with West Bengal Chief Minister Mamata Banerjee weighing in before her Murshidabad visit. Banerjee questioned the uproar, contrasting it with similar structures at other religious sites. Meanwhile, the Odisha government has sought to quell the issue, with the Law Minister attributing the initial claims about the wood's origin to a mistaken statement by a Puri temple priest, Rajesh Daitapati, who had earlier played a key role in the Digha temple's inauguration. Daitapati had initially claimed the wood was leftover sacred neem from the temple's Puri 2015Nabakalebar festival, a statement he later contradicted in Odisha. The recent controversy surrounding the origin of the neem wood used in the newly inaugurated Jagannath temple idol in Digha has been ad-dressed by the Odisha government, attributing earlier conflicting statements to a misunderstanding. The issue gained traction after Rajesh Daitapati, a prominent priest from the Puri Jagannath Temple who was involved in the Digha temple's inauguration, initially claimed the idol was crafted from leftover sacred neem wood from the Puri temple's 2015 'Navakalevara' ritual. This assertion sparked considerable debate. Subsequently, Daitapati reportedly retracted his initial statement in Odisha, leading to clarification from the state's Law Minister. The Minister stated that Dwaitapati had mistakenly conveyed the information regarding the wood's origin. Prior to her departure for Murshidabad on Monday, West Bengal Chief Minister Mamata Banerjee also commented on the matter, questioning the intensity of the controversy surrounding the Digha temple.

Job scam busted, man arrested in Kolkata for army job fraud

MI News Service, Kolkata: Police in Hastings have arrested Mohammad Sajada, a resident of Garden Reach, in connection with a scam promising jobs in the army. Sajada allegedly lured victims into paying money under the pretense of securing army positions through a purported Majorrank officer. While Sajada has been apprehended, police indicate that the main mastermind behind this fraudulent operation remains at large. The arrest followed a complaint filed after victims, who paid approximately 6 lakh, discovered the job offers were fake after consulting with an actual army personnel. The Hastings Police have apprehended a man, identified as Mohammad Sajada, a resident of the Garden Reach area, for his alleged involvement in a fraudulent scheme promising jobs in the Indian Army. While Sajada has been arrested, police officials have stated that the principal orchestrator of this elaborate con

remains at large. The case unfolded after a group of individuals, including a resident of Uttar Pradesh named Amid, were approached with the enticing offer of army recruitment through a purported Majorrank officer, leveraging a special quota. The victims were informed that the process would necessitate the submission of specific documents and a monetary payment. Subsequently, the complainants and their associates were instructed to convene at Maidan Chattar in Kolkata. There, they were allegedly met by an individual dressed in an army uniform and seated in a car, who assured them of job placements in exchange for financial consideration. Impressed by the attire and demeanor of the individual, the victims reportedly paid approximately 6 lakh. The fraudulent nature of the scheme came to light when the complainant shared the details with an acquaintance serving in the army.

Kolkata Rooftop restaurants get HC reprieve from demolition

MI News Service, Kolkata: The Calcutta High Court has strongly criticized the Kolkata Municipal Corporation's (KMC) ongoing demolition of rooftop restaurants, issuing an interim stay on the demolition of a Park Street establishment until next Thursday. Justice Gaurang Kant questioned the legality of the municipality's actions, stating, "You can't demolish like this," and pointing out issues with the legal basis of the demolition notice. This intervention came after a restaurant owner challenged the sudden demolition, arguing they possessed the necessary licenses and questioned if they were being unfairly targeted following the Mayor's directive after the Mechua Bazar fire. The court also heard that the restaurant had a pending regularization application with the KMC. The Calcutta High Court has strongly criti-

cized the Kolkata Munici-pal Corporation (KMC) for

its recent demolition drive targeting rooftop restaurants, even those claiming to possess valid permissions. Justice Gaurang Kant, presiding over a case filed by a Park Street restaurant owner, granted an interim stay on the demolition until next Thursday, pointedly telling the municipality, "You can't demolish like this." The judge further questioned the legal basis of the demolition notice, stating, "You can't demolish because of the section of the law under which you sent the notice to the hotel authorities." During the hearing, the plaintiff's lawyer argued that the sudden demolition was unwarranted and questioned its legality. "Can our restaurant be demolished overnight because there was a fire somewhere else?" the lawyer asked, referring to the recent Mechua Bazar fire that prompted Mayor Firhad Hakim's order to shut down rooftop establishments.

Indian toy exporters eye 'golden opportunity' as US buyers avoid Chinese products

MI News Service, New Delhi/Washington: India's toy exporters are aiming to utilise a "golden opportunity" emerging out of the steep tariffs imposed by the US on Chinese imports, and growing enquiries from American buyers eyeing alternative markets to reduce their reliance on Chinese goods. Toy Association of India has identified about 40 firms with the potential to export to the US market while meeting the compliance requirements. Currently, about 20 companies export toys in bulk to the American market, President Ajay Aggarwal told.

"We are getting more enquiries from US-based tov buyers in the last one month. Some Indian export houses have also got in touch with us seeking a list of the manufacturers who can make toy products as per US rules and regulations. They are looking for white labelling and original equipment manufacturers capable of meeting the compliance requirements of the American toy market," Aggarwal said.

News Service, New Delhi: Researchers have developed "venom maps" using local climate conditions that could help predict the venom characteristics of Russell's viper, a deadly snake found widely in India.

A team of researchers from the Indian Institute of Science (IISc), Bengaluru said the venom maps could help clinicians select the most appropriate treatment for patients with snake bites. The findings of the research have been published in the journal "PLOS Neglected Tropical Diseas-

Author Kartik Sunagar from the Centre for Ecological Sciences, IISc said. 'Russell's viper is arguably the clinically most important snake species in the world. It kills and maims more people than any other snake species.'

4 helmetless youth on one bike fly off flyover at High speed, die in Tragic MI News Service, Kolkata: In a tragic incident early Monday morning, two young men lost their lives and two others sustained critical injuries in a highspeed motorcycle accident on the Ultadanga flyover. The incident, which occurred in front of Rohini Coal India Housing, has cast a pall of gloom over the city, coming just four days after a similar fatal accident on the Maa Flyover near Pragati Maidan. According to police reports, four youths - identified as Shoaib (20), Sohel (18), Shahrukh, and Rahman, all residents of the Beniapukur area - were riding a single motorcycle at a high speed without wearing helmets. While traveling on the flyover, they reportedly lost control of the vehicle and collided forcefully with the railing of the ramp leading towards VIP Road. The impact of the collision caused all four riders to fall onto the flyover. Police personnel from the Laketown Traffic Guard under the Bidhannagar Commissionerate, despite the location falling under the jurisdiction of the Ultadanga police station, promptly responded to the scene and rescued the injured individuals.

Study finds new method to detect novel biomarkers for kidney diseases with nephrotic syndrome

BOSTON [US] : A study has revealed a major advance in the identification and tracking of renal illnesses linked to nephrotic syndrome

The findings of the study were published in the New England Journal of Medicine and presented at the 61st ERA Congress in Stockholm, Sweden.

By employing a hybrid methodology, scientists discovered that anti-nephrin autoantibodies serve as a dependable biomarker for monitoring the advancement of the disease, paving the way for more individ-

ualized therapeutic strategies. Nephrotic syndrome, defined by increased urine protein levels, is associated with kidney disorders, including membranous nephropathy (MN), primary focal segmental glomerulosclerosis (FSGS), and minimal change disease (MCD). Damage to podocytes, the kidney's filtering cells, is the main cause of nephrotic syndrome because it permits protein to seep into the urine

Children diagnosed with MCD or FSGS often receive a diagnosis of idiopathic nephrotic syndrome

They focused on brain vascular cells, which make up a small portion of cell types in the brain, to examine molecular changes associated with Alzheimer's disease. In particular, they looked at two cell types that play an important role in maintaining the blood-brain barrier: pericytes, the gatekeepers of the brain that maintain the integrity of blood vessels, and their support cells known as astrocytes, to determine if and how they interact. They found Alzheimer's disease patients' samples exhibited altered communication between these cells, mediated by a pair of mole

NEW JERSEY [US] : Infertility treatment patients were twice as likely to be hospitalised with heart disease in the year following delivery as spontaneously conceived patients, according to a study conducted by Rutgers Health experts using more than 31 million hospital records.

Infertility patients were 2.16 times more likely to be hospitalised for hypertension, or dangerously elevated blood pressure than normally conceived patients

"Postpartum checkups are necessary for all patients, but this study indicates they are particularly important for patients who undergo infertility treatment to achieve a conception," said Rei Yamada, an obstetrics and gynecology resident at Rutgers Robert Wood Johnson Medical School and lead author of the study.

The study authors say their results support standards of care that now call for an initial postpartum checkup three weeks after delivery, standards that some health systems have yet to adopt. Much of the elevated risk came in the first month after delivery, particularly for patients who developed dangerously high blood pressure

"And these results aren't the only ones to indicate that follow-up should occur early, said Cande Ananth, chief of the Division of Epidemiology and Biostatistics in the Department of Obstetrics, Gynecology, and Reproductive Sciences at Rutgers Robert Wood Johnson Medical School and senior author of the study. "We have been involved in a series of studies over the past few years that have found serious risks of heart disease and stroke to various high-risk patient populations within those initial 30 days after delivery - risks that

could be mitigated with earlier follow-up care.

The study analyzed the Nationwide Readmissions Database, which contains nationally representative data on about 31 million hospital discharges and readmissions per year. The database contains diagnosis codes, which let researchers find specific populations and identify reasons for readmission.

The researchers used data from more than 31 million patients who were discharged following delivery from 2010 to 2018, including 287,813 patients who had undergone any infertility treatment.

Although infertility treatment predicted a sharply elevated risk of heart disease, the study authors said the relative youth of infertility treatment patients kept their overall risk fairly low. Just 550 of every 100,000 women who received infertility treatment and 355 of every 100,000 who conceived naturally were hospitalized with cardiovascular disease in the year after deliv-

ery. The cause of the elevated risk of heart disease associated with infertility treatment remains unclear. The increase in heart disease could stem from the infertility treatments themselves, the underlying medical issues that made patients infertile or some other cause.

"Looking forward, I'd like to see if different types of infertility treatment and, importantly, medications are associated with different risk levels," said Yamada. "Our data gave no information about which patients had undergone which treatment. More detailed information might also provide insight into how infertility treatment impacts cardiovascular outcomes.

Traditionally, diagnosing these conditions has posed challenges due to overlapping histological features and hesitancy to conduct invasive kidney biopsies, particularly in children. The study, conducted across Europe and the USA, introduced a novel approach combining immunoprecipitation with enzyme-linked immunosorbent assay (ELISA) to reliably detect anti-nephrin autoantibod-

The findings revealed that anti-nephrin autoantibodies were prevalent in 69 per cent of adults with MCD and 90 per cent of children with INS who had not been treated with immunosuppressive drugs. Importantly, the levels of these autoantibodies corre-

protein to mice, creating a condition akin to MCD in the mice. Immunisation led to the phosphorylation of nephrin and notable alterations in cell structure, indicating the involvement of antibodies targeting nephrin in podocyte malfunction and nephrotic syndrome.

Dr Nicola M Tomas, co-lead author of the study, commented, "The identification of anti-nephrin autoantibodies as a reliable biomarker, coupled with our hybrid immunoprecipitation technique, enhances our diagnostic capabilities and opens new avenues for closely monitoring disease progression in kidney disorders with nephrotic syndrome.

Professor Tobias B. Huber, lead author of the study, furthered, "By providing insights into underlying mechanisms, these findings lay the groundwork for personalised interventions and pave the way for a new era of precision medicine for these complex conditions.

said senior author Nilufer Ertekin-Taner, MD, PhD, chair of the Department of Neuroscience at Mayo Clinic and leader of the Genetics of Alzheimer's Disease and Endophenotypes Laboratory at Mayo Clinic in Florida.

To conduct the study, the research team analysed human brain tissue from the Mayo Clinic Brain Bank, as well as published datasets and brain tissue samples from collaborating institutions. The study cohort included brain tissue samples from 12 patients with Alzheimer's disease and 12 healthy patients with no confirmed Alzheimer's disease.

All participants had donated their tissue for science. Using these and external datasets, the team analysed thousands of cells in more than six brain regions, mak-

cules known as VEGFA, which stimulates the growth of blood vessels, and SMAD3, which plays a key role in cellular responses to the external environment. Using cellular and zebrafish models, the researchers validated their finding that increased levels of VEGFA lead to lower levels of SMAD3 in the brain. The team used stem cells from blood and skin samples of the Alzheimer's disease patient donors and those in the control group. They treated the cells with VEGFA to see how it affected SMAD3 levels and overall vascular health. The VEGFA treatment caused a decline in SMAD3 levels in brain pericytes, indicating an interaction between these molecules. Donors with higher blood SMAD3 levels had less vascular damage.

Researchers find how areas of brain are associated with helping decisions

BIRMINGHAM [UK] : Researchers found that a particular brain region--which they identified through a study of patients who had brain damage to that region--controls our willingness to assist others.

Understanding the areas of the brain associated with "helping" decisions is crucial to comprehending how people could be inspired to take on major global issues like infectious diseases, climate change, and international conflict. It is also necessary to discover novel treatments for social interaction difficulties.

Researchers from the Universities of Birmingham and Oxford conducted the study, which was published in Nature Human Behaviour. It demonstrates for the first time how the ventromedial prefrontal cortex (vmPFC), a brain region, plays a crucial role in helpful, or "prosocial," activities.

Lead author Professor Patricia Lockwood said: "Prosocial behaviours are essential for addressing global challenges. Yet helping others is often effortful and humans are averse to effort. Understanding how effortful helping decisions are processed in the brain is extremely important." In the study, the researchers focused on the vmPFC, a region located right at the front of the brain, which is known to be important for decision-making and other executive functions. Previous studies using magnetic resonance imaging (MRI scanning) have linked the vmPFC to choices that involve a trade-off between the rewards available and the effort required to obtain rewards. However, these techniques cannot show whether a part of the brain is essential for these functions. Three groups of participants were recruited for the study. 25 patients had vmPFC damage, 15

patients had damage elsewhere in the brain, and 40 people were healthy age and gender-matched control participants. These groups allowed the researchers to test the impact of damage to vmPFC specifically.

Each participant attended an experiment where they met another person anonymously. They then completed a decision-making task that measured how willing they were to exert physical effort (squeezing a grip force device) to earn rewards (bonus money) for themselves and for the other person. By enabling participants to meet - but not see the person they were 'working' for in advance, researchers were able to convey the sense that participants' efforts would have real consequences, but hide any information about the other person that could affect deci-

sion-making. Each choice the participants made varied in how much bonus money for them or the other person was available, and how much force they would have to exert to obtain the reward. This allowed the researchers to measure the impact of reward and effort separately, and to use advanced mathematical modelling to precisely quantify people's motivation. The results of the study clearly showed that the vmPFC was necessary for motivation to help others. Patients with vmPFC damage were less willing to choose to help others, exerted less force on even after they did decide to help, and earned less money to help others compared to the control groups. In a further step, the researchers used a technique called lesion symptom mapping which enabled them to identify even more specific subregions of the vmPFC where damage made people particularly antisocial and unwilling to exert effort for the other person. Surprisingly, damage to a nearby but different subregion made people relatively more willing to help.

Co-lead author Dr Jo Cutler said: "As well as better understanding prosocial motivation, this study could also help us to develop new treatments for clinical disorders such as psychopathy, where understanding the underlying neural mechanisms can give us new insights into how to treat these conditions.

This region of the brain is particularly interesting because we know that it undergoes late development in teenagers, and also changes as we get older," added Professor Lockwood. "It will be really interesting to see whether this area of the brain can also be influenced by education - can we learn to be better at helping others?

13 kidnapped mine guards found dead in north Peru

MI News Service, Lima: The bodies of 13 mine company guards previously reported as kidnapped were found in north Peru's La Libertad department, local media said Sunday. "Sources from the Executive from the Branch" confirmed the discovery of the bodies in the Pataz province, reported private news network Radio Programas del Peru. Police reports said that the bodies were found bound, blindfolded and naked in a mineshaft, where they were reportedly shot. "Illegal miners colluding with criminals kidnapped 13 workers who were providing services to an artisanal miner.' which "attests to the terrible deterioration of security conditions in Pataz," mining company La Poderosa said on Friday. "This unfortunate event occurred after criminals attacked the artisanal mining operation to take control of it," the company said. Family members of the victims said they lost contact with the guards on April 27 while they were on duty, and the kidnappers "demanded a large sum of money from the mining company in exchange for their release." The mining company urged authorities to act swiftly on a complaint filed by the victims' families.

Iran rejects accusations of involvement in Houthi attacks on Israel

Bharat Gaurav Tourist Train to Showcase the Legacy of Chhatrapati Shivaji Maharaj

MI News Service, Kolhapur : The Heritage Special Tour will show-case the Raigad Fort, Pune (Lal Mahal, Kasba Ganpati, and Shivsrushti), Shivneri Fort, Bhimashankar Jyotirling, Pratapgad Fort, and Kolhapur (Mahalaxmi Temple and Panhala Fort) to the tourists. For the first time, Indian Railways is organizing a Heritage Tour on the 'Chhatrapati Shivaji Maharaj Circuit'. This tour will cover key sites related to the life of Chhatrapati Shivaji Maharaj, the founder of the Maratha Empire. The Bharat Gaurav Train will begin its journey from Chhatrapati Shivaji Maharaj Terminus (CSMT) and reach Mangaon Railway Station, the nearest station to Raigad Fort, located on the Konkan Railway Network. Raigad is the historic site where Shivaji Maharaj was coronated and later made it his capital. After exploring Raigad Fort, tourists will return to the train and head towards Pune, where arrangements will be made for dinner and hotel accommodation for the night.

On Day 2, tourists will visit key locations in Pune, including Lal Mahal, Kasba Ganpati, and Shivsrushti. Lal Mahal was constructed in 1630 by Shahaji Bhonsle for his wife Jijabai and son Shivaji. The current structure was rebuilt in 1984, and it houses a large collection of paintings related to Chha-

trapati Shivaji Maharaj's life. The Kasba Ganpati Temple is considered the town deity of Pune and was established in 1893. It is believed that the site was chosen by Shivaji's mother, Jijabai, which led Pune to be known as the city of Lord Ganesha. Tourists will then visit Shivsrushti, the largest theme park in India based on the life of Chhatrapati Shivaji Maharaj. Here, they will enjoy a 3D experience of Shivaji's life and other interactive sessions. After the night stay in Pune, on Day 3, tourists will visit Shivneri Fort, about 95 km from Pune, situated on a hill near Junnar City. This is the birthplace of Chhatrapati Shivaji Maharaj and a symbol of Maratha pride against

Muslim rule. After lunch, the tourists will visit Bhimashankar Jyotirling, one of the 12 Jyotirlings. Afterward, they will return to Pune for an overnight stay. The muchanticipated 'Chhatrapati Shivaji Maharaj Circuit Tour' will depart on June 9, 2025. This 5-night and 6-day tour will begin at Chhatrapati Shivaji Maharaj Terminus. The modern Bharat Gaurav AC Tourist Train, with Sleeper, Second AC, and Third AC coaches, has the capacity to accommodate 748 tourists. Tourists can board this train at Dadar and Thane railway stations as well. Tickets for this heritage journey can be booked on the IRCTC website on a first-come, first-served basis.

On Day 4, tourists will travel with the Bharat Gaurav Train to Satara, where they will visit Pratapgad Fort, the site of the famous battle in 1659 between Afzal Khan and Chhatrapati Shivaji Maharaj, which laid the foundation for the Maratha Empire. After lunch, the train will proceed to its final destination, Kolhapur. On Day 5, in the morning, the train will reach Chhatrapati Shahu Ji Maharaj Terminus, Kolhapur Railway Station. After breakfast and preparations at the hotel, tourists will visit the Mahalaxmi Temple (Ambabai) and Panhala Fort. Located on the Sahyadri mountains, this fort has witnessed several historic battles. It is also the place where Shivaji Maharaj stayed for 500 days before making a successful escape. Panhala Fort is also known as the 'Fort of Snakes' because of its serpentine shape. This fort is closely associated with the lives of Shivaji Maharaj and Sambhaji Maharaj. It is also remembered for the valor of Shivaji Maharaj's commander, Baji Prabhu Deshpande. Later, in the evening, the train will begin its return journey to Mumbai and will reach Mumbai on the morning of Day 6. Terrorism is an act against humanity, targetting Muslims for this is wrong: Madani

MI News Service, New Delhi: Jamiat Ulema-e-Hind chief Maulana Arshad Madani strongly condemned the recent terrorist attack on tourists in Pahalgam, stating that those responsible cannot be considered human.

Speaking at a press conference following a twoday working committee meeting of the Jamiat (Arshad Madani faction), he emphasized that targeting the entire Muslim community in the aftermath of such attacks is unjust and harmful. Madani ques-tioned the government's recent decision to revoke the Indus Water Treaty, highlighting the impracticality diverting rivers like Chenab, Ravi, Jhelum, Beas, and Sutlej. "These rivers have flowed for thousands of years and form the Indus. Where will you take this water? It's not that simple," he said. He urged the government to foster love over hatred, asserting that communal disharmony is not in the nation's interest. Addressing the demolition of houses in Kashmir after the attack, Madani said such action is justified only if it is certain that those homes belonged to terrorists. "But punishing people on mere suspicion is wrong," he warned. Without naming Pakistan, he called on the government to address terrorism at its roots to prevent future incidents. Madani stressed that the perpetrators of the Pahalgam attack are ignorant of Islamic teachings. "Islam



strictly forbids the killing of innocent people. It is a grave sin. Those who commit such acts cannot be called human," he said. He alleged that Muslims, particularly Kashmiris, are being unfairly targeted post-attack due to divisive policies. On the matter of security, Madani criticized the government for failing to prevent the attack despite heavy deployment of Army and BSF in the region. "How did terrorists reach such a crowded tourist destination undetected? And why did security forces take one-and-a-half hours to respond?" he questioned, crediting local civilians for aiding the victims. Regarding illegal immigration, Madani supported action against unlawful Bangla deshi immigrants but cautioned against harassment of Bengali-speaking citizens in states like West Bengal, Assam, and Tripura. On a potential war with Pakistan, he warned of severe economic consequences and advocated peaceful resolution. Commenting on the Waqf (Amendment) Act, he alleged that it was intended to seize Waqf properties rather than protect them.

Netanyahu vows retaliation after Houthi missile strikes Israel's airport

MI News Service, Tel Aviv: Israeli Prime Minister Benjamin Netanyahu vowed to retaliate against Houthi forces in Yemen and their ally, Iran, after a missile launched by the group struck Israel's international airport. Writing on the social media platform X, the official account of the Prime Minister's Office stated that "attacks by the Houthis emanate from Iran." It added that Israel "will respond to the Houthi attack against our main airport and, at a time and place of our choosing, to their Iranian terror masters." Earlier Sunday, Netanyahu issued another warning to the Houthis, threatening to launch a strike against the group. 'We attacked in the past, we will attack in the future," he said in a video statement. The Houthis claimed responsibility for a missile strike that hit a driveway leading to the main terminal of Ben Gurion Airport, outside Tel Aviv. Israeli and USdeployed aerial defence systems attempted to intercept the missile but failed, Xinhua news agency reported. The attack resulted in four minor injuries and caused damage. Several in-ternational airlines cancelled flights to and from Israel following the missile attack, including Air Europa, Swiss International Air Lines, Lufthansa, ITA Airways, and Brussels Airlines. The Houthis have intensified missile and drone attacks in recent weeks amid renewed US airstrikes on their positions in Yemen.

MI News Service, The Hague: The Hind Rajab Foundation has identified the Israeli military unit and commander allegedly responsible for the killing of Palestinian girl Hind Rajab and her family, and has filed a war crimes complaint with the International Criminal Court (ICC) in The Hague. The lawsuit was filed on Saturday, May 3, - the day Hind would have celebrated her seventh birthday. On January 29, 2024, the car carrying Hind and her family was struck by Israeli tank fire in Tel al-Hawa. Six relatives were killed instantly. Hind, wounded and terrified, survived for hours, whispering to dispatchers from the Palestine Red Crescent Society (PRCS): "I'm so scared... please come." An ambulance was dispatched to rescue her but was also shelled and destroyed. Both medics inside were killed instantly. Ten days later, rescue workers discovered



Hind's body beside her cousin, Layan. In a statement, the Belgium-based foundation, established in Hind's memory, named Lieutenant Colonel Beni Aharon — then commander of the Israeli army's 401st Armoured Brigade — as the principal perpetrator. According to the foundation, field commanders and operational officers. "These men are no longer anonymous. They are no longer shielded by silence," the foundation declared.

While we initially urge the ICC Office of the Prosecutor to issue an arrest warrant for Lt. Col. Beni Aharon, we are also preparing additional legal actions against other officers in the battalion. These will be filed in national courts under universal jurisdiction. We will pursue every individual involved those who gave the orders, those who carried them out, those who concealed the truth, and those who stood by," the statement continued. "Today, Hind should have been blowing out candles. Instead, we are naming her killer," said Dyab Abou Jahjah, spokesperson for the foundation. This is only the beginning. We are coming for every name, every link in the chain — armed

with the law and the truth."

The case is supported by extensive research conducted over the past year, incorporating findings from organisations including Forensic Architecture and Sky News. The foundation has compiled a comprehensive body of evidence and is urging judicial authorities to act with urgency and determination. Since Israel began its military campaign in Gaza on October 7, 2023, nearly 52,500 Palestinians — the majority women and children have been killed, with thousands more injured or missing beneath the rubble of devastated cities. In November, the ICC issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and for-Defence Minister Yoav mer Gallant for alleged war crimes and crimes against humanity. Israel also faces a separate genocide case at the International Court of Justice (ICJ).



Muzarabani, Mehidy Hasan, Sears named ICC Men's Player of the Month nominees for April



DUBAI [UAE] : Zimbabwe's pace spearhead Blessing Muzarabani, Bangladesh's versatile all-rounder Mehidy Hasan Miraz, and New Zealand's right-arm seamer Ben Sears have been announced as the nominees for ICC Men's Player of the Month for April 2025.

Muzarabani, a towering speedster from Zimbabwe, has been thriving on a scorching run since the beginning of the year. With a whip-like action, the 28-year-old played a starring role in the first Test against Bangladesh in Sylhet.

He returned with figures of 3/50 in the first innings, which included the big fish, Bangladesh captain Najmul Hossain Shanto. In his second turn, he scythed six scalps and gave away 72 runs as he steered Zimbabwe with his Player of the Match performance to a three-wicket triumph, their first victory in the format since March 2021.

Muzarabani finished as Zimbabwe's top wicket-taker in the series with 10 wickets under his belt across the two Tests in Bangladesh at an average of 20.50.

While Muzarabani stole the show in the first Test, Bangladesh's Mehidy Hasan grabbed the headlines in the second. The 27-year-old shone in the series opener and kept Bangladesh in the contest, claiming figures of 5/52 in the first innings and 5/50 in the second.

He emerged as the mastermind behind Zimbabwe's downfall in the second Test. In arguably a performance to remember from him, Mehidy Hasan anchored Bangladesh's first innings with a touch of flamboyance and slammed 104 off 162 balls to lift the hosts to 444.

He topped it up with another five-wicket haul and registered 5/32 in Zimbabwe's second innings to help Bangladesh end the series at 1-1 with a triumph by an innings and 106 runs in Chattogram.

Sears found his rich vein of form with the ball for New Zealand. With his searing pace, he unleashed carnage on his home turf against Pakistan and picked up backto-back five-wicket hauls in the last two matches of the ODI series and became the first player to achieve the milestone for the Blackcaps.

In the second ODI against the Men in Green in Hamilton, Sears ran rampant and tore through Pakistan's middle order, finishing with figures of 5/59 and setting up an 84-run victory for the Kiwis. In the final ODI of the series, he dazzled

with figures of 5/34 as New Zealand whitewashed Pakistan with a 3-0 series win. Sears was crowned with the Player of the Series award for his sensational performance. He picked up 10 wickets at an average of 9.30 at an economy rate of 5.07 to cap off a memorable April.
