Mamata Banerjee announces fresh exam notification for teachers on May 30, offers alternative posts to other dismissed teachers and others

MI News Service, Kolkata: West Bengal Chief Minister Mamata Banerjee on Tuesday addressed the pressing issue of nearly 26,000 dismissed school teachers in the state whose appointments were recently cancelled by the Supreme Court.

In a high-profile press conference held at Nabanna alongside Education Minister Bratya Basu, the Chief Minister made a series of crucial announcements that could significantly impact the future of the affected teachers as well as the state's education system.

Mamata Banerjee said her government will start the fresh recruitment process of teachers as per the Supreme Court directive, while simultaneously pursuing a review petition seeking reinstatement of those who lost

Addressing the highly anticipated press conference, she said the teachers who lost their jobs will be given the benefit of their experience and age relaxation in the fresh recruitment process, the notification for which will be issued on May 30.

We want all those teachers who lost their jobs to get their jobs back. But we also have to

by May 31," she said.
"Both the review petition and the process of issuing the notification will go on simultaneously," she said.

Mamata Banerjee's statement came amid massive protests by the teaching and non-teaching staff of statebacked schools, who lost their jobs because of an SC order in the School Service Commission (SSC) recruitment scam.

Announcing relief for the teachers who lost their jobs, the Chief minister said, "Age will not be a barrier. Those who lost their jobs will be allowed to sit for the exam even if they have crossed the usual age limit. They will also receive the benefit of their experience.

Earlier on Monday, a group of six representatives from the dismissed candidates met with the state education secretary. They placed a clear demand that eligible teachers be rein-

stated in their posts without being forced to undergo fresh examinations. The delegation also requested that the state government take full responsibility for safeguarding their futures. The state's top leadership, it appears, has been under considerable pressure to act decisively. Responding to the matter, Mamata Banerjee stated, "If I do not follow the court's order, these dismissed teachers may land in even greater trouble. We shall try our best within legal boundaries. I have to proceed by the law." She added that teachers who had already been employed should continue working (till December 31,as per the Supreme Court order) and those above the age limit of 40 would still be eligible to take the fresh exam,

"Some individuals caused the cancellation of the entire panel for personal gain, and now they are trying to show sympathy. As per the Supreme Court's order, candidates should take the exam and simultane-

In a significant development. Mamata Banerjee announced that the notification for the fresh teacher recruitment examination would be issued on May 30, a day prior to the expiry of the deadline on May 31. She also revealed that nearly 11,000 new vacancies have been created for Class IX-X teachers, along with additional positions in Group C and Group O categories totalling about

Importantly, she offered alternative employment options for those whose appointments had been cancelled. "Those asked to return money or barred from the exam can apply to other departments. The education department needs personnel for bell-ringing, cleaning, and other support roles. We will offer them three to four departmental options, and this will be notified separately within the next few days," Mamata Banerjee said. Stressing the state's

Tourism in Kashmir has been hit after the April 22 Pahalgam attack that left 26 people dead, he said during a visit at the picturesque Pahalgam on Tuesday.

"By all counts the atmosphere of fear in Kashmir has significantly reduced ", Farook Abdullah said and urged the visitors from outside Kashmir to come to the valley once again like before to enjoy its beauty and hospitality.. "What happened here last month was very sad, it should not have happened. People were coming here happily. People were busy with their work, they were not asking for government jobs. The situation was such in Pahalgam that there were no rooms available here," Abdullah said here. The NC chief visited the tourist resort and played golf at the Pahalgam Golf Course along with some friends. He said while the attack created an atmosphere of fear and uncertainty, the government has taken some steps to improve the security situation in the valley. "There was an atmosphere for fear, but I feel now the atmosphere of fear has reduced to a large extent.

MI News Service, Jammu : A massive landslide blocked the Jammu-Kishtwar national highway near Kandani, leaving hundreds of commuters stranded, officials said on

The landslide blocked the highway late in the afteronn on Tuesday near slide-prone Phagumar in Kishtwar dis-

They said the road clearance operation was immediately launched by the Border Roads Orgasnisations other agencies and efforts are being made to make the highway traffic worthy as soon as possible as this massive pile of huge stones has entirely blocked the Jammu-Kishtwar national highway leaving hundreds of commuters stranded on both sides, official sources

informed on Tuesday.

They said given the size of the landslide, the restoration work would take some more time is likely to be completed by Tuesday or Wednesday, the officials said, advising commuters to avoid travel on the highway for the time being though the road clearance operation have been taken up or war footing.

Hundreds of vehicles were left stranded on the strategic 250-kilometre highway — the only all-weather road linking Kashmir with the rest of the country

We are faced with a challenging situation due to massive deposits of muck on the highway at more than a dozen places, especially on the fourkilometre stretch between Seri and Maroog. The height of the sludge at some places is more than 20 feet," National Highways Authority of India (NHAI) project director Purshottam Kumar said. Sone of the agency's major machinery, including earth movers, are buried under the debris, he claimed. "Despite limited available resources of our own, we have arranged machinery from private contractors and deployed those to speed up the restoration work," he said, expressing satisfaction at the improved weather condition after two days of heavy rain. The highway has also suffered major

destinations.

"The road is destroyed at a number of places. The situation is very bad," Rajasthan native Devi Lal, who is heading home from the Magam area of central Kashmir's Budgam district, said

Accompanied by other members of his community, including women and children, Lal said they were walking to the problematic stretches before boarding a bus to Jammu.

Jamna, who was carrying a minor child on her shoulders, said stones and boulders were still coming down the hills overlooking the highway and added that the situation was frightening. "We have not taken meals for the past two days," she said as the group made their way to Udhampur.

Terrorism is Pak's war strategy, says PM Modi



MI News Service, Gandhinagar: Prime Minister Narendra Modi stated here on Tuesday that terrorism practiced by Pakistan is not a proxy war but a deliberate war strategy and India will respond accord-

Pakistan is engaging in a war through terrorism, Modi said, while speaking about Operation Sindoor at an urban development programme of Gujarat Government here this afternoon..

"We can't call this a proxy war as those who were killed on May 6 night in Indian strikes on terror camps in Pakistan, were given state honours in Pakistan. Pakistani flags were draped over their coffins, and their military saluted them," Modi said.

"This proves that these terrorist activities are not just a proxy war but a deliberate war strategy on their part. If they engage in war, then the response will be accordingly," he said. Modi said that whenever India and Pakistan went to war, Indian armed forces defeated Pakistan a way the neighbouring country would never for-

"Realising they could never win a direct war against India, they turned to proxy warfare, providing military training and support to terrorists in-

stead," he said. "No matter how strong or healthy the body is, even a single thorn can cause constant pain. We have decided that the thorn must be removed. Modi said.

"During Partition, Maa Bharati was divided into two, and that very night, the first terror attack on Kashmir was launched by Mujahideen," he said.Pakistan then captured a part of Mother India with the help of terrorists, in the name of Mujahideen, he said.

"If these Mujahideen had been killed on that day and Sardar Patel's advice had been accepted, then this series of terror attacks that has been going on for the last 75 years would not have been seen," Modi said. He said the people of Pakistan should understand that their government and army are supporting terrorism and must come forward to end the menace.

'Operation Sindoor is not just a military action. It is an expression of our Indian values and spirit. Those who harbour terrorism could never have

Later addressing a gathering in Bhuj town in the Kutch district of Gujarat, which shares land as well as maritime borders with Pakistan. Earlier on Monday the Prime minister launched projects worth over 82,950 crore in Dahod, Bhuj, and Gandhinagar.

Terrorism is a way of making money for your (Pakistan) government and army. The people of Pakistan must come forward to end terrorism. Live a happy and peaceful life and have your meal. Otherwise, my bullet is there for you," the PM added.

He also marked the 11th anniversary of taking oath as PM. On May 26, 2014, Modi was sworn in as PM after the Bharatiya Janata Party swept to power in the general elections, ending three decades of coalition politics. In 2024, Modi took oath for the third time as PM on June 9.

"On this day in 2014, I took oath as PM for the first time. The people of Gujarat placed their faith in me first, and then the entire nation joined hands. Since then, I have carried that responsibility with full dedication. We have taken decisions that were once unimaginable and unprecedented... today, India stands transformed, moving forward boldly in every sector," Modi said

"Today, 140 crore Indians are working hard to make our country a developed country. Whatever is needed for the progress of the country, we should make it in India itself, this is the demand of today's time. India is rapidly advancing in the world of manufacturing today... Today we are exporting many goods from smartphones to cars, toys, military weapons, medicines... Not only this, today India makes railways, metros and the technology required for it.", he asserted.

India's fight against terrorism will continue, says Ravi Shankar Prasad in France

Delhi: BJP MP Ravi Shankar Prasad exhorted members of the Indian community in France to make every effort to showcase Brand India as a beacon of peace that is fighting against the global curse of terrorism.

Addressing a gathering of community leaders and prominent members of the Indian diaspora in Paris on Monday evening, the allparty delegation led by Prasad conveyed the message that the terrorist attack in Pahalgam last month was a deliberate attempt to undermine peace and development in the Union Territory of Jammu and Kashmir.

India's response with Operation Sindoor was "pre-

MI News Service, Paris / New cise, targeted, proportionate and non-escalatory" and targeted at Pakistan-backed terrorist camps.

"When I see the growth of India, I am very proud of all of you because you are the brand ambassadors (of the country)," said Prasad.

"Please properly showcase Brand India, that we are for peace, we are for amity. But if innocent Indians are killed by terrorists, they will have to pay a cost. That is the winning Operation Sindoor," he said.

The former Union minister reiterated the central message of the delegation that any act of terrorism will be viewed as a war, "because in Pakistan, terrorism and the government estab-



lishment are together".

'And if a question is asked of you (diaspora) that the Prime Minister (Narendra Modi) had said this is not the era of war - then it is also not the era of terrorism.

Terrorism is a global curse, a global cancer, killing civilized society," he added.

Bankura: Alarming visuals from Sonamukhi Rural Hospital in Bankura district have gone viral once again, exposing the severely deteriorated infrastructure of one of the region's key healthcare facilities. After heavy rainfall on Monday, a local resident recorded and shared a video on social media showing waterlogged hospital premises, medicine boxes floating in dirty water, and patients and their attendants forced to sit on benches with their legs raised to avoid the

The viral footage has reignited concerns about the hospital's condition, especially as it comes less than a year after a disturbing image of a dog dragging a newborn by the mouth within the hospital premises triggered public outrage. Silent AI Revolution: Bengal emerges as 'data center powerhouse'

MI News Service, Kolkata: In a significant yet quiet revolution, West Bengal has made substantial strides in establishing itself as a prominent hub for Artificial Intelligence (AI)-driven data centers. While the state may have entered the race later than others, it has quickly gained mo-mentum, surpassing many in both infrastructure and ambition. This year alone, at least five operational data centers have been launched in and around Kolkata, albeit without major publicity.

The epicenter of this digital surge is New Town's Silicon Valley Hub, where a 40-acre mega campus is under development by Reliance Jio in collaboration with Microsoft. This stateof-the-art AI-regulated data center, as announced by Reliance Industries Chairman MukeshAmbani, is slated to be operational by 2026. Work is progressing rapidly to meet the deadline.

Apart from Reliance, other giants such as Airtel's Nxtra Data Center, LTI

Mindtree, STT, and NTT have made strong inroads. Notably, NTT (Nippon Telegraph and Telephone) has already inaugurated its 600,000 sqft facility in Action Area II of New Town. Adani Enterprises is also constructing a massive 525,000 sqft data center, nearing completion.

In North Bengal, Chief Minister Mamata Banerjee recently inaugurated a center at Webel IT Park in Siliguri, while significant projects are also underway in Uluberia, Uttarpara, and Haldia. The STT Kolkata DC-1 at Ultadanga and a second center in New Town further underscore the state's momen-

Hiranandani Group, Universal Success Enterprises, Techno Electric & Engineering, and CtrlS are investing in large-scale facilities, signaling robust private sector confidence. Altogether, these ventures are projected to generate employment for 30,000 to 40,000 individuals across the

Data centers, which house extensive servers and internet connectivity to manage and store information securely, demand stable electricity and protection from natural disasters. West Bengal's reliable power infrastructure has been instrumental in attracting such investments.

Experts note that skilled Bengali professionals working in cities like Bengaluru or Gurugram can now be retained instate at comparatively lower costs. With increasing demand for cybersecurity and AI expertise, Bengal's intellectual capital is proving vital.

This quiet revolution heralds a promising digital future for the state-making Bengal a new powerhouse in India's AI and data landscape.

Fresh bomb threat shocks Swasthya **Bhawan for 2nd consecutive day**

A moment of warmth and camaraderie-West Bengal Chief Minister Mamata Banerjee visited a private hospital to extend heartfelt wishes to RJD leader Tejashwi Yadav, his wife Ra-

jshree, and proud grandparents Lalu Prasad Yadav and Rabri Devi, celebrating the arrival of Tejashwi's son, in Kolkata on Tuesday.

MI News Service, Kolkata: Kolkata's SwasthyaBhavan, the nerve centre of the state's health department, was rocked by yet another bomb threat on Tuesday—just a day after a similar email had caused panic. The anonymous threat, delivered via email, claimed that four RDX explosives had been planted and would detonate by 5 PM. The alarming message triggered immediate security measures, with bomb squads and cyber specialists promptly deployed to the site.

While authorities remain tight-lipped, police sources confirmed that the latest email originated from a different address than Monday's, raising concerns about whether a coordinated cyber campaign is underway or if it is an act of mischief. As a precaution, the entire premises were cordoned off, and exhaustive searches were initiated both inside and around the SwasthyaBhavan indicated that the contents of the threatening email were explicit and designed to incite panic. Although early investigations suggest it may be a hoax, law enforcement agencies are treating the matter with utmost seriousness. Cybersecurity teams are examining the email headers and IP addresses to trace the origin of the threat.

The pattern has raised suspicions about possible foreign involvement, par-

ticularly given recent attempts by Pakistan and China to infiltrate Indian cyber infrastructure. Intelligence officials are exploring whether the email could be linked to those hostile cyber activities. Although no conclusive evidence of foreign hand has been found yet, the police have not ruled out the possibility. Officials also noted that such threaten-

ing emails could be the work of local miscreants aiming to create public disturbance or discredit law enforcement agencies. "It might be a deliberate ploy to harass the police or cause disruption in administrative functioning," one senior official suggested.

This second consecutive bomb scare has unsettled employees and disrupted operations at SwasthvaBhavan, Authorities are now considering tightening digital security protocols and implementing additional screening of email communicareceived by departments.

As of now, no explosive materials have been discovered. However, a comprehensive investigation is ongoing, involving bomb detection units, cybercrime specialists, and state intelligence officials. Whether the threat is a prank, a politically motivated act, or part of a larger cyber sabotage campaign, only time and foren-

Kolkata: In preparation for the high-stakes Kaliaganj Assembly by-election in West Bengal, the

State Election Commission has sought the deployment of 20 companies of Central Armed Police Forces (CAPF). The move aims to ensure a peaceful and free electoral process on June 19, when by-elections will simultaneously

Adding further administrative weight to the process, the ECI has appointed senior observer ShashankOjha for the West Bengal by-election. He is expected to arrive later this week to supervise preparations and oversee the implementation of polling protocols.

According to the final electoral roll, Kaliaganj has a total of 2,52,670 registered voters, comprising 1,30,363 male voters, 1,22,303 female voters, four third-gender voters, and 2,382 specially-abled electors.

Counting of votes is scheduled for June 23, and the outcome is expected to be a key indicator of the political temperature in Bengal ahead of future elections.

Man falls to death from ninth floor

MI News Service, Kolkata: A shocking incident unfolded on Tuesday morning in Kolkata's Beleghata area, sending shockwaves across the community. An unidentified elderly man, believed to be around 70 years old, tragically fell to his death from the ninth floor of a multi-storied building that houses the state's Sales Tax department. The incident has raised serious concerns and panic among office staff and residents, prompting an intensive investigation by the Kolkata Police.

The episode occurred around 10 a.m. at the Beleghata Sales Tax Building, just as employees were beginning to arrive for work. According to security personnel on duty, a loud thud startled the vicinity. Upon rushing to the source of the sound, they found a bloodied man lying motionless in the premises. Police from the Entally Police Station were immediately alerted. Responding promptly, law enforcement officers arrived at the scene, recovered the body, and transported it to the NRS Medical College and Hospital, where doctors pronounced the man dead.

While the identity of the deceased remains unknown, preliminary inquiries have revealed that the man entered the premises earlier that morning, allegedly claiming to be a lawyer and stating he had business in the building. This revelation has added a layer of mystery to the unfolding investigation. Authorities are now probing whether he was genuinely a legal professional or had assumed a false identity.

The primary question haunting investigators remains—was this a tragic accident, or did the man jump intentionally, indicating suicide? A post-mortem examination has been ordered to establish the exact cause of death. The results are expected to provide clarity on whether foul play was involved or if it was indeed a case of suicide.

Meanwhile, the entire area surrounding the Sales Tax office has been cordoned off, with police presence maintaining order. The incident has left employees and visitors rattled, many expressing unease over the security of the premises

Investigators are actively working to determine the man's identity and establish contact with his family. The unsettling event has left Beleghata tense and silent, awaiting answers. Until then, speculation continues to swirl as police dig deeper into this tragic fall from the ninth floor.

Cyclone 'Shakti' intensifies: Bengal's coastal districts on high alert

MI News Service, Kolkata: Cyclone 'Shakti' has begun intensifying over the Bay of Bengal, confirming early forecasts issued by the Alipore Meteorological Department. By noon on Tuesday, ominous dark clouds had engulfed the sky across large parts of coastal Bengal, with conditions resembling dusk well before evening. The strengthening storm has triggered grow ing concern across the state's shoreline com-

IREDA files bankruptcy case against Gensol

MI News Service, New Delhi: The Indian Renewable Energy Development Agency (IREDA) said it has filed a bankruptcy application against beleaguered Gensol Engineering before the National Company Law Tribunal.

According to a regulatory filing, Ireda has filed an application on May 14, 2025, under Section 7 of the Insolvency and Bankruptcy Code, 2016 against Gensol Engineering Limited, a listed company bearing an amount of default of around ₹510 crore. Last month, in an interim order, Sebi barred Gensol Engineering and promoters — Anmol Singh Jaggi and Puneet Singh Jaggi — from the securities markets till further orders in a fund diversion and governance lapses case. On May 12, Jaggi brothers resigned from the company following market regulator Sebi's interim order, according to an exchange filing. Anmol Singh Jaggi held the post of managing director while Puneet Singh Jaggi was a whole-time director.

Meanwhile, Gensol Engineering on Wednesday said the Securities Appellate Tribunal (SAT) disposed of its appeal but allowed the company to file its response on Sebi's interim order to bar the firm and its promoters from the securities market. In a regulatory filing, the company said the appeal filed by it before SAT has been disposed of, granting it an opportunity to file its response to Sebi's interim order within two weeks. It further informed that the markets regulator has been given directions to hear the company within two weeks thereafter and pass an appropriate order within four weeks. The tribunal has given no observations on Sebi's interim order, it stated. In its order on April 15, 2025, Sebi also debarred Jaggi brothers from holding the position of a director or key managerial personnel in Gensol until further orders.

Alarm Chain pulling without reason: Irresponsible actions that cause train delays and passenger hardship

2196 numbers Alarm Chain Pulling cases recorded from April 2024 MI News Service, Kolkata:

Eastern Railway has once

again raised concern over

the increasing instances of Alarm Chain Pulling (ACP) without valid reasons, which continues to be a significant cause of avoidable train delays and inconvenience to passengers. Despite repeated awareness campaigns and strict enforcement, misuse of this emergency mechanism remains a pressing issue. Alarm Chain Pulling is intended to be used only in genuine emergencies, such as serious health issues or safety-related incidents. However, it has been observed that in many cases, passengers resort to ACP for frivolous reasons—such as waiting for a relative who has not yet arrived at the station or attempting to deboard at a non-scheduled stoppage. Such irresponsible behaviour by a few disrupts the journey of many.

During the financial year 2024-25, a total of 1,882 ACP cases were registered across Eastern Railway. In the current financial year (from April 1 to May 25, 2025), 314 cases have already been recorded, indicating a continued trend of misuse. Furthermore, between January 1 and March 10, 2025, 872 ACP cases were registered—highlighting the growing scale of the

issue. As a result of these ACP incidents, 785 Mail/Express trains and 105 Passenger trains punctuality in financial year 2024–25. In the current financial year during the period from April 1 to May 25, 2025, 114 Mail/Express trains and 14 Passenger trains have already been delaved due to unwarranted AČP. These delays not only impact the travel experience of thousands of passengers but also disrupt the overall transportation of essential goods. In many cases, passengers miss critical appointments, job interviews, or competitive exams due to such avoidable interruptions. Eastern Railway urges all passengers to act responsibly and use the ACP mechanism only during genuine emergencies. Any misuse is punishable under the Indian Railways Act, and Eastern Railway, in coordination with the Railway Protection Force (RPF), is taking strict action against offenders. Passengers are also encouraged to dissuade others from engaging in such acts and to report any such incident immediately. Community awareness and cooperation are essential to curb this menace. Eastern Railway remains committed to ensuring smooth and punctual train operations and seeks the active support of the public to maintain efficiency and safety in the rail-

Study reveals key protein that helps prevent excessive bone loss in osteoporosis

Tokyo: Osteoporosis, a disorder characterised by porous and weak bones, is a major hazard to skeletal health. As the foundation of the human body, bones provide critical structural support. When bone mass decreases, it not only weakens this support but also lowers general function, resulting in a lower quality of life.

With an ageing population and a rise in osteoporosis cases, the burden on healthcare resources for long-term care is clear. As a result, there is a need to understand the mechanisms that cause osteoporosis and develop effective targeted therapeutics to mitigate its long-term effects.

Osteoblasts and osteoclasts are two types of cells that play critical roles in bone tissue maintenance and remodelling. Osteoblasts are bone-forming cells that synthesise and deposit new bone tissue, whereas osteoclasts break down and remove old or damaged bone tissue. Increased proportion of osteoclasts causes bone mass loss in situations such as osteoporosis, rheumatoid arthritis (joint inflammation), and bone metas-

tases (cancer that has spread to the bones). Osteoclasts develop from the development of macrophages or monocytes, two types of immune cells. Suppressing osteoclast differentiation could thus be used as a therapeutic technique to prevent bone loss. However, the precise molecular pathways driving the complicated process of bone remodelling are unknown.

In a new groundbreaking study, Professor TadayoshiHayata, Mr. Takuto Konno, and Ms. HitomiMurachi from Tokyo University of Science, along with their co-workers, delved deeper into the molecular regulation of osteoclast differentiation. Receptor activator of nuclear factor kappa B ligand (RANKL) stimulation induces the differentiation of macrophages into osteoclasts. Further, bone morphogenetic protein (BMP) and transforming growth factor (TGF)-b signaling pathways have been implicated in the regulation of RANKL-mediated osteoclast differentiation. In the current study, the researchers sought to investigate the role of Ctdnep1 - a phosphatase (an enzyme that removes phosphate



groups) that has been reported to suppress BMP and TGF-b signaling.

Giving further insight into their work set to be published on July 30, 2024, in Volume 719 of Biochemical and Biophysical Research Communications, Prof. Hayata states, "RANKL functions as an 'accelerator' for osteoclast cell differentiation. Driving a car requires not only the accelerator but also the brakes. Here, we find that Ctdnep1 functions as a 'brake' on osteoclast cell differentiation."

First, the researchers examined the

expression of Ctdnep1 in mouse-derived macrophages treated with RANKL and untreated control cells. They noted that Ctdnep1 expression remained unchanged in response to RANKL stimulation. However, it localized in the cytoplasm in granular form in the macrophages and differentiated into osteoclasts, distinct from its normal perinuclear localization in other cell types, indicating its cytoplasmic function in osteoclast differentiation.

Further, Ctdnep1 knockdown (down-regulation of gene expression) resulted in an increase in tartrate-resistant acid phosphatase-positive (TRAP) osteoclasts; wherein TRAP is a marker for differentiated osteoclasts. Additionally, Ctdnep1 knockdown led to an increase in the expression of crucial differentiation markers including 'Nfatc1', a RANKL-induced master transcription factor for osteoclast differentiation. These results support the 'brake function' of Ctdnep1, whereby, it negatively regulates osteoclast differentiation.

Moreover, Ctdnep1 knockdown also led to increased absorption of calcium

phosphate, suggestive of the suppressive role of Ctdnep1 in bone resorption. Lastly, while, Ctdnep1 knockdown did not alter BMP and TGF-b signaling, cells deficient in Ctdnep1 showed elevated levels of phosphorylated (activated) proteins downstream of the RANKL signaling pathway. These findings suggest that the suppressive effect of Ctdnep1 in osteoclast differentiation may not be mediated by BMP and TGF-b signaling, but, through the negative regulation of RANKL signaling and Nfatc1 protein levels

Overall, these findings provide novel insights into the process of osteoclast differentiation and reveal potential therapeutic targets which can be pursued to develop treatments that address bone loss due to excessive osteoclast activity. In addition to diseases characterized by bone loss, Ctdnep1 has also been reported as a causative factor in medulloblastoma - a childhood brain tumor. The authors are, therefore, optimistic that their research can be extended to other human diseases beyond bone metabolism

Researchers find how better sleep is linked to lower levels of loneliness

WASHINGTON: A recent study discovered that greater sleep health was linked to lower levels of loneliness, with the association being stronger among younger persons.

The findings of the study were presented at the SLEEP 2024 annual meeting. The findings show that higher sleep health is related with significantly lower total loneliness, emotional loneliness, and social loneliness.

Better sleep health was associated with lower total and associated

Better sleep health was associated with lower total and emotional loneliness across all ages, however this association was higher in younger persons. However, age did not influence the relationship between sleep health and social loneliness.

"Loneliness is an urgent public health crisis, and there is a

pressing need for providers to better understand and treat it," said lead author and principal investigator Joseph Dzierzewski, who has a doctorate in clinical psychology and is vice president of research at the National Sleep Foundation in Washington, D.C. "Our results highlight the important role that sleep plays in understanding loneliness across the adult lifespan. Perhaps efforts to improve sleep health could have a beneficial effect on loneliness, especially for young people." According to the

American Academy of Sleep Medicine, sleep is essential to health. The AASM and the Sleep Research Society recommend that adults should sleep seven hours per night on a regular basis to promote optimal health, productivity and daytime alertness. The study involved 2,297 adults with a mean age of 44

years; 51 per cent were male. Participants completed an online sleep health questionnaire and loneliness scale. The researchers analyzed the results using correlation and linear regression analyses along with moderation analyses.

In 2023 an advisory from the

U.S. surgeon general warned about a public health crisis of loneliness, isolation, and lack of connection. It noted that even before the onset of the COVID-19 pandemic, approximately half of U.S. adults reported experiencing measurable levels of loneliness.

According to the authors, efforts and programs that aim to reduce loneliness should include an emphasis on promoting sleep health, especially in younger adults.

"Why younger adults might experience more sleep-related benefits to loneliness than older adults is unknown and intriguing -- certainly worth further investigation." Dzierzewski said.

Study finds body temperature is linked to depression



WASHINGTON: A study from UC San Francisco revealed that individuals with depression may benefit from lowering their body temperatures, as they tend to be higher. The study, published in Scientific Reports, does not clarify whether depression causes increased body temperature or vice versa. have a higher body temperature due to impaired self-cooling, increased heat output from etabolic processes, or a com-Researchers analyzed data from more than 20,000 international participants who wore a device that measures body temperature and also self-reported their body temperatures and depression symptoms daily. The seven-month study began in early 2020 and included data from 106 countries. The results showed that with each increasing level of depression symptom severity, participants had higher body temperatures. The body temperature data also showed a trend toward higher depression scores in people whose temperatures had less fluctuation throughout a 24hour period, but this finding didn't reach significance. The

novel depression treatment method might work, said Ashley Mason, PhD, the study's lead author and associate professor of psychiatry at UCSF Weill Institute for Neurosciences. A small body of existing, causal studies has

Neurosciences. A small body of existing, causal studies has found that using hot tubs or saunas can reduce depression, possibly by triggering the body to self-cool, for example, through sweating.

"Ironically, heating people

up actually can lead to rebound body temperature lowering that lasts longer than simply cooling people down directly, as through an ice bath, said Mason, who is also a clinical psychologist at the UCSF Osher Center for Integrative Health.

"What if we can track the body temperature of people with depression to time heatbased treatments well?"

"To our knowledge, this is the largest study to date to examine the association between body temperature assessed using both self-report methods and wearable sensors - and depressive symptoms in a geographically broad sample," added Mason.

Hotter weather due to climate change could lead to more mosquitos: Study

VIRGINIA [US]: A recent study conducted by Virginia Commonwealth University scientists found that a warmer environment may result in more mosquitos as predators struggle to maintain their number.

As the cover feature in Ecology, a journal published by the Ecological Society of America, the study -- "Warming and Top-Down Control of Stage-Structured Prey: Linking Theory to Patterns in Natural Systems" -- found that rising temperatures, often linked to climate change, can make predators of mosquito larvae less effective at controlling mosquito populations.

Warmer temperatures accelerate the development time of larvae, leading to a smaller window of time for dragonflies could eat them.

This means there could be nearly twice as many mosquito larvae that make it to adulthood in the study area. The researchers looked at riverine rock pools at Belle Isle along the James River in Richmond and found that warmer temperature pools had more aquatic mosquito larvae, even when their predators that naturally control the populations were present. The native rock pool mosquito is not an important disease vector, but it is one of



the few local mosquitos that doesn't have to feed as an adult to lay eggs. So the findings might apply to similar taxa, like the invasive Asian rock pool mosquito.

"We might see larger populations of everyone's least favorite bug, mosquitos. While the mosquito larvae we studied here [are] the North American rock pool mosquito, these findings likely apply to species of mosquito that do act as vectors for diseases like West Nile or even Zika virus," said Andrew T Davidson, PhD, lead researcher on the study. He conducted the research through the PhD program in VCU's Center for Integrative Life Sciences Education. Predators help stabilize ecosystems and food webs, and the study looked at predator-prey interaction between dragonfly nymphs and mosquito larvae. Before fieldwork, the research was rooted in concepts of thermal physiology and short-term lab experiments that yielded predictive models of the relationship between predators, prey and temperature in the field. The field study then tested the models in a completely natural environment.

The study builds on Davidson's earlier research in Functional Ecology as well as work by lab mate C. Ryland Stunkle and the rest of the VCU rock pool team. The team also acknowledges the collaborative support of professor Brian Byrd of Western Carolina University's College of Health and Human Sciences. The recent work led by Davidson was part of a larger National Science Foundation grant that has involved scientists from VCU, the University of Richmond, Radford University, Western Carolina University and Eastern Carolina University. The collaborative award of nearly USD 1 million has included nearly USD 400,000 for VCU.

Adjuvants, pesticides disrupt honey bee's sense of smell: Study

WASHINGTON: Pesticide sprays have long been recognised as a threat to honey bees. In a new study, researchers uncovered the influence of such sprays on bees' sense of smell, which could disrupt their social signalling.

Honey bees live in dynamic communities and constantly communicate with each other using chemicals that serve as social cues. For example, nurse beeswho are responsible for taking care of larvae that ultimately become queens and worker beesconstantly monitor the larvae in the dark using pheromones.

The larvae emit brood pheromones to indicate that they need food. There are also alarm pheromones that workers produce to warn the other bees of danger. If these cues are dampened or not perceived properly, the colony may fail to thrive.

Since 2007, scientists have known that honey bees have been in trouble. One of the stressors that have raised concerns is insecticides, which affect honey bee health. Because these are usually used in combination with other chemicals, the resulting mixture can become unexpected-

ly toxic to bees. "For many years, it was assumed that fungicides do not have an adverse impact on insects because they are designed for fungal targets," said May Berenbaum (GEGC/IGOH), a professor of entomology.

"Surprisingly, in addition to insecticides, fungicides also have an adverse effect on bees and combining the two can disrupt colony function."

For more than a decade, reports originating from almond orchards, where two-thirds of the US honey bees are transported every year when the flowers are in bloom, implicated pesticide spray mixtures. In particular, the problem lies in the use of supposedly inactive chemicals called adjuvants, which increase the "stickiness" of the insecticide so it stays on the plants.

Because adjuvants have long been considered to be biologically benign, they are not subject to the same level of safety testing as other insecticidal agents.

"Recently, researchers have shown that adjuvants alone or when used in combination with fungicides and insecticides are toxic to bees," Berenbaum said.



Nurse bees are especially vulnerable to these combinations.

"The health of the queens is paramount," Berenbaum said. "If

healthy queens are not produced, the colony can suffer." To understand how combinations affect nurse bees, the researchers tested their effect on the olfactory system of honey bees using the adjuvant Dyne-Amic, the fungicide Tilt, and the insecticide

Altacor.

The researchers divided bees into four groups of ten bees and for a week exposed them to either untreated commercial pollen or to pollen that had been treated with either Dyne-Amic, or Tilt and Altacor, or all three together.

The bees were then anesthetized on ice and one antenna was carefully removed from each bee. The researchers then exposed the antenna to chemical mimics of brood and alarm pheromones and recorded the antenna's response using a technique called electroantennogra-

With this method, Ling-Hsiu Liao, a research scientist, and Wen-Yen Wu, a graduate student, in the Berenbaum lab, found that when nurse bees had consumed pollen contaminated by the three chemicals, their antennal responses to some brood pheromones and alarm

pheromones were altered.

Their finding suggests that these commonly-used pesticides can interfere with honey bee communication.

How these chemicals interact and influence the bees is still unclear. "There are many possible explanations for how consuming these chemicals can affect the sensory responses of bees," Liao said. "The antenna detects and triggers the response to olfactory signals. In this study we did not look at what other changes are triggered, particularly changes in behavior."

In addition to parsing out the underlying molecular pathways that are affected, the researchers are also interested in testing other mixtures of commonly used pesticides as well as looking at the response of bees in other populations. They hope that their work can help beekeepers rethink how they manage and protect their colonies.

The study "Effects of pesticide-adjuvant combinations used in almond orchards on olfactory responses to social signals in honey bees (Apismellifera)" was published in Scientific Reports.





Fresh wave of alleged extrajudicial killings sparks outcry in Balochistan

MI News Service, Barkhan: In continuation of alleged extrajudicial killings in Balochistan, three previously missing persons were killed in what is being widely condemned as a staged encounter by the Counter Terrorism Department (CTD) in Barkhan. In a separate incident, another youth was found dead under suspicious circumstances in Awaran district after reportedly being summoned by security

As per The Balochistan Post, early Monday morning, the CTD claimed to have conducted an operation in Tang Kirvar area of Barkhan district. The bodies of Abdul RehmanBuzdar, Fareed Buzdar, and Sultan Marri were

Health Unit (BHU) hospital in Rakni. All three had reportedly been victims of enforced disappearance for several months. A CTD spokesperson stated that the operation involved an exchange of fire with militants, resulting in fatalities and the recovery of weapons. However, families of the deceased and Baloch rights activists rejected the official narrative, asserting that the encounter was fake and the men were executed after prolonged illegal detention. In a related development, in Awaran's Kolwah tehsil, the body of a young man, Ghaus Bakhsh, was discovered hours after he was reportedly summoned to a local military

camp. His body bore signs of torture further fueling claims of custodial death. Human rights groups allege that such incidents reflect a deepening pattern of state-led violence in Balochistan. Similar cases in Dukki, Ziarat, and Quetta have been reported in recent months, where previously disappeared individuals were later killed in disputed operations. Baloch activists argue that the growing number of such cases underscores a systematic campaign of enforced disappearances and extrajudicial killings, demanding independent investigations international attention to end im-

"Sooner elections are held in Bangladesh, the better," says adviser to former PM Khaleda Zia

MI News Service, Dhaka: An adviser to former Prime Minister and BNP Chairperson Khaleda Zia said the sooner elections are held in Bangladesh, the better. The adviser also noted that the Army Chief has expressed concern about holding elections by December, as troops currently deployed for civilian and policing duties would prefer to return to their barracks. "No clear roadmap concerning when the election will be scheduled has been given. You know that the people of this country, for the last 16 years, have not had the scope to vote freely. The expectations of the people are very high. Today, those who are 35-36 years old have never voted in their lifetime. There is a big expectation that people must have the right to vote. I think the sooner, the better." Retired Major General FazleElahi Akbar, Defence and Security Adviser to the Former Prime Minister Khaleda Zia, said.

"I see the election is imminent. It is a matter of time, and people are expecting that there should be an election and there should be a party elected by the people who take into hand the problem that the country is facing," he told ANI in an interview The Army Chief and the three defence forces Chiefs of Bangladesh attended the inauguration of Akbar's Think Tank, Foundation for Strategic and Development Studies (FSDS). in a rare ceremony. He does not consider Army Chief General Waqar-uz-Zaman's recent speech on Army Officers Address, expecting elections by December, as a power struggle with the interim government "I think to say there is a power struggle is a little too much. After all, it's a government, the Army is an important institution, and the interim government is equally very important and very crucial. Army chief, I think the reason for his saying is that, after all, his troops are on the streets. No army in the world would like to do a job that is exclusively civil and policing in nature. In such a situation, the army chief has

raised his voice concerning

the integrity and standard of discipline to preserve the discipline and the professional competence of the military. He would like his troops to get back into the barracks and go back to business as usual," Akbar

Whether the election will be credible without the participation of the Awami League is a burning question that people have been discussing. However, Akbar believes that the Awami League is not in a position to participate in the vote. "Is Awami League pre-

pared to come and face the public and campaign for the election? I think this is an objective or the vision, the proposal is unattainable. Awami League is not in a position right now, even if the election is held within the next year or so. It is a utopic idea. It is better to let the Awami League rest and face the judiciary," Akbar, the Chairman of FSDS, said. He said that overthrowing Sheikh Hasina's government was not the sole achievement of the students and that they would not be able to form a people's political party, keeping their representatives in the government. "The political parties in the last 16 years fought the battle and created the ground. But certainly it is the students who ultimately show up at the final. They share courage, share unity, and share spirit that brought the Hasina regime down. So I have full respect for them," Akbar said. "But I would like to caution them, don't form a king's party by means with the support of the government. Historically, in Bangladesh, no king's party has survived. They must be very careful whether to form a king's party or the party of the people. The present demand is that the people who are in the cabinet and also part of the new party should not,' he added. When asked whether Bangladesh's economy has weakened since the removal of Sheikh Hasina as Prime Minister, Akbar said. "Statistically, the answer is yes. After all, the previous

Pakistan PM Shehbaz Sharif "ready to talk" with India, says: "We want to resolve all disputes"

The Pakistan PM said, "But if they accept my offer of peace, then we will show that we really want peace, seriously and sin-Sharif was in Iran on Monďay, after a visit to Turkiye. After Iran, he is scheduled to visit Tajikistan and Azerbaijan. Iranian state media IRNA reported that President MasoudPezeshkian has voiced Iran's support for a durable ceasefire between India and Pakistan, calling for dialogue between regional countries to resolve disputes and promote peace.

PBKS' unit has felt really different this year. The aura and legend of coach Ponting, proven top-class leadership of Shreyas Iyer and fearless batting by its Indian core and timely contributions by overseas talent have come together nicely to present the team as a team meant to be feared. Once considered by many a team that could give "two free points" to several fan favourite teams, a fixture against PBKS this year has been a boxoffice affair, which demands other teams work extremely hard and be at their absolute merciless with both bat and ball.


The result is, that fans have been treated to some great cricket, and Indian cricket has unearthed some stars that could serve them well in future. PBKS has been absolutely stunning as a batting unit this season, featuring seven batters who have scored at least 100 runs at an average of 30 or more and a strike rate of above 149.

Be it the fiery opening stands of breakout stars Privansh Arva and Prabhsimran Singh, the consistent and reassuring anchoring of skipper Shrevas Iver or timely blasts from the Australian stars, there is a lot to love about this

A look at PBKS's 'Stunning Seven':

-Shreyas Iyer: The 'Sarpanch Sahab' seems to have a Midas Touch which turns potential into absolute gold. In the course of these 14 league stage matches, PBKS appears to be as intimidating as a consistent championship-winning team. Iyer has been at its helm with the bat, top scoring with 514 runs at an average of 51.40, with a strike rate of 171.90 and five half-centuries. His best score is 97*. Iyer has been sensational away from home, having made 444 runs in nine innings with all five halfcenturies at an average of 88.80.

-Prabhsimran Singh: For four seasons, Prabhsimran struggled to break into the playing XI. For the next two years, his battle with inconsistency became a matter of frustration as he could not convert his promising starts



-Privansh Arva: The journey from Delhi to Punjab has been one to remember for this tidy left-hander. An unbelievable puller of the ball, Priyansh has been brilliant at the top along with Prabhsimran. He is the third-highest run-getter for the team with 424 runs in 14 matches at an average of 30.88, with a strike rate of 183.54. He scored a counter-attacking 39-ball ton against CSK and scored two halfcenturies, including a clean 62 against five-time champions Mumbai Indians (MI), which sealed the team's top spot finish. With a temperament for big games on display, the sight of Priyansh wearing Team India's blue colours would not be a surprising one. Headaches galore for Indian selectors already spoilt with options at the top.

-Nehal Wadhera: Another promising southpaw coming from Punjab, which has been producing some sensational T20 cricketers as of late. Having played some cameos for fivetime champions Mumbai Indians (MI), Wadhera has unlocked his true potential with PBKS. So far, he has made 298 runs in 12 innings at an average of 33.11 and a strike rate of 152.04, which includes two half-cen-Be it his calculated 33* in 19

balls against Royal Challengers Bengaluru (RCB) in a rain-hit match on a tough surface or his ruthless 37-ball 70 against Rajasthan Royals, the 24-yearold has produced some serious gems for PBKS this season.

-Shashank Singh: From an

'accidental buy' during the 2023 auction to a prized finisher with all the shots in his repertoire, Shashank has lived a dream with PBKS. Ramps, proper cricketing shots and a remarkably calm composure, the 33-year-old is everything one demands in the modern T20 landscape. In another stunning season so far, he has scored 284 runs at an average of 56.80 and a strike rate of 149.47, with two halfcenturies in 11 innings. His best knock, a thunderous 59* in 30 balls laced with five fours and three sixes, came against RR recently. -Josh Inglis: The Australian wicketkeeper-batter has enjoyed a great year so far. A century on Test debut, a century in the ICC Champions Trophy and now his first taste of IPL under the guidance of legendary Ponting and skipper Iyer. Having got some fine starts so far, the Aussie saved his best for the clash, on which hinged their hopes for a top-two finish. Possessing a bat swing that could send the ball into the orbit with the least amount of effort, Inglis made a quickfire 73 in 42 balls, with nine fours and three sixes, helping PBKS chase down 185. In seven innings, Inglis has made 197 runs at an average of 32.83 and a strike rate of 164.16, with a half-century and some important cameos. With PBKS guaranteed at least two matches, it is going to get better for him from here on. The 'Aussie' mentality could finally produce a season-best effort in the playoffs!

-Marcus Stoinis: The sea-soned Australian all-rounder brings to the franchise muchneeded firepower, experience and versatility. Whenever he has had a chance to bat, he has responded with just what his team wanted, scoring 126 runs in seven innings at an average of 31.50, strike rate of 193.85.

Real serious stuff starts now: Ponting lauds team's efforts as Punjab Kings gear up for knockouts after securing top-two spot in IPL

JAIPUR (RAJASTHAN)[INDIA] : After a wait of 11 years, Punjab Kings have secured a spot in the playoffs in the ongoing edition of the Indian Premier League (IPL). Further adding to their success, the side led by captain Shreyas Iyer managed to confirm a spot in the top two after a 7-wicket win over Punjab Kings at Sawai Mansingh Stadium, Jaipur on Monday

After electing to bowl, left-arm speedster Arshdeep Singh, Marco Jansen and Vijaykumar Vyshak picked up two wickets each to restrict the opposition to 184/7 in

Priyansh Arya (62 off 35 balls) and Josh Inglis (73 off 42 balls) scored half-centuries each to help

their side get the win in 18.3 overs with seven wickets to spare, as the Kings finished with 19 points in 14 games, guaranteeing themselves a spot in the top two.

Speaking after the match. Ricky Ponting praised the team for bouncing back after a loss to Delhi Capitals on Saturday, but also stressed the importance of the upcoming matches.

"Great team always find ways to respond and bounce back. Awesome result, great result for this group. We qualified 10-12 days ago. That was a big mile-stone for us. We talked about making sure of giving ourselves the best chance of finishing in the top two, and we have gone ahead and done that," Ponting said in the



dressing room.

"Awesome run chase, great win, really happy for all of you. But what you have done today has been outstanding. The real serious stuff starts now. Enjoy the moment for what it is. Lot of big

games are coming up," he further added

Meanwhile, Punjab batter Shashank Singh further highlighted how the players manifested the team's success and credited the management for their constant

support.
"It feels surreal and very satisficated this as a fying. We manifested this as a team. This year we will win the title. Our first aim was to finish top two. So, we passed the first hurdle. We believed, we manifested, and we worked hard. The credit goes to the management. Every single individual, including the players and the management. We had 4-5 camps before the IPL, and you can see the results, which is not easy in IPL," Shashank said at the post-match press conference.

Iyer further added that the team's mindset was always focused on the title. "Right from day one, our mindset was to go out there and win. We are not thinking about going through the playoffs. We are winning about winning the Championship," the Punjab skipper said.

"I personally feel everyone stepped up at the right time. We have been in that mindset that we have to win no matter what situation. Kudos to everyone and the management. Ricky has been fantastic, and for me, it was about gaining the trust of every individual. And that happened by winning matches, and I personally feel we need to maintain that relationship throughout," he signed

Williamson and Taylor played measured innings of 52* (89) and 47* (100), as Taylor's iconic whip through mid-wicket for four sparked emotional celebrations.
