Khatun, was tragically killed in an explosion during a Trinamool Congress (TMC) victory procession following the Kaliganj Assembly bypoll result. The incident occurred in Molandi, within the Krishnanagar police district, sparking a wave of political outrage and grief.

According to the police, the girl was wounded after being allegedly hit by a bomb that exploded on Monday afternoon at Barochandgar under Kaliganj police station limits.

Reacting swiftly and strongly, Chief Minister Mamata Banerjee expressed deep sorrow and condemned the violence in no uncertain terms. Taking to her official social media handle, the Chief Minister



wrote: "I am shocked and deeply saddened at the death of a young girl in an explosion at Barochandghar in Krishnanagar police district. My prayers and thoughts are with the family in their hour of grief. Police shall take strong and decisive legal action against the culprits at the earliest.

The Trinamool /Kolkata : The ruling Trinamool Congress in West Bengal has once again clinched the Kaliganj As-sembly seat defeating near-est rival BJP by a comfortable margin of over 50,000 votes on Monday, while AAP maintained a lead in both Ludhiana West seat in Punjab and in Gujarat's Visavadar constituency , as the Congress-led UDF has surged ahead of its rivals in Kerala's Nilambur, according to Election Commission

Congress was leading by over 50,438 votes in the by-election to the Kaliganj assembly seat in West Bengal's Nadia district after 23 rounds of counting on Monday. TMC candidate Alifa Ahamed secured 71,639 votes, while her nearest rival, BJP nominee Ashis Ghosh got 31,201. Congress candidate Kabil Uddin Shaikh, backed by the CPI(M), slipped to the third position with only 22,275 votes, election offi-

MI News Service, New Delhi : In a major development in the midst of a volatile situation in the Middle East, the Indian Army, through the emergency procurement route, has given orders, worth about Rs 137 crore, for porocuring hybrid mini unmanned aerial vehicles systems from well known Drone technology firm ideaForge Technology

Informing this corporate sources said on Monday that a key requirement during the assessment for the selection of unmanned aerial vehicles (UAV)and subsequent placement of order was that all critical sub-components must be sourced from non-border-sharing nations,

and that the platform be substantially indigenous in capability and design.

"ideaForge Technology has secured a significant win through the emergency procurement route. The order, valued at approximately Rs 137 crore, has been placed by the Indian Army for its highperformance hybrid Mini UAV systems, which are already battle-tested and inducted into the Army's inventory for ISR (Intelligence, Surveillance, and Reconnaissance) operations," the company said in a statement today. The company has its research and development and manufacturing units in Navi Mumbai, Bengaluru, Delhi, and the US.



#### Child killed in bomb blast during victory celebration

MI News Service, Nadia: What began as a day of celebration in Kaliganj swiftly turned into heartbreak when a bomb explosion took the life of a young girl shortly after by-election results were announced on Monday. The victim, Tamanna Khatun, a Class IV student, was standing outside her home in the Melendi area, holding her mother's hand, when the bomb exploded. Eyewitnesses claim the bomb was thrown during local victory celebrations and detonated near their house, fatally injuring the child.

Tamanna was rushed to a nearby medical facility, but doctors were unable to save her. Tearfully recounting the tragic moment, her mother said, "My daughter never leaves my side. We were just standing there when the blast happened. I woke up to find one side of my body burning... and my daughter lying lifeless." Local residents report that over 40 bombs were thrown during the celebrations, with some targeting homes of opposition supporters. Many

The remains have been sent for post-mortem examination, and a forensic and DNA analysis will be conducted to confirm the victim's identity. The case has been registered under multiple sections, and the accused are currently in police custody as further investigation continues. The incident has sent

## **West Bengal Council** revamps marking scheme for vocational subjects in HS classes

**MI News Service, Kolkata:** In a significant policy shift, the West Bengal Council of Higher Secondary Education has introduced a major overhaul in the evaluation structure for vocational subjects in Classes XI and XII. Under the revised system, vocational subjects will now be assessed through a 100-mark examination—split evenly between theory and practical components, with 50 marks allotted to each. This marks a departure from the earlier distribution, where practical exams carried 70 marks and theory just 30, signalling a move toward baltheoretical ancing understanding with hands-

on skills. However, the rollout of this change has sparked confusion and concern among both students and educators. Although the Council has formally announced the revision, the updated curriculum has not yet been released. Many students have yet to receive the requisite textbooks, leaving both learners and teachers uncertain about how to prepare for the new assessment structure.

Currently, 16 voca-tional subjects are offered at the higher secondary level, including Information Technology, Automo-Security, Retail, bile. Healthcare, Electronics, Apparel, Beauty and Well-ness, Plumbing, Construc-tion, Organised Retailing, and Tourism & Hospitality. Despite their growing relevance, these subjects continue to face structural neglect.

Questions have also arisen regarding the ra-tionale behind the sudden change. According to the Council, the shift aligns with Regulation 9(2) under the semester system, mandating that students must pass in five core subjects including Bengali, English, and three additional compulsory disciplines. However, marks obtained in vocational subjects, classified as optional, will not count under the 'best of five' rule-an exclusion that has ignited debate.

A section of students and educators argue that the Council's notification lacks clarity on whether vocational subjects are to be treated as optional or compulsory electives. Teacher associations have accused the Council of trivialising vocational education, pointing out that despite policy emphasis in both state and national education frameworks, adequate infrastructure is still

lacking in most schools. Notably, the Council had earlier announced in 2022 that vocational subjects would be available as electives starting from the 2023-25 academic session. Yet, in a surprising reversal in September 2023, it declared these subjects would remain strictly optional, deepening confusion.

Education experts stress the need for the government to adopt a clearer, more structured approach. Without a comprehensive policy and proper infrastructure, students risk being deprived of the true benefits of vocational education.

### Delhi to install gunshot sensors, smart cams to catch shooters

MI News Service, New Delhi: With several cases of gun violence in the national capital, Delhi Police is stepping up its response with a new tech-driven initiative involving advanced sensors and high-resolution cameras. These systems will instantly alert officers, help identify assailants and track getaway ve-hicles used to flee crime scenes.

Currently in its implementation stage, the project aims to enhance surveillance and rapid response across the city.

Sensors capable of detecting gunfire within a 500-metre to one-kilometre radius are being installed at strategic locations. Once a firing sound is detected, the sensors will trigger an alert to nearby PTZ (Pan-Tilt-Zoom) cameras, prompting them to rotate and focus precisely on the direction of the sound.

"These sensors will send an alert to the nearest PTZ camera, which will then swivel toward the suspected firing location. This will allow us to capture footage of the incident, the accused and the vehicle they use to escape," a senior police officer told.



## Study finds out link between nighttime heart rhythm, stroke

Bern [Switzerland] : New research has uncovered a powerful link between nighttime heart rhythm and future health conditions, even in people with no obvious sleep problems.

The study, conducted at the Department of Neurology, Inselspital, the University Hospital of Bern, examined 4,170 people over a 13-year peri-od and discovered that heart rate variability (HRV) during sleep can be a powerful early warning sign of future health conditions such as stroke, depression, and cognitive dysfunction. HRV reflects the fluctuation of time

intervals between heartbeats.2 HRV adjusts constantly in response to the physical and emotional demands of the body. During the day, HRV is physiologically high, corresponding to high lev-els of activity. At night, and especially during deep sleep, HRV typically reduces, reflecting a shift into a rest and repair mode, where the body focuses on recovery and recharging for the next day.

The research found that certain HRV patterns were linked to future health conditions. Participants who later developed stroke often showed unusually high and erratic HRV. In contrast, low HRV was common in these who further d those who further developed depres-sion. High HRV with altered frequency patterns were also observed in individuals who later developed metabolic diseases. Similarly, cardiovascular and endocrine diseases were also associat-



ed with high HRV. "HRV matters for brain and overall health because it reflects how well the body regulates itself - primarily through the activity of the autonomic nervous system", explained the lead author of the study, Irina Filchenko, MD, PhD. "This system controls vital unconscious processes such as breathing, digestion and muscle tone, helping the body maintain balance and adapt to internal and external demands.

unique window into how the body functions during sleep. This is especially important because sleep is a critical time for many physiological processes underlying long-term health, such as cellular repair, memory consolidation, and the clearance of metabolic waste from the brain."

Importantly, researchers believe that HRV could act as an early physiological marker, demonstrating subtle changes in body functioning before traditional symptoms or diagnoses appear. This could open the door to prevention and early

intervention for diseases Alzheimer's or stroke, where timely action can improve patient out-comes. Dr Filchenko noted, "Some participants had 'normal' sleep according to traditional criteria, with little sleep fragmentation and the expected balance of sleep stages. However, HRV told a differ-ent story, picking up risks that the common sleep metrics missed. This suggests we need to rethink how we

define and measure optimal sleep." The findings of the study also raise the possibility of using wear-able technology to monitor HRV pat-terns over time. While current consumer devices vary in accuracy and interpretability, experts believe future improvements could allow people to track changes in HRV as part of regular health monitoring.

The research adds to growing evidence that sleep is a critical pillar of long-term health, and that subtle patterns could offer a window of opportunity to prevent seri-ous disease. "The broader message is that sleep is not just a passive state of rest -- it is an active, dynamic process that plays a vital role in maintaining long-term health, especially brain health. Our findings reinforce the idea that primary prevention matters, and that health problems start long before the clinical symptoms appear", concluded Dr Filchenko.(ANI)

Nice [France] : New research has found immune changes in cancer patients that could help identify which patients are most at risk of dangerous heart complications from cancer drugs, known as immune checkpoint inhibitors

The study was led by Assistant Professor Pilar Martin, Head of the Regulatory Molecules of Inflammation Lab at the Spanish National Centre for Cardiovascular Research (CNIC) and group leader at CIBER-CV

She explained, "Immune checkpoint inhibitors have revolutionised cancer treatment, but they can also damage the hearts of some patients. In this study, we moni-tored how levels of immune cells, which are known to be involved in the development of heart diseases, change after treatment.

"We were surprised to see an early and rapid loss of protective immune cells, called regulatory T cells, after cancer patients started treatment. This suggests a window of vulnerability early in treatment."

Assistant Professor Martin continued. The new research is being presented at European Cardio-Oncology 2025, a scientif-ic congress of the European Society of Cardiology.

Immune checkpoint inhibitors are drugs that work by harnessing the patient's own immune response to attack cancer cells. Unfortunately, they can also have side effects, including causing heart damage or cardiotoxicity, in some patients. Approximately 1 in 100 patients treated with these drugs develop myocarditis, a life-threatening heart complication.

Researchers found that patients with lower levels of a blood biomarker, called CD69 and found in protective immune cells, experienced a greater decrease in protective immune cells and a resulting increase in destructive pro-inflammatory immune cells. Such a decline in protective immune cells has previously been associated with a greater risk of developing cardiovascular mulications such as m

immune response which puts them at much greater risk of heart damage," Professor Martin said.

"More work is needed to validate this biomarker and fully understand the immune changes that are taking place, but testing patients for this biomarker with a blood test is relatively cheap and easy and has the potential to help doctors identify which patients are at greatest risk of com-plications. This could allow doctors to montor these patients more closely, and in time I hope we can develop new treatments to prevent the immune dysregulation we see in these patients," Professor Martin continued.

Researchers analysed blood samples from 215 cancer patients from the Spanish Immunotherapy Registry of Cardiovascular Toxicity (SIR-CVT)2 before treatment and at 24 weeks, 1012 weeks, 6 months, and 1 vear after treatment with immune check point inhibitors. The patients had a range of different cancers, including lung, breast and skin cancer, and were treated with different types of immune check point inhibitor treatments, including anti PD1, PDL1 and CTLA4.

Patients were put into two groups dependent the amount of biomarker for a specific protective T-cell (CD69) in their blood and changes in levels of their immune cell populations were monitored over time.

While both patient groups experienced some decline in levels of a specific type of a protective immune cell (CD69 positive regu-Îatory T cells) in response to treatment, those patients with low starting levels of the protective biomarker had a much larger decrease. These patients also had an increase in immune cells with a role to kill other cells and others that have a role in inflammation.

Regulatory T cells are found in the blood and are important to maintain immune balance and stop the immune system damaging healthy tissues, including hlood he heart vessels research has shown how the wrong levels of these cells can result in damage to blood vessels and the heart, and this study suggests they could be key in mediating the heart damaging effects of immune checkpoint inhibitor cancer drugs. ## Eastern half of US sweltering again with dangerous heat wave expected to last until midweek

Madison (US), Jun 23 (AP) Tens of millions of people across the Midwest and East endured dangerously hot temperatures as a sprawling June heat wave that gripped much of the US was expected to last well into this week.

Most of the northeastern quadrant of the country from Minnesota to Maine was under some type of heat advisory on Sunday. So were parts of Arkansas, Tennessee, Louisiana and Mississippi, the National Weather Service said.

Weather service offices throughout the region warned of sweltering and sometimes life-threatening conditions through Wednesday.

Please plan ahead to take frequent breaks if you must be outside, stay hydrated and provide plenty of water and shade for any outdoor animals," the service office in Wakefield, Virginia, said on X.

Meteorologists say a phenomenon known as a heat dome, a large area of high pressure in the upper atmosphere that traps heat and humidity, is responsible for the extreme temperatures.

Meanwhile, twin 6-year-old girls were among three people killed when thunderstorms brought trees down onto homes in central New York before dawn Sunday, according to the Oneida County Sheriff's Office. Several inches of rain fell over just a few hours, inundating the small town of Kirkland.

A neighbour, Jared Bowman, said he ran next door to help the twins' mother escape through a window after a giant maple crashed through the roof around 4 am.

"She was yelling, Get my kids out!'" Bowman told the Post-Standard. A 50year-old woman died when a tree hit a house nearby, sheriff's officials said. The streets were littered with electrical lines and thousands in the region were without power

Gov Kathy Hochul declared a state



of emergency in 32 counties due to the strong storms and forecast extreme heat.

Sunday marked the second straight day of extreme heat across the Midwest and East Coast. Heat indexes on Sunday hit 103 F (39.4 C) in Chicago and 101 F (38.3 C) on Saturday in Madison, Wisconsin, turning that city's annual naked bike ride into a sticky and sweaty affair.

Lynn Watkins, 53, director of Sacred Hearts Day Care in Sun Prairie, a Madison suburb, said that she tried to sit outside to grill but it was so hot she had to go inside. She plans to cancel all outdoor activities at the day care on Monday with highs around 93 F (33.8 C) forecast

"I can't stand being outside when it's like this," she said. "I just want to sit in my air conditioning.

The heat index in Pittsburgh reached 105 F, and hovered around 104 F (40 C) in Columbus, Ohio.

Forecasts in Philadelphia called for a heat index of 108 F (42.2 C) on Monday.

Philadelphia declared a heat emergency. The city's public health department declared a heat emergency through Wednesday evening. Officials directed residents to air-conditioned libraries, community centres and other locations, and set up a "heat line" staffed by medical professionals to discuss conditions and illnesses made worse by the heat. With tem-

peratures in the mid-80s, Delaware's Rehoboth Beach was crowded Sunday.

"It's only going to get worse," said beachgoer Vak Kobiashvili. "People are trying to get out to the beach before it's too hot to really even manage to be outside.

Kobiashvili said even his dog didn't want to be outside.

"East Coast weather, at least from my perspective, is just very sweaty in the summer," he said. "It's that walking through a swamp kind of feeling.

Forecasters warned the heat index Cromwell, Connecticut, would reach 105 F on Sunday, making for a steamy day during the final round of the PGA

Travelers Championship. Fans sought shelter under trees and on air-conditioned benches. Many lined up for water at a hydration station near the ninth green

Karin Skalina, of New York, had been in the sun-soaked bleachers by the eighth green and eventually sought relief on a ventilated cooling bench. "Didn't work," she said.

"(We're) trying to follow the shade,' Skalina said.

Courtney Kamansky, of Newington, Connecticut, came prepared with extra water bottles. Asked if she was able to find shade, she pointed to her umbrella and said, "I bring it with me."

Cincinnati Reds shortstop Elly De La Cruz got sick Saturday while playing in extreme heat against the Cardinals in St Louis. Seattle Mariners reliever Trent Thornton, facing the Cubs in Chicago, also fell ill.

The heat is expected to persist this week with the highest temperatures shifting eastward. New York City is expected to see highs around 95 F (35 C) on Monday and Tuesday.

Boston is on track for highs approaching 100 F (37.7 C) on Tuesday, and temperatures in Washington, DC, were expected to hit 100 F on Tuesday and Wednesday.

Mark Gehring, a National Weather Service meteorologist in Sullivan, Wisconsin, said this level of heat is not uncommon during the summer months in the US, although it usually takes hold in mid-July or early August. The most unusual facet of this heat wave is the sheer amount of territory sweltering under it, he said.

"It's basically everywhere east of the Rockies," he said, referring to the Rocky Mountains. "That is unusual, to have this massive area of high dewpoints and heat

# Suicide bombing kills at least 19 at Damas cus church during Sunday mass

MI News Service, Damascus: A suicide bomber stormed a crowded church in the Syrian capital Damascus during Sunday mass, opening fire on worshippers before detonating his explosives, killing at least 19 people and injuring dozens more, security sources and a monitoring group said. The Syrian health authorities put the latest official death toll at 13, with 53 others wounded. The blast ripped through the Mar Elias Church in the Dweilaa district, a predominantly Christian neighborhood on the eastern outskirts of Damascus, leaving behind blood-stained pews, shattered icons, and scenes of chaos, according to eyewitnesses and local media.

The Syrian Observatory for Human Rights said the attacker opened fire inside the packed church before blowing himself up, causing "severe human losses." The monitoring group reported that the toll may rise given the critical condition of many of the injured.  $\oplus$

## "I haven't seen any of that": Hazlewood responds to Mitchell Johnson's harsh criticism after WTC loss

Australian pacer Josh Hazlewood and spinner Nathan Lyon responded to ex Aussie pacer Mitchell Johnson's harsh criticism of the team's bowling attack following their ICC World Test Championship (WTC) loss and Hazlewood defended his move to play in the Indian Premier Leagur (IPL) days before the marquee clash against South Africa. After Australia's five-wicket

defeat to South Africa in the World Test Championship (WTC) final, earlier in this month, former Australian veteran seamer Johnson used his column in The West Australian newspaper to question Aussie fast bowler Josh Hazlewood and spinner Nathan Lyon.

South Africa has won its first-ever world title in international cricket. This is also the country's second ICC trophy after the ICC Knockout 1998. Also, Australia skipper Pat Cummins' golden run as a captain, which started with the retention of the Ashes series against England and was followed by an incredible WTC mace and 50-over World Cup wins over India, came to a halt.

"We've seen concerns about Hazlewood's fitness in recent years, and his decision to prioritise returning to the delayed Indian Premier League over his national team preparations raised eyebrows," Johnson together ... but it's essential to consider when the right time is to make some tough calls," he added.

Hazlewood, who was managing a minor shoulder injury before the IPL was postponed, chose to return to India and resume commitments for Royal Challengers Bengaluru instead of heading straight to London before the WTC final.

Speaking as quoted by the Sydney Morning Herald, Hazlewood said he hasn't seen any of Johnson's column, and said IPL was the best place to get ready for any type of cricket that is coming up.

"I haven't seen any of that, to be honest," Hazlewood told the newspaper when asked about Johnson's column ahead of Australia's opening Test against the West Indies on Wednesday. "We know what's going on in inside our rooms. It seemed far and away the best place to get ready for any type of cricket that was coming up. The weather was definitely a factor as well. Just getting over there and playing intense competition like that, it's hard to replicate in training," he added.

Hazlewood told about his preparation before the WTC Final. He said it was raining in Sydney, and Brisbane was very wet; he felt India was the best place to bowl. "Sydney, it was raining, and I

### **JASPRIT BUMRAH LONE WARRIOR OF INDIAN BOWLING LINE-UP SINCE 2024 IN TEST**

LEEDS [UK] : Veteran Indian fast bowler Jasprit Bumrah continued to shine as the backbone of India's bowling attack, picking up his 14th five-wicket haul in Test cricket during the first Test against England at Leeds on Sunday, despite four catches being dropped off his bowling. Bumrah's performance helped India secure a slender six-run lead after England were bowled out for 465 by the end of the second session. Since 2024, the veteran seamer has been carrying India on his back. In tests since 2024, Bumrah has taken 78 wickets at an average of 15.07, with six five-wicket hauls. In contrast, the rest of India's fast bowlers have managed only 80 wickets at an average of 33.48, with one fifer, according to ESPNcricinfo. Bumrah once again emerged as a one-man army for India, register-ing a five-wicket haul to achieve a slender lead of six runs over England at the end of the second session, bundling them out for 465 runs. With his latest performance, Bumrah now has 12 fivewicket hauls in away Tests, equalling the legendary Kapil Dev, but in nearly half the matches (Bumrah in 34, Kapil in 66). Notably, Bumrah has five four-wicket hauls in Australia, three in England, three each in England and South Africa, and two in the West Indies. Only two of his five-wicket hauls have come in India. This is Bumrah's 10 five-wicket haul in SENA nations. becoming the first-ever Indian to touch this fig-

## A milestone-heavy, chart-climbing Test series against West Indies awaits Australia's iconic bowling quartet

ST JOHN'S [ANTIGUA] : Australian pacer Mitchell Starc will have two major milestones to tick off, as he will be aiming to become only the fourth Aussie to reach 400 Test wickets and become the 16th player from his team to feature in 100 Tests during the tour of West Indies from June 25 onwards.

The first Test of the threematch series will be held in Barbados. It will mark the start of Australia's ICC World Test Championship (WTC) 2025-27 cycle after its loss to South Africa in the final of the 2023-25 WTC cycle.

Currently, in 97 Tests, Starc has taken 387 wickets, with an average of 27.49, with the best figures of 6/48. He has taken 15 five-wicket hauls and two tenwicket hauls. He is Australia's fourth-highest all-time wickettaker in Tests. If he reaches to the 400 wicket mark, he will only be the second Aussie pacer to do so. Also, nine more wickets will help him overtake Brett Lee (718 international scalps in 322 matches) to become

## Ishan Kishan scores fiery 87 on County **Championship debut for Nottinghamshire**

NOTTINGHAM [UK] : Indian wicketkeeper-batter Ishan Kishan kickstarted his County Championship campaign with Nottinghamshire with a fiery halfcentury against Yorkshire on Monday.

The left-hander is serving as Kyle Verreynne's replacement while the World Test Championshipwinning South African is away playing a two-Test series in Zimbabwe.

Kishan has played two Tests for India, scoring 78 runs in three innings with a fifty. His most prolific format is ODIs, scoring 933 runs in 27 matches and 24 innings at an average of 42.40, strike rate of 102.19, with a century and seven fifties and best score of 210 In 32 T20Is for India, he scored 796 runs at an

average of 25.67, with a strike rate of 124.37, with six half-centuries and best score of 89.

After losing out his central contract with the Board of Control for Cricket in India (BCCI) last year, Kishan regained it for this year, being placed in the Cgrade category. He headed into the Championship with a decent Indian Premier League (IPL) season with Sunrisers Hyderabad, scoring 354 runs in 13 innings at an average of 35.40, with a strike rate of over 152, with a century and a fifty.
