**Intensive search** continues in J-K to flush out three heavily armed terrorists from Pakistan

MI News Service, Jammu; The intensive search to track down three Pak-istan-based Jaish-e-Mohammad (JeM) terrorists in a forested area of Jammu and Kashmir's Udhampur district continued for the third day on Saturday with heightened aerial surveillance,.

According to official sources, a cordon and search operation is also being carried out simultaneously by a joint

team of security forces. A Pakistan-based JeM terrorist was killed in an encounter with security forces on Thursday, while three of his associates remain trapped in the forested area of the Basantgarh belt.

Amid strengthening of the multitier cordon, the search operation, widened by the joint operation group, resumed this morning with the use of drones and sniffer dogs, they said.

The cordon has been further strengthened with additional reinforcements to eliminate the remaining terrorists of the group, the sources added.

**Inspector General of Police Bhim** Sen Tuti said the terrorists are reported to be still within the cordoned off area. He said that out of the four terrorists, one -- the commander of the

rorists, one -- the commander of the group -- has been killed. The group had been tracked for over a year. Two terrorists affiliated with JeM from this group were elimi-nated in Basantgarh in September last year.

However it is yet to be established that this group was in any way linked with the Pahalgam terror attack in which 26 civilians were killed on April 22 this year.

On Thursday, the four terrorists were found hiding near Karoor Nallah in the Bihali high-altitude belt and were engaged by the joint search party led by the Army's Para Commandos, resulting in an encounter.

One of the terrorists killed in the encounter has been identified as Haider alias Jabbar, code-named Maulvi, from Pakistan.

Supported by overground workers (OGWs), the terrorists had been moving from one place to another using forest cover and natural caves to hide, officials said. Five OGWs have been arrested over the past several months in the belt for providing food and shelter to the terrorists.

It is also believed that a local terrorist, who had returned from Pakistan after several years, is actively support-

ing the group. The search by troops led to the recovery of the body of the killed terrorist along with ammunition, explosive material, and cash, the officials said. Basantgarh lies on a traditional infiltration route used by Pakistani terrorists who enter from the International Border in Kathua and move via the higher reaches to Doda and Kishtwar districts in Jammu region and further into the Kashmir Valley. It has witnessed several encounters and terror incidents in the past. On April 25, Havaldar Jhantu Ali Shaikh of the Army's 6 PARA was killed in an encounter with terrorists in the Basantgarh area. On April 9, an encounter broke out between security forces and terrorists in the Jopher-Marta belt of Basantgarh in Udhampur district. On September 11 last year, two terrorists affiliated with JeM were killed in an encounter in the upper reaches of Basantgarh.

# TMC criticises EC's special revision of electoral roll 'to bring NRC through backdoor'

MI News Service, New Delhi : Describing it as nothing but a "sinis-ter move to bring the National Register of Citizens (NRC) through the backdoor," Trinamool Congress leader Derek O'Brien on Saturday expressed his strong reservations about the special intensive revision of electoral roll, as announced by the Election Commission.

Questioning the timing of the drive, the Trinamool Congress, at a press conference here today, said all participants of INDIA bloc will take up the issue both inside and outside Parliament during its coming Monsoon session.

The Election Commission last Monday issued instructions to carry out a Special Intensive Revi-

sion in Bihar to weed out ineligible names and ensure that all eligible citizens are included in the electoral roll, allowing them to exer-cise their franchise in the polls slated later this year.

Amid allegations of voter data being fudged to help the BJP, the exercise also introduces complete transparency in the process of addition or deletion of electors in the rolls. The last intensive revision for Bihar was conducted in 2003.

"Why is this exercise being sud-denly done right now?" O'Brien asked rhetorically at the press conference.

'We have evidence as to why it is being done now. It is because the latest internal survey of the BJP for

Bengal shows 46-49 seats for the BJP in the state's assembly polls (early next year). In their desperation to attempt to change things you do such things," he claimed.

"It's a sinister move to bring NRC through the backdoor," al-leged the TMC Rajya Sabha parlia-

mentary party leader. He added that INDIA bloc parties will take up the issue both inside and outside Parliament. "We are all on the same page on this. We will not wait for Parliament to start. This cannot wait," O'Brien said.

On Friday, the Communist Party of India (Marxist) wrote to the poll panel on the special intensive revision of electoral rolls in

Bihar and urged it to abandon the exercise. In a letter to Chief Election Commission Gyanesh Kumar, CPI(M) Politburo member Nilotpal Basu stated that while review of electoral rolls is a normal and routine process, the proposals appear to be putting a major part of the responsibility for inclusion or deletion from the electoral rolls is being imposed on the voters themselves.

After Bihar, the Election Commission will carry out a similar re-view of electoral rolls by the end of this year in five states going to polls in 2026.

The terms of the legislative assemblies of Assam, Kerala, Puducherry, Tamil Nadu and West Bengal are ending in May-June next year.

Incidentally only a couple of days ago West Bengal Chief minister Mamata Banerjee also raised the issue during An impromptu press conference in Digha where she had gone to attend the maiden Ratha Yatra from the newly constructed Jagannath Temple.

Expressing her strong opposition to the EC's move, she also alleged that it was being done keeping in in mind the next year's state assembly elections in Bengal. Doing it prior to the Bihar elections was just a false move, she said and reiterated her commitment to oppose the move unitedly by all opposition parties.

## Bangladesh govt reaffirms commitment to protect minority rights

MI News Service, Dhaka : The Interim government in Bangladesh has asserted that it remains "firmly committed to safeguarding the rights of all communities and protecting places of worship but building religious structures on public land is not permissible under any circumstance". The country's Foreign Ministry's statement on Saturday came a day after India denounced the reported destruction of a Durga temple in Dhaka and stressed the responsibility of Bangladesh's interim government to protect Hindus as well as religious institutions.

The ministry claimed that the temple in Dhaka's Khilkhet area was built on land owned by Bangladesh Railways, and its removal was carried out following due process to recover public land., the state-run BSS news agency reported. It alleged that the temple started as a makeshift pavilion, with organisers attempting to make the temporary structure permanent despite repeated reminders.

On June 26, Bangladesh Railways proceeded with the "peaceful eviction of all unauthorised structures along the rail track in Khilkhet area," it said. "While the laws of the land ensure full protection to all places of worship without discriminating against any built-in conformity with law, it is not permissible for any to build any religious structure encroaching public land under any circumstances," the ministry said. "Bangladesh remains firmly committed to safeguarding the rights of all communities, including protection of the places of worship," it added. During a briefing on Friday, External Affairs Ministry spokesperson Randhir Jaiswal said, "We understand that extremists were clamouring for demolishing the Durga temple in Khilkhet, Dhaka.

The interim government, instead of providing security to the temple, projected the episode as illegal land use...and they allowed the destruction of the temple today," he said.

"This has resulted in damage to the deity before it was shifted. We are dismayed that such in-cidents continue to recur in Bangladesh," he added. Jaiswal underlined that it is the responsibility of the interim government of Bangladesh "to protect Hindus, their properties, and religious institutions." The Hindu population in Bangladesh has been affected by a series of incidents against minority communities in the country since August last year and following the ouster of the Shiekh Sahina government.

#### Jewellery theft sparks political storm, TMC alleges Bengal BJP leader's involvement, link to Sukanta Majumdar

MI News Service, Kolkata: A theft incident in Odisha has snowballed into a political controversy in Bengal, with the Trinamool gai, with the Thanhoo Congress launching a scathing attack on the Bharatiya Janata Party (BJP) after CCTV footage allegedly showed a BJP leader from Nadia district involved in the crime. The incident involves the theft of jewellery worth approximately 25 lakh from a shop in Odisha, allegedly committed by Somnath Sahu, a BJP leader from Habibpur in West Bengal's Nadia district. According to Trinamool Congress, CCTV footage from the jewellery store in Odisha captures Somnath Sahu red-handed during the act of theft. He was reportedly apprehended shortly afterward and handed over to the local police.

## Mother arrest after killing her 6 month old son, body recovers from septic tank

MI News Service, Kalyani : A woman staged kidnapping drama after murder her infant son, police re-covered infant's body and arrest mother.In a deeply disturbing incident that has sent shockwaves across Nadia district of

West Bengal, a six-monthold infant was allegedly killed by his own mother, who then attempted to cover up the crime by claiming the child had been kidnapped.The incident occurred on Friday evening in Saguna area under the jurisdiction of Kalyani police station. The accused, identified as Rupa Ghosh (25), reportedly strangled her infant son and later disposed of his body in the septic tank of their house.After committing the crime, Rupa began crying loudly, claiming that her baby had been stolen from the house. Alarmed by her distress, neighbors gathered and joined in a frantic search. When their efforts proved futile, the family approached the police.Kalyani police officers began interrogating family



members, including Rupa. According to Police Officer Joy Das, the inconsistencies in Rupa's statements led to suspicion. After sustained questioning, Rupa confessed to the murder and led police to the septic tank, where the infant's body was recovered. The body was sent to Kalyani JNM Hospital for post-mortem. Rupa has been arrested and charged with murder.Her husband, Somnath Ghosh, who was not home at the time of the incident, expressed shock. He said, "She became irritable after our son was born. I cannot comprehend why she would do something so cruel."Neighbors. however, claimed that the couple had frequent domestic quarrels and that

an ongoing issue. Many are questioning whether such personal conflict led to the heinous crime — or if the mother was suffering from undiagnosed mental illness.Police Investigation is underway and a Police sources said that they were investigating all possible motives, including postpartum depression or other psychological factors. "It's a tragic case. We are taking expert consultation to understand the mother's mental condition," said the police officer. The incident has sparked wider conversation on the lack of mental health awareness, especially among new mothers, and the role of domestic instability. Local NGOs and child welfare activists have called for immediate support structures vulnerable for women."This is not just a criminal act, it's a symptom of a deeper societal failure. We need stronger intervention systems, before such tragedies occur, " a social worker said.

EC to issue showcause notices to eight dormant political parties

MI News Service, Kolkata: Over the past six years, a series of new political parties have emerged across West Bengal. However, these parties have exhibited minimal or no political activity following their registration-neither participating in elections nor engaging in public outreach or advocacy. In light of this concerning inactiv-ity, the Election Commission of India is now set to initiate show-cause proceedings against eight

such political entities. In a directive recently issued from New Delhi to the State Election Commission, it was highlighted that these eight parties, formed between 2019 and 2025, have remained virtually inactive. None of them have contested any elections, organized political events, or maintained visibility in the media. This raises fundamental questions about their legitimacy and relevance as recognized political organizations. The State Election Commission has been instructed to formally seek explanations from each of these parties. They are to be asked why they have remained politically dormant and whether they

possess any concrete plans

for future political engage-

ment. The Commission has

also been tasked with thor-

oughly examining their

documentation, and, if

necessary, recommending the cancellation of their registration as political parties.

The dormant parties in question are scattered across various districts of West Bengal, including one party each from North and South 24 Parganas, two from Birbhum, two from Kolkata, one from Murshidabad, and one from Uttar Dinajpur. Some of the names that have surfaced include the All India Tofsil United Party from North 24 Parganas, the Bharatiya New Democratic Party from South 24 Parganas, BanchitaSwaraj Party and Indian Democratic Congress from Birbhum, the Moolnivasi Party of India from Murshidabad, and the Banglar-Bikashbadi Congress from Uttar Dinajpur. ## Bratya Basu seeks detailed report in South Calcutta Law College incident

According to Southeast Kolkata Traffic Guard officials, although the Majerhat Bridge will remain operational, other nearby routes such as Dhanadhanya and Jirat bridges will be inaccessible. Major traffic diversions have been planned. Northbound vehicles will be rerouted from New Alipore Traffic Island, while southbound traffic will be diverted at Alipore Road and GobindaAuddy Road crossings. Additional police personnel will be deployed in high-traffic zones like Tollygunge Circular Road to manage congestion.





MI News Service, Balochistan: The Balochistan government on Friday extended the detention of Baloch Yakjehti Committee (BYC) chief organiser Mahrang Baloch and four other leaders for another 15 days under Section 3 of the Maintenance of Public Order (MPO), Dawn reported.Mahrang Baloch and other BYC leaders – Beebow Baloch, her father Ghaffar Baloch, Sabghat Ullah Shah Jee, and Bebarg Baloch - were arrested on March 22 and

sent to Quetta District Jail under MPO-3. The detention of BYC leaders has been extended for the fourth time.

After the BYC leaders completed three months in custody, the authorities issued a fresh notification extending their detention by another 15 days. Superintendent of Quetta District Jail Hameed Ullah Peechi confirmed the extension of their imprisonment. He said, "I have re-

ceived orders from the authorities concerned about extending the detention of Dr Mahrang Baloch and others by 15 more days. They will remain in jail for 15 more days." The BYC spokesperson criticised the government for extending their detention and termed the fresh orders illegal, and called for their immediate release, Dawn reported. BYC leader Sabhia Baloch stated, "The continued detention of these leaders after three months is illegal and unconstitutional." She accused the government of using various tactics to prolong their imprisonment and demanded their immediate in Tel Aviv in July, promptrelease.

injuries or impacts. Sirens were sounded in Beersheba, Dimona, Arad, and surrounding areas in southern Israel.


Residents received an early warning alert via push notification on their phones four minutes before the sirens began, warning of a long-range missile attack. The Houthis later claimed responsibility for the launch, stating they had targeted a "sensitive Israeli enemy target" in Beersheba. "The operation successfully achieved its goal, thanks be to Allah," the group said in a statement. The Times of Israel reported that the Houthis have continued attacks against Israel and maritime targets since November 2023, following the October 7 Hamas-led massacre. The Houthis had paused their fire after a ceasefire between Israel and Hamas in January 2025. By that point, over 40 ballistic missiles, as well as numerous attack drones and cruise missiles. had been launched by the group at Israel. One of those missiles killed a civilian and wounded several ing Israel's first strike in Yemen, The Times of Israel reported.

According to the outlet, since March 18, when the IDF resumed its offensive against Hamas in Gaza, the Houthis have fired 52 ballistic missiles and at least 13 drones at Israel. While some missiles have fallen short, the Houthis remain the primary actor still regularly attacking Israel. Iran conducted a 12-day missile campaign earlier this month, and Hezbollah's rocket fire from Lebanon had ceased following a November ceasefire. In parallel with these ongoing regional threats, the IDF issued tonight an evacuation warning to civilians in the central Gaza Strip. IDF Arabic spokesman Avichai Adraee's warning reads as follows: "To all Gaza Strip residents in Nuseirat, Al-Zahraa and Al-Mughraqa in the northern coast neighborhoods, Al-Nuzha, Al-Badi, Al-Busma, Al-Zahraa, Al-Bustaneim, Badr, Abu Huraira, Al-Ruda and Al-Safa: The IDF is operating with tremendous force to destroy the capabilities of terrorist organizations in these areas and will attack any area used to launch rockets."

The IDF statement urged the civilians to leave the area immediately. "For your safety, evacuate im-mediately southward to the Al-Mawasi area and do not return to dangerous combat zones. The terrorist organizations continue to bring disaster upon you - evacuate immediately,' the statement concludes.

He said that people had supported them since they had faith in AAP national convenor Arvind Kejriwal and Punjab Chief Minister Bhagwant Mann. "It is a matter of great joy that a very honest person, Sanjeev Arora, has become a member of the Punjab Vidhan Sabha today. I thank the people of Ludhi-ana West. They have sup-ported us by putting faith in Arvind Kejriwal's policies and Mann's work (as CM). They have supported Sanjeev Arora because of his decency. Many thanks to the public, workers and everyone," Arora, Punjab AAP chief, told ANI. He added, "Any person found involved in corruption or drug business will not be spared; action will be taken (against them)." With Sanjeev Arora winning the Ludhiana West by-election in Punjab, the party's Rajya Sabha seat has now become vacant, and the party Is yet to decide on a candidate for the same. "I don't know anything about this (who will go to the Rajya Sabha), our national convenor, Arvind Kejriwal, has said that the party will take a decision on this," Arora told ANI. Arora won the Ludhiana West assembly seat by-election by a margin of 10,637 votes, garnering 35,179 votes in total. Sanjeev Arora expressed gratitude to the public and the party lead-ership after his victory in the Ludhiana West assembly bypoll. Speaking to ANI, Sanjeev Arora said, "I express my gratitude to all the citizens of Ludhiana and also thank all the volunteers, counsellors, MLAs, ministers, leaders, and especially our Chief Minister Bhagwant Mann and party supremo Arvind Kejriwal."

## "Laluji got big opportunity, did nothing for Bihar...": **Deputy Chief Minister Samrat Chaudhary**

MI News Service, Patna: Bihar Deputy Chief Minister Samrat Chaudhary has slammed RJD supremo Lalu Prasad Yadav, saying that he and his party were in power for 15 years in the state but did little for its progress. In an interview with ANI, Samrat Chaudhary, a senior BJP leader in Bihar, took a dig at Lalu Prasad "social justice" model, saying it means "become a king, bring queen (to power) and then prince and princess" and alleged that the former Chief Minister has "no model for progress of Bihar" Noting that Lalu Prasad Yadav ruled the state for 15 years seven years as Chief Minister, and his wife Rabri Devi being the CM for the next eight years - Samrat Chaudhary said the Rashtriya Janata Dal leader failed to capitalise on the huge opportunity "Lalu ji got a big opportunity. He was the Chief Minister of Bihar and then there was puppet Chief Minister for 8 years. Even after that, he didn't do anything for Bihar," Chaudhary said. Janata Dal-United Nitish

Kumar has been Chief Minister of Bihar since 2005 except for a small period in between. He was Chief Minister for a very brief period earlier.

Political parties in Bihar are bracing up for the assembly polls later this year. The BJP and NDA have expressed confidence in returning to power in the Bihar assembly polls and have been reminding people of the "RJD misrule". The NDA leaders have said that Bihar's economy experienced severe stagnation under Lalu Prasad Yadav's rule, with industrial development largely being over-looked. They have said that average GDP growth rate from 2001-2005 was 2.9%, indicating a significant lack of economic progress and that Lalu Yadav's rule was "marred by widespread corruption, including the infamous fodder scam". This, they say, led to "a lack of accountability in government offices and a paralysis in effective governance" Samrat Chaudhary lauded Nitish Kumar for "developing Bihar", stating that his

development work has had a lasting impact on Bihar. "Bihar is a state where if you look at an individual's politics, you'll see a changing face. Politics in Bihar keeps rotating, sometimes we're in power, and sometimes in opposition. Why does Lalu ji follow Nitish ji? Nitish Kumar ji has a lasting impact on Bihar," he added.

"They (RJD) say they have social justice, but social justice doesn't mean someone becomes a king. He (Lalu Prasad) came as a son of a poor man and became a king after coming to power. First, the king came, then brought the queen, then brought the prince and princess - this is Lalu ji's concept. There's no model for Bihar's development for him," he added. Chaudhary said he would not have come to politics if Lalu Prasad had not sent him to jail "I would not have entered politics if Lalu Prasad Yadavji had not put me in jail. I would not have entered politics if Lalu Prasadji had not sent 22 members of my family to jail in 1995.

Parag Jain, one of the brains behind the meticuplanning lous of 'Operation Sindoor', has been appointed as the new Chief of the Research and Analysis Wing (R&AW), according to an official order issued here on Saturday.

The two-year tenure of Jain, an Indian Police Service (IPS) officer from the 1989 batch of the Punjab cadre, officially begins on July 1. He takes over from Ravi Sinha, who retires on June 30.

Before this, Jain was the head of the Aviation Research Centre, an organisation that deals with aerial surveillance, SIGINT operations, photo reconnaissance flights (PHOTINT), monitoring of borders and imagery intelligence (IMINT).

Jain is known for his exceptional expertise in integrating both human intelligence (HUMINT) and intelligence technical (TECHINT) and is widely credited as the mastermind behind the planning

of 'Operation Sindoor', providing intelligence support that enabled the armed forces to execute precise strikes on terror infrastructure in Pakistan Pakistan-occupied and Kashmir (PoK).

India hit nine terror camps across the border and Line of Control, including the headquarters of banned terror out-Jaish-e-Mohammed fits and Lashkar-e-Taiba on May 7.

The missile strikes were guided by pinpointed intelligence gathered by a

Jain is well-positioned to counter Pakistan's ongoing efforts to rebuild terror infrastructure in PoK.

Jain also brings extensive experience in addressing neighbourhood challenges and issues related to Khalistan terror groups. He played a crucial role in Jammu and Kashmir during the 2019 reorganisation of the erstwhile state of Jammu and Kashmir.

Throughout his career, Jain has held several significant positions. He was promoted to the rank of Director General of Police (DGP) in Punjab on January 1, 2021, though he was on central deputation at the time.

His career includes significant operational contributions during the height of terrorism in Punjab, where he served as SSP and Deputy Inspector General of Police in various districts.

Jain has also served in Indian Missions in Sri Lanka and Canada. During his tenure in Canada, he monitored Khalistan terror modules operating from the soil of that country.

Based on a complaint by local resident Abrar Ahmed, the Kharak Kuan police lodged an FIR against unidentified individuals under Section 299 (deliberate and malicious acts intended to outrage religious feelings of any class of citizens by insulting their religion or religious beliefs) of the Bharatiya Nyaya Samhita (BNS).

However, no arrests have been made as the police claim they are unable to identify the miscreants. "We will check the CCTV from Chhatri Chowk to identify the perpetrators. Appropri-ate actions will be taken against those who insulted the Shahi Masjid," station house officer (SHO) Rajkumar Malviya told reporters. Police maintained the law and order situation in the region is under control for the time being. Investigation for the accused is underway.

MI News Service, Tehran: A total of 4415 Indian nationals - 3597 from Iran and 818 from Israel – have been evacuated so far using 19 special evacuation flights during Operation Sindhu, the Ministry of External Affairs (MEA) said on Friday. The evacuated Indian nationals included more than 1500 women and 500 children. The flights, including three C-17 aircraft of the Indian Air Force, also brought home 14 OCI cardholders, nine Nepali nationals, four Sri Lankan nationals and one Iranian spouse of an Indian national. As tensions escalated in West Asia, the government of India had launched Operation Sindhu on June 18 to evacuate Indian nationals from conflict zones in Iran and Israel. On June 17-18, Indian Missions in Tehran, Yerevan, and Ashgabat coordinated the evacuation of Indian nationals from Iran through land border crossings to Armenia and Turkmenistan. Special evacuation flights commenced on June 18 and facilitated the return of Indian nationals to New Delhi. The majority of evacuations were carried out through Mashhad, after Iran opened its airspace for evacuation flights under Operation Sindhu on June 20 on New Delhi's request. 'We thank the Government of Iran for this gesture. A total of 3597 Indian nationals - including students, workers, professionals, pilgrims and fishermen - from more than 15 Indian states - were brought back to India from Yerevan, Ashgabat and Mashhad from June 18-26 using 15 special evacuation flights," the

"We're going to be trading in China. That's going to come a little bit down the road, but we're going to be trading in China. We have a lot of great things going and we're getting along with countries, but some will be disappointed. Because they're going to have to pay tariffs, and we've taken in already hundreds of billions of dollars in tariffs, no inflation," Trump said. India and Pakistan reached an understanding on May 10 to end the conflict after four days of intense cross-border drone and missile strikes. Trump has repeated the claim several times that he "helped settle" the tensions between India and Pakistan. However, India has been consistently maintaining that the understanding on cessation of hostilities with Pakistan was reached following direct talks between the Directors General of Military Operations (DGMOs) of the two militaries

No further details were revealed about the specifics of the ceasefire, including when it could go into effect.

Sudan plunged into war in April 2023 when simmering tensions between the Sudanese army and the rival RSF escalated into battles in the capital, Khartoum, and spread across the country, killing more than 20,000 people. The war has also driven more than 14 million people from their homes and pushed parts of the country into famine. UNICEF said earlier this year that an estimated 61,800 children have been internally displaced since the war began.

Guterres said on Friday that a humanitarian truce is needed for effective aid distribution, and it must be agreed upon several days in advance to prepare for a large-scale delivery in the El Fasher area, which has seen repeated waves of violence recently.

It was initially done in Assam, where around 1.9 million individuals were left out of the final list released in 2019, causing indiscriminate fear and anxiety. The central government has already suggested a countrywide NRC but the proposal has come under fire for its ability to exclude vulnerable groups of people. The NRC has ignited widespread

protests in India since 2019, particularly when combined with the Citizenship Amendment Act (CAA). The NRC-CAA combination was feared by protesters to be used for targeting Muslims. Opposition leaders, civil soci-

Although the central government has not formally proceeded with a pan-India NRC, apprehensions have continued because of the ongoing bureaucratic reforms and public statements from the government officials. The Election Commission of India, however, has not made any official notification connecting voter registration processes with NRC. Opposition party leaders, including Congress and RJD in Bihar, too have voiced alarm at strict documentation norms brought in during the current revision of electoral rolls. Activists of civil rights organisations have sought to know what the Election Commission means and demanded protective measures to prevent any citizen from being unjustly debarred from exercising their franchise.

### UN chief calls for **Passes Away at Safdarjung Hospital** ceasefire in Gaza

MI News Service, United Nations: UN Secretary-General Antonio Guterres called for a ceasefire in Gaza following the suspension of the 12-day war between Israel and Iran. The conflict between Israel and Iran has dominated headlines, but the suffering of Palestinians in Gaza must not be pushed into the shadows, said Guterres. "The ceasefire achieved between Iran and Israel offers hope. And hope is more needed than ever. So it is time to find the political courage for a ceasefire in Gaza.

Following the October 7, 2023, attacks by Hamas, Israeli military operations have created a humanitarian crisis of horrific proportions - more dire today than at any point in this long and brutal crisis, he told reporters at the UN headquarters in New York. Families have been displaced again and again, and are now confined to less than one-fifth of Gaza's land. And even these shrinking spaces are under threat. Bombs are falling — on tents, on families, on those with nowhere left to run. People are being killed simply trying to feed themselves and their families, he noted. "Let me be clear: Israel, as the occupying power, is required by international law to agree to and to facilitate humanitarian relief," he said, noting that UN-led humanitarian operations continue to be strangled, Xinhua news agency reported. For over three months, shelter materials and fuel for critical services have been blocked. Doctors are forced to choose who gets the last vial of medicine, or the last ventilator. Aid workers themselves are starving, he said. "This cannot be normalized.'

A handful of medical supplies finally crossed into Gaza earlier this week — the first from the United Nations in months. But this only underscores the vast scale of the crisis.

## FIH Hockey Pro League Women: India lose 0-3 to China

**BERLIN [GERMANY] :** China registered a determined 3-0 win against the Indian Women's Hockey Team on Saturday in Berlin, pushing them on the brink of relegation from the FIH Hockey Pro League (Women).

It was a disappointing outing for India, who missed converting from the chances, including a penalty stroke in the fourth quarter when Deepika hit the post, as per a press release from Hockey India.

"We are giving away too many soft PCs," was Chief Coach Harendra Singh's half-time analysis. From only six chances in the circle for China, they scored thrice with goals from Yang Chen (21'), Ying Zhang (26') - both these goals from PC, while Anhui Yu (45') scored a field goal.

"Execution and good structure are what helped us win today," was China's immediate reaction to the victory, which continues to firmly place them in the fourth position on the points table while India remains in the ninth place.

A favourable result in the upcom-

ing game between seventh-placed Germany and eighth-placed England would give some hope for India.

India made a good start, winning a Penalty Corner (PC) as early as the 4th minute but failed to convert.

China, meanwhile, which have been on the rise since their incredible Paris Olympic Silver Medal, took the lead in the 21st minute through a PC converted by Yang. She gave Savita no chance of saving it. Five minutes later, Ying pumped one in, to make it 2-0 by halftime, again through a PC. This one was a complete defencive collapse in PC, with the ball going in between defender Jyoti Singh's legs.

Singh's legs. China's third goal was a finelystruck field goal by Anhui Yu following which India had no hope of bouncing back. Overall, it has been an underwhelming show by the Indian Women's Hockey Team and they will be desperately hoping to end their campaign with a win when they meet China again tomorrow at 20:00 hours IST.

## Rahi, Mehuli and Niraj finish on top at National Shooting Trials in Dehradun



DEHRADUN (UTTARAKHAND) : Day five of the National Selection Trials 3 and 4 for Group A Rifle and Pistol shooters at the at the Trishul Shooting Range, Maharana Pratap Sports College, here in Raipur on Saturday, delivered another round of thrilling contests as Olympian Rahi Sarnobat, mixed team rifle Asian champion Mehuli Ghosh, and Navy's Niraj Kumar came out on top in their respective finals.

In the women's 25m pistol T4 final, 2018 Asian Games gold medallist Rahi Sarnobat produced a composed and clinical performance to outclass the field. She scored 40 hits in the final, finishing six points clear of Maharashtra's Abhidnya Ashok Patil, who scored 34. Haryana's Vibhuti Bhatia rounded off the podium with a score of 27, as per a press release from the National Rifle Association of India (NRAI).

Earlier in the qualification, it was a close duel between Rahi and Olympian Rhythm Sangwan, both registering scores of 582. Rhythm with 18 inner 10 hits edged into the top spot in qualification with two more 10s than Rahi. Anjali Choudhary and Vibhuti Bhatia also shot identical scores of 579-17x, with Anjali clinching third place based on the count of inner hits.

The finals lineup also included Ishneet Aulakh (578-16x), Heena Sidhu (577-10x), Abhidnya Ashok Patil (576-21x), and Chinki Yadav (576-14x).

In the women's 10 air rifle (ARW), Mehuli Ghosh shot 253.6 to win T4 finals, after she finished second in qualification, just 0.2 behind Olympian Ramita Jindal (633.5). Meghana M. Sajjanar of Railways finished in second place with 253.1 while Sonam Uttam Maskar held her nerve in the eliminations and clinched third with 231.4, narrow-ly edging out Ramita (210) by 0.1 at the 20-shot mark.

## "Line, lengths I bowled were not perfect...": India's Prasidh Krishna on Leeds Test performance

**LEEDS [UK]** : Ahead of the second Test against England at Edgbaston, Indian pacer Prasidh Krishna admitted that he could not bowl the line and lengths he wanted and would look to control his economy rate in the coming matches.

The second Test will take place at Birmingham from July 2 onwards. While Prasidh took a total of five wickets in the match, the same as pace spearhead Jasprit Bumrah, his economy rates of 6.40 and 6.10 across both innings attracted plenty of criticism from fans and experts alike, as he offered too many easy-to-hit deliveries.

Speaking ahead of the match in the pre-match presser, Krishna said, "I think if I look at the first innings, I was a little shorter than where I wanted to be, definitely 6-8 metres is ideal. That is what I would say. I think the second innings got slightly better because again the wicket was slightly slower."

"I had to pitch a few slightly behind 8 and then go slightly fuller when I am trying to get a wicket. So yeah, I definitely did not bowl the lengths that I wanted to," he added.

Krishna also said that he would like to bring down his economy rate in the coming games.

"I think I am learning as well. I cannot say anything, it is up to me, it is my responsibility to get better, and that is what I am trying, that is what I am working on and I just want to make



sure I put in the right kind of work and come back here and put up better numbers," he added.

On the possible absence of Bumrah from the second Test, Krishna said that the team is learning from each other no matter who is there and who is not, and the senior pacer had been talking to the

bowling group even before coming to England. "At least for me, I have been part of this team for a few years now, so the conversations are still going on. One thing you cannot get is experience that you have to do it yourself, and yeah, I think all of us are excited. If you look at the team, everybody is here. (Mohammed) Siraj has played a lot of games, he is going to continue playing, and then whoever comes in or whatever happens later, it is a great experience and it is an opportunity, that is the way we look at it," he added.

The pacer admitted that during the last match, the outfield was fast and his line and lengths were "not perfect" and hence the English batters took him on.

"Some of them were edges, some of them I tried bowling bouncers, I ended up giving runs, so I think somebody in the team had to do it. I am happy to do it, but definitely every time I come out to bowl, I am looking to keep the economy right down and build the pressure up," he added.

## BLUE TIGRESSES GEAR UP TO FACE RESILIENT TIMOR LESTE IN AFC WOMEN'S ASIAN CUP QUALIFIERS

CHIANG MAI [THAILAND] : After a thumping opening day victory, the Indian senior women's team will look to continue the winning momentum in the AFC Women's Asian Cup 2026 Qualifiers when they take on Timor Leste on Sunday at the 700th Anniversary of Chiang Mai Stadium.

The match will be streamed live on Changsuek YouTube Channel and Thai Women's Football Facebook Page.

The five-team Group B is currently led by Iraq, who are on four points after a 5-2 victory over Mongolia and a 0-0 draw with Timor Leste. India, who beat Mongolia 13-0, and Thailand, who beat Timor Leste 4-0, are on three points each.

Despite Timor Leste being ranked 158th, 32 places below Mongolia, Indian coach Crispin Chettri believed that the Southeast Asian side would pose a stronger challenge. Having watched all teams in action after the first two matchdays, there's now a much clearer assessment of all the remaining three opponents.

"Timor Leste are a better organised team than Mongolia, and I feel they are better organised defensively than Iraq as well. They prefer going for counterattacks. They don't mind keeping the ball either. So, in patches, they are good. But as Thailand dominated the match completely, we can't say much about their attack. But they have got pace in their



team as well," said Chettri, as per the press release from AIFF.

Chettri and his coaching staff were in attendance at the 700th Anniversary of Chiang Mai Stadium on Thursday as Timor Leste restricted 46th-ranked Thailand to four goals.

India, ranked 70, have never faced Timor Leste before. Coached by Indonesian Emral bin Bustamam, Timor Leste have been more active in international football as compared to Mongolia. They finished fourth in the 2024 AFF Women's Cup, where they drew against Laos and Singapore. They have played in four editions of the ASEAN Women's Championship, and the 2-1 win over Singapore in 2019 remains the only official victory in their history. The 0-0 draw with Iraq on Monday was their first-ever point in an AFC competition.

India utilised their five-day break to recover and prepare for the tighter schedule ahead, with three matches in a week. The Blue Tigresses had two morning training sessions on Tuesday and Thursday, and two evening sessions on Friday and Saturday.

"I think when you have a tournament of four matches, this kind of rest helps in team building. Tactically, we worked on a few things which maybe we didn't do well in the first match. We had four training sessions to work on that.
