Mamata Banerjee's 'Amader Samadhan' scheme for outreach begins in West Bengal

MI News Service, Kolkata: Ahead of the 2026 assembly elections, the West Bengal government on Saturday launched a Rs 8,000-crore outreach programme to address local issues like setting up street lamps, improving road conditions and ensuring water supply across dis-

tricts. The programme -Amader Para, Amader Samadhan (Our neighbourhood, our Solution) is the first-of-its-kind initiative in the country, Chief Minister Mamata Banerjee had said while outlining the scheme on July 22.

A task force headed by Chief Secretary State Manoj Pant would monitor the programme, and district-level task forces have been formed as many camps started functioning on Saturday.

"We are sanctioning Rs 10 lakh per booth. In total, the state government will be spending Rs 8000 crore on this programme. It will start on August 2,' she had said last week.

While these camps will be held for two months, there will be an administrative evaluation for 30 days, a government statement said.

"The implementation or addressing the issues raised by the people will take a period of three months from the day of launch," it said.

In the Kolkata Munici-Corporation area, there is one camp for every two booths. 'We had seen that

there are small teething issues plaguing a locality, which are too localised but need urgent attention. "While local civic bodies, people's representa-

tives and various agencies are there to look into various issues - like the setting up of a tap, need for an

proper lighting in the area, this interactive initiative is an inclusive one where various things can be brought up for being sorted out under one umbrella," a senior governofficial However in view of the growing demand from the people of different localities in districts specially in semi urban areas, decision has also been taken to repair local roads under the programme as many of these roads are full of pot holes causing immense problem for the plying of all types of vehicles includ-



Mamata Banerjee had said state government officials will be present on the ground to listen to the people's problems, and the centres will address these issues in a locality.

Meghalaya govt orders probe into 'mysterious disappearance' of 4,000 tonnes of coal

MI News Service, Shillong: In order to prevent massive corruption in government departments, the Meghalaya government has ordered a Commissioner level inquiry into the alleged misappropriation of over 4,000 metric tonnes (MT) of coal in the state. Informing this Deputy Chief Minister Prestone Tynsong. who also holds the Home portfolio, said on Saturday that instructions have been issued to the district authorities and the police to conduct a thorough inquiry into the matter.

'We have asked Deputy Commissioners and Superintendents of Police to investigate if there has been any misappropriation or illegal diversion of coal," the Deputy Chief minister said.

The directive comes close on the heels of a revelation by a High Court-appointed committee that over 4,000 metric tonnes of coal, already declared as extracted and inventoried, have vanished from two designated storage sites. The Committee, in its latest report to the Meghalaya High Court, said the disappearance raises serious questions about the state's mechanism for monitoring coal stock and preventing illegal transportation. Tynsong further stated that the government will take strong and appropriate action if any wrongdoing is established.

"If there is anything wrong, we will proceed according to the law. Even if it requires us to approach the Supreme Court, we will do so," he added.

The state's probe will focus on tracing both diesel and coal inventories, including movement, documentation, and field verification. A comprehensive report will be prepared and shared with the court in due course, an official said. The committee, in its latest report to the Meghalaya High Court, said the disappearance raises serious questions about the state's mechanism for monitoring coal stock and preventing illegal transportation. After the court pulled up the state government, state minister Kyrmen Shylla – who is from Jaintia hills that has the most coal reserves in the state – was quoted as saying: "I am not trying to justify but we need to remind ourselves that If you remember, Meghalaya has one of the highest rainfall in the country. So due to this high and heavy rainfall anything can happen. "Remember, there is an allegation that because of the rains in Meghalaya, floods happened in Assam, and from East Jaintia hills, rain water goes to Bangladesh. You never know, it could be because of the rains the coal got carried away," the minister had told reporters in Shillong on Monday.

PM Modi launches Rs 2,183.45 crore development projects in Varanasi

MI News Service, Varanasi: In his second visit to his Parliamentary constituency in three months, Prime Minister Narendra Modi inaugurated and laid foundation stones for as many as 52 development projects worth approximately Rs 2,183.45 crore in Varanari on Saturday.

In a major move to support farmers, the Prime Minister, as promised a couple of days ago, also released the 20th instalment of the PM-Kisan Samman Nidhi, transferring Rs 20,500 crore to the bank accounts of over 9.70 crore eligible farm-

ers across the country.

Additionally, he distributed assistive devices such as wheelchairs, tricycles, and visual aids to many people with disabilities and senior citizens during a special programme held at Banauli village in the Sevapuri block in his constituency in

"Hum Kaashi ke har parivar-jan ke pranaam karat hai (I extend my respectful greetings to every family of Varanasi)", said the Prime minister in the local dialect, drawing massive cheers from the crowd as he began his address.

Uttar Pradesh Chief Minister Yogi Adityanath, both his deputies—Keshav Prasad Maurya and Brajesh Pathak along with several ministers, public representatives, and BJP's state unit president Bhupendra Singh Chaudhary were present at the event.

According to Dilip Patel, head of the BJP's Kashi region unit, this marks PM Modi's 51st visit to his parliamentary constituency since he assumed office in

Coming just ahead of Rakshabandhan and in the auspicious month of Shravan, the visit is expected to provide a significant developmental boost to the Purvanchal region.

The 52 projects span key sectors such as road infrastructure, healthcare, education, sports, tourism, and urban development. Initiatives include road construction and their widening, hospital upgrades, improvement of educational institutions, better drinking water and sanitation, development of sports infrastructure, establishment of a homeopathic college, construction of paved ghats for religious tourism, expansion of electricity and parking facilities, pond renovation, and the setting up of libraries, animal hospitals, and dog care centres, according to an official statement.

These initiatives are designed to drive comprehensive urban transformation, revitalize cultural heritage, enhance connectivity, and elevate the overall quality of life in Varanasi. The Prime Minister landed in Varanasi at nearly 11 AM and soon afterwards laid lay the foundation stone and opened several development projects worth around Rs 2,200 crore. During her visit the Chief minister might hold an administrative meeting to streamline the efforts in providing relief to the marooned people apart from directing relief and rescue efforts and the rehabilitation process

Around 13 wards under Ghatal civic body and five Gram Panchayat areas are under water. Attendance in schools was thin, forcing many schools to postpone examinations.

Meanwhile, amid alleged release of excessive waters by the Damodar Valley Corporation (DVC), a worried state secretariat at Nabanna today wrote to the DVC for releasing waters without a proper plan in place.

As sources claimed, chief engineer of the state irrigation department has sent the letter, asking the DVC to release waters adhering to a proper plan.

The DVC had in the last 24 hours released 49,000 cusecs of waters, which would further precipitate the crisis as most rivers are in a spate.

more terrorists killed in encounter in J-K

MI News Service, Srinagar : After a few days lull, two more terrorists were killed following a fierce encounter with security forces in Jammu and Kashmir's Kulgam district

on Saturday, officials said. overnight encounter began after security forces launched a cordon and search operation in a forest area at Akhal in the south Kashmir district, following specific intelligence inputs about the presence of terrorists there.

After an initial exchange of fire between the two sides on Friday evening, the operation was halted for the nightbefore it began from early this morning. the officials said. "Intermittent and in-

tense fire fight continued through the night. Alert troops responded with calibrated fire and tightened the nooze while maintaining contact. One terrorist has been neutralised by Operation (Akhal) continues," Army's Chinar Corps said in a post on X this morning. Efforts are now being made to establish the true identity of both the deceased terrorists, they said. The encounter comes days after three heavily armed terrorists who carried out the deadly Pahalgam attack on April 22 were killed by security forces near Srinagar under

'Operation Mahadev'. They gunned down Sulieman alias Asif, the alleged mastermind of the Pahalgam attack, along with two of his associates, in an encounter at Mulnar in the Harwan area near Dachigam National Park on July 28. The other terrorists killed in the action who was involved in the Sonamarg Tunnel attack last year, and Hamza Afghani.

people, mostly 26 tourists, were shot dead by terrorists at Baisaran meadows in Pahalgam, which prompted armed forces to launch Operation Sindoor on May 7 against the terror infrastructure in Pakistan.

On Thursday, two more terrorists were killed near the Line of Control (LoC) in Poonch. Police said that the duo had infiltrated from Pakistan and were intercepted soon after they entered the Indian side.

Pakistani woman deported after Pahalgam attack to get visitor's visa



MI News Service, Jammu / New **Delhi :** The Ministry of Home Affairs (MHA) has informed the Jammu, Kashmir and Ladakh High Court that it has decided to grant a visitor's visa to Rakshanda Rashid, a Pakistani woman who was deported from Jammu after the April 22 Pahalgam terror attack, prompting the court to dismiss her petition seeking nod to return to her family here.

The court, has however, stated that the MHA order should not con-

Rashid (62), a Pakistani citizen who married Sheikh Zahoor Ahmed 35 years ago in Jammu, was deported as part of the decision taken by the Indian government to deport Pakistani nationals staying in India in the aftermath of the Pahalgam terror attack that claimed 26 lives.

Her husband is Sheikh Zahoor Ahmed, chairman of the Muslim Front, Jammu. Sharing details, advocate Ankur Sharma said, "The UT

government and Government of India had challenged a previous single-judge order wherein it was directed to bring back Rakshanda from Pakistan within 10 days following her deportation. The authorities have now agreed to issue a visitor visa to her.'

Rakshanda had applied for the renewal of her long-term visa (LTV), which had expired in January. While the authorities were processing her case, the Pahalgam attack

unfolded and she was told to leave for Pakistan after the Centre's decision to deport all Pakistani nationals.A division bench, comprising chief justice Arun Palli and justice Rajnesh Oswal, on Friday gave its assent to the authorities concerned for allowing the visitor's visa to the elderly woman. The court, however, said that the arrangement "shall not constitute a precedent in any

No duty concessions to US on agri, dairy, GM foods as India toughen stand

MI News Service, New Delhi : After the imposition of an additional 25 per cent import duty on Indian goods entering American markets from August 7 by the US President Donald Trump (on Thursday), India has toughened its stance on extending duty concessions on agri products, dairy and GM foods in the proposed bilateral trade agreement (BTA) with the

With the US not being able to finalise a permanent trade deal with India so far and specially after President Trump has unilaterally announced the imposition of additional 25 per cent tariff, India has decided to toughen its stand on the reciprocal basis on some of its essential products,

informed sources said here on Saturday. Earlier, this 25 per cent duty was to be

imposed from August 1. The President has also not specified the amount of additional penalty, which he has announced on India for buying crude oil and military equipment from Russia. Incidentally, India and the US have entered into negotiations for a fair, balanced and mutually beneficial BTA in March 2025 with a target to complete the first tranche/phase of the pact by October-November this year. So far, five rounds of talks have been completed. For the next round, the US team,

Puja payouts amid potholes: Jamuria locals question priorities

MI News Service, Asansol: A controversy has erupted in Jamuria, Asansol, over the government's decision to grant ₹1.10 lakh to each Durga Puja committee, while vital infrastructure—especially schools and roads-remains in disrepair. Though Puja organizers welcomed the ₹25,000 hike from last year, residents of Bakshimulia village voiced outrage over the state of local public education.

The secondary school in Bakshimulia, serving students from multiple wards and nearby panchayat areas, faces a dire teacher shortage. Once staffed with 17 teachers, only 9 remain today. No new appointments have been made, and a court-ordered cancellation of past hires further depleted staff. Teachers are now forced to handle subjects outside their expertise, with non-teaching staff sometimes stepping in. The result has been a sharp decline in academic outcomes—only 42 out of 92 students passed the Madhyamik exam this year. Compounding the crisis is the school's access road, which remains unpaved and becomes nearly impassable during the monsoon.

Citizenship confusion: NRC notice to Bengal man sparks outcry

MI News Service, Cooch bors expressed shock, noting **Behar:** Panic has gripped a family in Rampur Block 2 of Cooch Behar after Dipankar Sarkar, a lifelong West Bengal resident, received multiple notices related to the National Register of Citizens (NRC)-despite never having settled in Assam. Dipankar, a migrant laborer who has worked in Assam for over 15 years, was first served an NRC notice earlier this year and another more recently. Initially dismissing it as an error, he became alarmed after repeated calls from police demanding proof of his citizen-

"I didn't take the first notice seriously. But now the police are calling often. I've submitted all the documents I have," said Dipankar, who returned home on July 10 to resolve the matter. However, some key documents

that Dipankar's family has deep roots in Rampur. "His father was born here. They may be of refugee origin, but they've lived here for generations," said a local resident. District leader Abhijit De Bhowmik visited Dipankar's home, calling the situation "deeply concerning" and blaming "dangerous political divisions." This isn't the first case—Uttam Kumar Brajbasi of Dinhata faced similar harassment, drawing condemnation from Chief Minister Mamata Banerjee, who decried the targeting of legitimate citizens under the NRC. With more such cases emerging in border districts, fears are mounting administrative confusion threatening the rights of long-settled families with historical ties to Bangladesh. The extraordinary incident unfolded when 21-year-old Shaha Banu Devi, a resident of Assam's Bongaigaon district, went into labour while travelling from Bengaluru with

her family. According to railway sources, the expectant mother began experiencing severe labour pains shortly after the train crossed Balasore. Realizing the urgency of the situation, her family members immediately alerted the Railway Protection Force (RPF) personnel and the train's Ticket Examiner (TTI). With no time to transfer her to a medical facility, Shaha Banu Devi delivered her baby girl inside the moving train. Upon receiving the emergency alert, the train was halted at Belda station in West Bengal's Paschim Medinipur district. Railway officials, local healthcare responders, and RPF personnel sprang into action. Ambulances and stretchers were brought to the platform as the mother and newborn were safely evacuated from the compartment and rushed to Belda Super Specialty Hospital. Hospital authorities later confirmed that both mother and child are stable and in good health. "The passenger's condition was deteriorating, and it was becoming risky to delay further," a railway police officer said. "We are relieved that the emergency measures helped save two lives." The incident has drawn praise for the railway staff and fellow passengers, who acted with remarkable urgency and compassion. Their swift response turned a potential crisis into a moment of joy, as a new life began amidst the rhythm of

Mob justice in Durgapur: BJP leaders assault innocents

MI News Service, Durgapur: A disturbing case of mob justice has jolted Durgapur, where BJP workers—allegedly led by Yuva Morcha leader Parijat Gangopadhyay—brutally assaulted the occupants of a cattle-laden vehicle in broad daylight on Thursday. The attack occurred in the DPL Township area and quickly drew massive outrage after horrifying visuals of the assault went viral on social media. The victims were accused of cow smuggling, tied up, beaten, robbed, and humiliated—forced to walk while holding their ears in a public display of shame.

TMC leader and Pandaveswar MLA Narendranath Chakraborty condemned the act as "a dangerous escalation of political hooliganism," asserting that the men had legally purchased cows from Bankura and were transporting them to Jemua with valid documentation. Asansol-Durgapur Police Commissioner

Sunil Kumar Chowdhury confirmed that the transport was fully legal, dismissing the cow smuggling allegations. Two BJPlinked individuals—Deepak Das and Anish Bhattacharya—have been arrested, while 15-20 others have been identified. "No one is above the law," said the Commissioner, vowing swift justice. Parijat Gangopadhyay remains absconding but issued a defiant statement claiming the men lacked valid documents, justifying the mob's actions as "public resistance." He vowed to continue his campaign against cow smuggling, regardless of arrest. The incident has deepened political tensions in West Bengal, with TMC accusing BJP of promoting lawlessness. Civil society voices are raising alarms over the growing trend of mob violence cloaked in religious rhetoric, calling this case a critical test for law enforcement and democratic accountability.

Digital control room to be inaugurated at Nabanna

MI News Service, Kolkata: In a significant leap towards modernization and administrative efficiency, a state-of-the-art Digital Control Room is set to be inaugurated on the third floor of Nabanna, the administrative headquarters of West Bengal. The initiative marks a decisive step in the government's effort to digitize all official records and enhance real-time surveillance across the state.

According to official sources, the control room will not only digitize documentation processes but also provide live access to CCTV footage from multiple districts and remote regions. This centralized visual monitoring system is expected to play a pivotal role in ensuring law and order throughout West Bengal.

The control room will operate under the direct supervision of the Additional Director General (ADG) of Law and Order. The operational team will include one Sub-Inspector, two Assistant Sub-Inspectors (ASIs), and six constables. 

While this list identifies which names are missing from the draft voter roll, it does not mention why they were excluded," he said.

"This makes it impossible for political parties or to death, migration, or any other legitimate reason," Tejashwi claimed.

Malayalam writer, scholar and former **MLA Prof MK Sanu passes away**

Study finds how certain diabetes medications might prevent dementia

a study published, sodium-glucose cotransporter-2 inhibitors used to treat type 2 diabetes may prevent dementia, with higher advantages with prolonged

The findings of the Korea study were published in The BMJ.

The effect size may have been exaggerated in this observational analysis, the researchers add, and they now state that randomized controlled trials are required to corroborate these results.

According to the World Health Organization, the number of people with dementia globally is expected to reach 78 million by 2030 and type 2 diabetes is associated with a greater risk of developing dementia. A recent study of over 65s with type 2 diabetes suggested a decreased risk of dementia associated with SGLT-2 inhibitors versus another type of diabetes drug, dipeptidyl peptidase-4 (DPP-4) inhibitors. But the effects on younger people and specific types of dementia (eg, Alzheimer's disease, vascular dementia) remains unclear. To address this, researchers used the Korea National Health Insurance Service database to identify 110,885 pairs of adults with type 2 diabetes aged 40-69 years who were free of dementia and started



or a DPP-4 inhibitor between 2013 and 2021. All participants (average age 62; 56% men) were matched by age, sex, use of the diabetes drug metformin, and baseline cardiovascular risk and were followed up for an average of 670 days to see who developed

Potentially influential factors including personal characteristics, income level, underlying risk factors for dementia, other conditions and related medicine use, were also taken into account.

Over the follow-up period, a total of 1,172 participants with newly diagnosed dementia were identified. Dementia rates per 100 person years were 0.22 for those using SGLT-2 inhibitors and 0.35 for those using DPP-4 inhibitors, corresponding to a 35% reduced risk of dementia associated with use of SGLT-2 inhibitors compared with DPP-4 inhibitors. researchers also found a 39% reduced risk for Alzheimer's disease, and a 52% reduced risk for vascular dementia associated with SGLT-2 inhibitors compared with DPP-4 inhibitors.

What's more, the effect of SGLT-2 inhibitors seemed more pronounced with longer treatment duration. A 48% reduced risk of dementia was seen for more than two years of treatment versus a 43% reduced risk for two years or less. This is an observational study so no firm conclusions can be drawn about cause and effect, and the authors note that details of health behaviours (eg, smoking and alcohol consumption) and duration of type 2 diabetes were not fully available.

However, they point out that

nationally representative data that included relatively younger people with type 2 diabetes, and results were highly consistent across subgroups. As such, they say SGLT-2 inhibitors might prevent dementia, providing greater benefits with longer treatment, and they call for randomised controlled trials to confirm these findings. This study reports promising results that have important implications for clinical practice as well as from a public health perspective, say researchers from Taiwan in a linked editorial. They agree that further trials are needed to confirm these findings, and suggest that studies are also needed to explore the underlying mechanisms of any neuroprotective effects of SGLT-2 inhibitors." As no cure currently exists for dementia and few effective treatment options are available, strategies that can potentially prevent onset are critically important, they write. Given the substantial socioeconomic and public health burdens associated with both dementia and type 2 diabetes, they also recommend that clinical guidelines and healthcare policies should be updated regularly to incorporate latest best evidence on the potential benefits of SGLT-2 inhibitors, including reduced

Study finds temperature can influence microbial competition in rivers

LOS ANGELES [US]: Wastewater-derived antimicrobial resistance genes (ARGs) can penetrate and initially join natural biofilms after being injected into a river, a study said. Although, they may not last long, researchers reported this week in mSphere

However, as the river's temperature rises, the frequency of invasive ARGs reduces considerably, indicating that the preexisting microbial community is removing the resistant intruders. In barely two weeks, the concentration of ARGs in river water at 30 degrees Celsius (86 degrees Fahrenheit) returned to its initial level.

The finding suggests that rivers may offer a kind of defence against the spread of ARGs in wastewater. It was also contrary to what the researchers expect-

Most ARGs in wastewater originate in human faeces and thrive at the temperature of the human body, which is higher than most waterways. The microbiologists anticipated that warm rivers would be a welcome environment. "We thought they should be rather well-adapted to higher temperatures," said microbiologist Uli Klumper, PhD, at Technische Universitat Dresden's Institute of Hydrobiology.

"So if river temperatures are rising with climate change, we wanted to know if these bacteria from wastewater would have an easier time integrating with the natural biofilms.

Klumper co-led the study with his PhD student Kenyum Bagra, who joined TU Dresden on a DAAD exchange fellowship from the Indian Institute of Technology Roorkee, who led the study. The work was funded through the ANTIVERSA project by BiodivERsA, a European biodiversity organization.

Klumper, Bagra and their colleagues first immersed 27 glass slides in the Lockwitzbach River,



in eastern Germany, for a month. "It's relatively pristine," Klumper said.

They collected the slides, which had amassed a natural biofilm from the river, and immersed them in artificial river systems at 1 of 3 temperatures. After a week, they observed that the abundance of naturally occurring ARGs increased in the warmest water, at

30 degrees Celsius. Then, they exposed all the test slides to wastewater for 1 day and monitored the abundance of ARGs, both those that occurred naturally and those from wastewater, over the next 2 weeks. The ARGs from the wastewater readily invaded the biofilm in all 3 cases, with no difference in abundance by tem-

"The introduction seems to be temperature independent," Klumper said.

But that's where the similarities ended. In the warmest water, the abundance of the invasive ARGs dropped significantly over 2 weeks. By the end of the experiment, the overall level of ARGs had returned to its initial, natural abundance, and the invasive ARGs


Study reveals how new breast imaging tech transforms cancer diagnosis

ILLINOIS [US]: A new breast imaging technique detects cancer with high sensitivity while significantly lowering the likelihood of false-positive results, according to a study published today in Radiology: Imaging Cancer, a journal of the Radiological Society of North America.

Because nearly half of the screening population has dense breasts, many of these individuals require further breast imaging, usually with an MRI, following mammography. Low-dose positron emission mammography (PEM) is a novel molecular imaging technique that provides improved diagnostic performance at a radiation dose comparable to that of mammography. For the study, 25 women, median age 52, recently diagnosed with breast cancer, underwent low-dose PEM with the radiotracer fluorine 18-labeled fluorodeoxyglucose (18F-FDG). Two breast radiologists reviewed PEM images taken one and four hours post-18F-FDG injection and correlated the findings with lab results.

PEM displayed comparable performance to MRI, identifying 24 of the 25 invasive cancers (96 per cent). Its falsepositive rate was only 16 per cent, compared with 62 per



cent for MRI. Along with its strong sensitivity and low false positive rate, PEM could potentially decrease downstream healthcare costs, as this study shows it may prevent further unnecessary work compared to MRI. Additionally, the technology is designed to deliver a radiation dose comparable to that of traditional mammography without the need for breast compression, which can often be uncomfortable for patients. "The integration of these features--high sensitivity, lower false-positive rates, cost-efficiency, acceptable radiation levels without compression, and independence from breast density--positions this emerging imaging modality as a potential groundbreaking advancement in the

"As such, it holds the promise of transforming breast cancer diagnostics and screening in the near future, complementing or even improving current imaging methods, marking a significant step forward in breast cancer care. Low-dose PEM offers potential clinical uses in both

screening and diagnostic settings, according to Dr Freitas. "For screening, its ability to perform effectively regardless of breast density potentially addresses a significant

shortcoming of mammography, particularly in detecting cancers in dense breasts where lesions may be obscured," "It also presents a viable option for patients at high risk

who are claustrophobic or have contraindications for MRI." The technology could also play a crucial role in interpreting uncertain mammogram results, evaluating the response to chemotherapy, and ascertaining the extent of disease in newly diagnosed breast cancer, including involvement of the other breast. Dr Freitas, who is also a staff radiologist in the Breast Imaging Division of the Toronto Joint Department of Medical Imaging, University Health Network, Sinai Health System, and Women's College Hospital, is currently researching PEM's ability to reduce the high rates of false positives typically associated with MRI scans. "Should PEM successfully lower these rates, it could significantly lessen the emotional distress and anxiety linked to false positives," Dr Freitas said. Additionally, it might lead to a decrease in unnecessary

Study finds how new type of cell therapy help ARDS patients

LOS ANGELES [US] : A novel form of cell therapy may help patients who are critically ill with acute respiratory dis-tress syndrome (ARDS) brought on by severe COVID-19, according to a study. Professor Justin Stebbing of Anglia Ruskin University (ARU) is a co-senior author of a recent study that examines the application of agenT-797, an allogeneic, unmodified invariant natural killer T (iNKT) cell treatment developed by MiNK Therapeutics. The work was published in journal Nature Communications. The iNKT cell therapy has the effect of rescuing depleted T cells and inducing an anti-inflammatory cytokine response, perhaps activating antiviral immunity to assist these patients fight infection while also reducing severe, pathogenic inflammation of the lung. The new research was carried out at three medical centres and found that agenT-797, which is also under investigation in cancer trials, could be manufactured rapidly, had a tolerable safety profile and appeared to have a positive effect on mortality among critically unwell ČOVID-19 ARDS patients receiving intensive care.

The exploratory trial included 20 mechanically ventilated patients with severe ARDS secondary to Covid-19. Of the 20 patients in the trial, 14 survived (70 per cent) at 30 days (compared to a control group of 10 per cent), and there was an 80 per cent lower occurrence of bacterial pneumonia amongst those who received the highest dosage of agenT-797, compared to those who received fewer cells. Twenty-one patients were treated overall (the main trial, plus one under compassionate use), which included five who were also receiving veno-venous extracorporeal membrane oxygenation (VV-ECMO), known as 'the most aggresVV-ECMO, deoxygenated blood is pumped through a membrane lung and returned to the body via a cannula. This trial is believed to be the first immune cell therapy of any type to be used in critically unwell patients undergoing VV-ECMO. Survival of the VV-ECMO cohort was 80 per cent after 30 and 90 days, and 60 per cent after 120 days. This compares favourably to the overall survival of 51 per cent for patients with Covid-19 who were treated with just VV-ECMO at the same institution, during the same timeframe. Joint senior author Justin Stebbing, Professor of Biomedical Sciences at Anglia Ruskin University (ARU) in Cambridge, England, said, "During this small, exploratostudy we observed that MiNK's iNKT cell treatment, which is also being advanced for people with cancer, triggered an anti-inflammatory

Despite a poor prognosis critically ill patients treated with this therapy showed favourable mortality rates and those treated at the highest dose also had reduced rates of pneumonia, underscoring the potential application of iNKT cells, and agenT-797 in particular, in treating viral diseases and infections

Do you know genetic malfunction causes rare lung disease? Study finds

NEW YORK [US]: One of the most significant cells in the body is the macrophage. This immune cell, dubbed "big eater" in Greek, eats and breaks down dangerous substances like dust, debris, bacteria, and cancer cells. Macrophages play a particularly important role in the lungs, where they combat bacterial infections and remove excess surfactant, a lipid- and protein-rich covering that is essential for lung health but can accumulate sticky matter if left unchecked.

Researchers from Rockefeller University and other institutions have discovered a hereditary illness that causes defective cell function that was previously unknown.

By noticing an unexpected link between a particular subset of sick kids, the researchers were able to make their breakthrough. These nine youngsters had fought lifelong battles with life-threatening conditions such as progressive polycystic lung disease, pulmonary alveolar proteinosis (PAP), and recurring viral and bacterial infections that frequently left their lungs riddled with cysts and left them gasping for air. But as genomic data revealed, the children shared another characteristic: the absence of a chemical receptor that is supposed to call alveolar macrophages into action. It's the first time that this missing receptor, called CCR2, has been linked to disease. The researchers, including Rockefeller's Jean-Laurent Casanova and Institut Imagine's Anna-Lena Neehus, recently published their results in Cell.

The study also found that the children are missing half of their alveolar macrophages, which are located in the air sacs of the lungs.

"It was surprising to find that CCR2 is so essential for alveolar macrophages to properly function," said Casanova. "When it comes to lung defense and cleanup, people without it are operating at a double loss.

More formally known as C-C motif chemokine receptor 2, CCR2 sits on the surface of alveolar macrophages, a kind of monocyte (or white blood cell). It responds to the presence of a chemical ligand, or binding molecule, known as CCL-2, which is also expressed by monocytes.

The receptor and ligand work together to summon macrophages to the site of an infection, and to maintain the appropriate level of surfactant; too little can lead to collapsed lung tissue, and too much can result in narrowed airways.

It was among these immune cells that first author Neehus, of Casanova's lab at the Institut Imagine in Paris, was seeking evidence of genetic deficiencies that might

bodies that cripple a protein that stimulates the growth of infection-fighting white blood cells. The girls, however, didn't have the PAP autoantibodies. Instead, they had no CCR2--a newly identified genetic mutation. Perhaps its lack was connected to their pulmonary conditions, Neehus thought.

"It looked interesting and promising," she recalled. She soon found seven other children in the cohort who had the same CCR2 mutation and serious lung conditions: two more pairs of siblings, and one trio of siblings. They were from the United States and Iran. To explore the impact the variant might have on the children, the researchers

Several key findings emerged. "First we discovered that these patients have only half the normal counts of pulmonary alveolar macrophages, which explains the different types of lesions they have across the pulmonary tissues," says Casanova. With only half a crew, the reduced cleanup unit couldn't keep up with its workload, leading to tissue injury.

The macrophages were otherwise normal, as were the children's other immune cells. Without CCR2 signaling, monocytes have no idea where they're needed. In the study, a live-imaging analysis of the monocytes from the lungs of a 10-year-old girl with CCR2 deficiency showed the cells milling about aimlessly, unsure where to go. (See gif at top.) In contrast, live imaging of monocytes from a healthy control patient shows them migrating in the same direction, summoned by the teamwork of CCR2

This directionlessness also makes those with a CCR2 deficiency more susceptible to mycobacterial infections, because the macrophages can't find their way to the tissue clusters where mycobacteria take up residence, and thus digest the invaders. This had dire effects for three of the children in the study, who developed bacterial infections after being vaccinated with a liveattenuated substrain of Mycobacterium bovis, an agent of tuberculosis. Their immune systems failed to assemble a legion of macrophages at the vaccination site in the shoulder, causing tissue destruction or hard nodes that had to be surgically removed, or lymph node infections. (All of the children were effectively treated with antibiotics.)

The children inherited the deficiency from their parents--and yet their parents were healthy. "Each of the parents carries one disease copy of the gene, and both parents gave the affected copy to their chil-dren," said Neehus. "The parents aren't affected because they each only have one copy, whereas the kids have two.

Ševeral children were the result of consanguineous marriages, in which the parents are related. The offspring of such pairings have a higher risk of inheriting the mutation that causes CCR2 to disappear.

Portuguese Prime Minister Luis Montenegro said on Thursday that the government intends to consult President Marcelo Rebelo de Sousa and all political parties represented in Parliament to consider recognizing the State of Palestine during the 80th United Nations General

Assembly in September.

Former JD (S) MP Prajwal Revanna gets life imprisonment in rape case

MI News Service, Bengaluru: The Bengaluru Special Court, on Saturday, August 2, sentenced life imprisonment to former MP and suspended JD(S) leader Prajwal Revanna in a sexual assault and rape case involving a 48-year-old domestic help. The court also imposed a total fine of Rs 10 lakh on him. On Friday, the 34-year-old was convicted by the special court in one of the four sexual abuse and rape cases registered against him. The domestic help worked as the family's Gannikada farmhouse in Hassan district's Holenarasipura. She was raped at Hassan farmhouse and Bengaluru residence twice in 2021, and the act was recorded by the accused on his mobile phone. Earlier in the day, while the prosecution sought a life sentence for Revanna, the former MP sought leniency, claiming he did nothing wrong and that his only mistake was his



'fast' growth in politics. He broke down in court as he appealed to the judge for a lesser punishment. "...they say that I have raped multiple women, but none of the women have come out voluntarily to complain, they came six days prior to election (Lok Sabha polls last year)...the prosecution side brought them purposefully and made them give a complaint,"

Prajwal told the court. Pointing out that the woman (victim) had not complained to anyone, including her husband or kin, about the alleged rape, he said that she came and gave complaint when certain videos were circulated. Stating that he will bow down to the court's conviction, Prajwal said, "I have a family, I have not seen my mother and father for six months now....please give me a less sentence is what I request the court." "The only mistake I made in my life is growing fast in politics," Prajwal, arrested in May last year upon his arrival from Germany, told the court. The Special Investigation Team (SIT) which probed the case had filed a 1,632-page charge sheet with 113 witnesses in the case in September, 2024. Prajwal Revanna is the grandson of former Prime Minister and JD (S) patriarch H D Deve

Over 10,000 Gaza families receive cash aid amid hunger crisis: UN

MI News Service, United Nations: Relief workers have handed cash to more than 10,000 hungry families in Gaza, who find little food on the market to spend on, UN humanitarians said. "Market prices remain highly volatile and out of reach for many,' the UN Office for the Coordination of Humanitarian Affairs (OCHA) said on Friday, August 1. OCHA said that nearly a week after the Israelis allowed the scale-up of



relief convoys, the assistance that has entered Gaza remains insufficient. Convoys continue to face obstacles and danger along the routes mapped out by the Israeli authorities, Xinhua news agency reported. The office said the months-long deprivation of most life-sustaining basics has led to a deepening of the crisis, and large numbers of people reportedly continue to be killed and injured searching for food. More than 100 peotion ... We need to flood the strip with supplies using all channels and all gates," he said. OCHA said fuel remains in short supply, although limited quantities have been allowed to enter Gaza in recent days. "The United Nations and our partners need hundreds of thousands of liters of fuel every day to power critical facilities, including health, water and sanitation, as well as emergency telecommunication services," the office said.

Palestinian state backed by Western allies as **Gaza war rages**

MI News Service, Gaza Strip: Plans announced by France, the United Kingdom and Canada to recognise a Palestinian state won't bring one about anytime soon, though they could further isolate Israel and strengthen the Palestinians' negotiating position over the long term. The problem for the Palestinians is that there may not be a long term.

Israeli Prime Minister Benjamin Netanyahu rejects Palestinian statehood and has vowed to maintain open-ended control over annexed east Jerusalem, the occupied West Bank and the war-ravaged Gaza Strip territories Israel seized in the 1967 war that the Palestinians want for their state. Israeli leaders favour the outright annexation of much of the West Bank, where Israel has already built well over 100 settlements housing over 500,000 Jewish settlers. Israel's offensive in Gaza has reduced most of it to a smoldering wasteland and is pushing it toward famine, and Israel says it is pressing ahead with plans to relocate much of its population of some 2 million to other countries. The United States, the only country with any real leverage over Israel, has taken its side. Palestinians have welcomed international support for their decades-long quest for statehood but say there are more urgent measures Western countries could take if they wanted to pressure Israel

"It's a bit odd that the response to daily atrocities in Gaza, including what is by all accounts deliberate starvation, is to recognize a theoretical Palestinian state that may never actually come into being," said Khaled Elgindy, a visiting scholar at Georgetown University's Centre for Contemporary Arab Studies. "It looks more like a way for these countries to appear to be doing something," he said. Fathi Nimer, a policy fellow at Al-Shabaka, a Palestinian think tank, says they could have suspended trade agreements with Israel, imposed arms embargoes or other sanctions. "There is a wide tool set at the disposal of these coun tries, but there is no political will to use it," he said. Most countries in the world recognized Palestinian statehood decades ago, but Britain and France would be the third and fourth permanent members of the UN Security Council to do so, leaving the US as the only holdout. "We're talking about major countries and major Israeli allies," said Alon Pinkas, an Israeli political analyst and former consul general in New York. "They're isolating the US and they're leaving Israel dependent — not on the US, but on the whims and erratic behavior of one person, Trump." Recognition could also strengthen moves to prevent annexation, said Hugh Lovatt, an expert on the conflict at the European Council on Foreign Relations. The challenge, he said, "is for those recognizing countries to match their recognition with other steps, practical steps." Netanyahu says creating a Palestinian state would reward Hamas and eventually lead to an even larger Hamas-run

Donald Trump orders nuclear submarines to reposition amid war of words with Russia

MI News Service, Washington D.C.: United States President Donald Trump has ordered two nuclear submarines to shift their locations relative to Russia, as part of his latest tit-for-tat with leader Medvedev. On Friday, Trump posted on his platform Truth Social that the submarine movements came in response to the "highly provocative statements" Medvedev, a former Russian

president, made this week. A day earlier, Medvedev had warned that Trump should be mindful of "how dangerous the fabled 'Dead Hand' can be", a

reference to Russia's Cold Warera nuclear weapons system. "I have ordered two Nuclear Submarines to be positioned in the appropriate regions, just in case these foolish and inflammatory statements are more than just that," Trump wrote.

"Words are very important, and can often lead to unintended consequences. I hope this will not be one of those instances." In recent weeks, Trump has been enmeshed in an escalating war of words with Medvedev, who currently serves as the deputy chairman of Russia's Security Council under current President

Putin have a close relationship: When Medvedev served as president from 2008 to 2012. Putin was his prime minister. Afterwards, when Putin returned to the presidency, Medvedev served as his prime minister from 2012

But as Trump voices increasing frustration with Russia's ongoing invasion of Ukraine, he has increasingly singled out Medvedev, a noted war hawk, as a target for his anger. Both men have hinted at their countries' nuclear capabilities, and their public exchanges have grown in-

Vladimir Putin. Medvedev and creasingly tense. In a social media post earlier this week, Trump pivoted from a discussion of trade between India and Russia to an attack on Medvedev for his sabre-rattling remarks.

"I don't care what India does with Russia. They can take their dead economies down together, for all I care," Trump wrote. "Russia and the USA do almost no business together. Let's keep it that way, and tell Medvedev, the failed former President of Russia, who thinks he's still President, to watch his words. He's entering very dangerous territory!" Medvedev, mean-

while, has appeared to relish how his words provoke the US president.

"If some words from the former president of Russia trigger such a nervous reaction from the high-and-mighty president of the United States, then Russia is doing everything right and will continue to proceed along its own path," Medvedev responded in a post on Telegram. Medvedev then proceeded to reference the zombie apocalypse series The Walking Dead, in an apparent nod to the devastation Russia has the power to cause.

"And as for the 'dead econ-

omy' of India and Russia and 'entering dangerous territory' well, let Trump remember his favourite films about the 'Walking Dead'.

This week is not the first time Trump and Medvedev have taken their beef online. In late June, the two men likewise sparred and flexed their nuclear arsenals. Yashasvi Jaiswal's 118-run knock guides India to 304/6 against England at Tea on Day 5; visitors lead by 281 runs



LONDON [UK] : Young Indian opener Yashasvi Jaiswal's exceptional innings of 118 runs gave India an upper hand after the end of the second session in the fifth and final Test of the Anderson Tendulkar Trophy 2025, which is being played at the Kennington Oval in London on Saturday.

At the stroke of Tea on Day 3 of The Oval Test, Team India are 304/6 with Ravindra Jadeja and Dhruv Jurel unbeaten on the crease. After the end of the session, the Shubman Gill-led side led by 281 runs.

The visitors started the second session from 189/4 with Jaiswal (85*) and Gill (11*) unbeaten on the crease.

India didn't have a good start to the session as they lost the

wicket of Gill (11 runs off 9 balls). He was dismissed by the bowling of Gus Atkinson.

Team India touched the 200run mark in their 48th over. In the 51st over, Yashasvi Jaiswal completed his ton in 127 balls.

In the 55th over at the score of 229, Karun Nair (17 runs from 32 balls) was sent back to the pavilion as he was dismissed by Atkinson.

On the fourth ball of the 58th over, Jaiswal slammed a boundary, which brought his team's 250 in the innings.

In the 65th over at the score of 273, Jaiswal (118 runs in 164balls) was dismissed on the bowling of Josh Tongue.

Following Jaiswal's dismissal, the team's wicketkeeper-batter Dhruv Jurel came out to bat. He

joined left-hand batter Ravindra Jadeja on the crease.

The Indian cricket team touched the 300-run mark just before Tea as Jurel smashed 13 runs in an over, which was bowled by Tongue.

Both batters, Jurel and Jadeja, built an unbeaten 31(40) partnership before going back after the end of the second ses-

For the Three Lions so far, Atkinson has snapped three wickets (3/99 in 23 overs), Tounge has grabbed two wickets (2/100 in 26 overs), and Jamie Overton has bagged one wicket (1/74 in 18 overs) in their respective spells

Earlier, India started Day 3 on 75/2, with Yashasvi Jaiswal (51*) and night-watchman Akash Deep (4*) unbeaten on the crease, leading by 52 runs.

NEW DELHI [INDIA]: The Indian Super League (ISL) has seen a diverse range of foreign players over the years, stars who brought flair, experience, and a touch of glamour to Indian football. While many left a strong impact before moving on to other opportunities, a few chose to come back, drawn by the league's rising reputation and a sense of unfinished business, as per the official website of

Their comebacks weren't just about second chances; they were about impact, legacy, and sometimes redemption. From fan favourites to surprise returns, these players reminded everyone that the ISL still had a place in their journey

Eli Sabia began his ISL journev with Chennaivin FC in 2016, making an immediate impact with his composure and defensive awareness. He briefly stepped away from the league but returned to the Marina Machans in the 2018-19 season, becoming a mainstay in their backline. Over three more seasons at the club, Sabia established himself as a reliable leader at the back.

He later joined Jamshedpur FC, where his experience played a key role in their ISL Shield-winning campaign. Across both clubs, Sabia brought stability, guided younger players, and left a lasting impression as one of the league's dependable foreign defenders.

Carlos Delgado joined Odisha FC in the 2019-20 season and quickly established himself as a key figure in their defence, thanks to his strength, aerial dominance, and reading of the game. After a two-year hiatus, the Spanish defender returned to the club ahead of the 2022-23 campaign.

His leadership at the back was instrumental in Odisha FC's run to the ISL playoffs, the first time in their club history. Delgado's return brought much-needed stability and experience to a side determined to climb the ISL ladder. The following season, he played a major role in guiding the team to their first-ever semifinal appearance. Three seasons into his second stint, Delgado has now become one of Odisha FC's

Spanish centre-back Odei Onaindia first made his mark with Hyderabad FC in the 2020-21 season, impressing with his composure, positioning, and leadership at the heart of defence.



After a solid debut campaign, he opted to return to his former club Ĥowever, Hyderabad FC

brought him back for the 2022-23 season, and his second stint was even more impactful. Calm under pressure and consistent in duels, Onaindia remained a key part of one of the league's most organised defences as the side finished second in the table for a second season running. He later carried that same form to FC Goa, reuniting with coach Manolo Marquez and continuing to anchor the backline with authority. He was a crucial figure in

their Kalinga Super Cup triumph Stephen Eze became a key fig-

ure for Jamshedpur FC in the 2020-21 season, with his towering presence and aggressive style making an impact at both ends of the pitch. After spells abroad, the Nigerian centre-back returned to familiar territory in 2024-25, once again donning the Jamshedpur FC colours.

His experience and physicality added much-needed grit to the backline, as the Men of Steel enjoyed a solid campaign, reaching the ISL semi-finals and finishing runners-up in the Kalinga

Super Cup. Eze's return didn't just boost the defence; it reignited belief among fans who remembered the impact he made the first time around. Jorge Ortiz made a name for

himself in the ISL during his time with FC Goa from 2020 to 2022, dazzling fans with his flair and attacking versatility. With 21 goal contributions in two seasons, he was at the heart of FC Goa's forward play.

After a move to the Chinese Super League, Ortiz spent two years away from Indian football. But midway through the 2024-25 season, he made a surprise return, this time with Mumbai City FC. His arrival brought fresh energy and creativity to a struggling Mumbai City FC attack. While he didn't register a goal or assist, his presence added sharp-ness and fluidity to Mumbai City FC's attack, helping revive their rhythm in the final third and secure a place in the playoffs.

Another surprise return during the 2024-25 campaign came in the form of Raphael Messi Bouli, one that few saw coming. The Cameroonian striker had made his early mark in the ISL back in the 2019-20 season with Kerala Blasters FC, where he

scored eight goals and registered one assist in 17 appearances. His physical presence, relentless work rate, and passion quickly made him a fan favourite in Kochi.

After a long four-season absence, Messi Bouli returned to India, this time with another passionate fanbase, East Bengal FC. Despite the short stint, he made an instant impact, contributing to three goals in just five matches. Beyond the numbers, his hold-up play, intelligent link-ups, and ability to stretch defences gave East Bengal's attack a new dimension and energy when they needed it most

Victor Mongil's first stint in the ISL came with ATK FC during the 2019-20 season, where he slotted into the defence with calmness and discipline, helping the team lift the ISL Cup for a record third time

While he briefly moved on from the league, the Spanish defender returned to Indian football with Odisha FC in 2021-22 and once again showcased his value with composed performances at the back. He even wore the captain's armband on several occasions, guiding the Kalinga Warriors with maturity.
