PM Modi inaugurates Kartavya Bhavan

MI News Service, New Delhi : Prime Minister Modi Narendra Wednesday inaugurated Kartavya Bhavan, the first of the ten upcoming Common Central Secretariat buildings to house the bu-reaucracy in the National

The ambitious project is aimed at bringing ministries and departments under one roof for effi-

Kartavya Bhavan-03, the first to be inaugurated, will house the Home Affairs, External Affairs, Development, MSME, DoPT, Petroleum & Natural Gas ministries, and the Principal Scientific Adviser's office.Kartavya Bhavan buildings are also the part of the larger Central Vista project.

"The state-of-the-art building, consisting of swanky conference rooms, modern amenities and CCTVs, will house the offices of the ministries of Home Affairs, External Affairs, Rural Development, MSMEs, DoPT, Petroleum and Natural Gas. The Principal Scientific Adviser (PSA) will also have his of-fice in the building, which is spread over 1.5 lakh sq metres', said an official statement after the inau-

The Kartavya Bhavan will also have several green features, such as double-glazed glass win-dows, rooftop solar panels, advanced heating, ventilation, and cooling systems, and rainwater harvesting. There will also be powerefficient LED lighting to achieve 30 per cent energy

The plan for a common central secretariat was mooted by the Modi government as currently key ministries function from ageing buildings like Shastri Bhawan, Krishi Bhawan, Udyog Bhawan, and Nirman Bhawan, constructed between the 1950s and 1970s.

However, a few buildings, like the Vanijya Bhawan, which houses the Commerce Ministry, will be

Next in the pipeline is a brand-new Prime Minister's Office, to be called the Executive Enclave, and the Minister's resi-Prime

The original deadline for the completion of the first three CCS buildings was November 2023. However, now the entire project is expected to be completed by mid-2027.

Altogether, the new complex will have 10 new buildings housing different central government min-

"By December 2025, work will start on all the remaining buildings and, with the new building technology that we are using, we will be able to complete it within 24 months," Housing secretary K Srinivas said at a press briefing on Tuesday.

Death toll in Uttarkashi mud slide in Dharali risen to five

MI News Service, Dehradun: With the recovery of at least one more body by the rescuers from the rubble in flood-ravaged Dharali village, the death toll in yesterday's cloudburst and subsequent flash flood in Uttarkashi rose to five on Wednesday, as the search operation for over 60 missing persons resumed this morning amid heavy rain and inclement

Nearly half of the picturesque Dharali village was ravaged by flash floods on Tuesday afternoon claiming four lives within a few minutes of the massive mud slide and the natural disaster. However, around 130 people have so far been evacuated to safety by joint teams of the Army

The village is the main stopover on the way to the popular pilgrimage site of Gangotri, from where the Ganga originates, and is home to several hotels and home stays.

Soon after he was informed about the disaster, Prime Minister Narendra Modi spoke to Uttarakhand Chief Minister Pushkar Singh Dhami to get an update on the situation and assured him of all assistance from the Centre.

Chief minister Dhami also held a meeting with top officials at the State Emergency Operation Centre here to review the rescue efforts. This morning he also made an aerial survey of the flooded area in Dharali and Harsil from a helicopter. "The rescue work is going on war footing. Teams from the army, ITBP, and

SDRF have reached the spot. Around 130 people have so far been rescued... Debris has reached an army base. A road has been blocked. The DM and an SP rank officers are on their way to the spot. It's a challenging situation as it is still raining there," the Chief minister said.

Dhami said "Every life matters to us," and added that all necessary ments have been made for supplying food and medicines to the affected people. Over 160 police personnel have been deployed including 13 senior and SP-rank officers to oversee the disbursement of ration. Three nodal officers have also been appointed by the CM's office.

Meanwhile, the Indian Airforce has kept its MI-17 and Chinook helicopters on standby to look for the stranded people. But they will take off only after the weather clears.

Though preliminary survey indicated that about 60 people might have gone missing, but later it was found that the number would be much higher, as large number of people had gathered for the Har Dudh fair in Dharali village when the tragedy struck. The missing include 11 soldiers, Defence spokesperson Lt Col Manish Shrivastava said. But despite its soldiers going missing and its base being hit, the Army team is working with full courage and determination, Lt Col Shrivastava said. The Indian Air Force (IAF) has swung into action in response to

RBI decides to keep interest rate unchanged at 5.5 pc

MI News Service, Mumbai : After three successive interest cuts, the Reserve Bank of India (RBI) on Wednesday decided to keep policy rate un-changed at 5.5 per cent and retained the neutral stance, weighed by concerns over tariff uncertain-

Announcing the third bi-monthly monetary policy of the current fiscal, RBI Governor Sanjay Malhotra said that the growth rate projection for FY26 has been retained at 6.5 per cent.

He further said the Monetary Policy Committee (MPC) unanimously dekeep the short-term lending rate or repo rate unchanged at 5.5 per cent with neutral

Incidentally, RBI has kept its repo rate unchanged as the rupee remains under pressure due to US President Donald Trump's tariff threat. The rupee fell 16 paise yesterday, after Trump issued fresh threats to hike tariffs on Indian goods.Earlier in June, the RBI had cut the kev rate by 50 basis points in line with the softening inflation. Announcing his deci-

sion to maintain the bank's neutral stance, Malhotra statted that the uncertainty over tariffs is still evolving and a monetary policy transmission is underway. The MPC resolved to maintain a close vigil on developing data.

The prospects of external demand remain uncertain amidst ongoing tariff announcements and trade negotiations, said Malhotra, adding that the headwinds emanating from the prolonged geopolitical tensions pose risks to the growth outlook.

The real GDP growth projected for the current fiscal is 6.5 per cent, reflecting a continuous

growth outlook despite global concerns. This also contradicts Trump's "dead economy" jibe at India over its trade with Russia. The growth has been projected at 6.5 per cent in Q1, 6.7 per cent in Q2, 6.6 per cent in Q3, and 6.3 per cent in Q4. The central bank has taken decisive, forward-looking measures to support growth, assured Malhotra. The RBI Chief also shared the top bank's outlook on geopolitical challenges. Geopolitical uncertainties have somewhat abated, but global trade challenges continue to linger, he f said adding while the Indian economy holds bright prospects over the medium term the policymakers across the globe are faced with muted growth, slowing inflation. Headline inflation is lower due to volatile food prices, but the RBI has

Mamata Banerjee says SIR harasses common people by asking 'parents' birth certificates'

MI News Service, Jhars next to impossible for the common voters anywhere in India to produce documents specified by the Election Commission for its Special Intensive Revision (SIR) programme, West Bengal Chief minister Ma-mata Banerjee on Wednes-day gave the example of the Trinamool Congress National General Secretary Abhishek Banerjee MP, as well as her nephew, to explain the difficulties.

Citing the example of the newly named TMC leader in the Lok Sabha Abhishek Banerjee, the Chief minister told a massive gathering at a meeting at Jhargram after a three kilometre walk to press for her 'Bhasa Andolon' this aftermoon, that "it is in-deed very difficult for vast majority of common voters to explain the difficulties that they could face to produce documents specified by the ECI in its drive for SIR of electoral rolls, a process that is currently underway in neighbouring Bihar. "The Election Commission says those born

before 2002 will have to produce the birth certificates of their parents. Take Abhishek's example. He was born in 1987. He is now 37 years old. From where will he get the birth certificates of his parents? Can Amit Shah produce the birth certificates of his parents?" Mamata Baner-jee asked the people at the meeting here after her third 'Bhasha Andolan" movement) march after Kolkata and Bolpur .. Abhishek was born on November 7, 1987 to Mamata's elder brother,

Amit, and his wife, Lata. The SIR in Bihar and harassment of poor Bengali-speakers in BJP-ruled states has given Mamata Banerjee a chance to attack both the ECI and the BJP at the Centre. .

For the past about a month she has been severely criticising the SIR drive, through which around 6.5 million voters have alreadybeen deleted in Bihar in its preliminary

Since the day Bihar's SIR drive became public, Mamata Banerjee has

been warning that the Commission's real target is Bengal – due to vote next year - and "genuine" voters will be deprived of their right. "I am saying this to the

BJP voters as well. Whom you vote for is your demo-cratic right. I have nothing to say regarding that. Just remember if I am not there, your voting rights will be in peril too," she

Without naming Chief Election Commissioner (CEC) Gyanesh Kumar, the Chief minister asked the voters to be more vigilant and alert about the electoral rolls.

'The ECI is Amit Shah's puppet. They will keep changing the voters' list till the last day. Ensure that your name is there in the voters' list every day till you go to the booth. It is possible even after everything your name may be missing from the electoral rolls," she said.

Over the last couple of months the Trinamool Congress has been protesting against the central poll panel and its alleged bias attitude coupled with the attack on Bengali-speaking Muslims. The Delhi police in a recent FIR describing Bengali as "Bangladesh national language" has given the Trinamool additional firepower to hit the

"Now they are saying there is no Bengali language. Just imagine their audacity," the Chief minister said, referring to BJP IT cell chief Amit Malviya's attempted defence of the Delhi police. "When Prime minister Modi visits Dubai, he embraces the Sheikhs. I have no problems with that, but when he comes to Bengal he says all Muslims are Bangladeshi," she said.

Mamata Banerjee said the 1.5 crore migrants living in Bengal were treated as "Bengal's own."

"Then why will our people be mistreated? We have already brought back many of them. Their wellbeing is our responsibility. I am telling them there is no need to live in those states where they will be arrested and deported," Bengal's firebrand Chief

Election Commission is working as a 'slave of BJP', alleges Mamata Banerjee

MI News Service, Jhargram: Severely criticising the Election Commission of India (ECI) for recommending immediate suspension of four poll officials in the state on charge of alleged dereliction of duty, West Bengal Chief minister Mamata Banerjee has blamed the Commission for allegedly working as a 'slave of BJP'.

Coming down heavily on the ECI after the Commission has ordered suspension of a total of four officials from Bengal on charges of rigging in the registration of names in the voters' list, the Chief minister said state Chief Secretary had also been directed to file an FIR against the four. Among those four are two Electoral Registration Officers (EROs) and as many Assistant Electoral Registration Officers (AEROs).

The Chief Minister became furious on that issue on Wednesday and questioned "on what authority have pended?" She also made it clear that not only them, no other officer will be suspended.

Making this charge from Jhargram during her visit there today, Mamata Banerjee said there is a largescale conspiracy to introduce NRC in Bengal after introducing SIR. "No name should be deleted and left out from the voters' list in Bengal', she warned reiteraring her strong opposition to the possible exercise.

"The BJP is trying to prepare a voters' list for its own convenience through the SIR', the Chief Minister stated further. Reiterating that the BJP is waging 'terrorism' against the Bengali language, Mamata Banerjee said that a number of migrant workers from Bengal are being arrested and tortured in several BJP-ruled states by labeling them Bangladeshis. The Chief Minister has also called for turning her new 'language movement into a mass movement in the state and led from the front a mass rally here this afternoon in that connection after holding similar rallies in Kolkata and Bolpur a few days ago carrying the phographs of several Bengali luminaries like Rabindranath Tagore, working for the BJP.

Rain in Himachal Pradesh causes massive landslides, Kailash Yatra suspended, 413 pilgrims rescued

The Kinnaur Kailash Yatra was suspended and as many as 413 stranded devotees were rescued after heavy rain damaged the pilgrimage route in Himachal Pradesh, official sources said on Wednesday.

devotees were stranded after two makeshift bridges at Tanglippi and Kangarang were washed away due to the increased water flow in streams, they said.

The incident took place only a day after a massive mud slide and flash floods at a picturesque village of Bharali near Urratkashi in neighbouring Uttrakhand state on Tuesday killing five people and reportedly swept away about 60 others. The Indo-Tibetan Border Police (ITBP) shared videos of rescue operations on X, which showed pilgrims ziplining from one end of the streams to the other. As many as 413 pilgrims were rescued by the ITBP and the NDRF in the Tangling area along the Kinnaur Kailash Yatra route in Himachal Pradesh on Wednesday morning, after a flash flood washed away a large part of the trekking path, leaving hundreds of pilgrims stranded. The pilgrims were res-

cued using the rope-based traverse crossing technique, and were shifted to safer locations, ITBP officials said. The rescue operation was initiated after a



distress call was made by the Kinnaur district administration on Wednesday morning.Subsequently, ITBP and NDRF search and rescue teams were mobilised to the site.

The operation is being carried out by a 34-member ITBP team in coordination with a 14-member team of the NDRF.

The alleged reckless vertical hill-cutting for the construction of a four-laned project at Bhali in Seuni-Rajol NHAI's section near Kotla in Jawali subdivision of Kangra district has started showing its impact.

A massive landslide triggered on the Pathankot-Mandi national highway last evening (6.30 pm), blocking the highway for over 12 hours. Hundreds of private and public transport vehicles got stuck in the traffic jam.

The machinery of the construction company was pressed into service immediately after the blockade but was the work was affected due to relentless rain at night. A light vehicle with two occupants got trapped in the debris while crossing the spot but it was safely dragged out and occupants were rescued by locals with the help of the construction company's machinery.

According to Kangra Commissioner Deputy Hemraj Bairwa, the district administration had received information about the blockade at 8.45 pm on Tuesday and immediately diverted the traffic from Sanoura Chowk towards Batees Meel for vehicles moving from Kangra towards Pathankot and the traffic from Chamba towards Pathankot was diverted from Dramman towards Sanoura Chowk to Lunj. The traffic from Pathankot towards Kangra-Dharamshala was di-

Dilapidated house collapses in Chunchura

MI News Service, Hooghly: Panic gripped the Tamlipara area of Chunchura on Tuesday afternoon when a portion of a dilapidated house collapsed suddenly, trapping two residents inside a neighboring home. The incident has once again highlighted the risks posed by neglected, structurally unsound buildings amid continuous rainfall across Bengal. According to local sources, the house in question belongs to one Haridas Dutta and had long been declared "dangerous" by the Hooghly Chunchura Municipality. However, due to an ongoing dispute among co-owners, the structure could not be demolished, despite repeated warnings and visible signs of de-

At around 4:45 PM, a section from the rear of the structure gave way and collapsed directly in front of the entrance to the nearby Das family's residence. As a result, Savita Das and her grandson were trapped inside their home, unable to exit. Emergency services, including the fire department, responded swiftly after receiving the alert. The incident triggered widespread concern in the area, drawing a large number of residents to the scene. Local MLA Asit Majumdar and Hooghly Chunchura Municipality Health Department CIC



Joydev Adhikar also arrived to assess the situation. Following the incident, the municipality arranged for the debris to be cleared, ensuring safe access for the Das family and others in the vicinity. Recalling the terrifying moment, Savita Das said: The nouse collapsed around 4:45 PM. It had shown signs of damage before, but today it came crashing down. I could've been crushed had my grandmother not called out to me. I was sav ed by seconds." With the monsoon rains continuing, civic officials are expected to review the condition of other similarly dangerous structures in the area to prevent further tragedies.

Target or attacker? Youth injured in late-night blast

News Service, Birbhum: A late-night explosion rocked the Nalhati Municipality area of Birbhum district on Tuesday, leaving a young man severely injured. The victim, identified as Seelon Sheikh, reportedly lost his right wrist after a bomb detonated in his hand.

The incident occurred in

Ward No. 6, near the road leading to the local stone industry zone. Around midnight, residents were jolted awake by a loud blast. At first, many assumed it to be a skirmish or external disturbance. However, moments later, the cries of pain led locals to rush outside - only to find a bloodied young man lying on the road with a grievous hand injury. He was immediately rushed to Rampurhat Medical College and Hospital, where he remains in critical condition. "I received a call late at night saying my son was admitted to the hospital. When I arrived, I was shocked to see his wrist completely blown off, and his hand bones exposed," said Golam Mustafa, father of the injured youth. Police and forensic teams quickly reached the site to investigate. According to initial reports, Seelon may have been attempting to hurl the bomb himself, possibly due to an ongoing personal enmity, when it exploded prematurely, causing him serious harm. Authorities are treating the case with urgency. While no arrests have been made yet, police are actively probing the circumstances, including whether Seelon was the intended attacker or a victim of a mishap. The explosion has reignited concerns over illegal explosives and turf rivalries in certain parts of Birbhum, a region where political and personal tensions have previously led to violent episodes.

The ceremony, traditionally reserved for the deceased, included pinda daan, a yajna, the burning of Sumita's photograph, and even conducted publicly with a priest. "For me, my wife is dead," he

said. "This was my way of saying goodbye." The act has sparked intense debate in the community. While some empathize with Naren's pain, others are shocked by the public display. Religious scholars and legal experts are divided; although not illegal, such symbolic rituals raise ethical and psychological concerns. No legal steps have been taken, but the incident has created a sensation in the district, highlighting the deep emotional toll of betrayal and marital break-

While three members of the group managed to reach the mountain, Rajiv's health deteriorated on the return journey due to extreme cold and lack of oxygen. Battling freezing temperatures and treacherous weather,



but was declared dead on arrival. Heavy snowfall in Kinnaur and landslides in Uttarkashi have made this year's pilgrimage routes especially dangerous. Rajiv's family is now shattered. A working-class man and sole breadwinner, he supported his elderly mother and younger brother. "Rajiv didn't seek luxury—his joy was in devotion.

We're told he died from breathing issues and cold. We don't even have the means to bring his body back," said his son-inlaw, devastated. The family has vet to receive official assistance and has appealed to the West Chief Minister and Himachal Pradesh authorities for urgent help to repatriate his remains. "His mother is inconsolable. Now, even his last rites are uncertain," said a neighbor. Aditya Niyogi, Chairman of Bansberia Municipality, confirmed the death and assured support. "We've informed the Chief Minister's Office and stand with the family," he said. Rajiv's story is a painful reminder of how faith, hardship, and tragedy often in-

She was promptly taken to Gogra Rural Hospital, where doctors pronounced her dead upon arrival. "We suddenly heard a scream. When we reached the room, we saw Bristi lying uncon-scious. We quickly turned off the main power switch and rushed her to the hospital," said Sandip Roy, a relative of the deceased. Local authorities have not vet confirmed the exact cause of the electrocution, but an accidental electrical fault is suspected. No official comment has been made regarding a potential investigation. Man arrested for alleged rape of minor

Sandeskhali: Police in Sandeshkhali have arrested a 32-year-old man following a complaint of alleged rape filed by the family of a 17-year-old girl. The accused, identified as a resident of Jelekhali, was apprehended on Tuesday and is scheduled to appear before the Basirhat Sub-divisional Court on Wednes day.

According to the complaint filed at the Sandeshkhali po-



lice station, the suspect and the minor had been in a relationship for approximately six months. The girl's family alleges that the man, leveraging a promise of marriage, repeatedly engaged in sexual intercourse with her. These rivers, fed by glaciers, swell rapidly during the rainy season due to intense rainfall and glacial melt. 

Mamata's Jhargram rally turns into fierce defence of Bengali Language and Identity

MI News Service, Kolkata: Jhargram's Junglemahal reverberated on Wednesday with slogans of linguistic pride as West Bengal Chief Minister and Trinamool Congress (TMC) supremo Mamata Banerjee led a massive protest march to defend the Bengali language. Carrying portraits of cultural icons Rabindranath Tagore, KaziNazrul Islam, and Ishwar Chandra Vidyasagar Banerjee, flanked by senior ministers Firhad Hakim and Aroop Biswas, walked through the streets in defiance of what she called an orchestrated attack on Bengal's identity.

Addressing a charged gathering after the march, Banerjee launched a scathing attack on the BJP and the Election Commission. "We will not tolerate any terror against the Bengali language. If necessary, we will shed our blood, but we will not yield an inch of Bengal's land," she declared. She condemned the NRC notices sent from Assam to Bengal residents, calling it an insult to the legacy of Bengal's luminaries, and warned against any attempt to strike out Bengali-speaking citizens from the voter list under the guise of the 'Special Intensive Revision' exer-"Without Bengal, there is no India. Calling a Bengali a Bangladeshi is a disgrace. State officers are being intimidated, and people are taking their own lives out of NRC fear. Who will take responsibil-

ity for this?" she asked.

Electoral Office overhauls voter card delivery system amid fake voter concerns

MI News Service, Kolkata: In the wake of reports of bogus voters surfacing in certain assembly constituencies, the Office of the Chief Electoral Officer (CEO) of West Bengal has announced a major procedural overhaul in the distribution of Electoral Photo Identity

Under the revised system, effective from September 1, EPIC cards will no longer be routed through district election offices. Instead, once printed, the cards will be dispatched directly to voters' residences via Speed Post from the General Post Office (GPO), ensuring tighter control and minimising intermediary han-

Until now, the process required the Electoral Registration Officer (ERO) to forward new voter applications to the District Election Officer (DEO), who would then send them to the Saraswati Press for printing. The printed cards were returned to the DEO, forwarded back to the respec-



tive EROs, and finally delivered to voters through Speed Post. The new directive eliminates the intermediate district-level leg of the journey. Saraswati Press will now send printed EPICs straight to the GPO, from where the postal department will deliver them directly to voters. Officials believe this streamlined approach will reduce the risk of tampering. misplacement, unauthorised access to voter identity

In addition to new cards, the CEO's office has ordered immediate action on the backlog at Saraswati Press, where approximately 1.5 lakh EPICs are currently lying printed but undelivered. These cards, too, will now be sent directly to voters' homes through the postal department, bypassing district offices entirely.

Commission sources confirmed that this change is part of a broader strategy to strengthen electoral integrity and ensure that legitimate voters receive their cards securely and promptly. By cutting down the number of hands through which the cards pass, the CEO's office aims to close loopholes that could be exploited for fraudulent purposes.

Election officials have further stated that voters should be alert for their cards' arrival via Speed Post and report any discrepancies immediately. The measure, they stressed, is designed not only to expedite delivery but also to uphold public trust in the electoral process — an essential safeguard in the face of allegations of fake voter enrolments.

T7 Adit Tunnel in Bengal's Kalimpong unaffected after landslide: IRCON

Kalimpong: T7 Adit Tunnel, located in Kalimpong District of West Bengal on the Sivok-Rangpo Railway Project, remains safe and unaffected by the landslide that occurred on Monday, IRCON International Ltd stated.

IRCON, the executing agency for the project, stated that the landslide took place on a hill slope approximately 30 metres away from the portal of the T7 Adit Tunnel. The slide was limited to the left side and occurred in a private area outside the railway land's right-of-way (ROW).

The main tunnel and the Adit Tunnel are safe and unaffected by the landslide, and there is no possibility of any damage to the Tunnel, IRCON said in a press state-

The hill slope slide was triggered beyond the railway-protected hill slope, originating from within the forest area, due to non-stop rains in the hills since July 2025. Due to non-stop rains, seepage in the pre-existing hill cracks in the Forest area beyond the ROW leading to hill slope slide starting from the Forest land and seepage

slope caused movement of hill slope and slide of the boulders/debris from Forest area in to the Railway tunnel slope. It damaged the protected hill surface on the Left side of the Tunnel adit

IRCON had taken adequate precautions in advance to move the machinery and manpower away from the hill slope. There are no casualties or injuries to workers or the general public, and no loss of machinery or railway assets during the incident. There is no damage to the adjacent civilian habitation near

The hills slope above the Adit portal, and on the Right side of the portal is sta-ble as well. The Main tunnel portals are stable. The landslide occurred approximately 30 m away from the adit tunnel portal, and the tunnel itself remains unaffected, posing no danger. The adit tunnel, as well as the main tunnel, is safe and secure, and there is no possibility of any damage to the tunnel. However, in view of



Researchers discover protein that help prevent cancer treat-ment-related heart damage



Washington [US]: Blocking the protein CDK7 could prevent heart damage caused by a routinely used cancer chemotherapy treatment, according to a study conducted by scientists at Washington State University. Importantly, the researchers discovered that blocking CDK7 could improve the medication's cancer-killing efficacy.

Based on an animal model, the study's findings potentially lay the groundwork for future treatment options to decrease chemotherapyrelated heart damage and improve treatment efficacy. This has the potential to help people with cancer live longer lives. Heart damage caused by chemotherapy can manifest decades later and lead to heart attacks, heart failure, cardiomyopathy, and other types of heart dis-

The findings of the study were published in

study focused on doxorubicin, a chemotherapy drug used to treat breast cancer, lymphoma, leukemia and other cancers.

Capable of killing a wide range of cancer lls, doxorubicin and other similar chemotherapy medications are known to be toxic to the heart. Despite this toxicity, the drug still sees a lot of use.

"Doxorubicin remains the mainstay treatment for certain cancer types for which targeted therapies or other better treatments are not available," said senior study author Zhaokang Cheng, an associate professor in the WSU College of Pharmacy and Pharmaceutical Sciences.Cheng has been working to unravel the underlying mechanisms of doxorubicininduced heart toxicity to make the use of doxorubicin safer for patients who rely on the drug. This new study builds on findings from earlier research that showed that doxorubicin activates a protein known as CDK2. That protein then activates another known as FOXO1, which causes heart cells to die. Cheng's team collaborated with WSU cancer biology researcher Boyang (Jason) Wu to take a closer look at CDK7, a protein that helps fuel cell growth and has been shown to play a role in the development of cancer.

The researchers found that CDK7 activated CDK2, which set off the chain of molecular signals that eventually led to heart cell death. They also showed that mice that lacked the CDK7 gene were protected from doxorubicininduced heart toxicity. Next, they used a CDK7 inhibitor drug known as THZ1 to block the protein's activity and examine the impact on heart health and cancer growth. A similar inhibitor is currently being tested as an anticancer drug in clinical trials, but its effect on the heart is still not clear.

"We are the first to study the effect of THZ1 on the heart and tumour growth in the same model," said study first author Jingrui Chen, a WSU research associate. "And what we found is that this CDK7 inhibitor drug can increase heart function and at the same time inhibit tumour growth.'

Though more research is needed, the researchers said their findings suggest that combining doxorubicin and THZ1 could help prevent heart damage and increase the effectiveness of chemotherapy treatment.

The researchers' next step is to test the effect of THZ1 on heart damage and cancer growth in younger mice and follow them longer. This would more closely mimic longterm doxorubicin-induced heart toxicity seen in childhood cancer survivors. They also plan to look at other proteins that may somehow be involved in the signaling pathway that under-

Study reveals key protein that helps prevent excessive bone loss in osteoporosis

Tokyo [Japan], Osteoporosis, a disorder characterised by porous and weak bones, is a major hazard to skeletal health. As the foundation of the human body, bones provide critical structural support. When bone mass decreases, it not only weakens this support but also lowers general function, resulting in a lower quality of life.

With an ageing population and a rise in osteoporosis cases, the burden on healthcare resources for long-term care is clear. As a result, there is a need to understand the mechanisms that cause osteoporosis and develop effective targeted therapeutics to mitigate its long-term effects.

Osteoblasts and osteoclasts are two types of cells that play critical roles in bone tissue maintenance and remodelling. Osteoblasts are bone-forming cells that synthesise and deposit new bone tissue, whereas osteoclasts break down and remove old or damaged bone tissue. Increased proportion of osteoclasts causes bone mass loss in situations such as osteoporosis, rheumatoid arthritis (joint inflammation), and bone metastases (cancer that has spread to the bones). Osteoclasts develop from the development of macrophages or monocytes, two types of immune cells. Suppressing osteoclast differentiation could thus be used as a therapeutic technique to prevent bone loss. However, the precise molecular pathways driving the complicated process of bone remodelling are unknown.

In a new groundbreaking study, Professor Tadayoshi Hayata, Mr. Takuto Konno, and Ms. Hitomi Murachi from Tokyo University of Science, along with their co-workers, delved deeper into the molecular regulation of differentiation. Receptor activator of nuclear factor kappa B ligand (RANKL) stimulation induces the differentiation of macrophages into osteoclasts. Further, bone morphogenetic protein (BMP) and transforming growth factor (TGF)-b signaling pathways have been implicated in the regulation of RANKL-mediated osteoclast differentiation. In the current study, the researchers

- a phosphatase (an enzyme that removes phosphate groups) that has been reported to suppress BMP and TGF-b signal-

Giving further insight into their work set to be published on July 30, 2024, in Volume 719 of Biochemical and Biophysical esearch Communications, Prof. Hayata states, "RANKL functions as an 'accelerator' for osteoclast cell differentiation. Driving a car requires not only the accelerator but also the brakes. Here, we find that Ctdnep1 functions as a 'brake' on osteoclast cell differen-

First, the researchers examined the expression of Ctdnep1 in mouse-derived macrophages treated with RANKL and untreated control cells. They noted that Ctdnep1 expression remained unchanged in response to RANKL stimulation. However, it localized in the cytoplasm in granular form in the macrophages and differentiated into osteoclasts, distinct from its normal peri-nuclear localization in other cell types, indicating its cytoplasmic function in osteoclast differentiation.

Further, Ctdnep1 knockdown (downregulation of gene expression) resulted in an increase in tartrate-resistant acid phos-phatase-positive (TRAP) osteoclasts; wherein TRAP is a marker for differentiated osteoclasts. Additionally, Ctdnep1 knockdown led to an increase in the expression of crucial differentiation markers including 'Nfatc1', a RANKL-induced master transcription factor for osteoclast differentiation. These results support the 'brake function' of Ctdnep1, whereby, it negatively regulates osteoclast differentiation.

Moreover, Ctdnep1 knockdown also led to increased absorption of calcium phosphate, suggestive of the suppressive role of Ctdnep1 in bone resorption. Lastly, while, Ctdnep1 knockdown did not alter BMP and TGF-b signaling, cells deficient in Ctdnep1 showed elevated levels of phosphorylated (activated) proteins downstream of the RANKL signaling pathway. These findings suggest that the suppressive effect of Ctdnep1 in osteoclast differentiation may not be mediated by BMP and TGF-b signaling, but, through the negative regulation of RANKL signaling and Nfatc1 protein levels.

Overall, these findings provide novel insights into the process of osteoclast differentiation and reveal potential therapeutic targets which can be pursued to develop treatments that address bone loss due to excessive osteoclast activity. In addition to diseases characterized by bone loss, Ctdnep1 has also been reported as a causative factor in medulloblastoma - a childhood brain tumor. The authors are, therefore, optimistic that their research can be extended to other human diseases


Semaglutide ingredient can help protect kidney function in people with obesity: Study

WASHINGTON Semaglutide, a glucagon-like peptide-1 (GLP-1) receptor agonist, has been shown in the SELECT Trial to be effective in preventing the loss of kidney function in people who are overweight or obese and have established cardiovascular disease but do not have dia-

The remarkable secondary analysis from the SELECT (Semaglutide Effects on Heart Disease and Stroke in Patients with Overweight or Obesity) experiment, a randomised trial with a participant pool of 17,604 researchers today at the 61st ERA

The study's findings, according to experts, give individuals who suffer from obesity hope since this illness is known to increase the risk of renal function decline and macroalbuminuria, or abnormally high levels of the albumin protein

With an average follow-up of approximately 3.5 years, among patients who were administered a once-weekly subcutaneous injection of semaglutide 2.4 mg (n=8,803) adverse kidney-related events were experienced by 22% fewer persons (1.8%) compared to those receiving placebo (n=8,801) (2.2%) (p<0.05). These events included death from kidney causes, initiation of chronic kidney replacement therapy, significant (>= 50%) decline in kidney function, or onset of persistent macroalbuminuria. Semaglutide's ability to prevent the onset of macroalbuminuria was highlight-



the likelihood of kidney-related complications

The study also assessed the impact of semaglutide on estimatglomerular filtration rate (eGFR), a measure of kidney function in removing waste and excess water from the blood through urine. The findings indicated a significantly lesser decline in eĞFR among semaglutide recipients compared to the placebo group, with the effect being more pronounced in participants with baseline eGFR below 60 mL/min/1.73 m2 (p<0.001). These results indicate the potential for semaglutide to particularly protect kidney function in individuals with a pre-existing kidney

impairment. The reduction in urinary albumin-to-creatinine ratio (UACR) further substantiated semaglutide's beneficial effect on kidney health, with a significant decrease observed in semaglutide-treated individuals compared to placebo (p<0.001). UACR analysis measures the ratio of albumin (a protein) to creatinine (a waste product) in urine, aiding the detection of albuminuria, which can signal kidney damage or dysfunction. With semaglutide, there was a net 8.1% decrease in UACR in those with normal albumin levels at baseline, a 27.2% decrease in those with microalbuminuria (slightly raised albumin) at baseline, and a 31.4% decrease in those with macroalbuminuria at baseline relative to placebo. Importantly, the study found

no increased risk of acute kidney injury associated with semaglutide treatment, irrespective of baseline kidney function.

Over one billion people worldwide are affected by obesity.3 Rates of obesity are rising significantly, having doubled among adult women (8.8% to 18.5%) and nearly tripled in adult men (4.8% to 14.0%) between 1990 and 2022. The total number of children affected by obesity in 2022 was nearly 160 million, compared to 31 million in 1990

Professor Helen M. Colhoun, lead study author, commented, 'By addressing key markers of kidney health, semaglutide 2.4 mg weekly may contribute to a significant reduction in the risk of kidney-related complications, including chronic kidney disease and end-stage renal disease. This could lead to improved management of comorbidities and, ultimately, enhance the quality of life for individuals with obesity.

"The observed benefits in eGFR and UACR are particularly encouraging, suggesting potential for the enhanced management of kidney complications in the patient population with overweight and obesity without diabetes. The findings also underscore the importance of continued research into the possible renal benefits of semaglutide and highlight its role as a promising therapeutic option in the multifaceted management of cardiovascular and renal health in this high-risk

Researchers use 'cloaked' proteins to deliver cancer-killing therapeutics into cells Ithaca (New York) [US], : Researchers at Cornell University A major advantage of this approach was that lipid nanopar-

have created a generalized method for "cloaking" proteins, which may allow for the recycling of materials like antibodies for biological research and therapeutic applications.Lipid nanoparticles, which resemble tiny bubbles of fat, have the ability to ensnare the "cloaked" proteins. Because of their microscopic size, these bubbles are able to secretly deliver their cargo into living cells, where the proteins unfold and begin to work as medicine. The group's paper published in ACS Central Science. The lead author is doctoral student Azmain Alamgir, who works in the labs of the paper's co-senior authors, Chris Alabi, associate professor of chemical and biomolecular engineering, and Matt DeLisa, professor of engineering.

For some drugs to impact a cell's biology, and ultimately treat disease, they need to get inside the cell and reach a specific space. Protein-based therapeutics have



many virtues - they can have more specific effects, with lower toxicity and diminished immune response - but ease of delivery is not one of them. Proteins are large and cumbersome and don't freely diffuse into cells as easily as small molecules do. "We had been looking for a

clever way to efficiently get our engineered proteins inside of cells, especially in a translational context that would not only work in lab-cultured cells, but that would also be effective and safe in animal models and eventually in humans," DeLisa said. The researchers had the broad idea of using a bioconjugation approach that would allow the proteins to be loaded into lipid nanoparticles, which form around nucleic acids.

ticles were a key component in the successful COVID-19 vaccines developed by Pfizer-BioNTech and Moderna. Those vaccines worked by delivering a payload in the form of messenger RNA, which are nucleic acids. The researchers now would use the same lipid nanoparticle delivery concept the same materials even - but with a protein payload. The trick would be to make proteins look more like nucleic acids. The researchers found they could accomplish this by "cloaking" the proteins with a negatively charged ion, so they would join with the positively charged lipids electrostatically.

"The crux of our strategy is conceptually very simple," Alamgir said. "We're taking proteins and specifically remodeling their surfaces with negative charges, so they look like nucleic acids and can similarly assemble into nanoparticles when formulated with the characteristic lipids.

Light therapy helps in brain connectivity following injury

Illinois [US]: A study suggests that lowlevel light treatment may have an impact on the healing process in the brains of individuals who have experienced serious brain injuries.

The findings of the study were published in Radiology, a journal of the Radiological Society of North America

The ability of various wavelengths of light to heal wounds has been researched for many years. Low-level light treatment was used by researchers at Massachusetts General Hospital (MGH) on 38 patients who had experienced moderate traumatic brain injury, which is defined as a head injury severe enough to affect cognition and/or be detectable on a brain scan. Within 72 hours of their injury, patients underwent light therapy using a near-infrared lightemitting helmet.

"The skull is quite transparent to near-infrared light," said study co-lead author Rajiv Gupta, M.D., Ph.D., from the Department of Radiology at MGH.

"Once you put the helmet on, your whole brain is bathing in this light.

The researchers used an imaging technique called functional MRI to gauge the effects of the light therapy. They focused on the brain's resting-state functional connectivity, the communication between brain regions that occurs when a person is at rest and not engaged in a specific task. The researchers compared MRI results during three recovery phases: the acute phase of within one week after injury, the subacute phase of two to three weeks post-injury and the late-subacute

phase of three months after injury.
Of the 38 patients in the trial, 21 did not receive light therapy while wearing the helmet. This was done to serve as a control to minimize bias due to patient characteristics and to avoid potential placebo effects.

Patients who received low-level light therapy showed a greater change in resting-state connectivity in seven brain region pairs during the acute-to-suba-



cute recovery phase compared to the control participants.

There was increased connectivity in

those receiving light treatment, primarily within the first two weeks," said study coauthor Nathaniel Mercaldo, Ph.D., a

statistician with MGH. "We were unable to detect differences in connectivity between the two treatment groups long term, so although the treatment appears to increase the brain connectivity initially, its long-term effects are still to be

The precise mechanism of the light therapy's effects on the brain is also still to be determined. Previous research points to the alteration of an enzyme in the cell's mitochondria (often referred to as the "powerhouse" of a cell), Dr. Gupta said. This leads to more production of adenosine triphosphate, a molecule that stores and transfers energy in the cells. Light therapy has also been linked with blood vessel dilation and anti-inflammatory effects.

There is still a lot of work to be done to understand the exact physiological mechanism behind these effects," said study coauthor Suk-tak Chan, Ph.D., a

biomedical engineer at MGH. While connectivity increased for the light therapy-treated patients during the acute to subacute phases, there was no evidence of a difference in clinical outcomes between the treated and control participants. Additional studies with larger cohorts of patients and correlative imaging beyond three months may help determine the therapeutic role of light in traumatic brain injury.

The researchers expect the role of light therapy to expand as more study results come in. The 810-nanometerwavelength light used in the study is already employed in various therapeutic applications. It's safe, easy to administer and does not require surgery or medications. The helmet's portability means it can be delivered in settings outside of the hospital. It may have applications in treating many other neurological conditions, according to Dr. Gupta.

There are lots of disorders of connectivity, mostly in psychiatry, where this intervention may have a role," he said. "PTSD, depression, autism: these are all promising areas for light thera-

US President Donald Trump says Gaza occupation is 'up to Israel'

MI News Service, Washington D.C.: U.S. President Donald Trump declined to comment on Israel's reported plans to fully occupy the Gaza Strip, saying the decision is "completely up to Israel" while emphasizing his administration's focus on delivering food aid to Gaza residents. Speaking to reporters after a signing ceremony at the White House, Trump responded to questions about whether he supports Israel's Gaza reoccupation plan by saying, "I don't know what their proposal is on this matter. This is completely up to Israel. We are currently working to provide food to the people there.

Trump emphasized that Gaza residents "are clearly not in good condition regarding food" and said his administration is focused on addressing the humanitarian crisis. The president confirmed the U.S. is working with Israel on distributing food aid to Gaza and that some Arab states will provide financial contributions to the food assistance efforts. "Gaza people are not in good condition regarding food. I'm focused on that. And as far as I know, Israel will help us in terms of distribution and money, and Arab countries will also help in terms of both money and distribution. That's what I'm focused on. As for the rest, I really can't say anything. It's up to Israel," Trump stated. During the same press conference, Trump addressed questions about tariffs on countries buying energy from Russia, including China. When asked about implementing 100% tariffs, Trump said his Middle East Special Representative Steve Witkoff would meet with Russian officials in Moscow on Wednesday. "I never gave a percentage figure. But we will do quite a bit on this issue. You know, we have a meeting with Russia tomorrow. We'll see what happens. Then we'll make our decision," Trump said.

Regarding the Ukraine war, Trump stated, "Look, you need to understand this very well: This is Joe Biden's war. This is not my war. I'm here to get us out of this business. This is complete chaos, and I came to save us from this

Trump claimed to have ended five wars in the last five months, saying, "And to be frank, I want this (Russia-Ukraine war) to be the sixth." When asked about his potential successor, Trump indicated Vice President JD Vance would likely be the Republican nominee after him, saying, "Most likely. To be fair, he is the vice president. I think Secretary of State Marco Rubio could somehow come together with JD. Of course, it's too early to talk about this. There were great people among those who came on stage here too. But certainly, (JD Vance) is doing a great job and would probably be more advantageous in this case." Meanwhile, Israeli media reports reveal significant tensions between Prime Minister Benjamin Netanyahu and Chief of Staff Eyal Zamir over Gaza occupation plans. According to Israeli state television KAN, Zamir told Netanyahu that plans to fully occupy the Gaza Strip are "dragging the country into a trap.

During a heated meeting, Zamir reportedly questioned why he was facing accusations of leading a "coup attempt" from Netanyahu's son, Yair Netanyahu, while conducting military operations in Gaza. The Israeli Prime Minister's office reportedly sent a message to Zamir stating, "If the plan to occupy all of Gaza doesn't

suit you, you should resign." Netanyahu responded to Zamir's criticism by saying, "Don't threaten to resign in front of the press. I don't accept your constant resignation threats when we don't accept your plan. My son is 33 years old, an adult man." Israeli sources familiar with the matter told KAN that Netanyahu is inclined to fully occupy the Gaza Strip, while Chief of Staff Zamir opposes such a comprehensive occupation plan.

exceptional performance in The Oval Test, Indian fast-bowlers Mohammed Siraj and Prasidh Krishna gained their career-best ratings of 674 points and 368 points, respectively, in the latest ICC Men's Test Bowler Rankings on Wednesday.

While Player of the Match in the fifth Test, Siraj climbed 12 places to grab 15th spot in the latest ICC Men's Test Bowler Rankings, fellow pacer Krishna moved 25 places to rank 59th in the list after picking up eight wickets in the deciding Test, which India won by six runs.

This is both Siraj and Krishna's highest ever position in the Test ranking, after churning out match-winning spells in the final ICC. England pacers Gus Atkinson and Josh Tongue have also attained their career-best positions after snapping eight wickets each in The Oval Test. While Atkinson breaks into the top 10 for the first time, Tongue is up 14 places to secure the 46th position in the rankings table.

The Oval centurion Yashasvi Jaiswal gained three spots to break into the top five for Test batters with 792 rating points, even as the other centurions in the game, Joe Root and Harry Brook, continue to firmly hold the first two positions in the ICC Men's Test Batter Rankings. Gill, Stokes, Mulder nominated for ICC Men's Player of the Month for July 2025



NEW DELHI [INDIA] : India's Test captain Shubman Gill and two stylish all-rounders from England, South Africa Ben Stokes and Wiaan Mulder have earned nominations for ICC Men's Player of the Month of July 2025 following their exploits in red-ball cricket, according to the ICC website

Shubman Gill had a sensational month, amassing 567 runs at an impeccable average of 94.50 in three Tests during India's gripping series in England.

He played a starring role in India's record-breaking win at Edgbaston, where he scored a monumental 269 in the first innings, followed by 161 in the His combined 430 runs across

the two innings is the secondhighest tally, next only to Graham Gooch's 456. Gill continued his purple patch with another century - a second-innings 103 - in the fourth Test at Old Trafford, helping India secure a crucial draw that set up their

His consistency at No.4, carrying on the baton from all-time great Virat Kohli, provided stability and flair in equal measure, and combined with his extraordinary captaincy in his debut series. Gill's ability to convert starts into big scores, when wickets fell early on under pressure, was vital to India mounting comebacks instances.

Wiaan Mulder delivered a record-breaking all-round per-formance in South Africa's two-Test series against Zimbabwe. He scored 531 runs across the two matches at an astonishing average of 265.50, including a composed 147 in the second innings of the first Test.

However, his standout act came in the second Test at Bulawayo, where he smashed an unbeaten 367 in his maiden outing as South Africa's Test skipper the highest individual score in South African Test history.

Mulder also chipped in with the ball, claiming seven wickets at just 15.28 apiece, including a four-wicket haul in the first Test.

His ability to impact the game in both disciplines made him the standout Player of the Series.

England captain Ben Stokes showcased his trademark grit and all-round brilliance throughout the three Tests in July of the

England-India series.

He scored 251 runs at an average of 50.20 and took 12 wickets at 26.33, delivering in high-pressure situations with both bat and ball.

Stokes was named Player of the Match in back-to-back Tests first at Lord's, where his allround showing secured England a commanding win, and then at Manchester, where he took 5-72 and scored a counter-attacking

Stokes' 141 at Old Trafford set the stage for England as they piled on a mammoth 669 runs in their first innings. His leadership proved crucial in maintaining England's intensity and belief in a closely contested series.

With ball in hand, he bowled long spells, often breaking key partnerships and turning the tide in England's favour.

W ill Sanju Samson become Mahendra Singh Dhoni's successor at Chennai Super Kings? All eyes were on the 30year-old Rajasthan Royals skip-per as the IPL trade window is open, but a recent report claims that it seems highly unlikely for the Yellow Army to rope in the Kerala batter. Rajasthan Royals are unwilling to let their talismanic captain leave, and Sanju is reportedly convinced that he should stay and lead the franchise in the 2026 season.

Sanju Samson and Rajasthan Royals Sanju Samson made his Rajasthan Royals debuted in 2013 and has since played 11 seasons for them, becoming the longest-serving player in the team's illustrious history. Across 149 IPL matches for the Royals, the right-hander has scored 4,027 runs at an average of around 31.70 and a strike rate near 141. Samson has three IPL



centuries for Rajasthan to his credit, including a career-best 119 off 63 balls against Punjab Kings in 2021. He also holds the franchise record for the most

Taking over as captain in 2021, he has led the team for five seasons and, with 32 wins from 62 matches, has surpassed Shane Warne to become the most suc-

cessful RR skipper. A source close to the decisionmakers at RR reportedly told Mumbai Mirror that Sanju Samson is the undisputed leader of the team. The report said it has been officially decided by the team that their all-time leading run-getter should not be traded ahead of the upcoming season.

It was in July that rumours strengthened about Samson ending his long association with RR to become Dhoni's successor behind the stumps at Chepauk.
