He cited measures like the establishment of the Central Sanskrit University, centres for teaching Sanskrit, giving grants to scholars of the language and the launch of a mission to digitise ancient Sanskrit manuscripts to highlight his government's steps in this regard. It has benefited numerous countless students and researchers, he added. "Many influential ancient books, including Hindu epics, have been written in Sanskrit, a language now largely confined to use in religious practices',PM Modi said.

Greeting people on the occasion of World Sanskrit Day 2025 or Vishva-Samskrita-Divas linking the celebration with Shravan Poornima. Posting on X,Prime minister Modi called Sanskrit a "timeless source of knowledge and expression" and noted that its influence can be seen across many fields -- from science to literature. ECI delists 334 registered unrecognised political parties

: In a major move to "clean up" the country's electoral system, the Election Commission of India (ECI) on Saturday delisted 334 registered unrecognised political parties which have failed to fulfil the essential condition of contesting even a single election for six years since 2019. The offices of these parties could also not be physically verified and located anywhere.

These 334 registered unrecognised political parties are from different states and Union Territories across the country, the poll panel said..

"After considering all facts and recommendations

has delisted 334 RUPPs. Now, out of the total of 2854 RUPPs, 2520 are remaining," the ECI said in a state-

"These RUPPs will now not be eligible to avail any benefit under the provisions of Section 29B and Section 29C of the RP Act, 1951 and the Election Symbols (Reservation and Allotment) Order, 1968. Any party aggrieved by this order can appeal to the Commission within 30 days," it further added.

The delisting of RUPPs is part of ECI's comprehensive and continuous strategy to purge the system of parties which have become

redundant and merely exist

on paper. It was in June 2025 that the EC had set the ball rolling for "purging exercise" and directed the CEOs of States and UTs to conduct verification enquiries of 345 RUPPs regarding compliance with the above

In the report submitted by respective Chief Electoral Officers (CEOs), 334 RUPPs out of total 335, were found not complying

with the above conditions. CEOs conducted inquiries, issued show-cause notices to these RUPPs and provided each party an op-





Lanterns in the sky, Justice in the air: **Bankura** medicos rally for victim

MI News Service, Bankura: Bakura's skies lit up with lanterns and air echoed with chants of justice, as doctors, students, and members of civil society united in a powerful demonstration for Tilottama. One year after the harrowing RG Kar case shook Bengal, her parents are still waiting for justice.

On Friday evening, the protest stage at Bakura Sammilani Medical College once again became the heart of an emotional movement . Medical students gathered in large numbers. holding candles and realizing lanterns into the nighteach a symbol of plea unanswered. The resounding cry, "We want justice for Tilottama," filled the air as the crowed demanded not only a speedy trial but also an end to the cultural of intimidation in educational institutions. The movements, which began as the first major civic uprising after last year's tragedy, has grown into a state-wide call for action. On August 9. Tilottama's grieving parents will lead a march to Nabanna, determined to keep their daughter's story alive until justice is served.

Guardians of IISER K victimized student lodges complaint with police of ragging and apathy of Ph D Supervisor

MI News Service, Kalyani: While the guardian of victimized Ph. D. student Anamitra Roy (26) of Indian Institute of Science Education and Research (IISER) Kolkata, lodged a complaint with Haringhata police on Saturday, the concerned autopsy took place in All India Institute of Medical Sciences (AIIMS) Kalyani on the same day. The students were with the body. Consequently, his body was handed over. On the other hand, the IISER K students submitted a deputation to the IISER K Authority delineating the view, the victimized student described on his social media (Facebook) account. But the students were reluctant to say anything to media. However, police has initiated a case, police said.After the post mortem at AIIMS Kalyani, the body was taken to the IISER Kolkata campus. AIIMS K is at the stone throw distance from IISER K. The students were with dead body. On the other hand, a sources said that police are on spot of the incident, that is the laboratory. The body was kept in an ambulance, brought from Shyamnagar in North 24 Parganas. Anamitra Roy, a Ph.D. student of IISER Kolkata died by suicide at the Mohanpur, Nadia, campus. He attempted suicide in the lab on Thursday and died in AIIMS K at around 10 am, on Friday.In a detailed Facebook post, he has mentioned about consistent mental and physical abuse since childhood, both at home and outside, including bullying in school and college. He has accused a PhD student at IISER Kolkata of ragging. He suffers from Asperger's autism about which he found out recently. He has been in depression since he was 18.According to IISER Kolkata sources, Anamitra Roy, a Ph.D. student in the department of Biological Sciences in IISER Kolkata, allegedly attempted to commit by consuming something in a laboratory. However, he fall ill in the lab on Thursday night. Subsequently he was sent to nearby AIIMS Kalyani. He was admitted there and treatment initiated. But he died in AIIMS K at around 10 am. on Friday. However, IISER K has published a press release describing the sorrow following the premature death of Anamitra Roy but it described nothing on the incident.But in his face book page, Anamitra Roy described that he was suffered from ragging. Even he has written the name of a student there. Hrisikesh Roy, cousin brother of late Anamitra Roy, lodged the complaint with Haringhata police station on behalf of the victim's parents on Saturday.He has written in the complaint, "From his final post on social media, it is evident that he had been subjected to severe bullying and was pushed into a deep state of mental depression by one of his seniors, Mr. Sourav Biswas, at IISER, Kalyani, where he had been pursuing his Ph.D. Instead of receiving guidance and support from his Ph.D. supervisor, Dr. Anindita Bhadra, he was continually demoralized."He expressed his dissatisfaction for apathy of the authority regarding his complaint. He said, "Despite lodging a complaint with the Anti-Ragging Cell, no action was taken. It appears that all Anamitra wanted was a formal apology from the accused person. When this was denied, he was mentally pressured to take his own life as an act of silent protest.

State Govt moves to curb excessive billing in pvt healthcare sector

MI News Service, Kolkata: In a decisive step to rein in the rampant practice of excessive billing by private hospitals and nursing homes, the State Government has introduced a major legislative measure. Last June, the Clinical Establishments (Regulation) Amendment Bill was tabled during the Legislative Assembly session, aiming to shield patients' families from undue financial strain.

According to official sources. the amendment makes it mandatory for hospitals to adhere strictly to the treatment package initially communicated to the patient's family. If treatment costs are expected to exceed the agreed package, the hospital must provide written notification and obtain ex-

plicit written consent from the family. Additionally, any extra charges must be accompanied by a detailed bill and a clear, justified explanation.

With the passage of this amendment, all registered private hospitals, nursing homes, and diagnostic centres in the state will fall under its ambit. Non-compliance will invite administrative action, signalling the government's firm resolve.

Complaints have been frequent in cases involving minor surgeries or the treatment of specific ailments, where patients are billed beyond the declared package. Often, costs for treating secondary or incidental conditions are bundled into the package without timely disclosure to the family, leading to severe financial distress. There have also been recurrent allegations of unnecessary ICU admissions or prolonged ventilation to inflate bills.

The government anticipates that once the new law comes into force, families will enjoy greater relief and transparency in medical billing. Hospitals, however, maintain that incidental expenses are sometimes unavoidable. In certain cases, additional tests or treatments become necessary when unforeseen complications arise during ongoing care, leading to higher costs.

Despite these arguments, the State Government has issued an unequivocal directive: under no circumstances may additional charges be levied without the informed consent of the patient or their family. Officials emphasise that the amendment, once enacted into law, will enhance transparency, safeguard patient rights, and significantly curb financial exploitation under the guise of medical necessity.

This legislative intervention reflects a growing recognition of the need to regulate private healthcare billing practices. By mandating accountability and enforcing clear communication between hospitals and patients' families, the government seeks to restore public trust and ensure that access to treatment does not come at the cost of financial ruin.

TMC intensifies grassroots campaign, issues **WhatsApp** directives to representatives

MI News Service, Kolkata: In a significant organisational push, Trinamool Congress (TMC) State President SubrataBakshi has issued a comprehensive set of directives to all party MPs, MLAs, and Zilla-Parishad chairpersons, re-inforcing Chairperson Mamata Banerjee's call for deeper grassroots engagement. The instructions, circulated via the party's official WhatsApp chan-nels, are aimed at strengthening public out-reach while highlighting alleged central govern-ment neglect in funding key development projects, particularly water supply schemes.

During a recent virtual meeting with lawmakers and senior functionaries. Bakshi stressed that every public representative must devote more time to the state government's flagship "Amader Para, AmaderSamadhan" (Our Neighbourhood, Our Solution) camps. He urged them to use these forums to inform citizens about the Centre's "discrimina-tory approach", especially its refusal to release funds for critical water projects.

As part of the new mobilisation strategy, MPs have been instructed to allocate 1 crore from MPLADS funds, MLAs to contribute 10 lakh from their constituency development budgets, and Zilla-Parishads to earmark 5% of their annual funds for water-related infrastructure. Applications collected during the camps must be processed swiftly, with all related works completed within 90 days.

Bakshi emphasised that the party's development narrative must reach every booth, with state government schemes promoted as tangible examples of governance delivery. Representatives have also been told to amplify Mamata Banerjee's stand on the Special Summary Revision (SIR) of voter lists, portraying it as fairness and inclusivity.

In addition, all MPs MLAs, and ZillaParishad heads are mandated to hold or attend at least one public meeting daily in their respective constituencies to maintain consistent citizen contact. This, Bakshi noted, is vital to counter opposition narratives and reinforce the TMC's grassroots connection. The move follows a massive virtual outreach led earlier this week by TMC National General Secretary Abhishek Banerjee, who addressed over 9,500 party representatives, underscoring the importance of sustained public engagement in the run-up to future electoral contests.

With the directives now in circulation, the TMC is clearly seeking to blend governance outreach with political messaging, positioning itself as both the primary service provider at the grassroots and the principal defender of Bengal's rights against perceived central neglect.

According to him, Kolkata Police had pursued the case diligently, arresting civic volunteer Sanjay Roy soon after the incident. "But a section approached the court, leading to an order for a CBI probe," he said. "The CBI completed its investigation, filed the chargesheet, and a verdict was delivered — yet we remain dissatisfied." The minister accused

the opposition of exploiting the tragedy for politi-cal gain. "Those who went to court to stall the death penalty are the very ones marching to Nabanna today," he remarked, suggesting the true aim of such protests was to malign the state's Maa-Mati-Manush government. Hakim also linked the controversy to a broader political context, alleging that in BJP-ruled states, Bengalis face oppression and the Bengali language itself comes under attack. "To suppress the growing roar across the state opposition is politicising the RG Kar incident," he alleged. Reiterating the Chief Minister's engagement, Hakim said Mamata Banerjee had repeatedly met doctors, heard their grievances, and attempted to address their demands. Nonetheless, he claimed, the agitation persisted solely for political reasons. Chingrighata traffic woes to see swift resolution

MI News Service, Kolkata: Chingrighata, one of the most crucial intersections along the Eastern Metropolitan Bypass, continues to be a hotspot for severe traffic congestion and civic difficulties, largely exacerbated by ongoing Metro construction work and a series of recent infrastructural setbacks. A few days ago, a collapse on the Ambedkar Bridge along the Bypass caused prolonged gridlock, virtually paralysing movement through Chingrighata for hours. Kolkata Police Commissioner Manoj Kumar Verma sought to allay public concerns, assuring that a lasting solution was imminent. "The

traffic situation in Chingrighata has been problematic, but we are taking specific measures. Alternative routes are being explored, and infrastructure development work has already commenced. Met office warns of more rain ahead

MI News Service, Kolkata: Kolkata woke up to bright, clear skies on Saturday morning, prompting many to wonder if the monsoon rains had finally taken a break — or perhaps ended altogether. The question on the city's lips: Is the rain over? The answer, according to the Alipore Meteorological Office, is more nuanced.

While rainfall is expected to subside temporarily across South Bengal, meteorologists caution that

this is by no means the end of the season's showers. As per the forecast, the region will likely experience little to no rain from Sunday through Tuesday. However, a fresh spell is set to arrive on Wednesday, 13 August, bringing heavy rainfall to South 24 Par-

On 14 August, scattered heavy rain is predicted in West Midnapore and Jhargram, while Kolkata and other parts of South Bengal could see intermit-

tent showers. The current weather pattern is being influenced by the monsoon trough, which extends from Bankura to Kanthi before stretching into the Bay of Bengal. Simultaneously, a cyclonic circulation is active over Uttar Pradesh and Bihar, shaping rainfall trends in the region.

Adding to this, meteorologists report that a new low-pressure system is likely to develop along the Andhra Pradesh coast on 13 August. This could trigger renewed showers in South Bengal after the brief

In North Bengal, however, the rains are far from over. The Met Office has issued heavy rainfall warnings for the region until 13 August, with the possibility of very heavy rain on Monday. This applies to shops, restaurants, hotels, IT buildings, malls, and all other business enterprises operating in the area. While businesses can still display signboards in English or Hindi, Bengali must be prominently included. The decision will be formalised in an NKDA board meeting scheduled for Friday. Officials emphasize that the policy aims to uphold and respect the cultural sentiment of the Bengali-speaking population in the city. With the rapid urban growth of Newtown — including increasing numbers of residents, commercial hubs, government and private offices, educational institutions, and hospitals — this rule seeks to bring linguistic uniformity and cultural identity to public spaces. NKDA sources confirmed that this requirement will be implemented for all new trade licenses and during renewal of existing licenses.

Death row inmate found dead in **Jalpaiguri Central Correctional Home**

Kona Expressway:

Daytime ban on goods vehicles to ease pre-puja congestion

MI News Service, Kolkata: Construction of a six-lane elevated corridor is currently underway on the Kona Expressway, a major traffic artery connecting Howrah and Kolkata. As a result, the road narrows considerably near the Santragachi Bridge, leading to severe traffic snarls. Daily commuters have been facing significant inconvenience due to the bottleneck. In a bid to reduce congestion ahead of the festive season and during Durga Puja, authorities have announced that all goods vehicles will be barred from using the Kona Expressway between 6:00 a.m. and 11:00 p.m. The restriction will take effect from Sunday, August 10, police confirmed on Friday. There will be no such restrictions on goods vehicle movement after 11:00 p.m.

According to police, heavy vehicles previously accessed Kolkata via Durgapur Expressway and Delhi Road through Maitipara, crossing over Howrah and using the Second Hooghly Bridge. Under the new diversion plan, they will instead enter the city via Nivedita Bridge and Tala Bridge, heading towards Kolkata Port or various destinations in North and South 24 Parganas. Similarly, goods vehicles traveling from Kolkata to Howrahwhether towards the Mumbai Highway or via Maitipara—will now have to take alternate routes. Those entering Kolkata from the Mumbai Highway will also be redirected, using Andul Road or Howrah–Amta Road instead of the Kona Expressway. Howrah Police Commissioner Praveen Kumar Tripathi stated on Friday that arrangements are being made to facilitate smooth movement of heavy vehicles along Andul Road and Howrah-Amta Road as alternative corridors. There will be no restrictions on goods traffic along these

Guv Bose approves bill to curb overbilling in pvt hospitals

MI News Service, Kolkata: For years, allegations have persisted against private hospitals overcharging patients beyond agreed package rates. In numerous cases, even after patients or their families were informed of a fixed treatment package at the time of admission, the final bill at discharge turned out to be several times higher. Insurance companies often refused to cover these inflated amounts, forcing victims to bear the additional costs out of their own pockets. To address such complaints, a bill was recently passed in the West Bengal Legislative Assembly. Now, the measure has received its final seal of approval from Governor C.V. Ananda Bose. According to Raj Bhavan, the Governor has given assent to The West Bengal Clinical Establishments (Amendment) Bill, 2025. The bill, tabled In the Assembly on June 17 this year by Chief Minister Mamata Banerjee's government, seeks to prohibit private hospitals, nursing homes, and clinics in the state from charging patients extra beyond the declared package rates. Under the new provisions, if a patient's condition becomes critical during treatment and additional procedures or expenses outside the package are required, the hospital must inform the patient's family clearly in advance.

Furthermore, hospitals will be required to prominently display package rate charts within their premises in a manner easily visible to all. These displays must be provided in multiple languages. Hospitals will also be obligated to collect and maintain daily treatment-related data on a regular basis.

Bone marrow transplants now covered under SwasthyaSathi Scheme

MI News Service, Kolkata: The SwasthyaSathi card, already an essential healthcare tool for the common people of West Bengal, is set to cover one of the most expensive and life-saving medical procedures — bone marrow transplantation. The state health department has given the green signal to include the treatment under the scheme.

A recent notification Issued by the health department confirms that bone marrow transplants will now be conducted free of cost at state-run hospitals for patients holding a SwasthyaSathi card. The state government will allocate ₹5 lakh per patient to cover the expenses of the procedure. Currently, bone marrow transplants are

carried out in only nine hospitals across the state, of which just two are government medical colleges. These are NRS Medical College and Hospital, where the procedure began in 2009, and Kolkata Medical College. According to available data, the waiting list re-

mains long. NRS Medical College and Hospital currently has 145 patients awaiting the procedure, while private sector facility Apollo Gleneagles Hospital, near the EM Bypass in Salt Lake, has 256 patients on its list. Kolkata Medical College has 105 patients awaiting transplants. Tata Medical Center, a leading cancer care institution, has the highest number, with 887 patients in need of the treatment. Thakurpukur

patients awaiting the pro-Dr. Tufankanti-Dolui, head of the Hematology Department at NRS Medical College and Hospital, said, "At present, we perform three to four bone marrow transplants every week. With the inclusion of this facility under the SwasthyaSathi scheme, the number will certainly increase." The Inclusion of bone marrow transplantation under SwasthyaSathi is being hailed as a landmark decision aimed at making advanced healthcare accessible to economically weaker sections of society. Given the high cost of the procedure in private hospitals, this move is expected to bring substantial relief to patients suffering from critical blood disor-

Cancer Hospital has 134

ders such as leukemia, lymphoma, and aplastic anemia. Officials believe the initiative will also strengthen public trust in the state's healthcare infrastructure and reduce the financial burden on families. With the government bearing the cost, many patients who previously could not afford the treatment will now have a renewed chance at life.

Karnataka CM orders probe into allegations of electoral fraud

a significant political development. Karnataka Chief Minister Siddaramaiah has announced that his government will investigate allegations of electoral fraud during the recent Lok Sabha elections in the state. Speaking to reporters at Mysuru airport on Saturday, Siddaramaiah was responding to remarks made by Leader of the Opposition in the Lok Sabha, Rahul Gandhi, who urged the state government to take legal action against those involved in vote manipulation. Addressing a protest rally in Bengaluru on Friday, Rahul Gandhi specifically highlighted alleged fraud in the Mahadevapura Assembly segment and other constituencies, calling on the Chief Minister to act. "Legal action will be taken based on the recommendations," Siddaramaiah said, confirming the government's intent. The Chief Minister added that the matter would be examined ahead of the upcoming Bruhat Bengaluru MahanagaraPalike (BBMP) elections. The state's Advocate General will be tasked with conducting a swift inquiry and submitting a detailed report. However, Siddaramaiah noted that ultimate authority over the electoral roll lies with the Election Commission. When asked about former minister C.M. Ibrahim's allegation that 3,000 votes were purchased in Badami in 2018 to secure his victory, Siddaramaiah dismissed the

Badami for nomination and campaigning. I won by a margin of 1,600 votes. India's Defence production hits record 1.5 lakh crore in FY 2024-25

MI News Service, Delhi: Defence Minister Rajnath Singh on Saturday announced that India's annual defence production has reached an unprecedented ₹1,50,590 crore in the financial year 2024-25, marking the highest output in the nation's history. The milestone represents an 18% growth over the previous fiscal's figure of ₹1.27 lakh crore and an impressive 90% surge since FY 2019-20, when production stood at ₹79,071 crore.

According to the Defence Ministry, Defence Public Sector Undertakings (DPSUs) and other public sector manufacturers contributed nearly 77% of the total production, while the

private sector accounted for 23%. The private sector's share has risen from 21% in FY 2023-24 to 23% this year, signalling its expanding role in the country's demanufacturing ecosystem. Singh credited the achievement to the combined efforts of the Department of Defence Production, DPSUs, public sector manufacturers, and private industry players. He described the consistent upward trend as a testament to the strengthening of India's defence industrial base. Both public and private segments posted strong growth in FY 2024-25, with DPSUs registering a 16% increase in output and the private sector surging by 28%. The Defence Ministry

attributed this sustained growth to far-reaching policy reforms, improved ease of doing business, and a decade-long strategic push for indigenisation. "This record-setting achievement underscores the growing momentum of the government's drive towards selfreliance in defence manufacturing under the Aatmanirbhar Bharat initiative, spearheaded by Prime Minister Narendra Modi," the ministry said in a statement. Officials highlighted that the government's emphasis on reducing import dependency, coupled with efforts to build a robust domestic defence industrial complex, has yielded significant results.

LITHIUM DEFICIENCY COULD LEAD TO ALZHEIMER'S STUDY SUGGESTS

NEW DELHI: A study in mice and samples of human tissue has found lithium to be essential for normal brain function, and suggested that a loss of the trace metal could contribute to the development of Alzheimer's disease -- offering a different treatment approach, researchers stat-

The study highlights that a trace amount of lithium in the environment, including drinking water, could act as a nutrient, similar to iron and vitamin C, and help reduce the risk of dementia.

Metals in trace amounts --'trace metals' -- such as iron, zinc and copper are known to be crucial for healthy brain function.

The researchers from Harvard Medical School and other institutes in the US said the study is the first to show the natural occurrence of lithium in the brain and its role in preserving the normal function of all major brain cell types, protecting the organ from neurodegeneration associated with ageing.

Alzheimer's disease is a neurodegenerative disorder in which cognitive functions such as memory, thought processes, and decision-making decline with age and can eventually disrupt everyday activities. It is the most common form of dementia.


The team performed experiments in mice and also analysed samples of human brain tissue and blood taken from people in varied stages of cognitive health.

Findings from the decade-long study, published in the journal Nature, show that lowered levels of lithium in the human brain are one of the earliest changes leading to Alzheimer's, and that a similar depletion in mice advanced the disease, including memory

"The idea that lithium deficiency could be a cause of Alzheimer's disease is new and suggests a different therapeutic approach," senior author Bruce Yankner, professor of genetics and neurology at Harvard Medical School, said.

The team also found that reduced amounts of lithium in the brain were a result of clumping of beta-amyloid plaques -- beta-amyloid proteins are essential for the brain's normal function, but in Alzheimer's disease are known to abnormally accumulate.

in the development of the brain in infants and children and explains why infants must sleep upwards of 14 hours per day," the article notes.

In other words, getting enough sleep, keeping a regular schedule, and ensuring that you listen to your body's cues matter more than hitting specific hours on the clock.

Exercising within four hours of bedtime may affect sleep duration, timing and quality, new research published Communications suggests.

The study analysed data from an international sample of 14,689 individuals who wore a multi-sensor biometric device (WHOOP Strap) to track exercise, sleep and cardiovascular metrics. Participants were monitored over the course of a year, generating more than four million nights of data.

Engaging in strenuous workouts, including high-intensity interval training, football, rugby, or long-distance running, within four hours of bedtime was linked to delayed sleep onset, shorter sleep duration, poorer sleep quality, higher resting heart rate during the night, and lower heart rate variability.

Intense exercise raises breathing rate, core body temperature and heart rate, potentially keeping the body in a heightened state of alertness that interferes with sleep. To improve sleep, researchers recommend finishing exercise at least four hours before going to bed.

"If exercising within a four-hour window of bedtime, people could choose brief low-intensity exercises, such as a light jog or swim, to minimise sleep disruption and allow the body to wind down."

WHAT IS SICKLE CELL **ANAEMIA?**

Sickle cell anaemia is a genetic blood disorder in which the body produces an abnormal form of haemoglobin called haemoglobin S. Normally, red blood cells are round and flexible. allowing them to move smoothly through blood vessels. In sickle cell anaemia, many red blood cells become rigid and shaped like a crescent or sickle.

This unusual shape causes several problems. The sickled cells can clump together and block small blood vessels, which reduces blood flow and oxygen delivery to different parts of the body. These blockages can cause episodes of severe pain, known as sickle cell crises, as well as organ damage. The red blood cells also break down much more quickly than normal. While healthy red blood cells live for about 120 days, sickled cells often survive only 10 to 20 days. This leads to anaemia, a shortage of red blood cells, which can cause fatigue and weakness.

People with sickle cell anaemia are also more prone to infections. The spleen, an organ that helps fight infections, can become damaged from repeated blockages caused by sickled cells. Common symptoms include tiredness, episodes of pain, swelling in the hands and feet, frequent infections, delayed growth or puberty, and vision problems.

The condition is inherited. A child develops sickle cell anaemia if they receive the sickle cell gene from both parents. If they inherit only one copy, they have what is known as the sickle cell trait, which usually does not cause symptoms but can be passed on to children.

There is no universal cure for sickle cell anaemia, but treatments such as hydroxyurea. blood transfusions, and, in some cases, bone marrow transplants can help manage symptoms and reduce complications.

Rising from the Streets of Hyderabad: An Athlete's Journey to Cricket Stardom

Mohammed Siraj, born on 13 March 1994 in Hyderabad, comes from a humble background-his father was an auto-rickshaw driver and his mother a housewife, while his elder brother works as an engineer. He began playing cricket with a tennis ball on the streets and only started serious cricket around age 19, taking nine wickets in his first match for his uncle's club

He made his first-class debut for Hyderabad in the 2015-16 Ranji Trophy and quickly established himself by taking 41 wickets in just nine games, becoming one of the tournament's top wicket-takers. His breakout season earned him a spot with Sunrisers Hyderabad in the 2017 IPL, where he was acquired at over ten times his base price and impressed with 10 wickets in six matches.

Siraj made his T20I debut for India in November 2017 and followed with his ODI debut in January 2019 against Australia. He made his Test debut in December 2020 against Australia in Melbourne, where he claimed a five-wicket haulsignaling his arrival as a key

bowler for India. By January 2023, he had become the world's number-one ranked ODI bowler.

In major tournaments, Sirai has created history: in the 2023 Asia Cup final, he recorded 6/21 and became the first Indian to take four wickets in a single over. Most recently, during India's Test series in England, he surpassed Jasprit Bumrah to become the leading wicket-taker among Indian pacers in overseas Tests since his debut. His relentless pace, bowling variation, and emotional commitment have made him an indispensable



part of India's pace attack. Off the field, Siraj has flourished financially and

professionally. Following India's historic win at The Oval in 2025-where his five-

wicket performance helped the Anderson-Tendulkar Trophy-his estimated net worth reached around Rs 57 crore, bol-stered by IPL contracts, brand endorsements, and central BCCI contracts.

Mohammed Siraj's story is one of resilience, relentless effort, and rising beyond humble beginnings to become a frontline fast bowler for India.

Mohammed Siraj earned enormous praise for his stellar performance in the recently concluded Test series and his match-winning performance in the final game of the Anderson-Tendulkar Trophy. The Indian cricket legend Sachin Tendulkar also lauded the fast bowler for his infectious energy and never-say-die attitude

Among all the bowlers on either side, it was Siraj stood out for who Tendulkar. He was the only bowler to feature in all five Tests and shouldered a massive workload, bowling 1113 deliveries, 361 more than any other bowler in the series. With 23 wickets to his name, Siraj finished as the leading wicket-taker, leading the attack in the absence of Jasprit Bumrah in two crucial matches.

"Unbelievable. Superb approach. I love his attitude. I love the spring in his legs," Tendulkar said on his official Reddit account in a video, as quoted from ESPNcricinfo.

"For a fast bowler to be constantly in your face like that, no batsman will like it. And the approach he had till the end on the last day, I could hear commentators also saying he bowled around 90mph (145kph) on the last day after having bowled more than 1000 deliveries in the series.

The LoP referred to voter data published by the Election Commission of India on March 16, 2025, to back his claims. LoP Rahul Gandhi alleged that Aditya Srivastava is listed as a voter in Assembly Constituency 158 Jogeshwari East, Booth No. 197 in Mumbai, and Vishal Singh is listed in Assembly Constituency 174 Mahadevapura, Booth No. 458 in Bengaluru. He also said both were shown as voters in Assembly Constituency 173, Lucknow East, Booth No. 84. However, a fact-check by the Chief Electoral Officer (CEO) of Uttar Pradesh revealed that the names mentioned are not listed as voters in the claimed constituencies. The CEO's office clarified after verifying records that Aditya Srivastava is still enrolled in Assembly Constituency 174, Mahadevapura (Booth No. 458, Part No. 1265), and Vishal Singh is enrolled in the same constituency (Booth No. 513, Part No. 926). Their names do not appear in Lucknow East or Varanasi Cantt constituencies as claimed. Meanwhile, Mohammed Zubair, Alt News co-founder, alleged that Aditya Srivastava is registered in Lucknow East, Jogeshwari East, Mahadevpura constituencies. • Historic Milestone: First-Ever Freight Train carrying Cement arrives at Anantnag Goods Shed in Kashmir Valley

• Arrival of Freight train in Kashmir Valley heralds a new era of logistical and economic growth

MI News Service, New Delhi: ${\rm In}\ {\rm a}$ historic development for regional connectivity, a freight train has successfully reached Anantnag Goods Shed in the Kashmir Valley for the first time from Rupnagar, Punjab, marking a significant milestone in connecting the Kashmir region to the national freight network. The arrival of freight train, carrying cement, is set to accelerate infrastructure projects and improve living standards for the people of Kashmir. The inaugural freight train was loaded with 21 BCN wagons of cement. The journey, spanning approximately 600 kilometers, culminated at the newly commissioned Anantnag Goods Shed today in less than 18 hours. This event marks the firstever cement loading specifically for this facility, underscoring its readiness to support a new era of logis-



tical and economic growth in the Kashmir region. The cement transported on this train will be used for

crucial projects, including the construction of roads, bridges, public infrastructure, and residential housing in the Kashmir Valley. The logistics for this groundbreaking journey were executed with precision. An indent was placed with Northern Railway at 23:14 hrs on August 7, 2025, with the rake placement occurring at 09:40 hrs the following day i.e 08th August, Loading was completed by 18:10 hrs on August 8, 2025, with the train departing from the Gujarat Ambuja Cement Limited (GACL) facility in Rupnagar, Punjab at 18:55 hrs. The freight was hauled by an Electric WAG-9 locomotive (Loco No. 32177, TKD, Trip 08/09), highlighting the modern capabilities of the national railway network. The arrival of this first freight train is not just a logistical achievement but a powerful symbol of progress and integration, paving the way for a more connected and prosperous Kashmir Valley.

'Will die here': Palestinians refuse to leave Gaza City de-

At least 6 Palestinians killed, dozens wounded near aid crossing

MI News Service, Gaza City: At least six Palestinians were shot dead and more than 140 were wounded at the Israeli-run Zikim Crossing in northern Gaza, where UN aid convoys enter. Dr Mohamed Abu Selmiva. the director of Shifa Hospital, which received the dead and wounded, said all six were killed by Israeli gunfire. A Palestinian witness, who asked not to be named for security concerns, said a small number of looters with knives were among desperate crowds that unloaded a convoy, but that it was less chaotic than on previous days and that more trucks entered. e said Israeli troops still fired toward the crowds. There was no immediate comment from the Israeli military. Hundreds of Palestinians have been killed while seeking humanitarian aid in Gaza since May, when Israel eased a 2 1/2 month blockade. Witnesses, health officials and the UN human rights office say they were killed by Israeli fire. The military says it has only fired warning shots at people who approach its forces. Canadian Prime Minister Mark Carney says Israel's plan to take over Gaza is wrong and puts the lives of the hostages at a greater risk. "We join many others in viewing that this is wrong, that this action is not going to contribute in the improvement of the humanitarian situation on the ground. It is going to put the lives of the hostages at greater risk rather than lessoning it," Carney said. "We reiterate our call for an immediately ceasefire," he said when asked about it Friday. France condemned the plans "in the strongest possible terms".

In a statement from the foreign affairs ministry, France said it "reiterates its firm opposition to any plan for the occupation of the Gaza Strip and the forced displacement of its population".

BULAWAYO [ZIMBABWE] : After registering a victory over Zimbabwe, New Zealand skipper Mitchell Santner lauded the bowlers' performance, saying that the team bowled "very well" especially in the first innings.

Centuries from Devon Conway, enry Nicholls and Ravindra and a historic spell by pacer Zakary Foulkes helped New Zealand secure a massive win over Zimbabwe by an innings and 359 runs at Bulawayo on Saturday.

With this victory, the Kiwis have won the series 2-0, and they have secured their biggest win in Test cricket history.
