INDIA SHOT DOWN 6 PAKISTAN JETS DURING OPERATION SINDOOR: IAF CHIEF

MI News Service, New Delhi: Indian Air Force chief Amar Preet Singh said India had shot down at least five Pakistani fighter jets and one large military aircraft during Operation Sindoor, using the Russianmade S-400 anti-aircraft missile. He did not mention any losses suffered by India but said the key reason behind the success of the May 7-10 military operation was the "presence of political will".

Indian defence officials had earlier acknowledged that India had lost aircraft but not revealed how many. Air Chief Marshal Singh's comments marked the first official disclosure of the number of Pakistani jets India had shot down during Sindoor. His remarks came days after Rahul Gandhi alleged in Parliament that India had lost aircraft during the conflict because of the Narendra Modi government's failure to show "political will". "We have at least five fighters confirmed kills and one large aircraft, which could be either an ELINT aircraft or an AEW&C aircraft, which was taken on at a distance of about 300 kilometres," Singh said delivering the Air Chief Marshal L.M. Katre lecture in Bengaluru. "This is actually the largest ever recorded surface-to-air kill that we can talk about," he added. "A key reason for (the) success was the presence of clear political will. There were very clear directions given to us. No restrictions were put on us.... If there were any constraints, they were selfmade.... We decided how much to escalate and we had full freedom to



Captain Shiv Kumar, the defence attaché in Indonesia, had earlier said India had lost "some" combat jets on May 7 because of the "constraint given by the political leadership" against striking Pakistani military establishments and air defences. In Parliament, Rahul had cited Shiv Kumar to allege that the government had compelled the forces to conduct Operation Sindoor with their "hands tied behind their backs" to protect Modi's image. Before Shiv Kumar, Chief of Defence Staff Anil Chauhan had acknowledged that India had lost fighter jets on Sindoor's opening day before rectifying its tactical mistakes and launching attacks that "hit deep inside Pakistan" on subsequent days. Listing the other damages on Pakistan's defence capabilities, the air chief on Saturday said: "Shahbaz Jacobabad airfield, one of the major airfields that was attacked. Here there's an F-16 hangar. One half of

the hangar is gone and some aircraft inside might have been damaged. "And I'm sure there were some aircraft inside which got damaged there. We were able to get at least two command and control centres, like Murid and Chaklala. At least six radars, some of them big, some of them small...." 'Ghost' of Balakot The air chief said India had fought "a high-tech war", laying to rest the "ghost" of the Balakot air strike launched on Pakistan in 2019 in retaliation for the Pulwama terror attack. The air chief expressed disappointment at those who had questioned the success of the Balakot air strikes. "...In Balakot, we couldnot get anything from inside, and it became a big issuetrying to tell our own people, unfortunately, as to whatwe have been able to achieve," he said. "We had intelligence of what had gone on inside, had a human kind of intelligence where we had a very clear picture of the inside in terms of there had been huge damage." He added: "There have been so many terrorists who have been neutralised, but we could not convince our own people that, 'Look, we have achieved that'. So I am very happy that this time we were able to take care of that ghost of Balakot that we were able to tell the world

what we have achieved. Singh showed photos, videos and satellite imagery relating to Operation Sindoor. 'Good decision' Air Chief Marshal Singh defended the government's move to pause Operation Sindoor, saying the decision reflected wisdom after achieving key military objectives.

US President Donald Trump has repeatedly claimed to have bro-kered a "ceasefire" between India and Pakistan. But the Modi governmentsays the decision to stop the operation was its own and that a heavily battered Pakistan had requested the halt —claims that Singh appeared to endorse.

"People got down to their egos in the war. Our objective was very clear — to teach terrorists a lesson so they think twice before doing anything," the air chief said. "Once we achieved that, we should have looked for all windows of opportunity to stop. Some people very closeto me said, 'Aur maarna tha'," he

"Can we continue to be at war? Why should we remain at war when we can stop it? That's my way of looking at things, but I think the nation has taken a very, very good decision. The decision was taken at a much higher level. "In 80 to 90 hours of war, we were able to achieve so much damage that it was clear to them (Pakistan) that if they continue, they are going to pay for it more and more. "So they came forwardand sent a message to our DGMO that they wanted to talk. This was accepted onour side.

However, the Opposition believes that Trump's remarks raise questions that the Modi government needs to answer. Several Opposition leaders, including Rahul Gandhi and Mallikarjun Kharge —the leaders of the Opposition in the two Houses have questioned the timing and the logic behind the halt to Operation

Centre's 'Free Hand' key to Operation Sindoor's **success: Army Chief**

MI News Service, Chennai: Army Chief Gen Upendra Dwivedi asserted that Operation Sindoor was unlike any conventional mission and that it was akin to playing a game of chess as "we did not know" what would be the enemy's next move. In his address at a function at IIT-Madras, he recalled the intricacies of India's decisive military action in May on terror infrastructure in retaliation for the April 22 Pahalgam attack. Dwivedi claimed that the Centre gave a "free hand" to the armed forces to execute Operation Sindoor.

Dwivedi has mocked Pakistan's victory claim against India during the recent conflict, underlining the importance of the narrative management system. "Narrative management system is something which we realise in a big way because in the mind. If you ask a Pakistani whether you lost or won, he'd say, my chief has become field marshal, we must have won only, that's why he has become field marshal," said the Chief of Army Staff, taking a subtle jibe at Pakistan Army chief Asim Munir's promotion to

Field Marshal. Using the metaphor of the chess game, Gen Dwivedi said, "In Operation Sindoor what we did, we played chess. So, what does it mean? It means, we did not know what is the next move, the enemy is going to take, and what we are going to do. This is something, we call.. the grey zone. Grey zone is that we are not going for the conventional operations. But, we are doing something, just short of a conventional operation." "Conventional operation means, go with

everything, take everything you have. And, if you are able to come back, otherwise, stay there. That is called the conventional approach. Here, the grey zone means any activity that is taking place in all domains, that is something we are talking about and Operation Sindoor taught us that this is the grey zone," he said, "So we were making the chess moves, and he (enemy) was also making the chess moves. Somewhere we were giving him the checkmate and somewhere we were going in for the kill at the risk of losing our own, but that's the way, life is all about," the Army chief said. Earlier, Air Chief Marshal Amar Preet Singh said that India downed five Pakistani fighter jets, and one large Airborne Early Warning and Control (AEW&C) or early warning aircraft, during Operation Sindoor. Under Operation Sindoor in May, the IAF carried out precision strikes on multiple targets in Pakistan Pakistan-occupied

Kashmir linked to terror groups. The operation was aimed at destroying terror infrastructure and neutralising key operatives in wake of the Pahalgam attack.

200 still missing as Dharali rescue called off

News Service, Uttarakashi: The rescue operation in flash flood-hit Dharali village of Uttarkashi district was officially concluded on Saturday, with at least 200 villagers and tourists still missing. The Uttarakhand government has stopped short of saying that the missing are presumed dead, and its official death toll remains six, on the basis of bodies recovered.

A committee has been formed to prepare a rehabilitation plan for the survivors at Dharali, which saw houses, hotels, homestays, shops and offices in its lower reaches swept away by a torrent of mud, water and rocks on Tuesday afternoon. "A large number of roads in the neighbourhood of the devastated village were damaged because of flash floods or landslides. It was very difficult to conduct the

Arya was quoted as saying: "The rescue operation was over after about 400 people, who were stranded in the (upper reaches of the) village and adjoining areas, were taken to safe places." But, he said, the search

for those missing is continuing."Rescue teams, including those from the army, are using ground-penetrating radar to look for people who might be buried (under the debris)," he said. The deluge has left nothing standing in the Dharali market. "Hundreds might be buried a few feet below where I'm standing," Mahesh Kumar, who used to work at a homestay at Dharali market, told reporters on Saturday afternoon. He described how he had survived.

"Here, people alert each other by whistling (a signal) if they sense any danger. Some tourists were having

'Not bound by rules' to disclose voters excluded from draft roll: **EC**

The Election Commission (EC) has told the Supreme Court that there would be no deletion of any voter's name from the draft electoral roll in Bihar without issuance of prior notice, affording opportunity of being heard and a reasoned order. The poll panel also said that statutory framework does not require it to prepare or share any separate list of names of people not included in the draft electoral rolls, or publish the reasons for non-inclusion of anyone in the draft rolls for any reason. The EC filed an additional affidavit in the apex court on Saturday, days after it came out with the much-anticipated draft electoral rolls in Bihar, enlisting 7.24 crore voters but knocking off more than 65 lakh names, claiming that most of the persons concerned had died or migrated. Separately, the EC also filed its reply to an application filed by the petitioner seeking direction to the poll panel to publish a full and final assembly constituency and part/booth wise list of names and details of approximately 65

meration forms were not submitted along with reasons for non-submission. A bench headed by Justice Surya Kant is hearing the pleas against the EC's Special Intensive Revision (SIR) of electoral rolls in Bihar. In its additional affidavit, the poll panel said the first stage of SIR was completed and draft electoral roll was duly published on August 1. "It is further submitted that, as a matter of policy and in strict adherence to the principles of natural justice, no deletion of any elector's name from the draft electoral roll, published on August 1, 2025, shall be undertaken without: (i) issuance of a prior notice to the concerned elector indicating the proposed deletion and the grounds thereof, (ii) affording a reasonable opportunity of being heard and furnishing relevant documents, and (iii) passing of a reasoned and speaking order by the competent authority," it said.

It said these safeguards are further reinforced by a robust two-tier appeal mechanism under the relevant rules,

elector has adequate recourse against any adverse action. The EC said to ensure that no wrongful deletion from the draft rolls was carried out, strict directions were issued to prevent deletion without notice and a speaking order by the competent authority, with provision for appeals under section 24 of the Representation of the People Act, 1950. The poll panel said it is taking every possible step to ensure that no eligible elector is excluded from the electoral roll. In its separate reply, the poll panel said, "It is submitted that the statutory framework does not require the respondent (EC) to prepare or share any separate list of names of people not included in the draft electoral rolls, or publish the reasons for non-inclusion of anyone in the draft electoral rolls for any reason". "As neither the law nor guidelines provide for preparation or sharing of any such list of previous electors whose enumeration form is not received for any reason during the enumeration

Bengal migrant jailed in Maharashtra for months after failing to speak Hindi clearly

MI News Service, Kolkata: A migrant worker from Patiram in South Dinajpur district has purportedly been languishing in a jail in Ma-harashtra's Thane district for nearly three months after being branded as a Bangladeshi and allegedly because he could not properly explain his address in Hindi. Asit Sarkar, 54, had travelled to Maharashtra in January this year with his two sons in search of work.

The trio found jobs in a unit which manufactures gold-plated necklaces in Bhiwandi's Sonali area. But in late February, Narpoli police raided the locality and picked up seven migrant workers, including Asit, on suspicion of being Bangladeshi nationals, said

The police reportedly asked the workers to produce documents to prove their Indian citizenship. "All of them did. Six were released. But my husband was singled out and arrested. His crime was that he could not pronounce his home address properly in Hindi. When asked where he was from, he reportedly replied in Bengali, which made the police interpret that he was a Bangladeshi,' Asit's wife Lipi said, sitting at her home in Patiram. While Asit was remanded in judicial custody, his sons managed to evade arrest. One of them, Akash, who is 22, has returned home and has been running from pillar to post, seeking help for his father's release. He said that the Maharashtra police had come looking for him, too, in Thane. "I barely managed to flee. Since then, no one has allowed us to meet my father in jail," he said. Lipi said: "My husband does not know Hindi well. That does not make him a foreigner.

State Forest Department to Conduct Study on endangered **Gangetic dolphins**

MI News Service, Kolkata: A group of fishermen set out to catch hilsa during the peak monsoon season in the Bhagirathi River at Shadipur in Jamalpur, East Burdwan district, but instead found a Ganges river dolphin caught in their net. The Ganges river dolphin is recognised by the central government as India's national aquatic animal. Prashanta Pakar, a professional fisherman from Jamalpur, who caught the 50–55 kg Gangetic dolphin, said they released it back into the middle of the river after it became entangled in their fishing net. In 2024, after a gap of about two decades, hilsa weighing around one kilogram had been caught here, giving the fishermen hope that they would again land the prized "silver crop" this year. Instead, they found themselves with an endangered Gangetic dolphin in their net. Ganesh Choud-hury, a Gangetic dolphin expert from the Katwa area, said that fish form the main diet of these dolphins and, due to a shortage of fish in the Ganga, they are entering other rivers and lakes.

"In the Ajay and Bhagi-rathi rivers of Katwa, there are around 45–48 Gangetic dolphins, and they are regularly caught in fishermen's nets. While some are released alive, a few die after being trapped," he added.

Internationally acclaimed

swimmer and national

award-winner Sayani Das of Kalna had earlier posted a picture of herself swimming in the Ganga alongside a dol-phin. On World Wildlife Day this year, the Union minister of environment, forest and climate change released India's first-ever census figures for the Gangetic dolphin population. The survey recorded 6,327 dolphins in the Ganga and its tributaries. Of these, three were identified as Indus river dolphins and 6,224 as Gangetic river dolphins. The count showed 3,275 in the main Ganga and 2,414 in its tributaries. The census began in 2021, covering about 8,507 km of waterways. The highest numbers were recorded in Uttar Pradesh, followed by Bihar, West Bengal, and Prime Minister Narendra Modi personally released the Indian Gangetic Dolphin Census Report 2025 during a meeting of the Na-tional Board for Wildlife in Gujarat. "In 2004, West Bengal alone had about 4,000 Gangetic dolphins, but over the decades, due to food scarcity, pollution, and fishing activities, the number has dropped below one thousand," said Ganesh Choudhury. The Ganges river dolphin has been listed as an endangered species on the IUCN Red List since 1996. A long stretch of the Ganges between Sultanganj and Kahalgaon in Bihar has been declared the Vikramshila Gangetic Dolphin Sanctuary – the country's first protected area for the species. About a month ago, the Inland Waterways Authority of India and the Union MoEFCC jointly took steps to install sensors in cruise ships and other passenger and cargo vessels to protect Gangetic dolphins from

propeller strikes.

Darjeeling tea planters propose attendancelinked bonus, unions reject tiered structure

MI News Service, Darjeeling: The Darjeeling Tea Association (DTA) has, for the first time in the industry's history, proposed an atten-dance-linked bonus system for garden workers this

The lowest bonus rate is 8.33 per cent while the highest is 20 per cent of the workers' annual earnings. The final rate has to be negotiated between planters and workers' unions. On Friday evening, the Darjeeling Tea Association convened the bonus meeting for the Darjeeling tea industry in Darjeeling. Sources said that planters proposed a tiered bonus structure based on the number of days work put in by a worker in the year, which was rejected by the unions. Saman Pathak, CITU leader, who was present in the meeting said: "The plan suggested 16 per cent for workers with attendance of 240 or more working days in a year, 14 per cent for those with 191–239 days, 12 per cent for 151-190 days, and 8.33 per cent for 30– 150 days." The planters clarified to that the percentage mentioned was just an example and that they have not come up with any final percentage. They, however, confirmed that they proposed a tiered bonus structure. "Absenteeism is a major bane of the industry and this is why we propose a tiered structure," said Sandeep Mukherjee, the principal adviser of the Darjeeling Tea Association. "If bonus rate is agreed as per attendance there would be no need for central level negotiations every year. The attendance is kept at the garden level and every worker would be aware of the bonus they would be entitled to," said Mukherjee. Pathak, however, said that the proposal was rejected by the nine unions attending the meeting.

IISER students seek probe against antiragging committee members over scholar's death

MI News Service, Kolkata: Students of IISER Kolkata on Saturday demanded a probe against members of the institute's anti-ragging committee, alleging that they failed to respond to the complaint research scholar Anamitra Roy had lodged in April before de-ciding to end his life on Thursday night. The IISER students have called for the immediate dissolution of the anti-ragging committee and an apology from its members for what they described as negligence leading to Roy's

death. They also demanded the formation of a special investigation team comprising external members and a student representative to investigate the death of the third-year PhD scholar who, they alleged, was subjected to repeated bullying and abuse by senior research scholar Sourabh Biswas, who enjoyed the protection of his supervisor, Anindita Bhadra. The institute has now constituted a fact-finding committee with both external and internal members, including a representative from AIIMS Kalyani, and asked it to submit its report within seven days, sources said. An IISER spokesperson refused to share details about the probe team. Sources indicated that the Union human resource development ministry was also likely to send a fact-finding team. On Saturday, students submitted a 16-point charter of demands, which included the creation of a disciplinary action committee for professors and staff members, an external panel to investigate alleged scientific misconduct in Biswas's PhD thesis.

Man nabbed in **Rs55,000** online loan fraud in Kolkata

According to police sources, the accused met the complaint while returning from Odisha and struck up a conversation. Over several days, he allegedly gained the individual's trust and obtained sensitive account information. Investigation claim the loan without the victim's knowledge. It is not yet clear who was responsible. Those who were taken into custody should have been given adequate security. I am saddened to hear that Tilottama's mother was injured during the Nabanna campaign. It was not appropriate. This issue must be resolved, and the guilty must face justice," said the MLA. He further added, 'From what I can see, the investigation still appears incomplete. I hope the authorities concerned take prompt steps so that the culprits are identified and punished. Tilottama's father also reiterated his call for justice, stressing the need for a transparent investigation process. He urged that all concerned agencies work together to ensure that the truth comes out, while expressing faith that proper evidence and judicial processes can bring closure to the case. The incident, which occurred on August 9 last year, continues to evoke strong public sentiments, with many citizens and organisations holding demonstrations to demand justice.

Kunal Ghosh slams BJP's "lone" Nabanna protest by Shuvendu

MI News Service, Kolkata: The recent Nabanna campaign has sparked a fresh round of political debate, with senior leader Kunal Ghosh raising questions about the apparent ab-sence of key opposition figures during the programme. Speaking to the media, Ghosh remarked on the lack of visible participation from several prominent leaders, including Shamik Bhattacharya, Sukanta Majumdar, and Dilip Ghosh, during the protest led by Leader of the Opposition Shuvendu Adhikari.

Kunal Ghosh commented that Suvendu Adhikari appeared to be standing "alone" in the campaign and hinted at possible internal issues within the opposition camp. "If one listens closely, there are many things to be heard from within," he observed. He further alleged that while Adhikari's supporters took part in the campaign, certain actions during the day, particularly by some leaders, undermined the overall programme. In



response, BJP state spokesperson Shamik Bhattacharya defended Suvendu Adhikari's role, describing it as part of his constitutional duty as Leader of the Opposition. Bhattacharya maintained that Adhikari attended the protest to address pub-

lic grievances and dissatisfaction in the state. He also noted that other BJP leaders, MLAs, and workers had extended their support to the campaign. Former BJP state president Dilip Ghosh clarified that he was unable to join the protest due to health concerns but had offered his moral support. The Nabanna campaign has also led to legal repercussions, with seven cases registered in connection with the day's events. Allegations of clashes with the police have been made, and authorities have launched an investigation. Among the incidents under scrutiny is an alleged pushing incident involving Tilottama's mother. Kunal Ghosh claimed that a BJP leader was responsible for the act, a charge that the opposition has not accepted. The political fallout from the Nabanna campaign appears set to continue, with both sides trading accusations while investigations proceed into the incidents reported during the protest.

MI News Service, Kolkata: The father of Tilottama, the victim in the RG Kar Medical College case, has levelled serious allegations of political bias against a section of the doctors' protest platform that has been demanding justice for the past year. Speaking after a protest march to Nabanna on Saturday, he claimed that despite assurances, several groups did not participate in the event, and some members of the platform appeared to be working in alignment with a

particular political ideology. According to him, the Nabanna campaign had been intended as a non-political demonstration, and invitations were extended to multiple organisations and individuals who had previously supported their cause. While a few senior doctors were present, many others were absent. Expressing disappointment, he said, "We had invited everyone. A few senior doc-

tors came, but it is clear



a certain political ideology. I had requested them to join the campaign from any platform they preferred, but they did not accept that." The Nabanna march saw significant participation from supporters, with Tilottama's parents leading

from the front. However, the father questioned the absence of several groups who had been active in earlier stages of the movement. He also noted that the response from certain quarters had been lukewarm despite

While the main doctors' protest platform did not attend Saturday's march, they had organised a separate night-long sit-in the day before, demanding justice in the case. The event included a torchlight procession from College Square to Shyambazar, and demonstrations also took place in the suburbs. Tilottama's death has triggered continuous protests and demands for action, with her family and supporters vowing to continue their movement until justice is served.

possible fresh spell of heavy to death from 4th floor rainfall in the middle of August as a low-pressure system is expected to develop over the northwest and west-central Bay of Bengal by Wednesday. This system is likely to impact coastal and inland districts of Bengal and Odisha, prompting the authorities to advise fishermen to avoid venturing into the sea on Tuesday and Wednesday. At present, the monsoon trough remains moderately active, stretching across Delhi and extending east and southeast over Bathinda, Rohtak, Delhi, Bareilly, Lucknow, Patna, Bankura, and Digha, before continuing to the northeast Bay of Bengal. This active trough is supporting intermittent rainfall across several parts of the state. On Sunday, light to moderate showers accompanied by gusty winds of 30 to 40 kmph are expected in various districts of South Bengal. Districts such as West Midnapore, Bankura, Purulia, West Burdwan, Birbhum, Nadia, and Murshidabad are likely to experience rain with thunderstorms. Similar weather conditions are forecast for Monday and Tuesday, but rainfall activity is expected to intensify from Wednesday. The Meteorological Department predicts a high probability of heavy rain in parts of South 24 Parganas, with showers continuing across other South Bengal districts as well. If the low-pressure system becomes well-marked, the weather could worsen further. By Thursday, some areas in West Midnapore and Jhargram districts are likely to witness heavy rainfall. Rainfall activity is expected to gradually subside across South Benquate protections to prevent

Fake 'Private Police Station' busted, 6 arrested in major fraud case

MI News Service, Kolkata: Authorities have arrested six individuals, including the main accused, Bibhas Adhikari, for allegedly operat-ing a fraudulent "private police station" under the guise of an international investigation agency. The arrests were made in Noida, Uttar Pradesh, following an extensive probe into the illegal operation, which is suspected of being involved in large-scale financial fraud.

Investigators allege that the accused set up a fake investigation office where they produced counterfeit international recognition ID cards. Using this setup, they reportedly registered false cases themselves, then summoned individuals named as accused in these cases and extorted money from them in the name of conducting investigations. A search of the premises revealed a significant quantity of forged identity cards and other incriminating materials. Sources indicate that Bibhas Adhikari was already under scrutiny in connection with an earlier recruitment-related corruption investigation. In April last year, his home, office, and an ashram in Nalhati, Birbhum, were searched by central investigation agencies, resulting in the seizure of numerous documents. The current case, however, points to a separate and broader fraud network, involving impersonation of law enforcement and misuse of fabricated credentials. The accused allegedly also created a website for their so-called international investigation agency, through which they collected "donations" from unsuspecting individuals. Local residents claim that the ashram associated with Bibhas had previously been linked to multiple corruption allegations. Police are now expanding their investigation to identify other potential victims and to determine the full scale of the operation. The discovery of the fake police station has raised concerns about similar fraudulent setups potentially operating elsewhere.

Ballygunge mystery: High Court lawyer falls

MI News Service, Kolkata: Kolkata police are investigating the mysterious death of Calcutta High Court lawyer Kaustav Chandra Das, who fell from the fourth-floor window of his Ballygunge residence early Saturday morning. According to police sources, the incident occurred around 4:30 a.m. at a well-known residential complex in the area. Das, who lived with his wife and son, was found lying critically injured on the ground. He was pronounced dead at the scene, and his body has been sent for postmortem examination to determine the exact cause of death. Investigators are working to establish whether the fall was the result of suicide, an accident, or foul play. This tragedy follows another recent incident in Howrah, where a young boy, Abhay Porel, died after falling from the window of a multi-storey building in Balitikuri Naskar Para. According to local residents, the child fell while playing near an open window. Doctors declared him dead upon arrival at the hospital. Residents alleged that the building owner had constructed an unauthorized upper-floor structure and rented it out without installing protective grills on the windows, raising safety concerns. Both incidents have sparked renewed attention on residential safety measures, with authorities urging building owners and residents to ensure ade-

similar tragedies.

Kasha gang rape twist: **Court allows voice** sample test of accused

MI News Service, Kolkata: Kolkata Police have introduced a fresh development in the ongoing investigation into the Kasba gang rape case. The police have sought and obtained permission from the Alipore court to collect voice samples from the primary accused, Manojit Mishra, along with his alleged associates, Jaib and Pramit. According to police sources, forensic experts have already examined the mobile phones seized from the accused trio. The analysis has reportedly revealed several crucial audio clips and conversations that may hold significant evidentiary value. Investigators are now aiming to match these recordings with the voice samples of the suspects to verify their authenticity and establish a stronger case. The Alipore court approved the police's application for voice sample collection during a hearing on Saturday. Additionally, when the four accused — Manojit, Jaib, Pramit, and another co-accused — were produced before the court, they were remanded to judicial custody until August 22. The case stems from a disturbing incident that took place on June 25 inside Kasba Law College. As per the complaint filed by the survivor the following day, she was allegedly assaulted and raped between 7:30 pm and 11:45 pm in two separate locations within the institution the students' union room and the guard's room. The survivor told investigators that she was initially confronted in front of the college by Manojit Mishra, who allegedly threatened her and forcibly took her inside. She further claimed that she was threatened with assault using a hockey stick and was physically beaten during the ordeal. The case, which has sparked widespread outrage, continues to be a priority of Kolkata Police. The upcoming forensic voice analysis is expected to play a pivotal role in corroborating the survivor's statement and strengthening the prosecu-

phase, no such list can be sought by the petition as a matter of right," it said. The poll panel said exclusion of a name from draft electoral roll does not amount to deletion of an individual from electoral rolls. It said draft roll simply showed that duly filled enumeration form of existing electors has been received during enumera-

tion phase. But, on account of human involvement in execution of this exercise of scale, there is always a possibility that an exclusion or inclusion might surface due to inadvertence or error," it said. The EC said prior to publication of draft electoral roll, it had directed the CEO and others to share with political parties the booth-level list of individuals whose enumeration forms were not received due to any reason and seek their assistance for reaching out to them. It alleged that the petitioner's approach was consistent with its earlier attempts to malign EC by building false narratives on digital, print and social media. "Such attempts should be appropriately dealt with by this court, and heavy costs should be imposed for petitioner's attempts to deliberately mislead this court," it said. The poll panel said admittedly,

after the publication of draft rolls, political parties were supplied with an updated list of names of electors not included in draft roll so as to ensure that all attempts are made to reach out to them. "The political parties have acknowledged receipt of the said list," it said.

Milind Deouskar, General Manager/Eastern Railway delivered the welcome speech in which he mentioned that the AC EMU service introduced between Sealdah & Ranaghat is the first of its kind in Eastern India. This train will run in morning and evening peak hours for a comfortable journey of suburban passengers between Ranaghat & Seal-

Jagannath Sarkar, Member of Parliament, in his speech appealed to the commuters between Ranaghat & Sealdah to purchase monthly tickets and also spread the message for patronising this coveted AC EMU service so that more such trains can be available in future.

Bhattacharya, Member of Parliament, revealed how the Union Government is trying hard for all-round development of Railway network in West Bengal. Marching ahead in this direction, Railway Ministry has introduced the AC EMU services from Sealdah.

Shantanu Thakur, Hon'ble Union Minister of State for Ports, Shipping & Waterways expressed thanks to Prime Minister and Minister for Railways for taking such initiatives towards running of

Sukanta Majumdar, Union Minister of State for Education & Development of the North Eastern Region mentioned that the Eastern Railway has created history by running the first AC EMU local between Sealdah & Ranaghat. He also mentioned how various initiatives of the Union Government is putting impetus to the socio-economic development in West Bengal like historic increase in Railway Budget allocation, development of Amrit Bharat stations, OSOP (One Station One Product) stalls for the benefit of local artisans and indigenous industries. This launch marks a de-

fining chapter for suburban railway connectivity in Eastern India, particularly for the thousands of daily commuters between Sealdah and Ranaghat. For the first time, the Eastern Region introduces an air-conditioned EMU service, setting a new benchmark for comfort and convenience in local rail travel. This new 12-car AC EMU rake is a three-phase, underslung-type marvel of modern engineering. Each coach is fully air-conditioned, equipped with dual 15-ton roof-mounted packaged units for optimal cooling. Commuters will enjoy panoramic views through wide, double-sealed glass windows while experiencing smooth travel facilitated by wide vestibule gangways interconnecting all the coaches. With a capacity to seat over 1,100 passengers, these rakes prioritize both comfort and safety. The coaches come with stainless steel three-seater arrangements and aluminium modular luggage racks. Each coach features four automatic, electrically operated sliding

and deboarding. To further enhance safety, the train is equipped with high-resolution CCTV surveillance, with four cameras installed in each coach.

Among the train's passenger-friendly features is a GPS-enabled LED passenger information system that offers real-time updates and automatic audio announcements. Emergency talk-back units at every doorway allow passengers to immediately alert the motorman or guard in case of distress. An emergency alarm system is also integrated to bring the train to a stop if necessary. Two dedicated women's coaches, located at each end of the rake, ensure safety and comfort for female commuters. The inclusion of such modern safety features, coupled with clean and cool interiors, represents a major upgrade in the region's suburban rail

service. Regular commercial run of this train will commence from 11.08.2025 (Monday). The train is scheduled to leave Ranaghat at 08:29 AM to reach Sealdah at 10:10 AM during the morning peak, and in the evening, it will leave Sealdah at 6:50 PM to reach Ranaghat at 8:32 PM. The train will stop at Bidhannagar Road, Dum Dum Junction, Sodpur, Kharda-ha, Barrackpore, Naihati, Kanchrapara, Kalyani, and Chakdaha. To keep this premium yet accessible, the fare has been fixed affordably with a minimum of ₹35 and a maximum of ₹120 for the full stretch of journey from Sealdah to Ranaghat.

Himachal: Police rescue 3 kidnapped schoolboys in 12 hours; one arrested



MI News Service, Shimla: The Shimla District Police traced three kidnapped Class 6 students from the prestigious Bishop Cotton School (BCS) in less than 12 hours, ensuring their safe recovery, and arrested a 45-year-old man in connection with the case.

The district administration said it will soon issue safety directions to all schools to prevent such incidents in the future. The police said the case came to notice on Saturday evening when the school reported that three boys of class 6th had failed to return from an authorised outing.

"We immediately acted, forming teams led by Additional SP Navdeep Singh, SHO Sadar, and SHO Chhota Shimla, along with officials from neighbouring districts. Together, we successfully traced the children. This is a kidnapping case, and we will investigate the reasons behind it. The way our police team worked on this sensitive case is appreciable," police

official said. 'We used CCTV and cyber investigation tools to track the case. We identified the vehicle and located it in Chaithila village in Kotkhai, where the children were found safe. Investigation is being done with due diligence, keeping all aspects open. Our duty was to find the children safely, and we fulfilled it,"

Gandhi said. SP Gandhi emphasised that the investigation will remain transparent and will also examine measures schools should adopt for better safety.

"The person who took the children in the vehicle

has been taken into custody. It was a team effort that resolved a complicated and difficult case on very short notice," he said.

Deputy Commissioner of Shimla district administration, Anupam Kashyap, commended the police for their swift action.

"As you know, Himachal

Pradesh is a peaceful state, and Shimla generally runs in an orderly way. Such incidents do not usually happen. The police and administration are always alert. In this case, with proper coordinated effort, the Superintendent of Police and his entire team handled it competently and successfully. I congratulate them," Kashyap told ANI.

"Children need to be guided more intensively in schools. Generally, such issues don't arise in Shimla and Himachal Pradesh. Many officers regularly monitor schools, adopt them, and give students tips on physical fitness and safety. This incident should not have happened, but the prompt efforts by Shim-la Police were excellent. I believe the police remain ready day and night to fulfil their duty, and our aim is to ensure such incidents do not occur in the future,"

Kashyap said. Deputy Commissioner of Shimla added that school activity calenders will be reviewed in light of the incident, and safety monitor-

ing will be intensified. Police had registered a Case under Section 137B of the Bharatiya Nyaya Sanhita (BNS) at the New Shimla Police Station.

One of India's biggest automakers, Tata Motors, saw its consolidated net profit slump by over 62 per cent to Rs 4,003 crore in its fiscal first quarter. The three-month period saw demand slowdown in domestic markets, but the dip in Jaguar Land Rover (JLR) profits on account of winding down its legacy line and the impact of Trump tariffs added fuel to the

Total ops revenue for Q1 FY2026 was Rs 1,04,407 crore, down marginally from Rs 1,07,102 crore a year ago. The auto giant saw its volumes shrink across all its arms, but the major bite of the profits was taken out of JLR.

Incoming CEO of JLR, and the current Tata Motors Group CFO, P.B. Balaji, seemed to be relieved that they did not post losses. "Despite stiff macro headwinds, the business delivered a profitable quarter, supported by strong fundamentals."

JLR's topline was massively impacted by the US tariffs on cars produced in the UK and the EU. The planned legacy Jaguar phaseout added to more woes.

Outgoing JLR CEO Adrian Mardell said that the latest UK-US and the US-EU trade deals would "lessen the significant US tariff impact

The automaker also stated a few initiatives such as the "institutionalisation of dealer stock policy and focus on driving retails" and "supportive retail incentive schemes" with upcoming festive period campaign. "Q1 was a subdued quarter for the pas-

senger vehicle industry, with volume pressures persisting across most segments. Demand softness weighed on overall performance, although the Electric Vehicle category remained a bright spot, supported by new launches and growing customer interest," reasoned Tata Motors Passenger Vehicles MD Shailesh Chandra.

"Looking ahead, while the overall industry growth is expected to remain muted, we are confident that our recent and forthcoming series of launches—across ICE and EVs—will enable us to outperform the market and strengthen our position across key segments,"

Indian refiners can do without Russian oil but with trade-offs

NEW DELHI: Indian refiners, the world's biggest user of Russian oil, can operate supplies Moscow from a technical standpoint, but the shift would involve major economic and strategic trade-

Congress launches campaign urging people to 'register' against 'vote chori'

MI News Sevice, New Delhi: says similar alarms were Rahul Gandhi's claims of poll rigging, the Congress party has launched a dedicated web portal where citizens can register to demand accountability from the Election Commission (EC) against what it terms as "vote chori" (vote theft) and support Gandhi's call for digital voter rolls.

The portal allows users to click a link to access and download what the party describes as "proof" of vote theft, demand EC accountability, and report cases of alleged electoral fraud. It also features a video of Gandhi reiterating his charge of a "huge criminal fraud" in the elections, accusing the BJP and the EC of collusion.

Citing an example from a constituency in Karnata-ka, Gandhi described the alleged malpractice as "a crime against the Constitution." The portal's message

previously raised in Maharashtra and that it now has "proof" to back the claims.

Registered users on the portal receive a digital certificate affirming their stand against "vote chori" and supporting Gandhi's demand for digital voter rolls. The certificate bears the signatures of Congress Mallikarjun president Kharge, general secretary K C Venugopal, and treasurer Ajay Maken. Citizens can also register via a phone number provided on the site, after which they receive a link via SMS.

Several Congress leaders and supporters have already registered, sharing their certificates widely on social media to amplify the campaign.

Meanwhile, the Election Commission has pushed back strongly against the allegations. On Saturday, EC officials urged Gandhi to either sign a formal declaration substantiating his claims or apologise for what they called "fake" charges. But as the demonstration began to wind down, police and protest organisers sparred over the number of arrests as the organisers sought to show that the law was unworkable.

"The police have only been able to arrest a fraction of those supposedly committing terrorism' offences, and most of those have been given street bail and allowed to go home," Defend Our Juries, which organised the protest, said in a statement.

India qualify for AFC U20 Women's Asian Cup for first time in two decades



U20 women's national team secured qualification for the AFC U20 Women's Asian Cup for the first time in 20 years, after defeating hosts Myanmar 1-0 in their final Group D encounter at the Thuwunna Stadium in Yangon, on Sunday, according to the AIFF

The Young Tigresses finished top of their group with seven points, after winger Pooja's 27thminute goal secured a victory for them in front of a partisan crowd at the Thuwunna Stadium.

It was a game of two halves, the first dominated by India, while Myanmar controlled the proceedings in the second. Neha and Sibani Devi Nongmeikapam combined as early as the third minute, to the latter, who was merely inches away from tapping it in.

While the hosts absorbed all the pressure, they did launch a few counterattacks, and forward Su Su Khin came close in the ninth, after receiving a chestdown from Yin Loon Eain.

The hosts began to ease their way into the game as the minutes wore on, but India took the lead through Pooja minutes ahead of the 30-minute mark.

It was Pooja herself who had started the attack on the counter before crossing it in from the right. Her ball evaded one and all, but Neha, at the opposite flank, managed to get onto the end of it and sent it looping back in. Pooja, who had made her way to the

NEW DELHI [INDIA] : New Zealand all-rounder Thamysn Newton has announced her retirement from all forms of cricket, after a 14-year career consisting of 10 ODIs and 15 T20Is on Sunday.

Newton was a part of the squad in the 2016 ICC Women's T20 World Cup, where New Zealand women lost out on a final spot narrowly after being beaten by the eventual champions, West Indies women, by six runs in the semi-final, according to the ICC website.

The pace all-rounder has grabbed 11 wickets in 10 ODIs she has been a part of, including one five-wicket haul against Pakistan in 2016.

While in T20Is, she has snapped nine wickets in 15 matches, which includes best figures of picking three wickets, giving away just nine runs in only her third T20I.

Newton last played an ODI in 2017, she earned back her central contract with New Zealand in 2021 after a gap of three years. But she only played three more T20Is after that. She also played for Perth Scorchers in the WBBL 2017-18. In the New Zealand domestic circuit, Newton has won multiple tournaments, including the Hallyburton Johnstone Shield, the 50-over contest, claiming it once each for two different teams - Canterbury and Wellington.

She has also triumphed in Super Smash Wellington four times. She began her domestic career with Wellington in 2011-12 before switching over to Canterbury from 2014 to 2018.

She returned to Wellington again for a further five years before moving to Central Districts ahead of the 2023-24
