
Having Aadhaar, PAN card or voter ID doesn't make person Indian citizen: Bombay HC

MI News Service, Mumbai: A person does not become a citizen of India merely by possessing documents like Aadhaar card, PAN card or a voter ID, the Bombay High Court on Tuesday said while refusing bail to a man, allegedly from Bangladesh, for entering India illegally.

The man is accused of staying in India for more than a decade with forged and fabricated docu-

A bench of Justice Amit Borkar said provisions of the Citizenship Act lay down who can be a citizen of India and how citizenship can be acquired and documents such as the Aadhaar card, PAN card and voter ID are only meant for identification or availing services.

The court refused bail to Babu Abdul Ruf Sardar,



Bangladeshi national, who entered India illegally without a valid passport or travel documents. He allegedly procured forged Indian documents such as Aadhaar card, PAN card, voter ID and also an Indian passport.

In 1955, Parliament passed the Citizenship Act which created a permanent and complete system for acquiring citizenship, Justice Borkar noted.

"In my opinion, the

Citizenship Act of 1955 is the main and controlling law for deciding questions about nationality in India today. This is the statute that lays down who can be a citizen, how citizenship can be acquired and in

lost," he said. "Merely having documents such as Aadhaar card, PAN card or voter ID does not, by itself, make someone a citizen of India. These documents are meant for identifica-

tion or availing services, but they do not override the basic legal requirements of citizenship as prescribed in the Citizenship Act," the HC said.

The law draws a clear line between lawful citizens and illegal migrants, the bench said.
People falling in the

category of illegal migrants are barred from obtaining citizenship through most of the legal routes mentioned in the Citizenship Act, it added.

"This distinction is im-

portant because it protects the sovereignty of the country and ensures that benefits and rights meant for citizens are not wrongfully taken by those who have no legal status to stay in India," the court said. The bench, while refusing bail to Sardar, noted that verification of his documents was still on

and the investigation was also still continuing, and the police's fear that he may abscond if granted bail is a genuine apprehension.

The allegations in the case are not small and it is not just about staying in India without permission or overstaying, but it is about making and using fake and forged identity documents with the aim of pretending to be an Indian citizen, the HC said.

Sardar was booked under provisions of the Bharatiya Nyaya Sanhita, the Passport (Entry to India) Act and the Foreigners Order. The court noted the investigation in the case is still going on with regard to genuineness of the Aadhaar card, which is being verified by the Unique

Israeli Ambassador To India Slams Priyanka Gandhi For Taking Hamas Side

MI News Service, New Delhi: Israeli Ambassador to India, Reuven Azar showered diatribe upon Priyanka Gandhi for blindly supporting terrorist group Hamas in some passing references. Earlier Congress leader Priyanka Gandhi Vadra accused Israel of committing "genocide" in Gaza and criticised the Indian government for remaining "silent" while Palestinians face devastation.

Priyanka claimed the "Israeli state murdered over 60,000 people, 18,430 of whom were children" and accused it of starving civilians.

"The Israeli state is committing genocide. It has murdered over 60,000 people, 18,430 of whom were children.

It has starved hundreds to death including many children and is threatening to starve millions. Enabling these crimes by silence and inaction is a crime in itself.

It is shameful that the Indian Government stands silent as Israel unleashes this devastation on the people of Palestine," she wrote on X. Israeli Ambassador to India Reuven Azar rejected the accusations. "What is shameful is your deceit. Israel killed 25,000 Hamas terrorists. The terrible cost in human lives derives from Hamas's heinous tactics of hiding behind civilians, their shooting of people trying to evacuate or receive assistance and their rocket fire. Israel facilitated 2 million tonnes of food into Gaza while Hamas tries to sequestrate them, thereby creating hunger. Gaza population has grown

there. Don't buy Hamas numbers," he wrote on X.

Priyanka also condemned the killing of five Al Jazeera journalists in Gaza, calling it "cold blooded murder" and "another heinous crime committed on Palestinian

"The immeasurable courage of those who dare to stand for the truth will never be broken by the violence and hatred of the Israeli state," she wrote. "In a world where much of the media is enslaved to power and commerce, these brave souls reminded us of what true journalism is. May they rest in peace.

Priyanka has repeatedly spoken out against Israel's actions in Gaza and expressed solidarity with the Palestinian

Last year, during the winter session of Parliament, Priyanka carried a handbag emblazoned with the word "Palestine" and adorned with Palestinian emblems, including a watermelon — a symbol of solidarity with Palestine.

Journalist Anas al-Sharif and four colleagues were killed in Gaza City in what Al Jazeera called a targeted Israeli strike on a tent housing journalists.

The UN human rights office called the air strike a serious violation of international humanitarian law. The Committee to Protect Journalists reports that 184 Palestinian journalists and media workers have been killed in the Gaza conflict since October 2023, compared to 18 in the Rus-

Existential crisis led to arms licenses to indigenous people:

MI News Service, Guwahati: Amid criticism over the Assam government's decision to provide arms licence to indigenous people, Chief Minister Himanta Biswa Sarma.

Speaking to reporters, Sarma said land rights also needed to be ensured for the indigenous people, along with arms licences. "Guns are required. If vou don't have a gun, how will you stay in South Salmara-Mankachar and Bagbar? If you go there, you will understand," he said on the sidelines of a programme in Baksa, when asked about the criticism over the "lenient" arms licence pol-

"There are 20,000-25,000 people surrounding it, and 100 people are staying in a Satra' (Vaishnavite seat



of learning) amid them. They will need something," he claimed. Also Read - Rajya Sabha returns Manipur budget, GST bill Sarma maintained that gun licences will be provided only after due evaluation and verification. "Guns are needed, land is needed, rights are needed. But everything has to be within the purview of the law, not outside it, he added. The state cabinet had on May 28 decided that the government would give arms licences to indigenous people living in "vulnerable and remote" areas for instilling a sense of security in them. Sarma had identified Dhubri, Morigaon, Barpeta, Nagaon and South Salmara-Mankachar districts, and localities like Rupahi, Dhing and Jonia as "vulnerable and remote"

All these areas are largely dominated by Bengali-speaking Muslims. The opposition claims that the decision is aimed at polarising the people, and has the potential to jeopardise the state's hard-

EC summons Bengal **Chief Secretary to Delhi**

Service, Delhi/Kolkata: Less than a day after the West Bengal government wrote to the Election Commission that it doesn't intend to suspend just yet its officers alleged to have committed "irregularities" in electoral roll revision, the poll panel on Tuesday summoned state Chief Secretary Manoj Pant to Delhi to explain the decision, sources said. The state's top bureaucrat was directed to report in person to Nirvachan Sadan, the Election Commission of India headquarters in the national capital, by 5 pm on August 13. The move, interpreted by observers as a fresh flash point in the ongoing face off between the Mamata Banerjee government and the Commission, came in response to Pant's communication to the ECI on Monday stating that suspending the

identified officers and filing FIRs against them, as directed by the poll panel, would be "disproportionately harsh" and have "demoralising impact" on the officers' community in

The government, instead, chose to remove two of the five ECI-identified officials from active election duty for now and initiate an "internal inquiry" into the matter.

'Dissolve Lok Sabha,' says Abhishek Banerjee

MI News Service, New Delhi/Kolkata: Trinamool Congress (TMC) national general secretary Abhishek Banerjee on Tuesday demanded the dissolution of the Lok Sabha and fresh elections, alleging large-scale irregularities in the country's voter lists.

Speaking at Kolkata airport before leaving for Delhi, he accused the BJP of benefiting from a "tam-pered" electoral roll and questioned the Election Commission of India's ['ECI's] integrity.
"In one EPIC number,

there are multiple voters. And this is not data provided by any political party, this is ECI's data. Why should the BJP defend the ECI?" Abhishek asked, challenging the ruling party to explain the alleged discrepancies.

issue of faulty voter lists was not limited to Opposition-ruled states.

"It cannot be that your voter list was all clear and Bengal's is faulty," he asserted, calling it a "national problem" and



accusing BJP of selectively targeting certain states.

"If there is any irregularity in the voter list, then dissolve the entire Lok Sabha. Let all MPs, including the Prime Minister and Home Minister, resign and call for fresh polls," he said. He also demanded proceedings against the former CEC" if tampering was proven.

BJP came to power because of 'vote chori'. If needed, I will also resign. Let there be fresh elections," Abhishek declared, adding that any Special Investigation Report (SIR) on the matter should cover the whole country, not just selective states.

Referring to Monday's protest in Delhi, during which MPs from the INDIA bloc — including TMC leaders — were detained, he said, "If they had honhave engaged in a discussion yesterday. Amid 'SIR' fiasco, Centre passes key bills

MI News Service, New Delhi: The BJP accused Rahul Gandhi of spreading anarchy as the Opposition hit the streets to protest the special intensive revision (SIR) of electoral rolls and the government passed key bills in Parliament without proper discussion, citing repeated disruptions.

The BJP fielded education minister Dharmendra Pradhan at the party headquarters to slam the Opposition's protest march to the Election Commission office against the SIR.

"The Congress and other Opposition parties want to spread anarchy in the country. By using words like 'atom bomb' to attack the EC, Rahul Gandhi is speaking the language of big forces who want to destroy democracy in India," Pradhan said after Opposition MPs were detained during their protest. Later, parliamentary affairs minister Kiren Rijiju slammed the

Opposition for wasting Parliament's time and declared that the government would now proceed with the passage of important bills. "The Congress and the Opposition parties have wasted a lot of time in the ongoing monsoon session. Now, enough is enough. The government will now pass important bills," Rijiju told re-

"Due to the misunderstanding of one person and one family, the country cannot bear a big loss," he added, lashing out at Rahul for being an "irresponsible" leader of the Opposition. Multiple bills were passed by the two Houses when they resumed business after adjournments in the morning. The National Sports Governance Bill, the National Anti-Doping (Amendment) Bill and the Income-Tax (No 2)

Pak Army Chief is a well dressed Osama-**Bin-Laden: Former Pentagon Officer**

MI News Service, Washington: Former Pentagon official Michael Rubin has called Pakistan Army chief General Asim Munir, "Osama bin Laden in a suit" and accused Pakistan of behaving like "a rogue state" following reported nuclear threats made on American soil. Speaking to ANI, Rubin said, "Pakistan's threats on American soil are completely unacceptable... The Field Marshal's rhetoric is reminiscent of what we heard from Osama Bin Laden. There will be no amount of concession that will change his ideology or that of the Pakistani elite he represents." Rubin warned that Pak-

istan's nuclear arsenal could allow terrorist elements to "go rogue," adding, 'Americans look at terrorism through the lens of grievance... Asim Munir is Osama Bin Laden in a suit and there will be no amount of concession that will be given to Pakistan that is going to change his ideology or the Pakistani elite he represents...." He urged Washington to take immediate steps, including revoking Pakistan's major non-NATO ally status, removing it from the US Central Command, designating it a state sponsor



Villagers dump body at postmaster's house over crore -scam

News Service, Purulia: Tension ran high in Patjhalda village, under Jhalda-Darda gram panchayat in Purulia district, after locals staged a dramatic protest on Monday night by placing the body of a deceased deposit outsider the house of an absconding postemaster accused of embezzlement.

According Muruli Mandal, a migrant worker from the village, died earlier that day while undergoing treatment in Ranchi, Jharkhand. Villagers allege that Muruli Mandal had lakhs of rupees deposited in the local rural post office, which was misappropriated by Postmaster Soum Bhattacharya, who has been missing for several years. Protesters claimed that when they approached Bhattacharya's uncle, Tirthankar Bhattacharya, for financial assistance to cover funeral expenses, he refused. This led to the villagers bringing Muruli Mandal's body to his residence in protest. Police from Jhalda police station intervened and assured action, following which the protest was called off.

TMC leader shot dead amid election turmoil

Bakura: Bankura district witnessed heightened tensions on Monday night after a Trinamool Congress booth convener was shot dead in Chakai village under Sonamukhi police station. The deceased, identified as Sekender Khan alias Sayan Khan, was reportedly returning home on his motorcycle from Pakhanna Bazar when assailants opened fire on him near an irrigation canal at the entrance to the vil-

According to police, Khan sustained multiple bullet injuries to his back and head, leading to his death on the spot. His body was later recovered and taken to Sonamukhi Rural Hospital. The killing has reignited political tensions in the area, which has been marred by factional conflict within the Trinamool for nearly a year. On March 2, two factions of the party had clashed in Chakai, leaving one leader injured in a shooting. Following the latest incident, senior Trinamool leaders, including Bishnupur organizational district president Subrata Dut-Sonamukhi mayor Santosh Mukherjee, and deputy mayor Somnath Mukherjee, rushed to the hospital. The Trinamool leadership alleged that the BJP, in collusion with e CPI(M), orcnestrated the killing ahead of the 2026 Assembly elections. Denying the charges, Sonamukhi BJP MLA Dibakar Gharami claimed the murder was the result of an internal dispute within the Trinamool over land distribution. Police are investigating

Ragging row & razor scare rock Siliguri **Boy's High School**

MI News Service, Siliguri: Siliguri Boys' High School, one of the city's most prominent government institutions, has come under intense scrutiny following a series of disturbing incidents involving ragging, physical assaults, and alleged security lapses. The controversy began with allegations that an eighth-grade student was being harassed by classmates, who demanded money from him daily and assaulted him when he refused. Despite complaints, parents claim no concrete action was taken. On Tuesday, the victim's parents withdrew him from the school, citing safety concerns.

Recovery agent arrested, **gets bail later** MI News Service, Asansol:

Rajiv Banerjee, a recovery agent for a public sector bank in Asansol, was arrested by the Asansol South Police Phari (outpost) under the Asansol Durgapur Police Commissionerate (ADPC) for allegedly threatening a person while demanding money over a loan default.

He was produced before the Asansol Court today, where the police sought 10 days' custody for further investigation. However, the court rejected the custody plea and granted him bail after he submitted an affidavit along with his bail petition.

MI News Service, Cooch Behar: The North Bengal State Transport Corporation (NBSTC) will launch a smart card ticketing system before Durga Puja, introduce six Volvo sleeper buses and revise the wages of contractual workers.

The decisions were made at the 235th board meeting of the NBSTC held in Cooch Behar recently.

Parthapratim Roy, the cnairman of the NBSIC said that the smart card system was 90 per cent ready and passengers would be able to preload money, like mobile topups, and use the cards to buy tickets before or after boarding buses.

Broken roads halt marriages, flat sales and ambulances severe damage to the roads

Durgapur: Patients are ferried to hospitals in charpoys, parents find it hard to get a groom for their daughters and house owners find it difficult to sell their flats. Reason: the pathetic condition of roads.

Believe it or not, all these have happened not in some remote village in Durgapur, but in Bengal's industrial

"We usually ferry patients who need to be taken to hospitals on charpoys as the roads are so pathetic that the ambulance can-not reach our home," said Binay Samaddar, a resident at Sukanta Pally of ward 43 of the Durgapur Municipal Corporation.

Residents here alleged the road was not repaired for the past two years.

Asked if they lodged complaints with the local civic body representative, Samaddar said they did not have that option as the tenure of the elected civic board expired three years ago and no election was held since then.

Parbati Mukherjee, a resident of the same area, is facing a problem of a different kind. She is finding it difficult to get her daughter married as the prospective grooms and their families are not willing to visit her house, given the bad roads.

"I am not getting a groom for my daughter. Prospective grooms and their parents are unwilling to come to our house to see my daughter. The roads are



that bad," she said.

A resident of Steel Park area in ward 26 is finding it hard to get a buyer for her flat as the road approaching her housing complex is a "virtual death trap".

"I am looking for a prospective buyer of my flat as I need to sell it urgently. But I am not getting buyers because of the pathetic road condition. One of the prospective buyers, who was coming to visit my flat, fell off his two-wheeler and suffered injuries," said Pampa Chatterjee, the Steel Park

The residents' associations in the area have appealed to the administrative board running the day to day affairs of the town since 2022 in absence of an elected civic board.

"I have urged the civic body in writing to repair the road leading to our housing complex from the main road. I don't know when our problems will be looked into. There is no elected civic body in our town for the past three years," said tary of the Aalingan Welfare Association.

The 700-metre-long approach road was repaired before last year's Pujas but it appeared to be non-existent this monsoon, residents said.

Trinamool had won the civic body for two consecutive elections since 2012. In the last election held in 2017, Trinamool secured an absolute majority amid allegations of mass rigging.

As the elections have not been held to the Durgapur civic body for three years, there has been no proper road maintenance in this duration in the town. Almost all roads in Durgapur are death traps.

An engineer in the civic body said road repairs did not last because of Durgapur's faulty drainage system.

"Before repairing roads, we need to update the drainage system in the town. Waterlogging is a major problem in some parts of the town which caused

within a short span of relaying them," the engineer

A section of residents alleged systemic corruption. "It is not easy here to get

a road repair contract without paying a cut to ruling party leaders. If a contractor has to pay handsome cut money to get a repairing job, he will compromise on the quality of work. Ultimately, we suffer," said a resident not willing to come on record.

Chairperson of the board of administrators Anindita Mukherjee, also Durgapur's former mayor, claimed that restoration work of the damaged roads would start after monsoon and end before the Pujas. "We've already allocated funds for the job," she said. Durga Puja starts on September 28.

The CPM and BJP demanded immediate repair of roads.

"The civic body is run by a board of administrators and not an elected body. The civic poll was due in 2022, but the state government is unwilling to announce an election here and people are suffering. The roads are beyond usable," said Siddhartha Bose, a CPM activist.

BJP leader Amitabha Banerjee echoed Bose.

Trinamool leader Uttam Mukherjee said the people here were "happy" with the intensive development work in Durgapur. "Opposition parties are trying to make an issue out of nothing," he

Identification Authority of India (UIDAI). Sardar in his bail plea said he was a bona fide citizen of India and that there was no conclusive or reliable evidence to prove he is a national of Bangladesh.

He further claimed his documents are linked with his income tax records and business registration and that he has been residing in Mumbai's neighbouring Thane district since 2013.

The prosecution opposed the plea, claiming if the accused was released on bail, he may abscond.

The police further said a probe was on to ascertain if there was a larger organised network involving illegal immigration and identity fraud.

The court in its order noted the allegations against Sardar are not limited to a mere technical violation of immigration norms, but indicate a case of deliberate concealment of identity and creation of forged documents for obtaining the Indian citizenship benefits.

When the Constitution of India was being drafted, the country had just gone through a historic transformation and the partition at the time caused a massive movement of people across borders, creating a need to decide who would be accepted as citizens of the new nation, it noted

Keeping this in mind, framers of the Constitution decided to make an arrangement for deciding citizenship, the high court said. CM Mamata mandates weekly district visits for ministers in 'Amader Para' scheme

MI News Service, Kolkata: Chief Minister Mamata Banerjee has issued clear directives on the role and responsibilities of ministers in the state government's flagship public grievance redressal programme, Amader Para, Amader Samadhan (Our Locality, Our Solution). Under the new guidelines, ministers in charge of specific districts must visit their assigned areas at least once every week.

The Chief Minister has emphasised that these visits should not be ceremonial, but coordinated closely with the respective

District Magistrates (DMs) to ensure swift and effective resolution of citizens' problems. Ministers are to work in unison with DMs to address any administrative bottlenecks or complexities that may arise during the course of the programme.

According to the directive, ministers must also hold regular review meetings with the DMs to ensure that all activities linked to the Amader Para, Amader Samadhan camps are being implemented efficiently and without delay. The initiative, launched on 2 August, aims to

directly address locality-specific grievances of the public, making the administration more accessible and responsive.

Officials have described the scheme as a unique and original concept that places citizens at the very heart of governance. Far from being just another government scheme, it has been positioned as a citizen-centric revolution—one that empowers people by giving them a direct say in resolving issues in their neighbourhoods.

The Chief Minister had announced the initiative ahead of

the 2026 Assembly elections, highlighting its three-month operational plan at the booth level to deliver public services swiftly and effectively. She had assured that this mechanism would enable quick and simple solutions to local problems, reducing bureaucratic delays.

Implementation began promptly after her announcement, and within just two days, record numbers of services had been delivered through these camps. Both government officials and elected representatives have been instructed to partici-

pate actively in the programm

With the latest directive, Mamata Banerjee has now formalised the role of ministers, ensuring they act as active field leaders rather than passive overseers. stopped midway by Delhi Police barricades. The ensuing scuffle saw pushing, shoving, and chaotic scenes, with several women MPs, including Mahua Moitra and Mitali Bag, reportedly being manhandled. Some fell ill amid the commotion.

Speaking to the media at Kolkata's Dum Dum Airport before flying to Delhi on Tuesday, Banerjee alleged that what was meant to be a "completely peaceful programme" turned violent due to the police's "unprovoked aggression." He accused Delhi Police of "barbaric conduct" towards women parliamentarians, claiming they were "dragged by their

hair and pulled to the ground" — behaviour he said was "unthinkable in a civilised society." "This kind of intimida-

"This kind of intimidation and repression will not deter Trinamool Congress. If necessary, we will again call for a gherao of the Commission," Banerjee warned.

The protest on Monday had seen high-profile participation, with Rahul Gandhi, Priyanka Gandhi Vadra, and Akhilesh Yadav also joining the march. The ECI had reportedly offered to meet the MPs beforehand, but the march continued regardless. Tensions escalated when protesters attempted to breach police barricades,

leading to the confronta-

Following the incident, the Trinamool Congress launched a strong social media campaign against both the BJP and Delhi Police, accusing them of acting in tandem to suppress dissent. Banerjee's remarks on Tuesday made it clear that the party considers this episode not as the end of the confrontation, but as a spark for a renewed phase of coordinated opposition action.

"The unity of the INDIA bloc will only grow stronger," Banerjee asserted, signalling that the protest movement against the ECI's alleged partisanship is far from over.

Mayor Hakim announces Dhapa water project to add 20m gallons daily

MI News Service, Kolkata: Kolkata is set to take a significant step toward ending its drinking water woes, with the Dhapa Joy Hind Water Project expected to complete a major capacity expansion by mid-January. Mayor Firhad Hakim announced the development on Tuesday morning while inspecting the facility alongside senior officials from the Kolkata Municipal Corporation's (KMC) Water Supply Department.

Currently, the Dhapa Joy Hind plant purifies and produces around 30 million gallons of potable water each day. The new expansion will add an additional 20 million gallons daily, aimed at serving residents in areas stretching from Topsia to parts along the Bypass, as well as portions of Jadavpur and Tollygunge

"This augmentation will significantly improve water supply in these zones, reducing reliance on deep tube wells," Hakim stated during the visit. He emphasised that once the project is operational, many of the city's chronic water scarcity problems will be resolved.

In parallel, the KMC is building another water treatment facility near Garia Dhalai Bridge, designed to produce an additional 10 million gallons per day. This, too, will cater to high-demand neighbourhoods, further easing the load on the city's water infrastructure.

SIR row sparks dramatic suicide attempt outside Cal HC

MI News Service, Kolkata: Political tensions in West Bengal over the Special Intensive Revision (SIR) of electoral rolls took a shocking turn on Tuesday morning when a woman allegedly attempted to immolate herself in front of the Calcutta High Court, fearing her name would be deleted from the voters' list.

The Incident created panic in the court precincts and drew a large crowd of onlookers. Senior police officers rushed to the scene, and security around the High Court has since been tightened. The woman was immediately taken to SSKM Hospital for medical examination and treatment. According to court police sources, the Election Commission could

issue SIR guidelines for Bengal at any time, triggering anxiety across the state. Reports indicate that in a cooperative society voters' list, the names of three women — all residents of Amgachia in South 24 Parganas and active members of the Amgachia Srishti Sangh Primary Multipurpose Cooperative Society Ltd — were abruptly removed. The women alleged that the cooperative was formed in 2017, with elections held in 2025. Following the deletion of their names from the voters' roll, they approached the Calcutta High Court. A division bench subsequently ordered the republication of the voters' list. but the women claim the cooperative ignored the directive.

EC derecognises 12 political parties in Bengal

MI News Service, Kolkata: Ahead of the upcoming elections, the Election Commission has issued a significant order, cancelling the recognition of 12 political parties in West Bengal. The move has sparked intense debate in political circles. According to the Commission, these parties have not contested any election in the past six years, rendering them inactive in the political arena. As a result, they will no longer be eligible to field candidates or participate in electoral contests. The list of derecog-

nised parties includes: Ambedkarwadi Global People Peace Party, Gorkha National Liberation Front, Kamtapur Progressive Party, My He Bharat, National Confederacy of India, Nationalist Trinamool Congress Party, Niryatita Samaj Biplobi Parbatya Party, jatantrik Party, Paschim Banga Rajya Muslim League, Right Party of India, and The Religion of Man Revolving Political Party of India.

As lesson from Op Sindoor, Indian Air Force to focus on inducting long-range missiles

MI News Service, New missiles with over 200 km **Delhi:** Following the extensive use of long-range stand-off weapons to target enemy military bases and assets during Operation Sindoor, the Indian Air Force (IAF) is now focusing on the induction of long-range airto-ground, air-to-air, and surface-to-air missiles with strike ranges exceeding 200 kilometres.

During the operation, the IAF deployed missiles such as BrahMos, SCALP, Rampage and Crystal Maze, all of which have strike ranges well above 200 km.

Defence officials told ANI that the Indian Air Force is prioritising the induction of strike range across various categories, including air-toground, air-to-air, and surface-to-air weapons.

The Indian Air Force has also asked the Defence Research and Development Organisation (DRDO) to develop extended-range variants of the Astra air-to-air missile, capable of hitting targets beyond 200 km, officials stated.

Additionally, the Air Force is exploring the possibility of acquiring Russian R-37 missile variants, which have a range exceeding 200 km and could provide a significant edge against adversaries on both the western and

Diet has significant impact on risk of Alzheimer's disease: Research

CALIFORNIA [US]: In a detailed study, researchers identify which diets are effective in lowering the risk of developing

Findings were published in the Journal of Alzheimer's Disease, Diet's Role in Modifying Risk of Alzheimer's Disease: History and Present Understanding.

The role of nutrition in lowering the risk of Alzheimer's

disease has been extensively studied. Plant-based diets, such as the Mediterranean diet and traditional Chinese, Japanese, and Indian cuisines, have been shown to reduce risk, particularly when compared to the Western diet.

Alzheimer's disease rates rise in these countries as they make the nutrition transition to the Western diet. This study identifies dementia risk factors including higher consumption of saturated fats, meat, especially red meat such as hamburgers and barbeque as well as processed meats such as hot dogs, and ultra processed foods high in sugar and refined grains.

This review also lets us know why certain foods increase or reduce risk of Alzheimer's disease. For example, meat raised risk of dementia the most by increasing risk factors such as inflammation, insulin resistance, oxidative stress, saturated fat, advanced glycation end products, and trimethylamine N-oxide. This study also outlines several foods that are protective against Alzheimer's disease, such as green leafy vegetables, colorful fruits and vegetables, legumes (like heaps) puts, omega-3 fatty acids, and whole legumes (like beans), nuts, omega-3 fatty acids, and whole

Ultra processed foods can increase the risk of obesity and diabetes, themselves risk factors for Alzheimer's disease. Ultra processed foods often lack the very ingredients found in whole plant foods that keep dementia away, such



as anti-inflammatory components and antioxidants. Poverty is an important driver of Alzheimer's disease in the US since ultra processed foods and meat are cheaper sources of energy than fruits, vegetables, whole grains, and other more nutritious foods, thus promoting obesity.

The paper also suggests that Alzheimer's disease rates in the US are projected to increase by 50% from 2018 levels by 2038. This calculation is based on comparing trends of obesity in the US with Alzheimer's disease trends. This comparison shows a 20-year lag between obesity rates and Alzheimer's disease rates. This estimate is very close to the estimate published by the Alzheimer's Association in 2018, an estimate of a 56% increase. Our estimate suggests that the rising trend of obesity, due to consumption of meat and ultra processed foods, is the force driving dementia. Although our personal risk of Alzheimer's disease can be reduced with diet, it is expected that those who continue to eat the Western diet will continue to have a higher risk.

High blood pressure linked with environmental contamination by tellurium: Study

Nagoya, Japan: Higher amounts of tellurium, a pollutant transported from mining and manufacturing to foods, increase the risk of having high blood pressure (hypertension). Improved monitoring of tellurium levels in certain meals may help reduce high blood pressure in the general

The study was led by Nagoya University in Japan. According to Takumi Kagawa, one of the researchers involved in the study, the findings are significant as they indicate that tellurium exposure may contribute to elevated blood pressure, a significant public health concern. "The results indicate diet was the most significant contributor to increased urinary tellurium levels, compared to other lifestyle factors, such as smoking and working status, and physiological factors, such as age and sex. Dietary intake, an important aspect of our lifestyle, plays a significant role in increased urinary tellurium concentrations." The journal Environment International published the findings of research looking at the link between tellurium exposure and hypertension. In Japan, cereals and legumes, represented by rice and natto (fermented soybeans), are popular dietary choices. These foods are packed with essential nutrients, such as high-quality carbohydrates, vitamins, and minerals, that support a person's health. However, tellurium, a rare metaloid, can also be present in these ioods. Mining and manufacturing activities release dust, ash, and slag, which are

Moral reasoning displays characteristic patterns in brain: Research

CALIFORNIA [US]: Every day, we come across situations that we believe to be wrong: a starving child, a dishonest politician, an unfaithful spouse, or a dishonest scientist. These instances draw attention to a number of moral issues, such as those involving fairness, loyalty, and compassion. But what links them all together?

Philosophers, psychologists and neuroscientists have passionately argued whether moral judgments share something distinctive that separates them from nonmoral matters. Moral monists claim that morality is unified by a common characteristic and that all moral issues involve concerns about harm. Pluralists, in contrast, argue that moral judgments

are more diverse in nature. Fascinated by this centuriesold debate, a team of researchers set out to probe the nature of morality using one of moral psychology's most prolific theories. The group, led by UC Santa Barbara's René Weber, intensively studied 64 individuals via surveys, interviews and brain imaging on the wrongness of various behav-

They discovered that a general network of brain regions was involved in judging moral violations, like cheating on a test, in contrast with mere social norm violations, such as drinking coffee with a spoon. What's more, the network's topography overlapped strikingly with the brain regions involved in theory of mind. However, distinct activity patterns emerged at finer resolution, suggesting that the brain processes different moral issues along different pathways, supporting a pluralist view of moral reasoning. The results, published in Nature Human Behaviour, even reveal differences between how liberals and conservatives evaluate a given moral issue.

findings clarify that monism and pluralism are not necessarily mutually exclusive approaches, said first author Frederic Hopp, who led the study as a doctoral student in UC Santa Barbara's Media Neuroscience Lab. "We show that moral judgments of a wide range of different types of morally relevant behaviors are instantiated in shared brain


That said, a machine-learning algorithm could reliably identify which moral category, or "foundation," a person was judging based on their brain activity. "This is only possible because moral foundations elicit distinct neural activations," Hopp explained.

The group was guided by Moral Foundations Theory (MFT), a framework for explaining the origins and variation in human moral reasoning. "MFT predicts that humans possess a set of innate and universal moral foundations," Weber explained. These are generally organized into six categories:

Issues of care and harm, Concerns of fairness and cheating, versus oppression, Matters of loyalty and betrayal, Adherence to and subversion of authority, and sanctity versus degradation.

The framework arranges these foundations into two broad moral categories: care/harm and fairness/cheating emerge as "individualizing" foundations that primarily serve to protect the rights and individuals. Meanwhile loyalty/betrayal, authority/subversion and sanctity/degradation form "binding" foundations, which primarily operate at the group level.

Researchers created a model based on MFT to test whether the framework - and its nested categories - was reflected in neural

Sixty-four participants rated short descriptions of behaviours that violated a particular set of moral foundations, as well as behaviours that simply went against conventional social norms, which served as a control. An fMRI machine monitored activity across different regions of their brains as they reasoned through the vignettes. Certain brain regions distinguished moral from non-moral judgment across the board, such as activity in the medial prefrontal cortex, temporoparietal junction and posterior cingulate, among other regions. Participants also took longer to rate moral transgressions than non-moral ones. The delay suggests that judging moral issues may involve a deeper evaluation of an individuals' actions and how

they relate to one's own values, the authors said.

"Although moral judgments are intuitive at first, deeper judgment requires responses to the six 'W questions,'" said senior author Weber, director and lead researcher of UCSB's Media Neuroscience Lab, and a professor Departments

Communication Psychological and Brain Sciences. "Who does what, when, to whom, with what effect, and why. And this can be complex and takes time." Indeed, moral reasoning recruited regions of the brain also associated with mentalizing and theory of mind. The researchers also found that transgressions of loyalty, authority and sanctity prompted greater activity in regions of the brain associated with processing other people's actions, as opposed to the self. "It was surprising to us how well the organization into 'individualizing' versus 'binding' moral foundations is reflected on the neurological level in multiple networks, Weber said.

Next, the authors developed a decoding model that accurately predicted which specific moral foundation or social norm individuals were judging from finegrained activity pattern across their brains. This would not have been possible if all moral categories were unified at the neurological level, they explained.

'This supports MFT's prediction that each moral foundation is not encoded in a single 'moral hotspot," the authors write, "but (is instead) instantiated via multiacross the brain." This finding suggests that the distinct moral categories proposed by Moral Foundations Theory have an

underlying neurologic basis. In this way, moral reasoning is similar to other mental tasks: it characteristic patterns across the brain, with nuances based on the specifics. For instance, looking at pictures of houses and faces activates a brain region known as the ventral temporal cortex. "However, when looking at the pattern of activation in this region, one can clearly discern whether someone is looking at a house or a face," Hopp explained. Analogously, moral reasoning activates regions of the brain, "yet, the activation patterns in those same regions are highly distinct for different classes of moral behaviors, suggesting that they are not uni-

Far from merely an esoteric exercise, MFT provides a robust framework for understanding group identity and political polarization. Mounting evidence from survey and behavioral experiments suggests that liberals (progressives) are more sensitive to the categories of care/harm and fairness/cheating, which primarily protect the rights and freedoms of individuals. Conservatives, in contrast, place greater emphasis on loyalty/betrayal, authority/subversion, and sanctity/degradation categories, which

have complex differential neural responses when judging moral foundations," Weber explained. That means individuals at different points along the political spectrum likely emphasize completely

different values when evaluating a particular issue

This paper is part of an avenue of research that the Media Neuroscience Lab embarked on in 2016, aiming to understand how humans make moral judgments, and how the underlying processes vary across more and less realistic scenarios. "the observation that we can reliably decode which moral violation an individual is perceiving also opens exciting avenues for future research: Can we also decode if a moral violation is detected when reading a news story, listening to a radio show, or even when watching a political debate or movie?" Hopp said. "I think these are fascinating questions that will shape the next century of moral neuroscience."

The study's co-investigators include renowned neuroscientist and moral philosopher Walter Sinnott-Armstrong from Duke University and Scott Grafton, a professor in UC Santa Barbara's Department of Psychological and Brain Sciences. Jacob Fisher and Ori Amir also contributed as coauthors, and were, respectively, a Ph.D. student and a postdoctoral fellow in Weber's Media Neuroscience Lab at the time the work was conducted. Ultimately, the researchers say, our ability to cooperate in groups is guided by systems of moral and social norms, and the rewards and punishments that result from adhering to or violating them. "For millennia, fables and fairy tales, nursery rhymes, novels, and even the daily news' all weave a tapestry of what counts as good and acceptable or as bad and inacceptable," Weber said. "Our results contribute to a better understanding of what moral judgments are, how they are processed, and how they can be predicted across groups.

India Semiconductor Mission: Momentum builds further as India advances into Compound Semiconductor and Advanced Packaging landscape

MI News Service, Delhi: The Union Cabinet chaired by Prime Minister Shri Narendra Modi approved four more semiconductor projects under India Semiconductor Mission (ISM). Momentum is building up in semiconductor ecosystem in India with the six approved projects already in various stages of execution. These four proposals approved today are from SiCSem, Continental Device India Private Limited (CDIL), 3D Glass Solutions Inc., and Advanced System in Package (ASIP) Technologies. These four approved proposals will setup semiconductor manufacturing facilities with cumulative investment of around Rs.4,600 crore and are expected to generate a cumulative employment for 2034 skilled professionals which would catalyse the electronic manufacturing ecosystem resulting in creation of many indirect jobs. With these four more approvals today, total approved projects under ISM reaches to 10 with cumulative investments of around Rs.1.60 lakh crore in 6 states. Given the growing demand of semiconductors in telecom, automotive, datacentres, consumer electronics and industrial electronics, these four new approved semiconductors projects would significantly contribute to making Atmanirbhar Bharat. SiCSem and 3D Glass will be set up in Odisha. CDIL is located in Punjab and ASIP will be set up in Andhra Pradesh. SicSem Private Limited is collaborating with Clas-SiC

Wafer Fab Ltd., UK, to establish integrated facility of Silicon Carbide (SiC) based Compound Semiconductors in Info Valley, Bhubaneshwar, Odisha. This will be 1st commercial compound fab in the country. The project proposes to manufacture Silicon Carbide devices. This compound semiconductor fab will have an annual capacity of 60,000 wafers and packaging capacity of 96 million units. The proposed products will have applications in Missiles, Defence equipment, Electric Vehicles (EVs), Railway, Fast Chargers, Data Centre racks, Consumer Appliances, and Solar Power Inverters. 3D Glass Solutions Inc. (3DGS) will be setting up a vertically integrated advanced packaging and embedded glass substrate unit in Info Valley, Bhubaneshwar, Odisha. This unit will bring world's most advanced packaging technology to India. Advanced packaging brings the next generation of efficiency to semiconductor industry. The facility will have a large variety of advanced technologies including glass interposers with passives and silicon bridges, and 3D Heterogeneous Integration (3DHI) modules. Planned capacity of this unit will be approximately 69,600 glass panel substrates, 50 million assembled units, and 13,200 3DHI modules per annum. The proposed products will have significant applications in defence, high-performance computing, artificial intelligence, RF and automotive, photonics and co-packaged optics etc. Advanced System in Package Tech-

nologies (ASIP) will setup a semiconductor manufacturing unit in Andhra Pradesh, under technology tie-up with APACT Co. Ltd, South Korea, with an annual capacity of 96 Million units. The manufactured products will find applications in mobile phones, set-top boxes, automobile applications, and other electronic products. Continental Device (CDIL) will expand its discrete semiconductor manufacturing facility at Mohali, Punjab. The proposed facility will manufacture high-power discrete semiconductor devices such as MOSFETs, IGBTs, Schottky Bypass Diodes, and transistors, both in Silicon and Silicon Carbide. The annual capacity of this brownfield expansion will be to the tune of 158.38 million units. The devices manufactured by these proposed units will have applications in Automotive electronics including EVs and its charging infrastructure, Renewable energy systems, Power conversion applications, industrial applications and communication infrastructure. With the approval of these projects, semiconductor ecosystem in country would get significant boost as these projects include country's first commercial compound fab as well as highly advanced glass-based substrate semiconductor packaging unit. These would complement the growing world class chip design capabilities coming up in the country which are propelled by design infrastructure support provided by Government to 278 academic institutions and 72 start-ups.

Cabinet approves Investment Proposal for construction of 700 MW Tato-II Hydro Electric Project in Shi Yomi District of Arunachal Pradesh with an outlay of Rs.8146.21 crore and completion period of 72 months

MI News Service, Delhi: The Cabinet Committee on Economic Affairs chaired by the Prime Minister Shri Narendra Modi today has approved investment of Rs.8146.21 crore for construction of Tato-II Hydro Electric Project (HEP) in Shi Yomi District of Arunachal Pradesh. The estimated completion period for the project is 72 months. The project with an installed capacity of 700 MW (4 x 175 MW) would produce 2738.06 MU of energy. The Power generated from the Project will help improve the power supply position in the state of Arunachal Pradesh and will also help in balancing of the national Grid. The Project will be implemented through a Joint Venture Co. between Corporation Ltd. (NEEPCO) and the Government of Arunachal Pradesh. Govt. of India shall extend Rs.458.79 crore as budgetary support for construction of roads, bridges and associated transmission line under enabling infrastructure besides Central Financial Assistance of

Rs.436.13 crore towards equity share of the State. The state would be benefitted from 12% free power and another 1% towards Local Area Development Fund (LADF) besides significant infrastructure improvement and socioeconomic development of the region. NEW DELHI [INDIA]: The Indian Olympic Association (IOA) will convene a Special General Body Meeting on Wednesday with several key decisions set to shape the organisation's future course.

In a notice issued by IOA CEO Raghuram Iyer to the IOC member in India, members of the IOA Executive Council, presidents and secretary-generals of national sports federations, associate members, athlete representatives and sportspersons of outstanding merit, it was confirmed that the meeting will deliberate on three major matters, the consideration and passing of the audited statement of accounts for the financial year 2023-24 the appointment of a statutory auditor for the financial year 2024-25, and the crucial proposal to seek approval for submitting a bid to Commonwealth Sports to host

the 2030 Commonwealth Games in India, including any related actions required for the process. The voting process will follow Article 10.1 of the IOA Constitution, meaning each national sports federation will send two representatives, one male and one female, each with a vote, while the IOC member in India will have one vote. The Athletes Commission will be represented by one male and one female, each with a vote, and there will be eight representatives of sportspersons of outstanding merit, four men and four women, also with one vote each. As per Article 0.3 of the constitution, associate members, including state and union territory Olympic associations, sports control boards, and other federations not covered

All concerned bodies were asked to submit the names of their representatives to the IOA by August 5 ahead of what could be a landmark meeting for Indian sport. A decision to proceed with the ommonwealth Games 2030 bid would mark a significant step towards bringing the multisport event back to India for the first time since the 2010 Delhi edition.

The second T20I will be held in Cairns on Tuesday. In the first T20I, he became the youngest player from a Test-playing nation to take a T20I four-wicket haul. with figures of 4/20. He was also involved in a verbal exchange with Aussie batter Tim David. who had spliced a delivery aimed at his chest and had attempted to complain to the umpire for a no

"He went to the umpire and he was asking about it, Maphaka said as quoted by ESPNCricinfo after the match, which the Proteas lost by 17 runs while chasing 179. He also revealed that he was having none of his complaints, "I just told him to let the umpires deal with umpiring the game, and he must focus on batting," he added. David went on to smash a 52-

ball 83, with four boundaries and eight sixes, pushing Aussies to a match-winning 178 after they were five down at 71 runs. While Kwena stood out for Proteas as a bowler, starting his

spell by sending Mitchell Owen's stump out for a toss, he did not perform well in Zimbabwe during the tri-nation series against the



just three wickets for 92 runs in 10.5 overs. But now, Maphaka has shown how he belongs to this level of cricket. "It feels really good, coming off a few bad performances in Zimbabwe and just building up, playing some more professional and competitive cricket in the past few months, it feels really good to put in a good performance for the team and make history while doing it," he

During the tri-nation series, he opened the bowling and was also used as a first-change bowler. He was used extensively in the powerplay. But against Australia, with senior Kagiso Rabada back, Maphaka was used after fielding restrictions were lifted. Kwena termed it as a "tactical ploy" to get wickets in the

middle overs, instead of being protected by the Proteas team as a young bowler.

"It may have been a tactical ploy, but I think it's also just about giving me a little bit more freedom," he said.

"I am a guy that likes to take wickets in the middle, and I think the team understands that. It was really just a tactical ploy in terms of getting wickets through the middle rather than protecting me as a player," he added

Australia went really hard irrespective of wickets falling, but were 88/6 at the halfway stage, with Maphaka and spinner Senuran Muthuswamy producing just 17 runs and taking two wickets after the powerplay in the next four overs. "When a team is coming out all guns blazing, there are a few more opportuni-

ties to take wickets, so it is about being smart and understanding what you have to do when you're faced with those situations, Maphaka said.

Sometimes you go to a yorker, a bumper or a slower ball. It is all about reading the game and understanding what you need to do at that moment and keeping your plans as simple as possible, really," he added.

Before the Zimbabwe series, he had played five T20Is, two ODIs and a Test before turning 19. While his returns have not been at his best, he has no doubt that Proteas see him as a major future player, and he has learnt to handle that level of expectations, breaking out after a 'Player of the Tournament' U19 WC 2024, with 21 wickets.

"The most important part is just really accepting the fact that you are going to have bad days, you are going to have good days, and it is just sticking to your game plan and sticking to whatever you do best. I am not going to be the best player in the world overnight, and I understand that. It is all about growing as a player day by day, and just keeping focused on the grind and what I have to do to make myself better on a daily basis," he said.

"I have always been pretty confident and a real competitor," he said. "I never like losing. I always want to come out on top of the fight. It is something that has been instilled in me since I was really young," he concluded.

CINCINNATI **MASTERS**: **RYBAKINA. KEYS REACH PRE-QUAR-**TERS, SABALENKA'S NAME ETCHED IN **OPEN ERA HISTORY**

CINCINNATI [US] : World number 10 Elena Rybakina secured her round of 16 spot in the ongoing Cincinnati Masters tournament on Tuesday, while the defending champion and world number one Aryna Sabalenka also registered her name in the history books dur-

ing her win. Rybakina regrouped herself after a first-set loss, prevailing 4-6, 6-3, 7-5 in a three-set thriller.

Also, Madison Keys, the current Australian Open champion, defeated Aoi Ito 6-4, 6-0 for her spot in the pre-quar-

On Monday, Sabalenka prevailed over Emma Raducanu by 7-6 (3), 4-6, 7-6 (5) in a contest that lasted three hours and nine minutes. This was also the fourth-longest match of Sabalenka's career.

In the first-set tie-break, Sabalenka won six of seven points, hit back-to-back aces, and converted her third set point. She improved her record in first-set tie-breaks to 11 wins to zero losses. What were once Sabalenka's greatest flaws have now turned into a big strength. The flourish set the tone for the remainder of the match, with Sabalenka winning another tie-break in the final set. Following her match, Sabalenka said in the post-match interview, as quoted by the WTA's website, "Happy to get through this match. I really hope I have a day tomorrow." Sabalenka finished the match with a total of 46 winners and 72 unforced errors. The next challenge for the top-ranked star, a threetime Grand Slam champion, will be Jessica Bouzas Maneiro. This year, Sabalenka has won 18 tie-breaks in WTA tour-level tournaments, the most by a women's player in the Open Era.
