Massive cloudburst in **Kishtwar in** J-K, 10 feared dead

MI News Service, Jamuu: At least 10 people are feared dead in a massive cloudburst that struck a remote village en route the Machail Mata yatra in Kishtwar district of Jammu and Kashmir on Thursday, officials said.

The cloudburst hit Chasoti, the last motorable village en route to the Machail Mata shrine.

The annual yatra to the shrine has been suspended following the incident as authorities mobilised all resources and are heading to the scene to conduct a massive rescue and relief operation, the officials said.

Prelimiinary reportys reaching here this evening said at least 10 people, including some women have died after the massive cloudburst hit picturescue village in the Paddar area of Jammu and Kashmir's Kishtwar district on Thursday besides washing away several houses

and domestic animals
This last village that can be reached by road on the way to the Machail Mata shrine has also suffered huge damage after experiencing the nature's fury the re-ports said adding that the annual pilgrimage to the shrine has since been stopped and all available resources are being sent to the area for a massive rescue and relief operation, which are underway.

Union minister Jitendra Singh said he spoke to Deputy Commissioner Kishtwar, Pankaj Kumar Sharma, soon after receiving information from the Leader of Opposition in Jammu and Kashmir and local MLA Sunil Kumar Sharma.

In a post on X, Singh wrote, "Massive cloud burst in Chositi area, which could result in substantial casualty. Administration has immediately swung into action, rescue team has left for the site. Damage evaluation and necessary rescue and medical management arrangements being made. My office receiving regular updates, all possible assistance will be pro-

According to Singh, teams have been sent to the site to assess the damage, carry out rescue operations, and provide medical help to those affected. The Office of the Lieutenant Governor (LG) of Jammu and Kashmir posted on X, "Anguished by cloudburst in Chositi Kishtwar. Condolences to bereaved families & prayers for quick recovery of injured. In a gazette notification issued on Thursday, India has stated that OCI cards and registrations will be subject to cancellation if an individual faces criminal charges or convictions. Section 7D of the Citi-

zenship Act, 1955 (57 of 1955), the central government hereby states that an Overseas Citizen of India (OCI) registration shall be liable to get cancelled when a person has been sentenced to imprisonment for a term of two years and above or has been charge-sheeted for an offence entailing punishment of imprisonment for seven years or more,' read the notification issued by MHA. As per the MHA notification, an OCI registration or card is liable for cancellation "if the cardholder has been sentenced to jail for a term of two years or more, If the cardholder has been chargesheeted for an offence that carries a punishment of seven years seven years or more".These new rules will help tighten the framework around OCI registration., the notification said . Incidentally, the latest move of MHA is aimed at tightening the legal framework governing OCI status, which grants certain rights and privileges to foreign citizens of Indian origin.

"The provision applies irrespective of whether the conviction occurred in India or abroad, provided the offence is recognised under Indian law," official sources said.

The latest notification marks a shift toward stricter scrutiny of OCI holders, aligning the privileges of the card with a higher standard of legal and moral conduct.

The OCI scheme was introduced in August 2005, allowing foreign nationals of Indian origin to travel to India without a visa, offering long-term residency and multiple-entry benefits. In a gazette notification, the Ministry of Home Affairs said the OCI registration of individuals will be liable for cancellation if convicted of a serious criminal offence or formally charge-sheeted in involving grave charges. The latest notification marks a shift toward stricter scrutiny of OCI holders, aligning the

If Bengal was not there, India would not have got Independence, says Mamata Banerjee

Bengal Chief Minister Mamata try's freedom fighters came from need to learn many languages, in-Banerjee on Thursday said India would not have got Independence if Bengal was not there, as personalities like Rabindranath Tagore and Netaji Subhas Chandra Bose, had contributed significantly to shaping the nation's destiny..

Speaking at a function here on

the eve of 79th Independence day and marking the 12th anniversary of the 'Kanyashree' scheme, Mamata Banerjee said Bengal is the beacon of hope which stands for unity amid diversity. "If Bengal was not there, India would not have got Independence. Bengal's soil has produced eminent people like Rabindranath Tagore, Kazi Nazrul Islam and Netaji Subhas Chandra Bose. The national anthem, the national song and the 'Jai Hind' slogan are all created by these Bengali personalities in Bengal", she said. . Mamata Banerjee's statement at this juncture assumed an added significance as the ruling Trinamool Congress has now been leading a campaign centred around Bengali 'asmita' (pride), alleging "language terror" on migrant workers from West Bengal in BJPruled states. Maintaining that an

Bengal, she said, "You will find that almost 70 per cent of inmates of the Cellular Jail (in Port Blair) were Bengalis. Freedom fighters from Punjab came second." She told the schoolgirls present in the programme, "To-morrow is (79th) Independence Day. I urge all of you to discard narrowmindedness and divisive thoughts. Bengal stands for harmony and unity amongst diversity. We are always strong and united". She said those who had entered the country after the Partition are all Indian citizens. next year. As part of the scheme, poor schoolgirls in the age group of 13 to 18 are being provided Rs 1,000 annually besides a one-time grant of Rs 25,000 when they turn adult, provided that they are engaged in an academic or occupational pursuit and remained unmarried. The CM said her government has spent Rs 17,000 crore for implementing the scheme, which has also received UN recognition. "Due to Kanyashree, school dropout rates of young girls at the primary, secondary and higher secondary levels have significantly come down. Dropout rates at the primary level are zero," she said. The aim of the government is to make the youth self-sufficient and help them stand on their own feet.



Trainee Nurse's unusual death triggers tension

MI News Service, Hooghly: Tension gripped Borai Tematha in Singur after the body of a nursing student was recovered late Wednesday night from a room at a local nursing home.

The deceased, identified as Deepali Jana of Raynagar, Nandigram, had joined the nursing home just three days earlier for practical training. Police said she had completed her JNM Nursing Training examination in Bengaluru last year and was working there to obtain her training certificate. According to sources, nursing home staff discovered Deepali's body hanging in a fourthfloor room and immediately informed the local police station. Officers arrived promptly and recovered the body. However, the family alleged that the police removed it hastily before they could arrive, raising suspicions. The incident sparked unrest in the area on Thursday morning. Angry residents surrounded the police, blocked roads, and staged protests demanding answers. Deepali's parents also joined the demonstration, sitting on the road in grief. "I cannot understand what happened. My daughter came here for training. She was healthy and fine. I still don't know what went wrong," said the victim's mother. Police have launched an investigation into the incident. The cause of death is yet to be confirmed, and officials said all angles are being ex-

One slap, one life lost: Van driver killed in roadside clash

News Howrah: A shocking incident in Kona, Howrah, claimed the life of a 50-year-old van driver after a roadside dispute turned fatal. The victim, identified as Alok Naskar, died shortly after being slapped during an altercation with a pedestrian.

According to police sources, the incident occurred on Thursday afternoon near Kona School intersection on Benares Road. Naskar, transporting tiles from a quarry, reportedly lost control of his bicycle van and accidentally hit a pedestrian, identified as Asim Das (52). Witnesses say Das, angered by the collision, slapped Naskar in the heat of the moment. The force of the blow caused Naskar to collapse onto the road, where he sustained a severe head injury. Locals rushed the injured man to Jagdishpur Rural Hospital, where doctors pronounced nesses detained Das at the scene, but tensions escalated as an agitated crowd attacked him. A large police contingent from Dasnagar Police Station arrived promptly, rescuing the accused from the mob and taking him into custody. Police have registered a case of murder against Das, who remains under arrest. Investigators are reviewing CCTV footage of the area to piece together the sequence of events. The incident has left residents stunned, with Naskar's family demanding the strictest punishment for the accused. Authorities have urged the public to remain calm and allow the investigation to proceed.

Dhantala Man Gets Life Term for Brutal Murder of Wife

Ranaghat: A Fast Track Court in Ranaghat has sentenced a man to life imprisonment for the gruesome murder of his wife in Nadia district's Dhantala last year.

The convict, Nirmal Dutta, son of Sitanath Dutta of Kushaberia Paschimpara under Dhantala police station, was found guilty under Sections 85/103(1) of the Bharatiya Nyaya Sanhita (BNS) in connection with Dhantala PS Case No. 624/24 dated September 1, 2024.

According to the prosecution, the incident took place on September 1, 2024, at around 1:55 pm, when Nirmal attacked his wife, Sucharita Dutta, with a daw (sharp cutting weapon). When the victim's father, who was also the complainant, and her brother tried to rescue her, the accused assaulted them as well before fleeing from



the spot.

Police conducted a prompt and thorough investigation, leading to the submission of a chargesheet within the stipulated time. S.I. Prabin Ghosh was the Investigating Officer of the case, while APP Apurba Bhadra represented the pros-

ecution. On Wednesday, the Additional District Judge of the

Fast Track Court, Ranaghat, pronounced Nirmal Dutta guilty and sentenced him to life imprisonment along with

State govt orders cinema screens to show 1 Bengali film daily in prime time

MI News Service, Kolkata: Every cinema screen in Bengal, including those in plexes, will have to show at least one Bengali film between 3pm and 9pm, "prime time" in entertainment parlance.

The government issued a notification that said: "In every Cinema hall, and all screens (each screen) of every multiplex situated in this State, 365 (Three hundred and Sixty Five) prime time shows/screenings of Bengali films shall mandatorily be held throughout the year with at least one Bengali show per day for all 365 days during the year". Prime-time shows refer to screenings between

3pm and 9pm, the notice issued by Santanu Basu, the principal secretary of the information and cultural affairs department, said. The notification was shared at a meeting held at Nandan on Wednesday. Ministers Aroop Biswas and Indranil Sen presided over the meeting.

The meeting was the second in a week. The first took place on August 7, following a letter some of the leading names in Tollygunge had written to the chief minister, alleging discrimination in the allotment of slots to Bengali films. Most of the prime-time slots would be allocated to big-budget Hindi films, the letter said.

Police arrest ex-JU student over attack on Bratya Basu

MI News Service, New Delhi/Kolkata: Hindol Majumdar, a former Jadavpur University student who went to Spain to pursue higher studies, was arrested at Delhi airport on Wednesday morning while he was returning to the city for his alleged involvement in the attack on education minister Bratya Basu on the campus in March, said a senior police officer of Kolkata Police.

Bidisha Kalita, the DC of South Suburban Division (SSC) of Kolkata Police, said: "Hindol Majumdar, a former JU student, against whom a look-out notice was issued following his involvement in the attack on the education minister, was arrested on Wednesday morning. A team of Kolkata Police has gone to Delhi to seek his transit remand and take him into custody. He will be probefore Patiala House Court on Thursday".

Hindol's father, Chandan Majumdar, a retired professor at JU, said his son was detained at Delhi airport police station around 10.30am.

"Once he arrived at the airport, cops from Delhi airport police station detained him, producing the look-out notice. Later.

when I called Kalita, DC SSD, she confirmed that he has been detained for his alleged involvement in the attack on the education minister. We have contacted lawyers," Majumdar, a former dean of engineering and technology faculty, told.

He said Hindol was scheduled to come to Calcutta after meeting his sister in Delhi.


A section of ultra-Left students had detained Basu for hours after he went to the university on March 1 to attend the annual general meeting of a pro-Trinamool college and university teachers' association.

The students allegedly heckled the minister, demanding the immediate resumption of the campus polls. Port and councillor for Ward 82, led the charge by meeting with booth-level agents in Chetla on Monday evening. Other councillors across the city are following suit, with meetings scheduled throughout the week.


"We discussed the upcoming scrutiny of electoral rolls," Hakim told Metro on Tuesday. "Fresh names will be added, and those who have left the neighbourhood or died must be deleted. We've asked booth-level agents to stay alert so no wrong inclusion or omission occurs."

B.R. Singh Hospital introduces minimally invasive radiofrequency ablation for advanced Pain Management



MI News Service, Kolkata: B.R. Singh Hospital, Eastern Railway, has achieved a significant milestone in advanced pain management by introducing minimally invasive Radiofrequency (RF) ablation for the treatment of chronic pain. This modern technique is aimed at providing long-term relief to patients suffering from persistent pain, thereby improving their quality of life and reducing dependence on medication.

The newly installed RF equipment at B.R. Singh Hospital is being used in the Pain Clinic to manage complex pain cases with notable Radiofrequency success. ablation works by using heat generated through RF waves to target specific nerves, thereby interrupting the transmission of pain signals to the brain. Successful RF ablation can result in prolonged pain relief and decreased need for analgesics. Two recent cases at the hospital highlight the impact of this advancement:

a patient with chronic low back pain caused by lumbar facet joint arthropathy experienced complete pain re-lief following RF lesioning of the median branch of lumbar nerves, while another patient with hepatocellular carcinoma, suffering from severe abdominal pain, underwent celiac plexus neurolysis with RF lesioning of the splanchnic nerves and is now almost pain-free.

This development has been made possible with direct participation of Dr. Ananya Kanti Roy, Additional Chief Health Director/IC, Pain Clinic, and the Anaesthesiology team at B.R. Singh Hospital, mentored by Honorary Visiting Specialist Dr. Chinmoy Roy and with the constant support of Dr. Debasis Guha, MD, B.R. Singh Hospital. Israel destroys over 300 homes in Gaza's Zeitoun neighborhood in 3 days

MI News Service, Gaza: The Israeli military has demolished more than 300 homes over the past three days in the Zeitoun neighborhood in the central Gaza Strip as part of its ongoing occupation plan.

Mahmoud Basal, the spokesperson for the Civil Defense in Gaza, said Wednesday that the Israeli army has conducted heavy assaults in Zeitoun, deliberately targeting civilian residential areas.

He noted that the Israeli forces particularly targeted buildings with

five floors or more, and due to the explosives used, surrounding structures have also been destroyed.

Some homes were destroyed while residents were still inside, causing casualties, with demolitions carried out without prior warning and intense bombardment preventing civil defense teams from reaching the wounded. Israel is facing mounting condemnation for its genocidal war on Gaza, where it has killed more than 61,700 people since October 2023.

Legal experts note that while conviction has long been a ground for cancellation, the inclusion of charge-sheeting, prior to judicial determination, may raise concerns about due process and potential misuse. The move is expected to impact OCI holders involved in serious criminal pro-

The OCI scheme is available to individuals who were citizens of India on or after January 26, 1950, or were eligible to become citizens on that date. Wildfires ravage Europe in worldwide heat waves

MI News Service, Madrid: Record heatwaves have turned Europe into a sweltering sauna above 40 degrees Celsius as raging wildfires sweep many countries on high

The extreme summer heat has created favorable conditions for rampant wildfires, which have already killed several people, displaced thousands and forced firefighters to battle blazes across large parts of Europe. In France, a heatwave broke temperature records in the southwest, with maximums up to 12 degrees Celsius above normal, before spreading to the center-east and northeast of the country. "Often remarkable, even unprecedented maximum temperatures, often 12 degrees above normal levels, were reached this Monday," Meteo France said Tuesday in a press release. The intense heat, combined with dry winds and rare rainfall, has created ideal conditions for fueling wildfires, which have erupted across southern Europe and the

In Croatia, air temperature records were set in Sibenik, at 39.5 degrees, and Dubrovnik, at 38.9 degrees, while large forest fires raged along its coasts and ripped through neighboring countries in the Balkans. In Spain, for example, a lightningsparked wildfire near Madrid killed one man, forced hundreds of residents to evacuate, and scorched about 1.000 hectares of land, while a second fire in the southern resort

town of Tarifa prompted around 2,000 people to flee, and additional blazes in Zamora and Castilla y Leon forced hundreds more to leave. A fire map published on the website of national broadcaster RTVE shows widespread fire activities across the country, with orange and red indicators marking both active fires and affected zones.

Authorities are requesting

help from European partners

as Spain faces its 10th consecutive day of a record-breaking heatwave, with temperatures peaking at 45 degrees. The country is ready to seek more help from European allies, such as more firefighters. Spanish Interior Minister Fernando Grande-Marlaska was quoted by local media Cadena SER as saying on Wednesday. Meanwhile, wildfires continue to scorch northern Portugal, with more than 1,300 firefighters and 16 aircraft busy battling flames, one of which has been burning for 10 days. Large fires have also been roaring in northwestern Türkiye, Albania and Montenegro, where thick smoke blankets several towns. In Albania, one man died, while a Montenegrin soldier was killed during firefighting operations, and in Greece, wildhave prompted emergency evacuations at multiple tourist destinations. Meteorologists attribute the extreme heat to a large highpressure system drawing warm, dry air over the continent and expected to persist through at least Monday in many areas.

SC adjourns plea to save Indian nurse on Yemen death row

MI News Service, New Delhi: The Supreme Court on Thursday, August 14, adjourned for eight weeks the hearing on a plea seeking the Union government's intervention to rescue Kerala nurse Nimisha Priya from execution in Yemen. A Bench of Justices

Vikram Nath and Sandeep Mehta deferred the hearing on a writ petition filed by Save Nimisha Priya Action Council' after being informed that negotiations with the victim's family were currently underway, and granted liberty to mention the matter in case of any urgency. It may be recalled that the execution of Indian national Nimisha Priya, initially scheduled for July 16, has been temporarily halted. She was sentenced to death in Yemen for murdering Yemeni national Talal Abdo Mehdi and remains behind bars there. In the previous hearing, the Justice Vikram Nath-led Bench had asked the Centre to decide on a representation seeking permission to travel to Yemen to negotiate a pardon for the Indian citizen from the family of the victim. The Union Ministry of External Affairs (MEA) had earlier rejected the petitioner's request to grant travel clearance to the war-torn country, citing severe security risks in Yemen.



NEW DELHI [INDIA] : The newly appointed Test skipper, Shubman Gill, ate a massive chunk of batting record books following a 754 run outing during the tour of England, which saw him score four centuries in five matches and walk away with the 'Player of the Series' honours. Already a force to be reckoned with in ODIs, having scored 2,775 runs and 22 fiftyplus scores in 55 ODIs, there have been temptations to play him in the upcoming T20 Asia Cup, starting from September 9 onwards.

India will kickstart their campaign from September 10 against the UAE. There have been media reports that Gill could make his return to the T20I team, possibly as a vice-captain. As per reports, he could be in line to receive the ODI leadership once current skipper Rohit Sharma calls it quits, as per ESPNCricinfo.

The question is, does Gill fit in India's T20I plans?. His most recent T20 outing was in the Indian Premier League (IPL) 2025, where he scored 650 runs at a strike rate of almost 156, with six fifties in 15 matches and emerged as the fourth-highest rungetter. He is also identified as one of the faces which could dominate all format cricket for India in the coming decade. But the selection process is still complex, as last time when India played a full-fledged T20I squad, Rohit Sharma and Virat Kohli were still around in the T20 World Cup 2024, with Gill as a travelling reserve outside the main 15 players. Since then, scheduling and injuries have influenced India's selection in T20Is.

After the WC, Gill led a secondstring Indian side to series win in



Zimbabwe, and July 2024 was the last time he played T20Is for India. He ended the year 2024 with 266 runs in eight T20Is at an average of 38.00, strike rate of 133 and two fifties from the Zimbabwe series, improving his stats overall to 578 runs in 21 matches and innings at an average of 30.42, with a strike rate of over 139, a century and three fifties following an inconsistent string of scores in the start of his T20I career. Gill was appointed as Suryakumar Yadav's deputy for the T20I series in July, and as Test cricket took priority, Gill was not picked for T20Is, with Sanju

NEW DELHI [INDIA] : From dusty playgrounds to the grandest stages of global sport, India's journey since 1947 has been written with sweat, spirit, and unyielding dreams. In a country where sports have often carried the

hopes of a billion, some victories have gone beyond the scoreboard; they have become national memories, etched in collective pride. The Olympics have been the stage for some of India's most defining breakthroughs In 1952 at Helsinki, wrestler KD Jadhav clinched bronze in

the men's 57 kg freestyle wrestling category, becoming the first individual Olympic medalist for India after independence. Four years later, in Melbourne, the Indian men's hockey team, in a sport they had dominated for decades, won gold by defeating Pakistan, their first Olympic
