India's deep space exploration is next, PM Modi told scientists



MI News Service, New **Delhi**: Prime Minister Narendra Modi has asked space scientists in India to prepare for a deep space exploration mission to unravel the secrets that brighten the future of humanity.

In a video address on the National Space Day here on Saturday, PM Modi announced that India was preparing to set up a pool of astronauts for future missions and urged the youth to be part of this

group.
"We have reached the moon and Mars. Now, we have to peek into deep space, where several secrets that would benefit the future of humanity lie hidden, "PM Modi said.

Achieving one milestone after another in the space sector has now become a natural trait of India and its scientists, the Prime minis-

"Beyond galaxies lies our horizons, The endless universe tells us that no frontier is the final frontier and in the space sector too, at the policy level, there should be no final frontier," the Prime minister Modi told a gathering of space scientists, students, and policymakers from across the country.

He said India was making advances in breakthrough technologies such as electric propulsion and semicryogenic engines.

"Soon, thanks to the hard work of you, scientists, India will launch the Gaganyaan mission and will also build its own space station," he said.

ter also asked the private players whether five startups can become unicorns in the next five years.

"I would like the private sector to come forward ... can we reach a point where we can launch 50 rockets every year?" he asked space scientists and engineers.

PM Modi said his government possesses both the intent and the willpower to implement the next-generation reforms required to achieve this vision.

He said India viewed space technology not only as a tool for scientific exploration but also as a means to enhance ease of living. "Space-tech is in-

creasingly becoming an integral part of governance in India," he said, and cited satellite-based assessment in crop insurance schemes, satellite-enabled information and safety for fishermen, disaster management applications, and the use of geospatial data in the PM Gati Shakti National Master Plan. Mamata Banerjee is poorest among 31 CMs in India

MI News Service, Kolkata: West Bengal chief minister Mamata Banerjee, known for her absolute honesty, continues to be the poorest among all 31 CMs in the country with assets worth a little over only Rs 15

According to the latest report published by the Association for Democratic Reforms (ADR), prepared after state assembly polls and bye-elections held post Dec 2024 that from all available official data submitted to the Election Commission of India (ECI) and the Income Tax department, it has been established that Mamata Banerjee is the poorest CM in the Country by all means. .

The list draws from data mentioned in the affidavits

filed by the Chief ministers before the last assembly polls they contested.

According to the affidavits, Andhra Pradesh Chief minister N Chandrababu Naidu, continues to top the list with assets worth more than Rs 931 crore, followed by Pema Khandu of Arunachal Pradesh (Rs 332 crore). They are the only two billionaires on the list.

The report says the total assets of the 31 Chief ministers are worth a whopping Rs 1,630 crore. The report by ADR, which works in the area of electoral and political reforms, states that while Mamata Banerjee has declared assets of Rs 15 lakh, Jammu and Kashmir Chief minister Omar Abdullah has assets



worth Rs 55 lakh. Kerala CM Pinarayi Vijayan is third from the bottom of the last with as-

Mamata Banerjee's affidavit was filed before the bysets worth a little more than election for the Bhowanipore

assembly seat, held on Sept 30, 2021. In the income tax returns filed by her in 2020-21, her assets were worth only Rs 15.4 lakh. During the 2016 assembly polls, her assets were worth Rs 30.4 lakh. She mentioned in the affidavit that "cash in hand" with her was Rs 69,255, while she had a bank balance of Rs 13.5 lakh, which included Rs 1.5 lakh in her election expenditure account. The affidavit also showed that her Tax Deducted at Source (TDS) receivable was Rs 1.8 lakh for 2019-20. She also has jewellery of only 9 grams valued at Rs 43,837.According to the affidavit she did not have any landed property or residential house in her name. Ujjaini Halim, the coordinator of (West Bengal) ADR and West Bengal Election Watch said "when the affi-davits are filed with the Election Commission, they send them to the Income Tax department, We are not sure if there is any scrutiny of the affidavits filed by the MPs and MLAs of the country. However, these are the documents filed with the affidavits and we have to trust that.

She added that "we have seen that money plays a vital role in the elections in India. Election expenditures are on the rise and it is getting increasingly difficult for a candidate like Mamata Banerjee with a humble background to contest polls with such a meagre amount".

Heavy rain cripples life in Chamoli after landslides, 2 went missing

MI News Service, Chamoli (Uttarakhand): Weeks after the massive cloudburst that wreaked havoc in the picturesque Dharali village in Uttarkashi district killing five people and sent at least 65 others with large number of domestic animals missing, continuous heavy rain overnight in Tharali town of Chamoli district caused a flash flood like situation, depositing huge piles of de-bris in the area including at several houses and markets. Informing this official sources said on Saturday that as a result Tunri Gadhera, a dry canal that channels excess rainwater, has now filled with rocks and debris before joining the mighty Pindar River. They said two people went missing in the nearby Sagwara and Chepdon market areas following heavy rain. Kavita, a 20-year-old woman, was reported missing from Sagwara, and another person went missing in Chepdon, the official said. Chief Minister Pushkar Singh Dhami has expressed deep grief over the situation and destruc-

India has certain red lines: EAM Jaishankar on trade deal with the US



MI News Service, New Delhi : India has certain "redlines" in its trade negotiations with the US and New Delhi will not compromise on protecting the interests of farmers and small producers, External Affairs Minister S Jaishankar said on Saturday. Jaishankar said the negotiations for a trade deal between the two sides despite some stiff hurdles are

still underway. Speaking at the Economic Times World Leaders Forum, Jaishankar also said that US President Donald Trump's way of dealing with the world is a very major departure from the traditional way of doing so and the entire world is facing this issue.

"We've not had a US President who has conducted foreign policy as publicly as the current one. That itself is a departure that's not limited to India." he said.

The relations between New Delhi and Washington are on a downturn after Trump doubled tariffs on Indian goods to a whopping 50 per cent, including 25 per cent additional duties for India's purchase of Russian crude oil.

The External Affairs Minister said trade is "really the major issue" between the two countries.

"The negotiations are still going on and the bottom line is we have some red lines." "The red lines are primarily the interest of our farmers and to some extent small producers. So when people pronounced that we succeeded or failed etc." "My answer to this is -- we as a government are committed to defend the interests of our farmers and small producers. We are very determined on that. That's not something we can compromise on." The External Affairs Minister

14,000 new polling booths likely in Bengal soon: EC



MI News Service, Kolkata: West Bengal is likely to get nearly 14,000 additional polling booths ahead of the 2026 assembly elections, with the Election Commis-

sion calling an all-party meeting on August 29 to discuss the proposed reorganisation of polling stations, officials said on Saturday.

West Bengal currently has a little over 78,000 booths, spread across 294 assembly constituencies. According to officials in

the office of the state's Chief Electoral Officer (CEO), polling stations with more than 1,200 electors

will be bifurcated to ease voting. The West Bengal electoral officer (CEO) has decided to increase the number of booths in the state by nearly 14,000. While the CEO's office has prepared a draft list of the new booths, a final decision will be taken after an all-party meeting on August 29, officials said. "This is

MI News Service, New Delhi: The family of Ram Kumar Bind, the 20-yearold man who was arrested after attempting to scale a wall of the Parliament complex in Delhi, has appealed to the government for his release. They claim that their son is "sole support" to the family and may have acted out without knowing the consequences. Ram's father, Shiv Kumar Bind, said that his son and another brother, Umesh, work in a factory in Surat, Gujarat. "Ram's wife gave birth to a child just 12 days ago, and he left Surat on August 18 to return home. I don't know how he ended up in Delhi," the father said.

Ram's mother, Samla Devi, described her son as a simple man. "My son has no fault; the government should release him." She added that Ram is the sole support for the family,

Curiosity and code: Bengal computer scientist Eshan Chattopadhyay's path to Godel Prize

MI News Service, Kolkata: This year's Godel Prize winner, Bengal theoretical computer scientist and IIT Kanpur alumnus Eshan Chattopadhyay, feels that the recognition only reinforces his commitment to curiosity-driven research as he is open to taking greater risks and pursuing ideas stretching across disciplines. An associate professor of Computer Science at Cornell University, Chottopadhyay ex-

pressed interest in broader outreach,

hoping to make fundamental research more accessible. "Research has always been a curiosity-driven pursuit for me, and receiving this award is truly an honour. It reinforces the importance of doing fundamental work, but it doesn't really change how I approach research. Theoretical computer science is about understanding the essence of computation. I am now more open to taking bigger risks, especially in exploring connections between pseudorandomness and quantum computing," Chattopadhyay said.

Chattopadhyay was awarded the 2025 Godel Prize, one of the highest honours in theoretical computer science, for solving a problem that had puzzled researchers for nearly three decades. His research, conducted during his doctoral studies at the University of Texas at Austin under noted computer scientist David Zuckerman, created a two-source

extractor functional even when both sources of randomness are weak, and is considered to be a milestone in the world of computing and Indian academia. This breakthrough has wide-ranging implications for fields such as cryptography, machine learning, and complex simulations -- where reliable randomness is essential. The recognition comes nearly a

Police bring back the light of vision in Gayeshpur, Free eye camp by cops benefit hundreds

MI News Service, Kalvani: The otherwise quiet courtyard of the Gayeshpur Police Outpost turned into a bustling centre of hope on Friday. From the early hours, people started queuing up, some elderly, some daily wage workers, some police personnel themselves ,all waiting to have their eyes tested at a free eye check-up camp organised by the police.By the end of the day, close to 250 people had their eyes examined. For many, it was their first proper consultation with an ophthalmologist. The outcome was praiseworthy, 137 people were given free spectacles on the spot, while those detected with cataract were assured of special arrangements for surgery.For 72year-old Shanti Das, who had been struggling with blurred vision for years, the moment of receiving her spectacles was overwhelming. With tears welling up, she whispered, "It feels like



a curtain has lifted. I can see clearly again." Standing beside her, a constable remarked with a smile, 'These moments make our service worthwhile."Senior officers, including Dy. SP (HQ), Dy. SP Traffic, and IC Kalyani Debasish Panda, Gayeshpur police outpost incharge Jay Das attended the camp. They underlined the larger purpose of the initiative: "Policing is not just about maintaining law and order. Standing beside people in times of need,

even in matters of health, is our responsibility. Such efforts will continue in the future," one of them said. The atmosphere through the day resembled a community fair, orderly queues, doctors patiently attending to each person, police personnel guiding villagers, and children curiously watching the proceedings. The camp not only provided medical relief but also created a bridge of trust between the force and the community.Local resi-

dents hailed the initiative as "a rare humanitarian One resident gesture." commented, "For years, we have seen police only with uniforms and authority. Today, we saw them with empathy."Public health experts note that such outreach programmes are particularly crucial in semiurban and rural belts, where access to eye-care is facilities scarce. Cataract, a leading cause of preventable blindness in India, often goes untreated in poorer households. A free camp like this can make the difference between darkness and sight. As the sun dipped that evening, the Gayesh-pur Police Outpost glowed differently, not with flashing beacons or sirens, but with the light of compassion. For many who walked back home with clearer vision, it was not just about a pair of spectacles, but about seeing a kinder face of policing.

MI News Service, Murshidabad: Tension gripped New Farakka on Friday after a scuffle broke out between a police officer and a local panchayat functionary on National Highway 12. The accused, identified as Tariqul Sheikh, deputy head of Bewa-1 Gram Panchayat, was arrested following the incident. According to police sources, an engine-driven van carrying jute was intercepted at the New Farakka traffic intersection by ASI Tapas Ghosh, who was on duty with the traffic department. The officer informed the driver that such vehicles were not permitted on the national highway. The driver was reportedly asked to sign a bond pledging not to use the van on NH-12 again. Police allege that shortly afterward, the jute owner — identified as Sheikh — arrived at the spot and got into an altercation with the on-duty officer. During the heated exchange, the ASI was allegedly manhandled and sustained minor injuries. Eyewitnesses reported that abusive language was also used in the confrontation. Farakka police personnel reached the spot promptly and detained Sheikh. He was later arrested and charged in connection with

Jayant Mitra, once considered the face of Trinamool in Jangalmahal, had crossed over to the BJP in the run-up to the 2021 elections, formally joining the saffron camp at a rally addressed by Amit Shah in Midnapore. His defection was seen then as a setback for the ruling party. However, after a prolonged absence, the veteran leader was officially reinstated into Trinamool on Saturday at the directive of the party's All India General Secretary Abhishek Banerjee. Speaking after his return, Jayant Mitra admitted his decision to join the BJP was a "mistake" driven circumstances. joined the BJP as a victim of a wrong decision. From the very beginning, I regretted it. Today, Abhishek Banerjee has given me the opportunity to correct that mistake. I pledge to remain with Trinamool Congress till the end of my life," he said, striking a conciliatory tone. Party insiders believe his re-induction will bolster Trinamool's organizational hold in Jangalmahal — a politisensitive zone where Jayant Mitra once played a pivotal role in consolidating support for the party. Bankura district Trinamool president Tarashankar Roy welcomed the move, saying, "Jayantda is one of our

For weeks, locals had alleged that soil was being cut from areas adjacent to ponds near the Bankura-Shaltora road without permission and transported to fill low-lying land. Continuous rains since Wednesday seemingly emboldened the smugglers, who assumed that weakened surveillance would allow them to continue operations unchecked. However, acting on intelligence from a confidential source, officials of the Land Reforms Department swiftly moved in. Witnesses reported that as soon as the drivers spotted authorities, they abandoned their tractors and disappeared into the rain. Chhatna BLRO Shantanu Roy confirmed the seizure and said: "We are investigating whether the land from which soil was smuggled is private or government property. Identifying those behind the smuggling racket is now our priority." The incident underscores persistent concerns over illegal soil extraction in Bankura, a practice that not only undermines land management laws but also poses serious risks to the environment. With smugglers now exploiting weather conditions to evade detection, officials face mounting pressure to tighten surveillance and crack down on the illicit

Jhalda crippled by rain: Families cut off, supplies destroyed

MI News Service, Purulia: Days of relentless rainfall have left Jhalda reeling, with collapsed roads, snapped communication lines, and massive losses to essential supplies. Several wards of Jhalda Municipality, including Chunabhatti, remain cut off as floodwaters continue to

wreak havoc. The downpour, compounded by gushing mountain streams and overflowing city hydrants, has triggered flash flooding across wards 2, 3, and 7. Entire stretches of road have caved in, electric poles have collapsed, vehicles lie submerged, and houses and bound-

ary walls have crumbled under the pressure of rising waters. The scale of devastation has been compounded by the destruction of food stocks. In the ICDS warehouse, water entered storage rooms and submerged rice, pulses, and other essential items worth lakhs of rupees.

"The damage is massive. Food grains have been completely destroyed," confirmed warehouse storekeeper Montu Singh. Deputy Mayor of Jhalda Municipality Sudeep Karmakar and Jhalda Block 1 BDO Madanmohan Murmu visited the affected areas on Thursday

"Disaster response teams and firefighters are already on the ground. Steps will be taken to ensure such large-scale losses can be avoided in the future,' Karmakar said. But while officials cited natural calamity, local voices pointed to human

Since the publication was held up because of the legal complications, we were extremely concerned, as were the students and the parents."

MBBS & dental admissions process resume

MI News Service, Kolkata: The admission process for MBBS and dental courses resumed within hours of the Supreme Court issuing a stay on Calcutta High Court's conditions for the publication of the state JEE results.

The counselling and admission process for MBBS and BDS (dental) courses, which began on July 31, was put on hold on August 19. State health department sources had then said that the lack of clarity over how to go ahead with the OBC rules forced them to put the process on hold. The Supreme Court's order allowed the department to resume the process. "We have already resumed the admission process. The notice giving out the dates will be uploaded on the website," said Indrajit Saha, the director of medical education and the chairperson of the state's medical counselling committee. A revised provisional list of candidates along with their all-India ranks and state ranks — was published on the website of the West Bengal Medical Counselling Committee. Another notice — accessible only to candidates who had registered on the medical counselling committee's website — mentioned that the results will be published after 11am on Saturday. The results will allot colleges to candidates based on their ranks. The successful candidates will need to reach the medical colleges allotted to them to complete their admission process.

Siliguri readies SOP to collate tenants' details

MI News Service, Siliguri: The Siliguri Metropolitan Police will launch a mechanism on Saturday to keep detailed records of people staying in rented accommodations in the city.

Mayor Gautam Deb said on Thursday that the mechanism or an SOP (standard operating procedure) had been readied in association with the Siliguri Municipal Corporation (SMC) to ensure that the police and the civic body had complete information about tenants. "For the past three months, the police, along with us, have been working on the mechanism. It will be formally launched on August 9. The principal aim of developing the SOP is to ensure that would be implemented through the borough offices of the SMC. "All councillors will be requested to take a proactive role to ensure that information about each tenant in their respective wards is shared with the police and the civic body," he added. The decision to implement the mechanism was made at a meeting of the mayor-incouncil on July 7 and was passed at the monthly board meeting of the civic body on July 30, Deb said.

announcement from the mayor comes shortly after two women residing in ward 17, where he also stays, were accused of making racist and derogatory remarks against girls who stay in a rented accommodation. incident led to protests, and the police had to register a case and arrest the duo. They are out on bail now. "The house owners who let out their properties should also be alert. The company is looking at commercial operation of its lithium-ion cell manufacturing plant at Karnataka within the ongoing financial vear.

Responding to shareholders' query on capital expenditure towards lithium ion technology, Avik Roy MD and CEO of Exide Industries said that the company has already invested over ₹3700 crore towards the first phase of the lithium-ion

project. "We will probably invest another ₹600-700 crore in this fiscal," Roy said adding that with this investment, the requirement of phase 1 of 6 GWh (gigawatt hour) capacity will be met. In FY25, the company has made capital investment of around ₹1000 crore, and so far in FY26 additional equity infusion of ₹400 crore has been made increasing Exide's total equity investment in its subsidiary -Exide Energy Solutions Lim-

ited – to ₹3702 crore. "The development of core infrastructure - including pilot manufacturing lines. R&D labs and testing facilities – is at an advanced stage, with commercial production slated to commence within the current financial year," Roy told shareholders. The company is also optimistic about its prospects in the lead acid battery segment in FY26. "We are investing about ₹500 crore in our lead acid battery business as well as recycling business," Roy said. "Our investments in lithium-ion technology, alongside the continued strength of our lead acid battery business, position us well to meet the evolving energy demands. With India's rapid growth and the global shift toward sustainability, we see exciting opportunities ahead," said Sridhar Gorthi, chairman and independent director, Exide Industries. The company is also optimistic about the growth prospects of its storage solutions for rooftop solar applications and is also seeing growth opportunities in the energy storage requirement for

Industry groups warn against expansive telecom cyber rules

MI News Service, New Delhi:

In response to the Draft Telecommunication (Telecom Cyber Security) Amendment Rules, 2025, industry bodies including Broadband India Forum (BIF), Internet and Mobile Association of India (IAMAI), NASSCOM and CUTS International have raised a series of concerns in their submissions to the Department of Telecommunications (DoT). The rules, introduced with the stated aim of tackling telecom-related fraud and strengthening cyber security, have triggered a wave of criticism for what stakeholders say is regulatory overreach, increased compliance burdens, and potential infringement on user privacy. The submissions challenge

the legal basis of the draft, stating that the Telecom Act and its associated rules are applicable to entities offering telecommunication services or holding authorisation under Section 3 of the Act. The stakeholders refer to public statements by the former Union minister of communications who had clarified that Over-The-Top (OTT) platforms and digital service providers fall under the IT Act, 2000, not the Telecom Act. IAMAI, in its submission, stated, "The Draft Amendments introduce a new class of regu-

'telecommunication identifier user entity' ('TIUE') and defines them as any person or entity, other than a licensee or authorised entity, that uses telecom identifiers for user identification or service delivery. This definition is unqualified and will cover nearly all digital platforms or services that use

Satish Golcha appointed Delhi's new **Police Commissioner**

Assam gets its first IIM

MI News Service, New Delhi/Guwahati: Parliament passed a bill to amend the IIM Act to set up Assam's first Indian Institute of Management. Rajya Sabha members from Telangana demanded a similar institution in Hyderabad, a commitment made under the Andhra Pradesh Reorganisation Act in 2014.

Education minister Dharmendra Pradhan introduced the IIM (Amendment) Bill, 2025, in the Rajya Sabha and said the IIM to be set up in Guwahati would start functioning from the current academic session. It will be the 22nd IIM in the country. The Andhra Pradesh Reorganisation Act, 2014, which bifurcated undivided Andhra Pradesh to create Telangana, provides for the setting up of several new institutions in Telangana, including an IIM. However, the Centre is yet to fulfil the commitment. BJP member K. Laxman and Bharat Rashtra Samithi (BRS) member Ravichandra Veddiraju said the government should take the step to fulfil the long-standing demand of Telangana. "There is a demand for an IIM in Hyderabad. Let them consider Laxman said. BRS Rajya Sabha member K.R. Suresh Reddy told that the decision to deny the state an IIM for the past 11 years amounted to a violation of the 2014 law.v "We are not opposed to the IIM in Assam. But an IIM in Hyderabad is a commitment by the Union government under law. It should be implemented," Reddy said.

SC takes suo motu note of plight of cadets during military training

MI News Service, New Delhi: The Supreme Court has taken suo motu cognisance of difficulties faced by cadets, who were medically discharged from military institutes on account of disabilities suffered during training programmes. A bench of Justices BV Nagarathna and R Mahadevan will be hearing the case on Monday which was registered on August 12 after a media report flagged the issue of these cadets, who were once part of training at the nation's top military institutes such as the National Defence Academy (NDA) and Indian Military Academy (IMA). According to the media report, there are around 500 officer cadets who have been medically discharged from these military institutes since 1985, due to varying degrees of disability incurred during training, and are now staring at mounting medical bills with an ex-gratia monthly payment that's far short of what they need. It said at the NDA alone, there are around 20 such cadets, who were medically discharged in just five years, between 2021 and July 2025. The media report further highlighted the plight of these cadets because as per rules.

fied its August 11 direction prohibiting the release of stray dogs from shelters in Delhi-NCR, ruling that canines picked up by municipal bodies must be sterilised, vaccinated, and released back into the same areas. A three-judge special bench headed by Justice Vikram Nath clarified that this exemption would not apply to dogs infected or suspected to be infected with rabies, or those displaying aggressive behaviour. The bench, also comprising Justices Sandeep Mehta and N V Anjaria, said the earlier order prohibiting the release of stray dogs from shelters "shall be kept in abeyance for the time being." The court directed municipal authorities to set up dedicated feeding zones, stressing that "feeding of stray dogs shall not be permitted on the streets." It also ordered that notice boards be put up near these areas, warning that persons found feeding dogs on streets would face legal action. According to the order, municipal authorities have been directed to file a compliance report, giving full details of available resources such as dog pounds, veterinarians, dog-catching staff, and specially designed vehicles or cages, as required under the Animal Birth Control Rules, 2023. People who wish to and animal welfare.



Bengal govt mulls new rules on women's safety at workplaces

MI News Service, Kolkata: In a bid to enhance the security of working women, especially those on night shifts, the West Bengal government has drafted a set of new rules, including the setting up of a mandatory complaint committee in an organisa-tion and installation of CCTV cameras at workplaces, an official said.

According to the proposed rules, night shifts would not be mandatory for female employees of an entity, and an organisation has to ensure the safety of women even during their travel to and from its offices at night. The draft rules were introduced ahead of the completion of one year of the rape and murder of an on-duty doctor at the state-run RG Kar hospital. "Altogether 22 issues have been identified in the draft rules. It has been stated that the night shift will be from 8 pm to 6 am, and at least 10 women, or one-third of the total shift workforce, whichever is higher, must be present together," the official told.

It also proposed to make provisions for resting areas and canteens for female employees so that they don't need to leave the office premises, he said. "CCTV cameras are to be installed at the entry and exit points of the office as well as in the corridors," he added. The proposed rules also mandated the formation of an internal complaints committee at the workplace, which will enforce a "zero-tolerance policy in cases of sexual harassment", the official said.

The committee members will have to meet every three months to address such complaints. "As per the draft, if they fail to do so, the company will be fined under labour laws. and in certain cases, their operational clearances may be revoked,"

The draft rules also stated that an organisation should ensure the "safety of women even during their commute to and from the office at night", he said. "In this regard, the vehicles used by female employees for commuting must be brought under GPS tracking, and the presence of a trained female security personnel in those vehicles is mandated," the official said. All those vehicles must be equipped with emergency alert systems, he said, adding that an ambulance should also be made available. For workplace safety, emergency contact numbers must be prominently displayed in visible areas in offices.

The authorities should also communicate their safety policy in the local language," he said. The state has also sought suggestions from various sectors, such as information technology, health, transport, and also from the police for the safety of women working on night shifts, he said. Since the rape and murder of a woman doctor at the RG Kar Medical College and Hospital in August last year, Chief Minister Mamata Banerjee has been emphasising ensuring the safety and security of women at workplaces.

Further, municipalities have been asked to set up dedicated feeding zones for stray dogs in every ward, based on the number and concentration of dogs in each area. Expanding the scope beyond Delhi-NCR, the court impleaded all states and Union Territories in the matter and transferred to itself similar petitions pending before different high courts. The case will be heard again after eight weeks. Kolkatabased advocate Akash Sharma welcomed the SC order as a landmark balancing between public health



Parl panel recommends terrain training to avoid helicopter crashes

MI News Service, New Delhi: A parliamentary standing committee recommended terrain-specific training to avoid helicopter crashes and an in-depth analysis to study plane in-cidents not limited to human error but also factoring in procedures, training and technology.

The department-related parliamentary committee, dealing with "Overall Review of Safety in the Civil Aviation Sector", made several recommendations while taking into account the recent helicopter accidents during the high-risk Char Dham Yatra ride and recurring operational risks faced by aircraft. The committee recommended that the civil aviation ministry and the Directorate General of Civil Aviation (DGCA) develop and enforce a uniform regulatory framework applicable to all state-operated helicopters and other air

This framework must ensure that such operations are subject to the same rigorous central oversight, safety protocols, audits and crew competency standards as any other commercial air transport operator in the country. Recognising the unique challenges of Himalayan flying, the DGCA must make terrain-specific training and certification a mandatory prerequisite for any pilot authorised to operate in mountainous regions such as the Char Dham route, it said. This should include training in high-altitude operations, weather interpretation and emergency procedures spe-

India to export 5K tonnes of fertilizers to Bhutan



MI News Service, New Delhi: The National Seed Centre (NSC), which functions under ministry of agriculture & livestock of the Royal Government of Bhutan, signed an agreement with the Brahmaputra Valley Fertilizer Corporation Limited (BVFCL), in Siliguri on Monday to supply fertiliser to the neighbouring country.

Established in 2002, BVFCL is a central government undertaking operating under the union ministry of chemicals and fertilizers. It is headquartered at Namrup, Assam, and is a major fertiliser provider across the country. "The agreement marks a meaningful mile-stone in the continuing partnership between India and Bhutan, and reaffirms our shared commitment to corof agriculture and allied sectors, with particular focus on ensuring the availability of critical agricultural inputs, such as fertilisers, to the people of Bhutan," said a senior official of BVFCL.

Yonten Gyamtsho, the director of the department of agriculture in the ministry of agriculture & livestock of Bhutan, led the Bhutanese delegation. Satyajit Mishra, the general manager of BVFCL, led the Indian team. "The agreement will also facilitate the seamless supply of fertilisers from India to Bhutan and will ensure that farmers in Bhutan have continued and timely access to this essential agricultural input. This, in turn, will support Bhutan's food security and productivity objectives, the official added. A source said, as per the agreement, BVFCL will export certain varieties of fertilisers like Urea, Suphala (a blend of nitrogen, phosphorus and potassium), Single Super Phosphate, Muriate of Bhutan. "From the 2025-2026 fiscal year to the 2029-2030 fiscal year, 5,000 metric tonnes of these fertilisers will be exported to Bhutan as per the agreement," said a source.

Betting App: ED quizzes Suresh Raina



MI News Service, New Delhi: The Enforcement Directorate questioned former Indian cricketer Suresh Raina in an alleged illegal online betting app-linked moneylaundering case. An ED offi-cial said Raina's statement was recorded under the Prevention of Money Laundering Act (PMLA) as part of the investigation into the sports betting app 1xBet. "The agency questioned him regarding his links with the app, the endorsement fee earned and the mode of communication between the two parties," the official said. The agency had recently called representatives of Google and Meta for questioning, as several illegal betting apps have allegedly swindled numerous people and investors out of crores of rupees, or evaded paying taxes.

According to estimates by market analysis firms and probe agencies, there are about 22 crore Indian users of online betting apps, of which about 11 crore are

regular users. Last month, the ED had questioned actor Prakash Raj in connection with a money-laundering case linked to the promotion of illegal online betting and gambling apps by several celebrities. The agency has widened its probe and issued summons to several prominent persons after registering a case against 29 celebrities, including Raj, Vijay Deverakonda, Rana Daggubati and several social media influencers and YouTubers, for allegedly promoting illegal online betting platforms. Sources said several celebrities were suspected of having "endorsed" online betting platforms. The agency is also examining the financial transactions involving the celebrities who have claimed they were unaware of the true nature of the platforms. "They allegedly promoted these betting platforms through online pop-up advertisements, potentially encouraging users to engage in illegal gambling," said an ED official.





4. Add ginger-garlic paste and green chilies. Cook for 2 min-


5. Add tomato puree, red chili powder, coriander powder, cumin powder, and salt. Cook until the oil separates from the masala.

Professor Pankaj Kapahi, PhD, senior author of the study, says the public health implications of the research are significant. "Even though women are

tored into the care they receive outside of OB/GYN," said Pankaj Kapahi.

'These risk factors, whether positive or negative, clearly have a significant influence on a variety of age-related diseases and should be considered in the larger context of overall health,' added Pankaj.

The research was based on one of the most comprehensive analyses to date, using regression analysis on nearly 200,000 women in the UK Biobank to confirm genetic associations. "We identified 126 genetic

India temporarily suspends postal services to US

MI News Service, New Delhi: India, on Saturday, August 23, temporarily suspended postal services to the United States as the US-bound air carriers have denied carrying shipments due to a lack of clarity in the new norms issued by the American customs department, the Ministry of Communications said. However, services will continue for letters, documents and gift items up to USD 100. Under an Executive Order issued by the US administration on July 30, 2025, goods valued at more than USD 100 will be subject to customs duties in the United States, effective August 29. As per the Executive Order, transport carriers delivering shipments through the international postal network, or other "qualified parties" approved by the US Customs and Border Protection (CBP), are required to collect and remit duties on postal ship-ments. "While CBP issued certain guidelines on 15th August, 2025, several critical processes relating to the designation of "qualified parties" and mechanisms for duty collection and remittance remain undefined. Consequently, US-bound air carriers have expressed their inability to accept postal consignments after 25th August, 2025, citing lack of operational and technical readiness," a statement from the ministry said. Following the development, the "Department of Posts has decided to temporarily suspend booking of all types of postal articles," destined for the US with effect from August 25, 2025 except letters/documents and gift items up to USD 100 in value, it said. "These exempt categories will continue to be accepted and conveyed to the US, subject to further clarifications from CBP and USPS," the statement said.

Iranian, European FMs to hold phone call on nuclear issue

MI News Service, **Tehran:** Iran's Foreign Minister Seyed Abbas Araghchi is scheduled to discuss the country's nuclear issue in a phone call with his French, British and German counterparts on Friday, the official news agency IRNA reported. The European Union foreign policy chief, Kaja Kallas, will also take part in the discussion, IRNA quoted Iranian Foreign Ministry Esmaeil Spokesman Baghaei as saying.

Other issues on the agenda include Iran's demand for the removal of sanctions and the accountability of the European parties for the İsraeli-U.S. attacks on Iran's nuclear facilities in June, Baghaei said. Since last September, Iran and the three European countries of France, Britain and Germany have held several rounds of talks on a range of issues, including Tehran's nuclear program and the removal of sanctions. The latest round took place in Istanbul, Türkiye, in late July.



SC halts eviction of over 2,000 Bengali Muslim families in Assam's Golaghat district

The Jammu and Kashmir government on Friday ordered the take over of 215 schools which were run by the banned Jamaat-e-Islami (Jel) and its affiliate Falah-e-Aam Trust (FAT), to safeguard the future of the students enrolled in them.

MI News Service, Delhi: The Supreme Court on Friday ordered a status quo on ongoing eviction and demolition drives in Uriamghat and nearby villages of Assam's Golaghat district, providing temporary relief to more than 2,000 Bengali Muslim families who have lived in the area for decades.

A bench comprising Justices P.S. Narasimha and Atul S. Chandurkar issued the interim order while hearing a petition that challenged the Gauhati High Court's refusal to protect the affected residents. The petitioners approached the apex court after the High Court dismissed their writ appeals and upheld the state government's eviction measures. The families argued before the court that they are long-settled residents who have been in uninterrupted possession of the land for over 70 years. They pointed to state-issued documents such as ration cards, electricity connections, and inclusion in electoral rolls as evidence of legal recognition. According to them, the eviction violates provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, and the Assam Rules of 2015. They further



A of the Constitution. Authorities, however, justified the operation by citing the Assam Forest Regulation, 1891, claiming that the villages fall within the Doyang and South Nambar Reserved Forests. Eviction notices issued in July 2025 gave residents just seven days to

This large-scale eviction is part of one of Assam's most high-profile operations, aiming to clear nearly 15,000 bighas (4,900 acres) of land in the Uriamghat area. Since June 2025, the government has evicted over 3,500

four districts, displacing nearly 50,000 people. The operations have often been controversial. In Goalpara district, where 1,080 families were evicted in July, violence erupted on July 17 when protests turned deadly. Police firing killed a 19-year-old Muslim youth and injured several others, including security personnel.

The petitioners cited earlier Supreme Court rulings that mandate prior notice, fair hearing, and adequate rehabilitation before displacement. The case will now determine whether the Assam government can proceed with its eviction plans or must reconsider its approach to long-settled

Tourist Bus, With Indians Aboard, Crashes On New | dhaka rendezvous with York Highway, 5 Killed

MI News Service, New York: Five passengers aboard a tourist bus were killed Friday when their driver got distracted and crashed on a New York state highway, police said. The wreck happened 25 miles (40 kilometers) east of Buffalo as the tourists headed back to New York City after visiting Niagara Falls. The passengers were of Indian, Chinese and Filipino origin, authorities said. "It's believed the operator became distracted, lost control, over corrected and ended up... over there," said New York state police commander major Andre Ray at the scene Friday evening, giving the toll for the first time. No one else was in a life-threatening condition, Ray said. Several passengers received medical treatment and were released. Fifty-four people were on the bus when it crashed and no children were killed, US media reported, contradicting an earlier police briefing. The bus had traveled to Niagara Falls, on the border with

Canada, for the day and was heading home when the accident took place on a highway near Pembroke. - Mechanical error 'ruled out' - "Mechanical error was ruled out as well as impairment or intoxication," said Ray, who added that no charges had been brought. Translators were sent to the scene to help communicate with the victims. Eight helicopters were involved in the rescue effort, Margaret Ferrentino, president of Mercy Flight, a nonprofit provider of air ambulance services, told AFP. "The driver is alive and well -

- we're working with him. We believe we have a good idea of what happened, why the bus lost control. We just want to make sure that all the details are thoroughly vetted," a police spokesman said earlier. Pakistan gears up for **Bangladesh hardliners**

MI News Service, Islamabad: India will be closely watching the developments in the neighbourhood this weekend as Pakistan's Deputy Prime Minister and Foreign Minister Ishaq Dar are scheduled to be in Dhaka for a three-day visit. Although initially scheduled for April this year, the visit was postponed due to the hammering that Pakistan received during Op Sindoor which was launched in the aftermath of the heinous terror attack in Pahalgam in Jammu and Kashmir. Bangladesh's Interim Government's Foreign Affairs Adviser Touhid Hossain told Bangladesh Daily Prothom Alo, "Like with many other countries, we are trying to establish a normal relationship with Pakistan, focusing on trade, investment, and facilitating people's movement. In the past, an unnecessary atmosphere of hostility was created. We have moved away from that. But while seeking normal ties, the three unresolved issues remain on the table." Ishaq Dar is scheduled to meet a host of leaders from across the political spectrum in Bangladesh including Chief Adviser of the Interim Government of Bangladesh Muhammad Yunus, Foreign Affairs Advisor Touhid Hossain and Begum Khaleda Zia, Chairperson of the Bangladesh Nationalist Party and former Prime Minister. The concerning part is Ishaq Dar's meeting with leaders of the Jamaat-E-Islami Bangladesh, a hardline radical Islamic group which has openly taken an anti-India stance and has been blamed in the past for suppression of minorities and was banned by previous governments in Bangladesh for alleged terror links. The current administration in Bangladesh led by Yunus, has been trying to build close ties with Pakistan despite the tumultuous history and the violent and brutal atrocities committed by the Pakistan Army during the lib-

Nearly 62,300 Palestinians killed, famine deepens

least 62,263 Palestinians have been killed in Israel's genocidal war on the Gaza Strip since October 2023, the Health Ministry in the besieged enclave said on Friday. A statement from the ministry said 71 people were killed and 251 were injured in the past 24 hours, bringing the total number of injuries to 157,365.

The ministry also reported two new deaths from starvation and malnutrition, including a child, raising the total famine-related deaths to 273, among them 112 children. "Many victims remain trapped under rubble or in the streets," the minteams are still unable to reach them due to ongoing Israeli bombardment and

lack of equipment. Since March 18, when Israel resumed its military campaign after breaking a ceasefire and prisoner exchange agreement, the health ministry said 10,717 Palestinians have been killed and 45,324 injured. Meanwhile, Israeli forces continue to target civilians seeking humanitarian aid. In the past 24 hours, 24 people were killed and 133 more injured in such attacks. According to the ministry, 2,060 Palestinians have been killed and 15,197 injured while seeking aid since May 27. Israel's full blockade of the Gaza Strip, in place since early March, has created catastrophic conditions for the enclave's 2.4 million residents, leading to famine, widespread disease, and the collapse of essential services. Last November, the International Criminal Court issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and former Defense Minister Yoav Gallant for war crimes and crimes against humanity in Gaza. Israel also faces a genocide case at the International Court of Justice over its war

UAE condemns Israeli settlement plan

MI News Service, Abu Dhabi: The United Arab Emirates (UAE) on Friday condemned Israel's newly-announced settlement plan in the occupied West Bank and its ongoing military operations in the Gaza Strip. The Foreign Ministry said in a statement that the measures were "serious violations of international law and relevant UN resolutions" and posed a grave threat to regional and international efforts to achieve peace and establish an independent Palestinian state. It warned of "catastrophic consequences" from continued hostilities, saying they would worsen the humanitarian crisis and endanger regional security. The UAE urged an immediate halt to settlement expansion and military operations and called on the international community to act to stop the violations and launch a credible political process leading to lasting peace. Israel this week announced plans to build thousands of new settlement units in the West Bank, a move widely criticized by the international community as a major obstacle to a two-state

Missile launched from Yemen falls in central Israel, no casualties reported

MI News Service.Sanaa: A missile fired from Yemen landed in central Israel without causing casualties, the Israeli military and emergency services said. The Israel Defense Forces (IDF) said the missile appeared to have fragmented in midair, with shrapnel falling near Ben Gurion Airport on Friday, according to Channel 12 News. Air raid sirens sounded across central Israel, including Tel Aviv and West Jerusalem, after smartphone alerts were issued, Xinhua news agency reported.

The launch came hours after Israel said it intercepted a drone fired from Yemen toward villages near the Gaza Strip. No damage or casualties were reported in that incident. Earlier on Friday, the Israeli Air Force said it struck energy infrastructure used by Yemen's Houthi group in the capital Sanaa. The Houthis later claimed responsibility for the attacks, saying they had targeted Ben Gurion Airport with a hypersonic ballistic missile and drones in response to Israel's war in Gaza. Earlier on Sunday, Israel's military intercepted a missile fired from Yemen tocentral Israel, launched in apparent retaliation for an earlier Israeli

The missile triggered air raid sirens in Tel Aviv, Jerusalem and other cities. sending residents into shelters and safe rooms in the afternoon as tens of thou-



sands rallied in the streets demanding the release of hostages and an end to the war in Gaza. There were no reports of casualties or damage. "Following the sirens that sounded a short while ago in several areas in Israel, a missile launched from Yemen was intercepted by the IAF (Israel Air Force)," the military said in a statement. The Houthis, who con-

trol much of northern siles and drones at Israel and Israeli-linked shipping since November, while Israel has carried out retaliaairstrikes Houthi-controlled areas, including Sanaa and the Red Sea port of Hodeidah.

Dharmasthala case: SIT arrests whistleblower over 'fake evidence'

MI News Service, Mangaluru: In a major development on Saturday, August 23, the Special Investigation Team (SIT) has arrested the former sanitation worker turned whistleblower in connection with the Dharmas-

thala case. CS Chinnaiah alias Chinna was presented before a Belthangady court, the same day of his arrest. The SIT has sought 10 days custody for further investigation. The court granted the request, officials added. His arrest comes after the protection under the Witness Protection Scheme was withdrawn on Friday. An official from the SIT said that the whistleblower was arrested for "creating false evidence and perjury." The former sanitation worker, who is a Dalit, had appeared before SIT chief Pranab Mohanty

on August 22 and recorded his statement. In another development on Friday, Sujatha Bhat came in front of the media and stated that Ananya Bhat, who went missing from the temple premises, is not her daughter and is the child of her friend.

On July 3, the former sanitation worker claimed he was forced to bury over a hundred bodies, including women and minors bearing signs of sexual assault and rape in Dharmasthala along the Nethravati river, between 1995 and 2014. He had since identified 13 specific burial sites in the temple town of Dharmasthala. Following the accusation, the Karnataka government constituted the SIT to probe the allegations.

He had requested that the bodies be exhumed in his presence and alleged that the victims bore clear signs of sexual assault. During the month-long

excavation, the SIT recovered a skull and two human bones, which were sent for forensic examination. It was revealed that the remains belonged to a male. Veerendra Heggade. the Dharmadhikari (temple head) and Rajya Sabha member, denied all allegations as baseless and accused a campaign launched to malign the image of the temple.

If we need to struggle a bit for statehood, we will: Omar Abdullah

Abdullah also accused the Centre of selectively targeting opposition leaders through three proposed bills concerning the prime minister, chief ministers, and ministers. "So far, in all cases registered and arrests made, only opposition members have been targeted. If this step is genuinely to end corruption, then what impact has the government's work since 2014



achieved?" he asked. The chief minister clarified that he does not view laws themselves as inherently harmful but stressed that their misuse makes them dangerous. "I want to remind my friends in the BJP that they will not remain in power forever. The very laws they are misusing today could tomorrow be used against their own people. Playing with the law will not benefit the country," he cau-

Abdullah said the issue was now before a parliamentary committee, and his party would wait for the outcome. On the sacking of two government employees over alleged terror links, he distanced his government from the decision, saying, "This is something you will have to ask the Raj Bhavan about — we have no role in it.' He also addressed relief measures following a recent

cloudburst in the region. "For now, we are providing as much relief as we can. If, after assessment, more relief is required, we will provide that as well," Abdullah assured. By reaffirming his commitment to statehood and cautioning against misuse of laws, Abdullah positioned himself firmly as both a critic of the Centre's policies and an advocate for Jammu and Kashmir's demo-

Final to Donald Trump

WASHINGTON [US]: Ahead of the 2026 FIFA World Cup, FIFA President Gianni Infantino presented US President Donald Trump with the very first ticket to the tournament's grand finale. The final is scheduled to take place in New York-New Jersey on July 19, 2026. Trump's ticket, Row 1, Seat 1, Ticket No. 45/47, was handed over

during a meeting at the White House. Sharing the moment on his official Instagram handle, Infantino wrote, "Having announced that FIFA World Cup 2026 tickets will go

on sale for all 104 matches on Wednesday, 10 September 2025, it was a pleasure to present the first ticket to United States President Donald J. Trump at the White House. 'We look forward to hosting @realdonaldtrump at the showpiece final on Sunday, 19 July 2026 in New York New Jersey, along with the

millions of fans who will unite to celebrate our beautiful game across all the host cities in the United States, as well as in Canada and Mexico," he said. The 2026 competition will be the first World Cup held across

three countries, the United States, Canada, and Mexico, and the first to include 48 teams. It will take place from June 11 to July 19. Sixteen venues have already been chosen to host games, with 11 in the US, three in Mexico and two in Canada. The cities officially selected to host World Cup matches in the U.S.

are: New York/New Jersey (MetLife Stadium); Los Angeles (SoFi Stadium); Dallas (AT&T Stadium); San Francisco Bay Area (Levi's Stadium); Miami (Hard Rock Stadium); Atlanta (Mercedes-Benz Stadium); Seattle (Lumen Field); Houston (NRG Stadium); Philadelphia (Lincoln Financial Field); Kansas City, Missouri (Arrowhead Stadium); and Boston (Gillette Stadium).



Having assembled a well-balanced squad, UP Yoddhas eye PKL Season 12 glory

LUCKNOW (UTTAR PRADESH): UP Yoddhas will be aiming to put their best foot forward in a bid to secure the elusive Pro Kabaddi League (PKL) title in Season 12, according to a release from PKL. Since making their PKL

debut in 2017, the Yoddhas have been one of the most consistent teams in the league, having qualified for the Playoffs in every season with Season 10 being the only exception. Under head coach

Jasveer Singh, the Yoddhas were one of the standout teams in PKL Season 11 after finishing third in the league phase with 79 points, which included 13 wins in 22 games. The Yoddhas later defeated two-time PKL champions Jaipur Pink Panthers 46-18 in Eliminator 1, before they went down to Haryana Steelers 25-28 in the semi-final. The upcoming PKL Season 12 will see the Yoddhas continue with head coach Jasveer Singh, who has been part of their coaching setup since Season 6 after serving in the Indian Army for almost 25 years. Defender Sumit Sangwan will be leading the side along with vice-captain Ashu Singh. Having retained most of their core squad before the Pro Kabaddi Season 12 Player Auction, the Yoddhas weren't the busiest at the auction. Their total spend was INR 4.970 crore to



that in mind, let's examine the strengths and weaknesses of the Yoddhas ahead of Pro Kabaddi Season 12.

After emerging as one of the most impressive teams in PKL Season 11, the Yoddhas have managed to retain most of their players from the last campaign. The likes of raiders Bhavani Rajput, Gagan Raju Gowda, Surender Gill, Keshav Kumar, Shivam Chaudhary, right corner Hitesh, left corner Sumit Sangwan, right cover Ashu Singh and right corner Sahul Kumar will once again don the Yoddhas' jersey in the upcoming edition of PKL. The UP Yoddhas have also retained the services of their head coach, Jasveer Singh, as a core member, who has guided the team to five playoffs in six seasons. Furthermore, the Yoddhas used their FBM

Mahender Singh for INR 20 lacs for one season. The UPbased team also utilised their FBM option to re-sign their Iranian left corner Mohammadreza

Kaboudrahangi to bolster their defence

The Yoddhas further strengthened their squad by roping in experienced raider Guman Singh for INR 1.073 crore at the PKL Season 12 Player Auction. Since making his PKL debut in Season 7, Guman Singh has already accumulated 559 raid points in 81 matches, including 17 Super Raids and 26 Super 10s to his name. He could play a significant role for the Yoddhas in PKL Season 12.

UP Yoddhas have gathered a squad that has covered most of their bases with an aim to clinch their maiden PKL title in Season 12. With the likes of Guman

Singh, Bhavani Rajput and Gagan Raju Gowda in attack, along with Hitesh, Sumit Sangwan, Mahender Singh and Ashu Singh in defence, the Yoddhas have a balanced squad that could be one of strong contenders for the PKL trophy. One of the biggest weak-

nesses that UP Yoddhas may have to deal with is the lack of quality all-rounders in their squad. Most of the teams that have succeeded in winning the PKL title gen-erally tend to feature at least one, if not more quality allrounders in their team.

While the Yoddhas have Mahender Singh in the left cover position and Ashu Singh in the right cover position, their backups don't have enough experience in the PKL, which could derail their campaign if one of them is injured, or not available for any other reason. As a result, the likes of Sachin Manipal, Gangaram and Ronak will need to step up if given an opportunity.

Despite being one of the most consistent teams in the PKL in recent years, the Yoddhas have failed to capitalise their opportunities and end their title drought since joining the league in 2017. However, the upcoming PKL Season 12 could very well be their season if they can make the most of the balanced squad that they have assembled for the forthcoming
