India stays defiant on Russian oil issue

MI News Service, New Delhi: India forcefully rejected Washington's criticism that it is running a 'profiteering scheme" by buying discounted Russian crude oil with External Affairs Minister S Jaishankar asserting that New Delhi's procurement has been in national and global interest. Jaishankar emphatically said that India will continue to take decisions on the matter independently and suggested that the previous US administration was supportive of New Delhi's procurement of Russian energy as it stabilises the oil market.

"It's funny to have people who work for a pro-American business administration accusing other people of doing business," Jaishankar said.

"That's really curious. If you have a problem buying oil or refined products from India, don't buy it. Nobody forces you to buy it. But Europe buys, America buys, so you don't like it, don't buy it," he said.

His comments at the World Leaders Forum came when asked about US officials criticising India on its energy ties with Rus-

White House Trade Adviser Peter Navarro said on Wednesday that India is running a "profiteering scheme" by using dis-counted Russian crude oil and then selling refined petroleum products at premium prices in Europe and other places.

The external affairs minister also wondered why the same yardstick is not being used for China, the largest importer of Russian crude oil.

"The same arguments which have been used to target India have not been applied to the largest oil importer, which is China. (It) has not been applied to the largest LNG importer, which is the European Union," he said. "And when people say we are funding the war or putting money in the coffers of

(President Vladimir) Putin, Russia-European Union trade is bigger than India-Russia trade. So is Europe not putting money into Putin's coffers," he

> Jaishankar acknowl-edged that India's procurement of Russian crude oil has gone up in the last few years and noted that it is driven by national interests. "That's our right. In my business, we would say that's what strategic autonomy is about," he said.

> "We are buying (Russian) oil to stabilise the oil market. Yes, it is in our national interest. We have never pretended otherwise, but we also say it is in global interest." India turned to purchasing Russian oil sold at a discount after Western countries imposed sanctions on Moscow and shunned its supplies over its invasion of Ukraine in February

In his remarks, Jaishankar said there were discussions between New Delhi and the previous administration in Washington on the procurement of Russian crude oil.

"There were a series of very explicit conversations, saying, we have no issues with your buying," he said and referred to the G7 price cap on Russian crude oil. "The fact that you devised the price cap meant that you accept that there's an oil trade going on with Russia. Otherwise you wouldn't need a price cap." "In 2022, there was deep nervousness because oil prices were going up. There was great international nervousness about the price of oil. And there was a set of conversations with different people in the American administration at that time," Jaishankar

GAGANYAAN MISSION: ISRO completes air drop test of parachute based decel-

Delhi: The Indian Space Organisation (ISRO) on Sunday carried out its first Integrated Air Drop Test (IADT-01) of the parachute-based deceleration system developed for Gaganyaan programme.

The test validates the parachute system for the upcoming Gaganyaan mission, which aims to send

humans into space. The IADT-01 was a collaborative effort involving Isro, Indian Air Force (IAF), Defence Research and Development Organisation (DRDO), Indian Navy, and Coast Guard.

The test evaluated the full parachute deployment sequence — including extraction, drogue chute deployment, and final main parachute activation — to simulate real atmospheric

re-entry conditions.
"ISRO successfully accomplishes first Integrated Air Drop Test (IADT-01) for end to end demonstration

"We do not see space only as a field of research, but as the future of tomorrow's economy, security, energy, and humanity," Singh said.

He said that India is advancing beyond the Earth's surface into "new frontiers of space." "We've already marked our presence from Moon to Mars, and today, the nation stands fully prepared for

the defence minister said.

Union minister for science and technology Jitendra Singh has said that the development and ground testing of the Human Rated Launch Vehicle (HLVM3) for India's first human spaceflight mission, Gaganyaan, has been successfully completed, ANI reported.

In a written reply in the Lok Sabha, Singh stated, "As per the vision envisaged by the Government of India to land an Indian on the moon by 2040, the mission aspects, configuration of the launch vehicle and orbital module systems have been taken up. Training modules, including incremental training for the ongoing Gaganyaan programme and the proposed landing of an Indian on the Moon, are in line with the requirements of mission timelines.

In 2027, India will attempt its first human spaceflight under the

lowed by Chandrayaan-4 Venus, and the establishment of the proposed Bharat Antariksh Station

Singh said the country has also set its sights on placing an Indian astronaut on the Moon by 2040.

Gaganyaan mission is set for launch in December 2025, with the first crewed mission planned for 2028.

When completed, India will become the fourth country to achieve independent human spaceflight, after Russia, the US, and China.

The crewed mission aims to carry three astronauts to low Earth orbit (400 km) for up to three days before a safe return.

India conducts tests of Integrated Air Defence Weapons System

MI News Service, New **Delhi:** New Delhi: India has 'successfully" conducted the maiden flight tests of an integrated air defence weapon system (IADWS) off the coast of Odisha, military capabilities in the face of an evolving regional security scenario.

The IADWS is a multilayered air defence system consisting of indigenous quick reaction surface-toair missiles (QRSAM), very short range air defence system (VSHORADS) missiles and a high power laser directed-energy weapons (DEW) system, according to the defence min-

istry.
The indigenous air de-

important facilities against fence system was flighttested 1230 hours off the coast of Odisha on Saturday. Defence Minister Rajnath Singh congratulated the Defence Research and Development Organisation

(DRDO), the developer of the platform, and the armed forces on the flight tests. The flight tests of the new air defence system came three-and-half months after Operation Sindoor. "I congratulate the DRDO, Indian armed forces and the industry for successful development of IADWS," Singh said on social media. "This unique flight test has established the multi-layered airdefence capability of our country and is going to strengthen area defence for enemy aerial threats," he

Under the IADWS, an integrated operation of all the weapon systems will be controlled by a centralised command and control centre. The command and control centre has been developed by the DRDO, which is the nodal laboratory for the air defence programme The VSHORADS and DEW are developed by Research Centre Imarat and Centre for High Energy Systems and Sciences respectively.

"During the flight-tests, three different targets, including two high-speed fixed wing Unmanned Aerial Vehicle targets and a

multi-copter drone were simultaneously engaged and destroyed completely by the QRSAM, VSHORADS and high energy laser weapon system at different ranges and altitudes," the ministry all the weapon system components, including the missile systems and drone detection and destruction system, command and control mechanism along with communication and radars, performed "flawlessly". The performance of the system was confirmed by the Inte-Chandipur. The test was witnessed by senior scientists from the DRDO and representatives from the armed forces.

India and Algeria have a Joint Commission Mechanism (JCM) to comprehensively address bilateral cooperation. It is Gen Dwivedi's first visit abroad after Operation Sindoor. India launched Operation Sindoor on May 7, targeting terrorist infrastructure in territories controlled by Pakistan in response to the Pahalgam terror attack. The strikes triggered four days of intense clashes with Pakistan that ended with an understanding on stopping the military actions on May 10.

Siliguri Dist Hosp revives cancer OPD

MI News Service, siliguri: The Siliguri District Hospital has resumed services in the cancer outpatient department (OPD) with the appointment of a new spe-

For several months, patients in and around Siliguri had to travel to North Bengal Medical College & Hospital (NBMCH) in Susrutanagar, on the outskirts of the city, after the departure of an oncologist forced the closure of the district hospital's cancer OPD.

"The absence of services created significant hurdles, particularly for economically weaker patients, who struggled with the added cost and the

time of travelling to the NBMCH. Recently, after the appointment of a new specialist, the hospital resumed cancer OPD services every Tuesday and Friday," said a source.

"A tumour board also sits on Fridays to decide treatment protocols. With the revival of the cancer OPD, affordable and accessible care are back for patients," the source added.

Chandan Ghosh, the hospital superintendent, said that when the oncologist had left, a replacement couldn't be found immedi-"Patients chemotherapy were referred to NBMCH. With the new doctor joining, the services have restarted and patients are returning," Ghosh said.

The hospital's oncology infrastructure offers free chemotherapy, biopsy, and FNAC tests, along with surgeries.

The district hospital is also gearing up to strengthen its dialysis unit.

Currently operating with five machines, the facility can't cope with the rising number of patients. Last year, the authorities had decided to add five more machines, and after completing the tender process, a new company was contracted to supply them. Ghosh said the new machines would arrive after the Durga Puja sea-

Food poisoning kills 3 in Malda



MI News Service, Malda: Three members of a family, including a minor, died because of suspected food poisoning in Malda district. Swapan Mondal lived with his mother, Puspa, his wives, Bulti and Rinku, and his daughter, Piu, at Krishnapur under the jurisdiction of the Baishnabnagar police station. "We offered her water. When her condition deteriorated, we took her to the health centre at Bedrabad. Later in the day, my mother and my daughter (from the first wife) and Rinku also fell sick," said Swapan. Bulti, 35, Pushpa, 70, and Piu, 10, were shifted to a private nursing home in Malda. There, Bulti died.

The other two were shifted to Malda Medical College & Hospital, where both died in the evening. Rinku, the second wife, who was under treatment at the hospital in Bedrabad, has recovered but is still under treatment.

"I have no idea how it all happened," said Swapan. A police team reached Swapan's home and sealed a nearby tubewell. The police also collected food samples and water for forensic tests. "It seems to be a case of food poisoning. We are waiting for post-mortem reports. Food samples will be tested to check whether there was any contamination," said a police officer. The district health department is also conducting an inquiry, he said.

KMDA cracks down on encroachments under bridges

MI News Service, Kolkata: The Kolkata Metropolitan Development Authority (KMDA) has begun work to clear encroachments beneath flyovers and bridges under its aegis and fence off the area to prevent any further settlements or stalls in the days to come. Four city bridges have already been cleared of encroachments and fenced off, while a similar drive is now in full swing for eight more bridges. 'There are several flyovers or bridges in the city where makeshift settlements or stalls have come up, and even cooking is done in open flames. Our engineers are often unable to conduct inspections of these structures as the access is blocked by such settlements underneath," said a KMDA official. The official added that a fire in a settlement beneath the Durgapur Bridge in New Alipore in December last year, which damaged the concrete of the structure, was an eye-opener, following which the KMDA started inspections of the undersides of the structures and encountered hindrances due to encroachments. "Encroachment has been a serious issue that has been affecting a study on assessment of health conditions and carrying out work between the piers for restoration,"

pointed out the official. Maa Saradamoni Setu near Alipore Zoological Gardens, Karunamoyee Bridge that acts as a connector between Tollygunge and Haridevpur, Chingrighata flyover, and Ambedkar bridge on EM Bypass near Science City, has already been cleared of such settlements and fenced. Presently, similar work is undergoing in seven bridges, which include Baghajatin Bridge, Chetla Lockgate Bridge, Durgapur Bridge, Bagmari Bridge, Kamalgazi Bridge, Chitpore Bridge, Ultadanga flyover, and the slip bridge connecting VIP Road and Salt Lake. This clearing of encroachment has been undertaken with the assistance of the police and the respective local councillor. "The lifespan of the flyovers is decreasing. Heat from cooking fires is affecting the structures by causing the iron reinforcements to expand. If the temperature exceeds the threshold, the reinforcements begin to weaken. Daily exposure to heat from cooking over several years causes the reinforcements to lose strength over time, said a KMDA engineer. The Kolkata Metropolitan Development Authority will gradually undertake such work at all bridges and flyovers maintained by it.

Pvt bus operators seek subsidy to run e-buses

MI News Service, Kolkata: A section of bus operators in the city is set to appeal to the state government to allow them to operate electric buses in Kolkata. At present, electric buses in the city are operated only by the state government. "At a time when curbing air pollution has emerged as a major challenge and efforts are being made to switch over to electric vehicles for reducing pollution, we also want to contribute to this green cause. We will soon write to the chairman of the Kolkata Metropolitan Development Authority (KMDA) and the state Pollution Control Board to propose a subsidy package so that we can introduce electric buses in the city," said Tito Saha of City Suburban Bus Service (CSBS). The proposal to introduce electric buses was raised at the recent annual conference of the City Suburban Bus Service (CSBS), which was attended by senior officials of the state Transport Department, including Principal Secretary Saumitra Mohan and West Bengal Transport Corporation Managing Director Shiraz Daneshyar. A senior official of the Transport Department, responding to CSBS's proposal on electric buses. said the state government is currently focusing only on conventional diesel buses "A formal letter of demand or proposal in this regard will help us take up the matter. The primary concern will be the sharing of initial capital between the public and private sectors,' the official said. A Transport Department official noted that the state's experience in operating electric buses in the city has shown that their capital cost is significantly high, with the battery, sourced from China, accounting for over 40 per cent of the total vehicle cost and lasting a maximum of four years. At present, the Transport Department is focusing on CNG buses and has already received approval to procure 200 such vehicles.

altitude areas till August 27. An official of the traffic department said the strategic 250-km Jammu-Srinagar national highway and 434-km Srinagar-Leh national highway is open for traffic despite heavy rains, while the Mughal road connecting Poonch and Rajouri in Jammu with south Kashmir's Shopian and Sinthan road linking Kishtwar and Doda districts in Jammu with south Kashmir's Anantnag were closed owing to landslides at different places. A bridge near Logate Morh Jammu-Pathankot highway was damaged in the middle due to overflowing of Sahar Khad nallah following heavy rains in Kathua district, the officials said, adding the traf-fic on the highway was diverted through the alternate bridge.

Normal life was disrupted in Jammu city because of the heavy downpour which led to overflowing of streams and drains, leading to inunda-tion of roads and flood waters entering homes at several places including Janipur, Roop Nagar, Talab Tilloo, Jewel chowk, New Plot and Sanjay Nagar. Boundary walls of several houses were also damaged, while nearly a dozen vehicles were swept away in the flash floods, the officials said. Officials said water levels in major rivers and streams, including Basantar in Samba, Ujh and Ravi in Kathua, Chenab in Doda, Kishtwar, Ramban and Jammu and Tawi in Udhampur and Jammu rose sharply, prompting the administration to put disaster response teams and local police on alert. So far, there have been no immediate reports of casualties, but the rains have triggered landslides at several places in Rajouri and Poonch in Jammu region and Gurez in north Kashmir, the officials said. In Jammu region, Udhampur recorded the second highest 144.2 mm of rainfall followed by Katra, the base camp for the pilgrims visiting Vaishno Devi shrine in Reasi district, at 115 mm and Samba (109.0 mm) and Kathua (90.2 mm). Kolkata police now to track maids, drivers and Tenants

MI News Service, Kolkata: In the aftermath of the brutal murder of a 72-yearold woman inside her upscale New Garia residence, the Kolkata Police has announced sweeping measures to tighten surveillance on domestic workers, drivers, and tenants across the city. The move follows the chilling revelation that the accused, a domestic help hired barely days earlier, meticulously surveyed the house, disconnected CCTV cameras, and executed the killing with her partner before fleeing with jewelry, cash, and mobile phones.

Within 24 hours, investigators tracked and araccused—identified nanny Ashalata and her lover, Jalal Mir—bringing to light a chilling pattern: elderly couples living alone had been carefully marked as "soft targets." Police sources said that Ashalata, who entered the residence on August 17 through a nanny placement center, spent three days mapping the household's vulnerabilities. She learned that the victim's son lived abroad while the daughter resided in Mumbai, and that large sums of cash were kept for the elderly couple's care.

Heavy rains lash South Bengal; IMD warns of fresh low pressure in Bay

Back to-back murder stun Kolkata

The victim, identified as Nandita Basu, a senior resident of Kabi Sukanta Sarani, was found lying in a pool of blood inside her home around 1:45 pm. Neighbours alerted police after spotting her collapsed body with severe facial injuries. By the time officers arrived, she had succumbed to her injuries. According to initial police findings, the prime suspect

is none other than her son, Manik Basu, who allegedly attacked his mother following a heated altercation. Local residents claimed that frequent disputes between the mother and son often turned violent. Manik was taken into custody soon after the incident, and a case under culpable homicide charges has been registered. The crime mirrors the disturbing brutality of another case in New Garia's Panchasayar, where the bloodied body of Vijaya Das, wife of Prashant Kumar Das, was discovered with her hands, feet and face bound with tape. The elderly couple lived just a short distance from the local police station. While

Vijaya's body was found near the staircase, her husband was discovered injured in an adjacent room. Investigators have since arrested the family's domestic help, Ashalata Sardar, along with her as-sociate, Jamal. Police confirmed the recovery of stolen ornaments, including a ring and a bangle, from the duo. Two murders in two days-both involving elderly women, both inside their homes have triggered alarm across Kolkata, raising questions about safety and the vulnerabilities of senior citizens. Police are tightening surveillance in residential pockets even as investigations continue

Bishwa Bangla University shifted exams for TMCP Foundation day

At Calcutta University, undergraduate examinations were held on August 28 despite ob-

jections from TMCP. Acting Vice-Chancellor Shanta Dutta had stood firm on her stance that examinations could not be shifted. The stand-off provoked heated exchanges, with Education Minister Bratya Basu himself remarking that the VC should have been more considerate towards the Chief Minister's appeal. Against that backdrop, Biswa Bangla University's decision to shift its exam schedule is being viewed as a conscious deviation from Calcutta University's path. The authorities have maintained that academic timelines will not be compromised, as the rescheduled examinations will be held just two days later. Predictably, the announcement triggered political sparring. Opposition leaders described

the move as symptomatic of Bengal's academic decline. BJP's Bolpur organisational district president Shyamapad Mandal alleged, "This is a prime example of degradation. A university under the Biswa Bangla banner naturally becomes an extension of Trinamool." CPI(M) district secretary Gautam Ghosh echoed the criticism, stating, "Trinamool wants to play the 12 o'clock position in education." The ruling party's student wing, however, welcomed the move. TMCP leader Abhirup Chakraborty said, "The 28th is a declared day of observance. Unlike Calcutta University, where the decision was politically motivated, Biswa Bangla University has acted sensibly by keeping the collective opinion of students in mind."

Data breach jolts TET 2022, jobs still in limbo

Allegations have surfaced that personal details of over 1.5 lakh candidates from the 2022 TET examination have been leaked online through an unofficial website, triggering outrage and reasons services.

According to candidates, the web-

site in question provided direct access to names, roll numbers, and other personal information of successful examinees. It even displayed options to download the purported "West Bengal Primary TET 2022 Certificate," mimicking official processes with striking accuracy. The site further offered unrelated services, including voter cardrelated information — deepening suspicion of large-scale data harvesting. Candidates claim they were able to verify the data of 1,50,406 individuals,

a figure almost identical to the 1,50,491 candidates officially declared as having passed the 2022 TET. "This cannot be a coincidence. The data is genuine. How did this leak occur?" one agitating candidate asked. The revelation has come at a particularly sensitive time. Recently, thousands of TET pass-outs took to the streets demanding clarity on recruitment timelines. The leak has now added a new dimension, with many alleging that the entire recruitment system is compromised.

"We are being cheated on every front. First jobs are delayed, now our personal data is in the public domain," a protester said. Reacting to the controversy, Primary Education Board President Gautam Pal said he had no knowledge of the website. "I have to see if this is true. I am checking. If such a cycle exists, we will take action. This is not possible from our website," he told reporters. Cyber experts, however, warn that if confirmed, the breach could have serious consequences, ex-

posing candidates to identity theft and fraud. Political voices are also expected to weigh in, with the opposition likely to sharpen attacks on the state over what they will call yet another example of "collapse in governance." For now, the onus is on the Board to identify the source of the leak and assure anxious candidates that their data is secure. But until accountability is fixed, the already embattled TET recruitment process risks further erosion of public

Bharat Rashtra (BRS) Working President KT Rama on Thursday hit out at Telangana Chief Minister Revanth Reddy, saying that he should present the record of his 20-month rule to the people and face by-elections as a referendum on his gover-

Speaking at a massive gathering of key BRS workers from the Serilingampally constituency, KTR said, "In 10 years of BRS rule, no leader laid a hand on real estate or resorted to land grabbing. But in just 20 months, Congress leaders have unleashed anarchy through Hyderabad Disaster Management and Asset Protection Agency (HYDRAA)."

He said even court orders are ignored, and houses of the poor are being demolished without mercy.

As per the release, KTR pointed out that while BRS borrowed Rs 2.85 lakh crore over a decade, Revanth Reddy borrowed Rs 2.2 lakh crore in just 20 months--with no development to show for it.

"KCR used the funds to build 42 flyovers, worldclass hospitals, and sewtreatment plants in Hyderabad. What has Revanth built? Not even a single bridge or stormwater drain," he challenged.

"KCR deposited Rs 70,000 crore into the accounts of 70 lakh farmers. What has Revanth done with Rs 2 lakh crore?" he asked, adding,

At an event held at the Dehing Sports Complex in Margherita, Sarma highlighted the government's continuous support for SHGs in Assam.

"This support has included the provision of financial assistance and facilitation of bank loans. Women involved in these groups have become familiar with banking systems, engaged in the production of goods, and achieved self-sufficiency. Currently, Assam has 4 lakh SHGs with approximately 40 lakh women participating. As a result of these efforts, 8 lakh women now earn over 1 lakh annually," Sarma said.

He also mentioned that Prime Minister Narendra Modi had invited some of these "Lakhpati Baideos" to Delhi to recognise their success, and the Assam government has been actively working to acknowledge their achievements.

He expressed hope that more women in SHGs would follow this example.

The Chief Minister emphasised that the MMMUA initiative was commenced to empower women financially, explaining that the scheme offers women Rs 10,000 as seed capital in its first year.

"This amount could increase to Rs 25,000 in the second phase and Rs 50,000 in subsequent years if used for productive purposes. Women may use these funds either for group ventures or for individual activities such as weaving, animal husbandry, or starting a small business. Additionally, they could invest the funds in their husbands' businesses if they choose. To support these endeavours, women would receive three days of training through the Assam State Rural Livelihood Mission and Assam State Urban Livelihood Mission." he said.

"Mann must act, not blame": Pralhad Joshi hit back at Punjab CM over 'foodgrain theft' allegations

MI News Service, New Delhi: free ration for 55 lakh people. Union Minister for Consumer Affairs, Food and Public Distribution Pralhad Joshi on Sunday said that Punjab Chief Minister Bhagwant Mann should act against "diversion" and "misuse of food" meant for the poor instead of making allegations on the Central Government of "foodgrain

The Union Minister said the Mann government should act instead of making allegations against the Centre for illegal diversion and misuse of foodgrains meant for the poor.

After allegations of 'vote theft', Punjab Chief Minister Bhagwant Mann has now accused the Central Government of 'foodgrain theft'. The Chief Minister alleged that the Centre is conspiring to block Punjab's share of the Public Distribution System (PDS) ration.

Mann claimed that the Bharatiya Janata Party (BJP)led Central Government wants to snatch free ration from the poor of the state. He said Punjab has a total of 1.53 crore ration card holders, out of which there is a plan to stop

According to the Chief Minister, in July, free ration for 23 lakh people was stopped under the pretext of e-KYC, and now there is a threat to block ration for another 32 lakh people from September 30.

Responding to Mann's allegations, Union Minister Pralhad Joshi held a press conference today and said, Mann must act, not blame. There is pressure from lobbies to continue giving rations to ineligible people, and CM Mann is working under that pressure.

The Union Minister clarified that the order for e-KYC came from the Supreme Court; the Centre has only asked states and UTs to comply. He said that Punjab was advised to begin e-KYC in March 2023, and the deadline was extended three times in two years. Despite this, the Centre has never stopped rationing for even a single day. Between June and August 2025 alone, Punjab was allocated 1.74 lakh metric tonnes of

Noida dowry murder case: Police arrest mother-in-law of victim Nikki Bhati

Noida: The police have arrested the mother-in-law of the deceased woman, Nikki Bhati, in connection with the alleged dowry death case, police said on Sunday.

Earlier in the day, Nikki's husband, Vipin Bhati, was shot in the leg during a police encounter and admitted to a hospital for treatment.

The man accused of setting his wife on fire, who later succumbed to her injuries, was today brought to a hospital in Greater Noida for treatment after being shot in the leg during an encounter with Uttar Pradesh police.

The victim's father told ANI that she had 70 per cent burns and was pronounced dead at the Safdarjung Hospital in New Delhi.

"I reached there as soon as my elder daughter called me..The doctor told me she is 70% burnt..We took her to Safdarjung Hospital. The doctor told me to take her back because she would not be able to survive. He (her husband) should be hanged. They got married in 2016. He started harassing her a few

started her own work, and her husband began asking for the money she earned. I demand that the Court and CM give him the death penalty..."

Meanwhile, the family of the deceased woman, Nikki Bhati, held a protest outside the Kasana Police station today, demanding justice.

The father of the deceased woman alleged that her inlaws killed her over their demand for dowry.

"Her mother-in-law poured kerosene while her husband set her on fire. They kept asking for dowry; now their demands have been met. I just married my daughter as per tradition. Their dowry demands have been met now that my daughter has died. They demanded a car and tortured my daughter for

"That person is neither man nor human; he is a butcher. We once brought her home because of all this domestic violence, but because of societal pressure, they came and took her back on the promise of not repeating this. It con-

tinued. Now they have got what they wanted," he said. Reacting to the incident, Samajwadi Party women's wing national president Juhi Singh said that the strictest punishment should be given in the case. "Strictest punishment should be given in this case... The parents should empower their daughters, keep them safe and raise voice for their rights... This is not worth an apology... There are laws for crimes against women, but the government is not implementing them..."

Himachal Pradesh: Monsoon death toll climbs to 303; 155 rain-related, 148 road accident deaths

MI News Service, Shimla lated deaths were in Cham-The relentless monsoon in Himachal Pradesh has claimed 303 lives since June 20, with 155 deaths attributed to rain-related incidents such as landslides, flash floods, cloudbursts, drowning, and lightning, while 148 fatalities have occurred in road accidents, according to the State Disaster Management Author-

issued on Sunday evening. the SDMA reported that the monsoon has caused widespread destruction across all 12 districts, affecting both public and private infrastructure, agriculture, and livestock.

According to SDMA, 10 fatalities are due to landslides, and the number of deaths due to flash floods is 9. The number of deaths due to cloudbursts is 17, the number of deaths owing to drowning incidents is 32, the number of deaths due to fire is 3, 13 died of snake bites, 12 died due to electrocution, 34 died due to steep rocks, and the number of deaths due to other causes is 25.

Mandi and Kangra districts recorded the highest rain-related casualties, each reporting 29 deaths, followed by Chamba (14) and Kullu (13).

ba (22), Mandi (22), and Kangra (19), followed by Shimla (15) and Kinnaur (13). The state's hilly terrain and rain-damaged roads have been cited as major contributing factors to the surge in accidents. The SDMA estimated

the total monetary loss at Rs 2,348.62 crore. This includes extensive damage to public property such as In its cumulative bulletin PWD infrastructure (Rs 1,310.79 crore). supply systems (Rs 769.74 crore), power infrastructure (Rs 139.46 crore), and agricultural and horticultural losses exceeding Rs 2,743 crore combined.

The state has also reported the death of 1,833 large animals and the loss of 25,755 poultry birds.

A total of 317 houses have been fully damaged, 367 partially damaged, along with 836 cow sheds, 1,591 labour sheds/huts, and 465 shops/factories destroyed.

Authorities have urged residents to remain alert as rains continue in several districts, warning that unstable slopes, overflowing rivers, and waterlogged roads could pose further risks. Restoration and relief operations are ongoing, but officials caution that persistent rainfall could delay

Intervention for carers aids in prevention of elder maltreatment: Study



WASHINGTON DC [US]: A recent double-blind, randomised controlled trial found that elder abuse of older individuals with chronic illnesses including dementia, was reduced by an educational and social support

The study was published in the Journal of the American Geriatrics

Elder abuse is described as "an intentional act or failure to act by a carer or another person in a relationship involving an expectation of trust that causes or creates a risk of harm to an older adult." Coaches met with carers weekly for up to 12 sessions during the Comprehensive Older Adult and Carer Help (COACH) intervention assessed in this research to listen to their concerns and lead them through a specifically customised behavioural and educational intervention. Participants were given caregiving tools and coping methods, as well as maltreat-ment education so that they may be vigilant against abusive behaviours by themselves and others. A total of 80 carers were randomly assigned to either the COACH intervention or a control group.

Treatment group caregivers reported less mistreatment against their care recipient, which dropped from 22.5 per cent at baseline to 0 per cent following the completion of the 3-month intervention. In the control group, reported rates did not change significantly. "COACH was created to benefit older adults who rely on a caregiver and are particularly vulnerable to harm. It now stands out as the first intervention that has been shown to prevent elder mistreatment," said corresponding author Zach Gassoumis, PhD, of the University of Southern California.

Premature babies in neonatal care units are susceptible to fatal illnesses: Study

LONDON [UK] : Premature babies in neonatal care units are very sensitive and susceptible to potentially fatal illnesses. To help keep these babies safe, the danger of infection must be kept as low as possible. A particular problem is late-onset sepsis which starts from three days after birth, when bacteria get into the blood and grow. This can be very dangerous and babies with late-onset sepsis end up staying in hospital longer, need more treatment with antibiotics and can be left with life-long effects on their health. Bacteria from the Staphylococcus family are the most common causes of late-onset sepsis. Most members of this large group of bacteria are harmless; they are normal colonisers of our skin, which can even otect us from harmful microbes However, some strains, when they end up in the wrong place and get inside the body, can cause major particularly immunocompromised individuals neonatal babies. Staphylococcus capitis is an example of this. This is a species that is usually content living on our scalp, face and neck; capitis means "of the head' in Latin. Some strains of S capitis are however associated with late-onset sepsis. One particular strain, known as NRCS-A, has been identified as causing serious infections in neonates around the

Scientists think this strain first emerged in the 1960s and spread globally throughout the 1980s as it evolved resistance to the commonly used antibiotic vancomycin. Strains circulating now show

resistance to multiple antibiotics and reduced susceptibility to antiseptics that we use to sterilise the skin of babies. This makes the bacteria harder to treat and constrain has become so globally successful has remained a mystery. To try and understand what makes this strain able to spread around the world and to develop better

ways to keep it under control, Professor Mark Webber and his team from the Quadram Institute and the University of East Anglia analysed the genomes of hundreds of S capitis isolates. They worked with two Neonatal Intensive Care Units (NICUs), one in the UK and one in Germany, obtaining samples of S capitis from the skin and gut of neonatal babies, with and without lateonset sepsis. Their results, published in the journal Microbial Genomics, found that the NRCS-A strain was commonly carried on the skin and in the gut of uninfected neonatal babies, and that metals that are known to be hard

transmission between babies within NICUs was likely. By reading the complete genome of each sample, the team was able to identify tiny genetic differences caused disease and those that didn't. Professor Webber and his team found that the NRCS-A strains that can cause disease carried a set of unique genes, which they think allows them to survive in the gut as well as on the skin. This would make cleaning the skin to eradicate the bacteria ineffective as the babies will carry a reservoir in their gut microbiomes that cannot be easily removed, but can act as a source of infection. The genes found in the NRCS-A strains allow them to be resistant to nisin, an antimicrobial compound naturally produced by bacteria in the gut. They also carry genes to survive exposure to the toxic metals that our immune system uses to kill bacteria, as well as genes to scavenge essential

for bacteria to access in the gut environment. Further experiments also showed that the bacteria grow better in acidic conditions as found in the gut. Together, the evidence supports the idea these bacteria are adapted to exploit growth in the gut. If metal scavenging is critical to infection, this may also be the bacteria's Achilles heel, presenting a new way to counter its threat. There is early evidence that feeding babies a probiotic supplement of benign bacteria reduces the rate of late-onset sepsis and that these 'good bacteria' can extract metals before the S capitis, preventing their growth.

"Studying how strains like NRCS-A have become globally successful is crucial to understanding how bacteria evolve to colonise amerent environments and to give us new ideas about how to reduce the risks of infection in vulnerable populations," said Professor

"We hope this work can be the starting point for more research to develop better ways to protect newborn babies from the terrible consequences of infection." Dr Heather Felgate from Quadram Institute and lead author of the study said "There are still many questions to answer as to why NRCS-A has become so globally spread amongst NICU. But, working out how NRCS-A can evade the host immune system, spread and survive can also give us a head start with many other Staphylococcal species that cause sepsis in immunocompromised people in

NICU and Intensive care units."

Obesity rates lower among women who live in walkable neighbourhoods

WASHINGTON DC : According to a new study living in a more walkable neighbourhood reduces the risk of obesity-related cancers in women, specifically menopausal breast cancer, but also ovarian cancer, endometrial cancer, and multiple myeloma.

The findings are published in the journal Environmental Health Perspectives.

Obesity has been associated with an increased risk of 13 different forms of cancer in women, and physical activity, regardless of body size, reduces the risk of some of these malignancies.

Long-term investigations eval-uating neighbourhood walkability and the incidence of obesity-related cancer were, however, scarce until now. Women who resided in neighbourhoods with higher walkability levels, as measured by average destination accessibility and population density over approximately 24 years of followup, had a lower risk of obesityrelated cancers, particularly postmenopausal breast cancer. However, moderate protective associations were also found for endometrial cancer, ovarian cancer, and multiple myeloma. Women who had lived in areas with the highest levels of neighbourhood walkability (the top 25 per cent of walkability) had a 26 per cent lower risk of obesityrelated cancers compared to those

Small doses of mushrooms may be helpful for mental illnesses: Research

WASHINGTON DC [US] : A new study from the University of Southern Denmark suggests that psilocybin, the main ingredient in mushrooms with psychedelic characteristics, could be used as a therapeutic aid through microdosing.
Psilocybin has long been recog-

nized as a classic psychedelic sub-stance and has recently been investigated for its potential to assist in the treatment of various psychiatric disorders, primarily depression and addiction, through therapy supplemented with a high dose of psilocybin.
In such therapeutic treatment, the

Microdosing in Rats In the recent study published in Nature - Molecular Psychiatry, Associate Professor Mikael Palner and PhD student Kat Kiilerich from the Research Unit for Clinical Physiology

and Nuclear Medicine at the University of Southern Denmark examined the effects of small doses of psilocybin on rats.

Their focus was on repeated low doses of psilocybin, which are significantly lower than the doses typically used in therapeutic settings and are commonly referred to as 'microdos-

☐ Microdosing is a phenomenon popularized within performance culture, notably in areas like Silicon Valley, California, and has subsequently spread through stories and anecdotes on the internet as a form of selfmedication for various challenges, explains Mikael Palner, the last author of the study.

Effective for Stress and Compulsive Behaviors

The study conducted on rats showed that animals tolerated the repeated low doses of psilocybin well and did not exhibit signs of reduced pleasure (anhedonia), anxiety, or altered locomotor activity.

Most notably, repeated low doses of

psilocybin increased the rats' resilience to stress, and they displayed fewer compulsive behaviors. Additionally, an increase in the num-

ber of connections to the thalamus region of the brain, which serves as a kind of filter for our decisions and concerns, was observed.

□ The change in connectivity to the thalamus may contribute to our enhanced resilience to stress factors and could explain why so many people report positive effects on their wellbeing from small doses of psychedelic mushrooms.

A Promising New Approach Through the new study, the researchers have established a valid method that can be utilized for further research into the effects of repeated

low doses of psilocybin. The study also lends support to the numerous anecdotal reports of the benefits of microdosing as a therapeutic intervention.

This paves the way for additional research and potentially entirely new approaches to treating various mental disorders.

□ The increased anxiety and stress in society currently have placed a strong focus on microdosing, leading to a surge in the trade of mushrooms. Countries such as the Netherlands. Australia, the USA, and Canada have either legalized or are in the process of legalizing psilocybin for therapeutic treatment, says Mikael Palner.

□ It is, therefore, crucial that we understand the effects and side effects of these substances, which are already widely used by people around the

Enhanced Understanding with Potential

Mikael Palner developed an interest in researching psychedelic substances and psilocybin when he lived in Silicon Valley, California, eleven years ago and witnessed the surge of self-improvement practices that garnered significant media attention and prompted more people to experiment

with microdosing.

□ Some books were published that popularized the concept of using small doses of psychedelics to address both mental issues and enhance performance. This motivated me to launch the project I've been devoted to for the past six years, says Mikael Palner.

□ Now, we can determine the appropriate dosage in rats, enabling us to investigate the effects of microdosing, which could significantly advance our understanding of the brain and mental challenges. This benefits both the field of science and society at large.

Jaishankar slams 'Politics of Convenience' in US-Pakistan ties, rejects mediation on India-Pakistan issues

MI News Sevice, New Delhi: External Affairs Minister S. Jaishankar on Saturday sharply criticized the nature of ties between the United States and Pakistan, describing their relationship as one built on a "politics of convenience," where past concerns are often overlooked to suit present-day needs. Speaking at the ET World Leaders Forum, Jaishankar drew attention to the recurring pattern in Washington-Islamabad relations.

They have a history with each other. And they have a history of overlooking that history. It's not the first time we have seen such things," he said. In a pointed remark referencing the 2011 US raid in Abbottabad that killed al-Qaeda leader Osama bin Laden, Jaishankar noted: "Sometimes when you look at the certificates that somebody in the military will give, it's the same military which went into Abbottabad and found you-knowwho there."

While acknowledging the tactical advantages that shape such ties, the minister emphasized that India's engagement with Washington is guided by "larger structural strengths" rather than short-term considerations. "I know what I am about. I know what my strengths are. I know the importance and relevance of my relationship. So that's what guides me," he asserted.

Jaishankar also responded to criticisms raised during former US President Donald Trump's administration, which accused India of profiteering by buying discounted Russian crude oil and reselling refined petroleum products at higher prices in Europe and elsewhere. Rejecting the charge, he remarked: "It's funny to have people from a pro-business American administration accusing others of doing business. If you have a problem



buying oil or refined products from India, don't buy it. Nobody forces you. But Europe buys, America buys. So if you don't like it, don't buy it."

On questions surrounding Operation Sindoor and Trump's claims that Washington mediated a ceasefire between India and Pakistan, Jaishankar categorically denied any role for third-party intervention. "Since the 1970s, there has been a national consensus that we do not accept mediation in our relations with Pakistan," he said.

Acknowledging that several countries, including the US, had made phone calls urging restraint during the conflict, Jaishankar clarified: "That is not mediation. When Israel-Iran war was happening, I called. When Russia-Ukraine was happening, I called. In today's interdependent world, countries talk. But it is entirely different to suggest that an outcome negotiated directly between India and Pakistan was somehow imposed by outside mediation. It was not.'

By the end of September, more than 6,40,000 people will face "catastrophic" levels of food insecurity, categorised as IPC Phase 5.



in Gaza were civilians. How many people has Israel killed? And what did Israel say about killing them? Why is this latest report so important?

Here's what we know: The report was based on an internal Israeli intelligence database that records the deaths of fighters from Hamas and Palestinian Islamic Jihad (PIJ).

The database estimated that Israel has killed 8,900 fighters throughout its war on Gaza, according to data from May. That is an estimate because, of that number, 1,570 names are listed as "probably dead".

The 8,900 figure is out of 47,653 people whom the database lists as active fighters -34,973 Hamas, and 12,702 PIJ.

Let's put that against the total number of people Israel has killed in Gaza, which was 53,000 in May, according to +972 Magazine. That means 16.8 percent of the people Israel killed or "probably" killed were fighters.

According to the Health Ministry's most recent numbers, Israel has killed at least 62,686 people in its 22-month offensive on the enclave and wounded 157,951. Thousands more remain missing.

Studies have found the number of casualties is far higher. A peer-reviewed study published in The Lancet medical journal said the actual number killed in the first nine months of the war may have been 40 percent higher than reported. Many of the bodies of those

killed by Israel are incinerated during bomb or missile strikes, left rotting in areas occupied by

Israel has repeatedly claimed that it does all it can to limit civilian casualties and regularly disputes the Health Ministry's numbers.

In September, Israeli Prime Minister Benjamin Netanyahu bragged that Israel had the "lowest ratio of civilian to combatant deaths in the history of modern urban warfare", claiming the army was killing one civilian for every fighter it killed.

But this was months after Local Call and +972 reported on an Israeli army AI targeting system codenamed Lavender, which, according to sources in Israeli intelligence, marked tens of thousands of people in Gaza as potential fighters and eligible to

According to two of the sources, the army decided during the early stages of the war that it was permissible to kill up to 15 or 20 civilians for every junior Hamas operative earmarked for death by Lavender.

And members of Netanyahu's far-right coalition have shown little to no concern for Palestinian lives when addressing their domestic audience.

Speaking on Israeli radio last month, Heritage Minister Amichai Eliyahu said: "The government is rushing to erase Gaza, and thank God we are erasing this evil. All of Gaza will be Jewish.

Finance Minister Bezalel Smotrich told a settlement conference in May: "Gaza will be entirely destroyed," and what remains of its people would be exiled to a narrow strip of land in the south.

Throughout the conflict, Al Jazeera has reported on numerous accounts of civilians being massacred while seeking food, the dropping of heavy ordnance on displacement camps, the systematic destruction of Gaza's healthcare system and the deliberate killing of its medics as well as the use of starvation as a weapon of war.

"I think anyone who has closely observed the genocide in Gaza can't have been surprised by the report," Orly Noy of Local Call told Al Jazeera. "Everything we knew about

the war suggested that the mass killing, destruction and brutality there was indiscriminate. That is the nature of this war. This is its logic. Israel has created a mechanism for genocide that it's deploying indiscriminately across Gaza.

When approached by Local Call and +972, the Israeli military confirmed the existence of the database on which the report was based.

The seasoned right-handed batter said that he couldn't put his feelings into words and mentioned that all things have to come to an end. Pujara further thanked his fans and well-wishers for their love and support throughout his

"Wearing the Indian jersey, singing the anthem, and trying my best each time I stepped on the field - it's impossible to put into words what it truly meant. But as they say, all good things must come to an end, and with immense gratitude I have decided to retire from all forms of Indian cricket. Thank you for all the love and support!," Cheteshwar Pujara wrote on 'X'

Cheteshwar Pujara made his international debut against Australia in Bengaluru on October 9, 2010. The latter played a total of 103 Tests and amassed 7195 runs at an average of 43.60 Pujara slammed 19 hundreds and 35 half-centuries throughout his international career with a highest score of 206*.

Pujara is most remembered for India's Border-Gavaskar Trophy triumph in Australia in 2018 and 2020. He troubled Australia with his solid defence and technique.

The Indian red ball stalwart top-scored with 521 runs in four matches at an average of 74.42, three centuries and a fifty. His best score was 193.

In the 2020-21 series, he scored 271 runs from four matches at an average of 33.87, with three fifties and a best score of 77. In the final Test at The Gabba, he endured several body blows from Australian pacers on his body, making the win even more memo-

Apart from international cricket, Čheteshwar Pujara was a domestic legend with over 21301 runs from 278 first-class games. The latter slammed 66 tons and 81 half-centuries through his firstclass career.

Sourav Ganguly appointed head coach of Pretoria Capitals for SA20 2025-26 season

NEW DELHI: Former India captain Sourav Ganguly has been appointed as the head coach of the Pretoria Capitals ahead of the upcoming SA20 season, which kicks off on December 26. Ganguly replaces former England batter Jonathan Trott at the helm. marking his first-ever stint as a head coach in franchise cricket, as per ESPNcricinfo.

The Capitals will be hoping that Ganguly's appointment brings a change in fortune. After topping the group stage in the inaugural season of the SA20, the franchise fell short in the final against Sunrisers Eastern Cape. However, their performance has dipped in recent years, finishing fifth in both the 2023-24 and 2024-25 seasons, missing out on the playoffs on both occasions.

This new chapter adds another dimension to Ganguly's cricketing journey. While this is his first formal role as a head coach, the former Indian skipper brings plenty of leadership experience to the table. Between 2015 and 2019, he



served as the president of the Cricket Association of Bengal. After that, he became the mentor of the Delhi Capitals in the 2019 Indian Premier League (IPL) season. Soon after, Ganguly took over as the president of the Board of Control for Cricket in India (BCCI), a position he held until 2022.

Ganguly's move to the Pretoria Capitals also aligns with his role as Director of Cricket at JSW, the co-owners of both Delhi Capitals and Pretoria Capitals. His appointment signals JSW's intent to strengthen its SA20 project, and Ganguly will be deeply involved in shaping the team's future. The first big challenge for

Ganguly comes on September 9, when the SA20 player auction takes place. The Capitals are expected to make bold moves in the auction as they look to rebuild their squad under their new head

Australia's Connolly shatters 38-year-old record, while Mulder, South Africa hit new low in 3rd ODI

MACKAY: Wiaan Mulder and South Africa hit a new low while Australia's Cooper Connolly soared to new heights after the Baggy Greens ruthlessly pummelled the Proteas in the final ODI in Mackay on Sunday.

After allowing an unassailable 2-0 lead slip into South Africa's hands, Australia offered no clemency to the visitors at the Great Barrier Reef Arena. The purple patch that had evaded captain Mitchell Marsh and swashbuckler Travis Head returned in the third ODI. Australia fired all cylinders on its way to a daunting 431/2. Connolly ripped apart South Africa's batting order with his sizzling five-wicket haul. He cleaned up the middle order with his left-arm orthodox spinning

Just two days after turning 22, Connolly became the youngest to scythe a five-wicket haul for Australia, taking the record over from Craig McDermott, who scripted it at the age of 22 years 204 days against Pakistan in 1987. Connolly's magic with the ball left South Africa reeling and eventually surrendering a 276run defeat, their biggest loss margin in terms of runs. Connolly returned with figures of 5/22 in six



overs as Australia celebrated a consolation win. In the first innings, Marsh (100) and Head (142) were greeted by bright sunshine in Mackay after opting to bat. The plot of the series heavily favoured the team that batted first, and the explosive pair ensured that it remained intact.

The opening pair upped the ante to raise a 250-run opening stand, the fifth-highest in the format for Australia. Cameron Green joined the party, played his heart out and handsomely contributed

to the prevailing blitzkrieg.

He took a mere 47 balls to raise his bat and celebrate the

Australia in the format. Alex Carey flaunted his boundary-hitting muscle and contributed with a quick-fire 50* from 37 balls. With the top three firing centuries for fun, this was just the second such instance in the 50-over format, behind South Africa's rollicking effort against the West Indies in Johannesburg in 2015. While Australia implemented its destructive approach, Mulder emerged as the ideal target practice. Mulder, who made headlines for his decision not to pursue Brian Lara's elusive 400 against Zimbabwe last month, leaked
