Mamata congratulates **JU** for emerging as top state university and 9th nationally

MI News Service, Kolkata : West Bengal Chief Minister Mamata Banerjee on Thursday congratulated the teachers, students, researchers and officials of Jadavpur University, which topped the list of state universities and ranked ninth among varsities across all categories in the country. The India Rankings 2025 was released by the Ministry of Education under the National Institutional Ranking Framework (NIRF). The Chief minister said that JU was the only state varsity in the top 10 of the university list.

The Ministry of Education has released the much-awaited National Institutional Ranking Frame work (NIRF) 2025, marking its 10th edition. This year's rankings assessed institutions across 17 diverse categories, including engineering, management, medicine, law, pharmacy, research, and the newly added Sustainable Development Goals (SDGs) category, highlighting India's growing alignment with global academic benchmarks. Among the most closely followed lists, the State Public Universities category saw a major shift. Jadavpur University in Kolkata has emerged as the top-ranked state public university, climbing from the second spot in 2024 and overtaking Anna University, which slipped to second place. The category underscores the strength of state-funded institutions that have consistently contributed to accessible and quality education across India.NIRF evaluates institutions on five key paramteaching and learning, research and professional practice, graduation outcomes, outreach and inclusivity, and perception. For state universities, the rankings are particularly important as they highlight how regional institutions are competing nationally, offering affordable education while excelling in research and innovation. By showcasing academic excellence beyond central institutions. the NIRF state public university rankings strengthen the visibility of these universities, encouraging healthy competition, greater accountability, and

Union Education Minister Dharmendra Pradhan today released the Institutional Framework (NIRF) 2025, which annually lists the top-performing universities, colleges, and institutes in India. IIT-Madras has once again secured the top position as the best engineering college in India and continues to lead in the overall category. The NIRF 2025 engineering rankings highlight the dominance of the IITs, with 9 IITs, including IIT Roorkee, in the list. Southern institutions such as IIT Madras, IIT Hyderabad, and NIT Tiruchirappalli continue to strengthen their presence among India's best engineering colleges. The NIRF rankings are determined using weighted parameters that vary by category, but broadly cover teaching, learning and resources; research and professional

Bengal govt exploring legal options to appoint 'tainted' teachers to Group C, D posts, announces Mamata Banerjee

MI News Service, Kolkata: Rekindling the hopes of giving them back their lost government jobs, West Bengal Chief Minister Mamata Banerjee announced on Thursday that her government was exploring all legal options to appoint "tainted" teachers of the 2016 SSC exam to Group C and D posts. Speaking at a programme to observe Teachers' Day here, she also said the state government has initiated the recruitment process of "untainted" candidates of the 2016 school teacher recruitment test."I am consulting legal experts on options of appointing 'tainted' teachers to Group C and D posts. For those who have been teaching for years now, but have been marked 'ineligible', I am trying to seek a legal solution... Maybe, they could be recruited in Group C and D posts," the Chief minister said.

"We look at things not through a political prism, but from a human perspective," she said adding the state government was looking for

options to reinstate the "tainted" candidates in the cash-for-school jobs scam even if they cannot continue as teachers. "I am holding talks with lawyers to see if the tainted candidates cannot continue as teachers in the state-run schools, can be given employment in group-C and group-D categories, "she said. A week ago a Supreme Court division bench of Justice Sanjay Kumar and Justice Satish Kumar Sharma had instructed the state School Service Commission (SSC) to publish the names of the tainted candidates, who had allegedly paid money to secure jobs in government schools in teaching and nonteaching posts in the 2016 state-level selection test. The SC has also made it clear to the SSC and the state government that the tainted candidates will not be alowed to seek employment afresh.

In the wake of this critical situation Chief minister Mamata Banerjee rekindling hopes among these 'tainted' teachers has reiter-

ated that her government was looking for all legal and other options to reinstate the "tainted" candidates in the cash-for-school jobs scam even if they cannot continue as teachers. "These people have been teaching in schools for the last 10 years. We are trying to find a humane solution to the problem, since we don't handle these things politically," Mamata Banerjee told the assembled gathering of teachers from varsities, colleges and schools

She said the state government had already relaxed the age conditions for untainted teachers who are reappearing in the recruitment process. The chief minister said she had asked Chief Secretary Manoi Pant to seek legal opinion on the recruitment of group-C and group-D staff, who also lost their jobs by the

"Recruitment process of teachers is on. We still have around 21,000 vacancies. Whenever we try to fill the posts, someone or the

other goes to the court and get a stay order. Mamata Banerjee gives fiery speech against BJP in Bengal Assembly

MI News Service, Kolkata :The West Bengal Assembly witnessed pandemonium and high drama on Thursday as Chief Minister Mamata Banerjee came up with a blistering attack on the BJP, while a subsequent scuffle left the saffron party's chief whip injured.

Tensions erupted when Speaker Biman Banerjee called in marshals to evict BJP MLA and the party's chief whip, Sankar Ghosh, following his suspension.
BJP legislators stormed the well, chanting "Jai Shri Ram" slogans and stalling proceedings, even as the Trinamool Congress-led government sought to pass a motion condemning attacks on Bengali migrant workers in BJP-ruled states.

Amid the din, Chief minister Mamata Banerjee, who was present in House, rose to speak, accusing the BJP, Prime Minister Narendra Modi, and Union Home Minister Amit Shah of being "anti-Bengal" and blocking discussions on harassment of Bengalis. "BJP is a party of the corrupt, a party of vote thieves. They are the biggest dacoit party. We saw in Parliament how they used the CISF to harass our MPs," the Chief Minister said amid sloganeering and counter sloganeering and counter sto-ganeering by the opposition and the ruling party MLAs. Her attack grew sharper as she warned the Opposition benches. "Mark my words, a day will come when not a single BJP MLA will sit in this House. People will throw you out of power. The Modi and Amit Shah-led government at the Centre will colsoon," Mamata lapse Baneriee said.

Shankar Ghosh was suspended for the rest of the day for creating a ruckus inside the Legislative Assem-The suspension came after BJP MLAs began raising slogans as Chief Minister Mamata Banerjee was about to speak on the resolution. When Ghosh refused to leave, assembly marshals were called in, and he was dragged out of the House.

Chief Minister slammed the BJP legislators for their "unparliamentary conduct", accusing them of trying to disrupt a crucial debate on the rights and safety of Bengali migrant



workers. Responding to the chaos, Leader of Opposition in Bengal Assembly Suvendu Adhikari , who was also suspended from the House by the Speaker on Wednesday, alleged that.
"Today, in the West Bengal Assembly, democracy was murdered by Mamata and her servile administration,' Adhikari wrote in an X post in Bengali. In this brief four day session, the Trinamool Congress has tabled a motion under Rule 169, citing several recent incidents, including the alleged torture of a migrant worker in BJPruled states, to highlight the persecution faced by Bengalis" outside Bengal.

Meanwhile, Trinamool Congress MP Mahua Moitra on Thursday hailed the role of Chief Minister Mamata Banerjee as the Centre has decided to exempt individual life and health insurance from the GST. TMC MP mentioned that West Bengal CM had earlier written to Finance Minister Nirmala Sitharaman to exempt GST on life and health insurance. In a post on X, Mahua Moitra said, "Didi @MamataOfficial wrote to FM @nsitharaman on Aug 2, 2024, urging withdrawal of 18% GST on life & health innally done it, albeit to offset pain from friend Doland's 50% tariffs. @AIT-Cofficial continues to fight anti-people policies."

Earlier on Wednesday. the Union Government announced the complete removal of GST from individual health and life insurance. The decision was taken following the GST council meeting headed by Finance Minister Nirmala Sitharaman in New Delhi.

India-Singapore relations go far beyond diplomacy, says PM Modi

The prime minister said both sides decided that cooperation between the two countries in areas of artificial intelligence, quantum and other digital technologies will be enhanced. "We share common concerns regarding terrorism," PM Modi said in his statement to the media. "We believe that fighting against terrorism with unity is the duty of all countries which believe in humanity," he added. The Prime minister said the partnership between the two countries is rooted in shared values and it is guided by mutual interests and

GST reforms to provide huge relief to families, ease compliance for businesses

MI News Service, New Delhi : People in general, particularly those belonging to the middle income groups, have hailed the GST Council's last night's "forward-looking decisions" -- moving only to two rates of 5 per cent and 18 per cent from 22 September, simplifying refunds and MSME procedures, besides exempting individual life and health insurance from the indirect tax regime.

Industry bodies said the clarity will ease compliance, reduce litigation, and give businesses and consumers much-needed predictability. The GST Council on Wednesday night had approved a two-tier rate structure of only 5 and 18 per cent, which will be implemented from September 22.

The Goods and Services Tax (GST) Council, in its 56th meeting which lasted over 10 hours till Wednesday night, cleared the next-generation reforms under the eight-year old indirect tax regime. This effectively paves the way for a broad two-slab structure of 5 per cent and 18 per cent with a demerit rate of 40 per cent rate only for super luxury, sin and demerit goods. The lower tax burden on common people with sweeping rate cuts and reduction in GST slabs, ease blocked working capital, and facilitate ease of doing business with automated refunds and registration process.

Top Naga body in Manipur to enforce 'trade embargo' from Sep 8

MI News Service, Imphal: The apex body of Nagas in Manipur has announced that it will enforce a 'trade embargo' in all areas inhabited by the community in the land -locked North Eastern state from midnight of September 8 in protest against the scrapping of the Free Movement Regime (FMR) and fencing of the India-Myanmar border.

The 'trade embargo' would include preventing the plying of goods vehicles along the national highways in the Naga-inhabited districts of Senapati, Ukhrul, Chandel, Tamenglong, Kamjong and Noney in Manipur. Manipur depends on essential goods that are brought from other states, including Assam. NH-2 (Dimapur to Imphal) passes through Senapati district and is the most important national highway in the state. NH-37 (Silchar to Imphal) passes through Tamenglong and Noney. United Naga Council, in a statement issued on Thursday night, said, "As discussed and resolved in the presidential council meeting held on Au-

gust 11, we hereby an-

nounce that a trade embargo shall be enforced in all the Naga areas with effect from midnight of September 8, 2025, until further notification." It urged the Naga people to support the 'trade embargo'. "On the impending issue of unilateral abrogation of FMR and imposed border fencing, the Naga people have placed their sentiments and position loud and clear on record to the Government of India through official memorandum to the authorities followed by series of agitations, demonstrations, public rallies and number of memoranda and press statements to the government in a democratic approach with all civility, since January 19, 2024 to date," it said. "Yet, the indifferent attitude of the government demands stringent agitation to register our rigid stance against the scrapping of FMR & imposed border fencing," it added. Manipur shares a 398-km-long international border with Myanmar. Naga groups in the state have been opposing the scrapping of FMR and the ongoing border fencing work in the state.

Bengal braces for heavy rain, raising heat & humidity

Kolkata: The monsoon axis has once again aligned with a low-pressure system sweeping across eastern and central India, triggering intense rainfall activity across multiple states and issuing a stark warning for Bengal. Meteorologists confirm that the system, which crossed Odisha and Jharkhand on Wednesday, is now moving towards Chhattisgarh and will weaken into a depression within 24 hours before tracking further into Madhya Pradesh. Several districts of South remain under alert for light to moderate rainfall accompanied by thunderstorms through Thursday. The districts of North and South 24 Parganas, West Midnapore, Jhargram, Bankura, Purulia, West Burdwan and Birbhum are most at risk, with coastal belts bracing

for gusty winds reaching newed surge in heavy rain main partly cloudy, inter-30-40 kmph.

Son held as mother's half-burnt body dumped in river

MI News Service, Canning: A grim sequence of events in Canning has sparked outrage and suspicious after police intercepted the cremation of woman without valid documents and later recovered her half-burnt body from a riverbank. Her son has since been arrested a charges of foul play.

The deceased, identified as Sheetala Sardar (55), a resident of Baikunthapur village under Itkhola panchayat, reportedly died on Wednesday. Soon after, her son Arun Sardar and a group of villagers took her body to the Kaliganga crematorium for last rites. However, there was no death certificate issued by the local panchayat — a mandatory requirement for cremation. Alerted to the irregularity, police rushed to the spot. In a shocking twist, eyewitnesses allege that those present at the crematorium hurriedly abandoned the halfburnt body in the Piali river and fled before authorities could intervene. Police later retrieved the charred remains and transported them to Canning Sub-Divisional Hospital before sending them for post-mortem examination. Investigators confirmed that neither the family nor the son could produce proper documentation or convincingly explain the circumstances of Sheetala Devi's death.

The tragic death of Mukesh Mandal, a 30-year-old migrant labourer from Malda, has once again highlighted the precarious conditions faced by Bengali workers in other states. Mukesh, a resident of Paranpur village under Kshempur gram panchayat in Chanchal-II block, had gone to Bengaluru in search of work a few months ago. He had been missing for nearly two months, and last week, his decomposed body was discovered in a septic tank in

The news of his death reached his hometown on Wednesday, plunging the village into mourning. Maltipur MLA Abdur Rahim Bakshi visited the grieving employer for failing to communicate with them during Mukesh's disappearance. "This is unacceptable," he said, demanding accountability from the company and assurance for the family. Mukesh's parents allege that he faced harassment and neglect at his workplace. They claim the employer did not inform them about his disappearance and only learned of his death through police confirmation. The family is demanding a transparent investigation and compensation, accusing authorities of showing indifference to the plight of migrant workers. This incident comes amid rising concerns over the treatment of Bengali

ruipur-Canning Road near Chayani, where trader Shahabuddin Molla, accompanied by two associates, had halted for a meal at a roadside eatery. Moments later, two men targeted the black bag slung over his shoulder, sparking a violent confrontation.When Molla resisted, the assailants threatened that the bag contained a firearm. Within minutes, four more miscreants joined in, surrounding and thrashing the trader. His companions fled in panic, leaving him to face the gang of six alone. The attackers overpowered him, snatched the bag containing cash meant for purchasing paddy from farmers, and fled the scene. Eyewitnesses described the attack as sudden and terrifying. The trader was left severely injured, suffering blows across his body. He later lodged a formal complaint at Baruipur police station. Acting swiftly, police apprehended one of the accused late Wednesday night. A manhunt is underway to track down the remaining five culprits. The audacity of the daylight robbery has triggered widespread alarm among local traders, many of whom routinely carry large sums of cash for agricultural purchases. Authorities are facing mounting pressure to tighten security along the busy Baruipur-Canning corridor. Service, Jhargram: Jhargram was left reeling late Thursday night after a horrifying act of domestic violence inside a rented house, where a serving sub-inspector allegedly shot his parents dead before turning the weapon on himself. The officer, identified as Sub-Inspector Joydeep Chattopadhyay, was posted with the Jangalmahal Battalion in Jhargram. Police sources said Joydeep returned home from duty earlier than usual and, without warning, fired multiple rounds from his service revolver at his father and mother. He then attempted suicide by shooting himself.

The chilling sounds of gunfire jolted neighbors and the house owner, who rushed to the spot and discovered all three lying in pools of blood. Police were

immediately informed. The victims were shifted to Jhargram Hospital in a critical condition, but doctors confirmed that Joydeep's parents succumbed to their injuries soon after. Joydeep remains in a serious state under medical supervision. Investigators have confirmed the recovery of a suicide note from the house. Preliminary findings suggest Joydeep had been in prolonged mental distress, particularly over issues concerning his parents. "He was battling severe psychological turmoil," a senior police official said, adding that the note is being examined for more details. Neighbors described the family as reclusive. "They interacted with hardly anyone. The doors were always shut. His father was mute and never spoke.

Senior officers have taken charge of the investigation, and forensic teams have been deployed to reconstruct the sequence of events. The incident has once again cast a harsh spotlight on the mounting mental health crisis within the police force, where stress, isolation, and lack of systemic support often remain unaddressed until tragedy strikes. As Joydeep battles for his life, authorities are under pressure to not only establish the motive but also examine whether warning signs were missed-and whether stronger mental health safeguards for police personnel could have prevent-

ed this double tragedy.

signs of distress that might suggest such a drastic act. The sequence of events unfolded when the girl's elder sister returned home from tuition around dusk. She first noticed a handwritten letter on the table. Alarmed by its contents, she rushed upstairs, only to discover the horrifying sight of her younger sister hanging from a noose. Her cries alerted neighbours, who rushed in and informed the police. The letter's contents, though not officially disclosed, are now at the centre of the investigation. Police sources confirmed that the note may hold critical clues into the child's men-

ever, officers also stressed the need to verify handwriting and context before drawing conclusions. The body has been sent to Diamond Harbour Hospital for post-mortem examination. Police from Namkhana Police Station have initiated a case of unnatural death and are probing whether external pressure, neglect, or psychological distress triggered the tragedy. Local residents have expressed disbelief, with many insisting that a child of her age could not have taken such a decision without some form of external influence. "She was always lively, we saw her go to school every day.

her life?" one neighbour asked, reflecting the community's collective anguish. Child psychologists warn that the case underlines the growing vulnerability of children from broken or migrant households, where long-term parental absence can create emotional voids. The total expenditure under the scheme has amounted to ₹96.02 crore, Urban Development and Municipal Affairs Minister Firhad Hakim informed the state Assembly on Thurs-

Replying to a question from Trinamool Congress MLA Vivek Gupta, Hakim said that the state has no immediate plans to increase allocations for the scheme. He noted, however, that the state is awaiting dues from the Centre. "The central government owes us around ₹2 lakh crore. If the current government in Delhi falls and the next government clears our dues, we will consider increasing the Hakim said.

Under the Samabyathi scheme, families belonging to economically weaker and backward sections receive ₹2,000 from the state government to meet funeral expenses in the event of a death in the household. The assistance is provided only after submission of valid documents, including the identity proof of the deceased and the death certificate. The amount is given directly to the nearest kin of the deceased.

Considered one of the key welfare initiatives of the West Bengal government, the scheme aims to ensure that even the poorest families can perform the last rites of their loved ones with dignity. State Declares Heatwave a **Natural Disaster, Announces** 2 Lakh Compensation

MI News Service, Kolkata: In a landmark decision, the West Bengal government has officially included heatwaves in the list of natural disasters. This means that from now on, if anyone dies due to a heatwave or related conditions such as sunstroke, their families will receive ₹2 lakh as financial assistance from the state. According to sources at Nabanna, the decision was taken during a recent meeting of the State Executive Committee. Over the past few years, the state has witnessed several deaths during the summer months caused by extreme heat conditions. The recurring inciprompted government to take a policy decision on treating heatwave deaths at par with other natural calamities. In August, Chief Secretary Manoj Pant chaired a highlevel meeting to discuss the matter. It was at this meeting that the proposal to provide compensation for heatwaverelated deaths was finalised. The Department of Disaster Management and Civil Defence has since issued a formal notification outlining the decision. The notification clearly states that in cases of death caused by heatstroke or sunstroke, the victim's family will be eligible for compensation. However, it has also made post-mortem

examination reports mandatory to establish the cause of death. The compensation will be disbursed only after the verification process is completed. Until now, the state government provided ex-gratia assistance of ₹2 lakh for deaths caused by incidents such as lightning strikes, accidental fires, boat capsizes, falling trees, and collapsing walls. With the new notification, the state has expanded the list to cover 14 categories of incidents, which will now be officially recognised as natural disasters. Apart from heatwaves, these include riverbank erosion, heavy rainfall. wild animal attacks, electrocution, forest fires, and deaths caused by poisonous animal bites or attacks, among others.

Officials said the move reflects the government's recognition of the increasing risks posed by climate extreme change and weather conditions. By broadening the scope of disaster compensation, the state hopes to provide timely support to vulnerable families and strengthen disaster response mechanisms. The decision also places West Bengal among the few states in India to classify heatwaves as a natural disaster, marking an important step in disaster management policy.

Lalbazar Initiates Inquiry **Into Bhangar Convoy Mishap**

GST reforms to provide huge relief to families, ease compliance for businesses

"We thank and welcome the rectification of the GST inversion in the Man-Made Fibre (MMF) value chain by aligning MMF fibre and yarn at 5 per cent from 18 per cent and 12 per cent earlier respectively. "Reducing the tax on rooms up to Rs 7,500 to 5 per cent will make Indian hotels more affordable and attractive to both domestic and international travellers Incidentally, the GST Council has announced sweeping rate cuts for common-use items ranging from packaged and branded food items like fruit juices, butter, cheese, condensed milk, pasta, packaged coconut water, soya milk drinks, nuts, dates and sausages, and medical items including medical grade oxygen, gauze, bandages, diagnostic kits (5 per cent from 12 per cent) to nil GST rate for ultra-high temperature milk, chhena or paneer, pizza bread and khakra, plain

GST has also been reduced for white goods such as air conditioners, television sets, dishwashing machines to 18 per cent from 28 per cent. There is also going to be tax relief for motorcycles with engine capacity less than 350 cc and all automotive parts that will now be taxed at 18 per cent. Bigger cars will be taxed at 40 per cent. The GST rate on all electric vehicles will remain unchanged at 5 per cent. Another key decision was regarding the blanket exemption provided for life insurance, whether term or life, ULIP or endowment policies for individuals along with exemption for health insurance for individuals including family floater plans and policies for senior citizens. Beauty and physical well-being services used by common people such as services of gyms, salons, barbers and yoga centres will now face a lower GST of 5 per cent as against 18 per cent at present. With these reforms, the GST will now get rid of the multiplicity of slabs - 5 per cent, 12 per cent, 18 per cent and 28 per cent - with a broad two-slab structure – a merit rate of 5 per cent and a standard rate of 18 per cent – in addition to a special demerit rate of 40 per cent for super luxury, sin and demerit goods such as pan masala, tobacco and

"After that, we will have to question what was done for the last 11 years?... Today it seems that these 11 years were wasted. First of all, I will conduct a review next week regarding the work done in 11 years; we will have to take concrete steps to ensure that we do not face this situation after just two days of rain. Researchers use various technologies to characterize rare form of leukemia

TOKYO, JAPAN: Leukaemia is a popular term used to describe a type of blood cancer. However, leukaemia is classified into distinct categories based on the type of cell involved. Myeloid/natural killer (NK) cell precursor acute leukaemia (MNKPL) is a distinct form.

Because of its rarity, no consensus exists on the particular features required to clinically identify this condition. In a recent article published in Science Advances, researchers from Tokyo Medical and Dental University (TMDU) used a variety of methodologies to better characterise MNKPL's molecular profile and medication sensi-

tivity.
MNKPL was initially proposed as a leukaemia subtype in 1997.

Extramedullary involvement is one of the distinguishing features of MNKPL. It is common in Eastern Asian countries. Although the immunological characteristic of MNKPL has been studied earlier, a complete genetic characterisation of this cancer type has yet to be completed.

These details would contribute to better accurate diagnosis for patients, resulting in more suitable therapy recommendations. As a result, the TMDU group sought to examine MNKPL on a single-cell level.

"A single-cell exploration of MNKPL would not only help us better understand its clinical and genomic features, but also clarify the specific cellular origin of this disease," said Dr. Akira Nishimura, lead author of the study.

The team first used what is known as a multiomics approach to investigate MNKPL patient samples. They used various sequencing technologies to determine if there were any relevant mutations in specific genes, look for expression differences in certain signalling pathways at the RNA level, and examine any unique DNA methylation

"Our results demonstrate that MNKPL has molecular qualities that are distinct from other similar cancers, such as acute myeloid leukaemia. T-cell acute lymphoblastic leukaemia, and mixedphenotype acute leukaemia," explained Dr Masatoshi Takagi, senior author. "Specific hall-marks of MNKPL include activation of the NOTCH1 and RUNX3, as well as lower expression of the BCL11B.

Further work at the single-cell level in MNKPL cells showed that NK cells and myeloid cells come from a common progenitor cell type

The researchers also conducted in vitro drug sensitivity assays where they measured MNKPL cell responses to 79 individual anti-cancer drugs.

"We observed that MNKPL cells were highly

sensitive to a drug called L-asparaginase, which has already shown clinical effectiveness for this disease," said Dr. Nishimura. "Mechanistically, we found that this was from the low expression of asparagine synthetase, a quality that was distinct from other similar types of leukaemia."



Researchers give more insight into hip osteoarthritis among older adults with spinal deformity

ALPHEN AAN DEN RIJN [NETHERLANDS]: receiving surgery for adult spinal deformity (ASD) also have severe hip osteoarthritis (OA), which can lead to poor spinal alignment and physical functionality.

Findings of the study published in The Journal of Bone & Joint Surgery.

These differences persist even following operative treatment of ASD, according to the new research by Alan H. Daniels, MD and Bassel Diebo, MD of Brown University and colleagues from 20 North American spinal surgery centers. "Concomitant hip and spine disease are common, yet they remain challenging for joint arthroplasty and spine surgeons," the researchers write

Adult spinal deformity refers to various abnormalities of spinal curvature and alignment. As some of these deformities arise from wear and tear over time, they are likely to become more frequent in an aging population. For patients with ASD who do not improve with nonoperative treatment, spinal realignment surgery may be indicated Previous studies have reported high rates

of hip OA accompanying ASD. However, little is known about how OA affects patient characteristics and the outcomes of surgery for



ASD - in terms of both spinal alignment and patient-reported outcomes such as physical functioning and disability.

Drs. Daniels and Diebo and colleagues analyzed rates and outcomes of hip OA in 520 older adults who underwent surgery for ASD at one of 13 US and Canadian centers. About two-thirds of patients were women, and the average age was 59 years. Consistent with previous studies, 34% of patients were classified as having severe OA involving both hips.

The researchers compared the characteristics of ASD patients with and without severe hip OA, including key patient-reported outcome measures. Characteristics and outcomes were also compared at postoperative follow-up in 165 patients: 68 with severe bilateral hip OA, 32 with severe OA of one hip only, and 65 without severe OA in either hip.

On preoperative analysis, patients with severe bilateral hip OA were older (average age, 68 years) than those with unilateral (66 years) and or non-severe hip OA (60 years). Patients with severe hip OA also scored higher on a standard assessment of frailty.

At one-year follow-up, all three groups had similar correction of lordosis. However, patients with severe hip OA had worse spinal alignment, based on a radiographic measure called the sagittal vertebral axis (SVA). The difference in SVA was significant both preoperatively and at follow-up. Several patientreported outcomes were also found to be worse in patients with severe bilateral hip OA, who had lower scores for physical functioning both preoperatively and at follow-up. Although overall disability scores were not significantly different between groups, severe hip OA was associated with persistent reductions in activities such as walking, traveling, and climbing stairs. Frailty contributed to the differences in functional outcomes

Study finds how dietary changes can treat pulmonary hypertension

WASHINGTON: The lungs' blood arteries differ from those of the rest of the body. This distinction is obvious in pulmonary hypertension, in which only the lungs' blood arteries harden gradually, resulting in chronic lung disease, eart failure, and death.

The fundamental causes of this organ-specific channel stiffening remained unknown until University of Pittsburgh researcher Stephen Chan and colleagues uncovered an unexpected revelation regarding these blood vessel cells in pulmonary hypertension patients: they're hungry. Chan, Vitalant Chair in Vascular Medicine

and Professor of Medicine in the Division of Cardiology at the University of Pittsburgh, and his colleagues worked with Thomas Bertero's team at the Universite Cote d'Azur in France. They discovered that hypertensive pulmonary blood vessel cells have an insatiable desire for two amino acids.

The findings were published in the journal Cell Metabolism.

Amino acids are the building blocks of proteins, which help build cellular structures, carry out biological functions, and regulate tissue and organ function. As hypertensive pulmonary blood vessels metabolize gluta-



acids, called proline and glycine. Proline and glycine are the primary building blocks of collagen protein, which makes up 30 per cent of our body's total protein and provides a structural framework for our skin, muscles, bones mine and serine and the resulting elevated levels of proline and glycine in hypertensive pulmonary blood vessel cells drive the overproduction of collagen, which leads to vessel stiffening and impaired function--the hallmark feature of pulmonary hypertension.

Using rodent models for the disease, the researchers saw that drugs that limit cellular uptake of glutamine and serine deprived hypertensive pulmonary blood vessels of their craving. In turn, the lack of cellular glutamine and serine metabolism halted the excess production of collagen building blocks and collagen production. Knowing amino acids are most often absorbed through our diets, the team also discovered that reducing the dietary intake of glutamine- and serine-rich foods helped reduce collagen overproduction.

"For the first time, we have a dietary maneuver that may serve as an effective therapy for the disease," said Chan, who also directs the Vascular Medicine Institute and Center for Pulmonary Vascular Biology and Medicine at the University of Pittsburgh School of Medicine and UPMC.

Researchers find new mechanism of vestibular

[SOUTH KOREA] Researchers at Korea University's Anam Hospital have uncovered a new mechanism of vestibular neuritis.

Vestibular neuritis is one of the most common causes of acute dizziinflammation in the vestibular nerve and inner ear, which are important for balance and body motion sensa-


The findings of this study were published in the journal Neurology.

Various processes have been proposed as the cause of vestibular neuritis, such as reactivation of latent herpes virus or peripheral blood circulation disturbance in the inner ear, however, the specific reason has yet to be determined.

Prof. Lee and Park, working

together as a team (The Neurotology and Neuro-ophthalmology Laboratory of Korea University's Anam Hospital), have discovered a link between anti-GQ1b antibodies and vestibular neuri-

throughout the central nervous sys tem, including the human vestibular nerve and several cranial nerves, and anti-ganglioside antibodies are known to produce a variety of neurological symptoms by attacking ganglioside cells that exist between nerve cell membranes. GQ1b is mostly located in the cranial nerves that control ocular movement. Thus, when autoimmunity develops against those antigens, patients typically appear with double vision as a sign of 'anti-GQ1b antibody syndrome'. Based on



previous research, Prof. Lee discovered that the GQ1b antigen is also widely expressed in the vestibular nerve and cell body, providing

insights for the current study. The research team analyzed 105 had acute dizziness and visited Korea University's Anam Hospital from 2019 to 2023. 11 per cent of these patients were confirmed antiganglioside antibody positive.

Compared to those not having these antibodies, bilateral vestibular damage was observed in 33 per cent of the patients with those antibodies. The antibody converted negative along with the improvement of the functional deficits of the vestibular

The research team explained,

"The fact that autoimmunity plays a role in the development of acute dizziness, may help understand the mechanisms of other various vestibular disorders, too. We anticipate that this research may be a future springboard senting with acute vestibular syn-

Prof. Sun-Uk Lee, the leading author of this research said, "Acute dizziness causes great discomfort to patients and is also difficult to properly be diagnosed, depleting many resources for both patients and socie ty. We hope our research may help patients suffering from dizziness. As the association is confirmed clinically follow-up research will be conducted on how to incorporate these results into treatment."

Study finds new discovery of mechanism that controls cell division



UMEA [SWEDEN] : Scientists at Umea University in Sweden have shown that the movement of a unique protein complex known as the Mediator along DNA genes may affect the process of cell division. The finding might be significant for next studies on the management of particular illnesses.

We have gained in-depth knowledge of how cell division is controlled, which is important for understanding the causes of various diseases that are due to errors in cell division, such as vartumour diseases,"

Stefan Bjorklund, professor at the Department Medical Biochemistry and Biophysics at Umea University and lead author of the study. In each cell there is a machinery called the ribosome. It creates proteins using DNA as a template, which are essential for almost all cellular functions. But first, in a process known as transcription, the cells must make a copy of the instructions into mRNA. The research team at Umea University has discovered how the Mediator, a protein complex in the cell nucleus, can bind

to DNA and interact with another protein complex, Lsm1-7, to regulate the production of proteins that make up the ribosomes. The study shows that when cells grow too densely, cell division slows down. When this happens, the mediator moves to the end of the genes where it interacts with Lsm1-7. This has the dual effect of both slowing down the reading of the genes and interfering with the maturation of mRNA. This, in turn, leads to a reduced production of ribosomal proteins and thus a slower cell division

Combining anti-tumor medicine with chemo may boost children's cancer outcomes: Study

WASHINGTON: A recent study indicated that children who develop neuroblastomas, a rare type of cancer that starts in nerve cells, may benefit from getting particular anti-tumor medications in addition to chemotherapy.

The results of the BEACON trial conducted by the Cancer Research UK Clinical Trials Unit at the University of Birmingham found that combining anti-angiogenic drugs, which block tumours from forming blood vessels, alongside various chemotherapy drugs led to more young people seeing their tumours shrinking, from 18% in the control group to 26% among those on Bevacizumab. The findings are published in the Journal of Clinical Oncology today. The trial saw 160 young people aged 1-21, from 43 hospitals in 11 European countries, randomised with half receiving the anti-angiogenic drug called Bevacizumab on top of conventional therapy. The group who received Bevacizumab had an increase in the likelihood of responding to treatment, from 18% among those who only had the established therapy to 26% for those with the additional drug. who received Bevacizumab additionally had better one year progression-free survival rates. Supreme Court notice to NIA on Kashmiri separatist leader's plea for bail MI News Service, New Delhi: On September 4, During the Supreme Court

2025, the Supreme Court of India sought a response from the National Investigation Agency (NIA) regarding a plea by Kashmiri separatist leader Shabir Ahmed Shah, challenging a Delhi High Court order that denied him bail in a terror funding case.

The bench, comprising Justices Vikram Nath and Sandeep Mehta, issued a notice to the NIA but declined to grant Shah interim bail. The matter has been scheduled for a hearing in two weeks.

Shah, arrested by the NIA on June 4, 2019, is implicated in a 2017 case involving 12 individuals accused of conspiring to raise and collect funds to disrupt public order through activities like stone-pelting, damaging public property, and plotting to wage war against the Government of India.

The Delhi High Court, in its June 12, 2025, order, rejected Shah's bail application, citing the risk of him engaging in similar unlawful activities and potentially influenc- rights in such cases.

India & Russia talks for more S-400 deliveries

Moscow and New Delhi are negotiating increased deliveries of Russian S-400 surface-to-air missile systems to India, TASS news agency cited a senior Russian defence export official as saying. "India already has our S-400 system," TASS quoted Dmitry Shugayev, head of Russia's Federal Service for Military-Technical Cooperation, as saying.

"There is potential to expand our cooperation in this area as well. That means new deliveries. For now, we are in the negotiation stage." India signed a \$5.5 billion deal with Russia in 2018 for five S-400 Triumf longrange surface-to-air missile systems, which New Delhi says it needs to counter a

threat from China. But deliveries of the systems have been delayed



several times. Moscow is expected to deliver units of the final two S-400 systems to India in 2026 and 2027.

India's Narendra Modi told Vladimir Putin on Monday that India and Russia stood side by side even in difficult times after the Kremlin leader called the Indian prime minister his "dear friend" on the sidelines of the Shanghai Cooperation Organisation meeting in China.

Russian Foreign Minister Sergei Lavrov said in remarks published on Wednesday that India did not bow to the demands by the United States to stop purchasing resources from Russia and that Moscow "appreciated" that.

Speaking to reporters at the White House on Wednesday, Trump said he planned to talk to Putin in the coming days, but the Russian leader was aware of his administration's stance on the war.

"I have no message to President Putin. He knows where I stand, and he'll make a decision one way or the other," Trump said.

"Whatever his decision is, we'll either be happy about it or unhappy. And if we're unhappy about it, you'll see things happen."

Trump's comments came after Putin said earlier that he would be willing to meet his Ukrainian counterpart Volodymyr Zelenskyy in Moscow amid the US president's push for an agreement to end

"Donald asked me for such a meeting. I said: 'Yes, it's possible, let Zelenskyy come to Moscow," Putin said at the end of his visit to China, where he attended Beijing's commemorations of the 80th anniversary of Japan's defeat n World War II.

Hamas says ready for truce deal as Israel pounds Gaza City overnight



MI News Service, Gaza: On Wednesday, Israeli attacks across Gaza claimed at least 73 Palestinian lives, with 43 deaths reported in Gaza City alone, according to hospital sources cited by Al Jazeera. The assault continues to target the enclave's main urban center amid ongoing conflict.

Meanwhile, Hamas announced its agreement to establish an independent national administration for Gaza and expressed readiness for a comprehensive truce, which would involve releasing all Israeli captives.

However, Israeli Prime Minister Benjamin Netanyahu's office dismissed Hamas's statement, asserting that the

Escalating tensions further, Israel's far-right Finance Minister Bezalel Smotrich proposed a plan for Israel to annex nearly all of the occupied West Bank, urging Netanyahu's support.

Since the war began in October 2023, the toll has been devastating: at least 63,746 people have been killed and 161,245 wounded across Gaza. The conflict's origins trace back to the October 7 attacks, which resulted in 1,139 deaths in Israel, with approximately 200 individuals taken captive.

The situation remains volatile as diplomatic efforts and military actions persist, war could end immediately deepening the humanitarian if Hamas meets conditions crisis in the region.

USA HINDU GROUP seeks dismissal of Navarro

American Hindus Against Defamation (AHAD), a watchdog group operating under the larger organisation HinduPACT (Hindu Policy Research and Advocacy Collective), protested Navarro's remarks in an interview with Fox News earlier this week in which he said: "I would simply say this to Indian people to understand what is going racies," AHAD said.

Navarro, Trump's senior counsellor for trade and manufacturing, has been ranting against India's decision to continue buying Russian oil and thereby funding its war on Ukraine, even calling it "Modi's war".

Renaissance in TAJIKISTAN brings ban on BURQA & HIJAB

The winds of renaissance are flowing in central Asia, especially in Tajikistan and it has shaken the Islamic world and taken the non-Muslim nations by immense surprise. Tajikistan has officially banned 'Burqa' and 'Hijab'. Tajikistan is a nation with 90% Muslim population, and still it has created a silent revolution which hardly any non Muslim nation could even think of. It was a bold and brave step and the Tajik President is not at all repentant about it.

Tajikistan's President Emomali Rahmon has described the hijab as "foreign clothing" and taken steps to minimise the visibility of public religiosity. It is deeply linked to his politics and grip on power.

After years of unofficial curbs on religious clothing, the Tajikistan government has moved to formally ban the wearing of the hijab in the country.

The Bill was passed by the lower house of the Parliament (the Majlisi Namoyandagon), and was subsequently approved by the upper house (the Majlisi Milli). This move gives legal weight to the remarks made by President Emomali Rahmon, who has referred to the hijab as "foreign cloth-

NEW LAW ENACTED

It amends the existing law 'On Regulation of Holidays and Ceremonies' and forbids the "import, sale, promotion and wearing of clothing deemed foreign to the national culture". Central to these changes is the ban on the hijab, the head covering worn by Muslim women, as well as other garments associated with Islam.

WHY HIJAB IS DEEMED "ALIEN"? The hijab ban is the latest in a series of steps from President Rahmon, who heads a secular government, to promote what he has deemed "Tajiki" culture and minimise the visibility of public religiosity. It is deeply linked to his politics and grip on power.

Rahmon has served as the President of the Central Asian nation since 1994, with his 30-year rule marking one of the longest in the region. Early on in his career, he was positioned against more religious political parties.

He served as a people's deputy to the erstwhile Soviet Socialist Republic of Tajikistan, which was then a constituent state of the USSR. Following the collapse of the Soviet Union in 1991, the country witnessed a civil war between Soviet sympathisers (Rahmon was a part of this group) and ethnoreligious clans that constituted the United Tajik Opposition.

After widespread protests against the extent of poverty and lack of economic opportunities in the country, Rahmon emerged as the winner of the 1994 presidential elections. He heads the People's Democratic Party of Tajikistan, which has been in power since 1994.

Over the decades, he has instituted changes to the country's constitution to cement his authority. The most sweeping of these changes came in 2016 when the Constitution of Tajikistan was amended to remove the limit on the number of presidential terms. He has also banned faith-based political parties that could challenge his

Massoumeh Torfeh, a former spokesperson for the UN Mission of Observers in Tajikistan and journal-

ing religious restrictions: "The Tajik more women and men have donned Islamic-style dress. At the same time, Islamist armed groups have been active in the border areas of Tajikistan and Afghanistan."

However, some analysts argue that threats from radical Islam are overblown in many Central Asian countries. While there were increased public religious activities in the country, the idea that Islam was "revived" in the region only after the Soviet rule ended is not very accurate. Islamic practices formed a part of the local cultures and traditions even during Soviet control.

In another semifinal match taking place between South Zone and North Zone, Tamil Nadu stalwart Narayan Jagadeesan, selected as a back-up wicketkeeper-batter for India's recently-concluded tour to England, shined with an unbeaten century.

North Zone won the toss and put South to batting first. A 103stand between TanmayAgarwal (43 in 99 balls, with five fours) and Narayan kickstarted things off for South Zone. IPL tickets to be more expensive as Tax rates increase up to 40%



NEW DELHI: Watching the Indian Premier League (IPL) action live from a cricket stadium would be costlier, following the introduction of an increased Goods and Services Tax (GST) by the Centre on IPL tickets from 28 to 40 per cent

The final ticket prize for an IPL match, which has a base prize of Rs 1,000, will now be uptoRs 1,280-1,400, as per ESPNCricinfo. This raise puts the IPL in India's highest GST bracket, alongside casinos, race clubs, or any place featuring casinos or race clubs.

However, the people going to watch international matches seem to get some respite as the GST levied for these matches was the same as the IPL tickets, at 28 per cent, but this slab has been done away with. According to an official release, the changes in the tax rates as part of the GST reforms only talk about "sporting events like the IPL". Various finance and business publications have interpreted this to mean that international matches could fall under the other "recognised sporting events".

As of now, the "other recognised sporting events" attract 18 per cent GST for tickets priced above Rs 500, while the ones priced below are exempted from GST. So the tickets for international matches or state-run leagues could become cheaper in future.

Currently, if the base prize for an international match ticket is Rs 1,000, it costs Rs 1,280 after the inclusion of taxes. However, with the new change, the same price would decrease to Rs 1,180.

The changes will take effect from September 22 onwards, a week before the ICC Women's World Cup, hosted by India, begins. The tickets for the marquee women's cricket event have yet to go on sale. On August 30, a month before the tournament's beginning, the International Cricket Council (ICC) asked fans to "register your interest" to "ensure you are the first to receive the latest news and ticketing information straight to your inbox".

Talking about the upcoming matches, Harendra Singh, Chief Coach of the Indian Women's Hockey Team, said, "Our team has a good mix of youth and experienced players, and while we have had a few injury setbacks, I am still confident that the team will do well. The match against Thailand will help us test our strength and also give us a glimpse of what to work on before facing Japan the next day. The girls are confident and looking forward to the competition." India won the Women's Asia Cup twice, first in 2004 and again in 2017. In the last edition of the event, India had finished third in the tournament.

While Gulia, Jamwal, Lovlina have a bye in the opening round,

NikhatZareen will take on Jennifer Lozana of USA, as per a press release from Boxing Federation of India (BFI).

The 20-Indian contingent is focused on putting together a strong performance at the inaugural World Championships being held under the aegis of the World Boxing - a recently formed international governing body for boxing -- and their chances have definitely been boosted by the return of Nikhat, former world champion

Both Nikhat and Lovlina have not played any international event this year but were impressive in the domestic circuit and dominated the trials.
