'India needs better opposition for their criticism of GST': Nirmala Sitharaman

MI News Service, New Delhi : India deserves a better opposition and better opposition leaders, Finance Minister Nirmala Sitharaman said on Saturday, as she slammed their criticism of the Modi government on the GST reforms as "ill-informed" and untouched by facts leading up to the implementation of the unified indirect tax regime in 2017.

She was unsparing in her takedown of the Congress for blaming the BJPled NDA government for keeping four tax slabs when the GST was introduced and claiming vindication over the latest move to rationalise the structure by keeping only two slabs. It was not the BJP's decision nor the case that then-Union Finance Minister Arun Jaitley was deciding upon different tax slabs or what should be the GST rate for a particular item, Sitharaman said, adding Congress ministers, too, were part of it. "Are they (opposition) not aware of

Explaining the evolution of four GST rates in which opposition-ruled states played a crucial role as well in the run-up to its implementation in July 2017, Sitharaman said the country needs a campaign for a better Opposition and better opposition leaders on the lines of public movement against issues like tree-cutting. In a feisty response, she said she will have no qualm in tendering an apology if opposition leaders deal in facts and prove her wrong. "I have no ego. I will even apologise to people. But what they (opposition) are saying is nonsense." "The Congress has now stirred into action. If vou do not understand the issue, then the least you can do is keep quiet," she said, reminding the principal opposition party that it was an Empowered Committee of finance ministers from states that decided on keeping four slabs in the Goods and Services Tax before it was rolled out. It was this Committee that formulated what was to be implemented in the GST from 2017, she said. In deliberations stretching for years, including under the Congress-led UPA government, Left leader and then-West Bengal Finance Minister Asim Dasgupta was influ-



ential in driving consultations as head of the Em-Committee besides Finance ministers from other opposition-ruled states at different points of time, she noted. She said the Empowered Group had evaluated different levels of taxes on an item in different states, thrashed out an average and then agreed to keep that product in one of the four GST slabs nearest to the average.

In her seventh year as Finance Minister, spear-heading some of the government's major reforms aimed at giving relief to consumers, including the increase in income tax exemption to Rs 12 lakh in her last budget, and helping the industry, Sitharaman has often been at the receiving end of the Opposition's flak over economic issues. She launched a vigorous counterattack over its criticism of the government on the GST. "India deserves a better opposition. I strongly believe in it. India needs better opposition leaders. Such ill-informed commentary will do no good. These leaders are misleading the public and not serving the country. In fact, they are harming it," she said. Sitharaman was leader Jairam Ramesh's contention that Prime Minister Narendra Modi undermined the GST Council, a constitutional body that takes all decisions related to the indirect tax regime, with his announcement in his Independence Day speech of the upcoming rationalisation. PM Modi gave a message to the country about reforms as the country's Prime minister, she said and asked, "What is

'Dhol-tasha' rent the air as **Ganpati immersion processions** held amid rain in Mumbai

MI News Service, Mumbai : Beats of 'dhol-tasha' and clouds of 'gulal' filled the air as thousands of faithful devotees thronged the streets of Mumbai on Saturday, braving incessant rains, for immersion processions of Ganpati idols on Anant Chaturdashi, the last and final day of the 10-day festival. Both sides of roads were packed with people participating in the 'visarjan' (immersion) processions as beautifully decked idols of Lord Ganesh began

their final journey. Colourful 'rangolis' were drawn on roads where the processions are expected to pass, even as parts of the city witnessed light to moderate showers since morning. At Lalbaug in central Mumbai, famous for its iconic Ganpati mandals, the processions began with the immersion journeys of idols of Tejukaya, Ganesh Gully, and several other mandals. Majestic idols emerged from their pandals amid loud chants of "Ganpati Bappa Morya, Pudhchya Varshi Lavkar Ya". The procession of the famous Lalbaugcha Raja, which attracts huge crowds during the 10-day festival, had started late in the evening as final preparations were being made for the massive idol to make its final journey through Girgaon Chowpatty. Thousands gathered along the streets of Lalbaug and other major procession routes to bid farewell to the beloved deity, with prayers on their lips and to witness the vibrant spectacle filled with music, dance, and clouds of celebratory gulal. Huge crowds also gathered at Shroff Building in Lalaug, where the traditional "Pushpvrishti" (flower shower) is performed on Ganpati idols. Many had already lined both sides of the roads since morning, waiting patiently

'Fully reciprocate Trump's positive assessment of Indo-US ties': Modi

Modi's comments in a social media post came hours after Trump, amid current tensions between Washington and Delhi over tariffs and purchases of Russian oil, said the US and India have a special relationship and that he will always be friends with Prime minister Modi. "Deeply appreciate and fully reciprocate President Trump's sentiments and

Modi said adding that "India and the US have a very positive and forward-looking Comprehensive and Global Strategic Partnership". In Washington, Trump on Friday said, "I'll always be friends with (Narendra) Modi, he's a great Prime minister. He's great. I'll always be friends, but I just don't like what he's doing at this particular moment." "But India and the United States have a special relationship. There's nothing to worry about. We just have moments on occasion," he said in the Oval Office. Hours after

positive assessment of our ties," PM US President Donald Trump said that India and the US have a special relationship and "there is nothing to worry about", Prime Minister Narendra Modi on Saturday expressed appreciation and said that he "fully reciprocated" his sentiments and positive assessment of bilateral ties. This is Modi's first direct statement to the US President since Trump announced the imposition of 25 per cent tariff on Indian goods, and followed it a week later by announcing an additional 25 per cent tariff, totalling 50 per cent, over India purchasing Russian oil.

"I'll always be friends with (Narendra) Modi, he's a great Prime minister. He's great.But India and the United States have a special relationship. There's nothing to worry about. We just have moments on occasion," Trump added with a

The US president was responding to a question on whether he is ready to reset relations with India, as ties between the two countries continue to reel under possibly the worst diplomatic phase in over two decades. Hours later, on Saturday morning, PM Modi posted on X,

"Deeply appreciate and fully reciprocate President Trump's sentiments and positive assessment of our ties. India and the US have a very positive and forward-looking Comprehensive and Global Strate-



Tragic building collapse: Migrant worker and young daughter died

MI News Service, East Burdwan: In a devastating incident in Jaipur's Subhash Chowk, a building collapse claimed the lives of a father and his 5-year-old daughter, leaving the mother critinjured. deceased have been identified as Prabhat Bagdi (31) and his daughter, whose name has been withheld. The family, originally from Purbasthali in Purba Bardhaman, had been working as gold and silver craftsmen in Rajasthan for the past decade. "Had there been work locally, my son would not have had to go out," said the mother, Sumitra Bagdi, who sustained serious injuries in the collapse. The family's plight reflects a broader trend of migrant laborers from Bengal seeking livelihoods in other states due to inadequate local employment. Pur-basthali North MLA Tapan Chatterjee stated, "The lack of work opportunities under schemes like the 100-day employment program forces families to migrate. Today, hundreds of families from our village are working outside Bengal

Fresh Corruption Allegations Rock Gayeshpur Municipality

Dipankar Edbar, Kalyani (Nadia): Fresh allegations of corruption have surfaced against Gayeshpur Municipality chairman Sukanta Chatterjee, this time from within his own party. At least 10 Trinamool Congress councillors have accused him of bypassing due process and awarding roadwork contracts worth over ₹2.28 crore without tenders or board approval. The councillors alleged that the chairman neither convenes municipal meetings nor follows proper procedures. "Work orders are being ignored. Projects worth crores are being executed without tenders," a councillor said. This is not the first time Chatter-

jee has faced such charges. Earlier, he was accused of irregularities in projects worth over ₹4 crore. A noconfidence motion had also been brought against him by 11 Trinamool councillors a few months ago.Confronted with the fresh allegations, Chatterjee admitted to starting the roadwork but defended his decision. "The road was in a dilapidated condition and causing hardship to residents. Urgent repairs were necessary, so we engaged local contractors to start work immediately," he said. With the party yet to initiate action, the controversy has once again deepened the rift within the ruling board of Gayeshpur Municipality.

Class VII boy dies trying mobile magic trick

MI News Service, North 24 Parganas: A chilling incident has thrown the town of Bangaon into mourning after a Class VII student, reportedly influenced by videos of magic tricks on his mobile phone, died in a tragic mishap at home. The deceased, identified as Ripam Mandal (13), a resident of Kalupur area, was found hanging inside the bathroom of his house on Saturday morning. According to family sources, Ripam, described as a bright student with no history of depression or suicidal tendencies, had spent the morning fishing with his father before returning home. Moments later, he went into the bathroom to bathe but failed to come out. When his father, Debabrata Mandal, forced open the door, he discovered his son hanging. Ripam was rushed to Bangaon Hospital, where doctors declared him dead on arrival. He was good in studies. The thought of suicide never crossed his mind. He had been watching magic shows on his mobile and often tried to replicate small tricks at home. I believe he was attempting some towel trick when he accidentally got caught in the noose," his father said, struggling to hold back tears. The tragedy occurred barely a day after Teachers' Day, amplifying the grief among classmates, teachers, and

neighbors, who remember Ripam as cheerful and disciplined. Local residents gathered outside the Mandal household in disbelief. "He was a bright boy, full of life. None of us could imagine something like this," said one of Ripam's teachers. Police from Bangaon station have initiated an inquest and sent the body for post-mortem examination. Preliminary observations suggest accidental death, though investigators are not ruling out the influence of unsafe online content. The incident has sparked a wider debate on the dangers of unsupervised mobile usage among children. With increasing exposure to online content, experts warn that children often imitate risky stunts or socalled "magic tricks" withunderstanding consequences. potential Community leaders and educationists have urged parents to be more vigilant about children's screen time and the type of content they consume. "This is not an isolated case. Across the country, we are seeing children harmed while trying to replicate what they see on mobile screens. Awareness is urgently needed," a local child psychologist commented. As the Mandal family struggles with an irreparable loss, Bangaon finds itself asking an unsettling ques-— was the mobile phone the silent killer?

The initiative is being spearheaded by Cynosor's Tifoz unit, which has been operating on a 12-acre campus for the past two years, manufacturing BLDC fans. Woman's decomposed body found in locked flat

MI News Service, Hooghly: Panic gripped Baidyabati Municipality in Hooghly district after the decomposed body of a 29-year-old woman was recovered from her locked apartment on Friday evening. The deceased has been identified Deepshikha Goswami, an employee of a private firm who lived alone in Ward 19 of Baidyabati Municipality. According to police and local sources, Deepshikha had not been seen for the past several days. Suspicion arose after neighbors noticed a foul stench emanating from her flat. When repeated knocks on her door went unanswered, residents alerted Serampore

police. Officers broke open the door in the presence of her sister and discovered her body lying in the bathroom in a highly decomposed state. Police confirmed that the body has been sent to Serampore Walsh Hospital for postmortem examination to ascertain the exact cause of death. Preliminary estimates suggest she had died several days earlier. Ward councilor Paushali Bhattacharya, who rushed to the spot after being informed, said: "Deepshikha lived alone. Municipal health workers had visited her apartment earlier this week during a dengue survey, but there was no response at the time.

PM Modi's post came a day after Trump—in his first remarks on the huddle between PM Modi, Russian President Vladimir Putin and Chinese President Xi Jinping at the summit of the Shanghai Cooperation Organisation leaders in Tianjin last weekend—said on Friday that it "looks like we have lost India and Russia to deepest, darkest China". Trump's remark comes amid the strain in India-US ties over his imposition of 50 per cent tariff on India, and his own efforts to persuade Putin to end the war in Ukraine. Posting a photograph of Modi, Putin and Xi walking together, Trump took to Truth Social and had said, "Looks like we have lost India and Russia to deepest, darkest China. May they have a long and prosperous future together!".

Meanwhile, Prime Minister Modi has decided not to address the general debate at the annual high-level session of the United Nations General Assembly later this month, according to a revised provisional list of speakers issued in New York. External Affairs Minister S Jaishankar's name has been included in the list; he will address the session on September 27. In the White House, Trump also said that he is "very disappointed" that India would be buying "so much" oil from Russia.

Congress president Mallikarjun Kharge had said his party had been demanding simplification of the GST for several years and blamed the Modi government for burdening people with high tax rates for long.

SSC Recruitment Exams: SC Bars 'Tainted Candidates', Comm Announces Tight Security Measures

MI News Service, Kolkata: The School Service Commission (SSC) recruitment examinations are set to be held in West Bengal after nearly nine years, but the shadow of past irregularities continues to loom large. The Supreme Court has issued a clear directive that no "tainted or ineligible" candidates should be allowed to appear for the tests. The commission has already identified 1,806 such candidates, though questions reabout whether Sunday's examination will be completely free of malpractice. At a press briefing on Saturday, SSC Chairman Siddhartha Majumdar defended the commission's preparations and stressed that every possible safeguard has been put in place. He argued that all competitive examinations are provisional by nature, pointing out that even in universities, results are sometimes withheld when discrepancies are detected. Such instances, he said, should not be seen as undermining the overall process. The upcoming exams will be held in two phases, with the recruitment test for Classes IX and X scheduled for September 7 and for Classes XI and XII on September 14. Close to 5.65 lakh candidates are expected to appear across 636

and 478 centres in the second. To ensure order, candidates have been instructed to report to their centres by 10 a.m., well before the noon start time, to allow sufficient time for document verification. The last entry has been fixed at 11:45 a.m. Question papers will arrive at centres between 10 and 10:30 a.m., distributed shortly before noon, and opened only once the examination begins.

The commission has introduced bar-coded admit cards to check authenticity and has warned against any attempt to tamper with question papers. Candidates will be permitted to carry only transparent pens, clear water bottles, wristwatches, and valid photo identification. Mobile phones and smartwatches are barred for both candidates and staff, while observers will monitor proceedings at every centre. Provisions have also been made for differently-abled candidates, including scribes with minimum educational qualifications. With more than 26,000 teaching jobs already annulled by Supreme Court orders in connection with previous scams, the SSC faces tremendous pressure to restore public confi-

GST Reforms Bring Big Relief to Middle Class, Will Infuse New **Energy into the Economy: Union Minister Ashwini Vaishnaw**

MI News Service, New Delhi: In a major step on the financial front, the Central Government has introduced comprehensive reforms in the Goods and Services Tax (GST), providing significant relief to citizens, particularly middle-class families. Ŭnion Minister Ashwini Vaishnaw, in a press conference, said that under the leadership of Prime Minister Narendra Modi, this decision will not only reduce day-to-day expenses but also accelerate the country's economy.

explained Vaishnaw that earlier, reforms in income tax had provided exemption on income up to 12 lakh. Now, by reducing and simplifying GST rates, middle-class households will gain substantial benefits. He said that from basic essentials such as food, clothing, and housing to electronic products like televisions, refrigerators, mobile phones, power banks, and solar panels, the tax burden on almost every household item has been reduced.

Highlighting the broader impact, he stated that India's GDP is around 330 lakh crore, of which consumption accounts for 202 lakh crore. If GST relief leads to even a 10% rise in consumption, it could generate an additional 20 lakh crore in GDP. Increased production will drive employment growth and strengthen in-

The Union Minister emphasized that savings in the hands of middle-class families will increase. These savings will either go into deposits, high- economic growth.



er purchases, or investments. All three activities, he noted, will boost the economy and initiate a "positive cycle.

To ensure the message reaches rural and common consumers, the party and government will run a large-scale campaign through village gatherings, public meetings, and media outreach.

Speaking specifically on electronics manufacturing, Vaishnaw highlighted that in the past 11 years, production in this sector has grown sixfold and exports eightfold. Today, around 25 lakh people are employed in the industry, and India now manufactures everything from mobile phones to batteries and chips. Semiconductor and API (pharma) manufacturing has also begun in the country.

He assured that all industry associations have committed to passing on GST benefits directly to consumers. The Finance Minister has also made it clear that strict action will be taken against companies that fail to transfer these benefits.

Kolkata Man Arrested for

Cheating Using TMC MP's Name

MI News Service, New Delhi: A major tragedy was averted on Saturday afternoon when a multi-storey building collapsed in Delhi's Badarpur border area. Officials said there were no casualties or injuries as the structure was vacant at the time of the incident. The collapse, however, damaged several electric poles and led to a power outage in the area.

Sarvan Lal Meena, Station Officer at Jasola Fire Station, said that they received the call for the building collapse at 1:31

"The building was empty, and we received the call around 13:31. We rushed to the spot of the incident to witness that the middle part of the building had collapsed. Timely preventive measures save Larji power project from flood threats

Learning a lesson from the disaster of 2023, the state government successfully protected the Larji hydropower project this year from the challenges of heavy rains and floods. Under the directions of Chief Minister Thakur Sukhvinder Singh Sukhu and with the preparedness of the Himachal Pradesh State Electricity Board Limited (HPSEBL), the 126 MW project continued to operate smoothly, and the power house remained completely safe, according to the official statement.

Keeping in view the future challenges, the Board worked on a comprehensive safety plan, and preventive measures were adopted well in time, the most important being the installation of flood gates. The project site and the main entry point remained secure even during the floods in the Beas river due to the installation of gates. Moreover, the water seeping into the powerhouse was drained out immediately.

The Board management had already created field and tech-

MI News Service, Shimla: nical posts under the rationalisation of the Generation Wing in February 2025, which further strengthened the security arrangements of the Larji project. The project team effectively implemented the safety plan on site and succeeded in keeping the project safe even when silt deposits were formed during the flood on 26 August 2025, the statement read.

In 2023, the devastation had forced the complete shutdown of the Larji project for almost six months, causing a loss of nearly Rs.95 crore. An additional Rs. 185 crore had to be spent to make the project operational.

According to the statement, Chief Minister Thakur Sukhvinder Singh Sukhu has expressed satisfaction over the protective measures taken to safeguard the Larji project from floods. He directed that the special safety plan for the project should continue to be implemented effectively. He also congratulated the management, engineers and the entire team of employees who contributed to ensuring the safety of the project.

Breathing in sleep affects memory processes: Study

ow are memories formed when sleeping? Research led by Dr Thomas Schreiner, head of the Emmy Noether junior research group at LMU's Department of Psychology, demonstrated a direct relademonstrated a direct relationship between the emergence of certain sleep-related brain activity patterns and the reactivation of memory contents during sleep in 2021.

However, it was still unclear whether these rhythms were orchestrated by a central pacemaker. So the researchers joined up with scientists from the Max Planck Institute for Human Development in Berlin and the University of Oxford to reanalyze the data. Their results have identified respiration as a potential pacemaker. "That is to say, our breathing influences how memories are consolidated during sleep," says Schreiner. Learning processes investigated in the sleep laboratory For their original study, the researchers showed 20



study participants 120 images over the course of two sessions. All the pictures were associated with certain words. Then the participants slept for around two hours in the sleep laboratory. When they awoke, they were questioned about the associations they had learned. During the entire learning and sleep period, their brain activity was recorded by means of EEG, along with their breathing. The researchers discovered that previously learned contents were spontaneously reactivated by the sleeping brain during the presence of so-called slow oscillations and sleep spindles (short phases of increased brain activity). "The precision of the coupling of these sleep-related brain rhythms increases from childhood to adolescence and then declines again during ageing,' says Schreiner.

Breathing and brain activi-

Because respiration frequency also changes with age, the researchers then analyzed the data in relation to the recorded breathing and were able to establish a connection between them: "Our results show that our breathing and the emergence of characteristic slow oscillation and spindle patterns are linked," says Schreiner. "Although other studies had already established a connection between breathing and cognition during wake, our work makes clear that respiration is also important for memory processing during sleep.

Older people often suffer from sleep disorders, respiratory disorders, and declining memory function. Schreiner plans to further investigate whether there are connections between these phenomena and whether interventions - such as the use of CPAP masks, which are already used to treat sleep apnea make sense from a cognitive

Study finds how body reacts to high or low oxygen levels

I t only takes a few seconds of holding your breath to know that not obtaining adequate oxygen is detrimental to your health. Is it possible, however, to have too much? Indeed, breathing air that contains more oxygen than your body requires can lead to health problems or even death.

But with scant research on the topic, scientists have known little about how the body senses too much oxygen. Now, a new study from Gladstone Institutes has greatly expanded the scientific body of knowledge about the mechanisms at play, and why it matters for health.

Their findings, reported in the journal Science Advances, explain how breathing air with different levels of oxygen-from too little, to just right, or too much--affects the creation and degradation of different proteins in the lungs, heart, and brain of mice. Notably, the study also highlights a particular protein that may play a central role in regulating how cells respond to hyperoxia.

"These results have implications for many different dis-Gladstone savs Assistant Investigator Isha Jain, PhD, senior author of the new study. "More than 1 million people in the US breathe supplemental oxygen every day for medical reasons, and studies suggest it could be making things worse in some cases. That's just one setting where our work is starting to explain what's happening and

how the body responds."
Understanding Oxygen's Effects Most prior research on oxygen levels has examined the molecular effects of too little oxygen. And even in that realm, most of the focus has been on how low oxygen affects which genes are turned

"Our study enters uncharted territory by using mice and looking downstream of gene expression at which proteins abnormally accumulate or degrade in response to different oxygen concentrations.' says Kirsten Xuewen Chen. first author of the new paper and a graduate student at UC San Francisco.

The research builds on the team's prior work, which revealed that in response to too much oxygen, certain proteins containing iron and sulfur clusters become degraded. leading cells to malfunction.

"Now, we wanted to get a more dynamic picture of how proteins are regulated when oxygen levels are too high or

too low," Chen says. To do so, the team exposed mice for several weeks to air with oxygen level of 8 percent,

21 percent (the usual level we

efforts targeting HIF proteins in low-oxygen conditions. breathe in Earth's atmosphere). Meanwhile, they gave the mice food containing a distinct form of nitrogen that the animals' bodies incorporated into new proteins. This nitrogen isotope acted as a "label" that enabled the researchers to calculate protein turnover rates--the balance between protein synthesis and degradation--for thousands of different proteins in the lungs, heart, and brain.

"We're grateful to our collaborators who are the experts in this technique, known as stable isotope labeling of amino acids in mice," Jain says. "Without it, we could not have done this study

A Key Protein Builds Up The researchers found that oxygen levels more dramatically affected proteins in the lungs of mice than the heart or brain. They identified certain proteins with abnormal

turnover rates under high- or low-oxygen conditions.

One particular protein that conditions, MYBBP1A, piqued their attention. MYBBP1A is a transcription regulator, meaning it directly affects gene expression.

'This caught our eye because prior research has shown that other transcription factors called hypoxiainducible factors, or HIFs, play a big role in cells' response to low oxygen," Chen says. "Our work nominates MYBBP1A for a related role in hyperoxia sig-


MYBBP1A is involved in the production of ribosomes-cellular "machines" that build proteins. Further experiments surfaced clues that, in response to high oxygen levels, accumulation of this protein in the lungs may affect production of ribosomal RNA, key component of ribo-

First-of-Its-Kind Dataset The new study presents a first-of-its kind dataset of pro-

tein turnover rates in different tissues of mice exposed to different oxygen levels. The team hopes its results will inspire other researchers to further investigate the effects of too much or too little oxygen on the body, which could transform the way we treat disease.

Unsubstantiated conspiracy theories continue to attract people



Many people believe at least one conspiracy theory. And that isn't necessarily a bad thing conspiracies do

To take just one example, the CIA really did engage in illegal experiments in the 1950s to identify drugs and procedures that might produce confessions from captured spies

However, many conspiracy theories are not supported by evidence, yet still attract believers.

For example, in a previous study, we found about seven per cent of New Zealanders and Australians agreed with the theory that visible trails behind aircraft are chemtrails of chemical agents sprayed as part of a secret government program. That's despite the theory being roundly rejected by the scientific

The fact that conspiracy theories attract believers despite a lack of credible evidence remains a puzzle for researchers in psychology and other academic dis-

Indeed, there has been a great deal of research on conspiracy theories published in the past few years. We now know more about how many people believe them, as well as the psychological and political factors that correlate with that belief. But we know much less about how often people change their minds. Do they do so frequently, or do they to stick tenaciously to their beliefs, regardless of what evidence they come across? From 9/11 to COVID

We set out to answer this question using a longitudinal survey. We recruited 498 Australians and New Zealanders (using the Prolific website, which recruits people to take part in paid research). Each month from March to September 2021, we

presented our sample group with a survey, including ten conspiracy theories, and asked them how much they agreed with each one. All of these theories related to claims about events

that are either ongoing, or occurred this millennium: the September 11 attacks, the rollout of 5G telecom-

munications technology, and COVID-19, among others. While there were definitely some believers in our sample, most participants disagreed with each of the

The most popular theory was that pharmaceutical

companies (Big Pharma') have suppressed a cure for cancer to protect their profits. Some 18 per cent of the sample group agreed when first asked.

The least popular was the theory that COVID-19 vaccines' contain microchips to monitor and control people. Only two per cent agreed.

Conspiracy beliefs probably aren't increasing

Despite contemporary concerns about a pandemic of misinformation or infodemic, we found no evidence that individual beliefs in conspiracy theories increased on average over time.

This was despite our data collection happening during the tumultuous second year of the COVID-19 pandemic. Lockdowns were still happening occasionally in both Australia and New Zealand, and anti-government sentiment was building.

While we only tracked participants for six months. other studies over much longer time frames have also found little evidence that beliefs in conspiracy theories are increasing over time.

Finally, we found that beliefs (or non-beliefs) in conspiracy theories were stable but not completely fixed. For any given theory, the vast majority of participants were consistent sceptics not agreeing with the theory at any point. There were also some consistent believers who agreed at every point in the survey they responded to. For most theories, this was the secondlargest group. Yet for every conspiracy theory, there was also a small proportion of converts. They disagreed with the theory at the start of the study, but agreed with it by the end. There was also a small proportion of apostates who agreed with the theory at the start, but disagreed by the end.

Nevertheless, the percentages of converts and apostates tended to balance each other pretty closely, leaving the percentage of believers fairly stable over

Inside the rabbit hole'

This relative stability is interesting, because one criticism of conspiracy theories is that they may not be falsifiable: what seems like evidence against a conspiracy theory can just be written off by believers as part

of the cover up.
Yet people clearly do sometimes decide to reject conspiracy theories they previously believed.

AI creates proteins with high binding strengths

recent study published in Nature describes an AI-Adriven advancement in biotechnology with implications for medication discovery, disease diagnosis, and environmental monitoring.

Scientists at the Institute for Protein Design at the University of Washington School of Medicine employed software to design protein molecules with unusually high affinity and specificity to a number of complex indicators, including human hormones. Notably, the scientists obtained the strongest ever documented contact strength between a computergenerated biomolecule and its target.

Senior author David Baker, professor of biochemistry at UW Medicine, Howard Hughes Medical Institute investigator, and recipient of the 2023 Frontiers of Knowledge Award in Biology and Biomedicine, emphasized the potential impact: "The ability to generate novel proteins with such high binding affinity and specificity opens up a world of possibilities, from new disease treatments to advanced diagnostics." The team, led by Baker Lab members Susana Vazquez-Torres, Preetham Venkatesh, and Phil Leung, set out to create proteins that could bind to glucagon, neuropeptide Y, parathyroid hormone, and other helical peptide targets. Such molecules, crucial in biological systems, are especially difficult for drugs and diagnostic tools to recognize because they often lack stable molecular structures. Antibodies can be used to detect some of these medically relevant targets but are often costly


to produce and have limited shelf lives. There are many diseases that are difficult to treat today simply because it is so challenging to detect certain molecules in the body. As tools for diagnosis, designed proteins may offer a more costeffective alternative to antibodies," explained Venkatesh. The study introduces a novel protein design approach that uses advanced deep-learning methods. The researchers present a new way of using RFdiffusion, a generative model for creating new protein shapes, in conjunction with the sequence-design tool ProteinMPNN. Developed in the Baker Lab, these programs allow scientists to create functional proteins more efficiently.

Simple blood test to quickly recognize sarcoidosis developed

have developed a technique for quickly and cheaply identifying sarcoidosis, a chronic inflammatory illness characterized by the growth of microscopic lumps called granulomas in the lungs and other organs

The technique, which uses a simple blood test, may allow for the selective use of more intrusive diagnostic tests that are commonly employed to identify the disease. The results were reported in the American Journal of Respiratory and Critical Care Medicine.

"Currently, diagnosing sarcoidosis isn't a straightforward process and requires tissue removal and testing with additional screenings to rule out other diseases, such as tuberculosis or lung cancer," said James Kiley, Ph.D., director of the NIH's Division of Lung Diseases at the National Heart Lung, and Blood Institute (NHLBI).



"Using a blood test will help diagnose faster, particularly in those organs that are more challenging to biopsy and with less harm to the patient.'

Though the exact cause of sarcoidosis is unknown, researchers suspect it is an immune disorder triggered by a group of specific antigens, which are generally foreign substances that incite an immune response in the body. In the United States, an estimated 8-11 people per 100,000 are affected sarcoidosis each year, according to previous research.

To identify antigens and determine which might be linked to sarcoidosis, scientists collected lung fluid samples and blood cells from patients with pulmonary sarcoidosis and then extracted the genetic material.

Using a combination of molecular techniques, the researchers homed in on two newly described disease-specific antigen biomarkers that only

coidosis-positive patients. They next designed a highly

specific blood test, which only requires a small amount of blood, to determine if they could

detect coidosis. verify the test, researchers compared blood samples from 386 peowhich included patients with sarcoidosis, patients with tuberculosis, patients with lung cancer and healthy individuals.

The researchers confirmed that their test was able to differentiate patients who had sarcoidosis from those with other respiratory diseases.

Pro-Palestine activists face FIR in Kerala for unauthorized demonstration



Sevice, Pazhayangadi: In a concrackdown on pro-Palestine activism, Pazhayangadi Police filed an FIR against the Girls Islamic Organdistrict for raising pro-Paiestine slogans, flags, and banners during an unau-

thorized demonstration. The FIR targets GIO Kerala General Secretary Afra Shihab and 30 other members, charging them under Sections 189(2), 191(2), and 192 read with 190 of the Bharatiya Nyaya Sanhita for unlawful assembly, rioting, and liability for offenses by group members.

The suo-motu FIR alleges that on Friday, the group gathered at the ecologically sensitive Madayippara area with the intent to "commit an of-fense and disturb society"

From learning to leading: FIFA's workshop empowers young women administrators to move forward together

NEW DELHI [INDIA] : The FIFA Capacity Building Workshop for Administrators concluded in New Delhi as the participants addressed various avenues of empowering young women working in the realm of the beautiful game, as per the official website of All India Football Federation

President Kalyan Chaubey, who was present to address the gathering on the final day, expressed gratitude towards FIFA's continued support and underlined their significant involvement in Indian Football.

"Just a few months ago, we saw it in Kolkata with the Women's Coaches Development Programme. Now, with this workshop in Delhi for women administrators across the nation, the impact is already showing," Chaubey said, as quoted from the official website of AIFF.

Citing recent achievements of the national women's teams, he said, "From the senior women's team qualifying for the AFC Women's Asian Cup on merit, to the U20s reaching the AFC U20 Women's Asian Cup after 20 years, and the U17s winning the SAFF Championship crown last week, these aren't merely isolated victories. They reflect how the right guidance and capacity building are giving women's football in India the push it deserves.'

Chaubey's reminder of responsibility and recognition struck a chord with the youngest of the administrators present in the room. Still in their early twenties and barely out of classrooms, marking tiny footsteps into football's governance, they brimmed with fresh perspectives, energy and a readiness to forward the pitches laid down during the workshop.

Among them was Karnataka's 23-year-old Hemanshi Gour, for whom administration is but a continuation of her footballing journey. From playing in schoolyards without a coach to guiding state youth teams and managing the India U20s and U17s national teams, her path has never been linear, but always forward.

"Wherever you work, as a player, coach, or manager, you should feel satisfied at the end of the day," she reflected.

The workshop gave her an opportunity to merge her trajectory of diverse experiences.

"It gave me knowledge in every aspect, which I can take back to my teams," she noted. While the national team man-

ager's story is rooted in a lifetime with the game, Sai Divya Shree from Bengaluru, 22, a district footballer-turned social media intern, discovered her calling off the pitch during the pan-"I realised I wanted to explore

the off-field side of the game," she said. Today, she interns with the Roots FC media team, runs a podcast, and curates a women's football page, all steps that led her to the workshop in Delhi.

"For me, this workshop was about perspective," Sai said.

"It showed how different people contribute to women's football, and when it comes together, it feels like we're building something much larger than our-



selves," she added.

The same tinges of curiosity and determination were shared by the 22-year-old Ursha Mitra. Already working with Gokulam Kerala FC as a team manager, she is familiar with the doubts her age

There were times people didn't take me seriously because of my age," she admitted.

"But young administrators bring fresh perspectives. We are in tune with trends, we are creative and proactive. And as women, we can act as mediators in times of conflict, so we also bring stability," she noted.

Where Ursha draws strength from breaking age barriers, 22year-old Ridah Shaikh's journey, by contrast, has been shaped by a diverse sporting career. A former U16 side, played football and badminton, and now manages the Sesa FA team. "Administrators play a vital

role in helping players thrive," she explained. "When we take care of logis-

tics, facilities, welfare, and resources, players don't have to worry about off-field issues. That's how they grow," she added.

Together, the journeys of Hemanshi, Sai, Ursha, and Ridah represent the collective strength of a new wave of women administrators in football.

As the three-day workshop concluded, it brought with it a renewed commitment to strengthening the backbone of women's football in India. With FIFA's support and AIFF's vision, the focus now shifts from capacity building to implementation.

Shreyas handed India A captaincy for multi-day matches against Australia A; Rahul, Siraj to join squad for 2nd game



MUMBAI (MAHARASHTRA) : After being snubbed from India's 15-member squad for the Asia Cup, Shreyas Iyer has been handed the captaincy mantle of India A for the two multi-day matches against Australia A, with wicketkeeper Dhruv Jurel serving as his deputy.

Indian selectors and management faced widespread criticism from fans and former cricketers after Shrevas was excluded entirely and didn't even find a place in the travelling reserves. As it turns out. Shrevas will now lead India A in the two multiday fixtures against the touring Australia A, with both fixtures set to be played in Lucknow. The multi-day matches will be followed by three one-day games, scheduled to take place on September 30, October 03, and October 05, respectively, in Kanpur.

The series will kickstart from September 16, and the second multi-day match will commence on September 23. KL Rahul and Mohammed Siraj will be added to the squad for the 2nd multi-day match and will replace two players in the team after the first multi-day match. Notably, Siraj and Rahul didn't find a place in the South Zone squad for the ongoing Duleep Trophy, which raised a couple of

Jurel, who has been handed the vice-captaincy title, was set to lead Central Zone but was ruled out of the tournament, prompting Rajat Patidar to take up the leadership role. Tamil Nadu keeper N Jagadeesan, who was flown to London as an injury replacement for Rishabh Pant for the fifth Test against England, has impressed with his recent out-

ings.
On the second day of the first semi-final, the 29year-old spearheaded South Zone's batting attack against North Zone in the semi-final being played on Ground 1 of the BCCI's Centre of Excellence. He nullified the threat posed by Anshul Kamboj and the inform Auqib Nabi, but suffered an agonising fate.

Nishant Sandhu had him run out, forcing Jagadeesan to return to the dressing room on 197(352). He previously fell short of the mark during his first attempt when he was caught 17 short of a double ton in 2020.

Sai Sudharsan, who made his Test debut for India during the Anderson-Tendulkar Trophy, has been included in the 15-member list. Abhimanyu Easwaran, who was added to India's roster for the tour of England, returned without his maiden cap. He led East Zone in the Duleep Trophy but saw his side crash out of the tournament in the playoffs.

Devdutt Padikkal played a composed knock for South Zone in the semi-finals of the Duleep Trophy with a knock of 57(71). Nitish Kumar Reddy, who sustained an injury during the England tour and was ruled out of the remainder of the two Tests, has been thrown into the mix.

The pace bowling department comprises Prasidh Krishna, Gurnoor Brar and Khaleel Ahmed. Tanush Kotian will lead the spin department, along with Manay Suthar and Yash Thakur, Kotian impressed with his all-around skills, walloping 76(166) with the hat against West Zone in the ongoing semifinals. Meanwhile, Khaleel has struck twice for Central Zone in 15 overs.

Devajit Saikia believes India "fully prepared" for ICC Women's Cricket World Cup 2025 challenge



GUWAHATI (ASSAM): The Board of Control for Cricket in India (BCCI) secretary Devajit Saikia said on Saturday that the India Women's Cricket Team is "fully prepared" for the big challenges in the upcoming ICC Women's Cricket World Cup, scheduled to be held from September 30 to November 2

The Women in Blue will be playing the tournament opener against Sri Lanka in Bengaluru's M. Chinnaswamy Stadium. This would be the first match at this venue since Bengaluru stampeded

India will be hoping to go one step further at this year's tournament than they did in 2017, when they made it to their second Women's Cricket World Cup Final, missing out narrowly to England in a thrilling finish at Lord's.

Speaking on India's chances to lift the title, Saikia told ANI, "India is hosting the ICC Women's World

November 2 in India as well as in Sri Lanka. The Indian team has been doing extremely well. If you look at the last series in England also, in the white ball cricket, they have performed very well and defeating England in England is not an easy thing, but they have handsomely defeated England both in the T20 as well as ODI matches. So far, the Indian team has not won any ICC Women's Trophy. There is a big challenge for that this time around. The Indian team is fully prepared to take on this biggest challenge in the ICC World Cup.

Guwahati is set to host his maiden World Cup in the upcoming 2025 edition of the ICC Women's Cricket World Cup. Earlier on Thursday, the International Cricket Council (ICC) announced that renowned Indian singer Shreya Ghoshal will perform at the Grand Opening Ceremony in Guwahati. Ghoshal, who has also recorded the tournament's official anthem, "Bring it Home," will deliver a live performance that celebrates the energy, spirit, and unity of women's cricket on the global

Guwahati, for the first time, is hosting any World Cup matches. Prior to this, in 2023, when the Men's 50 overs ICC World Cup was held in India, Guwahati host ed four warm-up matches, but not the main matches. It was good that the warm-up matches held here were very successful. Three matches were held. One match was lost out. The infrastructure has developed much better now. The whole northeastern region, the only international venue is Guwahati. The people here are really eagerly waiting for this tournament. On 30th, I hope, with the opening game, northeastern India, as well as Guwahati, will be on the map. We will get a position in the world map so far as ICC tournaments are concerned," the BCCI secretary added. (ANI)
