Inaugurating the three day 16th Combined Commanders' Conference at the Eastern Command headquarters at Vijay Durg, formerly known as Fort Williams, here on Monday, the Prime minister hailed the Armed Forces for their success in Operation Sindoor and praised their role in nation building, anti-piracy besides ensuring safe return of Indian citizens from conflict zones, as well as providing Humanitarian Assistance and Disaster Relief (HADR) assistance to friendly countries whenever needed.. Speaking at the first major Armed Forces conference after Operation Sindoor earlier this year, the Prime Minister directed the Ministry of Defence to 'swiftly implement concrete steps to achieve greater jointness, at-manirbharta, and innovation to meet all future challenges and to prevail against any eventuality'

Later, the PM was briefed on the operational readiness of the forces in the context of the new normal created by Operation Sindoor and the future of warfare in the context of emerging technology and tactics. The Prime Minister also reviewed the reforms implemented in the last two years and the plan for the next

Dreaded Maoist carrying Rs 1 cr bounty on head among 3 red rebels killed

MI News Service , Ranchi: In a major success, a hardcore Maoist leader carrying a bounty of Rs 1 crore on his head, was killed along with two of his accomplices in a fierce gun battle with security forces in a deep jungle in Hazaribag district of Jharkhand on Monday morning, police said. The encounter took place inside the Pantitri forest under the Gorhar Police Station area early this morning at around 5 am, between the dreaded Sahdev Soren squad of the banned CPI (Maoist) and security forces, a senior officer said.

"After several hours of intense gun battle the bodies of Sahdev Soren, who was carrying a bounty of Rs 1 crore, and two other senior Maoist guerrillas have been recovered from the spot during the search operation," Jharkhand Police (operations) spokesperson Michael Raj said claiming that this was the Central Committee of the CPI (Maoists) "We had been looking for him for a long time". He also thanked the joint team of Cobra 209 and Hazaribagh police for their successful operation.

The second Maoist who was also gunned down in the encounter, has been identified as Raghunath Hembrom, a member of the Bihar-Jharkhand Special Area Committee (SAC), having a bounty of Rs 25 lakh on his head. The third Maoist eliminated in the encounter was Birsen Ganjhu alias Ramkhelawan, who was also a senior member of the regional committee of CPI (Maoists) and had a reward of Rs 10 lakh on his head. Police sources informed that the all three Maoists remained active in the border areas of Jharkhand and Bihar for a long time and were involved in carrying out several major violent incidents in the region. 

MI News Service, Kath-mandu : Nepal President Ramchandra Paudel on Monday administered the oath of office to three ministers inducted by newly appointed caretaker Prime Minister Sushila Karki into her cabinet.

Karki, 73, the Himalayan nation's first woman prime minister, assumed office on Sunday. She inducted Kulman Ghising, Rameshwor Khanal, and Om Prakash Aryal as ministers later in the day. The swearing-in ceremony of the three ministers took place at the President's Office, Sheetal Niwas, Maharjgunj, here.

Former Finance Secretary Khanal has been sworn in as Finance Minister, while former Nepal Electricity Au-

thority Managing Director Ghising has taken charge of three portfolios: energy, water resources and irrigation; physical infrastructure and transport; and urban development. Aryal, an advocate, has been sworn in as Minister for Home Affairs and for Law, Justice and Parliamentary Affairs. Soon after the swearing-in ceremony, they assumed their respective offices.

Former chief justice Karki was appointed as the Prime Minister at the recommendation of agitating 'Gen Z' group to head the caretaker government, which is mandated to conduct fresh elections on March 5, 2026. She took oath on September 12, ending days of political uncertainty after the abrupt

K P Sharma Oli, who with the help of the Army had fled to an undisclosed destination following widespread antigovernment protests spearheaded by 'Gen Z' group against a ban on social media and alleged corruption. Oli quit last Tuesday shortly after hundreds of agitators en-tered his office demanding his resignation. At least 72 people were killed in the nationwide protests with over 500 people suffering injuries. Housewife found with throat Slit inside emnty house Torchlight tiff turns fatal: Teen smashes youth's head slit inside empty house

MI News Service, Cooch Behar: A pall of horror has deceased on Dakshin Dhalpal in Tufanganj after the blood-soaked body of young housewife was discovered inside her home late evening. The 23-year-old woman,. Identified as Mangali Adhikari Layek, was found with throat slit, sparking panic and speculation in the locality.

According to police sources, Mangali had been alone at home while her husband, a daily-wage labourer, had gone out for work as usual. Suddenly, neighbors reported hearing a chilling scream from inside the house. When they forced open the door, they were confronted with a grisly scene- the woman laying in a pool of blood with fatal injuries inflicted by a sharp weapon. The Tufanganj police station, following which officers rushed to the spot. Tufabganj SDPO Manoj Kumar Kannedhara also arrived with a forensic team. The body was sent to Cooch Behar Medical College and Hospital for postmortem examination. Police have launched an investigation to ascertain whether the murder was the result of domestic discord, an act of revenge, or another motive. "The cause of death is clear, but the motive remains under probe. We are examining all possible angles," a senior police officer confirmed. The incident has revived grim memories of a similar



case in Kolkata's Narkeldanga area last month, where another young housewife was killed under suspicious circumstances, allegedly by her husband. In that case, police said the woman was targeted because she had given birth to two daughters. Local residents in Dakshin Dhalpal are reeling from the shock. "We still cannot believe such a brutal act could happen here. She was young and hardly spoke much," said a neighbour, refusing to be named. With the investigation at a preliminary stage, police have not ruled out the involvement of someone known to the victim. They are questioning family members and mapping her recent social interactions. As tension runs high, the gruesome killing of Mangali Adhikari has added to a growing string of mysterious housewife deaths in Bengal, leaving behind disturbing questions about women's safety behind closed doors.

Exam-Eve horror, student caught making bombs

MI News Service, Mursidabad: On the eve of his Higher Secondary examination, a teenager was caught in a shocking turn of events — allegedly making crude bombs inside a secret hideout in Murshidabad's Raninagar area. The illegal activity ended in disaster when one of the bombs exploded, leaving three youths injured and triggering panic across the locality.

The blast occurred late Sunday night at Nazrana Nabi intersection under Raninagar police station. Locals were jolted awake by a deafening explosion. Rushing to the spot, they found a young man writhing in pain with severe injuries, while two others had also sustained burns and shrapnel wounds. Police rushed the injured to Murshidabad Medical College and Hospital, where one youth remains in critical condition. According to investigators, the trio had been engaged in manufacturing crude bombs when one device went off prematurely. In a swift crackdown, Raninagar police arrested three persons, including the two injured youths. Officers confirmed that one of the arrested is a Higher Secondary examinee, scheduled to appear for his board exams this week. While police will produce two of the accused in court on Monday, the examinee has been granted temporary exemption to sit for the exam before being produced separately.

Stacks of cash found in teacher's house: Massive Gambling racket cracked

MI News Service, South Dinajpur: In a shocking revelation, police have arrested a school teacher for allegedly running a massive betting racket, recovering over ₹1.34 crore from his residence and inlaws' home in Balurghat. The accused, Apurba Sarkar, a science teacher at Nayabazar High School in Gangarampur and resident of Kayasthapara, was apprehended in Gangtok last Saturday. During police interrogation, Sarkar reportedly admitted that large sums of money were hidden at his in-laws'

house in Raghunathpur. On Sunday night, police recovered ₹1.17 crore from the bed and Thakur house of Apurba Sarkar's in-laws and an additional ₹17 lakh from his own house, bringing the total seized amount to ₹1.34 crore 97 thousand. Authorities said the cash was stacked in multiple locations due to the sheer volume, necessitating the use of a counting machine.

Apurba Sarkar, who had reportedly not attended school for the past 10–12 days, allegedly operated the betting business online. In connection with the case, the police also arrested Kunal Das (34) from Champatli, Gangarampur. Dakshin Dinaipur Superintendent Chinmoy

Mittal confirmed the arrests at a press conference on Monday and stated that 14 people have so far been apprehended in relation to the online gambling network in Gangarampur. Earlier, police had arrested individuals from Sarvamangala and Gangarampur for similar illegal activities. The Gangarampur police continue to investigate the operation of this large-scale betting racket, while all arrested individuals have been produced before the Subdistrict Court. Officials have vowed strict action against anyone involved in online gambling or illegal betting in the district.

Heavy rain threatens Durga Puja preparation

The Regional Meteorological Centre in Alipore has warned of heavy to very heavy rainfall across several districts in the next 2-3 hours, raising concerns for Durga Puja preparations already in full swing.

Dark clouds gathered over Kolkata on Sunday, triggering a yellow alert across the city. The Met office forecast intermittent showers accompanied by gusty winds at speeds of 30–40 kmph. The day's

maximum temperature is expected to hover around 31°C, while the minimum will remain near 26°C. Humidity levels are set to remain oppressive, with relative humidity ranging between 76–97 percent. Districts including Purulia, Bankura, Birbhum, West Burdwan and Murshidabad are likely to face heavy rain, while East and West Midnapore, Nadia, and both North and South 24 Parganas remain under yellow alert. North Bengal is bracing for the worst, with forecasts of heavy to very heavy rainfall in Darjeeling, Kalimpong, Jal-paiguri and Cooch Behar. The timing of the rains has

According to Parima, she was brought to the border by her uncle-in-law, Chand Sheikh, who had promised to escort her to her father's home in Bangladesh. However, after feeding her at a local hotel, the relative reportedly disappeared, leaving her and her children stranded at the border. Locals noticed her wandering helplessly and questioned her about the situation. Attempts to contact her husband and in-laws failed, as their phones were reportedly switched off. Parima alleged that she had been married to

ident, six years ago and had been living in Bangladesh with him. Nine months ago, she moved to Canning, India, with her husband but claimed that both her husband and in-laws subjected her to torture and pressure to return to Bangladesh. The woman remained at the border throughout the day, unable to proceed due to lack of valid travel documents. On Monday morning, Petrapole police detained Parima and took her into custody for questioning. She is scheduled to be presented before the Bangaon Subdistrict Court today. Authorities are investigating the circumstances that led to her being abandoned at the border and are examining her claims of domestic abuse. The incident has raised concerns about the safety of cross-border migrants and the exploitation faced by women and children at border points.

"I will try and do my best," he said. This is not Ganguly's first stint in charge of Bengal cricket. He earlier served as CAB president from 2015 to 2019 before moving on to head the BCCI from 2019 to 2022. More recently, he took over as head coach of Pretoria Capitals and was actively involved in the SA20 2026 auction last week. "The aim is to take Bengal cricket to a new height. Since I cannot bowl or bat anymore, my focus will be on strengthening the game here," Ganguly remarked. The newly elected panel includes SouravGanguly (President), NitishRanjan Dutta (Vice President), BabluKley Madan Mohan Ghosh (Joint Secretary), and Sanjay Das (Treasurer).

State Govt to Inaugurate Woodburn 2 Ward at SSKM Hospital

MI News Service, Kolkata: The state government is set to gift another advanced healthcare facility to the people, as Chief Minister Mamata Banerjee will inaugurate "Woodburn 2" at SSKM Hospital on Tuesday. Built at a cost of ₹66.63 crore, the new ward comprises 102 cabins and 8 suites, equipped with modern medical infrastructure including CCU units and operation facilities. The project draws inspiration from the notable success of the existing Woodburn Ward at PG Hospital, which has long been a benchmark for high-quality healthcare. Initially operated under a public-private partnership (PPP) model, Woodburn offered three types of cabins and was once reserved primarily for VIPs. Under Mamata Banerjee's leadership, however, access was opened to the general public, creating a new model of private-style healthcare services within a government hospital. Officials said that the new Woodburn 2 will adopt a consolidated charge system, unlike the older building where single, double, and suite cabins had different rates. The initiative aims to make specialized healthcare accessible to a broader section of society while maintaining affordability.

According to health administrators, many patients' families are forced to spend exorbitantly when consulting government doctors in private practice.



By providing private-style facilities within the public hospital system, Woodburn 2 is expected to significantly reduce treatment costs while ensuring quality service. Sources indicated that, along with the West Bengal Health Scheme, patients covered by four major sector health insurance providers will be able to avail cashless treatment at Woodburn 2. Any patient admitted through the SSKM outpatient or emergency department will have the option to request admission to this facility. The state government believes

that this expansion will address rising demand for private cabins in government hospitals, where patients are willing to pay extra for comfort and better facilities. Woodburn 2, therefore, is not just an infrastructural addition but a step towards transforming the healthcare model by blending public trust with private standards of care. With the inauguration scheduled for Tuesday, the new ward is expected to enhance SSKM's capacity, offering patients affordable yet high-quality treatment in a modern, patient-friendly

Kolkata Issues SOP for Rooftop Use After Park Street Fire

MI News Service, Kolkata: In the aftermath of the Park Street fire incident, the Kolkata Municipal Corporation (KMC) had ordered the closure of all rooftop restaurants in the city. With the festive season approaching, conditional permissions have now been granted for reopening, accompanied by a series of stringent regulations. On Friday, the Urban Development and Municipal Affairs Department released a Standard Operating Procedure (SOP) for the use of rooftops across all municipal areas of Bengal, including Kolkata.

According to the new guidelines, no fresh construction will be allowed on rooftops-whether residential or commercial. Mutation of rooftop ownership in any individual's name is strictly prohibited, as rooftops are to be treated as collective property

of all building residents. Locking rooftops or restricting residents' access will not be permitted. Any ongoing commercial activity without approval must be discontinued immediately, and unauthorized structures such as rooms or sheds will have to be demolished. Officials said the decision comes in response to the growing trend of using rooftops for restaurants, event spaces, sports turfs, and party venues, which not only posed fire hazards but also infringed upon residents' rights. The SOP aims to curb unsafe and uncontrolled use of rooftops. Commercial establishments already in operation will have to comply with KMC's strict conditions. These include keeping at least half the rooftop space vacant, installing CCTV cameras with access granted to police, and prohibiting the use of gas cylinders for cooking.

Justice Soumen Sen Appointed Acting Chief Justice of Cal HC

MI News Service, Kolkata: The Calcutta High Court witnessed a change in its leadership as Chief Justice TS Sivagnanam retired from service on Monday. Following his retirement, senior-most judge of the Calcutta High Court, Justice Soumen Sen, has been appointed as the Acting Chief Justice. The Union Ministry of Law and Justice issued an official notification on Monday confirming the appointment. Justice Sivagnanam, who demitted office after his final working day at the High Court, had been serving as Chief Justice with distinction. With his retirement, the administrative responsibilities of the High Court now rest with Justice Soumen Sen, who joined the Calcutta High Court as a judge on April 13, 2011. His tenure as a judge is due to continue until July 26, 2027. Over the years, Justice Sen has delivered several important verdicts and played a key role in the High Court's judicial proceedings. However, he also made headlines in the past due to his conflict with former judge AbhijitGangopadhyay. The flashpoint came during the hearing of the medical college admission case, where Justice Gangopadhyay had ordered a CBI investigation. A division bench headed by Justice Sen set aside that order, only for Justice Gangopadhyay to later reissue it citing "errors." The legal tussle became so complex that the Supreme Court was compelled to intervene and eventually transferred the case out of the Calcutta High Court.

Meanwhile, another development suggests that Justice Sen's tenure as Acting Chief Justice may be short-lived. Last Friday, the Supreme Court Collegium recommended his elevation as Chief Justice of the Meghalaya High Court.

Kolkata Police to Enforce Traffic Restrictions During Durga Puja

MI News Service, Kolkata: Kolkata Police will impose strict traffic regulations during the upcoming Durga Puja to ensure smooth movement and safety amid large festive gatherings. Ac-cording to police sources, heavy goods vehicles will face restrictions from Mahalaya (September 21), while general traffic control will begin from Tritiya. Several roads will also be made one-way to manage congestion during peak hours. Under the new directive, goods vehicles, which usually enter the city between 10 pm and 6 am, will now only be allowed between 10 pm and 3 am after Mahalaya. This measure is aimed at reducing congestion during the festive season. However, vehicles carrying essential services such as oxygen, fuel, medical supplies, vegetables, fish, milk, CNG, and petroleum products will be exempted from these restrictions. Kolkata Police had earlier shared details of the planned traffic diversions

From Dashami to the morning of Chaturdashi, the movement of heavy goods vehicles will remain restricted to facilitate smooth immersion processions across the city. During the Puja days, several major roads will remain closed to vehicular traffic for specific hours to allow safe pedestrian movement around pandals and highfootfall areas. Police officials said that the restrictions are essential to avoid traffic chaos and ensure the safety of visitors and residents during the city's biggest festival. The special traffic plan, which will remain effective throughout the Puja days, is designed to balance the movement of essential supplies while managing the unprecedented crowd pressure Kolkata experiences during Durga Puja.

Major Accident on Maa Flyover, Four Vehicles Involved

MI News Service, Kolkata: A major accident occurred on the Maa Flyover on Monday, involving four vehicles in a chain collision. According to preliminary reports, a speeding car rammed into three vehicles in succession, causing significant damage. Fortunately, no fatalities have been reported so far. Police have rescued the damaged vehicles and are investigating the exact cause of the crash. The accident took place near the divider on the Park Circusbound flank of the flyover, close to the Science City crossing. Eyewitnesses said one car was moving at a speed far above the permissible limit, estimated at nearly 80 kmph. During peak traffic hours on the busy flyover, the vehicle failed to slow down in time when the car ahead applied brakes, resulting in a multiple-vehicle collision. The Impact left four cars severely mangled, with at least three badly damaged. Several passengers sustained minor injuries, though police confirmed that no one was critically hurt. The driver of the offending vehicle has been detained for questioning. The accident also led to temporary congestion on the flyover, adding to commuters' woes.

Gold prices ease in future trade as traders await Fed **policy decision**



NEW DELHI: Gold prices fell Rs 148 to Rs 1,09,222 per 10 grams in the domestic futures market on Monday, mirroring a weak global trend as market participants stayed cautious ahead

On the Multi Commodity Exchange (MCX), the most-traded October futures fell Rs 148 or 0.14 per cent to Rs 1,09,222 per 10 grams in a turnover of 15,852 lots. The December contract also moved lower, shedding Rs 111 or 0.10 per cent to Rs 1,10,323 per 10 grams in 5,656 lots.

Gold hovered around Rs 1,09,000 per 10 grams, as investors awaited a crucial US Federal Reserve (Fed) policy decision meeting later this week.

Traders are pricing in a 25 basis points reduction at the Fed's upcoming meeting amid signs of labour market weakness, with some expecting that easing could extend into next year, said Jigar Trivedi, Senior Research Analyst at Reliance Securities. Silver, however, traded higher. The December contract rose Rs 121 or 0.09 per cent to Rs 1,28,959 per kilogram in 18,528 lots, while the March next year delivery edged up Rs 41 or 0.03 per cent to Rs 1,30,311 per kilogram in 1,072 lots.

In the global markets, Comex gold futures for December delivery dipped by 0.10 per cent to USD 3,682.72 per ounce. Silver futures for December delivery also depreciated by 0.25 per cent to USD 42.72 per ounce. Trivedi added that ahead of the Fed's announcement, investors will monitor key macroeconomic indicators such as US retail sales and industrial production, which could provide further clues on the strength of the American economy and the scope for additional interest rate cuts." Meanwhile, the US administration on Sunday renewed its request to a federal appeals court to fire Fed Governor Lisa Cook, raising concerns about the central bank's independence. At the same time, the US-China negotiations underway in

Madrid since Sunday are being watched closely," he said. Market participants expect gold to remain range-bound in the near term as traders prefer to wait for the Fed's signals before taking fresh positions, Trivedi added.

Recycling rare earth metals, a key avenue to reduce global supply gaps: McKinsey

tric vehicles and renewable energy surges for green transition, rare earth elements (REEs) have become indispensable even as they are scarce. A recent McKinsey report warned that global supply of REE magnets, vital for e-motors and wind turbines, could fall 30 percent short of demand by 2035.

Circular solutions such as recycling and recovery of scrap rare earth materials can be scaled up to ramp up the availability of such inputs for the industry, McKinsey report suggested.

"Demand for rare earth elements needed for magnets will likely surge over the next ten years. Postconsumer scrap could unlock additional supply, although recovery remains a challenge," the McKinsey report read.

Rare earth elements comprise 17 elements, four of which are most commonly used in magnets: neodymium (Nd), praseodymium (Pr), dysprosium (Dy), and terbium (Tb). The first two are primary constituents, and the latter two are additives to enhance performance in more demanding applications.

According to the global manage ment consulting firm, global demand for these materials is set to triple from 59 kilotons in 2022 to 176 kilotons in 2035, driven largely by battery electric vehicle (BEV) adoption and wind energy expan-

Yet supply is heavily concentrat-

In 2023, China accounted for over 60 percent of mined REEs and more than 80 percent of refined



Recent Chinese export restrictions on specific medium and heavy REEs highlight the vulnerability of global supply chains.

"With an expected surge in demand for REEs in the next decade facing a mined and refined supply that is highly concentrated

in China, global and local supply chains will need to navigate significant geopolitical developments, such as China's recent export restrictions on specific medium and heavy REEs1 and unique sustainability challenges. In addition, the recent rise of REEs to the top of resilience agendas in many coun-

tries is expected to accelerate these trends, creating new opportunities for circular REE magnet value chains by resolving current recovery challenges," the McKinsey report noted.

Even with new mining and processing projects under way in other regions, McKinsey projects that

available primary supply could lag demand by around 60 kilotons by

Circularity, the report suggests offers a promising path to bridge the gap. By 2035, the REE value chain could generate about 40 kilotons of pre-consumer scrap during magnet manufacturing and another 41 kilotons of postconsumer scrap as products reach end of life.

Currently, most REE magnets embedded in appliances, electronics, or vehicles are lost during recycling, ending up in smelters where their value is destroyed.

"REE magnets are a challenge for today's recycling ecosystems; devices are partially dismantled shredded, and then sorted based on their magnetic properties, among other things. As a result, REE magnets may end up in an iron smelter, where they would be lost as slag, it further read.

Manual dismantling is laborintensive and often uneconomical, especially for smaller magnets in consumer devices

Promising alternatives include robotic disassembly, hydrogenbased processing, and bulk metallurgical methods, but most remain at pilot or early development

Enabling better recovery of REEs will likely require new approaches," the report said.

Today, more than 80 percent of recoverable REE magnets come from consumer electronics and appliances. If recovery systems are place, this transition could unlock significant secondary supply, the report suggested.

This simple diet could help protect memory, even with Alzheimer's genes: Study

WASHINGTON: A new study led by investigators from Mass General Brigham, Harvard T.H. Chan School of Public Health, and the Broad Institute of MIT and Harvard suggests that a Mediterranean-style diet may help reduce dementia risk

The study, published in Nature Medicine, found that people at the highest genetic risk for Alzheimer's disease benefited more from following a Mediterranean-style diet, showing a greater reduction in dementia risk compared to those at lower genetic risk.

"One reason we wanted to study the Mediterranean diet is because it is the only dietary pattern that has been causally linked to cognitive benefits in a randomized trial," said study first author Yuxi Liu, PhD, a research fellow in the Department of Medicine at Brigham and Women's Hospital, a founding member of the Mass General Brigham healthcare system, and a postdoctoral fellow at the Harvard Chan School and Broad. "We wanted to see whether this benefit might be different in people with varying genetic backgrounds, and to examine the role of blood metabolites, the small molecules that reflect how the body processes food and carries out normal functions.

Over the last few decades, researchers have learned more about the genetic and metabolic basis of Alzheimer's disease and related dementias. These are among the most common causes of cognitive decline in older adults. Alzheimer's disease is known to have a strong genetic component, with heritability estimated at up to 80%

One gene in particular, apolipoprotein E (APOE), has emerged as the strongest genetic risk factor for sporadic Alzheimer's disease -- the more common type develops later in life and is not directly inherited in a predictable pattern. People who carry one copy of the APOE4 variant have a 3-to-4-fold higher risk of developing Alzheimer's. People with two copies of the APOE4 variant (called APOE4 homozygous) have a 12fold higher risk of Alzheimer's than those without.

with precision. Throughout the halls and grounds of the almost 1,000-yearold castle west of London, hundreds of people are working to make sure King Charles III puts on the best show possible when he welcomes US President Donald Trump for his historic second state visit this week.

The visit, featuring glittering tiaras, brass bands and a sumptuous banquet served on 200-yearold silver, is a display of the pomp and ceremony that Britain does like no one else

But it's a spectacle with a purpose: to bolster ties with one of the world's most powerful men at a

time when his America First policies are roiling longstanding trade and security relationships. 'We're buttering up to him,"

said Robert Lacey, a royal historian and consultant on the Netflix series "The Crown.

"He wouldn't come to Britain if he wouldn't have the chance to stay at Windsor Castle, probably pay homage to the (late) queen he admires so much, and to meet the

king."
Soft power in action: Three centuries after Britain's kings and queens gave up political power and settled for the role of ceremonial head of state, the royals remain a robust instrument of "soft power," which the elected government uses to reward friends and wring concessions out of reluctant allies

State visits are the monarchy's ultimate tool, with world leaders vying to get the full royal

treatment. During seven decades on the throne, the late Queen Elizabeth II hosted everyone from Romanian dictator Nicolae Ceausescu to South African President Nelson Mandela.The rovals have also hosted the last four US presidents, though not all were full-scale state visits.

Hospitality with purpose : While the impact of soft power is hard to quantify, it contributes to a feeling of friendship that "may incline another party to be more open to your entreaties," said Martin Farr, an expert in modern British history at Newcastle University.

Six years ago, Britain sought Trump's support as it prepared to leave the European Union. This time the UK is lobbying for favourable trade terms and help in combating Russian aggression in Ukraine.

"A new Trump presidency, a

new prime minister, a different government, but the same sense of panic and the same feeling that the biggest lever we can pull with this president is to flatter him and to try and connect him with something he seems genuinely to be impressed by, which is monarchy, and the fact that his mother of course was born" in Scotland. Farr said. So Prime Minister Keir Starmer hurried to Washington in February, just five weeks after Trump began his second term, and handed him the king's invitation for a state visit

It was the first time any world leader received the honour of a second state visit, and the first time the invitation was delivered in a personal letter from the king, which Trump proudly displayed for TV cameras."It's a great, great honour, and that says at Windsor, Trump said as he praised the king. "That's really something.

Pomp and circumstance: There will be plenty of glitz for a president who has gilded the Oval Office and plans to build a White House ballroom for 650 guests.

While the president and first lady Melania Trump will arrive in the UK late Tuesday, the meat of the visit begins the next day. After welcoming the Trumps, Charles and Queen Camilla will accompany them on a carriage ride through the Windsor estate, then back to the castle along a path lined by members of the armed forces. Inside the crenellated walls of the castle, which William the Conqueror started building in 1070, a military band will play the national anthems of both countries before Charles and Trump review the guard of honour in scarlet tunics and tall bearskin hats. Hundreds of military personnel will take part in the ceremonies - mounted troops, foot

guards and musicians - after months of rehearsals. When rifles are shouldered, it will come with a single thwack. When boots hit the ground, they will do so in unison. "God Save the King" and "The Star-Spangled Banner" will be note-perfect

Highlighting history :After the welcoming ceremonies, Trumps will view an exhibit of documents and artwork put together to highlight the shared history of Britain and the US.

The palace hasn't said what will be included, but the options are myriad for two countries with common legal and democratic traditions that stretch back to Magna Carta, the historic charter of rights signed in 1215 at Runnymede, just a few miles from Windsor. But the centrepiece of the visit will be Wednesday night's state banquet, where the men will don white ties and tail coats and

the women will wear designer gowns and jewels that will sparkle in the flickering light from antique candelabra. "The tiaras will be out in force," said Hugo Vickers, a royal historian and author of "Alice," a biography of the late Prince Philip's mother. "It will all look very splendid.'

Dinner for many: The king and queen will join their guests around the massive Waterloo Table, which is about half the length of a football field and has space for 160 guests. It takes five full days to set the table, which will be laid with the Grand Service, a silver-gilt dining service that includes more than 4,000 pieces ranging from serving dishes to dinner plates and egg cups.

Vickers said the silver and ceremonies pave the way for conciliation, which Elizabeth believed was the way to solve even intractable problems.

level crossings or breaking the gate booms by the impatient road vehicle drivers is often observed at different places. These incidents of road traffic jam or damaging the gate barrier due to irresponsible behaviour of the road vehicle drivers not only affects punctuality of train movement but also creates unnecessary traffic jam on the road, delaying road vehi-

It has been observed that, in level crossing gates over Sealdah Division, there is a tendency of the approaching road vehicles to hinder the closing of level crossing gates by resisting the gatemen somehow while the onduty gateman is trying to lower the gate boom. Even small vehicles and pedestrians forcibly enter the level crossing gates in closed condition creating possibility of fatal incidents. Sealdah division urges everyone, be the road vehicle owner or pedestrians or the rickshaw pullers, not to forcibly enter the level crossing gate when the gate is closed or closing or the buzzer is ringing or the road signal at level crossing is red.

If any road user prevents the on-duty gateman in closing the level crossing gate in time enters the level crossing when the gate is closed, then such act of that person is a punishable offence also under the provisions of

The road users at level crossing should keep in mind the following points:

 Never attempt to cross the tracks once the gate has started to close.

Don't Cross a close level crossing gate

• Do not bypass, force open, or ignore a closed or closing gate under any circum-

 Stay alert for warning signs and signals, and wait until the gate is fully open and a clear signal is given before crossing.

 Violation of safety rules at level crossings may result in penal measures.

It may be noted that, Eastern Railway, Sealdah Division is also conducting awareness campaigns at different level crossing gates from time to time to educate the people about safe crossing practices. These campaigns focus on the dangers of violation of rules at level crossings and obeying traffic rules to give safe passage of train for a seamless movement of train traffic and once again urges all concerns to follow safety and traffic rules at level crossing gates scrupulously which will be beneficial for easy flow of both rail and road traffic.

AXAR PATEL AWARDED 'IMPACT PLAYER OF THE MATCH' MEDAL FOLLOWING WIN OVER PAKISTAN IN ASIA CUP

DUBAI [UAE]: Following the victory against Pakistan during the ongoing Asia Cup, the Indian allrounder Axar Patel was given the 'Impact Player of the Match' award in the dressing room for his fine bowling and fielding perform-

Axar was one of the standout performers in the clash against Pakistan, taking 2/18 in his four overs, getting an aggressive Zaman and skipper Salman Agha in quick succession as spin was introduced in the attack, reducing Pakistan to 49/4 in 10 overs

He also took a fine catch to dismiss a dangerous Hassan Nawaz for a single-digit score, making him the sixth victim of the day. Pakistan was restricted to 127/9 and India chased it down easily with 25 balls and seven wickets left. In a video by the Board of Control for Cricket in India (BCCI), the team's training assistant Nuwan Senevirathne gave Axar the medal, calling him "silent and effective in all three depart-

Speaking in the video after the match, Axar hailed 'Player of the Match' Kuldeep Yadav for his match-winning spell of 3/18 in four overs.

"Donno match mein Kuldeep Kuldeep bhai hi dikh rahe hai (It was Kuldeep, Kuldeep in these two matches)," he joked to Kuldeep, referring to his early 'Player of the Match' winning four-wicket haul against UAE.

Kuldeep also expressed happiness with his performance, saying that two months of work on his fitness, training and bowling during the five-Test tour to England paid off finally. "I ticked those numbers (during the England tour while



training and practising). I hoped that I got play in Asia Cup because conditions were suitable for me. But it is also important to stay in the rhythm and execute things well," he added.

Kuldeep also thanked his Delhi Capitals (DC) skipper for helping him out with the bowling, pointing out how Axar adviced him to give more revs and spin on the ball.

"There are small things, while I was bowling, you told me to give the revs on the ball, the ball is gripping and spinning. I got this in mind. I had delivered just one over and decided to give the ball some spin and get some bounce. Because of that, I got three wickets, you got two, a total of five. Credit goes to you, you bowled really well. Perhaps you had bowled before and knew the conditions well. You had great control and got two wickets of set batters

in the middle-order," he added. On his own bowling performance, Axar noted that this time, he was trying to bowl more slower and put in more revs on the ball.

In the last match, I observed that it was easy for batters to hit me on the speed I was bowling on. So I decided to bowl more slower and give more revs to the ball," said the experienced all-rounder, who took 1/13 in three overs against UAE in the campaign

Axar also hailed skipper Suryakumar Yadav for his "mature knock"

"As a batter, I know it is difficult to hit and rotate the strike. You just cannot hit big shots from the word go. You had to take calculated risks. This is what he did. There was no wild hitting. He waited for the ball, played late. It was a mature innings," he con-

captain Sourav Ganguly on Monday spoke on whether Sunday's India-Pakistan clash in the Asia Cup could have been avoided, saying that while "terror must stop, sports cannot

The India-Pakistan rivalry got another chapter in its storied history. With the match being the first between the two nations since the Pahalgam terror attacks on India back in April and consequent launch of Operation Sindoor by the Indian Armed Forces against Pakistan-sponsored terror, the tensions were at an all-time high.

Team India, battling backlash for even going ahead with the match in the multination tournament, restricted Pakistan to 127/9. Skipper Suryakumar Yadav and Abhishek Sharma's heroics with the bat were the highlights as India secured an easy seven-wicket win.

The highlight of the match occurred after the match, as the skipper and his batting partner walked off the field without shaking hands with the Pakistan team, and the skipper dedicated the win to the armed forces, while expressing solidarity with the Pahalgam victims.

Speaking of the match that could have been avoided, Ganguly told the media in Kolkata, "Terror must stop; it is most important, but sports also cannot stop. Terror must stop, not just in India, Pakistan, but all over the world. On Pakistan Cricket Board (PCB) lodging a

complaint with the International Cricket Council (ICC), asking for the removal of match-referee Andy Pycroft over alleged violation of the ICC Code of Conduct and Marylebone Cricket Club (MCC) laws on the spirit of cricket, Ganguly simply said, Everyone has their own side of the story.

Following the match, Indian skipper Suryakumar Yadav expressed solidarity with Pahalgam terror attack victims and dedicated the win to the Indian Armed Forces and lauded their efforts in combating the Pakistansponsored terror, most notably the launch of Operation Sindoor in the aftermath of April's Pahalgam terror attacks.

"Just wanted to say something. Perfect occasion, taking the time out, we stand by the families of the victims of the Pahalgam terror attack. We express our solidarity. Want to dedicate the win to all our armed forces who showed a lot of bravery. Hope they continue to inspire us all, and we give them more reasons on the ground whenever we get an opportunity to make them smile, Suryakumar said after the win in the postmatch interview.

Following that in the press conference, on being asked about handshake being against the sportsman spirit, Suryakumar had replied, "I feel a few things in life are ahead of sportsman spirit. I have told it at the presentation as well. We stand with all the victims of the Pahalagam terror attack. We stand with their families also and express our solidarity. As I said, we dedicate this win to our brave armed forces who took part in Operation Sindoor. As they continue to inspire us all, we will try our best to, whenever given the opportunity, inspire them as well if possible.

In the aftermath of the incident, the Asian Cricket Council (ACC) President Mohsin Naqvi on Monday demanded "immediate removal" of the match referee of India-Pakistan Asia Cup clash, Andy Pycroft, "over the violation of the ICC Code of Conduct and the

Marylebone Cricket Club (MCC) Laws." Speaking on the incident, Naqvi wrote on



X, "The PCB has lodged a complaint with the ICC regarding violations by the Match Referee of the ICC Code of Conduct and the MCC Laws pertaining to the Spirit of Cricket. The PCB has demanded an immediate removal of the Match Referee from the Asia

Following the match, Pakistan skipper Salman Agha chose not to attend the postmatch presentation, and for the press conference, head coach Mike Hesson was sent to face the media.

During the presser, Hesson broke the silence about Salman's absence while expressing his disappointment about India refraining from engaging in the customary handshake when his side made attempts towards it. Hesson did not directly pin Salman's absence due to the incident that took place after the match, but alluded to it

obliquely.

"We were ready to shake hands. We are obviously disappointed that our opposition did not do that. We sort of went over there to shake hands, but they had already gone to the changing room. That was a disappointing way for the match to finish. We were willing to shake hands. We were keen to shake hands at the end of the match, but that did not happen, and that was pretty much the end of it," Hesson said.
