

Mamata launches 2nd phase of 'Banglar Bari' scheme months before election

MI News Service, Kolkata : Months before the West Bengal Assembly election, the Mamata government launched the second phase of the Banglar Bari housing scheme project. The scheme, the first phase of which was launched in December 2024, aims at providing pucca houses to another 16 lakh families.

Emphasising her track record of fulfilling promises, the Chief Minister announced that 12 lakh beneficiaries have already received the second instalment of Banglar Bari — a scheme aimed at providing houses to the rural poor. She said that with the Centre stopping funds to the state under the Pradhan Mantri Awas Yojana (PMAY), the state government would provide funds to 2.8 million families in rural areas to build houses before 2026, when the state assembly elections are due. "We have identified around 2.8 million beneficiaries. For now, we have released funds to 1.2 million households. If the Centre doesn't release the funds, we will provide the funds for the remaining 1.6 million households by the

start of 2026 in two phases," Mamata Banerjee said during the launch of Banglar Bari scheme at the state secretariat. With the Centre stopping funds to the West Bengal government under the PMAY, the state government

launched Banglar Bari to provide financial assistance to families in rural areas to build houses. Under the Banglar Bari scheme each household would get Rs 1.2 lakh in two installments of Rs 60,000 each to build a pucca house in rural areas. "For three years the people of West Bengal have been deprived. In these three years, the Centre sent at least 69 teams. We had replied to all their queries and provided all documents. But de-

Centre provided 60% of the funds under the PMAY while the state shared 40%. But massive allegations related to nepotism and financial irregularities surfaced in 2022 following which the Union government stopped releasing funds to the state. This prompted the state government to launch Banglar Bari with its own funds.

In October last year protests broke out again in various districts over allegations of corruption and nepotism when the state government was preparing the list of beneficiaries for the Banglar Bari scheme. There were protests in Purulia, West Burdwan, Hooghly, South 24 Parganas and Birbhum. Villagers staged demonstrations outside BDO and panchayat offices alleging that names of deserving beneficiaries were being dropped to include those having close links with local party leaders. "The chief minister ordered a re-verification. More than 27,000 teams conducted a survey of 3.5 million families and came up with a draft list. Thereafter a final list of 2.8 million beneficiaries was

GST rates rationalisation will not pose fiscal burden on govt : Crisil

MI News Service, Kolkata: The recent rationalisation of GST rates is unlikely to pose a fiscal burden on the government, global ratings firm Crisil said. In its latest report, the well repute international ratings firm said the government has estimated a net loss of an annualised Rs 48,000 crore in the short term on account of GST rationalisation.

The total GST collections in the previous fiscal were Rs 10.6 lakh crore. Hence, the loss does not seem significant, the report said. The Goods and Services Tax (GST) Council recently decided to rationalise the tax rates and have a two-rate structure of 5 per cent and 18 per cent. The revision, to be effective from September 22, will reduce the prices of a large number of products and services. The GST simplification from four to two slabs can bring more goods and services under the formal net, which would gradually support tax buoyancy over the medium term, the Crisil report said.

Before the rationalisa-tion of the GST rates, the majority (70 per cent to 75 per cent) of the revenue came from the 18 per cent slab, it said. Only five per cent to six per cent of revenue came from the 12 per cent tax rate slab, and 13 per cent to 15 per cent from the 28 per cent slab. The ratings firm said that reducing tax rates on items from 12 per cent may not render significant revenue loss. Rates are unchanged on several fast-growing services like mobile tariffs. New services such as e-commerce delivery brought under the GST ambit and will be taxed at 18 per cent. An increase in disposable incomes due to benefits on certain mass consumption items could further drive up their demand and tax collections, the report said. Producers passing tax changes onto the consumers is a key factor which would also determine the spending pattern of the latter, it added

Meanwhile, highlighting that the second generation GST reforms will boost the economy by increasing demand, Union Finance Minister Nirmala Sitharaman on Thursday said in Kolkata that the determination of September 22 as the date when revamped taxes will come into effect has a very strong influence on West Bengal. "I am happy to say that the determination of 22nd September as the implementation date for the next generation GST reforms was largely influenced by (Durga) Puja. The Shubh Mangal Diwas when the revamped GST comes into effect coincides with the first day of Navratri, the day


Tripura Police arrested two Bangladeshi and four Indian nationals from Belonia in the south Tripura district on Thursday. The four Indian nationals, residents of West Bengal, went to Bangladesh a few months ago and returned to Tripura along with two Bangladesh citizens illegally, without any valid documents. The BSF detained another Indian national after he illegally entered Tripura from Bangladesh. This man, a resident of Tripura, also went to the neighbouring country earlier without any valid passport or documents.

Tripura, which has an 856 km border with Bangladesh, is surrounded on three sides by the neighbouring country, making the northeastern state very vulnerable and sensitive to cross-border migration issues. Tripura Chief Minister Manik Saha on Wednesday once again firmly reiterated that the state government would not allow illegal immigrants from Bangladesh or Myanmar to enter Indian territory under any circumstances. The Chief Minister earlier said that during a recent meeting with the senior security officials of different agencies, he had requested officials in the state to maintain close coordination among them to deal with the border-related issues and

Rahul Gandhi again digs at EC on 'vote chors'

: Congress leader Rahul Gandhi reiterated his "vote chori" allegations again on Friday and took another swipe at the Election Commission, calling it an "elecwatchman" tion "stayed awake, watched the theft, and protected the thieves". His remarks came a day after he ramped up his attack on the issue of vote theft, accusing Chief Election Commissioner Gyanesh Kumar of protecting those who "destroyed democracy". To buttress his allegation, he cited data from a Karnataka assembly constituency to claim that votes of Congress supporters were being systematically deleted.

But the Election Commission dubbed the allegations as "incorrect and baseless" and said. "No deletion of any vote can be done online by any member of the public, as misconceived by Rahul Gandhi." In a post in Hindi on X on Friday, Rahul Gandhi said, "Wake up at 4 a.m. Eliminate two voters in 36 seconds, Then go back to sleep - this is how vote theft happens!

"Chunaav ka chawkidaar jaagta raha, chori dekhta raha, choron ko bachata raha (The election watchman stayed awake, watched the theft, and protected the thieves)," the Leader of Opposition in the Lok Sabha charged. The Congress leader also shared a 36-second video from his press conference in which he explains the modus operandi of the alleged "vote theft". In a post on Thursday evening, Rahul Gandhi had said, "The nation's youth, the nation's students, the nation's Gen Z, will defend the Constitution, protect democracy, and stop vote theft. I always stand with them. Jai Hind!" In his fresh offensive against the Election Commission, Rahul

said on Thursday that the poll panel must stop protecting "vote chors" and provide within a week information sought by the Karnataka CID in an investigation into voter deletions. Addressing a joint press conference with U.K. Prime Minister Keir Starmer at Chequers, the British PM's countryside residence here on Thursday, President Trump said he has a "very good relationship" with Prime minister Modi and also wished him on his 75th birthday — a gesture reciprocated by the Indian leader with a "beautiful" statement. Despite imposing a massive 50 per cent tariff on India last month, President


tone and went out of his way to stress his friendship with Prime Minister Modi.



Kolkata hosp conducts MVR on Rare Dextrocardia Patient

News Service, Kolkata: There are no exact numbers for how many people undergo mitral valve replacement surgery in India annually, but the procedure volume is high, with at least one hospital performing over 1,000 such surgeries every year.

Kolkata's Desun Hospital recenty announced the successful Mitral Valve Replacement (MVR) surgery on a 46-year-old male patient Vikash Paswan from Jharkhand, who has dextrocardia, a rare condition where the heart is positioned on the right side of the chest, instead of the left.

The surgery, performed by a skilled team of cardiac surgeons and anaesthetists, achieved the rare feat, led by Dr. Soumyajit Ghosh, Senior Consultant CTVS Surgeon. He said "Performing such a surgery on a patient who has dextrocardia is a difficult task as it goes against our clinical instincts. Since we rarely come across such cases, it has been a different experience.

Dr Subhendu Sarkar, Senior Cardiac Anaesthetist, said, "The role of proper anaesthesia is crucial in such cases. While anaesthesia management plays a major role in every surgery, in this case, since the patient has dextrocardia, it's even

CCTV Installation at JU Stalled **Amid Bureau**cratic Delays

MI News Service, Kolkata: Despite no official objections, the installation of CCTV cameras across Jadavpur University has remained stalled, caught in bureaucratic hurdles and administrative red tape. While some students have shown minor reluctance, strong opposition to the project is not evident. Yet, the long-pending demand for enhanced security continues to be delayed. The debate over campus surveillance intensified a few years ago after the death of a first-year undergraduate student of the Bengali department. The student died after falling from the third floor of a hostel building. Though it initially appeared to be a suicide, the subsequent investigation highlighted the possibility of ragging. That tragic incident triggered renewed demands for CCTV coverage across the university premises.

University sources confirmed that though some work had been initiated, a large portion remains incomplete. The main campus still requires 50 CCTV cameras, while the Salt Lake campus is awaiting the installation of 20. Additionally, the proposal for appointing 30 new security guards has yet to receive approval. Speaking to TV9 Bangla earlier, Jadavpur University Pro Vice-Chancellor AmitavaDatta stated, "We had already written to the government regarding both these issues. A detailed report on CCTV installation was also submitted. The letters have been resent, and we hope the government will take steps accordingly." Echoing this, JUTA General Secretary Parthapratim Ray remarked, "Following the student's death in 2023, there were repeated appeals for more security guards as well as CCTV cameras. Based on this, a private firm even submitted quotations. But the state government has not granted approval to these requests so far."

Kasba Law College **Survivor's Family Seeks Transfer From** The Campus

MI News Service, Kolkata: More than two months have passed since the shocking rape incident at Kasba Law College, yet the trauma continues to haunt the survivor. Her father has now said that returning to the same campus could take her back to that "night of horror," intensifying her mental distress. To protect her emotional health, the family has decided to seek a transfer to another institution.

The incident dates back to June 25, when first-year students of the college had gone to complete their examination formality. Among them was the survivor, who did not return home that evening. Later, she herself lodged a complaint at the local police station, alleging rape by a temporary staff member of the college. The triggered outrage across Kolkata and West Bengal, sparking demands for stronger campus safety measures. It later emerged that the survivor did sit for her first-year examinations. The authorities of South Calcutta Law College arranged for her to appear separately at an external location, away from the college premises. However, the survivor has made it clear that she does not wish to step into Kasba Law College again. Her family fully supports that decision. Her father said, "My daughter is already shattered mentally. If she has to see that place again, it will break her further. I do not want her to go back there. That is why we have decided on a college transfer." When asked how a transfer could be arranged mid-academic session, he explained, "She has already completed her first-year examination.

Kolkata Police to Begin Puja Crowd Control from Mahalaya, Extra Forces Deployed

MI News Service, Kolkata: Kolkata Police will begin managing Puja crowds from Mahalaya, with additional forces deployed to ensure smooth celebrations and public safety. Commissioner of Police Manoj Verma on Friday announced that special focus will be given to traffic management and crowd control in major Puja pandals across the city. "Our main priority is the safety of the common people. Several meetings have already been held with Puja organizers to ensure that the traffic system remains functional during the festival," Verma told reporters. He confirmed that coordination meetings have also been held with the Public Works Department (PWD), Kolkata Municipal Corporation (KMC), and CESC, while immersionrelated matters have been discussed with the Port authorities. "Kolkata Po-

lice is fully prepared," he added. Verma outlined the deployment plan, saying, "From tomorrow itself, we are keeping certain arrangements in place. During the Puja days, we will deploy a significant amount of extra manpower. Traffic control will receive special attention, and crowd management will be prioritized at the larger pandals. Police presence will continue throughout the night, with additional forces on duty even between 2 AM

However, weather may play spoil-sport this Puja season. According to forecasts from the India Meteorological Department (IMD), a low-pressure system is expected to form over the Bay of Bengal after Thursday, September 25. Meteorologists have indicated that the system is more likely to develop near the Odisha coast in the

northern Bay. The path it takes on landfall will determine the weather's impact on Bengal. If it intensifies over Odisha, Bengal may escape severe rainfall, but uncertainty remains. The possibility of heavy rain during Puja poses additional challenges. With massive crowds expected to throng pandals, any downpour could further complicate police efforts to regulate traffic and maintain law and order. Authorities admit that the combination of festival rush and adverse weather will increase operational pressure, but the police assure citizens that comprehensive preparations are already in place. Kolkata Police, along with civic agencies, are working round the clock to ensure a safe, smooth, and celebratory Durga Puja — even as the looming threat of rain hangs over the city's biggest festival.

Haridevpur Gangrape **Accused Arrested in** Kolkata

MI News Service, Kolkata: A late-night plea for cash from a fugitive son to his mother ended in his arrest. Police on Thursday night nabbed Debanshu Biswas, one of the prime accused in the Haridevpurgangrape case, red-handed near Deshapriya Park after his mother arrived there with money at his request. Earlier this month, the other accused, ChandanMallick, had been arrested from Bardhaman station on September 10. Since then, police had been searching intensively for Debanshu, tracking his movements and keeping his family under close surveillance. The case dates back to the night of September 5, when Chandan and Debanshu allegedly lured a young woman to a Regent Park flat on the pretext of attending a party. There, the duo allegedly gangraped her. The traumatised survivor managed to return home and filed a complaint at Haridevpur police station, following which both accused absconded. While Chandan was arrested within days, Debanshu proved more elusive. According to police sources, he initially fled to Delhi and later to Uttar Pradesh.

SSC Teacher Recruitment Exams'

Result Likely by October-End

The new phase of teacher recruitment examinations conducted by the School Service Commission (SSC) has already sparked debate and raised questions, though the process has drawn massive participation. A total of 5.65 lakh candidates applied this year. The examinations for Classes IX-X were held on September 7, with 3,19,919 candidates appearing. The test for Classes XI–XII followed on September 14, where 2.46 lakh aspirants took part. Despite the large turnout, uncertainty over the results continues to fuel anxiety among applicants. After the exams, Education Minister BratyaBasu and SSC Chairman Siddhartha Majumdar addressed a press briefing, assuring that results would be declared after Durga Puja, though no exact date was given. According to sources, the commission is targeting the last week of October for publish-

ing results, likely after Kali However, with several

festive holidays lined up in October, the possibility remains that results could spill over into early November. Soon after, the list for interviews will be released. Officials had earlier indicated that interviews would begin in November and continue for several weeks. The recruitment process is expected to conclude by December 31. The current exercise follows a major setback in 2016, when the Calcutta High scrapped the entire teacher recruitment panel over corruption charges. Nearly 26,000 teachers and staff lost their jobs, and though the matter reached the Supreme Court, relief never came. Amid ongoing disputes over eligibility and fairness, the SSC recently published a fresh list of 1,806 candidates shortly before holding the new round of examinations.

Kolkata Wakes to Overcast Skies, IMD **Warns of Thunderstorms and Rain**

MI News Service, Kolkata: experienced overcast skies with intermittent light rain on Friday, September 19, 2025. as the India Meteorological Department (IMD) predicted thunderstorms and moderate showers throughout the day. The city recorded a morning temperature of 31°C, with humidity levels hovering around 79 percent and southwesterly winds moving at 8 kmph. The day began with misty conditions, reducing visibility to 3.5 km under nearly 75 percent cloud cover. Atmospheric pressure stood at 1008 mb, while the UV index was measured at 6, requiring sun protection during occasional clearer periods. Sunrise was at 5:24 AM, and sunset is expected at 5:35 PM, ensuring

nearly 12 hours of daylight despite dense clouds. According to IMD updates, the city is currently witnessing slight to moderate thunderstorms with intermittent rain, coupled with high humidity at 85 percent and southeasterly winds blowing at 3.7 kmph. Temperature monitoring from different stations reported 29.4°C at Alipore and 28°C at Dum Dum, both recording steady cloud cover. While the past 24 hours saw no measurable precipitation, the IMD estimates a 93 percent chance of afternoon rainfall today, with possible accumulation of up to 3.85 mm. Patchy rain has already been reported since the early hours, with intensity likely to increase by afternoon and evening.



India grew by a modest 2.84 per cent to 19,64,547 units in August as against 19,10,312 units in the same month last year, as customers postponed purchases expecting a price cut ahead of GST reforms, Federation of Automobile Dealers Associations (FADA) said. Passenger vehicle (PV) sales were marginally up at 3,23,256 units last month as compared to 3,20,291 units in August 2024, FADA said in a statement. PV retails in August recorded a modest growth of 0.93 per cent YoY. Two-wheeler retail sales in August this year were at 13,73,675 units as against 13,44,380 units in the year-ago month, up 2.18

FADA said in the two-wheeler segment enquiries remained strong, fuelled by the onset of festivals such as Onam and Ganesh Chaturthi, with many customers keen on auspicious-day deliveries. However, excessive rains and localised floods in North India disrupted rural mobility, while erratic supply of popular scooter models constrained conversions.

"The landmark GST 2.0 announcement also led to buyers deferring purchases to September in anticipation of lower rates," it noted. Despite these factors, overall sentiment is steady, and dealers remain confident that the festive season ahead will unlock robust growth mo-

The Supreme Court on Friday adjourned to September 22 the hearing on bail pleas of activists Umar Khalid, Sharjeel Imam, Gulfisha Fatima and Meeran Haider in the UAPA case related to the alleged conspiracy behind the February 2020 riots in Delhi. A bench of Justices Ara-

vind Kumar and Manmohan deferred the pleas. The activists have chal-

lenged a September 2 Delhi High Court order which denied bail to nine people, including Khalid and Imam, saying "conspiratorial" violence under the garb of demonstrations or protests by citizens could not be allowed. Illicit trade raising socio-economic security concerns: Justice Manmohan

New Delhi : Supreme Court's Justice Manmohan on Friday outlined the damning impact on economy, employment and mushrooming of criminal syndicates as the consequences of illicit trade in the country. He was speaking at an event titled "Movement against Smuggled and Counterfeit Trade (MASCRADE)" organised by FICCI CAS-CADE (Committee Against Smuggling and Counterfeiting Activities Destroying

"We now have estimates of illicit trade, and according to some people, it creates three trillion dollars annually. It is not just revenue loss for the country, but beyond this, the real cost is in the form of job losses, innovation being exploited, and the growth of criminal syndicates; and that is a huge problem. When we look at the bigger picture, we know that there are socioeconomic and security concerns," the judge

Illicit trade, Justice Manmohan said, also endangers human life.

"Imagine you are sick and taking medicine, but still not recovering because it is a counterfeit product. So it has very serious issues attached to it," he added. He said such products did not provide any tax to the government, nor did they come with a warranty, and if something went wrong, people

Therefore, it (illicit trade) needs to be curbed. Civic society needs to come together. We already have a legal frame-



work to deal with it; we have the Safety and Security Act, we have IPC, we also have the IT Act, the Bureau of Indian Standards Act, and I am informed that some acts are also coming in agriculture-related materials."

He flagged another issue. We are now living in a virtual world, and most things are happening in the online world. The loss now is even bigger, and it

requires a new approach to deal with this bigger challenge," the judge said.

Pointing out the negative impact on the film industry, he said, "They say the film industry is worth about 2.5 billion dollars, and the copyright trade in it is 2 billion dollars. Today, the challenges are entirely different. When I used to be in practice, the violation was related to DVDs being sold in

Palika Bazar, and that was the only way of violation. Today, how is it taking place? It is taking place through servers outside the country, from places where we cannot

reach, where no police or court can reach. Justice Manmohan said many a times, filmmakers are troubled with torrent-type anonymous websites.

"How do we enforce our orders against them?" Justice Manmohan said. He said most of the time, the profits from illicit trade were used to fund terror-

"There are huge challenges and we have to come together to beat them, especially the challenge through e-commerce websites. It is time to engage the platforms to prevent illicit trade that is taking place, and it is time to engage the influencers. We have to change the strategy; we have to make sure we stay one step ahead to deal with illicit trade. "This can only happen if there is cooperation from everyone traders, lawyers, civil society, companies and the government and I see it is in everyone's interest," Justice Manmohan said. The 11th edition of MASCRADE was a two-day conference where a report on the GST reforms was released. It saw participation by international organisations, such as World Intellectual Property Organisation, United Nations Office for Drugs and Crime and European Union Intellectual Property Office

New drug could be first to stop deadly fatty liver disease: Study

California [US] : Researchers at the University of California San Diego School of Medicine have identified a new investigational drug that shows promise in treating metabolic dysfunction-associated steatohepatitis (MASH), a serious form of fatty liver disease linked to obesity and type 2 diabetes that can lead to cirrhosis, liver failure, and even liver cancer.

The study, published in the August 23, 2025 online edition of The Lancet, found that the medication, ION224, targets a liver enzyme called DGAT2, which plays a key role in how the liver produces and stores fat.

By blocking this enzyme, the drug helps reduce fat buildup and inflammation, two major drivers of liver damage in MASH.

This study marks a pivotal advance in the fight against MASH," said Rohit Loomba, MD, principal investigator of the study and chief of the Division of Gastroenterology and Hepatology at UC San Diego School of Medicine.

'By blocking DGAT2, we're interrupting the disease process at its root cause, stopping fat accumulation and inflammation right in the liver," added Rohit Loomba.

The multicenter, Phase IIb clinical trial involved 160 adults with MASH and early to moderate fibrosis across the United States. Participants received monthly injections of the drug at different doses or a placebo over the course of one year.

At the highest dose, 60% showed notable improvements in their liver health compared to the placebo group. These benefits occurred regardless of weight change, suggesting the drug could be used alongside other therapies.

The medicine showed no serious side effects linked to the

MASH, formally known as nonalcoholic steatohepatitis (NASH), affects people with metabolic conditions like obesity and type 2 diabetes. It is often called a "silent" disease because it can progress for years without symptoms.

More than 100 million people have some form of fatty liver disease in the U.S. and as many as 1 in 4 adults worldwide may be affected, according to the Centers for Disease Control and Prevention. If left untreated, MASH can progress to liver failure and often may require a transplant.

'This is the first drug of its kind to show real biological impact in MASH," Loomba said.

If these findings are confirmed in Phase III trials, we may finally be able to offer patients a targeted therapy that halts and potentially reverses liver damage before it progresses to lifethreatening stages," added Loomba.

Loomba, who is also director of the metabolic-dysfunctionassociated steatotic liver disease (MASLD) research centre at UC San Diego School of Medicine, and a gastroenterologist and hepatologist at UC San Diego Health, adds that for patients and families affected by this serious condition, these results bring new hope for better care and outcomes.

He emphasises that early intervention and targeted therapies may also help reduce the burden on health care systems by preventing costly and complex liver disease down the line. (ANI)

Kuldeep should be part of Test cricket if you have to take 20 wickets: Anil Kumble

NEW DELHI [INDIA] : Decorated spinner Anil Kumble has advocated for left-arm ball tweaker Kuldeep Yadav's inclusion in the Test fold, who brings along an 'Xfactor' with him that takes India a

step closer to scything 20 wickets. Kuldeep, who firmly believes that rhythm is everything, sat out the entirety of India's tour of England earlier this year. It wasn't about his form or the lack of skill set that he offers; the team combination and the urge for batting depth left no room for him.

Instead of sulking or brooding, the 30-year-old devised a pattern of training, analysing his game and identifying markers. There were certain moments throughout the 2-2 series draw when fans and former cricketers voiced their opinion about Kuldeep being the missing factor that could have changed the complexion of the

With Axar Patel, Ravindra Jadeja and Washington Sundar, offering batting expertise along with rolling their arms to cast spin magic, Kuldeep is often overlooked at the cost of adding more runs to the board. But Kumble sees Kuldeep as a necessary cog in India's bowling machinery.

"I think Kuldeep Yadav should be a part of Test match cricket if you have to take 20 wickets. Yes, there is Ravindra Jadeja, Washington Sundar, and Axar Patel. But I think Kuldeep's X-factor is that it's not easy to pick him.



And we have seen that," Kumble said on The Great Indian Cricket Show. "I would like to see Kuldeep being the number one spinner as a listed spinner in the playing XI. And then whatever you want to do after that, all-rounders, fast bowlers and then you pick the rest of the players," Kumble added.

Recently, he opened up about how being snubbed during the England tour became a valuable learning lesson and helped him come up with new ideas to finetune his game.

"In England, obviously, looking at the conditions and the combination of the team, I did not get a place in the team. But obviously, it was a very good time for me to work on myself, to improve my fitness and to give more volume to

bowling because it is very important," Kuldeep said while speaking to reporters on Thursday.

"I learned a lot. As a player, you learn a lot when you do not play. When the team reacts to situations, you can judge from the outside. You have a lot of ideas that you are in this situation, how you react and how you bowl. I got a lot of ideas from there," he

In the fast-paced T20I format, Kuldeep has maintained his economical stature and the knack for scything wickets with his hard-todecode variations. He has claimed seven in two appearances at the ongoing Asia Cup, the second most in the tournament and has been vital to confirming India's ticket for the Super Four stage.

"Ît's not how I had hoped to end the season, at the World Championships in Tokyo. I wanted to step out there and give my best for India despite all the challenges, but it wasn't my night," Neeraj Chopra said in a post on X.

"I'm really happy for Sachin, who threw a personal best and almost brought home a medal. Congratulations to @keshorn_walcott, @peters_oly and @Curt_Thompson_on their well-deserved podium places. Grateful for all your support, this only makes me determined to come back stronger," he added.

The world javelin title went to Trinidad and Tobago's Keshorn Walcott, who managed the best throw of 88.16 m, marking his first World Championship gold 13 years after his Olympic triumph in London. At the second spot was Anderson Peters,

the 2024 Olympics bronze medallist with a best throw of 87.38 m, followed by America's Curtis Thompson with a throw of 86.67 m.

Fans could not get the best of the India-Pakistan rivalry between Neeraj and Arshad Nadeem, as Neeraj finished eighth with a best throw of 84.03 m, while the Olympic champion Nadeem ended at tenth with an 82.73 m
