SEBI simplifies securities transfer from nominee to legal heir

MI News Service, New Delhi: Markets regulator Sebi on Friday simplified the process of transferring securities from a nominee to the legal heir. When a nominee transfers securities to a legal heir, the transaction is sometimes treated as a "transfer" and assessed for capital gains tax.

However, under Section 47(iii) of the Income Tax Act, 1961, such a transmission is exempt and should not attract tax. While the nominee can claim a refund later, this causes unnecessary inconvenience. To resolve this, a working group consulted the Central Board of Direct Taxes (CBDT) and recommended the use of a new reporting code "TLH" (Transmission to Legal Heirs). This code will help ensure such transfers are correctly reported and not taxed as capital gains. "A standard reason code shall be used by the reporting entities while reporting the transmission of securities from a nominee to a legal

His presence at a public rally guarded by both JeM cadres armed with M4 rifles and local police officers reflects the Pakistan state's support for JeM, the sources said.

BENGAL gave Rs 8 trillion



MI News Service, Kolkata: Bengal has contributed over ₹8 lakh crore (trillion) to the national exchequer by way of direct and indirect taxes over the last eight years, Amit Mitra, the principal chief adviser to chief minister Mamata Banerjee, said. The staggering figure fished out by Mitra was in response to the claim made by Union finance minister Nirmala Sitharaman on Thursday that Bengal has received its due from the central tax kitty by way of devolution of taxes, central schemes and centrally sponsored schemes. Of ₹1.07 lakh crore tax devolution budgeted for FY26, ₹47,526 crore has been released as on September, she said. Countering this, Mitra said that it is the 'constitutional right' of Bengal to receive the fund and spelt out the tax collected by the Centre from the recent past. He also reiterated the complaint that the Modi government has not released ₹1.93 lakh crore due to it. Steel investment Speaking at the annual general meeting of Merchants Chamber of Commerce & Industry, Mitra said Bengal has been trying to attract both large and small industries. At the event, MCCI president Amit Saraogi said

New set of GST reforms coming into force from Sept 22

Union Finance Minister Nirmala Sitharaman has said with the slew of GST reforms set to come into effect from September 22, a total of Rs 2 lakh crore will be in the hands of the people, boost-

ing domestic consumption. With the simplification of the Goods and Services Tax from the earlier four slabs to 2 slabs, Sitharaman said Prime Minister Narendra Modi is keen to ensure that the poor and downtrodden, middle class families and the micro, small and medium enterprises (MSMEs) largely benefit out of the GST reforms. The new set of GST reforms with a revised tax structure is set to come into force from September 22. "With the proposed GST reforms, there will be an increase in consumption in the domestic market. The Finance Ministry does not receive the Rs 2 lakh crore as taxes from the public, but it goes back into the economy aiding domestic consumption," she said.

Elaborating, she said, because of the two slab structure, the price of a product which a customer normally buys gets reduced. "For example, when you buy the same product, say a soap in larger quantities, the manufacturer increases the production. To increase production, he recruits a lot of people, and when there are a lot of people, they pay tax to the income. And there will be revenue to the government as indirect taxes. When this virtuous cycle keeps on happening, it is good for the economy," she said. To keep it simple,

Sitharaman said when there is more spending from the public, there is higher demand. When there is higher production to meet the demand, there will be more jobs. And when there are more jobs, there will be a wider tax base. To support her point, the finance minister said when the number of entrepreneurs who were paying taxes stood at 65 lakh before GST was introduced in 2017, it did not get reduced to 10 lakh. "But, entrepreneurs understood the benefit and in the last 8 years it has only increased to 1.5 crore," she said. Congress leader Rahul Gandhi termed the GST as a Gabbar Singh Tax, but it was not a Gabbar Singh Tax. "It (GST) only increased the tax base from 65 lakh entrepreneurs to 1.5 crore in the last 8 years," she remarked. PM Modi has been insisting that the GST reforms should largely benefit the poor, middle class families and MSMEs in particular, she said. Sitharaman also took a dig at a political comment whether the government was levying higher taxes for those products all these eight years and now it has been staging a drama that the rates have been cut or completely removed under the GST 2.0 reforms.

"One senior person asks whether the government was levying higher charges for all these eight years (since GST was introduced in 2017). I wish to state here that neither the NDA government nor the Prime Minister is inclined to do that," she said without divulging

EC prepares for nationwide SIR rollout

MI News Service, New Delhi: The Election Commission has asked its state election officers to be ready for the SIR by September 30, in an indication that the poll authority could launch the voter list cleanup exercise as early as October-November.


According to officials, at a conference of state chief electoral officers (CEOs) here earlier this month, the EC top brass asked them to be ready for the Special Intensive Revision (SIR) rollout in the next 10 to 15 days. But for the sake of greater clarity, the deadline of September 30 was set. The CEOs have been told to keep voter lists of their states, published after the last SIR, ready Several state CEOs have already put up the voter lists published after their last SIR on their websites. The website of the Delhi CEO has the voter list from 2008, when the last intensive revision took place in the national capital.In Uttarakhand, the last SIR took place in 2006 and the electoral roll from that year is now on the state CEO's website. The last SIR in states will serve as the cut-off date, just as the 2003 voter list of Bihar is being used by the EC for intensive revision. Most states had the last SIR between 2002 and 2004 and have nearly completed mapping of current electors with those as per the last intensive revision. The EC has said that after Bihar, SIR will be carried out in the entire country. Assembly elections

in Assam, Kerala, Puducherry, Tamil Nadu and West Bengal are due in 2026. The primary aim of the intensive revision is to weed out foreign illegal migrants by checking their place of birth.

The move assumes significance in the wake of a crackdown in various states on illegal foreign migrants, including from Bangladesh and Myanmar.



Another schoolgirl murdered in Nadia over rejected proposal

MI News Service, Taherpur: Barely weeks after the murder of 18-year-old student Ishita Mallick in Krishnanagar, Nadia has been shaken again by another brutal killing of a teenage girl and this time she was hacked to death allegedly over a spurned love propos-

The victim, Anushka Mandal (16), a Class X student from Birnagar Ichhapur, was found dead in the early hours of Saturday, her body lying near a cattle shed in a mango orchard close to her home. Police said she had been attacked with a

The accused, identified as Shubho Mondal (19), a local resident, has been arrested. According to investigators, Mondal had allegedly been stalking and harassing Anushka for months, pressuring her into a relationship despite repeated refusals. He had even been warned by the girl's family around 6 months back.

On Friday evening, Anushka left home around 7 pm. for private tuition via the home of her maternal uncle. But amid a local power outage, she was allegedly abducted, a little away from her own home.

Her uncle, Mrinal Sarkar, said, "She was dragged

a mango orchard. One of her slippers was found near the house, and marks of dragging were visible on the

When she did not return home, her family and neighbours began searching. Around 1 am., her bloodsoaked body was discovered in the or-

chard. Police sent the body for autopsy. Villagers, suspecting Shubho, confronted him at his residence and reportedly found bloodstains and fresh bandages on his hands. He was handed over to the police, who noted incon-

sistencies in his statements during questioning before placing him under arrest.

Preliminary investigation revealed deep wounds on Anushka's throat, along with multiple cut injuries on her hands, face, and other parts of the body.

The killing has triggered outrage in the area, with residents demanding the strong punishment for the accused. This case comes in the wake of the shocking murder of Ishita Mallick (18) last month, who was shot dead by her former boyfriend Deshraj in Krishnanagar after she ended their relationship.

Med commission advisory on rabies management to colleges

Kolkata: With timely administration of post-exposure prophylaxis (PEP) immediately after an animal bite rabies is 100 per cent preventable and at the same time it's also 100 per cent fatal, the National Medical Commission (NMC) states while issuing on advisory for medical colleges and institutions across the country on how to prevent the disease.

As rabies remains a major public health concern in India, primarily transmitted to humans through dog bites, the Union min-

welfare has directed all 780 medical colleges and institutions to play a pivotal role in ensuring timely case management, surveillance, training, and community awareness

Research showed that Bengal contributed highest 43 per cent of total rabies cases between 2005 and 2020 in the country.

The NMC, sole regulatory body that monitors medical education and research in teaching hospitals across states and union territories (UTs), in its advisory issued 16 September states: almost 100 per cent preventable with timely administration of post-exposure prophylaxis (PEP) immediately after an animal bite."

The teaching hospitals have been instructed to ensure the sustained availability of Anti-Rabies Vaccine (ARV) and Anti-Rabies Serum (ARS) for timely and effective management of animal bite victims.

The WHO report shows, India is endemic for rabies and accounts for around 36 per cent of the world's human rabies deaths transmitted by dogs.

istry of animal husbandry and dairying in February in Parliament, revealed that India reported 22 lakh dog bite cases and over five lakh cases of bites from other animals, including monkeys, in 2024 across the country.

This has allegedly led to the deaths of a total of 48 people, as per the data.

Showers threaten to spoil festive mood

Kolkata: As the countdown to Durga Puja begins, Bengal finds itself caught in the grip of late monsoon showers that show no signs of retreating. The weather office has warned that the rain clouds are likely to shadow Mahalaya, the day that marks the ceremonial invocation of the goddess, dampening festive spirits for both shoppers and traders.

The Alipore Meteorological Department on Friday said thunderstorms with scattered showers are expected in at least eight districts of south Bengal on Sunday, coinciding with Mahalaya. The affected districts may include South

24-Parganas, East and West Midnapore, Purulia, Bankura, West Burdwan, Birbhum and Murshidabad. Intermittent rain is likely to continue through the weekend.

Kolkata, which has so far escaped major weather alerts, may see light showers on Mahalaya. But forecasters cautioned that the city could receive scattered thunderstorms the following day, with gusty winds reaching 30 to 40 kilometres per hour across South Bengal. In North Bengal, where the rain has been heavier in recent weeks, the intensity is expected to ease after Saturday. Jalpaiguri and Alipurduar districts are un-

ers Friday, while Darjeeling, Kalimpong, Cooch Behar and Malda may face spells of rain Saturday. From Sunday onward, no major weather alerts have been issued for the region. Meteorologists said the wet spell has been triggered by a cyclonic circulation that recently formed over the Bay of Bengal and has now shifted toward eastern Bihar and adjoining areas.

Sitting about 1.5 km above sea level, the system continues to draw moisture inland, fuelling rains across the state.

The showers come as markets and pandals brim with the buzz of Puja preparations. nostalgic touch to the season. "We are used to battling the rain before the Puja," said Sushmita Dutta, a shopper in north Kolkata. "Umbrella in one hand, shopping bags in the other — this is part of the Mahalaya charm. On Friday, Kolkata record-

ed a minimum temperature of 28.6 degrees Celsius, about 2.3 degrees above normal. The maximum temperature on Thursday stood at 33.8 degrees Celsius, a degree higher than usual.

For now, Bengal's Puja spirit remains undeterred — even if the goddess is welcomed under cloudy skies.

State police to deploy 15,000 extra personnel for Durga Puja

Service, News Kolkata: With just nine days left before Durga Puja, West Bengal Police said Friday that it is prepared to manage massive crowds expected across the state during the biggest festival for Bengalis.

Additional 10,000 to 15,000 police personnel will be deployed across districts starting from Mahalaya, which marks the beginning of the festive season. The deployment will cover not just the four days of Puja but also the carnivals that follow, said additional director general (law and order) Javed

"From security at different ghats on Mahalaya to managing the rush of visitors during Puja days, we are ready," Shamim told reporters. "Police deployment has been made district-wise depending on the scale of festivities. Alongside the force from headquarters, home guards, NCC cadets, and local volunteers will also be roped

Traffic management will be a key focus during the fortnight-long celebrations that stretch beyond Durga Puja to Lakshmi Puja, he said. "Durga Puja is the biggest festival for Bengalis. Ensuring the safety of

visitors is our responsibility. We are prepared to give everyone a safe and enjoyable Puja," Shamim said. The Kolkata metropolitan area will see the largest deployment, but police officials are also giving special attention to suburban districts where large crowds gather. Mr Shamim cited Ranaghat in Nadia district as an example, pointing to the popular Puja at Kalyani ITI crossing and the large-scale celebration planned by Abhijan Sangha this year.

'Řanaghať draws a huge crowd. But when the homework is done in advance, crowd management is not a problem," he said.

After the main festivities conclude, carnivals showcasing idols from major pujas will be held in Kolkata and across districts. Police said those days also attract heavy footfall, requiring additional security and traffic control measures.

"Carnivals are as important as Puja days when it comes to law and order. We will ensure adequate deployment to prevent any untoward incident," Shamim said. Authorities expect record crowds this year as Durga Puja approaches its first anniversary since UN-ESCO recognised it as an Intangible Cultural Heritage of Humanity.

The IISCO Steel Plant (ISP) of the Steel Authority of India Limited (SAIL) will be expanded into a state-ofthe-art green steel facility, marking the largest single investment by the central government in West Ben-

gal to date. On Thursday, a significant agreement was signed between ISP, Burnpur, and a consortium comprising Metso India Pvt. Ltd., KolkThe contract pertains to the construction of a 2.673 MTPA (Million Tonnes Per Annum) Sinter Plant Complex—the first major project sanctioned under ISP's expansion initiative.

Surjeet Mishra, director-in-charge of ISP and Durgapur Steel Plant (DSP), confirmed that the agreement includes the installa-

NIA busts trafficking racket: 2 held in North 24 Pgns

MI News Service, Kolkata: In a major breakthrough against organized human trafficking, the National Investigation Agency (NIA) has arrested two individuals from North 24 Parganas for their alleged role in a crossborder trafficking racket that spans from Bangladesh to multiple Indian states.

The arrests follow an extensive probe that began after Odisha police rescued a minor girl from Bhuban eswar earlier this year. The victim, trafficked across the Bangladesh border, was first taken to Kolkata and then moved to Cuttack. Based on her statement, investigators unearthed leads pointing to an international trafficking network operating through the porous borders of North 24 Parganas. Acting on this

intelligence, the NIA team from Bhubaneswar, with the assistance of West Bengal's Special Task Force (STF), conducted coordinated raids on Saturday at multiple locations in Bongaon's Petrapole landport area and Gaighata's Dinga Malik. Two suspects— Amir Ali Sheikh, a Bongaonbased foreign currency trader, and Amal Krishna Mondal, a cloth merchant from Gaighata-were detained and interrogated for over 14 hours before being formally arrested. Investigators believe Krishna Mondal was responsible for arranging safe accommodation for trafficked victims after they crossed into India, while Sheikh handled the financial side of the operations through foreign exchange transactions

TMC forms core committees to resolve local factional conflict

MI News Service, Kolkata: In a strategic organizational revamp ahead of upcoming elections, the Trinamool Congress (TMC) is reportedly extending the "Birbhum model" of internal administration to districts across the state. The approach, which emphasizes the formation of core committees at block levels to manage factional conflicts, aims to strengthen cohesion and leadership streamline structures.

The model, first successfully implemented in Birbhum, replaces traditional block leadership with smaller core committees. Each committee, typically comprising six to eight members, is headed

by the district leadership. For instance, in Siuri Block 2 of Birbhum, a core committee has been estabwhile similar lished. committees have been formed in Sagardighi and Lalgola blocks, with MLA Byron Biswas and Ruma Banerjee appointed as conveners respectively. In Baharampur town, eight-member core committee replaces the town president, with Naru Gopal Mukherjee serving as convener. Meanwhile, the core committee framework is being mirrored in Hooghly, where Arambagh and Serampore organizational districts have also adopted this structure. In Balagarh, a seven-member committee

now oversees party activities, while a six-member committee in Khanakul Block No. 1 is headed by District President Ramendu Singh. Political analysts note that the core committee system allows for more agile decision-making and could help mitigate internal disputes ahead of elections. The TMC has previously im-

plemented this model in Birbhum and the Darjeeling plains, and now aims to consolidate party organiza-tion at the block level across multiple districts. Party insiders suggest that this structural shift could play a key role in strengthening organizational discipline and electoral readiness in the coming months.

Charu Market shootout sparks panic on MAHALAYA

MI News Service, Kolkata: The festive atmosphere of Mahalaya was jolted on Sunday afternoon when unidentified miscreants opened fire inside a gym in Kolkata's densely populated Charu Market area, triggering chaos and fear among residents. According to police and eyewitness accounts, incident occurred around 12:30 p.m. at a gym located on Deshpran Sasmal Road, barely 280 meters from Charu Market Police Station. The facility, situated on the ground floor of a residential building, was crowded with members at the time of the attack. Investigators said four armed assailants arrived on two motorcycles, all wearing helmets and raincoats. While two remained outside with the engines running, the other two entered the gym reportedly in search of its owner, identified as Joy. They questioned the receptionist about his whereabouts and, upon not finding him, fired two rounds inside the premises before fleeing. Eyewitnesses described scenes of panic as the gunfire echoed through the gym packed with members and the surrounding residential neighborhood. "The gym was full, and people outside on the street also rushed for cover when the shots were fired," one resident said. Although no one was injured, the brazenness of the day-light attack in a residential locality has left the commu-

nity shaken. "How can armed men move freely with weapons and fire in such a crowded place, right next to a police station?" asked a local resident, reflecting the growing anxiety over security in the area. Police officers from Charu Market station rushed to the spot immediately and cordoned off the area. Forensic teams have collected evidence, and CCTV footage from the vicinity is being scanned to track the assailants. As of late Sunday evening, no arrests had been made. Senior officials confirmed that the firing appeared to be a targeted attack, though the gym owner was not present at

ISRAEL offensive at Gaza kills 34

60 Jewish and Arab peace and reconciliation organisations, known as It's Time Coalition, called for an end to the war, the release of the hostages and the recognition of a Palestinian state. "We refuse to live forever by the sword. The UN decision offers a historic opportunity to move from a death trap to life, from an endless messianic war to a future of security and freedom for both peoples," said the coalition in a video statement.

Yet a ceasefire remains elusive. Israeli bombardment over the past 23 months has killed more than 65,000 people in Gaza, destroyed vast areas of the strip, displaced around 90 per cent of the population and caused a catastrophic humanitarian crisis, with experts saying Gaza City is experiencing famine. Israel didn't respond to the strikes. In a statement Sunday, the military said it killed Majed Abu Selmiya, who it said was a sniper for Hamas' military wing and was preparing to carry out more attacks in the Gaza City area, without providing evidence. The alleged militant is the brother of the director of Shifa hospital, Dr. Mohamed Abu Selmiya, who called the allegations a lie and said Israel was trying to justify the killing of civilians. Dr. Selmiya told The Associated Press that his brother, 57, suffered from hypertension, diabetes and had vision problems. As the attacks continue, Israel has ordered hundreds of thousands of Palestinians sheltering in Gaza City to move south to what it calls a humanitarian zone and opened another corridor south of the city for two days this week to allow more people to evacuate. Palestinians were streaming out of Gaza City by car and on foot, though many are unwilling to be uprooted again, too weak to leave or unable to afford the cost of moving. Aid groups have warned that forcing thousands of people to evacuate will exacerbate the dire humanitarian crisis. They are appealing for a ceasefire so aid can reach those who need it.

Freedom of speech not for hurting communities': SUPREME COURT

MI News Service, New Delhi: The Supreme Court asked five social media influencers, including "India's Got Latent" host Samay Raina, to display their unconditional apology on their podcast or show for ridiculing persons suffering from disabilities and



It said the court would consider imposing a penalty for offending disabled persons by social media influencers, including Raina at a later stage.

The five are accused of making fun of disabled and those suffering from Spinal Muscular Atrophy (SMA) and visual impairment. Except Sonali Thakkar alias Sonali Aditya Desai, who

was exempted from physical appearance subject to her undertaking that an unconditional apology will be aired in her programme, the rest of the social media influencers were present in the court. The bench told Attorney General R Venkataramani

that the guidelines for social media regulations should not be a knee-ierk reaction to one incident but based on broad based parameters incorporating views of all stakeholders. The top court also pulled up Raina for his affidavit giving an apology and said he initially tried to defend himself and tried to look innocent.

Complaints against RAMDEV was sponsored: Centre tells SC

MI News Service, New Delhi: The Supreme Court was on Tuesday informed that a closure report has been filed by Chhattisgarh Police in a case over voga guru Ramdev's alleged remarks against the use of allopathic medicines during the Covid pandemic.

Solicitor General Tushar Mehta brought the development to the notice of Justices M M Sundresh and Satish Chandra Sharma.

Mehta said the complaints against Ramdev appeared to have been 'sponsored" by some interested groups.

Senior advocate Siddharth Dave, representing Ramdev, said in line with the previous directions, Chhattisgarh filed its response but Bihar was yet to do it. The bench then adjourned the matter for December. Previously, the complainants were asked to be impleaded as parties in his plea seeking stay of the criminal proceedings.

The Patna and Raipur chapters of the Indian Medical Association (IMA) lodged complaints in 2021 alleging Ramdev's remarks were likely to cause prejudice to Covid control mechanism and may dissuade people from availing proper treatment.

Ramdev impleaded the Centre, Bihar, Chhattisgarh and IMA as parties.

Dave earlier said his client made a statement in 2021 that he does not believe in allopathic medicines to which some doctors took offence and



lodged multiple against him.

As an interim relief, Ramdev sought a stay on investigation on the criminal complaints.

The IMA lodged complaints in Bihar and Chhattisgarh over Ramdev's remarks against the use of allopathic medicines during the pandemic.

The yoga guru was booked under various provisions of IPC and the Disaster Management Act, 2005. Ramdev, whose statements stirred a nationwide debate on Allopathy versus Ayurveda had, however, withdrawn them after receiving a letter from then Union Health Minister Harsh Vardhan, who called his remarks

"inappropriate". The Delhi Medical Association (DMA), meanwhile, sought permission to become a party to the case, alleging that Ramdev insulted Allopathy and "instigated" people to disregard vaccines and treatment protocols.

The DMA, having 15,000 doctors as members, claimed Ramdev's Patanjali earned over Rs 1,000 crore by selling "Coronil" kits which were not approved by the competent authority.

Intensive Ticket Checking Drive at Howrah Station Yields Significant Results

Delhi airport's revamped Terminal 2 to be operational from Oct 26

The Indira Gandhi International Airport (IGIA) in the national capital, also the country's busiest airport, has three terminals - T1, T2 and T3.

The upgraded Terminal 2 at the IGI airport is set to become operational from October 26, coinciding with the beginning of the winter schedule, airport operator DIAL said in a release.

"From the intervening night of October 25-"26, 2025, approximately 120 daily domestic flights operated by Air India and Indigo are set to shift operations to the upgraded Terminal 2," the release said. Currently, T1 and T3 are operational. IGIA, operated by the Delhi International Airport Ltd (DIAL), has four runways and handles around 1,400 flight movements daily.

A mega multi-speciality health camp was jointly organised by the Indian Minorities Federation (IMF) and the New India Development (NID) Foundation at Nangal in Punjab as part of Sewa Pakhwada (Fortnight of Service) dedicated to the celebrations of PM Modi's 75th birthday to provide underprivileged communities access to essential health services in line with the Modi government's goal for ensuring quality healthcare for every citizen.

The doctors and health experts present at the Health Camp said PM Modi has ensured easy access to quality and affordable healthcare for every Indian during the last 11 years.

They added that after introducing transformative healthcare initiatives like Jan Aushadhi Kendras and Ayushman Bharat, the Modi government has now implemented GST reforms, reducing GST on essential health products and exempting 33 life-saving medicines from tax.

Service, Mumbai: Maharashtra Chief Minister Devendra Fadnavis on Sunday lauded the recently approved Goods and Services Tax reforms and termed it as a "historic initiative".

Speaking to the reporters, CM Fadnavis stated that the "bold" step taken by the PM Narendra Modi-leď Union Government will reduce the prices of daily-use products. He also considered the step as a massive boost to the Indian economy and the Atmanirbhar Bharat initiative.

'The second generation GST reforms are a historic initiative...This is a very bold step taken by the PM Modi-led government and the prices of daily-use products will reduce and they will highly benefit from it...This will also boost the Indian economy and is a big step towards 'Atmanirbhar Bharat'," Devendra Fadnavis told reporters.

Earlier today, Prime Minis-ter Narendra Modi urged citizens to adopt Swadeshi and prioritise Made in India products, as the newly approved Goods and Services Tax (GST) reforms come into effect from September 22, the first day of Shardiya Navaratri'.

"We need to make every home a symbol of Swadeshi... every shop should be adorned with Swadeshi products," the Prime Minister said in his address to the nation.

Calling the GST reforms a "Bachat Utsav", Modi appealed to people to buy products made in India, saying they carry the hard work and "sweat" of the country's youth. "We should buy products that are Made-In-India... in which the hard work of our country's youth is involved... the sweat of our country's sons and daughters,"

The Prime Minister said the GST reforms reflect the Union Government's "Nagrik Devo Bhava" mantra and will result in substantial savings for the



following the mantra of 'Nagrik Devo Bhava', and we can see its reflection in the next generation's GST reforms. If we combine the income tax exemption and the GST exemption, the decisions made in one year will save the people of the country more than Rs 2.5 lakh crore, and that's why I say, 'This is a savings festival," he said. Emphasising self-reliance

as the path to a developed India, Modi said the reduction in GST rates will directly benefit small businesses and MSMEs. "To reach the goal of a developed India, we must walk on the path of self-reliance, and a very big responsibility to make India self-reliant also lies on our MSMEs. What is needed by the people of the country, what we can make in our own country, we should make right here in the country... The reduction in GST rates and the simplification of rules and procedures will greatly benefit our MSMEs, small industries, and cottage industries," he added.

He also drew a parallel between Swadeshi during the independence movement and the

drive for economic strength. Their sales will increase, and they will have to pay less

ceive a double benefit... Just as the country's independence gained strength from the mantra of Swadeshi... similarly, the country's prosperity will also gain strength from the mantra of Swadeshi alone," he said.

The reform in the Goods and Services Tax (GST) structure approved during the 56th meeting of the GST Council earlier this month is set to come into effect from Septem-

The current four-rate system will now be replaced with a streamlined two-slab regime of 5 per cent and 18 per cent. A separate 40 per cent slab has been retained for luxury and sin goods.

This new framework is expected to ease compliance, reduce consumer prices, boost manufacturing, and support a wide range of industries, from agriculture to automobiles and from FMCG to renewable energy, and is intended to lower the cost of living, strengthen MS-MEs, widen the tax base, and drive inclusive growth.

The textile and handicrafts industries are also major beneficiaries. The inverted duty structure on man-made fibres has been corrected, and GST on yarn and fibres has been reduced to 5 per cent.

ED raids premises of **Imperial Group in Himachal Pradesh** and Delhi for **FEMA** provisions

Directorate of Enforcement (ED) conducted search operations at six premises located in Himachal Pradesh and Delhi belonging to Imperial Group owner Manavinder Singh, his wife Sagri Singh and related entities as part of a foreign exchange violation probe linked to alleged undisclosed foreign assets, a release said. The search operations on Friday and Saturday were conducted under the provisions of the Foreign Ex-Management Act change (FEMA) 1999 in connection with an investigation related to undisclosed assets held outside India, undisclosed foreign investments and the financial interests of Sing, his wife and the entities under the Imperial Group, the release said.

The Imperial Group is a group of companies operating inter alia in the aerospace and real estate sectors and is chaired by Singh.

The Auramah Valley luxury residential project in Himachal Pradesh's Naldehra is also a part of the aforesaid group.

Additionally, according to the seized financial statements and records pertaining to the undisclosed foreign entities and undisclosed assets held outside India, the value of those located outside India in Singapore, Dubai, British Virgin Islands and Thailand is more than Rs 80 crore.

Earlier, ED provisionally attached immovable properties valued at Rs 696.21 crore located in Haryana's Panchkula in connection with its ongoing probe in the case of Pearl Agro Corporation Limited (PACL) and others under the Prevention of Money Laundering Act.

ED said its investigation stems from the Central Bureau of Investigation's First Information Report registered on February 19, 2014, against PACL Ltd, PGF Ltd, late Nirmal Singh Bhangoo, and others.

The case pertains to massive fraudulent collective investment schemes floated by PACL, through which the company and its associates deceitfully raised and misappropriated around Rs 48,000 crore from unsuspecting investors, which constitutes Proceeds of Crime (POC).

ED's investigation has revealed that the funds mobilised from lakhs of investors were layered and diverted through multiple transactions to conceal their illicit origins. "Part of the tainted funds

were utilised for the acquisition of 11 immovable properties, valued at Rs 696.21 crore, in the names of entities such as DSS Megacity Pvt Ltd, Saramati Realtors Pvt Ltd, Saramati Techno Build Pvt Ltd, Shiv Megacity Project Pvt Ltd, and Roseco Builders Pvt Ltd. The layering was deliberately structured to project the assets as legitimate, thereby attempting to mask the Proceeds of Crime," said the agency in a

Study finds body temperature is linked to depression

WASHINGTON: A study from UC San Francisco revealed that individuals with depression may benefit from lowering their body temperatures, as they tend to be higher. The study, published in Scientific Reports, does not clarify whether depression causes increased body temperature or vice versa. People with depression may have a higher body temperature due to impaired self-cooling, increased heat output from metabolic processes, or a commetabolic processes, or a com-UC San Francisco revealed metabolic processes, or a combination of the two. Researchers analyzed data from more than 20,000 international participants who wore a device that measures wore a device that measures body temperature and also self-reported their body temperatures and depression symptoms daily. The sevenmonth study began in early 2020 and included data from 106 countries. The results showed that with each increasing level of depression symptom severity, participants had higher body temperatures. The body temperatures data also showed a trend data also showed a trend toward higher depression scores in people whose temperatures had less fluctuation throughout a 24-hour period, but this finding didn't reach significance. The findings shed light on how a novel depression treatment method might sion treatment method might work, said Ashley Mason, PhD, the study's lead author and associate professor of psychia-try at UCSF Weill Institute for Neurosciences. A small body of existing, causal studies has found that using hot tubs or saunas can reduce depression,



possibly by triggering the body to self-cool, for example, through sweating.

"Ironically, heating people up actually can lead to rebound body temperature lowering that lasts longer than simply cooling people down directly, as through an ice bath," said Mason, who is also a clinical psychologist at the UCSF Osher Center for Integrative Health

"What if we can track the body temperature of people with depression to time heat-based treatments well?"

"To our knowledge, this is the largest study to date to examine the association between body temperature assessed using both self-report methods and wearable sensors - and depressive symptoms in a geographically broad sam-

ple," added Mason.
"Given the climbing rates of depression in the United States, we're excited by the possibilities of a new avenue for treatment."

Study reveals key protein that helps prevent excessive bone loss in osteoporosisHotter weather due to climate change could lead to more mosquitos: Study

Tokyo: Osteoporosis, a disorder characterised by porous and weak bones, is a major hazard to skeletal health. As the foundation of the human body, bones provide critical structural support. When bone mass decreases, it not only weakens this support but also lowers general function, resulting in a lower quality of life.

With an ageing population and a rise in osteoporosis cases, the burden on healthcare resources for long-term care is clear. As a result, there is a need to understand the mechanisms that cause osteoporosis and develop effective targeted therapeutics to mitigate its long-term effects. Osteoblasts and osteoclasts are two types of cells that play critical roles in bone tissue maintenance and remodelling. Osteoblasts are bone-forming cells that synthesise and deposit new bone tissue, whereas osteoclasts break down and remove old or damaged bone tissue. Increased proportion of osteoclasts causes bone mass loss in situations such as osteoporosis, rheumatoid arthritis (joint inflammation), and bone metastases (cancer that has spread to the bones). Osteoclasts develop from the development of macrophages or monocytes, two types of immune cells. Suppressing osteoclast differentiation could thus be used as a therapeutic technique to prevent bone loss. However, the precise molecular pathways driving the complicated process remodelling are

In a new groundbreaking Professor TadayoshiHayata, Mr. Takuto Konno, and Ms. HitomiMurachi from Tokyo University of Science, along with their co-workers, delved deeper into the molecular regulation of osteoclast differentiation. Receptor activator of nuclear factor kappa B ligand (RANKL) stimulation induces the differentiation of macrophages into osteoclasts. Further, bone morphogenetic protein (BMP) and transforming growth factor (TGF)-b signaling pathways have been implicated in the regulation of RANKL-mediated osteoclast differentiation. In the current study, the researchers sought to investigate the role of Ctdnep1 - a phosphatase (an enzyme that removes phosphate groups) that has been reported to suppress BMP and TGF-b signaling.

Giving further insight into their work set to be published on July 30, 2024, in Volume 719 of Biochemical and Biophysical

Hayata states, "RANKL functions as an 'accelerator' for osteoclast cell differentiation. Driving a car requires not only the accelerator but also the brakes. Here, we find that Ctdnep1 functions as a 'brake' on osteoclast cell differentiation." First, the researchers examined the expression of Ctdnep1 in mouse-derived macrophages treated with RANKL and untreated control cells. They noted that Ctdnep1 expression remained unchanged in response to RANKL stimulation. However, it localized in the cytoplasm in granular form in the macrophages and differentiated into osteoclasts, distinct from its normal peri-nuclear localization in other cell types, indicating its cytoplasmic function in osteoclast differentiation. Further, Ctdnep1 knockdown (downregulation of gene expression) resulted in an increase in tartrate-resistant acid phosphatase-positive osteoclasts; wherein TRAP is a marker for differentiated osteoclasts. Additionally, Ctdnep1 knockdown led to an increase in the expression of crucial differenmarkers including 'Nfatc1', a RANKL-induced master transcription factor for osteoclast differentiation. These results

Ctdnep1, whereby, it negatively regulates osteoclast differentiadown also led to increased absorption of calcium phosphate, suggestive of the suppressive role of Ctdnep1 in bone resorption. Lastly, while, Ctdnep1 knockdown did not alter BMP and TGF-b signaling, cells deficient in Ctdnep1 showed elevated levels of phosphorylated (activated) proteins downstream of the RANKL signaling pathway. These findings suggest that the suppressive effect of Ctdnep1 in osteoclast differentiation may not be mediated by BMP and TGF-b signaling, but, through the negative regulation of RANKL signaling and Nfatc1 protein levels.Overall, these findings provide novel insights into the process of osteoclast differentiation and reveal potential therapeutic targets which can be pursued to develop treatments that address bone loss due to excessive osteoclast activity. In addition to diseases characterized by bone loss, Ctdnep1 has also been reported as a causative factor in medulloblastoma - a childhood brain tumor. The authors are, thereoptimistic that their research can be extended to other human diseases beyond bone

VIRGINIA [US]: A recent study conducted by Virginia Commonwealth University scientists found that a warmer environment may result in more mosquitos as predators struggle to maintain their

As the cover feature in Ecology, a journal published by the Ecological Society of America, the study -- "Warming and Top-Down Control of Stage-Structured Prey: Linking Theory to Patterns in Natural Systems" -- found that rising temperatures, often linked to climate change, can make predators of mosquito larvae less effective at controlling mos-

Warmer temperatures accelerate the development time of larvae, leading to a smaller window of time for dragonflies could eat them.

This means there could be nearly twice as many mosquito larvae that make it to adulthood in the study area. The researchers looked at riverine rock pools at Belle Isle along the James River in Richmond and found that warmer temperature pools had more aquatic mosquito larvae, even when their predators that naturally control the populations were present. The native rock pool mosquito is not an important disease vector, but it is one of the few local mosquitos that doesn't have to feed as an adult to lay eggs. So the findings might apply to similar taxa, like the invasive Asian

rock pool mosquito. "We might see larger populations of everyone's least favorite bug, mosquitos. While the mosquito larvae we studied here [are] the North American rock pool mosquito, these findings likely apply to species of mosquito that do act as vectors for diseases like West Nile or even Zika virus," said Andrew T Davidson, PhD, lead researcher on the



study. He conducted the research through the PhD program in VCU's Center for Integrative Life Sciences Education. Predators help stabilize ecosystems and food webs, and the study looked at predator-prey interaction between dragonfly nymphs and mosquito larvae. Before fieldwork, the research was rooted in concepts of thermal physiology and short-term lab experiments that yielded predictive models of the relationship between predators, prey and temperature in the field. The field study then tested the models in a completely natural environ-

The study builds on Davidson's earlier research in Functional Ecology as well as work by lab mate C. Ryland Stunkle and the rest of the VCU rock pool team. The team also acknowledges the collaborative support of professor Brian Byrd of Western Carolina University's College of Health and Human Sciences. The recent work led by Davidson was part of a larger National Science Foundation grant that has involved scientists from VCU, the University of Richmond, Radford University, Western Carolina University and Eastern Carolina University. The collaborative award of nearly USD 1 million has included nearly USD 400,000 for VCU.

Adjuvants, pesticides disrupt honey bee's sense of smell: Study

WASHINGTON: Pesticide sprays have long been recognised as a threat to honey bees. In a new study, researchers uncovered the influence of such sprays on bees' sense of smell, which could disrupt their social signalling.

Honey bees live in dynamic communities and constantly communicate with each other using chemicals that serve as social cues. For example, nurse bees-who are responsible for taking care of larvae that ultimately become queens and worker bees--constantly monitor the larvae in the dark using pheromones.

The larvae emit brood pheromones to indicate that they need food. There are also alarm pheromones that workers produce to warn the other bees of danger. If these cues are dampened or not perceived properly, the colony may fail to thrive.

Since 2007, scientists have known that honey bees have been in trouble. One of the stressors that have raised concerns is insecticides, which affect honey bee health. Because these are usually used in combination with other chemicals, the resulting mixture can become unexpectedit was assumed that fungicides do not have an adverse impact on insects because they are designed for fungal targets," said May Berenbaum (GEGC/IGOH), a professor of entomology. "Surprisingly, in addition to

insecticides, fungicides also have an adverse effect on bees and combining the two can disrupt colony function.

For more than a decade, reports originating from almond orchards, where two-thirds of the US honey bees are transported every year when the flowers are in bloom, implicated pesticide spray mixtures. In particular, the problem lies in the use of supposedly inactive chemicals called adjuvants, which increase the "stickiness" of the insecticide so it stays on the plants.

Because adjuvants have long been considered to be biologically benign, they are not subject to the same level of safety testing as other insecticidal agents.

"Recently, researchers have shown that adjuvants alone or when used in combination with fungicides and insecticides are toxic to bees," Berenbaum said.



Nurse bees are especially vulnerable to these combinations.

"The health of the queens is

healthy queens are not produced, paramount," Berenbaum said. "If the colony can suffer." To under-

stand how combinations affect nurse bees, the researchers tested their effect on the olfactory system of honey bees using the adjuvant Dyne-Amic, the fungicide Tilt, and the insecticide

The researchers divided bees into four groups of ten bees and for a week exposed them to either untreated commercial pollen or to pollen that had been treated with either Dyne-Amic, or Tilt and Altacor, or all three

The bees were then anesthetized on ice and one antenna was carefully removed from each bee. The researchers then exposed the antenna to chemical mimics of brood and alarm pheromones and recorded the antenna's response using a technique called electroantennogra-

phy.
With this method, Ling-Hsiu Liao, a research scientist, and Wen-Yen Wu, a graduate student, in the Berenbaum lab, found that when nurse bees had consumed pollen contaminated by the three chemicals, their antennal to some responses pheromones and

Their finding suggests that these commonly-used pesticides can interfere with honey bee communication.

How these chemicals interact and influence the bees is still unclear. "There are many possible explanations for how consuming these chemicals can affect the sensory responses of bees," Liao said. "The antenna detects and triggers the response to olfactory signals. In this study we did not look at what other changes are triggered, particularly changes in behavior.'

In addition to parsing out the underlying molecular pathways that are affected, the researchers are also interested in testing other mixtures of commonly used pesticides as well as looking at the response of bees in other populations. They hope that their work can help beekeepers rethink how they manage and protect their colonies.

The study "Effects of pesticide-adjuvant combinations used in almond orchards on olfactory responses to social signals in honey bees (Apismellifera)" was published in Scientific Reports.

Indian Railways Enhances Freight Connectivity with Time-tabled Cargo Services

MI News Service, New Delhi : Indian Railways has taken a significant step in freight logistics by launching scheduled, commodity-specific, time-tabled cargo services, connecting key production and consumption centres across the northern region. These services aim to improve customer satisfaction, ensure reliable transit times and provide industry-aligned logistics solutions. The newly introduced services

include the Annapurna Service from Ludhiana to Varanasi, transporting foodgrains over 704 km in an average of 17 hours; Gati-Vahan Service from Farrukhnagar (Haryana) to Lucknow for automobiles, covering 557 km in 28 hours, down from the earlier 70-hour transit; Niryaat Cargo Service from Garhi to Mundra Port for containers, covering 1061 km in 32 hours; and Anantnag Cement Cargo Service from Roopnagar to Anantnag, transporting cement over 586 km



in 31 hours. Extensive planning and coordination were undertaken with freight stakeholders, including FCI, automobile operators, container train operators and adjacent railway zones, to chart suitable paths across inter-divisional and interzonal networks. Initially introduced as trial services, these time-tabled cargo trains have now stabilised and are operating efficiently.

The feedback from customers has been highly encouraging. FCI appreciated the Annapurna Service for improving the dispatch of sponsored foodgrains from surplus areas of Punjab and Haryana to deficit regions in Uttar Pradesh, allowing better labour and truck planning at unloading points. Maruti Suzuki Ltd. highlighted the Gati-Vahan Service's reduction in transit time from 70 hours to 28

hours, helping ensure delivery commitments comparable to road transport. Exporters using the Niryaat Cargo Service reported transit times of less than 40 hours to Mundra Port, enabling timely coordination with ports and shipping companies. Cement firms welcomed the Anantnag Cement Cargo Service and the opening of the Anantnag goods shed, which streamlined labour and truck operations, boosting rake dispatches despite weather disruptions.

With scheduled timings and advance information on train arrivals and departures, these services are enabling better logistics planning for both consignors and consignees, enhancing pre-dictability and efficiency. Indian Railways remains committed to strengthening freight connectivity and providing world-class, reliable services that support industry, trade and regional development.

Beth Mooney predicts special outing for Australia in Women's **Cricket World Cup**

NEW DELHI: Australian opener Beth Mooney believes that there is no limit to what their team can achieve in the ICC Women's Cricket World Cup 2025 with a fully fit squad, according to an ICC statement.

In their final outing before the ICC Women's Cricket World Cup 2025, defending champions Australia overcame a feisty Indian batting effort to seal a series win with a record outing in Delhi.

This win was possible on the back of Beth Mooney's 138 off 75 balls, a knock during which she equalled the third-fastest century in Women's ODIs.

Speaking after the contest, the Player of the Match, Mooney, believed the result boded well for her side going into the World Cup.

"To win World Cups, you need to be the most adaptable team and the most composed team," Mooney said, as quoted by the ICC. "We showed that a lot tonight, when Smriti was obviously coming quite hard (at us), and building some partnerships with Harman (HarmanpreetKaur), and then Deepti (Sharma) coming in at

the end," she added.

While Australia posted a record 412 after Mooney's effort, their joint-best total in ODIs, equalling 412/3 made in the 1997 World Cup against Denmark, India gave them a fright with a blazing start.

SmritiMandhana's sensational 125 led the chase, with the batter scoring the second-fastest ton in the format. She was ably supported by Deepti Sharma and HarmanpreetKaur's quick fifties. However, Australia managed to keep their cool, with Megan Schutt (2/53) and Kim Garth (3/69) leading the way with the ball. Schutt reached the landmark of 300 international wickets, just the second Australian to achieve the feat in women's cricket apart from Ellyse Perry.

Mooney was pleased with Australia's bowling effort, and added that once the likes of Annabel Sutherland and Phoebe Litchfield, who had both missed the game, returned to the XI, there was no limit to what the side could do at the World Cup.

"It's been nice to see the girls come up with different ideas on the field, and the fielders back it up. Obviously, Belsy (Annabel Sutherland) Phoebe and (Litchfield) have been on the sidelines. So, when they get their opportunity in the side, once they are fit and firing, there's absolutely no ceiling for this group. I think there for this World Cup," she noted. Mooney showered her praise on Mandhana, who went on to win the Player of the Series award for her 300 runs.

China Masters Final: Satwiksairai. Chirag go down in straight games, settle for runner-up spot

BEIJING: India's highly rated SatwiksairajRankireddy ChiragShetty once again saw the

gold medal slip out of their grasp after they came up short in the final at the China Masters on

At Shenzhen Arena, Satwik and Chirag faced a stern test against world number one and crowned Champions Kim Won Ho and SeoSeung Jae of South Korea. Despite putting in the hard yards, the Indian duo failed to complete the quest and went down with a 19-21, 15-21 defeat in a contest that lasted for 45 minutes.

Last week, the duo settled for a runner-up spot at the Hong Kong Open 2025 after fumbling against China's Liang Wei Keng and Wang Chang. At the end of August, Satwik and Chirag had to make do with a bronze medal at the BWF World Championships after suffering a heartbreak in the semi-final against Chen Bo Yang and Liu Yi of China. The pattern once again continued for the duo.

In a final that was decided in straight games, the South Korean pair raced to a 0-3 lead in the opening game, but Satwik and



to restore parity at 3-3. In the fastpaced rallies, the Indian pair thrived with their attacking intent and quickly gained a 10-7 lead.

The Indian pair went from strength to strength and established a handy 14-7 advantage. The unforced errors came back to haunt them as the South Korean's mounted an imposing comeback. sued their opposition and caught up to them at 15-all. The world number one pair reclaimed their lead at 18-19 and eventually wrapped up the game to go 1-0

The second game bore a resemblance to its predecessor, with Satwik and Chirag enjoying a slender advantage at 8-6.

However, once again, the South Korean shuttlers turned the tide after the halfway mark. With precision and a delightful drop shot, the path for gold was clear. Satwik pusned nis return serve long, handing the crown to Kim and Seo. The Indian pair was forced to reflect on another silver lining finish in the quest for

Ram Gopal Kothari becomes first Indian to complete marathon at Geographic North Pole



NEW DELHI: Kolkata-born entrepreneur and explorer Ram Gopal Kothari etched his name in history by becoming the first Indian to complete a full marathon at the Geographic North Pole -- a feat achieved by only a rare few worldwide.

The North Pole Marathon is a race like no other, held on drifting sheets of sea ice only a few metres thick, floating above frigid Arctic waters. Athletes face temperatures around minus 8-degree Celsius, piercing winds that cut through layered clothing, and even the possibility of polar bears straying near the course. With an icebreaker ship on standby, armed patrols for safety, and a dedicated medical team, the event feels less like a marathon and more like a true Arctic expedition.

This edition saw participants depart from Longyearbyen, Svalbard, aboard the French icebreaker Le Commandant Charcot. The voyage spanned from 78°N to 90°N across dense sea ice, providing remarkable wildlife sightings of polar bears, seals, walruses, and blue whales along the way, as per a press release.

For Kothari, who was attempting his first-ever full marathon, the race was a trial of willpower. The first 21 kilometres went smoothly in two hours and 45 minutes. But from the 28th kilometre onwards, slushy melting ice caused his legs to sink with every step, soaking his shoes and sparking severe cramps. He suffered nine muscle cramps and an injured toe, but refused to stop. "I was not just running on ice," he later said.

"I was running on a promise, and on the belief that India has a place everywhere -- even at the top of the world." He finished in just over eight hours," he added.

What makes Kothari's feat even more inspiring is the story behind it. Growing up in Burrabazar, Kolkata, in a modest two-room home with an asbestos roof, he shared a single toilet with his extended family. He studied at Shree MaheswariVidyalaya where his success is now a source of pride for the community. Though he calls himself an average student, he acknowledges that the strength and determination instilled by his parents became the foundation of his extraordi-

nary journey.
In 2012, his world seemed to collapse. Crushed by financial losses and mental strain, he came close to ending his life. Then came a call from his wife, Shipra, asking him to hold on for their children a moment that changed everything. Picking himself up, he restarted with door-to-door insurance sales on the footpath. Slowly, grit turned into growth, and today his enterprise spans five offices across India. Travel gradually became central to Kothari's pursuits. He completed his first halfmarathon at the Tata Mumbai Marathon in 2018 and, by 2022, had visited all seven continents, including Antarctica, reached via

the challenging Drake Passage.
Kothari's explorations cover some of the most extreme destinations on the globe. They include staying in an igloo in Greenland, experiencing the Polar Night in Svalbard with its 24 hours of darkness illuminated by the northern lights, visiting Yakutia, the coldest inhabited city, and skydiving in Empuriabrava, Spain He has also been to Ushuaia, the southernmost settlement on Earth, and swum with whale sharks and humpback whales in the Pacific Ocean, even making physical contact while scuba div ing. Closer to danger, he once fell nearly 100 metres while attempting Mount Elbrus in Europe, yet survived to continue climbing and running. Following his North Pole achievement, Kothari has outlined ambitious future goals; completing the World Marathon Challenge of seven marathons on seven continents in seven days, summiting the highest peaks on each continent, and travelling to 100 countries by 2027. He has currently visited 70 nations.

CPL 2025 final: Guyana Amazon Warriors Face Trinbago Knight Riders in high-pressure showdown

blockbuster final in the Caribbean Premier League (CPL) as Guyana Amazon Warriors lock horns with Trinbago Knight Riders (TKR) on Sunday at Providence. With two old rivals meeting again, the build-up has been charged with excitement among both players and supporters. Coaches Lance Klusener and Ottis Gibson believe that keeping emotions under control will be crucial in deciding the champion, as per ESPNcricinfo.

TKR's assistant coach Ottis Gibson highlighted the importance of experience in big games, pointing to the likes of Nicholas Pooran, Kieron Pollard, Andre Russell and Sunil Narine, stalwarts of T20 leagues across the world.

"Emotions - that's the beauty of sport, isn't it? I guess the team that handles those emotions the best will most likely come out on top," Gibson said, as quoted from ESPNcricinfo.

'This is the CPL final - it's a big day in the Caribbean. (These are) two of the best teams over a number of years now in the final. Guyana will have home advantage and a lot of crowd support behind them," he added.

"But we, as Trinbago, will also carry a lot of travelling support. We've got a lot of experienced players that have won big finals before - IPL (Indian Premier League), World Cups - and we've been leaning on that experience throughout the tournament. And we will be doing that tomorrow night as well," he noted. "It's just (about) controlling those emotions and trying to make sure they don't get in the way of making cricket-



ing decisions on the move,' Amazon Warriors' Klusener said. "Not really much more to add to that (from Gibson)," he added. Trinidad has long been regarded as the heartbeat of T20 cricket, producing global stars year after year. Pollard, now nearing the end of his illustrious playing career and already stepping into coaching roles in the IPL, remains a towering presence. Pooran, meanwhile, has taken over as the new

face of Caribbean batting, a sixhitting powerhouse. Yet, despite playing in 12 CPL seasons, the left-hander is still chasing his maiden CPL title. According to Gibson, the hunger to finally lift the trophy in his home league has given Pooran added motivation this year. For TKR, their last title came in 2020, when Pollard led the side to an unbeaten season. Since then, however, consistency has eluded them. "Look, Trinidad,

as the gold standard for T20 cricket in the Caribbean," Gibson said, as quoted from ESPNcricinfo.

The number of world-class players that they've produced... (but) we haven't won it (CPL title) since 2020. And that's the main motivator really; we haven't won it for so long. So the opportunity to do that is a massive driver for everybody. So, Andre especially; Nicholas Pooran has never won the CPL. So there's a lot of reasons why everybody is really motivated for tomorrow night. We can't wait to get started," he added.

On the other side, the Warriors will be banking on youthful firepower. Among their standout performers this season has been Quentin Sampson, a 25-year-old local talent who rose from tapeball cricket to the CPL stage. Opening the innings, Sampson has smashed his way into the limelight with back-to-back fifties against St Lucia Kings and Barbados Royals, playing a key role in Guyana's journey to the final. "Sampson has taken his opportunity," Klusener said, as quoted from ESPNcricinfo. "Sport is about taking those little opportunities that come along. So he's responded to that, and I'm thoroughly happy for him. The ball is in his court now as to where he goes with that talent and with those performances he's shown," he noted. This competition will finish, and he will go back to his country, and it's up to him to make those changes that he needs to make and grow. As coaches you can only do so much; a lot of it comes from the person inside. So watch this space and let's see how he goes," he said.
