News Jammu: The elections to fill four Rajya Sabha seats from Jammu and Kashmir, which have been lying vacant since 2021, will be held on October 24, the Election Commission said on Friday

Separately, Rajya Sabha by poll to fill the vacancy created by the resignation of AAP member from Punjab Sanjeev Arora will also be held on October 24.

He had resigned following his election to the Punjab assembly. His Rajya Sabha term was to otherwise end on April 9, 2028.

While announcing the schedule, the EC said that the erstwhile state of Jammu and Kashmir was bifurcated into the Union Territories of Jammu and Kashmir (with legislature) and Ladakh (without legislature).

As per the Jammu and Kashmir Reorganisation Act, four sitting members of the Rajya Sabha representing the existing State of Jammu and Kashmir will be deemed to have been elected to fill the seats allocated to the Union Territory of

Jammu and Kashmir. All four seats were lying vacant since the expiration of the term of the sitting members due to the non-availability of the required electorate to conduct the elections at the time of occurrence of the vacancies.

After the constitution of the State Legislative Assembly of UT of Jammu and Kashmir, there is a required electorate to conduct the Biennial Elections, it noted.

MiG-21 flies through Indian skies for last time

Chandigarh: The legendary Mikoyan-Gurevich MiG-21 fighter jets, the backbone of the Indian Air Force's combat fleet for more than six decades, streaked through Indian skies for the last time on Friday -- its final adieu threaded through history and many a remembrance.

The sun shone bright, the skies were cloudless and a brilliant blue, providing a picture perfect setting for the elaborate farewell to the Russian origin warhorse that was inducted into the IAF in

Describing the MiG-21 as a mighty machine and a national pride, Defence Minister Rajnath Singh said there is deep attachment to the aircraft that shaped our con-

"MiG-21 is not only an aircraft or machine but also proof of deep India-Russia ties," the Defence minister

"The history of military aviation is incredible. The MiG 21 added many proud moments in our military aviation journey," Singh told the gathering.

There has been no fighter jet in the history of globai military aviation made in such big numbers, the minister said. More than 11,500 MiG 21 aircraft were made. Of them, 850 fighter jets remained part of the IAF, he

"This number is the testimony of this aircraft's popularity, credibility and multi-dimensional capability," Singh said while pointing out that its contribution was not been limited to one incident or a war.

He also recalled its role in the 1971 war with Pakistan, the 1999 Kargil conflict as well as the 2019 Balakot air

Besides him, former IAF chiefs A Y Tipnis, S P Tyagi and B S Dhanoa, Group Captain Shubhanshu Shukla, India's first man on the International Space Station, and scores of veterans, many who had piloted the aircraft, were present on the occasion.

Air Chief Marshal A P Singh flew the sortie of the MiG-21 Bison aircraft with call sign Badal 3.

Dilbagh Singh, who became the IAF chief in 1981, led the first MiG-21 Squadron here in 1963.

The culmination of MiG-21 operations took place with a ceremonial flypast and decommissioning event, marking the closure of a historic

chapter in India's air power. The country's first supersonic fighter and interceptor aircraft were retired at the decommissioning event in Chandigarh, where it was first inducted.

The ceremony marked by a spectacular display by IAF's elite skydiving team 'Akash Ganga', which skydived from a height of 8,000 feet.

This was followed by a majestic flypast of the MiG-21 aircraft accompanied by precision of the air warrior drill team and an aerial sa-

The fighter pilots flew MiG-21s in the three-aircraft Badal formation and the four-aircraft Panther formation roared over the skies one final time

The Surya Kiran aerobatic team also enthralled the audience with their breathtaking manoeuvres.

MiG-21 jets, belonging to number 23 Squadron, took part in the flypast ceremony, and were given a water cannon salute.

The Jaguar and the Tejas aircrafts also took part in the ceremony.

Tejas is an indigenously built single-engine multirole fighter aircraft capable of operating in high-threat air environments. It has been designed to undertake air defence, maritime recon-

Durga Puja likely to be wet this year :IMD MI News Service, Kolkata: Even as the people are yet to recover from the effect of last Tues-

day's unprecedented rainfall in the city and its neighbourhood inundating many localities and claiming as many as ten lives in electrocution, the India Meteorological Department (IM D) has forecast light to moderate rainfall at many places in South Bengal over the next seven days, owing to a low-pressure system formed over the Bay of Bengal on Friday.

This has once again raised apprehension about a wet Durga Puja festival that commences on September 28.

It said that heavy rain is likely to occur in South 24 Parganas, Kolkata, Howrah, East and West Midnapore, Jhargram, Nadia and East and West Burdwan districts on September 27 and 28..

The low pressure area is likely to concentrate into a depression and thereafter cross the south Odisha-Andhra Pradesh coasts on Saturday, the

The four-day Durga Puja festival will commence on September 28, with the day being celebrated as 'Maha Shasti'. The IMD advised fishermen not to venture into the sea till Sunday along and off the West Bengal-Odisha coast as the sea condition is likely to be rough to very rough owing to the weather conditions.

Kolkata weather today shows overcast conditions with temperatures ranging from 26°C to 31°C . Weather in Kolkata today features generally cloudy skies with light rain and thundershowers continuing throughout the day. Humidity remains high at 79% with wind speeds at 10 km/h and visibility at 8 km due to misty conditions.



Heavy rain in Kolkata on September 22-23 created unprecedented chaos, with the city recording 251.4mm rainfall in 24 hours-the third-highest September rainfall since 1978. This deluge was exceeded only by 369.6mm on September 28, 1978, and 259.5mm on Septem-

Waterlogging in Kolkata affected major areas, with Garia Kamdahari recording 332mm, Jodhpur Park 285mm, and Kalighat 280mm of rainfall. Flooding in Kolkata brought life to a standstill, causing 10 deaths, mostly from electrocution, and severe disruption to Metro, rail-

Bonus cuts: Tea estate managers flee amid workers' protest

MI News Servicew, Jalpaiguri: The managerial staff in at least two tea estates in the western Dooars under the Jalpaiguri district had to bear the brunt of worker protests over bonus.

While the manager of one of the gardens was forced to flee from his bungalow as workers demonstrated at his residence demanding bonus at the rate of 20 per cent of their annual wages according to the state advisory, workers in another tea estate forced the manager to leave the garden and asked him to return with cash to disburse bonus.

In both gardens, the management had announced they would pay bonus at the rate of 10 per cent, citing financial constraints. The workers, however, refused to listen.

Rajen Indowar, the manager of Dharnipur tea estate in Nagrakata block of the district, who was confined by agitated workers since Wednesday, secretly fled from his residence. The management had offered workers a bonus at the rate of 10 per cent.

Although police personnel were deployed at the bungalow, workers, including women, continued their demonstration throughout the night.

'Around 8am, we came to know that the manager left through the bungalow's backyard. We did not threaten him, we simply demonstrated in front of his bungalow, demanding a 20 per cent bonus. Why did he leave without paying us?" said Bishni Oraon, a woman worker.

There are 375 workers in the garden. Contacted, Indowar said he was feeling insecure in the bungalow.

They kept me confined in the bungalow and did not let me eat. I was feeling unsafe, and with the efforts of some workers, I managed to escape. We had said we would give them bonus at 10 per cent rate on Friday, but they did not agree," he said. In Debpara, a tea estate in neighbouring Banarhat block that employs around 900 workers, manager Uttam Sengupta had an unusual experience.

For the past three days, the workers had not joined duty, participating in a sit-in against the management that offered a 10 per cent bonus. Workers asked Sengupta to leave the garden and arrange funds to pay workers bonus at the rate of 20 per cent. "We asked him to leave the garden, meet the owner, arrange the money, and then return. This is because we will not settle at any rate below 20 per cent as has been advised by the state government," said Minati Oraon, a worker of Debpara

Truck driver burnt to death on NH12

MI News Service, Darjeeling: Neeraj Zimba, the secretarygeneral of the Gorkha National Liberation Front and the Darjeeling MLA, has reminded Union home minster Amit Shah that it was on his "request and in the spirit of coalition dharma" that the GNLF had supported the BJP in the 2021 Bengal Assembly elections.

The reminder comes after the Election Commission of India removed the GNLF from the list of registered unrecognised parties on September 19 for failing to contest any election conducted by the EC since 2019. Zimba, a GNLF leader. had successfully contested from the Darjeeling Assembly seat in 2019 and 2021 on a BJP ticket. "Sir, it is pertinent to remind you that since 2019, the GNLF has stood firmly behind the BJP in both the Lok Sabha and Assembly elections in the Darjeeling region of West Bengal," the letter written by Zimba on September 23 reads.

'On your request and in the spirit of coalition dharma, our party extended unequivocal support to the BJP candidates in all the three Assembly seats of Darjeeling Hills and Kalimpong," Zimba has written. The MLA said the history of the GNLF was inseparably linked to the aspirations of Indian Gorkhas. The party founded on April 5, 1980, by Subash Ghisingh had led the Gorkhaland agitation in the mid-1980s and signed an agreement with the central and state governments in 2005 to bring the Darjeeling hills under the Sixth Schedule of the Constitution.

"To erase such a historic organization from the register of recognized political

parties on a technicality of election participation is to negate four decades of legitimate political struggle and service," Zimba has said. The EC delisted 474 par-

ties from across the country, including 12 from Bengal, for their failure to participate in elections in the past six years. In its order to delist the

political parties, the EC has stated: "Whereas, 474 political parties listed at Annexure -A enclosed herewith. have been found to not having contested any election conducted by the Election Commission continuously for six years,

since 2019... The EC had granted a hearing to the GNLF on August 29 to explain its stand.

Despite the delisting, the EC still has a provision for aggrieved parties to appeal before the commission within 30 days of the order.

However, the GNLF has sought Shah's intervention. "We therefore humbly reguest your intervention in this matter. As the Hon'ble Home Minister and as the guardian of India's federal and democratic spirit, we seek your guidance and support in engaging with the Election Commission of India so that the registration of the GNLF is restored," said Zimba, who has written the letter "on behalf of the President (Mann Ghisingh) and Members of the GNLF".

CESC Agrees to Compensate Families of Electrocution Victims

: The Calcutta Electric Supply Corporation (CESC) has finally agreed to compensate the families of the nine people who died due to electrocution following heavy flooding in Kolkata earlier this week. After the city was inundated during Monday night's torrential downpour, nine people lost their lives in the accumulated water by Tuesday morning. Since then, West Bengal Chief Minister Mamata Banerjee had been demanding immediate compensation for the bereaved

CESC confirmed that each of the nine families would receive ₹5 lakh as compensation. The Chief Minister had repeatedly criticized the private power distribution company, holding it responsible for the fatalities. Speaking after the incident, Mamata Banerjee had said, "CESC must take responsibility for these deaths. Immediate deployment of staff is essential." She further lashed out at the company, stating, "While they are running their business here, they are not modernizing the infrastructure properly. In Rajasthan, they are carrying out modernization work, but here, nothing is happening. I've grown tired repeating this."

Banerjee reportedly spoke with CESC chairman SanjivGoenka regarding the matter.

Meanwhile, the Calcutta High Court has sought a formal report on the electrocution incident. In a suomotu case, a division bench comprising Acting Chief Justice Soumen Sen and Justice Apurb Singh Roy directed CESC to submit a detailed account of the incident. The report must outline the steps taken to improve drainage and safety measures. Additionally, the Kolkata Municipal Corporation has been asked to submit a report on the drainage and preventive measures implemented in affected areas.

The state government has also been Instructed to clarify its position regarding compensation to the victims' families. The next hearing of the case has been scheduled for November 7, by which time all partiesincluding CESC, KMC, and the state government—must submit their reports and responses.

This move by CESC comes after intense public pressure and direct intervention by the Chief Minister, highlighting concerns over urban infrastructure, private utility accountability, and disaster management in Kolk-

Cal HC Rejects Centre's Decision to Deport Migrant Workers to Bangladesh

: In a major setback to the central government, the Calcutta High Court has struck down the decision to deport Birbhum resident Sonali Bibi, who is pregnant, along with her family, to Bangladesh. The ruling came from a division bench comprising Justice Tapabrata Chakraborty and Justice Ritabrata Kumar Mitra. The court ordered that the family and others from Paikar village in Birbhum, who were targeted for deportation on suspicion of being Bangladeshi nationals, must be brought back within four

The central government had requested a six-week temporary stay for the enforcement of its order, which the High Court also rejected.

tions that West Bengal's migrant workers face harassment while working in other states. In recent months, several states, including Delhi, Gujarat, and Maharashtra, have been identifying and detaining suspected illegal immigrants. A significant portion of those detained are reportedly migrant workers from West Bengal, with some suspected Bangladeshis also being caught.

Complaints suggested that authorities often act aggressively, even detaining workers who speak Bengali. The Calcutta High Court, in this landmark ruling, emphasized that the deportation order was unjust and must be reversed immediately, providing relief to the affected migrant families.

Subsequent searches conducted in the residential premises of Arpita Mukherjee, a close aide of Partha Chatterjee, further led to the seizure of nearly ₹50 crore in cash and gold jewellery worth over ₹5 crore.

Partha Chatterjee was accused of being involved in a racket effecting illegal appointments of unmerited candidates to the posts of primary school teachers, assistant school teachers and other posts in the education department.

After several unsuccessful candidates in the teachers' eligibility test conducted by the West Bengal Board of Primary Education moved the Calcutta High Court, the latter ordered a CBI probe into the allegations on June 8, 2022.

Calcutta High Court has directed the immediate return of six Bengali migrant workers, including a pregnant woman named Šonali Bibi, who were pushed back to Bangladesh. The court declared the Delhi FRRO's detention and deportation orders unlawful, marking a significant legal victory for the affected families.

Reacting sharply to the verdict, All India Trinamool Congress (TMC) General Secretary Abhishek Banerjee took to social media, accusing the BJP of practicing exclusionary politics. "Today, the long arm of the law has finally caught up. The Hon'ble Calcutta High Court has held the FRRO (Delorder unlawful and directed the immediate repatriation of six people, including the pregnant woman from Birbhum, who were labelled 'Bangladeshi Migrants' and expelled," He further highlighted what

he described as a "cruel and systematic campaign of harassment" against Bengalis. "The people of Bengal will not tolerate xenophobia, humiliation, or the politics of exclusion. Come 2026, those who trafficked in fear and persecution will face a decisive verdict from the electorate," Banerjee added, reaffirming TMC's commitment to protecting the dignity, rights, and language

West Bengal Govt to Recruit 13,421 Primary Teachers After Durga Puja

gal government has announced that it will recruit 13,421 primary teachers after Durga Puja. The West Bengal Board of Primary Education (WBBPE) issued a notification in this regard, confirming that candidates who qualified in the 2022 and 2023 TET (Teachers' Eligibility Test) examinations will be eligible to apply.

Education Minister BratvaBasu shared the development on social media platform X, saying, "This festive season brings good news for young job seekers in Bengal aspiring for teaching posts. Under the leadership of Chief Minister Mamata Banerjee, WBBPE has issued the recruitment notification for 13,421 vacancies. The appointment process will begin immediately after Puja. Best wishes to all job aspirants.

On Wednesday, WBBPE published the results of the 2023 primary TET examination, in which 6,754 candidates were declared successful. While the results of the 2022 TET were declared earlier, legal disputes surrounding reservation policies



had delayed recruitment. Minister Basu had previously assured aspirants that 2022 TET-qualified candidates would not be left out, and the new notification confirms their inclusion.

WBBPE President Gautam Pal said, "Due to legal complications, primary teacher recruitment had been stalled. Now that the issues have been resolved, the recruitment process is beginning with the publication of this notification. All TET-qualified candidates will be eligible to apply."

According to the notification, candidates must submit their academic quali-

fee. The fee has been fixed at ₹600 for general category applicants, ₹500 for OBC-A and OBC-B candidates, and ₹300 for SC and ST candidates.

Earlier this month, on September 5 (Teachers' Day), Chief Minister Mamata Banerjee had announced that the state would recruit over 35,000 teachers in government-aided and government-sponsored schools. These include vacancies in secondary and higher secondary schools, as well as in the primary level. Following her announcement, the School Service Commission (SSC) released a notification for secondary and higher secondary teacher recruitment, covering classes IX to XII. The SSC recruitment examination has already been conducted smoothly across the state.

With the latest WBBPE notification, the long-awaited recruitment drive for primary teachers is set to begin after Durga Puja, bringing relief to thousands of candidates who had been waiting for the process to move forward.

Kolkata Police on High Alert to Ensure Smooth Durga Puja **Amid Rain Forecast**

With the India Meteorological Department (IMD) forecasting spells of rain during the Durga Puja festivities, the Kolkata Police headquarters at Lalbazar has swung into action to prevent waterlogging woes from disrupting the celebrations. Directives have been issued to all traffic guards and officer-in-charges of police stations to ensure prompt removal of accumulated water around pandals.

Senior police officials will also hold discussions with puja organisers and the Kolkata Municipal Corporation (KMC) to coordinate measures. A list of vulnerable roads prone to waterlogging has already been prepared, with plans to divert traffic through alternative routes to keep movement smooth. Police have further instructed that if waterlogging occurs in front of pandals, necessary steps must be taken to avoid inconvenience to pandal hoppers. To expedite drainage, arrangements are being made in collaboration with KMC to clean drains near pan-

Alongside civic arrangements, a massive security deployment will begin from Friday. As many as 10,000 police personnel will be on duty across the city. The deployment includes 36 Deputy Commissioners (DCs), who will supervise Assistant Commissioners, Inspectors, and other officers stationed at pandals and major roads. Home Guards,

lice, and NCC cadets will also support the force. Around 4,500 traffic police personnel will be on the streets to regulate vehicle movement.

The city's surveillance and security measures during Puja will include:125 police pickets, 52 watchtowers, 62 PCR patrol vehicles, 16 heavy radio flying squads, 13 special heavy radio flying squads, 30 PCRM vehicles, Several mobile police assistance vans and traffic assistance booths, 12 Quick Response Teams (QRTs), 11 wireless vans stationed at fire service centers, 14 trauma-care ambulances and 10 mobile missing-person squads.

Additional deployment will cover Kolkata's 32 metro stations, with an average of 11 extra police personnel at each station. Forty women officers on 20 scooters will be part of the "Winners" team, ensuring women's safety. Drone surveillance and additional control rooms will further strengthen monitoring.

Special arrangements have also been made at key public places, including Kalighat Temple, seven other temples, Alipore Zoo, major parks, and Science City, where additional police forces will be posted.

Authorities have assured that every precaution is being taken to ensure a safe, secure, and uninterrupted Durga Puja for the city's residents and visitors.

Fresh Row Over Liquor Party at JU; Security **Concerns Deepen**

Kolkata: Despite recent guidelines warning of strict action against substance abuse on campus, allegations have surfaced that a liquor party was organised inside Jadavpur University (JU). According to reports, when security personnel tried to intervene, they were allegedly assaulted. A security guard was punched on the nose by former students, while several current students were also said to be present at the gathering late on Wednesday night.

The incident comes barely weeks after the September 11 tragedy, when the body of thirdyear student AnamikaMondal was recovered from a lake near Gate No. 4 of the university. She had attended a programme at the campus parking lot that night, leading to questions about alcohol consumption and the lack of security measures inside the institution.

Following that incident, JU authorities had issued a guideline explicitly stating that anyone caught consuming drugs or alcohol on campus would face action under the law. The administration also decided to clear bushes where such gatherings reportedly took place and invited tenders for the same. Plans were also announced to install high fencing along the

leged liquor party and the assault on a guard have once again raised serious questions about campus security.

Adding to the debate, a section of students has opposed the installation of CCTV cameras on campus, citing privacy concerns. Meanwhile, Deputy Commissioner (SSD) BidishaKalita submitted a detailed security report on JU to Kolkata Police Commissioner Manoj Verma.

In her report, Kalita stated that the entire campus requires 230 CCTV cameras, including 60 for the main hostel. She also recommended that CCTV access should be given directly to Jadavpur Police Station. The report further suggested setting up a permanent police outpost inside the campus to ensure round-the-clock monitoring.

With continuing incidents of law and order challenges, the tussle between student groups and security measures remains a pressing issue. While the administration insists on tighter vigilance, sections of the student community are resisting surveillance initiatives.

Authorities have stressed that maintaining discipline and ensuring safety at JU is of utmost importance, especially after the recent incidents that have shaken public confidence in the cam-

Cal HC Clears Way for Kidney Transplant in Landmark Order

Kolkata: In a significant and unprecedented directive, Justice Amrita Sinha of the Calcutta High Court has granted permission for a kidney transplant, overturning a decision by the state health department's forum that had earlier rejected the application. The order allows Sheikh Habibur Rahman of East Burdwan to receive a kidney from a willing donor after months of legal and medical uncertainty.

Habibur, a resident of East Burdwan, has been suffering from chronic kidney disease for several years. In 2024, after being admitted to a private hospital in Kolkata, doctors informed him that both of his kidneys had failed and that transplantation was the only viable option. Following medical advice, the hospital authorities approached the state health department for necessary approvals.

The health department informed that Habibur's name was listed at number 26 on the official waiting list for kidney transplantation. As his condition deteriorated, a resident of Madhyamgram came forward voluntarily to donate a kidney. With all medical documents and supporting papers in place, Habibur's family reapplied to the health department seeking approval for the transplant.

However, the concerned forum of the health department rejected the plea, raising doubts about possible financial connections between the donor and recipient. With no appellate authority above this forum in the state, Habibur's wife approached the Calcutta High Court, filing a petition seeking urgent permission for her husband's transplant.

New Delhi: Domestic generic producers are likely to see near-term gains as higher prices for branded drugs can push demand towards cost-effective alternatives after the US announced its decision to impose 100 per cent tariffs on the pharmaceuticals industry from October 1, analysts said on Friday.

Generic drugs are currently exempted from US tariffs and according to Sudarshan Jain, Secretary General, Indian Pharmaceutical Alliance (IPA), the latest tariff announcement is for "branded or patented drugs, and not applicable to generics".

Domestic pharmaceutical firms supply a substantial proportion of drugs to US residents

New Delhi: The Food Safety and Standards Authority of India (FSSAI) has emerged as a global leader in food safety and standards, said Union Minister of Health and Family Welfare JP Nadda on Friday.

Speaking at the third Global Food Regulator Summit, at Bharat Mandapam here, Nadda said the summit will showcase India's commitment to global food safety, enhance global cooperation to ensure that the food systems are safe, resilient, and inclusive

He also highlighted the crucial role played by FSSAI in developing global food safety standards, such as the initiation of rapid testing kits and mobile labs for testing.

"FSSAI has emerged as a global leader in food safety and standards, playing a pivotal role on the international stage through the Codex Alimentarius Commission. India, through FSSAI, hosts the Codex Committee on Spices and Culinary Herbs, and has developed 14 global standards and serves as the regional coordinator for Asia, promoting street food safety and regional cooperation," the Union Minister said.

"India has secured critical Codex support for standards related to millets, cashew, and advanced supplement and functional food standards," Nadda said.

Underscoring FSSAI's leadership in international cooperation, he cited partnerships through MoUs with nations such as Bhutan, Argentina, Chile, New Zealand, Brazil, and recently with Australia

"At the national level, FSSAI has modernised food standards, approved rapid testing kits, and expanded laboratory infrastructure, including mobile testing laboratories. FSSAI has also strengthened safe food imports by recognising accredited overseas labs, introducing provisional clearances for importers, and enhancing transparency through integration with SWIFT and iSCATE systems," Nadda said.

Further, he stressed the need for food safety because the "quality of our diet influences the quality of our body, mind, and life".

The Health Minister also called food "a powerful force", and stressed the need for better compliance to build global trust.


Emphasising the need for food safety, he added that global exchange of food products can have a significant impact on the health and well-being.

"When countries engage in the global exchange of food prod-

"When countries engage in the global exchange of food products, they are not just trading goods. It has an impact on the health and well-being of their populations," Nadda said.

"Any lapse in food safety can lead to serious public health crises, disrupt trade, and damage the reputations of businesses and nations alike. Therefore, food safety is not just about compliance, but more importantly, about building trust in the global food systems," the Health Minister added.

Loss of smell may linger for years after Covid-19: Study



New Delhi: Although it may not be noticeable, the loss of smell may linger for years for some people after a Covid-19 infection, according to a study.

The study led by researchers at the US National Institutes of Health and New York University Langone Health used an objective, 40-odour test to explore a link between the coronavirus that causes Covid and hyposmia -- the reduced ability to smell.

The results revealed that 80 per cent of participants who reported a change in their smelling ability after having Covid earned low scores on a clinical scent-detection test taken about two years later. Of this group, 23 per cent were severely impaired or had entirely lost their sense of smell.

Notably, 66 per cent of infected participants who did not notice any smelling issues scored abnormally low on the evaluation as well, the researchers said.

"Our findings confirm that those with a history of Covid-19 may be especially at risk for a weakened sense of smell, an issue that is already underrecognised among the general population," said study co-lead author Leora Horwitz, professor at NYU Grossman School of Medicine

Horwitz added that 60 per cent of uninfected participants who did not report olfactory problems also tested poorly during the clinical evaluation.

The new study in 3,535 men and women, published in the journal JAMA Network Open, is the largest to date to examine loss of smell after Covid by using a formal test.

The findings suggest that health care providers should consider testing for loss of smell as a routine part of post-Covid, the team said.

Experts are now also exploring ways to restore the ability to smell after having Covid, such as with vitamin A supplementation and olfactory training to "rewire" the brain's response to odours.

Tata AIG suspends cashless services at Max Hospitals across India

New Delhi: After Star Health, Niva Bupa, and Care Health, Tata AIG has now become the fourth health insurer to suspend cashless facility at Max Hospitals.

While Star Health and Niva Bupa have suspended the facility for all 22 Max Hospitals across the country, CARE's cashless claim suspension is limited to Max Hospitals in Delhi NCR.

In a statement, Max Hospitals said that Tata AIG suspended cashless services at its hospitals from September 10. It added that the insurer also demanded an abrupt downward tariff revision.

"Max Healthcare and TATA AIG General Insurance Company had negotiated, renewed, and signed a two-year tariff agreement effective from January 16, 2025, until January 15, 2027. However, in July 2025, TATA AIG abruptly sought a meeting and demanded further rate reductions," according to a Max Hemital gradesparson.

Hospital spokesperson.

"They unilaterally proposed a downward revision of the agreed tariffs and threatened to suspend cashless services. When we did not accept it, cashless services at our hospitals were suspended effective September 10, 2025," the spokesperson said.

Meanwhile, Tata AIG noted Protection that it has put in place special den



arrangements to ensure that customers face no inconvenience.

"All claims are being prioritised and fast-tracked, allowing policyholders to continue receiving uninterrupted and seamless access to treatment and care. Our dedicated service teams are monitoring every case closely to provide complete support and ensure zero disruption for our customers," the health insurer added.

On Niva Bupa, Max Healthcare spokesperson clarified that the hospital continued cashless services long after ending the contract and that "any further reduction is unviable".

Earlier this month, the Association of Healthcare Providers of India (AHPI) demanded that insurance companies to immediately restore cashless services to policyholders, as patients faced severe inconvenience at the hospitals.

Such delays in empanelment are restricting patient choice and forcing many families into the reimbursement route, which defeats the purpose of health insurance.

"AHPI strongly insists that cashless services must be restored immediately to all affected hospitals, to protect patients from financial and emotional stress, and empanelment of new hospitals must be expedited, so that patients can access care across India without disruption," said the Association, representing over 15,000 hospitals and healthcare institutions across the country, last week.

Trump's 100 pc tariff on pharma unlikely to immediately impact Indian exports: Experts

New Delhi: The latest announcement of a 100 per cent tariff on pharmaceutical drugs by US President Donald Trump is unlikely to have any immediate impact on the Indian exports, said experts on Friday.

ed and sustained action to address the issue.

The experts noted the move targets imports of branded and patented pharmaceutical drugs and does not apply to generics medicines, which make a large chunk of Indian exports to the US.

"The proposed 100 per cent tariff on branded and patented pharmaceutical imports is unlikely to have an immediate impact on Indian exports, as the bulk of our contribution lies in simple generics, while most large Indian companies already operate US manufacturing or repackaging units and are exploring further acquisitions," said Namit Joshi, Chairman of the Pharmaceuticals Export Promotion Council of India (Pharmexcil).

"The executive order refers to patented / branded products supplied to US. It does not apply to generic medicines," added Sudarshan Jain, Secretary General, Indian Pharmaceutical Alliance.

In a post on Truth Social, the US President stated, "Starting October 1, 2025, we will be imposing a 100 per cent Tariff on any branded or patented Pharmaceutical Product, unless a Company IS BUILDING



their Pharmaceutical Manufacturing Plant in America."

From life-saving oncology drugs and antibiotics to chronic disease treatments, India is helping stabilise global healthcare systems. Currently, India supplies over 45 per cent of generic and 15 per cent of

biosimilar drugs used in the US.
US is India's largest export market for pharmaceutical goods. In FY 24, of India's

\$27.9 billion worth of pharma exports, 31 per cent or \$8.7 billion (Rs 7,72,31 crore) went to the US, according to Pharmexcil. Another \$3.7 billion (Rs 32,505 crore) worth of pharma products were exported in just the first half of 2025.

"India has long been a cornerstone of

the global supply chain for affordable, highquality medicines, supplying nearly 47 per cent of the US's pharmaceutical requiretaken a direct call on generics. Nonetheless, it is prudent to remain prepared for future policy shifts and to build risk-mitigation strategies," he added.

Meanwhile, pharmaceutical stocks declined sharply by up to 5 per cent, following Trump's declaration. Major pharma giants like Sun Pharma, Biocon, Zydus Lifesciences, Aurobindo Pharma, Dr. Reddy's, Lupin, Cipla, and Torrent Pharma were among those hit.

UN Human Rights Council MI News Service, Geneva: At the 60th session of the United Nations Human Rights Council (UNHRC), the CEO of the ECO FAWN Society, Sai SampathMettu, in his oral intervention, highlighted India's ongoing efforts to modernise its judiciary and expand access and praised India's advances in judicial reforms and the integration of technology to improve the justice delivery system. Mettu drew attention to India's digital judiciary initiatives, including the e-Courts Mission Mode Project and the JUSTIS App, which have significantly improved transparency, efficiency, and accessibility. These measures have particularly benefitted marginalised groups, such as women, rural communities, and persons with disabilities, enabling them to seek legal remedies more effectively and without unnecessary obstacles. The pandemic posed a significant challenge for courts worldwide, but India's swift adoption of virtual hearings ensured the continuity of judicial proceedings. This adaptation not only prevented delays in justice but also accelerated the integration of digital tools into roucourt operations, demonstrating the resilience and adaptability of India's legal system. Highlighting the government's long-term commitment, Mettu stated that India has invested over USD 800 million in judicial infrastructure and digital capacity. These investments aim to create a more inclusive, technology-driven justice system that up-

Building on his bilateral engagement, Jaiswal further highlighted Ambassador George's intervention at the United Nations. "Secretary (West) @AmbSibiGeorge delivered India's National Statement at the 6th Ministerial Meeting of the Group of Friends of Victims of Terrorism. Referring to the scourge of cross border terrorism that India faces, Secretary reiterated India's zero toler-



emphasized the need for the world to come together in the fight against terrorism in all its manifestations.'

Earlier on Monday, during the high-level segment marking the 80th anniversary of the United Nations General Assembly, George had broadened India's message by underlining the country's "readiness to work with partners to support the Global South in responding to environmental disasters," the MEA said. This reflected India's wider positioning of its fight against terrorism alongside its commitment to global solidarity and resilience.

Carrying this theme forward, at the High-Level Solutions Dialogue on Early Warning and Extreme Heat, Ambassador George had mentioned India's national Heat Action Plans as a key framework to tackle rising temperatures. He had pointed to the use of digital tools for last-mile alerts and promotion of low-cost cooling solutions as part of India's domestic response to climate risks.

Speaking at the session alongside representatives from Singapore, Maldives, European Union and Finland, he had said India stood ready to work with partSouth, to strengthen early warning systems, risk reduction and disaster management measures. Rising global temperatures, he had noted, had left vulnerable countries most exposed to environmental disasters, and collective action was necessary to address this challenge.

Apart from these UN engagements, Ambassador George had also attended the Commonwealth Foreign Affairs Ministers Meeting (CFAMM) 2025, held on the sidelines of the UNGA. He had reiterated India's commitment to the values and principles of the Commonwealth Charter and stressed the need for reforms to make the organisation better reflect the realities of contemporary times, India at UN wrote in a post on X.

Bandladesh minorities face arowing persecution, GHRD alerts UN Human Rights Council

MI News Service, Geneva: At the 60th session of the United Nations Human Rights Council (UNHRC), the UN-EU Human Rights Officer, Charlotte Zehrer from Global Human Rights Defence (GHRD), in her oral intervention, has drawn international attention to the precarious conditions faced by ethnic and religious minorities in Bangladesh, calling for urgent action from the UNHRC.

She highlighted what she described as a "deeply concerning" pattern of violence and discrimination. Ms Zehrer reported more than 2,400 incidents of attacks against minorities in the past year, noting that indigenous people in the Chittagong Hill tracts, along with Hindu and Christian communities across Bangladesh, have been the primary targets.

She described the multiple forms of abuse, including assaults on homes and places of worship, gender-based violence predominantly in the form of rape, arbitrary arrests, fabricated blasphemy charges, land confiscation. forced displacement, and the coerced resignation of minority professionals.

She also warned of growing cases of forced religious conversions teenagers and young adults. While acknowledging the co-



Bangladeshi government, the Human Rights Council, and the Office of the High Commissioner for Human Rights (OHCHR). She urged that such engagement must go further; she also urged the need for genuine accountability and immediate steps to protect vulnerable communities.

She specifically appealed for the release of detained minority leaders and activists, the reform or repeal of discriminatory laws, and impartial investigations into all reported human rights violations. It further called for stronger international oversight, recommending that the United Nations consider deploying a fact-finding mission to monitor the situation closely.

"Ensuring justice for minorities in Bangladesh is not only a national responsibility but also an international obligation," she stated, urging the Council to intensify efforts to hold perpetrators accountable.

surrounding areas. Residents confirm that they have faced inconsistent supply and have been forced to pay higher-than-standard rates. The administration and gas suppliers have yet to resolve this, leaving many citizens in uncertainty over how to meet their energy needs during the colder months. Without immediate measures such as regulating gas prices, ensuring equitable distribution, and promoting alternative energy solutions, the region could face long-term social and ecological consequences.

Establishing local filling stations and subsidised supply chains are among the suggested solutions to mitigate the crisis and prevent residents from resorting to environmentally harmful practices.

The dispute over gas pricing in Muzaffarabad is more than an economic issue; it represents a critical intersection of affordability, governance, and ecological responsibility.

As winter approaches, citizens, environmentalists, and policymakers alike are closely watching to see whether a sustainable solution will be implemented or if rising gas prices will prompt residents to turn to unsafe and environmentally damaging

Asia Cup: Harris Rauf fined 30 pc of match fee, Shahibzada Farhan reprimanded by ICC: Report

NEW DELHI: The International Cricket Council (ICC) has handed Pakistan's Harris Rauf a fine of 30 per cent of his match fee and reprimanded opener Shahibzada Farhan for their controversial gestures during the team's Super s encounter against India in the Men's T20 Asia Cup on Sunday, according to a report.

While Rauf has been handed a fine of 30 per cent of his match fees for his actions, gesturing an aeroplane crash, Farhan has been reprimanded for his gunshot celebration with the bat during the same game. The duo were found guilty of

breaching a Level 1 offence under the player Code of Conduct. Rauf made controversial political gestures of a plane crash while Farhan made gestures of gunfire with his bat, which fans believe allude to Pakistan's false claims about bringing down Indian jets during Operation Sindoor.

However, no fine has been levied against Farhan, who was only issued a warning by the board, Cricbuzz reported

The PCB had filed a complaint against the Indian team for skipper Suryakumar Yadav's alleged political statements after the two sides' first game on September 14. Notably, players of Team India

players Suryakumar dedicated the win to the country's armed forces.

Meanwhile, the BCCI lodged a complaint with the ICC against Rauf and Farhan for their controversial gestures during the two teams' Super 4s clash.

Both Rauf and Farhan defended their actions, with the former saying that his "6-0" gesture meant nothing and wasn't pointed at India, and the latter pointing out former India captains MS Dhoni and Virat Kohli's similar celebrations with the bat in his defence.

Level 1 breaches typically result in a fine of up to 50 percent of the match fee and one or two demerit points. In this instance, the players received only financial penalties and warnings, but they were explicitly warned to avoid repeating such infractions.

India and Pakistan are set to face off for a third time at the Asia Cup as the two teams will play the tournament's final this Sunday While Suryakumar Yadav and his men are unbeaten in the tournament so far, Pakistan have suffered two defeats in six games that they've played in the two stages of the tournament, both at the hands of India

Building on the momentum from Dubai (2023) and London (2024), Season 3 signifies GCL's debut in India, the birthplace of both chess and the league concept.
The draft kicked off on Friday

with the Icon Round, where

Alpine SG Pipers selected Fabiano Caruana, PBG Alaskan Knights narrowly beat competitors to acquire Gukesh, and fivetime World Champion Viswanathan Anand remained with the Ganges Grandmasters. Speaking on the occasion, Peeyush Dubey, Chairperson of the Global Chess League, stated: "Bringing the Global Chess League to India is a statement on where the sport stands today. India is not only the birthplace of chess but also its most dynamic growth market, producing cham-

pions and inspiring millions. "At the same time, GCL remains a truly global league, uniting players and fans from every corner of the world. The successful completion of the draft sets the stage, and we are ready for a spectacular Season 3 this December at Mumbai's Royal Opera House, even as the league continues to chart a worldwide journey in the years ahead," he

Adding to the day's drama. Mumba Masters made a bold move for Wesley So, engaging in a bidding war with American Gambits and PBG Alaskan Knights before securing the American Grandmaster. Meanwhile, Ganges Grandmasters bolstered their team by signing 20-year-old German Vincent Keymer.

Suhail Chandhok, CEO of Mumba Masters, said upon securing his preferred pick: "We wanted to retain the core of our squad, and we managed to do that with Harika, Humpy, and



MVL (Maxime Vachier-Lagrave). We had most boxes ticked. One thing on our mind was to get one of our top picks from male superstars, and we got our top pick,

The highlight of the round was the duel for Erigaisi that ignited a three-way competition; after several bids, PBG Alaskan Knights emerged victorious, bringing him together with Gukesh to create India's ideal

"We had a big task because we had to pick all six players, and we are happy that we got World Champion Gukesh, along with a balanced team in the end They (Gukesh & Damp; Arjun) will be more than happy to satisfy the fans with their performance. It's happening in India, and it will definitely bring more cheer to our team," said PBG Alaskan Knights' Coach Abhijit Kunte.

Before the draft, four teams strengthened their rosters through retainments. Alpine SG Pipers kept former women's World Champion Hou Yifan and R. Praggnanandhaa, while American Gambits signed Hikaru Nakamura and Bibisara Assaubayeva ahead of the draft. Alireza Firouzja, Alexandra Kosteniuk, and Wei Yi remained with Triveni Continental Kings after winning the title last season. Indian superstar women Koneru Humpy and Harika Dronavalli,

China Open 2025: **Defending champion Gauff** powers into second round

BEIJING : Second seed Coco Gauff of the United States opened her title defense at the China Open tennis tournament with a commanding 6-4, 6-0 win over Russia's Kamilla Rakhimova on

The 21-year-old American, currently ranked world No. 3, pulled away after a tight first set to complete the victory in one hour and 42 minutes in the joint WTA and ATP event being played in the Chinese capital.

"I expected it to be close," said Gauff. "She's a great player and has had competitive results with top players in the last few tournaments. I was just a little bit tight at the beginning, but I was able to loosen up and get in a flow.

In her first match since the US Open, Gauff fought through a drawn-out second game to save four break points before finding rhythm. She broke Rakhimova for a 4-3 lead and never looked back, sealing the opening set 6-4. The French Open champion then raced through the second set, breaking



twice and wrapping up the match without facing serious resistance, reports Xinhua.

Gauff has experienced a season of highs and lows. On clay, she reached consecutive finals at the WTA 1000 events in Madrid and Rome before capturing her second Grand Slam title at

Roland Garros, where she defeated Arvna Sabalenka in the final. But her momentum stalled in the summer, suffering a firstround exit at Wimbledon to

Davana Yastremska of Ukraine,

and later fell to Naomi Osaka in

the Round of 16 at the US Open. "This, for some reason, feels less pressure," Gauff said of her return to Beijing. "When you play well at a place, you have a lot of confidence. When those tough moments happen, you feel the

LA LIGA: MADRID DERBY STANDOUT GAME OF GAMEWEEK 7; BARCA TO FACE REAL SOCIEDAD

MADRID: The season's first derby between Atletico and Real Madrid will be the standout match of the seventh round of games in Spanish La Liga Gameweek 7 as Atletico look to drag themselves back into the title race and ensure their hopes are not snuffed out before the end of September.

Julian Alvarez's hat-trick on Wednesday at home to Rayo Vallecano saw Atletico come back for a late win, which keeps them nine points behind league leaders, Real Madrid, after Real won 4-1 away to Levante on Tuesday.

A win for Atletico would pull Diego Simeone's side to within six points of its neighbour, but defeat would leave them 12 points off the pace, and that would surely be too much ground to recover, even though the campaign is still in its early stages.

Real Madrid have a 100 percent record at the start of the season, while coach Xabi Alonso has virtually a full squad to choose from, with only Trent Alexander-Arnold in the treatment room.

For Atlético de Madrid, this derby comes at a pivotal moment. Simeone's men have endured a rocky start to the campaign, dropping too many points early. But nothing breathes life into Atleti's season like a derby win. A victory here wouldn't just hand them three points. It would close the gap on their city rivals, revive faint title hopes, and give them their first league win over Real Madrid in more than two years. The last triumph came back in Matchday 6 of the 2023/24 season, a 3-1 win at the Metropolitano. First Madrid Derby for Xabi



This will be Xabi Alonso's first derby as Real Madrid coach. The Spaniard has already made a flying start, winning all six games so far to lead Los Blancos to the top of the table. But Simeone's Atlético will be his sternest test yet.

Alonso is no stranger to these high-octane fixtures, having played in 16 derbies as a Real Madrid midfielder. He won 12 of those, and even famously celebrated from the sidelines in the 2014 Champions League final while suspended. Now he gets to script his own derby chapter as coach.

Interestingly, Alonso has already clashed with Simeone on the touchline before. Back in 2022/23, his Bayer Leverkusen side drew 2-2 at the Metropolitano in the Champions League, and Atlético later beat them in another group clash. That history adds yet another subplot to Saturday's
