Bridges collapse, hills submerged: CM expresses alarm over North Bengal flood

CM Mamata Banerjee on Saturday expressed grave concern over the widespread flooding that has severely impacted several parts of North and South Bengal following unprecedented rainfall and massive river inflows from neighbouring regions. In a detailed statement shared on her official X handle, Mamata Banerjee said she was "deeply worried and concerned" about the situation, which has resulted in the tragic loss of lives, large-scale damage to infrastructure, and widespread inundation, especially in the northern districts. "We are shocked and saddened to know that we have lost some of our brothers and sisters due to the massive rainfall and river-induced floods. PG 3

DARJEELING LANDSLIDES Casualties cross 20



MI News Service, Darjeeling: At least 10 people died and several others went missing as incessant heavy rainfall triggered multiple landslides across the Darjeeling hills on Saturday, sweeping away homes, damaging roads, and cutting off several remote hamlets, officials said. Furthermore, due to the excessive rainfall, an iron bridge also collapsed.

The Dhudia bridge, which is an iron bridge over the Balason River at Dudhia, connecting Siliguri and Mirik, was damaged and collapsed due to the heavy rainfall in the region. Rescue and relief operations are underway by the local administration, police, and disaster response teams, Darjeeling Sub-Divisional Officer (SDO) Richard Lepcha told. The National Disaster Response Force (NDRF) has joined the rescue operations in Mirik Lake area, one of the vorst-hit zones, officials said.

Chief Minister announced compensation for the victims without specifying the amount and said she would visit north Bengal on October 6 to assess the situation in the region where a large number of tourists have also been affected. Prime Minister Narendra Modi has said he is 'deeply pained" by the loss of lives in Darjeeling. "We are committed to providing all possible assistance to those affected," he said on X.

In a post on X, PM Modi said: 'The situation in Darjeeling and surrounding areas is being closely mon-itored in the wake of heavy rains and landslides." Banerjee described the situation as "grave". "Due to incessant rain in Bhutan, the water has overflowed into North Bengal This disaster is unfortunate - natural calamities are beyond our control.

J&K Police attaches property of TRF founder SAJAD GUL under UAPA

MI News Service, Srinagar: Jammu and Kashmir police on Saturday attached a property worth ₹2 crore belonging to designated terrorist Sajad Ahmad Sheikh alias Sajad Gul, the founding chief of The Resistance Front (TRF), who is reportedly hiding in Pakistan. The development comes days after the police attached the housecum-office of Hurriyat hawk Syed Ali Shah Geelani, marking a renewed crackdown on high-profile separatists or militants by government agencies. The TRF is believed to be responsible for orchestrating several attacks after the 2019 scrapping of the special status, including the Pahalgam massacre on April 22. The police said the ownership of the property, built on 15 mar-

las of land, is in the name of Gul's father, Ghulam Mohammad Sheikh, according to the revenue records. However investigation revealed that Gul is an active stakeholder, the police added. The house, located at Rose Avenue, HMT, has been attached under the provisions of the Unlawful Activities (Prevention) Act. The police said the attachment was carried out in connection with FIR No. 235/2022 registered at the Parimpora police station under Sections 13, 38 and 20 of the UAPA, and Sections 2/3 of the Enemy Agents Ordinance Act. The proceedings were initiated under Section 25 of the UAPA, which empowers authorities to attach properties used or intended to be used for terrorist

activities. The attachment was done in the presence of the executive magis-

According to the police, Gul has been involved in militant activities, spreading anti-national propaganda and inciting disaffection against the government through online and social media platforms. "This attachment forms part of the ongoing strategy of Srinagar Police to disrupt the financial, logistical, and operational networks of terrorism, including their cross-border sponsors and sympathisers. The action sends a clear message that individuals or entities aiding terrorism will face strict legal consequences, including the forfeiture of illegally acquired assets,' a police statement said.

NEPAL FLOOD: Death toll rises to 51 as Modi offers support

MI News Service, Kath-mandu: At least 51 people have been killed across eastern Nepal till Sunday morning in various incidents triggered by landslides and floods following heavy downpours since last night, an official of the Armed Police Force (APF) said. As many as 37 of the deaths occurred in Ilam district, Koshi province, where landslides triggered by continuous heavy rainfall have wreaked havoc over the past two days, said Kalidas Dhaubaji, APF spokesperson. Of the 37, eight people each were killed in Deumai and Maijogmai municipalities, six each in Ilam municipality and Sandakpur rural municipality, five in Suryodaya, three in Mangsebung, and one in Fakfokthum village, according to a press release by the National Disaster Risk Reduction and

Management (NDRRMA). Elsewhere, two people died in Udayapur and one in Panchathar due to floods and landslides. Separately, three people were killed in a lightning strike in Rautahat and two in Khotang district.

Meanwhile, six people died in Panchthar district in an accident caused by roads damaged by the heavy rainfall. Four people went missing after being swept away by the swollen river in Langtang Conservation Area of Rasuwa district, and one each went missing in incidents of floods in Ilam, Bara, and Kathmandu. Additionally, four of the 16 people on a trekking expedition in the Langtang area remain unaccounted for, Dhaubaji said. Nepal Army, Nepal Police, and APF

Amid TMC protest, Nisith Pramanik reaches BJP worker's home in Cooch Behar

MI News Service, Cooch Behar: BJP leader Nisith Pramanik faced protests from Trinamool Congress supporters near Dinhata in Cooch Behar district on Saturday afternoon while he was on his way to meet BJP workers whose houses had been vandalised by alleged Trinamool activists.

At Bhetaguri Chowpathi, a prominent crossing in Bhetaguri, Trinamool workers waved black flags and surrounded Pra-manik's convoy. The absence of police personnel at the scene has raised questions about his security arrangements.

Pramanik, however, was undeterred by the protest and reached the house of Sumita Barman, a BJP worker who was allegedly attacked. On Friday afternoon, she said, Trinamool workers had van-

dalised her home The former MP spoke to her, handed over a cheque for ₹2 lakh to her as financial assistance, and also checked the

He also contacted Suvendu Adhikari, the leader of the Opposition in the Assembly, from there. Sumita spoke to Adhikari over the phone, and the latter assured full support from the BJP and promised to arrange a sewing machine for her.

West Bengal is moving forward on the oath of 'SIR' (special intensive revision of the electoral roll). No matter how hard the Trinamool tries to stop us, we will put in all efforts to ensure that the SIR is conducted in Bengal. We will also request the deployment of paramilitary forces in Bengal," Pramanik said, while talking to newspersons.

Sources said that the political conflict began on Thursday night. Some BJP workers, who were in a Durga Puja pandal at the vegetable market in Bhetaguri, found two Trinamool workers, Tapan Barman and Naresh Barman, and assaulted them.

Both got injured and were hospitalised. On Friday afternoon, Trinamool workers allegedly attacked in retaliation and vandalised the house of four BJP workers, including Sumita Barman.

"Trinamool goons openly attacked four BJP homes in broad daylight on Friday, including that of an elected panchayat member. The role of the police is also under question," said Biraj Bose, a district vicepresident of Cooch Behar.

Sunil Ray Sarkar, a local Trinamool leader, however, denied the charge.

"It was our workers who were assaulted by BJP supporters on Thursday night. They ended up with head injuries, and we have filed a complaint with the police. I have no information that any house has been ransacked," said Sarkar.

Police officers, when contacted, said the investigation is in progress. No arrests have been made so far, said sources.

Siliguri hosts Durga Puja Carnival

MI News Serivce, Siliguri: The Trinamool Congress-led board of the Siliguri Municipal Corporation (SMC) is all set to host a vibrant Durga Puja Carnival on Saturday. The event will feature participation by 11 prominent Durga Puja organising committees and clubs and cultural troupes representing the state information and cultural affairs department.

"On Saturday, we will begin the programme from Venus More (Hashmi Chowk) at 5pm, and the participants will proceed along the Hill Cart Road to the main venue at Mahatma Gandhi Chowk (Airview More), where they will perform, mavor Gautam Deb told newspersons at the SMC on Friday. One of the key highlights of the event will be a special 15minute-long "sandhya arati (evening prayer)" at the main venue. The carnival will also showcase a vibrant display of ethnic cultural groups in traditional attire, along with tribal artists who will perform with traditional musical instruments, thus adding rich cultural flavour to the celebrations.

In preparation for the event, Deb visited the venue and chaired a coordination meeting with representatives from cultural groups, the district administration, hoteliers' associations, the state public works department and civic authorities. "We have made comprehensive arrangements for spectators," he said. "These include seating arrangements and bio-toilets. Also, LED screens have been installed at all major junctions so that people can see the event live from different locations in the city." From Mahatma Gandhi Chowk, the idols will head for Lalmohan Moulik Ghat, which is nearby and is on the left bank of the Mahananda river, for immersion. For smooth conduct of the event, multiple agencies, including the Siliguri Metropolitan Police, civil defence, staff of the SMC and the PWD, and NCC cadets, will work in coordination throughout the programme, sources said.

'Ma Balaichandi' puja begins after Dashami: Durga Puja in another form

MI News Service, Raiganj While most parts of Bengal bid a farewell to Durga on Bijoya Dashami, the spirit of celebration remains very much alive in many villages across north Bengal as the goddess is being venerated in different forms and names after Dashami.

In Khadimpur, a village located in the Raiganj block of North Dinajpur district, the Durga Puja begins only after Dashami. While people in other areas immerse idols in rivers and ponds, the people of Khadimpur begin their own week-long worship of the goddess in her local form — "Ma Balaichandi".

From children to the elderly, the entire village comes alive with devotional fervour, hosting a week-long celebration filled with worship, fairs and cultural performances. The origins of this puja are steeped in history. Situated in Kamalabari panchayat, the original shrine was set up under an ancient tree, with a tinstructure surrounded by a brick wall on about 1.3 acres of land. Over the years, a permanent temple has replaced the old shrine.

According to tradition, the worship begins on the Dashami night, and this year too, the rituals started on Thursday night, with prayers and offerings going on throughout the day on Friday. A village fair is also hosted at the venue. On the day of the Puja, the goddess is adorned with gold and silver ornaments. In-



terestingly, the idol of "Balaichandi" is a deviation from the classical form of Durga. She is worshipped as "Ma Chandi," with four arms instead of 10, and without "Mahishasura" (the demon) and the lion mount.

"People eagerly wait for this puja, not before Durga Puja begins, but after it ends," said Nirmal Barman, a member of the puja committee. The entire village eats vegetarian meals on the Puja day, praying for family well-being, he said. The puja draws visitors from nearby Raiganj and Hemtabad, with hundreds visiting the temple and enjoying the fair.

In Alipurduar district, a similar vibrant celebration follows the Durga Puja — the "Bhandani Puja," primarily observed by the Rajbanshi community in villages and tea gardens. Since Friday, the Bhandani Puja has been celebrated in Alipurduar 1 block, with being held on grounds beside the temples. For the Rajbanshis, the goddess is worshipped in three names, "Bhandani," "Bhandarani," and "Bhandali." In some places, she is also referred to as "Bondurga". One of the prominent pujas is being held at Pradhanpara, adjacent to the Jaldapara National Park.

In 2025, the puja reached its 128th year in the village. "This puja began over a century ago as the villagers started venerating the goddess to keep themselves safe from wild animals," said Shyamal Munda, secretary of the puja committee in Pradhanpara. A two-day fair accompanies the puja. and cultural events are being held at the venue.

In other places like Kalabari and Purba Bholardabri, the Bhandani Puja and celebrations are being held for three days, starting from Dashami. "It is an old custom to organise the Bhandani Puja. The puja begins after the Durga idols are immersed on Dashami and continues for four days," said an Alipurduar resident. "These pujas give people an opportunity to continue their celebrations for some more days, and thousands congregate in these villages to witness the rituals and join the festivities," he added.

New mother 'jumps' to death from nursing home, family alleges medical neglect

MI News Service, Dinajpur: A 28-year-old woman who recently gave birth reportedly committed suicide by jumping from the second floor of a private nursing home in South Dinajpur's Gangrampur on Friday morning. A source said locals heard a loud sound near the nursing home, which is located opposite the super-specialty hospital. They found the woman lying in a pool of blood. She was rushed to the hospital, where doctors pronounced her dead. Mamani Mahanta De was a resident of Ramakrishnapally, in ward 17 of Gangarampur. Last Sunday, she was admitted to the nursing home with labour pains, and on Monday, she gave birth to a boy. Both mother and child were initially reported to be stable. According to her family, Mamani fell ill on Thursday and was acting erratically, unable

"My wife gave birth to our first child on Monday. We were supposed to take them home today," said Balaram De, the deceased's husband. Why did the nursing home not treat her or at least refer her to another facility? And how could a patient leave the ward and jump without anyone noticing? Also, a boundary wall is needed to protect the building. Otherwise, we doubt how long this damaged building will survive, and once it collapses, we have no idea where we will conduct the classes," he

added. A local said the two elephants strayed into the garden from the nearby Gorumara National Park. The windows of the classrooms were ripped off, and furniture and equipment in the office were destroyed.

According to a source, there are 180 primary students at the school.

On Saturday morning, locals expressed their disgruntlement with the state forest department.

"We are perturbed by repeated elephant attacks at the tea estate, and yet, the forest department does not take any steps to prevent the animals from entering the garden. Also, the primary school education department should take initiatives to repair the school," said a worker of the garden.

Security forces rescued four people, including a pregnant woman, from Ilam district using helicopters and admitted them to a hospital in Dharan municipality. The monsoon is currently active in five of Nepal's seven provinces: Koshi, Madhes, Bagmati, Gandaki, and Lumbini. Offering help to the neighbouring country, Prime Minister Narendra Modi said in a social media post, "The loss of lives and damage caused by heavy rains in Nepal is distressing. We stand with the people and Govern-ment of Nepal in this difficult time. As a friendly neighbour and first responder, India remains committed to providing any assistance that may be required." Meanwhile, the Nepal government has allowed some vehicles to travel to and from Kathmandu as weather conditions improved. On Sunday, Kathmandu Valley received less rainfall compared with the past two days, and road blockages caused by landslides have been cleared on some national highways. "As per the decision of the Monsoon Counter Command Post, vehicles operating for emergency services and vehicles transporting goods as well as passenger vehicles and shortdistance vehicles halted in the middle of the national highways will be allowed to move towards their destinations keeping in view the conditions of the roads in coordination with the local authorities," read a statement from the NDRRMA. However, the statement added that vehicle movement will continue to be restricted at night on risky roads and highways until further notice. On Saturday, authorities had restricted entry and exit of vehicles from Kathmandu due to continuous rainfall and landslide risks, issuing a red alert for areas around the Bagmati

Bridges collapse, hills submerged: CM expresses alarm over North Bengal flood

MI News Service, Kolkata: CM Mamata Banerjee on Saturday expressed grave concern over the widespread flooding that has severely impacted several parts of North and South Bengal following unprecedented rainfall and massive river inflows from neighbouring re-In a detailed statement shared on

her official X handle, Mamata Banerjee said she was "deeply worried and concerned" about the situation, which has resulted in the tragic loss of lives, large-scale damage to infrastructure, and widespread inundation, especially in the northern districts. "We are shocked and saddened to know that we have lost some of our brothers and sisters due to the massive rainfall and river-induced floods. I convey my heartfelt condolences to the families of the deceased and assure that all assistance will be sent to them immediately," she stated. According to government reports, North Bengal recorded over 300 mm of rainfall within just 12 hours on Friday night. The deluge was intensified by heavy inflow into



the Sankosh River and water discharge from Bhutan and Sikkim, leading to widespread destruction across the region. The Chief Minister revealed that two iron bridges have collapsed, and multiple major roads remain either submerged or completely washed away. Extensive flooding has been reported in Darjeeling, Kalimpong, Jalpaiguri, and Alipurduar districts, with especially dire conditions in Mirik, Matigara,

and surrounding hilly areas. Mamata Banerjee has been monitoring the situation closely since Friday night, conducting virtual meetings with Chief Secretary H.K. Dwivedi, Director General of Police, and district of-ficials. Public representatives including Gautam Deb and Anit Thapa also participated in the discussions. She announced that she wild personally visit North Bengal on Sunday to assess the ground situation and oversee rescue and relief operations. Advising tourists to remain calm, she urged those stranded in hill districts to stay where they are until safely evacuated. "Rescue costs will be borne by us. Tourists need not worry," she assured. To streamline emergency responses, 24×7 control rooms have been activated at both state and district levels. Landslides have occurred at seven locations. I am keeping a close watch and hope to reach by around 3 pm on Monday," she said. Thousands of tourists have been stranded across the region due to the landslides and road blockages. The CM assured them that the state

government would make arrangements to bring them back safely and appealed to tourists not to panic or rush to leave. 'Many tourists stranded. I request them not to hurry. Please stay where you are. Hotels must not overcharge them. Their safety is our responsibility, and the administration will ensure that," she said. Banerjee also announced that the families of those killed in the disaster would receive government compensation and employment for one of their members, though she did not specify the amount. According to reports compiled by the NDRF and the district administration, 10 deaths have been confirmed so far, while two others remain untraced. Fatalities were reported from several locations - Sarsaly, Jasbirgaon, Mirik Basti, Dhar Gaon (Mechi), and Mirik Lake area. At least four people were rescued from the debris in Dhar Gaon, where heavy mudslides flattened several houses. Motor Vehicle Tax shouldn't be levied if vehicle not used in 'public place': SC

MI News Service, New Delhi: Motor vehicle tax is compensatory in nature and if a vehicle is not used or not kept for use in a 'public place', then its owner should not be burdened with motor vehicle tax for such period, the Supreme Court has said. A bench of Justices Manoj Misra and Ujjal Bhuyan delivered its verdict on an appeal challenging a December 2024 judgement of the Andhra Pradesh High Court.

"Motor vehicle tax is compensatory in nature. It has a direct nexus with the end use. The rationale for levy of motor vehicle tax is that a person who is using public infrastructure, such as, roads, highways etc. has to pay for such usage," the apex court said. Referring to section 3 of The Andhra Pradesh Motor Vehicle Taxation Act. 1963, the bench said the legislature has consciously used the expression 'public place' in this provision.

"If a motor vehicle is not used in a 'public place' or not kept for use in a 'public place' then the person concerned is not deriving benefit from the public infrastructure: therefore, he should not be burdened with the motor vehicle tax for such period," the top court said in its judgement delivered on August 29. It said section 3 of the Act is the charging provision and it authorises the state government to impose tax on motor vehicles. The bench said the taxable event

in the state. "Therefore, the tax is on the user or intendment for use of motor vehicle in a 'public place'. Thus, if a vehicle is actually used in a 'public place' or kept in such a way that it is intended to be used in a 'public place' then the tax liability accrues," it said. The top court said when admittedly the motor vehicles of the appellant firm in this case were confined for use within the Rashtriya Ispat Nigam Limited (RINL) premises which is a closed area, then question of the vehicles being used or kept for being used in a 'public place' does not arise. The bench said in this case, the motor vehicles in question were used or kept for use only within the restricted premises of RINL which was not a 'public place'. "Therefore, the said vehicles are not liable to be taxed for the period the said vehicles were used or kept for use within the restricted premises of RINL," it said, while allowing the appeal.

The bench delivered its verdict on

an appeal filed by a firm engaged in the business of providing logistic support since 1985. It noted the firm was awarded a contract in November 2020 for handling and storage of iron and steel materials at central dispatch yard within Visakhapatnam Steel Plant, Andhra Pradesh, a corporate entity of RINL. The bench said the company deployed 36 motor vehicles for plying within the central dispatch yard premises. The firm told the apex court that the central dispatch yard was enclosed by compound walls and ingress and egress was regulated through gates where Central Industrial Security Force (CISF) personnel were deployed and no member of public has any right to access it.

The issue arose after the firm requested the Andhra Pradesh authority for exemption from payment of motor vehicle tax for the period its vehicles were confined and used within the central dispatch yard premises. The bench noted this request was made in terms of section 3 of the 1963 Act. Later, the matter reached the high court where a single judge held that the firm was plying its vehicles within the central dispatch yard which is not a 'public place'. The single judge directed the state authorities to refund Rs 22,71,700 to the company. Thereafter, the authorities challenged the order before a division bench which set aside the single judge's order.

Supreme Court refuses to ban THE **SATANIC VERSES'**

MI News Service, New Delhi: The Supreme Court refused to examine a plea seeking a ban on Salman Rushdie's controversial novel "The Satanic Verses". The plea came up for hearing before a bench of Justices Vikram Nath and Sandeep Mehta. The petitioners' counsel referred to the Delhi High Court's November last year order. The high court had closed the proceedings on a petition challenging the Rajiv Gandhi government's decision to ban the import of 'The Satanic Verses" in 1988. The high court observed since authorities failed to produce the relevant notification, it has to be presumed that it does not exist. The Centre banned the import of the Booker Prizewinning author's "The Sa-Verses" law-and-order reasons in

1988, after Muslims across the world viewed it as blasphemous. "You are effectively challenging judgement of the Delhi High Court," the apex court observed and dismissed the plea filed by three Mumbai residents. The petition, filed through advocate Chand Qureshi, alleged the book was available due to the order passed by the high court. The plea said the petitioners discovered on June 14 this year that vendors in Mumbai were selling the "controversial and blasphemous book" and it was also available on a prominent online shopping platform. It alleged the order was passed by the high court "perfunctorily" on the government's submission that it was unable to find the notification. "The legal basis for the ban was Section 11 of the Indian Customs Act, 1962, due to which the ban was imposed. However, after the Delhi High Court revoked the ban... the blasphemous book was being sold in India for the first time in 36 years,' the plea said. It further claimed the book was highly likely to violate public order as in the past several decades, not only the author but also the booksellers and those circulating the book were physically attacked and international relations between Iran and the UK several other countries had also strictly put restriction

The voluntary post lasts three years, extendable if conduct is satisfactory. Salary is ₹18,360 per month, with a daily wage of ₹612. Postgraduate aspirant Santosh Mohapatra said: "For the last two years, I have appeared at interviews. No opportunity so far. Any job is important for me." Biju Yuva Janata Dal president Chinmaya Sahoo criticised the government for lacking a concrete youth policy, noting only 57,000 appointments in 15 months against a promised 1.5 lakh and highlighting irregularities in several recruitment exams.

Police arrest doctor after 14 children die from toxic cough syrup

MI News Service, Bhopal (MP): A doctor in Madhya Pradesh's Chhindwara district has been arrested following the deaths of 14 children allegedly linked to contaminated Coldrif cough

Most of the affected children had been treated at the private clinic of Dr Praveen Soni, a government-appointed practising in Parasia, according to media reports. Soni is accused of prescribing Coldrif syrup to children who presented with routine cold and fever symptoms in early September, according to a report.
Following initial recovery,

the children's conditions worsened, with reduced urine output and kidney infections, ultimately leading to fatalities. Kidbiopsies later revealed diethylene glycol contamination in the syrups. The Madhya government banned the sale of cough syrup due to suspected renal failure, with officials stating the drug samples were found to contain a highly toxic substance.

The Central Drugs Standard Control Organisation (CDSCO) has also initiated risk-based inspections at the manufacturing units of 19 drugs, including cough syrups and antibiotics, across six states, the Union health ministry said on Saturday. A sample of the syrup, tested by the government drug analyst at the Drug Testing Laboratory in Chennai, was de-clared "Not of Standard Quality" by the Tamil Nadu Directorate of Drug Control, officials said here. The action by

ment came in the wake of the deaths of 14 children in Chhindwara district due to suspected kidney failure. Of these, 10 deaths were reported in Parasia subdivision since September 7, local officials said. Financial assistance of Rs 4 lakh was sanctioned for the kin of the 14 deceased children, officials said. Of those who died, 11 were from Parasia sub division, two from Chhindwara city and one from Chaurai tehsil. ODISHA registers over 37K crimes against women in 14 months

MI News Service, Cuttack: Odisha Chief Minister Mohan Charan Majhi informed the assembly that 37,611 cases of crime against women were registered in the state between June 2024 and July this year. In reply to a query of Congress MLA Sofia Firdous, the chief minister said 2,933 cases of rape, 9,181 molestation, 1,278 sexual harassment, 2161 public disof crime against women. robing of women, 8,227

kidnapping/abduction women, 5,464 dowry-related torture and 6,134 non-dowry torture were reported in the state during those 14 months. Similarly, 702 eve-teasing cases, 174 attempt to rape, 334 refusal to marry after sex, 447 stalking, three acid attack cases, three attempt to acid attack cases, 127 trafficking of women, 264 dowry homicide and 44 dowry suicide cases were also registered in different police stations across the state. Majhi said. In connection with the above crime against women cases, 5,979 people, including 225 women, were arrested, he said. Noting that preventive measures were taken to improve the safety and security of women in the state, the chief minister said all sensitive cases against women, such as rape, POCSO and acid attacks, are being monitored and supervised by SP or additional SP-level officers. A children and women online abuse monitoring unit is functioning under the CIDcrime branch to look into cybercrime against women and children, he said. Similarly, Majhi said that Investigative Units on Crime Against Women (IUCAW) is functioning in 29 districts, which takes up the investigation of important and sensitive cases

The CM further said that CCTV cameras have been installed in many districts to monitor the activities of antisocials and criminals to prevent crimes and to promote safety of women. The state government has been trying to expand the CCTV surveillance, he added. While 24 Special POCSO courts have been functioning to expedite trial in sexual offences against children, steps are being taken by district police to improve patrolling in important public places to prevent sexual harassment of women, as per the statement, he said. Besides, Child Marriage Prohibition Officers (CMPO) under the Prohibition of Child Marriage Act, 2006, Protection officers under the Protection of Women under Domestic Violence Act, 2005, Dowry prohibition officers under the Dowry Prohibition Act, 1961, are functioning for the cause of safety and security of women, he added.

Govt to examine state inputs on HIMALAYAN weather crisis

MI News Service, New Delhi: The environment ministry will examine the responses of the governments of Himachal Pradesh and Uttarakhand on the management of abnormal weather conditions in the higher Himalayas. Himachal Pradesh has stressed the need for a water inflow and flood warning system, whereas Uttarakhand has sought to carry out scientific studies at the national level on the flow of the Ganga and the Yamuna. The suggestions made by Himachal Pradesh and Uttarakhand came in separate affidavits filed in response to recommendations made by the joint committee appointed by the NGT on various issues, including abnormal weather conditions, river flow, snowmelt and cloudbursts, in the higher Himalayas. The reply was filed in a pending suo motu petition by the NGT on the issue related to the protection and declaration of the higher Himalayas as an eco-sensitive zone.

Himachal Pradesh, which has recently witnessed massive floods, informed the NGT that there is a need to develop an inflow and flood warning system basin-wise for all major rivers to get alerts in case of cloudbursts and glacial lake outbursts.

Uttarakhand, where a flash flood in the Kheer Ganga river in Uttarkashi's Dharali village caused widespread devastation recently, submitted before the NGT that policies and scientific studies must be undertaken at the national level through central institutions on the Ganga and Yamuna rivers. Avneesh Arputham and Ankit Sharma. appearing for the environment ministry, submitted before a bench headed by NGT chairperson Prakash Shrivastava that they needed four weeks to examine the suggestions of the two states. The tribunal posted the matter for November 28.

Centre envisages reforms in IIMs

They are not interested in accepting the credits of new IIMs. It would be very difficult for them to accept acacredits demic universities and private institutions," he said. A director of an IIM said the government might prod the IIMs to accept the academic credits of institutions of a certain standard. To achieve the government's Viksit Bharat@2047 goal, the Centre may ask the IIMs to increase their seats and introduce MBA courses in Indian languages. The IIMs have already enhanced the number of seats by 25 per cent in all courses to implement the 10 per cent reservation for the Economically Weaker Sections (EWS). At the meeting, the govern-



HIMACHAL: Snow leopards count up 62% in 4 yrs

MI News Service, Shimla: The population of rare snow leopards in high-altitude tribal areas of Himachal Pradesh has increased by 62 per cent over the past four years, says a newly released survey. The count stood at 51 in 2021, according to the baseline survey conducted by the Wildlife Wing of the state Forest Department. It has now increased to 83, officials said on Friday, citing the study conducted during the past one year. The survey also involved strong community participation, indicating that the long-term conservation plans with community involvement are bearing results, they added. The new survey released on Thursday (the first day of the Wildlife Week being observed from October 2 to 8) said the count excluded cubs and exceeded the estimated upper confidence limit of 73 over the 2021



survey, reflecting possible expansion of habitats. The survey was conducted through a large-scale camera trapping exercise across six sites over an area of 26,000 sq km. The snow leopards and their habitats were detected in the tribal areas of Lahaul-Spiti, Kinnaur and the Pangi valley.

However, the study also recorded their presence beyond the protected areas, which comprise the Kibber Wildlife Sanctuary, Great Himalayan National Park, Sechu Tuan Nallah Wildlife Sanctuary and Asrang Wildlife Sanctuary. In addition to snow leopards, the survey also drew distribution maps for key prey species such as the blue sheep, Himalayan ibex and musk deer, as well as other high-altitude mammals such as Himalayan wolves, brown bears, leopards, red foxes, and martens. Notably,

Study finds how bacterial vaccine demonstrates potential as treatment for cancer immunotherapy

researchers developed probiotic bacteria that train the immune system to eliminate cancer cells, paving the way for a new class of cancer vaccinations that take advantage of bacteria's innate tumour-targeting abilities. These microbial cancer vaccines can be tailored to each person's specific original tumour and metastases, perhaps preventing future recur-

In mice models of advanced colorectal cancer and melanoma, the bacterial vaccine stimulated the immune system, causing primary and metastatic malignancies to shrink - or in many cases disappear entirely. All while leaving healthy body parts alone.

The findings were published in

The bacterial vaccine proved to be particularly more efficacious than peptide-based therapeutic cancer vaccines that have been used in numerous previous cancer clinical trials

"The important advantage of our system is its unique ability to coordinately restructure and activate all arms of the immune system to induce a productive antitumor immune response. We believe this is why the system works so well in advanced solid tumor models which have been particularly difficult to treat with other immunotherapies," says Andrew Redenti, an MD/PhD student at Columbia University's Vagelos College of Physicians and Surgeons who helped lead the

study.
"The net effect is that the bac-

eliminate the growth of advanced primary or metastatic tumors and extend survival in mouse models, says Jongwon Im, a PhD student at Columbia University who helped lead bacterial engineering aspects of the study.

The bacterial vaccine is personalized for each tumor. "Every cancer is unique - tumor cells harbor distinct genetic mutations that distinguish them from normal healthy cells. By programming bacteria that direct the immune system to target these cancer-specific mutations, we can engineer more effective therapies that stimulate a patient's own immune system to detect and kill their cancer cells," says Nicholas Arpaia, PhD, Professor Microbiology & Immunology in the Columbia University's Vagelos College of Physicians and Surgeons who directed the research with Tal Danino, PhD,

Associate Professor of Biomedical

Engineering at Columbia's School

of Engineering. "As we continue to integrate additional safety optimizations through further genetic programming, we are getting closer to the point of testing this therapy in patients," he added. Bacteria have been utilized in the treatment of cancer since the late 19th century, when Dr. William Coley, who was a surgeon at New York Hospital, observed tumor regression in a subset of patients with inoperable tumors injected with bacteria. Bacteria are still employed as a therapeutic today in patients with early-stage bladder cancer.



Researchers now know that some bacteria can naturally migrate to and colonize tumors, where they can thrive in the often oxygendeprived environment and locally provoke an immune response.

But used this way, bacteria do not usually precisely control or direct the immune response to attack the cancer. "These qualities alone don't typically give bacteria enough power to stimulate immune responses capable of

good starting point for building a new domain of cancer therapeutics," said Nicholas Arpaia, PhD.

The new system starts with a probiotic strain of E. coli bacteria. The researchers then made multiple genetic modifications to precisely control the way in which the bacteria interact with and educate the immune system to induce tumor killing. The engineered bacteria encode protein targets called neoantigens - that are spe-

bacterially-delivered neoantigens train the immune system to target and attack cancer cells that express the same proteins. Neoantigens are used as tumor targets so that normal cells, which lack these cancer-marking proteins, are left alone. Due to the nature of the bacterial system and additional genetic modifications engineered by the scientists, these bacterial cancer therapies also simultaneously overcome

immunosuppressive mechanisms

tumors use to block the immune

These genetic modifications are also designed to block the bacteria's innate ability to evade immune attacks against themselves. As a safety measure, this means the engineered bacteria can be easily recognized and eliminated by the immune system and are quickly cleared from the body if they do not find the tumor.

When tested in mice, the researchers found that these intricately programmed bacterial cancer vaccines recruit a wide array of immune cells that attack tumor cells, all the while preventing responses that would normally suppress tumor-directed immune attacks. The bacterial vaccine also reduced the growth of cancer when administered to mice before they developed tumors, and prevented regrowth of the same tumors in mice that had been cured, suggesting the vaccine may have the ability to prevent cancer from returning in patients who've experienced remission.

In people, the first step in creating these microbial vaccines would be to sequence a patient's cancer and identify its unique neoantigens using bioinformatics. Next, the bacteria would be engineered to produce large quantities of the identified neoantigens, as well as other immunomodulatory factors. When infused into the patient whose tumors are to be treated, the bacteria would head to the tumors, make themselves at home, and steadily produce and deliver their payload of engineered "medicines." Once activatimmune system would be prompted to eliminate cancer cells that have spread throughout the body and prevent further metastatic development.

Since each tumor has its own of neoantigens, the immunotherapy will be custommade for each patient. "The time to treatment will first depend on how long it takes to sequence the tumor. Then we just need to make the bacterial strains, which can be quite fast. Bacteria can be simpler to manufacture than some other vaccine platforms," Danino

says.

The researchers think their approach may succeed where earlier cancer vaccines have not. In the latter, while immune responses against tumor neoantigens may be induced, direct modulation of the immunosuppressive tumor environment is not accomplished to such a degree.

Arpaia adds, "Bacteria allow delivery of a higher concentration of drugs than can be tolerated when these compounds are delivered systemically throughout the entire body. Here, we can confine delivery directly to the tumor and locally modulate how we're stimulating the immune system.

Study gives insights into quality of life for adults with congenital heart disease



WASHINGTON: Adults with congenital heart disease (CHD) can now gain vital insights into their long-term quality of life according to data from the Congenital Heart Initiative (CHI). CHI is the nation's first and largest patient-focused registry for people with CHD, and it recently launched its inaugural research, which included over 4,500 participants from all 50

states. This study, published in JAMA Network Open, represents a big step forward in providing better information to the 1.5 million adults in the United States who

were born with CHD. "Studies like this that leverage actual patient voices and experiences help us get a better sense of how to advise, support and treat people with CHD as they age, says Anitha John, M.D., Ph.D., director of the Washington Adult Congenital Heart program at Children's National Hospital and senior author of the study. "Also, researchers get a clearer picture of the questions that need to be answered to make sure they have the best quality of life possible."

Treatments for children born with congenital heart disease have improved so significantly in the last two decades that life expectancy continues to increase

There are now more adults living with congenital heart disease than there are children with CHD," says Scott Leezer, patient co-principal investigator for the Congenital Heart Initiative registry and co-author of the study. "However, a significant gap remains in what we know about the adult CHD population. As an adult CHD patient, I was excited to contribute to creating this registry, bringing more answers to people like me who want to know how our unique hearts impact our bodies and quality of life over

The authors note that the study's findings and the registry data currently have a few limitations. First, the registry only contains patient-reported outcomes and no clinical data. The first substudy of the CHI, the CHI-RON study, addresses this challenge by incorporating additional data sources for a subset of consenting CHI participants.

Additionally, recall bias,

underlying neurocognitive challenges and survey fatigue, may have limited participation in the CHI to a smaller subset of adults with CHD. Efforts are underway to develop methods for people with congenital heart disease who have neurodevelopmental deficits or other disabilities to engage in the registry. The CHI is temporarily closed to new registrants as the study team redesigns the study to better align with the needs of the community.

"We are grateful for everyone who joined this registry, answered survey questions and shared their experiences," savs Thomas Carton, Ph.D., chief data officer at Louisiana Public Health Institute and study co-author. "The CHI registry is a big step forward for adults with CHD, but also can serve as a model for how to bring together physicians, researchers and patients as active participants in care, research and advocacy."

Study finds novel approach to treat neurological diseases

SAN FRANCISCO: The matter of what causes complicated neurological disorders like Alzheimer's or multiple sclerosis continues to perplex scientists and doctors, with unknowns impeding early diagnosis and successful treat-

Even when identical twins have the same genetic risk factors, one may acquire a specific neurological condition while the other does

That's because, unlike diseases like cystic fibrosis or sickle-cell anaemia, which are caused by a single gene, most neurological problems are linked to a large number--sometimes hundreds--of genetic variants Furthermore, these polymorphisms cannot identify who will develop disease on their own, because neurological diseases are heavily influenced by environmental factors and vascular hazards such as high blood pressure, age-

ing, heart disease, or obesity. But there's one often-overlooked thread that connects most neurological diseases, says Katerina Akassoglou, PhD, a senior investigator at Gladstone Institutes: They're marked by a toxic immune reaction caused by blood that leaks into the brain through damaged blood vessels.

"Interactions between the brain, blood vessels, and the immune system are a common thread in the development and progression of many neurological diseases that have been traditionally viewed as very different conditions," says Akassoglou, a senior investigator with the Gladstone



and director of the Center for Neurovascular Brain Immunology at Gladstone and UC San Francisco. "Knowing that leaked blood is a key driver of brain inflammation, we can now approach these diseases from a different angle. She and her collaborators

share their insights on this topic in a commentary article published in Cell's 50th anniversary "Focus on Neuroscience" issue. Akassoglou and her lab have long investigated how blood that leaks into the brain trigger neurologic diseases, essentially by hijacking the brain's immune system and setting off a cascade of harmful often-irreversible effects that result in damaged neurons. One blood protein in particular--fibrin, normally involved in blood coagulation--is responsible for setting off this

detrimental cascade. The process has been observed in conditions as diverse as Alzheimer's, traumatic brain injury, multiple sclerosis. premature birth, and even COVID-19. However, Akassoglou and her team found that the process could be prevented or interrupted by "neutralizing" fibrin to deactivate its toxic properties--an approach that appears to protect against many neurological diseases when tested in animal models.

"As a first step, we know that neutralizing fibrin reduces the burden posed by vascular dysfunction," Akassoglou says. Regardless of what initially caused the blood leaks, be it a head injury, autoimmunity, genetic mutations, brain amyloid or infection, neutralizing fibrin appears to be protective in multiple animal models of disease.

The scientists previously developed a drug, a therapeutic mono-

targets fibrin's inflammatory properties without affecting its essential role in blood coagulation. This fibrin-targeting immunotherapy has shown, in mice, to protect from multiple sclerosis and Alzheimer's, and to treat neurological effects of COVID-19. A humanized version of this first-inclass fibrin immunotherapy is already in Phase 1 safety clinical trials by Therini Bio, a biotech company launched to advance discoveries from Akassoglou's lab.

In the Cell commentary, Akassoglou and her colleagues make the case that seemingly disparate neurological diseases must be viewed differently in light of new research on the blood-brain immune interface. They say that in the coming decade, scientific breakthroughs will emerge from collaborative networks of immunologists, neuroscientists, hematologists, geneticists, computer scientists, physicists, bioengineers drug developers, and clinical researchers. These partnerships-forged across academia, industry, and foundations--will catalyze innovation in drug discovery and transform medical practice for neurological diseases.

"This is a new opportunity for drug discovery that goes beyond addressing genes alone or environmental factors alone, Akassoglou says. "To usher in this new era, we must leverage new technologies and embrace an interdisciplinary approach that accounts for the important roles of immune and vascular systems in neurodegeneration."

Study: Biomarker may predict response to immunotherapy in liver cancer

NEW YORK [US] : According to a preclinical study conducted by Cornell Medicine researchers, it may soon be feasible to detect whether individuals with hepatocellular carcinoma, a kind of liver cancer, may benefit from immunotherapy.

The work, published on October 17 in Molecular Cell, sheds fresh light on a pair of proteins known as p62 and NBR1, and their conflicting roles in regulating the interferon response in hepatic stellate cells, an important immunological component in the liver's fight against tumours. The study shows that high amounts of the immune-suppressing NBR1 in these specialised cells can help identify patients who are unlikely to respond to immunotherapies. It also reveals that NBR1-lowering techniques can decrease tumours in animal models, indicating a potential new therapy option for the subgroup of patients who do

"P62 and NBR1 are yin and yang," said the study's co-principal investigator Dr. Jorge Moscat,

the Homer T. Hirst III Professor of Oncology in Pathologyand a member of the Sandra and Edward Meyer Cancer Center at Weill Cornell Medicine. "In contrast to NBR1, if p62 is high in hepatic stellate cells, a patient is protected from cancer, but if it is low, the immune system is knocked down. If NBR1 is high, the immune system is impaired, but if NBR1 is low, the immune response increases.

Until recently, patients with hepatocellular carcinoma had few treatment options, and those that were available extended life by few months. Immunotherapy has offered a new alternative for these patients and may extend their lives for up to

two years.
"The liver is an organ that is tremendously immune suppressed," said co-principal investigator Dr. Maria Diaz-Meco, the Homer T. Hirst Professor of Oncology in Pathology and a member of the Meyer Cancer Center at Weill Cornell Medicine. "Reactivating the immune system



is a very attractive approach that is now bearing fruit.

However, not all patients respond to immunotherapy, and only a small percentage achieve long-term remission. Clinicians cannot currently predict which patients would benefit. "We need biomarkers to identify which patients will respond and who will

achieve long-term survival," she said. Drs. Moscat and Diaz-Meco worked with co-first authors Dr. Sadaaki Nishimura and Dr. Juan F. Linares, a postdoctoral associate and an instructor, respectively, in the Department of Pathology and Laboratory Medicine at Weill Cornell Medicine, and Dr. Antoine L'Hermitte, formerly of Sanford Prebys Medical Burnham Discovery Institute, on the study.

The investigators aimed to identify biomarkers and potential therapeutic targets by studying what goes wrong in the liver's healing mechanisms that leads to cancer. Prior research has found that levels of the tumor-suppressing protein p62 are irreversibly depressed in patients who develop hepatocellular carcinoma. The new study shows that, usually, p62 helps promote an immune response by activating a protein called STING, which pushes NBR1 out of the way, triggering an immune response that destroys tumor cells. NBR1, by contrast, promotes the breakdown of STING and blocks the immune response. Deleting NBR1 from hepatic stellate cells in mice with hepatocellular carcinoma rescues the immune response and shrinks tumors even when p62 levels

remain low. The team is now investigating how they can develop a therapy that would degrade NBR1 in patients and block it from interacting with STING. The goal is to reactivate the immune system and help increase the effectiveness of immunotherapy. Drugs that activate STING are also in development and might provide another approach to help boost the immune response in patients with hepatocellular carcinoma. The team will also study whether knocking down NBR1 might help prevent the metastasis of many types of cancer or prevent tumors from becoming resistant to therapy. Dr Moscat and Dr. Diaz-Meco plan to continue their studies of the pathways that regulate the immune response in the liver.
"If we don't fully comprehend

the molecular mechanisms reguthese processes. immunotherapy will not progress, and we won't be able to understand why it works in some patients and not others," Dr. Diaz-Meco said.



IRAN executes 6 accused of ties to Israel

MI News Service, Tehran: Iran has executed six fighters accused of waging armed attacks in the southwestern province of Khuzestan, according to state media, as the country continues its accelerated executions of people it says have ties to Israel following the 12-day June conflict with Israel and the United States.

"The death sentence for six separatist terrorist elements, who in recent years had carried out a series of armed operations and bombings targeting security in Khuzestan province, was carried out at dawn today," the judiciary said. The identities of all those executed and details of their arrests and sentencing were not immediately clear. But Mizan reported that they were involved in the killings of four security personnel, including two police officers and two members of the Basij paramilitary force, in 2018 and 2019.

The report also said they had "confessed to planning and executing acts of sabotage such as making and planting bombs, blowing up the Khorramshahr gas station". Iran usually links what it calls "separatist and terrorist" groups to its arch-nemesis, Israel. In a separate execution, authorities hanged Kurdish fighter Saman Mohammadi after convicting him for "Moharebeh" - waging war against God. Mohammadi, arrested in

2013, was reportedly involved in the 2009 killing of the Friday prayers imam in the western city of Sanandaj, as well as in armed robberies and kidnappings, including the killing of a conscript. The executions came less than a week after Iran said it hanged Bahman Choobiasl, a man it described as "one of the most important spies for Israel in Iran". Mizan reported that Choobiasl was executed over his meeting with officials from the Israeli spy agency, Mossad. Get instant alerts and updates based on your interests. Be the

first to know when big stories happen. According to Mizan, Choobiasl had worked on "sensitive telecommunications projects". Iran's Supreme Court rejected the defendant's appeal and confirmed the death sentence on charges of "corruption on Earth", it said. Entangled in a

and a full-blown conflict this June, Iran has put to death many individuals it accuses of having links with Mossad and facilitating its operations in the country.

Israel's offensive in June involved 12 days of air attacks, including several that targeted Iran's top generals and nuclear scientists, as well as civilians in residential areas, for which Iran retaliated with barrages of missiles and drones. The US also carried out extensive strikes, on Israel's behalf, on Iranian nuclear sites during the conflict. According to Amnesty International, Israeli attacks on Iran killed at least 1,100 people. In response to the June war and protests in recent vears over the state of the economy, women's rights and some calls for regime change, Iran has sentenced more people to death. According to the Oslo-based group Iran Human Rights and the Wash-DC-based Abdorrahman Boroumand Center for Human Rights in Iran, the number of people executed in 2025 was more than 1,000, but it notes that the number could be higher as Tehran does not report each execution. Iran is the world's second most prolific executioner after China, according to

human rights groups including Amnesty International.

JIHADIS rape man in Dresden Rly Stn

MI News Service, Dresden (Germany): Brutal attack on a 19-year-old young man at Dresden's main train station transmits shock waves in Germany. According to police, two 15-year-old Syrians allegedly threatened, robbed, and then raped a young Czech man on Sunday morning.

The Syrian youths allegedly attacked their victim around 4:15 a.m. The 19-year-old was on his way home at Wiener Platz near the main train station early Sunday morning when he was allegedly first ambushed and then sexually assaulted. The police, in response said: "The suspects allegedly robbed the man of 300 euros at knifepoint and raped him."

The victim immediately called the police after the incident, who were able to apprehend the perpetrators shortly thereafter. The police stated: "The two were in the immediate vicinity of the crime scene." The suspects were arrested, and the investigating judge in Pirna issued an arrest warrant. They are in custody. The two are said to live in Heidenau and Neustadt and, according to a spokesperson for the Dresden public prosecutor's office, have not yet come to the attention of the police.

The young man from the Czech Republic lives in Dresden. He received outpatient medical treatment. The severity of his injuries has not been disclosed. The public prosecutor's investigation is ongoing. Just in August, a knife attack on US citizen John Rudat (20) caused out-

Modi to inaugurate Navi Mumbai **International Airport on Oct 8**

MI News Service, Mumbai: The airport, which received its aerodrome licence from the Directorate General of Civil Aviation (DGCA) on September 30, is set to begin commercial operations from December. The airport was developed in multiple phases by Navi Mumbai International Airport, with the Adani Group holding a 74 per cent stake and the remaining 26 per cent owned by Maharashtra government's land development authority, CIDCO.

CIDCO vice chairman and managing director Vijay Singhal said at a briefing on Saturday, "The Prime Minister will inaugurate the airport at 2.40 pm on October 8, and it will be operational from December." Navi Mumbai International Airport, with airport code 'NMI', will be the second airport serving the Mumbai Metropolitan Region. Once fully operational, it is expected to handle 90 million passengers and manage 3.2 million metric tonnes of cargo annually, making it one of the largest aviation hubs in Asia. Initially, the airport will start with one runway and a terminal capable of handling 20 million passengers per year, about onethird the capacity of Mumbai airport.

airline Commercial flights are likely to start in mid-November, with ticket sales commencing weeks before. Maharashtra chief minister Devendra Fadnavis announced that the airport will be named after the late DB Patil, a politician and social activist who ensured fair compensation for farmers who gave up land for the building of Navi Mumbai. "While granting permission for the airport construction earlier, the Centre had approved the name 'Navi Mumbai International Airport'. With the proposed renaming, it will now be known as 'Loknete DB Patil Navi Mumbai International Airport'. Prime Minister Narendra Modi has approved the state's proposal," Fadnavis said.

He also added that approvals for renaming Pune airport after Jagadguru



Sant Tukaram and Chhatrapati Sambhaji Nagar (Aurangabad) airport after Chhatrapati Sambhaji Maharaj are in the pipeline. "The official name announcement will coincide with the commencement of passenger operations. During the interim 'dry run' period, advance bookings and technical readiness procedures will be conducted," he said.

SANAE TAKAICHI to become Japan's first female PM

MI News Service, Tokyo: Japan's governing party elected former Economic Security Minister Sanae Takaichi, a hard-line ultra-conservative and China hawk, as its new leader, making her likely to become the country's first female prime minister. In a country that ranks poorly internationally for gender equality, the 64-year-old Takaichi makes history as the first female leader of Japan's long-governing conservative Liberal Democratic Party (LDP). Takaichi is one of the most conservative members of the male-dominated party.

An admirer of former British Prime Minister Margaret Thatcher, Takaichi is a protege of former Japanese Prime Minister Shinzo Abe's ultra-conservative vision and a regular at the Yasukuni Shrine, seen as a symbol of Japan's wartime militarism, which could complicate Tokyo's relations with its Asian neighbours. Takaichi beat Agriculture Minister Shinjiro Koizumi, the son of popular former Prime Minister Junichiro Koizumi, in a runoff in a vote by the LDP. Takaichi replaces Prime Minister Shigeru Ishiba as the party hopes to regain public support and stay in power after major election losses

She is likely to be Japan's next prime minister because the party remains by far the largest in the lower house, which determines the national leader, and because opposition groups are highly splintered. Takaichi vows to strengthen Japan-US alliance Takaichi later said she will immediately work on stemming rising prices, while also focusing on diplomatic and security challenges. A parliamentary vote is expected in mid-October. The LDP, which has been criticised by opposition leaders for creating a prolonged political vacuum, said Takaichi needs to hurry because the winner will soon face a diplomatic test: a possible summit with US President Donald Trump, who could demand that Japan increase its defence spending.

A meeting is reportedly being planned for late October. Trump will travel to the Asia-Pacific Economic Cooperation summit in South Korea starting October 31. Takaichi said en- wings in the party.

matic priority. "It is essential to ... confirm the reinforcement of the Japan-US alliance," she said. Takaichi will also need cooperation from key opposition groups to implement her party's policies.

Ishiba, who achieved a 15 per cent tariff deal with Washington and put Japan's ties with South Korea and other Asian countries on track during his one-year stint, said "I hope the LDP will band together under new (party) president Takaichi to serve for the country and the people, as well as the world and for the new era." Direct air cargo mission flagged off to Antarctica from Goa

MI News Service, Goa: The Goa-based National Centre for Polar and Ocean Research (NCPOR) has sent a direct air cargo flight from the state to Antarctica, marking a significant step in enhancing logistical efficiency for India's polar expeditions, an official has said. The cargo flight loaded with 18 tons of essential supplies, including scientific equipment, medicines, and annual provisions for Indian research stations in the Antarctic, took off from Manohar International Airport, Mopa, in North Goa. Dr Thamban Meloth, director of NCPOR, flagged off the flight, a DROMLAN-operated IL-76 aircraft, the official said. NCPOR, under the Ministry of Earth Sciences, is a premier institution responsible for India's research activities in the polar and Southern Ocean realms.

This direct route strengthens India's self-reliant polar logistics and underscores our commitment to cutting-edge Antarctic research," said Dr Meloth. A senior NCPOR spokesman said this shipment, routed via the gateway city of Cape Town in South Africa, marks a significant step in enhancing logistical efficiency for India's polar expeditions. "The cargo will support ongoing scientific research in glaciology, oceanography, and climate studies at stations like Bharati and Maitri," the spokesman said. He said that the mission was facilitated by GMR Aero Cargo and Logistics, with support from Alpha Crux, Ultima Antarctic Logistics, and South Africa.

Thursday. Draft rules proposed to allow any authorised officer under the rules to enter any place, whether physical or digital, and search and arrest without warrant any person found to be suspicious of having committed or about to commit any offence under the Promotion and Regulation of Online Gaming (PROG) Act 2025.

"Notwithstanding anything contained in the Bharatiya Nagarik Suraksha Sanhita, 2023, offences under section 5 and section 7 shall be cognizable and non-bailable,' according to the draft

Section 5 under the draft rules prohibits enti-

ties from offering, aiding, abetting, inducing or engaging in online money games and online money gaming services.

Section 7 bars banks, financial institutions, or any other person from facilitating financial transactions for any online money gaming service. The draft rules have

The Act approved by Parliament in August bars online money games and money-based gaming gaming services in the country, as well as their promotion. The rules propose protection to officers or persons authorised to conduct searches of suspicious places, including devices under the Act, from any sort of lawsuit or legal proceedings. The Ministry of Electronics and IT has invited feedback and comments on the draft rules by October 31.

International Series: Ormsby turns season around with play-off win over Vincent as Bhullar's challenge falters in Jakarta

JAKARTA: Australian Wade Ormsby defeated Scott Vincent from Zimbabwe on the first hole of a sudden-death play-off to win the Jakarta International Championship, as Gaganjeet Bhullar's hopes of a sixth win in Indonesia faltered on the final day at the Damai Indah Golf - PIK Course on Sunday.

The 45-year-old Ormsby had gone into the final round tied on -11 with Vincent, the International Series Morocco victor, and 2023 BNI Indonesian

Masters champion Bhullar. Although Bhullar and Vincent both picked up a birdie on the first, the Indian dropped three shots on the front nine to fall away. Two early birdies after the turn gave the Indian hope, but two costly doubles on 15 and 18 dashed any hope he had.

That left Vincent and Ormsby in a play-off, and the man from Down Under triumphed after making a routine par on the par-four 18th, where Vincent found water with his second shot. Both had finished on -12 with one-under rounds as the nerves kicked in, one ahead of a packed bunch including Scott's younger brother Kieran Vincent, Doyeob Mun of Korea, and the Thai trio of Pavit Tangkamolprasert, Poom Saksansin, and Sadom Kaewkanjana.

While Bhullar was the highest-placed Indian on seven under overall, Viraj Madappa carded a 66 to finish on three under, and Chikkarangappa S. finished a shot further back on two over after a 74.

It is Ormsby's fifth victory on the Asian Tour and second on The International Series. His last win came at the 2023 International Series Thailand.

The victory also made up for being penalised one shot after his third round when he was judged to have accidentally moved his ball when he addressed it on the fourth. He had been enduring a poor season with his best finish a tied 21st at the International Series India presented by DLF.

"It was a bit of a grind," said Ormsby, who made nine straight pars on the back nine.

"Probably didn't have my best stuff out there, but I was just hanging in there. Feel bad for Scotty, you know, he kind of let a couple slip at the end there. But I hit a couple of great shots in that play-off hole, so

that makes me feel better about the whole thing." Vincent was attempting to become the first player win back-to-back events on The International Series, having won the International Series Morocco in July. It means he has now finished runner-up in his last two Asian Tour events, as he was joint second in the Shinhan Donghae Open last month.



WPAC 2025: Zileide, Fatma hand Polish long jump legend Karolina a rare defeat

NEW DELHI: Zileide Cassiano Da Silva of Brazil and Fatma Damla Altin of Turkiye became only the second and third athletes in history to defeat Karolina Kucharczyk-Urbanska (Poland) in a global women's long jump T20 competition when they relegated her to a bronze medal at the World Para Athletics Championships here on Sunday.

Zileide Cassiano Da Silva and Fatma Damla Altin, who finished behind the Polish athlete at the Paris 2024 Paralympic Games, found their pace, rhythm, and flight to leap 5.88m and 5.72m, securing gold

The legend Kucharczyk-Urbanska, who was returning to the World Para Athletics Championships after missing 2024, had a best of 5.55m.

It was only the third defeat in a global competition for Karolina Kucharczyk-Urbanska in 10 global competitions since making her debut in 2011. She has won gold in four World Championships and three Paralympic Games. Although she has breached the 6m often, an ankle injury has meant she had to settle for a season's best jump for bronze.

Kucharczyk-Urbanska said the bronze felt like gold because she is dealing with an injured ankle. She also said she liked how she fought till the end to be on the podium despite competing in unfamiliar heat and humidity. "I had a lot of fun today," she said. I fought hard to get on the podium," she said.

Interestingly, Mikela Ristoski (Croatia), the athlete who had beaten the Polish jumper both at the World Para Athletics Championships in Christchurch in 2011 and the Paralympic Games in Rio de Janeiro in 2016 - was engaged with Kucharczyk-Urbanska in the fight for bronze but was unable to edge her renowned rival off the podium.

From the shot put circle, the Netherlands' Lara Baars threw the iron ball over 9.77m to set a new World Record in the women's F40 class. The only competitor to surpass the 9m mark, the 28-year-old broke her own World Record twice, making it the 30th world record in New Delhi 2025

Meanwhile, on Sunday morning, the Jury of Appeal reversed an earlier decision and reinstated four marks of Brazilian Paulino dos Santos Thiago in the men's Shot Put F57 final, including a best of 14.82m that gave him the silver medal and relegated India's Soman Rana to bronze and Finland's Teijo Koppikka out of the podium.

While India's count of medals remained at 18, it now has six medals of each colour and is placed seventh on the table. India's hopes of rising higher rest on sprinter Simran Sharma's shoulders as she competes in the women's 200m T12 final, where she will go up against Clara Barros Da Silva (Brazil) and Venezuela's Alejandra Paola Perez Lopez.

A part of me will always be here: Inter Miami honour legendary retiring midfielder Sergio Busquets

Miami CF honoured the legendary midfielder Spanish Busquets. who recently announced that the 2025 MLS season would be his last as a player, after Saturday's 4-1 home victory over the New England Revolution.

Miami played a video tribute for Busquets on the Chase Stadium scoreboard featuring fellow FC Barcelona icons Pep Guardiola, Xavi Hernandez and Lionel Messi - with whom he forms the club's "Core Four" along with Luis Suarez and Jordi

"I have no words. A part of me, of my heart, will always be here Busquets said with you," "Hopefully, it can end in the best way possible. Which is being in the playoffs and going for the

Busquets, who joined Miami in July 2023 from Barcelona FV, has been crucial to the club's ongoing growth, offering his vision and skill in midfield, along with his experience and leadership.

He has won the Leagues Cup 2023 and the 2024 Supporters' Shield with the Herons. Overall, he has made 107 appearances across all competitions, scoring one goal and providing 19 assists.

Busquets further revealed plans to take a sabbatical from football after retirement at the end of the 2025 MLS season, before chasing a coaching career.

I think in the future, yes (I'd want to be a coach), but for now I'd rather take a sabbatical." he



said. "It's a long time, with hardly any weekends. Like any footballer obviously, playing for the national team and everything gives you another plus, but you also have less time. "You want to enjoy time with your family, time for me, for them, seeing my children, being with them, travelling more, watching football from a different perspective. And then, in the future, we'll see.'

Busquets made his Barca debut on September 13, 2008, when Pep Guardiola (already familiar with him from Barca Athletic) handed him his chance against Racing Santander.

The defensive midfielder made 722 appearances for Barcelona, the third highest in the club's history. He has won 32 trophies, including nine La Liga titles, seven Copa del Rey wins, and three UEFA Champions League victories. His career total of trophy wins stands at 36 major titles across Barcelona, Spain, and Inter Miami.At the international level, Busquets made 143 appearances for Spain while being part of the 2010 World Cup winning squad and the UEFA Euro victory in

Messi becomes second player in **MLS** history to reach at least 40 combined goals and assists

FORT LAUDERDALE: Lionel Messi has added another milestone to his crowded mantle after recording three assists in the 4-1 home win over the New England Revolution, reaching 41 goal contributions this season. Messi became only the second player in MLS history to reach at least 40 combined goals and assists in a regular-season campaign, following Carlos Vela's record 49 with LAFC in 2019.

He assisted Tadeo Allende's goal in the 32nd minute, which opened the scoring. Then, before the half-time break, he linked up with former FC Barcelona teammate Jordi Alba with a fine piece of dribbling inside the box. The classic combination doubled Miami's lead, MLS reports.

Dor Turgeman pulled one back for the visitors in the 59th minute, but Miami responded almost immediately. Messi, just a minute later, set up Allende's second goal of the night, shortly before Alba added a brace of his own to round out the scoreboard.

"He gave us the possibility of opening the score and then securing the result," head coach Javier Mascherano said post-game of Messi's latest standout performance. "Not only with the pass for Jordi, but when they [New England] made it 2-1, and in the next play with an assist that only he can give. He keeps showing the ability he has and, more than anything, the ambition and desire to go for more." Messi has two more games to increase his goal contributions and possibly challenge Vela's record, starting with Saturday's regular-season.
