The opposition party's assertion came after Prime Minister Modi welcomed the agreement on the first phase of US President Donald Trump's peace plan for West Asia, under which Israel and Hamas have decided to pause fighting

Modi also said the agreement was a reflection of the strong leadership of Netanyahu.

list of candidates for other seats. If you find Kishor Ji's name on the list, then he will be contesting. It's quite clear. Kishor Ji will launch the party's election campaign from Raghopur on October 11",

Singh said. The inaugural list cov-51 constituencies across 26 districts, marking the party's formal entry into the state's electoral arena.

Outlining the party's campaign plans, Singh said "We will soon release the list of candidates for other seats soon. He, however, did not disclose the total number of seats they would contest.

As the first list does include Kishor's name,the suspense over whether the Jan Suraaj founder himself will enter the electoral fray, has remained alive. Bihar assembly elections will be held in two phases on November 6 and November 11. The results for all 243 seats will be declared on November 14 paving the way for the formation of a new government.

China to resume after five years INDIA, CHINA TO RESUME DIRECT FLIGHTS

MI News Service, New Delhi / Beijing: Acting "faithfully" on the improvement of relations between Prime Minister Narendra Modi and President Xi Jinping to strengthen bilateral ties, both India and China have decided to resume direct flight between the two countries after a gap of over five years. .

Speaking at a media briefing on Thursday, the first since the Chinese Foreign Ministry resumed its regular schedule following the eight-day national holidays, Chinese government spokesperson Guo Jiakun said the direct flights to and from several cities of both the countries would resume by the end of October and described the move as a "positive step",

Incidentally, India has announced on Thursday that direct flights to various Chinese cities would resume from October 26.

This is the latest move

that demonstrates how the two countries are faithfully acting on the important common understanding between President Xi Jinping and Prime Minister Narendra Modi in Tianjin on Aug 31, Guo said in response to a question. Modi and Xi had met on

the sidelines of the Shanghai Cooperation Organisation (SCO) summit in Tianjin and welcomed the positive momentum and steady progress in bilateral relations since their last meeting at Kazan, Russia, in October 2024.

Guo said China stands ready to work with India to view and manage bilateral relations from a strategic and long-term perspective, to be friends, good neighbours and partners who support each other's suc-

He used a metaphor of a cooperative pas de deux (dance) of the dragon and the elephant to emphasise

ties of China and India in promoting peace, prosperity and greater deliverables for the people of both countries and for Asia at

large.
Chinese airlines such as Air China, which previously operated flights between the two countries, is however, yet to announce formal plans for resumption of air services. Indian carrier IndiGo

and China Eastern will be the first two airlines to resume direct flights between the two countries, people familiar with the development had said. IndiGo had said in a statement that it plans to op-erate daily flights from Kolkata to Ğuangzhou from October 26.

"Subject to regulatory approvals, IndiGo will also introduce direct flights between Delhi and Guang-zhou shortly," it said.

The passenger air services between the two sides were suspended following the COVID-19 pandemic in 2020. They were not restored in view of the over-four-year border face-off in eastern Ladakh, which ended in October last year.

The Ministry of Civil Aviation had said India and China would resume direct air services by the end of October.

Mahananda swallows entire colony, residents lose homes and life savings

MI News Service, Jalpaiguri: In a devastating turn of events along the Mahananda River in Porajhar, Jalpaiguri, an entire riverside colony has been swallowed by floodwaters, leaving residents destitute and highlighting longstanding issues of illegal land sales and mismanagement. Locals allege that river char lands were sold at exorbitant prices, with ruling party leaders and panchavat officials reportedly facilitating settlements in exchange for money. Families who invested their life savings in the land have now lost both their homes and their money. Many residents purchased plots for lakhs of rupees, only to witness the rising river sweep away houses, livestock, and personal belongings, including schoolbooks soaked and ruined by silt.

Evewitnesses described scenes of despair, with families forced to take shelter in relief camps and depend on aid from voluntary organizations, including the Ramakrishna Mission. "We invested 1.5 lakh rupees, and now that land, once priced at 4 lakh rupees, is gone along with our homes," a resident said, visibly distraught. Authorities confirmed that the dam in the area broke during the disaster, sparing some residents from being swept further downstream to-



ward Bangladesh. Nonetheless, the event has exposed the peril of unchecked settlement on riverbanks and the exploitation of vulnerable communities. The area affected falls under the Dabgram-Phulbari assembly constituency, where the state leadership has taken notice. Chief Minister Mamata Banerjee expressed anger, and local party officials, including the block president, were arrested and expelled. However, residents allege that enforcement has been inconsistent, with some offenders quickly obtaining bail while the victims continue to suffer. This tragedy underscores the interconnection between environmental hazards, poor governance, and exploitation of marginalized communities, leaving a cautionary tale for policymakers, residents, and authorities across flood-prone regions.

Early man electrocuted to death in illegal electric trap set to kill pigs

MI News Service, Howrah: A shocking incident of negligence and tragedy has rocked Howrah's Pantihati area, where an elderly man was electrocuted to death after coming in contact with an illegal electric trap laid to ward off


wild pigs. The deceased, identified as Nabakumar Das (60), a resident of Dhalipara in Pantihal, had gone missing on Wednesday evening after heading out to cut grass for his livestock. When he failed to return home, his family lodged a missing person's complaint at Jagatballabhpur Police Station that night. On Thursday morning, Nabakumar's charred body was found in a nearby paddy field — his entire body bearing signs of severe burns. Shock and grief swept through the locality as police arrived at the scene and sent the body for post-mortem examination. Preliminary investigations suggest that the farmland where Nabakumar's body was found had electric wires illegally connected to a

power source — a crude setup designed to electrocute wild pigs that had been ravaging crops in the area. Investigators believe Nabakumar may have accidentally touched the live wire while cutting grass. Local residents allege that such dangerous electric traps have become a common practice in rural stretches of Howrah, as farmers struggle to protect their standing crops from herds of pigs that regularly destroy farmlands. Police from Jagatballabhpur have launched a probe into the incident, examining who was responsible for setting up the fatal trap and whether electricity theft was involved. The body has been sent for forensic examination to confirm the cause of death. A pall of mourning hangs over Pantihal as the community reels from the horrific death. What began as a desperate attempt to save crops has ended in the gruesome electrocution of an innocent man — a grim reminder of how fatal desperation can become when law and safety are ignored.

MI News Service, Canning: Political temperatures flared in South 24 Parganas after a sharp war of words broke out between TMC MLA Saokat Molla and ISF leader Naushad Siddiqui, following of series of explosive remarks made at a party works' meeting.

People across Bengal are increasingly supporting ISF despite intimidation," he added. Responding to the controversy, BJP spokesperson Debjit Sarkar refrained from taking sides, saying, "This kind of po-

litical exchange is not new. The people of Bengal are focused on change through the ballot, not on these statements." The verbal duel between the two legislators has once again highlighted the fractured political equations in Bengal's minority-dominated regions, particularly ahead of the upcoming civic and local body elections. Even as investigations into the alleged defamatory remarks continue, political observers note that such charged exchanges reflect the intensifying contest for influence among emerging and established parties in South Bengal.



Whistle revolution: A sound that sends children to school

MI News Service, Asansol: In a heartwarming example of community-driven reform, residents of Palashdiha village in Asansol, West Bardhaman have turned a simple soundthe blowing of a whistle-into a powerful tool for education and social change.

Every morning, as the whistle echoes through the narrow lanes of the village, children stop playing and rush home to get ready for school. What began as a small community experiment has now evolved into a successful grassroots initiative that's curbing absenteeism and reviving school attendance among rural children. The initiative, launched by the voluntary organization Food Education and Economic Development (FEED), was conceived in response to rising school truancy in the area. With most parents working as daily wage laborers — in fields, construction, and local industries — many children were left unsupervised in the mornings and often skipped school. To counter this, FEED assigned local youth and elderly volunteers to take on a new morning duty: blowing whistles an hour before school starts. The sharp sound serves as a reminder for children across the village — an unconventional alarm clock urging them to prepare for class. "Earlier, our children used to forget the time and stay out playing," said Ganga Bhuiyan, a resident. "Now, when the whistle blows, everyone knows it's time for school. It has made a real difference." Teachers and parents alike have praised the effort, noting a visible increase in attendance and punctuality. The model has also caught the attention of neighboring villages, which are now planning to replicate the "whistle alert" system in their own areas. What began as a small act of community awareness has grown into a symbol of collective responsibility — a simple, rhythmic reminder that education begins not only with classrooms, but with a community that cares.

Woman found dead, husband missing-police suspect murder

MI News Service, Falakata: A pall of shock and suspicion has gripped Falakata after the body of a young woman was discovered under mysterious circumstances inside government quarters on Wednesday evening. Authorities suspect foul play, while the woman's husband has been missing since the incident.

The deceased, identified as Babli Devi (27), was found lying lifeless on the floor of Quarter No. 10B, Type One, in a residential colony. According to sources, Babli's husband, Ranjan Kumar, a Class IV government employee, had recently moved into the quarters with her just a few days prior. Local residents reported that repeated calls to the couple went unanswered throughout the evening. Concerned by the unusual silence, neighbors eventually broke open the door — only to find Babli's lifeless body inside. Authorities were immediately alerted. Preliminary investigation suggests possible foul play, and Ranjan Kumar has been absconding since the discovery, prompting a full-scale search operation. "We are investigating all possible angles, including domestic dispute and premeditated murder,' said an officer from Falakata Police Station. The quarter's assigned resident, Lakshmiswar Barman, also a government employee, stated, "The quarters were vacant, so I allowed Ranjan and his wife to stay temporarily as per official instructions. I had no personal connection with them." The body has been sent for post-mortem examination to determine the exact cause of death. Authorities have sealed off the premises and are examining the scene for evidence. What began as a routine evening in the otherwise quiet government colony has now turned into a chilling crime scene with a missing husband, a dead wife, and a community haunted by unanswered questions.



Mayor Hakim urges organisers to remove banners, hoardings still covering Kolkata

Kolkata: Even after the Durga Puja festivities and Lakshmi Puja, large parts of Kolkata remain covered in banners, hoardings, and pandal structures. Expressing his displeasure, Mayor Firhad Hakim appealed to organisers to immediately remove all advertisement banners and temporary constructions to restore the city to normalcy.

According to Kolkata Municipal Corporation (KMC) officials, Wednesday was the deadline for dismantling all Durga Puja pandals across the city. However, from north to south Kolkata, several pandals still remain partially dismantled, with bamboo scaffolding, platforms, and advertising structures cluttering the streets. In many areas, even though idols have been immersed, the remnants of pandals and sponsor hoardings are still blocking footpaths and roadside spaces.

Concerned over the situation, the Mayor said during a civic meeting, "Pedestrians and vehicles are facing difficulties because of the leftover banners, hoardings, and bamboo railings. I request all Puja organisers to clear them at the earliest and bring the city back

continued negligence could lead to health hazards. "It's still raining in Kolkata. If water accumulates on the pandal platforms, it will become a breeding ground for mosquitoes. Though dengue cases are under control now, we must remain cautious," he said, urging organisers to carry out anti-mosquito spraying in their

Sources in the KMC added that civic teams have been instructed to inspect major roads and Puja sites to ensure post-festival clean-up. Notices may be issued to organisers who fail to comply.

In response to another question, Hakim clarified that the Dhapa dumping ground will soon be transformed into a waste-processing unit. "There will be no landfill at Dhapa in the future. A modern waste processing plant will be built on KMC's own land in compliance with the National Green Tribunal's directives. The project will be completed within three years," he said.

Civic officials added that plans are also being drawn up to install new solid waste management facilities across the city as part of a broader environmental improvement initiative following the festivals.

Police Nab Infamous Brotherin-Law Duo in Just a Day After **Swift CCTV Identification**

In a dramatic breakthrough, police arrested two notorious burglars — a brother-in-law and his brother-in-law's son-in-law — within 24 hours of a major burglary in South 24 Parganas, following rapid identification from CCTV footage. The duo, identified as Mohammad Kashem and Mostafa Molla, were known for roaming around Kolkata and adjoining districts disguised as scrap buyers during the day, targeting locked houses and looting valuables worth lakhs.

The latest burglary took place on Monday at the residence of schoolteacher Biplab Das in Canning. Das was not at home at the time. CCTV footage revealed the two men breaking the lock and entering the house — Kashem leading the way with Mostafa close behind. Using a hammer and metal bar hidden inside their sacks, they broke open an almirah and escaped with gold ornaments worth over ₹2 lakh.

Upon returning home, the family found the house ransacked and immediately lodged a complaint at Canning police station. Officers from the team led by Inspector Sayan Bhattacharya reviewed local CCTV footage and identified the culprits within just

A massive search operation was launched across Canning and Basanti. By late Tuesday night, the police tracked the duo to a hideout in Canning and arrested them as they attempted to flee. Both were produced before the Alipore court on Wednesday and remanded in six days of police custody.

According to investigators, Kashem, a seasoned criminal, became Mostafa's mentor after marrying his sister. The pair, residents of the Akra-Santoshpur area in south Kolkata, would travel by train to different localities, posing as kabadiwalas (scrap dealers) to scout houses. Their focus was always on homes left unattended. They broke locks, looted cash and jewellery, and fled within minutes.

Police records show that the two had been arrested several times earlier by Lalbazar detectives for similar thefts. In January this year, they were nabbed by Sonarpur police in connection with a string of robberies in Garia and Sonarpur. After securing bail, they fled Santoshpur and set up base in Basanti, from where they continued their operations across

Canning, Basanti, and Gosaba. Police said efforts are underway to recover the stolen jewellery and identify other possible associates linked to

State Govt to Honour **Frontline Workers for Disaster Response**

MI News Service, Kolkata: The state government has decided to confer special awards on firefighters, SDRF personnel, police officers, engineers, and doctors who risked their lives during the recent natural disaster in North Bengal, a senior official said on Thursday.

The state government sources said Chief Minister Mamata Banerjee is likely to visit North Bengal again on Monday, with Darjeeling included in her itinerary. During the visit, she is expected to oversee ongoing reconstruction and repair work and hold a high-level administrative meeting.

Youth found murdered after attending friend's birthday party

Kolkata: Mystery shrouds the death of a young man whose blood-soaked body was recovered from a dumping ground in Dum Dum's Pramodnagar area on Thursday morning. The deceased has been identified as Ganesh Samaddar. Police suspect that he was brutally murdered and his body dumped among piles of garbage to conceal the

According to police and local sources, Ganesh had gone out on Tuesday evening to attend a friend's birthday party. Before leaving, he had informed his sister about his plans. The two spoke again on Wednesday, but since then, he neither returned home nor could his family contact him over the phone. Growing increasingly worried, his relatives began searching for him.

On Thursday morning, locals at Pramodnagar noticed a human hand protruding from a heap of garbage at a nearby dumping ground. Alarmed by the sight, they removed some of the trash and found the bloodstained body of a man. Police were immediately informed and soon arrived at the spot to recover the remains.

Officers later traced the had beaten him brutally.'

firmed the body was that of Ganesh Samaddar. Preliminary examination revealed multiple injuries on his face and head, suggesting he was struck with a heavy object. Police believe the killers may have dumped the body in the garbage pile to destroy evidence and delay identification.

Centre releases first instalment of Fifteenth Finance Commission grant

Kolkata: The Union government has released ₹680.71 crore to West Bengal as the first instalment of untied (basic) grants under the Fifteenth Finance Commission for rural local bodies (RLBs) and Panchayati Raj institutions (PRIs) for the financial year 2025-26, the Ministry of Panchayati Raj announced on Thurs-

According to the ministry, the funds were released on October 6 for 3,224 gram panchayats, 335 block panchayats, and 21 zillaparishads across the state.

Between the previous fiscal year 2024–25 and the current year 2025-26, a total of ₹4,181.23 crore has been recommended and released to West Bengal — comprising ₹2,082.13 crore in untied grants and \$2,099.10 crore in tied grants, the ministry stated. Untied grants, also known

as basic grants, offer flexibility to local bodies to address area-specific needs, excluding salaries and administrative expenses. These funds can be utilised for projects such as road and footpath maintenance, yati Raj system.

Service, LED or solar street lighting, environmental protection, income generation, digital connectivity, and maintenance of village playfields and crematoriums, among

In contrast, tied grants are allocated for specific purposes such as sanitation, maintaining Open Defecation Free (ODF) status, ensuring clean drinking water supply, rainwater harvesting, and stormwater drain-

addition to these funds, the Centre released ₹151 crore under the Fifteenth Finance Commission's health sector grant to West Bengal for the year 2024-25. The grant, titled Support for Diagnostic Infrastructure to the Primary Healthcare Facilities for the Sub-Centres (For Rural), aims to enhance diagnostic facilities in rural healthcare centres.

According to the ministry, the grant will help equip primary healthcare institutions to deliver diagnostic services at the grassroots level, thereby improving access to medical facilities for villagers under the Pancha-

Bengal STF Seizes Rs 3 Cr Worth of Heroin in Twin Raids; Four Drug Peddlers Arrested

In a major Kolkata: post-festive breakthrough, the Bengal Special Task Force (STF) seized 2.8 kilograms of heroin worth nearly ₹3 crore in two separate operations across the state. Four suspected drug traffickers have been arrested in connection with the seizures. Police have lodged cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act and are interrogating the accused to trace the supply network.

According to STF sources, the first operation was conducted on October 7 in the Palashi area under Kaliganj police station in Nadia district. Acting on a tip-off, STF officials intercepted two men and caught them red-handed while they were attempting to smuggle around one kilogram of heroin packed in small pouches. The arrested individuals were identified as Hafizul-Shikari (53) and JibraelMondal (63). Both were booked under the NDPS Act and are currently being interrogated to determine the source and intended destination of the consignment.

In a separate raid on Saturday, another STF team, in coordination with Belur Government Railway Police (GRP), conducted a joint operation at Dankuni railway station. Two more traffickers were ar-

Service, rested from the spot — identified as Mahirul Biswas (64), a resident of Hariharpara in Murshidabad, and AbidParvez (66) from Singhbhum in Jharkhand. Officers recovered 1.8 kilograms of heroin from their possession.

Preliminary investigations revealed that the narcotics had been brought from Dimapur in Nagaland — a known trafficking hub in Northeast India - and were likely meant to be circulated in Kolkata and its adjoining districts during the festive season. However, police are yet to confirm the final destination or intended buyers of the seized consign-

During questioning, the accused reportedly told investigators that they had come to Dankuni to deliver the drugs, though they claimed ignorance about the receiver's identity. Investigators are probing whether a larger Inter-state syndicate is involved.

Police sources said that separate cases have been registered by Belur GRP and the Bengal STF, and parallel investigations are underway to identify the network's king pins. Officers are also verifying whether the seized heroin was part of a larger consignment meant to flood the city's drug market during the Durga Puja festivities.

CISF, police increase surveillance following bomb threat at Madurai airport

MI News Service, Madurai: The Central Industrial Security Force (CISF) and Tamil Nadu police on Thursday intensified surveillance following a bomb threat at the Madurai airport, officials said.

Sniffer dogs and bomb detection experts carried out thorough checks on vehicles entering the airport premises An email received by the Madurai Airport Director claimed that a bomb had been placed inside the airport.

Following this, Airport Director Muthukumar informed ANI on a phone call that the Madurai District Collector and the Commissioner of Police had been informed about the threat. Subsequently, CISF personnel and police jointly conducted intensive searches in and around the airport premises.

All vehicles entering the airport were subjected to strict checks by the bomb disposal squad before being allowed inside. Sniffer dogs were deployed, and bomb detection experts carried out detailed inspections at vehicle parking areas, passenger arrival zones, and other public gathering points within the airport.

Earlier on October 4, Madurai's Meenakshi Amman Temple received a bomb threat via e-mail, according to the police. The threat targeting the renowned temple triggered extensive security operations in the aftermath.

According to Madurai city police, an email threat was sent to the Director General of Police (DGP) office, claiming that a bomb had been planted Inside Madurai Meenakshi Amman Temple.

Careless Driving at Level Crossings Impacts Train Punctuality - Railways Urge Public Cooperation

Khurda Road Division of ECoR appeals for safe and responsible behaviour and to follow safety norms at Railway Level Crossings MI News Service, Bhubaneswar: Khurda Road Division of East Coast Railway has expressed serious concern over the increasing incidents of Level Crossing (LC) Gate violation and gate breaking by Road Vehicles, which are not only endangering lives but also causing disruption and delay to train services over Khurda Road Division.

In several cases, road users forcefully try to cross LC Gates even after the gate is closed or while being closed, leading to damage to boom barriers and signal failures. This irresponsible behavior results in loss of punctuality, disruption of train operations and risk to life and property.

During 2024, a total of 113 incidents of LC Gate breaking were reported under Khurda Road Division, out of which 92 persons were arrested.

In 2024 (up to October 8th), 88 such incidents had been reported and 72 individuals were arrested. Similarly, during 2025 (up to October

8th), 64 incidents of LC Gate breaking

have been recorded, with 47 persons ar-In the current year (2025), LC Gate breaking incidents have been reported

across various areas: 11 incidents in Bhubaneswar area 8 incidents in Brahmapur area

7 incidents each in Puri, Bhadrak, and

Jajpur Keonjhar Road areas 6 incidents in Cuttack area 5 incidents each in Palasa and Khurda

Even after Repeated Awareness Drives by Khurda Road Division, conducted by Safety Department and Railway Protection Force (RPF) personnel and continuous counseling of Road Users at Level Crossings, such incidents are still contin-

uing by the violators.

WHO monitoring situation amid deaths of children from cough syrup in MP

MI News Service, Delhi: The World Health Organisation (WHO) is closely monitoring the health situation in India amid clusters of pediatric illnesses and deaths in Madhya Pradesh and Rajasthan, according to a statement.

According to the statement by the WHO, the Central Drugs Standard Control Organisation of India (CDSCO) stated that none of the contaminated cough syrups, which led to the deaths of 20 children, were exported. Expressing condolences to the families of the deceased, WHO said, "These which emerged during the week of 29 September, describe symptoms consistent with acute renal failure and acute encephalitis syndrome, with suspected links to the use of oral syrup medicines. WHO is deeply saddened by the reported fatalities and extends its sincere condolences to the affected families and

WHO communicated that it stood ready to support national authorities in investigating and responding to these tragic events, the statement added. On October 8. the WHO received confirmation from the CDSCO that Diethylene Glycol (DEG) had been detected in at least three oral syrup medicines. These medicines were among those consumed by children in the reported clus-

ter of cases CDSCO have identified the contaminated products as Coldrif, Respifresh TR and ReLife, with 48.6 per cent DEG, 1.342 per cent DEG, and 0.616 per cent DEG, respectively. CDSCO informed WHO that the above products have been recalled and that the identified manufacturers have been ordered to stop production of all medical products. CDSCO also stated that none of the products were exported from India.

WHO has not received

any official information as to the source of the DEG contamination or if contaminated pharmaceutical material has been identified, the statement said. In the statement, WHO expressed deep concern over the developments and emphasised the potential risk of contaminated products being exported to other countries, particularly via unregulated channels.

It flagged the regulatory gap in DEG/EG screening for domestically marketed medicines in India, and sought to identify the source of the contamination and identify and remove any contaminated pharmaceutical material that may be in circulation. WHO stands ready to support national authorities in investigating and responding to these tragic events. It remains committed to supporting India in safeguarding public health and ensuring the safety of medical products, the statement added.



The 2025 Nobel Prize in Chemistry was awarded to Susumu Kitagawa, Richard Robson, and Omar M. Yaghi for developing metal-organic frameworks (MOFs) — porous materials that can trap gases, purify water, and store energy. Their innovation has revolutionized reticular chemistry, offering sustainable solutions for climate change, water scarcity, and clean energy.

Robson pioneered network design, Kitagawa created "breathing" frameworks, and Yaghi expanded them into practical, scalable systems. MOFs can capture carbon dioxide, harvest water from air, and store hydrogen fuel. This Nobel highlights how molecular science can shape a greener, smarter, and more sustainable future for humanity.

MOLECULES WITH A MISSION

HOW THREE CHEMISTS BOTTLED AIR, WATER, AND HOPE

t began, as great revolutions often do, with a puzzle no one guite knew how to solve. For decades, chemists dreamed of a material so porous it could hold immense amounts of gas - a solid that could trap carbon from the air, store hydrogen fuel safe-ly, or even pull water out of desert air. But every attempt failed. The materials collapsed under pressure, dissolved in humidity, or simply couldn't hold their shape.

Then, quietly and methodically, three scientists -Susumu Kitagawa of Japan, Richard Robson of Australia, and Omar M. Yaghi. Jordan-born chemist now based in the United States began building frameworks from the ground up. They used metal ions and organic linkers like LEGO bricks, creating crystalline scaffolds that seemed to defy logic. Their creations, known as metal-organic frameworks, or MOFs, turned out to be molecular "sponges" that could soak up gases, store energy, and purify water.

In October 2025, their persistence was recognized with the world's highest scientific honour - the Nobel

Prize in Chemistry. A Dream Built Atom by

When the announcement came from Stockholm, 82year-old Richard Robson was, quite literally, frying fish in his Melbourne kitchen. "I cooked the fish," he told reporters later, laughing, "and then all this commotion started!

It was the kind of moment Nobel committees love when quiet, unassuming work done in laboratories decades ago changes the world. suddenly

Robson's early experiments in the 1980s had been largely academic. He wasn't trying to save the planet; he was fascinated by the idea of connecting metal ions into infinite networks. But his crystalline "lattices" - stable, geometric and full of empty space - became the blueprints for a revolution.

Thousands of kilometres away, at Kyoto University, Susumu Kitagawa was asking a similar question: what if those frameworks could actually breathe? What if gases could move in and out of those tiny pores, like air through a sponge? In the 1990s, he proved it was possible. His lab demonstrated that some materials could absorb and release gas molecules without breaking apart. For the first time, "porous coordination polymers" - the ancestors of

MOFs - were real. Meanwhile, a young scholar named Omar Yaghi, born in Amman to Palestinian parents, was dreaming bigger still. After struggling through war-torn childhood years and eventually earning a PhD in the U.S., Yaghi turned his sights on designing materials with precision - frameworks

whose pore size, shape, and chemistry could be tuned molecule by molecule. He coined the term "reticular chemistry", from the Latin reticulum, meaning "net."

Together, the trio transformed chemistry itself.

To understand their discovery, imagine Hermione Granger's enchanted handbag from Harry Potter - small on the outside, infinite on the inside. MOFs are like that, but real.

Each framework is a repeating network of metal nodes connected by organic molecules. The spaces between them - the pores can be unimaginably large on a molecular scale. A single gram of MOF material can have the surface area of a football field.

That space can be used to store, trap, or separate almost anything: carbon dioxide, hydrogen, methane,

even water vapour. It's chemistry that looks like magic - except it's meticulously engineered.

this "molecular as the Nobel "molecular And magic, Committee called it, is precisely why the three chemists were chosen. Their work not only opened a new scientific field but also gave humanity powerful tools to fight two existential crises: climate change and water scarcity.

The Promise in Every Pore In Yaghi's California lab, a small glass box hums quietly.

Inside sits a metallic powder - a MOF that can literally pull water from the air. Even in the parched heat of the Mojave Desert, it condenses droplets each night, enough for a family to drink.

"Water is in the air around us," Yaghi explains in interviews, his tone equal parts scientific and poetic. You just need the right net to catch it.

Elsewhere, researchers are using MOFs to capture carbon dioxide directly from industrial chimneys or even the open atmosphere. The same principles that allow a MOF to absorb water also let it "soak up" greenhouse gases with astounding efficiency.

In another branch of research, MOFs are being developed to store hydrogen for clean fuel cells, filter toxins from water, and trap harmful chemicals before they reach the air we breathe.

The global MOF market is

now booming - from clean energy startups to environmental engineering companies, all racing to turn these crystalline sponges everyday technology.

Triumph Collaboration

What makes the 2025 Nobel Prize special is not just the discovery itself but the way it happened.

Kitagawa, Robson, and Yaghi worked independently, often on different continents, never as formal collaborators. Yet their research formed a perfect triangle: Robson built the structural foundations, Kitagawa brought functionality and flexibility, and Yaghi scaled the concept to global relevance.

In the Nobel Committee's words, "Their collective work transformed coordination chemistry into a field that now stretches from laboratory benches to industrial plants.

It's a rare reminder that science is often a relay race, not a solo sprint.

The Human Element Beyond the laboratory glassware and formulas, this year's Nobel also tells a deeply human story - one of perseverance, identity, and imagination.

For Yaghi, who spent part of his childhood as a refugee, the recognition carries emotional weight. "This prize isn't just for me," he said in a press conference. "It's for every young scientist who believes that ideas - not origins - define success.

In Kyoto, Kitagawa expressed quiet satisfaction that "chemistry, often seen as abstract, has become a tool for humanity

And in Melbourne, Robson simply smiled. "I was just curious," he said. "Curiosity, it turns out, can be quite use-

Science for a Changing World

The implications of their work extend far beyond chemistry.

In climate change mitigation, MOFs could capture billions of tons of CO? every year - possibly enabling carbon-negative industries.

In clean energy, they could store and release hydrogen or methane efficiently, making fuel cells safer and cheaper. In water technology, they might help turn desert air into drinkable water, offering hope to millions facing drought.

In environmental cleanup, MOFs could remove microplastics, pesticides, or heavy metals from air and water streams.

Each of these possibilities is being tested somewhere right now - in university labs, start-up accelerators, and pilot projects worldwide.

It's a glimpse of a future where chemistry isn't just a subject in textbooks, but a living force shaping our planet's fate.

Challenges Remain Yet even magic materials have limits. MOFs can be fragile, and producing them at industrial scales remains expensive. Some degrade in humid or acidic environments. Others require energy-intensive regeneration But scientists are optimistic. The field is evolving rapidly, with newer frameworks - stronger, cheaper, and more stable - being dis-

covered almost monthly. In a sense, the Nobel Prize is both a reward and a challenge: recognition for what's been achieved, and a reminder of what still lies

The Legacy of 2025 This year's Nobel in

Chemistry is not just a celebration of molecular architecture; it's a statement about what science can be.

At a time when the world wrestles with political division and environmental despair, three chemists quietly built bridges - between elements, between disciplines, and between nations.

Their "bottomless" materials may one day help humanity breathe cleaner air and drink water pulled from the sky. But their greater gift is the reminder that curiosity and cooperation remain our most powerful resources.

In the end, the story of the 2025 Nobel Prize in Chemistry is not about molecules at all.

It's about imagination and the boundless spaces we can create when we dare to think small.

Krasznahorkai Wins Prize For Bridging East and West Through Prose

bringing seminal authors to greater global renown, the 2025 Nobel Prize for Literature was conferred on Hungarian litterateur Laszlo Krasznahorkai, whose demanding, yet pensive, post-modern, near-surrealist works draw on the traditions of Nikolai Gogol, Frank Kafka, and Samuel Beckett, but go ahead to span both his Central European milieu and

that of the mystic East. Announcing the award, the Swedish Academy said Krasznahorkai was chosen "for his compelling and visionary oeuvre that, in the midst of apocalyptic terror, reaffirms the power of art". The second Hungarian to win the top global literary award after Imre Kertesz in 2002, Krasznahorkai, 71, is also the first from his country to win the Man Booker International Prize in 2015. Let's take a brief look at

some of his work, particularly his novels. The author, whose oeuvre

straddles novels, novellas, short stories, other writings, and screenplays, is not an easy read, describing his own work as "reality examined to the point of mad-

And then stylistically, his work is marked by a distinctively dense style, where sentences go on for pages and pages, paragraphs are clunky and unbroken, the

narrative voice and focus suddenly change from character to character, sometimes in the same sentence, time is fluid, and the story's pace, according to one critic, moves at the same speed as social change

Krasznahorkai debuted with "Satantango" (Hungarian, 1985 English translation "Satan's Tango", 2012), which is postmodernist and multi-perspective in nature, and structured like the tango, with half a dozen steps forward alternating with the same number backwards, and has chapter titles like "We Are Resurrected", "The Distance, As Seen", and "The Distance, as Approached from the





Resembling Gogol's "The Government Inspector", it is set in an unnamed decrepit and isolated Hungarian village, though being near a town (also unnamed), where a con man comes and poses as a saviour. He acquires full influence over the inhabitants, takes away all their hard-earned savings, persuades them to move to another village, but brings them to the town and disperses them around the

Brought to the screen by acclaimed Hungarian filmmaker Bela Tarr in 1994, the film was seven hours long!

Krasznahorkai's second "Az ellenallas

translation "The Melancholy of Resistance", 2000) was a political allegory with apocalyptic atmosphere, mirroring the political and social upheaval sweeping through then Communist-ruled Central and East Europe. Set in yet another unnamed, but restless town, it has a mysterious circus, whose sole exhibit is a dead whale, contributing to the disquiet, further fuelled by the arrival of a trainload of rabble rousers, and a housewife taking control to fight them off.

How can this all be interpreted, particularly in the light of contemporary events, the author leaves to the readers to think

The author moved out of Central Europe with "Haboru es haboru (1999, English translation "War and War", 2006) about a Hungarian man, obsessed with a mysterious manuscript, and deciding to go to New York City to write it down and post on the Internet, and then further with "Rombolas es banat az Eg alatt" (2004).

Coming out in English as "Destruction and Sorrow Beneath the Heavens" (2016), it tells of a Hungarian man travelling to China to find out about traditional Chinese culture and its understanding and reception by the present-day society

Upon meeting Rajnath Singh, the Australian PM underscored how India and Australia's defence partnership is built on trust, shared interests and a commitment to a peaceful, secure and prosperous Indo-Pacific. He expressed delight on meeting Singh, and said on X, "Australia and India's defence partnership keeps getting stronger - built on trust, shared interests and a commitment to a peaceful, secure and prosperous Indo-Pacific. Great to meet with the Indian Defence Minister Rajnath Singh on his first trip t" Australia for the Inaugural Australia-India Defence Ministers' Dialogue."

Earlier, Rajnath Singh held a productive meeting with Australia's Deputy Prime Minister and Defence Minister Richard Marles. The leaders reviewed the full spectrum of India-Australia defence cooperation, including defence industry, cyber defence, maritime security and regional challenges. Noting the rapid growth of India's defence industry and India's grow-



ing stature as a credible source of highquality defence tech globally, Singh said that they discussed the potential for deeper defence industry partnerships between India and Australia.

India and Australia inked key defence agreements during the visit of the Defence Minister. Australia's Deputy Prime Minister and Defence Minister Richard Marles has described the newly signed defence agreement with India as a "hugely significant step" in strengthening the operational partnership between the two nations' armed forces. Speaking exclusively to ANI, Marles said, "I think the significance of today is that what we are seeing in terms of deep trust and strategic alignment is now being expressed in a much deeper operational level of engagement between our two defence forces. The Agreement that we have signed in terms of staff talks between our operational commands is hugely significant... We are very excited about that."

Global Leaders Welcome Gaza Ceasefire and Hostage-Release Agreement, Urge Full Compliance and Two-State Solution



MI News Service, Paris: President Emmanuel Macron and Euro-Commission President Ursula von der Leyen on Thursday welcomed the overnight agreement securing a ceasefire in Gaza and the release of hostages, praising the diplomatic efforts that enabled the breakthrough. The deal, mediated by the United States, Qatar, Egypt, and Turkey, marks a significant step toward de-escalating the ongoing conflict.

In a statement on X, Macron expressed hope for hostages and their families, as well as for Palestinians in Gaza and the wider region. "I welcome the agreement reached overnight for the release of the hostages and the ceasefire in Gaza, and I commend the efforts of President @realDonaldTrump, as well as the Egyptian, and Turkish mediators who helped make it happen," he said. Macron called on all parties to fully uphold the agreement, emphasizing that it should herald the end of the war and the beginning of a political process grounded in the two-state solution. He also reaffirmed France's commitment to supporting peace and reconstruction efforts in the region.

Von der Leyen echoed similar sentiments, highlighting the collaborative effort to secure a ceasefire and ensure the safe release of hostages. "Am also encouraged by the support of the Government

of Israel and the Palestinian Authority. Now, all parties must fully uphold the terms of the agreement. All hostages must be released safely. A permanent ceasefire must be established. The suffering must end," she said. The European Union pledged continued support for the delivery of humanitarian aid and for post-conflict

In India, Prime Minister Narendra Modi welcomed the first phase of President Donald Trump's peace plan, commending the leadership of Israeli Prime Minister Benjamin Netanyahu. He expressed hope that the agreement would bring respite to the people of Gaza and pave

the way for lasting peace. Israeli Ambassador to Reuven Azar thanked all parties involved, particularly the US, for their role in facilitating the deal. UN Secretary-General Antonio Guterres also lauded the agreement and urged full compliance.

Qatar confirmed that all provisions and mechanisms of the first phase of the ceasefire, including the release of hostages and prisoners and entry of humanitarian aid, had been finalized. Israeli Prime Minister Netanyahu called it "a great day for Israel" and Hamas issued a statement affirming its commitment to the ceasefire and the agreed prisoner exchange, while stressing it would uphold the Palestinian people's national rights.

Malda Division's RPF Arrests Two Mobile **Theft Offenders at Dharhara Railway Station**

The discussion focused on enhancing passenger experience, improving punctuality, strengthening cleanliness and hygiene, and deepening participative governance in alignment with the national vision of Viksit Bharat 2047.

Addressing the gathering, Shri Vishal Kapoor, Divisional Railway Manager (DRM), Howrah, described Amrit Samvad as "a continuing conversation between people and systems — where those who travel and those who serve work together to build a better railway."

A Century of Heritage and Service Established in 1925, Howrah Division stands among the oldest and

busiest divisions of Indian Railways. Recalling its historic roots, the DRM noted that the first section of the East Indian Railway — from Howrah to Hooghly — opened in 1854, making Howrah the birthplace of railway history in Eastern India.

"Howrah is not just a terminus; it is an institution that has carried India's progress and its people for a hundred years," he remarked.

Strong Operational Performance

Between April and September 2025, Howrah Division achieved remarkable operational results:

- 204.99 million passengers carried (+7.46%)₹809.69 crore earned from passenger
- revenue (+5.42%)

kiosks, digital lockers, vertical gardens, and station advertisements-have simultaneously enhanced convenience and revenue generation.

Amrit Bharat Stations - Redevelop-

ment of 14 Stations

The DRM announced that 14 stations of Howrah Division are being redeveloped under the Amrit Bharat Station Scheme:

Bally, Sheoraphuli, Chandannagar, tablished to address repeated or delib-Bolpur, Sainthia, Rampurhat, Azimganj, Katwa, Nabadwip Dham, Ambika Kalna, and Khagraghat Road.

Each of these stations will feature modern lounges, lifts, escalators, barrier-free access, green building structures, unified signage, improved lighting, CCTV coverage, One Station One Product kiosks, and redesigned public plazas connecting both sides of

Plans have been developed in consultation with passenger bodies, local representatives, and civic stakeholders blending heritage with modernity.

"Our vision is to make every station a civic landmark," said the DRM. Stakeholder Dialogue and Passen-

Emphasising that Amrit Samvad is an ongoing process, the DRM noted that Passenger Associations are being regularly consulted on issues such as punctuality, amenities, and operational planning.

The Division is addressing even minor operational challenges such as short-origin delays, crowd-flow management, and coordination between freight and passenger services.

"Our aim is not just punctuality on paper, but reliability that passengers actually experience," he stated.

He further invited feedback from passengers and stakeholders, observing that "crowd-sourced information is a new initiative through which the Division can continuously refine its efforts toward passenger convenience and system efficiency.

Swachhata-From Campaign to Culture As part of the Centenary Year initiatives, Howrah Division has launched a Special Cleanliness Campaign under the Swachhata Hi Seva programme.

The campaign encompasses all stations, colonies, and circulating areas, with focus on deep cleaning, waste segregation, beautification, and awareness drives in collaboration with staff, schools, NGOs, and passengers.

The DRM appealed to all stakeholders — passengers, vendors, contractors, and civic partners — to join hands in maintaining cleanliness and hygiene.

"The Railways will ensure sustained cleanliness drives, infrastructure, and monitoring; public participation and ownership will make every station truly

clean and welcoming," he said. He further highlighted that accountability mechanisms have been es-

Women's World Cup: Richa Ghosh's brilliant 94 lifts India to 251 against South Africa

a masterclass in how to build an ODI innings, scoring a 76-ball 94, and with Sneh Rana coming up with a blazing cameo as India posted a challenging 251 all out against South Africa in Match 10 of the ICC Women's ODI World Cup here on Thursday.

Coming in to bat with India reeling at 102/6, Richa blasted 11 fours and four sixes and raised 88 runs for the eighth wicket with Sneh to help India recover and post a fighting total. Richa scored the highest score by a batter coming at No.8 and gave the bowlers a total they could defend.

With brilliant hitting, wicketkeeper batter Richa and Sneh turned the tide in India's favour as South Africa made hara-kiri of their bowling and fielding, putting down a few catches as Richa and Sneha fought back brilliantly. Richa virtually lifted India on her shoulders, absorbing the early pressure and then blasting some brilliant shots as India raised 98 runs in the last 10 overs.

Asked to bat first, Smriti Mandhana and Pratika Rawal gave India a good start, posting the best power-play score for the hosts in the World Cup, scoring 55 for no loss in

While Smriti was a bit circumspect fol-lowing her twin failures so far, she managed to hit one four and India's first six of the match, jumping down the pitch to hoist Ayabonga Khaka over her head. But got out attempting another big one just after the

mandatory Power-play.

Her partner Pratika Rawal (37 off 56) added 28 runs with Harleen Deol before she



too departed, picked by Tazmin Brits off Tumi Sekhukhune for another soft dismissal. Harleen (13 off 23), skipper Harmanpreet Kaur (9), Jemimah Rodrigues (0) and Deepti Sharma all departed in quick procession to the dressing room as India slumped from 55 for no loss at the end of the 10th over to 102/6 at the halfway stage of the innings, all failing to apply themselves and adapt as the South Africans cut

The South African medium pacers,

Ayabonga Khaka and Nadine de Klerk, along with left-arm spinners Nonkululeko Mlaba and Chloe Tryon, bowled superb line and length to tie down the Indian batters as the hosts went 86 balls without scoring a boundary as India's scoring rate went down

from five an over to three at one stage. Richa Ghosh broke the shackles in the 29th over off Tryon and repeated the act on a couple of more occasions to give the innings a bit of momentum. She and Amanjot Kaur, who came into the playing XI

after missing the last match due to a fever, added 37 runs for the seventh wicket, taking the score past 150, before she was out for 13 off 44 balls, studded with one four. She tried to break the shackles and ended up offering an easy catch to Sune Luus off Tryon, failing to reach the pitch, attempting

Richa soldiered on, slog-sweeping a slower one from de Klerk over the deep midwicket for her second six of the evening, adding to the four boundaries scored earlier. Sneh Rana struck Mlaba for back-toback boundaries in the 43rd over and sent one past fine leg off de Klerk in the next

A boundary off a wide and another four by Richa of de Klerk helps her reach her first fifty of the ODI World Cup off 53 balls. That was India's best over with Sneh and Richa hammering 16 runs as India inched towards the 200-run mark. Sneh and Richa raised the half-century of their eighth-wick-et partnership off 36 balls to give the score some respectability.

Richa blasted two fours and a six off successive balls off Khaka for 19 runs in the 47th over, giving a blazing finish to the

The match had started an hour late because of a brief spell of rain and a wet outfield. No overs were lost, though.

Shanghai Masters: Djokovic battles past Bergs to record 80th Masters 1000 semis

SHANGHAI: Novak Djokovic's resilience and experience once again came to the fore as he battled past Belgium's Zizou Bergs 6-3, 6-4 on Thursday to secure a semi-final berth at the 2025 Shanghai Masters.

Despite not being at his physical best, the 38-year-old Serbian extended his dominance on the ATP Masters 1000 stage, becoming the oldest semi-finalist in Masters 1000 history.

Djokovic, who endured a leg issue and heat-related exhaustion in his fourth-round victory over Jaume Munar, was again made to work hard under testing conditions.

The World No. 5 appeared to be struggling with discomfort in his left foot during the opening set but dug deep to clinch his 80th Masters 1000 semi-final appearance - another record in his illustri-

The Serbian looked poised to seal victory when he broke Bergs to lead 5-4 in the second set, but the 26-year-old Belgian, playing his first ATP Head2Head match against Djokovic, showed impressive resolve to immediately break back.

What followed was one of the most thrilling exchanges of the tournament - Djokovic surviving four smashes and a daring volley from Bergs before reclaiming the break in a pulsating rally. This time, he made no mistake serving out the match to claim his mile-"I was just trying to stay alive to be honest on the court," Djokovic

admitted afterward. "My first encounter with Bergs. He's a great guy. Obviously, a lot of firepower in his game. At times, I just tried to play an extra ball in the court and make him miss the ball, and that's what happened. I should have closed out the match at 5-4. He played a good game, again I was a little bit too passive. Having battled through another gruelling encounter, Djokovic

acknowledged the challenge of adapting to the conditions in Shanghai. "Very challenging conditions these days for all the players, and I was just trying to stay alive on the court. I'm glad to overcome The 24-time Grand Slam champion is now just two wins away

from a record-extending 41st Masters 1000 title, and his first since

Standing between Djokovic and another Shanghai final will be Valentin Vacherot, the Monegasque qualifier who stunned 10th seed Holger Rune 2-6, 7-6(4), 6-4 earlier in the day.

ISSF World C'ship Shotgun: India's skeet shooters primed for challenge as action set to begin in Athens

NEW DELHI: India's skeet shooters will compete at the Malakasa Shooting Range in Athens, Greece, as the ISSF World Championship Shotgun 2025 kicks off on Friday with the first two qualifying rounds for the men's and women's skeet events.

India's men's skeet team will be led by Olympians Mairaj Ahmad Khan and Anantjeet Singh Naruka, recently crowned Asian Champion, along with Bhavtej Singh Gill, to complete the team. In the women's division, Olympian and former Junior World Championship silver medallist Raiza Dhillon will lead, supported by Ganemat Sekhon and Parinaaz Dhaliwal.

Naruka, who has been performing well after his recent showing at the Asian Championships in Shymkent, is set to compete among a strong field of 121 shooters. The compe tition is led by Vincent Hancock from the United States, a fourtime Olympic gold medallist and three-time World Champion, often considered one of the finest skeet shooters ever. Mairaj, India's most accomplished international skeet shooter, aims to leverage his experience in hopes of securing his third individual ISSF medal. Paris 2024 gold medallist Hancock, who previously secured gold in Lonato this year, will be joined by Paris Olympic silver medallist Conner Prince, along with 2023 World Championship medalists Eetu Kallioinen of Finland (silver) and Azmy Mehelba of Egypt (bronze).

The men's competition is further intensified by several worldranked shooters, such as World No.1 Christian Elliott (USA), who secured gold in Buenos Aires and silver in Lima; World No.3 Hector Andres Flores Barahona (Chile); World No.4 Jakub Tomecek (Czechia); and World No.6 Daniel Korcak (Czechia), the bronze medallist from Lonato.

The line-up features World No.8 Henrik Jansson of Sweden, the silver medallist at Lonato, along with Denmark's Jesper Hansen, ranked No.10 globally and the Nicosia silver medallist,



making for a very competitive

The women's skeet event will have 63 competitors competing for the top honours. Raiza Dhillon is participating after winning consecutive silver medals at the Junior World Cup in Suhl and New Delhi, and she also secured a solid fifth place at the senior Lima World Cup earlier this year.

Ganemat Sekhon, who previously won a silver medal at the Junior World Championship, brings valuable experience and depth to the Indian team as she competes for her third individual ISSF medal.

Leading the global scene is World No.1 Samantha Simonton from the USA, who took gold in Lonato and earned silver in both the Lima and Nicosia World Cup stages. She will be accompanied by her fellow American Dania Jo Vizzi, ranked World No.3 and the Baku World Championship silver medallist. Vizzi has had an impressive season, winning gold in Buenos Aires, silver in Lonato, and bronze in Lima.

Also competing are World No.2 Arina Kuznetsova (AIN), the gold medallist from Nicosia and bronze medalist from Buenos Aires, and Greece's Emmanouela Katzouraki (World No.6), the bronze medallist from the Baku

World Championship. Veteran American sports legend Kimberly Rhode (Ŵorld No.11), a six-time Olympian and three-time Olympic gold medallist, joins China's Jiang Yiting (World No.7), junior world record holder and Paris 2024 mixed team bronze medallist, to form a highly competitive women's field.

The skeet qualification rounds will begin at 11:30 am IST on October 10, with athletes shooting 50 targets each on Day 1 and Day 2, and then 25 targets on October 12. After completing a total of 125 targets, the six top shooters in both men's and women's categories will advance to the finals, scheduled for 5:30 pm IST (women's) and 7:00 pm IST (men's) on Sunday. There, the new World Champions will be crowned.
