

# PM Modi skips Gaza summit sends junior Minister to Egypt

MI News Service, New Delhi: Even as more than 20 top leaders from all corners of the globe gathered at Sharm el-Sheikh in Egypt on Monday at the signing ceremony of the first phase of the US-brokered Gaza peace plan to end the two year long bloody conflict between Israel and Hamas, Prime Minister Narendra Modi remained conspicuous with his absence in this global gathering. Instead, he sent Minister of State Kirti Vardhan Singh to represent India at the highlevel summit co-chaired by US and Egyptian Presidents Donald Trump and Abdel Fattah El-Sisi. Despite personal invitations from both the US and the Egyptian Presidents, PM Modi's decision to skip has set off speculation about why he's not attending the gathering in Sharm el-Sheikh where the galaxy of world leaders had converged to finalise the framework of a much-awaited peace deal in the Middle East and discuss Gaza's post-war reconstruction. Expressing his disappointment Congress MP Shashi Tharoor has expressed reservations over India sending a minister of state to the peace summit, where many heads of state had gathered. "This is no reflection on Kirti Vardhan Singh, whose competence is not in question; but given the galaxy of grandees present, India's choice could be seen as signalling a preference for strategic distance, which our statements don't

# Donald Trump slaps additional 100% tariff on China

MI News Service, Washington (DC) :Escalating the US-China trade tensions further amid the present volatile global geo-political scenario, American President Donald Trump has announced a 100% tariff on Chinese imports. The move follows China's export curbs on rare earth minerals. The US President reignited his trade war with China, announcing an additional 100 per cent tariff on Chinese imports on Saturday, escalating ten-

sions between the world's two largest economies. Donald Trump said the new tariffs, along with US export controls on "any and all critical software", will take effect from November 1. He claimed that the move was in retaliation for Beijing's "extraordinarily aggressive" export curbs on rare earth minerals, key elements used in electric vehicles, smartphones, and military hardware. "It is impossible to believe that China would have taken such an

action, but they have, and the rest is history," Trump wrote on Truth Social. The announcement rattled global markets, with the Nasdaq falling 3.6 per cent and the S&P 500 dropping 2.7 per cent, marking Wall Street's worst single-day fall since April. Currently, Chinese goods face US tariffs of 30 per cent, which were imposed earlier under Trump's first



Cost competitiveness and the principles of comparative advantage across countries were supposed to be the guiding principles, but a fundamental change has crept in, he added. "The situation has changed fundamentally. The global economy and trade have become considerably fragmented. Established rules are being increasingly questioned while new norms are yet to be firmly set in. The COVID pandemic and the Ukraine-Russia conflict have accelerated the move toward self-reliance," he said. The former governor of the RBI said that the vulnerability in global supply

# **Britain Deputy High Commissioner Dr Andrew Fleming Calls Indo-UK Trade Agreement a Landmark in Bilateral Relations**

British Deputy High Commissioner Dr Andrew Fleming has described the India-UK Comprehensive Economic and Trade Agreement (CETA), signed in July this year, as a landmark development in the bilateral relations between the two countries.

"This is going to unlock huge opportunities for trade and investment across diverse sectors. For the Indian engineering sector, it holds great promise," Fleming said while presenting the EEPC India Eastern Region awards to top-performing engineering goods exporters at the joint ceremony of the 40th and 41st awards here on Monday.

The UK diplomat noted that the recent visit of Prime Minister Narendra Modi, leading one of the largest-ever trade dele-gations to Britain, underties with India. "India has made sig-

nificant strides towards becoming a global superpower in the engineering segment, and EEPC India has played a vital role in this development," Dr Fleming said. Commenting on India's promotional support for engineering exports, he praised EEPC India for its exemplary role in nurturing and supporting its members' international business aspirations over the past seven decades.

During the ceremony, Fleming presented 73 awards to 42 member exporters from the region for their outstanding engineering export performance during the financial years 2021-22 and 2022-23.

**Nadia carpenter dies** by suicide after being allegedly humiliated by local moneylenders



Nadia: A 35-year-old carpenter from Bahirgachhi village under Nakashipara police station limits in Nadia district allegedly died by suicide on Tuesday after being humiliated and assaulted by local moneylenders over non-repayment of

The deceased, identified as Bapan Das (35), had reportedly borrowed money at a high interest rate from local lenders a few months ago to meet household expenses. Family members alleged that when he failed to repay the interest on time due to lack of work the lenders repeatedly threatened and abused

On Tuesday morning, two moneylenders allegedly came to his house, abused him in filthy language, assaulted him and forcibly took away the house deed. Humiliated before his family and neighbours, Bapan allegedly ended his life soon after.

His brother-in-law Pradip Das told reporters, "Bapan had borrowed rupees 10,000 from one person who later demanded rupees 1 lakh. Another lender from whom he took rupees 50,000 claimed ₹3 lakh. They refused to give him time to repay and forcibly took away the land documents. Unable to bear the insult,

he took this step." Bapan's father Biswajit Das said, "They took away the house deed and abused him. My son could not bear the humiliation and ended his life. We want exemplary punishment for those responsible."

reinstatement as chairman. The letter, prominently branded with the party's name, circulated widely on social platforms and was flagged for its inauthenticity by Trinamool party leaders. Police investigations confirmed the letter's forgery, leading to Bibhas's prompt detention.Political Fallout and Party Reactions-District Trinamool Congress President Ajit Maiti condemned the fraudulent claim, distancing the party from Bibhas's actions and abeling them as the work of malicious elements attempting to exploit the system. He assured that strict action would follow against any cadre involved in fraud tar-

while, BJP's Ghatal MLA Sheetal Kapat seized the opportunity to criticize the ruling party, calling for comprehensive police action against Bibhas and other municipal officials allegedly involved in corrupt practices, including the current chairman's purported tender irregularities. Kapat warned that administrative accountability must be enforced swiftly to restore public trust. The arrest marks a significant escalation in scrutiny of municipal governance, underscoring persistent challenges of corruption and misuse of power in local administrative bodies. Authorities continue to probe the matter as political tensions in the region intensify.

# **Agameshwari Mata: The Ancient Goddess of Nadia**

MI News Service, Nadia: Among the oldest and most revered Kali worships in West Bengal's Nadia district is the Agameshwari Mata Puja, a celebration steeped in devotion, mystery, and centuries of tantric tradition. The dark-hued goddess, adorned with ornaments and radiant eyes, is believed to be between 400 and 500 years old, depending on local lore.

The worship was initiated by Sarbabĥauma Agambagish, a descendant of the great scholar and tantric practitioner Krishnananda Agambagish of Nabadwip. The title Agambagish itself derives from Agam Shastra, denoting mastery over ancient tantric scriptures.

According to legend, Sarbabhauma married the daughter of Mathuresh Goswami, grandson of the Vaishnav saint Adwaitacharya of Shantipur. After the marriage, Mathuresh Goswami moved with his daughter and son-in-law to Shantipur, where he established a panchamundi asana, a sacred seat used in tantric meditation. There, Sarbabhauma attained spiritual perfection through intense austerities and worship.

It is said that he molded the image of the goddess from clay gathered from the Ganges and performed the first worship, immersing the



er afterward. That ritual of creating and immersing the goddess each year continues to this day, faithfully upheld by the Boro Goswami family, descendants of the original worshipper. The rituals of Agameshwari Puja are deeply symbol-

idol back into the holy riv-

ic. On Vijaya Dashami, after Durga Puja ends, the goddess is ceremonially marked with vermilion, and on Kojagori Lakshmi Puja, the paatkhilan (ritual awakening) takes place. The grand worship of Agameshwari Kali is then held on Diwali night, known locally as Dipanwita Kali Puja. The idol of the goddess

stands 16 to 18 feet tall, and the night before the puja, her eyes are painted in a solemn ritual known as Chakshudan, performed by the artisan

who fasts and purifies himself before the ceremony. After this, the Goswami family adorns the goddess with ornaments, sandalwood paste, and perfumes before the night-long worship begins.

Unlike many other Kali rituals, no animal sacrifice is practiced here. The offerings are entirely vegetarian, symbolizing purity and compassion. Sugarcane and white pumpkin serve as symbolic substitutes for sacrifice. The goddess is offered a 36-course vegetarian feast, all prepared by initiated women of the family.

The offerings include three types of greens (red spinach, taro leaves, and spinach), mixed vegetable dishes (shuktani), lentils (black gram, mung, and others), pumpkin curries, chanar dalna (cottage cheese curry), pulao, two kinds of chutney (tomato and elephant apple), and an array of Bengali

After the night of worship, the following day marks the Niranjan, the farewell to the goddess. In earlier times, devotees would carry the massive clay idol on their shoulders to the river. Though now transported by vehicle, the devotion remains unchanged, continuing a sacred tradition that has flowed through generations, just like the Ganges itself.

term. China retaliates with 10 per cent duties on American products. The new 100 per cent levy could effectively halt most bilateral trade, a move economists fear could push the global economy toward another slowdown. Trump's latest move comes after China tightened export controls on rare earth elements, vital to industries from renewable energy to defence, by requiring special permits for their export and restricting shipments of technologies used in mining and refining. Trump accused Beijing of "holding the world captive" by weaponising its domi-nance over the rare earth supply chain, saying, "China is becoming very hostile."

According to experts, the restrictions deepen the supply chain crisis for the US and its allies. The data from the Centre for Strategic and International Studies shows China currently controls nearly 70 per cent of global rare earth mining and over 90 per cent of magnet production. The tensions have also cast doubt over the upcoming Asia-Pacific Economic Cooperation (APEC) summit later this month, where Trump and Chinese President Xi Jinping were expected to meet for the first time since Trump's return to office in January this year. "I was to weeks, at APEC in South Korea, but now there seems to be no reason to do so," Trump said in his post.

ment, CESC, and the West Bengal Pollution Control Board. The meeting aims to outline strict guidelines regarding the use of loudspeakers, permissible decibel limits, and idol immersion protocols. The Calcutta High Court has already set the noise limit at 90 decibels for Diwali night, and the police are determined to enforce this order strictly. Senior police officials have warned that the use of banned firecrackers or violation of sound regulations will invite immediate legal action. "No compromise will be tolerated on the issue of noise pollution," a police source said.

Commissioner Manoj Verma has also made it clear that vigilance will be tighter than in previous years. All police stations have been instructed to intensify night patrols and coordinate with local puja committees. In addition to enforcing sound norms, managing large crowds during the festival will be a top priority. To handle the massive turnout expected during Kali Puja, extra police personnel, mobile patrol vans, and drones will be deployed across key areas of the city. Control room teams will intervene promptly in case of any overcrowding or disturbance. A senior police officer emphasized that while festivals are meant for joy and celebration, the primary goal is to prevent any untoward incidents. Kali Puja will be observed on October 20, and during the October 15 coordination meeting, police will issue final instructions to all puja organizers regarding safety responsibilities and compliance protocols.

# Darjeeling's Famous Oranges Devastated **Massive Crop Loss Reported Across Hills**



MI News Service, Kolkata: Known globally for its tea and its world-famous or-anges, the "Queen of Hills" has been left battered by heavy overnight rain and massive landslides. The calamity has caused widespread destruction of Darjeeling's prized orange orchards, bringing despair to farmers just weeks before harvest season. For tourists, the orange orchards of Darjeeling are as captivating as the Toy Train or Tiger Hill. The sight of endless rows of orange trees, laden with fruit, is one of the region's biggest attractions. However, this year, nature's fury has left the orchards devastated. In several areas, orange groves have been swept away into deep gorges; in others, trees have been uprooted or buried under landslides. Farmers, who were expecting a rich harvest within a month, now stare at ruin.

The state's Agriculture and Horticulture Departments, along with the Gorkhaland Territorial Administration (GTA), have already stepped in to assess the situation. Officials are working with farmers to provide relief and suggest alternative crops such as maize and vegetables to minimize losses. According to preliminary reports, nearly 450 hectares of orange orchards have been destroyed. Mirik - also known as the "Orange City" - has suffered the most severe damage. # PM Modi skips Gaza summit sends junior Minister to Egypt Nobel Peace Prize ambi-

post, among other diplomatic measures against Pakistan. At the 25th Shanghai Cooperation Organisation (SCO) summit in China last month, PM Modi, in presence of his Pakistani counterpart, flagged "certain nations" backing terrorism. PM Modi said India has suffered the "brunt of terrorism" for four decades and, following the Pahalgam attack, "it is natural to raise whether the open support of terrorism by some countries can be acceptable to us. We have to unanimously oppose colour. This is our duty towards humanity". In July, Sharif had extended an olive branch for "meaningful talks" with India, but it went unheeded. The other factor would have been the likely risk of US President Donald Trump, who is co-chairing the summit, using it to once again repeat his claim that he brokered a ceasefire between India and Pakistan in the aftermath of Operation Sindoor. Indian diplomats would be wary of Trump pulling what he did with Armenia and Azerbijan recently -- getting leaders of two hostile countries to pose for a photo op so that he can claim to have solved yet another conflict and further his

tions. It's also worth noting that relations between India and the US, which soured after President Trump imposed 50 per cent tariffs on India as punishment for continuing Russian oil purchases despite repeated warnings, have just started warming up. India has urged the US to lift the levies, arguing that affordable energy is crucial for its 1.4 billion citizens and the impasse remains despite recent talks between the two sides. After Trump imposed the tariffs, PM Modi reportedly refused to take calls from the US President at least four times. But on his 75th birthday last month, the Prime Minister finally spoke with the President when he called to offer his wishes. In recent days, the two leaders have engaged several times, including when PM Modi welcomed Trump's 20-point peace deal to end the war in Gaza. On October 9, the Prime Minister again dialled Trump, congratulating him on the success of the peace plan, while also reviewing the "good progress" in bilateral trade negotiations. Despite the renewed bonhomie, Trump has again repeated his claims of ending the India-Pakistan conflict.

"At present, India is in free trade agreement negotiations with the US, the EU, Peru, Oman, and New Zealand, among several others. The underlying priority of our trade negotiations is to secure fair and balanced agreements in the best interest of our nation and people," he added.

The lack of clarity on permissions, absence of visible enforcement, and continued silence from key stakeholders have sparked concern among environmentalists and locals alike. As construction continues unchecked, the question remains— who is granting the green signal, and at what cost to one of Bengal's most ecologically sen-

# Echoes of Revolution: Khudiram Bose's **Delhi University Shock: Woman Student Attacked, Staffer Among Accused**

MI News Service, Delhi: In a chilling recurrence of violence against women within academic institutions, a grim incident unfolded at Delhi's South Asian University, where a female student was forcibly assaulted by four individuals on campus premises. The attack, which included tearing of her clothes and an attempted gang rape, has sent shockwaves through the university community and reignited widespread concerns over campus safety. The incident occurred on Sunday afternoon as the student was moving from the auditorium to the canteen when four assailants accosted her. Among the accused, one has been identified as a non-teaching university employee. Promptly after the assault, the victim's friend reported the matter to the police, leading to the registration of an FIR and the initiation of a formal investigation by Delhi Police. Authorities are meticulously examining CCTV footage from across the university to piece together the events. Amid growing unrest, students have vocally demanded stringent punitive action against the perpetrators, underscoring the urgent need for enhanced protective measures within educational institutions. The university administration has yet to issue an official statement regarding the incident but claims full cooperation with law enforcement agencies investigating the case.

As soon as the news of the incident spread, nearby villagers and passersby rushed to the spot and began rescue efforts. Local people informed the fire department and police. Burn-injured passengers are being taken to Jawahir Hospital in Jaisalmer. The cause of the fire is currently unknown.

BJP Rajasthan President Madan Rathore expressed condolences over the death of people in a bus accident in Jaisalmer, where a private bus travelling from Jaisalmer to Jodhpur caught fire.

Extending condolences to the families of those who lost their lives and those injured in the tragic accident, Rathore said the incident is extremely painful and unbearable

He said that the incident is not merely an accident but a calamity that has devastated many families. He prayed for the speedy recovery of the injured and said that he prays to God to grant peace to the departed

# **WHO** flags three contaminated cough syrups in India. including Coldrif

New Delhi : The World Health Organisation (WHO) has identified three adulterated syrups manufactured in India, including the infamous Coldrif cough syrup, and has urged authorities worldwide to report to the agency if any of these products are detected in their respective countries.

The development comes weeks after the deaths of several children in Madhya Pradesh, linked to the consumption of adulterated cough syrup.
Among the three contaminat-

ed syrups flagged by WHO is Coldrif, which recently triggered widespread outrage following the children's deaths.

The global health body has identified specific batches of from Pharmaceuticals, Respifresh TR from Rednex Pharmaceuticals, and ReLife from Shape Pharma as the affected medicines.

WHO warned that the identified syrups could cause severe and potentially life-threatening illnesses. The Coldrif syrup, manufactured in Tamil Nadu, sparked major alarm after it was found to be dangerously contaminated with the toxic chemical diethylene glycol (DEG).

Tests revealed DEG concentrations exceeding 48 per cent -- an alarming figure far above the per-

missible limit of 0.1 per cent. Following this, Sre Pharmaceuticals had its manufacturing license revoked, and its owner, G. Ranganathan, was arrested. The authorities also ordered a comprehensive inspection of other drug manufacturing companies across the southern state to identify potential lapses in

# Maldives world's 1st country to eliminate mother- $\oplus$ to-child transmission of HIV, syphilis and hepatitis B

New Delhi: In a landmark public health achievement, Maldives has become the first country in the world to achieve 'triple elimination' of mother-to-child transmission (EMTCT) of hepatitis B, HIV and syphilis, the World Health Organization (WHO) said on

Maldives was currently validated by the WHO for eliminating -to-child transmission hepatitis B. The country, had, achieved WHO validation or EMTCT of HIV and syphilis in 2019.

'Maldives has shown that with strong political will and sustained investment in maternal and child health, elimination of mother-tochild transmission of these deadly diseases, and the suffering they is possible," DrTedrosAdhanomGhebreyesus, WHO Director-General.

This historic milestone provides hope and inspiration for



towards the same goal," he added. Mother-to-child transmission leads to infections that affect millions worldwide. In the WHO South-East Asia Region alone, provisional estimates indicate that in 2024, more than 23 000 pregnant women had syphilis and over 8,000 infants were born with con-genital syphilis. About 25,000

HIV-positive pregnant women required treatment to prevent transmission to their babies, while hepatitis B continues to affect more than 42 million people in the Region, the WHO said.

"The landmark feat is an important step towards 'Healthy Beginnings, Hopeful Futures,' for

health by ending preventable deaths and prioritising long-term well-being," said Dr Catharina Boehme, Officer-in-Charge, WHO South-East Asia Regional Office. In Maldives, over 95 per cent

of pregnant women have received antenatal care, with nearly universal testing for HIV, syphilis and hepatitis B. With a strong strongimmunisation system, no babies were born with HIV or syphilis in 2022 and 2023. A 2023 national survey confirmed zero hepatitis B among young children (first grade of school), surpassing elimination targets, the WHO said.

"This historic validation is a moment of immense pride for the Maldives and a reflection of our nation's steadfast commitment to protecting mothers, children and future generations," said Abdulla Nazim Ibrahim, Minister of Health, Maldives, while pledging to sustain the progress for the

# Covid virus can cause changes in sperm, raise anxiety risk in future generations: Study

New Delhi, Oct 14 (IANS) While Covid-19 infection is known to have lasting effects on the brain, an alarming animal study showed that SARS-CoV-2 infection in fathers before conception can cause changes in sperm, altering children's brain development and behaviour, and increasing the risk of anxiety later.

The findings, published in the journal Nature Communications, show that Covid could have long-lasting effects on future gener-

Previous studies have shown that male mice exposed to specific environmental and lifestyle factors, like a poor diet before mating, could change brain development and behaviour in offspring.

"This is because the father's experiences can alter the information carried in sperm, including specific RNA molecules, which transmit instructions for offspring development," said lead researcher Professor Anthony Hannan at the University of Melbourne's



Health in Australia. In the new study, the team wanted to see whether the Covid virus would have a similar effect on sperm RNA and the offspring. To probe, the team let male mice recover from SARS-CoV-2 infection for a few weeks before they mated with healthy females.

The offspring showed more anxious behaviours compared to offspring from uninfected fathers. All offspring from Covid-affected fathers displayed increased anxiety-like behaviours. Female offspring also had significant changes in specific gene activity in their brain's hippocampus region, which is important for anxiety, depression, and other affective

"These kinds of changes in the hippocampus, as well as other brain regions, may contribute to the increased anxiety we observed in offspring, via epigenetic inheritance and altered brain development," said Dr. Carolina Gubert from the Institute.

Further analysis of the RNA from the infected fathers' sperm showed that Covid had altered various molecules, including some involved in the regulation of genes that are known to be important in brain development.

"If our findings translate to humans, this could impact millions of children worldwide, and their families, with major implications for public health," said Hannan, while calling for



neurological conditions can be prevented or effectively treated, yet services remain out of reach for most - especially in rural and underserved areas - where people too often face stigma, social exclusion, and financial hardship. We must work together to ensure that brain health is prioritised and properly invested in," Farrar said.

The report, based on data from 102 countries, showed that 63 countries have a national policy addressing neurological disorders, but only 34 reported having dedicated funding to address them.

Without strong policy frameworks, health systems remain fragmented, underresourced, and ill-equipped to meet the needs of patients and families.

Further, essential services were also found out of reach for most people, with only 49 countries including neurological disorders in their universal health coverage benefit packages.

Critical services such as stroke units, ediatric neurology, rehabilitation, and palliative care are frequently lacking or concentrated in urban areas, leaving rural and underserved populations without access to lifesaving and life-sustaining care.

The WHO has urged governments to make neurological disorders a policy priority through bold leadership and sustained investment; expand access to neurological care through universal health coverage and health system strengthening.



# WHO issues alert over 3 adultrated cough syrups manufactured in India, cautions use globally News Service, Geneva: The World Glycol (DEG) in at least three products-

Health Organisation (WHO) has issued a medical product alert for three adulterated oral liquid medicines (cough syrups) manufactured in India. It has warned that the identified syrups commonly used to treat cold, flu, and cough symptoms, have been linked to cases of severe illness and child fatalities and could cause severe and potentially life-threatening illnesses.

The global health body has urged authorities worldwide to report to the agency if any of these products are detected in their countries. The Organisation said that such medications should not be prescribed or dispensed to children below two years of age and are generally not recommended for those under five. The WHO has identified specific batches of Coldrif from Sresan Pharmaceu-Respifresh TR from Rednex Pharmaceuticals, and ReLife from Shape Pharma as the affected medicines. The products identified in this alert are considered substandard as they fail to meet their quality standards and specifications, the WHO said. On October 8, India's Central Drugs Standard Control Organisation (CDSCO) reported to the WHO the presence of Diethylene



-COLDRIF, Respifresh TR and ReLife. These medicines were manufactured by Sresan Pharmaceutical, Rednex Pharmaceuticals, and Shape Pharma, respectively. Following the deaths of several children in Madhya Pradesh a week ago, linked to the consumption

of Coldrif cough syrup, the Government of India had issues an advisory to all states and union territories, urging extreme caution in the prescription of cough syrups for children. The Coldrif syrup, manufactured in Tamil Nadu by Sresan Pharmaceuticals, was found to be dangerously contaminated with the toxic chemical diethylene glycol. The company's manufacturing license was revoked, and its owner, G. Ranganathan, was taken into custody. "Diethylene glycol is toxic to humans when consumed and can prove fatal. The contaminated oral liquid medicines referenced in this alert are unsafe, and their use, especially in children, may result in serious injury or death. Toxic effects can include abdominal pain, vomiting, diarrhoea, inability to pass urine, headache, altered mental state and acute kidney injury, which may lead to death." WHO said.

# **Gaza**: Suspects shot after ignoring warnings not to enter the yellow line

MI News Service, Tel Aviv: IDF forces in Gaza opened fire on suspects who approached them in the north of the Strip and crossed the yellow line earlier today, according to an I"F spokesperson. The spokesperson emphasised that this was a violation of the agreement and that attempts had been made to warn the suspects before firing. The suspects did not respond and continued to approach the forces, who then fired in order to eliminate the threat. It was also stated that reports of terrorists infiltrating the defensive perimeter were incorrect. The IDF calls on Gaza residents "to follow IDF instructions and not approach the deployed forces." Five casualties were reported in Gaza.

# 2nd Test: Rahul hits unbeaten 58 as India beat WI by seven-wicket to sweep series 2-0

NEW DELHI: India needed exactly an hour on day five to complete a seven-wicket win over West Indies and seal a 2-0 series sweep at the Arun Jaitley Stadium on Tuesday. KL Rahul anchored the chase with an unbeaten 58 off 108 balls, hitting six fours and two sixes to help India easily hunt down 121.

The victory marks India's first Test series win under Shubman Gill's captaincy, following the drawn 2-2 result in England earlier this year. Though the margin suggests an easy victory, India were to earn it in New Delhi and defeat West Indies for the tenth straight time in Tests.

West Indies, asked to follow on, refused to fold easily, thanks to John Campbell and Shai Hope's twin centuries and a defiant last-wicket 79-run stand which led to the contest stretching to day five. But once play resumed, India made quick work of the chase despite an early wobble and earn 12 valuable points to their World Test Championship tally, where they are still at number three and their points percentage now at 61.9.

With 700 noting points Healy

With 700 rating points, Healy now sits behind Mandhana, Nat Sciver-Brunt, and Beth Mooney, and shares her position with Laura Wolvaardt.

The South Africa skipper also climbed three places to joint-fourth after consistent knocks, including a match-winning 70 against India. Meanwhile, New Zealand captain Sophie Devine, the leading run-scorer in the tournament so far, rose two places to sixth, underlining her impact at

the World Cup. Further down the list, South

Africa's rising star Nadine de Klerk made an eye-catching jump of 26 spots to 32nd, following her vital contributions in successful Proteas run chases in Visakhapatnam.

In the Women's ODI Bowling Rankings, England's Sophie Ecclestone continues to hold the No. 1 position, with Australia's Ashleigh Gardner close behind.

But it was a breakthrough week for several bowlers. Australia seamer Annabel Annabel Sutherland climbed six spots to a career-best eighth, while South Africa's left-arm spinner Nonkululeko Mlaba broke into the top 10, rising three positions after taking eight wickets so far in the tournament. Gardner also continues to dominate the All-rounder Rankings, retaining her top spot, though Chloe Tryon of South Africa entered the top 10 for the first time after climbing three places to achieve a new personal best. NEW DELHI: After the conclusion of the skeet events, attention now turns to the trap competition, as the International Shooting Sports Federation (ISSF) World Championship Shotgun 2025, enters its second phase in Athens, Greece.

Range in the Greek capital for the
first 50 targets of the qualification
round.

The women's trap event promises a competitive line-up, led by defending World Champion Lin Yi-Chun of Chinese Taipei. The 80-athlete field also includes World No.1 Lada Denisova (AIN), World No.2 Silvana Stanco of Italy, World No.3 Alessandra Perilli of San Marino, and World No.4 Carey Jeana Garrison of the USA. Other leading names include Paris Olympic champion Adriana Ruano (Guatemala).

Leading India's charge will be Asian Champion and World No.8 Neeru Dhanda, who has been in consistent form this season with a fourth-place finish at the Lonato World Cup and a top-six performance in the Buenos Aires Mixed Team event. She will be joined by Aashima Ahlawat, Asian Championship bronze medalist, and Kirti Gupta, who completes the Indian women's triad.

In the men's section, veteran Zoravar Singh Sandhu, currently ranked World No.12, will spearhead the Indian challenge alongside former Junior World Champion Vivaan Kapoor, and Bhowneesh Mendiratta, who claimed silver at the Asian



Championship in Kazakhstan.

The men's trap event will see participation from 141 athletes, including reigning World Champion Giovanni Cernogoraz of Croatia, who will be joined by his 2023 podium companions Marián Kova?ócy of Slovakia and Khaled Al-Mudhaf of Kuwait. Paris Olympic gold medalist Nathan Hales of Great Britain and bronze medalist Jean Pierre Brol of Guatemala (World No.4) are also among the headliners in a stacked field.

The competition will also feature top-ranked shooters, including World No.1 Mauro De Filippis

(Italy), William Hinton (USA, World No.2), Walton Eller (USA, World No.3), and Giovanni Pellielo (Italy, World No.5), ensuring a high-calibre battle for the podium.

The trap qualification rounds will begin on Wednesday with 50 targets each for men and women, followed by another 50 on October 16, and a final 25 on October 17. After 125 targets in qualification, the top six from each category will move to the finals for World Championship medals. The women's trap final is scheduled for 5:30 PM IST, followed by the men's final at 7:00 PM IST on the same day.

# Formula 1: James Vowles hails Alex Albon's 'outstanding' 2025 season NEW DELHI: Williams team Can you even just push him. He is

principal James Vowles has lavished praise on Alex Albon, describing his 2025 Formula 1 season as "outstanding" and highlighting a noticeable "step up in his confidence and belief" that has been central to team's' resurgence this year.

Albon has enjoyed a superb campaign, sitting eighth in the Drivers' Championship with 70 points after scoring in 11 of the 18 races so far. His consistent form, including personal-best P5 finishes in Australia, Miami, Imola and the Netherlands, has propelled Williams to fifth place in the Constructors' standings - a significant jump for the Grovebased outfit. By contrast, his new teammate Carlos Sainz, who joined from Ferrari with four career wins to his name, has scored 32 points this season.

Speaking on the Beyond The Grid podcast, Vowles reflected on Albon's remarkable growth since joining the team. "I can tell you from the outset he was very quick, but he needed the right forum where the world isn't questioning his teammates or what's going on," Vowles said.

"There's no questioning now. Carlos is absolutely the reference you need. Alex, this year, every time there has been a result (available), he's gone and picked it up. Simple as that. His pace has been outstanding. I think if there's any doubts, it should be



gone by now in people's minds."
Vowles believes Albon's transformation this year goes beyond pure performance - it's rooted in his mental composure and growing self-assurance.

"I would say the biggest difference I've noticed with Alex is a step up in his confidence and

belief," he explained. "That's the main thing - in the team and in

The Williams boss also praised Albon's openness and teamwork in helping Sainz adapt to the car's unique characteristics

"We have some peculiarities in this car on just how to approach certain corners, but he's really, really good at vocalising that, and helping Carlos as well - he's not keeping it for himself," said Vowles.

"It's immediately straight out there, 'Look at this, this is what I'm doing here', and then helping the engineers drive the direction of travel. In that way, he's more vocal than I've heard him before and his direction is absolutely snot on."

Zampa, meanwhile, is expected to link up with the Australian squad ahead of the second ODI against India on October 23.

Cricket Australia said that Inglis is expected to return for the third ODI in Sydney on October 25.

Alex Carey has been released from the squad for the first ODI to play in South Australia's round two Sheffield Shield match against Queensland as part of his build-up to the Ashes. He will rejoin the squad in Adelaide ahead of the second match of the series.

India's white-ball tour of Australia, under the new captain Shubman Gill, starts with the ODI series opener on October 19 at Perth Stadium and is followed by matches at Adelaide Oval and Sydney Cricket Ground on October 23 and 25, respectively.

It is followed by the five-match T20I series beginning on October 29.The last time India toured Australia for a bilateral ODI series, the visitors lost by a 2-1 margin in 2020/21, but managed to win the subsequent T20I series by the same margin on the same tour.
