The West Bengal Board of Secondary Education (WBBSE) has reiterated that district inspectors and school inspectors whose children will appear for the '26 Madhyamik Examination will not be allowed to participate in any examination-related duties. The directive, issued through an official notification, aims to uphold transparency and prevent potential conflicts of interest in the state's secondary examinations. The circular further Instructs all Dis and Sis to inform the Board if their sons or daughters are appearing for the upcoming Madhyamik exams. This policy, according to the WBBSE, is not new but has been reinforced following an incident last year that raised questions about exam integrity. WBBSE President RamanujGangopadhyay stated, "If any DI or SI's child appears in the Madhyamik, they cannot remain associated with exam management. PG 3

PM Modi to Launch Bihar Election Campaign with Four Rallies This Month

ter Narendra Modi is set to kick off his campaign for the upcoming Bihar Assembly elections next week, with four major rallies planned by the end of this month. The announcement was made on Sunday by Bihar BJP president Dilip Jaiswal during a press conference in Patna. Jaiswal said the Prime Minister will launch his campaign with a rally in Samastipur on October 24, followed by another public meeting in Begusarai later the same day. "The PM, who is among the tallest leaders in the world, will visit Karpoori Gram in Samastipur district, the birthplace of Bharat Ratna Karpoori Thakur, and pay floral tributes to the former Bihar first rally," Jaiswal said. "His second rally will be held in Begusarai in the af-

According to the BJP state president, Modi will return to the poll-bound state on October 30 to hold two more rallies — one in Muzaffarpur and another in Chhapra, the headquarters of Saran district. "These events are part of a series of public meetings that will highlight the central government's achievements and its commitment to Bihar's development," Jaiswal added. He also confirmed that the Prime Minister's campaign schedule includes additional rallies on November 2, 3, 6, and 7. Details of the venues and timings for

The BJP, along with its allies in the National Democratic Alliance (NDA), is gearing up for an intense campaign season, with Modi expected to play a central role in mobilizing voters across the state. The party is banking on the Prime Minister's popularity and his previous outreach efforts in Bihar to strengthen its position against the opposition alliance. The Bihar Assembly elections will be conducted in two phases. In the first phase, polling will take place in 121 constituencies on November 6, followed by voting in the remaining 122 seats on November 11. The results are expected to set the tone for political alignments ahead of the 2026 general elections.

WBBSE Issues Strict **Guidelines to Ensure** Fairness and Neutrality in 2026 Secondary Examinations

MI News Service, Kolkata: The West Bengal Board of Education Secondary (WBBSE) has announced a set of strict directives to uphold transparency, neutrality, and fairness in the upcoming 2026 Madhyamik (secondary) examinations. The board has instructed all schools to ensure that no controversial, politically biased, or socially inappropriate content appears in exam question papers. According to the circular, all examination questions must strictly labus and maintain neutral language and context, leaving no room for misinterpretation or dispute. The board underscored that the headmaster or headmistress of each school will be held directly accountable if any objectionable or off-syllabus questions are found. The move aims to ensure uniformity and maintain the academic credibility of the

state's examination process. Several school administrators have welcomed the directive. Partha Pratim Vaidya, Principal of Jadavpur Vidyapeeth, noted that while the warning is directed primarily at school heads, teachers preparing question papers must exercise utmost caution. "Vigilance at every level—from teachers to administrators—is essential to avoid unnecessary controversies, he said. The WBBSE has

TMC Announces District-Level Reshuffle to Strengthen Outreach Ahead of 2026 Assembly Polls



MI News Service, Kolkata: Trinamool Congress (TMC) on Sunday undertook a major organisational reshuffle across several districts in West Bengal, including its minority cell, as part of a strategic effort to consolidate voter support and counter the BJP ahead of the 2026 Assembly

The party announced new block and town presidents for its women's, youth, and workers' wings in districts such as Nadia, Birbhum, and Basirhat (North 24 Parganas), alongside fresh district-level committees. "The TMC, under the inspiration and guidance of party chairperson Mamata Banerjee, is pleased to announce the list of new Trinamool Congress block and town presidents,' the party said in an official statement.

Sources revealed that the reshuffle particularly focuses on strengthening engagement with the minority community. New presidents were appointed in 35 organisational districts, including Kolkata North and South, North and South 24 Parganas, and Murshidabad (Berhampore and Jiaganj), as part of the party's efforts to counter the BJP's Hindutva narrative and consolidate minority votes.

TMC state general secretary Kunal Ghosh told, "We are effecting these changes based on the performance of leaders and workers and their connection with the masses. More changes will follow in the coming days." The appointments are expected to improve grassroots engagement and strengthen the party's organisational base ahead of the election season. In addition to the structural changes, the TMC has initiated block-level Bijoya Sammelanis — post-Durga Puja outreach programmes — to engage with local communities and highlight government achievements. Over 60 such events have been held across the state so far. A party insider added that around 50 ministers, MPs, and MLAs have been assigned to visit various including constituencies, those held by the BJP. These visits aim to showcase welfare schemes, strengthen local connections, and prepare party cadres for booth-level activities in the lead-up to the electoral roll revision.

The organisational revamp Is seen as a key component of the TMC's election strategy, ensuring active leadership at all levels of the party and closer engagement with voters across West Bengal. 

Youth dies mysteriously after liquor party in Nadia, three friends arrested

Dipankar Edbar, Nadia : A night of drinking turned tragic in Nadia's Hanskhali area after a 25-year-old man, identified as Soumen Biswas, was found dead under mysterious circumstances. Police have arrested three of his friends who were present at the drinking session. According to police sources, on Saturday night, Soumen and three of his friends gathered for a liquor party on the terrace of a house in Bagula under Hanskhali police station limits. During the party, Soumen reportedly collapsed and became unconscious. His friends rushed him to Bagula Rural Hospital, where doctors de-



clared him dead on arrival. The police later detained the three friends and questioned them regarding the incident. On Sunday, they were produced before the Ranaghat sub-divisional court, which remanded them in police custody for

Dipankar Edbar, Nadia: In a shocking incident at Jawaharlal Nehru Memorial Hospital in Kalyani, Nadia, two female attendants al-Kalyani, Nadia, two female attendants allegedly abandoned a woman patient on a trolley midway because her family failed to pay them immediately.

Though government hospitals officially have no provision for hiring such attendants, it is widely known that "unofficial ayas" operate across many hospitals. Their high-handedness and demand for money often leave poor patients and their relatives helpless and harassed. The incident came to light after a video development by a kin of the woman being left unattended on a trolley went viral on social media, prompting the hospital authorities and local administration to step in.

In response, Kalyani police have been using loudspeakers in and around the hospital premises for several days, urging people not to pay anyone for services that are supposed to be provided free of cost in government hospitals. Regarding the incident, hospital authorities stated that an internal inquiry has been initiated and that strict action will be taken if anyone is found involved in the act. The Hospital Aditional Super Atin Mandal said, "There is nothing wrong with the government policy. At times, misunderstandings arise when patients or their families engage in activities within the hospital, but this should not be confused with any official government directive. While sources said that the issue of ha-



rassing patient by Ayas gone viral, we have not yet received any written complaint or formal advisory regarding the matter. Once we do, appropriate written communication will be issued, and necessary arrangements will be made accordingly. It is important to remember that when a patient is admitted, it affects not only the patient but also their family's mental well-being. If anyone needs to visit the hospital, they should do so responsibly. Whether it is a doctor, a nurse, or any member of the hospital staff-all are human beings doing their best to serve patients. We have not received any official complaint yet, but we are actively investigating. If any incident has taken place, and if the patient's family informs us, it will

help us take faster action. As stated earlier, all government hospitals and medical colleges, including the College of Medicine and J.N.M. Hospital, provide treatment completely free of cost. Necessary arrangements have been made to ensure this. If any unfortunate incident occurs, we will certainly take preventive measures to ensure that people receive timely and proper treatment. That remains our primary goal."

No-cracker plea for flood aid: NGOs want people to donate for relief

MI News Service, Siliguri: Representatives from the Himalayan Nature and Adventure Foundation (Hnaf), and Sabuj Mancha, a collective forum of 65 NGOs across the state, urged north residents to abstain from bursting crackers during Diwali and Kali Puja season.

The organisation instead appealed to people to donate their resources to victims of the recent floods in north Bengal. "Several people lost their lives, people have become homeless, and their livelihoods are at stake after the landslides and floods that struck large parts of the Darjeeling hills and the adjoining plains on October 5. In light of this tragedy, we are appealing to the people across north Bengal not to buy crackers this year. Instead, we urge them to donate that money for the rehabilitation of the affected families," said Animesh Bose, the programme coordinator of Hnaf, on Saturday.

These organisations have been running relief camps and distributing aid across the flood-affected regions. In addition to their appeal, several NGOs have also called on the administration to enforce the Supreme Court's guidelines regarding the use of fireworks, that is, allowing the use of crackers only between 8pm and 10pm during Kali Puja and Diwali, and 6am to 10am during Chhath Puja.

Only green crackers are allowed to be burst in Bengal, but this diktat, as well as the timing restrictions are regularly flouted across the state during festivities. Bose, who is also the vice-president of Sabuj Mancha, expressed concern over a temporary cracker market that has been opened at Kawakhali on the outskirts of Siliguri. "We request the administration to step up vigilance at the market to prevent the sale of banned crackers," he said. To aid in the monitoring of crackers, the organisations have launched a public helpline number (9434233833). "We want people to call up the helpline to report violations or irregularities related to firecracker usage or sales," said a representative of the Mancha.

A group of medical professionals have also joined the anti-cracker campaign, urging people to consider the severe health and environmental impact of firecrackers.

More CAA hearing centres set up by Union ministry of communication in two districts MI News Service, Nadia/North 24 as applicants are getting hearing

pgs: The Union ministry of communication has set up two additional district-level committees (DLCs) or hearing centres — one each in Nadia and North 24-Parganas — to expedite the processing of thousands of citizenship applications under the Citizenship (Amendment) Act.

Earlier, there was only one DLC in each of the two districts to verify documents of CAA applicants. The increase in the number of DLCs effectively means more hearing centres for citizenship applications.

Nadia and North 24-Parganas are two crucial districts that together house nearly one-fourth of the total estimated two crore persecuted Hindu refugees, particularly from the Matua community. The move to increase the number of hearing centres for citizenship applications is considered politically significant ahead of next year's Assembly polls, as the BJP aims to help as many Matuas as possible obtain citizenship status. 

Trinamool spokesperson Arup Chakraborty said: The efforts of the BJP and the central government to expedite citizenship hearings prove that SIR would create trouble mainly for Hindu Bengalis, as those who escaped from Bangladesh are Hindus. Now, the BJP's ploy of SIR would affect the Matuas, who are also Hindus.

10th rhino found, sent to Jaldapara National Park

MI News Service, Alipurduar: All the greater onerhinoceroses horned swept away in the devastating floods in Alipurduar been successfully tranquillised and relocated to the Jaldapara National Park, the largest habitat of the species in Bengal. The operation, now being hailed as the largest coordinated rhino rescue and release mission ever in India, was carried out over a span of 13 days by the Jaldapara

wildlife division. The final rhino, the 10th, was rescued on Friday from a low-lying area in Patlakhawa of Cooch Behar and was released safely into the national park after a thorough veterinary examination. Parveen Kaswan, the divisional forest officer of Jaldapara wildlife division, said: "This has been the most extensive rhino rescue operation ever conducted in any forest in India. The work is almost over, but we will continue



scanning the Patlakhawa Putimari forests (in Cooch Behar) for a few more days to ensure no animals remain stranded." "The credit goes entirely to our field staff, many of whom haven't slept properly for 13 days," he added.

On October 5, heavy rain caused the Torsha river to overflow, inundating large parts of the park. Ten rhinos were reported missing. Five of them were found stranded near human habitations, while five others were swept downstream into the Behar district,

10km to 15km away from the park boundary. The mission com-

bined efforts from forest staff, veterinary experts, drone teams and elephant squads. Monitoring teams, comprising range officers and trained elephants, were deployed to locate the displaced rhinos and guide them back," said a source. The process involved tranquillising the rhinos under veterinary supervision and bringing them back to the park.

"Fire tenders with water hoses kept the animals hydrated during transit," the source added. Kaswan said the first five rhinos, spotted close to the park, were guided back without tranquillisation within the first three days. The remaining five required full-scale rescue procedures, given their distance and proximity to human settlements. "On Friday, the 10th rhino. which had eluded earlier rescue attempts, was finally found," said the DFO.

2 dead as car falls into gorge in Kurseong

MI News Service, Kurseong: others were injured when their car plunged into a gorge at Pankhabari in Darjeeling's Kurseong subdivision early on Saturday. According to a police source, the car was descending from the Darjeeling hills via Pankhabari when it lost control near the Tin Ghumti bend, approximately 30km from Kurseong town.
"Initial investigations

suggest that the driver lost control at a bend, and the car veered off the road and fell into the gorge. There were five people in the vehicle, all from the Naxalbari area of Siliguri subdivision. Two among them, Sumit Singha of Footani More and Rajesh Paswan of Kotiajote, died on the spot," said a police officer. A local noticed the wrecked vehicle in the He immediately alerted others. Personnel from the Garidhura police outpost and the traffic department of Kurseong police station recovered the bodies with the assistance of locals.

The injured passengers are under treatment at the North Bengal Medical College & Hospital (NBMCH). Police have initiated a probe.

Meet organised by Alipurduar administration to extend relief to tea garden families

MI News Service, Alipurduar: The Alipurduar administration held a meeting at the collectorate on Friday with management representatives of 20 tea estates in the district to take stock of the situation in the gardens affected by flash floods earlier this month. Sundarbans homemaker fights off crocodile while crab fishing MI News Service, South 24 Pgs: A 37 year-old homemaker from the Sundarbans displayed remarkable courage on Saturday by fighting off a crocodile for 30 minutes before villagers rescued her from the jaws of

the reptile. Around 6am, Pranati Pramanik was collecting crabs in a creek near the Ashwini Maiti ghat of Bonshyamnagar village under Patharpratima block, South 24-Parganas, when the crocodile pounced on her.

Wife of a migrant labourer, she was later admitted to the Patharpratima Rural Hospital. Her condition is stable. Local residents said that due to her husband's alleged negligence and the family's poverty, Pranati stayed in a dilapidated house with



her two school-going daughters, one in Class XI and the other in Class II. She would catch crabs every day for some earnings, sometimes accompanied by her daughters.

On Saturday, as usual, Pranati went to catch crabs in the forest near Ashwini Maiti's fishing village ghat. While she was pulling up her fishing net, it got entangled in the mangrove roots, causing her to inadvertently

Suddenly, a crocodile lunged at her and clamped its jaws around her waist. Showing great presence of mind, Pranati clung to a tree to prevent going underwater and tried to fight off the reptile with her fists while screaming for help. Finally, villagers, including women, rescued

her. The crocodile escaped. Forest officials said saltwater or estuarine crocodiles have increasingly been straying into creeks, canals and water bodies close to human habitation in the Sundarbans. This is the nesting season for crocodiles, during which they tend to turn more aggressive, often leading to a rise in human-crocodile conflicts in areas bordering the delta.

11 Migrant Workers **Trapped in Oman After Job Fraud**

MI News Service, Kolkata: Eleven migrant workers from Murshidabad, who had travelled to Oman for employment, were rescued after falling victim to a fraudulent recruitment agency. The workers, who had been wandering from place to place without shelter or resources, are now safely under the care of the Indian Embassy in Muscat, following the swift intervention of the West Bengal government.

According to official sources, the workers were allegedly deceived by an unscrupulous recruitment network that promised them jobs in Oman. However, once they arrived, they were left stranded with no employment, accommodation, or valid documents. News of their plight reached Nabanna, the state secretariat, prompting immediate action from the state administration to ensure their safety and repatriation. In a social media post, the Trinamool Congress (TMC) stated: "Eleven migrant labourers from Murshidabad, who had gone to Oman for work, were trapped by a dishonest re-cruitment agency. Left helpless, they were moving from one place to another without food or shelter. Upon learning of their condition, our humane and responsive government immediately intervened to secure their safety and well-being. With the active efforts of the state administration, the workers are now in the protective cus-tody of the Indian Embassy in Oman, where proper arrangements have been made for their stay and food." The post further added that the stranded labourers have expressed their desire to return home. "We sincerely hope that the Ministry of Exter-nal Affairs will take swift and compassionate action to bring them back safely to their families," the TMC

Failure to comply with this directive may invite disciplinary action from the board.

The board now aims to introduce a more rigorous monitoring system to prevent such occurrences. The WBBSE has set the deadline for submission of test papers between November 3 and 13, allowing schools sufficient time to finalise their exam preparations in line with the new guidelines.

Man Beaten to Death in Salt Lake, Two Arrested; Police Probe Cause

Housewife's Death **Turns Into Murder Probe; Husband** and Sister-in-Law **Arrested**

WBBSE Bars Inspectors from **Exam Duties If Their Children Appear for Madhyamik 2026**

MI News Service, Kolkata: The West Bengal Board of Secondary Education (WBBSE) has reiterated that district inspectors (Dis) and inspectors (Sis) whose children will appear for the 2026 Madhyamik Examination will not be allowed to participate in any examination-related duties. The directive, issued through an official notification, aims to uphold transand potential conflicts of interest

in the state's secondary examinations. circular further Instructs all Dis and Sis to inform the Board if their sons or daughters are appear-

Madhyamik upcoming exams. This policy, according to the WBBSE, is not new but has been reinforced following an incident last year that raised questions about exam integrity. WBBSE President RamanujGangopadhyay stated, "If any DI or SI's child appears in the Madhyamik examination, they cannot remain associated with exam management. Generally, they voluntarily inform the Board and recuse them-selves from related responsibilities. However, due to an unfortunate incident last year, we were compelled to issue this reminder officially." The Madhyamik exstate's amination, the

secondary-level exam, is organized and supervised primarily under the responsibility of DIs and SIs. Their roles include managing question papers, ensuring confidentiality, and overseeing fair conduct of the exams. Allowing officials with direct family involvement in the test process could, therefore, raise questions about fairness and secrecy. Last year, controversy erupted when the son of a Inspector from

Malda appeared for the Mad-hyamik exam. The officer failed to disclose this information to the Board, and the matter came to light only after four subjects had

already been conducted. Upon discovery, the WBBSE immediately removed the DI from all examination-related duties. Learning from that episode, the Board has taken a proactive stance this year by issuing an early warning and emphasizing strict compliance. "This decision is meant to ensure absolute transparency and fairness in the examination process," Gangopadhyay added. The notification has been circulated to all district education offices and schools across West Bengal to prevent any recurrence of last year's oversight and to maintain the integrity of the state's most significant public examination.

Kolkata's AQI Deteriorates Sharply; Cyclone Watch Issued Over Bay of Bengal

MI News Service, Kolkata: The city woke up to a bright and sunny Sunday morning, with temperahovering around 33°C under clear skies. However, beneath the pleasant weather lies a growing environmental concern — a sharp decline in Kolkata's air quality, with several areas recording "poor" levels on the Air Quality Index (AQI).

According to data from the West Bengal Pollution Control Board (WBPCB), the AQI in parts of the city touched alarming levels on Sunday. At Jadavpur in South Kolkata, the AQI was recorded at 242, while the RabindraBharati University (Sinthee) station in North Kolkata registered 252 — both falling under the "poor" category. The figures mark a significant jump from Friday's AQI levels, which ranged between 179 and 185.

Experts have attributed the sudden deterioration to weather changes, including lower humidity and calm winds following

monsoon. These conditions have caused particulate matter (PM2.5 and PM10) — fine dust and pollution particles — to remain trapped near the ground instead of dispersing into the upper atmosphere. Vehicle emissions and ongoing construction activity in densely populated zones have further worsened the air quality. Saturday's citywide AQI stood at 169, categorized as "moderate" under Indian standards, with PM2.5 at 77 $\mu g/m^3$ and PM10 at 135 μ g/m³. Officials clarified that the recent spike in pollution is not related to fireworks. The WBPCB has advised children, the elderly, and individuals with respiratory problems to stay indoors and avoid prolonged exposure to outdoor air. The Board also announced that special surveillance teams will monitor air pollution and possible violations during Kali Puja on Monday, ensuring compliance with environmental

SSKM Create Med Milestone with Rare Heart Surgery on Preg Woman MI News Service, Kolkata: In a urgent surgery, but the presence of repair the damaged vessel

groundbreaking medical achievement, doctors at SSKM Hospital have successfully performed a complex open-heart surgery on a five-month pregnant woman, saving both mother and child. The rare procedure was conducted by the hospital's Cardiothoracic and Vascular Surgery (CTVS) department, setting a new benchmark in public healthcare. The patient, 21-year-old Jaba Barman from Cooch Behar, was suffering from a rare and life-threatening heart condition known as Ruptured Sinus of Valsalva. Her husband, Nitai Barman, is a toto driver by profession. Jaba had been experiencing severe breathing difficulties since September, which led doctors to diagnose the cardiac rupture after an echocardiogram. In this condition,



an abnormal dilation develops in a section of the aorta, causing it to rupture. Blood then flows from the aorta into the right chamber of the heart, leading to chest pain, breathlessness, and the risk of complete cardiac failure. Such cases demand a five-month-old fetus made the operation highly risky.

Doctors explained that the use of a heart-lung machine during the surgery could have led to a 90% chance of fetal death, alongside a serious threat to the mother's life. Despite these odds, a multidisciplinary team was formed comprising specialists from cardiothoracic surgery, anaesthesia, gynaecology, and perfusion. Initially, doctors tried inserting a device to block the abnormal blood flow, but when the patient's condition deteriorated due to infection, jaundice, and falling hemoglobin levels, emergency open-heart surgery became unavoidable. The team proceeded with extraordinary caution, stopping the patient's heart temporarily during the procedure to

The surgery, conducted on

Thursday, lasted several hours but ended successfully. Both Jaba and her unborn baby are now stable and under close observation. Professor ShubhenduSekharMahapatra, head of the CTVS department, said, "The mother's condition was extremely critical with multiple complications, including jaundice and sepsis. Performing this surgery successfully was a major challenge, and we are delighted with the outcome." Jaba's husband expressed gratitude, saying, "The doctors here are truly godlike. They not only saved my wife but also our unborn child." The remarkable success has brought pride to West Bengal's public healthcare system, demonstrating SSKM Hospital's excellence in advanced cardiac care.

In joint Op, Assam Rifles recover weapons from Manipur's Bishnupur

hand: The Union Home reports dramatic decline Maoist-affected districts across India, plunging from 182 in 2013 to just 11 as of October 2025, signaling a decisive victory in the government's antiinsurgency Union Home Minister Amit Shah has unequivocally declared the nation will be completely free of Maoist insurgency by March 31, 2026. This pledge follows sustained efforts by the Narendra Modi-led NDA government since 2014 to eradicate left-wing through a combination of security operations and socio-economic development initiatives.

According to official data, the Maoist presence has been severely crippled, with only three districts— Bijapur, Sukma, and Narayanpur in Chhattisgarh—remaining Maoist strongholds. These figures underscore a steep decline from the 18 affected districts reported as recently as April 2025, reflecting the removal of seven districts from the Maoist list within six months. The government's stringent operations have led to the | Date: 18.10.2025

killing of 312 Maoists in clashes with security forces this year alone, alongside the apprehension of 836 insurgents. Importantly, 1,639 Maoists have surrendered and re-integrated into society, including toptier members such as a Politburo and a Central Committee member. In a hard-hitting message, Amit Shah appealed to Maoist cadres to abandon violence and uphold the Indian Constitution, reaffirming the government's commitment to offer a peaceful path to rehabilitation. He issued a stark warning to those who reject this overture: security forces will respond with uncompromising force. With a defined deadline just over

five months away, the Union Home Ministry is emphatically pursuing a Maoist-free India, signaling an end to decades-long insurgency and bringing the promise of peace and progress to the affected regions.

Diwali returned marred by deadly road accidents: 12 dead

MI News Service, Uttarak**hand:** In a devastating road accident in Udham Singh Nagar district of Uttarakhand, four workers lost their lives while returning home after the Diwali vacation. The workers, employed by a contractor in the Khatima area, were headed to Sambal in Uttar Pradesh when their vehicle, a pickup van, collided head-on with a tractortrolley on the Khatima-Nankana Sahib road. The impact of the collision was fatal for four workers, who died instantly at the scene. Three others sustained serious injuries and were initially admitted to Khatima Civil Hopsital before being transferred to a better-equipped facility for ad-

vanced medical care. This tragic incident adds to the growing toll of road accidents during the festive season, casting a shadow over Diwali celebrations. In a related and equally grievous incident, eight pilgrims perished in a catastrophic bus accident on Saturday evening in the Chandshali Ghat area of Nandbarbar district, Maharashtra. The pilgrims had been returning from a visit to the Astamba Devi temple when the driver reportedly lost control of the bus, causing it to plunge into a deep ditch and overturn. The force of the crash was severe; many passengers were ejected from the wreckage, and several others remained trapped inside the mangled vehicle. Local police quickly responded to the scene, organizing urgent medical evacuation to Taloda Subdistrict Hospital. The most critically injured were subsequently referred to the district hospital.

which led to this pivotal discussion.The court referred to Section 25 of the Hindu Marriage Act, highlighting that permanent mainte-nance must be adjudicated by thoroughly examining the financial status, income, property, and conduct of the applicant spouse. Furthermore, the bench observed that the petitioner was not contesting the dissolution of the marriage itself but was instead seeking financial security The court maintenance.

India near Maoist-free status: Just 11 district left, target set for march 2026

MI News Service, New Delhi: The Union Home Ministry reports a dramatic decline in Maoist-affected districts across India, plunging from 182 in 2013 to just 11 as of October 2025, signaling a decisive victory in the government's anti-insurgency campaign. Union Home Minister Amit Shah has unequivocally declared the nation will be completely free of Maoist insurgency by March 31, 2026. This pledge follows sustained efforts by the Narendra Modi-led NDA government since 2014 to eradicate leftwing extremism through a combination of security operations and socio-economic development initiatives. According to official data, the Maoist presence has been severely crippled, with only three districts—Bijapur, Sukma, and Narayanpur in Chhattisgarh—remaining Maoist strongholds. These figures underscore a steep decline from the 18 affected districts reported as recently as April 2025, reflecting the removal of seven districts from the Maoist list within six months. The government's stringent operations have led to the killing of 312 Maoists in clashes with security forces this year alone, alongside the apprehension of 836 insurgents. Importantly, 1,639 Maoists have surrendered and re-integrated into society, including top-tier members such as a Politburo and a Central Committee member.In a hard-hitting message, Amit Shah appealed to Maoist cadres to abandon violence and uphold the Indian Constitution, reaffirming the government's commitment to offer a peaceful path to rehabilitation. He issued a stark warning to those who re ject this overture: security forces will respond with uncompromising force.

Researchers unveil new tool that reveals gene behaviour in bacteria



ANGELES Bacterial infections responsible for millions of deaths each year, with the global threat made severe by the increasing resistance of microbes to antibiotic treat-

This is due, in part, to bacteria's capacity to switch genes on and off when they

detect environmental changes, including the presence of drugs.

Such switching is accomplished through transcription, which converts the DNA in genes into its chemical cousin in mRNA, which guides the building of proteins that make up the microbe's structure.

Understanding mRNA production is regulated for each bacterial gene is central to efforts to counter resistance, but approaches used to study this regulation to date have been laborious. According to a new study, scientists revealed a trick that may speed such efforts.

According to the study authors, organisms from bacteria to humans grow as their cells multiply by dividing, with each cell becoming two. Before cells divide, they must copy their DNA such that each of the two daughter cells has a copy. To do so, a molecular machine called DNA polymerase ticks down the DNA chain, reading and making a copy of each gene one

Publishing online Jan. 24 in the journal Nature, the study adds to explanations of how gene expression throughout the genome is shaped by DNA replication

during bacterial growth.

Specifically, the research team found that when DNA polymerase arrives at any specific gene, it disrupts the transcription in a way that reveals the state of that gene's regulatory status.

"Our study results show that the constant replication of genes during the cell cycle as the bacterial cells reproduce and grow can be exploited to learn about many aspects of how genes are regulated," said study lead investigator Andrew Pountain, PhD, a postdoctoral research fellow at NYU Langone Health and its Institute for

Systems Genetics.
"We like the analogy of the electrocardiogram in medicine," said Itai Yanai, the senior investigator of the study and professor at NYU Langone's Institute for Systems Genetics.

By monitoring patterns of electrical activity in the heart, the ECG reveals a series of waves that provide a detailed, graphical view of a patient's cardiac health. Similarly, waves of changes in the abundance of mRNA in response to a gene's replication produce a signature on a graph, which the authors termed the transcriptionreplication interaction profile, or TRIP.

The researchers showed how specific waves can be linked to certain features. For example, whether a gene is under a specific form of control, known as repression, where a protein blocks that gene's mRNA from being made. These repressed genes were found to have characteristic, spiked TRIP patterns.

"Our aim is to understand how gene regulation shapes these TRIPs, with a goal of using them to diagnose gene regulation across the entire set of thousands of genes in the bacterium," added Yanai.

"We hope that our further investigations of gene expression profiles will offer insight into how groups of genes respond to disruptions or changes in their environ-

High blood pressure may increase risk of strokes, finds study

MICHIGAN [US] : A Michigan Medicine study found that high systolic blood pressure (the top number on the blood pressure reading and how hard the heart pumps blood to the arteries) increases the risk of the two most common types of strokes over

The study looked at the average systolic blood pressure years before the first stroke in over 40,000 adults aged 18 and older who had no history of stroke.

Researchers covered three types of stroke: ischemic, a clot that cuts blood supply to the brain and the cause of over 85 per cent of all strokes; intracerebral hemorrhage, a bleed within the brain; and subarachnoid hemorrhage, bleeding between the brain and the tissues that cover it. They found that having a mean systolic blood pressure that is 10-mm Hg higher than average was associated with a 20 per cent higher risk of overall stroke and ischemic stroke, as well as a 31% greater risk of intracerebral hemorrhage.

"Our results suggest that early diagnosis and sustained control of high blood pressure over the lifespan are critical to preventing



stroke, ischemic stroke and intracerebral hemorrhage, especially in Black and Hispanic patients who are more likely to have uncontrolled hypertension than white patients," said senior author Deborah A. Levine, M.D., M.P.H., professor of internal medicine and neurology at University of Michigan Medical School.

Black patients had a 20 per cent higher risk of ischemic stroke and a 67 per cent higher risk of intracerebral hemorrhage than white patients. Hispanic patients had a 281% higher risk of subarachnoid hemorrhage, but not any other stroke type, compared to white patients. While Black and Hispanic patients had a higher risk of stroke, researchers found little evidence to suggest that race and ethnicity affected the association between cumulative systolic blood pressure and the type of stroke that affected any

"Examining racial inequities advances our understanding of the social, economic and political

among racial and ethnic minority groups," said Kimson E. Johnson, Ph.D., M.A., M.S.W., first author and postdoctoral research fellow at the University of Michigan. While systolic blood pressure is a modifiable target for preventing stroke and other cardiovascular diseases, a national study conducted in 2020 found that blood pressure control in the United States worsened from 2013 to 2018, especially for Black and Hispanic adults. Self-monitoring of blood pressure improves blood pressure diagnosis and control and is accurate and cost-effective, but it remains an underused tool, Levine says.

"Two major barriers to selfmonitoring of blood pressure are lack of patient education and insurance not covering the home blood pressure monitors, which cost \$50 or more," she said.

"Health care systems and providers must educate and urge their patients to do home blood pressure monitoring, and insurers must pay for home blood pressure monitors to optimize people's blood pressure and reduce their chances of having a stroke.'

Study assesses therapeutic strategies for severe obesity in adolescents



Illinois [US]: According to a study, adolescents with severe obesity who got both meal-replacement therapy and financial incentives had a higher reduction in body mass index compared to those who just received meal-replacement therapy. The finding was published in JAMA Pediatrics. Justin Ryder, PhD, Vice Chair of Research for the Department of Surgery at Ann & Robert H. Lurie Children's Hospital of Chicago and Associate Professor of Surgery and Pediatrics at Northwestern University Feinberg School of Medicine, was a co-author of the study.

Severe obesity currently affects about one in five children and adolescents in the U.S., according to the Centers for Disease Control and Prevention, and is defined as having a body mass index, or BMI, either at or above the 95th percentile for age and sex. The condition is associated with an increased risk of adult obesity, cardiovascular disease, type 2 diabetes and other conditions.

Previous research has found that meal replacement therapy (MRT), rather than traditional lifestyle modifications, is more effective in helping reduce BMI in adolescents with severe obesity. In the current study, the investigators sought to determine if MRT paired with financial incentives to adolescents with severe obesity would increase the efficacy of MRT and lead to a greater reduction in BMI, when compared to MRT alone. "There's literature for adults that supports that tying in financial incentives to weight loss or physical activity programs increases adherence.

incentives behavioural/nutrition weight loss program using meal replacement therapy would adherence increase through adherence, increase the efficacy of the treatment. Dr Ryder said. Of the 126 adolescents enrolled in the study, 63 participants received MRT plus financial incentives and 63 participants received only MRT for one year. MRT included preportioned meals totalling 1,200 calories per day, and financial incentives were provided based on reduction in body weight from baseline. Research explores secrets of lipid synthesis inside cells

LOS ANGELES [US] : South Korean researchers at the IBS Spectroscopy and Dynamics (IBS CMSD) have made a useful discovconcerning microscopy.

The team has successfully

developed Two-Color Infrared Photothermal Microscopy (2C-IPM), a unique method for studying neutral lipids within lipid droplets of living cells.

This new microscopy can be combined with isotope labelling, which allows thorough monitoring of neutral lipid synthesis within individual lipid droplets. Lipid droplets (LDs) are struc-


tures made up of pockets of neutral lipids (triglycerides) enclosed in a monolayer of phospholipids. They have long been regarded

as uninteresting organelles whose sole function is to store excess energy in the form of neutral

However, recent studies indicate these droplets actually are dynamic players in various cellular metabolic activities.

It was found they are actively involved in regulating lipid toxicity and cell communication, as well as their correlation with prevalent diseases like obesity and nonalcoholic fatty liver disease.

Understanding the functions of LDs is thus imperative for the



diagnosis and treatment of these conditions.

Researchers have traditionally stained the cells with lipophilic dyes and employed fluorescence microscopy to study LDs within cells. However, this method has several significant limitations. First is photobleaching of the dyes, which restricts the observation duration of the LDs to very short time windows. Another limitation is the fluorescent dyes themselves. The currently used fluorescent dyes simply target the hydrophobic environment within LDs, utilizing unspecified binding incapable of accurately analyzing the composition and quantity of

Unlike previous methods that relied on fluorescent microscopy, the new 2C-IPM technology uses an infrared (IR) spectroscopic method and does not require the use of fluorescent dyes. The new method monitors neutral lipids within LDs directly by detecting changes in IR absorbance. Importantly, this advantage allows researchers to observe the synthesis of neutral lipids within individual LDs in living cells over a long period. Employing the newly

Hypertension guidelines do not include potassium-enriched salt: Study

NEW SOUTH WALES [AUSTRALIA]: An international panel of experts published a suggestion in the scientific journal Hypertension published by the American Heart Association, calling for the inclusion of low-sodium potassium-enriched salt in hypertension therapy guidelines.

High levels of sodium intake and low levels of potassium intake are wide-spread, and both are linked to high blood pressure (hypertension) and a greater risk of stroke, heart disease and premature death. Using a salt substitute where part of the sodium chloride is replaced with potassium chloride addresses both problems at once. Professor Alta Schutte at The George

Institute for Global Health and UNSW Sydney said that despite data from randomised controlled trials demonstrating the health benefits of potassium-enriched, sodium-reduced salt substitutes, they are rarely used.

We found current clinical guidelines offer incomplete and inconsistent recommendations about the use of these salt substitutes," she said.

"Given the wealth of evidence available, we feel it's time to include salt substitutes in treatment guidelines to help address spiralling rates of uncontrolled high blood pressure around the world and reduce preventable deaths.

Potassium-enriched salt can be used as a direct replacement for regular salt (sodium chloride) when seasoning, preserving or manufacturing Importantly, while other salt reduction strategies make foods taste less salty, switching to potassium-enriched salt is

undetectable by most people. "Unwanted taste effects are the main reason why efforts to reduce salt intake have failed for more than two decades. The willingness of patients to keep using potassiumenriched salt removes that barrier, which is why it can be a game-changer," Prof Schutte added. A global collaboration of researchers from the US, Australia, Japan, South Africa and India reviewed 32 separate hypertension treatment guidelines - two from global organisations, five from regional organisations and 25 from country organisations - published between 1 January 2013 and 21 June 2023. They found all guidelines referred to sodium reduction, with most recommending reducing salt intake.



Many also recommended increasing dietary potassium intake, but only two the Chinese and European guidelines made a specific recommendation for using potassium-enriched salt.

Dr Tom Frieden, President and CEO of Resolve to Save Lives, a global public health organisation focused on preventing 100 million deaths from cardiovascular disease, said that the number of people living with hypertension had doubled in the past 30 years to about 1.3 billion. "High blood pressure kills more than ten million people every year - almost 20 people every minute. Twenty percent of these deaths can be linked to a single cul-prit: eating too much salt," he said. Based on the evidence, there is little doubt that most patients with hypertension and their families should reduce their overall salt intake and, when choosing to consume salt, should switch from regular salt to potassium-enriched salt. This will help reduce blood pressure and protect against serious complications such as stroke and premature death.'

Dr Frieden emphasized the shift required to our food environment. "As a society, we must prioritize availability and accessibility of low-sodium, potassium-enriched salts - at home, in restaurants, and in grocery stores. These products should not be marketed or priced as a luxury. Low-sodium, potassium-enriched salt can become the new default." Another barrier to uptake has

been concerns about causing elevated levels of potassium in the blood (hyperkalaemia) in people with advanced kidney disease.

Professor Bruce Neal, Executive
Director at The George Institute
Australia and Professor of Clinical Epidemiology at Imperial College London, said it is clear that patients with advanced kidney disease should not use potassium-enriched salts, but this applies to a very small proportion of the population, and these patients are already recommended to avoid salt

"No issues with serious harm from hyperkalaemia were recorded in any of the trials to date, though all were done in clinical settings. Our recommendation for use in hypertension is based on patients being managed by a healthcare worker. Healthcare workers know not to recommend potassium-enriched salt in the presence of kidney disease and risks for these patients can be avoided.'

The authors argued that given potassium-enriched salt is one of the few dietary interventions patients comply with long-term, it is logical to at least consider the use of potassium-enriched salt for all those with hypertension.

"We strongly encourage clinical guideline bodies to review their recommendations about the use of potassiumenriched salt substitutes at the earliest opportunity - if the world switched from using regular salt to potassium-enriched it would prevent millions of strokes and heart attacks every year at very low cost," added Prof Schutte.

Fragile Ceasefire reached between Pakistan and Afghanistan



MI News Service, Kabul: clashes along their shared border, Pakistan and Afghanistan have agreed once again to a ceasefire, signaling a fragile attempt at restoring peace amid deep-rooted mistrust. The announcement came from the Qatari Foreign Ministry following high-level talks held in Doha, mediated by Qatar and Turkey. The conflict, which has resulted in the deaths of at least 15-20 civilians and injured hundreds, erupted despite a previous 48-hour truce last Friday, which was reportedly violated by Pakistan.

During Saturday's dialogue, defense ministers from both nations met to address the ongoing violence. Pakistan pledged to curb terrorism along the border and commit to stabilizing the region, while Afghan representatives staunchly denied allegations of harboring militants who allegedly target Pakistani territory. Both nations accused each other of initiating hostilities, underscor-ing the deep-seated animosity and reciprocal accusations that have long characterized their fraught relationship. The mediators emphasized the urgency of peace, warning that sus-

ploit regional instability to regain strength. The ceasefire's sincerity faces an early test after Pakistan's recent airstrike Paktika Afghanistan's province resulted in the deaths of eight individuals, including three Afghan cricketers-Kabir, Haroon, and Shibghatullah—who were traveling to a match. In protest, the Afghanistan Cricket Board has withdrawn its team from the trination series involving Pakistan and Sri Lanka, prioritizing national sovereignty over sports diplomacy. JAMSHEDPUR: Jharkhand registered a commanding victory over Goa, winning by an innings and 113 runs in their Col CK Naidu Trophy encounter at the Keenan Stadium. The hosts delivered a complete all-round performance to outclass the visitors in every department.

Batting first, Goa was bundled out for 183 runs in their opening innings. Veer Yadav top-scored with 28, while Chittem DevanKumar contributed 21. Jharkhand's bowling attack was led by Shubh Sharma, who claimed 4 wickets for just 23 runs, ably supported by Shamshad with 3 for 49. Jharkhand responded with a dominant batting display, piling up a mammoth 552 for 8 declared. Bisesh Dutta starred with a magnificent 168-run knock, while Kounain (79), Satya Setu (75), Robin Minz (75), and Abhishek (53 not out) all made valuable contributions. For Goa, Anuj bowled tirelessly to finish

with figures of 6 for 118. Facing a daunting deficit, Goa showed some resistance in their second innings but were eventually dismissed for 256. Messi wins 2025 MLS Golden Boot

NASHVILLE: Inter Miami CF superstar Lionel Messi has won the 2025 MLS Golden Boot, netting 29 goals to become the league's leading scorer in his second full season with the Herons.

Messi contributed 19 assists as he outperformed LAFC's Denis Bouanga (24 goals) and Nashville SC's Sam Surridge (24 goals). He becomes Miami's first-ever Golden Boot winner and the first Argentine to claim the award since Valentín "Taty" Castellanos did so with New York City FC in 2021. The Argentine great tallied three goals and provided an assist during Saturday's 5-2 Decision Day victory in Nashville, reaching 48 goal contributions (29 goals, 19 assists) this season - just short of Carlos Vela's MLS record 49 for LAFC in 2019.

Now, Messi appears set to become the league's first-ever player to win consecutive MVP awards, following a historic 2024 campaign that saw Miami claim that year's Supporters' Shield in record-breaking fashion. Messi and Miami are the Eastern Conference No. 3 seed in the MLS Cup Playoffs, where they'll face No. 6 Nashville in a Round One Best-of-3 Series. This year's MLS Cup champion will be crowned on December 6. Messi, the most decorated footballer of all time, now adds the MLS Golden Boot to his unparalleled CV. He is the latest in an exclusive list of players to secure the honour since the league's inaugural season in 1996. From 1996 to 2004, the MLS Golden Boot was awarded based on a points system that gave two points for a goal and one for an assist, before switching to solely counting goals.

Earlier this week, Messi became the player with the most assists in men's international football after setting up two goals in Argentina's 6-0 thrashing of Puerto Rico in an international friendly at Chase Stadium. His pair of assists took his international tally to 60, surpassing Neymar and Landon Donovan, who each have 58. With this achievement, Messi is now just three assists short of 400 across his professional career.

BWF World Jr C'ships: Tanvi Sharma takes silver, loses to Phichitpreechasak in final



GUWAHATI: Tanvi Sharma's sensational run at the BWF World Junior Championships ended with a silver medal in the girls' singles event here on Sunday. The top-seeded Indian lost to Thailand's second-seeded Anyapat Phichitpreechasak 15-7, 15-12 in the summit clash, which lasted 28 minutes. Tanvi became the fifth Indian and the third female shuttler to win a silver medal at the Junior World Championships. Her loss in Sunday's final means Olympic medallist Saina Nehwal remains the only Indian to win gold at the championship, with her title triumph coming in 2008

Besides Tanvi and Saina, who also won a silver medal in 2006, Aparna Popat (1996), Siril Verma (silver medallist in 2015) and Sankar Muthusamy (silver medallist in 2022) are the other three Indians who have won medals in the tournament.

Tanvi made a cautious start in the opening game against Anyapat, struggling to counter the Thai shuttler's clever drop shots and committing several unforced errors to trail 8-5 at the interval. Anyapat capitalised on the advantage and claimed the opening game with ease.

Leylah Fernandez lifts fifth career title with Japan Open win



The victory marked Fernandez's fifth career title and her second of 2025. All five of her career titles have been won on hard courts.

Her run in Osaka, which included five consecutive wins, was only the second time since her victory in Washington, D.C., in July that she won back-to-back matches.

With the win, Fernandez climbed five spots to No. 22 in the WTA Live Rankings and reclaimed the Canadian No. 1 ranking from Victoria Mboko, WTA reports.

Fernandez started the match confidently, taking less than 30 minutes to race through the first set and bagel the young Czech. Valentova looked emotional during the changeover after falling behind 5-0, perhaps feeling the pressure of what was arguably the most significant moment of her career so far. However, she regrouped and played more freely in the second set, breaking

In the third set, Fernandez's previous experience proved crucial to the current match. Leading 2-1, she pounced on Valentova's second serve on break point, unleashing a crosscourt backhand followed by a down-the-line backhand winner to secure the break

Valentova responded with another break to narrow the score to 4-3 and secured several additional break points during the third set, but Fernandez held firm for the rest of the match and ultimately sealed the win.

Meanwhile, Taylor Townsend and Kristina Mladenovic won the women's doubles trophy on Saturday, beating Stom Hunter and Desirae Krawczyk for their first title as a team.

For Townsend, a two-time Grand Slam champion and current world No. 2, it is her 11th career WTA doubles title and her fourth of the season

Aishwarya Pissay wins silver in the 2025 World Rally-Raid Championship

The Rallye du Maroc is regarded as

one of the world's toughest cross-country rallies and the ultimate test, before Dakar, featuring over 2,299 km of racing, including 1,478 km of special stages through Morocco's unforgiving terrain of dunes, rocky pistes, and com-

plex navigation. Competing in the Rally2 class, Aishwarya battled challenging conditions, high temperatures, and technical terrain to emerge victorious in her category. "Morocco tested everything - skill, endurance, and spirit. To finish this rally and secure a World Championship silver means everything to me. It's been years of hard work, sacrifice, and belief. I'm proud to carry India and Asia on this global stage," said Aishwarya Pissay. With this result, Aishwarya cements her position as India's most successful female racer and one of Asia's leading motorsport athletes, with four FIM World Titles and eleven National Championships to her name. Her success at Rallye du Maroc also highlights her growing dominance on the world rally-raid stage as she continues her journey toward Dakar 2026. Competing as a privateer with strong sponsorship support from TVS Racing and her partners, Aishwarya demonstrated exceptional consistency and professionalism throughout the season - a testament to her determination and the strength of India's emerging motorsport talent.

Spinner Nasum Ahmed added to Bangladesh squad for West Indies ODIs

DHAKA: The Bangladesh Cricket Board (BCB) announced on Sunday that left-arm spinner Nasum Ahmed has been added to the ODI squad for the ongoing three-match series against the West Indies. The inclusion of the 30-year-old reflects the team management's effort to strengthen their spin department following a spin-dominated first ODI

Nasum, who last featured in an ODI in December 2024, has played 18 matches in the format, claiming 16 wickets at an economy rate of 4.48. His recall is likely a tactical decision, prompted by the spin-friendly conditions witnessed in the series opener at the Sher-e-Bangla National Cricket Stadium (SBNCS) in Mirpur.

On a sluggish, turning pitch in the first ODI on Saturday, spinners from both sides made a significant impact. For the West Indies, left-arm spinner Khary Pierre impressed with a miserly spell of 1 for 19 from his 10 overs, while off-spinner Roston Chase also chipped in with two



crucial wickets. However, it was Bangladesh's spin attack that stole the show. Leg-spinner Rishad Hossain and left-arm orthodox Tanvir Islam shared eight wickets between them, playing pivotal roles in securing a comfortable victory for the

With Bangladesh now leading the series 1-0, the addition of Nasum Ahmed provides further variety and depth to the spin arsenal. The second and third ODIs are scheduled to be held at the same venue on October 21 and 23, where spin is once again expected to play a decisive role.
