INDIA upgrades tech mission in Kabul to full-fledged embassy

MI News Service, New Delhi: India on Tuesday announced upgrading its technical mission in Kabul to the status of an embassy as part of broader efforts to deepen its bilateral engagement with Kabul. The announcement came over a weekand-a-half after External Affairs Minister S Jais-hankar said during his meeting with Afghan counterpart Amir Khan Muttaqi that India will upgrade its diplomatic presence in Kabul. India had withdrawn its officials from its embassy in Kabul after the Taliban seized power in August 2021. In June 2022, India re-established its diplomatic presence in the Afghan capital by deploying a "technical team". The Ministry of External Affairs (MEA) said the Indian embassy in Kabul will further augment India's contribution to Afghanistan's comprehensive development, humanitarian assistance, and capacity-building ini-

"In keeping with the decision announced during the recent visit of the Afghan foreign minister to India, the government is restoring the status of the technical mission of India in Kabul to that of the Embassy of India in Afghanistan with immediate effect," it said. The MEA said the decision underscores India's resolve to deepen its bilateral engagement with the Afghan side in "all spheres of mu-tual interest". "The Embassy of India in Kabul will further augment India's contribution to Afghanistan's comprehensive development, humanitarian assistance, and capacity-building initiatives, in keeping with the priorities and aspirations of Afghan society," it said in a statement. The mission will be headed by a diplomat in the rank of Charge d'affaires, it is learnt. Muttaqi was in India this month for six days that signalled a new approach in New Delhi's ties with Kabul though it has not yet recognised the Taliban set up. The foreign minister of the Taliban set-up had said Afghanistan will not allow any elements to use its territory against New Delhi's interests. Muttaqi told a select group of journalists that Kabul will also send diplomats to India as part of step-by-step efforts to improve the bilateral ties. "We will not allow any (element) to threaten anyone else or use the territory of Afghanistan against others. Daesh is a challenge for the region and Afghanistan is at the frontlines of this struggle, he had said.

Centre blocks MGNREGA funds

Bengal govt mulls alternative employment

MI News Service, Kolkata: The Bengal government has begun the process to provide alternative employment to migrant workers and their families under schemes similar to the MGNREGA (100-day work). The move follows reports of torture of Bengali-speaking migrants in BJP-ruled states as well as the Mamata Banerjee government's urgency to create jobs in the rural heartland with the Centre freezing funds for jobs under the MGNREGA for over three years.

Recently, the state panchayat and rural development department issued instructions through the district magistrates to the MGNREGA offices in all the districts to register migrant workers and their family members for job cards. Upon issuance of these cards, the state plans to offer alternative employment for 14 days to one month under schemes like Karmashree and Shramashree run by the Mamata Banerjee government. A preliminary list which the department has prepared shows that around 57,000 such prospective beneficiaries have been identified across the state, and among them, nearly 30,000 are from north Bengal districts. "We are already providing alternative work under the 100-day

work framework. A new list of names has reached us for enrollShramashree schemes. We are currently verifying the details," said Shama Parveen, the district magistrate of Jalpaiguri. During the Covid-19 pandemic, migrant workers who returned from other states were offered employment under the 100day work scheme across districts.

However, as the Centre halted funding for the scheme in Bengal, citing alleged irregularities, many workers had to go to other states for employment. In due course, the Trinamool government introduced its own alternative employment initiatives, providing work through varidepartmental construction projects to individuals holding valid job cards. "Now, the focus has shifted to verifying and consolidating existing records of migrant workers between the MGNREGS offices and the data received from the state labour department. The idea is to offer jobs to these workers as well as to their family members," said a source. "The workers who do not have job cards are to be issued new ones. The verification process of the names has begun, although it remains unclear how many migrant workers would be willing, or able, to return home to avail this short-term employment in Bengal. A section of them who have stayed back, however, would benefit from the scheme," the source added. The apprehension seems to be correct as Nazimul Haque, a migrant worker from Berubari in Jalpaiguri who is currently employed in Kerala, said it is unlikely that the workers would return home.

"I earn around ₹800 a day here (Kerala). Why would I return to my district for a few days of low-wage work? However, it makes some sense if the state offers jobs to my family members, as our family income would increase then," Haque

MI News Service, Patna: The Rashtriya Janata Dal released a list of 143 candidates for the 243-member Bihar Assembly, signalling what party insiders said was a "no compromise" stand on its share and choice of seats. Although the list left out

Kutumba, where the Congress has fielded its state president Rajesh Ram, it named candidates for at least five seats that the Grand Old Party too had claimed, setting up "friendly fights". These seats are Hajipur, Lalganj, Kahalgaon, Narkatiaganj and Sikandra (Scheduled Caste). The RJD also named candidates for two constituencies — Tarapur and Gaura Boram where junior ally Vikassheel Insaan Party had already fielded nominees. This apart, Mahagathbandhan partners Congress and CPI are both in the fray in Bachhwara, Rajapakar and Rosera. Five of the 10 seats facing "friendly fights" go to the polls in the first phase, on November 6. On Monday, the last date for withdrawal of nominations, there was no clarity on whether any partner had pulled out any candidate to avoid a "friendly fight".

Nominations can be withdrawn till November 6 for the second phase of polling on November 11, so there's time left to break the deadlock on the remaining five seats. "The Congress will have to withdraw its candidates because our leaders are in no mood to relent. Talks are on but there seems to be very little progress," an RJD leader said. RJD sources said their list — released on the last day for withdrawals for the first phase — represented the full complement

of seats the party intended to contest. They said there would be "no compromise' on either the tally or the choice of constituencies. In the 2020 Assembly elections, the RJD had contested 144 seats. The Congress released its third list of six candidates on Monday, taking its total to 61. The CPIML Liberation, the principal Left party in the alliance, has already declared 20 candidates, with no disputes reported relating to these seats. The total seats being contested by these three parties comes to 219, since 5 seats are common to the RJD and the Congress. This leaves 24 seats to be shared among Vikassheel, the CPI and the CPM — provided the Congress does not

The RJD's decision not to contest from the reserved (Scheduled Caste) Kutumba seat is being seen as an effort to avoid a direct clash with its oldest ally. However, the party's move of fielding candidates from several seats claimed by the Congress reflects its overarching desire to retain its preeminent position within the alliance. RJD chief Lalu Prasad and son Tejashwi Yadav have remained confined to their homes in Patna for the past couple of days, avoiding any public interaction.

Union food processing minister and Lok Janshakti Party (Ram Vilas) chief Chirag Paswan on Mondav taunted the Opposition alliance over the looming "friendly fights". "I am a keen observer of politics but where such a big alliance is on the verge of a split. There can be a dispute over the choice of seats, but they have not been able to even decide the number of seats," Chirag said. "There is nothing called a 'friendly fight'. Either you are friends or you are fighting against each other... The Mahagathbandhan will pay a big price for this. The NDA was progressing strongly, and now the Mahagathbandhan has given us a walkover on many seats that appeared challenging." In a minor relief for the Opposition bloc, the Jharkhand Mukti Morcha has withdrawn from the Bihar

JAPAN elects its first female Prime Minister

parliament elected ultraconservative Sanae Takaichi as the country's first female prime minister Tuesday, a day after her struggling party struck a coalition deal with a new partner expected to pull her governing bloc further to the right. Takaichi replaces Shigeru Ishiba, ending a three-month political vacuum and wrangling since Liberal Democratic Party's disastrous election loss in July. Ishiba, who lasted only one year as prime minister, resigned with his Cabinet earlier in

his successor. Takaichi won 237 votes — four more than a majority — compared to 149 won by Yoshikoko Noda, head of the largest opposition party, the Constitutional Democratic Party of Japan, in the lower house, which elects the prime minister. As the results were announced, Takaichi stood up and bowed deeply. The LDP's alliance with the Osaka-based rightwing Japan Innovation Party, or Ishin no Kai, ensured her premiership because the opposition is not united. Takaichi's untested alliance is still short of a majority in both houses of parliament and will need to court other opposition groups to pass any legislation — a risk that could

KALI PUJO IMMERSION: Cuttack mobilises 64 platoons & Anti-Terror units

Cuttack has been placed on high alert ahead of Diwali and Kali Puja, with the immersion procession of Goddess Kali scheduled for October 24. Around 64 platoons of police, along with 800 auxiliary police personnel (APR) and anti-terror squads, have been deployed across the city to ensure a peaceful celebration. "The 1,000-year-old city is known for its bhaichara (brotherhood) and communal harmony. Whatever happened is a thing of the past. We are hopeful that nothing will go wrong," said Cuttack mayor Subhas Singh. The heightmunal violence that broke out during Durga Puja immersion last month, when clashes between the police and Vishwa Hindu Parishad (VHP) activists left several shops torched and a dozen police personnel, including Rishikesh Khilari Dnyandeo, injured. The city had been under curfew for 36 hours and internet services were suspended. DCP Dnyandeo told The Telegraph that the administration is taking no chances this time. "More than 300 officers, 64 platoons of police, 800 APR personnel and anti-terrorist squads have control and law enforcehave also strengthened our intelligence network," he said. He confirmed that the immersion route will remain the same as during Durga Puja but with tighter surveillance and additional deployment. "We have intensified patrolling and stressed on strategic deployment. We appeal to citizens to cooperate and ensure nothing goes wrong," he added. Over the past 24 hours, the police executed four non-bailable warrants, checked 522 vehicles and collected ₹5.66 lakh in fines.

24 DEATHS: India must do more to stop toxic cough syrup sales, says **WHO**

has more work to do in halting sales of toxic cough syrup, despite some progress, a World Health Organization official told Reuters, after at least 24 children died following consumption of a domestically-made medicine. The children died after taking the Coldrif cough medicine made by Sresan Pharma, which tests showed contained the toxin diethylene glycol in quan tities nearly 500 times the permissible limit.

They came just two years after global pledges to tighten the system following the deaths of at least 300 children around the world linked to similar toxins in syrupbased medicines made in India and Indonesia. But enforcement issues persist, the WHO said. "They have made some strides," said the official, Rutendo Kuwana, referring to a new Indian rule requiring medicine to be tested for contaminants



like diethylene and ethylene glycol before export.

However, no such rule exists for syrups sold locally - a "regulatory gap" the WHO has flagged. "It's a work in progress," added Kuwana, the WHO team lead for incidents involving substandard and falsified medicines. "There's a lot that needs to be done. It's a big

Last week Reuters reported that India plans to scrap its export rule once companies upgrade their facilities to international standards by a year-end deadline. India's health ministry and the Central Drugs Standard Control Organisation (CDSCO), the

to repeated telephone calls. A WHO spokesperson said by email on Monday the agency welcomed all steps to improve medicine quality.

However, in response to a question about dropping the export tests, the spokesperson said medicines, including raw materials, should be tested throughout the production process, not just at the end. By law, Indian drugmakers must test each batch of raw materials and the final product, but CDSCO said in October some firms had not been doing this. Kuwana

Kerala accepts Centre's **PM SHRI** scheme funds

MI News Service, Kochi: The Kerala government has decided to join hands with the BJP at the Centre to avail its share of ₹1,500 crore under the PM SHRI education programme after months of dilly-dallying and right before the state elections in the summer of

The CPI, the second largest ally in the Left Democratic Front government, and the Opposition United Democratic Front have strongly opposed PM SHRI, fearing it could lead to the implementation of the National Education Policy in Kerala. Early this year, the government had state claimed that it would not sign the MoU on PM SHRI as it entails implementing multiple recommendations endorsed by the NEP, introduced by the Modi governChief minister Pinarayi

Vijayan had said the NEP poses a threat to the country. It was twice taken up for discussion in the state cabinet. But owing to opposition from the CPI, the idea was dropped. But on Monday, general education minister V. Sivankutty said: "Why should the education department not accept the Centre's funds when the health and agriculture departments had already claimed their assistance? Sources in the education department said Kerala was facing a financial crunch in the fag end of the Pinarayi-led second LDF government's term, and any amount coming from central grants is acceptable as it would help them to undertake development activities in the school sector.

Political heat in Bhanghar Clash over firecrackers turns violent



MI News Service, Bhangarh: Political tensions flared into violent confrontation late Monday in Bhangarh's Bhogali Gram Pamchayat area, as TMC and ISF worker clashed over the bursting of firecrackersan incident that quickly escalated into streets battles, counter-allegations, and arrests on both sides.

Local sources and police report that the chaos begun in Bhumru village, where TMC activists Rabbani Mollah, Sabir Mollah, Nawab Mollah, and Shahid Mollah were reportedly celebrating by bursting firecrackers. ISF supporters, however, claimed that actual bombs were thrown, not just firecrackers—a charge that sharply raised tempers and triggered a heated verbal exchange between the rival fac-

tions. The dispute soon devolved into physical violence. Both groups accused each other of brutal beatings, with Trinamool alleging that ISF members attacked their workers with iron rods, resulting in head injuries. ISF leadership dismissed the accusation as fabricated, countering that their own supporters were targeted and assaulted by Trinamool's so-called Ghasful camp. Canning East MLA Sawkat Mollah weighed in, claiming, "The entire incident was orchestrated in advance by anti-social elements sheltered by the ISF, targeting our party workers." As tensions spiraled, a significant police force from Uttar Kashipur police station was deployed to Bhumru village late at night. Police intervened to prevent further escalation and began questioning residents and party members from both sides. Two individuals were taken into custody as police launched a formal investigation. Regional authorities remain on high alert, with law enforcement monitoring the area amid ongoing volatility. The pre-election climate has heightened anxieties across Bhangarh, raising fears of further political violence in the months

Superstition turns deadly: Witchcraft allegation triggers brutal murder

Purulia: In a chilling reminder of deep-rooted superstition and mob violence, a 37-year-old woman was dragged out of her home and hacked to death on suspicion of witchcraft in Chapuri village under Para Police Station in Purulia on Monday night. The victim, Padavi Tudu, was struck on the head with a sword allegedly wielded by her sister- in- law Jaleshwari Tudu after being accused of practising witchcraft. Witnesses said blood-curdling cries tore through the night as armed family members and neighbours stormed into the courtyard and assaulted her mercilessly.Padavi's husband, Subhash Tudu, recounted the horrifying sequence. "They came accusing my wife of be-

lage meeting if there were any doubts, but no one listened. They struck her on the head with a sword. She collapsed instantly," he said. The victim was rushed to Para Primary Health Centre, where doctors declared her dead on arrival. Blood stains and signs of struggle were still visible at the site on Tuesday morning. Local police arrested six individuals, including the primary accused Jaleshwari Tudu, who was later produced before the Raghunathpur Sub-Divisional Court. Police sources confirmed that Jaleshwari initially showed no remorse and denied witchcraft as the motive, claiming, "There was a fight; I hit her with a rod, not because of witchcraft." Investigators, however, maintain that superstition and long-standing tension between Everyone carried weapons. I pleaded with them to hold a vil- to the killing. Condemning the

incident, Dr. Nayan Mukherjee of the District Science Forum said, "This is a shameful act for our society. Despite years of awareness campaigns, these witch-hunt killings persist. We urge the administration to ensure exemplary punishment for those responsible."Padavi's husband has called for the harshest possible sentence, demanding that the killers face the gallows. "They took my wife's life in the name of blind belief. They should be hanged," he said, his voice breaking. The brutal attack has once again exposed the dangerous mix of superstition and violence that continues to claim lives in rural Bengal, despite decades of legal prohibitions and awareness drives. Police have tightened security in Chapuri as investigations continue, fearing possible re-taliation or unrest in the area.

Sonarpur: A gruesome murder in Sonarpur has stunned the state—a four- year- old girl allegedly killed by her own grandfather inside their home in the Kadamtala area of Kodalia. The chilling incident, which police describe as "rare and horrifying," has raised grave questions about mental instability, motive, and the depths of human depravity. According to investigators, the child's screams pierced through the neighborhood Sunday evening. When locals rushed inside, they discovered the girl lying motionless in a pool of blood. She was immediately taken to a nearby hospital, where doctors pronounced her dead on arrival. The scene inside the house was one of unimaginable brutality.

The child's grandfather was arrested on Monday, and during interrogation, he confessed to the murder. However, the motive remains shrouded in uncertainty. Police are examining whether the act stemmed from a perverse impulse, deep-seated rage, or psychological breakdown. "This appears to be an extreme case of aberrant behavior. Such incidents are exceptionally rare and deeply disturbing," said a senior officer said a senior officer of Sonarpur Police Station. According to interrogation details, the accused claimed he killed the girl because she

days." Taking advantage of a quiet moment while the child slept, he allegedly took a kitchen knife and attacked her repeatedly. Investiga-tors, however, suspect underlying mental illness or emotional instability drove the act. "We are seeking medical reports to confirm his mental condition," a police source said. The tragedy has shattered the family and shaken the community. The girl's mother collapsed after the incident and remains under treatment, while her father is away in Mominpur. The grandmother and a domestic help have been detained for questioning. Police are also probing whether anyone else in the household had prior knowledge of the crime or ignored warning signs of the accused's instability. Residents of Kadamtala described the accused as a volatile, irritable man who often shouted at children. "No child in the lane went near him. He kept his granddaughter locked indoors most of the time," said a neighbor. The accused reportedly developed respiratory issues during questioning and has been admitted to Baruipur Hospital under police watch. As Sonarpur reels from the horror, investigators face a chilling question: was this a crime born of rage, illness, or something even darker.

Son arrested for killing father in Drunken attack

Bardhman: A shocking case of domestic violence turned fatal in East Bardhaman's Khandaghosh area when a 26-year-old man allegedly beat his father to death with a bamboo stick studded with nails. The accused, Pradeep Roy, was arrested early Monday by Khandag-hosh Police on charges of brutal patricide. The victim, Bipattaran Roy, 50, suffered severe head and body injuries after being reportedly attacked by his son inside their home at Raipara, Sagrai. According to locals, Pradeep returned home drunk around 6 p.m. on Sunday and began assaulting his father without prov-

This wasn't the first such incident—residents the accused had frequently beaten both parents during drunken rages for months. During the latest outburst, Pradeep allegedly picked up a bamboo pole fitted with nails and struck his father repeatedly until he collapsed in a pool of blood. Neighbours rushed in after hearing desperate cries and found Bipattaran grievously injured. He was first taken to Khandaghosh Block Primary Health Centre, then shifted to Burdwan Medical College Hospital, where doctors declared him dead around 1 a.m. The brutality has sent shockwaves through the quiet village community. Bipattaran's wife, who was away during the attack, returned home to find her husband lifeless on the floor. In tears, she demanded the harshpossible punishment for her own son. "He killed his father in cold blood. He should be hanged," she said, her grief mingled with fury. Neighbours echoed her sentiment, describing Pradeep as short-tempered and violent, with a history of abusing both his parents and wife. Locals revealed that his wife had recently left home with their young child due to constant torture. Police have launched a full investigation into the incident. "The accused has been arrested and is being interrogated. We are verifying prior complaints from the family and the locality," said a senior officer from the Knandagnosh Police Station. The gruesome killing has once again underscored the growing frequency of alcohol- fueled domestic assaults in rural Bengal—acts that now blur the line between familial conflict and outright barbarism.

Youth held for alleged Kidnapping of two minors

Dinajpur: Panic gripped South Dinajpur's Nazirpur area after a man alleged-ly tried to lure and kidnap two minors on a motorbike under the pretext of asking for directions to a relative's house. The dramatic incident unfolded on Monday afternoon in Kashipur village, under the Patiram Police Station limits, and led to a swift rescue operation by police within an hour.

According to official sources, the accused, Suman Mahato of Kundu Colony in Balurghat, approached two children— 10 and 11—who were fishing near Boyrakuri Jora Bridge. Claiming he was lost, Suman requested their help to locate a relative's home in a nearby village. When the unsuspecting minors agreed, he allegedly persuaded them to get on his bike. Moments later, villagers noticed the scene and grew suspicious. As the rider sped away with the children, panic erupted. Word of a possible kidnapping spread quickly, and within minutes, locals mobilized, raising an alarm and alerting police. Officers from Patiram Police Station, led by DSP (VHQ) Vikram Prasad and OC Satkar Sangbo, coordinated with personnel from Balurghat and Hili stations to track the suspect. After an intense 55-minute search, police intercepted

the bike in Kashipur and



rescued both children unharmed. The accused was immediately arrested and taken into custody. As enraged residents attempted to beat him, forces had to step in to prevent mob assault. Police later said initial questioning sug-gests Suman's explanation of "asking for directions" was dubious, and the veracity of his statement is under investigation. The rescued minors, students of Class V and VI at a local school, are safe and reunited with their families. Their emotional parents thanked police for their swift response, which likely prevented a potential tragedy. Authorities have launched a detailed probe to determine whether Suman acted alone or had any ulterior motive. A senior officer said, "We are verifying his background and cross-checking possible links to other suspicious activities."The incident has reignited concerns over child safety in rural Bengal, where quick community vigilance and rapid police action averted what could have been another horrifying headline.

Massive Paint Factory Fire Guts Industrial Belt

Khardaha: Panic through the Ishwaripur industrial belt of Khardaha on Tuesday morning after a devastating fire ripped through a paint factory, reducing it to rubble and sending thick plumes of smoke billowing across the skyline. The inferno broke out around 7 a.m., rapidly engulfing the chemical-filled facility before spreading toward nearby units. Eyewitnesses described scenes of chaos as explosions echoed from within the factory, spewing flames several stories high. Initially, five fire tenders were deployed, but the blaze soon overwhelmed containment efforts. Within an hour, 20 fire engines from multiple stations joined the operation as firefighters struggled in suffocating heat to prevent the fire from spreading to adjacent factories."The intensity was

We've surrounded the fire



from all sides and prevented it from crossing to neighboring plants. Had it spread further, this could have turned catastrophic," said a senior fire official at the site. By 9:30 a.m., after nearly three hours of relentless firefighting, the blaze was brought "largely under control." Preliminary findings suggest the fire was triggered by a short circuit, though officials caution that a full forensic examination is underway. Authorities confirmed that no casualties had been reported so far. However, the factory was completely gutted. Secondary damage was also reported in a nearby jersey manufacturing unit, caught briefly in the inferno's path before crews contained the flames. Fire-

fighters described the operation as both "intense and precarious," citing poor industrial spacing and the clustering of multiple small factories without adequate fire gaps. "Factories here are virtually stacked on one another. Such density makes these areas death traps during a fire," added another official. Khardaha's air remained thick with smoke hours after the blaze was subdued, while fire department units continued cooling operations. Senior officials from the Barrackpore Police Commissionerate and the West Bengal Fire Services remained on-site to supervise damage assessment and ensure no secondary outbreaks occurred. The incident underscores mounting safety concerns in North 24 Parganas' industrial pockets, where lax safety compliance and unplanned construction continue to leave workers and residents

Kali Puja turns tragic: Multiple blazes engulf across Kolkata

MI News Service, Kolkata: What began as a night of devotion and celebration during Kali Puja turned tragic across Kolkata and its suburbs, as multiple fire incidents disrupted festivities and caused significant property damage. The most serious blaze occurred in Behala's Charkatala area (Ward No. 116), where a massive fire engulfed the Kali Puja pavilion of the Purbasha Regional Youth Association around 8:30 p.m. on Monday night.

Eyewitnesses said the fire spread rapidly, consuming the entire temporary structure made mostly of flammable materials before firefighters arrived. Local residents and puja organizers attempted to douse the flames, but by the time one fire engine reached the scene, the pavilion had been reduced to ashes. Fortunately, the idol of Goddess was miraculously saved. Preliminary reports suggest stray fireworks may have ignited the fire. In another major incident in Howrah district's Amta region, two shops were gutted in the Khalna area. The fire reportedly started when candles lit at a shop selling petroleum-based products triggered an explosion, which quickly spread to an adjoining electrical appli-ance store. The fire intensified rapidly, prompting the fire service to deploy initially five engines, later reinforced by three more units when the blaze grew uncontrollable. Local residents assisted the fire brigade in battling the flames. Though there were no reported casualties, the damage to property is still being as-Police launched inquiries into both incidents to determine the exact causes. These tragic events highlight the pressing need for stricter fire safety protocols, particularly during festivals that involve fireworks, open flames, and temporary structures. Authorities have unged puic or thorities have urged puja organizers to ensure all necessary precautions are in place to prevent such disasters in the future.

Kamalgazi flyover carnage: Speeding bikes trigger festive tragedy

MI News Service, Kolkata: The festive cheer of South 24 Parganas was shattered on Monday morning when a devastating accident on the Kamalgazi flyover left a young man critically injured and underscored, yet again, the lethal consequences of reckless riding.According to police, Arun Naskar, 35, a private-sector employee from Dhopagachi, Baruipur, was traveling towards Kolkata when tragedy struck. Another biker, identified as Apurva Mandal of Khudiram Metro area, was speeding on the opposite lane, reportedly returning home after purchasing firecrackers. In a moment of pure chaos, Apurva's bike rammed into Arun's with such force that Arun was flung over the flyover railing, both bikes hurtling off the edge. Another rider, caught up in the incident, suffered injuries as well. Local residents, alarmed by the crash and blood-stained roads, rushed to the scene, managing to send all three injured to hospital. Hospital sources indicate Arun remains in a critical state but has survived thus far. City police have seized both bikes and have launched an investigation, citing excessive speed and negligence as probable causes behind the horrific crash.The incident comes as a grim reminder of the deadly risks on the city's roads risks that escalate perilously during the festive season when unruly riding spikes.In a separate incident late Sunday, tragedy struck again on South 24 Parganas' Basanti State Highway. Two motorcycles collided head-on at Dhuri near Basanti Police Station No. 7. Three young men—including Abdul Hamid Molla, Arsaifuddin Gharami, and Hossain Molla—were rushed

to local hospitals.

Smokey skies, arrests, and denials Kolkata's diwali under fire

MI News Service, Kolkata: The night sky over Kolkata glittered with fireworks this Diwali- but by dawn, the city had turned into a smoky chamber of toxins. Residents woke up coughing as air quality nosedived across several neighborhoods. Yet, in a striking statement, Mayor Manjor Kumar Verma asserted the Kolkata pollution levels were "significantly bet-ter" than those of other Indian cities. For hours after midnight, thick smog blanketed the metropolis, blurring streetlights and suffocating entire neighborhoods. Data from the Central Pollution Control Board (CPCB) showed that by 12 a.m. on Monday , Kolkata's Air Quality Index (AQI) stood at 227 near Victoria Memorial, 190 in Bidhannagar, 166 in Ballygunge, 198 in Jadavpur, 134 near Rabindra

Bharati, and 166 in Belur- levels that fall squarely within the "poor" to "moderate" category. Despite visual evidence of heavy pollution and relentless explosions of crackers, the Mayor maintained the city's air quality remained "comparatively better" than most other urban centers nationwide. The Kolkata police, too had predicted trouble. In the run-up to Kali Puja, the mayor had warned residents against using banned firecrackers, stressing that offenders would face strict legal action. His warning proved prescient. By Monday night, authorities had arrested 183 people for bursting illegal fireworks and another 451 for violating related restrictions. Over 850 kilograms of banned firecrackers were seized across multiple zones. A senior police officer described the night as "Chaotic but

controlled" saying sustained monitoring and swift intervention prevented any large-scale accidents. Ordinary citizens, however, described a different reality. Across Kolkata, residents complained of burning eyes, breathlessness, and choking streets. One local from south Kolkata said, "It was unbearable. There were crackers everywhere. The air was so polluted I could feel it even inside my house."By late morning on Tuesday, hospitals reported a noticeable rise in patients suffering from respiratory distress, particularly among the elderly and children. Mayor Defends the City's Record Addressing the media on Tuesday, Mayor Manoj Verma acknowledged the pollution spike but insisted that Kolkata compared favorably with other metros. "Even with incidents of banned firecrackers, the overall pollution and noise levels were lower than last year and considerably less than other major Indian cities," he asserted. Environmental activists, however, questioned the mayor's optimism. "Numbers don't change the reality of smog and poor enforcement," said one activist. "The city may not be Delhi, but the air is still far from breathable."The Data Behind the "Poison" According to CPCB guidelines, an AQI reading between 0–50 is considered good, 51–100 satisfactory, 101–200 moderate, 201– 300 poor, 301-400 very poor, and 401-450 severe. Any value beyond 450 falls under the "hazardous" category. With large parts of Kolkata registering values above 200, the city, once again, finds itself grappling with air laden with particulate matter long after the fireworks fade.

While she has previously made statements that appeal to right-wing con-stituents, including pledges to visit the controversial Yasukuni Shrine and adopt a tough stance toward South Korea, Nakabayashi cautioned that such positions may be more about rallying political support than longterm strategy, warning that full implementation could complicate Japan's security environment. Economists and financial strategists have also weighed in on the economic landscape Takai chi inherits. Masamichi Adachi of UBS Securities highlighted the multiple pressures on her government, from rising prices and a supplementary budget to Japan's commitments on defense spending and relations with the United States.

Kolkata police cracks down: 183 arrested, 852 kg banned firecrackers seized

MI News Service, Kolkata: cent years, Kolkata Police arrested 183 people and seized 852 kilograms of banned firecrackers during Kali Puja night, amid esca-lating concerns over air and noise pollution in the city. The decisive overnight operation spanned multiple precincts, with police teams maintaining roundthe-clock surveillance across neighbourhoods notorious for illegal fireworks activity. According to city police sources, the drive intensified following a surge in complaints from across central and fringe areas on Monday night.

Kolkata Police Commissioner said, "Pollution remained largely under control compared to recent years and other major metros. We received numerous public complaints last night, particularly from newly added zones. Over a hundred people were arrested, and strict legal action is being taken."Despite the arrests and seizures, the city experienced a brief rise in pollution during the peak of celebrations. Air Quality Index (AQI) readings showed that between 11 p.m. and midnight, the pollution level touched 373—classified as "very poor" under Central Pollution Control Board (CPCB) standards. By Tuesday morning, however, the average AQI across Kolkata subsided to 166, falling into the "moderate" range. CPCB data indicated that, even with the spike, Kolkata fared better than other major Indian cities where pollution levels breached alarming thresholds. "Due to geographical location, pollutants from northern states drift into Bengal.

GRSE strengthens indigenous research shipbuilding

MI News Service, Kolkata: In keeping with its commitment towards Atmanirb-Garden Reach Shipbuilders and Engineers (GRSE) Ltd laid the keel for an advanced Acoustic Research Ship (ARS) that it is building for the Naval Physical and Oceanographic Laboratory (NPOL), a unit of the Defence Research and Development Organisation (DRDO).

The contract for the advanced ARS was signed between GRSE and NPOL in October 2024. With an overall length of 93 metres and width of 18 metres, the ARS will be a very advanced platform with state-of-the-art research equipment.

The ARS will be capable of speeds ranging from 4 knots to 12 knots. At top speed, the ship will have an endurance of 30 days or 4.500 nautical miles in a single mission. It will have a complement of 120 personnel. The capabilities of the ARS will include de-

ployment, towing and retrieval of various equipment such as acoustic modules, carrying out temporal and/or spatial highresolution surveys of sound velocity profiles and collec-

and offshore deployments. The research vessel will also carry out meteorological surveys to understand the influence of atmospheric parameters in sound propagation studies and undertake shallow water acoustic reverbera-

tion of ocean tides/current

Iconic ASRANI passes away at 84

News Mumbai: Veteran actor Asrani, who entertained generations with his comic timing but was equally at ease in a wide gamut of roles that straddled films as diverse as Sholay, Abhimaan, Mere Apne, Bawarchi, Guddi and Parichay, passed away in a hospital here on Monday, his manager said. He was 84. A veteran of over 350 films in a career spanning five decades, Govardhan Asrani, known popularly by the mononym Asrani, cemented his place in the hearts of the audiences through his portrayal of the eccentric jailer in Šholay. His dialogue, "Hum angrezon ke zamane ke jailor hai" in Sholay has achieved a cult status since. The character was modelled on Charlie Chaplin in The Great Dicta-



The end came on Monday afternoon, four days after he was admitted to Bharatiya Arogya Nidhi Hospital in suburban Juhu.

"He was a bit unwell. He was admitted following breathing issues. He passed away today at 3pm. We were told by the doctors that water had accumulated in his lungs," Asrani's manager Babubhai Thiba told PTI.

Asrani had largely played character roles in Hindi films and the lead in some Gujarati movies. Hours before his death, Asrani's Instagram handle had

uploaded Diwali greetings from the actor. His last rites were held on Monday evening at the Santacruz crematorium in the presence of family and close

friends. "We did not inform anyone about his demise as it was his wish that we should keep it a private thing," Thiba added. Asrani is survived by his

Asrani was born into a middle-class, Sindhi Hindu family in Jaipur. His father owned a carpet shop. Along with his studies, Asrani worked as a voice artist at All India Radio, Jaipur, to pay for his education.

Researchers discover protein that help prevent cancer treat-ment-related heart damage



Washington [US]: Blocking the protein CDK7 could prevent heart damage caused by a routinely used cancer chemotherapy treatment, according to a study conducted by scientists at Washington State University. Importantly, the researchers discovered that blocking CDK7 could improve the medication's cancer-killing efficacy.

Based on an animal model, the study's findings potentially lay the groundwork for future treatment options to decrease chemotherapyrelated heart damage and improve treatment efficacy. This has the potential to help people with cancer live longer lives. Heart damage caused by chemotherapy can manifest decades later and lead to heart attacks, heart failure, cardiomyopathy, and other types of heart dis-

The findings of the study were published in

study focused on doxorubicin, a chemotherapy drug used to treat breast cancer, lymphoma, leukemia and other cancers.

Capable of killing a wide range of cancer lls, doxorubicin and other similar chemotherapy medications are known to be toxic to the heart. Despite this toxicity, the drug still sees a lot of use.

"Doxorubicin remains the mainstay treatment for certain cancer types for which targeted therapies or other better treatments are not available," said senior study author Zhaokang Cheng, an associate professor in the WSU College of Pharmacy and Pharmaceutical Sciences.Cheng has been working to unravel the underlying mechanisms of doxorubicininduced heart toxicity to make the use of doxorubicin safer for patients who rely on the drug. This new study builds on findings from earlier research that showed that doxorubicin activates a protein known as CDK2. That protein then activates another known as FOXO1, which causes heart cells to die. Cheng's team collaborated with WSU cancer biology researcher Boyang (Jason) Wu to take a closer look at CDK7, a protein that helps fuel cell growth and has been shown to play a role in the development of cancer.

The researchers found that CDK7 activated CDK2, which set off the chain of molecular signals that eventually led to heart cell death. They also showed that mice that lacked the CDK7 gene were protected from doxorubicininduced heart toxicity. Next, they used a CDK7 inhibitor drug known as THZ1 to block the protein's activity and examine the impact on heart health and cancer growth. A similar inhibitor is currently being tested as an anticancer drug in clinical trials, but its effect on

on the heart and tumour growth in the same model," said study first author Jingrui Chen, a WSU research associate. "And what we found is that this CDK7 inhibitor drug can increase heart function and at the same time inhibit tumour growth.'

Though more research is needed, the researchers said their findings suggest that combining doxorubicin and THZ1 could help prevent heart damage and increase the effec-

Semaglutide ingredient can help protect kidney function in people with obesity: Study

WASHINGTON Semaglutide, a glucagon-like peptide-1 (GLP-1) receptor agonist, has been shown in the SELECT Trial to be effective in preventing the loss of kidney function in people who are overweight or obese and have established cardiovascular disease but do not have dia-

The remarkable secondary analysis from the SELECT (Semaglutide Effects on Heart Disease and Stroke in Patients with Overweight or Obesity) experiment, a randomised trial with a participant pool of 17,604 researchers today at the 61st ERA

The study's findings, according to experts, give individuals who suffer from obesity hope since this illness is known to increase the risk of renal function decline and macroalbuminuria, or abnormally high levels of the albumin protein

With an average follow-up of approximately 3.5 years, among patients who were administered a once-weekly subcutaneous injection of semaglutide 2.4 mg (n=8,803) adverse kidney-related events were experienced by 22% fewer persons (1.8%) compared to those receiving placebo (n=8,801) (2.2%) (p<0.05). These events included death from kidney causes, initiation of chronic kidney replacement therapy, significant (>= 50%) decline in kidney function, or onset of persistent macroalbuminuria. Semaglutide's ability to prevent the onset of macroalbuminuria was highlight-



the likelihood of kidney-related complications

The study also assessed the impact of semaglutide on estimatglomerular filtration rate (eGFR), a measure of kidney function in removing waste and excess water from the blood through urine. The findings indicated a significantly lesser decline in eGFR among semaglutide recipients compared to the placebo group, with the effect being more pronounced in participants with baseline eGFR below 60 mL/min/1.73 m2 (p<0.001). These results indicate the potential for semaglutide to particularly protect kidney function in individuals with a pre-existing kidney

impairment. The reduction in urinary albumin-to-creatinine ratio (UACR) further substantiated semaglutide's beneficial effect on kidney health, with a significant decrease observed in semaglutide-treated individuals compared to placebo (p<0.001). UACR analysis measures the ratio of albumin (a protein) to creatinine (a waste product) in urine, aiding the detection of albuminuria, which can signal kidney damage or dysfunction. With semaglutide, there was a net 8.1% decrease in UACR in those with normal albumin levels at baseline, a 27.2% decrease in those with microalbuminuria (slightly raised albumin) at baseline, and a 31.4% decrease in those with macroalbuminuria at baseline relative to placebo.

Importantly, the study found no increased risk of acute kidney injury associated with semaglutide treatment, irrespective of baseline kidney function.

Over one billion people worldwide are affected by obesity.3 Rates of obesity are rising significantly, having doubled among adult women (8.8% to 18.5%) and nearly tripled in adult men (4.8% to 14.0%) between 1990 and 2022. The total number of children affected by obesity in 2022 was nearly 160 million, compared to 31 million in 1990

Professor Helen M. Colhoun, lead study author, commented, By addressing key markers of kidney health, semaglutide 2.4 mg weekly may contribute to a significant reduction in the risk of kidney-related complications, including chronic kidney disease and end-stage renal disease. This could lead to improved management of comorbidities and, ultimately, enhance the quality of life for individuals with obesity.'

"The observed benefits in eGFR and UACR are particularly encouraging, suggesting potential for the enhanced management of kidney complications in the patient population with overweight and obesity without diabetes. The findings also underscore the importance of continued research into the possible renal benefits of semaglutide and highlight its role as a promising therapeutic option in the multifaceted management of cardiovascular and renal health in this high-risk

Study reveals key protein that helps prevent excessive bone loss in osteoporosis

Tokyo [Japan], Osteoporosis, a disorder characterised by porous and weak bones, is a major hazard to skeletal health. As the foundation of the human body, bones provide critical structural support. When bone mass decreases, it not only weakens this support but also lowers general function, resulting in a lower quality of life

With an ageing population and a rise in osteoporosis cases, the burden on healthcare resources for long-term care is clear. As a result, there is a need to understand the mechanisms that cause osteoporosis and develop effective targeted therapeutics to mitigate its long-term effects.

Osteoblasts and osteoclasts are two types of cells that play critical roles in bone tissue maintenance and remodelling. Osteoblasts are bone-forming cells that synthesise and deposit new bone tissue, whereas osteoclasts break down and remove old or damaged bone tissue. Increased proportion of osteoclasts causes bone mass loss in situations such as osteoporosis, rheumatoid arthritis (joint inflammation), and bone metastases (cancer that has spread to the bones). Osteoclasts develop from the development of macrophages or monocytes, two types of immune cells. Suppressing osteoclast differentiation could thus be used as a therapeutic technique to prevent bone loss. However, the precise molecular pathways driving the complicated process of bone remodelling are unknown.

In a new groundbreaking study, Professor Tadayoshi Hayata, Mr. Takuto Konno, and Ms. Hitomi Murachi from Tokyo University of Science, along with their co-workers, delved deeper into the molecular regulation of differentiation. Receptor activator of nuclear factor kappa B ligand (RANKL) stimulation induces the differentiation of macrophages into osteoclasts. Further, bone morphogenetic protein (BMP) and transforming growth factor (TGF)-b signaling pathways have been implicated in the regulation of RANKL-mediated osteoclast differentiation. In the current study, the researchers



- a phosphatase (an enzyme that removes phosphate groups) that has been reported to suppress BMP and TGF-b signal-

Giving further insight into their work set to be published on July 30, 2024, in Volume 719 of Biochemical and Biophysical esearch Communications, Prof. Hayata states, "RANKL functions as an 'accelerator' for osteoclast cell differentiation. Driving a car requires not only the accelerator but also the brakes. Here, we find that Ctdnep1 functions as a 'brake' on osteoclast cell differen-

First, the researchers examined the expression of Ctdnep1 in mouse-derived macrophages treated with RANKL and untreated control cells. They noted that Ctdnep1 expression remained unchanged in response to RANKL stimulation. However, it localized in the cytoplasm in granular form in the macrophages and differentiated into osteoclasts, distinct from its normal peri-nuclear localization in other cell types, indicating its cytoplasmic function in osteoclast differentiation.

Further, Ctdnep1 knockdown (downregulation of gene expression) resulted in an increase in tartrate-resistant acid phos-phatase-positive (TRAP) osteoclasts; wherein TRAP is a marker for differentiated osteoclasts. Additionally, Ctdnep1 knockdown led to an increase in the expression of crucial differentiation markers including 'Nfatc1', a RANKL-induced master transcription factor for osteoclast differentiation. These results support the 'brake function' of Ctdnep1, whereby, it negatively regulates osteoclast differentiation.

Moreover, Ctdnep1 knockdown also led to increased absorption of calcium phosphate, suggestive of the suppressive role of Ctdnep1 in bone resorption. Lastly, while, Ctdnep1 knockdown did not alter BMP and TGF-b signaling, cells deficient in Ctdnep1 showed elevated levels of phosphorylated (activated) proteins downstream of the RANKL signaling pathway. These findings suggest that the suppressive effect of Ctdnep1 in osteoclast differentiation may not be mediated by BMP and TGF-b signaling, but, through the negative regulation of RANKL signaling and Nfatc1 protein levels.

Overall, these findings provide novel insights into the process of osteoclast differentiation and reveal potential therapeutic targets which can be pursued to develop treatments that address bone loss due to excessive osteoclast activity. In addition to diseases characterized by bone loss, Ctdnep1 has also been reported as a causative factor in medulloblastoma - a childhood brain tumor. The authors are, therefore, optimistic that their research can be extended to other human diseases

Researchers use 'cloaked' proteins to deliver cancer-killing therapeutics into cells

have created a generalized method for "cloaking" proteins, which may allow for the recycling of materials like antibodies for biological research and therapeutic applications.Lipid nanoparticles, which resemble tiny bubbles of fat, have the ability to ensnare the "cloaked" proteins. Because of their microscopic size, these bubbles are able to secretly deliver their cargo into living cells, where the proteins unfold and begin to work as medicine. The group's paper published in ACS Central Science. The lead author is doctoral student Azmain Alamgir, who works in the labs of the paper's co-senior authors, Chris Alabi, associate professor of chemical and biomolecular engineering, and Matt DeLisa, professor of engineering.

For some drugs to impact a cell's biology, and ultimately treat disease, they need to get inside the cell and reach a specific space. Protein-based therapeutics have



many virtues - they can have more specific effects, with lower toxicity and diminished immune response - but ease of delivery is not one of them. Proteins are large and cumbersome and don't freely diffuse into cells as easily as small molecules do. "We had been looking for a

clever way to efficiently get our engineered proteins inside of cells, especially in a translational context that would not only work in lab-cultured cells, but that would also be effective and safe in animal models and eventually in humans," DeLisa said. The researchers had the broad idea of using a bioconjugation approach that would allow the proteins to be loaded into lipid nanoparticles, which form around nucleic acids.

ticles were a key component in the successful COVID-19 vaccines developed by Pfizer-BioNTech and Moderna. Those vaccines worked by delivering a payload in the form of messenger RNA, which are nucleic acids. The researchers now would use the same lipid nanoparticle delivery concept the same materials even - but with a protein payload. The trick would be to make proteins look more like nucleic acids. The researchers found they could accomplish this by "cloaking" the proteins with a negatively charged ion, so they would join with the positively charged lipids electrostatically.

"The crux of our strategy is conceptually very simple," Alamgir said. "We're taking proteins and specifically remodeling their surfaces with negative charges, so they look like nucleic acids and can similarly assemble into nanoparticles when formulated with the characteristic lipids.

Light therapy helps in brain connectivity following injury

Illinois [US]: A study suggests that lowlevel light treatment may have an impact on the healing process in the brains of individuals who have experienced serious brain injuries.

The findings of the study were published in Radiology, a journal of the Radiological Society of North America

The ability of various wavelengths of light to heal wounds has been researched for many years. Low-level light treatment was used by researchers at Massachusetts General Hospital (MGH) on 38 patients who had experienced moderate traumatic brain injury, which is defined as a head injury severe enough to affect cognition and/or be detectable on a brain scan. Within 72 hours of their injury, patients underwent light therapy using a near-infrared lightemitting helmet.

"The skull is quite transparent to near-infrared light," said study co-lead author Rajiv Gupta, M.D., Ph.D., from the Department of Radiology at MGH.

"Once you put the helmet on, your whole brain is bathing in this light.

The researchers used an imaging technique called functional MRI to gauge the effects of the light therapy. They focused on the brain's resting-state functional connectivity, the communication between brain regions that occurs when a person is at rest and not engaged in a specific task. The researchers compared MRI results during three recovery phases: the acute phase of within one week after injury, the subacute phase of two to three weeks post-injury and the late-subacute

phase of three months after injury.
Of the 38 patients in the trial, 21 did not receive light therapy while wearing the helmet. This was done to serve as a control to minimize bias due to patient characteristics and to avoid potential placebo effects.

Patients who received low-level light therapy showed a greater change in resting-state connectivity in seven brain region pairs during the acute-to-suba-



cute recovery phase compared to the control participants.

There was increased connectivity in

those receiving light treatment, primarily within the first two weeks," said study coauthor Nathaniel Mercaldo, Ph.D., a

statistician with MGH. "We were unable to detect differences in connectivity between the two treatment groups long term, so although the treatment appears to increase the brain connectivity initially, its long-term effects are still to be

The precise mechanism of the light therapy's effects on the brain is also still to be determined. Previous research points to the alteration of an enzyme in the cell's mitochondria (often referred to as the "powerhouse" of a cell), Dr. Gupta said. This leads to more production of adenosine triphosphate, a molecule that stores and transfers energy in the cells. Light therapy has also been linked with blood vessel dilation and anti-inflammatory effects.

There is still a lot of work to be done to understand the exact physiological mechanism behind these effects," said study coauthor Suk-tak Chan, Ph.D., a biomedical engineer at MGH.

While connectivity increased for the light therapy-treated patients during the

acute to subacute phases, there was no evidence of a difference in clinical outcomes between the treated and control participants. Additional studies with larger cohorts of patients and correlative imaging beyond three months may help determine the therapeutic role of light in traumatic brain injury.

The researchers expect the role of light therapy to expand as more study results come in. The 810-nanometerwavelength light used in the study is already employed in various therapeutic applications. It's safe, easy to administer and does not require surgery or medications. The helmet's portability means it can be delivered in settings outside of the hospital. It may have applications in treating many other neurological conditions, according to Dr. Gupta.

There are lots of disorders of connectivity, mostly in psychiatry, where this intervention may have a role," he said. "PTSD, depression, autism: these are all promising areas for light thera-



war-hit Ukraine MI News Service, Kiev: As the lights went out in her hometown, 40-year-old Zinaida Kot could not help but think about her next dialysis treatment for kidney disease. Without electricity, the machine that keeps her alive stops working. Kot is among millions of Ukrainians who are bracing for another winter of power cuts and possibly blackouts as Russia renewed its campaign of attacks on the country's energy grid. In some regions — mostly those closer to the front line in the east — the season of buzzing generators has started, as well as long hours of darkness with no power or water. The attacks have grown more effective as Russia launches hundreds of drones, some equipped with cameras that improve targeting, overwhelming air defences — especially in regions where protection is weaker. The consequences are already reshaping daily life especially for those whose survival depends on electricity. For Zinaida Kot, who has been on dialysis for seven years, this is far worse than mere discomfort. In early October, a Russian strike left the small northern town of Shostka — with a prewar population of nearly 72,000 — without electricity, water, or gas. The town lies just 50 kilometres (31 miles) from the front line in northern Sumy region. Gas service was later restored, and elec-

draw from the upcoming Tri-Nation T20I Series involving Pakistan and Sri Lanka, originally scheduled to be held in Rawalpindi and Lahore between November 17-29, calling the attack "a cowardly act carried out by the Pakistani regime." "The Afghanistan

Cricket Board expresses its deepest sorrow and grief over the tragic martyrdom of the brave cricketers from Urgun District in Paktika Province, who were targeted this evening in a cowardly attack carried out by the Pakistani regime," the ACB said in a statement.

"The ACB considers this a great loss for Afghanistan's sports community, its athletes, and the cricketing family." The board identified the slain players as Kabeer, Sibghatullah, and Haroon, who were returning home from a friendly match in Sharana when the incident occurred. Seven others were injured. "In response to this tragic incident and as a gesture of respect to the victims, the Afghanistan Cricket Board has decided to withdraw from participating in the upcoming Tri-Nation T20I Series involving Pakistan," it added. "May Allah grant the martyrs the highest ranks in Jannah and bless the injured with a speedy recovery.'

Ferns on Thursday will secure India's place in the semifinal, but a loss would leave them in misery as the Women in Blue will need to

If India suffer a defeat against the Sophie Devine-led side, they'll have to beat Bangladesh in their final group-stage encounter on Sunday and hope for the New Zealand to lose their last group stage contest to England.

In that case, India and New Zealand will finish with six points each and their qualification will depend on their Net Run Rate (NRR). HarmanpreetKaur and Co. are currently tied with New Zealand on four points but are placed above them courtesy of a

The India vs New Zealand contest, if washed out, will also benefit the hosts even if they lose to Bangladesh. However, terms and

conditions apply. Even in this scenario, they'll gain the advantage only if England beat New Zealand and also if Sri Lanka and Pakistan don't get to six points on the table.

India are to face New Zealand and Bangladesh at the same venue in Navi Mumbai, and if both their matches get washed out, they'll be through the semi-final. But then again, England will have to beat the Kiwis, or that encounter too will have to be

BCCI WRITES TO ACC CHIEF MOHSINNAQVI TO HAND OVER ASIA CUP TROPHY TO INDIA: REPORT

NEW DELHI : The Board of Control for Cricket in India (BCCI) has written an email to MohsinNaqvi, President of the Asian Cricket Council (ACC), to return the Asia Cup trophy to India, which won the title in Dubai recently.

After beating Pakistan by five wickets in the summit clash, the Indian team refused to accept the Asia Cup trophy from MohsinNaqvi during the post-match presentation ceremony because the ACC chief also serves as the chairman of the Pakistan Cricket Board (PCB) and also Pakistan's Interior Minister.

As per a media report, BCCI secretary DevajitSaikia said the board is awaiting a response from Naqvi, and if there is nothing from his side, we will escalate the matter to ICC with an official mail, adding that the board is "going step by step with the process and will keep pursuing the

After the Asia Cup final, the Indian team management had enquired who would be presenting the silverware and indicated willingness to receive it from Emirates Cricket Board vice-chairman Khalid Al Zarooni, but Naqvi is said to have rejected the proposal.

When the presentation ceremony began, India spinner KuldeepYadav, Abhishek Sharma, and batter TilakVarma received their individual awards from other dignitaries on stage. When Naqvi finally stepped onto the dais, the Indian side made clear they would not accept the trophy from him. Moments later, the trophy was discreetly removed from the venue, leaving the champions without their prize.

BCCI, however, had raised strong objections in the ACC meeting on September 30 over the decision not to hand over the winner's trophy to the Indian team and the drama created by the ACC chairman during the post-match presentation ceremony.

BCCI vice president Rajeev Shukla, who represented the BCCI at the meeting, had confronted Naqvi with tough questions. "Why was the trophy not handed over to the winning team? The ACC trophy is not the personal property of any individual," Shukla reportedly said during the discussions.
