The gesture—sending prasad to Bitan's parents—arrives amid a calendar of high-profile visits and ceremonial duties as ministers, MPs, and party officials gathered for Kali Puja events. The day's schedule mirrored a blend of political theatre and solemn remembrance. Mamata Banerjee, who has long used Kali Puja as a platform to project continuity and oversight, presided over morning and afternoon rituals within a setting crowded by party insiders, bureaucrats, and security personnel. JAMMU: Security forces conducting 120 ANTI-TERROR OPERATIONS daily

police chief Bhim Sen Tuti said security forces were conducting 120 anti-militancy operations daily in the region's 10 districts. The stunning revelation points to the monumental challenge posed by a resurgent militancy adept in jungle warfare in an area which had remained militancy-free for years before the scrapping of Jammu and Kashmir's special status in 2019. A total of 120 operations a day amounts to 44,000 missions annually, and the disturbing reality is that security forces achieve only limited success despite their relentless efforts, which at times require the involvement of troops for days on end.

Every day, around 120 operations are launched in the entire Jammu zone. This is a daily duty. Whether they are speculative operations or precise, pinpointed information-based operations. It keeps happening continuously," Tuti, the Jammu zone inspectorgeneral of police, told reporters in Jammu. "In the last two years, it (strikes by foreign militants) has emerged as an important challenge. We are strengthening our counter-terrorism grid, strengthening the border-protection grid. We will soon succeed in taking the foreign terrorists in these forests to task. I hope so." The Jammu region comprises 10 districts spread over 26,000 sqkm. The re-



gion was a success story for security forces, which, with massive local support, managed to keep militancy at bay for nearly two

But the scrapping of Article 370 in 2019 was followed by a revival of militancy, made deadlier by militants trained in jungle warfare. They succeeded in inflicting significant casualties on security forces, police and civilians before melting into the forests. The success of troops has only been modest. The forces are tight-lipped about the number of militants operating in the Jammu region or the details of improvisation in their counter-insurgency strategies. But police sources put the number of militants in the dozens. The last time security forces succeeded in neutralising a militant - Haider alias Maulvi in the Dudi Basantnag forests of Udhampur was in June. His associates had managed to escape. Hundreds of operations launched in four months after that have borne no fruit. Instead, one soldier was killed in Basantgarh, Udhampur, on September 20, while the militants involved gave the forces the slip. Security forces lost several men to militant attacks earlier too. Four policemen were killed in March in Kathua district after militants took a team led by a deputy superintendent of police by surprise. India reopens door for Indian-origin researchers to return

MI News Service, New Delhi/Washington: The government's plan to get Indianorigin faculty or researchers settled abroad to return and teach or conduct research at Indian institutions is gaining momentum, according to sources. While a similar plan has been considered in the past, it has been hit by several roadblocks, including procedural delays and uncertainties. The plan is being considered afresh against the backdrop of the recent developments in the United States, where most of these faculty members or scientists are employed.

According to the sources, a scheme is being designed in consultation with ministries of Education and Science and Technology with an aim to bring back established Indian-origin scientists and researchers with significant academic work to their credit who are willing to spend a defined period in India to pursue research or teach. "The IITs have already been trying to attract reputed foreign faculty, including Indian-origin ones who are now settled abroad or have their major body of work there," a source said. Earlier this month, the White House asked at least nine US universities to sign an agreement pledging to uphold the Donald Trump administration's higher education priorities or risk losing out on preferred access to federal funding. At the same time, top universities such as Harvard University have had billions of dollars in federal

faculty policies — actions critics say amount to coercive suppression of institutional independence. At present, the Ministry of Science and Technology runs Visiting Advanced Joint Research (VAJRA) Faculty Scheme to bring back overseas scientists and academicians, including resident Indians (NRI) and Overseas Citizens of India (OCI), to work in public funded institutions and universities for a specific period of time. The Ramanujan Fellowship provides attractive avenues and opportunities to Indian researchers of high calibre living abroad to work in Indian institutes and universities in all areas of science, engineering and medicine. Also, the Biomedical Research Career Programme (BRCP) provides an opportunity to early, intermediate and senior level researchers to establish their research and academic career in basic biomedical or clinical and public health in India. These fellowships are open to all eligible researchers who wish to relocate or continue to work in India. In 2015, the Bengaluru government cleared a "Welcome Home proposal" to bring back tled in universities and institutions abroad to ensure jobs in Karnataka-run universities and colleges for Indian-origin scientists, research scholars and professors if they return to the state.

Al misuse: Centre proposes strict IT rules

MI News Service, New **Delhi:** The government on Wednesday proposed that artificial intelligence and social media firms should clearly label AI-generated content to tackle the spread of deepfake and misinformation, prompted by simi-lar moves by the European Union and China. With nearly 1 billion internet users, the stakes are high in a sprawling country of many ethnic and religious communities where fake news risks stirring up deadly strife and AI deepfake videos have alarmed officials during elections. The new rules require platforms to label AI-generated content with markers covering at least 10% of the

surface area of a visual display or the initial 10% of the duration of an audio clip, placing more responsibilities on the likes of OpenAI, Meta, X and Google. Social media companies will also have to obtain a user declaration on whether uploaded information is AI-generated, and deploy reasonable technical measures to ensure checks and balances, the Indian government's draft proposal said. The rules will "ensure visible labelling, metadata traceability, and transparency for all public-facing AI-generated media," IT ministry said, inviting suggestions from the public and industry by

DIWALI: Delhi chokes under toxic smog

MI News Service, New Delhi: The national capital woke up to a toxic haze on Tuesday following Diwali celebrations, with air quality plunging to "very poor" levels because of widespread bursting of firecrackers. The sharp deterioration in air quality has reignited a political tussle between the ruling

BJP and the Opposition AAP. According to the Central Pollution Control Board, Delhi's average Air Quality Index (AQI) stood at 351 at 4pm on Tuesday, firmly in the "very poor" category. Similar readings recorded earlier in the day: 352 at 8am, 346 at 5am, and 347 at 6am. The post-Diwali average AQI in 2024 was 339, despite a complete ban on firecrackers. This year, the Supreme Court permitted the use of "green crackers" for a limited time. Amitabh Kant, former CEO of Niti Aayog and India's G20 Sherpa in 2023, took to X to voice his concern. "The Supreme Court has prioritised the right to burn crackers over the right to live and breathe," he said.

Kant, who has always advocated the Centre's policies, made strong remarks against pollution, saying the readings at 36 of 38 monitoring stations hit the red zone with AQI above 400. "Delhi's



execution can save Delhi from this health and environmental catastrophe," he wrote. The political blamegame also hung heavy, just like the smog. Delhi's environment minister Manjinder Singh Sirsa of the BJP pointed fingers at the AAPled Punjab government for allegedly encouraging stubble burning in the neighbouring state. In a media conference,

Sirsa presented videos purporting to show farmers in Punjab burning crop residue with their faces covered. "The AAP is deliberately forcing farmers to burn stubble in Punjab so that the smoke impacts Delhi," he alleged. "Farmers don't want to burn stubble but are being made to." AAP leader Saurabh Bharadwaj denied this and questioned the BJP for stopping the live-streaming of pollution data from Monday night.

"No farmer in Punjab would burn crop residue to malign Diwali. As per reports, compared to the last five years, cases of crop residue burning were far less this time," he said. According to a study, the 2025 post-Diwali period was the most polluted since 2021 when average PM2.5 concentration touched 488 micrograms per cubic metre, three times more than the pre-festival level of 156.6 micrograms per cubic metre.

Tech issue: Al flight makes precautionary landing at Mumbai

A Newark-bound Air India flight, operated with a Boeing 777 aircraft, returned to Mumbai on Wednesday morning due to a technical issue. The Boeing 777 plane, which took off at around 1.50 am for Newark on Wednesday, was airborne for over three hours before returning to Mumbai, according to information available on flight tracking website Flightradar 24.com. "The crew of flight AI191 operating from Mumbai to Newark on 22 October, made a precautionary air-return to Mumbai due to a suspected technical issue. The flight landed safely back in Mumbai, and the aircraft is undergoing necessary inspections," the airline said in a statement. Air India said AI191 and AI144 (scheduled to operate from Newark to Mumbai) were cancelled. All affected passengers at Mumbai have been provided hotel accommodations and have been rebooked on alternative Air India and other airlines' flights to their destination. Durgapur court sets TI Parade for accused in MBBS students gang-rape

MI News Service, Durgapur: The Durgapur court on Wednesday ordered a Test Identification (TI) parade of six accused individuals implicated in the alleged gang-rape of a 23-yearold second-year MBBS student from Odisha. The incident reportedly occurred outside the IQ City Medical College on October 10. The TI parade is scheduled for October 24 at the Phoolihore Correctional Home, where all accused are currently incarcer-

The court action followed a petition by the survivor's advocate, Partha Ghosh, who emphasized the urgency of conducting the parade to aid the investigation. Wasef Ali, a 23-year-old classmate of the victim, has been identified as the prime accused in a premeditated attack. Of the six arrested suspects, four-Wasef Ali, Nasiruddin Skalias Samrat (23), Apur Bauri (21), and Firdous Sk (23)—were remanded to judicial custody until October 26 following their production before the Durgapur Mohokuma Court. The remaining two accused, Sk Riazuddin and Sk Safiq, who have recorded their judicial confessions, have likewise been remanded until October 26. Police have reportedly pressed for these two to turn approvers in the case. According to the investigation, the victim and Wasef Ali had left the medical college campus around 8 p.m. on October 10 to purchase dinner. During this time, three of the arrested accused discov-

near the campus. The accused demanded money from the pair; while the male friend was sent to procure the cash, the victim was allegedly raped by one assailant as two others stood guard. Subsequently, two more accused arrived at the scene. The victim's mobile phone was seized during the assault. After the male friend returned with the money, both were released. Police are currently scrutinizing the statements of the survivor, her male companion, and five youths from the village. However, numerous inconsistencies remain in their accounts as investigators continue the painstaking task of correlating evidence and establishing the facts in this high-profile case.

Firecracker Chaos: 5 houses burn in Arambagh

MI News Service, Howrah: A devastating fire erupted in Howrah during Diwali celebrations, caused by falling lanterns, prompting widespread alarm and destruction. The incident occurred late Tuesday night in the Bantra police station jurisdiction on Narsingh Dutt Road, where a burning lantern re-portedly ignited the tiled roof of a residential house. The fire rapidly consumed the premises, reducing the entire structure to

Emergency response teams arrived promptly, breaking down the door to contain the blaze. Despite these efforts, the house was entirely gutted. Fortunately,

no casualties have been reported. The proximity of the fire to a private hospital across the street heightened tension and panic throughout the area. The Howrah Fire Brigade's timely intervention prevented a larger catastrophe in a densely populated neighborhood. Simultaneously, a separate fire incident has been reported in Arambagh, within aKhanakul's Benapukur area. Here, five houses were engulfed by flames during firecracker festivities. The initial conflagration is believed to have originated from a household in the Rajhati No. 1 Gram Panchayat, owned by a prominent BJP figure. The

combustible environment created by the celebrations. Reports confirm two individuals sustained injuries, and two others suffered panic attacks. Local political actors from both BJP and Trinamool Congress mobilized at the site, with the area MLA arriving swiftly to oversee containment efforts. "The fire station is so close, yet the engines arrived nearly half an hour late. By then, everything was gone," said a resident

to ashes in the fire. Locals, however, managed to rescue a cow tied inside the house just

Police from Shantipur station reached the spot soon after and brought the situation under control. When contacted, fire officials declined to comment on the delay. The incident has sparked resentment in the locality, with residents demanding an inquiry into the alleged negligence by the fire brigade.

Deaf-Mute rescued from brick Kilin after assault

What began as a celebration dance in front of the local Kali Puja mandap descended into brutal violance late Tuesday night, culminating in the death of 41-year-old Varun Mandal. Eyewitness accounts reveal that the atmosphere turned hostile following a heated argument between Varun Mandal and Chiranjit Mintra, allegedly fueled by intoxication.



11-yr-old's tragic death exposes brutal abuse in Sanjay Roy's family

MI News Service, Kolkata: Vidyasagar Colony in Bhavanipur has been gripped by outrage and sorrow following the mysterious death of an 11-year-old girl, an incident that has brutally exposed the dark underbelly of domestic violence and systematic abuse within the family of convicted RG Kar tax case accused Sanjay Roy.

The minor girl, niece of Sanjay Roy and daughter of his elder sister Babita, was found lifeless, hanging from a cupboard under circumstances that locals and family alleged are deeply suspicious. This tragedy comes as a continuation of a dis-tressing family saga, marked by the enigmatic death of girl's mother, Babita, four years prior- a death surrounded by its own shadow of mystery. Shocking revelations have surfaced about the prolonged and inhumane physical and mental torture inflicted upon the girl from her tutor and neighbors details relentless abuse: severe beatings, forced prolonged study sessions stretching forced prolonged study sessions stretching from midnight to 8 a.m., denial of playtime, and incessant psychological torment. The minor was reportedly forced to bang her head against walls if she failed to meet harsh academic expectations, and punishment was meted out mercilessly regardless of exam results. The girl was repeatedly assaulted with a belt, a fact confirmed by her grandmother. The grandmother's allegations add a chilling dimension to the case. Following the mother's death and the subsequent marriage of Babita's widower to her younger sister Pooja—who is also Sanjay Rov's sister—the familial atmosphere

reportedly worsened. The grandmother claimed she was barred from visiting her granddaughter, and the girl was isolated from her own family. "They lived separately and would not let me enter the house. The girl wanted to come to me but was kept away," she stated. Community members express rising anger and demand decisive legal action against the accused stepmother and father, whose names are now under intense scrutiny for their role in this ongoing nightmare of abuse and neglect. The case has ignited fierce debate and condemnation over the abuse of minors and the failure of familial protection in this household. This tragic episode unfolds an alarming narrative of abuse, neglect, and the consequences of unresolved family trauma that demand urgent intervention and justice for the victims.

ED again Summons Bengal prison Minister in recruitment probe

MI News Service, Kolkata: The Enforcement Directorate (ED) has once again summoned West Bengal State Prison Minister Chandranath Sinha, marking the third time the central agency has sought to question him in connection with the ongoing teacher recruitment corruption case. Despite earlier interrogations, the ED remains unsatisfied with the minister's responses, prompting renewed scrutiny. Chandranath Sinha, who was implicated in the scandal that has rocked the state's education and administrative sectors, has been under the ED's intense examination since March 2024. At that time, the ED conducted a raid on his Bolpur residence, seizing cash amounting to Rs 41 lakh. Although a chargesheet naming him was filed, the

However, the court granted him bail, a decision reaffirmed with subsequent extensions. His legal counsel contested the necessity of prolonged

Bengal braces for rain and thunderstorms this weekend

This precipitation is likely to be accompanied by thunderstorms, adding volatility to the region's weather. North Bengal's hilly

Kalimpong, Jalpaiguri, and Malda will also see scattered rainfall during the weekend, potentially intensifying into Monday, albeit with shortlived showers. The Meteorological Department highlights that the deepening of a lowpressure system in the southwest Bay of Bengal into a deep depression is a primary factor driving this weather transition. This depression is advancing towards the Tamil Nadu coast, while a new cyclone has simultaneously emerged in the south Andaman Sea, further complithe atmospheric conditions. Residents are advised to stay alert for weather updates over the coming days as scattered rain and thunderstorms are predicted to affect all districts, including Kolkata, by Saturday and Sunday. Kolkata to reclaim direct flight link with Guangzhou after 5 years

Kolkata is set to become the first Indian city to have a direct aviation link with mainland China as IndiGo Airlines has decided to launch a daily non-stop flight between Kolkata and Guangzhou, China starting October 26 (Sunday). The day will also witness the private airliner resume its one-stop flight between Kolkata's Netaji Sub-has Chandra Bose International Airport and London in the United Kingdom. "In yet another milestone for the nation's growing aviation network, @IndiGo6E Airlines is all set to re-establish direct air connectivity between Kolkata Airport and Guangzhou, China. This revived route marks a renewed chapter in international air travel, while opening fresh horizons for growth," the Airports Authority of India (AAI) posted on, its X handle. The restoration of the aviation connectivity between the two most populous nations in the world follows a series of diplomatic engagements, including Prime Minister Narendra Modi's recent visit where he met Chinese President Xi Jinping. The two discussed strategies to enhance trade ties amidst global economic uncertainties, setting the stage for renewed air connectivity. Guangzhou, historically known as Canton, is a major port city north-west of Hong Kong on Pearl River. It is renowned for hosting the massive Canton Fair and is home to a vast network of wholesale markets and shopping malls that cater to both domestic and international businesses. As a global trade hub, Guangzhou's connection with Kolkata is expected to significantly boost trade and tourism, not just for Kolkata and West Bengal, but for the entire region as Kolkata is a gateway for 11 states, including the entire landlocked northern states of the country. The Kolkata-Guangzhou direct flight will be operated on IndiGo's state-of-the-art A320neo aircraft, departing Kolkata at 10 pm and reaching Guangzhou at 4.05 am local time.

Mamata Banerjee, who has long used Kali Puja as a platform to project continuity and oversight, presided over morning and afternoon rituals within a setting crowded by party insiders, bureaucrats, and security personnel. Senior Tri-namool leaders, including Abhishek Banerjee, joined alternately for puja cere-

monies and public ceremonies. Meanwhile, Bitan Adhikari, a victim connected to the Kashmir Pahelgaon attack, remains a focal point of community grief. His family's outreach to the public has kept his memory in the political spotlight, with Mamata Banerjee's prasad gesture presented as a sign of ongo-ing support. The family's earlier appearances at public events, and Mamata Banerjee's attendance at related ceremonies at Kalighat and Lake Kalibari, highlight the administration's ongoing attempt to balance commemoration with governance amid ongoing security concerns and political pressures. Officials disclosed that the day's engagements included a routine review of Kali Puja arrangements, with Abhishek Banerjee and other party figures participating in the evening schedule fol-lowing a day of formal and informal engagements.

Al misuse: Centre proposes strict IT rules

November 6. The potential for misuse of generative AI tools "to cause user harm, spread misinformation, manipulate elections, or impersonate individuals has grown significantly," the government added. OpenAI, Google and Meta did not respond to Reuters queries. Indian courts are hearing high-profile lawsuits related to deepfakes. Bollywood stars Abhishek Bachchan and his wife Aishwarya Rai Bachchan have asked a New Delhi judge to remove and prohibit creation of AI videos infringing their intellectual property rights, and challenged YouTube's AI training policy. The rules about covering 10% of surface area are "among the first explicit attempts globally to prescribe a quantifiable visibility standard," said Dhruv Garg, founding partner at public policy research firm, Indian Governance and Policy Project. If implemented, the rules will require AI platforms in India to build in automated labelling systems to identify and mark AI-generated content at the point of creation, he added. India is emerging as a big market for AI firms. OpenAI CEO Sam Altman said in February that India was its second-largest market by number of users, which have tripled in the past year.

The 30th edition of AON's 'Annual Salary Increase and Turnover Survey 2024-25 India is based on inputs from 1,060 organisations across 45 industries. Further, its survey stated that salary increases are projected to vary across industries, with real estate/infrastructure (10.9 per cent) and non-banking financial companies (10 per cent) seeing the highest increases in 2026. The automotive or vehicle manufacturing is expected to witness 9.6 per cent salary growth, followed by engineering design services (9.7 per cent), retail (9.6 per cent) and life sciences (9.6 per cent), reflecting continued investment in critical talent pools.

Metro to run special services on Bhatri Dwitiya Adani defence under DRI probe

Indian authorities are probing Adani Enterprises' defence arm for allegedly evading import duties on missile components, according to two government officials with direct knowledge of the matter.

The investigation, led by the Directorate of Revenue Intelligence (DRI), began in March and concerns potential tariff evasion amounting to approximately \$9 million.

The inquiry centres on Adani Defence Systems and Technologies, one of the businesses of billionaire Gautam Adani's coal-to-airports conglomerate.

The company manufac-tures defence equipment such as drones, missiles, and small arms primarily for India's security forces.

In August, Gautam Adani stated that his company's drones were used by the Indian military during the May conflict with Pakistan, in which both sides deployed jets and missiles.

Officials alleged that the company misclassified shortrange surface-to-air missile parts as components of longrange missile systems, which are exempt from import tax-

The alleged misclassification allowed the firm to avoid paying both a 10 per cent im-

port tax and an 18 per cent local tax applicable to shortrange missile components.

SC acquits 4 convicts in 35-yr-old murder case

News Service, New **Delhi:** The Supreme Court has exercised its extraordinary constitutional powers under Article 142 of the Constitution to acquit four convicts sentenced to life in jail for a murder dating back 35 years, although only one of them had filed an appeal.

The court noted that the prosecution's claims were full of contradictions and inherent improbabilities".

A bench of Justice Sanjay Karol and Justice Sandeep Mehta passed the judgment on the appeal filed by Kannaiya challenging the concurrent findings of guilt recorded against him by a sessions court and affirmed by Madhya Pradesh High Court.

Under criminal law jurisprudence, every individual convict has to file an appeal against the conviction. But in this case, the three other convicts — Govardhan, Raja Ram and Bhima — had not done so. Under normal cir-

cumstances, only Kannaiya was entitled to be acquitted, but the top court exercised its extraordinary powers under Article 142, which empowers it to pass any order, judgment or decree to render complete justice, to acquit all four in

In October 1999, the first additional sessions judge of Mhow in Indore had sentenced the four to life imprisonment in a murder case. In 2012, Madhya Pradesh High Court affirmed their conviction and sentence.

It was the case of the prosecution that the four convicts, armed with axes and other lethal weapons, killed Ramesh when he resisted their attempts to demolish his hut in Chak village on September

Congress leader Mansoor Ali Khan too added that her outrage seemed selective, focusing only on Karnataka and not other states like Maharashtra. Shaw responded, saying she has a vested interest in her city and state, emphasising her plea is driven by civic concern, not politics.

The exchange between Shaw

and Shivakumar comes amid growing public support for Shaw's stance. Residents have echoed her concerns, sharing their own experiences with poor roads and garbage issues.

A former IIM faculty member said the new interdisciplinary courses would face several constraints related to market accentability, resources and infrastructure. In addition, the IIMs would begin to function like general universities and lose their brand value, he said.

"The IIMs never came under the regulations of the University Grants Commission (UGC) because they focused on niche courses. They created their own brand. Now by starting BSc and BA programmes, they may gradually come under the UGC's regulations. It means they will become general universities." the former faculty member said.

He said the government wanted the IIMs to start courses to "cash in on their brand" and increase their resource generation. "The IIMs do not have adequate

faculty to teach the new subjects that are being clubbed with management. They will mainly depend on outside experts. The regular faculty members will lose interest in the new programmes and may take a few classes only. Keto diet metabolite may power up CAR T cells to kill cancer: Study


PENNSYLVANIA [US]: Researchers at Penn Medicine's Abramson Cancer Centre and the University of Pennsylvania's Perelman School of Medicine have found that a straightforward dietary supplement may offer a novel way to enhance CAR T cell performance.

The early research, presented at the 66th American Society of Haematology (ASH) Annual Meeting and Exposition (Abstract 4), suggests a potentially economical way to enhance CAR T cell function and cancer-fighting capabilities, even though the strategy needs to be evaluated in clinical trials.

CAR T cell therapy is a personalized treatment approach, pioneered at Penn Medicine, that reprograms patients' own immune cells to kill their cancer.

"Thousands of patients with blood cancers have been successfully treated with CAR T cell therapy, but it still doesn't work for everyone,' said co-lead author Shan Liu, PhD, a postdoctoral fellow who presented the study at ASH. "We took an outside-the-box approach to improve CAR T cell therapy, by targeting T cells through diet rather than further genetic

Liu co-led the study with Puneeth Guruprasad, PhD, who earned his PhD at Penn and is now a medical student in the Perelman



School of Medicine. The lead authors worked under the mentorship of co-senior authors Marco Ruella, MD, an assistant professor of Hematology-Oncology, a researcher with the Center for Cellular Immunotherapies and the scientific director of Penn Medicine's Lymphoma Program; and Maayan Levy, PhD, an assistant professor of Microbiology.

First, the research team tested the effect of several different diets, including ketogenic, high-fiber, high-fat, high-protein, high cholesterol, and a control diet, on CAR T cell's tumorfighting capabilities using a mouse model of

diffuse-large B-cell lymphoma. They found improved tumor control and survival in the mice receiving a ketogenic diet compared to all other diets. In subsequent studies, they found higher levels of beta-hydroxybutyrate (BHB), a metabolite produced by the liver in response to a ketogenic diet, was a key mediator of this effect. The research builds on previous work from Levy's team, which found that BHB strongly suppressed the growth of colorectal tumors in lab experiments. "Our theory is that CAR T cells prefer BHB as a fuel source rather than standard sugars in our body, such as glucose," Guruprasad said. "So, increasing the levels of BHB in the body gives the CAR T cells more power to take out the cancer cells." Next, the research team tested a BHB supplement combined with CAR T cell therapy in laboratory models of human cancer (on a standard diet); the results showed complete obliteration of the cancer in the vast majority of mice and resulted in higher CAR T cell expansion and activation. To see if BHB, which occurs naturally at various level in our bodies, had a similar effect in humans, the team assessed blood samples from patients who had recently received CAR T cell therapy and found that greater BHB levels were associated with better CAR T cell expansion in patients.

Researchers identify new potential treatment for cardiac arrhythmias

Arizona [US] : A recent study by researchers at the University of Arizona College of Medicine - Phoenix and the University of California Davis Health discovered a new target for developing a medication to treat atrial fibrillation, the most prevalent kind of irregular heart rhythm.

According to the US Centres for Disease Control and Prevention, atrial fibrillation, also known as AFib or AF, accounts for approximately one in every seven strokes and is associated with a considerable increase in morbidity and death. The American Heart Association predicts that more than 12 million people will have AFib by 2030, and existing treatment approaches are inadequate, according to researchers.

Proteins involved in physiological processes of the heart have been a target of research for AFib for some time. Until recently, most research suggested that treating AFib through inhibition of specific small-conductance calcium-activated potassium channels, or SK channels, could either reduce or worsen arrhythmias under different conditions.

"Our study used pioneering experimental and computational approaches to decipher how the human SK2 channel can be dynamically co-regulated. The study is especially timely considering inhibitors of SK channels are currently in clinical trials to treat AFib, making further insight into their regulatory mechanisms paramount," said Nipavan Chiamvimonvat, MD, chair of the Department of Basic Medical Sciences at the U of A College of Medicine - Phoenix. The paper, "Atomistic Mechanisms of the Regulation of Small Conductance Ca2+-Activated K+ channel (SK2) by PIP2," was published in the journal Proceedings of the National Academy of Sciences.


Researchers discover that unique immune cells stop metastatic cancer

New York [US] : The majority of cancer deaths are caused by metastatic disease, which occurs when cancer spreads from the primary tumour to other areas of the body. and researchers understand how cancer cells escape the primary location to seed new tumours, it is unclear why some cancer cells produce new tumours decades later and others do not.

A research team at the National Cancer Institute-designated Montefiore Einstein Comprehensive Cancer Centre (MECCC) has uncovered a natural immunological response in mice that prevents escaping cancer cells from growing into tumours elsewhere in the body. The study was published today in the jour-

"Preventing or curing metastases is the most critical challenge in cancer," said study leader Julio Aguirre-Ghiso, Ph.D., director of MECCC's Cancer Dormancy Institute. "We think our findings have the potential to point to new therapies to prevent or treat metastatic disease." The study's co-first authors are Erica Dalla, Ph.D., a former student, and Michael Papanicolaou, Ph.D., a

Cells that migrate from primary tumors and seed metastatic tumors are called disseminated cancer cells (DCCs). Some DCCs



behave aggressively, immediately starting tumors in new tissue, while others remain in a state of suspended animation referred to as dormancy. "It's long been a mystery how some DCCs can remain in tissues for decades and never cause metastases, and we believe we've found the explanation," said Dr. Aguirre-Ghiso, who is also professor of cell biology, of oncology, and of medicine and the Rose C. Falkenstein Chair in Cancer Research at Albert Einstein College of Medicine.

Breast cancer and many other lungs. In research involving three mouse models of metastatic breast cancer, Dr. Aguirre-Ghiso and colleagues determined that when breast cancer DCCs spread to the lung's air sacs (alveoli), they are kept in a dormant state by immune cells known as alveolar macrophages

"Alveolar macrophages are the lung's first responders, defending the organ against bacteria and dangerous substances like environmental pollutants, said Dr. Aguirre-Ghiso. These specialized macrophages, he notes, appear early in embryonic development and reside within lung tissue for life.

"Our findings demonstrate a new role for these macrophages, actively interact with them, and-by secreting a protein called TGFb2--produce signals in the cancer cells that keep them in a dormant state," Dr. Aguirre-Ghiso said.

Since every organ in the body has its own set of tissue-resident macrophages, they may function to keep DCCs in check in those organs as well. Our study has shown for the first time that these specialized macrophages function to actively induce dormancy in

Confirming the importance of alveolar macrophages in keeping DCCs dormant, Dr. Aguirre-Ghiso and his team found that depleting them in the mice significantly increased the number of activated DCCs and subsequent metastases in their lungs compared to mice with normal levels of the immune

As DCCs become more aggressive, the researchers found, they become resistant to the pro-dormancy signals produced by alveolar macrophages. Ultimately, this evasion mechanism enables some DCCs to "wake up" from dormancy and reactivate to form metas-

"Understanding how immune cells keep DCCs in check could lead to new anti-metastatic cell therapies among other strategies," Dr. Aguirre-Ghiso said. For example, he noted, it may be posto strengtnen signaling so that DCCs never awaken from dormancy or find ways to prevent older DCCs from becoming resistant to dormancy

Wurzburg [Germany] : When cells divide, there is a substantial risk of genetic harm. After all, the cell must repeat its whole genetic material, including billions of genetic letters, before it can divide. This repeatedly produces "reading errors" in the genome. Other factors, including as exposure to sunlight, alcohol, and cigarettes, are also responsible for the buildup of DNA damage over a person's lifetime.

Of course, the cell is not impotent in the presence of such injuries. It contains a large library of biological mechanisms that are activated in response to DNA damage. The precise term for this is DNA damage response (DDR). Specific signaling pathways are usually responsible for the immediate recognition and repair of DNA damage, ensuring the cell's survival.

A team of scientists from Julius-Maximilians-Universitat Wurzburg (JMU) in Bavaria, Germany, has recently conducted a closer examination of one of these signaling routes. The researchers discovered a new mechanism for the DNA damage response that is mediated by an RNA transcript. Their findings serve to widen the conceptual perspective of the DNA damage response and link it more closely



NEAT1 itself does not repair DNA damage. However, as the Wurzburg team discovered, it enables the controlled release and activation of an RNA-binding DNA repair factor. In this way, the cell can recognize and repair DNA damage highly efficiently.

According to the scientists, knowledge about the role of NEAT1 methylation in the recognition and repair of DNA damage could open up new therapeutic options for tumors with high NEAT1 expression. However, it must first be clarified whether these results, which were obtained in simple cell systems, can also be transferred to complex tumor models.

Kaspar Burger's research was supported by the German Cancer Aid and the Mildred Scheel Early cer, among other things Of course, the cell is not pow-

erless in the face of such lesions. It has an extensive catalog of cellular mechanisms that are set in motion following DNA damage. DNA damage response, or DDR for short, is the technical term for this. Fresh Russian offensive kills 6 at Kiev

MI News Service, Moscow/ Kiev: Russia launched a massive drone and missile attack on Ukraine's capital, killing at least six people, Ukrainian officials said.

Emergency services rescued more than 10 people after a fire caused by drone debris hit the sixth floor of a 16-story residential building in the Dnipro district of the capital. Kyiv, where two people were found dead, local authorities reported. The attack also blew out windows of a medical facility and debris was found at another residential building, Kyiv mayor Vitali Klitschko reported on his Telegram channel.

In the Darnytskyi district of the capital emergency services were responding after drone debris hit a 17story residential building causing a fire on five floors. Fifteen people had to be rescued including two children.

In the Desnianskyi district, 20 people were rescued after the façade of a 10-story building was damaged and a gas pipe caught fire. Debris from a drone also fell on a dormitory building and rescue workers were headed to the scene, Klitschko said.

The large-scale overnight aerial attack also targeted other cities in Ukraine including Zaporizhzhia and the port city of Izmail in the southern Odesa region.The attack came as Ukrainian President Volodymyr Zelenskyy has been trying to strengthen Ukraine's position by seeking long-range Tomahawk missiles from the United States, although President Donald Trump has waffled on whether he would provide them.

USA-Aus critical minerals pact sparks optimism

MI News Service, Washington: Donald Trump's backing of Australia's critical minerals will bring muchneeded financial support to the industry, but experts say the U.S. president will have to wait longer to shift the supply chain away from China and weaken its market dominance.

In a wide-ranging agreement signed on Monday, U.S. and Australia committed a combined \$3 billion to mining and processing projects, and to a price floor for critical minerals, a step long sought by Western miners. The countries will also sign off on financing that includes offtake rights.

The White House said U.S. investments into Australia would unlock deposits of critical minerals worth \$53 billion, without offering many details.

Trump said in a year they would have "so much critical mineral and rare earths that you won't know what to do with them." "They will be worth about \$2," Trump told reporters in a news conference later.

Global mining industry experts gathered at a conference in Sydney on Tuesday welcomed the news, which they said would open up investment opportunities, but they were sceptical of Trump's time horizon.

"The time frame for various projects to be ready even for 2027 would be heroic, and unachievable in the case of many projects," Barrenjoey analyst Dan Morgan told

China accounts for 90% of the world's refining capacity for rare earths which have crucial uses in sectors such as clean energy, defence and automobiles. In a note on Monday flagging risks of supply disruptions, Goldman Sachs noted China also controls 69% of global rare earth mining, and 98% of magnet manufacturing.

While rare earths are common in the Earth's crust, China has mastered the technically difficult and environmentally-harmful refining process, compara-

tively cheaply.

With trade tensions and security concerns rising, the U.S. and its Western allies have been looking to loosen China's grip. In April and May, Beijing squeezed global automakers with export curbs on a range of rare earths items and related

magnets, and earlier this month expanded its export controls.

Benchmark prices in China for the most popular type of processed rare earths, NdPr oxide rallied by 40% to \$88 a kilogram in August, after several years of weakness.

They have since tailed back to \$71, but western world developers are calling for governments to support a higher floor price that will enable them to build production.

It's unrealistic to expect prices to drop further and the market to be swamped with supply in the short term, said Dylan Kelly, head analyst at fund Terra Capital.

"Prices right now aren't necessarily reflective of a market dynamic that can see prices fall any further," Kelly said, adding that Monday's announcement had increased the investment allure Australian projects.

"There's lot out there to sink our teeth into that could really shift the gear on a number of different projects for us.

ICC RANKINGS: BUMRAH CONTINUES TO HOLD TOP TEST **BOWLER SPOT; SIRAJ GAINS BIG IN ODI**

DUBAI: India's star pacer Jasprit Bumrah remains at the top of the ICC Men's Test bowler rankings, but the latest update has brought some movement among Indian players and increased competi-

Fellow India quick Mohammed Siraj made a strong return to the ODI rankings, re-entering at 17th position after his first appearance in over a year, following an impressive outing in the recent ODI series against Australia.

Meanwhile, Bumrah's lead at the top of the Test rankings has been reduced to just 29 points by Pakistan's Noman Ali, who achieved a new career-high rating after his standout performances in Lahore.

Noman's 10-wicket performance in Pakistan's 93-run victory over South Africa lifted him four places to second overall, with a total of 853 rating points. His teammate Shaheen Afridi also rose three spots to 19th after taking four wickets in the second innings


of the same Test. Among Pakistan's batters, Mohammad Rizwan moved up four places to 16th, Babar Azam gained two to 22nd, and Salman Agha jumped eight positions to 30th. The Test batting charts, however, continue to be led by England's Joe Root.

In the South African camp, Ryan Rickelton's first-innings score of 71 in the first Test against Pakistan earned him a maiden entry into the top 50, while Tony de Zorzi's century propelled him to 54th.

Elsewhere, several Australian and English players were rewarded for standout performances in whiteball cricket. In Perth, Australia's stand-in captain Mitchell Marsh moved up two places to 42nd in the ODI batting rankings after his Player of the Match performance against India.

Pacers Josh Hazlewood and Mitchell Starc also made gains, rising to 10th and 21st, respectively, among ODI bowlers. Bangladesh spinner Mehidy Hasan Miraz climbed six spots to 18th after consistent performances against the West Indies.

England's white-ball squad saw significant upward movement following their T20I victory over New Zealand in Christchurch. Harry Brook advanced 18 places to reach 20th among T20I batters, while Adil Rashid climbed three spots to secure third place in the T20I bowling rankings.
