The march is slated to start at 1:30 p.m. from the base of the Gandhi statue at Dharmatala and proceed to the Jorasanko Thakurbari. 

# EC starts training BLOs in Bengal, TMC launches parallel booth-level assistance

MI News Service, Kolkata; As announced last week, the Election Commission of India (ECI) launched an elaborate training programme for Booth-Level Officers (BLOs) in West Bengal on Saturday for the upcoming Special Intensive Revision (SIR) of electoral rolls. The training programme, which began in various district headquarters, besides in Kolkata, would be completed by November 3, as the SIR process is scheduled to begin on the very next day, officials said.

For instance, in south Kolkata's Nazrul Mancha, training was underway for BLOs of Bhabanipur, Rashbehari, Ballygunge, Tolly-Kasba, Jadavpur, Metiabruz, Behala Purba and Behala Paschim assembly constituenelection officials informed.. When the Election Commission began training Booth Level Officers across West Bengal for SIR of electoral rolls, the ruling Trinamool Congress (TMC) has also launched a parallel voter-assistance operation simultaneously and accused the EC of deliberate deletions of many voters names in some booths. ECI officials said the first phase of training focused on the mobile application of BLOs, as they will use them for on-the-spot verification and distribution of enumeration forms.

"BLOs will be trained to operate the application, identify acceptable documents and explain procedures to voters," a senior ECI official said. The commission also

moved to stabilise online services after heavy traffic threatened the old portal. The ECI also launched a new website to let voters search 2002 SIR lists without crashes.

Meanwhile, according to Trinamool Congress (TMC) sources, they have decided to simultaneously set-up "anchal" (Zone) -wise help desks from November 4 till December 4 (for SIR). Party All India General Secretary Abhishek Banerjee during a closed-door virtual meeting, told TMC's state functionaries that not a single BLO should be left "unattended for even a minute" and they should be shadowed all the time . He also directed Booth Level Agents (BLA-1s) in every district to appoint BLA-2s

to accompany BLOs during doorto-door verification and act as "shadow companions" to prevent any unfair deletions. Abhishek Banerjee announced that from November 4 the TMC will set up 6,200 voter-assistance camps across 2,861 municipal wards and 3,345 gram panchayats. Each camp, he said, will be equipped with laptops, printers and Wi-Fi and will operate from 9 am to 5 pm everyday for a month to help people check names, submit claims and objections, and

24 Parganas, Nadia and Cooch Behar districts, saying hundreds of names visible in 2002 lists were now missing. In one Basirhat booth alone, the online list shows a blank stretch from S. No. 859-892. Names present in 2002 have simply vanished today. Barely days into the Election Commission's Special Intensive Revision (SIR), Bengal is witnessing names van-ishing from electoral rolls across Natabari, Mathabhanga, Ashoknagar and Basirhat, raising fears of a coordinated voter purge.

"We have to be with the people of Bongaon, Ranaghat. Just like in Assam where we saw lakhs of Hindus were left out - in Bengal due to SIR a lot of people will face difficulties. So Trinamool Congress workers must stand firm with them and provide all help," he said. He said the party would continue to pursue every democratic and legal avenue

## **Abhishek accuses BJP** of 'hypocrisy' over party MP's comment on Indo-Bangla border

MI News Service, Kolkata; All India General Secretary of the Trinamool Congress Abhishek Banerjee on Saturday slammed BJP MP Jagannath Sarkar for his comment on the India-Bangladesh border, and alleged that the "hypocrisy" of the saffron party has "fallen to new depths".

In a purported video, which was telecast on news channels, Sarkar was seen commenting at a meeting on Thursday in his constituency, Ranaghat in botdering Nadia district, that "if we win the assembly polls next year, there will be no barbed wire fencing with Bangladesh." Sarkar also claimed, "If the Trinamool Congress wins the elections, there will be no barbed wire fencing, as infiltration from Bangladesh will continue.

Reacting to this in a social media post on Saturday, Abhishek Banerjee demanded that the BJP should immediately suspend Sarkar if the party truly believes in the integrity of India. Taking strong exception to Sarkar's comments, the TMC MP alleged, "The hypocrisy of the BJP leadership has fallen to new depths. @BJP4India MP from Ranaghat, Jagannath Sarkar, declares that if the BJP comes to power, there will be no borders between India and Bangladesh- both nations will become one again!" He also claimed that the BJP government at the Centre and Union Home Minister Amit Shah "keep blaming the West Bengal government for not giving land to "protect the very borders their own MP wants to erase". ## At least 9 devotees killed in Venkateswara temple stampede in Andhra Pradesh

MI News Service, Hyderabad : At least 9 people, mostly women, were crushed to death and two others injured at a stampede among devotees in a temple at Kasibugga in Srikakulam district of Andhra Pradesh on Saturday. According to Kasibugga sub-division incharge DSP Lakshman Rao, the stampede occurred at Kasibugga's Venkateswara Swami temple at around 11.30 am in which at least "Seven devotees had died and two others were injured". According to preliminary reports, the incident occurred as large crowds gathered at the temple during morning rituals. Soon after the incident local authorities and rescue teams rushed to the temple to assist other devotees and move the injured to nearby hospitals. Thousands of devotees had gathered at the Venkateswara Swami Temple to pray during 'Ekadashi', one of Hinduism's most sacred days,

## TMC MP Mamatabala Thakur threatens indefinite fast on SIR issue

MI News Service, Kolkata: Trinamool Congress MP Mamatabala Thakur on Saturday threatened an indefinite sit-in from November 5 if the Special Intensive Revision (SIR) of electoral rolls by the Election Commission is directed against any single member of the Matua community.

People of the Matua community, a Scheduled Caste, had migrated from erstwhile East Pakistan after independence and settled in the border districts of West Bengal in the past several decades. Thakur said she will sit on a hunger strike before the residence of Matua patriarch Binapani Devi at Sangh headquarters, Thakurnagar in North 24 Parganas district

In a fiery address that sent ripples of alarm across India's political landscape, TMC Rajya Sabha MP and All India Matua Mahasangha president Mamata Bala Thakur framed the SIR-a rigorous voter list cleanup-as a veiled weapon to disenfranchise vulnerable communities like the Matuas, millions of Hindu refugees from Bangladesh now facing documentation nightmares. "Implement SIR, and you'll see India burn like Nepal did—Modi and Shah, hear this: we'll fight tooth and nail to protect every citizen's right," she declared, her voice a clarion call amid a sea of banners decrying electoral exclusion. This stark warning, elevates a regional grievance into a national flashpoint, igniting fears of widespread agitation as the 2026 elections

Thakur's speech tapped into a deep vein of anxiety among the Matuas, whose ancestors fled per-



secution only to face a new battle for legitimacy in India's bureaucratic maze. The SIR, pitched by the Election Commission as a safeguard against fraudulent voters, demands stringent proof of citizenship-birth certificates, pre-1971 residency documents—that many Matuas, displaced by Partition's chaos, simply don't possess.

To the crowd, Thakur painted a vivid picture of families haunted by the specter of deleted names, stripped of voting rights earned through decades of struggle. "This isn't revision; it's erasure," she charged, accusing the BJP-led center of using SIR to tilt electoral scales by targeting minority-heavy constituencies. Her words, met with roars of approval, transformed the rally into a crucible of resistance, where shared histories of exile fueled a collective resolve to defy what many see as statesanctioned marginalization. Aiming Union Minister Shantanu Thakur, her BJP-aligned kin and rival, Thakur sharpened her attack, branding him a "traitor to Matua blood" for championing policies she claims betray the community. "Shantanu fronts for RSS-BJP's plot to chain us through SIR, stripping our votes to weaken Bengal's voice," she asserted, reigniting a bitter feud rooted in Thakurnagar's fractured legacy.



## **ED files PMLA complaint against Amrit Feeds,** promoter Harish Bagla in Rs 144.68-cr bank fraud case

The complaint was produced before the chief judge of the city sessions court on October 23, 2025, following an ED probe triggered by a Serious Fraud Investigation Office (SFIO) complaint lodged on March 22, 2024.

The federal agency's probe revealed that the city based compalaundered through a network of

The alleged fraud related to an outstanding term loan of Rs 93.62 crore and an outstanding cash-credit facility of Rs 51.06 crore that turned into non-performing assets in 2015-16. The loans were reportedly from Axis Bank, Punjab National Bank, Bank of India and HDFC Bank.

The investigation was initiated based on a complaint filed by the Serious Fraud Investigation Office (SFIO) against AFL, its related companies, and its directors/ promoters for siphoning off bank

# **BLOs Protest During SIR Training in Bengal Allege Pressure and Lack of Safety Measures**

MI News Service, Kolkata: Tension flared during the final phase of Booth Level Officers' (BLO) training at Nazrul Mancha on Saturday as several officers staged a protest against the Election Commission during the ongoing SIR preparation in West Bengal. The officers alleged that despite being on official duty, the Commission had failed to ensure their safety and well-being. They also complained of being overburdened with dual responsibilities managing school duties along with SIR fieldwork. discontent among BLOs had been simmering ever since the announcement of the SIR process. On Saturday, it escalated during the training session when officers voiced their frustration. Many claimed they were being marked absent in their respective schools despite performing official election duties. Commission has

clearly stated that BLOs are on duty during the SIR period. Yet, no coordination is being made with school authorities, which is creating unnecessary pressure," said one agitated officer. The SIR process —
part of a Special Intensive
Revision of the electoral
rolls — officially began across West Bengal last week. BLOs are being trained on how to conduct door-to-door voter verification, collect information, and upload using a designated mobile application. The data collected will ultimately determine which names remain on the voter list and which are deleted.

Training for BLOs started across the state on October 28 and will continue until November 3. In Kolkata, two major sessions were held on Saturday at Derozio Hall, College Street. Officers from Chowringhee, Beliaghata, and Jorasanko participated in the morn-

ing session (11 a.m. to 1 p.m.), while BLOs from Entally, Shyampukur, and Kashipur-Belgachia attended the afternoon session (2 p.m. to 4 p.m.). Separate training was also held for Maniktala zone BLOs at the conference hall of Jessop Building. Sources said SIR forms have already been downloaded and printing will be completed by Saturday. BLOs are expected to receive them by November 3, and door-todoor distribution will begin from November 4.

The Election Commission has rolled out the  $training\ in\ phases -- start$ ing from the Chief Electoral Officer's office, followed by district and aswho then train BLO supervisors and finally the fieldlevel BLOs. The SIR process has already been completed in Bihar, where around 30 lakh "invalid" names were reportedly removed from the rolls.

## **SIR Panic**; Mayor Assures Citizens

MI News Service, Kolkata: Kolkata witnessed long queues outside the Kolkata Municipal Corporation (KMC) offices on Friday as panic spread among residents over the need for birth certificates following the recent SIR directive. To calm the anxious crowd, Kolkata Mayor Firhad Hakim personally visited the queues and spoke to applicants, assuring them that there was no cause for alarm.

During a virtual meeting with Trinamool Congress (TMC) National General Secretary Abhishek Banerjee, the Mayor also raised the issue, informing him about the prevailing

fear. "I assured the citizens not to worry. Chief Minister Mamata Banerjee is with them. Trinamool will extend all necessary assistance to ensure genuine voters are not left out," Hakim said. The rush began after the Election Commission listed eleven documents required for voter verification, one of which is the birth certificate. For those whose names were not included in the electoral rolls before 2002, the document serves as key proof of age and citizenship. As a result, hundreds of people—many in their forties or older—have been crowding the KMC headquarters over the past two days, leaving aside daily work to obtain the certificate. Applicants have travelled from different parts of the city and even from districts such as Murshidabad. One such applicant, Anisur Rahman from Lalgola, arrived in Kolkata early Friday morning carrying an old hospital record from Eden Hospital showing a name and birth date but with an unclear stamp. He had been waiting in line at Gate No. 6 since 8 a.m.

"There is a sudden rush for birth certificates. People are getting unnecessarily worried. They used central agencies like the ED and CBI to scare us earlier, and now they are

frightening ordinary citizens," the Mayor said. According to KMC's Chief Health Officer Dr. Ranita Sengupta, the corporation's infrastructure allows for issuing about 450 birth certificates per day.

"The sudden surge has created pressure. Most of the applications we are receiving are for documents that are 50-55 years old, and retrieving such old records may not always be possible," she noted. Authorities have urged citizens to remain calm, assuring that necessary steps will be taken to streamline the process and assist all genuine applicants.

## **Mamata and Abhishek Plans Mas**sive Rally Against SIR on Nov 4

MI News Service, Kolkata: Accusing the BJP of a deeprooted conspiracy over the Special Intensive Revision (SIR), West Bengal's ruling Trinamool Congress (TMC) has announced a massive protest march to be led by party supremo Mamata Banerjee and National General Secretary Abhishek Banerjee. According to party sources, the rally will take place on November 4 — the very day Booth Level Officers (BLOs) are scheduled to begin door-to-door verification under the SIR process. The march is slated to start at 1:30 p.m. from the base of the Gandhi statue at Dharmatala and proceed to the Jorasanko Thakurbari. Several TMC MPs, councillors, and senior leaders will join the march alongside Mamata and Abhishek. The Election Commission has initiated a special intensive revision of the electoral rolls across 12 states, including West Bengal, ahead of next year's Assembly elections. The TMC has consistently opposed this move, expressing concern that the SIR drive could be misused to delete the names of legitimate voters. Calling it a

## At least 7 devotees killed in Venkateswara temple stampede in Andhra Pradesh

marked by fasting and prayers to Lord Vishnu. Police said the situation spiralled out of control as the crowd swelled beyond capacity, triggering a stampede near the temple main gate. 'Several people, mostly women, collapsed as devotees surged forward all at once," another senior police official said. He said the exact cause of the stampede is being investigated, while efforts are underway to identify the victims. Visuals from the temple complex showed utter chaos as some devotees tried to help those trapped in the melee. As the news of stampede reached Prime Minister Narendra Modi, who was in neighbouring Chhattisgarh today, he immediately announced payment of ex-gratia for those killed and injured from the PM's fund. "Pained by the stampede in Venkateswara Swamy Temple in Srikakulam, Andhra Pradesh. My thoughts are with those who have lost their near and dear ones. I pray that the injured recover soon," said the statement from Modi. An ex-gratia of Rs 2 lakh each from PMNRF will be given to the next of kin of those who lost their lives, while those injured will receive Rs 50,000, the PMO announced. Reacting to the incident, when a day of worship turned into tragedy, Andhra Pradesh Chief Minister N Chandrababu Naidu, in a post on X said, "The stampede at Kasibugga Venkateswara temple in Srikakulam district anguished me. It is very sad that devotees have died in this unfortunate incident. I convey my deepest sympathies to the families of the victims." The CM also said that he directed officials to ensure the best treatment for the injured and that he instructed the authorities and local leaders to monitor the relief work at the stampede site. The state government has also announced compensation to the victims.

## "Urge both State and Central Govts to act immediately": Rahul Gandhi on devastation caused by Cyclone Montha in Andhra Pradesh

MI News Service, New Delhi: Congress MP Rahul Gandhi on Saturday expressed his deep concern over the devastation caused by Cyclone Montha in Andhra Pradesh. The cyclone has resulted in significant losses, with estimated damages amounting to Rs 5,244 crore. Gandhi emphasized the need for immediate relief and assistance to the affected people, particularly farmers who have lost their crops.

In a post on X, he urged both the State and Central Governments to act immediately. He said, "The destruction caused by Cyclone Montha in Andhra Pradesh has caused immense hardship across many districts. My thoughts are with everyone who has lost their loved ones, homes and livelihoods. It's heartbreaking to see our farmers, who worked tirelessly for months, lose their entire crop overnight. The Congress Party in Andhra Pradesh is on the ground, listening to people and assessing the damage. We urge both the State and Central Governments to act immediately - the scale of devastation demands urgent and compassionate action."

Crops over 1.38 lakh hectares were damaged, affecting 1.74 lakh farmers and causing losses of Rs 829 crore. 4,794 km of roads, along with 311 culverts and bridges, were damaged, causing losses of Rs 2,794 crore. The government has taken steps to provide relief, including distributing essentials like rice, lentils, onions, sugar, and palm oil to those in relief camps.

Andhra Pradesh Chief Minister N Chandrababu Naidu has credited technology-driven real-time monitoring and best practices for ensuring people's safety. The government has announced compensation for damaged crops and financial assistance to flood-affected families. Minister Dola Sree Bala Veeranjaneya Swamy assured that every farmer who suffered crop loss would receive full support and compensation from the government.

Earlier in the day, Andhra Pradesh Congress Committee Chief YS Sharmila Reddy demanded "National Disaster" status to the farmers affected by Cyclone Motha. She visited Bantumilli Mandal in Pedana Constituency of Krishna District today to inspect the extensive crop damage caused by Cyclone Motha.

During her visit, she interacted with farmers, observed the devastation firsthand, and expressed deep concern over the unprecedented losses suffered by the farming community.

Speaking to the media, Sharmila Reddy said, "Farmers across the region have lost everything due to the cyclone, which wreaked havoc on thousands of acres of cultivated land. She remarked that the destruction is visible everywhere, with crops completely flattened and livelihoods shattered. Despite such extensive damage, the state government has deliberately understated the extent of the losses in its official reports. The government's preliminary estimate of Rs 800 crore in damages is grossly misleading and far from reality.

According to the Congress Party's assessment, crop damage has occurred across nearly 20 to 22 lakh acres in the state, with losses amounting to more than Rs 20,000 crore. Paddy alone was damaged in over 13 lakh acres, cotton in 3 lakh acres, and groundnut and maize to-

gether in more than 4 lakh acres. Sharmila Reddy said that the government's reluctance to acknowledge the real extent of the damage raises serious questions about its intentions. She wondered if the administration was deliberately downplaying the losses to avoid paying fair compensation to farmers.

She pointed out that farmers were already struggling under heavy debts even before the cyclone struck, and their situation has worsened dramatically since then. Each farmer has invested nearly Rs 35,000 per acre in cultivation, and today, that investment has been completely lost. She accused the state government of failing to conduct proper ground-level surveys and of ignoring the cries of farmers who are desperate for support and relief.

Taking strong exception to the silence of the central leadership, Sharmila Reddy criticised Prime Minister Narendra Modi for failing to even acknowledge the crisis. She said that the Prime Minister visits Andhra Pradesh for political reasons but never speaks about the problems of its people. She alleged that deceiving Andhra Pradesh has become a habit for the Modi government, while leaders like CM Chandrababu Naidu and deputy Chief Minister Pawan Kalyan remain silent spectators, offering tacit approval. She said that the BJP continues to exist in the state only because of the support of the people, but once in power, it conveniently forgets the state's issues. For the Prime Minister, she added, Andhra Pradesh seems to mean only votes, not people.

## Police say Srikakulam temple stampede occurred at unregistered private shrine; no prior permission taken for event

pede that claimed nine lives at the Sri Venkateswara Swamy Temple in Srikakulam occurred at a privately built, unregistered shrine where organisers had not taken prior permission or informed authorities about the event, police officials said on Saturday.

According to officials, the tragedy took place after an iron grill collapsed, causing several devo-tees to fall from a height of about seven feet. At the time, nearly 3,000 to 5,000 people were present at the temple premises for the religious event. Two of the injured are said to be in serious condition.

Srikakulam Superintendent of Police, KV Maheswara Reddy, told ANI that the incident occured within the limits of Kasibugga police station.

"A total of nine people have lost their lives --eight women and one boy. There was a queue; the same queue line was used for entry and exit. The iron grill collapsed, and people fell from around seven feet to the ground, leading to the incident," Reddy said.

He confirmed that the

Temple was constructed on private land without registration or official oversight. "It's a private temple, where a private person has constructed this on his private land. He hasn't taken any permission and hasn't informed the local Police about today's program..., Reddy said.

He said that the police rushed to the site soon after receiving information about the stampede. "In the morning, when we got the information, we had sent the force, but it was too late by then because there was no prior information from the temple person who was organising this program. As a result, there was no communication yesterday or today. Once we have got the information, we have sent it," he said.

SP Reddy added that the situation is now under control. "The situation is peaceful now. Around 3,000-3,500 people were present here. Only two are in serious condition, while the rest of the injured are stable," he added.

Earlier in the day, President Droupadi Murmu expressed shock and grief over the tragedy.





## Dark chocolate, berries may help boost memory and relieve stress

NEW DELHI: Struggling with memory and stress issues? A bite of dark chocolate or a handful of berries may help boost your memory levels and also cut down stress, according to an animal

The improved memory and cognition may be due to flavanols, found abundantly in cocoa and berries, said the team from Shibaura Institute of

Technology, Japan. The study, published in journal Current Research in Food Science,

demonstrated that flavanol intake can trigger wide-ranging physiological responses resembling those induced by exercise -- functioning as a moderate stressor that activates the central nervous system and enhances attention, arousal, and memory. Flavanols also protect against neuronal damage.

"Stress responses elicited by flavanols in this study are similar to those elicited by physical exer-Thus, moderate intake of flavanols, despite their poor bioavailability, and quality of life," said Dr. Yasuyuki Fujii from the Shibaura Institute.

In the study, the team investigated how flavanols affect the nervous system through sensory stimulation. They tested the hypothesis that the astringent taste -- a dry, puckering, rough, or sandpapery sensation in the mouth -of flavanols may act as a direct signal to the brain.

The researchers conducted experiments in 10week-old mice, administering flavanols orally at

can improve the health doses of 25 mg/kg or 50 mg/kg body weight, while control mice received only distilled water.

Behavioural showed that flavanol-fed mice exhibited greater motor activity, exploratory behaviour, and improved learning and memory compared to controls.

Flavanols enhanced neurotransmitter activity across several brain regions. Dopamine and its precursor levodopa, norepinephrine, and its m e t a b o l i t e normetanephrine were



elevated in the brain immediately after the administration.

These chemicals regulate motivation, attention, response, and

Furthermore, enzymes critical for noradrenaline

(tyrosine hydroxylase dopamine-beta-hydroxylase) and transport (vesicular monoamine transporter 2) were upregulated, strengthening the signalling capacity of the noradrenergic system.

In addition, biochemical analysis revealed higher urinary levels of catecholamines -- hormones released during stress -as well as increased activity in the hypothalamic paraventricular nucleus (PVN), a brain region central to stress regulation.

# US review links Israeli forces to widespread rights abuses in Gaza

MI News Service, Washington, DC A classified assessment by the US State Department's inspector general has reportedly found that several Israeli military units were responsible for hundreds of incidents that may constitute serious human rights violations in Gaza during the two-year campaign against Palestinians.

The internal investigation disclosed by 'The Washington Post' represents the first known acknowledgment within the US government of the magnitude of Israeli actions potentially breaching the 'Leahy Laws', which bar American military assistance to foreign forces implicated in atrocities such as torture, extrajudicial killings, or targeting civilians.

Officials familiar with the findings said the inspector general's report was finalized shortly before the recent ceasefire. Two senior US officials confirmed that the assessment documented extensive instances where Israeli conduct appeared to violate these human



rights standards.

The Leahy Laws, authored by former Senator Patrick J. Leahy, were designed to ensure that USsupplied weapons or funding do not enable abuses by allied security forces. However, successive administrations including those of Donald Trump and Joe Biden have consistently avoided enforcing these laws on Israel, despite growing evidence of violations in Gaza

and the occupied West Bank.

One former senior State Department official, Charles Blaha, expressed concern that accountability could fade as attention to the conflict wanes. "My fear is that once the fighting quiets down, so will the calls for justice," he said.

Sources told The Post that reviewing each case could take "several years," partly because of an unusual process specific to Israel.

Unlike other countries where a single objection can halt aid, any decision to restrict military assistance to Israel reportedly requires a consensus among top-level officials, effectively shielding Israel from the usual consequences of Leahy Law violations.

The United States currently provides Israel with \$3.8 billion in annual military aid, making it the largest recipient of American assistance in the world, an amount that increased significantly following October 7, 2023, when Israel launched its devastating military assault on Gaza.

Despite numerous reports by UN agencies and rights organizations documenting widespread destruction, mass civilian casualties, and possible war crimes, Washington has continued to supply arms and funding to Israel. The inspector general's report now raises further questions about US complicity and whether its own human rights laws will ever be applied to its closest ally in the Middle East

### **UK health agency warns of rising** meningitis threat among young people MI News Service, London:

Children and young adults, particularly university students, face an increased risk meningococcal meningitis and septicaemia, the UK Health Security Agency (UKHSA) warned on Thursday, following a nationwide rise in confirmed

UKHSA figures show 378 cases of invasive meningococcal disease (IMD) were recorded in 2024-25, up from 340 the previous year. Most infections involved children and young adults, with the MenB strain responsible for 90 percent of cases in babies and all cases 15-to-19-year-

Health officials cautioned that students startuniversity especially vulnerable due to close contact and communal living. Declining vaccination rates among infants and teenagers have further heightened the risk. "These latest figures are a stark reminder meningitis remains a serious threat to children and young adults," said Public Health Minister Ashley Dalton, urging eligible individuals to get vaccinated. She added that prompt immunization "offers crucial protection against this devastating disease, which can take hold in a matter of hours."

## Hezbollah leader accuses U.S. of fueling "Israeli aggression" in Lebanon

Hezbollah leader Naim Oassem on Friday accused the United States of fueling "Israeli aggression" in Lebanon, saying Washington presents itself as a mediator while working to undermine the country's sovereignty.

"America has given Lebanon nothing and violations," iustifies Qassem said at an event Beirut's southern suburbs, accusing the United States of exerting political pressure on Lebanon. He reaffirmed Hezbollah's commitment to resisting Israel and defending Lebanon's sovereignty. "Every piece or land in Lebanon is

Qassem praised President Joseph Aoun's order for the army to confront Israeli incursions, calling it a "responsible stance" that deserves national backing. He urged the government to strengthen the military to better counter Israel, describing resistance as a "national, not partisan, duty.

Addressing Lebanon's political factions, Qassem warned against internal divisions and "serving Israeli interests." "We ask our partners not to stab us in the back or serve Israeli interests," he said.

## Dalit youth publicly humiliated and beaten in Bharthana, UP MI News Service, Lucknow:

A disturbing incident unfolded in the town of Bharthana in Uttar Pradesh's Etawah district, where a young man from the Dalit community was subjected to public humilia-

tion and assault. The victim, identified as Sumit Diwakar, lodged a formal complaint claiming that on 8 October he was stopped in Rani Nagar locality by three men-Nandan Gupta, Laddu Gupta and Satyendra Kumar, residents of Purana Bharthana Mohalla.

According to Sumit's statement to the police, the accused hurled caste-based slurs at him, forced him to assume the "murga" (rooster) posture in the middle of a road, brutally beat him and threatened to kill him. He said the attackers even recorded the distressing spectacle on video, which later went viral on social media.

Following the complaint and the circulation of the footage, the local Bharthana police registered a case under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act (SC/ST Act) along with relevant provisions of the Indian

The Superintendent of Police (Rural), Shri Shree Chandra, confirmed that the in-

cident was taken seriously; one of the accused has reportedly been arrested and the video is under examination as part of the investigation. He also clarified that while the viral clip clearly shows the assault, one alle-

gation made by the victim of his face being urinated upon has not been corroborated by the evidence so far.

Residents in the area say the incident has rattled the local Dalit community, with many expressing fear and frustration about the slow pace of official action. A number of activists have criticized the silence around caste-based violence, saying that such public acts of humiliation reflect a culture of impunity. The police have appealed to the public not to share rumours and to allow the investigation to proceed based on verified facts.

The viral nature of the video has once again highlighted how digital exposure is forcing authorities to act but also exposing how deeply entrenched caste-based abuse remains in certain regions. As the investigation continues, community leaders are calling for the prompt arrest of all accused and for the state to ensure protection and justice for the victim, so that such incidents do not continue unchecked.

## Israel receives remains from Hamas amid fragile ceasefire

MI News Service: Deir al-Balah: The Red Cross said it transferred the unidentified remains of three people to Israel late Friday but they were still being examined and may not be those of missing hostages, an Israeli military official said.

The source, who spoke on condition of anonymity because they weren't authorized to speak to the media, said the remains had earlier been turned over to the Red Cross by Hamas in Gaza. The handover follows Israel's return Friday of the bodies of 30 Palestinians to authorities in Gaza. That completed an exchange after militants turned over remains of two hostages, in a sign that the tense Israel-Hamas ceasefire agreement is edging forward.

The handover brings the number of Palestinian bodies returned by Israel to 225, only 75 of which have been identified by families, according to Gaza's Health It is unclear if those returned

The terror group's military wing confirmed it handed over the remains of three bodies to Israel.According to the Al-Qassam Brigades, it had offered samples of the unidentified bodies it found, but "the enemy refused to receive the samples and requested to receive the bodies for examination." Hamas said it handed over the remains "to counter the enemy's claims.

He further said, "I am asking Congressman Riley Moore, together with Chairman Tom Cole and the House Appropriations Committee, to immediately look into this matter and report back to me."

Trump asserted that the United States will not idly by when such atrocities are happening in Nigeria and other countries. "We stand ready, willing, and able to save our Great Christian population around the World!" he said.

In June, over twenty people were killed in a mil-itant attack on the home village of a Nigerian bishop, just days after he testified before the US Congress about the persecution of Christians in the country, Fox News reported.

Mark Walker, President Donald Trump's ambassa-dor-designate for International Religious Freedom, told Fox News that the United States must increase pressure on Nigeria to respond to the escalat-

## China using religion and matchmaking to infiltrate Taiwan's society: MAC Dy Minister Shen Yu-chung

MI News Service, Taipei: China is reportedly manipulating religious exchanges and matchmaking programs to subtly infiltrate Taiwan's society and sway public senti-ment, Taiwan's Mainland Affairs Council (MAC) Deputy Minister Shen Yu-chung told lawmakers, as reported by

According to The Taipei Times, during a recent session of the Legislative Yuan's Foreign Affairs and National Defense Committee, Democratic Progressive Party (DPP) legislator Chen Chun-yu cited findings from the Taiwan Information Environment Research Center, revealing that more than 16,000 Taiwanese citizens participated in cross-strait matchmaking activities organised by religious groups in China last year.

Most of these gatherings reportedly took place in Fujian Province, a region long recognised as a focal point of China's "united front" campaigns targeting Taiwan.

Shen emphasised that while the government welcomes genuine cultural and religious exchanges, evidence has emerged that Beijing has embedded political motives into these interactions. He said Chinese temples have been instructed to portray Matsu as a "Chinese goddess," and that many tour packages connected to these religious events include pro-Beijing propaganda and narratives designed to shape the participants' perceptions.

The Chinese Communist Party is using religious celebrations and matchmaking platforms to bring young Taiwanese closer to Chinese citizens, subtly pushing a shared cultural identity that undermines Taiwan's sovereignty, Shen stated. He warned that such efforts reflect a deliberate soft-power strategy by Beijing aimed at advancing cultural assimilation and long-term influence over Taiwan's younger generation, as cited by The Taipei Times.

## US: 13-year-old suspect in grandmother's murder shot dead during chase

MI News Service, Washington DC: A 13-year-old boy was shot and killed by a deputy in US's North Carolina after he allegedly charged at the officer with a piece of lumber during a chase, Associated Press reported.

The incident occurred on Thursday and is now under review by the State Bureau of Investigation, as per standard protocol.

According to officials, as per AP, the sequence of events began unfolding in Raeford, about 90 mile southwest of Raleigh, where deputies discovered 68-year-old Connie Linen dead inside her home during a welfare check. The Hoke County Sheriff's Office identified her death as a homicide and named her grandson — the 13-year-old — as the primary suspect. Paperwork had already been completed to charge him with first-degree

murder.

Later, Lee County deputies located the boy behind an abandoned mobile home in the Cameron area. When officers approached, he fled, grabbed a two-by-four piece of wood from a nearby yard, and allegedly charged toward a deputy. The officer then fired, fatally striking the teen.

The Lee County Sher-iff's Office described the boy as being 5 feet 11 inches tall and weighing 150 pounds. No additional details about the shooting or the investiga-

tion have been released.

"This has been a tragic and emotional situation for everyone involved," Hoke County Sheriff Roderick Virgil said in a statement on Friday. "We ask that our community come together with compassion and understanding as we all process this difficult event," Virgil added.

Earlier on October 24, another earthquake of magnitude 3.7 struck the region at a shallow depth of 10km, making it susceptible to aftershocks.

Pakistan. Shallow earthquakes are generally more dangerous than deep earthquakes. This is because the seismic waves from shallow earthquakes have a shorter distance to travel to the surface, resulting in stronger ground shaking and potentially more damage to structures, as well as

greater casualties. Afghanistan, Pakistan,

and northern India lie in one of the most seismically active zones in the world, where the Indian and Eurasian tectonic plates meet. The region fre-quently experiences modearthquakes, often felt across borders due to the proximity of fault lines.

Pakistan is among the seismically active countries in the world, crossed by several major faults.

This collision zone makes the country highly vulnerable to violent earthquakes. Provinces such as Balochistan, Pakhtunkhwa, and Gilgit-Baltistan lie on the southern edge of the Eurasian plate, while Sindh and Punjab are located on the northwestern edge of the Indian plate, contributing to frequent earthquake ac-

Balochistan is located near the active boundary between the Arabian and Eurasian tectonic plates.

Other vulnerable re-

gions, such as Punjab, which lies on the northwestern edge of the Indian plate, are susceptible to seismic activity. Sindh, though less prone, is still at risk due to its location.

## 'Officially hanging up my racquet': Rohan Bopanna announces retirement ed me why I started and who I am.

Grand Slam winner Rohan Bopanna announced his retirement from professional tennis on Saturday, bringing an end to his 20-year-long celebrated career, which saw him bring many laurels to the country.

Bopanna's decision to hang up his boots came days after his last appearance at the Paris Masters 1000, where he teamed up with Alexander Bublik. The duo ultimately lost the Round of 32 match, falling 5-7, 6-2, 10-8 to John Peers and James Tracy.

"How do you bid farewell to something that gave your life its meaning? After 20 unforgettable years on tour, it's time I'm officially hanging up my racquet," he wrote in a lengthy social media

widely regarded as one of India's greatest tennis players, Bopanna built a remarkable lega-

cy based on a powerful serve, deft net skills, and a lasting influence in both men's and mixed doubles. Over a career spanning more than twenty years, the 45-year-old has been a cornerstone of Indian tennis, representing the nation with pride in numerous Davis Cup campaigns and at the Olympic Games.

breakthrough Bopanna's moment came in 2017, when he lifted the French Open mixed doubles title alongside Gabriela Dabrowski, cementing his place among the sport's elite. Yet, it was in 2024 that he achieved one of the most extraordinary feats of his career - clinching the Australian Open men's doubles crown and ascending to World No. 1 at the age of 43, a testament to his resilience, professionalism and

enduring love for the game.

"As I write this, my heart feels
both heavy and grateful. Starting my journey from a small town of



Coorg in India, chopping blocks of wood to strengthen my serve, jogging through coffee estates to build stamina and chasing dreams on cracked courts to standing under the lights of the biggest arenas in the world - it all feels surreal. Tennis hasn't been just a game for me - It has given me pur-

pose when I was lost, strength when I was broken and belief when the world doubted me, Bopanna's post read.

"Every time I stepped onto a court, it taught me perseverance, resilience to rise, to fight again when everything inside me said I couldn't - and most of all, remindTo my wonderful parents - you are my heroes.

You gave me everything so I could chase this dream. The sacrifices you made, the quiet strength you carried, the faith you never lost...I owe it all to you. To my sister, Rashmi - you've been my gentle constant and my cheerleader through it all.

You've always seen the best in me, even when I couldn't. To my family - thank you for being my anchor, my safe haven, and the love that kept me standing through every high and low.

## IND-A vs SA-A: Rishabh Pant scores 64 not out to conclude evenly poised Day 3

BENGALURU: India A finished at 119/4 in the final innings against South Africa A in what was an evenly-poised outing for both sides on Day 3 of the first unofficial test, happening here at the BCCI Centre of Excellence Ground 1. India A survived an early scare as they kicked off the fourth innings, courtesy of Rishabh Pant's half-century.

To start the proceedings on Day 3, Gurnoor Brar got an early breakthrough in the first session to add pressure on the visitors. Just when the opposition batters looked to get going, Manav Suthar made his first strike as the hosts continued to enjoy

Tanush Kotian finished his eight-over spell with four wickets while Anshul Kamboj picked three as the Rishabh Pant-led India A held the visitors to 199 runs in their second innings. With that, the hosts set themselves a 275-run target, with more than two days in hand to chase. However, India's start to the final innings was not as they would have hoped, as the team's top-order faltered. The South African bowlers made early inroads as India's top three -- Sai Sudharsan, Ayush Mhatre, and Devdutt Padikkal -- walked back to the dugout scoring 12, 6, and 5 runs, respectively.

Tshepo Moreki got his side an early breakthrough by dismissing India A opener Mhatre before Okuhle Cele joined his team's celebrations by sending Padikkal



packing. With that, India were reduced to 25/2 in nine overs before the teams took Tea.

The third and final session of the day was relatively slow as middle-order batters Pant and Rajat Patidar played sluggish knocks to save their wickets. The duo shared an 87-run partnership in 148 deliveries before Tiaan van Vuuren struck.

Patidar fell prey to the 24year-old all-rounder as India A sustained another blow before the close of play. Ayush Badoni survived a scare on the final delivery of the last over of the day as India ended the session scoring 94 runs at the loss of two wickets. India A need 156 more runs to

win with six wickets in hand heading into Day 4, with Pant, unbeaten on 64, and Badoni (0 not out) in charge of the batting. Brief scores:

After repeated interruptions and overcast skies, only 31 overs could be bowled on the first day, with Jharkhand reaching 91 for 2 at stumps. Opting to bat first after winning the toss, Jharkhand's top order had to contend with a damp pitch and a bit of swing in the early overs. Opener Shikhar Mohan displayed grit and composure, holding the innings together with a patient unbeaten 42. He looked confident against both pace and spin, driving fluently whenever the bowlers erred in length. At the other end, captain Virat Singh joined Mohan after the early dismissals and steadied the ship with an assured 16 not out. The pair added valuable runs through sensible batting, showing maturity and restraint as the bowlers extracted some move-

ment off the surface.

Earlier, opener Sharandeep Singh got off to a promising start, striking a few crisp boundaries, but his stay was cut short for 22 when he was trapped in front after misjudging a delivery that nipped back in. The second wicket fell soon after, putting Jharkhand briefly under pressure before Mohan and Virat steadied the innings.

Nagaland's bowlers, led by Jonathan Rongsen and Saurabh Kumar, bowled disciplined spells, sharing one wicket each. Despite the limited play, both extracted decent movement under cloudy conditions, keeping Jharkhand batters in check.

Persistent drizzle and a wet outfield meant that play began late and was further reduced by fading light in the evening session.

## Women's World Cup: Once India crosses ropes, all good work will have to be redone again, says Anjum Chopra very close to my heart, as to how that

NEW DELHI : A new champion will be crowned when the 2025 Women's ODI World Cup on Sunday will see India and South Africa both chasing a historic first title at the DY Patil Stadium in Navi

For the hosts, who won the U19 Women's T20 World Cup earlier this year, a run to the final has been brightened by a stunning semi-final win over Australia, which in turn has electrified fans and reignited hopes of a lasting legacy for women's cricket.

Anjum Chopra, the former India captain, has been present at every game of the Indian as part of her commentary work in the tournament. Ahead of the final, Anjum took out some time from a hectic schedule to speak exclusively to IANS on the final, witnessing an epic semi-final win, its architects and more. Excerpts:


Q. From your vantage point, how do you see the Indian team shaping up for the final?

A. So the crystal ball is something that I don't have. But there are very many indicators to feel confident about the fact that India should be in a good space getting into the final. That's about as essential as it is before starting a World Cup final. But the moment they cross those ropes and they're in it at the start of the game till the end, I think it will all have to be redone.

All the good work will have to be redone all over again, because that's something where the scores start from 0-0. Of course, getting into the final, the confidence will be there, yet again when you are in a big game, you still have to play the ball to its merit, score runs or chase down the target.

Q. What were your emotions while watching India win that semi-final over a mighty Australia?

A. I was as calm as what I saw the chase to be and having this conversation with a couple of people from the Indian team as well on the ground later. I asked them, how did they maintain their calmness on and off the field? What they just told me; I reflected it back on what I was doing at that time



was very good and conscious awareness of remaining in the moment, contest. and being in the present. That was just a reminder and an indicator for me as well that whilst I'm watching the game as a broadcaster, obviously, I'm seeing it as a player also. But how to remain in that very moment and believe in the process that the team is showcasing out there in the centre in all possible manner, I was telling myself that it really doesn't matter how we start, or what is the middle phase.

It was like let's wait till the end of the match, or the last ball of this 100over contest is bowled and then we'll know what the result is. Let's not think of what is happening, whether it is good or bad. We'll see what the result of this match is, and that's how I played it out in the entire 100 overs.

Q. Jemimah Rodrigues' unbeaten 127 was not just a match-winning knock, but a statement of maturity and control. How do you see her shaping for the final? A. So, I personally feel that it (the lows Jemimaĥ had before the Navi Mumbai leg began), happens to any and every cricketer. Any cricketer or sports person who comes into a team like an Indian team will find themselves in a situation where things are not going ideally the way that they would want it to be. For Jemimah also to find it out it's not only Jemimah. I mean, there are players in this Indian team who have not even got a game.

There are players who, when they come into the Indian team, even in the future, will find themselves in difficult scenarios. So, it's a very normal life for a person in a team, especially in an Indian team. But how you come out of it is obviously a very individual battle, as Jemimah put it rightly, that she was in tears almost every night right through this World Cup and various other things that she said.

So, it's about how that player comes out and showcases on the stage that they are put on. She did very well in the game against New Zealand by getting a quality 70-odd runs (76 not out) in a crucial game. She did very well in the field, even when she was left out from the Indian eleven against England. Prior to that also, when she played in the game against Australia, she fielded really well. So, that was always up to her, how she manages her skill, and temperament, but how she has come out is for everyone to see. That's all credit to her and how she has made sure that when she comes out, she's able to deliver on that front. It's never been an alone journey. You don't rise in an individual manner, but you can fall as an individual.

But when you look at that rise again, it's never an individual journey. There are many people who have assisted her. There are many people who would have helped her. It's a compliment to everyone by the kind of performance that she showcased on the ground.

Q. Harmanpreet Kaur hit a crucial 89 in the semi-final. What is it about her game or mindset that allows her to hit those high notes in knockouts?

A. It's nice. As I said, every moment of that game is something that I have

game was played out. Not only because the result makes it out to be so sweet, but the manner in which the cricket was played. Again, I say the way we started bowling, fielding, then the

So, when Harman came in at the fall of Smriti's wicket, I saw her walk from the dugout onto the centre, then how she was taking guard, stance and played that first run down the ground. From there on, I was very surprised that she got out the way she got out. I thought she would not make a mistake as she did in the game against England 70 off 70.

But probably there was a little concentration error or for whatever reason, she got out. But it was very special to see Indian cricket, and the women's cricket game, shift a gear or shift a base completely, not just a gear, but shift a base.

It was just in terms of how the game was played out, how the result came out. how individuals have participated in getting this result for the Indian cricket team. This victory against Australia is a massive shift in the women's game in India and globally The game has actually magnified this shift, with the result going India's way.

Q. How do you see this Indian team going from the emotional high of a semi-final win to resetting for the final?

A. Next morning, they would have been very normal. I mean, after the game, it was a high, they would have gone back and I'm sure there were celebrations and speeches. We saw a few that came out from the handle of the Indian women's cricket team. They would have celebrated, gone back to their rooms, and slept.

Next morning at breakfast, it might have been smiles. But I'm pretty certain that by next afternoon, everything would have been back to normal. Because a team or players who would have prepared in the manner they would have to get this sort of result would not let them go out of that zone for too long a time.
