Confusion erupts in BLOs training sessions

in Bengal before SIR MI News Service, Kolkata: As the political atmosphere in West Bengal has heated up over the Election Commission's decision to conduct Special Intensive Revision (SIR) of the voters list, hundreds of Booth Level Officers (BLOs) in West Bengal have raised their voice in protest during their on the job training On Saturday and Sunday, fresh controversy emerged after disruptions were reported during the three day of training sessions of Booth Level Officers (BLO) in Kolkata and several districts. According to informed sources, government staff raised obections regarding official duty status, working hours and security cover. Many teachers assigned as BLOs alleged that their schools marked them "absent" during the training hours. They demanded that they should be marked "on duty" for those days. Teachers also sought central security cover during their month long job and warned that they will not work without adequate protection. Several women teachers also refused to work after evening hours without security cover. A large number of BLOs also raised issues with being forced to work beyond duty hours. However, Election Commission sources said the demand for central security cannot be accepted as law and order is a state subject. Meanwhile, TMC state General Secretary and party spokesman Kunal Ghosh said the state government was unaware that teachers were being appointed as BLOs. He said the SIR exercise forces teachers to work beyond regular duty hours and this had created problems for them. He added that the education department had no prior knowledge about this BLO deployment. the ruling Trinamool Congress and Chief Minister Mamata Banerjee have openly opposed the SIR exercise. 

MI News Service, Hyder**abad**: At least 24 people were killed and four others suffered injuries when a tipper lorry carrying gravel collided head-on with a crowded public bus in Ranga Reddy district of Telangana on Monday, police said. Among the deceased 10 were women, the police added. After the collision the Telangana Road Transport Corporation (RTC) vehicle near Chevella this morning, the bus was completely destroyed causing so many casualties.. ED attaches assets worth over Rs 3,000 Cr of Anil Ambani in money laundering case

MI News Service, New Delhi ; In a major crackdown on big corporate entity, the Enforcement Directorate (ED) has attached assets worth more than Rs 3,000 crore linked to Reliance Group Chairman Anil Ambani as part of a money laundering investigation against his group companies, official sources said on Monday. The federal probe agency has issued four provisional orders under the Prevention of Money Laundering Act (PMLA) for attaching the properties, including the 66-year-old Ambani's house in Pali Hill, Mumbai, apart from other residential and commercial properties of his group companies, they said.

A plot of land belonging to Reliance Centre on Maharaja Ranjit Singh Marg in Delhi and multiple other assets in the national capital, Noida, Ghaziabad, Mumbai, Pune, Thane, Hyderabad, Chennai and East Godavari have also been attached. In a statement the Enforcement Directorate today said that it has provisionally attached over 40 properties of the Reliance Anil Ambani Group, including the family's famed Pali Hill residence in Mumbai, in a money laundering case, with the total value of the seized assets exceeding Rs 3,000 crore. Mystery deepens over student's death in residential school

MI News Service, West Bardhman: A fresh wave of shock has rippled through West Bardhman following the mysterious death of a ninthgrade student inside a private residential school hotel. The body of the deceased teenager, identified as 14-year-old Shambhu Kumbhakar from Kenda in Purulia, was found hanging in the hostel premises late Sunday night. According to sources, Sham-

bhu was a class 9 student at Ramkrishna Sarada Mission Vidya Mandir in Kenda. The school authorities reportedly rushed him to Chakoltod Rural hospital, where doctors declared him dead on arrival. The discovery has sparked intense tension in the locality, with hundreds gathering outside the school premises in protest. Agitated residents later blocked the Kenda- Tamna state road, alleging negligence and lack of transport by school authorities. Family members of the deceased have accused the institution of concealing crucial details about the incident, "We were not informed about what exactly happened. We learned from others that he had already died by the time we reached the hospital,' alleged a relative. Preliminary reports suggest the students was found hanging inside the hostel when most boarders had gone for dinner. The warden reportedly discovered the scene upon checking the rooms. Police from Kenda station reached the spot to bring the situation under control as protest intensified. What has further deepened public suspicion is the eerie similarity with another recent case in West Medinipur, where the body of 18-year-old Abhinandan Samanta a secondary examination candidate, was found hanging inside a school building at Daskagram Satish Chandra Saravarthasadhak Shikshasadan High school under Sabang police station. In that case too, the boy's body was discovered after he had gone missing from the hostel in the morning. Local residents and parents' groups have demanded a through investigation into both incidents, citing rising concerns over student safety in residential institutions across the region. Police have initiate inquest proceedings, while the exact cause of Shambhu's death awaits confirmation the post-mortem examination.

Bloodshed on Bengal border: Officers assaulted by cattle smugglers

News Mursidabad: Violence erupted late Sunday night in the porder areas of Samsergan, Mursidabad, when a police team came under attack while attempting to stop cross-border cattle smuggling. Two personnel, including a civic volunteer, sustained injuries in the assault, sending tension ripping across the Nimtita-Dhanghara stretch along the Indo-Bangladesh border.

Acting on the tip-off, officers from Samserganj police station launched a late-night raid in Dhanghara, a region notorious for cattle smuggling routes leading directly into Rajshabi , Bangladesh. As police confronted the traffickers, a violent clash broke out. During the scuffle, smugglers allegedly assaulted the officers with sticks and stones in a bid to escape. Despite injuries, the police managed to overpower and arrest two accused-identified as Babar Sheikh and Rami Sheikh, both residents of Dhanghara. The duo was produced before the Jangipur Sub-Divisional Court on Sunday. Police suspect the arrested men acted as local facilitators for cross-border smuggling networks. Several others involved in the attack fled the scene, and search operations are underway. Three cattle were recovered during the raid. Law enforcement officials said the area's proximity to the international border and the ease of crossing through fenced zones have made Dhanghara a long-standing hub for illegal cattle movement. Officers fear that organized rackets, with possible cross-border links, are using remote riverine routes to smuggle livestock into Bangladesh. The incident has once again thrown the spotlight on rampant cattle trafficking in Bengal's border belts—a problem that has persisted for years despite repeated crackdowns. Local residents expressed shock that police personnel themselves came under attack while performing their duty to curb the illegal trade.

Medical student assault: Two accused may turn witnesses

Durgapur: The ongoing case surrounding the alleged assault of a second-year medical student from Durgapur Medical College took a new turn on Monday as legal teams clashed in court over the chargesheet filed by the police. The defense argued that the chargesheet was submitted "under pressure," while government lawyers proposed that two of the accused be turned into witnesses in accordance with legal provisions.The development came during a hearing at the Durgapur Subdivisional Additional District Court, where all six accused were brought from jail custody. Representing the prosecution, government lawyer Bivas Chatterjee asserted that the investigation was completed swiftly and efficiently, with the police filing their final report on October 30—just 20 days after the alleged incident. Bivas Chatterjee said the chargesheet marked a breakthrough for the Asansol-Durgapur Police Commissionerate, which prepared after an intensive investigation. We have petitioned for trial proceedings to begin at the earliest and expect the process to conclude within two months,"

Bivas Chatterjee stated. According to the chargesheet, three of the accused have been charged with gang rape and robbery, while the remaining two face charges of robbery and aiding in the assault. Police sources maintain that one of the accused committed the sexual assault, while the others directly assisted him, thereby constituting an act of gang rape under the law. However, the defense has strongly refuted the police version. The lawyer representing the accused classmate of the victim argued that the investigation was rushed and the chargesheet filed within 20 days despite the Investigating Officer having 90 days for evidence compilation. The defense counsel alleged that his client had been unlawfully detained at the police station prior to his formal arrest

sion of CCTV footage from those days as evidence. The defense further contended that pressure from higher authorities influenced the timing of the police report, calling the chargesheet's validity into question. "This was done to satisfy external pressure rather than ensure due process," the counsel claimed before the court. Following arguments from both sides, the court ordered that the six accused be remanded in judicial custody for one more day. The next hearing has been scheduled for Tuesday. The incident, which occurred on the night of October 10, sent shockwaves through the Durgapur Medical College community. According to police, the victim was abducted and physically assaulted by a group of youths, including her own classmate. The case has been one of the most high-profile investigations undertaken by the Asansol-Durgapur Police Commissionerate this year, with authorities promising swift

BJP alleges irregularities in **BLO** appointment in Burdwan

Burdwan: The BJP has once again raised sharp questions over the appointment of Booth Level officers (BLOs) in Burdwan, alleging large-scale procedural violeaders claim that several BLO positions have been filled illegally, allegedly in a manner that benefits the ruling TMC.

At a press conference on Sunday, BJP's Burdwan District president Abhijit alleged that at least 20 BLOs appointed in Burdwan South constituency do not meet the Election Commission's stipulated criteria. The party has submitted a detailed list of names of the Commission, seeking immediate intervention and review. "The work has not been conducted as per the Commission's guidelines," Abhijit told re-

Family alleges negligence after transfusion mishap in Gangarampur

MI News Service, South Dinajpur: A shocking case of medical negligence has surfaced at Gangarampur Super Specialty Hospital in South Dinajpur, where a young woman reportedly fell critically ill after being administered blood of the wrong group. The incident triggered protests inside the hospital premises, prompting police intervention to control the situation. The victim, identified as 22-year-old Moushumi Mardi of Goalgaon in Kushmandi block, had been undergoing treatment for severe anemia. She was initially admitted to Kushmandi Rural Hospital but later referred to the Gangarampur Super Specialty Hospital as her condition deteriorated. Doctors reportedly advised an urgent blood transfusion after discovering a sharp drop in her hemoglobin count.

According to the patient's family, hospital authorities collected a blood sample from Moushumi and sent it to the Gangarampur Blood Bank. Based on the report, the blood bank provided a unit of AB positive blood, which was subsequently transfused. Within minutes of the procedure, the patient allegedly developed spasms and acute physical distress. Her condition worsened rapidly, forc-



tal on Sunday afternoon. Angered by the incident, family members and local residents gathered at the hospital and staged a protest, accusing the staff of gross negligence and mishandling of the transfusion process. Panic gripped the campus as the situation turned tense, and a large police contingent from Gangarampur police station, including a combat team, was deployed to restore order. Chief Health Officer of Dakshin Dinajpur, Dr. Sudip Das, confirmed the transfusion reaction but urged caution against premature conclusions. "The patient was in a critical condition when admitted, with very low hemoglobin levels. During the transfusion, complications occurred, and she was referred to Malda Medical College for further management. The matter is under thorough investigation,' he stated. Authorities have initiated an internal inquiry to determine whether a procedural lapse at the blood bank or in the transfusion process led to the adverse reaction. No formal complaint has yet been lodged with the police. The incident comes close on the heels of similar allegations in other hospitals across the state, raising renewed concerns about blood safety protocols and accountability in government-run medical institutions.

Strong message from TMC's Bangaon Chief: Get active or step aside

'Those who are ready to work on the ground-let them come forward and take charge," he stated from the stage, urging greater accountability from local units. Calling the BLA-2 assignment a critical link in electoral groundwork, Das reminded his cadre that superficial or symbolic participation would not yield lasting results. "This is a three-month task that must be taken seriously," he noted, emphasizing that sustained effort alone could secure the party's success in challenging constituencies like Bagda. Without naming anyone, Das warned against over-reliance on past victories or local-level maneuvering, saying that such complacency could undermine broader political goals. MLA's hospital function sparks political storm



MI News Service, Dhupguri: A controversy has erupted at Dhupguri Sub-Divisional Hospital in Jalpaiguri after a public address programme was reportedly held beside the hospital's labour ward to mark the commencement of a new building The event, organized to thank Chief Minister Mamata Banerjee for approving the hospital's expansion plan, has drawn criticism for allegedly violating hospital protocols. According to reports, a loudspeaker was used during the thanksgiving programme, staged adjacent to the labour ward where patients were undergoing treatment. The event coincided with the beginning of work on a six-storey hospital block, for which the state government has sanctioned more than 28 crore rupees. Chief Minister Mamata Banerjee had virtually laid the foundation stone for the project on May 19 earlier this year. The gathering was attended by

Dhupguri MLA Nirmal Chandra Roy,

acting as chief guest, along with Trinamool district and block-level leaders, including INTTUC Block President Alam Rahman, Dhupguri Rural Block President Malay Roy, Town Trina-mool Core Committee Member Anita Singh Roy, and Youth Congress Town President Shuvo De Sarkar. However, the location and manner of the event have triggered sharp reaction from opposition groups, who labeled it "insensitive and inappropriate" to host a political celebration so close to a sensitive medical zone.Dhupguri Block Health Officer Ankur Chakraborty admitted that while the organizers verbally informed him about a programme, no formal permission was obtained for using the hospital premises. "No written approval was taken from me. I was told about a small program, but I was not aware that microphones were being used. Use of loudspeakers inside hospital premises cannot be justified under any circumstance," he said. Responding to the controversy, MLA Nirmal Chandra Roy denied the allegation of high-volume microphone use. "No loud microphone was played. The event was organized by the civic society to express gratitude for the new hospital building. I was not aware of any restrictions regarding microphone use within hospital premises," he said. The incident has once again brought into focus recurring questions about political functions being held in public healthcare premises. Woman dies amid SIR confusion. political storm follows

Hooghly: Fresh tension has gripped parts of Hooghly district amid the ongoing Special Intensive Revision (SIR) of voter lists, following the death of an elderly woman in Dankuni and the illness of another resident in the same locality. The ruling Trinamool Congress has blamed the SIR process for spreading fear and anxiety among citizens, while the BJP has dismissed the allegations as politically motivated. The deceased, identified as 60-year-old Hasina Begum, was a resident of Ward No. 13 under Dankuni Municipality. In recent years, she had been living with her daughter in Ward No. 20. Local residents said Hasina had been deeply distressed over remarks and discussions surrounding the SIR process—an extensive verification exercise

being undertaken across the state. According to witnesses, Hasina collapsed suddenly on Sunday evening while return-

ing home. "She sat down by the roadside holding her head. We rushed her home, but she was unconscious. Doctors at the hospital declared her dead," said a neighbor. Dankuni Municipality Chairperson Hasina Shabnam visited the family on Monday morning and directly linked the death to growing fear over voter list revisions. "Her name wasn't in the 2002 list, and that created panic. We've been urging people to stay calm, but I don't know how many more lives will be lost to this fear," Shabnam said. She also claimed that another local resident suffered a cardiac problem triggered by similar anxiety related to the revision drive. The SIR process has already

triggered controversy in several districts including Agarpara, Ilambazar, and East Burdwan, where residents and local leaders reported confusion over voter verification procedures. Rejecting the allegations, BJP leader Debashish Mukherjee accused the ruling party of manufacturing panic for political gain. "There is no reason for fear over the SIR. Interestingly, the Chief Minister herself once supported this very process back in 2002. At that time, 69,000 names were left out of the draft list, but she had then shifted the blame to the Left government. Today, her party is doing the same, Mukherjee said. The incident has further intensified the political crossfire over the SIR process, which opposition parties say is being politicized by both sides in the run-up to next year's polls.

Tribal woman dragged, brutally beaten in love triangle feud

News Birbhum: A shocking incident of violence against a tribal woman has surfaced in Birbhum district, sparking political outrage and renewed debate over women's safety in rural Bengal. The victim, a resident of Amgachi village in Siuri, was allegedly dragged from her home, taken to a forested area, and brutally assaulted on Sunday evening. According to police sources, preliminary investigations suggest that the assault stemmed from personal enmity linked to a relationship dispute. The woman, who had been living alone for some time after separating from her husband, reportedly developed a romantic relationship with an individual named Suku Soren. In recent months, however, she became friendly with another man, which allegedly enraged Soren.

Police believe Soren, accompanied by his associate



Bablu Tudu, stormed into the woman's home, assaulted her, and later dragged her nearly one and a half kilometers before continuing the assault in a secluded area. Hearing her screams, local residents intervened and rescued the severely injured woman. She was admitted to Siuri Hospital and later shifted to Burdwan Medical College and Hospital as her condition deteriorated. Hospital sources said she has been placed under close observation and is currently stable. Siuri police have since arrested both accused individuals. Investigators are examining whether other persons were involved and are awaiting medical reports to verify

the extent and nature of the assault. Meanwhile, the incident has ignited political confrontation in Birbhum. Local BJP leaders alleged that the woman was gangraped and accused the police of attempting to downplay the crime. "The police are shielding the culprits under political pressure. We confronted them because they are not acting with seriousness," said local BJP leader Deepak Das. Police have refuted the allegations of inaction, stating that arrests were made promptly after the complaint and that an indepth inquiry is underway. Trinamool Congress leaders have yet to issue a statement on the incident. The brutality of the attack and the political reactions surrounding it have sparked widespread public anger, with demands for transparency in the investigation and accountability from local authorities.

Sovan Chatterjeere joins TMC with Baisakhi Banerjee

MI News Service, Kolkata: After a gap of seven years, former Kolkata Mayor Sovan Chatterjee has offi-cially returned to the Tri-namool Congress (TMC) ahead of the upcoming As-sombly elections. Accompasembly elections. Accompanied by Baisakhi Banerjee, he rejoined the party on Monday at the TrinamoolBhavan, where senior leaders Aroop Biswas and Sub-rataBakshi handed them the party flag. Speaking to re-porters after his return, Chatterjee said he intended to work actively to strengthen the party. Just a month ago, Chatterjee had made a comeback in public administration when he was appointed Chairman of the New Town Kolkata Development Authority (NKDA). Before this appointment, he and Baisakhi reportedly held several rounds of discussions with Chief Minister Mamata Banerjee and Abhishek Banerjee, paving the way for his formal reinstate-ment in political activities. Party insiders suggest that Sovan Chatterjee will play a key role in the party's campaign strategy for the up-coming elections. His return is seen as a strategic boost for TMC as it prepares to consolidate its organizational base. In 2018, Sovan Chatterjee resigned abruptly from his posts as Kolkata Mayor and Cabinet Minister, distancing himself from active politics. Later, ahead of the 2021 Assembly elections, he and Baisakhi Banerjee joined the BJP in Delhi and were announced as star campaigners. However, their stint with the saffron camp was short-lived, and they soon drifted away from the party. Over the past year, the duo rekindled their ties with Trinamool leaders, and Sovan gradually reconnected with several old colleagues. Despite his political hiatus, he continued to maintain personal contact with Mamata Banerjee, notably visiting Mamata her residence during Bhai Phonta celebrations each year. Recently, multiple private meetings were held between the Chatterjee-Banerjee duo and Abhishek Banerjee. This was followed by a significant meeting with Mamata Baneriee at Richmond Hill in Darjeeling, which reportedly finalized his political return. Soon after, Sovan was given the NKDA chairmanship -

swift breakthrough, Kolkata Police cracked the Haridevpur shootout case within just three hours on Monday morning, arresting the accused, Bablu Ghosh, from a car near the Police Training School (PTS). The incident, which unfolded early in the day, saw Bablu allegedly shooting his lover, MousumiHaldar, before fleeing the scene.According to police sources, Bablu was attempting to escape in a rented car after locking up his house and taking his belongings. Acting on intelligence inputs, a team led by Sub-Inspector JaydebBairagi from Haridevpur Police Station traced the vehicle using its registration number and intercepted it near PTS. Officers described the quick arrest as a major achievement for the city police. The shootout occurred around 6:30 a.m. when 50-year-old MousumiHaldar stepped out for her morning walk. Two men on a motorcycle reportedly approached her and opened fire, hitting her in the back. Before collapsing, Mousumi managed to name her attacker—Bablu Ghosh. Eyewitnesses confirmed her statement, identifying Bablu as a local poultry trader who was known to have an extramarital relationship with the victim. Investigators believe the attack stemmed from personal tension in their relationship.

Fake social media profile of exminister triggers cyber fraud probe

MI News Service, Kolkata: A case of cyber fraud has been reported involving a fake social media profile created in the name of former West Bengal minister and exchief secretary Manish Gupta. The Kolkata Police's cyber crime division at Lalbazar has initiated an investigation after Gupta recently lodged an official complaint, though the incident reportedly occurred several months ago.

According to police sources, cyber fraudsters allegedly created a fake Facebook account using Manish Gupta's name and photograph. They also used his image on a WhatsApp profile and began sending messages to people known to him. Because the fraudsters used the former bureaucrat's photograph on both platforms, many of his acquaintances believed the messages were genuine.

Investigators revealed that the scammers sent messages to several of Gupta's contacts, claiming an urgent need for money and requesting immediate financial help. Believing the requests to be authentic, some individuals reportedly transferred money to the bank accounts provided by the fraudsters. Once Gupta became aware of the situation, he personally alerted his acquaintances to beware of the fake profile and not to respond to such messages.

CM Mamata proud as Bengal's Type-1 diabetes model earns global acclaim



MI News Service, Kolkata: West Bengal's healthcare initiative to combat Type-1 diabetes has earned global recognition, positioning the state as a model for the world in fighting the disease. The programme — the first staterun initiative of its kind in India — has been hailed by Harvard Medical School Associate Professor Dr. Gene Bukhman, an international expert on non-communicable diseases. Dr. Bukhman recently visited SSKM Hospital in Kolkata and lauded Bengal's structured healthcare model for treating children and adolescents with Type-1 diabetes. Following his visit, Chief Minister Mamata Banerjee shared the news on social media expressing pride in the state's achievement. "I am delighted to announce that the 'Bengal Model' to fight Type-1 diabetes has become a global model to emulate," she wrote. The Chief Minister also congratulated all medical professionals and administrators associated with the initiative for their success. Earlier this year, the International Society for Pediatric and Adolescent Diabetes (ISPAD) had selected the its excellence in providing advanced healthcare facili-ties for young diabetes patients. This recognition, experts say, highlights Bengal's leadership in developing a sustainable, organized public healthcare network for managing Type-1 dia-betes — a chronic autoimmune disorder primarily affecting children and adolescents. Medical experts explain that diabetes is generally classified into Type-1 and Type-2. Type-1 diabetes results from genetic or autoimmune factors where insulin-producing cells in the pancreas are destroyed, stopping insulin production. Although symptoms of both types are similar, the prevalence of Type-1 among children has increased significantly, linked to modern lifestyle and dietary habits.

To address the rising burden, Bengal's Department of Health and Family Welfare launched a state-level public health programme dedicated to Type-1 diabetes care. Spelished in every district, offering regular treatment and counselling services. India has one of the world's largest populations of children with Type-1 diabetes, yet West Bengal remains the only state with such a comprehensive, government-driven care system. The initiative began with four districts and later expanded to eleven more. Notably, the National Health Mission does not include juvenile diabetes treatment under its central programme, prompting Bengal to act independently.

SIR of Voter List to Begin on November 4; BLOs to Visit Homes for Enumeration

MI News Service, Kolkata: The Special Intensive Revision (SIR) of the voter list is set to begin from Tuesday, November 4, across nine states and three Union Territories, with the most crucial part of the process the Enumeration phase kicking off. For the first time, voters will directly experience this stage of the SIR as Booth Level Officers (BLOs) begin door-to-door visits to distribute and collect enumeration forms. From November 4 to December 4, BLOs will visit households, explain how to fill out the forms, and later collect them. Each BLO will make up to three visits to a voter's residence if necessary. The Election Commission announced the SIR on October 27, and at midnight that day, the 2025 draft electoral roll was officially frozen. BLOs will visit the homes of individuals whose names are already on the current draft voter list to deliver the forms. Each BLO,

carrying an official ID issued

by the Election Commission,

will provide two copies of the enumeration form to every voter — one must be signed and returned, while the other can be kept by the voter. If a voter is not present at home, the BLO will leave the form in the letterbox, under the door, or through a window, and return later to collect it. No documents are required during form submission

during form submission. The forms provided will be partially pre-filled, containing existing voter details. Voters will only need to verify and update any changes. A blank box will be provided where each voter must attach a recent color passport-size photograph one photo for the submitted form and one for their own copy. If a BLO fails to meet a voter after three visits, the voter can also submit the enumeration form online, which will later be verified by the BLO. Only after the publication of the draft electoral roll will voters need to furnish one of 11 accepted identity documents, as per official notice.

ED attaches assets worth over Rs 3,000 Cr of Anil Ambani in money laundering case

land parcels, with an aggregate value of approximately Rs 3,084 crore. The case stems from the alleged diversion and laundering of public funds raised by two group companies: Reliance Home Finance Ltd. (RHFL) and Reliance Commercial Finance Ltd. (RCFL). The ED probe found that between 2017 and 2019, Yes Bank invested nearly Rs 5,000 crore in these companies. These investments subsequently turned non-performing, leaving outstanding dues of over Rs 3,300 crore. The investigation uncovered a complex routing of funds to bypass regulations. According to the ED, public money invested in the erstwhile Reliance Nippon Mutual Fund was indirectly channeled through Yes Bank to the Anil Ambani Group companies, sidestepping SEBI's conflictof-interest rules that prohibit direct mutual fund investments in group firms. The ED's fund tracing revealed "intentional and consistent control failures" in the lend-ing process. The agency stated that loans to grouplinked entities were "speed processed" without essential checks. Many loans were processed on the same day as application, sanction, and agreement, and in some cases, disbursal preceded sanction," the ED said, adding that field investigations were waived and documents were often found to be "left blank, overwritten, and undated." In a related development, the ED has also intensified its probe into the Reliance Communications Ltd. (RCOM) loan fraud case, where it has detected a diversion of over Rs 13,600 crore. The ED stated that it continues to trace the proceeds of crime and that recoveries made through such attachments would ulti-mately benefit the general public. According to ED officials,

the attachment orders were issued on October 31 and the assets include Anil Ambani family's residence at Mumbai's Pali Hill area, the Reliance Centre in New Delhi, and several other residential, commercial and land assets spread across Delhi, Noida, Ghaziabad, Mumbai, Pune, Thane, Hyderabad and Chennai. Dur ing 2017-2019, Yes Bank invested Rs 2,965 crore in RHFL instruments and Rs 2.045 crore in RCFL instruments. By December 2019, these investments had turned non-performing, with Rs 1,353.50 crore outstanding for RHFL and Rs 1,984 crore for RCFL. The ED investigation

found that direct investment by Reliance Nippon Mutual Fund into Anil Ambani Group's financial companies was prohibited under the Securities and Exchange Board of India's (SEBI) conflict-of-interest norms.RES YOU MAY LIKE The fundtracing exercise revealed a pattern of on-lending, diversion, and siphoning of funds to group-linked companies. The ED said the loans were 'speed-processed" without due diligence in several cases; applications, sanctions, and agreements occurred on the same day, and in some instances, funds were disbursed even before loan applications were filed. Investigators flagged blank or undated documents, weak financials of borrowers, inadequate or unregistered security creation, and mismatched end-use of funds. ED termed these lapses as "intentional and consistent control failures.

Man Detained for Taking Photos Outside American Center in Kolkata

MI News Service, Kolkata: A youth was detained outside the American Center in Kolkata after security personnel grew suspicious of his activities. According to sources, the man was seen taking photographs near the high-security premises located on Chowringhee Road, prompting the guards to stop and question him. Security officials from the American Center immediately alerted the Shakespeare Sarani Police Station, following which officers arrived at the scene and took the youth into custody for questioning. The detained individual reportedly a resident of North 24 Parganas, police confirmed. Eyewitnesses said the youth had been loitering around the area for some time, behaving in a manner that drew attention from locals and security staff. 'He was moving around the American Center and taking pictures of the premises. Finding his behavior unusual, the guards detained him and informed the local police," a senior officer stated. According to the Land-slide Atlas of India 2023 published by Isro, Darjeeling ranks as the 35th most exposed district among 147 landslide-prone areas, the NGT observed. Heavy rain in the first week of October triggered landslides leading to disruption in road connectivity on key routes in north Bengal and collapse of the Dudhia bridge over the Balason river, disrupting national and state highways. The heavy rainfall caused at least 33 deaths and extensive destruction in Darjeeling and surrounding regions. In 2023, the glacial lake outburst flood in Sikkim caused significant

downstream damage in Darjeeling and Jalpaiguri districts, exposing the region's vulnerability, the NGT noted. The proceeding was initiated by the NGT on the basis of a news report which blamed unsustainable development, changing rainfall patterns, and lack of institutional preparedness for the large-scale landslides and severe environmental degradation in the Darjeeling hills. Whether development took place in violation of the environment norms or not, the tribunal has sought to know, quoting news reports raising substantial issues relating to the implementation of green laws. "The news item raises concerns about national security implications due to Darjeeling's strategic location near the 'chicken's neck' corridor, underscoring the need for nationallevel interventions in climate resilience and disaster management in the Eastern Himalayas," the

ED conducted search operations at Chakdaha in Nadia and detained three members of a family in fake passport case

The Enforcement Directorate (ED) on Monday conducted raids at different locations, including the house of a carpenter at Chakdaha in West Bengal's border district of Nadia and detained three members of a family for their suspected involvement in making fake Indian passports and distribution against payments to foreigners, including Pakistani, sources said.

Official sources said the ED also raided a shop near the passport office at Anandapur near Ruby Hospital on EM Byepass and the federal agency officials also were seen to have entered into the passport office for an inquiry regarding the fake passport racket.

As many as four ED sleuths aided by 12 armed CRPF personnel about 6 AM raided the house of Biplab Sarkar, and detained him, his mason brother Biplab and their father in the alleged fake passport case.

According to ED sources, the search was conducted at the premises of Biplab Sarkar, who is suspected of being an agent in the issuance of passports fraudulently. The raid is being conducted as part of its investigation into the

MI News Service, Chakdaha: case linked to a Pakistani national, Azad Mallik, who was arrested earlier this year from Birati in North 24 Parganas.

Sources said Biplab Sarkar's name surfaced during the interrogation of Indu Bhushan Halder, a middleman arrested last month for helping foreigners get Indian Identity documents (passport) in lieu of money. The family members of Biplab Sarkar are also under the scanner for being involved in the same activities.

The ED team reached Parari village in Chakdaha earlier this morning and went straight to Biplab Sarkar's house. The search began as soon as they entered his ordinary clay house. The team also got the passport.

The ED is investigating how fake passports were made and where all the people travelled to. Sarkar's family members were also questioned.

Pakistani citizen Azad Mallick was arrested in the fake passport case earlier this year. At that time, the ED conducted searches at sevdesh border in the North 24 Parganas and Nadia districts.

on the same sources. Last month, an accused named Indu Bhushan Haldar was arrested in Nadia in a passport forgery case. Indu Bhushan had renewed Azad Mallick's Indian passport.

Sources said Biplab Sarkar has been linked to Indu Bhushan, and it is learned that about 350 fake passport applications were made from Indu Bhushan's cyber cafe in Chakdaha.

Based on that information, the ED raided Sarkar's house. Although he works as a carpenter, investigators are probing whether he has any Bangladeshi connections. The reason is that Indu Bhushan also used to make fake photo identity cards in several cases.

The investigators are checking the travel history and all his bank transactions. The officials are also checking the documents and passports of his brother, Bipul Sarkar and their family members. Their travel history was also being checked. Sarkar's mobile phone was also being scanned.

The ED also searched the shop in the Anandapur passport seva kendra in the eastern part of the city in the fale passport case.

Omar govt biased against **Hindus & nationalists,** says BJP MLA

MI News Service, Srinagar: A BJP legislator said the Omar Abdullah government was neglecting her constituency for being "Hindu and nationalist", fuelling an uproar in the Jammu and Kashmir Assembly. Speaking during Zero Hour, Kishtwar MLA Shagun Parihar accused the government of ignoring her constituency's devel-

opment. "Seventy per cent of the population in Kishtwar still lives in hilly areas. Even the benefits of central schemes are not reaching these people. Roads are in deplorable condition. The area is being deliberately neglected for being Hindu and Rashtrawadi (nationalist)," she said.

The remarks were bitterly contested by legislators, including minister Javid Dar and deputy chief minister Surinder Choudhary.

"The BJP legislator should refrain from making such divisive statements," Dar said.

Choudhary said nationalism was not the forte of any particular community. "Not just Hindus, Muslims and Sikhs are also nationalists. Everyone is working for the betterment of the nation," he said, urging Parihar's remarks to be expunged.

Parihar defended her remarks and claimed that PDP legislators also accused Hindus of following a "divide and rule policy", but nobody objected to

Speaker Abdul Rahim Rather called for restraint and reminded the BJP lawmaker to maintain the decorum of the House. "You are a first-time MLA. Words should be used with care and intelligence," he said. "You have to achieve big goals, and for that, focus on hard work and constructive discussion."

Parihar's remarks mask an irony. Kishtwar is part of the Muslim-majority Chenab Valley, but out of its eight MLAs, six are Hindus. In Kishtwar district, too, Muslims constitute 57 per cent of the population, but all

Pradesh have higher proportion of women with obesity compared to men, according to a shocking revelation in the Economic Survey tabled in the Parliament on Monday. In the National Capital Territory (Delhi), 41.3 per cent of women are obese compared to 38 per cent for men, said the survey, citing National Family Health Survey (NFHS). In Tamil Nadu, it is 40.4 per cent for women while 37 per cent men are obese. In Andhra Pradesh, 36.3 per cent of women are obese as against 31.1 per cent for men.

Tabled by Union Finance

Minister Nirmala Sitharaman, the survey said, "Combined with an ageing population in some states, obesity presents a concerning situation. Preventive measures must be taken to enable citizens to have



a healthier lifestyle." The survey added that obesity is higher in cities than in rural areas, affecting 29.8 per cent men in urban localities compared to 19.3 per cent of men in villages. Unhealthy diets contribute to 54 per cent of total disease burden in India, said the

increased consumption processed food items, reduced physical activity and limited access to diverse foods.

The survey warned that preventive measures must be taken to enable citizens to have a healthier lifestyle. In order to reap the gains of the country's demographic dividend, it is critical that Indian population's health parameters transition towards a balanced and diverse diet, said the document. The adult obesity rate in the country has more than tripled while the rise among children is the steepest in the world, after Vietnam and Namibia, said the survey, citing a World Obesity Federation report. The Economic Survey was tabled a day ahead of the presentation of the Union

MENTAL HEALTH CRISIS **EMPHASISES ACCESS ISSUES**

American According to the Psychological Association's 2023 Practitioner Pulse Survey, the ongoing mental health crisis is posing substantial obstacles for many psychologists as they deal with increased demand from patients coming with increasingly

severe symptoms year after year.

The survey, which was completed by 561 licenced practising psychologists between August 30 and September 29, 2023, discovered that not only did more than half of psychologists (52 per cent) report an increase in the severity of symptoms among their patients, but 41 per cent reported an increase in the number of sessions spent treating each patient, which may limit their capacity to accept new patients.

Similarly, more than half (56 per cent) said that they had no openings for new patients. And more than two-thirds (69 per cent) of psychologists who maintained a waitlist said that the average wait was up to three months for a first appointment, while 31 per cent said average wait times were longer than three months. Psychologists reported increasing demand for treatment of certain mental health conditions, including anxiety disorders (68 per cent) and trauma- and stressor-related disorders (50 per cent), among

those who treat those disorders. continues, psychologists are under

Evans Jr., PhD. "These findings underscore the sustained demand for care, led by increased severity of symptoms and extended treatment courses, compounded by increases year after year. This paints a clear picture of psychologists operating at the brink of their

Psychologists have shown themselves to be adaptable, changing their work habits during the pandemic to include fully remote or hybrid practices. Only 21 per cent are now offering fully remote practices (down from a peak of 64 per cent in 2020), according to the poll, yet more than two-thirds (67per cent) are now working in hybrid practices seeing some patients in person and others remotely.



SELANGOR, MALAYSIA : Early exposure to antibiotics might increase long-term vulnerability to asthma. Importantly, the study team discovered a chemical generated by gut bacteria that might possibly be used in the future as a simple therapy, in the form of a food supplement, to prevent asthma in children, according to recent study from Monash University.

Asthma affects around 260 million people worldwide, resulting in approximately 455,000 deaths each year.


Professor Ben Marsland's study, published today (TBC) in the journal Immunity, identified a long-term asthma prevention. Importantly the finding of the of antibiotics increases the risk of asthma, according to Professor Marsland. "We know that recurrent use of antibiotics early in life disrupts a person's healthy gut microbiota and increases the risk of allergies and asthma. Researchers shed light on how to restore nerve cells after injury



LA JOLLA (CALIFORNIA): More than 3 million people in the United States suffer from peripheral neuropathy each year, a condition in which nerves outside of the brain and spinal cord are destroyed, resulting in pain and loss of feeling in the affected areas.

Peripheral neuropathy can be caused by diabetes, trauma, genetically inherited disease, infection, and other reasons.

Salk researchers identified a way to repair destroyed nerves in mice during peripheral neuropathy. They discovered that the protein Mitf aids in the activation of the repair function of the nervous system's specialist Schwann cells.

The findings, which will be published in Cell Reports, may inspire new therapeutics to increase repair function and heal peripheral neuropathy.

We wanted to know what mechanisms control damage response in peripheral nerves under varying conditions--like acute trauma, genetic disorders, or degenerative diseases," says senior author Professor Samuel Pfaff. "We found that Schwann cells, which are special cells in nerves that protect and support

neurons' axons, enter their repair state because of a pathway mediated by the protein Mitf.

The peripheral nervous system is made up of all the nerves that branch out from the brain and spinal cord to give us sensation throughout our bodies. There are many cell types in peripheral nerves, but Pfaff and his team focus on understanding neurons, which transmit information throughout the nervous system, and Schwann cells, which protect healthy neurons and repair damaged ones.

The peripheral nervous system's ability to repair damage is remarkable considering that the central nervous system--made up of the brain and spinal cord--is not able to repair damage. Yet, the mechanisms that orchestrate this feat have remained poorly under-

To unravel how Schwann cells differentiate to begin repairing peripheral nerve damage, the researchers looked at mouse models of Charcot Marie Tooth disease (CMT), a type of heredi-

tary neuropathy.

"Going into this project, I thought that when you have a

genetic nerve degeneration disorder, cells are dying and recovery isn't possible," says first author Lydia Daboussi, a former postdoctoral researcher in Pfaff's lab and current assistant professor at UC Los Angeles. "But our findings show that there are gene programs turned on by Mitf that repair some of the damage done in those chronic disease scenarios, and when you turn those programs off, disease symptoms get

In mice with CMT, the researchers noticed that the Schwann cells completing the repairs had high levels of Mitf in their nuclei--where the genetic instructions for how to be a Schwann cell and how to conduct repairs are stored.

Upon investigation of this relationship between Mitf and Schwann cells, they found that Mitf was in the cytoplasm of Schwann cells until sensing neuronal damage. Damage then prompted Mitf to relocate from the cytoplasm of the cell to the nucleus, where it would direct the Schwann cell to make repairs.

To validate the importance of Mitf in creating repair Schwann cells, the researchers removed Mitf altogether. In cases of both trauma and CMT, nerve repair was arrested in the absence of Mitf--demonstrating that Mitf is required for peripheral nerve repair and regeneration.

According to Daboussi, Mitf acts like a fire extinguisher. Always there, sitting in the Schwann cell, unnoticed until damage occurs. And when that damage occurs, Mitf is ready to go and immediately turns on the cell's repair functions.

Most surprising, noted Pfaff, was that Mitf was orchestrating these repairs during a chronic dis-

Researchers reveals ways of preventing cancer cells from colonizing liver

ZURICH [SWITZERLAND]: Nine times out of ten, metastasis is the cause of cancer deaths. This is the point when the primary tumour has sent out cells, like seeds, and invaded other organs of the body. Despite significant advancements in the treatment of primary tumours, medicine remains mainly powerless against metastases. As of right now, there are no drugs that stop this process.

Researchers from Department of Biosystems Science and Engineering at ETH Zurich in Basel, under the direction of Andreas Moor, have now published findings in the journal Nature that demonstrate how colorectal cancer cells colonise the liver. Their research will aid in the creation of therapies that might

impede the spread of disease. Cancer is said to metastasise when cells from the primary tumour break off and travel via the circulatory system to other parts of the body. "Colorectal cancer metastasises to the liver because of how our blood flows, Moor says. Blood is first enriched with nutrients in the intestines before it goes to the liver, which metabolises the nutrients. For colorectal cancer cells, the liver is the last stop. "They get caught in the liver's capillary network," Moor says.

Costanza Borrelli, a doctoral student, and other members of Moor's team have now shown that the liver cells also play a large role in whether or not the cancer cells lodged there can colonise their new location. Science has known for over a century that, much like plant seeds in soil, cancer cells are dependent on their environment, yet it was previously unknown which molecular mechanisms play a role here.

Using sophisticated tests on



genetically modified mice, Moor and his team have discovered that the secret lies in certain proteins on the cell surface. When liver cells have a protein called Plexin-B2 and the colorectal cancer cells possess certain proteins from the semaphorin family, the colorectal cancer cells can attach themselves to the liver cells.

Cancer cells that have semaphorins on their surface are especially dangerous, as attested by clinical studies cited by Moor's researchers in their paper. The study data shows that colorectal cancer metastasises earlier and more frequently to the liver if the tumour has large amounts of semaphorin. Plexin and its counter-

part semaphorin were previously known to the research community for their function in the nervous system, where the two proteins steer growing nerve cells and ensure they form the right pathways. "Why liver cells also create plexin and what this protein does in healthy livers is anything but clear - and interests us immensely," Moor says. In other words, the question of its function remains open.

What Moor and his team have discovered, however, is that direct contact between plexin and semaphorin triggers fundamental changes in colorectal cancer cells. To break off from the primary tumour, the cancer cells have to

change their identity: they free themselves from the surface layer of the intestine, or epithelium, severing their close connections to neighbouring cells.

Once in the bloodstream, the cancer cells resemble those from connective tissue called mesenchyme. Yet once they find their new niche - thanks to the plexin on some liver cells - the cancer cells turn back into their sedentary form. "An epithelisation process takes place," the researchers wrote in their paper. Moor expands: "You can spot this immediately if you look at the cancer cells, as they form invaginations similar to the folds or crypts in the intestines.'

The researchers' discovery will have an impact on more than colorectal cancer patients: further tests have shown that plexin also encourages the formation of metastases in melanoma and pancreatic cancer. For Moor and his team, this throws up many new research questions. One in particular is drawing their focus: when cancer cells cluster together to form a tumour, they also influence cells in their environment. "Cancer cells set up their own

ecosystem," Moor explains. If efforts to inhibit the crucial interaction between plexin and semaphorin succeed, it may be possible to prevent the cancer from establishing new tumours in the first place. That's because early on, when the relationships among the cells in this ecosystem have not yet been firmly established, tumour metastases are especially vulnerable, Moor explains. He appears confident that an answer lies within this "critical period of time in the development of metastases", even though the path to any potential treatment is still long.

Families in Gaza take refuge in cemeteries amid war devastation

Nighttime is another matter. "When the sun goes down, the children get scared and don't want to go, and I have a few children, four small ones," Brikah said. "They are afraid to go out because of the dogs at night, and

The vast majority of Gaza's population of over 2 million people has been displaced by the two years of war between Hamas and Israel. With the ceasefire that began on October 10, some have returned to what remains of homes. Others are still crowded into the strip of remaining territory that Israeli forces don't control.

Here and in other cemeteries in Gaza, there is life among the dead. A prayer rug hangs on a line. A child pushes a water jug on a wheelchair between the graves. Smoke rises from a cooking fire.

Palestinian women stand

among graves in a Khan Younis cemetery where displaced families have set up tents, in the southern Gaza Strip, on October 31. Photo: AP

One of Brikah's nearest neighbours is Ahmad Abu Said, who died in 1991 at the age of 18, according to the carving on his tombstone that begins with lines from the Quran. There is unease, a feeling of disrespect, at setting up camp here.

Brikah said her family's home elsewhere in Khan Younis was destroyed. There is no return for now. Israeli forces occupy their neighbourhood.

Mohammed Shmah said he has been living here for three months. He said his house had been destroyed, too.

"I'm a grown man, but I still get scared of the graves at night. I hide in my tent," he said, perched on a broken tombstone and squinting in the sun. He said he had only 200 shekels (around USD 60) on him when a friend took it to help bring his family to the cemetery.

The lack of money for shelter elsewhere is one reason keeping families living among

the graves, said Hanan Shmah Mohammed's wife. With care, she washed dishes in a soapy container the size of a pie tin,

guarding precious water. "Of course, life in the cemetery is full of fear, dread and worries, and you don't sleep in addition to the stress we experi-

ence," she said. There is no guarantee of safety, even among the dead. Israeli forces have bombed cemeteries during the war, according to the United Nations and other observers. Israel has accused Hamas of using some cemeteries for cover, and has argued that the sites lose their protection when they are used for military

During the war, bodies in Gaza were buried wherever they could, including in hospital courtyards. According to custom, Palestinian families are buried near loved ones. The fighting has largely disrupted

Now, with the ceasefire, the search is on for the dead.

Netanyahu vows to disarm Hamas, warns Lebanon over Hezbollah

MI News Service, Tel Aviv: Israeli Prime Minister Benjamin Netanyahu vowed on Sunday to disarm Hamas and demilitarise the Gaza Strip, saying his gov-ernment would keep targeting remaining militant cells despite a ceasefire that took effect last

"Some Hamas cells remain active in parts of Gaza under our control, and we are systematically eliminating them," Netanyahu told ministers, citing areas in Rafah and Khan Younis in southern Gaza, Xinhua News Agency reported.

"Disarming Hamas and demilitarising the Gaza Strip is our guiding principle," he said, adding that it was a goal he had agreed on with US President Donald Trump. "If it cannot

be achieved one way, it will be achieved another." Netanyahu said Israeli forces

would continue to act to protect troops still in Gaza, adding that Israel would notify its US allies of operations "but will not ask their permission." He said Israel would not compromise its "supreme security responsibility." His remarks came as the

White House works to preserve the ceasefire and secure further hostage releases, even as Israeli strikes have continued, though at a reduced pace.

Gaza health authorities said on Sunday that at least 236 Palestinians had been killed and 600 wounded by Israeli fire since the truce began more than three weeks ago, bringing the total death toll since October 7,

Netanyahu also urged Lebanon's government to enforce its commitment to disarm Hezbollah, accusing the group of rearming, and warned that Israel would act in self-defence if necessary.

Separately, Defence Minister Israel Katz called on Beirut to remove Hezbollah forces from southern Lebanon, saying in a statement that "maximum enforcement will continue and intensify - we will not allow any threat to residents of the north.

The Israeli military said it killed four members of Hezbollah's elite Radwan Force on Saturday in the latest strike, part of ongoing cross-border attacks that have persisted despite the ceasefire reached last November

"We have enough nuclear weapons to blow up the world 150 times," Trump said. "Russia has a lot of nuclear weapons, and China will have a lot. They have some. They have quite a bit."

US Energy Secretary Chris Wright has clarified that the testing will not involve nuclear explosions at this time. This was the first clarity from the Trump administration since the president took to social media last week to say he had "instructed the Department of War to start testing our nuclear weapons on an equal basis."

Messi in India? Kerala sports minister's renewed claim sparks fresh wave of skepticism

MALAPPURAM: The Kerala government has once again stirred public excitement and controversy with Sports Minister V. Abdurahiman asserting that Argentine football legend Lionel Messi will play in India next year.

According to the minister, the state has received a new email from the Argentine Football Association (AFA) confirming that the G.O.A.T player Messi and his team will visit India in March.

"Two days ago, we received an email from the AFA team confirming their visit to Kerala in March,' Abdurahiman said.

He added that the match was initially planned for November but had to be deferred due to infrastructural issues at the Jawaharlal Nehru Stadium in Kochi.

However, this fresh claim has drawn widespread skepticism, with critics recalling the earlier unfulfilled promise of Messi's visit.

The absence of any official agreement or confirmation from the AFA has led to questions about the government's credibility and the procedures followed in organising what is billed as a major international sporting event.

The Opposition and sports enthusiasts have also raised concerns over why the Kochi stadium was partially dismantled for "renovation" despite the lack of a signed

With no documented terms, the government is now under pressure to clarify who the sponsors are, what the contractual commitments were, and whether due diligence was observed.

Adding to the controversy, it has emerged that the sponsors involved in the initiative have alleged links to the notorious Muttil tree felling case despite the government's previous assurances that it would not engage with tainted entities.

As anticipation mixes with disbelief, many are demanding transparency and official documentation to substantiate the minister's claim.

For now, Messi's supposed Kerala appearance remains more of a political talking point than a confirmed sporting event, a story that continues to keep football fans across the country guessing and
