Nepal Rastra Bank (NRB) issued a letter of intent to the China Banknote Printing and Minting Corporation on Friday for the design, printing, supply and delivery of the notes, the bank officials said. The total project cost has been fixed at USD 16.985 million, according to the Currency Management Department of

the bank. Under the agreement and as per the letter of intent, the China Banknote Printing and Minting Corporation will exclusively design, print, supply and delivery of the notes, the bank officials said adding that the Chinese company was selected for the 16 million dollar contract on the basis of the lowest evaluated bid. The firm has previously printed Nepalese banknotes of Rs 5, Rs 10, Rs 100, and Rs 500 denominations, the officials said. Erlier the Nepal Rastra

Mother kills infant, dumps body in bushes



Alipurduar: A chilling case of infanticide has sent shockwaves through the South Chechakhata area of Alipurduar Junction, where a seven-month-old baby was found dead after being strangled and dumped in nearby bushes. The child's mother has reportedly con-fessed to the crime during police interrogation. The grim sequence began Friday afternoon when the infant, son of Joydeep Ghosh, was reported missing from the family's residence.

According to initial statements, the mother had told her father-in-law that the baby had vanished while she was bathing. Panic spread through the neighborhood as relatives and locals launched a frantic search, suspecting a case of child abduction. Police from Alipurduar station quickly swung into action, deploying sniffer dogs, combing the surrounding areas, and examining CCTV footage to trace the missing child. Surveillance was intensified at the railway station amid fears that the baby might have been taken away. However, as investigations deepened, inconsistencies emerged in the family's statements, prompting officers to question the mother further. Late Friday night, under interrogation, the mother broke down and confessed to killing her child. Acting on her statement, police located the infant's body in a bush behind the house. The discovery left neighbors stunned. Authorities have yet to establish the motive behind the horrifying act. Locals suspect the woman might have been suffering from psychological distress. Police have launched a detailed investigation to uncover the circumstances leading to the tragic death. The body has been sent for postmortem, and the mother remains in police custody as the probe continues.

Two Youths Found **Dead on Road After Midnight Crash**



MI News Service, Uluberia: A gruesome accident on Uluberia's Amta Road late Friday night left two unidentified youths dead, their bodies found lying in pools of blood on both sides of the road. The horrifying sight stunned locals, who discovered the bodies beside a mangled motorcycle around 11 p.m. According to police sources, the cause of the accident remains unclear. Investigators are examining CCTV footage from nearby establishments to determine whether the two were struck by another vehicle or lost control of their bike. The bodies were sent to Uluberia Sarat Chandra Chatterjee Medical College and Hospital for post-mortem examination.

Eyewitnesses recounted the shocking scene. "At first, we saw a bike lying in the dark. When we went closer, we found two boys lying motionless. Blood was flowing across the road," said a local resident who immediately alerted police. Officers from Uluberia police station reached the spot and began the recovery operation. As of Saturday morning, efforts are ongoing to identify the deceased youths. Police have collected evidence from the scene and are probing all possible angles, including reckless driving or a possible hit-and-run. Incidentally, Friday turned into a day of road tragedy across the region. In a separate mishap, a private passenger bus in Kolkata's Rajarhat area plunged into the Kharoa Canal after reportedly speeding, leaving around 40 passengers injured. The dual incidents have once again raised concerns over increasing road accidents and reckless driving on state highways.

Confusion in SIR Drive: BLO's Own Family Faces Verification Gap

Chunchura, Hooghly, amid Bengal's ongoing Special Intensive Revision (SIR) of electoral rolls, after it was revealed that a Booth Level Officer (BLO) assigned to distribute enumeration forms does not have her own family listed in the 2002 voter roll. The disclosure has triggered political murmurs and renewed questions over the authenticity and accessibility of old electoral data. The incident involves BLO Amita Biswas of Booth No. 196 in the Keota area of Chunchura. While distributing SIR verification forms door to door, it emerged that none of her immediate family members - including her husband, fatherin-law, or brother-in-law — appear in the 2002 voter list being used as a reference point for the current revision.

Speaking to reporters, Amita admitted the anomaly and said, "My father-in-law, Samarendra Biswas, is 86 years old and has

Her husband, Shuvendu Biswas, echoed similar concerns, stating, "We have voted before and after 2002, but our names were never found in that particular electoral list. Those who have valid papers will be fine, but others without documents may find it extremely difficult to verify their names now. This can cause unnecessary complications, especially for older residents."The issue has drawn local political attention, as it highlights recurring flaws and inconsistencies in voter list main-

Bengal SIR: Name Missing? No Link to Citizenship, Says EC

MI News Service, Kolkata: able during the visit, BLOs will Amid growing anxiety across Bengal over the ongoing Special Intensive Revision (SIR) of electoral rolls, election officials have clarified that the omission of a name from the list does not raise any question about a person's citizenship. The clarification comes as confusion spreads among residents fearing exclusion from voter records. The Election Commission has confirmed that the SIR, currently underway in nine states and three union territories, is a routine process aimed at updating and verifying voter rolls. Contrary to popular belief, this is not the first SIR exercise in Bengal — similar revisions were conducted eight times between 1951 and 2004. However, this year's phase has gained heightened attention due to misinformation linking it to citizenship status.

Under the current process, Booth Level Officers (BLOs) are visiting households to distribute enumeration forms, which have two sections — one retained by the BLO and the other kept by the voter. Residents must indicate whether their name, or their parents' name, appeared on the 2002 voter list. If confirmed, no additional documents are required. In cases where individuals are unavail-

make up to three attempts or provide guidance for completing the form later, including through an online option for those outside the country. After enumeration concludes, the Election Commission will release a draft electoral roll on December 9, allowing citizens to verify their entries online or at local offices. Those whose names are missing will have the opportunity to file claims or objections by submitting basic documents such as proof of address. Following verification, the final voter list is scheduled for publication on February 7.Officials reiterated that non-inclusion in either the draft or final list does not equate to loss of citizenship. "The voter card is a proof of identity, not proof of citizenship. Similarly, missing from the electoral roll does not mean a person ceases to be a citizen," a senior elec-tion official said. Citizens can reapply online or through the BLO at any stage to have their names restored. Experts have urged residents to remain calm and participate in the revision process. Bardhaman Hospital Row Wrong Blood Allegation Sparks Outrage



Bardhaman: A shocking case of alleged negligence at Bardhaman Medical College and Hospital has sparked outrage after the family of a deceased woman accused the facility of transfusing the wrong blood, leading to her death. The incident has raised serious questions about procedural lapses in one of the state's major government hospitals. The deceased, identified as Namita Bagdi of Burdwan, was admitted to the hospital after a snake bite. On November 2, a mix-up allegedly occurred when blood meant for another patient — also named Namita — was administered to her. Family members claim that the blood brought for Namita

woman, was mistakenly given to Bagdi.Following the transfusion, Bagdi's condition allegedly deteriorated rapidly. Despite being shifted to the ICU, she succumbed to complications soon after. Her distraught father, Dukari Bagdi, voiced his anguish, saying, "What will happen now? Will I ever get my daughter back?" The family maintains that her health worsened only after hospital staff administered the wrong blood and blames the nursing staff for negligence.The hospital authorities, however, have contested the allegations. The Medical Superintendent-cum-Vice Principal stated, "The patient was brought in with a snake bite and was in critical condition. After some media reports suggested

Early Winter Surprise: Plains Beat Hills in Temperature Drop



Winter has set foot in Bengal earlier than expected, bringing a sudden chill across the state and surprising meteorologists with an unusual temperature pattern. In a rare twist, the western district of Birbhum - particularly Shantiniketan and Sriniketan - has recorded lower temperatures than the hill town of Kalimpong. According to meteorological scientist Sourish Banerjee, the "setting in" of winter conditions has officially begun in the state. Dry, clear skies and cold northwesterly winds are prevailing across Gangetic South Bengal. Over the next four days, the night temperature is expected to drop further by

two to four degrees. Shantiniketan has already recorded a minimum temperature of 15.8 degrees Celsius, while Kalimpong stood at 16 degrees on Saturday morning. The hill station of Darjeeling recorded a cooler 10 degrees but remains within its normal November range. The phenomenon has sparked curiosity as the plains in western Bengal are currently outpacing some hilly zones in terms of temperature decline.In Kolkata, mercury levels are gradually sliding toward the winter mark. The capital recorded around 20 arrived ahead of schedule.

Night temperatures are projected to remain below normal for the next seven days across both North and South Bengal. Court Verdict to Decide Sonajhuri Haat's Future: Minister



Birbhum: The state government will not take any immediate action regarding the much-debated relocation of Santiniketan's famous Sonajhuri Haat until the ongoing court case over its land is settled, State Minister Chandranath Sinha confirmed on Friday. The weekly market, a cultural and tourism landmark near Bolpur, currently operates on land belonging to the Forest Department.Uncertainty has surrounded the future of Sonajhuri Haat for months, with traders and artisans expressing concern about possible displacement. The matter escalated

gan over conducting trade activities on forest land. Addressing the issue during a Synergy and Trade Conference organized by the State Small, Medium and Cottage Industries Department at Biswa Bangla University Auditorium, Minister Sinha clarified, "Sonajhuri Haat continues as usual.

But since the case is before the court, the government will wait for the court's decision. The next step will depend entirely on the verdict."Sources in the district administration indicated that if the High Court orders a relocation, the state is exploring an alternative site — possibly in the Ahmedpur area

on the premises of a defunct sugar mill. Officials said the aim would be to rehabilitate traders without disrupting their livelihoods.Traders in Bolpur, however, remain anxious, fearing that the charm and footfall of the iconic haat could be lost if it is moved. Sonajhuri Haat has long been a major attraction for Santiniketan visitors, known for its blend of handicrafts, tribal art, and folk music. Trinamool's Birbhum Core Committee convener, Anubrata Mondal, who was also present at the conference, refrained from commenting on Sonajhuri Haat's legal uncertainty but expressed optimism about the district's industrial prospects. "There are discussions about new industries in Birbhum. It is a positive development, and I am happy to see progress coming," Mondal said. Clerical Error Turns Tragic: Malda Youth Critical After Suicide Bid



MI News Service, Malda: A clerical error in the voter list allegedly drove a young man in Malda to attempt suicide out of fear and mental distress. The incident, which occurred in Nazirpur village under Mahendrapur Gram Panchayat of Harishchandrapur, has sparked political controversy and drawn snarp criticism from the victim's family against election authorities. The youth, identified as Rajesh Ali, consumed poison on Friday evening and was first taken to Harishchandrapur Rural Hospital in critical condition. As his condition deteriorated, he was transferred to Chanchal Super Specialty Hospital, where he remains under intensive care.

According to his family, the issue erupted after Rajesh discovered that his father's name, previously recorded as Adil in the 2002 voter list, had been wrongly entered in the updated list. The mismatch allegedly caused him intense anxiety over potential verification issues under the electoral system. "Everything is correct on his Aadhaar card and old voter card, but in the latest list, even his father's name went wrong. He panicked and drank poison," said his brother, Mafizul Islam. Enraged relatives have blamed the Election Commission for negligence, demand ing an immediate correction of the records. The incident prompted Harishchandrapur MLA and State Minister Tajmul Hossain to rush to the hospital and meet the victim's family. Trinamool Congress leaders have seized the opportunity to criticize what they termed "bureaucratic chaos under central oversight" of voter data. The party alleged that such administrative lapses are eroding public trust in the electoral process. Police are investigating the complaint filed by the family, while election officials have promised to review the records and verify the source

after legal proceedings bewhere a proposed busi-Poor Man's Mud House Used for Awas Yojana Fraud

Allegations of large-scale irregularities have surfaced in the Bangla Awas Yojana at Harishchandrapur in Malda, where a government survey worker has been accused of diverting a housing benefit by falsely claiming a poor villager's dilapidated hut as another person's unmade house. The incident has triggered political uproar across the region. The complainant, Pitambar Das of Bangabari village under Tulsihata gram panchayat, lives in a mud house on the verge of collapse. Pitambar Das said his name initially appeared on the housing scheme list, and administrative staff had visited his home and recorded photographs. Days later,

MI News Service, Malda: his name vanished from the list, reportedly replaced by that of another person who already owns a multi-storey

building. Pitambar Das alleged that the survey official responsible for preparing the beneficiary list connived in the fraud. "They showed someone else's concrete house as mine and removed my name. I have filed a written complaint to the Block Development Officer, demanding justice," he said. Local political tensions have since flared. The BJP has accused ruling Trinamool Congress workers of embezzling funds meant for the poor under the guise of the state-run housing scheme. Party leaders claimed that the central

EC Orders Action Against BLOs for Improper SIR Form Distribution

MI News Service, Kolkata: The Election Commission has issued a strict directive against Booth Level Officers (BLOs) accused of distributing SIR (Special Intensive Revision) forms from unauthorized locations instead of visiting voters' homes. The Commission has ordered **Electoral Registration Officers** (EROs) to issue show-cause notices to such BLOs and initiate disciplinary proceedings if necessary. Reports had been pouring in from several districts that BLOs were handing out voter revision forms from party offices, local leaders' homes, or even roadside setups, instead of conducting door-to-door distribution as per protocol.



In response, the Commission convened a meeting on Saturday and reviewed the growing number of allegations. It was noted that despite repeated instructions, many BLOs continued to flout EC guidelines by distributing forms from arbitrary locations rather than conducting The Commission, taking serious note of the matter, has now directed strict disciplinary action and show-cause proceedings against the

Abhishek Forms Special Team to Visit SIR Victims' Families, Announces Rs 3 Lakh Aid Each

MI News Service, Kolkata: Amid rising panic over the ongoing Special Intensive Revision (SIR) of electoral rolls in Bengal, the Trinamool Congress (TMC) has decided to reach out to the families of individuals who allegedly died due to stress or fear surrounding the process. Abhishek Banerjee, TMC's national general secretary, has formed a special team to visit these bereaved families and provide both emotional and financial assistance. Each affected family will receive ₹3 lakh as compensation from the party. Starting Saturday, senior party

leaders will begin visiting the homes of those who reportedly died by suicide or from heart attacks linked to SIR-related anxiety. Samirul Islam and ParthaBhowmik will visit the family of PradipKar in the evening, while Dr. Shashi Panja and SudipRaha will travel to Titagarh around 4 PM. Chandrima Bhattacharya and SudipRaha will visit



Dankuni later in the day, and Jaya Dutta, along with local leaders, will go to Hooghly. Arup Chakraborty and his team will head to Uluberia. Since the SIR process began, a wave of anxiety-driven deaths has been reported from several parts of Bengal, including Agarpara, Cooch Behar, Dankuni, Digha, Uluberia, Kandi, Behrampore, Ilambazar, and re-cently from Sainthia, Kulpi, and

Dhupguri. In Sainthia, 52-vear-old BimanPramanik reportedly died of cardiac arrest after days of distress over an error in the 2002 voter list where his and his sister's surnames were mistakenly recorded as "Pal" instead of "Pramanik." Despite assurances from local officials, he remained anxious and succumbed to a heart attack on Wednesday evening. In South 24 Parganas' Kulpi area, another tragic death was reported. Shahabuddin Paik, a resident of Kalicharanpur village, suffered a fatal stroke after learning from a BLO that his wife's name was missing from the voter list. He was admitted to Diamond Harbour Hospital but passed away shortly after. The TMC has blamed the Election Commission for "creating unnecessary fear" among citizens, while accusing the BJP of exploiting the situation politically. The BJP, in turn, has dismissed the allegations as "an attempt to divert attention from administrative failures.

Kalyan Banerjee Seeks Stronger Cyber Fraud Laws

Kalyan Banerjee, a Trinamool Congress Member of Parliament, has revealed how he became the victim of a sophisticated financial fraud that drained ₹57 lakh from one of his dormant bank accounts - and how the money was ultimately restored by the bank. Responding to the incident, Banerjee raised concerns about ordinary depositors, be available to citizens who face similar frauds without the leverage of political influence. He questioned the sufficiency of existing safe-guards and called for stronger institutional measures, including the establishment of a specialised cyber crime branch dedicated to tackling digital banking fraud.

Banerjee also criticised recent relaxation of withdrawal safeguards by the Reserve Bank of India, noting that prior telephone verifications for large cash withdrawals had provided an additional layer of security. He warned that the easing of such controls could embolden fraudsters. The MP urged greater accountability from banks, emphasising that public trust in the financial system could be severely undermined if digital

MI News Service, Kolkata: banking becomes a major Kalyan Banerjee, a Tri-conduit for theft. He demanded stronger government oversight and clearer consumer protections to prevent similar incidents, and called for urgent steps to tighten digital banking security across the country. Investigations are ongoing nationwide now. Speaking on November 8, Baneriee recounted the episode in detail. He said the account in question belonged to a subbranch under the jurisdiction of the Calcutta High Court main branch and had lain dormant for about a decade after he stopped using it following his tenure as a legislator. Fraudsters allegedly reactivated the account by completing a fresh KYC (Know Your Customer) process. Banerjee claimed that his photograph was superimposed on forged documents and counterfeit PAN and other identification papers were submitted to the bank to facilitate the activation. State Bank of India has reportedly credited the ₹57 lakh back to his account. Bank officials described the incident as an administrative lapse in internal processes, and have initiated investigations into how the fraudulent KYC was accepted. No arrests have been reported so far.

Mayor Hakim Assures Easy Access to Birth Certificates

MI News Service, Kolkata: Citizens born within the Kolkata Municipal Corporation (KMC) area will receive birth certificates without difficulty if their documents are in proper order, Mayor Firhad Hakim assured on Friday. Speaking during his regular citizen interaction programme 'Talk to Mayor', Hakim clarified that the process remains transparent and accessible through the KMC's official website. "The website clearly shows the years for which birth certificates can be issued. There's no need to create unnecessary confusion around this matter," he said. The mayor's remarks came in response to political controversy surrounding the issuance of birth certificates, after Leader of Opposition SuvenduAdhikari had filed an RTI seeking details about the process. In reply, Deputy Mayor Atin Ghosh earlier stated that all records were available online and that the system was functioning Taking a firmer stance

on Friday, Hakim sharply criticised the attempts to politicise the issue. "Anyone can simply open the computer and see everything for themselves

where, when, and to how many people birth certificates have been issued. All the details are publicly available," the mayor said. Hakim also addressed concerns related to the ongo-Special Intensive Revision (SIR) of electoral rolls, acknowledging that the process had temporarilv diverted several civic employees from their usual duties. "Many municipal staff have been assigned to assist with the SIR pro-

new website to facilitate the online submission of enumeration forms as part of the ongoing Special Intensive Revision (SIR) of electoral rolls. This comes after several inquiries were raised regarding the start of online applications under the SIR process. According to the Election Commission, voters can now access the Enumeration Form through the official Voter Services Portal. The initiative is aimed at ensuring that eligible voters who are currently living away from their registered constituencies-such as students, miworkers. professionals—can conveniently complete the process online without physical verification delays. Officials confirmed that the online facility has been made fully functional from Friday. The system allows users to log in using their voter credentials, fill out the enumeration form, and upload necessary documents, including proof of age, address, and identity. The portal is designed with userfriendly navigation and multilingual support to assist applicants from different regions. The Commission has also assured that all data submitted online will be securely stored and verified through the same process followed for updates and corrections will automatically reflect in the electoral rolls. With the launch of the online enumeration service, voters now have two options to participate in the SIR process-either by submitting physical forms collected by BLOs or by completing the process digitally through the Voter Services Portal.

Hrs on Sunday for Maintenance Work MI News Service, Kolkata: Commuters Bridge. Similarly, vehicles coming via traveling between Howrah and Kolkata AJC Bose Road that typically use VidyasagarSetu will be redirected from are set to face major traffic restrictions

this Sunday, November 9, as the iconic Second Hooghly Bridge—better known as VidyasagarŠetu—will remain completely closed for vehicular movement for 16 hours due to scheduled maintenance work.

According to an official notification. the bridge will be shut from 5 a.m. to 9 p.m. to allow for essential repair and renovation work aimed at ensuring public safety. Kolkata Police confirmed that during this period, all vehicles that normally use VidyasagarSetu will be diverted through Howrah Bridge. Detailed diversion plans have been issued to manage the expected increase in traffic. Last Sunday, the bridge had also been closed for eight hours for similar repair work. This time, authorities expect heavier congestion as the closure



period has been doubled. Officials clarified that the ongoing maintenance is crucial for the structural health and long-term safety of the bridge. According to the revised traffic plan, vehicles approaching from Khidderpore via CGR Road intending to access VidyasagarSetu will instead be diverted left from Hastings Crossing towards St. George's Gate Road, and then proceed via Strand Road to reach Howrah

Grade Road towards Hastings Crossing, before moving through St. George's Howrah Bridge. Alternately, vehicles may take a right turn from Hastings Crossing to proceed via K.P. Road as instructed by traffic personnel. Kolkata Police have warned that dicongestion, particularly along St. George's Gate Road and Strand Road, as all diverted vehicles funnel toward Howrah Bridge. Additional traffic police will be deployed in these areas to manage the flow and assist motorists. Meanwhile, vehicles traveling from Howrah to Kolkata that usually cross via VidyasagarSetu have been advised to use Howrah Bridge or NiveditaSetu instead.

Bengal Border Districts See Surge in Muslim Marriages Under Special Marriage Act

MI News Service, North Dinajpur: An unprecedented surge in Muslim couples registering their marriages under the Special Marriage Act (SMA) has been reported this November across West Bengal's minority-dominated border districts including North Dinajpur, Malda, Murshidabad, and Cooch Behar. Officials attribute this unusual spike to rising anxiety over the ongoing Special Intensive Revision (SIR) of electoral rolls and fears relating to citizenship verification. According to data accessed by news agencies, approximately 1,130 Muslim couples applied for marriage registration in Bengal between November 2024 and October 2025, with more than half those applications filed in the four-month window from July to October 2025, coinciding with SIR activities in neighbouring Bihar and impending SIR implementation in Bengal. The majority of applications originated from North Dinajpur (199), Malda (197), Murshidabad (185), and Cooch Behar (97) — areas that share borders with Bangladesh and Bihar.

Traditionally, Muslim marriages in rural Bengal are solemnized and registered under the Bengal Muhammadan Marriages and Divorces Registration Act of 1876 by kazis (marriage registrars). However, officials note that this system lacks uniform documentation and rigorous address verification, causing difficulties in official recognition by government and private bodies. By contrast, marriage certificates issued under the Special Marriage Act provide standardized and widely accepted legal proof, often used as citizenship documents in government procedures. Sources explained that the increasing voter verification exercise under the SIR has made many couples anxious about their documentation status, prompting them to seek a marriage certificate under the Special Marriage Act as a safeguard to affirm legal marital status and citizenship credentials.

The opposition BJP immediately seized on the issue, accusing the ruling party of attempting to influence the process through administrative collusion. "This is a clear violation of Election Commission rules.

We will request the BDO to act immediately. If no action is taken, we will approach the Commission and also lodge a formal complaint," said BJP district committee member Kishan Kedia. He further alleged that the Trinamool was "trying to manipulate voter inclusion to protect illegal residents" and warned that "names cannot be arbitrarily added or removed." In response, Bulbul Khan denied any wrongdoing, claiming the situation had been misrepresented. "We are helping people in the field. BLOs are visiting homes as required. Some people have come to my house as it is centrally located. There is no harm in that. Everyone is working for the public," he stated. The incident adds to a series of similar complaints from across Bengal, where BLOs have allegedly deviated from prescribed procedures during SIR form distribution. The Election Commission, already monitoring reports of irregularities, has recently ordered show-cause notices and disciplinary action against officers who fail to follow protocol. As the controversy deepens, both political camps have escalated rhetoric over the issue, while local authorities have confirmed that an internal inquiry will be conducted to verify

He had declared 2025 as the 'Year of Reforms', underscoring the importance of development of new technology by DPSUs and the need for enhancing exports and indigenisation. To achieve this objective, he exhorted them to increase their investment and manpower for R&D. Since then, all the DP-

SUs have prepared their R&D roadmap for the next five years. Over the last 10 years, a total sum of Rs 30,952 crore has been invested in R&D by the 16 DPSUs. The pace of R&D is now proposed to be doubled with projected expenditure of Rs 32,766 crore over the next five years. While most of the Ř&D investment over last 10 years was made by old DPŠUs notably Hindustan Aeronautics Limited



Limited and Bharat Dynamics Limited, the thrust on R&D is now spread across all DPSUs. In next five years, the seven new DPSUs formed upon corporatisation of the Ordnance Factory Board will invest over Rs 3,000 crore for R&D, while defence shipyards have planned an investment of over Rs 1,300 crore, according to the Ministry of Defence.

During the event, a compilation of D&D/R&D projects carried out in the last 10 years, and the plan for the next five years will be released. In addition, the new R&D Manual of HAL providing flexibility, speed, risk assessment, and allocation in R&D projects will be unveiled.

Rajnath Singh will also release a report on renewable energy, titled 'Swayam'. This report is the first-ever attempt made under the aegis of Department of Defence Production to compile the energy efficiency practices of all the 16 DPSUs.

Notably, the performance of DPSUs in 2024-25 has been commendable. The total turnover stood at Rs 1.08 lakh crore, up 15.4% from that in 2023-24. The DPSUs recorded cumulative Profit After Tax in 2024-25 of Rs 20,021 crore, registering a growth of 19.5 % over the previous year.

Remarkably, in 2024-25, DPSU's achieved an increase of 51% in exports over the previous Financial Year. The event will witness felicitations to various DPSUs for their notable achievements in different areas and exchange of significant MoUs.



Himachal Women's Commission takes cognisance of FIR against BJP MLA

mission, Himachal Pradesh, led by Vidya Negi, on Saturday termed the allegations against BJP MLA and former Deputy Speaker Hans Raj "serious" and urged the Chamba Police to conduct a fair, impartial, and in-depth investigation into the matter.

Negi, who has been heading the Commission for the past four months, told ANI in Shimla that the Commission took suo motu cognisance of the complaint after receiving it first through social media and later as a formal written complaint from a woman who accused the Churah MLA of exploitation, intimidation, and issuing threats to her life.

"It has been four months since I took charge as Chairperson, and during this period, we received this complaint first on social media and later formally. The girl has alleged that BJP MLA Hans Raj exploited her, threatened her, and that she faces a threat to her life. We have taken cognisance of the matter," Negi said.

She added that several women's groups, including one led by Jan Mahila Samiti, had submitted written representations to the Commission, supporting the complainant and seeking a proper inves-

the matter had reportedly surfaced once before, nearly a year ago, and the Commission had sought details on the action taken at that time. "We have spoken to the SP and directed that the investigation should determine whether there is any real threat to the girl or her family on the ground. If such a threat exists, the police must ensure full security to them," Negi stressed.

Calling it a "very serious matter," Negi said the Commission's role is to ensure that every woman who approaches them is heard and that her case is pursued fair-

"If any woman comes to us alleging injustice, our first duty is to raise her voice and ensure proper investigation by the concerned department. The truth or falsehood of the case will be determined by the police," she said.

Referring to the BJP's 'Beti Bachao, Beti Padhao' slogan, written requests demanding the Chairperson remarked a fair probe and justice for that such slogans must trans-

late into action on the ground "The BJP talks about 'Beti Bachao, Beti Padhao'. I am not here to decide who is guilty, but if such slogans are given at the national level, they must be practised sincerely on the ground. Unfortunately, we have seen similar allegations earlier - in Chamba, Solan, and against BJP leaders or their family members," she claimed.

Negi urged central and state authorities to ensure that no bias affects the investigation and that justice is delivered to the complainant.

"This is not about politics; it's about justice. A fair investigation must be carried out without discrimination. Senior leaders at the Centre should also help ensure that women and girls who come forward get justice," she add-

While stating that it was too early to draw conclusions as the allegations were yet to be proven, Negi expressed concern about the broader atmosphere for women in

"We cannot say anything concrete right now as the investigation is still ongoing. But the environment being created for women today, especially the younger generation, is not healthy. There is always a risk that powerful people, including elected representatives, might try to influence such investigations,"

New antibody could be promising cancer treatment: Study

Researchers at Uppsala University and KTH Royal Institute of Technology have created an antibody that has the potential to treat a variety of cancers. Researchers were able to integrate three different functionalities in the antibody, which combined significantly increased the action of T cells on the cancer

Researchers have developed a unique type of antibody that both targets and delivers a drug package via the antibody itself, while simultaneously activating the immune system ("3-in-1 design") for personalised immunotherapy treatments.

"We have been researching precision medicine for close to 15 years now, as well as how we can use antibodies to influence an important key protein (CD40) in the immune system. We can now show that our new antibody method works as precision medicine for cancer," explains Sara Mangsbo, professor at the Department of Pharmacy at Uppsala University, who together with Johan Rockberg, professor at KTH Royal Institute of Technology, is the study's lead



author. The drug redirects the immune system to find and target specific mutations and gene changes that are only found in cancer cells, known as neoantigens. This is achieved by the new antibody both delivering the unique tumour-specific material directly to a particular type of immune cell and by stimulating this cell simultaneously, which then has the capacity to greatly enhance the T-cell response to the tumour. The results show that the method works in several

ways. Not only does it activate the right type of immune cells in human blood samples, but animal models show that mice receiving the treatment had prolonged survival and, at higher doses, also save the mice from cancer, and that the method is safer than previous cancer treatments the researchers have studied. Customised precision medicines can be both costly and timeconsuming to develop.

"The advantage of our drug is that it is easy to produce on a


tailored to the patient's disease or specific tumour. The medicine consists of two parts that are combined, a targeting bispecific antibody - which can be produced in large quantities in advance - and a custom peptide part, which is produced rapidly synthetically on a small scale for a desired type of cancer. Both in terms of production cost and the short time it takes to tailor a peptide to a new tumour, this increases availability and should make it quicker for patients to go from diagnosis to treatment," explains Johan Rockberg, Professor at KTH Royal Institute of Technology.

The aim of the study was to establish a more flexible, faster and safer treatment for cancer than those currently available. The study has already shown that the method has the potential to be customised for each patient, strengthening the immune system against cancer. The next step is to use the fully optimised production process to manufacture the drug candidate for further safety studies and then start clinical trials in

Patients with obesity and renal dysfunction may now be eligible for kidney transplants

ILLINOIS [US] : A collaborative research between a bariatric and transplant surgery team has provided fresh hope for individuals with end-stage renal disease (ESRD) and obesity. The study's authors investigated the results of metabolic and bariatric surgery in ESRD patients, as well as whether such surgery might enhance their eligibility for kidney transplantation. The findings are reported in the Journal of the American College of Surgeons.

"Obesity is a worsening problem in the United States, significantly impacting transplant eligibility. We established the CORT initiative - a collaborative for obesity research in transplantation recognizing the urgent need to address this issue, especially in underserved populations who suffer the most from obesity-related diseases," said corresponding study author Anil Paramesh, MD, MBA, FACS, professor of surgery, urology, and paediatrics and director of the kidney and pancreas transplant programs at Tulane University School of Medicine. Patients with ESRD face many difficulties without a transplant; their only alternative is to prolong life through dialysis, a process that is not only costly and time-intensive but also significantly diminishes the quality of life, Dr Paramesh noted. The study, conducted between January 2019 and June 2023, followed 183 ESRD patients referred for bariatric surgery, with 36 under-going weight loss surgery and 10



subsequently receiving kidney transplants. Results showed a 27% reduction in average BMI at the time of transplant, alongside improvements in hypertension and diabetes management. This improvement in the management of comorbid conditions enhanced patients' overall health and transplant viability. With obesity being a major cause of transplant exclusion, this collaborative program represents a path forward for patients who previously would be ineligible, Dr Paramesh said and may help pave the way for increased patient education and access. We've seen that bariatric surgery is not just about weight loss; it significantly improves other serious conditions like diabetes, high blood pressure, and sleep

apnea. This approach not only helps in reducing the patients' weight to a level where they can safely receive a transplant but also addresses the broader issue of health care disparities, particularly affecting Black and lower-income individuals," said Dr Paramesh.

However, the study also faced challenges, including a high drop-off rate of patients unwilling or unable to undergo surgery, and unique postoperative compli-

cations such as hypotension.
"Our findings indicate a pressing need to enhance patient education and support, making sure that potential candidates understand the benefits of weight loss surgery and its role in improving their eligibility for transplant,

Research shows how oestrogen protects against fatty liver

WASHINGTON DC [US] : New research from Sweden's Karolinska Institutet demon-Sweden's strates how oestrogen protects against MASLD, a fatty liver disease that has developed rapidly during the obesity epidemic. The study, published in the journal Molecular Systems Biology, demonstrates how a new medicine under development could become a future treatment for fatty liver disease and liver can-

The global obesity epidemic has resulted in a dramatic increase in fatty liver, a disease in which fat that does not fit into fat cells is stored in liver cells

Since last year, fatty liver due to obesity (and not excessive alcohol consumption) is known as MASLD (metabolic dysfunctionassociated steatotic liver disease) According to previous research as many as one in three adults are affected by some degree of MASLD, which in the worst cases can develop into cirrhosis and liver cancer.

However, the disease is very unevenly distributed between the sexes, with a large majority of affected individuals being men.

"Women have a natural protection until menopause due to the female sex hormone oestrogen," explains Claudia Kutter,



researcher Department of Microbiology, Tumor and Cell Biology, Karolinska Institutet who led the

Although women's protection has been known for some time, the mechanism behind the protective effect has been less clear. Now Claudia Kutter's research team may have found the answer.

The pharmaceutical company will now start clinical trials of the drug as a protection against fatty liver disease, while Claudia Kutter's research team will continue researching further ways to tackle the disease

"We want to focus on how to find the disease earlier and identifying new treatment targets,' she says. "Different approaches may be needed for different patients depending on their gender and hormonal status.

Researchers develope simple blood test to quickly recognize sarcoidosis

LOS ANGELES [US] : Researchers have developed a technique for quickly and cheaply identifying sar-coidosis, a chronic inflammatory illness characterized by the growth of microscopic lumps called gran-ulomas in the lungs and other organs.

The technique, which uses a simple blood test, may allow for the selective use of more intrusive diagnostic tests that are commonly employed to identify the disease. The results were reported in the American Journal of Respiratory and Critical Care

"Currently, diagnosing sarcoidosis isn't a straightforward process and requires tissue removal and testing with additional screenings to rule out other diseases, such as tuberculosis or lung cancer," said James Kiley, Ph.D., director of the NiH's Division of Lung Diseases at the National Heart, Lung, and Blood Institute (NHLBI).

"Using a blood test will help diagnose faster, particularly in those organs that are more challenging to biopsy and with less harm to the patient.'

Though the exact cause of sarcoidosis is unknown, researchers suspect it is an immune disorder triggered by a group of specific antigens, which are generally foreign substances that incite an immune response in the body. In the United States, an estimated 8-11 people per 100,000 are affected by sarcoidosis each year, according to previous research.

To identify antigens and determine which might be linked to sarcoidosis, scientists collected lung fluid samples and blood cells from patients with pulmonary sarcoidosis and then extracted the genetic material. Using a combination of molecular tech-



niques, the researchers homed in on two newly described disease-specific antigen biomarkers that only bind to the antibodies of sarcoidosis-positive

They next designed a highly specific blood test, which only requires a small amount of blood, to determine if they could accurately detect sarcoidosis. To verify the test, researchers compared blood samples from 386 people, which included patients with sarcoidosis, patients with tuberculosis, patients with lung cancer and healthy individuals. The researchers confirmed that their test was able to differentiate patients who had sarcoidosis from those with other respiratory diseases

More testing needs to be completed before this screening method is ready for clinical use, but it's possible that could be a reality within a few years, said Samavati.

People with essential tremor may be at higher risk of dementia, finds study

MINNEAPOLIS [US] : People suffering from essential tremor, a movement disorder marked by involuntary shaking, are three times more likely to have dementia than the general population, according to studies

The findings will be presented at the American Academy of Neurology's 76th Annual Meeting, which will take place in Denver and online from April 13 to 18,

Essential tremor is the most common tremor disorder, even more prevalent than Parkinson's disease. In addition to arm and hand tremors, people may have uncontrollable shaking of the head, jaw, and voice.

"While many people living with essential tremor experience mild tremor, in some individuals, the tremor can be quite severe," said study author Elan D. Louis, MD, MSc, at University of Texas Southwestern Medical Center in Dallas and a Fellow of the American Academy of Neurology. "Not only do tremors affect a person's ability to complete daily tasks such writing and eating, our study suggests that people with essential tremor also have an increased risk of developing

The study involved 222 people with essential tremor who had an average age of 79 at the start of the study. They took thinking and memory tests to determine whether they had normal cognitive skills, mild cognitive impairment or dementia at the start of

Participants then had followup exams every 1.5 years for an average of five years

Of this group, 168 people had normal cognitive skills, 35 had mild cognitive impairment and 19 had dementia at the start of the

During the study, 59 developed mild cognitive impairment and 41 developed dementia. Researchers then compared the rate at which people developed mild cognitive impairment and dementia, as well as the prevalence of these conditions, to the rates and prevalence for the general population. They also compared participants to the rates and prevalence for people with Parkinson's disease.

Researchers found 19% of participants had or developed dementia during the study, and each year an average of 12% of people diagnosed with mild cognitive impairment went on to develop dementia. These rates were three times higher than the rates in the general population. However, the rates were lower than those seen in people with Parkinson's disease, a population for which dementia is more prevalent.

"Our main motivation was to contribute to the reduction of the existing disparity in the knowledge that diabetic patients have regarding their disease," said first author Prof Pedro Lopes Ferreira, director of the Center for Health Studies and Research of the University of Coimbra. "With this study we evidenced the need to improve the disease knowledge of type 2 diabetic patients.

Knowledge levels vary widely To measure diabetes knowledge, the researchers employed a



Many individuals with type 2 diabetes lack potentially

test designed for persons with type 1 or type 2 diabetes. The test, among other things, asks about diet, signs and symptoms, and medication control. The research included 1,200 diabetics, over 40 per cent of whom were treated with insulin. The remainder of the sample followed particular diets, with some also using non-insulin oral antidiabetics, while others depended only on food.

The results showed that many participants (71.3 per cent) could answer food-related questions correctly, and that more than four out of five respondents demonstrated good knowledge of the positive impact of physical activitv. More than 75 pre cent of respondents also knew about the best method for testing blood sugar levels. In other areas, however, the

researchers found that knowledge was severely lacking. For example, when asked which food item should not be used to treat low blood sugar levels, only 12.8 per cent of participants answered correctly. The lowest percentage (4.4 per cent) of correct answers was on a question concerning the symptoms of ketoacidosis, a potentially life-threatening, latestage T2D complication.

One of the main reasons for this disparity in knowledge is probably the behavior of health professionals and the areas that are prioritized when informing Lopes patients,

Equipping patients with knowledge The researchers found

explained.

that the use of medication was one factor that impacted T2D knowledge. The percentage of correct answers was 51.8 pre cent for non-insulin treated patients, and 58.7 per cent for patients using insulin. Looking at socioeconomic and demographic factors, being younger than 65 years, having a higher education, not living alone, and following a specific diet had a positive impact on disease knowledge.

The researchers said that their results highlight the need to improve T2D knowledge about certain aspects of the disease, for example, blood sugar monitoring, which can help to avoid spikes in blood sugar levels that are associated with acute and chronic complications. Knowledge gaps within individual sections of the test are also something that needs to be addressed urgently, the team pointed out.

They also stated that studies with even more participants could help to better understand the role of the socioeconomic and clinical determinants of the disease. "We focused on patients' own knowledge of their disease, rather than disease management being based solely on biological indicators. We hope that the results obtained will allow professionals to change the way they inform patients," Lopes Ferreira concluded.

Vande Bharat Express trains from Varanasi

Turkey issues arrest warrants for Netanyahu, 36 Israeli officials over Gaza war crimes

MI News Service, Istanbul: Turkey's Chief Public Prosecutor's Office in Istanbul has issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and 36 other senior officials on charges of war crimes, genocide and crimes against humanity in Gaza. The warrants were approved by the Istanbul Criminal Court on Friday, November 7, following a wide-ranging investigation into Israel's military operations in Gaza since October 7, 2023, which Turkish authorities said resulted in the deaths of thousands of civilians and the destruction of vital infrastructure.

According to the statement, Israel's actions were conducted "systematically", resulting in: Widespread civilian casualties: The bombing of hospitals and residential area:Blockade of humanitarian aid to Gaza:Long-term destruction of civilian infrastructure. Among the incidents cited were the October 17, 2023, airstrike on Al-Ahli Baptist Hospital, which killed 500 people, and the March 21, 2025, attack on the Turkish-Palestinian Friendship Hospital.

The investigation extended to the Global Sumud Flotilla, a humanitarian convoy intercepted by Israeli naval forces in international waters while en route to Gaza. Prosecutors said the activists aboard were unlawfully detained, prompting Turkey to launch legal proceedings under the United Nations Convention on the Law of the Sea and relevant provisions of the Turkish Penal Code.

Victims repatriated to Turkey between



October 4 and 10, 2025, underwent medical and psychological examinations at the Istanbul Forensic Medicine Institution. Their testimonies, along with evidence provided by the Istanbul Bar Association No. 2, were included in the investigation file.

Following the review, prosecutors charged the 37 Israeli officials under:Article 77 - Crimes Against Humanity: Article 76 - Genocide: The list of those named includes:Benjamin Netanyahu, Prime Minister of Israel:Israel Katz, Defence MinisterItamar Ben-Gvir, National Security Minister: Eval Zamir, Chief of General Staff:David Saar Salama, Navy Commander.

The National Intelligence Organisation (MİT) and the Istanbul Police Department have been directed to identify and locate the suspects. The Prosecutor's Office said that the Gaza investigation is being conducted "meticulously and comprehensively" and reaffirmed Turkey's stance on accountability for war crimes and violations of international law.

Russia launches massive strike on Ukrainian military, energy facilities

MI News Service, Moscow: Russia said Saturday that it targeted Ukrainian military-industrial and gas-en-ergy facilities in response to alleged Ukrainian attacks on civilian sites. The Russian Defense Ministry described the operation as a "massive strike" using high-precision long-range weapons from air, land and sea, including hyper-sonic Kinzhal missiles and combat drones.

"All designated targets have been hit," the ministry said in a statement. Russia's air defense systems shot down two guided aerial bombs and 178 drones over the past day, said the ministry.

Delhi HC delivers split verdict on Engineer Rashid's plea against parole costs for attending Parliament

MI News Service, Delhi: The Delhi High Court on Friday delivered a split verdict on a petition filed by jailed Jammu and Kashmir MP Sheikh Abdul Rashid commonly known as Engineer Rashid challenging the financial conditions imposed on him for attending Parliament sessions while in custody. A division bench comprising Justice Vivek Chaudhary and Justice Anup Jairam Bhambhani expressed divergent opinions on the matter, with Justice Chaudhary rejecting Rashid's plea and Justice Bhambhani ruling in his favour. The case will now be referred to the Chief Justice's Bench to resolve the deadlock. Rashid had approached the High Court seeking modification of a March 25 order passed by a coordinate bench that required him to deposit around ₹4 lakh with the jail authorities as a prerequisite for attending Parliament during

his custody parole. Senior Advocate N. Hariharan, representing Rashid, contended that the amount demanded was unreasonably high and effectively hindered the parliamentarian's ability to represent his Baramulla constituency. He further argued that the inclusion of salaries of escorting police personnel in the cost calculation was inconsistent with the Delhi Prison Rules and that no administrative notification could override those statutory provisions. Rashid, the counsel said, was willing to bear legitimate daily expenses such as food and logistical costs but not the salaries of accompanying officers. The Delhi Police, in response, submitted a detailed cost breakdown to justify the charges, while Senior Advocate Siddharth Luthra appeared on behalf of the National Investigation Agency (NIA).

Sheikh Abdul Rashid, who won the 2024 Lok Sabha elections from Baramulla, has been incarcerated in Tihar Jail since 2019 following his arrest by the NIA in a 2017 terror-funding case under the Unlawful Activities (Prevention) Act (UAPA). A former MLA, Rashid has on multiple occasions been granted temporary bail and custody parole to either attend parliamentary proceedings or participate in election campaigns.

You can't study Sanskrit like a Brahmin: Dalit Phd scholar alleges caste bias by Kerala University dean

MI News Service, Thiruvananthapuram: A Dalit research scholar from Kerala University, Vipin Vijayan, has accused the Sanskrit Department, Dr. C. N. Vijayakumari, of caste discrimination and academic harassment after his PhD degree was allegedly withheld despite meeting all formal aca-

demic requirements. Vijavan, who completed his M.Phil and PhD research under the same professor's supervision, claimed that the Dean refused to forward his PhD file for approval and made casteist remarks questioning his right to study Sanskrit. "She told me that a Pulayan or Parayan can never master Sanskrit the way a Brahmin does," he wrote in a detailed social media statement on Wednesday, calling the experience "emotionally devastating and academically humili-

The scholar said that although his thesis Sadgurusarvasam: A Study was approved by two external examiners appointed by the Vice-Chancellor, the Dean allegedly blocked his final viva-voce certification, stating he was "not qualified to even speak Sanskrit." Vijayan said he possesses postgraduate degrees in Sanfrom Sree Sankaracharya University and Kerala University it-

He alleged that caste and political bias motivated the obstruction, noting that he was once a member of the Students' Federation of India (SFI), while Dr. Vijayakumari is "openly aligned with RSS-BJP ideology" and a member of a Sangh-affiliated teachers' body. "If I am politically biased, why is hers never questioned?'

Kashmir clerics slam Vande Mataram order as hindutav push, demand withdrawal

MI Service, Srinagar: The Mutahida Majlis-e-Ulema (MMU), an alliance of leading Islamic scholars and religious organisations in Jammu and Kashmir led by Mirwaiz Umar Farooq, has denounced the Jammu and Kashmir government's directive instructing schools to commemorate the 150th anniversary of Vande Mataram.

The group described the move as an attempt to impose an "RSSdriven Hindutva ideology" on the Muslim-majority region under the guise of cultural celebration.

In a statement released in Srinagar, the MMU said the order issued by the Department of Culture directing schools to hold musical and cultural events featuring 'Vande Mataram' was "coercive, unjust, and un-Islamic." It urged Lieutenant Governor Manoj Sinha and Chief Minister Omar Abdullah to revoke the order immediately, citing widespread public concern.

The directive has caused deep anguish among Muslims of the region, who are reaching out to the religious leadership to take up this serious matter," the statement read. "Forcing Muslim students or institutions to engage in acts that conflict with their faith is both unjust and unacceptable.

The government circular called on schools across Jammu and Kashmir to organise assemblies



and performances between October 31 and November 7 to mark the 150th anniversary of the national song. Earlier, the Chief Secretary chaired a meeting to ensure the participation of schools across the Union Territory, calling student involvement "crucial for broader outreach.'

The MMU argued that Vande Mataram contains expressions of reverence that contradict the Islamic belief in tawhid, or the oneness of God. "Reciting or singing Vande Mataram involves devo-

Islam," the statement said. "Islam teaches love for one's nation through service, compassion, and moral integrity not through rituals that compromise faith.

The religious body alleged that the order reflected a larger ideological campaign aimed at reshaping the cultural and religious identity of the region. "The directive appears to be a deliberate attempt to advance an RSS-inspired narrative in a Muslim-majority territory rather than promoting genuine unity and mutual respect," the

It added that Muslims in Kashmir have consistently demonstrated patriotism through community service, education, and social welfare. "Compelling participation in religiously sensitive activities violates freedom of belief and mutual respect," it said, urging the administration to withdraw the order immediately to avoid further distress.

As of now, the Jammu and Kashmir administration has not issued any official response to the MMU's statement. Vande Mataram, written by Bankim Chandra Chatterjee in the 1870s and later included in his 1882 novel Anandamath, became a rallying cry during India's freedom struggle and was adopted as the national song in 1950.

Abhishek Sharma achieves multiple feats upon completing 1000 T201 runs

BRISBANE: Abhishek Sharma made history by hitting 1,000 runs in T20 Internationals, setting new world and Indian records. He achieved the feat during India's fifth and final T20I of the ongoing series against Australia as the two sides squared off here at The Gabba on Saturday.

He became the fastest to reach this milestone for a single country in terms of balls faced and also the quickest Indian based on matches played. Abhishek's achievement surpassed the previous global record held by Australia's Tim David, who scored 1,000 runs in 569 balls during his impressive 74 off 38 balls in Hobart on November 2.

Suryakumar Yadav was previously in second place, having faced 573 balls, while New Zealand's Finn Allen was third with 611 balls. In terms of total balls faced in T20Is, David now ranks sixth, having faced 614 balls to score



Additionally, Abhishek almost both Singapore and Australia. broke Virat Kohli's record, who

over 29 matches. Abhishek reached the milestone in 28 innings. Therefore, Abhishek is the fastest Indian to 1,000 runs in T20Is based on matches played.

Abhishek has the record for reaching 1,000 runs the fastest in terms of balls faced. However, the record to reach this milestone in the fewest matches is shared by England's Dawid Malan and the Republic's Sabawoon Davizi, both achieving it in their

India's Sanju Samson (995 runs) and Tilak Varma (991 runs) are close to reaching the 1,000run mark in T20I cricket, but neither made it to India's playing XI in the fifth and deciding T20I against Australia.

It is also noteworthy that Abhishek Sharma survived two scares, once before reaching the 1,000-run milestone and again in the match during the first 11 balls

Had a discussion with Naqvi, trying to bring Asia Cup trophy home at the earliest, says Saikia

One is the formal board meeting and the other is the informal board meeting. There were two meetings and in both the meetings, I and the chairperson of PCB, Mohsin Naqvi were present." "But



as it (the Asia Cup trophy issue) was not on the agenda of the ICC's meeting, we made a request and the ICC facilitated a meeting between me and Naqvi on the sidelines of the board meeting." 'We had a long meeting for about an hour and at the initiative of one of the very senior ICC board members, who's a very senior person. So, they facilitated the conversation, and then the discussion between India and Pakistan happened yesterday at the ICC's meeting place." "Mohsin Naqvi and I had a cordial discussion and we are trying to solve this problem. He will also be giving us some

up some options so that the stalemate can be broken at the earliest possible time," said Saikia to IANS on Saturday. Before leaving for the ICC quarterly meeting in Dubai, Saikia had told IANS about raising the grievance around the delay in the Asia Cup trophy handover despite a letter being sent to the continental body. It remains to be seen if a solution to the trophy handover issue comes in the next few days. There were certain reports suggesting that a committee might be constituted to resolve the Asia Cup trophy impasse. Saikia, however, dismissed.
