Detonators used in Delhi blast, links found with Faridabad terror module

MI News Service, New Delhi: The death toll in the powerful blast near Red Fort rose to 12, with two more people succumbing to injuries since last night, police said on Tuesday. Till last night, ten people were confirmed to have died in the blast and 30 others were injured, officials said. The driver of the private car that exploded near the Red Fort on Monday evening, allegedly had links to the Faridabad terror module where huge cache of explosive material was seized, Delhi Police sources said today adding Umar Mohammad, a Pulwama resident and a doctor, was allegedly driving the Hyundai i20 car that was used in the explosion near the parking area of the Red Fort Metro Sta-

Preliminary findings by police and other investigating agencies suggest ammonium nitrate, fuel oil and detonators might have been used in the blast near the Red Fort Metro station gate Number one at around 7 pm last evening, causing huge damage in that area besides claiming several lives and injuring 30 people. The investigators said initial findings suggest a possible link between the Delhi blast and the Faridabad terror module, where nearly 400 kg of ammonium nitrate was seized. However, final reports are still awaited, the source added. Police said CCTV footage of the car that exploded shows a "masked man" driving the car. Multiple

Delhi Police remains on high alert after the powerful blast that ripped through a slow-moving car at a traffic signal near the Red Fort metro station and also leaving several other vehicles gutted

and completely destroyed. Hours before the blast in Delhi, eight people, including three doctors, were arrested, and over 2,900 kg of explosives were seized with the uncovering of a "white collar" terror module on Monday. The 2,900 kg of explosive material recovered in Faridabad includes ammonium nitrate, potassium nitrate and sul-

phur. Of this, 360 kg of inflammable material, suspected to be ammonium nitrate and some arms and ammunition were recovered. according to police. Police sources alleged Umar Mohammad was another doctor in the Faridabad module who had already been arrested. Umar Mohammad, who is a doctor by profession, was al-

legedly associated with the Jaishe-Mohammad terror module, they said. According to sources, a man named Tariq from Pulwama, Jammu and Kashmir, who has been arrested, is said to have given the Hyundai i20 car to Umar Mohammad. After his fellow doctors, who were part of the terror module, were arrested, Umar Mohammad allegedly carried out this terror attack, fearing that he too might be caught, sources added. Following the blast, security across the national capital has been intensified, and vehicle checking at all border points intensified as well. All vehicles entering Delhi, whether private or commercial, are being thoroughly checked and verified as part of heightened security measures, officials said."Multiple teams have been deployed to scan CCTV footage from the vicinity of the Red Fort and adjoining routes to know more about the masked man driving the Hyundai i20 car in which the explosion occurred,' the police said.

Chargesheet filed against Deshraj Singh in Krishnanagar college girl murder case

Krishnanagar: Seventy-eight days after the brutal murder of a college girl inside her own home in Krishnanagar, police on Tuesday filed a chargesheet against the main accused, Deshraj Singh, along with his father and maternal uncle.

According to police sources, Deshraj had allegedly shot the young woman after entering her residence, enraged over being rejected in a one-sided love affair. The incident, which had triggered widespread outrage in the locality, took place nearly two and a half months ago in the Krishnanagar police district area.

Additional tendent of Police (Krishnanagar Police District) Mit Kumar Makan said, "The chargesheet has been filed under Section 103 of the Bharatiya Nyaya Sanhita (murder) and relevant sections of the Arms Act."

He added that the chargesheet runs to about 300 pages and includes statements from 21 witnesses. Forensic evidence, ballistic reports, and digital data collected during the probe have been annexed to the document.

Police officials said Deshraj was arrested soon after the incident, and his family members were later booked for alleged complicity in sheltering him and obstructing the investigation.

The gruesome crime had sent shockwaves through Krishnanagar town, with residents and student groups staging protests de-manding swift justice for the

Frosty nights ahead as Bengal's minimum temps fall sharply

Couple accuses of holding dual citizenship, enjoying benefits in both India and Bangladesh she claimed, are enrolled



Service, Hanskhali: A bizarre case of alleged dual citizenship has triggered political uproar in Nadia's Bagula area, after a local woman accused her in-laws of being citizens of both India and Bangladesh, and enjoying the government benefits of both nations simultaneously.

The complainant, Mousumi Biswas, a resident of Majdia Naghata in Krishnaganj, married Biswajit Biswas, a resident of College Para in Bagula, about a year ago. Mousumi has alleged that Biswajit, who she claims is an employee of the Kolkata Municipal Corporation, hid a serious illness from her before

Following disputes over the issue, she was allegedly driven out of her matrimonial home. Mousumi later lodged a written complaint with Hanskhali Police Station, accusing her in-laws of holding

Bangladeshi citizenship. In her complaint, Mousumi claimed that her father-in-law, Sunil Biswas, is a Bangladeshi national who entered India on a medical visa. She further alleged that her sister-inlaw, Shiuli Biswas, and Shiuli's husband, both residents of Orakandi in Gopalganj, Bangladesh, are schoolteachers there, yet their names also appear on the Indian voters' list.

Mousumi alleged that her sister-in-law fraudulently availed of several West Bengal government welfare schemes, including Lakshmir Bhandar, by concealing her true identity. Their two children,

in a government primary school at Garapota, Nadia, even though the family primarily resides in Ban-

The allegations have stirred intense political debate. Local Trinamool Congress leader Anup Das said, "It's a serious offence if someone is enjoying the benefits of two countries simultaneously. The administration must investigate and act firmly."

Echoing similar con-cerns, BJP district leader Amit Pramanik remarked, "This proves our fears right. This is exactly why NRC and SIR are essential. People cannot be citizens of two countries and exploit both systems.

When approached for comment, Jabarani Biswas, the accused wommother-in-law, denied all allegations, claiming she has no daughter, only two sons. However, several neighbours contradicted her statement, insisting that she indeed has a daughter living in Bangladesh.

The police are yet to of-ficially confirm whether a probe has been initiated. The alleged cross-border dual-citizenship issue has meanwhile sparked heated discussion across Bagula, with residents demanding a thorough in-

Excise duty surges set to spike liquor costs from Dec 1

News Kolkata: Liquor lovers in West Bengal may soon have to dig deeper into their pockets. The state government has announced a revision in excise duties on all categories of liquor, excluding beer, with the new rates coming into effect from December 1, 2025. The move, notified recently by the State Excise Department, is expected to significantly impact retail prices of both Indian-made and foreign liquor across the

According to the official notification, additional excise duty will be levied on all types of alcoholic beverages except beer. The department has directed all manufacturers, distributors, and wholesalers to clear their existing stock at the current price by **November 30, warning that unsold inventory after that date must be sold under the new price structure. The timing of this revision just weeks before Christmas and New Year's Eve celebrations—has sparked concern among traders and consumers alike. Industry insiders predict a temporary market disruption in early December, as sellers rush to adjust pricing and liquidate old stocks. "This sudden revision is likely to affect consumer demand and may cause temporary instability in the supply chain," said a senior distributor, request-ing anonymity. "Retailers are already under pressure to manage old inventory before the new rates take effect." While officials assert that the decision aims to boost the state's excise revenue, they have refrained from specifying the projected increase in collection. "It will take at least a month after implementation to assess the exact impact on revenue," a senior Excise Department of-ficer stated. For consumers, however, the impact will be immediate. With liquor prices set to rise just ahead of the festive season, Bengal's traditional winter revelry from Christmas celebrations to year-end gatherings—could come with a heavier price tag this year.

Court on Tuesday issued notice to the Election Commission of India (ECI) on pleas challenging the constitutional validity of the Special Intensive Revision (SIR) of electoral rolls in Tamil Nadu and West Bengal.

A bench of Justices Surya Kant and Joymalya Bagchi also ordered that the High Courts to keep in abeyance the petitions filed before them in relation to the SIR of these states and Bihar.

It has now posted the matter for hearing on November

"Since this court is seized of the matter pertaining to legality of SIR of electoral rolls in various states, including Bihar, WB, TN, Pondicherry, etc., we request jurisdictional High Courts to keep in abeyance or defer the writ proceedings if any filed in those High Courts touching the validity of SIR in their states," observed the

SIR in West Bengal was challenged by TMC MP Dola Sen, and West Bengal Pradesh Congress Committee, while netra Kazhagam (DMK), through its secretary RS Bharathi, challenged the SIR exercise in Tamil Nadu.

Supreme Court seeks ECI

During the hearing, senior advocate Kapil Sibal, appearing for DMK, alleged that the SIR exercise was being undertaken in a tearing hurry, unlike before, when it used to take three years to revise the electoral rolls.

To this, the bench asked the petitioners why they were so apprehensive about the exer-

"The situation in different states is different. This monsoon season in Tamil Nadu there would be a lot of rain, that might not be in other states. It's always heavy during November and December. It is not uniform across the country. The BLOs, etc., will have to manage the flood relief as well. December and January are harvest season too in Tamil Nadu, and that time is not conducive. Christmas vacations will also be declared, there might be minimum participation in enumeration process. This may not be relevant in other states," Sibal Bengal.

Meanwhile, the apex court also asked ECI to respond to an application seeking a direction to the panel to ensure that an acknowledgement slip is given to all voters who submit the enumeration forms.

ECI announced last month that it will conduct the second phase of SIR of electoral rolls across 12 states and Union Territories, with the final voter list to be published on February 7, 2026. The first phase of SIR was done in Bihar before the assembly polls.

AIIMS Kalyani Conducts Landmark International Workshop on Facial Plastic and Reconstructive Surgery

MI News Service, Kalyani: In a pioneering initiative, the Department of ENT and Head-Neck Surgery at AIIMS Kalyani, in collaboration with the Departments of Anatomy and Anaesthesiology, recently organ-ised a three-day international surgical workshop titled "RHI-NO-AESTHETICON." The event focused on the intricacies of Rhinoplasty and Facial Plastic Surgery, offering participants an in-depth exposure to both cosmetic and reconstructive procedures of the face.

This was the first-ever international surgical workshop hosted by AIIMS Kalyani, marking a milestone for the institute's growing role in advanced medical training and research. One of the unique highlights of the programme was the use of fresh frozen cadavers for hands-on training, a first for AIIMS Kalyani, allowing participants to experience the feel of live tissues during practice sessions.

The workshop was inaugurated by Dr. (Prof.) Aravind Executive Director, AIIMS Kalyani, along with Prof. Dwaipayan Mukherjee, Presi-



dent, AOI, who presided as the Chief Guest.

The event brought together several eminent experts, including Dr. Ullas Raghavan from the United Kingdom, an internationally recognised Facial Plastic Surgeon, Dr. Narmaya Thapa from Kathmandu, Nepal, Prof. Rakesh Kumar, Head of ENT, AIIMS New Delhi, and Dr. Kapil Soni, among other distinguished faculty members.

The workshop covered a broad range of reconstructive and aesthetic surgical procedures, addressing congenital deformities of the lip, palate, and ear; post-cancer facial reconstruction; and rejuvenation of ageing features such as drooping eyelids, jowls, and chin, through surgical as well as minimally invasive methods.

Participants, including residents, trainees, and junior surgeons, expressed high appreciation for the sessions, citing the rare opportunity for direct, practical learning under the supervision of global experts.

The second phase, in which eight ministers of his cabinet are in the fray, involves high stakes for the ruling NDA, as also the opposition INDIA bloc, which pins its hopes on the incumbency factor, as also the high concentration of Muslims voters in many of the poll-bound districts. After today's polling, the results for this high stake election will be declared on Novem-

Earlier in the morning, about 38.5 per cent electorates exercised their franchise in the first four hours of voting, which began at 7 a.m. in the second phase, an election official said. Till then Gayaji district recorded the highest polling of over 38.4 per cent, followed by Kishanganj (35.81%) and Jamui (35.77 %). Bhagalpur district, had, however, recorded the lowest turnout of 23.43 per cent till 11 am. Voting for the 122 constituencies in the 243 member Bihar assembly in the second and final phase were held amid tight security arrangements. Prime Minis-ter Narendra Modi and Chief Minister Nitish Kumar urged electors to exercise their franchise in the final phase of polling and set a new voting record. Opposition Congress leader Rahul Gandhi and Chief ministerial candidate of Mahagathbandhan Tejaswi Yadav of the RJD also made similar appeal to the voters. "Today marks the second and final phase of voting in the Bihar assembly elections. I urge all voters to participate enthusiastically and set a new voting record. I especially urge my young friends from the state, who are voting for the first time, to not only cast their votes themselves but also inspire others to do so," the PM said on X, while Nitish Kumar said voting is "not only our right, but also a responsibility". "I appeal to voters to exercise their right to vote in the second phase of the Bihar assembly elections," he said in a social media post. The districts which went to the polls today include West and East Sitamarhi, Champaran, Madhubani, Supaul, Araria and Kishanganj, all sharing borders with Nepal.

Shah holds security review meeting after Delhi blast

The high level meeting at the Home Ministry office in Kartavva Bhawan to assess the security situation in the national capital, reviewed the progress of the investigation and measures to strengthen security in and around Delhi. The Delhi Police has filed a First Information Report (FIR) under the Unlawful Activities (Prevention) Act (UAPA) and the Explosives Act in connection with the blast. The case, registered at Kotwali police station, invokes Sections 16 and 18 of the UAPA, which pertain to punishment and conspiracy for terrorist acts, along with relevant provisions of the Bharatiya Nyaya Sanhita. According to investigators, the explosion occurred when a slow-moving car halted at a traffic signal near the Red Fort metro station. The high-intensity blast destroyed the vehicle, triggered a fire, and damaged several nearby cars. Forensic teams and bomb disposal experts have collected samples from the scene for analysis. Meanwhile, the national capital remains on high alert. Security has been tightened across key locations, including the Indira Gandhi International Airport, railway stations, and bus terminals. Raids are underway at multiple locations to trace those responsible.

"There were three passengers inside the i20 car. Other vehicles nearby were also destroyed. Teams from the Delhi Police, FSL, NIA, and NSG inspected the place of occurrence and are taking stock of the situation," he said. Officers said the blast was so powerful that it gutted several vehicles and shattered window panes of nearby cars, buildings, and glass panels of the metro station. According to the Delhi Fire Services, ten fire tenders were rushed to the spot, and the blaze was brought under control by 7.29 pm. "All senior officers are also looking that the blast related to Faridabad terror network," another source said. Videos shared by local traders showed the magnitude of the explosion - mangled bodies, damaged vehicles, and scattered debris near the blast site.

raise awareness among the Railway beneficiaries about its causes, prevention, and treatment on 10.11.2025, at the hospital's conference room. Dr. Suresh Chandra Mondal, Assistant Professor, Department of Gynaecology

& Obstetrics, Malda Medical College and Hospital, along with his students, delivered an informative session covering the symptoms, causes, risk factors, diagnosis, and management of the condition, which often goes unreported by those affected. He highlighted how this ailment significantly impacts the quality of life, particularly among women.

Dr. Mondal emphasized the importance of lifestyle modifications, early diagnosis, and identification of associated risk factors such as diabetes, smoking, alcoholism, and repeated childbirth. He elaborated on both

non-surgical and surgical treatment options available for managing the condition. Dr. Mondal also discussed the use of Platelet Rich Plasma (PRP) therapy, which promotes healing and improvement without the need for surgical intervention. Stress incontinence refers to the involuntary

leakage of urine during activities that put pressure on the bladder, such as coughing, sneezing, laughing, or exercising. This condition occurs when the pelvic floor muscles that support the bladder and urethra are weak, or when the sphincter muscle controlling urine flow becomes weakened. Common causes include pregnancy, childbirth, obesity, aging, and prostate surgery.

Doctors, healthcare professionals, patients, and women employees from various departments actively participated in the session. The seminar proved highly beneficial in promoting awareness among both male and female employees, paramedical staff, and patients regarding this important yet often overlooked health concern.

Seoul: South Korea's new carbon reduction target unveiled this week is expected to pose challenges for local businesses amid lingering global economic uncertainties, while at the same time offering an opportunity for a full-fledged green transition that will pay off in the long run, experts said on

Tuesday.
On Monday, the Presidential
Commission on Carbon Neutrality and Green Growth said it approved a goal to reduce South Korea's greenhouse gas emissions by 53-61 percent from 2018 levels by 2035.

The nationally determined contribution (NDC) target, endorsed at a Cabinet meeting on Tuesday, will be officially unveiled at the 30th United Nations Climate Change Conference (COP30) in Belem, Brazil, which began Monday and will run through Nov. 21, reports

Yonhap news agency. The business community fears the carbon reduction plan may deal a harsh blow to key industries, including automobiles, steel, petrochemicals and cement, as they will face higher financial burdens in building carbon reduction facilities and purchasing emission credits. "While adjusting to changes in the global economic environment, including U.S. tariff policies, has become an urgent issue, setting the reduction target at 53 to 61 percent by 2035 will pose a significant burden for companies," a group of 14 business lobbies said in a joint statement. The business organisations noted that relevant reduction technologies have not yet been fully commercialised. urging the government to introduce additional support measures for companies, such as refraining from raising electricity rates.

Scientists uncover cellular "toolkit" to reprogram immune cells for cancer therapy: Study

Scania [Sweden] : A team of researchers at Lund University in Sweden has identified the molecular tools that are needed to reprogram ordinary cells into specialised immune cells. This finding could pave the way for more precise and personalised cancer immunotherapies. The team has taken a significant step toward harnessing the immune system to combat cancer. Their work describes how they identified a genetic toolkit that programs two powerful subtypes of dendritic cells - key sentinels of the immune system.

Dendritic cells are a diverse group of immune cells that act as the body's "teachers", guiding the immune system to recognise and attack threats such as viruses, bacteria or tumours. Each subtype triggers different immune responses, adapting to the nature of the threat. Supplying patients with dendritic cells designed to target their cancer could make treatments more precise and powerful. Understanding how cellular diversity is generated during the development process has long been a mystery. Scientists have identified some of the so-called transcription factors - proteins that switch genes on and off - that control the development of cells, but how these factors work together to create different types of dendritic cells has been unclear.

Now. the team researchers behind this publication has conducted a systematic mapping of the pathways to

70 different transcription factors and seeing how they could reprogram ordinary cells into dendritic cells, they identified two distinct toolkits that reprogrammed skin or cancer cells into powerful dendritic cell subtypes. Advanced gene analysis revealed that these factors, early in the process, open different parts of the genome and thereby determine the fate of different cells. "Through cellular reprogramming, one cell type can be converted into another. We identified two specific combinations of three factors that act as tools to build two dendritic cell types: conventional type 2 dendritic cells and plasmacytoid dendritic cells," said Filipe Pereira, professor of molecular medicine at Lund University, who has led the research. When tested in mouse cancer models, one engineered dendritic cell subtype triggered a strong immune response against melanoma, while others acted against breast cancer in ways similar to their natural counterparts. While still in the early stages, the findings suggest that supplying patients with dendritic cells tailored to their specific cancer could in the future, make immunotherapy more powerful and personalised. "Immunotherapy is one of the most promising areas in medicine, but many patients still do not respond. Our work shows that by generating specific dendritic cell types, we can better match the immune

Scientists find brain chemical tied to trauma and depression: Study

New York [US] : Researchers identified SGK1 as a key chemical connecting childhood trauma to depression and suicidal behaviour. High SGK1 levels were found in the brains of suicide victims and in people with genetic variants linked to early adversity. Drugs that block SGK1 could offer a new kind of antidepressant, especially for patients resistant to SSRIs.

Neuroscientists from Columbia University and McGill University have identified a brain chemical that appears to drive depression and suicidal thinking in individuals who faced trauma or hardship during childhood.

The researchers found that high levels of a stress-related protein called SGK1 are closely associated with depression among people who endured early-life adversity. This discovery opens the door to a new type of antidepressant that blocks SGK1 activity and may be more effective for people who were neglected or abused as children.

Studies show that about 60% of adults in the United States diagnosed with major depression and roughly two-thirds of those who attempt suicide experienced some form of trauma or adversity during childhood.

"Current antidepressants are often less effective for people with a history of childhood adversity, who represent a large proportion of adults with depression," says the study's lead author, ChristophAnacker, assistant professor of clinical neurobiology in the Department of Psychiatry at Columbia University Vagelos College of Physicians and Surgeons. "What's exciting about our study is that it raises the prospect of quickly developing new treatments, as SGK1 inhibitors are in development for other conditions, and gives us a screening tool to identify people at greatest

Why Depression After Early Trauma May Be Different Childhood adversity (such as physical abuse or growing up in a dysfunctional family) is one of the strongest predictors of

depression in adulthood. While common antidepressants like SSRIs are helpful for many people, they are less effective for those who experienced early trauma. "This suggested to us that the biological processes that lead to depression and suicidality in general may differ from those with less stressful childhoods," Anacker explains.

Around ten years ago, Anacker's team discovered unusually high levels of SGK1 -a stress-responsive protein -- in the blood of unmedicated patients with depression. Evidence of SGK1's Role in

Depression and Suicide In the latest research, the

scientists examined the brains of adults who had died by suicide and found elevated SGK1 levels. Those who had suffered childhood trauma showed the highest concentrations, up to twice as much as others who had also died by suicide. The researchers also studied children exposed to early adversity and discovered that those carrying genetic variants that increase SGK1 production were more likely to experience depression as teenagers. These findings point to SGK1

as a biological driver of depression and suicidal behaviour, particularly among people affected by trauma early in life.

Developing a New Kind of Antidepressant Based on these results,

Anacker and his colleagues suggest that drugs designed to block SGK1 might help prevent or treat depression in individuals with a history of trauma. In experiments with mice, SGK1 inhibitors delivered into the bloodstream prevented the animals from developing depressive-like behaviours during chronic stress. SGK1 inhibitors are already being evaluated for use in other conditions, including atrial fibrillation. Anacker's team now hopes to begin clinical trials in people who have depression and a background of early life adversity.

The researchers also propose that genetic screening could identify individuals most likely to benefit from an SGK1-targeted antidepressant.

'There's an urgent need to identify and treat people with the greatest risk of depression and suicide after exposure to early life adversity and SGK1 is a promising avenue to explore, Anacker says.

The research, titled "Hippocampal SGK1 promotes vulnerability to depression: the role of early life adversity, stress, and genetic risk", was published in Molecular Psychiatry.

At Least 12 killed, 27 injured after suicide bombing outside Islamabad district court in Pakistan



MI News Service, Islamabad: At least twelve people were killed and 27 others injured on Tuesday in a suicide blast outside the district and sessions court building in Islamabad's G-11 area, according to Dawn.

The explosion took place amid several high-profile events being hosted in the capital, including the Inter-Parliamentary Speakers' Conference, the 6th Margalla Dialogue, and a cricket match between Pakistan and Sri Lanka in Rawalpindi.

Dawn quoted a senior Islamabad police official confirming the initial death toll. Later, Interior Minister Mohsin Naqvi briefed reporters outside the court, stating that a "suicide blast" had occurred at 12:39 pm.

Confirming the casualties, the minister said that the injured were receiving medical treatment and that Prime Minister Shehbaz Sharif was personally monitoring the

The attacker stood outside the court for around 12 minutes. He first attempted to go inside the court, but then targeted the police vehicle after he was unable to do so," Naqvi said.

He added that an investigation was underway, with identifying the attacker being a top priority. "I assure you we will identify him in the next few hours," he said, adding that authorities were linking the blast to other developments in the capital. "In the coming hours or day, we will be very clear about it. We are not taking this blast as a normal blast because today's blast is taking place in Islamabad, on this occasion, at this time, and it conveys a lot of messages.

Naqvi assured that those responsible would not be spared and said the Army, Rangers, and police were ensuring the security of all international events in the city.

A spokesperson for the Pakistan Institute of Medical Sciences (PIMS) confirmed to Dawn that "12 people have been martyred in the blast," adding that the number of injured had risen to 30. "Following the attack, an emergency has been declared at PIMS, and medical assistance to the injured is underway," the spokesperson said. "All resources are being utilised to assist the injured."

According to Dawn, security was tightened around the Judicial Complex, adjoining courts, and other key buildings across Islamabad following the explosion. Videos circulating on social media showed flames and thick smoke rising from a burnt vehicle behind a security barrier.

Eyewitness lawyer Mohammed Shahzad Butt described it as a "massive blast." He told AFP, "Everyone started running inside out of panic. I have seen at least five dead bodies lying at the front gate."



Taiwan detects eight PLA aircraft

fence (MND) on Tuesday detected eight sorties of Chinese military aircraft and three naval vessels operating around the island until 6 am (UTC+8). One of the eight sorties crossed the median line of the Taiwan Strait and entered the island's northern air defence identification zone (ADIZ), according to a statement released by the ministry on X. "8 sorties of PLA aircraft and 3 PLAN vessels operating around Гаiwan were detected up until 6 a.m. (UTC+8) today. 1 out of 8 sorties crossed the median line and entered Taiwan's northern ADIZ," MND wrote in an X post.

"We have monitored the situation and responded," the MND added, referring to the routine air and naval deployments by China's People's Liberation Army (PLA) and Navy (PLAN) near the Island. Earlier, on Monday, Taiwan's MND detected six sorties of Chinese military aircraft and seven naval vessels operating around the island until 6 am (UTC+8). Two of the six sorties crossed the median line of the Taiwan Strait and entered the island's southwestern air defence identification zone (ADIZ), according to a statement released by the ministry on X.

"6 sorties of PLA aircraft and 7 PLAN vessels operating around Taiwan were detected up until 6 a.m. (UTC+8) today. 2 out of 6 sorties crossed the median line and entered Taiwan's southwestern ADIZ. We have monitored the situation and responded," MND wrote in an X post.

The medi'n line in the Taiwan Strait serves as an unofficial boundary between Taiwan and China, but Beijing has increasingly violated it in recent years as part of its pressure campaign against Taipei.

The latest military movements come amid heightened ten-



what they see. During the ceremony, Trump also noted that the United States and India were "pretty close" to reaching a "fair trade deal" and indicated his willingness to re-

duce tariffs imposed on New Delhi. "We're making a deal with India, much different deal than we had in the past. So right now, they don't love me, but they'll love us Trump said. He added, "We're getting a fair deal, just a fair trade deal. We had pretty unfair trade deals. They're very good negotiators, Sergio, so you have to take a look at that, if you would please.

MADRID: LamineYamal has been withdrawn from Spain's squad for their upcoming 2026 World Cup qualifiers after receiving medical treatment, the Spanish Football Federation (RFEF) confirmed on

According to the RFEF, the 18-year-old Barcelona winger, who has been sidelined for his club's last five matches with the problem, underwent a radiofrequency

procedure on Monday. "This procedure was performed without prior notification to the national team's medical staff, who only learned of the details through a report received at 10:40 p.m. last night, which indicated a medical recommendation for rest for 7-10 days," RFEF said in a statement.

"In view of this situation, and prioritising the player's health, safety and well-being at all times, the Royal Spanish Football Federation has taken the decision to release the player from the current squad."

Yamal was originally expected to join the Spain squad on Monday as preparations began for their upcoming 2026 World Cup qualifiers. However, the Barcelona winger continues to struggle with a groin injury that has sidelined him in recent weeks and kept him out of Spain's previous qualifying window in October. Spain currently lead Group E with a perfect record - four wins from four matches, scoring 15 goals without conceding. A pair of positive results in the upcoming fixtures would secure their place at the 2026 World Cup, to be held in the United States, Canada, and Mexico.

Luis de la Fuente's side will first travel to Tbilisi to face Georgia on Saturday, before returning home to play Turkey in Seville on November 18. Yamal, who has been in fine form for Barcelona this season, has scored six goals and provided six assists in 11 appearances across competitions. JEK beat Delhi for the first time in Ranji Trophy history

NEW DELHI: Jammu and Kashmir achieved its first-ever win against Delhi in Ranji Trophy history, defeating the hosts by seven wickets on Tuesday here at the ArunJaitley Stadium.

It was their second outright victory of the season, advancing the team to second place in the Elite Group D points table, just behind leaders Mumbai.

J&K chose to bowl first after winning the toss, and AuqibNabi tore through the Delhi batting line-up with figures of 5-35, supported by Vanshaj Sharma (2-57) and AbidMushtaq (2-30), as the hosts were dismissed for 211 in their first innings.J&K also lost their top order

early, but skipper ParasDogra's 106 off 183 balls and Abdul Samad's 85 off 115 balls, followed by KanhaiyaWadhawan's quick 47 off 81 balls, kept the momentum going, with the visitors folding at 310 all out, taking a 91-run lead.

Arsenal's Premier League clash against Everton rescheduled

LONDON: Arsenal's Premier League clash against Everton in December has been rescheduled, with the fixture at the Toffees' new Hill Dickinson Stadium now taking place on Saturday, December 20 at 8 pm.

This Premier League match was previously scheduled for Sunday, December 21. However, the EFL scheduled Arsenal's Carabao Cup quarterfinal against Crystal Palace on Tuesday, December 23, due to the Eagles' participation in the UEFA Conference League.

When that fixture was officially scheduled and before tickets went on sale for the Gunners' away game at Everton, Arsenal opened dialogue with the Premier League and Everton Football Club to request a date change to avoid playing two matches in the space of 48 hours. As a result, the

match has moved to Saturday, December 20. "Playing two matches within 48 hours contravenes FIFA recommendations, which have established a consensus for a minimum of 72 hours' rest between games. This recommendation is in place to protect player health and fitness. Recovery time between matches is especially important during busy periods of the season, such as December," Arsenal said in a statement on Tuesday.

"It is also worth noting that Christmas Eve was mooted as the date for the Carabao Cup quarter-final but was rejected due to the proximity to Christmas Day, which would impact our supporters and workforce," it added.

Arteta has previously voiced his frustration over the fixture reshuffle, calling for a more balanced approach. Speaking after the EFL Cup date was confirmed,

Arteta said, "Hopefully they will move our Premier League match, because to play two days later doesn't make any sense. So now that we know the date for the EFL Cup match, I'm sure the Premier League will adjust accordingly.

Sinner downs ailing Auger-Aliassime to begin ATP Finals title defense

TURIN ` TURIN : Home favouriteJannik Sinner Home made a confident start to his ATP Finals title defense with a 7-5, 6-1 victory opening against an injury-hampered Canadian Felix Auger-Aliassime.

With his one-hour, victory, 41-minute Sinner improved to 1-0 in Bjorn Borg Group. The 24-year-old

Italian is now on a 27-match winning streak indoors and has not dropped a set at the ATP Finals since his 2023 final defeat to Novak Djokovic, ATP reports. With his win at Inalpi Arena,

Sinner also kept alive his chances of pipping Carlos Alcaraz for ATP Year-End No. 1. The Italian trails his rival by 1,050 points in the Live Rankings, with Alcaraz having begun his ATP Finals campaign by defeating Alex de Minaur on Sunday afternoon. Sinner and Auger-Aliassime played out a hardfought first set. The Canadian dug deep to fend off two break points at 3-2 and a set point at 5-4, but he was unable to deny Sinner a decisive break in a 12th game in which he also appeared to start feeling pain in his left leg after he served at 0/30. Auger-Aliassime took an off-court medical time-out at the end of the first set and although he battled but was unable to recover from dropping serve in the second game of the second set. He also received treatment on his leg on court at 0-3, when he indicated to the physio that he was feeling pain in his left calf, and again at 1-4. Sinner struck the ball cleanly throughout the match and he retained his focus throughout as Auger-Aliassime's physical struggles played out across the net. The second seed finished the match having won 89 per cent (32/36) of points behind his first serve, according to ATP Stats. "I hope it's nothing too serious. I wish him obviously a very speedy recovery and hopefully he is back to 100 per cent physically," Sinner said of Auger-Aliassime.

Do whatever it takes to get football season underway: Sunil Chhetri's plea to AIFF

NEW DELHI: Veteran India striker Sunil Chhetri has urged the Al India Football Federation (AIFF) to take all necessary steps to restart the Indian Super League (ISL) season in the country.

In a joint statement, the top players of the country came together to issue a plea for the commencement of India's topflight football tournament.

'We, professional footballers who play in the Indian Super League, are coming together to make a plea, and more importantly to send the message that we stand united in our efforts to get the Indian Super League season underway. To put it simply, we want to play, and now," Chhetri wrote in an Instagram post which was shared by many footballers in including country SandeshJhingan, Gurpreet Singh Sandhu,

LallianzualaChhangte. The unified plea underscores the deepening unease within India's football fraternity as the ISL, which typically kicks off by September, remains in limbo well into November. With the AIFF's recent tender for the league's commercial rights failing to attract even a single bidder, the resulting stalemate has cast serious doubt over the ISL's immediate future and left its stakeholders mired in uncertainty

Facing growing pressure, the AIFF plans to move the Supreme Court to seek modifications to the ISL's governing framework. Justice L. NageswaraRao, appointed by the Court to oversee AIFF affairs, has held talks with officials to chart a way out of the

West Indies and Afghanistan to play three-match T20I series in UAE

facing a quality West Indies side offers an ideal platform for their buildup.

The West Indies were co-hosts of the most recent T20 World Cup, advancing to the Super Eight stage but falling short of a semifinal berth. Afghanistan, on the other hand, created history by reaching the semifinals for the first time in that tournament.

The two sides have faced each other in eight T20 internationals so far, with West Indies holding a 5-3 lead in the head-to-head record.
