Such practices have contributed to devastating landslides and floods in the hills and plains on October 5 this year, they said. As a part of their initiative, representatives of the Jami Jibika Paribesh Bachao Avijan (Land, Livelihood, and Environment Protection Movement) — a 29-member forum formed in March this year — sent a memorandum to Mamata Banerjee through the Divisional Commissioner of Jalpaiguri on Friday. "Over 100 landslides occurred and incessant rainfall — over 300mm within just 12 hours - flooded vast areas of these districts, displacing thousands of residents, said Avijit Majumder, a representative of the forum.

such devastation is uncontrolled river mining and the construction of dams. In the light of recent disasters across Darjeeling, Kalimpong, Jalpaiguri and Alipurduar, the government must up comprehensive plans to maintain the region's ecological balance and protect its environment, they said. NDA achieves landslide victory in Bihar elections, a massive blow to INDIA bloc

MI News Service, Patna : Creating a sunami as well as a history, the ruling NDA achieved a landslide victory for the alliance in elections to the Bihar Assembly winning as many as 204 seats for a two third majority in the 243 member house Bihar went to the polls in two phases this time on November 6 and 11. As per the election results after the day long counting from 7 a.m. on Friday morning, the ruling NDA alliance won 204 seats, far surpassing the simple majority mark of 122, according to the Election Commission. On the other hand the opposition INDIA bloc

mained way behind and showing a dismal result by winning only 33 of the 243 seats in the assembly

Among the NDA allies, the BJP clinched the highest 92 seats. while its prime ally JD(U) won in 84 othrers ,followed by the LJP(RV) in 19, the HAM (S) in four, and the RLM was in one seat after the final round of counting in the evening. In total contrast within the opposition bloc, the RJD could manage to win only in 25 seats and the Congress only five. The CPIM(L) Liberation five, and the CPI and CPI(M) got one seat each.

colleague singer-turnedpolitician Khesari Lal Yadav who also lost from Chhapra assembly, while BJP nominee Maithili Thakur, a first timer and a singer, won from Alinagar. RJD's Osama Shahab, the son of gangster-turned-politician Mohammad Shahabuddin, however won from Ragunathpur, and state minister Leshi Singh of the JD(U) retained his seat in Dhamdaha. Bhiar Deputy CM Samrat Choudhary of the BJP also won from Tarapur.

Another Deputy CM, Vijay Kumar Sinha, won in Lakhisarai while JJD founder Tej Pratap Yadav was at the fourth spot in Mahua, as LJP(RV)'s Sanjay Kumar Singh retained his seat. "The NDA will form the government in Bihar again. We have won with a vast majority. People of Bihar trusted the double-engine government. And the fact that not a single booth has required recounting, which only proves the ground situation," said the BJP spokesperson..

Bihar Assembly poll results won't have any bearing on West Bengal: TMC

MI News Service, Kolkata: Exuding full confidence, the ruling Trinamool Congress on Friday asserted that the poll results in neighbouring Bihar, where the BJP-led NDA recorded a landslide victory to retain power, will not have any impact whatsoever on next year's assembly elections in West Bengal. TMC spokesperson Kunal Ghosh claimed in a post on X that the Mamata Banerjee-led party will certainly come to power for the fourth time with over 250 seats in the 294 member state assembly. He said the Bihar poll results also showed again that the Congress had failed miserably in its opposition to BJP.

centered on one man: Nitish Kumar. As the NDA's advantage solidified through the day, freshly minted posters began appearing across the city, leaving no ambiguity about who, in the JD(U)'s telling, remained Bihar's central axis of power. Outside the Chief minister's residence in the heart of Patna , a massive poster of Nitish Kumar standing beside a crouching tiger, with the tagline 'tiger abhi zinda hai' (the tiger is still alive), became the first showstopper of the morning. The imagery was not subtle. It was defiant, triumphant, and unmistakably aimed at setting the tone before the numbers

saw a visual grammar of its own --

bold, swaggering and unmistakably

Through the day, more posters sprouted across arterial stretches, roundabouts, party offices and neighbourhood corners, as though Patna itself had been cast in a JD(U) production. One declared: 'Humaare Bihar mein ek star, har baar Nitish Kumar' (in our Bihar, there is only one star; every time, it is Nitish Kumar). The design was more striking, a towering image of Nitish Kumar, with a big photograph of Prime Minister Narendra Modi in the backdrop. Another went even further, stating simTasveere in baatein karte hain, picture abhi baki hain (photographs tell a story, the film is not yet over) --JD(U) worker ulation, fanned by the Mahagathbandply, 'Bihar ka matlab Nitish Kumar' (Bihar means Nitish Kumar), a sweep-

Political observers said the visual grammar made the JD(U)'s message crystal clear: In Bihar's political theatre, Nitish Kumar is not just the protagonist, he is the plot. "The line 'Hamaare Bihar mein ek star' is not just praise. It is a reminder that whatever the arithmetic at the Centre, Bihar's leadership mantle is that of Nitish ji," a JD(U) worker told a TV channel, pointing to the posters. The timing was even more telling. Even though the BJP was leading in more seats than the JD(U), the posters doubled as a calibrated counter to weeks of spec-

han and pockets of the political commentariat that the BJP might project a new CM face after the polls. Both parties had publicly dismissed the buzz, but the visuals on Friday appeared crafted to silence it once and for all. For the JD(U) cadre, the posters worked as reassurance and assertion in equal measure: reassurance that Nitish Kumar was firmly in command, and assertion that within the NDA, hierarchy had its own logic, and Nitish Kumar remained its senior-most partner in Bihar. The visuals appeared almost in lockstep with counting trends.

Congress alleges 'counting irregularities' as NDA sweeps Bihar poll

MI News Service, Patna: Bihar Congress chief Rajesh Ram on Friday raised doubts over the "integrity" of the counting process even as Election Commission placed the NDA comfortably ahead of the Mahagathbandhan with the final results of the Assembly polls being declared... The Election Commission's numbers showed a sweeping results in favour of the ruling alliance signalling a sharp tilt in favour of the BJP-led coalition.

Within the NDA, the BJP won the highest 90 seats, followed by the JD (U) which clinched 80 more, with other allies LJP (RV) (21) and HAMS (5) adding heft to the front. BENGAL tops SIR performance charts

News Kolkata: West Bengal has emerged as one of the top performers in the ongoing Special Intensive Revision (SIR) of electoral rolls, having distributed 93.22 per cent of voter enumeration forms — among the highest proportions in the country.

According to Election Commission of India (ECI) data, 7.14 crore forms have already been delivered to electors in the state, which has a total voter population of 7.66 crore.

A senior official in the office of the state Chief Electoral Officer (CEO) said 80,861 Booth Level Officers (BLOs) have been deployed for the door-to-door exercise, which began on November 4 across 12 states and Union Territories. In comparison, BJPruled states such as Uttar Pradesh, Madhya Pradesh, and Chhattisgarh have recorded lower distribution figures at 79.89 per cent, 74.41 per cent, and 78.41 per cent, respectively.

IND-SA FIRST TEST: Bumrah's 5 wkts demolishes South Africa at Day 1

MI News Service, Kolkata: ripped off South Africa for just 159 in their first innings on Day 1 of the first Test at the Edens Garden on Friday. Jasprit Bumrah was the star of the show with his five-wicket haul as India dominated South Africa on Day 1 of the first Test in Kolkata.

India lost the wicket of opener Yashasvi Jaiswal in the final session; Proteas speedster Marco Jansen cleaned up Jaiswal for 12. India at stumps reached 37/1 after 20 overs, trailing by 122 runs, with KL Rahul and Washington Sundar at the crease.

Proteas started the final session on 154-8. Jasprit Bumrah returned after tea to skittle out the last two wickets as he bundled out Simon Harmer and Keshav Maharaj in the 55th over to square off South Africa's innings.

Bumrah was outstanding for his 5 for 27, Kuldeep was excellent as well, Mohammed Siraj had a slightly off-day, but he too chipped in with two wickets in an over. Bumrah became the first fast bowler

to pick a five-fer in the opening day of a Test in India, since Ishant Sharma, in a D/N Test against Bangladesh at the same

Earlier in the match, exceptional bowling performance from Indian bowlers demolished South Africa's middle order and restricted them to 154/8 at the end of the second session in the first Test of the twomatch series. At the stroke of Tea, South Africa are struggling at 154/8 in 52 overs with Tristan Stubbs 15* unbeaten on the

South Africa started the second session at 104/3, with Mulder (22*) and de Zorzi (15*) unbeaten. Kuldeep Yadav struck early, trapping Mulder leg-before-wicket for 24 in 51 balls (with three fours), leaving SA at 114/4 in 29.5 overs.

Soon Zorzi also gave in to the pressure, trapped lbw by Bumrah for 24 in 55 balls, with a four and a six. SA had half their side down at 120 runs in 32.3 overs. Kyle Verreynne and Tristan Stubbs, two batters with an attacking game, were left to provide stability to the WTC champions.

When the partnership was building, Verreynne was trapped leg-before-wicket by Mohammed Siraj for just 16 runs, reducing SA to 146/6 in 44.1 overs. Siraj soon got his second, removing Marco Jansen without disturbing the scorers, leaving SA at 147/7 in 44.4 overs.

Proteas touched the 150-run mark in 47.4 overs. Axar Patel joined the party as well, getting a wicket of Corbin Bosch for single digits on the last ball of the session. At the end of the first session, SA was 104/3, with Mulder (22*) and de Zorzi (15*) unbeaten.

Electing to bat first, South African openers Aiden Markram and Ryan Rickelton were initially cautious, till Rickelton broke the shackles in the fourth over, making good use of a quick outfield and Mohammed Siraj's questionable lengths and getting two successive fours.

While Jasprit Bumrah was containing the runs pretty well on one hand, Siraj was leaking runs and undoing his hard work. As seen in the sixth over, he was struck with three boundaries, including a straight as an arrow cover drive and a scrumptious cover drive by Markram, which ended the over at a score of 31.

Siraj was taken off the attack, but the introduction of spin with Axar Patel did not exactly pay dividends, as Markram got two boundaries against him in the eighth over and a six over long-on in the 10th over. SA touched the 50-run mark by 9.2 overs, ending the first 10 overs at 57/0, with Markram (26*) and Rickelton (23*).

However, Bumrah beat the outside edge of Rickelton's bat and left the ball crashing into his off-stump, giving India their breakthrough in the 11th over. Rickelton was gone for 22-ball 23 (with four boundaries) and SA was 57/1 in 10.3 overs.

In the 12th over, extra bounce cost Markram his wicket as he attempted to get a feel for a fifth-stump delivery that bounced too high; the ball hit the shoulder of his bat, and Rishabh Pant dived to grab a catch. Markram was gone for a 48-ball 31 (with five fours and a six), with SA suddenly under the pump courtesy another piece of brilliance from Bumrah, at 62/2

The fresh pair of Temba Bavuma and Mulder had the task of taking the Proteas through the remainder of the session without a wicket. However, a delivery spinning back into Bavuma got the inside edge of his bat, with Dhruv Jurel ready to grab it at short-leg. Bavuma was gone for three, with SA at 71/3 in 16 overs

The institute felicitated top-performing researchers from faculty, resident doctors and students. Awards were also presented to the best-performing departments in recognition of their research output.


Kalyani hosts inter-school essay competition celebrating Nazrul's legacy

ZSI Scientists Identify New Slender Gecko Species in Andhra Pradesh

MI News Service, Kolkata: In a significant addition to India's reptilian diversity, scientists from the Zoological Survey of India (ZSI) have announced the discovery of a new species of slender gecko from the Eastern Ghats. The species, belonging to the genus Hemiphyllodactylus, was located in the Tirumala Hill ranges of the Seshachalam Biosphere in Andhra Reserve Pradesh—an area already known for its rich biodiversity. The newly catalogued species has been formally named Hemiphyllodactylusvenkatadri sp. Nov., in honor of its type locality, the sacred Venkatadri Hills of The Tirumala. name Venkatadri draws from Sanskrit: Venkata, referring to Lord Vishnu—"one who re-moves sins"—and Adri, meaning mountain. The discovery has been detailed in the international journal Herpetozoa (Vol. 38, 2025) and is the result of a collaborative effort involving ZSI's Freshwater Biology Regional Centre (Hyderabad), Reptilia Section (Kolkata), and Fakir Mohan University (Odisha). Molecular studies conducted by the team established that the new species shows a 9.7-12.9 percent genetic divergence from its closest relatives found in peninsular India, including H. jnana, H. nilgiriensis, and H. peninsu-

laris. Distinct morphological

traits further distinguish the Venkatadri Slender Gecko. These include 12–16 chin scales, 6–8 pre-cloacal pores, and 5–7 femoral pores separated by poreless scales. The species also displays a notable lamellar arrangement of 2-2-2-2 on both limbs. Researchers found the gecko under tree bark in a sandalwood plantation encircled by tropical dry deciduous forest at an elevation of roughly 881 meters. This marks only the second Hemiphyllodactylus species reported from Andhra Pradesh, the first being H. arakuensis.

Congratulating the research team, ZSI director Dr.Dhriti Banerjee said, "Discoveries Venkatadri Slender Gecko strongly reiterate the need for sustained systematic surveys and molecular research in the Eastern Ghats. This region remains one of India's most underexplored biogeographic pockets, yet it consistently reveals remarkable new reptile species." The finding highlights the importance of continued biodiversity conservation in ecosystem facing increasing anthropogenic pressures. Geckos, a subgroup of lizards, share classic reptilian traits such as ectothermy and watertight skin and represent one of the most diverse reptile groups globally.

Inmates Across Bengal Anxious as SIR Process Sparks Confusion in Prisons

MI News Service, Kolkata: Uncertainty looms large for inmates across West Bengal as the Statewide Special Identity Registration (SIR) begins. Among them is Alim from Birbhum, currently lodged in Dum Dum Central Correctional Home after being convicted of murder. Also anxious is Amir Ali of Baruipur, who is named in multiple cases involving snatching and robbery. With SIR procedures under way, these inmates and their families are deeply worried about what the new identification requirements might mean for their future. Across the state's 59 correctional homes, one question dominates conversations among inmates: What will happen to us under the SIR process? According to officials, the Election Commission of India has issued no specific notification regarding inmates, leaving both convicts and undertrial prisoners in a state of confusion. Their families, too, remain concerned, unsure of the implications of the new system for those behind bars. The state's correctional

network includes 7 central correctional homes, 3 open correctional homes, 5 special homes, 1 women's cor-

prisons, and 31 subsidiary prisons. Together, they house over a lakh inmates—both undertrial and convicted. High Court lawyer Tapas Bhanja, who has long worked on inmate rights since the Covid-19 period, explains the distinction. "There are two categories of inmates: undertrials and convicts. Anyone sentenced to more than two years cannot contest elections, but they retain the right to vote," he said. He added that families can take the enumeration forms to correctional homes, where inmates are allowed to fill and sign them following prison protocols. "Convicted inmates can vote only if they are released on parole. Undertrials may vote if they are released on bail," he clarified. SIR, he said, poses no legal barrier for either category. The Election Commission announced the SIR process in West Bengal on 27 October, and the procedure has already begun. This has triggered widespread public debate and political discussion, along with petitions filed before the Calcutta High Court. One such case is being heard by the division bench of Acting

Chief Justice Sujoy Paul.

Cal HC Seeks Detailed Affidavit on Land Transfer for Indo-**Bangladesh Border Fencing**

MI News Service, Kolkata: The Calcutta High Court on Friday directed the West Bengal government to file an affidayit detailing the current status of land meant to be handed over to the Centre for fencing along the Indo-Bangladesh border. The order was Issued by the Division Bench of Acting Chief Justice Suvajit Pal, which gave the status of the details of the superior the property of the part of the Pa state a 15-day deadline to submit the report. The Bench, however, declined to issue any interim order, despite a request from the Centre's counsel, the Additional Solicitor General. During the hearing, the Centre alleged that the West Bengal government had failed to transfer the required land for border fencing, even though funds for land acquisition had already been provided. According to available data, nearly 2,216 kilometres of the India-Bangladesh border in West Bengal remain unfenced. The Union government has been pushing to expedite fencing work, accusing the state of non-cooperation. The matter has gained renewed urgency following political instability in Bangladesh after the fall of the Sheikh Hasina government in August 2024. The Centre has intensified efforts to secure vulnerable stretches of the border. However, attempts to carry out fencing have faced resistance from Bangladesh's Border Guard (BGB) at several points, prompting counter-responses from India. Both sides have since held multiple rounds of discussions between the Border Security Force (BSF) and BGB to ease tensions.

At around 10 AM, Prime Minister will visit the underconstruction Bullet Train Station in Surat to review the progress of the Mumbai-Ahmedabad High-Speed Rail Corridor (MAHSR) — one of India's most ambitious infrastructure projects symbolizing the nation's leap into the era of high-speed connectivity

The MAHSR spans approximately 508 kilometres, covering 352 km in Gujarat and Dadra & Nagar Haveli, and 156 km in Maharashtra. The corridor will connect major cities including Sabarmati, Ahmedabad, Anand, Vadodara, Bharuch, Surat, Bilimora, Vapi, Boisar, Virar, Thane, and Mumbai, marking a transformative step in India's transportation infrastructure. Built with advanced engineering tech-

niques on par with international standards, the project features 465 km (about 85% of the route) on viaducts, ensuring minimal land disturbance and enhanced safety. So far, 326 km of viaduct work has been completed, and 17 out of 25 river bridges have already been constructed.

Upon completion, the Bullet Train will reduce travel time between Mumbai and Ahmedabad to nearly two hours, revolutionizing inter-city travel by making it faster, easier, and more comfortable. The project is expected to boost business, tourism, and economic activity along the entire corridor, catalyzing regional development.

The Surat-Bilimora section, covering around 47 km, is in an advanced stage of completion, with civil works and trackbed laying fully completed. India scraps QCOs across textiles, plastics & metals; GTRI urges vigil on import surges

(QCOs) on a wide range of raw materials across textiles, plastics and mining has brought major relief to industry, but Global Trade Research Initiative (GTRI) warn that the government must now closely track import surges to ensure the absence of mandatory certification does not open the door to low-grade or dumped supplies.

According to an analysis by GTRI, the rollback announced on November 13, removes BIS certification requirements for 14 products under the Chemicals & Petrochemicals Ministry and six under the Mines Ministry. These include key intermediates such as PTA, MEG, polyester fibres, polypropylene, polyethylene, PVC resin, ABS, polycarbonate as well as metals like aluminium, lead, nickel, tin and zinc.

The reforms follow the Gauba Committee report, which highlighted how QCOs expanded from fewer than 70 a decade ago to nearly 790, many of them covering raw materials with no direct safety implications. Domestic industry had long argued that QCOs on industrial inputs created delays, testing bottlenecks and higher costs without improving product quality.

GTRI says, textile clusters in Surat, Ludhiana, Tiruppur and Bhilwara, along with plastics processors, 90 per cent of which are MSMEs, are set to benefit from smoother access to imported intermediates. The earlier rules, GTRI notes, caused long queues at BIS labs, port detentions and demurrage charges, often crippling small manu-

Exporters too are expected to gain from easier sourcing of globally certified materials, helping improve India's competitiveness in technical textiles, moulded plastics, engineering goods and synthetic-



The withdrawal of QCOs on aluminium, zinc, lead, nickel and tin restores flexibility for downstream sectors including auto components, electronics, batteries, construction and defence. Since India has no primary nickel production and limited domestic supply of some specialised grades, the previous QCO regime had risked chok-

The GTRI report says MSMEs are now urgently awaiting similar reforms in steel, where continuing QCOs have created shortages and driven up prices. In stainless-steel flats alone, domestic capacity falls well short of demand, yet foreign suppliers avoid BIS certification due to costs and limited scale. Other categories like fasteners, auto hinges and telescopic channels face similar distortions, with small manufacturers claiming that the current rules favour a

However, while the rollback marks a major step towards aligning with global regulatory norms, GTRI cautions that regulators must now "monitor import trends, daily if required" to prevent dumping of inferior materials. The absence of QCOs, the think-tank warns, may prompt overseas suppliers to offload excess stocks at predatory prices. The government may need to rely on anti-dumping duties, safeguard actions or tariff-rate measures if injury to domestic industry is detected.

The report emphasises that India's new approach of removing QCOs where they add friction rather than safety, should continue, but with strong surveillance mechanisms to protect MSMEs and maintain fair competition. (ANI)

WTO Chief urges India to lead global trade reforms, warns against shift to power-based system

Visakhapatnam : World Trade Organisation (WTO) Director General NgoziOkonjo-Iweala on Friday said India should play a leading role in driving reforms at the WTO, stressing that the global trading system must remain rules-based rather than power-

Addressing the inaugural session of the 30th CII Partnership Summit 2025 in Visakhapatnam, she said the world is witnessing major changes in trade, and India is well-positioned to take advantage of these shifts.

"India should be a leader in the reform process at the WTO. India should be a leader, making sure that we do not stay in a system that becomes more powerbased instead of rule-based. We must do the work that is necessary to give reform a chance. We must correct old wrongs and seize opportunities that are emerging,'

She noted that global supply chains are being reconfigured, and India is emerging as a key beneficiary. She also highlighted the rapid growth of green trade and digitally delivered services, stating that the latter is expanding at a rate of 6 to 8 per cent and is now worth almost USD 5 trillion. India, she added, has a unique opportunity to excel further as it is already doing well in digitally delivered trade. South-South trade is also growing again, giving

India more room to expand.
Okonjo-Iweala said India is playing a major role in ongoing reforms, noting that it can help create a more flexible system that allows even smaller developing countries to benefit.

She said her message to India is to work together with the global community to strengthen a trading system that has largely delivered for the world but can still deliver more, especially for developing countries.

The WTO chief praised India's economic progress, calling it the world's fastest-growing large economy over the past few years, with growth exceeding 6 per cent in 2024-2025. She said this momentum is expected to continue, backed by strong domestic demand, sustained investment, and stable macroeconomic conditions. She also congratulated Prime Minister NarendraModi, the government, and the people for this performance. emerging opportunities Highlighting the importance of constructive reform. (ANI)

India's treated used water could unlock an economic opportunity of up to \$35 billion by 2047, creating over 1 lakh new jobs: CEEW

New Delhi: India's treated used water (TUW) economy could unlock up to INR 3.04 lakh crore (USD 35 billion) in economic opportunity by 2047, combining Rs 72,597 crore (USD 8.35 billion) in potential annual market revenue with Rs 1.56-2.31 lakh crore (USD 18-27 billion) in infrastructure investment, according to a new independent study released today by the Council on Energy, Environment and Water

The study, Financing for Treated Used Water Reuse in India, projects that India could reuse 31,265 million m³ of treated used water in 2047--enough to meet a significant portion of industrial and irrigation demand--if backed by the right mix of financing, regulation, and

At present, India treats only about 28 per cent (20.24 billion litres per day) of the used water it generates, and more than 80 per cent of cities either do not reuse treated water or lack functional reuse infrastructure, leaving vast untapped potential in urban systems.

Scaling up the reuse of treated used water could also create over 1 lakh new jobs across the country by 2047.

advances its National Framework on Safe Reuse of Treated Water, offering policymakers a data-backed roadmap to finance and scale reuse across cities. Urban India generates more than 72 billion litres of used water per day, yet much remains untreated or underutilised. With water demand rising rapidly, TUW offers a practical, scalable solution to close the supply-demand

CEEW's findings come as India

Under the new Liquid Waste Management Rules 2024, bulk users such as industries and utilities must now treat and reuse at least 20 per cent of their wastewater--rising to 50 per

The shift adds regulatory weight to a rowing market that can simultaneousy reduce freshwater extraction, boost local resilience, and generate green employment.

ShaluAgrawal, Director Programmes, CEEW, said, "India must treat used water as an asset, not a liability. Every litre reused is an investment in our cities' resilience, our industries' competitiveness, and our energy security. Treated used water is not the



end of a cycle, it's the beginning of a circular economy for urban India. It is India's next big resource for growth, jobs, and resilience. By financing circular solutions today, through public-private partnerships, municipal green bonds, and industry co-investments, we can turn what was once considered waste into wealth for a sustainable

The CEEW study also highlights how circular investments are already delivering results in Indian cities. Surat currently supplies tertiary-treated used water to industries at Rs 36 per kilolitre--slightly lower than freshwater rates--helping the city generate over Rs 230 crore in revenue between 2014 and 2021.

The study also proposes Water Reuse Certificates as a market-based mechanism allowing bulk users that exceed their reuse targets to trade credits with those falling short, monetising efficiency gains and creating incentives for compliance.

NitinBassi, Fellow, CEEW, added, "Scaling treated-used-water reuse is one of the most practical ways to watersecure India's cities. Urban local bodies must lead India's shift to treated-usedwater reuse by developing long-term city plans, diversifying funding, and setting fair, cost-recovery tariffs. Beyond the one lakh direct jobs expected in plant operations, expanding reuse will also create employment in construction and technology services, generate steady municipal revenue, attract green investment, and reduce pollution in rivers. With the right planning, pricing and business models, used water can become a financially sustainable and environmentally restorative urban

CEEW's projections are based on national and state-level data from the Central Pollution Control Board, the National Mission for Clean Ganga, and the Ministry of Housing and Urban

The study estimates future treatment capacity using historical growth rates to 2047, values reuse based on existing industrial and irrigation tariffs and analyses lifecycle costs, job coefficients, and energy footprints across common treatment technologies to provide a realistic investment and employment roadmap. Kannauj police launch major drive to enforce loudspeaker noise limits

MI News Service, Lucknow: Authorities in Uttar Pradesh's Kannauj district have carried out a largescale campaign to curb noise pollution, removing 31 loudspeakers and reducing the volume of 54 others to within legal limits. The three-day operation, led by Superintendent of Police Vinod Kumar, targeted 171 religious and public sites across the district to ensure compliance with

initiatives in other Uttar Pradesh districts such as Muzaffarnagar, Azamgarh, and Firozabad, where police have acted against excessive loudspeaker use at religious places. In Kannauj, officers found 85 loudspeakers exceeding the permitted decibel levels. Of these, 54 were adjusted to meet the standards, while the remaining 31 were dismantled and later distributed to educational institutions for reuse.

Superintendent Kumar said the campaign aimed not only to enforce the law but also to spread awareness about responsible use of sound systems. "Noise control is about maintaining peace and mutual respect in society," he stated, adding that the police were engaging with community leaders to encourage voluntary compliance. Residents have largely supported the move, citing the constant disturbance caused by loudspeakers used during religious or social events. A local resident expressed that the noise was becoming unbearable many times. Officials stressed that noise control is both a legal and civic duty, urging citizens and religious institutions to cooperate. The administration hopes that this initiative will promote a culture of respect and tranquility, setting an example for other districts in the state to follow.

UN relief agency for Palestinians faces dire financial situation: UN official

MI News Service, United nations: The UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) is facing a dire financial situation, with a shortfall between the last quarter of 2025 and the first quarter of 2026 at approximately 200 million U.S. dollars, the UNRWA chief said Thursday.

Addressing the UN General Assembly Fourth Committee, UNRWA Commissioner-General Philippe Lazzarini said that despite the steady implementation of austerity and cost control measures amounting to 150 million dollars in 2025 and strict cashflow management, severe deficit and cashflow crises are jeopardizing the viability of the agency's operations.

Unlike in previous years, the projected income in the first guarter of 2026 is too low to absorb a large deficit from 2025. Lazzarini said. "In the absence of a significant influx of new funding, the delivery of critical services to millions of Palestine refugees across the region will be compromised," he said

The viability of political plans for Gaza depends on successful stabilization and recovery, which requires rapidly scaling up humanitarian assistance and reinstating critical public services, he stressed. According to Lazzarini, UNRWA today delivers 40 percent of all primary healthcare in the Gaza Strip, with its "unrivaled" delivery capacity of 12,000strong workforce and deep reserves of community trust. He said that UNRWA is providing some 14,000 medical consultations each day; bolstering public health through immunization campaigns, nutrition screenings, water quality testing and pest control campaigns; conducting in-person learning for more than 40,000 children; and supporting nearly 300,000 children through online learning platforms.

However, UNRWA's operations continue to be undermined by political attacks and precarious finances, said Lazzarini, pointing to the Israeli Knesset's adoption of legislation in 2024 that forcibly removed UNRWA international staff from the occupied Palestinian territory and blocked the entry of its supplies into Gaza, and a "virulent disinformation campaign" that has tarnished the agency's reputation and strangled funding for its

Islamophobic graffiti found at Indian Statistical Institute Kolkata amid rising hostility after Delhi blast

MI News Service, Kolkata: Hatefilled graffiti with Islamophobic messages appeared on the Indian Statistical Institute (ISI) campus in Kolkata, sparking outrage among students and concerns over growing communal tensions. The graffiti, which read "Muslims and dogs should not enter the premises" and "No Muslims allowed," was discovered on the doors and stair railings of the CV Raman Hall, the boys' hostel, a day after the Red Fort bomb blast in Delhi.

Students noticed that an old message saying "Dogs shouldn't enter the premises" had been tampered with and someone added the words "Muslims &" in white chalk, turning it into a hateful statement. They immediately reported the incident to the administration, prompting an inspection by ISI director Sanghamitra Bandyopadhyay, dean Biswabrata Pradhan, and hostel warden Subhamoy Maitra. The administration condemned the act. and a written complaint was filed demanding an inquiry and review of CCTV footage from cameras near the hostel gate.



However, students told reporters that the administration declined to share the footage, saying they would investigate internally. Officials suggested organizing a sensitization programme in response, but students expressed dissatisfaction, describing the steps taken as inadequate and delayed. Despite assurances that a public statement would be issued, none had been released as of late November 12, raising fears among students that the matter might be suppressed. The defacement appeared just hours after an explosive-laden car detonated near Delhi's Red Fort, killing at least 13 people. The attack triggered a surge of Islamophobic rhetoric online and offline, with

right-wing influencers and media figures promoting unverified claims that vilified Muslims collectively.

Across states, particularly in Rajasthan and the NCR region, reports emerged of Muslim passengers and Kashmiri residents being singled out by police for scrutiny and harassment. Observers have linked the graffiti to this rapidly intensifying wave of hate, describing it as a reflection of how online bigotry and communal propaganda are spilling over into physical spaces, even on academic campuses. They warn that such incidents deepen fear and alienation among minority students, undermining the sense of safety and equality that educational institutions are meant to uphold

Russia downs 216 Ukrainian drones overnight: Defense Ministry




MI News Service, Moscow/Kiev: Russian air defense forces shot down 216 Ukrainian drones overnight, the Russian Defense Ministry said Friday. According to the ministry, 66 drones were intercepted over southern Russia's Krasnodar region and 59 over the Black Sea. Krasnodar's regional operational headquarters said three people were injured in the port city of Novorossiysk by the attack, which also sparked a fire at an oil depot. Novorossiysk has declared a state of emergency following the attack, said Mayor Andrey Kravchenko. Meanwhile, at least four people were killed and 27 others were injured in Russian drone and missile attack on Kiev overnight on Friday, Tymur Tkachenko, head of the Kiev City Military Administration, reported. Ukrainian President Volodymyr Zelensky said on X that Russia used about 430 drones and 18 missiles in the strike on Ukraine.

Over 150 Palestinians stranded on plane for 12 hours in South Africa MI News Service, Johan-MI News Service, Islam-

nesburg: South African aufaced thorities criticism Friday after they held more than 150 Palestinians, including a woman who is nine months pregnant, on a plane for around 12 hours due to complications with their travel documents.

A pastor who was allowed to meet with the passengers while they were still stuck on the plane said it was very extremely and that children were screaming and crying. The Palestinians landed on a charter plane at Johannesburg's O.R. Tambo International Airport on Thursday morning after a stopover in Nairobi, Kenya, South Africa's Border Management Authority said in a statement.

The Palestinian passengers did not have exit stamps from Israeli authorities, did not indicate how long they would be staying in South Africa and had not given local addresses, leading immigration authorities to deny them entry, the statement said. The 153 passengers including families and children were allowed to leave the plane on Thursday night after South Africa's 6 intervened and a local non-governmental organization called Gift of the Givers offered to accommodate them. The Border Management Authority said 23 passengers had



South Africa.

Gift of the Givers founder Imtiaz Sooliman said it was the second plane carrying Palestinians to land in South Africa in the last two weeks and that the passengers themselves did not know where they were going. He said both planes were believed to be carrying people from war-torn Gaza. It was not immediately clear who organized the charter plane. South Africa has long been a supporter of the Palestinian cause and the treatment of the travellers has sparked anger.

The Senate and the National Assembly, the upper and the lower houses of the country's parliament, respectively, passed the amendment bill earlier this week. Minister of Law Azam Nazeer Tarar told the parliament that the establishment of the FCC will provide a dedicated court to adjudicate constitutional matters, aims to ease the caseload of the Supreme Court, and seeks to promote timely and uniform interpretation of the Constitution. Aminudappointment was made by the president under Article 175A(3) read with Article 175C of the Constitution, and took effect immediately upon the oathtaking ceremony. 1st Test: Tough to bowl on a slow wicket, says Kuldeep Yadav, breaking down his dayone plan as India skittle out South Africa

KOLKATA: Kuldeep Yadav said that sticking to his stump-hitting method and drawing from recent preparation against South Africa were central to his success on a slow and demanding Eden Gardens pitch, as India bowled out the visitors for 159 on the opening day of the first Test on Friday.

While Jasprit Bumrah stole the headlines with a five-wicket haul, Kuldeep's disciplined spell (2 for 36) and clever planning played an equally important role in India's decisive grip on the contest.

Speaking on JioStar's post-match show Cricket Live, Kuldeep described the step-up in intensity when playing Test cricket and how his India A outing against South Africa earlier this month gave him useful

insight.

"When you play a Test match, your intensity always goes up, and obviously, you need a lot of energy. When we played as India A, it was a good practice match against South Africa, and I bowled to Temba Bavuma there. I knew what sort of shots he plays, so I was prepared to bowl accordingly.

Kuldeep said the sluggish pitch made his job as a wristspinner more demanding, as he had to generate his own pace to trouble the batters. "Today, the



wrist-spinner, it's tough to bowl on this type of wicket because there is hardly any pace. You have to generate that pace your-

Despite the conditions, he stuck to his approach of attacking the stumps - a method he believes translates across for-

"My bowling type is all about hitting the stumps; that's the most important thing in any format: ODI, T20, or Test. Cricket has changed a lot; players try reverse sweeps and sweep shots, so you don't want to miss those leg-before chances. That was my plan.'

That plan paid off as Kuldeep played a key role in breaking South Africa's early resistance, providing control in the middle overs and striking at crucial

Bumrah, meanwhile, was at his lethal best, returning 5 for 27 to dismantle South Africa after their promising start. His incisive spells triggered collapses at vital junctures, leaving India firmly in control by

With Mohammed Siraj (2 for 47) and Axar Patel (1 for 21) also contributing, India's wellrounded bowling effort ensured South Africa squandered the advantage of winning the toss.

ISSF World C'ship: Esha nails maiden individual medal with bronze in women's 25m pistol

Mixed Team and Junior World champion Esha Singh added another feather in her decorated cap, nailing a maiden individual world championship medal, claiming bronze in the women's 25m Pistol Olympic event at the Olympic Shooting Range in Cairo, Egypt, on Friday. The Indian shot a score of 30 in the final, to finish behind in-form Chinese Yao Qianxun (silver, score: 38) and reigning Olympic Champion Yang Jiin (gold, score:

Esha's effort came as India wrapped up engagements in the 10 Olympic events on schedule at the International Shooting Sport Federation (ISSF) World Championship Rifle/Pistol, Cairo 2025, with a historic haul of one gold, three silver, and three bronze medals. Overall, India are placed third on the table with three gold, five silver, and four bronze medals, behind leaders China with 10 gold and Korea, who are second with six gold

Beginning the day in fourth and seventh spots respectively, Esha and double Olympic medallist Manu Bhaker shot confident, rapid-fire rounds to sail into the top eight with scores of 587 and 586 respectively. Esha took fifth while Manu took the sixth qualifying spot in the field of 86.

Yang topped qualifications as well with 591, which came on the back of a stunning 300/300 in the rapid round.

Mixed team silver medallist in Paris, Sevval Tarhan of Turkey,

Iranian Haniyeh Rostamiyan and France's former European and junior world champion Lamolle Mathilde, also went through. Unknown North Korean Kim Hyon Suk made up the final eight.

Rahi Sarnobat's 572 was not enough for the Indian trio to win a team medal as they finished fourth with a tally of 1745, three short of the bronze-winning French team.

Yang laid down the gauntlet with a perfect five to start the 10series final, comprising five rapidfire shots each. Both the Indians began with four hits, but in the first elimination stage after series four, Esha was third and Manu joint fourth, as Sevval was the first to bow out. Yang and Yao broke away at this stage, and the fight for bronze reached a climax when Esha, Manu, and Lamolle tied at 23 hits each after the seventh series. That brought about Manu's

exit as she managed two hits even as Esha and Lamolle shot a per

The Frenchwoman then shot three as Esha struck a four to confirm her medal, bowing out after the ninth series as Yang out-

gunned Yao for gold. It was Esha's third individual ISSF medal of the year, having won gold and silver in the World Cup stages earlier. Her final international engagement will be at the ISSF World Cup Finals in Doha in December.

FIDE World Cup 2025: Arjun Erigaisi, Harikrishna draw opening game of Round 5



PANAJI : Grandmaster (GM) Arjun Erigaisi's efforts to break through GM Levon Aronian's defence did not fructify, while GM P Harikrishna played out a quick draw in the opening game of the fifth round of the FIDE World Cup 2025 here on Friday. Playing white, Arjun could not convert his slight advantage in the double rook endgame as the two players split points after 41 moves.

Earlier, Harikrishna played a solid game with black to ensure that giant-killer GM Jose Eduardo Martinez Alcantara had no opportunities to win with white.

A total of 24 Indian players started the competition that saw 206 players from 82 countries vying for the Viswanathan Anand Trophy. After four rounds, only two Indians are still in the fray to win the title and also grab a spot on offer in the Candidates tournament. On Friday, Arjun was keen on grabbing the advantage against two-time champion Aronian with white pieces. It looked like the Armenian-born Aronian was in trouble when he took almost 30 minutes to play his 21st move. To his credit, he found a way to get out of trouble and then played solid chess to ensure that he goes into the second game with a theoretical advantage as he

There was no such trouble for Harikrishna, as he was well prepared for Alcantara's plan, and both the players raced to a rookpawn endgame quickly and then opted for a draw in 41 moves. At the time of writing, six of the eight matches had ended in a draw.

Erigaisi defeated GM Peter Leko in both the rapid games, while P Harikrishna made the most of the chances he got to beat GM Nils Grandelius in the second game to advance to the pre-quarterfinals of the FIDE World Cup 2025 here on Thursday.

Praggnanandhaa's campaign came to an end after losing to former World Rapid Champion GM Daniil Dubov in the fifth round. With Pranav V and Karthik Venkataraman losing in the classical games in round 5, there were three Indians in the tiebreak, and two of them ultimately advanced to the next round.

Turkiye bans 102 footballers over widening betting scandal

ANKARA: Turkiye's football authorities have handed temporary bans to 102 professional players as part of a widening investigation into illegal betting activities in the country The Professional Football Disciplinary Board of the Turkish Football

Federation (TFF) on Thursday suspended 25 players from the Super Lig and 77 from the second-tier First League, with punishments ranging from 45 days to 12 months. The investigation reviewed allegations against 1,024 footballers, of whom 102 were sanctioned.

Among the most notable cases is Galatasaray and Turkish national team defender Eren Elmali, who was banned for 45 days and removed from the national team squad, reports Xinhua.

Earlier this week, Elmali admitted on Instagram to placing a bet on a football match approximately five years ago, but said it did not involve his own team. He joined Galatasaray earlier this year. His teammate Metehan Baltaci, who plays for Türkiye's Under-21 team, received a nine-month suspension. Konvaspor's Alassane Ndao was handed the longest ban of 12 months. The TFF stressed that players who have been provisionally referred to the disciplinary board are not permitted to play in matches during the ongoing investigation.

Trident Open 2025: Manu Gandas triumphs in three-way playoff to return to winning ways

CHANDIGARH : Manu Gandas endured an ordinary final round of one-over 73 before fighting back and keeping his nerve to triumph in a three-way playoff at the inaugural Trident Open, an INR 1 crore event, played at the Chandigarh Golf Club here on

Gurugram-based Gandas (66-73-69-73), the PGTI Order of Merit leader, and local lad Yuvraj Sandhu (72-69-70-70) and the 21year-old Shubham Jaglan (71-69-71-70), who made his PGTI debut this week, ended the regulation 72 holes with matching totals of seven-under 281 to take the match into a playoff. Gandas prevailed in the playoff with a par to return to winning ways after one year and 10 months.

Gandas' ninth prof saw him pick up a cheque worth INR 15 lakh that also lifted him from 14th to seventh position in the PGTI Order of Merit.

The 17-year-old rookie Manoj S, the third-round leader, who was looking to become the voungest player to win as a professional on the PGTI, shot a last round of 75 to finish tied fourth at six-under 282 along with Shaurya Bhattacharya (71), the winner of PGTI's last event.
