Kolkata chokes on diversions as Vidyasagar Setu Shuts for repairs

Traffic movement across the city faces a major disruption today as the iconic Vidyasagar Setu remains closed for sixteen hours, from 5 a.m. to 9 p.m., for essential maintenance work. The shutdown, announced by the Hooghly River Bridge Commissioners (HRBC), has triggered widespread diversions, affecting commuters and logistics services across key arterial routes connecting Kolkata to Howrah and beyond. The bridge, which serves as one of the city's busiest links over the Hooghly River, has been closed to facilitate critical inspection and structural maintenance ahead of the winter season. This includes checking joints, tightening cables, and routine inspection of expansion bearings. Authorities said the decision was taken after technical reports called for immediate preventive upkeep to ensure long-term safety and structural stability of the bridge. PG 3

ISRO to launch **CHANDRAYAAN-4** in '2028

MI News Service, Bengaluru: ISRO is gearing up for one of its busiest times with seven more launches planned this financial year, even as India's first human spaceflight remains scheduled for 2027, its chairman V Narayanan said. In an interview he said ISRO is preparing for a phase of rapid scaling in science, technology and industry capacity. Narayanan said ISRO (Indian Space Research Organisation) is targeting seven more launches before the end of the current financial year, including a commercial communication satellite, and multiple PSLV and GSLV missions. A milestone will be the launch of the first PSLV man-ufactured entirely by the Indian industry. The ISRO chief said the government has approved the Chandrayaan-4 mission, designed as a lunar sample-return mission and it will be India's most complex lunar endeavour yet. are targeting 2028 for Chandrayaan-4," he said.

Another key mission is LUPEX, the joint lunar polar exploration programme with JAXA (Japan Aerospace Exploration Agency). ISRO is simultaneously working to triple its annual spacecraft production in the next three years to keep pace with expanding mission demand. Chandrayaan-4 will attempt to bring back samples from the moon -- a capability currently demonstrated only by the US, Russia and China. LUPEX aims to study water ice at the lunar south pole. Narayanan said ISRO has begun work on an Indian Space Station, targeted for completion by 2035. "The first of the five modules will be placed in orbit by 2028, said. The endeavour would make India the third major nation to operate a space station, as the US-led ISS nears its end and China's

Tiangong moves into full operation. On India's maiden human-spaceflight mission, Gaganyaan, Narayanan clarified that only the timeframe for uncrewed missions has shifted. "Let me make it clear: the uncrewed mission was targeted for 2025. The crewed mission was always planned for 2027, and we are holding on to that date," he said. Three uncrewed test missions will precede the first flight with Indian astronauts. He said Prime Minister Narendra Modi has also directed ISRO to work towards sending Indian astronauts to the lunar surface and bringing them back safely by 2040. India's longterm human-spaceflight plan now aligns it with the world's leading space powers. The US plans lunar crewed missions under Artemis, while China has set a 2030 target for its first crewed moon landing. India's share in the global space economy is

He added that 27 police personnel, two revenue officials, and three civilians from the adjacent area sustained injuries. The police station building has been severely damaged, and even the adjacent buildings have been affected," Prabhat said. He noted that the extent of damage and the circumstances of "this unfortunate incident" are being assessed. The DGP said the police stand in solidarity with the families of the deceased in this hour

MI News Service, New Delhi: Investigations high-intensity blast near Delhi's Red Fort — which killed 12 people and injured several others have revealed that one of the ar-rested suspects, Dr Muzammil Ganaie, had carried out multiple reconnaissance visits to the Red Fort area in January this year, weeks before the Republic Day celebrations. Police analysing dump data from Dr Muzammil's mobile phone said his repeated presence around the Red Fort was detected in the first week of January. "These visits were part of a detailed reconnaissance ahead of a planned attack on January 26," a senior police officer said, requesting anonymity. Officials suspect the reconnaissance was part of a larger

conspiracy to target the historic monument, which might have failed due to heightened security and intense patrolling in the area at the

Sovan Chatterjee's TMC Homecoming **Fuels Buzz Over Behala Candidature**

Kolkata: Former cabinet minister and ex-Kolkata Mayor Sovan Chatterjee's return to the Trinamool Congress (TMC) after seven years has triggered intense speculation over whether he will replace his estranged wife and sitting MLA Ratna Chatterjee as the party's candidate from Behala East in the 2026 Assembly polls.

Once one of Chief Minister Mamata Banerjee's most trusted lieutenants and en-dearingly called "Kanan," Sovan formally rejoined the party earlier this week. His return was announced at Trinamool Bhavan, in the presence of minister Aroop Biswas and TMC state secretary Subrata Bakshi. He and his partner Baisakhi Banerjee later met TMC national general secretary Abhishek Banerjee, where Sovan was formally handed charge as Chairman of the New Town Kolkata Development Authority (NKDA).

Sovan's quiet political re-emergence began in September when he met both Mamata and Ab-

past differences. His appointment as NKDA chief seen within the party as politically strategic rather than a routine administrative role-has fuelled talk of his imminent return to elec-

toral politics.

Within TMC, conversations have now turned to the seat he may contest. Two constituencies are under consideration: Behala East and Behala West. Sovan twice represented Behala East in the Assembly, but his political career began in Behala West, where he served as councillor of Ward 132 for more than two decades before taking charge as Mayor in 2010.

'No lapse or excuse will be tolerated': Bengal CEO directs officials to finish SIR form collection by Nov-end

MI News Service, Kolkata: West Bengal Chief Electoral Officer Manoj Kumar Agarwal has delivered a message to district election authorities: finish collecting the Special Intensive Revision (SIR) enumeration forms within this month. The directive was issued during a video conference with district officials. One official said, "The instruction to collect the enumeration forms by November-end came from the CEO. He has asked district officials to strictly follow the instruction." By 6 pm on Saturday, 98.5 per cent of forms, over 7.55 crore, had been distributed across the state. Agarwal, however, questioned why the final stretch was still pending even after weeks of groundwork. He made it clear that district administrations will be held fully accountable.

'District officials have been told that no lapse or excuse will be tolerated. They have been instructed to resolve any local issues immediately," he told PTI. The Election Commission has also cautioned that the collection process must remain peaceful and free of misconduct. Agarwal said strict action would be taken against anyone who misbehaves with voters during the exercise.

Pellets shot to drive away a wild elephant end up injuring nine people at Jalpaiguri MI News Service, Jalpaiguri: Nine persons were injured by pellet shots that personnel of the state forest department fired to drive away a wild elephant in the west Damdim, Malbazar, in Jalpaiguri on Thursday night. Police took the injured to the rural hospital in Odlabari. They are in stable condition after receiving the necessary treat-

A source said that on Wednesday, a herd of 30–40 elephants from Targhera forest entered the paddy fields in west Damdim. Local farmers and members of the quick response team managed to drive the elephants back into the forest by 5am.

However, a tusker from the herd was trapped near Kalijhora, a stream, and later took shelter in a patch of forest nearby. Members of the wildlife squad of Malbazar began monitoring its movement. Soon, a crowd gathered to catch a glimpse of the animal. As forest workers attempted to guide the elephant into the forest, the elephant — agitated by the noise and commotion charged towards them.

32 kg ganja seized from Krishnanagar-Karimpur bus, 7 arrested in Chapra raid Dipankar Edbar, Nadia:

Acting on a tip-off on early Sunday, Chapra Police intercepted a passenger bus near Baro Andulia crossing and seized 32 kg. of ganja concealed inside multiple bags on board. Police received secret information that a large consignment of ganja was being transported towards Chapra in a bus (registration WB 37C 5128) which plies between Krishnanagar and Karimpur. The vehicle was detained and subjected to a thorough search.

During inspection, officers found a white bag hidden inside a broken plastic bucket, containing eight packets of ganja. Two more bags were subsequently recovered, each carrying an additional eight packets, taking the total seizure to 32 kilograms. According to police, the contraband was being transported with the alleged assistance of the



bus driver, contractor and helper. The narcotics and packaging were seized following all legal formalities.

Seven persons were arrested in connection with the case. They were identified as Bankim Biswas (42), of Kachudanga, PS Murutia, bus contractor, Apurba Halder (30), of same locality, bus helper, Taheruddin Mondal (58), of Madhubona, PS Jalangi, Rajjak Hossain (30), of Madhubona, PS Jalangi, Hamidul Islam Miya (40) of Kupita, PS Domkol, Tariba Khatun (45) of Kirtonia Para, PS Jalangi, Pravas Biswas (41) of Mahisbatan, PS Karimpur, bus driver.

Nadia police arrest 11 Bangladeshis hiding near border, 2 locals held for providing shelter

Dipankar Edbar, Ranaghat (Nadia) : In a major security operation near the Bangladesh border, Hanskhall police on Sunday arrested 11 Bangladeshi nationals, including five men and five women, who had allegedly been hiding in Umarpur, a village close to the international boundary in Nadia district.

Acting on a tip-off that came in late Saturday night, police carried out a swift raid in the borderside settlement and detained the group. On Sunday, all ten were produced before the Ranaghat Sub-Divisional Court, where the judge remanded them to 14 days' judicial custody.

According to investigators, the Bangladeshis had been sheltered by some residents of the area. Police have also arrested two locals for allegedly providing them refuge. Officials said they are probing



whether more Bangladeshi nationals are hiding in nearby villages. The arrests come amid

heightened tension along the Bengal coast. Earlier, the Coast Guard intercepted a Bangladeshi fishing trawler that had "inadvertently" crossed the international maritime boundary into Indian waters in the Bay of Bengal. Twenty-nine Bangladeshi fishermen aboard the vessel were detained and handed over to Frazerganj Coastal Police, who are expected to produce them in court today.

With two separate incidents within days, one at sea and another along the land border, security agencies are examining whether the cases are connected or simply coincidental breaches. Senior police officials said enhanced surveillance has been ordered across Nadia's border belt.

Bangla Pokkho's grand march in Siliguri on five-point demands

Nurul Islam Khan : A grand march of several thousand Bengalis and Bhumiputra Janajati was held in Siliguri on the call of Bengali nationalist organization Bangla Pokkho. The procession was led by Bangla Pokkho's general secretary Garg Chattopadhyay. This grand procession was organized on the initiative of Siliguri District Secretary Giridhari Roy. Organizing Secretary and Supreme Council Member Kaushik Maiti, Supreme Council Member Rajat Bhattacharya and Maha Sahin were present. Abhishek Mitra Majumdar of Jalpaiguri, Uttam Das of Alipurduar, Sahin Badsha of Malda, Soumya Bera of Kolkata, Akshay Bandyopadhyay of West Burdwan, Sutanu Pandit, District Secretary of Purba Medinipur, Debashish Majumdar, District Secretary of North 24 Parganas Rural and other district secretaries were present in the meeting.

Dinhata BJP leader held for 'scuffle with cops' amid row over unauthorised rally

MI News Service, Cooch **Behar:** Tension sparked at Babupara in Dinhata, Cooch Behar, on Friday night when police arrested Cooch Behar district BJP general secretary Ajay Roy. The police said they had received a complaint that Roy was preparing a victory rally without administrative permission to celebrate the NDA's win in the Bihar Assembly polls. The police said they acted after residents complained that an unauthorised rally could trigger unrest.

A brief scuffle broke among the cops and Roy, his family and supporters, as they tried to prevent the arrest. Roy was booked for obstructing police duty. BJP leaders denied any plans of a rally. They claimed Roy was only celebrating the NDA victory outside his home.

Leader of Opposition Suvendu Adhikari accused the state government of political vendetta. District BJP president Abhijit Barman alleged north Bengal development minister and Dinhata MLA Udayan Guha was behind Roy's arrest. Guha dismissed the charge. "The law will take its own course," he said.

On Saturday, Roy was taken for a medical checkup and then produced in court, which rejected his bail plea. He was put in judicial custody till Novem-

On his way to court, Roy said he had been "unjustly arrested" and that the BJP "cannot be suppressed".

BJP leaders later met senior police officers to protest the arrest. Dinhata police officers maintained that the arrest was needed as specific complaints of an unauthorised rally were received.

National Investigation Agency arrests youth in Bengal's Uttar Dinajpur over suspected terror links

MI News Service, N. Dinajpur : A youth has been arrested in West Bengal's Uttar Dinajpur district by the National Investigation Agency (NIA) over suspected links to terror organisations, a senior police officer said on Saturday.

According to officials, the youth was detained from the Sujapur area on Friday morning after NIA sleuths grew suspicious of his activities. "The arrested youth has been identified as Janisur Alam, a resident of Ludhiana," the officer said, noting that Alam had been spotted moving suspiciously around the station premises before officers intervened.

A source in the central agency said, "During questioning, he allegedly attempted to flee, following which he was taken into custody." The source further suggested that the youth "may be linked to multiple acts of sabotage". Investigators are still determining whether his activities have any direct connection to the recent blast in Delhi.

'We are yet to establish whether he has any direct connection to the Delhi blast. Digital devices and documents were seized from his possession," the official said. The explosion near the Red Fort in New Delhi claimed 13 lives and left several others injured. The government has described the incident as a "terrorist incident".

Following the blast, the NIA also conducted a raid on Wednesday at the Murshidabad residence of migrant worker Moinul Hasan, an officer said. An agency source told PTI, "Hasan had worked intermittently in Delhi and Mumbai, and during his time in Delhi. he shared accommodation with a Bangladeshi national with whom he is believed to have maintained long-term contact.

Detectives are now examining whether Hasan had any links to extremist organisations during that period or if he had any connection to the youth arrested in Uttar Dinajpur.

Jalpaiguri: Three die as bike collides with pick-up van on Teesta bridge

The victims' families claim that the pick-up van rear-ended the bike. A police source, however, said they collided head-on.

Arindam Pal Chowdhury, the deputy superintendent of police (traffic) of Jalpaiguri, said: "The pickup van was seized after the accident. The driver has fled, and we are searching for him. Two men were rescued from the spot at night and taken to the medical college, where they were declared dead. On Saturday morning, another body was recovered from the Teesta river. We have initiated a probe."



Commission cracks down on BLOs Over voter list errors

MI News Service, Kolkata: The Election Commission has issued a stern warning to Booth-Level Officers (BLOs) across West Bengal, making it clear that any lapse or false entry detected during the ongoing intensive voter list revision will invite strict punitive action. The message came during a high-level review meeting convened by Chief Electoral Officer (CEO) Manoj Kumar Agarwal on Saturday as part of the state's final preparatory phase before the arrival of a central delegation.

Deputy Election Commissioner Gyanesh Bharti is scheduled to visit Bengal on November 18 to assess the progress of the revision process. Ahead of that, the CEO met with all district magistrates to finalize "lastminute preparations" and review inconsistencies in the distribution of enumeration forms. Officials confirmed that 7.45 crore forms have already been distributedcovering nearly 97 percent of the target. The Commission, however, expressed dissatisfaction over the pace of work in certain districts, notably West Burdwan and South 24 Parganas. During Saturday's meeting, senior Commission officials took a firm tone, questioning the reasons behind the delay and instructing district authorities to ensure 100 percent coverage without further lapse. Inside sources said the Commission's directives were unequivocal: the accountability for data integrity rests squarely on field officers. From form distribution to verification and data entry, no error or manipulation will be tolerated. "Any instance of false entries or deliberate inaccuracies will attract disciplinary action against the concerned BLOs," an official present at the meeting stated. The warning comes at a time when a section of BLOs has voiced grievances against workload and resource gaps. Yet, the Commission has reiterated that impar has reiterated that impartiality and accuracy remain non-negotiable, adding that both BLOs and Electoral Registration Officers (EROs) must coordinate closely to maintain the credibility of the voter rolls. The ongoing revision process forms part of the Commission's statewide election preparedness exercise ahead of the next electoral cycle, with the final list scheduled for publi-

Kolkata chokes on diversions as Vidyasagar Setu Shuts for repairs

MI News Service, Kolkata: Traffic movement across the city faces a major disruption today as the iconic Vidvasagar Setu remains closed for sixteen hours, from 5 a.m. to 9 p.m., for essential maintenance work. The shutdown, announced by the Hooghly River Bridge Commissioners (HRBC), has triggered wildespread dispusions, as triggered widespread diversions, affecting commuters and logistics services across key arterial routes connecting Kolkata to Howrah and beyond. The bridge, which serves as one of the city's busiest links over the Hooghly River, has been closed to facilitate critical inspection and structural maintenance ahead of the winter

This includes checking joints, tightening cables, and routine inspection of expansion bearings. Authorities said the decision was taken after technical reports called for immediate preventive upkeep to ensure long-term safety and structural stability of the bridge. The closure has compelled the Kolkata Police's Traffic Department to initiate extensive diversions. Vehicles heading from the heart of Kolkata toward Howrah have been redirected via Howrah Bridge and the Nivedita Setu, while those bound for Alipore, Behala, and Taratala are being advised to take

ED seeks to grill former RG Kar | Gold trader murder: Shocking video nails BDO's role

MI News Service, Kolkata: The Newtown gold trader murder case taken a chilling turn with investigators captures BDO Prashant Barman and his aids brutally assaulting the victim. The footage, retrieved from the mobile phone of the BDO's driver, Raju Dhali, has reached the hands of the Bidhannagar Detective Branch, sending shockwaves through the investigating ranks. According to senior officers, the video clearly shows Prashant Barman personally thrashing the gold trader before directing his associates to continue the assault. When visibly tired, the BDO is seen sitting on a chair and instructing others to "keep beating until he dies." His voice, investigators confirm, is distinctly audible in the audio accompanying the footage. The Detective Branch is now conducting a forensic examination of the

video to verify authenticity, timing, and sequence of events leading to the trader's death. The BDO's car, previously suspected to have been used in the crime, was recovered on Saturday. Another vehicle, a blue-lightfitted car allegedly used to transport and dump the body, has also been seized from the Kolkata area following Raju Dhali's interrogation.

Preliminary findings suggest the trader was killed on October 28, and investigators tracked the second vehicle's movement through GPS data obtained from the driver's phone. Both vehicles are now under forensic inspection, as the police piece together the chain of events leading to the murder. Officials describe the video evidence as a potential breakthrough that could decisively link the district offi-

SSC under spotlight as full-score candidates miss interview chance

The latest SSC teacher re-

cruitment process for higher secondary and secondary levels has triggered widespread discontent among fresh candidates after several high scorers reportedly failed to receive interview calls. The controversy has deepened as 'in-service' teachers appear to have gained an edge through experience-based scoring under the prescribed selection criteria. The recruitment test for classes XI-XII was held on September 14, with 2,46,000 applicants, while the test for classes IX-X, conducted on September 7, saw 3,19,919 aspirants. Against a total vacancy of 35,726 posts — 12,514 for XI-XII and the remainder for IX-X — only a little over 20,000 candidates have been short-listed for interviews, according to SSC data. Sources indicate that the cutoff marks for various subjects remained high — 77 in English, 73 in Bengali, 71 in Arithmetic, and 75 in History. Yet, in some subjects, even candidates achieving perfect SSC officials have clarified that selections are based on a combination of written marks, TET scores, and experience weightage, ensuring that both new entrants and currently serving teachers are considered within statutory guidelines. In English and Bengali, the competition has been especially intense, with many freshers missing out despite strong performances. Mathematics and History show similar patterns, where the experience component of scoring provided marginal advantages to in-service applicants. Officials, however, maintained that the selection process strictly follows the notified recruitment rules and transparency protocols. While 50 percent of the shortlisted candidates belong to the fresher category, many serving teachers failed to make it through XI-XII document verification but are expected to feature in the upcoming

EC clarifies: Aadhar only for voter ID linking

MI News Service, Kolkata/ New Delhi: The Election Commission of India (ECI) has clarified that the Aadhaar card cannot be treated as proof of citizenship, residence, or date of birth in any part of the Summary Intensive Revision (SIR) process for voter rolls. The clarification comes amid the ongoing drive to link the electoral database with the Aadhaar ecosystem following legislative amendments introduced in 2021.Responding to a public interest litigation filed by Advocate Ashwini Kumar Upadhyay, the Commission has submitted an affidavit affirming that Aadhaar serves only as a tool for identity verification aimed at curbing duplicate voter registrations. It stressed that the document's role is limited under Section 23(4) of the Representation of the People Act, 1950, and does not extend to establishing citizenship eligihaar is not proof of citizen ship or domicile. Officials noted that in the ongoing voter list revision process, Aadhaar has been assigned as Document No. 12, signifying its use strictly for identity verification rather than for determining residential or citizenship status. The Commission underscored that the eligibility to vote remains constitutionally defined-requiring an individual to be 18 years or older and an "ordinary resident" of the concerned constituency. Revised electoral forms, including Form 6, now reflect this legal and constitutional distinction. Legal experts observing the matter say the clarification upholds the integrity of voter eligibility norms while maintaining clear boundaries between identification and enfranchisement rights. The Supreme Court has also upheld this interpretation, reiterating on October 7 that

Howrah Division Conducts Fortress Ticket Checking Drive At Sheoraphuli, Detects 1046 Irregularities

Chingrighata traffic snarl: KMDA mulls new bridge

MI News Service, Kolkata: Kolkata: In a bid to ease traffic congestion around the Chingrighata crossingespecially for vehicles travelling from Salt Lake Sector V towards Science City—the Kolkata Metropolitan Development Authority (KMDA) is set to build a new concrete bridge with a steel girder. The structure will extend from

the existing narrow bridge over the Shantinagar canal up to Captain Bheri. The current bridge forms the narrowest stretch on the Science City-bound flank of EM Bypass. Adding to the bottleneck, a bus stop located at the starting point often causes traffic to slow down as buses halt

to pick up passengers. "To address this, we have decided to construct a bridge that will run above the existing one up to Captain Bheri and shift the bus stop to the new bridge. Counter Intelligence continues raids across Valley

MI News Service, Srinagar: The Counter Intelligence wing of Jammu and Kashmir Police on Thursday carried out raids at several locations across the Valley in connection with the "whitecollar terror module" and the recent blast near Delhi's Red Fort, officials said.

Around 10 persons, including three government employees, have been picked up for questioning from various parts of Kashmir. The officials said the investigators picked up the suspects from Anantnag, Pulwama and Kulgam districts during overnight raids. The raids are currently being carried out by Counter Intelligence Kashmir (CIK) at 13 locations, they said. Around 15 people have been detained for questioning, and several digital devices and incriminating materials have been recovered, the officials said. Further details are awaited, they added. Earlier on Wednesday, Anantnag Police carried out coordinated raids in the district amid a massive crackdown against the banned organisation Jamaat-e-Islami (JeI). Meanwhile, in Kulgam, police are carrying out a crackdown against the anti-national elements, checking vehicles at the Navyug tunnel. The raids were based on credible intelligence inputs indiattempts JeI-linked elements to revive their activities under different fronts, police officials said. They said the raids were carried out at several locations across the 10 districts of the Kashmir valley -

Srinagar, Ganderbal, Budgam, Baramulla, Bandipora, Kupwara, Anantnag, Kulgam, Pulwama, and Shopian. In north Kashmir's Baramulla district, police in Sopore launched a major coordinated operation and carried out a district-wide counter terror and separatist ecosystem action, by conducting simultaneous raids at over 30 plus locaacross Zaingeer, and Rafiabad areas with the assistance of other security forces, they

Meanwhile, security agencies have recovered the diaries of Delhi blast case accused Dr Umar and Dr Muzammil, which mention the dates November 8 to 12, indicating that the planning was underway for such an incident during that period, sources said. According to the sources, the diary also contained the names of about 25 individuals, most of them hailing from Jammu and Kashmir and Faridabad. According to the information from the diaries, it can be said that the blast was to be carried out as part of a well-planned conspiracy. These diaries were recovered on Tuesday and Wednesday from Dr Úmar's room number four and Muzammil's room number 13. Additionally, police recovered a diary from Muzammil's room, the same location where they recovered 360 kg of explosives in Dhaui, located just 300 meters from Al-Falah University. The diaries carried code words which investigators are now piecing together. The agencies are also looking into whether different vehicles were being prepared for the blasts.

The world's thirdChina accounted for more than 75 per cent of oil demand growth over the past ten years, but this picture is changing, and India becomes the new epicentre of growth in oil demand," the IEA said. "Oil demand in India increases by 2 mbpd to 2035 - the largest increase in any country — and continues to rise through to 2050. The next largest increases to 2035 are in Africa (1.2 mbpd), and Southeast Asia (1 mbpd)," the IEA said. But this growth comes at a cost, a heavier import bill. India's crude oil import dependence will climb from 87 per cent in 2024 to 92 per cent by 2035, despite ongoing efforts to boost domestic production. At the same time, India is consolidating its position as a refining powerhouse. "Since 2022, India has emerged as a global swing supplier, refining volumes of Russian crude oil exports that previously flowed to Europe. India's refining capacity grows from 6 mbpd in 2024 by 1.5 mbpd to 2035 which solidifies its role as a key exporter of transport fuel," the IEA said. VANDE MATARAM to be compulsory in UP schools: Yogi

MI News Service, Ayodhya: Uttar Pradesh chief minister Yogi Adityanath said singing Vande Mataram would be made mandatory in all schools across the state, seeking to mine the controversy over the national song to draw political mileage for the BJP ahead of the second phase of polling in Bihar.

Addressing an Ekta Yatra (Unity March) in Gorakhpur, he said this step would inspire a feeling of reverence and pride among citizens towards "Bharat Mata" and the motherland. "There should be a sense of respect for the national song Vande Mataram. We will make its singing compulsory in every school and educational institution of Uttar Pradesh," he said at the event to commemorate the 150th birth anniversary of Sardar Ballabhbhai Patel. BJP governments across the country have planned month-long celebrations in Patel's honour.

Prime Minister Narendra Modi ignited a political row last week by reciting from Vande extracts Mataram that carry religious connotations and alleging that the Congress's adoption of only the first two stanzas as the national song in 1937 "sowed the seeds for the division of India". A Hindutva hardliner, Adityanath had cam-paigned extensively in Bihar, where the last phase of polling on 122 seats would be held on Tuesday. BJP sources have said the party didn't get encouraging feedback from the ground after the first phase of polling on 121 seats on November 6.

"Our internal reports suggest that projecting Nitish Kumar once again as the NDA's chief ministerial face may hurt us in Bihar. We need something else to pull voters in the second phase. But we don't need to be on the spot to campaign. The news of Adityanath's decision will reach Bihar through the media and may help us," a senior BJP leader said.At the Gorakhpur event, Adityanath said: 'Vande Mataram has also completed 150 years.

Kerala HC asks Kerala to approach SC on SIR

MI News Service, Kochi: Kerala High Court suggested that it would be appropriate for the state government to approach the Supreme Court for deferment of the special intensive revision of electoral rolls being carried out by the Election Commission.

Taking up the Kerala government's plea, Justice V.G. Arun said that since similar petitions from Bengal, Bihar and Tamil Nadu were pending before the Supreme Court, it would be appropriate for Kerala to move the apex court.

The Kerala government has been opposing the SIR, especially when the state is to hold local body polls in two phases on December 9 and 11. The state government highlighted administrative and logistical challenges because of the upcoming elec-Advocate-general Gopalakrishna Kurup said 1.76 lakh government employees and 68,000 security personnel would be deployed for the local body polls, and the SIR would require an additional 25,668 employees. The state said that if the SIR is implemented at this juncture, the government machinery would come to a standstill. The high court will give its verdict on the writ petition on Friday. When the high court asked why the state had not approached the Supreme Court, Kurup said the state election commission had already started implementing the SIR. Senior lawyer Rakesh Dwivedi, representing the Election Commission, clarified that half of the SIR exercise has been completed in Kerala. The preparation for the SIR had started in October, and the enumeration forms are

India's Army Chief General Upendra Dwivedi described the battlefields of Ukraine as a "living lab" for modern warfare, saying the lessons drawn from it are shaping India's defence preparedness, especially along its own borders. Speaking at the Delhi Defence Dialogue, Dwivedi said, "We are watching closely Ukraine battlefields because it is the living lab in terms of the conditions what we are having along our borders.

"Drones are stalking the armoured columns, EW is jamming the radios, precision fires are reaching much bevond 100 kms range, infocampaigns win wars even before a single shell lands,' he said, noting how rapidly evolving battlefield dynam-

ics are redefining strategy Outlining what he called the three "Ds" transforming warfare, the Army Chief said: "Democratisation the newest technology com $ing\ in; Diffuse -- geographi$ independent but dependent; and Demography." On India's own milioutlook, Dwivedi emphasised that geography continues to dictate strategy. "As far as India is concerned by virtue of our land borders, the way we are having it, land will remain the currency of victory," he said. "If you take your mind back to the meeting which took place between President Trump and Putin in Alaska, they also discussed about the land only." Dwivedi also

highlighted India's growing use of artificial intelligence and data analytics in military operations. SC bans mining activities within 1 km of national parks, sanctuaries

MI News Service, New Delhi: The Supreme Court on Thursday banned mining activities within an area of one km from national parks and wildlife sanctuaries, noting that such activities will be hazardous to the wildlife . A bench comprising Chief Justice of India BR Gavai and Justice K Vinod Chandran was considering pleas on issues related to the notification of areas under Saranda Wildlife Sanctuary (SWL) and the Sasang daburu Conservation Reserve (SCR) as a conservation reserve in Jharkhand. "It has been the consistent view of this court that mining activities within one km of the protected area will be hazardous to the wildlife. Though in the case of Goa Foundation, the said directions were issued with respect to the State of Goa, we find that such directions need to be issued on a pan-

India basis. "We direct that

mining within national parks and wildlife sanctuaries and within an area of one km from boundary of such national park or wildlife sancshall not be tuary permissible," the bench said. The top court also directed the Jharkhand government to notify the region as a wildlife sanctuary.

It clarified that the rights of the tribals and forest dwellers in the region should be protected as per the Forest Rights Act and asked the state government to widely publicise it. Earlier, the bench had asked the Jharkhand government to take a decision to declare the ecologically-rich Saranda region as a reserve forest. The matter pertained to a longpending proposal to notify Saranda Sasangdaburu forest areas in West Singhbhum district as a wildlife sanctuary and conservation reserve, re-

DIABETES COMBAT: Kolkata hosts interaction with world's top physicians

MI News Service, Kolkata: On the occasion of 'World Diabetes Day', Kolkata recently hosted an interesting interaction with world's renowned doctors, especially the 'Diabetes Specialist'. The experts hinted at taking quality food, especially protein to combat the menace of diabetes. A healthy and balanced diet can be as effective as medicine in managing and controlling diabetes, doctors said at an awareness meet. Reducing stress, having adequate sleep and exercising are the other factors that are important in controlling the "chronic metabolic disease", doctors said. A healthy diet will include good carbohydrates, fats and protein. The doctors have said that they should be consumed in the right amount and not in extremes, as excess of anything is not good for health.

Said Jeffrey Mechanick, an endocrin ologist and professor of medicine at Mount Sinai Hospital in the US. Carbohydrates that do not spike blood sugar levels are better than other forms of carbohydrates, said doctors. "The quality and quantity of carbohydrates consumed are also very important. Consuming lowglycemic carbohydrates like nuts and seeds that do not spike blood sugar levels is a good option," said Agnes Siew Ling Tey, senior lead,

clinical science and nutrition at the pharmaceutical company Abbott. Mechanick highlighted that the management of diabetes no longer focuses on only managing the glucose levels in the bloodstream, but comprehensively on what can be the health impacts of diabetes. "It can impact the kidneys, eyes and nerves," said Mechanick. "In India, people go from pre-diabetes to Type 2 diabetes rather quickly," he added. "The general populace is getting their information from non-scientists and non-doctors

who are everywhere on social media. There is a need to plug these knowledge gaps. We have science-based information, but we do not have the awareness," said Dr. Shashank Joshi, an endocrinologist and diabetologist at Lilavati Hospital and Research Centre in Mumbai. "screening the blood sugar levels from an early age can help." He added. Dr Joshi further said, "A man who is 25 years or older and has a waist circumference of more than 90cm should undergo screening.

Brain scan reveals why Parkinson's drugs don't always work: Study

University Researchers are using an advanced brain imaging method called MEG to understand why Parkinson's drug layedone described and the state of the state drug levodopa doesn't work equally well for everyone.

By mapping patients' brain signals before and after taking the drug, they discovered that it sometimes activates the wrong brain regions, dampening its helpful effects.

This breakthrough could pave the way for personalised treatment strategies, ensuring patients receive medications that target the right areas of their brain more effectively.

The new study by the Simon Fraser University (SFU) researchers, published in the journal Movement Disorders, looks at why levodopa - the main drug used in dopamine replacement therapy is sometimes less effective in patients.

The drug is typically prescribed to help reduce the movement symptoms associated with the neurodegenerative symptoms for the vast majority of patients, not everyone experiences the same level of benefit.

In order to find out why this is the case, an SFU collaboration with researchers in Sweden has used magnetoencephalography (MEG) technology to determine how the drug affects signals in the brain.

"Parkinson's is the second most prevalent neurodegenerative disease worldwide and it is the most rapidly increasing, in terms of incidence," says Alex Wiesman, assistant professor in biomedical physiology and kinesiology at

"Treating this disease, both in terms of helping people with their symptoms, but also trying to find ways to reverse the effects, is becoming more and more important. If clinicians can see how levodopa activates certain parts of the brain in a patient, it can help to inform a more personalised approach to treatment," added Wiesman.



The study was a collaboration with researchers at Karolinska Institute in Sweden, who used MEG to collect data from 17 patients with Parkinson's dis-

ease - a relatively small sample size. Researchers mapped participants' brain signals before and after taking the drug, in order to see how and where the

drug impacted brain activity.

MEG is an advanced non-invasive technology that measures the magnetic fields produced by the brain's electrical signals. It can help clinicians and researchers to study brain disorders and diseases, including brain injuries, tumours, epilepsy, autism, mental illness and more.

Using this rare brain imaging technology, Wiesman and team developed a new analysis that lets them "search" the brain for off-target drug effects.

"With this new way of analysing brain imaging data, we can track in real time whether or not the drug is affecting the right brain regions and helping patients to manage their symptoms," says Wiesman.

'What we found was that there are sometimes 'off-target' effects of the drug. In other words, we could see the drug activating brain regions we don't want to be activating, and that's getting in the way of the helpful effects. We found that those people who showed 'off target' effects are still being helped by the drug, but not to the same extent as others," said Wiesman.

Parkinson's disease is a neurodegenerative disorder, meaning parts of the brain become progressively damaged

It affects predominately the dopamine-producing neurons in a spe-

cific area of the brain called the substantia nigra. People with Parkinson's disease may experience a range of movement-related

symptoms, such as tremors, slow movement, stiffness and balance problems. Wiesman hopes that a better under-standing of how levodopa affects an

individual's brain signals could improve how drugs are prescribed to treat Parkinson's.

This new type of brain imaging analysis is not only for studying Parkinson's disease; any medications that affect brain signaling can be studied using the method developed by Wiesman and colleagues.

Researchers find how areas of brain are associated with helping decisions

BIRMINGHAM [UK]: Researchers found that a particular brain region--which they identified through a study of patients who had brain damage to that region--controls our willingness to assist others.

Understanding the areas of the brain associated with "helping" decisions is crucial to comprehending how people could be inspired to take on major global issues like infectious diseases, climate change, and international conflict. It is also necessary to discover novel treatments for social interaction difficulties.

Researchers from the Universities of Birmingham and Oxford conducted the study, which was published in Nature Human Behaviour. It demonstrates for the first time how the ventromedial prefrontal cortex (vmPFC), a brain region, plays a crucial role in helpful, or "prosocial," activities. Lead author Professor Patricia Lockwood said: "Prosocial behaviours are essential for addressing global challenges. Yet helping others is often effortful and humans are averse to effort. Understanding how effortful helping decisions are processed in the brain is extremely important."

In the study, the researchers focused on the vmPFC, a region located right at the front of the brain, which is known to be important for decision-making and other executive functions. Previous studies using magnetic resonance imaging (MRI scanning) have linked the vmPFC to choices that involve a trade-off between the rewards available and the effort required to obtain rewards. However, these techniques cannot show whether a part of the brain is essential for these functions. Three groups of participants were recruited for the study. 25 patients had vmPFC damage, 15 patients had damage elsewhere in the brain, and 40 people were healthy age and gender-matched control participants. These groups allowed the researchers to test the impact of damage to vmPFC specifically. Each participant attended an experiment where they met another person anonymously. They then completed a decisionmaking task that measured how willing they were to exert physical effort (squeezing a grip force device) to earn rewards (bonus money) for themselves and for the other person. By enabling participants to meet but not see - the person they were 'working' for in advance, researchers were able to convey the sense that participants' efforts would have real consequences, but hide any information about the other person that could affect decision-making. Each choice the participants made varied in how much bonus money for them or the other person was available, and how much force they would have to exert to obtain the reward. This allowed the researchers to measure the impact of reward and effort separately, and to use advanced mathematical modelling to precisely quantify people's motivation. The results of the study clearly showed that the vmPFC was necessary for motivation to help others. Patients with vmPFC damage were less willing to choose to help others, exerted less force on even after they did decide to help, and earned less money to help others compared to the control groups. In a further step, the researchers used a technique called lesion symptom mapping which enabled them to identify even more specific subregions of the vmPFC where damage made people particularly antisocial and unwilling to exert effort for the other person. Surprisingly, damage to a nearby but different subregion made people relatively more willing to help. Colead author Dr Jo Cutler said: "As well as better understanding prosocial motivation.

Study gives insight into effectives of CT scan to assess people with chest pain



WASHINGTON [US]: Previous investigations indicated that less than 40 per cent of patients with stable chest discomfort who underwent invasive coronary angiography had obstructive coronary artery disease. Recent randomized clinical trials have shown that using computed tomography angiography (CTA) first in evaluating these patients is beneficial, and a new study presented at the American College of Cardiology Cardiovascular Summit backs up this strategy, finding that CT was associated with a higher likelihood of revascularization when compared to other imaging modalities or no testing.

Stable angina is a type of chest pain that happens when the heart muscle requires more oxygen than usual--for example, under stress, exercise, or cold weather--but does not receive it, frequently due to blocked coronary arteries. Patients with stable angina are typically treated with guideline-directed pharmacological therapy and lifestyle adjustments, but they may also require a coronary revascularization operation to restore enough blood flow and alleviate their symptoms.

"Right now, when a patient presents to their primary care physician or cardiologist with symptoms suspicious for angina, they are commonly referred for additional testing," said Markus Scherer, MD, Director of Cardiac CT and Structural Heart Imaging at Atrium Health-Sanger Heart & Vascular Institute and the study's senior author.

Between October 2022 and June 2023, researchers at Atrium Health-Sanger Heart & Vascular Institute in Charlotte, North Carolina, assessed 786 patients who had no prior diagnosis of coronary artery disease and underwent elective invasive coronary angiography (ICA) for the evaluation of suspected angina. The pre-ICA testing strategies were: no noninvasive testing with direct referral to ICA (44%), stress echocardiogram (3%), stress myocardial perfusion imaging (15%), stress MRI (2%) and coronary CTA (36%). The study cohort had a mean age of 66 years, was 63% male, 37% female, 81% White, 13% Black, 1% Asian, 1% Hispanic and 1%

The researchers compared rates of subsequent revascularization between patients whose initial evaluation was coronary CTA versus stress testing or clinical judgement (no testing). The "CT first" strategy was associated with subsequent revascularization in 62% of patients compared to 34% for the combination of other modalities or direct ICA referral.

The 2021 AHA/ACC Guideline for the Evaluation and Diagnosis of Chest Pain suggests either non-invasive functional imaging or coronary CTA as the initial test without specifying a preference for one or the other.

According to the researchers, there are a multitude of reasons health systems don't currently use a CT first approach, including the availability of high-quality CT scanners; availability of qualified cardiac CT interpreting physicians; and challenges in transitioning to a newer approach after decades of preestablished patterns (i.e. stress testing). Furthermore, a CT first approach is predominately advocated for patients with unestablished coronary artery disease and does not apply to all, as some patient factors may reduce the accuracy and utility of coronary CTA.

"While care must be individualized, for patients with unknown or unestablished coronary artery disease, the transition to a 'CT first' strategy should be a high priority for cardiovascular care providers," Scherer said. "The non-invasive approach has a lower risk and cost than a diagnostic heart catheterization and, for the CT approach--but not stress testing--provides information on the absence, presence and extent of coronary atherosclerosis and whether or not there are high risk plaques as well as vessel blockages, which helps streamline patient management and risk reduction."

Since coronary CTA is less expensive than both nuclear myocardial perfusion imaging and ICA, there is a direct cost saving to patients and third-party payers with the CT first approach, according to Scherer. From the perspective of a health system, the most financially efficient evaluation approach becomes more important during the transition to a value-oriented health care system.

According to the authors, the study demonstrates "real world" credence to the randomized trials showing similar benefits to a "CT first" strategy and this strategy for the evaluation of patients with chest pain and an unestablished history of coronary artery disease.

"Cardiac catheterization labs are a capital and human resource intensive care environment. Using them for their maximum potential of treating disease, rather than diagnosing it, bring the highest yield for these resources to the health care system," Scherer said.

Following a successful pilot study, researchers at the University of Auckland are conducting a clinical trial of castor oil as a potentially safe and natural treatment for dry eye con-It is estimated that dry-eye

illness affects approximately 58 per cent of the population aged 50 and up in Australia. Some risk factors for devel-

oping dry eye disease include advanced age, menopause, increased screen time, and contact lens wear. Blepharitis is the leading

cause of dry eye illness, accounting for more than 80 per cent of cases. It is a chronic disease with known cure. 'Currently, patients are left grappling symp-

toms of dry-

grittiness, ness and, in cases watery eyes that feel uncomfortable impacting on their quality of life and work productivity," says doctoral Catherine investigator Jennings.

Current treatments, such as antibacterials and anti-inflammatories, are generally unsuitable for long-term use, due to significant side effects and the potential for antimicrobial resistance.

"Often patients are left feeling helpless when attempting to manage a chronic condition," Jennings said.

The current trial is of a product containing coldpressed castor oil enhanced with manuka and kanuka oils applied using a rollerball attached to a small glass bottle.

"The previous pilot study, conducted by our research team, was unique in its use of castor oil in such an application on the eyelids, with the product not known to be used anywhere else in the world for treating blepharitis," said Jennings.

Castor oil comes from a flowering tropical or subtropical shrub from the species Riccinus communis. It has been used therapeutically for millennia, including more recently in eye cosmetics and eye makeup

In the pilot study, 26 patients with blepharitis were treated with cold-pressed castor oil over four weeks. They had measurable improvements in symptoms, such as reduced redness of the lid margin, decreased thickening of the eyelid, and a decline in bacterial profusion, as well as

reduced eyelash crusting. Building on the success of the pilot study,

Polycystic ovary syndrome linked to memory, thinking problems: Research

to research published in the online edition of Neurology, the medical journal of the American Academy of Neurology, people with polycystic ovary syndrome may be more prone to experience memory and cognitive issues in middle age. The study does not establish a link between cognitive deterioration and polycystic ovarian syndrome. It merely displays a correlation.

Polycystic ovary syndrome is a hormonal disorder that is defined by irregular menstruation and elevated levels of a hormone called androgen. Other symptoms may include excess hair growth, acne, infertility and poor metabolic

"Polycystic ovary syndrome is a common reproductive disorder that impacts up to 10% of women," said study author Heather G. Huddleston, MD, of the University of California, San Francisco. "While it has

been linked to metabolic diseases like obesity and diabetes that can lead to heart problems, less is known about how this condition affects brain health. Our results suggest that people with this condition have lower memory and thinking skills and subtle brain changes at midlife. This could impact a person on many levels, including quality of life, career success and financial security. The study involved 907

female participants who were 18 to 30 years old at the start of the study. They were followed for 30 years, at which time they completed tests to measure memory, verbal abilities, processing speed and

At the time of testing, 66 participants had polycystic ovary syndrome

In a test measuring attention, participants looked at a list of words in different colors and were asked to state the color of the ink rather than

read the actual word. For example, the word "blue" could be displayed in red, so the correct response would be red.

Researchers found for this test, people with polycystic ovary syndrome had an average score that was approximately 11% lower compared to people without the condition. After adjusting for age, race

and education, researchers found that people with polycystic ovary syndrome had lower scores on three of the five tests that were given, specifically in areas of memory, attention and verbal abilities, when compared to those without this

At years 25 and 30 of the study, a smaller group of 291 participants had brain scans. Of those, 25 had polycystic ovary syndrome. With the scans, researchers looked at the integrity of the white matter pathways in the brain by looking at movement of water molecules in the brain tissue.



Researchers found that people with polycystic ovary syndrome had lower white matter integrity, which may indicate early evidence of brain aging.

Additional research is needed to confirm these findings and to determine how this change occurs, including looking at changes that people can make to reduce their chances of thinking and memory problems," Huddleston said.

"Making changes like incorporating more cardiovascular exercise and improving mental health may serve to also improve brain aging for this population.

A limitation of the study was that polycystic ovary syndrome diagnosis was not made by a doctor but was based on androgen levels and selfreported symptoms, so participants may not have remembered all the information accurately. The study was funded by the University of California,

Pakistan: Kerosene oil, light diesel prices witness second hike in 15 days

MI News Service, Islam**abad**: The prices of kerosene oil and light diesel saw a hike for the second time within a month, Ary News reported on Sunday.

As per Ary News, Pakistan's Oil and Gas Regulatory Authority (OGRA) issued a notification confirming the revised prices. As per the notification, the price of kerosene oil has been raised by Rs9.29 per litre, rising from Rs185.05 to Rs194.34 per litre. The price of light diesel oil has increased by Rs6.82 per litre, shooting the new rate to Rs170.08 per litre, up from Rs163.98.

The government recently raised the price of high-speed diesel by Rs6

prices remain unchanged for the next fortnight.

Ary News reported that earlier, on November 1, the price of kerosene oil was increased by Rs3.34 per litre, from Rs181.71 to Rs185.05, while light diesel oil rose by Rs1.22 per litre, Rs162.76 Rs163.98. The back-toback increases within just 15 days has sparked frustration among the public and transporters.

According to Ary News, goods transporters announced an increase of four percent in transportation fares following the latest petroleum price hike, on Sunday.

Referring to a video statement by the Pakistan Goods Transport Association Alliance's President, Malik Shehzad Awan, Ary News reported that he strongly condemned the increase in petroleum product prices, stating that the entire transport community rejects the hike in fuel

The intricate interstate terror network was exposed after a small but significant incident of JeM posters appearing on the walls in Bunpora, Nowgam, on the outskirts of Srinagar, on October 19. Srinagar police registered a case and reviewed CCTV camera footage, leading to the arrest of three locals — Arif Nisar Dar alias Sahil, Yasir-ul-Ashraf. and Magsood Ahmad Dar alias Shahid, all with prior stone-pelting cases against their names. Their interrogation led to the arrest of Maulvi Irfan Ahmad, a former paramedicturned-Imam from Shopian, who allegedly supplied the posters and used his access to radicalise the doctors.

Afghan police seize illicit drugs, arrest 21 smugglers

MI News Service, Kabul: Afghan counter-narcotics police seized a quantity of illicit drugs, including crystal meth, and arrested 21 suspected smugglers in separate operations across multiple provinces, the Ministry of Interior Affairs said in a statement on Sunday. The seizure included 86 kg of raw hashish, 5 kg of crystal meth, a quantity of methamphetamine, stimulant tablets, and some other types of narcotics.

Israel reiterates opposition to Palestinian state before UN vote as Hamas denounces "expansionist tendencies"

MI News Service, Jerusalem/Gaza: Israel on Sunday reaffirmed its opposition to the creation of a Palestinian state, a day before the United Nations Security Council is scheduled to vote on a U.S.-backed resolution supporting the socalled 20-point Gaza peace plan. Hamas later condemned the remarks, saying they revealed Israel's "expansionist

Israeli Prime Minister Benjamin Netanyahu restated the position at the start of the weekly cabinet meeting. "Our opposition to a Palestinian state west of the Jordan River stands firm and has not changed in the slightest," he said. Netanyahu said the U.S. plan calls for a demilitarized Gaza and the dismantling of Hamas's military capabilities. "Hamas will be stripped of its weapons, either the easy way or the hard way," he said, adding that U.S. President Donald Trump shares this view.

Defense Minister Israel Katz repeated the message, saying Israel's policy remains clear and that there would be no Palestinian state. He said that Gaza would be "fully demilitarized, down to the last tunnel," Katz said that in the so-called "yellow zone," a cordoned-off strip where Israeli forces remain deployed, the Israel Defense Forces (IDF) would carry out the disarmament. In other parts of the enclave, the task would be undertaken by an international security force, "or by the IDF itself."

In a statement, Hamas spokesperson Hazem Qassem said that Katz's comments in support of continued blockade and rejection of Palestinian statehood "confirm the expansionist tendencies of the occupation." Qassem accused 'Israel of working to perpetuate the state of conflict and

instability throughout the region. The United States is pressing the Security Council to approve a resolution that "welcomes the establishment of the Board of Peace," a transitional governing body for Gaza that Trump would theoretically lead through the end of 2027. It would also authorize a temporary "International Stabilization Force" that would work with Israel, Egypt, and newly-trained Palestinian police to secure border areas and advance demilitarization.

According to media reports, the latest draft differs from earlier versions by acknowledging the possibility of a future Palestinian state. Palestinians seek a sovereign state that includes the West Bank and the Gaza Strip, with East Jerusalem as the capital, a goal supported by many countries. As of September, Palestine had been recognized as a sovereign state by 157 of the 193 UN member states.

Ukraine savs ready to resume prisoner exchange with Russia

MI News Service, Kiev: Rustem Umerov, secretary of Ukraine's National Security and Defense Council, said Saturday that Ukraine has agreed to resume the prisoner exchange process with



Russia during recent consultations mediated by Türkiye and the United Arab Emirates. "As a result of these negotiations, the parties agreed to activate the Istanbul arrangements. This concerns the release of 1,200 Ukrainians," Umerov wrote on Facebook. Technical consultations will take place soon to finalize all procedural and organizational details, said Umerov, adding that Kiev aims to bring Ukrainians home from captivity by the winter holidays. Ukraine and Russia held three rounds of negotiations in Türkiye in May, June and July, reaching the so-called Istanbul agreements on exchanging their captives and bodies of fallen soldiers.

1st Test: SA beat India by 30 runs in Kolkata, take 1-0 series lead (Ld)



KOLKATA: Despite being bowled out for 159 on day one after choosing to bat first, World Test Championship winners South Africa executed a remarkable comeback to defeat India by 30 runs in the first Test at Eden Gardens on Sunday. Chasing a modest target of 124, South Africa dismissed India for only 93 in 35 overs on Day 3.

The 30-run victory also marked South Africa's first Test win in India after 15 years, as the visitors now hold a 1-0 lead in the two-match series. Off-spinner Simon Harmer starred with figures of 4-21, while the rest of the attack combined to dismantle India's batting order on a challenging pitch, where anything above 100 to chase was always going to be a tough ask.

In the chase of 124, India sorely missed Shubman Gill, who was

ruled out due to neck surgery and needed hospitalisation. After skipper Temba Bavuma's fighting 55 not out, and his handy 44-run stand with Corbin Bosch, South Africa's lead was extended to 123. Harmer's excellent bowling, along with key wickets from Marco Jansen, Aiden Markram, and KeshavMaharaj, helped the Proteas stun India and leave the crowd silent. Resuming day three from 93/7, India were the early favourites to make further inroads and take control of the game. However, South Africa seized control by adding 60 crucial runs, with Bavuma's unbeaten 55 helping them reach 153 in their second innings. Bosch started by sweeping RavindraJadeja for four and scored singles to advance the total. With Bavuma providing stability from the other end, South Africa added 27 runs in the first

30 minutes. Bavuma continued to gain confidence - defending firmly with soft hands - even as Bosch swept and reverse-swept KuldeepYadav for four and six respectively, before his off-stump was rattled by JaspritBumrah'sinswinger. With steely composure and risk-free

JaspritBumrah'sinswinger. With steely composure and risk-free batting, Bavuma reached his first half-century of the Test with a streaky four to fine leg. Bavuma also scored his seventh fifty-plus inning in his last 11 Tests, earning warm applause from the crowd. Mohammed Siraj then delivered a decisive burst, rattling Harmer's off-stump with a length ball before trapping Maharaj lbw with a yorker to conclude South Africa's innings.India's chase of 124 began uncertainly as Jansen had YashasviJaiswal poking at a length ball, which took the outside

edge to keeper Kyle Verreynne,

dismissing the opener for a fourball duck. In his subsequent over, Jansen's extra bounce surprised KL Rahul, who edged to Verreynne. Facing a disciplined Jansen and consistent off-spinner Simon Harmer, Jurel and Sundar survived nervous moments before the lunch break. The post-lunch session began with Jurel's fluent flicks and Sundar's patience helping India reduce their target to under 100 runs. It also helped that South Africa was briefly without Jansen, who left the field after lunch but returned quickly.

There was a moment of drama when Bosch thought he had Jurel caught behind, only for the review to show the ball had missed the bat. Just as India looked settled, Harmer struck with his innocuous short ball, for which Jurel went on the back foot to pull but miscued it to deep midwicket. His dismissal

resulted from South Africa's relentless pressure, which produced only one run from 20 deliveries. The crowd's disappointment was set to grow when South Africa believed they had Rishabh Pant caught at backward short leg off Maharaj. However, the crowd cheered happily when the large screen showed "not out," as replays revealed the ball had deflected off the fielder's forearm.

But Harmer struck again when, on another innocuous delivery, Pant played a firm straight shot that returned to the off-spinner, who took a simple catch to dismiss the stand-in India captain for two. With Sundar displaying patience in his solid defensive batting, Jadeja demonstrated proactiveness by taking a boundary off both Jansen and Harmer. A hush fell over Eden Gardens when Harmer released some dip on a fuller ball to hit Jadeja on the boot and trap him lbw, with the dismissal also costing India a review. Aiden Markram's useful off-spin bowling provided South Africa with another vital breakthrough as he found Sundar's outside edge and had him caught at first slip, ending the all-rounder's resistance at 31 off 92 balls. Harmer struck again when his off-break spun past Kuldeep's defensive shot and hit him on the back leg, trapping him lbw. Kuldeep reviewed, but it was in vain as Harmer took his fourth wicket. Axar had the crowd roaring with delight by slog-sweeping Maharaj for four, before smashing him for two sixes. But Maharaj had the last laugh when Axar tried to slogsweep his slower delivery, but the bat turned at the point of impact and the top edge was caught by Bavuma running back from mid-wicket. On the very next ball, Maharaj had Siraj edging to first slip, sparking jubilant victorious scenes in the Proteas

Parthiv believes that the 2022 champions have an excellent and settled squad, as he said, "We've let go of few young players also, because we have quite a few young players in the side. I think we have a very solid and settled squad. That is the reason why we've not let go of a lot of players."

The team will look to strengthening their overseas contingent when the management heads to the IPL 2026 auction next month. Having released many of their overseas players, GT will need to revamp that section to strategise accordingly in their hunt for a second title.

We'll have to try and see once the last list comes out," Pathiv concluded.

U.S downed World Cup-bound Paraguay 2-1 in friendly



CHESTER: The U.S Men's National Team started a twomatch series against World Cupbound South American opponents during the November international window with a confident display, securing a 2-1 victory over a lively Paraguay side at Subaru Park. The team took an early lead with a fourth-minute goal from midfielder Gio Reyna and clinched the win with a second-half winning strike FolarinBalogun. strike by striker

The victory extends the USMNT's current unbeaten streak against World Cup-qualified opponents to four consecutive matches. In September, Paraguay secured qualification for the FIFA 2026 World Cup, marking the nation's return to the tournament for the first time in 16 years.

The USMNT started the match aggressively; the opening moments proved to be exciting,

and the fans at Subaru Park witnessed two goals in the first 10 minutes of action.

The US team were rewarded with the opening goal from a recycled corner kick as Giovanni Reyna put the hosts ahead with a glancing header after Max Arfsten's pass. For the second, Paraguayan forward Alex Arce finished a superb first-time cross from Atlanta United standout Miguel Almirón to level the match

The United States seized a good opportunity to take the lead in the 19th minute. Fullback SerginoDest, making his second start under Pochettino, faced his defender 1v1 on the right flank in the US attack and advanced towards the goal.

Dest's superb cutback created a precise, low pass to Roldan, who was free inside the 18-yard box. Roldan struck a powerful, firsttime shot on target, but Paraguay's goalkeeper Orlando Gill made the save.

The two World Cup-bound sides went into the half-time break at 1-1, though the U.S. held a slight advantage in first-half possession at 55 percent.

Around the 64th minute, the U.S. increased its intensity in and around the goal, including a tantalising chip across the six-yard box from midfielder Tanner Tessmann.

Moments later, Balogun delivered a clever backheeled pass to Dest running forward, but Paraguay managed to recover and clear the ball from danger in both attacks. Challengers Bengaluru shared a farewell note for Livingstone Liam the English after player was released from their squad ahead of the Indian Premier League 2026 auctions. Ten teams will get into a bidding war on December 16 at the Etihad Arena in Abu Dhabi. Livingstone was released from the RCB's squad as franchise announced their retentions Saturday evening. With November 15 being the retention deadline, the allrounder was among the eight members released by RCB, as the 2025 champions let go of players from their championshipwinning squad.

The Bengalurubased franchise shared a farewell

shared a farewell note for the English cricketer on their official X account, writing, "Stepped up when it mattered the most and left his mark on our most glorious chapter. You lived it, Liam, and we loved it! Thank you for everything. You'll always be an RCBian at heart." Last year, RCB signed Livingstone for Rs 8.75 crore during the mega auction, but he scored only 112 runs in 10 matches. With the franchise now sharing a farewell note, the all-rounder is unlikely to be repurchased by them. The RCB's most significant snub was England all-rounder Liam Livingstone, who was released due to his underwhelming performance last year. Additionally, South African pacer Lungi Ngidi was also released by the franchise. RCB tasted glory for the first time in 18 years as they lifted the coveted silverware in 2025. The Bengaluru-based franchise finished second in the points table after the league stage. They then achieved consecutive victories over Punjab Kings in Qualifier 1 and the final, held on May 29 and June 3, respectively, ending an 18-year wait for their inaugural IPL title. ViratKohli was the top scorer for the RajatPatidarled squad in IPL 2025, while Australian fast bowler Josh Hazlewood recorded the most dismissals.
