"Politics overtaking economics": Jaishankar warns at IIM Calcutta

Union External Affairs Minister S. Jaishankar delivered a sharp assessment of shifting global power equations during his address at IIM Calcutta on Saturday, warning that the world economy is entering an increasingly volatile and politically driven phase. Without naming former U.S. President Donald Trump, Jaishankar appeared to criticise Washington's recent policy direction, suggesting that radical shifts in American trade and strategic behaviour have accelerated uncertainty. Jaishankar, who visited Kolkata to receive an honorary doctorate from IIM Calcutta, used the platform to outline deep geopolitical and economic transformations underway across the world. According to him, "America has made radical changes in its policies in recent times." PG 3

EC extends schedule for **SIR** by 1 week

MI News Service, New Delhi/Kolkata: The Election Commission on Sunday extended by one week the entire schedule of the ongoing Special Intensive Revision (SIR) of electoral rolls in nine states and three Union Territories amid allegations by opposition parties that the "tight timelines" were creating problems for people and ground-level poll officials. In a statement, the poll authority said the enumeration form distribution will now continue till December 11 instead of December 4. The draft electoral rolls will now be published on December 16 in place of December 9, while the final voters' list will be out on February 14, 2026 in place of February 7.

Officials said the commission took the decision to extend the timeline for all phases of the SIR based on internal discussions with chief electoral officers of states and UTs where

the exercise is underway.
Alleging at least 40
deaths of booth-level officers (BLOs) during the SIR, largely by suicides due to "stress of meeting tight deadlines", the opposition parties have questioned the timing of the voters' list revision. The EC has junked these charges, saying the exercise is going on smoothly. Reacting to the EC's decision to revise the SIR schedule, Congress leader Pramod Tiwari said it was an indication that the poll panel knew the timelines were not "practical". The decision to tweak the SIR schedule comes on the eve of the Winter Session of Parliament beginning Monday. The last session was a virtual washout over demands by the opposition for a debate on the SIR, then being held in Bihar. Opposition leaders, while emerging from an all-party meeting, on smooth functioning of the session, said they will press for a debate on SIR. The EC had announced SIR in these states and UTs on October 27. Nearly 51 crore electors will be covered in the massive voters' list cleanup exercise. The states and Union Territories are: the Andaman and Nicobar Islands, Lakshadweep, Chhattisgarh, Goa,

Among these, Tamil Nadu, Puducherry, Kerala, and West Bengal will go to the polls in 2026. In Assam, where also polls are due in 2026, the revision of electoral rolls was announced separately. It is being called 'Special Revision'. Most states had the last SIR of the voter list

Bangladesh ex-PM KHALEDA ZIA 'critical'

MI News Service, Dhaka: Bangladesh's former prime minister and opposition leader Khaleda Zia remains in "very critical" condition at a Dhaka hospital, her party said on Sunday, as her exiled son and acting party chief Tarique Rahman signaled uncertainty over his return. Khaleda, 80, was admitted to a private hospital on November 23 with a severe chest infection affecting her heart and lungs, doctors and senior Bangladesh Nationalist Party officials said. Her deteriorating health comes at a sensitive time for her political party, which has regained prominence after Sheikh Hasina, Bangla desh's long-serving former prime minister, was ousted in a student-led uprising last year. Rahman, who has lived in London since 2008, wrote on Facebook on Saturday that his return to Bangladesh was "not en-



tirely" in his control, fuelling speculation over political or legal hurdles. Hours later, the interim government led by Muhammad Yunus said it had "no restrictions or obiections" return."There are no obstacles in this matter," Yunus' press secretary Shafiqul Alam said in a Facebook post. Khaleda's condition has deepened uncertainty within the Bangladesh Nationalist Party as it weighs its next steps with its matriarch gravely ill and its act-

ing chairman still abroad.

Star, son of Roshan Kumar, was attacked on Friday evening by two wolves while he was playing outside his house.

According to villagers, one of the wolves seized the child and dragged him away, prompting neighbours to raise an alarm and chase the animals with sticks and rods. They found the boy, severely injured and unconscious, in a field. He was first taken to the Kaisarganj community health centre and then referred to the district hospital. MI News Service, Siliguri: The fare for helicopter services between Sikkim's capital Gangtok and Bagdogra near Siliguri in West Bengal has been reduced to Rs 3,100 per person, from the earlier rate of Rs 4,500, an

DITWAH: IAF sends more aircrafts to Colombo

MI News Service, New Delhi: India has expanded its humanitarian assistance under Operation Sagar Bandhu, as Sri Lanka continues to reel from Cyclone Ditwah, deploying additional aircraft and helicopters to support relief work and evacuation.

A C-130J transport air-

craft carrying equipment meant for a National Disaster Relief Force (NDRF) team landed in Colombo on Sunday. According to a senior official, this aircraft will now be used to bring back Indian citizens stranded in Sri Lanka. The Indian Air Force has already positioned Mi-17 V5 helicopters in Colombo for fast deployment during relief operations. In an update shared on X, the IAF "#OperationSagar-Bandhu | IAF Humanitarian Assistance As part of India's ongoing relief efforts in Sri Lanka, the Indian Air Force has positioned Mi-17 V5 helicopters in Colombo for swift HADR operations." The post added that its transport aircraft are earmarked for "large-scale evacuation" of Indian nationals, with "mul-

tiple missions" planned from Trivandrum and Hindan. It also noted: "Alongside evacuation, essential relief material, including Bhishm cubes and medical supplies are also being airlifted to support affected communities. The IAF remains steadfast in safeguarding lives and extending timely assistance to our neighbours in need." Nearly 21 tonnes of relief material reached Colombo on board a C-130J and an IL-76 deployed from the Hindan air base. NDRF personnel, four canines and eight tonnes of humanitarian assistance and disaster relief equipment. The Navy has also been mobilised. INS Sukanya is on its way to Sri Lanka with additional aid, while two Chetak helicopters from INS Vikrant are carrying out search and rescue sorties alongside Sri Lanka Air Force personnel.

Cyclone Ditwah has caused widespread devastation across the island. A recent update from Sri Lanka's Disaster Management Centre placed the death toll at 132, with 176 people missing over the last four days. More than 43,900 people across 12,313 families have been affected. The Indian High Commission in Colombo is assisting stranded Indian passengers at the Bandaranaike International Airport, where severe air traffic disruptions have left many without flights. Officials said food, water and other support are being provided on the ground. India has also moved relief assets internally. For relief efforts in Tamil Nadu, a C-17 aircraft transported an NDRF team and equipment load from Pune to Chennai on the night

Jamiat chief Mahmood Madni defends JIHAD



MI News Service, New Delhi/Bhopal: Mahmood Madni, chief of Jamiat Ulema-a-Hind, accused the Supreme Court of working under government pressure to undermine minority rights and declared that oppression would trigger "jihad", drawing a sharp re-action from the BJP. "After the verdict in the Babri Masjid, triple talaq and several other cases, it seems that the courts have been functioning under govern-

ment pressure for a few years now. The court is hearing Gyanvapi (mosque) and Mathura (Krishna Janmbhoomi) cases while ig-noring the (Places of) Worship Act," Madni said at the national governing body meeting of the Jamiat Ulema-e-Hind, an association of Muslims, in Bhopal. The Supreme Court is eligible to be called supreme only when it follows the Constitution and when it upholds the law. If it doesn't do that, it doesn't deserve to be called supreme," he added. He said the term "jihad' was being misused to malign Muslims, stressing that it means a "struggle against oppression", adding: "Jab jab zulm hoga, tab-tab jihad hoga".BJP spokesperson and MP Sambit Patra said the "inflammatory" speech

Drones to surveil hill forests, boost wildlife protection in North Bengal

MI News Service, Siliguri: The forest department is set to introduce drone surveillance in the hill forests of Singalila. Senchal and Valley Neora strengthen the monitoring of wildlife and curb illegal activities following the successful use of remote aerial vehicles in the Jaldapara National Park over the past year.

Bhaskar JV, the chief conservator of forests (wildlife, north), said four drones deployed in Jaldapara last year had proved immensely effective, especially during emergencies involving straying wildlife.

Jaldapara, "In drones have helped us track elephants, gaur and one-horned rhinos when they stray outside the forest. During the recent floods, several rhinos were swept into the shallow Torsa river. With drone support, we were able to locate, tranquilise and safely bring them back," he said

Encouraged these results, the department will now deploy five drones each in Singalila, Senchal and Neora Valley forests, said Bhaskar. While Singalila and Senchel are in Darjeeling district, Neora is Kalimpong district.

Jaldapara, which is spread 216.51sqkm, significant recorded improvements in animal protection since drones were introduced.

"Not a single poaching incident was reported in the past year. Movement of poachers was not detected, and timber smuggling has come under control," a forest department officer

Drones have been used to monitor wide river stretches, grasslands and difficult terrain. Foresters say the technology has emerged as a powerful supplement to tradi-

tional patrolling. "Within a short time, a drone can scan large areas that foot patrols cannot cover as quickly. Combined with patrolling by vehicles and elephants, drone surveillance enhances our ability to detect movement, monitor sensitive zones and respond swiftly," the

forester said. Jaldapara, globally known for its population of one-horned rhinos, has benefited particularly from real-time monitoring. When drones are linked to the Internet, the foresters can track live locations of rhinos, elephants and other wildlife, even in remote areas. "If any unusual activity is detected, immediate action can be taken," the officer said

One of the biggest successes of the drone programme came on the night of October 4, when the Torsa river flooded large parts of Jaldapara, and eight rhinos were

swept away.
"Using drone images, we could track every rhino and rescue all of them safely. Such a coordinated operation is rare in the history of the forest department," another officer said.

Parveen Kaswan. the divisional forest officer of Jaldapara, said technology would continue to complement traditional methods.

"We use different technologies for protection and conservation. Drone cameras are one of them. They have given us great results, but patrolling on foot and on elephant-back will continue, as they remain essential tools,



Suspected smuggler gunned down by BSF during night crossing attempt in Nadia

Dipankar Edbar, Krishnaganj (Nadia) : A suspected cross-border smuggler was shot dead by the Border Security Force (BSF) along the Matiari-Banpur stretch of the Indo-Bangladesh border in Nadia district early Sunday, after he allegedly ignored repeated warnings from patrolling

troops. The incident has triggered tension in several villages close to the frontier, officials said. According to BSF sources, personnel on night patrol spotted a man moving suspiciously towards the fencing, apparently attempting to slip into Bangladesh. Despite multiple verbal warnings and hand signals, the individual continued to advance. BSF claims the jawans fired only when he tried to scale the border fence. He collapsed immediately after being hit.

A team from Krishnaganj police station reached the spot soon after and sent the body for post-mortem. Investigators are yet to

Upon sustained interrogation, three women confessed to being Bangladesh nationals who had illegally crossed the international border through the Ramnagar area under Hanskhali police station, with the help

of Bara Chupria in Nadia district. They stated they were entering India for employment and had been assured safe passage by the tout. None possessed passports, visas or any authorised border-crossing permits.

All four were immediately apprehended. The Bangladesh nationals were booked under Section 21 of the Immigration & Foreigners Act for illegal entry and stay, while the tout was arrested under Section 24(1) for facilitating infiltration. Officials said all legal protocols, including those related to the handling of women and children, were strictly followed. Following a written complaint, GRPS Ranaghat registered Case No. 19/2025 dated 29.11.2025 under relevant provisions of the Immigration & Foreigners Act. RPF Post, Ranaghat, said the swift response and coordination between the two agencies prevented movement of the infiltrators into Indian territory. Himalayan musk deer photographed in Bengal after nearly 70 years

MI News Service, Siliguri: The elusive Himalayan musk deer, which is categorised as an endangered species on the IUCN Red List, has been sighted in Bengal after a gap of nearly 70 years, with the being photographed in the Neora Valley National Park in Kalimpong district.

The images, captured on December 17, 2024, by a trap camera installed by the Wildlife Institute of India (WII), confirm the presence of the rare species in Bengal for the first time since 1955.

The cameras, which had originally been set up to research red pandas, recorded multiple clear images of the musk deer from different angles. However, the state forest department had not been informed about the images until recently. The camera data were being transmitted directly to the WII headquartered Dehradun, leaving Bengal foresters in the dark.

Bhaskar JV, chief conforests (wildlife, north), said the WII had not yet provided



detailed information about the findings to the depart-

"It is disappointing that the WII has not provided the details to us, even though we are the apex department in the state, and the national park is also located in our state," Bhaskar said.

According to records, the previous official sighting of a musk deer in Bengal occurred in the Singalila National Park of existed at the time.

therefore generated considerable excitement within the state's wildlife community. Wildlife researcher

Animesh Bose, who has participated in several surveys in the Neora Valley forest, said the discovery highlighted the region's rich but unexplored biodiversity. "We would urge the state forest department to prioritise habitat protection and conservation for the musk deer. We also hope that Unesco will consider the proposal to recognise the national park as a world heritage site," he said.

In 1999, the Neora Valley park was nominated for heritage status, but Unesco has yet to grant it. With the presence of multiple Red List species, including the Bengal tiger, golden cat, and now the musk deer, the Neora Valley stands as one of India's most biodiverse and least disturbed forests.

Bhaskar Das, a member of the governing counthe Indian Mountaineering Foundation who is based in Jalpaiguri, has said while musk deer populations have been recorded in Jammu & Kashmir, Arunachal Pradesh, Uttarakhand, Sikkim, and the sub-Himalayan forests, this is the first photographic record of the ani-

mal in Bengal. "Considering that it is an endangered species, an urgent assessment of its habitat in Neora Valley is needed. Also, entry into the park's virgin forests for any purpose other than scientific research should be banned to strengthen the case for the Unesco recognition," he said.

Honey badger, leopards, pangolin and more: Trap cameras reveal Purulia wildlife thriller

MI News Service, Purulia: From India's largest mammal to one of the planet's smallest cats. An animal imperilled by traffickers to a small carnivore ever ready to take on predators of any size. These animals and more have over the past year been captured by trap cameras installed in a forest in Purulia, Bengal's westernmost district that borders Jharkhand and is part of the Chhotanagpur Plateau.

An NGO installed the trap cameras in a pocket of the Kotshila forest in collaboration with the Bengal forest department. Three minutes of footage — a montage of images shot by multiple cameras that was shared with this newspaper — bears testimony to Purulia's biodiversity. It's difficult to take one's eyes off the footage, because the animals just keep coming. It begins with an Indian muntjac (Muntiacus muntjak), commonly called the "barking deer" because of the barklike sound it makes to sound the alarm when it senses danger.



A small Indian civet (Viverricula indica) appears next, looking for food. A full-grown leopard (Panthera pardus) follows, its eyes glowing in the dark and directed at the camera before it turns away. Just one clip has been shot in daylight: it shows two leop-

ards cuddling each other. The next to enter the scene is a sloth bear (Melursus ursinus), moving slowly at first before suddenly picking up speed. A honey badger (Mellivora capensis), probably clicked for the first time in Bengal, is a tenacious small carnivore with a reputation as one of the world's most fearless animals, ready to fight back against much

An Indian pangolin crassicaudata) makes a brief appearance. Scaly, toothless and nocturnal, pangolins are among the world's most trafficked mammals, hunted for their scales and meat. Most of this is smuggled into China, and the rest into Southeast Asia, for use in traditional medicines. Next is a rustyspotted cat (Prionailurus rubiginosus), which is among the world's smallest cats. It looks like a kitten. covered in a fawn coat with rusty brown spots on its back, and with an unmarked tail. This is the first formal documentation of the species in Bengal, foresters said.

Airport alert: UP resident arrested before foreign flight

MI News Service, Kolkata: A man wanted in several criminal cases in Uttar Pradesh was intercepted and detained at Kolkata's Netaji Subhas Chandra Bose International Airport while attempting to board an international flight. Authorities in Uttar Pradesh had previously issued an alert regarding the suspect due to multiple active complaints registered against him. Acting on this communication, the Kolkata Airport police began closely monitoring passenger movement to identify the individual if he attempted to travel.

Based on the informa-tion shared by UP law en-forcement, airport officials were able to locate and confirm the suspect's presence during routine checks. Before he could board his scheduled flight to a foreign destination, officers from the NSCBI Airport police station detained him and placed him under custody. As part of standard procedure, he was subsequently taken to the Dumdum municipal hospital for a medical examination to assess his condition before further legal processing. Preliminary investigation by the police revealed that the man claimed he had been travelling to Uttar Pradesh for medical treatment. Despite this assertion, officers noted that the outstanding criminal cases against him took precedence, making immediate arrest necessary. After completing the required formalities and verifying his identity, the Kolkata Police handed him over to the Uttar Pradesh Police team that had arrived to take charge of the suspect.

"Politics overtaking economics" Jaishankar warns at IIM Calcutta

Jaishankar delivered a sharp assessment of shifting global power equations during his address at IIM Calcutta on Saturday, warning that the world economy is entering an increasingly volatile and politically driven phase. Without naming former U.S. President Donald Trump, Jaishankar appeared to criticise Washington's recent policy direction, suggesting that radical shifts in American trade and strategic behaviour have accelerated uncertainty. Jaishankar, who visited Kolkata to receive an honorary doctorate from IIM Calcutta, used the platform to outline deep geopolitical and economic transformations underway across the According to him, "America has

made radical changes in its policies in recent times. They are bringing about political and economic changes through various transactions with different countries." He described this evolving environment as "worrying," emphasising that politics is increasingly overshadowing economics. "In this uncertain world, politics is gradually overtaking the economy. We must reassess our supply chains - both demand and sources of supply — and diversify them," the Minister said, urging a strategic rethinking of India's economic dependencies. Driver's revolt: "Impossible" toto cost sparks chaos

MI News Service, Kolkata: Toto and e-rickshaw drivers staged a massive demonstration at Dum Dum Cantonment Health Ground on Sunday morning, expressing strong resentment toward the state government's newly enforced Toto registration policy. The protesting drivers alleged that the imposed registration system demands exorbitant fees and recurring annual expenses—such as insurance, pollution certificates, renewal charges, and taxes—which they say are unbearable for economically vulnerable operators. Many argued that these mounting costs threaten their ability to sustain their daily livelihoods.

A large number of Totos and e-rickshaws participated in the agitation, with drivers claiming that the payment and registration process lacks transparency. They accused middlemen and brokers of exploiting the situation by collecting money without issuing proper receipts, raising concerns about corruption within the Motor Vehicles (RTO) office. According to the drivers, instead of providing regulatory clarity, the new system has widened opportunities for unfair practices and financial exploitation. Alongside economic grievances, drivers also voiced anger over what they described as routine police harassment on major routes such as VIP Road and Jessore Road. They accused officers of stopping them arbitrarily while carrying passengers, making daily operations increasingly difficult. The recent protest follows several days of escalating agitation. On Friday, members of the E-Rickshaw Drivers Union affiliated with CITU intensified their movement by surrounding the Rajganj BDO

Their demonstration disrupted administrative work as they raised slogans demanding immediate relief. The union also organized a large procession that received strong support from the broader Toto driver community. Collectively, the drivers urged the government to intervene urgently and revise the registration policy to reduce the financial burden and protect their livelihoods

medical college in Lucknow but died on the way, officials said. Confirming the incident, Divisional Forest Officer (DFO) Ram Singh Yadav told PTI that the attack took place between 5 PM and 6PM near the sugarcane fields of Mallahan Purwa village, close to the Ghaghara river. "The child succumbed to his injuries while being taken to Lucknow for treatment. Postmortem formalities are being completed, after which the financial assistance sanctioned by the government will be provided to the family," the DFO said, adding that the pug marks of a wolf were found at the spot where the child was found. A search operation has been launched in the area using specialised teams and drones, and three cage traps have been installed near the village, Yadav said. He said that nine people, including seven children, have been killed and 32 injured in wolf attacks in Kaisarganj and Mahsi tehsils since September 9. Chief Minister Yogi Adityanath visited the area on September 27 and ordered that wolves attacking humans must be safely rescued, and if capture was not possible, they should be shot. Since September 28, the forest department shooters have shot four wolves.

MI News Service, Kolkata: The sit-uation in Falta has sharply escalated after Leader of the Opposition Suvendu Adhikari issued a serious allegation that a planned attack may be underway targeting the Election Commission's special inspection team. His claim comes at a time when allegations of dead voters' names being inserted into the rolls have triggered intense scrutiny in the region.

BENGAL: Liquor prices to rise after hike in excise duty MI News Service, Kolkata: Liquor prices

in Bengal could increase by 10 to 40 from next month following a notification from the state excise department. This revision mandates higher rates of additional excise duty on both Indian Made Foreign Liquor (IMFL) and country liquor.

Industry sources said that distributors and wholesalers across the state have been told to clear existing stock at old prices by November 30, and any unsold inventory post-deadline must be sold under the new pricing structure, with the compulsory application of a new Maximum Retail Price (MRP) sticker.

While the new labels are vet to be registered, sources said that prices of standard 180 ml bottles could increase by 10 to 20 and 750 ml bottles could increase by as much as 40 per bottle. "There will



be more clarity when the new prices come in by this month-end," a distributor said.

The increase in excise duty comes ahead of the peak sales period in December and January. Moreover, with the GST rate reforms, the tax on most goods and services has been brought under the 5 and 18 per cent tax brackets, leading to a loss in revenue for the state.

Centre gives nod to Adani's Rs 136 Cr plan

MI News Service, New Delhi: The Union ministry of environment, forest and climate change has granted clearance for Adani Airport Holdings Ltd's Rs 136 crore plan to build a five star hotel inside the Thiruvananthapuram International Airport, a project spread across a little over 8,000 sq m and designed to house 240 rooms with food and beverage fa-

cilities offering 660 seats. Officials said the approval followed a detailed examination by the Expert Appraisal Committee Infra 2 during its August meeting. The land was handed over to the Adani Group's airport subsidiary under a long term concession agreement signed with the Airports Authority of India in January 2021. The ministry recorded that the proposed hotel will be a five storey structure with a height of 23 metres.

It will include two basement levels for parking, a ground floor and four upper floors, with a total built up area estimated at nearly

34,000 sq m. Authorities have been informed that the project intends to meet about half of its daily water requirement through recycling, using treated water generated by an on site sewage treatment plant.

Transport, too, is now a thriving sector, with hundreds of trucks moving in and out of the town carrying raw materials and finished goods.

Court extends Anmol Bishnoi's custody till Dec 5

MI News Service, New Delhi: New Delhi: A Delhi court extended the NIA custody of deported gangster Anmol Bishnoi for seven more days. Special Judge Prashant Sharma ordered the extension till December 5 in the hearing conducted at the NIA headquarters amid high security. Wanted in connection with the killing of NCP leader Siddique, firing at actor Salman Khan's residence in April 2024, the killing of Punjabi singer Sidhu Moosewala, among other crimes, Anmol was "removed" from the US on November 18. He was detained in the US in Nowas vember last year.

Earlier on November 19, Anmol, the brother and close aide of gangster Lawrence Bishnoi, was sent to 11 days of NIA custody. Absconding since 2022, USbased Anmol is the 19th accused to be arrested for his involvement in the terrorgangster syndicate led by his jailed brother Lawrence.

INDIA & INDONESIA to boost defence cooperation

MI News Service, New Delhi: India and Indonesia reiterated the importance of maintaining a free, open and peaceful Indo-Pacific, guided by international law and respect for sovereignty, against the backdrop of China's growing assertiveness in the region. In their wide-ranging talks, Defence Minister Rajnath Singh and his visiting Indonesian counterpart Sjafrie Sjamsoeddin also broadly agreed to set up a joint defence industry cooperation committee to ensure bilateral collaboration in areas of transfer of military technologies and

for supply-chain linkages. India's experience in submarine development and supmanagement, including Scorpene-class submarine programme, was acknowledged as highly valuable for Indonesia's future plans, the defence ministry said. 

WAQF: SC agrees to hear pleas for extension of time

MI News Service, New Delhi: The Supreme Court agreed to hear on December 1 various pleas, includ-ing the one filed by All India Muslim Personal Law Board, seeking extension of time for the mandatory registration of all waqf properties, including 'waqf by user', under the UMEED portal. A bench comprising Justices Dipankar Datta and Augustine George Masih took note of the submissions of lawyer Fuzail Ahmad Ayyubi, appearing for one of the petitioners, that the pleas needed to be listed for hearing urgently. "List these applications along with I.A. No...on December 01, 2025," the bench said. Besides All India Muslim Personal Law Board (AIMPLB), AIMIM leader Asaduddin Owaisi and various others have moved the top court, seeking extension of time for mandatory registration of all waqf properties.

Earlier, a lawyer had said the six-month period for the mandatory registration of waqf was nearing its end. In an interim order on September 15, the top court put on hold a few key provisions of the waqf (Amendment) Act, 2025, including a clause that only those practising Islam for the last five years could create waqf, but refused to stay the entire law, outlining the presump-



tion of constitutionality in its favour. It also held the Centre's order to delete the 'waqf by user' provision in the newly amended law was prima facie not arbitrary and the argument that waqf lands would be grabbed by governments held "no water". 'Waqf by user' refers to a practice where a property is recognised as a religious or charitable endowment (waqf) based on its uninterrupted long-term use for such purposes, even if there isn't a formal, written declaration of Waqf by

the owner.

The Centre launched the Unified Waqf Management, Empowerment, Efficiency and Development (UMEED) Act central portal on June 6 to create a digital inventory after geo-tagging all waqf properties. According to the mandate of the UMEED portal, details of all registered waqf properties across India are to be mandatorily

Should shift to conser vation-led water stra tegy: JAL SHAKTI MIN



MI News Service, New Delhi: Jal Shakti Minister C. R. Paatil said building new dams was no longer a feasition due to high costs, land acquisition hurdles and shrinking river flows. He urged states to align with the Centre's conservation-driven approach.
"We all know water gives

life, but it also gives destruction when we fail to manage it," Paatil said at the inauguration of the Ministry of Jal Shakti's two-day summit on 'Vision for Sujalam Bharat'. Noting India's persistent water imbalance, he said, "We have 18 per cent of the world's population and livestock, but only 4 per cent of global freshwater resources. We need water every moment, but we have not been able to organise it properly." Paatil argued that large dams were becoming impractical. "We have more than 6,500 dams, but we still store only about 750 BCM of water. It takes 25 years and Rs 25,000 crore to build a dam. Do we have that much time? Do we have that much money?" he said. He added that high costs, acquisition delays and declining river flows were major obstacles. He said the government had shifted focus to water conser-

"Government alone cannot do this. Water is not just a state subject, but it is the responsibility of all of us," he said. He urged officers to prioritise work over positions. "Put your talent to national service," he said. "If you put your vision on the ground, you can do great work." Min-ister of State for Jal Shakti Raj Bhushan Choudhary said India's groundwater status demanded urgent intervention, with nearly 29 per cent of assessed units falling into 'over-exploited' or 'critical' categories. He cited steep de-Haryana.

'These realities call for a cohesive, science-driven, and sustainable water management strategy," he said. He added that conservation and artificial recharge were central to the government's water-security plan, with initiatives such as the Jal Shakti Abhiyan and JSJB turning water stewardship into "a shared national responsibil-

Choudhary said the 'Catch the Rain' campaign had delivered "extraordinary results", reporting 1.94 crore water-related works since 2019 and mobilising more than four crore youth. He also pointed to health improvements linked to Namami Gange. Better water quality in Uttar Pradesh and Bihar, he said, had reduced diarrhoea, dysentery and enteric fever cases. "Water security is not only an environmental or economic issue. It is a matter of dignity, health and social equity," he said. Minister of State V. Somanna said India must combine traditional knowledge with modern tools to secure long-term water availability

Crash: Indian, American investigators tussle over probe

MI News Service, Ahmedhabad: The investigation into the Ahmedabad-London Air India crash has been "marked by points of tension, suspicion and poor communication" between senior Indian officials leading the probe and the US experts assisting them, according to a report in The Wall Street Journal.

The flashpoint came when two US National Transportation Safety Board (NTSB) specialists landed in New Delhi in late June. Indian authorities had arranged for them to take a late-night military flight to a "remote" facility to analyse the jet's flight-data and cockpit-voice recorders, according to the WSJ. Researchers find how eye ultrasounds help detecting brain shunt failure in children

WASHINGTON: A recent study suggests that using an ocular ultrasound in the emergency room could help detect children with brain drainage tube failure quickly and safely.

Research presented at the Pediatric Academic Societies (PAS) 2024 Meeting in Toronto.

A ventricular shunt is a small

plastic tube that is surgically placed to drain excess fluid and relieve pressure on the brain. Ventricular shunts are used on children to treat hydrocephalus, a disorder caused by improper brain fluid drainage or absorption from tumors, brain bleeds, and other sources. According to specialists, within two years following implantation, about 30% of shunts break, become misplaced, or become clogged, and an additional 5% fail annually after that.

When a patient visits the emergency department for potential shunt failure, their symptoms are often nonspecific, including headache, vomiting, and fatigue,



according to researchers. Shunt failure is life threatening, and children with shunts typically undergo multiple computed tomography and magnetic resonance imaging scans per year, exposing them to excessive radia-tion and sedation. A backup of fluid causes the optic nerve sheath

to swell, which researchers can measure with eye ultrasound.

The study found that comparing the diameter of the optic nerve when a patient is symptomatic to the diameter when they are well can help determine if a shunt is

"The research team is interest-

ed in finding ways to lessen radiation exposure and expedite diagtion exposure and expedite diagnosing shunt failure in the emergency department," said Adrienne L. Davis, MD, MSc, FRCPC, pediatric emergency medicine research director at The Hospital for Sick Children (SickKids) and presenting author. "The study uses patients as their own controls by measuring the ontic nerve by measuring the optic nerve when well and sick--a strategy that individualizes this test for every patient and recognizes that every patient and recognizes that every patient with a shunt has a unique degree of shunt depend-ence and ability to tolerate high

brain pressures."

The researchers studied 76 pairs of eye ultrasounds of nearly 60 children presenting to the Toronto hospital's emergency department with potential shunt failure. HEIDELBERG, GERMANY : Fatty chronic liver inflammation and can possibly result in liver cancer. Scientists at the German Cancer Research Centre (DKFZ) and the University of Tubingen have demonstrated in mice that intermittent fasting on a 5:2 schedule can block this progression.

Fasting lowers the development of liver cancer in mice who already have liver inflammation. The researchers discovered two proteins in liver cells that are both responsible for the beneficial effect of fasting. An approved medication can partially replicate

The animals were fed with a high-sugar and high-fat diet correspondind to the typical Western diet. One group of mice had constant access to the food. As expected, these animals gained weight and body fat and developed chronic liver inflammation.

The mice in the other group were given nothing to eat on two days a week (5:2 intermittent fasting, or 5:2 IF for short), but were allowed to eat as much as they wished on the other days. Despite the high-calorie diet these animals did not put on weight, showed fewer signs of liver disease and had lower levels of biomarkers that indicate liver

Vitamin D medicine do not protect children from bone fractures: Study



large clinical research sponsored by Queen Mary University of London and the Harvard T.H. Chan School of Public Health discovered that vitamin D supplementation do not strengthen bone strength or prevent bone fractures in vitamin D-deficient youngsters. The findings call into question widely held beliefs about vitamin D's benefits on bone health.

Around one-third of children have at least one fracture before the age of 18. This is a major global health issue, as childhood fractures can lead to life years of disability and/or poor quality of life. The potential for vitamin D supplements to improve bone strength has attracted growing interest in recent years, based on vitamin D's role in promoting bone mineralisation. However, clinical trials designed to test whether vitamin D supplements can prevent bone fractures in children have not previously been con-

Working with partners in Mongolia, a setting with a particularly high fracture burden and where vitamin D deficiency is highly prevalent, researchers from Queen Mary and Harvard conducted a clinical trial to determine if vitamin D supplementation would decrease risk of bone fractures or increase bone strength in schoolchildren. The study, published today (1 December) in Lancet Diabetes & Endocrinology, is the largest randomised controlled trial of vitamin D supplemen-

tation ever conducted in children. Over the course of three years, 8,851 schoolchildren aged 6-13 living in Mongolia received a weekly oral dose of vitamin D supplementation. 95.5% of participants had vitamin D deficiency at baseline, and study supplements were highly effective in boosting vitamin D levels into the normal range. However, they had no effect on fracture risk or on bone strength, measured in a subset of 1,438 participants using quantitative ultra-

The trial findings are likely to prompt scientists, doctors and public health specialists to re-consider the effects of vitamin D supplements on bone health.

Dr Ganmaa Davaasambuu, Associate Professor at the Harvard T.H. Chan School of Public Health, said:

"The absence of any effect of sustained, generous vitamin D supplementa tion on fracture risk or bone strength in vitamin D deficient children is striking. In adults, vitamin D supplementation works best for fracture prevention when calcium is given at the same time - so the fact that we did not offer calcium alongside vitamin D to trial participants may explain the null findings from this study.

Professor Adrian Martineau, Lead of the Centre for Immunobiology at Queen Mary University of London, added:

"It is also important to note that children who were found to have rickets during screening for the trial were excluded from participation, as it would not have been ethical to offer them placebo (dummy medication).

Thus, our findings only have relevance for children with low vitamin D status who have not developed bone complications. The importance of adequate vitamin D intake for prevention of rickets should not be ignored, and UK government guidance recommending a daily intake of 400 IU vitamin D remains important and should still be followed."

Researchers find link between adverse childhood experiences, muscle dysmorphia

dolescents and young adults who had adverse childhood experiences (ACEs) prior to the age of 18 were shown to have a much higher likelihood of exhibiting signs of muscle dysmorphia, according to a recent study.

The findings were published in the Clinical Social

These new findings emphasize the need for greater understanding of the relationship between muscle dysmorphia, or the pathological pursuit of muscularity, and adverse childhood experiences (such as emotional abuse, sexual abuse, and domestic violence), as prior research has shown that over half of North American children and adolescents experience at least one adverse childhood experience in their lifetime.

Those who experience adverse childhood experiences may engage in the pursuit of muscularity to compensate for experiences where they once felt inferior, small, and at risk, as well as to protect against future victimization," says lead author Kyle T. Ganson, PhD, MSW, an assistant professor at the University of Toronto's Factor-Inventash Faculty of Social Work. "The experience of adverse childhood experiences may also increase body dissatisfaction, specifically muscle dissatisfaction, which is a key feature of muscle dysmorphia." Previous studies have



shown that adverse experiences in childhood can lead to harmful health effects. While prior research has demonstrated that adverse childhood experiences are highly common in people with eating disorders and body dysmorphic disorder, few studies have looked at the association between adverse childhood experiences and muscle dysmorphia.

The study's researchers analyzed data from over 900 adolescents and young adults who participated in the Canadian Study of Adolescent Health Behaviors. In total, 16% of participants who experienced five or more adverse childhood experiences were at clinical risk for muscle dysmorphia, underscoring the significant traumatic effects that such experiences can have on mental health and well-

"Importantly, our study found that gender was an important factor in the relationship between adverse childhood experiences and muscle dysmorphia symptoms," says Ganson. "Boys and young men in the study who have experienced five or more adverse childhood experiences had significantly greater muscle dysmorphia symptoms when compared to girls and young women.

The authors note that boys and young men who experience adverse childhood experiences may feel that their masculinity was threatened from these experiences. Therefore, they engage in the pursuit of muscularity to demonstrate their adherence to masculine gender norms such as dominance, aggression, "Ît is important for health care professionals to

Sleep, are also present when awake in patients with epilepsy and may protect against the condition's heightened brain excitability, according to a new study led by UCL researchers.

The research, published in Nature Communications and involving the National Institute for Health and Care Research (NIHR) UCLH Biomedical Research Centre, examined electroencephalogram (EEG) scans from electrodes in the brains of 25 patients with focal epilepsy (a type of epilepsy characterised by seizures arising from a specific part of the brain), while they carried out an associative memory

The electrodes had been placed in the patients' brains to localise abnormal activity and inform surgical treat-

During the task, participants were presented with 27 pairs of images that remained on a screen for six seconds. The images were in nine groups of three - each group featuring a picture

ber which images had been grouped together. EEG data were recorded continuously throughout the task.

After reviewing the EEG data, the team found that the brains of people with epilepsy were producing slow waves - lasting less than one second - while they were awake and taking part in the task

The occurrence of these "wake" slow waves increased in line with increases in brain excitability and decreased the impact of epileptic spikes on brain activity

In particular, there was a decrease in the "firing" of nerve cells, which the researchers say could protect against epileptic activity.

As part of the research, the team also wanted to test if the occurrence of "wake" slow waves had any negative effects on cognitive function.

During the memory researchers found that the slow waves reduced nerve cell activity and so affected cognitive performance - increasing the length of time required by patients to complete the task.

The team reported that for each increase of one slow wave per second, the reaction time increased by 0.56 seconds.

Professor Walker said: "This observation suggests that the cognitive difficulties - in particularly, memory deficits - experienced by individuals with epilepsy may be attributed, in part, to the brief impairments induced by these slow waves.

The team hope that future studies will be able to increase such activity as a potential novel treatment for people

Meditation training can support wellbeing in older people: Research

n 18-month meditation pro-Agramme can increase the well-being of older persons, according to a new randomised controlled trial led by an international team co-direct-

The findings, published in PLOS ONE, show that meditation can improve people's awareness, connec-

tion to others, and insight. While the meditation training did not confer significant benefits on two commonly used measures of psychological wellbeing and quality of life, the researchers say their findings may reveal limitations in existing methods

of tracking wellbeing. Lead author Marco Schlosser (UCL Psychiatry and University of Geneva) said: "As the global population ages, it is increasingly crucial to understand how we can support older adults in maintaining and deepening their psychological wellbeing. In our study, we tested whether long-term meditation training can enhance important dimensions of wellbeing. Our findings suggest that meditation is a promising nonpharmacological approach to support human flourishing in late life.

The study is the longest randomised meditation training trial conducted to date, and explored the impact of an 18month meditation programme on the psychological wellbeing of more than 130 healthy French-speaking people aged 65 to 84. The study, led by Principal Investigator Professor Gael Chetelat, took place in Caen, France. It was conducted by the European Union's Horizon 2020-funded Medit-Ageing (Silver Sante Study) research group which involves UCL, Inserm, University of Geneva, Universite de Caen Normandy, Lyon Neuroscience Research Center, University of Liege, Technische Universitat Dresden, and Friedrich Schiller University Jena.

The researchers compared a meditation programme, which included a nine-month mindfulness module followed by a nine-month loving kindness and compassion module, delivered by weekly group sessions (two hours long), daily home practice (at least 20 minutes), and one retreat day, with a



group that did English language training (as a comparison group) and a nointervention control group.

The team found that meditation training significantly impacted a global

score that measures the wellbeing dimensions of awareness, connection, and insight. Awareness describes an undistracted and intimate attentiveness to one's thoughts, feelings, and

sense of calm and deep satisfaction. Connection captures feelings such as respect, gratitude, and kinship that can support more positive relationships with others. Insight refers to a selfknowledge and understanding of how thoughts and feelings participate in shaping our perception - and how to transform unhelpful patterns of thought relating to ourselves and the world. The benefits of meditation training to an established measure of psychological quality of life were not superior to English language training, while neither intervention significantly impacted another widely used measure of psychological wellbeing. The researchers suggest this may be because these two established measures do not cover the qualities and depth of human flourishing that can potentially be cultivated by longerterm meditation training, so benefits to awareness, connection and insight are missed. The programme did not benefit everyone equally, as participants who reported lower levels of psychological wellbeing at the start of the trial showed greater improvements compared to those who already had higher levels of wellbeing.

Co-author Dr Natalie Marchant (UCL Psychiatry) said: "We hope that further research will clarify which people are most likely to benefit from meditation training, as it may confer stronger benefits on some specific groups. Now that we have evidence that meditation training can help older adults, we hope that further refinements in partnership with colleagues from other research disciplines could make meditation programmes even more beneficial.'

Senior author Dr Antoine Lutz (Lyon Neuroscience Research Center, Inserm France) said: "By showing the potential of meditation programmes, our findings pave the way for more targeted effective programmes that can help older adults flourish, as we seek to go beyond simply preventing disease or ill-health, and instead take a holistic approach to helping people across the full spectrum of human wellbeing.

While lower than the 11,746 cases reported in September and the 14,363 recorded in August, the figure remains one of the highest monthly admissions on record. Shahalibanda blast: Police probe finds gas leak in store, dismiss rumours

of IED, LPG blast



MI News Service, Hyderabad: The Hyderabad police maintained that the explosion at Gomathi Electronics at Shahalibanda, which killed two people, was triggered due to a gas leak from an electronic item stored inside and dismissed rumours of an IED or LPG blast.

South Zone deputy commissioner of police (DCP), Kiran Khare, told reporters that after the deinvestigation revealed that the explosion was a result of a gas leak from either a water dispenser or a refrigerator stored inside the electronic store. "There were 15 -20 refrigerators in the store. The leaked gas triggered a huge fire and subsequent explosions in the store. Hence, the information that the explosion was caused by an IED or LPG blast is

false," the DCP said. Two people, store owner Shiva Kumar Bansal and a two-wheeler biker, Sajjad Ali, were killed. Eight others suffered injuries. The fire engulfed the two-floor building. The stored goods were completely gutted, while a car, an auto rickshaw, and two scooters were damaged.

U.S. freezes all asylum decisions as suspect in National Guard shooting charged



MI News Service, Washington: U.S. officials on Friday announced a freeze on all asylum decisions as the man of Afghan nationality accused of shooting two National Guard members near the White House was charged with first-degree murder following one soldier's death.

U.S. Citizenship and Immigration Services (USCIS) Director Joseph Edlow said Friday on X that his agency "has halted all asylum decisions until we can ensure that every alien is vetted and screened to the maximum degree possible.'

At the same time, U.S. Secretary of State Marco Rubio announced that the Department had State paused visa issuance for all individuals traveling on Afghan passports, saying the measure was implemented immediately as part of efforts to safeguard national

security.

The case prompted the moves after U.S. Attorney for the District of Columbia Jeanine Pirro said the charges against the suspect-- a 29year-old Afghan national, Rahmanullah Lakanwal-had been upgraded to firstdegree murder following the death of one National Guard soldier and the critical injury

of another shot on Wednesday near the White House. U.S. President Donald

Trump announced the soldier's death on Thursday, calling the shooting "an act of terror." He also vowed to permanently pause migration from all Third World Countries to allow the U.S. system to fully recover." The USCIS said on

Thursday that it would reexamine green card holders from 19 "countries of conincluding Afghanistan. Pirro said Lakanwal would be charged with one count of first-degree murder and two counts of assault with intent to kill while armed. Lakanwal was shot by another Guard member and taken into custody. Investigators said he had driven from his home in Washington state to the capital before the shooting, though a motive has not yet been established.

Lakanwal entered the United States in 2021 under then-President Joe Biden's Operation Allies Welcome program. He had worked previously with the CIA in Afghanistan and was described by officials as having been "clean on all checks" before working with the CIA and before moving to the United States.

UN chief reiterates call for irreversible progress toward two-state solution

MI News Service, United nations: UN Secretary-General Antonio Guterres on Saturday reiterated his call for irreversible progress toward a two-state solution, in a message on the International Day of Solidarity with the Palestinian People. This year's International Day of Solidarity with the Palestinian People, which is observed annually on Nov. 29, comes after two years of horrific suffering in Gaza, and the start of a muchneeded ceasefire, Guterres said.

Noting that survivors are mourning the deaths of tens of thousands of friends and family; hunger, disease and trauma run rampant; injustice also continues in the occupied West Bank, including East Jerusalem; and hundreds of humanitarians have been killed, the



UN chief said: "In so many ways, this tragedy has tested the norms and laws that have guided the international community for generations." "The killing of so many civilians, the repeated displacement of an entire population and the obstruction of humanitarian aid should never be acceptable under any circumstances," he underscored.

As the recent ceasefire offers "a glim-

mer of hope," "it is now vital that all parties respect it fully and work in good faith towards solutions that restore and uphold international law," the UN chief stressed, adding that lifesaving humanitarian aid must be allowed to enter Gaza at scale, and the international community must continue to stand firmly with UNRWA, the UN relief agency for Palestinians. "I repeat my call for an end to the unlawful occupation of the Palestinian Territory ... and for irreversible progress towards a two-State solution, in line with international law and relevant UN resolutions. with Israel and Palestine living side by side in peace and security within their secure and recognized borders, on the basis of pre-1967 lines, with Jerusalem as the capital of both States," Guterres said.

China kicks off title defense with comfortable win at ITTF Mixed Team World Cup



CHENGDU (CHINA) : Two-time winner China clinched an 8-1 victory over Hong Kong, China in their opening encounter as the 2025 International Table Tennis Federation (ITTF) Mixed Team World Cup kicked off in Chengdu on Sunday.

Olympic champions Wang Chuqin and Sun Yingsha earned China a three-game lead after sweeping Wong Chun Ting and Doo Hoi Kem 12-10, 11-8, 12-10 in the mixed doubles.

As each match only consists of three games, every point is more important in this tournament," said men's world No. 1 Wang Chuqin. "We had trailed in the match but gradually adjusted ourselves to bounce back.

"We met Wong and Doo many times in the last Olympic cycle, and we are familiar with each other. They played really tough, and we felt much better after narrowly winning the first game,"

Kuai Man moved China further ahead after triumphing 11-4, 11-9, 9-11 over Zhu Chengzhu in the women's singles, and Lin Shidong sealed the victory with an 11-3, 11-4, 11-1 victory over Lam Siu Hang in the men's singles, reports

The eight-day ITTF Mixed Team World Cup adopts a different competition format from other team events, beginning with mixed doubles, followed by women's singles and men's singles, and then men's and women's doubles if required, with their order of play determined by the team captain of the lower-ranked team. Each individual match consists of three games, resulting in either a 3-0 or 2-1 scoreline. Team matches continue until one side secures eight game victories.

The tournament was inaugurated in 2023, and China has won the past two editions. Since the mixed team event was included at the 2028 Los Angeles Olympic Games earlier this year, teams would attach greater importance to the Mixed Team World Cup in their Olympic preparations.

Also on Sunday, South Korea defeated Sweden 8-3, Chinese Taipei cruised past the United States 8-3, and Egypt edged Chile 8-7 in a five-match thriller.

Sixteen teams are divided into four groups, with China drawn into Group 1 alongside China's Hong Kong, Egypt, and Chile. China faces Egypt on Monday.





BHARATH CLASSIC GUJARAT: THAILAND'S POOSIT CLINCHES TITLE WITH BIRDIE ON FINAL HOLE, BAISOYA FINISHES THIRD



AHMEDABAD Supupramai of Thailand won the inaugural \$500,000 Bharath Classic Gujarat, finishing one shot ahead of aggressive Korean Woo-young Cho at Kensville Golf Resort near Ahmedabad on Sunday. Poosit (69) birdied the 18th and final hole of the day to hold off Wooyoung Cho (65), even as Sachin Baisoya dominated Kensville Golf Resort with a 10-under 62. His impressive round included two remarkable birdie streaks - one with six consecutive birdies and another with four in a row.

His brilliant performance on the final day saw him tied for third place, making him the best Indian finisher at the event cosanctioned by the Asian Tour and the Indian Golf Premier League (IGPL). Poosit's final round of 69 secured his first Asian Tour victory, finishing with a total score of 18-under par 270. Cho (65) ended just one shot behind on 17-under 271. Poosit also earned the Asian Tour card with this win.

Baisoya, a frequent participant on the IGPL Tour yet still seeking his first victory, was tied for the lead at 15-under par with leader overnight Janewattananond, as well as Thailand's Panuphol Pittayarat and Ekpharit Wu. Although an Indian win was not achieved, it was still a successful week for them, with four players finishing in the Top-10 and a total of eight in the Top-20.

As Baisoya finished third, Yuvraj Sandhu, a multiple winner at his home course, significantly improved his chances on the Asian Tour with a seventhplace finish, scoring 14 under Ahmedabad Amateur Ishaan

Chawhan, who had an impressive week, couldn't maintain his early momentum and shot 71, though he remained under par throughout all four rounds. With a score of 13-under, he

was tied for eighth place alongside IGPL Order of Merit leader Aman Raj, who shot 68, and two Thai players, Settee Prakongvech with 68 and Chonlatit Chuenboonngam with Pukhraj Singh Gill (69) was tied for 12th place at 12-under par, while Ajeetesh Sandhu (69) and Khalin Joshi (66) were tied for 17th at 11-under par. Saptak Talwar (66) was tied for 19th.

The first US\$500,000 Bharath Classic was jointly sanctioned by the Asian Tour and the Indian Golf Premier League (IGPL) Tour. The IGPL has three additional events scheduled for 2025, while it was the second-tolast tournament of the season on the Asian Tour. This week was crucial for

players aiming to improve their position on the Asian Tour's Order of Merit to secure spots for the next year. Additionally, the top four on the IGPL will earn entry into the final stage of the Asian Tour Q-School and qualify for the 2026 International Series The soft-spoken Poosit, whose top finish on the Asian

Tour was sharing third place at last year's SJM Macao Open, said, "Amazing, I can't believe it. I was struggling on the front nine; I was not playing well. It was all about mindset - that got me through. "I came here to try and

improve my ranking on the Merit list. It was on my mind, not winning. But to secure my card this week with the win, it's beyond my dreams. "Before the last two tourna-

ments, I changed the loft and lie on my putter. It made such a big difference - I started holing The highlight of the day, how-

ever, came from Sachin Baisoya who shot a bogey-free 62 on Sunday. Starting from the 10th tee with the shotgun start system used over the final two days here, Baisoya began with six consecutive birdies to reach the turn at this par-72 course on 6 under 30.

On the front nine, he continued his impressive streak with four consecutive birdies from holes two to five, followed by two crucial par saves on holes 18 and one. "I owe this round a lot to my iron play today," Sachin said

"I practised for about an hour esterday as I felt I was hitting my irons badly for the last three or four tournaments. I also took some coaching from Sudhir Sharma, who told me not to worry and just play my natural

"So the plan was to try something different today from the first four days, and that is exactly what happened today from the start. Most of my shots landed between three and five feet, and also my putting was very solid."

The modest Chawhan mentioned that his four days here felt like an extended golf lesson. The 22-year-old left-handed player, who was sidelined for over two years due to injuries, said, Playing with all the Asian Tour players, watching them and talking to them has been a learning experience.

"I went in with the mindset that I had nothing to lose save making a point to myself. I was away from golf for different phases, which added up to oneand-a-half years, with injuries to the wrist and knee, and this is my first full season in four

On what helped him bring in impressive cards of 67, 69, 68, and 71 this week, Chawhan said, Even though I play here regularly, the course was set up differently from what we get as amateurs, and that was a challenge. For me, the highlight of the week has to be my iron play as the other aspects of my game weren't that great."

Asked what he was planning to do next, the Vijay Divecha trainee added, "I might turn pro, but will have a talk with my coach first. Right now, the focus is on the All-India Amateur (in mid-December) at Tollygunge Club.'

Sandhu, too, was pleased at his display here. "I started slowly (level par 72 on Thursday), but after that the momentum was good.

He added, "But for a few shots and putts that I left out there, I could have been in much closer contention (at 14 under, five shots behind winner Poosit) than I was."

Happy if that's what's needed to win: Head ready to open again in Khawaja's absence

NEW DELHI: Australia's Travis Head said that he's more than willing to remain at the top of the order after his blistering century in the first Ashes Test. His remarks come as questions linger over Usman Khawaja's fitness and long-term place in the nation-

Head, Australia's established No. 5 for much of the past four years, stepped in as opener during the second innings in Perth when Khawaja was sidelined with back spasms. He responded with a superb 123 off 83 balls, driving Australia to a rapid chase of 205 and a 1-0 series lead ahead of Thursday's Test at the

Khawaja, who turns 39 next month, has been named in the 14-man squad and insists he is "confident" of being available. But with only one century and an average of 31.84 over the past two years, his spot is far from assured.

Head said his role for the next Test had not yet been defined, but added that he is comfortable with whatever responsibility he's given, including another stint at the top.

"I'm happy. If that's what is needed to win a Test match and if that's what's required then, yeah, I'm fine with it. I'm preparing for anything at this stage... There's a fair bit to work through. I've just got here. We haven't really had many conversations over the last week.

"It's been about just spending some time out of the game as much as you can. You don't get much time to chill out in a massive series like this, where it's pretty full-on every single day," Head was quoted as saying by The West Australian.

Australia coach Andrew McDonald revealed after the Perth Test that the team had even floated the idea of rotating their opening pair between innings, a tactic Head says he would willingly embrace.

Head explained that the concept has been on the table for some time. "We've talked about that a lot:



how you get there, and what personnel we have to be able to potentially do that and the personalities in the line-up," he said.

'You've seen it a little bit in the T20 team as well, where we're trying to push the boundaries in powerhitting, and [asking] do we take singles at certain stages... I feel like I can play in any role, so I'm open to it, and it's just trying to work out in-game and in moments when that may come out and when you may use that.

'All options are on the table and have been for a long period of time about where this team can potentially get better, and where there's opportunities to potentially win games of cricket in moments. It's always been on the table," Head added.
