## State Blames Centre for Soaring Egg Prices in West Bengal With the onset of winter, the price of poultry eggs usually rises slightly, but this year, the increase has broken all previous records. The cost of a pair of eggs has surged

to ₹15, prompting West Bengal Chief Minister Mamata Banerjee to directly blame the central government for the steep price hike. Speaking to the media, Banerjee argued that the primary feed for chickens and ducks, which is supplied to farms across the state, has been increased by the Centre by 12 per cent annually. She claimed that this systematic rise in feed prices has been directly responsible for pushing up the cost of eggs to unprecedented levels. "Why are egg prices rising so sharply?" asked Banerjee. "The main feed for poultry is being increased in price by 12 per cent every year by the central government. Those who talk loudly about eggs on social media should remember that we supply eggs to 12 other states. PG 3

# CM Mamata blames Amit Shah for being behind SIR 'ploy' in Bengal, says BJP dug its own grave

MI News Service, Malda: West Bengal Chief Minister Mamata Banerjee on Wednesday tore into the BJP over the Election Commission's rollout of the Special Intensive Revision (SIR) of electoral rolls barely three to four months before the Assembly polls, accusing Union Home Minister Amit Shah of "orchestrating" the exercise to unsettle voters and "capture West Bengal by trickery". Addressing a massive anti-SIR rally in Malda's Gazole on the first day of her two day visit to Malda and Murshidabad districts, Mamata Banerjee said the saffron camp had "miscalculated the pulse of Bengal" and ended up "digging its own grave" by pushing for a hurried revision process that triggered panic among citizens. "Home Minister Amit Shah is behind this ploy of implementing SIR when the electiuons are at the doorsteps", she al-

"Shah wants to capture Bengal by hook or by crook and at any cost. But remember, by doing SIR in Bengal, you have dug your own grave. Bengal and Bihar are not the same. You cannot win Bengal by cleverness and trickery," she thundered. She also alleged that the EC's November 4 rollout of SIR had unleashed "widespread fear", with people believing their names would be arbitrarily dropped from the voters' list. 'Till now, 39 ordinary citizens, including four BLOs, have died due to SIR panic, suicides included. We are helping their families. This trauma cannot continue," she added. Similar incidents, she claimed, had occurred in a number of other states as well.

Mamata Banerjee clarified that the

TMC was not opposing the revision itself but the "politically motivated haste". "We are not against SIR or census. But why the tearing hurry? A citizen again has to prove he is a citizen. Why?" she asked.

This has been done to disrupt Bengal's development work. They have blocked our dues, yet we are running schemes. Now they want to wreck

everything in the name of SIR," said Mamata Banerjee. Amid thunderous applausefrom the packed gathering, the Chief minister announced that from December 12, the TMC will set up statewide "May I Help You" camps to assist citizens when SIR hearings begin later this month. She also appealed to migrant workers to ensure tht they fill up their forms, warning that "names may be struck off if forms are not submitted". Ratcheting up her attack on the BJP's ideological thrust, Mamata Banerjee asserted, "We don't need to learn Hindutva from the BJP. I do not practise communal politics; I practise secular politics. I respect every religion. I will not allow unrest in Bengal." Without naming the BJP-led Union government, she fired a sharp warning, "You

think you can do everything with brute force? You want to create an Emergency-like situation? Remember, people speak the last word. People will not forgive you." "The BJP is like bed bugs; they bite till you remove them. They must be removed politically so Bengal is no longer harmed," she thundered. She also accused the Centre of withholding funds and said "We get only GST. All our tax money is taken away by the Centre. Bengal is supposed to get

on "humanitarian grounds" the entr of a pregnant Sonali and her young son into India, nearly six months after they were pushed into Bangladesh. Rs 1.87 lakh-crore. Now we hear even cigarette taxes will be taken. You have grabbed everything across India. Does it not shame you? And then you want to grab Bengal forcefully?" she said. Mamata Banerjee also referred to the case of Sunali (Sonali) Khatun, the pregnant woman and her child who were pushed into Bangladesh by the BSF earlier this year and whose return the Supreme Court allowed on humanitarian grounds on Wednesday.

"The court asked the Centre to bring back Sonali Khatun and vher 8 year old son . We fought the case," she said. "Sonali is an Indian citizen. Then why did the BSF push a pregnant woman to Bangladesh? Was it because she is Bengali? Is that why she was branded Bangladeshi and thrown across the border?", she asked. The Supreme court on Wednesday allowed

said, "As long as I am here, no Bengali will be pushed back or sent to a detention camp." The showdown over SIR comes as Went Bengal heads into its most polarised Assembly election in years, with the TMC framing the revision as a tool for intimidation and the BJP insisting it is a routine process.

For Chief minister Mamata Banerjee, the issue feeds into a larger narrative that the BJP is using institutional levers to unsettle linguistic minorities, weaken welfare delivery, and stir anxieties around citizenship. She, however, insisted that she was in Malda not to seek votes but to "stand by anxious citizens". "I have come not to ask for votes, but come to stand by you. Do not be afraid. No one will go to a detention camp. Your names will not be dropped. Bengal will remain safe," she thundered amid huge applause.

## Kashmir freezes as sub-zero temperatures drop further



MI News Service, Srinagar: The severe cold wave conditions intensified across the Kashmir valley as the minimum temperature dropped further below the freezing point on Wednesday with a thick layer of fog engulfing most parts of the upper riches of the Union Territory, official sources here said.

Srinagar recorded a low of minus 5.4 degree Celsius on Tuesday night, down from minus 3.5 degree Celsius the previous night, they said. As a result a thick blanket of snow and dense fog engulfed the entire capital city of Srinagar and other places in the valley, especially around water bodies including the famous Dal lake. Most of the streets in the city look deserted as majority of population preferred to remain indoors because of the harsh weather condition, while very few people were seen warming themselves with

#### SC allows Sonali Khatun and her child's entry into India from Bangladesh on 'humanitarian grounds' and maintained that they were

MI News Service, New Delhi : In a landmark decision , the Supreme Court purely on "humanitarian grounds" on Wednesday allowed the entry of a pregnant woman and her eight-year-old child into India, months after they were detained in Bangladesh after they were pushed back from Delhi. A bench of Chief Justice Surya Kant and Justice Joymalya Bagchi asked the West Bengal government to take care of the minor and directed the Chief Medical Officer of Birbhum district to provide all possible medical assistance to the pregnant woman Sonali Khatun, including free of cost delivery at a good hospital. . The bench



noted the submission of Solicitor General Tushar Mehta, appearing for the Centre, that the competent authority has agreed to allow the

woman and her child back into the country purely on humanitarian grounds without prejudice to rights and contentions, and they would be kept under surveillance. The top court said they would eventually be brought back to Delhi from where they were picked up and deported to Bangladesh.

Senior advocates Kapil Sibal and Sanjay Hegde urged the court that there were others also, including Sonali's husband who are in Bangladesh and need to be brought back to India for which Mehta may seek further instruction. Mehta contended that he would be contesting their claim of being Indian citizens Bangladeshi nationals and it was only humanitarian grounds that the union government was allowing the woman and her child into India. The woman's father alleged that the families, working as daily wage earners in Sector 26 of the Rohini area in Delhi for over two decades, were picked up by police on June 18 on suspicion of being Bangladeshis and subsequently pushed across the border on June 27.The bench was hearing an appeal filed by the Union government challenging a Calcutta High Court direction to bring back

#### Mother buries newborn alive in Jalpaiguri, father arrested

MI News Service, Jalpaiguri: newborn was buried alive by his mother in Jalpaiguri's Rajadanga Gram Panchayat, triggering widespread outrage and a police probe. The disturbing incident unfolded in the Khaldhura Rickshaw area of North Majhagram under Krani block, where locals discovered the baby's lifeless body partially buried next to the family home around 8 a.m.

According to eyewitness accounts, Regina Begum, the mother, concealed her entire pregnancy, even reportedly tampering with a pregnancy test by using water. She gave birth to a son but immediately attempting to bury the newborn alive. Villagers intervened upon spotting the grim scene, but Regina fled the spot, allegedly placing the infant's body in a barn before absconding. The father, Ziyarul Haque, who reportedly left for business as usual that morning, has since been arrested by Kranti police. Local residents express shock and confusion over the incident, labeling the child's death as unusual and shrouded in mystery.

## **BCKV** baby corn study earns international spotlight across four Asian nations

Mohanpur: A baby corn agronomy study from Bidhan Chandra Krishi Viswavidyalaya (BCKV), Mohanpur, ȟas drawn international visibility after being presented across four Asian countries over the past two years. The research, conducted under the ICAR All India Coordinated Research Project on Maize, forms part of the M.Sc dissertation of young agronomist Mayukh Bhattacharyya, guided by agronomist Sonali Biswas.

The study, "Effect of Integrated Nutrient Management on Baby Corn in the New Alluvial Zone of West Bengal", examined how combined use of chemical fertilisers and organic amendments could raise productivity while improving soil health.

Field trials carried out during the 2023–24 rabi season assessed farmyard manure (FYM), green manure (Dhaincha) and recommended fertiliser doses in multiple combinations. Integrated nutrient treatments led to

index, biomass accumulation and nutrient uptake.

Baby corn yield (dehusked cob) nearly doubled over farmer-level practices, while fodder yield also saw a considerable rise. The most profitable treatment involved the recommended fertiliser dose with 15 t/ha FYM, which recorded the highest benefit-cost ratio. Soil organic carbon levels improved, indicating longterm sustainability potential

The findings were first showcased in Kuala Lumpur in 2023 at the 6th International Conference on Health Care and Allied Sciences, where Bhattacharyya received the Best Paper Presenter Award. During this period, he also taught agriculture at Lincoln University College, Malaysia.

In 2025, he represented India at the International Symposium on Sustainable Plantation Management in Colombo, with the presentation later published as a book chapter in the sympo-

The work was subsequently recognised at the World Congress on Climate Change and Its Effects in Kathmandu, where Bhattacharyya received the Innovative Young Researcher Award.

The next presentation is scheduled at the International Conference on Organic Agriculture 2025, to be held from November 26-28 at the SEAR-CA headquarters, University of the Philippines Los Baños.

Bhattacharyya has authored peer-reviewed papers, farmer-oriented publications and holds two Indian patents, an AI-based plant disease diagnostic tool and a UV-based pathogen-neutralisation device, reflecting his focus on translational agri-technology.

The multi-country dissemination of the BCKV study underscores the growing prominence of research emerging from eastern India's alluvial regions and aligns with a global shift towards soil health, integrated nutrient management and sustainable input

## **Bengal winter bites:** Temps plunge 4°C by weekend

Kolkata: West Bengal is bracing for a sharp winter surge as temperatures are set to fall by 2-4°C across the state by the end of the week, with dry and chilly conditions tightening their grip after Cyclone Dittoa's weakening and gradual fade-out along the coast. According to the Alipore Meteorological Department, the state will face an intensifying cold spell marked by dense morning fog, clearer afternoons, and no rainfall, thrusting Bengal into a sudden seasonal chill soon after Dittoa degraded into a depression nearly 40 km off the Tamil Nadu-Puducherry-Andhra

In South Bengal, Kolkata's minimum tempera-ture, recorded at 17.7°C on Wednesday, is expected to slide down to around 15°C by Friday and Saturday. The western districts will feel the drop even more sharply, with lows plunging to 11-12°C. Coastal belts will see an uptick in early-morning fog, while persistent north-westerly winds push night temperatures steadily downward, keeping condi-tions near normal for now but declining rapidly as the cold wave tightens. North Bengal will remain rain-free, continuing with an extended dry spell. Light fog is likely to blanket the mornings in Cooch Behar, Jalpaiguri, and

Alipurduar, as well as in the foothill regions. The hills will experience harsher conditions: Darjeeling may hover around 6°C, while areas like Malda stay milder at around 17°C. Daytime warmth will be moderate, but evenings and nights will turn significantly colder. Adding to the chill, a western disturbance passing over Haryana on December 5 is expected to intensify the cold across eastern India. Though cyclonic activities over northwest India and systems forming near Assam are evolving, no rain is forecast for Bengal. Instead, a spell of unbroken, vigorous winter cold is set to grip both the plains and the hills with full force.

In a remarkable recognition of humanitarian service, Ambarish Nag Biswas, secretary of the West Bengal Radio Club (WBRC), has been selected for the inaugural "Amateur Radio Hero Award" by HamCation 2026, one of the world's largest amateur radio shows held annually in Orlando, Florida.

The announcement reached him early on Wednesday through an official email from Mike Banigan (KJ4UDO), Awards Chairman of HamCation Ambarish Nag Biswas said. The award, being introduced for the first time, honors an amateur radio operator who has gone "above and beyond" in offering communications support during disasters or moments of critical public need.

Amateur or ham radio is often mistaken as a hobby of antennas and call signs. But in Bengal, over the last decade, it has quietly evolved into an alternative communication backbone during cyclones, floods, missing-person searches, and other emergencies, largely due to the tireless efforts of WBRC.

Ambarish Nag Biswas has been at the center of this transformation.

During Cyclone Amphan, Yaas, and repeated storms along the Bay coast, when phone lines collapsed and towers buckled, ham radio operators under WBRC maintained uninterrupted communication between disaster zones, control rooms, and rescue teams.

His team has also played a role in reuniting a huge of lost persons, including children, with their families across India through their "Missing Persons Tracking Protocol".

"It is impressive learning about your efforts using amateur radio to support the community during times of need," Banigan wrote in the mail, notifying Biswas of the selection.

HamCation, sponsored by the Orlando Amateur Radio Club, is the second-largest amateur radio

Over the past years, multiple global research papers and academic presentations have documented WBRC's model of humanitarian ham radio operations, from cyclone communication architecture to emergency medical transport coordination. These have made the club a case study in how volunteer radio can augment modern disaster management

The award will be conferred on February 14, 2026, during the HamCation 2026 banquet. Public announcement of the awardees is scheduled on the programme Ham Nation at 9 PM EST on December 3 (Thursday morning in India).

Speaking after the announcement, Ambarish Nag Biswas said: "This is not my achievement alone. It is the recognition of Bengal and its people. Ham radio showed the world that even a hobby, when used for humanity, can save lives. We are proud of the work we have done, and want to do much more

He expressed gratitude to volunteers, government agencies, and citizens who have supported the club's mission, and appealed for continued encouragement as WBRC prepares to expand training, cyclone-zone communication units, and student

### Nadia farmer's efforts revive near-extinct 'Sankene' paddy variety



MI News Service, Tehatta: In a quiet corner of rural Bengal, a long-forgotten indigenous paddy variety is finding its way back to the fields. Lakkhan Pramanik, a farmer from Harekrishnapur village in the Hogolbaria police station area, has been recognised with the Plant Genome Saviour Farmer Award for conserving 'Sankene', a rice variety once on the verge of extinction in West Bengal. The award, instituted by the Union Ministry of Agriculture, is conferred on only three farmers nationwide each year.

Mr. Pramanik's interest in traditional agriculture began early. Over the past seven to eight years, he has been cultivating and


preserving rare crop varieties, including Sankene, with support from Bidhan Chandra Krishi Viswavidyalaya (BCKV), the Krishi Vigyan Kendra in Nadia and the 'Banglar Krishi' initiative. He has also been instrumental in promoting Govindobhog rice cultivation and local-level marketing.

Explaining the cultivation process, Mr. Pramanik notes that Sankene is suited to waterlogged fields and can be grown without chemical fertilisers. Its production cost remains relatively low, around Rs 2,500 to Rs. 3,000 per bigha, while the average yield per bigha is roughly four quintals. The rice, considered nutritionally rich, currently sells for about rupees 2,500 per quintal.

Mr. Pramanik applied for the national rec-

ognition in August 2023. The award was presented in November at the C. Subramaniam Convention Centre of the Indian Agricultural Research Institute in New Delhi, along with a cash prize of ₹1 lakh.

Commenting on the achievement, BCKV Vice-Chancellor Ashok Kumar Patra said that conserving traditional seed varieties is vital for future research and resilience. "Such initiatives from farmers at the grassroots level will significantly contribute to the preservation of biodiversity and encourage further scientific inquiry," he said.

#### Cal HC Grants Age **Relaxation for Non-Disqualified Non-Teaching Staff**

MI News Service, Kolkata: The Calcutta High Court has directed age relaxation for non-teaching staff, including Group C employees and clerks, allowing them to appear in upcoming examinations. The court emphasized that only candidates who are not "tainted" will be eligible for this benefit. Justice Amrita Sinha remarked that the School Service Commission (SSC) cannot deny age relaxation to candidates who are not disqualified and that such concessions must be provided in the next recruitment process. The petitioners, who participated in the 2016 recruitment process for non-teaching posts but did not pass, had approached the court after the process was cancelled due to allegations of corruption. The Supreme Court had previously ruled that candidates who are not "tainted" are eligible to sit for the exam and must During the hearing, Justice Sinha instructed the commission to identify non-disqualified candidates and publish the list, ensuring transparency. cutta High Court Division Bench on Wednesday delivered a verdict that secured the employment of 32,000 primary teachers in West Bengal, overturning a controversial previ-ous ruling. The decision was met with immediate and strong delight from Chief Minister Mamata Banerjee.Speaking to reporters in Murshidabad after concluding her Malda tour, the Chief Minister gave her first reaction: "This is very good news. I am extremely happy. The humanitarian aspect of the primary teachers' situation has been considered, and their families have been saved. I am satisfied."The job cancellation order was previously passed by former Justice Abhijit Gangopadhyay, who has since resigned from

the judiciary to join politics and is now a BJP MP. The Chief Minister refrained from commenting on the former judge directly, stating, "I have nothing to say about anyone. I am just happy that the primary teachers have received justice and their families are secure. "She further emphasized her government's priority: "Running to the court repeatedly and snatching people's jobs is wrong. Our job is to give jobs, not to take them away."The Division comprising **Fapabrata Chakraborty and Justice** Ritabrata Kumar Mitra, not only upheld the jobs but also observed that the earlier ruling by former Justice Gangopadhyay constituted an "unwanted interference in the judicial system."On this observation, the Minister maintained

Justice will take its own course. I am happy that the brothers and sisters who were employed have gotten their jobs back." Education Minister Reacts to the VerdictThe verdict was also hailed by the State's Education Minister, Bratya Basu. Shortly after the Division Bench order was pronounced, he posted on his X (for-merly Twitter) account, "After today's Division Bench order of the Hon'ble High Court, I congratulate the Primary Education Board. The Single Bench judgment has been cancelled. The jobs of 32,000 primary teachers remain fully pro-tected. Heartiest wishes to the teachers as well. Truth has prevailed."The recruitment process began in 2016 based on the 2014 (Teacher Eligibility Test). In

May 2023, the single bench led by former Justice Abhijit Gangopad-hyay had ordered the cancellation of 32,000 appointments, though the teachers were allowed to continue working temporarily. The court had directed the state to initiate a new recruitment process within three months. This directive was challenged by the Primary Education Board in the Division Bench. The case was heard by a bench of former Justices Subrata Talukdar and Supratim Bhattacharya, and later by the bench of Justices Chakraborty and Mitra. The hearing concluded on November 12, with the verdict reserved until today, Wednesday. The Division Bench's ruling has brought significant relief and joy to the 32,000 primary teachers and their families

## **State Blames Centre for Soaring Egg Prices in West Bengal**



MI News Service, Kolkata: With the onset of winter, the price of poultry eggs usually rises slightly, but this year, the increase has broken all previous records. The cost of a pair of eggs has surged to ₹15, prompting West Bengal Chief Minister Mamata Banerjee to directly blame the central government for the steep price Speaking to the media, Banerjee argued that the primary feed for chickens and ducks, which is supplied to farms across the state, has been increased by the Centre by 12 per cent annually. She claimed that this systematic rise in feed prices has been directly responsible for

pushing up the cost of eggs

to unprecedented levels. "Why are egg prices rising so sharply?" asked Banerjee. "The main feed for poultry is being increased in price by 12 per cent every year by the central government. Those who talk loudly about eggs on social media should remember that we supply eggs to 12 other states. Why has the Centre increased the cost of poultry feed?" she added, sharply criticizing what she described as "uninformed commentary" on social media. The Chief Minister also highlighted the broader economic context and accused the central authorities of failing to provide adequate support to the state.

## Cal HC Upholds Jobs of 32,000 Teachers, Overturning **Previous Cancellation Order**

MI News Service, Kolkata: The fate of 32,000 teachers in West Bengal was determined today by the Calcutta High Court Division Bench. Justices Tapabrata Chakraborty and Ritabrata Kumar Mitra delivered the verdict shortly after 2:00 PM, instructing that the jobs of the 32,000 primary teachers are to be retained and remain valid. The Division Bench observed that cancelling appointments after nine years of service would have an adverse impact. "We must consider the families of those who have been working for nine years," the bench stated. 'The entire system cannot be damaged for the sake of those who were unsuccessful." The previous singlebench order, delivered by Justice Abhijit Gangopadhyay, had annulled the jobs, citing significant flaws in the entire interview procedure. However, the Division

Justice Chakraborty stated that the Court could not conduct a 'roaming enquiry,' making a direct reference to the involvement of the CBI in the case. There was no question raised regarding the quality of education or teaching provided by the current job holders. The Court noted that there was no concrete proof that the examiner during the interview process received money to award additional marks. Therefore, it could not be conclusively stated that the entire interview process was flawed. Finally, the Court pointed out that the petitioners who brought the case were not employed in these positions. MI News Service, New Delhi: India's army chief said that Operation Sindoor had been "just a trailer" and the country was fully prepared for future chal-

"Operation Sindoor (against terror groups based in Pakistan and PoK) was just a trailer which ended in 88 hours. We are prepared for any circumstances in future," General Upendra Dwivedi said. "If Pakistan gives a chance, we will teach it how to behave responsibly with a neighbouring nation."

"All we are asking is to adopt a peaceful process, which we will cooperate with. Until then, we will treat terrorists and their sponsors alike," Dwivedi said. "We will respond to those who encourage terrorists. Today, India is so accomplished that it is not scared of any blackmail attempts." He added.

Underscoring how India

had "set a new normal" after the April 22 Pahalgam Dwivedi said: "When a country encourages state-sponsored terrorism, it becomes a matter of concern for India. "India talks about progress. If someone creates obstacles in our course, then we will have to take some action against them. When we talk about the new normal, we have said that talks and ter-

ror can't go together." On the lessons learnt from Operation Sindoor, Dwivedi underlined three points — integration between the forces, ensuring proper supplies for a drawn-out battle, and ensuring that decisions are taken at every level of the command chain.

"Whenever some operation happens, we learn from it. This time too we learned things. One of the things we learned was that we have very less (sic) time to make any decision, and take a decision at every level on time," he said.

Stressing integration among the forces, the army chief said "today's battles are multi-domain". "Just the army cannot fight a battle, everyone has to fight to-gether," he said, and he said, and referred to the air force, navy and central paramilitary forces.

#### ZSI reveals new national record of Yunnan Keelback from Arunachal

MI News Service, Kolkata: In a remarkable discovery that bridges colonial-era natural history with modern biodiversity research, scientists at the Zoological Survey of India (ZSI), Kolkata, have confirmed the presence of Yunnan Keelback (Fowlea yunnanensis) within India's administrative boundaries for the first time. During a recent examination of historical collections, researchers from the Reptilia Section of ZSI, namely Sumidh Ray, Anirban Das and Dr Pratvush Mohapatra, identified one of the original specimens collected by renowned naturalist Dr. John Anderson during the 1868 Yunnan Expedition.

Anderson had described the variety "vunanensis" in 1879 based on three specimens deposited in the Asiatic Society of Bengal's Indian museum, which were later transferred to the ZSI (voucher numbers ZSI-R-4191, 4192, 4196). One of these original specimens has now been formally designated as a "Lectotype" by the research team. In addition to this historical identification, the team uncovered seven more specimens (collectively catalogued under voucher number ZSI-R-24039) preserved in the Reptilia Section. These specimens were collected from Gibbon's Land in Namdapha Tiger Reserve, approximately 16 km east of Miao in Arunachal Pradesh, by the former scientist of ZSI, Dr S. Biswas & team on 22 December 1982.

(e) the details of the zones for which these coal-fired steam engines are to be produced along with the routes in these zones on which new coal-fired steam-engine trains proposed to be operated?

It may be noted that the Consequential Train Accidents during the period 2004-14 was 1711 (average 171 per annum), which has declined to 31 in 2024-25 and further to 11 in 2025-26 (upto November, 2025). Another important index showing improved safety in train operations is Accidents Per Million Train Kilometer (APMTKM) which has reduced from 0.11 in 2014-15 to 0.03 in 2024-25, indicating an improvement of approx. 73% during the said period.

app has already seen around 1.5 crore downloads and has proven effective for user safety. With the app and the associated portal, he said, "26

have been returned to the consumers, 41 lakh mobile connections have been disconnected and 6 lakh frauds have been blocked."

Congress leader Pawan Khera questioned Scindia's claim that users can delete the app, arguing that government orders contradict verbal assurances. "They say something, they write something else and do something else altogether," Khera declared.

He said mandatory installation of the app "raises serious concerns" and accused the ministry of misusing "safety" as an

Addressing a press conference, Khera said: "What Pegasus was to VIPs of the country, Sanchar Saathi app is to common man; objective being spying on citizens.

The controversy escalated after a government order dated 28 November surfaced. The directive mandated all mobile phone manufacturers to pre-install the Sanchar Saathi app on every new handset sold in India, and to push it to existing devices through software updates.

The order also instructed companies to ensure the app is "readily visible and accessible" to users at first setup and that its features "are not disabled or restricted.'

The order gave manufacturers 90 days to comply.

It triggered widespread outcry from political parties and social media users, who warned that the app could potentially




## NTPC to Host Regional Round of Electron Quiz 2025 in Patna

## Nadda urges MPs to boost awareness, mobilise communities to eliminate TB

New Delhi, Union Minister of Health and Family Welfare JP Nadda sensitised the Members of Parliament from across party lines on the TB-Mukt Bharat Abhiyaan and urged them to boost awareness and mobilise communities to eliminate the world's most infectious disease. In the first of a series of interactions with

Parliamentarians, with a special focus on MPs from Uttar Pradesh, Nadda underscored the important leadership roles of the MPs in achieving the goal of TB elimination. The MPs were informed about the campaign objec-

tives, key activities being undertaken, and their role in supporting the campaign.

The Minister urged the MPs "to monitor the campaign in their respective constituencies, raise awareness and reduce stigma around the disease, and mobilise the community to actively participate in the campaign"

He also highlighted the progress the country made in tackling the TB burden.

"India's TB incidence (new cases emerging each year) reduced by 21 per cent -- from 237 per lakh population in 2015 to 187 per lakh population in 2024 -- over almost double the pace of the decline observed globally at 12 per cent, as per the World Health Organization's Global TB

'Similarly, India's TB mortality rate has decreased from 28 per lakh population in 2015 to 21 per lakh population in 2024, reflecting significant progress in reducing deaths due to TB," he added.

The MPs were also informed about several novel interventions that have been rolled out in the last 10 years, including the swift uptake of new technologies like AI-enabled hand-held chest x-ray machines and Truenat machines, the adoption of more effective, shorter treatment regimens, decentralisation of TB care through the network of Ayushman Arogya Mandirs, community engagement, etc.

Further penetration of TB screening services and awareness generation at the ground level is crucial for the success of the TB elimination efforts," said Nadda, while encouraging the MPs to support these efforts to make it a Jan Andolan.

### IIT Bombay study shows how TB bacteria shield themselves from antibiotics, stay alive longer

New Delhi : The bacteria Mycobacterium tuberculosis, which causes the world's most infectious disease Tuberculosis (TB), can survive antibiotic treatment and live longer by changing their outer fat coating, according to a new study led by researchers from the Indian Institute of Technology (IIT) Bombay on Wednesday


Even with effective antibiotics and widespread vaccination campaigns, TB continues to take

Globally, 10.7 million people developed TB and 1.23 million died from the disease in 2024. while India carries one of the highest burdens -- over 2.71 million cases in 2024.

In the study, published in the Chemical Science journal, the researchers showed that the key to the bacteria's drug tolerance lies in their membranes -- complex barriers made mostly of fats, or lipids that protect the cell.

The team grew the bacteria under two conditions: an active phase, when the bacteria were dividing rapidly as they do in an active infection, and a late stage mimicking dormancy, as seen in latent infections.

When they exposed the bacteria to four common TB drugs: rifabutin, moxifloxacin, amikacin, and clarithromycin, the team found that the concentration of drugs needed to stop 50 per cent of bacterial growth was two to 10 times higher in dormant bacteria than in active ones.In other words, "the same



drug that worked well in the early stage of the disease would now be needed at a much higher concentration to kill the dormant/persistent TB cells. This change was not caused by genetic mutations, which usually explain antibiotic resistance, said Prof. Shobhna Kapoor from the Department of Chemistry, IIT-

Lack of mutations associated with antibiotic resistance in the bacteria confirmed that the reduced drug sensitivity could be linked to the bacteria's dormant state and most likely their membrane coats rather than genetic changes. Further, the team identified more than 270 distinct lipid molecules in the bacterial membranes, which showed clear differences between active and dor-

While the active bacteria had loose, fluid membranes, the dormant ones had rigid, tightly ordered structures, indicating its

"People have studied TB from the protein point of view for decades," said Kapoor.

"But lipids were long seen as passive components. We now know they actively help the bacteria survive and resist drugs,'

Next, the team found that the

antibiotic rifabutin could easily enter active cells but barely crossed the outer membrane of dormant ones. "The rigid

becomes the main barrier. It is the bacterium's first and strongest line of defence,' explained Kapoor.

If the outer membrane blocks antibiotics, weakening it could make the drugs work better.

"Even old drugs can work better if combined with a molecule that loosens the outer membrane," said Kapoor, noting that the approach makes bacteria sensitive to the drugs again without giving them a chance to develop permanent resistance.

## Death toll from floods, landslides in Indonesia rises to 712

MI News Service, Jakarta: The death toll from recent floods and landslides across three provinces on Indonesia's Sumatra Island has risen to 712, with 507 people still missing, the National Disaster Management Agency (BNPB) said on Tuesday.

The agency reported that disasters have displaced about 1.1 million people in North Sumatra, West Sumatra, and Aceh provinces.

Rescue teams have faced difficulties reaching several villages on Sumatra Island, as floods swept away roads and destroyed bridges. Although helicopters and boats have been deployed, local authorities said deteriorating weather conditions and damaged infrastructure continue to hamper response efforts.

At the same time, efforts to restore telecommunications services are also being accelerated. The Ministry of Communication and Digital Affairs reported that more than 90 percent of transmission towers in flood- and landslide-affected areas in West Sumatra and North Sumatra have resumed operations.



The ministry is also accelerating efforts to restore telecommunications networks, ensuring residents can reconnect and access essential information. Indonesian President Prabowo Subianto said on Monday that the government's rescue and relief efforts are being carried out with

## Seven Maoists, two DRF personnel cop killed in encounter in Chhattisgarh



MI News Service, Bijapur: Seven Maoists and two District Reserve Guard (DRG) personnel were killed in an encounter in Chhattisgarh's Bijapur district on Wednesday, officials said. Another jawan suffered injuries in the gunfight, they said, adding that the operation was still underway.

The gun battle took place in a forest of the Gangaloor area adjoining Dantewada district when a joint team of security personnel was out on an anti-Maoist operation, said Bijapur superin-tendent of police, Dr. Jitendra Yadav. Personnel belonging to the DRG and Special Task Force, both units of the state police, and CoBRA (Commando Battalion for Resolute Action- an elite

So far, bodies of five Maoists have been recovered from the spot, the official said. "Two DRG personnel, Head Constable Monu Vadadi and Constable Dukaru Gonde, were martyred during the operation. Another jawan Somdev Yadav sustained injuries. He has been evacuated for treatment," he said. With the latest action, 269 Maoists have been killed in encounters in Chhattisgarh so far this year. Of them, 239 were eliminated in the Bastar division, comprising seven districts, including Bijapur and Dantewada, while 27 others were gunned down in Gariaband district, which falls in the Raipur division. #### Mass wedding in Gaza celebrates joy amid the city ruins



MI News Service, Khan Younis: Palestinians gathered in the ruins of southern Gaza to celebrate the mass wedding of more than 50 couples on Tuesday, December 2, a rare moment of hope after two years of devastation, death

Weddings are a key part of Palestinian culture but have become rare in Gaza during the war, and a tradition that some couples have been able to restart in the wake of a fragile ceasefire.

Couples walked hand-in-hand past the crumbled buildings of southern Gaza in a line of other couples dressed in exactly the same way.

"Despite everything that has happened, we will begin a new life," said Hikmat Lawwa, one of the grooms getting ready to marry. "God willing, this will be the end of the war," he said.

As roaring crowds waved Palestinian flags in the southern city of Khan Younis, the celebrations were dampened by the ongoing crisis across Gaza. Most of Gaza's 2 million residents, including Eman and Hikmat Lawwa, have been displaced by the war, entire areas of cities have been flattened and aid shortages and outbursts in conflict continue to plague the daily lives of peo-

"We want to be happy like the rest of the world. I used to dream of having a home, a job, and being like everyone else," Hikmat said. "Today, my dream is to find

Eman, who was cloaked in a white, red and green traditional dress, said the wedding offered a small moment of relief after years of suffering. But she said it was also marked by the loss of her father, mother, and other family members who were killed during the war.

"It's hard to experience joy after such sorrow," she said, tears streaming down her face. "God willing,

The celebration was funded by Al Fares Al Shahim, a humanitarian aid operation backed by the United Arab Emirates. In addition to holding the event, the organization offered couples a small sum of money and other supplies to start their lives together.

#### Asim Munir Is A 'Radical Islamist', Wants War With India: Imran Khan's Sister

News Rawalpindi: One of the three sisters of the jailed former Pakistan Prime Minister Imran Khan attacked the country's army chief, Field Marshal Asim Munir, claiming that he is a "radi-cal Islamist" who "yearns for a war with India"

While speaking with Sky News on 'The World with Yalda Hakim', Aleema Khan, Imran Khan's sister, said that Munir's "Islamic radicalisation" forces him to fight nonbelievers while criticising the country's first Chief of Defence Forces (CDF). She alleged, "Asim Munir is a very radicalised Islamist and Islamic conservative. This is the reason why he yearns for a war with India. His Islamic radicalisation and conservatism force him to fight against those who don't believe in Islam," Aleema said

on the show. "Whenever Imran Khan comes to power, you will see that he always tries to befriend India, and even the



India, even the allies of India will suffer," she said. Claiming that her brother's thinking was of a ""pure liberal" compared to Munir, Aleema appealed to the West to increase its efforts to free Imran Khan, whom she described as an "asset". Her interview comes amid mounting rumours about Imran Khan's health and claims by his family seeking proof that he is alive. According to a Pakistani news outlet, The Dawn, authorities at Rawalpindi's Adiala Jail allowed one of the other sisters, Uzma Khanum, to meet the former Prime Minister.

## Indigo cancels over 70 flights due to crew shortages IST



MI News Service, Mumbai: IndiGo has cancelled over 70 flights, including those from Bengaluru and Mumbai airports, on Wednesday, mainly due to crew shortages, sources saidScores of IndiGo flights were delayed at various airports, as the carrier struggled to get the crew for operating its flights, sources said. IndiGo said there have been cancellations and delays.

"We have had several unavoidable flight delays and some cancellations in the past few days due to various reasons, including technology issues, airport congestion, and operational requirements," the airline spokesperson said in a statement. "IndiGo has been facing acute crew shortage since the implementation of the second phase of the FDTL norms, leading to cancellations and huge delays in its operations across the airports," a source told PTI.

'The situation turned bad on Tuesday for the airline and the shortage turned worse on Wednesday with scores of flights cancelled and delayed from across airports in the country," the source said. IndiGo's on-time performance from six key domestic airports plummeted to 35 percent on Tuesday. In contrast, Air India clocked 67.2 percent, Air India Express 79.5 percent, SpiceJet 82.50 percent and Akasa Air 73.20 percent, according to the Civil Aviation Ministry website.

#### Railways' transparent move: OTP-based Tatkal ticketing system to be implemented soon

MI News Service, Kolkata, 3 Dec.25: Indian Railways has decided to implement an OTP-based ticketing system for Tatkal tickets purchased at the counter to enhance passenger convenience and transparency. This new system will be implemented at all reservation counters across the country in the next few days. Railways implemented the Aadhaar OTP system for online Tatkal tickets in July 2025. This was followed by the introduction of an OTP-based online ticketing system for all general reservation bookings in October 2025. Both these initiatives were widely accepted by passengers, making the ticketing process more transparent. The Railways launched a pilot project for an OTP-based Tatkal ticketing system for counter bookings in November 2025. Currently, this system has been implemented on 52 trains. Under this system, when booking Tatkal tickets at the counter, an OTP is sent to the mobile number entered in the passenger's form, and the ticket is issued only after verification.

MI News Service, United **nations:** Amid continuing reports of Israeli attacks in all five Gaza governorates, UN humanitarians said on Tuesday that they answered a Civil Defense distress call and helped coordinate the rescue of in-

jured people in Gaza City. The UN Office for the Coordination of Humanitarian Affairs (OCHA) said the rescues occurred on Monday in the Tufah neighborhood, following a distress call from Civil Defense teams. Details of the nature of the distress call were not available.

The World Health Organization said its team led the medical evacuation of 18 patients and 54 companions from Gaza for treatment abroad, adding that more than 16,500 patients still need life-saving care that is not available in Gaza. OCHA said that with winter approaching, the humanitarian community in the Gaza Strip is working to scale up the delivery of assistance to people in need, including children, who have suffered immensely over the past two years.

In the past two months, humanitarian partners have provided, alongside the distribution of other essential supplies, tens of thousands of critical items to help prepare for colder weather, including shoes, clothes, blankets and towels, to children across the

The humanitarian office repeated its call for the opening of all available border crossings and corridors, so that patients can seek treatment in the West Bank, and it stressed the need for unimpeded access for international emergency medical teams to enter Gaza.

## Global growth to slow to 2.6 pct in 2025: UN report

MI News Service, Geneva: Global growth will slow to 2.6 percent in 2025, down from 2.9 percent in 2024, due to growing pressure from financial volatility and geopolitical uncertainty facing global trade and investment, the United Nations Trade and Development (UNCTAD) said in a report released on Tuesday.

The UNCTAD's Trade and Development Report 2025 shows that shifts in financial markets affect global trade almost as strongly as real economic activity, influencing development prospects worldwide, said the UN trade body. The report said that despite potential gains from new technologies like artificial intelligence, global growth is projected to remain

subdued in 2026, at 2.6 percent. UNCTAD said that its projection was based on a global growth aggregate using market exchange rate (MER) weights rather than purchasing power parity (PPP) weights used by the Organization for Economic Co-operation and Development (OECD), with the latter leading to a higher global growth forecast. The OECD on the same day predicted that global GDP growth will slow from 3.2 percent in 2025 to 2.9 percent in

UNCTAD Secretary-General Rebeca Grynspan said the findings show how financial conditions increasingly determine the direction of global trade. "Trade is not just a chain of suppliers. It is also a chain of credit lines, payment systems, currency markets, and capital flows,"

The report said developing economies are forecast to grow by 4.3 percent in 2025, significantly faster than advanced economies. However, factors such as higher financing costs, greater exposure to sudden shifts in capital flows, and rising climate-related financial risks

In addition, climate vulnerability adds to financial pressures, with countries repeatedly exposed to extreme weather paying an estimated 20 billion U.S. dollars more each

vear in interest. UNCTAD called for a set of re-

## Kohli closes in on Rohit to top ODI rankings after Ranchi heroics

overtaking his teammate Rohit Sharma to lead the ODI batting rankings after he scored his 83rd international century to rise in the ICC Rankings update released on Wednesday.

In the first ODI of India's three-match series against South Africa in Ranchi, Kohli, 37, scored an impressive 135 off 120 balls. His performance elevated him one place, now ranking fourth among ODI batters in the latest ICC Men's Player Rankings.

This brings Kohli's rating up to 751 points, placing him just 32 points behind teammate Rohit Sharma at the top of the ODI batter rankings. Kohli was the leading batter for over three years towards the end of the last decade but has not held the top spot since Pakistan's Babar Azam overtook him in April 2021.

Meanwhile, Rohit extended his lead at the top, surpassing second-placed Daryl Mitchell of New Zealand and Afghanistan's Ibrahim Zadran in third, while Kohli moved ahead of his teammate Shubman Gill to claim the fourth position, closing the gap on the former India captain at the top.

India celebrated additional success as veteran left-arm spinner Kuldeep Yadav advanced one spot to rank sixth among ODI bowlers. Meanwhile, the top spot in the T20I all-rounder rankings changed

once more after the recent tri-series in Pakistan. Pakistan secured the tri-series with a six-wicket win over Sri

Lanka in the final, and opener Saim Ayub capitalised on the success by reclaiming his position at the top of the T20I all-rounders rank-Ayub initially claimed the top spot at the start of October but was recently overtaken by Zimbabwe veteran Sikandar Raza. However,

his performance of 36 in the tri-series final, along with a crucial Sri Lankan wicket from four economical overs, helped the impressive 23-year-old regain one place and move back up to No.1. Teammates Abrar Ahmed (climbing four spots to fourth) and

Mohammad Nawaz (rising two spots to 11th) benefited from Pakistan's success in the tri-series as they improved their positions in the T20I bowling rankings.

Additionally, Nawaz advanced three places to fourth among allrounders after being named Player of the Tournament.

Sri Lanka will be boosted by Kamil Mishara's performance in the tri-series, where he scored 169 runs over four innings and climbed from outside the top 100 to the 18th spot among T20I batters.

Moreover, three Bangladesh players also saw improvements after

their recent 2-1 series victory against Ireland at home.
Parvez Hossain Emon rises 21 places to 38th, and Towhid Hridoy moves up five positions to share 42nd, as both make gains in the T20I batter rankings. Meanwhile, Mustafizur Rahman climbs two spots to eighth in the T20I bowler list.

South African players experienced significant improvements after their Test series sweep against India. Left-arm pacer Marco Jansen was the biggest winner, rising in both bowling and all-rounder rankings due to his strong performance in the 2-0 series victory.

Jansen achieved a new career-high rating by climbing five spots to fifth on the Test bowlers list. Meanwhile, teammate Simon Harmer surged 13 places to 11th after taking 17 wickets across two match-

es and earning Player of the Series honours. Jansen advanced four spots to second in the Test all-rounders rankings. Meanwhile, teammates Kyle Verreynne (up three spots to 38th), Ryan Rickelton (up five places to 39th), and Tristan Stubbs (up 16 slots to 47th) all achieved notable increases in the Test batter

The incident happened during the 22nd over of South Africa's innings when Rana gestured towards the dressing room after dismissing Proteas batter Dewald Brevis.

It was considered that the action might have provoked an aggressive response from the batter, resulting in the pacer receiving one demerit point on his disci-

plinary record.
